PARENTS OF LGBTQIA+ TO CJI FOR LEGAL STAMP OF 'RAINBOW MARRIAGES'

Over 400 parents write to Chief Justice of India D. Y. Chandrachud making the passionate plea

n a letter to the Chief Justice of India D.Y. Chandrachud, the parents of Indian LGBTQIA+ children appealed to consider the plea for Marriage Equality and added that "we hope to see the legal stamp on rainbow marriages of our children in our lifetime."

The letter by 'Sweekar-The Rainbow Parents' assumes significance it comes when a five-judge constitution bench headed by the CJI is hearing a batch of petitions seeking legal validation for same-sex marriage for the fourth day.

The letter stated, "We desire to see our children and

our children-in-law find legal acceptance for their relationship under the Special Marriages Act in our country. We are certain that a nation as big as ours, which respects its diversity and stands for the value of inclusion, will open its legal gates of Marriage Equality to our children too. We are

LGBTQIA+ denotes to lesbian, gay, bisexual, transgender, queer, questioning, intersex, pansexual, twospirit, asexual, and ally. The letter further stated,

"We are appealing to you to consider the plea for Marriage Equality." "From knowing about gender and sexuality to understanding the lives of our children, to finally accepting their sexuality and their loved onewe have gone through the whole gamut of emotions. We empathise with those who are opposing Marriage Equality because some of us were there too. It took us

The letter further said that Gender and Sexuality made to election manifestos and corporate India has also begun opening up gradually to the idea of queer lives.

"Society is a changing and evolving phenomenon. Just as a rising tide lifts all boats, the judgement by the honourable Supreme Court created a ripple effect on society and has helped move the needle from hate to tolerance to acceptance," the rainbow parents said.

"We desire to see our children and children-in-law find final legal acceptance for their relationship under the Special Marriage Act in our country. We are certain that a nation as big as ours which respects its diversity and stands for the value of exclusion, will open its legal gate of marriage equality to our children too.

BJP GOES ALL OUT ON SCRAPPING OF MUSLIM QUOTA

'nio Home Minister Amit Shah on Tuesday defended the BJP government's decision in Karnataka of scrapping four percent quota for Muslims saying the party never believed in 'religionbased reservation'.

The former BJP chief also took a dig at Congress for its stand that the quota would be restored if it is voted to power in the state after the 10 May Assembly polls.

"There was a religion based reservation of four percent for Muslims. Without falling for the vote bank politics, the BJP government abolished the Muslim reservation," he said addressing a public meeting at Terdal in this district.

"We believe that religion based reservation should not happen," Shah opined.

The Minister added that after abolishing Muslim reservation, the BJP government increased the res-

Referring to the Basavarai Bommai government's decision to increase the SC reservation from 15 percent to 17 percent, Shah noted that the internal reservation of SC (Left) now stands at six percent, SC (Right)- 5.5 percent and other SCs 5.5 percent.

Responding to Congress president D K Shivakumar who has promised to restore the Muslim reser-

ervation for the Scheduled vation if his party comes to power, Shah sought to know whose quota the party will scrap if it manages to form the government in Karnataka.

> "Whose reservation will be decreased if four percent reservation for Muslims is restored? Will it be Vokkaligas or Lingayat, Dalits, Scheduled Tribes or the Other Backward Castes?' the Minister asked.

At the fag end of its term, the BJP government decided to abolish the four per-

cent reservation for Muslims under 2-B category. The four percent was later split into two and distributed among Vokkaligas in 2-C category and Lingayats in 2-D category.

Vokkaligas and Lingayats are the two major dominant communities of Karnataka. Shah's statement came on

AWAITS SC HEARING

Govt not to implement 4% reservation for Muslims: CM Bommai

Karnataka Chief Minister Basavaraj Bommai on Tuesday said the state government will not implement its decision to scrap four percent reservation for Muslims in 2B category of the 'Other Backward Castes' till the hearing in the Supreme Court is completed.

He emphasised that the reservation for 17 sub-castes of extremely backward Muslims who are placed in Category-1 and Category 2-A have not been touched. "We had decided that till the time the hearing is complete we will not take it forward. Court has not given any stay. We only have said that you (SC) hear the case; so long the case is heard, we will not implement it," Bommai told the media. He was reacting to the Supreme Court's direction to the Karnataka government

category. "There are about 17 sub-castes within Muslims - Pinjar, Darzi, Chakarband. Those are still in the backward classes only under Category-1 and 2A. Those who are extremely poor are still in those two categories," Bommai said.

He also said that the Muslims have been placed in the Economically Weaker Section category which is entitled for 10 percent reservation.

"Those who were getting four percent have been put in the 10 percent category. This way, no injustice has happened," Bommai explained. In her reaction, the Union Minister of State for Agriculture and Farmers' Welfare Shobha Karandlaje said the Constitution of India does not permit religion-based reservation. "The previous government had introduced it as part of its appeasement politics," Karandlaje said.

WRONG TO SAY 'I AM RAISING QUESTIONS **OVER PULWAMA ATTACK': SATYA PAL MALIK**

Former Jammu and Kashmir governor Satya Pal Malik has said that it was "wrong" to state that he was raising questions over the 2019 Pulwama terror attack

only after demitting office.

His remark came on Monday in response to a question on Union Home Minister Amit Shah's recent statement that he was "levelling allegations after parting ways with us". "It is wrong to state that I raised this issue when I was out of power," he told reporters in Sikar in Rajasthan, adding that he had raised it on the day of the attack.

Forty Central Reserve Police Force (CRPF) personnel were killed in the terrorist attack on a convoy of security vehicles in Jammu and Kashmir's Pulwama in February 2019. Malik, who was then governor of Jammu and Kashmir, has recently alleged intelligence failures and that the central government denied aircraft for the



movement of security personnel. Asked about the allegation

that the CBI's recent summons to Malik was linked to his criticism of Prime Minister Narendra Modi and his government, Shah had last week said such a charge is not true as he was called by the probe agency earlier too.

In an interview with India Today, Shah had said, "I can say with complete conviction that the BJP has be covered up. If someone is levelling allegations after parting ways with us, then

it should be evaluated accordingly by the media and people."

On Monday, Malik said Defence Minister Rajnath Singh is a "serious candidate" for the post of prime minister and that "if it is in his destiny, he will become one".

Asked about the BJP's prospects in the Lok Sabha elections next year, he said, "I wish them well, but in politics and elections, no implementation of the Predone nothing that needs to one knows what will happen. The current situation is difficult for them, they will have to do some things."

ABORTION BASED ON SEX DETERMINATION BEHIND GENDER DISPARITY: DELHI HC

Abortion based on sex-determination is a powerful method of perpetuating gender inequalities, the Delhi High Court has said, emphasising the law must have teeth to sternly deal with such situations till attitudinal changes at family level are achieved. The restriction of access to

foetal sex information is directly related to the problem of misogyny which affects women of all socioeconomic backgrounds not only in this country but globally as well, the court said. Justice Swarana Kanta Sharma made the observations while passing a slew of directions to the authorities for a strict Conception and Pre-Natal Diagnostic Techniques Act, 1994 (PCPNDT Act). The high court's order came while

refusing to quash an FIR against a doctor who was booked under several sections of the PCPNDT Act after a raid was conducted at a hospital here on information regarding illegal sex determination. It, however, set aside as bad in law the cognisance taken by the trial court in the absence of any complaint filed by appropriate authority under Section 28 of the Act. The court said the well-intended and well-implemented PCPNDT Act and Rules are means for intervention to combat gender imbalance. "The social context of the Act as well as the offence need to be remembered, and it has to be kept in mind that the gender-based violence, whether be it safety of a female child after birth or even when she is not born, is not only the concern of the State, but also of the Courts of law," it said.

HC GRANTS BAIL TO MAN ACCUSED OF PASSING INFORMATION TO PAKISTAN

The Delhi High Court on Tuesday granted bail to a primary school teacher who was arrested in 2015 for being part of a "network" involved in alleged anti-national activities supported by Pakistanbased intelligence operatives.

According to the prosecution, the accused was involved in the process of collection of information regarding deployment of the Indian Army and the Border Security Force in Jammu and Kashmir, and passing the same to persons

across the border, thus endangering national security. Justice Amit Sharma said the accused, who was facing trial under Official Secrets Act for serious and grave offences, satisfied the requirement of section 436A of the Code of Criminal Procedure (CrPC) for bail after undergoing half the sentence provided for the offence he is charged with. The court said although the prosecution made an assertion with regard to the likelihood of the accused affecting the security of the country and the chance of his absconding if released.

ACCOMMODATION

RECOGNISE TRANSGENDER AS THIRD GENDER FOR FREE BUS TRAVEL: HC

The Delhi High Court has granted one month's time to the city government authorities to decide a representation to legally recognise transgender community as the third gender in bus tickets issued by the DTC. In case of noncompliance, the managing director of the Delhi Transport Corporation (DTC) shall remain present before it on 18 August the court ordered. The court's order came on

a contempt petition filed for

"wilful non-compliance" of an October 2022 order of a division bench, which had granted four months to the authorities to take a view on the representation.

The order of the division bench had come on public interest litigation by a person belonging to the transgender community, who sought legal recognition of the community as the third gender in bus tickets and provide free travel for them in DTC buses. Women travelling in DTC buses are issued pink tickets that allow them to travel for free.

JNU students began sit-in protest, demanding hostel rooms

A group of students are on a protest at the Jawaharlal Nehru University here alleging they are yet to be assigned hostel rooms despite being in the second semester which has forced them to put up at rented accommodations.

The protesting students began a sit-in at the Dean of Students' office in the university on Monday evening. They said the demonstration would continue till their demands are met. There was no immediate response from the

JNU administration over this. The protesters also claimed that they have been locked inside the office and denied "basic necessities of accessing the toilets".

In a statement, the Jawaharlal Nehru University Students' Union (JNUSU) said, "Students have been sitting inside the Dean of Students' Office since Monday, demanding hostels. Despite being into the second semester, students are being forced to stay in rented rooms and pay exorbitant rents." The students also alleged that the

Barak was being delayed, adding to the woes of the students. "The construction of Barak Hostel is with the CPWD, which has given the contract to a private company. This private company has failed to pay the workers and supervisors on time, due to which work has been stopped. The handover of the hostel is being delayed indefinitely as a result," the JNUSU claimed."The students have also demanded that all women students who are in dorms be given hostels immediately.

HC REFUSES TO GRANT URGENT HEARING TO GOOGLE

NEW DELHI: The Delhi High Court on Tuesday refused to grant an urgent hearing to Google on its challenge to a single-judge bench order asking the Competition Commission of India (CCI) to consider a plea of the Alliance of Digital India Foundation (ADIF) against the tech giant's policy of allowing the use of third-party payment processors for paid app downloads and in-app purchases on a commission basis. The matter was mentioned for an urgent listing by senior advocate Sandeep Sethi, who appeared for Google before a division bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad.

HC ORDERS CHIEF SECRETARY TO FILE PERSONAL AFFIDAVIT

RAIPUR: The Chhattisgarh High Court recently directed the State Government's Chief Secretary to file a personal affidavit explaining why no steps are taken to verify physical disability certificates as per a circular issued by him in 2019. The petitioner had previously moved before the High Court in 2019, filing a Public Interest Litigation (PIL) in which he emphasized the widespread misuse of 'disability certificates' issued under the Rights of Persons with Disabilities Act, 2016. While disposing of the case, the Court had then ordered the Chief Secretary of the State to issue appropriate directives to the relevant authorities to guarantee that no one other than a physically disabled person is allowed to profit from the Act's provisions.

SC ADJOURNED HEARING ON MUSLIM RESERVATION ISSUE

NEW DELHI: The Supreme Court on Tuesday adjourned the hearing on a petition challenging the Karnataka government's decision to scrap 4% OBC reservation for Muslims until 9 May. Meanwhile, the Karnataka government has reiterated that no admissions or postings will be made based on the government directive till 9 May. The Karnataka government had previously requested an adjournment and assured a bench of Justices KM Joseph and BV Nagarathna that no new appointments or admissions would be made based on Karnataka's ruling scrapping Muslim reservation until the next date of hearing. The state administration also informed the court last week.

RESIDENTS OF SOCIETY NEED TO PROVIDE WATER TO ANIMALS: HC

MUMBAI: In a dispute between a housing society and its members over feeding stray dogs and feeding points, the Bombay High Court has stated that it would be an obligation of the residents of the society to always make provisions for adequate water to be made available to the animals, especially considering the onset of the summer season. In its decision recently, a division bench of Justices Girish Kulkarni and R N Laddha acknowledged the petitioner's, an animal lover, assertion that she would like to supply drinking water to the dogs. "The parties must resolve the dispute amicably because drinking water should not be denied to the dogs," the court observed.

TOP OF THE DAY

10% REBATE ON **PROPERTY TAX IN HARYANA**

CHANDIGARH: Haryana Urban Local Bodies Minister Kamal Gupta said on Tuesday that people will get a 10 percent rebate on property tax payments made in ULB units until 31 July this fiscal. He directed officers to run an awareness campaign to make the public aware of this initiative so that the maximum number of people could avail themselves of the rebate. Gupta was holding a meeting with officers of Urban Local Bodies (ULB) in Sonipat, according to an official statement here. He said the state government has started several public welfare schemes to improve the standard of living of the common people, and the benefits of these schemes are being directly provided to the people.

3 COPS INJURED IN PCR-TRACTOR **COLLISION**

GURUGRAM: Three police personnel were injured after a tractortanker collided with a PCR van that was part of Haryana BJP president OP Dhankar's convoy near Himgiri Chowk here police said on Tuesday. The tractor-tanker driver allegedly came on the wrong side of the road, which led to the accident, they added. After the collision, the tractor overturned, and the PCR van was badly damaged. All three police personnel were injured, the complaint added. The driver of the tractor fled after the incident, and the vehicle did not have a number plate. The tractor-tanker has been impounded, and a hunt is on to nab the driver, a police official said.

NEPALI NATIONAL ARRESTED FOR MURDER

SHIMLA: A Nepali national who killed his wife two months ago was arrested on Tuesday after the mutilated body of the deceased was recovered from a field, police said. The incident was reported in the Madog area of the Chopal subdivision of Shimla district. The body was recovered after the owner of an orchard here found shoes and clothes on his property and informed the police, they said, adding that the forensic team identified the deceased as 27-yearold Maya. The woman had been reported missing for two months, they said An investigation revealed that Maya was killed by her husband, Gopal, in February.

SMUGGLER HELD WITH 1KG OF HEROIN IN PUNJAB

HOSHIARPUR: A man was arrested with 1 kg of heroin in his possession near Mahilpur, police said on Tuesday. The man, identified as Sokha was intercepted during a special check at Harbans Gate in Mahilpur here on Monday night, they said. Fifty injections filled with narcotics and 25 syringes were found in his possession, they said. Sokha was booked under the Narcotic Drugs and Psychotropic Substances Act, the police added.

DEATH OF A DOYEN

END OF AN ERA IN INDIAN POLITICS: BADAL'S DEMISE LEAVES A VOID

Tive-time former Punjab chief minister and Shiromani Akali Dal patriarch Parkash Singh Badal, known for his winsome humility and strong rural roots, died on Tuesday. He was 95. "Mr. Badal passed away at around 8 p.m.," hospital director Abhijeet Singh told The hospital issued a medical bulletin shortly afterwards in which it said, "Despite appropriate medical management, S. Parkash Singh Badal succumbed to his illness. Fortis Hospital Mohali deeply condoles the death of S. Parkash Singh Badal."

During his long political career, Badal served the state as chief minister five times: 1970-71, 1977-80, 1997-2002, 2007-12, and 2012-17. At 94, Badal last year became the country's oldest candidate to fight a state election when he en-

tered the electoral battle for the 13th time but could not save his pocket borough of Lambi in Muktsar district, only his second defeat in a political career spanning more than seven decades.

Born on December 8, 1927, in Abul Khurana, near Malout, Badal graduated from the Forman Christian College, Lahore. His political journey began in 1947, when he became the 'Sarpanch' (village head) of Badal village, then in Bathinda district. Thereafter, he became the chairman of the block

samiti.

the first time in 1957, when he was elected to the Punjab Assembly from Malout constituency as a Congress member. He then moved to the Gidderbaha assembly seat from where he was elected as an MLA on a SAD ticket during the 1969 mid-term poll. Badal was re-elected in the 1972 elections, but as the SAD could not form a government, he became the leader of the op-

Badal was chief minister for 15 months in 1970-71 and for 32 months in 1977-1980. During the 1977 elections, he again won the Gidderbaha constituency and became the chief minister of the SAD-Janata Party government. His government passed the Punjab Women and Children Development and Welfare Corporation Bill, 1979, to ensure the development of women and children in the state. He was again elected to the state assembly in the June 1980 and

September 1985 elections from the Gidderbaha assembly constituency.

In 1986, Badal formed the Shiromani Akali Dal (Badal). Badal, after shifting to Lambi constituency, was elected legislator in 1997 and became the chief minister on February 12 of that year as the leader of the SAD-BJP government.

During this tenure, his government took the decision to provide free electricity and waive land revenue for farmers. Badal was reelected from Lambi seat in 2002, 2007, 2012 and 2017. In 1967, he lost the Gidderbaha seat to the Congress' Harcharan Singh Brar by a margin of just 57 votes. This was his first electoral loss. The second came last year. The grand old man of Punjab politics has not been keeping well for the past few years. He was hospitalised in June of last year following complaints related to gastritis and bronchial asthma.

The demonstration was staged at Verka Chowk in the city on Tuesday by the agitators, including "Nihangs," who demanded the culprits receive harsh punishment. In a video that surfaced on social media, the

man wearing shoes could be seen entering the sanctum sanctorum of Kotwali Sahib gurdwara after crossing the railing and then hitting two 'granthis' who were reciting from the Guru Granth Sahib and then pushing the holy book.

Jasvir Singh, who works as an electrician, was later overpowered by devotees present in the shrine and beaten up. He was then handed over to the police. On Monday, police said the accused had been booked under IPC sections 295 A (deliberate and malicious acts intended to outrage religious feelings of any class by insulting its religion or religious beliefs) and 307

HARYANA ACB ON TOES, TABS ON SENIOR OFFICIALS

With around one year left in the forthcoming assembly elections in Haryana, the BJP-led government claims to take stern action against those officials involved in taking bribes during its regime so far. It is evident from the last few months that the ACB has been taking action on a large scale, and hardly a day passes when some government employee or officer is not caught taking bribes. The BJP government is leaving no stone unturned to set up its image as an anti-corruption government.

In continuation to this, it is pertinent to mention that the opposite faction accused the ruling faction of taking action against the honest officials with ill intentions. The issue of arresting a woman for allegedly taking a bribe of Rs 3 lakh for passing bills in Haryana Kaushal Vikas Mission recently on behalf of a senior IAS official led to uproar in the state. The involvement of high officials in it is echoing across the state. The Anti-Corruption Bureau (ACB) has questioned the accused senior IAS officer, Vijay Dahiya, for the case since

it surfaced. Apart from this, the bureau is also keeping an eye on other suspicious officers and employees of the department. It has now come to light that the bureau is now preparing to investigate the history of officers with a dark past. In light of the ongoing scenario, it is believed that now the bureau is engaged in brainstorming on preparing a list of such officers. In a way, the bureau has been given a free hand by the government as well. Apart from this, the issue continues to remain in the political corridors.

As per information provided by the Bureau, five HCS officers were arrested on corruption charges during the year. Also, two chief engineers, a superintending engineer and an executive engineer, a chief accounts officer and a joint director of the urban local bodies department have been arrested on charges of misappropriation of public funds. In addition, a total of 193 government servants, including 27 gazetted officers, 166 non-gazetted officers, and 27 private individuals, have been arrested

during 2022.

KOTKAPURA POLICE FIRING

SIT files supplementary chargesheet in court

A Punjab Police SIT probing the 2015 Kotkapura police firing incident in which two men were killed submitted a supplementary chargesheet in a local court in Faridkot district on Tuesday, official sources said. The 2,400page charge sheet was filed by the Special Investigation Team, headed by Additional Director General of Police L. K. Yadav.

The SIT had filed a 7.000page chargesheet in the matter on February 24. In the first chargesheet, the SIT had named the then Chief Minister Parkash Singh Badal, then deputy CM Sukhbir Singh Badal, and ex-DGP Sumedh Saini, along with several others. Sukhbir Badal and Sumedh Saini were named as the "masterminds of conspiracy for use of illegal excessive force to hide the inaction" of the state on three sacrilege incidents in Faridkot. Badal, the then-state chief minister, was blamed for "facilitating

the execution of the conspiracy" in the 7,000-page charge sheet.

The series of incidents that threw several districts of the state into turmoil began with the theft of a 'bir' (copy) of the Guru Granth Sahib from Faridkot district in 2015. Soon after, several handwritten sacrilegious posters were found pasted on walls at places in the district, while people in Bargari village found torn pages of the holy book scattered around.

The incidents triggered vociferous protests in Faridkot. As the police mounted resistance to rein in agitations, Gurjeet Singh and Kishan Bhagwan Singh, were killed in Behbal Kalan and a few injured at Kotkapura in Faridkot in police firing. While the Yadav-led SIT is probing the Kotkapura firing case, another SIT led by Additional Director General of Police Naunihal Singh is investigating the Behbal Kalan firing incident.

According to officials. a highly loaded vehicle caused a 50-year-old steel bridge to collapse, stopping traffic in the region. Late on Monday night, the bridge collapsed. According to them, the truck's driver was hurt and is receiving medical attention at the local hospital.

The bridge, which spans the Dadahu-Renuka-Sangrah-Haripurdhar road at Danoi Khud, 6 kilometres from Dadahu village in this part of Sirmaur district, was constructed in 1972 and has a per-vehicle load capacity of 10 tonnes. The locals claimed that the bridge had eroded over the previous 30 years due to the

fact that trucks frequently utilised it to transport up to 40 tonnes of limestone from the mines in Sangrah.

Sangrah Deputy Superintendent of Police (DSP) Mukesh Dadwal said the traffic to and from Sangrah-Haripurdhar and Dadahu-Renuka has been diverted since Monday night. Commuters have been advised to commute on Jarag-Khud Dravil road.

Ram Bhaj, a local resident of Renuka Ji, said Sangrah is only 25 km away, but due to the current diversion through the Jarag-Khud Dravil road, commuters will now have to cover around 60 km. The affected road is especially busy during the summer as a large number of tourists visit Haripurdhar from April to June.


14,000 MSME TO GENERATE 3.5 LAKH JOBS: HARYANA CM

Candidates who have registered with the Kaushal Rozgar Nigam Limited (HKRNL) portal will get jobs in the private sector, Haryana Chief Minister Manohar Lal Khattar said on Tuesday.

"About 8 lakh youth in the state are registered on the HKRNL portal. The private sector can meet its manpower requirements through this portal," Khattar said. Addressing the 'Corporate Vaartha' programme, he said that the government will help set up 14,000 MSME units to generate 3.5 lakh job opportunities under the Programme to Accelerate Development for MSME Advancement (PADMA)

HKRNL CEO Makarand Pandurang said that 373 PhD holders, 45,342 postgraduates, and 1,33,480 graduates, among others, are registered with the HKRNL. Interacting with the corporate representatives at the event, the chief minister said that a database of families has been prepared on the basis of income in Haryana through Parivar Pehchan Patra (PPP).

In this database, there are 13 lakh families whose income is less than Rs 1 lakh per year and 29 lakh families whose income is less than Rs 1.80 lakh. It is the priority of the government to provide self-employment and government and private sector employment to these families, he said. He also said that the unique programme of PPP in Haryana is being appreciated across the country, and many

states are also following it.

Parliament has power; how far can courts go into it, asks SC

and PS Narasimha, said. Observing that there is no denying that there is a link between the 1954 Act and the personal laws of various religions, the bench said, "Therefore, you cannot confine to the Special Marriage Act and it has to go beyond it.'

On the fourth day of the hearing, senior advocate Saurabh Kirpal, who appeared in the court on behalf of the petitioners, vehemently pleaded for legal validation of same-sex marriage, saying seven per cent of the country's GDP will be affected if the LGBTQIA++ (lesbian, gay, bisexual, transgender, queer, questioning, intersex, pansexual, two-spirit, asexual and ally) are denied this fundamental right.

He said gay and lesbian people are also like heterosexuals and if their marriage is not registered here, they will leave for another country for better rights, and contended that it will be a "gay brain-drain".

The bench referred to section 21A of the Special Marriage Act, which provides certain reliefs to Hindus, Buddhists, Sikhs or Jains in property and other related issues if they solemnise their marriages under the law, and said it is very specific and if the court has to make some provisions of reading it, it has to be consistent with other provisions.

The bench told senior advocate Menaka Guruswamy, who represented the petitioners, that suppose the top court substitutes the terms man and woman with "spouse" or "person" in section 4 of the Act, which deals with conditions relating to solemnisation of special marriages, the question will be can it "stop at that today".

"Dr Guruswamy, the point really is that the fact that the canvas which is covered by these petitions also falls or does fall within the domain of Parliament is undisputed," the CJI said, adding, "You cannot dispute the fact that Parliament has the legislative power over the canvas which is covered by these petitions, which is Entry 5 of the concurrent list," the bench said. Guruswamy contended that the Centre cannot come to the court and argue that this a matter for Parliament as when the fundamental rights of an individual are violated, he or she has the right to approach the court.

Referring to the 1997 Vishaka verdict that laid down the guidelines to handle cases of sexual harassment at workplace, the CJI said it was a classic example where the court laid down the framework pending the legislature coming up with a law in this regard. "The test really is this--how far does the court go," the bench said.

Referring to the submissions advanced by the petitioners, it said there is no doubt that adoption, succession and

intestacy are matters governed by personal laws even today. "My lords have been that north star, not just for LGBTQ rights, my lords have been the north star in many facets of fundamental rights pre the legislature walking the talk," Guruswamy said.

She said the petitioners are not asking for anything special and are only asking for a workable interpretation of the Special Marriage Act. "We are also part of 'we the people' and we are citizens of this country. The basic structure (of the Constitution) also belongs to us," Guruswamy said.

The bench said the petitioners are right in asserting that marriage itself is a bouquet of rights and though they have identified three aspects -- gratuity, provident fund and pension -- "actually, it does not stop at that at all".

Chinese defence minister to hold talks with Rajnath Singh

Considered a close associate of Chinese President Xi Jinping, Gen. Li's India visit is regarded significant as it comes amid the vexed standoff between the armies of India and China in eastern Ladakh since May 2020.

"Upon invitation, Chinese State Councillor and Defence Minister General Li Shangfu will attend the meeting of the Council of Defense Ministers of the Member States of the Shanghai Cooperation Organization (SCO) in New Delhi, India, from April 27-28," China's Ministry of National Defence (MND) said in a statement.

"During the meeting, General Li will address the conference and meet with the heads of delegations from relevant countries to communicate and exchange views on the issues of the international and regional situation, as well as defence and security cooperation", the statement said.

Gen Li is widely expected to hold a bilateral meeting with Defence Minister Singh and discuss the progress of the military and diplomatic talks to resolve the festering standoff.

Ahead of Gen Li's visit, the Chinese defence ministry spoke positively about the 18th round of the China-India Corps Commander Level Meeting held at the Chushul-Moldo border meeting point on the Chinese side on 23 April. It said both sides have agreed to "speed up" the settlement of "relevant issues" related to the prolonged standoff in eastern Ladakh, besides safeguarding peace in the border areas. The two sides had a friendly and candid exchange of views on relevant issues, said the Defence Ministry's statement.

"Under the guidance of the leaders of the two countries and based on the achievements of the meeting between the two foreign ministers, both sides agreed to maintain close contact and dialogue through military and diplomatic channels, speed up the settlement of relevant issues on the western section of the China-India boundary, and continue to safeguard the peace and tranquillity in the border areas," it

SCO defence ministers to discuss ways to combat terrorism

The visit by Li to India would come amid the three-year border standoff in eastern Ladakh, and days after India and China held a fresh round of military talks. The SCO meeting will be chaired by Singh. "The defence ministers will discuss amongst other issues concerning regional peace and security, counter terrorism efforts within SCO and an effective multilateralism," the ministry said.

It said India attaches special importance to SCO in promoting multilateral, political, security, economic and people-to-people interactions in the region.

"The SCO pursues its policy based on the principles of sovereignty and territorial integrity of nations, non-interference in internal affairs, equality of all member states and mutual understanding and respect for opinions of each of them," it added.

The ministry said the ongoing engagement with SCO has helped India promote its relations with the countries in the region with which New Delhi shared civilisational linkages, and is considered its extended neighbourhood.

The SCO member countries are Kazakhstan, China, Kyrgyzstan, India, Pakistan, Russia, Tajikistan and Uzbekistan. Apart from the member states, two observer countries --Belarus and Iran -- will also be participating in the SCO defence ministers' meeting.

People familiar with the matter said the Pakistani defence minister may attend the meeting through video conferencing. The SCO was founded at a summit in Shanghai in 2001 by the presidents of Russia, China, the Kyrgyz Republic, Kazakhstan, Tajikistan and Uzbekistan.

Over the years, it has emerged as one of the largest transregional international organisations. India and Pakistan became its permanent members in 2017.

FORCED TO RUN FROM PILLAR TO POST FOR JUSTICE

NEW DELHI: In a petition filed by wrestlers in the Supreme Court said that they are being forced to run from pillar to post to get justice.

"The attitude of the police was shockingly rude towards the complainants and this is a grave injustice and a clear violation of their basic human rights", stated the wres-

The petition further stated that the police has taken the complaints and did not even issue a formal receipt of the complaint. "As per print media, it is in circulation that the accused in fact has been given clean-chit in the matter and the committee report is lying at the Ministry of Sports and despite requests the report is not being made public", the wrestlers further stated in the petition.

The wrestlers also added that even after being sexually, emotionally, mentally, and physically exploited by the accused and his close aides on numerous occasions, the Petitioners along with other wrestlers mustered up the courage to raise their voices before the appropriate authority against such acts and sat on protest (dharna) at Jantar Mantar seeking appropriate action against the perpetrators.

Rahul moves Gujarat HC in defamation case

Congress advocate BM Mangukia confirmed Gandhi has filed an appeal in the HC here against the sessions court order. The HC is expected to soon take up Gandhi's application for hearing.

A metropolitan magistrate's court in Surat on 23 March sentenced the former Congress president to two years in jail after convicting him under Indian Penal Code sections 499 and 500 (dealing with criminal defamation) in the 2019 case filed by Gujarat BJP MLA Purnesh Modi.

The case was registered against Gandhi following the BIP MLA's complaint over his remark, "How come all thieves have Modi as the common surname?" made during an election rally at Kolar in Karnataka on 13 April 2019.

Soon after the magistrate's court verdict, the 52-year-old politician, elected to the Lok Sabha from Wayanad in Kerala in 2019, was disqualified as a Member of Parliament under provisions of the Representation of the People Act.

Later, Gandhi, a four-time MP, filed an appeal before the Surat sessions court against the magistrate's verdict, saying his conviction was "erroneous and patently perverse". A stay on conviction by the sessions court could have

paved the way for Gandhi's reinstatement as an MP. Arguing against Gandhi's plea for a stay on conviction in the sessions court, Purnesh Modi's lawyers had said his client felt offended because the Congress leader tried to de-

fame all people with the Modi surname through his remark.

Violent protesters torch police station in Bengal

On Tuesday, hundreds of people, belonging to the Adivasi and Rajbongshi communities, had organised a "thana gherao" programme in protest. Protesters broke barricades and threw stones at the police station, an officer said. Later, the police personnel started a baton charge, fired rubber bullets and burst teargas shells but could not stop the mob from entering the police station and setting it on fire, he said. In the incident, one vehicle was also set ablaze.

Though the state administration sent in policemen from neighbouring police stations and deployed Rapid Action Force personnel in full riot gear, it failed to disperse the

Agitators refused to believe in the post-mortem report which said that the girl had consumed poison and died and that there were no marks of violence on the body.

Another group of protesters had demonstrated in front of the SP's office at Raiganj, the district headquarters, during the day. The protestors broke through two barricades but were stopped 200 metres from the SP's office by the third barricade and the heavy police bandobast.

The entire district has been on the boil following the death of the 17-year-old girl. While the police and the Trinamool Congress had said that the girl had consumed poison even before the post-mortem was completed, the girl's family had maintained that she was raped and murdered and had demanded a CBI probe.

On Monday, the National Commission for the Protection of Child Rights (NCPCR) chairperson Priyank Kanoongo had said that the team of the National Commission for Protection of Child Rights (NCPCR), which visited the Kaliaganj area where violent protests broke out after the girl's body was found in a canal on Friday, had to face "all sorts of non-cooperation" from the State administration. He had promised to send a report to Union Home Minister Amit Shah. Earlier on Monday, the state administration suspended four ASIs who were seen dragging away the corpse.

BJP leaders slammed the Bengal Police for "insensitively dragging" the body of the young girl. "In this video, the body the West Bengal Police is insensitively dragging is that of a minor rape and murder victim from the Rajbongshi community in Uttar Dinajpur's Kaliaganj. Such haste is often seen when the purpose is to eliminate or dilute evidence and cover up the crime," BJP leader Amit Malviya had tweeted.

On 18 April, the top court had deferred till April 25 hearing on a batch of pleas challenging scrapping of the four per cent Muslim quota in Karnataka after the state government sought time to file its reply. It had recorded the assurance given by the state government on April 13 that no quota benefits in admission to educational institutions and appointment in government jobs will be given to Vokkaligas and Lingayats will hold the field till the next date

On April 13, the Karnataka government's decision to scrap four per cent Muslim quota ahead of the assembly polls came under the scanner of the Supreme Court, which questioned the government order and said prima facie it appeared to be on a "highly shaky ground" and "flawed".

Taking note of the observations, the Karnataka government had assured the top court that it will put on hold its March 24 order by which it had given quotas in admission to educational institutions and appointment in government jobs to Vokkaligas and Lingayats, till the next date of hearing. The four per cent reservation for Muslims was to be equally split between the two communities.

The top court said from the records tabled before it appears that the Karnataka government's decision is based on "absolutely fallacious assumption".

Pro-Khalistanis' outreach bar foreign governments from taking action

media is witnessing massive increase in pro-Khalistani content and a surge in disinformation warfare targeting India. This event has coincided with the emergence of Khalistani entity Amrit Pal Singh back home.

All these contents have a common theme; of India violently suppressing individuals and groups that are demanding a separate Khalistan.

Officials have identified multiple Youtube 'journalists', Twitter users, who are associated with local organizations that are churning out content in support of Khalistani

Some of these 'media' groups and 'journalists', investigation has revealed, were infact present at the Indian High Commission building in London last month when it was attacked by Khalistani groups. The National Investigation Agency (NIA) is investigating this attack.

Sources told the Daily Guardian a radical group, "Sikh Youth UK', based out of Birmingham, is at the forefront of anti-India activities in the UK. In September 2019, the founder of this group, Kaldip Singh Lehal and his sister Rajbinder Kaur were charged by the counter-terror police for money laundering worth £50,000 in the name Sikh charitable donations. Charges were also slapped on the founders for providing false or misleading information to the Charity Commission for England and Wales since it is not a registered entity

Another entity that has been found to be an active member of this Khalistani group is Amneet Kaur Saini, who is working as a 'writer' for a Birmingham based news website that covers local news. Kaur had participated in the protest cum vandalism that was organized outside the Indian High Commission in London. The protests were organized to oppose the Punjab Police attempt to arrest the pro-Khalistani hardliner Amritpal Singh. During the protests, pro-Khalistani groups tried to vandalize the Indian flag at the Indian High Commission.

She also has been a vocal supporter of the release of Jagtar Singh Johal aka Jaggi Johal, who was arrested by Punjab Police on 4 November 2017 for murdering a former Indian army Brigadier (retd) Jagdish Gagneja. Johal was arrested on the basis of intelligence inputs that were provided by the British MI5 and MI6 to the Indian agencies. It is alleged that he is a vital member of the pro-Khalistani terror organization Khalistan Liberation Force (KLF).

Saini did not respond to this newspaper's mail seeking her version on the matter.

It has emerged that these protests saw the participation of members of various pro-Khalistani groups, such as Sikh Youth UK, Federation of Sikh Youths, and Sikh Youth Jathebandia. Similarly, overseas agencies had identified multiple YouTube entities like @SatlujTV which has now been shut down. These channels were propagating Khalistan sentiments

Significantly, these Khalistani groups, have arranged a public letter that has been purportedly signed by members of 350 plus UK based Sikh Organizations in which they have asked Rishi Sunak 'to stop calling them as terrorists'. However, inquiry has revealed that many of the people and organizations never signed this letter. The said letter and its content were devised by the officials of Pakistan

intelligence agencies in order to to tie the Khalistani cause to Sikh sentiments and stop Sunak administration from taking steps to control the Khalistani terror groups.

Cheetah needs more space in other parks beyond Kuno

In India, the size of national parks and sanctuaries is small as compared to those in Africa. There are parks which are as big as 15,000 sq kms to 20,000 sq kms where iconic species like cheetahs, lion elephants, giraffes coexist. Not only this, many of these parks are fenced.

eath of another cheetah in Kuno national park seems to have opened up Pandora's Box. This is the second death of a cheetah. Interestingly, both the cats died even before they could be released in the open forest. There is another issue that has been baffling the team of the government officials and those from Cheetah Conservation fund (CCF). After the male cheetah Oban, now rechristened as Pawan. continued to move out of the 748 sq km jungles of Kuno, he was captured and put behind an enclosure. During its adventures beyond the Kuno boundaries, it was tranquilised twice before being jailed in a boma. Amidst all this, there are reports of the forest department of Madhya Pradesh writing to the Centre to look for the second home for cheetah, an issue already mentioned in the Cheetah action plan. In fact, Mukundura hills national park in Rajastregard.

hensions over the carrying capacity of Kuno. They have also criticised the project for its "unscientific approach". In India, the size of national parks and sanctuaries is small as compared to those in Africa. There are parks which are as big as 15,000 sq kms to 20,000 sq kms where iconic species like cheetahs, lion elephants, giraffes coexist. Not only this, many of these parks are fenced. The issue is debated as the project cheetah proponents defended the decision to introduce the cat in the smaller parks like Kuno which, like other national parks of India, is unfenced and spread barely across 748 sq km area in Sheopur district of Madhya Pradesh adjoining Sawai Madhopur district of Rajasthan where famous Ranthambore tiger reserve is located. India plans to release 21 cats in Kuno when experts believe it cannot carry even 10. They said one cheetah needs 100 sqkm area, a point vehemently contested by the project proponents in India and also those from South Africa and Namibia.

In the first lot of Cheetahs that were brought from South Africa, there were 8 cats. Four were released in

the open forest, one of them, Oban or Pawan, was brought back after it continued to move out. One female, Sasha, died on March 26. Three females are still in enclosures. After the latest cheetah casualty, there are 11 left from the lot brought from South Africa in February this year. It means there are 14 cheetahs remaining to be released in the open forest of Kuno, an issue staring at the officials of the cheetah project. After Sasha's death because of kidney failure, the South African cheetah believed to have died because of stress caused by prolonged confinement. The 12 South African cheetahs were captured 9 months ago. There was a delay in the sighing of MoU, leading to continued confinement in enclosures. If Uday, the cheetah that died on April 23, was under stress, so could be the remaining 11. South African experts involved in the translocation recommend their release in the wild.

Imagine the plight of the field workers. Both Indian and those from Namibia track the cheetahs in the jungle. They chased Oban or Pawan beyond the boundaries of Kuno when the cat had reached the adjoining districts. Carrying equipment to track the animal, a team of 9 to 10 people had a tough time. If 14 more are released, it would require about 140 more people to track the animals 24X7. They should also be equipped with drones, vehicles, wireless sets among other things. Also imagine the noise created by the drones and the movement of so many people inside the jungle while tracking the

animals.

quired to make a decision over the second home for the cheetah. Besides, about 4,000 sq kms area around Kuno bordering Rajasthan and Uttar Pradesh needs to be developed as a cheetah landscape.

And for doing this, the

government needs to show a political will as this would require certain restrictions for the conservation of the iconic species. The cheetah action plan also said that more cheetah populations are required to be developed. The idea was to develop 3 to 5 separate cheetah populations. As per the Cheetah Action Plan-Kuno by itself is not viable for the long-term as the site is not big enough to have viable population and for that you need at least 3 populations and then move cheetahs between them as a managed meta- population; that is the vision of the cheetah project. Gandhisagar Wildlife Sanctuary spread over in Mandsaur in Madhya Pradesh and Chittorgarh in Rajasthan and Nauradehi in Damoh and Sagar districts of Madhya Pradesh were also selected as the second home but it would not only take time but huge sums around $Rs\,300\,crore\,to\,Rs\,400\,crore$ to develop each of them. This would include the development of grasslands, prey base and shifting of villages.

But the best possible available and ready site for cheetahs is Mukundura. With grass lands in between, this mountainous jungle has a variety of trees and animals. In fact, cheetahs were to be brought first to Mukundura but zeroed in on Kuno.

A cheetah does not understand the administrative boundaries of a forest and follows its instinct. For the animal, its safety and prey are paramount. Before the translocation, cheetah's movement outside the park was also expected. As the cheetah action plan also expects a high mortality rate, then why is there so much fuss over the death. It is happening because the cheetahs are dying before their release in the wild. Prolonged captivity of the animal is believed to be the reason and the progress for a second home is very slow.

Keeping all the cheetahs in Kuno will be like putting all the eggs in one basket. The government officials, who looked as stressed as cheetahs, needed to make a quick decision.

NOT A POLITICAL CAKEWALK

CAN NITISH UNITE THE OPPOSITION?

The Bihar Chief Minister has been very busy during the last few days, travelling to Lucknow, Delhi and Kolkata meeting various Opposition leaders. Nitish Kumar has realised that in order to give the BJP some sort of a credible fight in the 2024 elections, the Opposition needs to get its act together. However, there are cracks within. The Telangana Chief Minister K Chandrasekhar Rao has been busy trying to prop up a Non Congress-Non BJP front. In this, he is aided and abetted by Mamata Banerjee, Arvind Kejriwal and Akhilesh Yadav who see the Congress as much of a threat as the BJP at the state level. But, the canvas is larger than a string of assembly elections and regional aspirations have to be docked for any sort of a coalition to take place at the Central level. More to the point, no Opposition alliance is possible without the Congress as it is the only pan-Indian party in the Opposition.

Hence, Nitish Kumar has taken this initiative to reach out to all the Opposition parties. It is interesting that his tour de unity began with the Congress where he met Rahul Gandhi and Mallikarjun Kharge. After that he called on Mamata Banerjee and Akhilesh Yadav (but not Mayawati - as one is not quite sure which boat she will finally board). At the press conference in Lucknow, the Bihar Chief Minister made it amply clear that he is not harbouring any ambitions to be the Prime Minister.

Earlier, Kharge too had stated that the Congress was not keen on portraying any PM face. Hence, the Opposition is united on strategy - that the fight against Modi would not be individual-based but would be issue-based. They have realised (wisely) that given the PM's credibility, it would be futile to wage a war against the cult of Modi. Better to take on the BJP on the government's performance - or lack of it.

Interestingly, the Opposition also seems to have zeroed in on the one issue it thinks can work - which is politics of caste. Pitching Mandal against Mandir has been done before and admittedly these are the two planks on which most elections are fought in India. Hence, Nitish has been championing the cause of the caste census and now even Rahul Gandhi and Akhilesh Yadav have picked this issue.

As a footnote, it would be important to note that Nitish Kumar is accompanied by his deputy Tejashwi Yadav during these coalition building courtesy calls. Tejashwi is Lalu Yadav's heir apparent and one who has carved a niche for himself as a caste warrior and champion of the backwards. Also, the BIP has long been harping on the differences between Tejashwi and Nitish and hinting that Nitish would soon return to the BJP fold. Well the duo putting up a united appearance will nail that rumour as well. So, there has been a flurry of activity within the Opposition camp with Nitish Kumar taking the lead. As he himself admitted, he is no JP (the socialist leader Jayprakash Narayan who led the Opposition movement against then Prime Minister Indira Gandhi in the 70s)., but he is definitely offering himself as a sort of sutradhar to string the Opposition together. Not unlike the role played by Harkishen Singh Surject in UPA 1.

Input tax credit: Burden of proof is a burden to prove

Ever since the debates on introduction of GST started, it has always been boasted as a tax which would eliminate the cascading effect of multileveled taxes levied by executive. The idea was to get away with 'tax on tax' through a mechanism which would allow 'seamless flow of credit across goods and services'. It, however, has not been as merrier as was portrayed.

Beginning with the written law, coupled with injudicious interpretations by law implementing authorities, road to avail 'input tax credit' (ITC) has been arduous. Law enforcing agencies have pressed upon the end consumer or beneficiary of a supply transaction to check infiltration in the supply chain, despite of him having all parameters verified in accordance with the statue. In support of their claims, agencies harp upon the provisions of law which casts the burden of proof on the recipient of supply with respect to eligibility of ITC. Resultantly, rigorous documentation synced through online portal appears to be insufficient to avail ITC, which otherwise is unified

to the business transactions of a recipient of supply.

Recently, Supreme Court while dealing with a Karnataka VAT matter1, was faced with this legal issue as on whom the burden to prove eligibility of ITC would lie, if a purchasing dealer had tax paid invoices and acknowledgments of payments from the selling dealer. Challenging the order of the High Court, State argued before Supreme Court that the agencies cannot recover tax arrears from a seller who is not registered or has not furnished tax returns. Merely by making payments through banking modes, purchasing dealer cannot be relieved of its responsibility in law, as seller has not deposited that tax to the revenue exchequer. Supreme Court, referring to the provisions of Karnataka VAT Act regarding burden of proof for availing ITC, categorically held that mere production of invoices or payment receipts would not serve the requirements of statute listed for discharg-

ing burden of proof for

availing ITC by a purchasing dealer. The purchasing dealer, claiming ITC, must prove beyond doubt the actual transaction, which can be done by furnishing the name and address of the selling dealer, details of the vehicle which delivered goods, payment of freight charges, acknowledgment of taking delivery of goods to establish actual movement of goods, in addition to tax invoices and particulars of payment. While dealing with this issue, Supreme Court weighted the concept of burden of proof over the principle of 'lex non Cogit Ad impossibilia' i.e. law does not compel a person to do impossible

The ruling of the Supreme Court certainly emphasises upon the need to prove the transaction by the recipient of supply, which would be squarely applicable to GST in view of the similar provisions in the statute. Investigations in GST on account of fake invoicing would certainly be fuelled backing on the ratio of Supreme Court ruling. Concomitantly, there

GST law is predominantly implemented through the online portal wherein there is an automated mechanism to reconcile inward purchases of a recipient with outward supplies of its supplier. Details of the parties to a transaction are readily available and verifiable. To go with this, various checks are in place to ensure deposit of tax collected by a person on its outward supplies, non-adherence to which would result in adverse consequences. GST law further has unique concept of 'e-way bills' where prior to any movement of goods from a location of supplier to its recipient is captured and shared on real time basis. These parameters appear to be in sync with Supreme Court ruling. The recipient of supply of goods would be in a reasonably finer position to establish the transaction of supply and discharge its burden of proof, had these parameters are complied

lenge would rise for the recipient of supply of services as part from tax invoice and payment details to the supplier, a recipient would not have any tangible source to establish the inward supply of services given its very intangible nature. In such a scenario, supporting documentation would be of higher importance ranging from underlying service agreement, communication trail with supplier of services along with tangible deliverables. Corroborative evidence would be the ultimate recourse in the event of default of by supplier. It would, State of Karnataka v. Ecom Gill Coffee Trading Pvt. Ltd. Civil Appeal No. 230/2023, however, still be tried against the confession statements of non-compliant supplier or an unavailable supplier.

At the same time, law enforcing agencies too must take judicious approach. The law has always worked on the principle of 'ei incumbit probatio qui dicit, non qui negat' i.e. the bur-

A recipient of supply of either goods or services or both, if had complied with given conditions of statue and has confirming documentation, as mandated by rules, must not be framed on basis of statements of a supplier or nonavailability of supplier at the stage of investigation. Clarifications issued by CBIC do not call for recovery of tax dues from a person where his active role in an alleged fake invoicing transaction is not established by documentary evidence. It, would, however, be interesting to see as to how the law enforcing agencies interpret and use Supreme Court ruling in Karnataka VAT issue, especially while dealing with recipient of supply of services. On the whole, ITC availment in GST is an uphill battle taking GST far away from being a 'good and simple tax'.

SUPREME COURT: NOTICE ISSUED ON WOMEN WRESTLERS' PLEA **ALLEGING SEXUAL HARASSMENT** BY WFI PRESIDENT



Uttarakhand High Court: Offences Affecting 'Secular Fabric' Of Country Cannot Be Compounded | Sec. 295A IPC

The Uttarakhand High Court in the case Brajesh v. State of Uttarakhand observed and has held that the offences which outrage the religious sentiments of communities and have the tendency to affect 'secular fabric' of the country. the same cannot be compounded.

The Single judge bench headed by Justice Sharad Kumar Sharma in the case observed and has rejected to compound an offence as it is stated under Section 295A of the Indian Penal Code, 1860. In the present case, the complaint was

being registered against the petitioner, wherein he claims to be the Deputy District Secretary of Rashtriya Hindu Vahini, Udham Singh Nagar and he being the accused of using derogatory words for another religion and he has also posted the same on his WhatsApp

status. Thus, the petitioner in the case approach the High Court in order to quash the case which is pending on the ground of amicable settlement.

It has also been observed by the court that before using of the inherent power as stated under Section 482 of the Code of Criminal Procedure, 1973, the same must be conscious as to whether the said offence has the wide social impact. The court in the case also noted that the offences punishable as stated under Section 295A of the Indian Penal Code, 1860 and has the tendency to affect the 'secular fabric' of the country and therefore, the same cannot be compounded as stated under section 320 of Code of Criminal Procedure.

The court opined while stressing on the words deliberate and malicious as stated under section 295A of Indian Penal Code, 1860.

The court stated that Deliberate means.

it being the conscious act, being made by the person which belongs to a particular community to outrage the respect, which is enjoyed by other religion in this country.

Further, the court observed that if it being a citizen under Article 5 of the Constitution of India and if the person does not carry respect for other religion, the same may lead to a certain catastrophic situation which at time becomes uncontrollable by the administration and are particularly being so called constructed religious groups of the said country.

Accordingly, the court rejected for quashing the pending complaint by compounding the case.

The counsel, Advocate Mr. Harshpal Sekhon appeared for the petitioner.

CHHATTISGARH HIGH COURT: DIRECTED CHIEF SECRETARY FOR FILING OF PERSONAL **AFFIDAVIT TO EXPLAIN THE INACTION; IDENTIFYING FAKE DISABILITY CERTIFICATES**

The Chhattisgarh High Court in the case Chhattisgarh Divyang Seva Sangh v. State of Chhattisgarh And Ors observed and has ordered the Chief Secretary of the State Government for filing the personal affidavit wherein it is showed as to why no steps are to be taken in order to verify the physical disability certificates as per the circular issued in the year 2019 by him.

In the present case, the petitioner had earlier filed a Public Interest Litigation, PIL and has approached the High Court in the year 2018 wherein the petitioner highlighted the frequent misuse of the 'disability certificates and the rights which is being issued under the Rights of Persons with Disabilities Act, 2016.

The court in the case observed and has directed the Chief Secretary of the State to issue appropriate directions to the concerned authorities for ensuring that no person other than a physically disabled person who is being allowed to avail the benefits as it is being provided under the Rights of Persons with Disabilities Act, 2016. Thus, the court disposed of the plea filed in the case.

It has also been noted by the court that the directions

Agrawal in its order stated that the Chief Secretary, Government of Chhattisgarh is directed for filing his personal affidavit as to why no positive steps are being taken in order to verify the physical disability certificates as per circular issued by him in the month of May, 2019.

Accordingly, the court listed the matter to be next heard after two weeks.

DELHI HIGH COURT: GOOGLE MOVED CHALLENGING THE ORDER OF SINGLE JUDGE DIRECTING CCI TO CONSIDER APPLICATION OF START-UPS AGAINST NEW PAYMENT POLICY

he Delhi Hight Court in the case observed, wherein the Google moved while challenging an order of the single judge directing the Competition Commission of India in order to take up the applications moved by an alliance of start-ups against tech giant's new in-app user choice billing policy and the same needs to be considered on or before April 26, 2023.

The division bench comprising of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad was hearing the present matter.

In the present case, the appeal has been moved against the order of Justice Tushar Rao Gedela,

wherein he disposed of the plea moved by Alliance of Digital India Foundation, against Google's new policy. Thus, the petitioner in the plea also seek direction on the tech giant in order to keep the same in abeyance till the issue is being adjudicated by Competition Commission of India.

The bench of Justice Tushar Rao Gedela stated that there being no impediment, legal or otherwise, in directing the CCI in order to take up the application as stated under section 42 of Competition Act as filed by the petitioner for hearing and in order to consider the same in accordance with law on or before 26.04.2023. thus, it has also been made clear by Justice Gedela that the observations made herein are only for the purpose of deciding the present list made before the said court and shall not tantamount

to any expression which being on the merits of the case and the same is therefore, which being without prejudice to the rights and contentions of all parties to be taken at the appropriate proceeding.

It has also been observed by the single judge that $the \,proceedings \,which \,are$ being initiated before the **Competition Commission** of India would not be vitiated due to vacancy or due to any defect in its constitution. Adding to it, the court stated that merely because of the defect or due to ant vacancy in the constitution of the CCI, the CCI cannot be considered as a statutory authority for not having jurisdiction to adjudicate the complaints or the other proceedings which are pending before the court.

Pulled Up Civic Body Chairman For Issuing Demolition Notice To Sessions Judge: Calcutta High Court

The Calcutta High Court in the case observed and has pulled up the Chairman of English Bazar Municipality of Malda District (the Municipality) for issuing the notice of the District and Sessions Judge, Malda for the demolition of a building which is being constructed withing the premises of the court.

The division bench comprising of Acting Chief Justice ACJ T. S. Sivagnanam and Justice Hiranmay Bhattacharyya in the case observed and has informed the Advocate General S. N. Mookherjee that it would pass of the appropriate orders if in the case, the said notice is not being withdrawn off.

It has also been asked by the ACJ to AG that something unusual and surprising has been happened. The same being unheard of. How can the demolition notice be issued by civic body to a session judge.

Further, the ACJ stated that the most unfortunate part being that the chairperson



is an advocate, who used to practice in that court. Thus, even the family members of him use to practise there and being a lawyer is not that he is aware that under the Government Buildings Act, these municipal laws would not apply. Yet, the lawyer has audacity to issue notice.

The court in the case observed and has also noted that it can embarrass the said municipality by asking the report of the illegal constructions which being within the municipality.

HOW TO CHECK STORM OF RUMOURS?

Serious questions have resurfaced after a fake video of Aaradhya went viral on social media!

hen I sat down to write my column this week, these few lines sprang into my head and began making noise. I began to ponder what type of nasty mentality the individual must have had who posted the fake news on social media about Abhishek and Aishwarya Rai Bachchan's daughter Aaradhya's illness and even death. The wicked mind posted the video and people unknowingly spread it? We are a culture that gives and receives blessings; how can we ever contemplate death for someone? Unfortunately, the presence of such warped minds on social media is on the rise.

This is not the first incident involving the Bachchan family. They approached court, but there are several similar stories. Such crimes continue to be committed against those who participate in social activities. What exactly is movie gossip? The same thing happens with the politicians. It's entertaining to target and embarrass others. It's a kind of disease.

The perpetrators don't think about its impact on others, or how it impacts their family?

In the case of Aaradhya, the Delhi High Court has ordered delisting and deactivation of all such videos from Google and YouTube, and prohibited the uploading of any video that violates Aaradhya's privacy. The court has also sought specific information about those who posted fake footage about Aaradhya. It is as simple as clicking a button to collect this information for Google and YouTube. Let us hope this

information will reach the court and the perpetrators would be punished. The court has also observed that it is the responsibility of Google and YouTube not to allow such videos to be uploaded! The question that arises here is what kind of attitude these platforms are displaying. The Indian courts warned not once but several times, and the government also tried to rein them in but these social media platforms have been continuously trying to find an escape route. I don't understand why? Do they ex-

ert so much influence that

they can do whatever they want and the law should not take its course against them?

Keep in mind that all these platforms began as means of interaction but were cleverly renamed social media. Do they have anything which can be termed media? The term "media" refers to a forum for analysing news and issues. There is a provision in the newspapers, TV stations and even websites to investigate the news and ensure its authenticity. The journalists working on these platforms ensure that nothing inappropriate is published, but there is no such safeguard on social media! You can publish or upload anything on Google, YouTube, Twitter, Instagram or Facebook. It makes no difference to them what you upload. After all, there must be some checks and balances somewhere. Actually, people create hullabaloo when the government considers action. However, they do not

I believe that the Internet is a rich source of knowledge that has altered our perception of the world, but we must also pay attention to what is presented in front of the people and what they are watching. Everything has a positive and negative

side. We must strike a balance. The decent people on the social platform are also bearing the brunt of other people's faults.

Recently, videos showing migrant workers from Bihar being beaten up and chased away in Tamil Nadu, suddenly started appearing on social media. People in Bihar were outraged, and the administration in Tamil Nadu was perplexed as to why the government machinery had not received information about such an incident. After a quick investigation, it was discovered that this

fake video was created by Manish Kashyap, a You-Tuber from Bihar. In Tamil Nadu, no such incident had occurred. Many of the videos were from outside of Tamil Nadu and rather old. Manish showed a video of labourers returning home on Holi as an escape. People naturally trusted him at first. This reminds me of a 'sher' of Wasim Barelvi:

Woh jhooth bol raha tha bade salike se,

Main aitbaar na karta to aur kya karta?

Manish is presently in judicial custody, but the question is the same again: Why did YouTube allow such videos to be uploaded without verification? In fact, there is no provision for any such control. You may be startled to learn that Twitter has dissolved its own Trust and Safety Council. There is no available information about what arrangements were made after that. The UN spokesperson Stéphane Dujarric has even stated that an environment that spread hatred is fostered by social media sites. At least in India, we are witnessing this and dealing with the consequences. It is impacting our social fabric. Shariq Kaifi has rightly penned these lines: Jhooth par uske bharosa kar

liya, Dhoop itni thi ki saayaa kar liya!

So it's time to be cautious. It's natural to get confused when so many things are served to you so quickly. Apply your mind... or else this storm of rumours will hurt you too!

A POWERFUL SOLAR **STORM PRODUCES** STUNNING AURORAS

An intense solar storm has the northern lights gracing the skies farther south than usual. A blast of superhot material from the sun late last week hurled scorching gases known as plasma toward Earth at nearly 2 million mph (3 million kph), the National Oceanic and Atmospheric Administration said Monday.

Earth felt the brunt of the storm Sunday, according to NOAA, with forecasters warning operators of power plants and spacecraft of the potential for disruption. Auroras were reported across parts of Europe and Asia. In the U.S., skygazers took in the sights from Wisconsin, Washington state, Colorado, California, New Mexico and even Arizona — mostly a reddish glow instead of the typical green shimmer.

"I don't want any expectations of these green curtains moving back and forth" so far south, said Bill Murtagh, program coordinator at the NOAA Space Weather Prediction Center in Boulder, Colorado.

Although conditions have eased, auroras might still be visible as far south as South Dakota and Iowa late Monday and early Tuesday if skies are dark. The farther north, the better the show as the energized particles interact with the atmosphere closer to Earth, according to Murtagh.

China faces social instability as unemployment rises sharply

China is heading towards social instability as unemployment rises to a historical level, reported Geo-politik.

The youth unemployment rate is approaching historical highs, coupled with various challenges such as debt risks and slowing global growth, indicating that China's economic outlook is still uncertain after the devastating effects of the zero-Covid policy. Apart from an uneven recovery, persistent youth unemployment is a concern, especially as a record 11.58 million students have graduated from universities and colleges this year, reported Geo-politik.

A strong undersea earthquake early Tuesday sent streams of people fleeing to higher ground in eastern Indonesia before the tsunami danger passed.

Footage released by the National Disaster Mitigation Agency showed streams of people in a village on Mentawai Island fled to the highlands by foot and motorcycles under the rain in darkness, while some patients at the village's hospital were evacuated to its yard as cracks showed in the facility's floor.

The shocks were felt in districts and cities of West Sumatra and North Sumatra provinces, and some places ordered evacuations to higher ground.Residents in parts of West Sumatra province, including the provincial capital of Padang, felt the earthquake strongly for about 30 seconds, agency spokesperson Abdul Muhari said.

"Many residents in several villages on Mentawai island chose to stay displaced in higher ground although the tsunami alert was ended due to fears of aftershocks," he said, adding that authorities were still collecting information about the damage.

The magnitude 7.1 earthquake was centered 170 kilometers (105 miles) southeast of Teluk Dalam, a coastal town in the South Nias regency of North Sumatra, at a depth of 15 kilometers (9 miles), the U.S. Geological Survey said. Aftershocks measured as strong as 5.8. After an initial tsunami alert, Indonesia's Meteorology, Climatology and Geophysical Agency lifted it just before dawn, about two hours after the quake. The agency initially put a preliminary magnitude at 7.3, but later revised it to 6.9. Variations in early measurements are common.

The agency's head of the Earthquake and Tsunami Center, Daryono, who goes by a single name, said that based on sea-level observations, minor tsunamis of 11 centimeters (4.3 inches) were detected in Tanah Bala coastal area of South Nias regency.

Indonesia, a vast archipelago of 270 million people, is frequently struck by earthquakes, volcanic eruptions and tsunamis.In November, a magnitude 5.6 killed at least 340 people and damaged more than 62,600 homes in part of West Java.

MOB IN HAITI CAPITAL BURNS TO DEATH 13

A mob in the Haitian capital beat and burned 13 suspected gang members to death with gasoline-soaked tires Monday after pulling the men from police custody at a traffic stop, police and witnesses said.

The horrific vigilante violence underlined public anger over the increasingly lawless situation in Port-au-Prince where criminal gangs have taken control over an estimated 60% of the city since the July 2021 assassination of President Jovenel Moïse. Six more burned bodies were laid in a nearby neighbourhood later Monday, and some witnesses said that police killed them and residents set them on fire, but the AP could not verify the accounts independently.

The Armenia-Azerbaijan conflict

 What is the historical background of the Armenia-Azerbaijan conflict?

The Armenian-Azerbaijani conflict is rooted in a dispute over sovereignty in NagornyKarabakh, a mountainous area of some 4,400 square kilometres. In 1987 Nagorny Karabakh's Armenian population began a campaign to separate from Azerbaijan and unify with Armenia. The dispute was still unresolved by the time of the Soviet Union's collapse in 1991, and a two-year war in the early 1990s ended in a decisive Armenian military victory.

By the time of the ceasefire in May 1994, more than 25,000 people had lost their lives, and more than a million were forcibly displaced from their homes. Almost all of the territory of Nagorny Karabakh had broken away from Azerbaijani control. A new entity was established, the de facto Nagorno-Karabakh Republic, which has not been officially recognised by any state, including Armenia, to this day.

■ What are the main issues at stake in the Armenia-Azerbaijan conflict?

Azerbaijan planning a long-term presence in Armenia, The recent large-scale cross-border attacks inside Armenia by Azerbaijan, with reports estimating at least 286 people killed from both sides and hundreds more wounded, highlights the wider picture of a collapsing Russian-led security order in Eurasia.

Coming on 12 September, the attacks coincided with Ukraine's successful counter-offensive in Kharkiv and fresh fighting between Tajikistan and Kyrgyzstan. Several key actors in Eurasia now see Azerbaijan as a critical – or at least important – partner in solving new problems flowing from the war in Ukraine. For the Kremlin, Azerbaijan is a pivotal link for a more isolated Russia seeking new routes to Iran and Asia.

The ECA has a strong influence with UEFA, including in decisions on how the Champions League is run and distributes money. "We do feel we aren't represented anywhere in European football," Crystal Palace co-owner Steve Parish said.

Top Indian shuttlers, including double Olympic medallist PV Sindhu, will hope to find their rhythm as they begin their campaign in the main draw of the Asia Badminton Championships, here on Wednesday.

The 40th edition of the prestigious continental competition started here on Tuesday with the qualifying rounds, while the main draw comprising all the top players will happen only from Wednesday.

It will be a tough task for India to return with a medal, considering most of the top players have been struggling with rhythm and form this season.

India have so far won 17 medals at ABC with Dinesh Khanna claiming the lone gold in 1965 and the likes of Sindhu, Prannoy and Lakshya will have to really play out of their skins to break the title drought.

On a comeback trial after a long injury lay-off, Sindhu has shown some spark when she reached the finals of the Madrid Spain Masters and the 8th seeded Indian will hope to find her 'A' game when she begins her campaign against Taiwan-

In men's singles, world number 9 HS Prannoy has been consistent and he will look to gear up for the bigger battles with a good show in the opening round against Phone Pyae Naing of Myanmar, while 2021 world championships silver medallist Kidambi Srikanth will take on Bahrain's Adnan Ebrahim.

Former world number 6 Lakshya Sen has endured a difficult phase in 2023 as his ranking plummeted after a series of early exits, forcing the Indian to take a break.

The Commonwealth Games champion has a tough road ahead with former world champion Loh Kean Yew of Singapore standing on the way in the opening round.

In women's singles, Malvika Bansod will face top seed and last year's finalist Akane Yamaguchi of Japan, while Aakarshi Kashyap meets Indonesian Komang Ayu Cahya Dewi. In men's doubles, sixth seeded pair of Satwiksairaj Rankireddy and Chirag Shetty, who won the Swiss Open super 300 title early this year, will open against Malaysian

INJURY SIDELINES ONS JABEUR AT MADRID OPEN

Defending champion Ons Jabeur is unable to defend her Madrid Open title this year as she has withdrawn from WTA 1000 event due to injury. The World No.4 from Tunisia withdrew from the tournament on Monday because of a left calf injury.

Jabeur reached the last four of last week's Stuttgart Open, but she retired from her semifinal match against World No.1 Iga Swiatek with a sprained left calf while trailing 3-O. Two-time Grand Slam finalist Jabeur said on social media that medical exams showed, "A small tear in my calf and I will need more time to recover. I am sad to announce that I won't be able to compete and defend my title this year [at Madrid.]"

Jabeur was seeded fourth in the Madrid main draw before withdrawing. Shelby Rogers of the United States, previously the highestranked unseeded player, will replace Jabeur as the Tunisia's Ons Jabeur in action.

No.33 seed in the draw. A qualifier or fortunate loser will fill Rogers' previous slot in the draw.

This is Jabeur's second injury of the season. Jabeur had minor knee surgery after the Australian Open this year, which kept her out of the entire Middle East swing in February.

Jabeur came back for the Sunshine Double and then appeared to be back to her

best on clay. She won her fourth career WTA singles victory on dirt in Charleston in early April, then beat Jelena Ostapenko and Beatriz Haddad Maia in Stuttgart before retiring in the semifinals. She entered the French Open last year as one of the championship favourites after success on red clay, including a title in Madrid, but she was knocked out in the first round.
