Prime Minister Narendra Modi on Friday inaugurated the priority section of Delhi-Ghaziabad-Meerut Regional Rapid Transit System (RRTS) Corridor at Uttar Pradesh's Sahibabad RapidX stationa state-of-the-art regional mobility solution aimed to transform regional connectivity in the country through construction of new world class transport infrastructure

The Prime Minister also flagged off the RapidX train connecting Sahibabad to Duhai depot, marking the launch of RRTS in India. This is India's first RapidX train which will be known as "Namo Bharat".

The 17 km priority section of Delhi-Ghaziabad-Meerut RRTS Corridor will connect Sahibabad to Duhai depot with stations at Ghaziabad, Guldhar and Duhai on the way. The foundation stone for Delhi-Ghaziabad-Meerut corridor was laid by the Prime Minister on March 8,

2019. With the train service operational, the travel time between Sahibabad and Duhai Depot will be 12 minutes, which would usually take around 30-35 minutes by road.

The RRTS project is developed in line with the Prime Minister's vision to trans-

form regional connectivity in the country through construction of new world class transport infrastructure. The RRTS is a new rail-based, semi-high-speed, high-frequency commuter transit system.

With a design speed of 180 kmph, RRTS is a transfor-

mational, regional development initiative, which is designed to provide high-speed trains for intercity commuting every 15 minutes, which can go up to a frequency of every 5 minutes as per requirement.

MAN ARRESTED IN GUJARAT FOR SPYING FOR PAK

AHMEDABAD: Gujarat Police Anti-Terrorism Squad (ATS) on Friday arrested a man for allegedly sending sensitive information to Pakistan using a messaging platform. As per the ATS officials, the espionage attempt has been targeted at the family of Indian Army personnel. The accused has been identified as Labhshankar Maheshwari from Tarapur town of Gujarat's Anand district. The ATS officials further informed that the accused has been a Pakistani citizen who later got Indian citizenship. SP, Gujarat ATS, Om Prakash Jat while speaking at a press conference regarding the arrest informed that the ATS received inputs from Military intelligence that a Pakistan agent was using Remote Access Trojan (RAT) malware to access phones and steal sensitive information. He further said that the accused has been working on the instruction of a person associated with the Pakistan Embassy. "Gujarat ATS received input from the military intelligence that a Pakistani army or a Pakistan agent is using WhatsApp on an Indian SIM Card. He was using Remote Access Trojan (RAT) malware to access phones and steal sensitive information. The SIM Card was issued under the name Muhammad Saklain Thaim from Jamnagar. TMC MP MAHUA MOITRA'S COUNSEL WITHDRAWS FROM DEFAMATION CASE

TMC MP Mahua Moitra's counsel on Friday withdrew from a case in the Delhi High Court, which sought restraint orders against BJP MP Nishikant Dubey, an advocate, and various media outlets from disseminating any alleged defamatory content about her.

Senior advocate Gopal Sankaranarayanan withdrew from the matter after advocate Jai Anant Dehadrai informed the court that Sankaranarayanan had contacted him on Thursday night to withdraw his complaint to the Central Bureau of Investigation (CBI) against the Trinamool Congress (TMC) leader. Dehadrai is the advocate against whom Moitra sought relief.

Sankaranarayanan stated that Dehadrai had previously instructed him, which prompted him to approach him. He informed his client, Moitra, that Dehadrai was a member of the Bar and had assisted him in a previous case, so he suggested that Dehadrai speak to him.

The Popular Front of India (PFI) has moved the Supreme Court challenging an Unlawful Activities (Prevention) Act (UAPA) tribunal's confirmation of the five-year ban imposed by the Central

government.

The matter was scheduled for a hearing before a bench of Justices Aniruddha Bose and Bela M Trivedi, but it was adjourned as the petitioner had requested an adjournment through a circulated letter.

In its petition, the PFI has challenged the UAPA tribunal's March 21 order, which upheld the central government's decision from September 27, 2022. The government had banned the PFI for a five-year period, citing its alleged connections with global terrorist organizations such as ISIS and its efforts to disseminate communal hatred in the country.

The government had offi-

cially declared the PFI, along with its associates, affiliates, and fronts, including Rehab India Foundation (RIF), Campus Front of India (CFI), All India Imams Council (AIIC), National Confederation of Human Rights Organization (NCHRO), National Women's Front, Junior Front, Empower India Foundation, and Rehab Foundation, Kerala, as an "unlawful association." The notification, under the UAPA, stated that it would be effective for a fiveyear period from the date of its publication in the official gazette, subject to any orders made under section 4 of the UAPA.

In September of the previous year, over 150 individuals allegedly linked to the PFI were detained or arrested in raids conducted across seven states. An extensive nationwide crackdown by government agencies on this 16-year-old organization resulted in the arrest of over a hundred of its activists and

Delayed disposal of cases will erode litigants' trust in judiciary: Apex court

The Supreme Court on Friday issued directions, including a few to the high courts, for ensuring speedy trial and disposal of old cases, observing that litigants may become disillusioned if the legal process moves at a snail's pace.

A bench comprising jus-

tices S Ravindra Bhat and Aravind Kumar referred to the country-wide data of the National Judicial Data Grid on pendency of cases and said joint efforts by the bar and bench were needed to tackle the issue.

The bench stated, "Litigants may become disillusioned when the legal process moves at a snail's pace. We have expressed our anguish where some litigations are pending for 50 years as per NJDG," and referred to some old cases which have not been decided for over 65 years in states like West Bengal, Maharashtra and Uttar Pradesh.

Justice Kumar stated, "Litigants will lose confidence in the judicial system when the delay continues."

The bench stated that liti-

gants should be circumspect about seeking frequent adjournments. They should not take goodness of the presiding officers as their weakness," the judges said as they issued as many as 11 directions to deal with pendency of cases.

The bench stated, cases pending for over 5 years needed to be monitored by the respective high courts.

adhya Pradesh Chief Minister Shivraj Singh Chouhan on Friday took a dig at the INDIA bloc after its constituents fielded candidates against each other in assembly polls, saying the opposition grouping is driven by the motto of "friendship in Delhi and wrestling in states".

INDIA members Congress, the Samajwadi Party (SP) and the Aam Aadmi Party (AAP) have separately announced candidates for the November 17 assembly polls in Madhya Pradesh, clearly indicating the bloc is not working at state-level.

Upset with the Congress for not conceding any seat so far for the SP in Madhya Pradesh, its president chief Akhilesh Yadav on Thursday hinted the grand old party could get the same treatment from his outfit in Uttar Pradesh.

In stinging remarks that exposed chinks in the opposition INDIA grouping, Yaday said the Congress leadership should not allow its "small leaders" to comment on his party.

The SP and the AAP have announced candidates on multiple seats for polls in the BJP-ruled state, which has a 230-member assembly. Latching on to apparent cracks in the recently formed bloc of more than two dozen parties, Chouhan dubbed it an incoherent coalition and called it 'ghamandia' (arrogant).

AIADMK LS POLL SLOGAN IS SAFEGUARDING RIGHTS **OF MINORITIES: EDAPPADI K PALANISWAMI**

Ahead of the 2024 Lok Sabha polls, both the AIADMK and the DMK have been expressing confidence at winning all 40 seats. Now, after the alliance break up with the BJP, the AIADMK has gone a step further and is fervently wooing the minority communities in the state.

Speaking at a rally in Sankarankovil late Wednesday night AIADMK general secretary Edappadi K Palaniswami (EPS) said, "People of Tamil Nadu are our masters. We will safeguard the rights of the people of the state to get new schemes and funds for them from the central government and to safeguard the rights

of the minorities in Tamil Nadu. This is the AIADMK's poll slogan for the Lok Sabha elections.'

Numerous minority leaders, including Manithaneya Jananayaga Katchi leader Thamimun Ansari, SDPI leader Nellai Mubarak and All India Majlis-e-Ithihathul Muslimin state president TS Vakil Ahmed, have held meetings with EPS over the last few weeks.

EPS also raised the Cauvery row and said at the rally, "National parties (Congress and BJP) are coming to power one after another. But they don't bother about the people of Tamil Nadu and treat us like dust. The AIADMK is here to safeguard the interests of the state.'

Despite the fact that the AIADMK is now wooing the minority parties in Tamil Nadu, their alliance with the BJP the past few years had some of these parties aligning with the DMK. EPS raised the release of Muslim prisoners in the Assembly in a bid to get the Muslim vote on the AIADMK side. The AIADMK has now chosen its 2024 electoral strategy as the rights of minorities but time will tell how far the party is successful in win-

While EPS has been reiterating to the people that the AIADMK will not ally with the BJP in 2024 or 2026, the BJP has not issued any statement on this so far.

It's believed that this

assassination was a result of an ongoing vendetta between the rival Bishnoi and Bambiha gangs. Further inquiries have pinpointed gangster Lawrence Bishnoi as the mastermind behind the brutal murder. Goldy Brar, identified as a close accomplice of Bishnoi and believed to be in Canada, is also under investigation concerning this case. In light of this, the police have issued a Red Corner Notice for Brar via Interpol.

It's noteworthy that Moosewala had previously contested an election in Mansa during the last Punjab Assembly elections as a Congress candidate. However, he faced defeat at the hands of AAP's Vijay Singla.

DELHI COURT PROLONGS NEWSCLICK DUO'S CUSTODY OVER ALLEGED PRO-CHINA TIES

Patiala House Court in Delhi has extended the judicial custody of NewsClick's founder and Editor-in-Chief, Prabir Purkayastha, and HR head Amit Chakravarty until October 25. This follows an earlier 10-day remand by the court. The pair were apprehended by Delhi Police under the antiterror law, Unlawful Activities (Prevention) Act, over

claims that NewsClick received substantial funding for promoting pro-China

Purkayastha's attorney contended the allegations, citing a previous protection from the Delhi High Court in 2021 and challenging the rationale behind labelling journalistic activities as terrorism. The lawyer said, "If I through any article raised questions against the Central Government's COVID policy, is that an act of terrorism?" The defence also highlighted Purkayastha's reputation as a distinguished journalist and raised concerns about his association with fellow journalist Gautam Navlakha, which seems to be the basis for the UAPA charges.

Meanwhile, Advocate Rohit Sharma, representing Chakravarty, emphasised that Chakravarty is not involved in content creation and questioned the reasons

for his arrest, highlighting that he handles administrative tasks.

The Special Cell of Delhi Police alleges that News-Click, via the People's Dispatch Portal, propagated misleading narratives for monetary gains from illicitly channelled foreign funds. The police FIR suggests that both Indian and foreign entities funnelled these funds to India with malicious intent to undermine the country's sovereignty and unity.

Prachi Malik, a 23-year-old woman from Delhi, was brutally attacked by her ex-boyfriend and stalker, Gaurav Pal, inside a taxi. Malik met Pal in 2021 and ended their relationship due to his increasing obsession. Prior to the attack, Malik had distanced herself from Pal, who insisted she quit her job and marry him. Despite blocking his number, Pal's persistence became evident when he followed her, knowing her whereabouts. The previous night's events escalated when Malik blocked his persistent calls.

Even after his arrest, Pal threatened Malik's life. Malik's main concern now is that Pal remains behind bars. She stated, "I don't through."

Malik had previously voiced concerns about Pal's behaviour to the police, who promised intervention. Authorities now face scrutiny for their inaction, as they claimed the situation was "resolved amicably." Malik's commitment to her work stems from her desire to support her single mother and four siblings, a fact Pal seemingly ignored.

Bhatnagar's plea emphasised the historical significance of these trees, termThey were planted during colonial times, stretching from Kingsway Camp to the Coronation Pillar. This area hosted the Delhi Durbar in 1877 and King George V's coronation in 1903. "Although Delhi lacks a formal policy on 'Heritage Trees', the importance of preserving such trees is undeniable," argued the

Furthermore, the petition criticised the order for tree felling as lacking transparency and details. It did not specify the reasons for the felling nor did it explore alternatives to save the trees, which contradicts previous court orders.

DELHI EXPERIENCES WORST OCTOBER POLLUTION SINCE 2020

Delhi's air quality this October has been the most polluted since 2020, with current data indicating minimal improvement in the foreseeable future. The average Air Quality Index (AQI) for the first 19 days of this month stands at 181.7, surpassing the averages of 2022 and 2021, though still below 2020's

Forecasts predict the AQI to decline into the poor category by Friday, likely persisting for the subsequent six days. IMD officials attribute this to decreasing wind speeds, dipping from 6-8 km/hour to 4-8 km/hour by the weekend. Although a slight rise in wind speed is anticipated on Sunday, air quality is projected to remain poor.

The notably better AQI in 2022, the best in six




years, was credited to a late monsoon retreat coupled with consistent postmonsoon rainfall caused by western disturbances (WD). Similarly, 2021's improved AQI was due to an increased number of rainy days. In contrast, 2022 saw

only one WD affect the

day of rainfall. While the city experienced a brief improvement in AQI over the past three days due to rain and robust winds, the effect is transient, with only a slight chance of light rain forecasted for Sunday. However, conditions cur-

ed in the upcoming week.

MADHYA PRADESH: CONGRESS RELEASES CANDIDATE LIST AND A COMPREHENSIVE LOOK AT THE POLITICAL LANDSCAPE IN THE STATE

The assembly elections in Madhya Pradesh is one of several pivotal events on the horizon in the upcoming assembly election cycle that will begin in November. The Congress had on Sunday released its first list of 144 candidates for the state. With this, the Congress has declared all but one candidate for elections to the 230-member assembly in Madhya Pradesh.

The Congress replaced its candidate for the Datia assembly constituency, fielding Rajendra Bharti in place of Avadesh Nayak. He will contest against BJP candidate and Home Minister Narottam Mishra. Bharti, a former MLA, had defeated Mishra in the past but lost the last election by a slender margin. The party also fielded Ravinder Singh To-


bly seat and he will contest against Union Agriculture Minister Narendra Singh Tomar. From the Gwalior assembly seat, considered the bastion of Union minister Jyotiraditya Scindia, the Congress has fielded Sunil Sharma, who had unsuccessfully contested in a bypoll against sitting MLA and minister Pradhuman Singh Tomar, a known Scindia loyalist. Pradhuman Singh Tomar had switched over to the BJP along with Scindia


after the last assembly polls. In order to gain a comprehensive understanding of what lies ahead in these elections, a data intelligence unit analysed the state assembly's election data from 1962 to 2018. The data revealed intriguing patterns in the victory margins over the years. Tight races highlighted the power of grassroots efforts, while big wins stressed targeting swing areas.

With specific regard to tight races, it was found that 24% of seats had margins of less than five percent. This means that a mere whisker decided the outcome of every fourth seat. On the other hand, in terms of clear wins, only one in eight seats witnessed victories of over 30 percent, indicating the presence of strongholds. There was also a middle ground, where one in three seats fell within the 5-15% margin. These were highly competitive races but with leads that were nonetheless clearly established.

As Madhya Pradesh gears up for another electoral showdown by the end of this year, the historical patterns suggest a strong political undercurrent in the state. The result could serve as a crucial indicator for national politics.

Over the last six decades,





the political terrain in Madhya Pradesh has undergone significant transformations.

2003

The period from 1962 to 1985 marked the dominance of the Indian National Congress in Madhya Pradesh. Data reveals that in 1962, 1967, and 1972, the party secured a broad range of victories, from razor-thin margins to substantial leads.

Frequently establishing itself as the prevailing authority with a substantial majority, the party became closely associated with governing the state. Nevertheless, as the 1980s approached, the party's prominence began to diminish, marking the onset of a decline in its complete dominance.

In 1967, the Bharatiya Jana Sangh emerged as a significant player, eventually evolving into the contemporary Bharatiya Janata Party (BJP). While the Congress continued to maintain its stronghold for an additional decade, the foundation for an alternative political force was laid during this time.

Around 1977, there was a shift in political dynamics. The Janata Party assumed a prominent position, echoing a nationwide sentiment against the Congress, which had recently imposed and subsequently lifted a state of emergency in the country. Nevertheless, this shift was temporary, as the Congress

regained power by 1980.

2013

2008

The BJP began to assert its influence in the 1980s, and as we progress through the years on the heatmap, the saffron shade becomes notably more pronounced, particularly during the 1990s and 2000s. Remarkably, the party exhibited a proficiency in securing victories with significant margins, as evident from the clustering of warmer colours in the "20 to 30%" and "30% and above" categories. By 1990, they had not only arrived on the scene but had established dominance, winning 220 out of 320 seats and heralding a new era in the state's political landscape. It's important to note that prior to

the separation of Chhattisgarh, Madhya Pradesh had 320 assembly seats.

2018

Since 2003, the Congress faced challenges in Madhya Pradesh, losing thricein 2003, the BJP won big with 173 seats; Congress got only 38.

The 21st century has been a precarious balancing act, with both parties experiencing peaks and valleys.

The BJP's dominance in the 2003 and 2013 elections was evident, but the Congress's resurgence in 2018 suggests a state open to change its course. With narrow margins and high stakes, the forthcoming elections could swing in either direction.

While both parties have witnessed their fair share of nail-biting conclusions, the BJP seems to have a greater number of seats with clearcut victory margins, particularly in the 10 to 15% and five to 10% ranges. On the flip side, the Congress holds a slight advantage in the most tightly contested seats (with less than a 5% margin).

SURVEY RESPONDENTS SAY BHUPESH BAGHEL FIRST CHOICE FOR CM IN CHHATTISGARH, RAMAN SINGH COMES A CLOSE SECOND

The Congress on Wednesday announced 53 candidates for the ensuing Chhattisgarh Assembly elections which will be held in two phases on 7 and 17 November. The party has dropped 18 sitting MLAs so far in the state where it is seeking to retain power in Chhattisgarh under Chief Minister Bhupesh Baghel and fielded over two dozen new faces. CM Baghel and his 12 cabinet colleagues and state Assembly Speaker Charandas Mahant will face the electoral test and the votes will be counted on December 3. Congress has so far declared candidates for 83 out of the total of 90 seats. The filing of nominations for the first phase began on 13 October. Twenty constituencies are slated to go to polls in the first phase on 7 November while the second phase of polls will be held on 17 November, covering 70 constituencies.

Ahead of the upcoming elections, India News conducted an exclusive ground survey to understand the political pulse of the state and understand the sentiment on the ground.

MUMBAI RECORDS 'VERY POOR' AIR QUALITY, EXPERTS SAY CITY ON BRINK OF POLLUTION CRISIS



According to data from the **Central Pollution Control** Board, as of the evening of 19 October, the city of Mumbai had an average AQI (air quality index) score of 156 while New Delhi was at 121. The financial capital has been waking up to a thick blanket of smog owing to a rapid increase in construction activities. According to experts, the situation could worsen, setting the stage for

Several ongoing infrastructure projects in the city, as well as large-scale building construction and demolition works, have caused a surge in dust particulate pollution in the air, impacting the health of people. "A combination of high moisture and dust is caused due to the multiple redevelopment and construction projects that are operational across the city," the India Meteorological Department (IMD) scientist Sushma Nair said. "There is moisture, anticyclonic wind circulation which does not allow the wind to ascend. The anti-cyclone is right over Mumbai,"

MAHARASHTRA TO ENTER RED ZONE OF AEROSOL POLLUTION

- In 2023, aerosol pollution in Maharashtra is anticipated to move from its current "vulnerable" orange zone to the "highly vulnerable" red zone.
- High aerosol amounts include particulate matter (PM2.5 and PM10) consisting of sea salt, dust, sulphate, black and organic carbon. If inhaled they can be harmful to people's health.
- Aerosol optical depth (AOD) is the quantitative estimate of the aerosol present in the atmosphere and it can be used as a proxy measurement of PM2.5.
- Maharashtra currently falls under the orange category which is a vulnerable zone with AOD between 0.4-0.5.
- However, rising aerosol pollution is expected to push the AOD higher than 0.5 to enter into the most vulnerable (red) zone. The values of AOD range from 0 and 1.0.

Trends data from Google showed that the search interest for air purifiers was the highest in Maharashtra compared to the rest of India in the past seven days. Shopping websites such as the delivery giant Amazon are providing attractive discounts on air purifier products as concerned citizens are snapping up the product to enhance indoor air quality ahead of the festive season. "Mumbai needs to implement dust management, as there is a lot of construction being undertaken in the city at the moment and that is contributing significantly towards air pollution in the city," said Rishi Aggarwal, founder of the Mumbai Sustainability Centre.

UP GOVT MAY MOVE SC AGAINST ALLAHABAD HC VERDICT: DCM MAURYA

The Uttar Pradesh government intends to re-evaluate the Allahabad High Court's order in the Nithari serial killings case and may approach the Supreme Court if necessary, stated Deputy Chief Minister Keshav Prasad Maurya.

On Monday, the high court acquitted domestic help Surendra Koli and his employer Moninder Singh Pandher in the infamous 2005-06 case, where they were previously sentenced to death. The court cited the prosecution's failure to establish guilt "beyond reasonable doubt" and the mishandling of the investigation.

This verdict has stirred memories of the heinous crimes involving young children, brought to light by the discovery of skeletal remains behind a Noida residence near Delhi. Fami-



lies of the victims have expressed a sense of injustice.

The voting for these 20 seats is scheduled for November 7, with the elections taking place in two phases within the state. The total number of voters for these 20 constituencies in the first phase is 40,78,681, consisting of 19,93,937 men, 20,84,675 women, and 69 third-gender voters. The electoral process will be facilitated through 5,304 polling stations.

In contrast. wins in Madhya Pradesh, Rajasthan, or Chhattisgarh have strong local leaders, making a Telangana victory a significant milestone for the Gandhis.

ustin Trudeau's foolish parliamentary antics have hampered a promising partnership of nations that have the potential to grow as trade and cultural partners. Clearly, the Canadian PM lacks a smart Foreign affairs committee and a solid team of advisors. that could make him realize he just shot himself in the foot. The bumbling premier seems to have learnt little from the misadventures of his father and might repeat the glaring mistakes that have stained Canada's political history and its security narrative.

Following New Delhi's issuance of a safety advisory there is a possibility that Indian students might not consider Canada as their destination for higher education. This possible shift in student preferences could impact the education sector that contributes about C\$22 billion (\$16.3 billion) in an-

nual revenues to Canada.

Indian students who remain in Canada for employment and possibly pursue permanent residency continue to contribute to the Canadian economy over the long term. This means that a significant proportion of its citizens are reaching retirement age, and the birth rate is not sufficiently high to replace the retiring workforce. ductivity. A break down in trade ties might lead to increased prices for potash in the Indian market and reduce crop yield. This could impact food prices for consumers and the profitability of farmers.

Furthermore, India seeks to establish itself as a global pharmaceutical powerhouse. It is already known for producing high-quality and cost-effective medicines. When it comes to exports to Canada, pharmaceuticals play a crucial role, contributing significantly to the bilateral trade relationship.

During the COVID-19 pandemic, India played a pivotal role in supplying essential pharmaceutical products, including vaccines, to Canada. This collaboration highlighted the importance of the pharmaceutical sector in addressing global health crises.

Iron and steel products are another significant category of Indian exports to Canada. These products are essential for various industries, including construction, manufacturing, and infrastructure development. Gems and jewelery, electrical machinery and organic chemicals are some of the other exports from India to Canada. The grinding halt to trade talks between the two

these sectors. Although Canada's share in FDI inflows into India is minuscule, it was likely to grow substantially over the years, given the potential of the Indian economy. The current gloomy outlook on their relationship is unfortunate for both nations.

India and Canada have established a Comprehensive Economic Partnership Agreement (CEPA) with the objective of enhancing trade and investment within the technology sector. Within the framework of this agreement, both nations have pledged to lower tariffs and address non-tariff barriers in the trade of technologyrelated goods and services, encompassing areas such as information technology, electronics, and telecommunications. Additionally, the CEPA encompasses provisions for collaborative efforts in the realms of digital innovation and support for startup ventures.

In recent years, India has sought to position itself as an alternative to China as a global supply-chain hub. The ongoing tensions in the India-Canada relationship threaten to disrupt this strategy. A trade deal with Canada could have been a crucial step in enhancing India's role as a reliable supplychain partner.

Similar in value of exportimport relationships, India and Canada so far enjoyed a promising economic partnership, with over 600 Canadian enterprises, including prominent names like Bombardier and SNC Lavalin, maintaining significant operations in India. Conversely, more than 30 Indian companies, including major IT players such as TCS, Infosys, and Wipro, have made substantial investments totaling billions of dollars in Canada. These investments have not only strengthened economic ties but have also led to the creation of numerous job opportunities in both countries. One wonders how the current stand-off will affect these corporates, employees and their plans for further expansion.

It is unfortunate that Canada has chosen to become a safe haven for terrorists and anti-India activities. Although both countries stand to lose, this nose-dive in relationships brought on by Trudeau's short-sightedness is going to hurt Canada much more than India. His choice of political appeasement over economic ties is likely to end badly not just for him but for Canadians in general.

AKHILESH TOUGHENS STAND ON SEAT SHARING WITH CONGRESS IN UP

Samajwadi Party boss and former Uttar Pradesh Chief Minister, Akhilesh Yadav is not amused with

the statements made by the State Congress Chief

Ajay Rai that the grand old party was preparing

to put up nominees in all the 80 seats for the forthcoming Lok Sabha polls. Rai had earlier questioned the wisdom of the Samajwadi Party in fielding a nominee against the official congress candidate in Uttrakhand, and its attempts to weaken the Congress in Madhya Pradesh where it has no say or stakes. This despite the fact that the Congress had supported the SP fully during the by-election to Ghosi. Akhilesh reacted sharply to Rai's assertions and maintained that the Congress needed to make its stand clear whether it wanted to have cooperation with his organization as part of the understanding reached at the meetings of the Indian National Developmental Inclusive Alliance (IN-DIA). He was unsure whether the Congress would be able to identify too many seats where its nominees could win in a Parliamentary poll. This was a dig the SP supremo had at the Congress leadership since the party has only one seat (Rae Bareilly) in the current Parliament and its chances of winning in the State are considered bleak, given that there is no organizational network, and the Gandhis are losing their charm with each passing day. In 2019, Rahul Gandhi had been defeated from the family bastion of Amethi by union minister Smriti Irani and it is unlikely that either he or Privanka Gandhi Vadra would be able to win the seat back from the BJP. Even Akhilesh's overall position in UP is not very sound and the Samajwadi Party has to do much more, if it has to wrest seats from the BJP during the Parliamentary confrontation. In fact, after Gujarat, Uttar Pradesh is the strongest BJP state and whether one likes it or not, there is wide acceptance for Yogi Adityanath's leadership. The general belief is that the current Chief Minister, the first in the States's history to have been re-elected, has made UP, far safer than it ever was, and was likely to virtually repeat the BJP's performance in the Lok Sabha election. This is regardless of the fact whether the INDIA alliance partners work out things amongst themselves or enter the fray separately. Many political analysts also are of the view that the BJP may not be able to replicate its performance in all the States, but so far as UP and Gujarat are concerned, it shall fare very well from all accounts. Although Ajay Rai is a five-time MLA, he should realise that it was not the time to have a sparring match with allies, who are much stronger. There are reports that the Congress may retain Rae Bareilly, because there has been a secret understanding the party has reached with Mayawati. However, this was not going to be sufficient. Unless and until, the Congress gets into double digits in India's largest state, its chances of making a comeback nationally would always be bleak. The Hindi heartland is where the Congress needs to improve its performance to be a contender for the top spot, which has been eluding it for the past two polls. Yes, it is true that the differences amongst INDIA partners have surfaced during the Assembly polls which shall be held in November. The Congress and the BJP are facing each other in three States and other allies must not play spoilers by fielding candidates there since they are marginal players and therefore should honour the spirit of the coalition of helping each other. The best news for the alliance partners would be if the BJP is humbled not only in these three states but also in Telangana and Mizoram. The outcome would have an impact on the Lok Sabha polls and may provide a psychological advantage to the INDIA partners nationally. However, what needs to be seen is that the partners have many contradictions and none of them would want the Congress to be stronger again. A weak Congress suits them more than a weak BJP since most of the allies have at some stage or the other been partners of the BJP as well but were occupying the space which Congress once held. This is the reason, why the Congress leadership in general and Mallikarjun Kharge in particular must ensure that state leaders do not speak out of turn and try and adjust with the partners in the larger interests of the alliance. It is also anticipated that the INDIA alliance may develop cracks closer to the polls, and three leaders who could play a role in widening them would possibly be Nitish Kumar, Arvind Kejriwal and Sharad Pawar. And if Akhilesh Yadav was to join them, the alliance would collapse prematurely. In UP, the Congress cannot regain its lost ground, till its traditional vote bank of Brahmins, Dalits and Muslims comes back in its fold. This is unlikely to happen and instead of wooing these three segments, some party leaders are surprisingly talking about OBC politics, knowing fully well that by and large, the OBCs have always been against the Congress. It is very important that for INDIA alliance to move forward, the partners need to strengthen the perception regarding the common intent, and work toward the objective instead of publicly differing on minor issues. Perception sometimes help, whatever be the reality.

Geopolitical jigsaw: Unravelling its impact on financial market resilience

Increased uncertainty and rising cross-border tensions affect global capital flows and financial stability. Tensed ties between the USA-China, the Russia-Ukraine crises, the most recent Israel-Hamas war etc., are a few recent geopolitics situations which have affected overall financial and capital market stability. As per the IMF report, since 2016, there has been about a 15 per cent reduction in bilateral cross-border allocation of portfolio investment and bank claims between the USA and China.

IMF October 2021 Outlook report estimated global economic growth (in 2022) to be five per cent. The Organization for Economic Cooperation and Development (OECD) projection slackened to 2.2 per cent in 2023. European Union (EU) Autumn 2022 Economic Forecast stated that the EU, due to its vicinity to the Russia-Ukraine war, was exposed to lower growth as it relies on imported fossil fuels. This war impacted Europe's economy, where growth in 2023 is projected to be just 0.29 per cent and 1.58 per cent in 2024. This has created an uncertain investment environment for India, where India has to navigate its uncertainty with a proper policy structure.

The Middle East's considerable position as a prominent oil provider highlights its potential to instigate global disruptions, as seen by the tangible existence of substantial geopolitical risks. The Israel-

Hamas conflict exerts a significant influence on the global economy. According to Bloomberg's analysis, there is a potential for the price of oil to increase significantly, reaching a level of USD 150 per barrel. Additionally, this jump in oil prices might have a negative impact on global economic development, potentially resulting in a decline of 1.7 per cent.

The escalation in crude oil prices can potentially result in elevated inflation levels in importing nations such as the United States, India, China, and other countries. Consequently, the expenses associated with production in many industries and the energy expenditures for both firms and people experience an increase. In the opinion of other experts, the rise in crude oil prices will happen if there is any in-

terruption in the Strait of Hormuz. In the realm of the capital market as well, there was an early period of turbulence. However, it is now widely believed that the ongoing battle will remain limited to the borders of Gaza and Israel. Anticipated financial market turbulence is unlikely until the conflict extends to more geographical areas. Therefore, it is challenging to anticipate a more extensive influence on the capital market. The financial market in Israel exhibited an immediate reaction characterised by significant declines in major stock indices, namely TA125 and TA35, which closed almost 7 per cent down. Additionally, government bond prices experienced a



decline of three per cent. According to reports, the Central Bank of Israel has announced its intention to engage in the sale of USD 30 billion in foreign exchange reserves. This measure is being undertaken with the objective of providing support to the domestic currency, the Shekel, and mitigating fluctuations in the exchange rate of the Shekel. The Tadawul All Share Index in Saudi Arabia had a decline of 1.3 per cent as well. On Monday, October 09, 2023, the primary stock markets in the Middle East experienced a decline during the initial trading session. The EGX30 index in Egypt had a decrease of almost 5 per cent. The Nifty index in India experienced a marginal decrease of 0.7 per cent. On the same day, the Indian markets declined as the Nifty50 and the SENSEX declined approximately one per cent each during the initial trading session. Potential negative repercussions could be experienced by Indian retail investors in the event of esca-

lating the existing conflict, particularly if it attracts involvement from

other regional states. As a consequence of the aforesaid geopolitical occurrence, investors may seek secure investment options, such as gold and treasury bonds. The price of spot gold had a 1.2 per cent increase, reaching USD 1,853.79 per ounce. Similarly, US gold futures rose by 1.2 per cent, reaching USD 1,867.80. In addition to the above-mentioned factors, the Indian equity market had a substantial outflow of USD 2.2 billion from Foreign Institutional Investors (FIIs) in September 2023. This withdrawal represents one of the most significant monthly decreases since January 2023. Nevertheless, due to the persistent increase in US 10-vear bond yields, investors hastily divested from Indian equities, which are commonly perceived as higher-risk assets and hence less appealing. Concerns about a possible escalation of geopolitical tensions in West Asia encouraged

FIIs to continue selling their Indian equity holdings throughout October 2023 and the following months. In addition, the share prices of Indian pharmaceutical businesses, oil marketing businesses and IT businesses conducting their operations in Israel may also be impacted in the event of an escalation of the

The outlook for the future is bleak inside the complex network of geopolitical uncertainty and its substantial repercussions on worldwide financial markets. The intricate and unpredictable nature of the connection between international politics and the global economy is evident when examining the consequences of recent wars. Financial markets exhibit a remarkable degree of resilience and adaptability. However, in order to navigate the evolving landscape, market participants are faced with the ongoing challenge of striking a delicate equilibrium between managing risks and capitalizing on potential opportunities. What will be the outcome of this geopolitical puzzle - will peace and stability prevail, or will there be a disintegration of components? The definitive answer cannot be ascertained until a certain period of time has

DELHI HIGH COURT PERMITTED WOMAN LIVING SEPARATELY FROM HUSBAND TO **TERMINATE 23 WEEKS PREGNANCY**

he Delhi High Court in the case Mrs B. v. The Union Of India And Anr observed and has permitted the woman living separately from her husband and desirous of taking divorce to terminate her 23 weeks pregnancy.

The bench headed by Justice Subramonium Prasad in the case observed and took note of the opinion given by the medical board of All India Institute of Medical Sciences, AIIMS wherein it is stated that the foetus was normal and that it being safe to terminate the said pregnancy.



The same came after it has been directed by the court to constitute a medical board to examine the woman's condition and to consider if it would be safe for her to undergo the medical termination of the pregnancy.

The woman in the matter informed the court that she had no desire of living with her husband and that it was tough for her to take the decision to terminate the pregnancy of her.

On the other hand, it was also submitted by the man that he wishes to live with her and tried to reconcile the situation but failed.

In the present case, the court was dealing with the petition moved by the 31-year-old woman who got married in June and came to know that she was carrying a single intrauterine pregnancy after a month.

Therefore, it being the case of her case that right from the early stages of marriage, she was being tortured, abused verbally, physically, mentally, and emotionally by her husband at her matrimonial home. Thus, it has been alleged by the women befor ethe court that husband

committed physical assault on her for the first time in July and the second instance took place in August, when she was 3 months pregnant.

Therefore, the woman has been living in her parental home and she did not want to continue with her pregnancy.

The court also noted the decision taken by the court in the case Supreme Court in X v. Principal Secretary, Health and Family Welfare Department, Govt. of NCT of Delhi and Another, thus, the ratio being that it is the prerogative of each woman to evaluate her life and arrive at the best course of action in view of the change in material circumstance.

The Apex Court in the

case observed and is of the opinion that change in material circumstance may result when the woman separates from her partner and she may no longer have the financial resources in order to raise the child

Further, the Apex Court in the case has included the cases of domestic violence perpetrated on a woman under Rule 3B(c) of the MTP Rules wherein a woman is permitted to terminate her pregnancy up to 24 weeks on the ground of the change of marital status during the ongoing pregnancy.

Accordingly, the court issued the notice and has ordered that the woman's husband be impleaded.

Supreme Court Collegium Recommended The Appointment of Two Judicial Officers Of Delhi High Court

The Supreme Court Collegium had recommended the appointment of them as Delhi High Court judges on October 10, 2023.

The Chief Justice Satish Chandra Sharma administered the oath of office to the newly appointed judges.

The Central Government has notified the appointments of them.

Therefore, the announcement was made by Law Minister Arjun Ram Meghwal on X i.e., the formerly Twitter.

The Supreme Court Collegium stated that the Delhi High Court's Chief Justice, in consultation with his two senior-most colleagues recommend the elevation of



judicial officers.

The Supreme Court Collegium with regards to the appointment of judge Shailender Kaur in its resolution stated that the Judgment Evaluation Committee has given an 'A' rating to the judgments of the judge.

The resolution stated that the collegium is conscious of the fact that the officer has recently retired from the Delhi Higher Judicial Service on 30.09.2023. therefore, the Collegium is of the considered view that she is suitable for appointment as a judge of the Delhi High Court.

However, the resolution stated with regards to the appointment of Ravinder Dudeia who is presently the Registrar General of the Delhi High Court, thus, it has been stated that the Judgment Evaluation Committee has also given an 'A' rating to his judgments.

The resolution stated while considering the long experience of the officer in judicial service, merit and integrity, and is of the opinion that the officer is suitable for appointment as a judge of the Delhi High Court.

The Supreme Court Collegium has taken note of the fact that the proposal involves the non-recommendation of a senior judicial officer.

It has also been stated by the Supreme Court Collegium that the cogent reasons have been recorded by the Collegium of the High Court for not recommending his name. thus, this court is in agreement with the Collegium of the High Court for not recommending his name.

in the case stated that if you have to be truly equal in all respects, the commitment that Constitution makers gave to all sections of society

by entrenching emancipatory provisions such as Article 15(2), Article 17 and Article 23 and Article 24 of the Constitution, each of us must live up to its promise. Therefore, the Union and the States are the duty bound to ensure that the practice of manual scavenging is completely eradicated and each of them owe to this large segment of the population, who have remained the unseen, unheard, and muted, in bondage systematically trapped in

human conditions. However, the conferment of entitlements and placement of obligations upon the Union and States through the express prohibitions in the Constitution and the provisions of the 2013 Act mean that they are being obliged to implement the provisions in the letter and spirit.

The bench of Justice Bhat in its judgement stated that upon all of us citizens lie the duty of realising true fraternity. It is not without reason that our Constitution of India has placed great emphasis on the value of dignity and fraternity.

The court in the case remarked that all of us today who proudly bask in the achievements of our republic have to awake and to arise so that the darkness which has been the fate of generations of our people is dispelled and they enjoy these freedoms and justice-social, economic and political-that we take for

Accordingly, the court listed the matter for further consideration on February 01, 2024.



STATE/UTS MUST NOTIFY 'DISTRICT OFFICERS' UNDER POSH ACT: SC ISSUES SLEW OF DIRECTIONS

ANALYSIS

hile not leaving even a drop of doubt in the mind of anyone, the Apex Court as recently as on October 19, 2023 in a most learned, laudable, landmark and latest judgment titled Initiatives For Inclusion Foundation & Anr vs Union of India & Ors in Writ Petition (Civil) No. 1224 of 2017 and cited in Neutral Citation: 2023 INSC 927 in the exercise of its original civil jurisdiction has issued a slew of directions to the Union Government and all State/UT Governments to ensure the effective implementation of the provisions of the Sexual Harassment at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (POSH Act) read with its Rules. It must be noted that the Bench of Apex Court passed these most commendable directions in a writ petition that had been filed under Article 32 of the Indian Constitution by an organization named 'Initiatives For Inclusive Foundation' seeking effective implementation of the provisions of the POSH Act. The most significant among these directions is the direction made mandatory by the Court that the States and Union Territories must appoint a "District Officer"

even though in the Section 5 itself it is not mandatory.

Most significantly, what constitutes the "real backbone" of this learned judgment is then laid bare in para 22 wherein it is postulated that, "Having regard to the above discussion, it is appropriate for this court to issue the following directions (under the relevant heads) to ensure the effective implementation of the POSH Act, and render it workable:

A. Coordination between Union Government and State/UT Governments

i. The Women and Child Development Ministry of every State/UT, through its Principal Secretary, should consider identifying a 'nodal person' within the Department, to oversee and aid in coordination as contemplated under the POSH Act. This person would also be able to coordinate with the Union Government on matters relating to this Act and its implementation.

ii. Each State/UT Government is to submit a consolidated report of its compliance with the below directions to the Union Government within 8 weeks. The latter is hereby directed to consolidate the various reports, identify any lapses in the compliance by the State and try to remedy it, before filing

compliance - detailing the States' compliance, and the Union Government's action taken in regard to the direction within 12 weeks from the date of this judgment.

B. Appointment of public authorities

iii. The concerned Principal Secretary of the State/ **UT Ministry of Women** and Child [or any other Department, subject to amendment of the Rules as per direction (vii) below], will personally ensure appointment of a district officer in each district within their territorial jurisdiction, as contemplated under Section 5 within four weeks from the date of this iudgment.

iv. Thereafter, each appointed district officer (a) must in compliance of

Section 6(2) appoint nodal officers in every block, taluka and tehsil in rural or tribal area and ward or municipality in the urban

(b) must constitute a LC, as contemplated under Section 6 and 7 of the Act;

(c) ensure the contact details of these nodal officers. and LCs, shall be forwarded to the nodal person within the State Government Ministry of Women and Child Development within 6 weeks from the date of this judgment.

v. Thereafter, a circular/ bulletin containing names of all district officers, and their contact details (phone, address, and email), along with a district wise chart of the various nodal officers and their contact details, must be uploaded on the department's website (or in the absence of one, on

the main State government website) in a conspicuous location, along with a compiled version of the Act. Rules, and simple charts/ explainers on the basics of the Act, within 6 weeks from the date of this judg-

C. Amendments and gaps in Rules that State must fill

vi. The Union Government ought to consider amending the Rules, so as to operationalise Section 26 of the Act, by recognising a reporting authority, and/or a fine collecting authority. This direction must be read in light of the discussion in paragraph 8 (role of district officer with regards to annual compliance reports) and paragraph 21 (on the penalty regime contemplated in the Act and resulting lacunae in the Rules) above.

This will ensure greater uniformity in the implementation of the Act

viii. The District Officers and LCs should be mandatorily trained regarding their important responsibilities. Given their position in the redressal framework contemplated in the Act, they must first be sensitised to the nature of sexual harassment, the gendered interactions that

The State Governments, must organise periodic, and regular training sessions at the District level which are to be attended by the District Officer, members of the LC, and nodal officers [ref: Section 24(b)].

E. Larger efforts towards awareness

ix. In furtherance of Section 24, the State/UT Governments, and Union Government are hereby directed to set out the financial resources allocated and or needed, to developing educational, communication and training material for spreading awareness of the provisions of this Act to the public, and formulate orientation and training programmes as elaborated in direction (viii) above. This plan of action must form part of the compliance affidavit filed by each State. The discussion in paragraph 16 is to be read along with this direction.

x. The District Officers, once nominated by the State are hereby directed to identify the non-governmental organisations working with women and their protection within the district, and take action pursuant to their duty under Section 20(b) for creation of awareness.

xi. The appropriate government or district officers in question, must also undertake effort to spread awareness on the existence of LCs, and make them approachable for the unorganized sector - thus operationalizing the horizontal import of this Act.

xii. The directions (iv) and (v) passed in Aureliano Fernandes v. State of Goa & Ors. (Judgment

Appeal No. 2482/2014.) (supra) cover specifically the direction to authorities, management and employers to familiarize the members of the ICCs and LCs of their duties and detailed step-wise manner in which an enquiry ought to be conducted on receiving a complaint of sexual harassment; conduct orientation programmes, workshops, seminars, awareness programmes, etc. and to educate women employees and women groups about the Act, Rules, and regulations are reiterated. The modules prepared by NALSA [as per direction (vi) in Aureliano Fernandes] to conduct workshops and organize

xiii. It is relevant to add here that the Ministry of Women and Child Development, Government of India, has prepared a Handbook for implementation of POSH Act [Government of India, Handbook on Sexual Harassment of Women at Workplace (2015) https://wcd.nic.in/ sites/default/files/Handbook%20on%20Sexual%20Harassment%20

It is hereby directed that a targeted effort be made to share this information with each District Officer, who may in

turn disseminate it to their respective LCs, the nodal officers appointed under Section 6(2), and employers who constitute their own ICCs.

F. Annual Compliance Reports

xiv. Due compliance with Section 21(1) and (2), and Section 22, must be undertaken by each District Officer, of the State – including collecting the reports from the IC/employers (or information where no report is available), and from the LC, and preparation of a brief report to be shared with the State government. The State/UT Governments is hereby directed to create a Standard Operating Procedure (SOP) including the procedure, and timelines for this process, so as to enable it to, in turn, comply with Section 23 of the Act, i.e., monitoring implementation and maintaining data. This direction may be read in light of the discussion contained in paragraph 18

compliance by employers xv. The directions passed in Aureliano Fernandes v. State of Goa & Ors. [Judgment dated 12.05.2023 in Civil Appeal No. 2482/2014.] (supra) address most specifically, the constitution of ICs – in public establishments [falling broadly within Section 2(o)(i)] and some private establishments - such as bodies governing professional associations, etc.; those directions are hereby reiterated, to avoid multiplicity or overlap of efforts. It is however further directed that efforts made must be in line with the scheme of the Act, and through the

for the various roles.

xvi. Similarly, directions are hereby made to hospitals, nursing homes, sports institutes, stadiums, sports complex, or competition or games venues [as defined in Section 2(o)(iii) and (iv)] to establish ICs, and report compliance as per the duties under this Act.

xvii. The District Officer must be supplied a list of establishments (compiled by the relevant departments of the State/UT Government) that fall within the scope of Section 2(o), so that they may write to them and ensure that they are well versed with the provisions relating to employers, and their duties (including constitution of ICC under Section 4, duties under Section 19, etc.) and are implementing them in letter and spirit. This will also enable collection of annual reports, as contemplated under Section 21. The consequent direction to all private sector workplaces under Section 2(o) (ii) can be passed once the District Officer is able to discern an exhaustive list of entities."

Finally, the Bench concludes by holding in para 23 that, "List this matter in the first week of February 2024, for further compliance."

In sum, the most commendable directions that have been issued by the Apex Court to check brazen and rampant sexual harassment of women in work places must be implemented promptly on a war footing. No doubt, States/ UTs must comply with the directions issued by the Apex Court in this leading judgment and comply with accordingly! No denying it!

Same Sex Marriage Judgment: Analysis

In a nation where the rich tapestry of diversity is woven into its very identity, the recent pronouncement by the Supreme Court of India on same-sex marriage has evoked a sense of missed opportunity—a lamentable instance where the scales of justice, equality, and progress seemed to tip askew. While ostensibly rooted in legal intricacies and the demarcation of legislative boundaries, the verdict reveals itself as a poignant mo-

ment in time when India, in the eyes of many, could have etched a legacy of soci-

etal transformation. The global stage unfurls a dynamic narrative of inclusivity, where numerous nations have embraced same-sex marriage as an embodiment of the universal right to love and commit-

India, with its splendid mosaic of cultures and traditions, stands at a unique juncture.

Regrettably, the Supreme Court's stance on same-sex marriage does not align with this global tide of acceptance. The reluctance to legalize

same-sex marriages appears rooted in a reluctance to overstep legislative boundaries, as the Court cites the legislature as the rightful arbitrator of such matters.

However, history teaches us that judicial intervention has often been the necessary impetus for societal change, setting in motion the pendulum of progress. By shying away from the task, the Supreme Court inadvertently leaves the LGBTQ+ community at the mercy of societal prejudices and systemic

discrimination. Notably, Chief Justice DY

Chandrachud acknowledged that an individual's right to enter into a union should remain undisturbed, unencumbered by their sexual orientation. This acknowledgment, while commendable, unfurls the verdict's profound contradiction. If the right

to unite in a loving bond is indeed a fundamental tenet. then why does the Hon'ble court, an entity sworn to uphold justice and equity, withhold this right from same-sex couples?

The 1 Advocate Dhruv Sharma, Junior Associate of Ms. Mayuri Raghuvanshi, Advocate-on-Record divergence between principle and practice casts a disconcerting shadow over the Court's dedication to safeguarding essential rights.

The judiciary's resistance to a more progressive stance becomes particularly evident in the case of adoption rights for same-sex couples. A majority of the judges on the bench opposed Chief Justice Chandrachud's

stance on allowing these couples to offer loving homes to children in need. This stark divergence represents a disheartening lapse, missing the opportunity to ensure that children, regardless of their parents' sexual orientation, are placed in environments of love and care. The belief that only heterosexual couples can serve as good parents is not only



The verdict's hesitancy to advance a more progressive stance seems to stem from a reluctance to infringe upon legislative jurisdiction. While this concern is valid, it should not act as a shield behind which the judiciary hides from pressing social issues. The judiciary has a

societal norms and address-

ing injustices, a role not to be abdicated when the cause is as just as recognizing the rights of the LGBTQ+ com-

The verdict's hesitance in addressing the essential matter of extending adoption rights to samesex couples perpetuates the discrimination these individuals face in accessing vital benefits,

including Provident Fund, pension, gratuity, and insurance. Excluding these couples from these fundamental rights reinforces the notion that they are somehow unworthy, perpetuating an injustice that remains

indefensible.

Moreover, the verdict's disapproval of a gender-neutral interpretation of the Special Marriage Act seems to undermine the very principles of equality and inclusivity that the nation should uphold. Instead of advocating for inclusivity, it expresses concerns that such an interpretation may inadvertently expose women to vulnerabilities. Such apprehensions, although understandable, should be addressed through careful legislative drafting and implementation,

not through excluding cer-

tain groups from the law's protective ambit.

This verdict represents a missed opportunity to challenge entrenched prejudices and misconceptions about the LGBTQ+ community. By adhering to societal norms that discriminate against same-sex couples, it unwittingly fosters the notion that these individuals are second-class citizens, perpetuating stereotypes and biases that linger in our society.

The argument that samesex marriage and LGBTQ+ rights are not a priority in the face of a forthcoming general election is inherentbe at the forefront of the nation's priorities, irrespective of political considerations. The recognition and protection of LGBTQ+ rights are not mere political issues; they are a matter of fundamental fairness and equality. It is the duty of a just and progressive society to ensure that all its citizens are treated with dignity and respect, regardless of their sexual orientation. In conclusion, the Supreme Court's verdict on same-sex

marriage in India represents a missed opportunity to achieve the principles of equality, justice, and inclusivity. The Israeli military said it had struck more than 100 targets across Gaza linked to the territory's Hamas rulers, including a tunnel and arms

depots. On Thursday, Israel's De-



fence Minister Yoav Gallant ordered ground troops to prepare to see Gaza "from the inside," hinting at a ground offensive aimed at crushing Gaza's militant Hamas rulers nearly two weeks after their bloody incursion into Israel. Officials have given no timetable for such an operation.

Over a million people have been displaced in Gaza, with many heeding Israel's orders to evacuate the northern part of the sealed-off coastal enclave. Gaza's overwhelmed hospitals are rationing their

by Hamas. More than 200 trucks and some 3,000 tons of aid were positioned at or near Rafah, but work has not yet begun on repairing a road on the Gaza side that was damaged by airstrikes. Israel has evacuated its own communities near Gaza and Lebanon, putting residents up in hotels elsewhere in the country in a state-funded program.

Biden said he was sending an "urgent budget request" to Congress on Friday, to cover

Amid the Israel-Gaza war, increasing anti-US protests and potential terrorist attacks, the United States has issued a worldwide caution for Americans travelling overseas. The US State Department on Thursday issued a 'worldwide caution' alert as Middle East

tensions soar. "Due to increased tensions in various locations around the world, the potential for terrorist attacks, demonstrations or violent actions against US citizens and interests, the Department of State advises US citizens overseas to exer-

cise increased caution," the

travel advisory said.

"US citizens should stay alert in locations frequented by tourists," the advisory said. The advisory also urged US citizens to enrol in the 'Smart Traveler Enrollment Programme' so that they can receive information and alerts and can be easily located in an emergency overseas. The latest conflict has been triggered by the unprecedented attacks against Israel by Hamas militants on October 7. Israel has launched a massive counteroffensive in Gaza to avenge the attacks. Protesters march to US Embassy in Indonesia over Israeli airstrikes

Protesters marched from several mosques to the heavily guarded U.S. Embassy in Indonesia's capital Friday to denounce the staunch American support for Israel and demand an end to Israeli airstrikes on the Gaza Strip.

Similar protests also took place in front of the United Nations mission, a few kilometers (miles) from the embassy, and in the compound of the Indonesian Ministry of Foreign Affairs. Authorities estimated that about 1,000 people participated in the rallies across Jakarta following Friday prayers in the world's most populous Muslimmajority nation. A brutal incursion into south

ern Israel by Hamas fighters on Oct. 7 provoked Israel to declare war against the militant group that rules Gaza. The Israeli siege of and airstrikes on the Palestinian territory were the focus earlier this week of demonstrations at Egyptian universities, inside a congressional office building in Washington, outside the Israeli Embassy in Bogota and near the U.S. Embassy in Bei-



the U.S. Embassy halted traffic along the way as they chanted "God is great," and "Save Palestinians." Waving Indonesian and Palestinian flags and signs read "We are proud to support Palestine," more than 100 noisy demonstrators gathered along a major street in Jakarta that runs outside the embassy.

"The U.S. actually know this war and violence occurred because Palestinians want free from Israel's occupation, but

they close their eyes and pretend to be deaf," a speaker told the crowd, "We call for a twostate solution for Palestinians to end the war." Some protesters voiced their anger by burning portraits of U.S. President Joe Biden and Israeli Prime Minister Benjamin Netanyahu.

About 1,000 police office were deployed around the embassy, the nearby presidential palace and the U.N. mission. Indonesia does not have formal diplomatic relations with Israel, and there is no Israeli Embassy in the country. It has long been a strong supporter of the Palestinians.

In a statement posted on social media, Meloni said her relationship with Andrea Giambruno had ended. She said their paths had diverged "for some time." The announcement came after Giambruno, an on-air television personality, was caught on audio seemingly making lewd remarks to colleagues.

Ex-PM Nawaz Sharif reaches Dubai before heading to Islamabad today

Former Pakistan Prime Minister Nawaz Sharif has arrived in the UAE to meet a select group of people a day ahead of his return to Pakistan without the fear of immediate arrest upon landing, according to a media report on Friday.

Sharif, also the Pakistan Muslim League-Nawaz (PML-N) supremo, landed in Dubai late on Thursday night and is expected to return to Pakistan on a chartered flight, ending a selfimposed four-year exile in London, Geo News reported. In Pakistan, the Islamabad High Court on Thursday provided temporary relief to Sharif as it granted the 73-year-old former prime minister a protective bail in the Avenfield and Al-Azizia corruption cases until October 24. An anti-corruption court also suspended his arrest warrant in the

"His (Sharif's) arrival comes after a few hours of delay as he was held up in Jeddah, Saudi Arabia, for an important meeting. He was given 'special protocol' on arrival at the Dubai airport," Geo News said, quot-

"Nawaz will be meeting a selected group of people during his two-day stay in Dubai and will leave for Pakistan on Saturday morning - first to Islamabad and then to Lahore," it said.

The report also said that Sharif would be returning to Pakistan in a chartered plane along with 150 people. Sharif was on a self-imposed exile in the United Kingdom after jumping bail in 2020. The three-term Pakistan prime minister was serving a seven-year jail term when the Islamabad High Court suspended his sentence in 2019 for eight weeks to allow him to go abroad to seek medical treatment. But he never came back. Sharif's return to Pakistan

on Saturday is declared by his party as his effort to lead the party's campaign for the general election expected in the last week of January 2024.He stepped down as Pakistan's prime minister in 2017 after he was disqualified for life from holding public office by the Supreme Court after a probe into his family's wealth following the 2016 Panama Papers leak. Sharif has consistently denied any wrongdoing and termed it as a politically motivated case.

It posted further that Israeli PM Netanyahu told the Russian President that the Israeli forces won't relent till they "eliminate Hamas".

"The Prime Minister made it clear that Israel had been attacked by brutal and abhorrent murderers, had gone to war determined and united, and would not stop until it had destroyed Hamas's military and governing capabilities," the Israeli PM's office posted further.

According to the Russian Foreign Ministry, during their telephone conversation, Putin highlighted the measures Russia is taking to stop the bloodshed in the Gaza Strip from escalating further."President of Russia Vladimir *Putin spoke with Prime Minister of the State of Israel @netanyahu over the phone," the Ministry of Foreign Affairs of Russia posted on X.

"President Putin laid out the steps being taken by Russia to prevent the further escalation of violence in the Gaza Strip," it added.

Moscow said the conversation was centred on "the crisis situation resulting from the brutal escalation of the Israeli-Palestinian conflict"." The Israeli side was in particular informed of the essential points of telephone correspondences that took place today with the leaders of Palestine, Egypt, Iran and Syria," the Kremlin said in a statement. The Russian

President also expressed "his sincere condolences to the families and friends of the deceased Israelis", the Kremlin said. 🔁 ritish Prime Minister Rishi Sunak's governing Conservative Party suffered huge losses in two by-elections on Friday, losing to the Opposition Labour Party, which overturned a sizeable Tory majority in the seats of Mid Bedfordshire and Tamworth in England. While Sunak is touring the Middle East for crisis talks over the Israel-Gaza conflict, Labour leader Keir Starmer declared that his party was "redrawing the political map." Labour made history in Mid Bedfordshire by overcoming a 24,664 Tory majority to win the seat for the first time and pulled off a 23.9 per cent swing to Labour from the Tories in Tamworth.

"Winning in these Tory strongholds shows that people overwhelmingly want change and they're ready to put their faith in our changed Labour Party to deliver it," said Starmer.

The historic results mark the second-highest-ever by-election swing to Labour. With the Tories also trailing in the nationwide opinion polls, the results will be a welcome boost to Labour ahead of an expected general election in 2024. Conserva-

AUSTRALIA KEEPS CHINESE COMPANY'S STRATEGIC PORT LEASE, DEFYING CANCELLATION

CANBERRA

The Australian government announced Friday it has decided not to cancel a Chinese company's 99-year lease on strategically important Darwin Port despite U.S. concerns that the foreign control could be used to spy on its military forces.

The Department of Prime Minister and Cabinet said it decided after an investigation of the eight-year-old lease that current monitoring and regulation measures are sufficient to manage security risks for critical infrastructure such as the port in the northern garrison city of Darwin.

"Australians can have confidence that their safety will not be compromised while ensuring that Australia remains a competitive destination for foreign investment," it said in a statement.

Landbridge Industry Australia, a subsidiary of Rizhao-based Shandong Landbridge Group, signed

the lease with the debtladen Northern Territory government in 2015. That was three years after U.S. Marines began annual rotations through Darwin as

The Australian decision comes before Albanese flies to Washington, D.C., next week to meet President Joe Biden. Albanese also plans to soon become the first Australian prime minister to visit China in seven years. Neil James, chief executive of the Australian Defense Association think tank, said regulation cannot solve the security risk posed by Chinese control of the port.

"Our problem is going to be if there's ever any increased strategic tension with China and if we have to do something, even if it's regulatory, it's going to be escalatory and make the tension worse," James said.

"The only way to avoid this problem is not to have the lease in the first place and they should bite the bullet and get rid of it," James added. Middle East crisis stirs oil supply concerns, gas queues unlikely

Fifty years after the 1973 Araboil embargo, the current crisis in the Middle East has the potential to disrupt global oil supplies and push prices higher. But don't expect a repeat of the catastrophic price hikes and long lines at the gasoline pump, experts say.

The Israel-Hamas war is "definitely not good news" for oil markets already stretched by cutbacks in oil production from Saudi Arabia and Russia and expected stronger demand from China, the head of the International Energy Agency said. International benchmark Brent crude

traded above \$91 a barrel on Thursday, up from \$85 per barrel on Oct. 6, the day before Hamas attacked Israel, killing hundreds of civilians. Israel immediately launched airstrikes on Gaza, destroying entire neighborhoods and killing hundreds of Palestinian civilians in the days that have followed.Fluctuations since the attack pushed oil prices as high as \$96. One worry is that the fighting could lead to complications with Iran, home of some of the world's largest oil re $serves. \, Its \, crude \, production \,$ has been constrained by international sanctions, but oil

As space around our planet becomes increasingly congested, ensuring the safe navigation of thousands of satellites and space debris fragments gains paramount importance. This necessity has given rise to the field of space domain awareness, which focuses on monitoring and managing satellites and space debris in Earth's three primary orbital regions, signifying the growing significance of space traffic management in our modern world. Currently, there are over 8,700 active sat-

ellites in various Earth orbits. Understanding the intricacies of space debris involves recognizing the three primary satellite orbits. Low Earth orbit, the most common, hosts at least 5,900 active satellites positioned up to 1,000km above Earth's surface, constantly in mo-

tion. Notably, the International Space Station orbits in this region, completing 16 circuits around Earth each day. Moving higher, we encounter medium Earth orbit, situated between 10,000 and 20,000km above Earth. Although less crowded, it accommodates critical satellites like those powering the Global Positioning System (GPS). These varying orbits play a pivotal role in satellite functionality and the challenges of managing space debris.

How do we track them all? This is where space domain awareness comes in. It is the field of detecting, tracking and monitoring objects in Earth's orbit, including active satellites and space debris.

We do much of this with ground-based tracking, either through radar or optical systems like telescopes. While radar can easily track objects in low Earth orbit, higher up we need optical sensors.



Sheeran's performance in Mumbai will be the final




stop in the Asia Tour and also feature a guest, singersongwriter Calum Scott.




their own mood as well as the

And the mind is weakened by unnecessary and negative thoughts that are influenced by any vice, be it anger, ego, or greed. The mind can be made powerful by some simple practices. When we wake up in the morning, we can create certain thoughts every day, such as, 'I am powerful... I am a child of God, the Almighty... Being His child, I too am like Him... powerful, peaceful, and stable...' Regularly practicing this awakens the latent powers of the soul, and then we will find that we do not get upset, afraid, or angry very easily.

The biggest source of strength for the soul is God. We can connect with Him simply by remembering Him. 

WORLD CUP 2023: INDIA TRIUMPHS AGAINST BANGLADESH WITH KOHLI'S CENTURY

India's World Cup 2023 journey continued on a triumphant note as they clinched their fourth consecutive victory, defeating Bangladesh by seven wickets at Pune's MCA ground. The match was characterized by record-breaking moments and exceptional displays of skill.

Virat Kohli's unbeaten century, his 48th in ODIs, was the focal point of the match. Notably, he achieved the impressive milestone of 26,000 international runs in just 567 innings, surpassing Sachin Tendulkar's record of 600 innings. Batting first after winning the toss, Bangladesh posted 256 runs for the loss of eight wickets during their 50 overs. Despite some bright moments, India's bowlers effectively contained them.

This match marked a historical note as it was the first ODI between India and Bangladesh on Indian soil in almost 25 years. Notably, the last time these two teams met in India was in May 1998, a match that featured current chief coach Rahul Dravid and bowling coach Paras Mhambrey in the Team India XI.
