INDIA TO APPROACH FATF WITH NEW **EVIDENCE OF PAK TERROR CAMPS**

Sources say that a high-level meeting of security and diplomatic officials took place in New Delhi on Sunday to discuss the security situation in the region.

ndia is gearing up to approach the Financial Action Task Force (FATF) and other international forums including the United Nations with a "fresh set of evidence" on terror infrastructure in territory under the control of both Pakistan and Afghanistan. The diplomatic and security officials from New Delhi will share "hard facts" with the Parisbased terrorism financing watchdog and global community, detailing how terror groups such as Jaish-e-Mohammed (JeM) and Lashkar-e-Taiba (LeT) are maintaining their training camps in Pakistan and some provinces of Afghanistan, sources told The Daily Guardian. "The evidence collected by our security agencies over the past few months are sufficient to establish that the terror camps have the backing of the governments in Pakistan and Afghanistan," sources said, adding, "India is getting cooperation from the US administration and its intelligence agencies in this mission."

American diplomats would be working in close coordination with their Indian counterparts at FATF and the UN to ensure that the global forums mount pressure on Pakistan and Afghanistan to dismantle



the terror camps immediately, sources said. US Ambassador to India, Eric Garcetti's statement reaffirming Washington's commitment to fight alongside New Delhi against the menace of terrorism assumes significance in this context. He made this statement after paying tributes to the victims at the US Consulate

niversary of the 26/11 terror attacks on Sunday. Sources told this newspaper that a high-level meeting of security and diplomatic officials took place in New Delhi on Sunday, during which they reviewed the security situation in the region with focus on the growing activities of the terror camps in Pakistan and Afghanistan. According to sources, a couple of more meetings will be held to give the final shape to the dossier of evidence on terrorists being sent by Pakistan to the Indian region. The experts in security and diplomatic establishments have scanned the evidence gathered by Indian intel-

ligence and security agencies. Some satellite images have also been collected by the experts showing terror camps operating on Pakistan soil, sources said.

Indian security agencies have collected a huge amount of evidence from the terrorists who have been eliminated in certain areas of Jammu and Kashmir over the past few months. Only three days ago, a top LeT commander and his associate were killed in an encounter in Jammu and Kashmir's Rajouri. Identified by the codename Qari, he had been active in the Rajouri-Poonch region with his group for the past one year. Sources

S&P raises India's FY24 growth projection to 6.4%

Endorsing the Government and Indian policymakers' confidence in the resilience of the Indian economy, S&P Global Ratings, on Monday, revised India's growth forecast for the financial year 2023-24 (ending in March 2024) upward to 6.4% from 6% projected earlier, with robust domestic momentum appearing to have offset headwinds from high food inflation and weak exports. This is in sync with RBI's estimate of 6.5%. The US rating agency's "Economic Outlook Asia-Pacific Q12024: Emerging Markets Lead The Way", suggests that India's growth, with its solid domestic demand like other Asia-Pacific emerging market economies as Indonesia, Malaysia, and the

country's property weakness continuing to weigh on the economy and the latter projection of 2024 aligning with the S&P estimate of economic slack persisting next year. The expectation for developed economies is one of lowest growth, especially for those exposed to the weak global trade conditions like South Korea, Taiwan, Singapore, or where the central bank has raised interest rates a lot to fight inflation as in the case of Australia and New Zealand. Even then, 2023 GDP growth is likely to exceed 1% in all Asia-Pacific economies and S&P projects a modest pick-up in growth in 2024, due to a gradual improvement in external demand and some monetary policy easing. The manual horizontal drilling of the tunnel at Silkyara, Uttarakhand, where 41 tunnel workers have been trapped for more than two weeks, started on Monday evening. It started after the US-made Auger drill broke down once again, with its blades getting destroyed by the iron grill on the tunnel ceiling. The manual drilling is being conducted primarily by "rat hole miners", with the assistance of the Indian

name from digging rat hole sized tunnels to extract coal. Meanwhile, on the second day of vertical drilling on top of the Silkyara-Barkot tunnel, around 36 metres were drilled, with another 50 metres to go to reach the trapped tunnel workers.

SC TO HEAR DMK MINISTER V SENTHIL BALAJI'S PLEA TODAY

he Supreme Court on Tuesday will hear a Plea filed by DMK minister V Senthil Balaji challenging a Madras High Court order that dismissed his bail plea on 19 October, citing concerns that he might influence witnesses if released on bail.

Earlier the top court had directed DMK Minister V Senthil Balaji, arrested by the Enforcement Directorate (ED) in a money laundering case, to submit his latest medical reports for examination.

The Madras high court, while dismissing the bail plea, remarked that based on Balaji's health report, it did not appear to be a medical condition that could only be addressed if he were released on bail. The high court also cited Balaji's past conduct, his current position as a minister without portfolio, the abscondence of his brother Ashok Kumar, and an alleged attack on Income Tax Officials by Balaji's supporters during earlier searches as reasons for its decision.

Balaji was arrested on June 14 by the ED in connection with a money laundering case related to a cash-for-jobs scam that occurred when he was the Transport Minister in a previous AIADMK regime.

CITIZENSHIP AMENDMENT ACT

Union Min informs CAA rules by March 30; TMC calls it electoral gimmick

While the Union Minister of State for Home Affairs, Ajay Kumar Mishra, has claimed that the rules for the Citizenship Amendment Act (CAA) will be framed by the Centre by March 30, 2024, the Trinamool Congress has brushed it off as just another electoral gimmick before the 2024 Lok Sabha elections.

Mishra made the announcement while attending a festival of the Dalit Matua community that has been demanding it for long. He told the large crowd that had gathered for the annual Ras Utsav at Thakurnagar in West Bengal's North 24-Parganas district.

"I am assuring that members of the Matua community will not lose their citizenship. They are all safe. According to the latest information I have, the laws for CAA will be framed by March 30, 2024," Mishra said. The Centre had earlier said that it was in the process of framing laws for the CAA.

During his 2021 election campaign at Thakurnagar, Union Home Minister Amit Shah had announced that the Centre would enforce CAA once Covid-19 vaccination across the country was over.

However, the BJP has not spoken on this issue since then and it suffered a setback in the Bengal panchayat polls earlier this year.

Passed by Parliament in 2020, CAA offers citizenship to religious minorities who entered India from Afghanistan, Pakistan and Bangladesh before 2015. The Trinamool Congress (TMC) insists that CAA is unconstitutional saying that it excludes Muslims and links citizenship to faith in a secular country.

The Matuas are a part of the large Dalit Namasudra community that migrated from East Pakistan (now Bangladesh) during India's partition in 1947 and the 1971 Bangladesh Liberation War to escape religious persecution.

Located close to the Bangladesh border, Thakurnagar town has the headquarters of the All India Matua Mahasangha of which BJP leader and Union Minister of State for Shipping, Shantanu Thakur, is the president.

Thakur was present on the dais when Mishra made the announcement on Sunday afternoon. Since 2019, Thakur represents the Bongaon Lok Sabha seat which was earlier won by his aunt and TMC leader Mamata Bala Thakur.

Implementation of the CAA has been the principal demand of the Matuas. Shantanu Thakur, too, has raised it on several occasions.

Support of the Matua and other Dalit communities helped BJP win several seats in the 2019 Lok Sabha and 2021 State polls.

Shantanu Thakur was made a Minister of State during the Union Cabinet reshuffle in 2021. This was seen as a move by the BJP central leadership to keep the Matuas happy. Thakur even accompanied Prime Minister Narendra Modi to Bangladesh on the eve of the 2021 Assembly polls. Modi offered prayers at the Matua temple at Orakandi near Dhaka and praised Thakur in his speech, triggering a sharp reaction from Chief Minister Mamata Banerjee.

Reacting to Mishra's announcement, TMC leaders said BJP is once again raising the citizenship issue in Bengal with an eye on the coming

The BJP won 18 of Bengal's 42 Lok Sabha seats in 2019.

Lok Sabha polls.

TMC Rajya Sabha member Santanu Sen said: "CAA is a thorn for the BJP. During the 2021 Assembly polls, BJP did not even mention CAA in Assam but raised it in Bengal hoping to capture votes. In Gujarat, on the other hand, attempts are being made to enforce CAA in some districts. Bengal's Matuas have understood the trick."

"Mamata Banerjee has said several times that Bengal does not need CAA because those people have been casting their votes, owning property and having jobs for decades, and are already citizens. They do not need fresh citizenship certificates from the Centre," Sen added.

KCR EYES THIRD TERM, CONGRESS **KEEN TO WREST POWER**

As campaigning for election in Telangana entered the last 24 hours on Monday the key parties, including the ruling BRS, put in all their resources to attract voters with promises ranging from welfare schemes that include farm loan waivers, higher pensions, loans for backward classes and more government jobs. Voting on Thursday would mark the culmination of balloting process in five states whose result will be declared on 3 December, setting the tone for fresh strategies and realignments for the 2024 Lok

The result on 3 December will also determine the path that K Chandrasekhar Rao controlled BRS shall play in an anti-BJP grouping. If KCR decides to focus on national politics in 2024, his son K rabi crops under the Rythu T Rama Rao is expected to handle affairs in the state.

With the election in Telangana being a direct fight between the ruling BRS and the Congress, the BJP, as the third player, is seeing itself in a position to disturb the apple cart of both the main rivals.

The BJP's vote share has been on the rise in the state from 6.98 per cent in the 2018 assembly election to 19.65 per

cent in the 2019 Lok Sabha elections. The more the number of seats that the BIP manages to win in the current election, the more the chance of the contest yielding a hung assembly.

The BJP had won just one seat in Telangana assembly in 2018 but since then it has managed to spread its network in the state. The BJP won four Lok Sabha seats in the state in 2019.

The 3.17 crore voters in the state will vote on Thursday in 119 seats, out of which 31 are reserved for SC/ST candidates. According to the Election Commission 1.2 lakh polling centres have been identified as critical.

Meanwhile on the penultimate day of campaigning, the ruling BRS received a setback with the EC withdrawing permission to Telangana government for disbursements of financial aid to farmers for Bandhu Scheme after state minister T. Harish Rao violated the poll code by making a public announcement

The poll body, in a notification, said that there shall be no disbursement under the scheme till the model code of conduct in the state of Telangana ceases to apply.

Apart from the Kamareddy seat in North Telangana where a prestige battle is unfolding between the Chief Minister K Chandrasekhar Rao or KCR and Congress's Revanth Reddy, a key contest is lined up in Sircilla constituency where KT Rama Rao, son of Telangana CM and working president of BRS, is contesting for the fourth

KTR owes his electoral success to the weavers' community called 'Padmashalis', who are dominant in Sircilla constituency.

While there are signs of discontent among a section of young voters over lack of job opportunities, KTR's connection with the electors is likely to help him emerge as a winner this time as well.

Though the issue of suicides among weavers appears to have died down, the community still has high expectations from the Bathukamma Saree scheme the was launched in 2017 with the goal to support the weavers. The weavers claim that at present they get employment under the scheme for just three months in a year. They want the scheme to benefit

them through the year. Congress leaders alleged the youth are not happy with the ruling party for not keeping its word on poll promises. For example, despite making a promise of providing

12 lakh jobs the ruling party managed to provide only 12,000-13000 jobs in the state in the last nine years, alleged a Congress leader.

KTR, the political heir of

KCR's legacy, is also looking to consolidate his position as the CM-in-waiting with his fourth straight win from the constituency. KTR began his political career in 2009 when he contested the Andhra Pradesh Legislative Assembly Elections from the Sircilla Assembly constituency. He won by a close margin of 171 votes, defeating independent candidate K. K. Mahender Reddy.

In 2014, KTR defeated Congress candidate Konduru Ravinder Rao with a massive margin of over 53,000 votes. In 2018, he won in Sircilla for the third consecutive time with a margin of over 89,000 votes. In this constituency, there are a total of 1,84,427 voters, which includes 91,139 male voters, and 93,275 female voters. In the 2018 Telangana assembly elections, Sircilla recorded a voter turnout of 80.57%. In 2014 the turnout was 73.62%.

Sircilla constituency is part of the Karimnagar Lok Sabha constituency. Sircilla comes under Rajanna Sircilla district and the North Telangana region of Telangana. It is categorised as a rural seat.

EC revokes permission to disburse aid from Telangana govt

In a strong statement, the Election Commission announced on Monday the revocation of permission granted to the Telangana government for the distribution of financial aid to farmers for rabi crops under the Rythu Bandhu Scheme.

This decision was made after a state minister violated the provisions of the model code by publicly announcing the disbursement. Despite initially approving the state government's request to distribute the rabi instalment during the model code of conduct period, the poll panel took this action based on specific conditions.

The state was asked not to publicise the disbursement during the poll code as part of the condition.

BENGAL BJP ALLEGES RS 5,000-CR COVID SCAM BY MAMATA GOVT

The Leader of Opposition in the West Bengal Assembly, Suvendu Adhikari, has written to the Enforcement Directorate (ED), alleging that the Health Ministry in West Bengal, headed by Chief Minister Mamata Banerjee, perpetrated a scam in the purchase of PPE kits and other medical equipment during the Covid-19 pandemic in 2020 and 2021. In his threepage complaint, Suvendu Adhikari alleged that the total corruption amounted to Rs 5,000 since a PPE kit chased for Rs 1200. He also named some bureaucrats who were allegedly involved

Taking to his official handle on social media platform X, Adhikari shared a detailed post informing that he had written to the director, ED, principal director general of the Income Tax Department and secretary, Union Ministry of Health & Family Welfare, seeking an inquiry into the alleged irregularities in the purchase of Personal Protective Equipment (PPE) kits. "A huge financial scam was

executed in WB during the Covid Pandemic period, with regard to the purchase of PPE kits and other medical equipment by the WB Health Department. Huge funds were provided by the Central Govt at that time to bolster the efforts to fight against the virus collectively," Adhikari posted from his official X handle. He wrote that considering the urgency of the situation, no stringent measures were placed which could have delayed the procurement process. "The Central Government allowed the State Governments to act swiftly in good faith and this was misused by the ruling Trinamool Congress Government in the State," he said. He alleged: "The corrupt WB Govt saw this as a clear opportunity to siphon funds and hundreds of crores were stolen.

Congress leader, Priyanka Gandhi Vadra attacked the government led by Chief Minister K Chandrasekhar Rao, asserting that influential figures in the BRS are orchestrating governance from farmhouses.

She claimed that under this regime, the wealth gap is widening, with the poor getting poorer while the ruling party grows richer. Speaking at a campaign rally in Bhongir, approximately 50 km away, she alleged that if the BRS returns to power, the government will be run from a "farmhouse," allowing the liquor mafia to dominate the state, with a lack of employment opportunities

She alleged that all "big" leaders in the BRS are sitting in farmhouses and running the government, and the poor are becoming poorer while the ruling party is becoming richer.

Addressing a poll rally at Bhongir, she alleged that if the BRS is voted to power again, the government will run from "farmhouse" and the land liquor mafia will rule the state, while there will not be any employment opportunities available.

"Big leaders of Telangana are sitting in their mansions and farmhouses and running the government... All its (BRS) leaders are sitting in big mansions. All their policies are for big business people only. They do not have anything for the small business people, middle class, poor, Dalits and Adivasis," she said.

According to her, all government employees across the country are urging the implementation of the old pension scheme, yet the Centre maintains that it lacks the funds to fulfill this

DELHI COURT PERMITS K'TAKA DEPUTY CM SHIVAKUMAR TO TRAVEL ABROAD

A Delhi court has granted permission to Karnataka Deputy Chief Minister D K Shivakumar, an accused in a money laundering case, to travel abroad. Special Judge Vikas Dhull approved Congress member Shivakumar's trip to Dubai from 29 November to 3 December based on his application.

The application stated that he had been invited to attend the upcoming COP28 Local Climate Action Summit in Dubai by His Excellency Dr Sultan Ahmed Al Jaber, COP28 President-Designate, and Michael R Bloomberg, the United Nations Secretary-General's Special **Envoy on Climate Ambition**

and Solution. The judge, noting that the accused is an eight-time MLA and the current Deputy Chief Minister of Karnataka, considered the possibility of him fleeing from India as quite remote

The judge imposed several conditions, including furnishing a Fixed Deposit Receipt (FDR) of Rs 5 lakh before the court, submitting a complete travel itinerary, and refraining from contacting co-accused or influencing witnesses while abroad. The application asserted

that the investigation was complete, a prosecution complaint had been filed, and the applicant had no criminal antecedents.

The Enforcement Directorate (ED) opposed the application, alleging Shivakumar's involvement in a criminal conspiracy to move tainted cash and conceal its

Shivakumar was booked under the Prevention of Money Laundering Act based on a charge sheet filed by the Income Tax Department in 2018, accusing him and his associate SK Sharma of engaging in transactions involving large amounts of unaccounted-for money through "hawala" channels.

DJB contractors association launchesstrike from Monday

The Delhi Jal Board contractors association went on a strike on Monday over non-payment of dues, its general secretary Vinay Mangla said and claimed that around 1,150 contractors will halt their work until payments are made to evervone.

"It is an open-ended strike, and we are expecting it to go on for a week," he said.

The Delhi Jal Board Contractors Welfare Association had written to the additional chief engineer, mentioning that the $contractors\ would\ stop\ all$ ongoing work due to nonpayment of funds.

"After detailed deliberations and finding no option,

that all ongoing works related to water leakages, water contamination, maintenance of water supply, settled sewerage system, maintenance of sewerage system, operation of tube wells and pumping stations, providing sewer beldars, engagement of labours and de-silting work will be

stopped from November

27," the letter read. The decision was taken following a meeting of the association on November 23 over dues pending since February. The association said the works will be taken up only on receipt of dues by all contractors concerned. DJB Vice-Chairman Somnath Bharti said the Delhi government has been doing

everything possible to en-

sure the release of funds for the board for the last three months.

"The water minister has repeatedly directed the finance department regarding the same and even wrote to the L-G to ensure this. Despite repeated directions from the finance minister, the finance department has not released funds for the last three months.

They keep on raising different queries and objections to delay the release of funds," he said. Earlier, Delhi Water Minister Atishi claimed the city was staring at a "man-made water crisis" due to the stoppage of funds to the Delhi Jal Board by the finance department and demanded Lt Governor V K Saxena's immediate intervention in the matter.

DELHI-NCR FACES SEVERE AIR QUALITY CRISIS, WITH AN AQI EXCEEDING 400

The air quality in Delhi and the NCR region has remained distressingly poor over the past month, with many areas reporting an Air Quality Index (AQI) exceeding 400 on Monday morn-

The deteriorating pollution levels have made breathing increasingly challenging for residents, with a slight improvement noticed over the weekend quickly reversing as pollution soared back to the 'severe' category on Monday.

Alarming AQI Levels Recorded

According to the Central Pollution Control Board, the AQI stood at 402 in Anand Vihar, 419 in RK Puram, 437 in Punjabi Bagh, and 435 in ITO at 7 am on Monday. Other areas also registered high pollution levels: Indira Gandhi Airport at 376, Lodhi Road at 347, Rohini at 422, Okhla at 413, Alipore at 417, and DU North Campus at 424, all falling within the 'serious' category.

Hope Amidst Weather

The Meteorological Department predicts partly cloudy skies on Monday with the possibility of light rain and drizzle in various areas. Delhiites are eagerly anticipating relief from pollution due to the anticipated rainfall, which may also bring a drop in temperature by up to four degrees Celsius. Police nabs two sharpshooters linked to Arshdeep Singh after gun battle

Two sharpshooters of international gangster Arshdeep Singh's gang have been arrested following a brief exchange of fire with police near Mayur Vihar in east Delhi, officials said on Monday.

According to them, the arrested accused have been identified as Rajpreet Singh (25), and Virender Singh (22) and they were planning to kill Punjabi singer Elly Mangat.

"During the encounter, five rounds of bullet were proof jacket of a police "In retaliation, the po-

lice team fired six rounds. During this exchange of fire, one of the accused, Virender Singh, sustained a gunshot injury on his right leg," a senior police officer said, adding that both accused were sent to LBS hospital for treatment after the encounter.

Two revolvers, 13 live cartridges, a hand grenade, and a stolen motorcycle were seized from them, police said. An FIR for an attempt to murder has been registered under the Explosive Substances Act and the Arms Act against the accused.

"Based on the disclosure made by the accused, a raid was conducted at Dairy Skaner in Gautam Buddh Nagar, Uttar Pradesh and another associate, identified as Sachin Bhati, suspected to be having a huge cache of arms, was apprehended," police said in a statement.

The senior police officer said that during interrogation, the accused admitted that they were tasked by Arshdeep Singh to kill singer Elly Mangat.

ASSESSING SUBRAT PATHAK'S PERFORMANCE AS KANNAUJ'S MP



SURGE IN MILK, EGG, AND MEAT PRODUCTION IN INDIA

Production of milk, egg and meat has significantly increased in 2022-23 over the past five years, though wool output during the same period has witnessed a negative growth, says a report released by Union minister Parshottam Rupala here.

The Basic Animal Husbandry Statistics 2023 report, which was released by the Union Minister for Fisheries, Animal Husbandry and Dairying during National Milk Day event here, is based on the Animal Integrated Sample Survey (March 2022 to February 2023).

The survey is conducted across the country in three seasons, summer (March-June), monsoon (July-October) and winter (November-February).


The country's total milk production is estimated at 230.58 million tonnes in 2022-23, registering a growth of 22.81 per cent compared to the figures of 2018-19 when the output was 187.75 million tonnes.


According to the report. the production increased by 3.83 per cent in 2022-23 over the estimates of 2021-22. The annual growth rates in the past few years were 6.47 per cent in 2018-19, 5.69 per cent in 2019-20, 5.81 per cent in 2020-21 and 5.77 per cent in 2021-22

The top milk-producing state in 2022-23 was Uttar Pradesh with a share of 15.72 per cent, followed by Rajasthan (14.44 per cent), Madhya Pradesh (8.73 per cent), Gujarat (7.49 per cent) and Andhra Pradesh (6.70 per cent).

In terms of annual growth rate (AGR), Karnataka with 8.76 per cent topped the list, followed by West Bengal (8.65 per cent) and Uttar Pradesh (6.99 per cent) over the previous year.

More than 2.5 lakh staff will be engaged in poll duties for the November 30 Telangana assembly polls, Chief Electoral officer Vikas Raj has said. He said out of 1,68,612 postal ballots issued, 96,526 have been polled till November 26.

"Almost definitely not less than 2.5 lakh people will be making this (poll) arrangement. When it comes to police, 45,000 Telangana police will be deployed. A total of 23,500 Home Guards were sought from neighbouring states. They are expected in a day or two,"

S&P raises India's FY24 growth projection to 6.4%

CONTINUED FROM P1 is poised to grow by 4.2% in

2024 and 4.4% in 2025, compared to 4.1% in 2023.

Going ahead, for India, S&P expects growth to slow in the second half of the fiscal year as subdued global growth, a higher base and the lagged impact of rate hikes weigh down on the country, bringing down S&P's estimate of FY25 growth by 0.5 percentage points to 6.4% from 6.9%. The Indian economy though would bounce back to 7% growth in FY26 and FY27.

According to the S&P report, with core inflation continuing to ease, the region's central banks are unlikely to have to tighten monetary policy again. Still,

given the pressure from higher-for-longer US interest rates, any meaningful falls in policy rates for the next six months can be ruled out.

The robust labour markets and service sectors, as in India's case, have buoved growth. The services sector PMI has fallen in Japan and Australia, but it remained above 50 in Japan. The S&P Global purchasing managers' indices (PMIs) suggest Asia-Pacific economies have generally continued to expand. While India's manufacturing gauge eased, at above 55 it remained strong as emerging market economies gained support from the post-pandemic resumption of the earlier robust domestic demand trend. In October, manufacturing PMIs remained below 50 in developed economies, although they have risen in South Korea and Taiwan, reflecting stronger activity in the semiconductor industry. In Southeast Asia, the manufacturing PMI mostly exceeded 50 in October, including in the Philippines, where it has jumped since September. Only in Malaysia it remained below 50.

The composition of the recovery after the pandemic slump differs across the region, shows S&P data. With the exceptions of Hong Kong, and Thailand, GDP exceeded the 2019 level by between 0.1% in Japan and 15.5% in India, in the first half of 2023.


In Northeast Asia, India, Australia, and New Zealand, fixed investment has recovered considerably more than private consumer spending. In Northeast Asia, this is partly because high-tech firms such as semiconductor producers are making large investments. On the other hand, in all Southeast Asia economies, the fixed asset investment recovery has lagged that in consumption.

In India, observes S&P, there was a transitory spike in food inflation in the July-September quarter, but it appears to have had little effect on underlying inflation dynamics. Still, headline inflation remains above the Reserve Bank of India's (RBI's) target of 4%, suggesting it will be a while before the rate cycle turns.

The rating agency expects policy rates in the region (excluding Japan) to fall later in the fiscal ending March 2024, by between 100 bps in India and 25 bps in Taiwan and Thailand. In Australia, India, and the Philippines, lingering inflation risks are keeping central banks occupied. Key risks to growth stem from possibly slower growth in the West and China as well as unexpected increases in inflation in the US which may force policy rates there to be even higher for longer thus exacerbating the pressure on Asian currencies and markets. Risks remain but so does the potential for growth in the region. In coming months, the spotlight may shine a little more brightly on emerging markets where domestic demand is strong.

The TDP chief recently underwent cataract surgery at L V Prasad Hospital in Hvderabad. He was arrested on September 9 and released on interim medical bail on October 31, which is now made regular.

20 killed In Lightning strikes amid unseasonal rains in Gujarat

A devastating toll of twenty lives has been reported due to lightning strikes across different regions of Gujarat amid unexpected and widespread rainfall on Monday, according to reports. An official from the State Emergency Operation Centre (SEOC) confirmed a total of 20 rain-related fatalities scattered across Gujarat. The casualties were attributed to lightning strikes

during the unseasonal rainfall that battered the state on Sunday.

According to SEOC, the affected districts included Dahod, Bharuch, Tapi, Ahmedabad, Amreli, Banaskantha, Botad, Kheda, Mehsana, Panchmahal, Sabarkantha, Surat, Surendranagar, and Devbhumi Dwarka. Expressing grief, Union Home Minister Amit Shah extended condolences for the lives lost due to adverse weather conditions

and lightning strikes in

various cities of Gujarat on Sunday. He emphasized the ongoing relief work conducted by the local administration.

In a statement issued on Sunday night, Union Minister Amit Shah expressed deep sorrow, saying, "I am deeply saddened by the news of the death of many people due to bad weather and lightning in various cities of Gujarat.

I express my deepest condolences for the irreparable loss to those who lost their loved ones in this tragedy. The local administration is engaged in relief work, praying for the speedy recovery of the injured."

The India Meteorological Department (IMD) anticipates a reduction in rain activity on Monday. SEOC data revealed that 234 out of 252 talukas in Gujarat experienced rainfall on Sunday, with several districts recording significant rainfall of 50-117 mm in 16 hours, disrupting normal life and causing crop damage.

Hailstorms in Rajkot and disruptions in the ceramic industry of Morbi district added to the challenges. IMD's Ahmedabad centre director, Manorama Mohanty, assured that the rains would subside on Monday, focusing on some parts of south Gujarat and Saurashtra districts.

NBFCs anticipate 14-17% asset growth; RBI emphasizes better liability management

Even as Reserve Bank of India Governor Shaktikanta Das advised non banking financial companies (NBFCs) to further strengthen their asset liability management and avoid all forms of exuberance regarding credit growth at the overall, sectoral and sub-sectoral levels, the assets under management (AUM) of NBFCs are set to log a healthy 14-17 per cent growth next fiscal on the back of continued strong credit demand across retail loan segments. Retail credit growth continues to be driven by sound underlying macro and micro factors. The two largest traditional segments of home loans and vehicle finance now comprise 25-27 per cent each of the NBFC AUM. Both segments are expected to report steady growth. In the home loan segment, growth of 12-14 per cent next fiscal will be driven by HFCs' focus on affordable home loans (ticket sizes of less than Rs 25 lakh), while vehicle finance is expected to grow 18-19 per cent this fiscal and sustain 17-18 per cent growth next fiscal on the back of solid underlying-asset sales.

AUMs may be moderately lower than 16-18 per cent expected in the current fiscal because unsecured retail loans -- the fastest growing segment in the AUM pie of the NBFCs so far -- are likely to see a relatively slower growth as these financial entities recalibrate their strategies due to the recent regulatory measures issued by the RBI, finds CRISIL. The RBI Governor has flagged the need for NBFCs - amidst galloping credit growth in the current period -- to take care that expansion of the credit

WHEN A BOLLYWOOD TIGER SAVES DEMOCRACY IN PAKISTAN

This time, there is a twist in the tale, or a variation in the standard Bollywood formula. Tiger 3, the latest offering from the YRF Spy Universe, declared to be a box-office hit by the trade pundits has thereby resurrected the fortunes of aging superstar Salman Khan. After a series of successive

flops, Salman Khan's future hinged on this film. The film world can be notoriously cruel and had this film too met a fate similar to that of his other recent releases he could have been written off by many as a has-been. Now Tiger 3 is not a particularly well-made film, even by mainstream standards. Many scenes are unoriginal, the dialogues are not particularly memorable, and while Salman Khan does his best, acting has never been his strong suit. The songs too are not great. How then has the film managed to grab the audience's interest? One suspects that is because of the twist in the tale.

It is one thing to battle terrorism and evil, finish off the bad guys, and make the world, ipso facto, a safer place. That has been the standard formula thus far. It is a different matter, a far nobler action, one might say, when the hero battles the military in the neighbouring state, foils the attempted assassination of a female prime minister and thereby prevents a military coup from taking place.

The famed psychologist Sigmund Freud wrote on how our dreams often represent wish fulfilment. Does Indian cinema too often represent unfulfilled fantasies of the Indian public? A while ago in An Action Hero, a Dawood Ibrahim like figure is neutralised by Ayushman Khurana. It was an excellent film but the idea was not original for Dawood Ibrahim had already been killed by RAW agents in D-Day, another Bollywood production. And now in Tiger 3 Bollywood has gone a step further and helped democracy survive in Pakistan. The fantasy in Tiger 3 is really about India, as a great magnanimous power humbling truant Pakistan. Therein lies its special appeal.

In a recent interview former RAW chief Vikram Sood rubbished the idea that a male RAW agent could ever be romantically entangled with a female ISI agent. Mr Sood may be a great sleuth but he possibly hasn't watched enough cinema, and needs to learn the art of suspending disbelief. After all, if James Bond can have amorous relationships with Russian ladies in more than one film including in Golden Eye, why cannot Salman Khan have an attractive wife named Zoya who happens to be an ISI agent from neighbouring Pakistan? Katrina Kaif, who gets to play Zoya in the movie gets the chance to demonstrate that she can show and kick ass both. In a scene that will have front benchers drooling, and some of us on recliner seats in the multiplexes sitting up as well, she battles and downs a female Chinese martial arts expert inside a Turkish hamam wearing only a towel.

Attractive female partners from an adversary nation are not all that Bond, Tiger and Pathan share in common though. Bond has a female boss, the legendary 'M'. In Tiger 3, Salman too reports to a female chief of the RAW. Female bosses appear to be in vogue for only a few months ago, in Pathan Shah Rukh Khan too had a female boss played by Dimple Kapadia. James Bond is, after all, a time-tested brand. What's not to like, copy and paste here? Moreover, such casting nicely feeds into the nari mukti, or female empowerment narrative.

Tiger 3 does not paint the Pakistani public as evil but rather as victims of a cruel, grasping military. This is actually close to the truth. It is extremely doubtful if the film will ever be permitted to be screened in theatres in Pakistan, but it will nonetheless be widely watched on pirated videos smuggled into Pakistan and Afghanistan. Young boys and girls in Islamabad and Lahore eagerly watching Tiger 3 on video inside their homes, with curtains tightly drawn, may even cheer Salman on as he battles the Pakistani army, much to the consternation of their parents, a few of whom may actually be serving in the military.

Tiger 3 is likely to confuse Pakistani audiences who get to watch it. Towards the end of the film, the female Pakistani prime minister who is dressed up like Benazir Bhutto publicly thanks Tiger and RAW on Pakistani television for saving her life and democracy. Before Tiger is permitted to depart for his next mission, a group of Pakistani children play a patriotic tune for him as a token of their nation's gratitude. As a nice little touch, one of the girls plays a sitar.

What's next from Bollywood? Perhaps in Tiger 4 Salman Khan can take on both the Pakistani military as well as their Chinese overlords who are in cahoots with them in supressing democracy. That may be a bit much even for him. So perhaps just like superheroes often come together in the Marvel Universe, we could have a film titled Tiger and Pathan in which Salman handles the Pakistani military and Shahrukh Khan, the bigger star, deals with the Chinese? Do we want to miss out on a release in China? After all, Three Idiots made millions at the Chinese box office. However, China will, in any case, not allow a film that targets the Pakistani military to be screened in their country so it doesn't really matter if they too are targeted. Not to worry. Even without a China release Pathan reportedly managed to do business of a thousand crores.

Indian cinema clearly needs to improve the quality of its offerings, but regardless and in the meanwhile, more power to Bollywood's soft power!

Are we being driven by data?

'We need more data and information to help us set a clear direction for us', is an overused statement we hear in every nook and corner. We indeed believe that we have huge data emerging through various activities and interventions that are taking place around us and we have also gained the habit of calling ourselves smart, meaning everything in our lives has become smart, starting from

the city to a school and much

more. Smartness also makes us believe that these days anything and everything is measurable! Is that true? Are we able to measure all resource footprints? meaning water consumption, energy usage, waste generation, employment, income and so on. And yes, it is not just about measuring the resources we generate, but also the losses we incur, be it economic losses from natural disasters, or any kind of recession we are going through.

going through.

These expectations of measuring all around us may seem overwhelming, but an approach that can help us rectify these things is a must. Having said that, we have to have clear data pertaining to all of these, otherwise it is easier said than done. And then, this is not all, getting the data is not enough, it needs to be communicated to the public as well, for their feedback

and understanding. Almost everything we see around is filled with criticism, the traffic management, the electricity bills, water quality, the air pollution, the flooding of rivers, the congestion in transport facilities and what not. For everything that we see around we feel that the systems are not equipped to deal with a size of population we have in our country.

And it is almost every now and then that the inability to analyze future scenarios is being talked about. Almost every third intellectual reflects that the one and only solution for addressing this challenge is nothing but a trustworthy data, with intermittent risk assessments.

Quality and accessible data has the capacity to directly influence both the governments and people's mindset to help formulate and execute effective programs. India being an emerging economy, it definitely has robust public data system, starting from the decennial Census, annual sample surveys, health surveys and various others that are thematic in nature. And when evidence-based planning becomes the bedrock of any country, it can pave the way for dynamic economic progress and resilience in the longer term.

When it comes to planning, it is the data that has so much to tell us: like children born in a particular state have better longevity than the neighbouring states; literacy rates of one region have influenced decision making among the vouth as compared to any other region in the country. A report of NITI Aayog talks about statistics like, the number of murders reported per lakh population in India is 2.4: there are about 13 courts per 10 lakh population in India; for every 1 crore people in India, 34 corruption cases have been reported; while 15 states/Union Territories have achieved full birth registration, there is room for improvement, with Punjab leading at 99.2 percent, followed by Gujarat and Rajasthan at 98.7 percent.

This is indeed data that tells us about disparities in the country. However, it is these disparities and differences that help us in arriving at specific decisions on budgets, and further on monitoring the utilization of those budgets to ensure better generation of data on what has worked and what has not

The other aspect on which we face criticism is the data

collection methods which needs to be modernized, when compared with other developed and developing economies. Computerized surveys employing various modes like in-person, telephone, web, and text-based interviews, necessitate a different approach to questionnaire design. Because these methods not only deliver faster and better data sets. but also enable improved data quality monitoring through audio recording, interviewer prompts, and such other methods. We also should accept and acknowledge that India now is an inseparable part of the global indices which has been and will also be inflating and deflating India's position on the global stage in years to come. And so it is also a time to increase monetary investment in data collection systems.

Top of Form
The other aspect which cannot be overlooked at any cost is that India is currently undergoing a personal data revolution, driven by the widespread adoption of digital services. While personal data brings considerable value, it also introduces significant new risks. The substantial volume of personal data collected raises

worries about potential consequences such as the loss of individual privacy, financial losses in the event of breaches, and the possibility of unfair discrimination, marginalization, or exclusion of individuals and groups.

The government has also

undertaken various initiatives to establish extensive platforms for handling large datasets, necessitating the acquisition and processing of massive amounts of data. And indeed a classic example of data analytics is the governments crucial role in tax administration. Needless to say, the reality of timely reminders for advance tax payments, identification of mismatches in Income Tax Returns (ITRs) and potential high-risk transactions absolutely reflects that we are hugely leveraging data analytics. Undoubtedly, we have miles to go, but a set of steps have been taken which signify a commitment to enhance the quality and availability of data, for both policymaking and public dissemination, reflecting a forward-looking approach to information management and governance in India.

KERALA HIGH COURT: ALL TOURIST BUSES CANNOT BE OPERATE AS STAGE CARRIAGES

LEGALLY SPEAKING

he Kerala High Court in the case Abdulla. H. Naushad V the State of Kerala Transport Department observed and has passed an interim order wherein the court directed that all the India tourist vehicles cannot be permitted to operate as stage carriers.

It has also been directed by the said court that the authorities in the matter can take the appropriate actions against the tourist buses with all the Indian tourist permits that operate as the stage carriages.

The bench headed by Justice Dinesh Kumar Singh in the case observed and has directed the petitioner who were tourist bus operators to pay fifty per cent of the fine amount which is being imposed by the penalty challans for using their tourist bus in violation of the all-India tourist permit conditions.

The court stated that all the India tourist vehicles cannot be permitted to operate as



stage carriage as it is detriment to the stage carriage operators which includes KSRTC and if the petitioners are violating the permit conditions, the petitioners are liable to be fined.

In the present case, the court was hearing the writ plea moved by the petitioner-tourist bus operators who have approached the High Court against the penalty challans issued against them for operating their tourist bus with all India tourist permits as stage carriers. Thus, they also seek the direction against the authorities for issuing such penalty challans against tourist buses with all India tourist permits in violation of the provisions of

the Motor Vehicle Act. 1988 The court observed that when the said matter came up for hearing, the Government Pleader, P. Santhosh Kumar submitted before the court that the vehicles of the petitioner with all India tourist permits were being used

as stage carriers in violation of the all-India tourist permit

conditions It was also informed by the said court that the penalty challans were issued against the petitioners.

The court observed that earlier an application was moved by the KSRTC wherein restricting the operations of All India Tourist Permit vehicles through the nationalized routes and scheme covered ROUTES formulated under the Motor Vehicles

Delhi High Court To Delhi Police, MCD: Consider Feasibility Of Holding Muslim Mahapanchayat Meeting At Ramlila Ground On December 18

The Delhi High Court in the case Mission Save Constitution v. Union of India and Ors observed and has directed the Delhi Police and Municipal Corporation of Delhi, MCD to consider the feasibility of holding a public meeting i.e., the All India Muslim Mahapanchayat at the Ramlila Ground on December 18, 2023

The bench headed by Justice Subramonium Prasad in its order stated that the application already given by the organization, Mission Save Constitution, for holding the Mahapanchayat on December 18, 2023 be treated as a representation.

The court stated that the Respondent No.3/MCD and the Police Authorities are directed to consider the feasibility for holding the Mahapanchayat at

Ramlila Ground, Delhi on December 18, 2023.

In the present case, the court was dealing with the petition moved by the organization wherein seeking direction on the authorities to act upon its request and grant NOC to organize the public gathering at Ramlila Ground.

Therefore, the organization is founded by Advocate Mehmood Pracha and it claimed to work for the masses, especially the depressed classes, about their constitutional rights.

The court observed that the permission was initially sought for holding meeting on December 04, wherein the MCD took a stand that the Ramlila Ground was not available for the said date and the same can be allotted subject to NOC from Delhi

It has also been stated by the Delhi Police that the

NOC was already given to Maha Tyagi Seva Sansthan for organizing 'Mahayagya for Vishwa Jan Kalyan' at Ramlila Ground from December O3 to December 15, and therefore, Ramlila Ground was not being available for December 04.

> The court in the case stated that it was going into the controversy as to whether the Maha Tyagi Seva Sansthan should have first approached the MCD and then the Police Authorities or as to whether the petitioner organization should have first approached the Police Authorities and then the MCD.

The counsel appearing for the organization submitted before the court that out of the dates given by the MCD and the Police Authorities, December 18 was the most convenient for holding the Mahapanchayat.

Therefore, the court stated that let the application already given by the Petitioner on 10.11.2023 for holding the Mahapanchayat on December O4, 2O23 be treated as the representation for holding the Mahapanchavat on December 18, 2023.

Further, the court stated

that it had last month refused to grant permission to the organization to hold a similar public meeting at the Ramlila Ground on October 29. The court while considering the facts and circumstances of the case observed and has upheld the decision of the Delhi Police, wherein it revoked the permission which is granted to the organization for holding the meeting. Thus, the court stated that the same cannot be held arbitrary. Accordingly, the court listed the matter for further consideration on November 28, 2023.

PUNJAB AND HARYANA HIGH COURT SEEKING RESPONSE FROM CHANDIGARH MUNICIPAL CORPORATION IN PIL FOR EFFECTIVE IMPLEMENTATION OF ANIMAL BIRTH CONTROL RULES

The Punjab and Haryana High Court in the case Arushi Lamba v. Municipal Corporation, Chandigarh and Anr. and has issued the notice on the Public Interest Litigation, PIL moved wherein seeking the directions to Chandigarh Municipal Corporation to take adequate and appropriate steps with regards to the effective and expeditious implementation of the Animal Birth Control Rules, 2023, the ABC Rules in Chandigarh.

The Division bench comprising of Acting Chief Justice Ritu Bahri and Justice Nidhi Gupta in the case observed and has issued

notice to the municipality. The petitioner in the plea states that on filing the representation in the said regard before the Municipal Corporation, 'neither satisfactory' nor true picture of the adoption and imple-



mentation of the Animal Birth Control Rules 2023 was being provided.

In the present case, the Arushi Lamba who being the resident of of Chandigarh, has filed the petition highlighting that ABC Rules have been notified by the Central Government in March 2023, under the Prevention of Cruelty to Animals Act, 1960. The said Rule upersede the Animal Birth Control (Dog) Rules, 2001, and address the 2009 guidelines which is laid down by the Supreme Court in the case India v. People for Elimination of Stray Troubles.

Further, the court stated that it aims to provide guidelines for the sterilisation and immunisation of stray animals through Animal Birth Control ABC programmes and these programmes must be conducted by the Local Bodies, Municipalities, Municipal Corporation and Panchay-

It has also been provided by the ABC Rules, 2023 that the Animal Birth Control and the Anti-Rabies Programmes should be carried out jointly by the mentioned Government bodies while focusing on guidelines to resolve dog bites without relocation of the animals. The petitioner in the plea

stated that the rule 20 ABC Rule has also been referred to state that, it accredits the responsibility of making necessary arrangements for feedings of community animals, especially making of the provisions for feeding spots and shelter homes for stay animals residing in that

Adding to it, the plea stated that on filing the RTI seeking information with regards to the status of the implementation of the Rule.

Further, the court stated that the response submitted by Municipal Corporation was neither satisfactory nor depicted a true picture of the adoption and implementation of the Animal Birth Control Rules 2023 in U.T. Chandigarh.

Accordingly, the court listed the matter for further consideration on January 25, 2024. The counsel, Advocate Arushi Lamb appeared for petitioner.

Supreme Court: Splitting Of Trial Under Section 317(2) Of CrPC Cannot Be Done When Further Investigation Has Already Been Ordered

The Supreme Court in the case S. Mujibar Rahman v State observed and has held that the splitting of trial as stated under section 317(2) of the Code of Criminal Procedure, 1973 cannot be ordered when further investigation has already been ordered.

The court stated that the further investigation cannot be sone when the investigating agency has not furnished a non-traceable certificate before it.

The Supreme Court bench comprising of Justice Abhay S. Oka and Justice Pankaj Mithal in the case observed wherein the court was hearing an appeal against the judgement of the Madras High Court, wherein the

court allowed the Criminal Revision petition and split the trial under section 317(2) of the Code of Criminal Procedure, 1973.

The said case was related to property damages involving offences as stated under Section 395, Section 397, Section 212, Section 120B, and Section 3 of the Tamil Nadu Public Property Damages Act against 31 accused

The court stated that it being pertinent to note that section 317(2) of the Code of Criminal Procedure, CrPC stated that if the accused in any such case is not represented by a pleader, or if the Judge or Magistrate considers his personal attendance necessary, he may, if he thinks fit and for reasons to be recorded by him, either he



can adjourn such inquiry or trial, or order that the case of such accused be taken up or tried separately.

The bench remarked that this court finds that the High Court has not even considered the reasons recorded by the learned Magistrate in the order dated July 16, 2019. Secondly, it has not been no-

the learned Judicial Magistrate on 13th February 2019 had permitted further investigation. Thus, when the High Court permitted the splitting of the trial, two important aspects were not noted by the High Court. The first one was that the learned Magistrate was not satisfied that the police had made sufficient efforts to procure the presence of all the accused.

Therefore, the second factor which is more important is the order of further investigation passed on February 13, 2019 and this being not the stage at which the High Court could have permitted splitting of the case.

The court stated that the case dates back to 2016 when demonetization was announced. It was also alleged before the court that when the accused had induced the petitioner to believe that he could exchange the old notes (500,1000 Rupees) for the new 2000 rupees notes. Thus, the petitioner took 30 lakhs but was attacked by the accused who took away all the money and then he filed the complaint to the police.

The petitioner allegedly found that there was a collusion between the investigating officer and certain accused individuals, compromising the investigation in this case and he made a representation to the Superintendent of Police (SP) about the same.

On the other hand, it has been directed by the SP to the respondent No. 1 to file a petition under section 173(8) CrPC for further investigation, which the magistrate allowed. Consequently, the respondent no 1 seek the splitting of the trial, which was rejected by the trial court in 2019 due to the ongoing order for further investigation. Therefore, he moved the criminal revision application before the HC

which allowed it and split the trial of some of the accused.

It has also been noted by the High Court that the case was pending since 2016 where summons remained unserved for 3 accused individuals, and nonbailable warrants were pending against 8 others out of a total of 30 accused persons.

The High Court in its order stated that the lower court to split the case against the accused who were absent and proceed with criminal proceedings against the rest of the accused persons.

The petitioner filed an SLP before the Supreme Court, aggrieved with the said order. The counsel appearing for the petitioner argued before the court that the High Court had passed the order without being acquainted with the order of the judicial magistrate ordering further investigation in pursuance of the application by respondent no.1.

The petitioner relied in the judgement in the case Subramaniam Sethuraman v. State of Maharashtra in order to contend that an order obtained by fraud is a nullity.

Further, he also argued that no revision shall lie against an interlocutory order. He asserted that an order passed under section 317 CrPC is an interlocutory order.

Accordingly, the court set aside the judgement of the High Court and has restored the order of the Judicial Magistrate passed in 2019.

The counsel, Advocate on record A. Velan appeared for the petitioner.

PAPER APOLOGY CANNOT BE ACCEPTED IN **CONTEMPT CASES: ANDHRA PRADESH HC**

ANALYSIS

n a very significant judgment with far reaching consequences which no one can ever afford to just gloss over, the Andhra Pradesh High Court in a most learned, laudable, landmark and latest judgment titled P Satyanarayan Reddy vs M Saraswathi, Deputy Director, Tribal Welfare in Contempt Case No. 1032 of 2019 that was pronounced as recently as on November 7, 2023 minced just no words to say in no uncertain terms that "paper apology" cannot be accepted in contempt of court cases. The Court was most forthright in observing that, "Paper Apology" is an apology which is hollow; or with no remorse, regret or repentance, or if it is only a device to escape the rigour of the law. It must also be disclosed here that the Court observed so while holding clearly that Mrs M. Saraswathi, the Deputy Director of Tribal Welfare guilty of contempt of court under Section 12 of the Contempt of Court Act, 1971 (CC Act).

At the very outset, this brief, brilliant, balanced and bold iudgment authored by the Single Judge Bench comprising of Hon'ble Sri Justice Ravi Nath Tilhari sets the ball in motion by first and foremost putting forth in para 2 that, "This contempt case is filed against the respondent Smt. S. Saraswathi, Deputy Director, Tribal

Welfare I.T.D.A., Rampachodavaram, East Godavari District, (Presently Director) with respect to the judgment and order dated 14.08.2019 passed by the writ Court in W.P.No.11279

FACTS

To put things in perspective, the Bench envisages in para 3 that, "The petitioner was working as Secondary Grade Teacher, in Ashram Upper Primary School, Kansuluru Village, Chinturu Mandal, East Godavari District. He was not considered for promotion to the post of School Assistant (Maths). He had given representations to the 1st respondent, the last being dated 18.07.2019, but when there was no response and two of his juniors were already promoted he filed W.P.No.11270 of 2019 for the following relief:

"... to declare the Orders passed by the Respondents in not treating B Tech with Chemical Engineering with Maths as one of the subjects as required qualification as per G O Ms No 45 Social Welfare TW SER II/ A1 Department dated 28 6 2011 for promotion to the post of School Assistant Maths as illegal arbitrary discriminatory and violates the Article 14 16 and 21 of Constitution of India and consequently direct the respondents to effect promotion

of the petitioner with effect

from 16 7 2019 with all consequential benefits and to pass...""

As we see, the Bench then states in para 4 that, "The Writ Court, disposed of the writ petition vide order dated 14.08.2019 directing the 1st respondent to consider the petitioner's representation dated 18.07.2019 strictly in accordance with law, and bearing in mind all the relevant Rules as well as the G.Os., applicable to the case of the petitioner, within a period of four (4) weeks from the date of receipt of copy of the order."

As it turned out, the Bench then specifies in para 6 that, "The petitioner served a copy of the order to the respondent on 07.09.2019. The time as granted, expired on O7.10.2019. The respondent did not comply and did not pass any order."

Of course, the Bench then mentions in para 7 that, "The petitioner filed contempt peti-

Do note, the Bench notes in para 23 that, "The G.O.Ms. No.45 (Social Welfare (TW. SER.III/A1) Department) dated 28.06.2011 is very clear. The qualification possessed by the petitioner is also not in dispute. The petitioner had the Graduation Degree (B.Tech) with Maths as one of the subjects. B.Tech degree is also a Bachelor's Degree. The contention raised by the respondent that the Bachelor Degree, is normally understood as B.Sc.,/B. Com.,/B.A.., with three years course and B.Tech., degree is four years study course, is nothing but after thought and an effort to justify the act of seeking clarification from the Director of Tribal Welfare which is unexpected of the respondent who held the post

of Dy. Director at that point of time and as per her letters seeking clarification, possess the educational qualification of M.A., LL.B. Besides, in the order of the writ Court it was clearly observed that, ".....finding prima facie the petitioner is meeting all the requirements of G.O.Ms.No.45, Social Welfare (TW.SER.III/A1) Dept., dated

28.06.2011.....". Nothing has been brought on record, contrary to such prima facie finding of the writ Court to justify seeking of clarification from the Director of Tribal Welfare as also for not considering the petitioner's case in accordance with the order of the writ court. The rejection after 17 (seventeen) months, holding the petitioner not qualified as per G.O.Ms.No.45, is in clear defiance of the order of the writ court. The subsequent Memo dated 25.09.2022 of the Direc-

thereof also, it was only after about 8 (eight) months that the petitioner was granted promo-While citing the relevant case law, the Bench observes in para 27 that, "In Kapildeo Prasad Sah v. State of Bihar AIR 1999 SC 3215, the Hon'ble Apex

Court held that even negligence

tor, Tribal Welfare also clearly

holds the petitioner fulfilling

the qualification, but in spite

drawn to the Court's order and its implication." Resultantly, the Bench propounds in para 28 that, "From the aforesaid judgments, it is very much clear that even where the Court's order is ignored a case of civil contempt is made out if the party fully knew of the order of the court and was conscious thereof. Even negligence and carelessness can amount to disobedience, particularly when attention of the person is drawn to the Court's order. It is not necessary to prove that he appreciated that it did breach the order."

As a consequence, the Bench expounds in para 29 that, "In view of the aforesaid consideration, I hold that the charge No.1 as framed against the respondent stands proved. The respondent rejected the case of the petitioner vide order dated 12.04.2021 after 17 months though the petitioner fulfilled the requisite qualifications under G.O.Ms.No.45 dated 28.06.2011. The respondent has deliberately and willfully disobeyed the order dated 14.08.2019 passed by the writ court in W.P.No.11279 of 2019."

While citing a recent and relevant case law, the Bench hastens to add in para 31 stating that, "In Arun Kumar Yadav v. State of U.P. (2013) 14 SCC 127, the Hon'ble Apex Court held that no one has the authority to conduct in a manner which would demean and disgrace the majesty of justice which is dispensed by a Court of law. The administration of justice is the paramount role of the Court. It was held that the apology should be prompt and genuine. The concept of mercy and compassion is ordinarily attracted keeping in view the infirmities of the man's nature and the fragile conduct, but in a Court of law a counsel cannot always take the shelter under the canopy of mercy for the law

has to reign supreme." Further, the Bench observes in para 32 that, "In Arun Kumar Yadav (supra) the Hon'ble Apex Court referred to the judgment in L.D. Jaikwal v. State of U.P (1984) 3 SCC 405 in which it was observed that "We do not think that merely because the appellant has tendered his apology we should set aside the sentence and allow him to go unpunished, otherwise, all that a person wanting to intimidate a Judge by making the grossest imputations against him has to do, is to go ahead and scandalize him, and later on tender a formal empty apology which costs him practically nothing. If such an apology were to be accepted, as a rule, and not as an exception, we would in fact be virtually issuing a 'licence' to scandalize Courts and commit contempt of Court with impu-

nity"."

Furthermore, the Bench clarifies in para 33 that, "In All Bengal Excise Licensees' Assn. v. Raghabendra Singh (2007) 11 SCC 374 the Hon'ble Apex Court held that it is settled law that a party to the litigation cannot be allowed to take an unfair advantage by committing breach of an interim order and escape the consequences thereof. It was observed that "under the constitutional scheme of this country orders of the High Court have to be obeyed implicitly and the orders of this Court for that matter any Court should not be trifled with". In that case it was found that the respondents therein acted deliberately to subvert the orders of the High Court. The Hon'ble Apex Court observed that "it is equally necessary to erase an impression which appears to be gaining ground that the mantra of unconditional apology is a complete answer to violations and infractions of the orders of the High Court or of this Court.""

In addition, the Bench, to put it shortly, states in para 34 that, "It is apt to refer Bal Kishan Giri v. State of U.P. (2014) 7 SCC 280 as well in which the Hon'ble Apex Court held, in paras-13 to 17, as under:

"13. In Asharam M. Jain v. A.T. Gupta [(1983) 4 SCC 125 : 1983 SCC (Cri) 771], while dealing with the issue, this Court observed as under: (SCC p. 127, para 3)

"3. ... The strains and mortification of litigation cannot be allowed to lead litigants to tarnish, terrorise and destroy the system of administration of justice by vilification of Judges. It is not that Judges need be protected; Judges may well take care of themselves. It is the right and interest of the public in the due administration of justice that has to be protected."

17. In L.D. Jaikwal v. State of U.P. [(1984) 3 SCC 405:1984 SCC (Cri) 421], this Court noted that it cannot subscribe to the "slap-say sorry-and forget" school of thought in administration of contempt jurisprudence. Saying "sorry" does not make the slapper poorer. [See also T.N. Godavarman Thirumulpad (102) v. Ashok Khot [(2006) 5 SCC 1: AIR 2006 SC 2007] .] So an apology should not be "paper apology" and expression of sorrow should come from the heart and not from the pen; for it is one thing to "say" sorry, it is another to "feel" sorry."

What's more, the Bench clearly states in para 35 that, "In Bal Kishan Giri (supra) the Hon'ble Apex Court held that a conduct which abuses and makes a mockery of the judicial process of the Court is to be dealt with iron hands and no person can tinker with it to

prevent, prejudice, obstruct or interfere with the administration of justice. An apology tendered is not to be accepted as a matter of course by the Court."

Without mincing any words, the Bench propounds in para 36 that, "The present is not a case of accidental or unintentional disobedience. The respondent acted deliberately to subvert the order of this Court. Her act is contumacious. The apology tendered by the respondent in the facts of the case is considered not bona fide. The apology tendered is rejected."

CONCLUSIONS:

As things stand, the Bench states in para 40 that, "The charge No.1 against the respondent has been proved. Respondent is held guilty of committing civil contempt of the Court. The apology has been rejected. The act of the respondent substantially interferes with the due course of justice or due administration of justice. By the act of the respondent, the petitioner was prevented from justice by not complying with the order."

Adding more, the Bench holds in para 41 that, "On charge No.2, I hold that the charge No.1 having been proved, the respondent deserves punishment under Section 12 of the Contempt of Courts Act, 1971."

Quite significantly, the Bench notes in para 42 that, "In the facts and circumstances, mere imposition of fine will not meet the ends of justice. Sentence of imprisonment is necessary. However, the Court is taking a lenient view in imposition of sentence of imprisonment."

If 'Saptapadi Has Not Been Completed, Marriage Won't Be Complete And Binding: Patna HC open for the Family Court to

While ruling on a very significant legal point pertaining to the marriage ceremony and when it could be considered complete and binding, the Patna High Court in a most learned, laudable, landmark and latest judgment titled Ravi Kumar vs Bandana Kumari in Miscellaneous Appeal No. 248 of 2020 that was pronounced as recently as on 10-11-2023 has annulled a marriage that was held at gunpoint in 2013. The Patna High Court said that if 'Saptapadi' has not been completed, marriage would not be considered to be complete and binding. It must be noted that the Patna High Court had annulled the marriage of a Constable who was abducted and forcefully married to a woman. Earlier the Constable had filed an appeal under Section 19(1) of the Family Courts Act, 1984 against the judgment of the Family Court which had dismissed his petition filed for decree of nullity of marriage.

At the very outset, this brief, brilliant, bold and balanced judgment authored by Hon'ble Mr Arun Kumar Jha for a Division Bench of Patna High Court comprising of Hon'ble Mr PB Bajanthri and himself sets the ball in motion by first and foremost putting forth in para 2 that,

"The instant Miscellaneous Appeal has been filed by the petitioner/appellant under Section 19(1) of the Family Courts Act, 1984 against the judgment 27.01.2020 passed by the learned Principal Judge, Family Court, Lakhisarai in Matrimonial Case No. 51 of 2013 dismissing the petition of the petitioner filed for decree of nullity of marriage under Section 12(1)(c) of Hindu Marriage Act, 1955 read with Rule 6 of Hindu

Marriage Rules, 1956." To put things in perspective, it would be material to note that the Division Bench envisages in para 3 while shedding light on the facts of the case stating that, "The case of the petitioner/appellant as it appears from the record, is that the petitioner/appellant is a Constable in communication coy Section 'A'. On 30.06.2013, the petitioner along with his uncle had gone to Ashok Dham Temple in Lakhisarai for worship. When the petitioner and his uncle had been purchasing materials for worship at about 02:00 pm, three persons, namely, Rajesh Kumar, Deepak Kumar and Bipin Singh all of Village Chauki, P.O., Balgudar P.S. and DistrictLakhisarai along with six unknown persons who were armed with pistol and knives came and surrounded the petitioner and his uncle. These persons brought the respondent near the petitioner and threatening him with life at gun point and dagger forced him to put vermillion (sindur) to the forehead of the respondent. On resistance being shown by the petitioner, he was assaulted with slaps and fists. The uncle of the petitioner was also surrounded and threatened by the aforesaid persons. Finding no way out as being in custody of the above noted persons, the petitioner put sindur on the head of the respondent but without any religious or spiritual rites and rituals. After performance of the so called marriage, the petitioner and respondent were kept confined in a dark room in the house of the above named Bipin Singh. The uncle of the petitioner was also threatened and confined to the house of Bipin Singh. After sunset, the uncle of the petitioner was set free and he was asked to come with his family members along with ornaments and clothes for respondent as the marriage has been performed. Thereafter, the uncle of the petitioner went to the Lakhisarai Police Station and informed the police about the incident at about O2:00 pm on O1.O7.2O13, but the police did not register the case. On the same night, the petitioner somehow managed to come out of the house of the respondent who is the daughter of above named Bipin Singh and went to inform the police about the incident but again the police did not take any action. Thereafter, the petitioner reached his village. Since the petitioner was required to join his duty immediately, he went to his service place and after getting leave, he came to file this case. Meanwhile, the uncle of the petitioner has also filed a criminal case in the Court of learned C.J.M., Lakhisarai vide Complaint Case No. 431C/12 under Section 323, 341, 352, 387 and 365 IPC. Thus the petitioner submitted that the so called marriage is in contravention of religious and customary laws and is voidable as the petitioner was forced to put sindur on the head of the respondent under threat and coercion. The petitioner has not performed any religious function out of his free will and consent and prayed the learned Family Court to annul the so called marriage while passing a decree of nullity.'

As it turned out, the Division Bench enunciates in para 4 that, "The respondent appeared and filed her written statement. In her written statement, the respondent submitted that she is the wife of the petitioner and their marriage has been solemnized on 30.06.2013 under Hindu customs and at the time of marriage, the

father of the respondent tutes the cornerstone of this gave the petitioner gift of gold, Rs. 10,00,000 (Ten Lacs) and other material. The respondent went to her matrimonial home and after passage of some time, the petitioner demanded a Maruti Car and tortured the respondent. The respondent denied all the averments made by the petitioner in his petition contending that respective allegations are false and fabricated. The respondent further submitted that she has filed a complaint case under Section 498 IPC vide Complaint Case No. 599C of 2015 which was pending in the Court of learned S.D.J.M., Lakhisarai."

Do note, the Division Bench notes in para 34 that, "Section 7 of the Hindu Marriage Act, 1955 reads as under:-

"7. Ceremonies for a Hindu (1) A Hindu marriage may

be solemnized in accordance with the customary rites and ceremonies of either party thereto.

(2) Where such rites and ceremonies include the Saptapadi (that is, the taking of seven steps by the bridegroom and the bride jointly before the sacred fire), the marriage becomes complete and binding when the seventh step is taken."

Most significantly, the Division Bench unmistakably holds in para 35 what constibare perusal of the aforesaid provision, it is obvious that when such rites and ceremonies including Saptapadi the marriage becomes complete and binding, when seventh step is taken. Conversely, if 'saptapadi' has not been completed, the marriage would not be considered to be complete and binding. Now, the respondent has claimed that all rituals were performed and 'saptapadi' was complete. It is surprising that Pandit who performed the marriage ceremony has no knowledge about the essentials of the marriage and his deposition is not clear about the place of marriage. The photographs of the purported marriage cannot help the case of the respondent since it has not been properly exhibited and could not be considered admissible. Moreover, the photographs on their own could not reveal anything. It is not the case of the petitioner/appellant that no marriage was ever solemnized rather it is his contention that he was forced into marriage. Under the circumstances, even if the photographs are taken into consideration, it cannot be said that the marriage was being solemnized without any outer influence. It has all

along the contention of the

petitioner that his marriage

was under duress and the

notable judgment that, "From

same was rebuttable contention for which the onus was on the respondent, but she failed to discharge this onus. On the other hand, the petitioner's case has been supported by witnesses who remained unimpeached dur-

ing cross-examination." It cannot be glossed over that the Division Bench propounds in para 36 that, "The learned Family Court has adopted its own reasoning for disbelieving the case of the petitioner, but, in our opinion, the said view is flawed. The learned Family Court went on the premise that the petitioner did not immediately lodge the complaint either to the police or to the court and this gap makes the case of the petitioner disbelievable. As discussed herein before, the petitioner has explained the situation and there is no undue delay, even the petitioner took steps post marriage through his Officer in the Army Command. So, it cannot be said that the petitioner slept over the matter. Similarly, the learned Family Court has recorded that at the time of marriage, persons from both sides were present. But, where from the Family Court come to this conclusion is not forthcoming from the evidence of the respondent's side. When the learned Family Court expressed his opinion that photographs has not been examined, it was not

rely on the same documents. Then, in absence of material to otherwise, the learned Family Court's finding that not performing the ritual of 'saptapadi' does not mean that marriage was not performed, is devoid of any merit. Another aspect which has been taken into consideration by the learned Family Court is about respondent staying in her matrimonial home for a few days. But, where is the evidence to prove this contention? It remains only a statement in absence of any supportive evidence. If the respondent has resided in her matrimonial home after her marriage, there would have been corroborative evidence which is clearly lacking in the present case. Further, the learned Family Court relied on respondent lodging a case under Section 498(A) of IPC. But, dates and events makes it amply clear that the case was lodged by the respondent on 17.08.2015, i.e., after two years of the marriage. It does not appear to a co-incidence that the said case was lodged after the Matrimonial Case No. 51 of 2013 came into existence. So, the case under Section 498(A) IPC being a counterblast to the matrimonial case, cannot be denied."

A THIRD RELEASE OF HOSTAGES AND PRISONERS

On Sunday, Hamas freed 17 more hostages, including 14 Israelis, in a third exchange under the four-day truce In turn, Israel released 39 Palestinian prisoners. Most hostages appeared to be physically well, but 84-year-old Elma Avraham was airlifted to Israel's Soroka Medical Centre in life-threatening condition because of inadequate care, the hospital said. Those released Sunday included nine children and three Thai nationals. With a total of 17 freed, Thailand said it was pursuing the safe return of the 15 remaining Thai hostages, who were the largest single group of foreigners held by the militant group. Thais working in Israel are mostly employed as semi-skilled farm labourers. The Palestinian prisoners released were mostly teenagers accused of throwing stones and firebombs during confrontations with Israeli forces, or of less-serious offenses. Many Palestinians view prisoners held by Israel, including those implicated in attacks, as heroes resisting occupation. A fourth exchange is expected on Monday, for a total of 50 Israeli hostages and 150 Palestinian prisoners as agreed upon in the cease-fire deal. The freed hostages have mostly stayed out of the public eye, but details of their captivity have started to trickle out.

ELON MUSK TO MEET ISRAEL PRESIDENT ISAAC HERZOG TODAY

Business tycoon Elon Musk is set to meet Israel President Isaac Herzog on Tuesday amid the ongoing Israel-Hamas conflict, The Times of Israel reported.

The Israeli President's Office confirmed the meeting between Tesla owner Elon Musk and Herzog. Herzog said that he would be joined in the meeting by some family members of hostages who are being held in Gaza, as reported by The Times of Israel.He further said that he will "emphasise the need to act to combat rising anti-

semitism online." Musk, however, has recently come under fire for his endorsements of a virulently antisemitic trope on X, as well as the platform's complete failure to crack down on rampant disinformation and hate speech amid the ongoing war, The Times of Israel reported. The failure to combat antisemitism on the app and comments viewed as anti-Semitic, shared by Musk himself resulted in several advertisers like Apple and Disney cutting off their spending on the microblogging site.

Amid the row over endorsing 'anti-semitic' post on X, the platform owner and Tesla CEO Elon Musk has said that the social media platform will file a "thermonuclear lawsuit" against the media watchdog 'Media Matters' alleging that it "completely misrepresented the real user experience" and "undermined free speech".

Musk is currently in Israel and is also expected to meet Prime Minister Benjamin Netanyahu during his visit. Earlier this week, Musk announced that X would be donating all revenue from advertising and subscriptions "associated with the war in Gaza" to hospitals in Israel and the Red Cross/Crescent in Gaza.

DEVASTATING DAMAGE

Turkey sends 500-ton aid to Herat quake victims in Afghanistan

A 500-ton aid shipment from Turkey was delivered to the earthquake-stricken province of Herat in Afghanistan, Khaama Press reported citing the Afghanistan Red Crescent. The Afghanistan Red Crescent reported on Sunday that the Turkish aid materials had reached the province of Herat through the Torghundi port. According to the organization, these aid deliveries were handed over to government officials in Herat province in the presence of the Turkish ambassador, acting on behalf of the Turkish government.

During the handover ceremony, the Taliban officials announced that out of these aid packages, 300 tons would be distributed to the earthquake victims in Herat, while the remaining 200 tons would be allocated to recent returnees from neighbouring countries.

'WILL NOT STOP UNTIL EVERY HOSTAGE RETURNED TO THEIR LOVED ONES': BIDEN

After the release of 13 hostages in Israel, US President Joe Biden has vowed unwavering commitment to ensuring the return of every hostage to their loved ones.While speaking at a press briefing on Sunday, President Biden said that he would not stop until every hostage is returned to their loved ones.He also underscored the 13 hostages, including an American, who were released yesterday under a deal brokered and sustained through intensive US diplomacy.

"We will not stop working until every hostage is returned to their loved ones. This has been the product of a lot of hard work and weeks of personal engagement for me and my team," he said.

The US President further highlighted that he has been in close contact with other West Asia countries.

"We have been in close contact with the leaders of Qatar, Egypt, and Israel, speaking with each one of them repeatedly over the past few weeks," he added.

He further said that he, his wife, and so "many Americans are praying" that 4-year-old Israeli-American Avigail Idan will be all right after she was released from Hamas captivity earlier on Sunday. Idan saw her mother killed in front of her in Kibbutz Be'eri during Hamas's October 7 terror attack and then ran to her father, who shielded her with his body, as terrorists then shot him dead, said Biden. She then ran to her neighbour's home, where she, along with those inside, was taken hostage in

"What she endured is unthinkable," Biden empha-

sised, noting that she celebrated her 4th birthday on Friday in captivity and that he had personally pressed for her release in a recent call with the emir of Qatar. Biden then expressed hope that the truce will be extended so that more hostages can be released. Moreover, US President Biden stated that he has pushed for a pause for weeks in order to get hostages out of Gaza and more humanitarian aid into the Gaza Strip. Roughly 200 trucks of aid have entered Gaza during the past three days of the truce, he said.

"Innocent children in Gaza are suffering greatly as well because of this war that Hamas has unleashed," leading to the deaths of thousands of civilians, Biden noted. He again stressed his plan to advance a two-state solution after the war.

"I get a sense that all the players in the region... are looking for a way to end this so the hostages are all released and (that) Hamas is...no longer in control any portion of Gaza," Biden said.

After the release of the hostages, hundreds of Israelis were seen cheering in Ofakim as the convoy made its way to Hatzerim Airbase near Beersheba, according to The Times of Israel. The Israel Defence Forces said that the Red Cross handed them 13 hostages near the border fence in northern Gaza. One was taken by helicopter to a hospital, and the other 12 were taken in a convoy to the Hatzerim airbase.

META SPOKESPERSON INCLUDED IN RUSSIA'S WANTED LIST

A spokesperson for US tech conglomerate Meta, which owns Facebook and Instagram, has been added to Russia's wanted list, according to an online database maintained by the country's interior ministry, Voice of America has reported.

The spokesperson, Andy Stone was reported on the list by Russian state agency Tass and independent news outlet Mediazona on Satur-

In October, Russian authorities classified Meta as a "terrorist and extremist" organization, opening the way for possible criminal proceedings against Russian residents using its platforms.

Meta listed as a "terrorist and extremist" organization could lead to criminal investigations and fines for users. The interior ministry's database does not give details of the case against Stone, stating only that he is wanted on criminal charges.

Mediazona, the independent news website that covers Russia's opposition and prison system, claims that Stone has been on the wanted list since February 2022, but authorities made no related statements at the time and no news media reported on the matter until this week, reported Voice of America. In March this year, Rus-

sia's federal Investigative Committee opened a criminal probe into Meta. It was alleged that the company's actions following Moscow's all-out invasion of Ukraine in February 2022 amounted to inciting violence against Russians. Stone announced temporary changes to Meta's hate speech policy following Russia's troop invasion into Ukraine. The changes allowed for "forms of political expression that would normally violate (its) rules, like violent speech such as 'death to the Russian invaders."

In the same statement. Stone added that "credible calls for violence against Russian civilians" will remain banned. Mediazona claimed Sunday that an unspecified Russian court earlier this month issued an arrest warrant for Stone on charges of "facilitating ter-

PAK APEX ANTI-GRAFT BODY QUIZZES EX-PM **IMRAN KHAN IN CORRUPTION CASE**

Pakistan's incarcerated former Prime Minister Imran Khan was interrogated in jail by the country's anti-corruption watchdog in a multibillion rupee corruption case, according to a media report on Monday.

A National Accountability Bureau (NAB) team visited the 71-year-old Pakistan Tehreek-e-Insaf (PTI) party chief in the Adiala Jail on Sunday, a senior official of the anti-graft watchdog told the Dawn newspaper. The former premier has been incarcerated in the highsecurity jail in Rawalpindi since September 26 in various cases. The NAB team interrogated Khan for over two

hours in connection with the charges he faces in the GBP 190 million (Rs 50 billion) Al-Qadir Trust corruption case, the report said.

The Al-Qadir Trust case is about the settlement of 190 million pounds, about Rs 50 billion, which the UK's National Crime Agency sent to Pakistan after recovering the amount from a Pakistani property tycoon. Khan, being the prime minister then, instead of depositing in the national treasury, allowed

the businessman to use the amount to partly settle a fine of about Rs 450 billion imposed by the Supreme Court some years ago.

The tycoon, in return, allegedly gifted about 57 acres of land to a trust set up by Khan and his wife, Bushra Bibi, to establish the Al-Qadir University in the Sohawa area of the Jhelum district of Punjab. Officials from the account-

ability bureau have been visiting the Adiala Jail since November 15 to investigate the PTI chief's role in the case. The notice served to the accused says that the anticorruption body took cognisance of the commission of offences of corruption and corrupt practices as defined under the NAB laws.

The provided assistance includes essential items such as food, clothing, spices, hygiene products, blankets,

and tents, Khaama Press reported.

These aid deliveries from Turkey to Afghanistan come as recent reports state that Turkey plans to strengthen its friendly relations with Afghanistan through its TIKA (Turkish Cooperation and Coordination Agency), Maarif, and the Turkish Red Crescent. eijing called for a cease-fire in Myanmar after a coalition of ethnic fighters seized several crossings along Myanmar's border with China in the past month.

However, China will continue live-firing drills on its side of the frontier aimed at "testing the mobility, border control abilities and firepower capabilities of the military units so that the People's Liberation Army is ready for any emergency", the army newspaper PLA Daily said.

Myanmar heavily relies on trade with China, especially for importing manufactured goods and exporting agriin Myanmar's border region has been a constant irritant to China, which nevertheless backed the military leaders who seized power in the Southeast Asian nation in 2021 from an elected government.

Yet China is highly wary of conflicts spilling over the shared border that is already rife with drug trafficking and people smuggling.

Cybercrime targeting Chinese victims has become a major concern, and China has pushed hard to eliminate the groups based in Myanmar and other countries and to send the perpetrators back to China for prosecution.

"China is highly concerned



about the conflicts in Myanmar and has urged all sides to cease fire and start peaceful dialogues to prevent the situation from escalating further," the PLA Daily said.

Meanwhile, the PLA will "safeguard border security and protect the lives and property of people living in the border areas".

The paper said the live-fire exercises that began on Saturday will "boost the sense of responsibility and vigilance of the troops" and will continue for several days. The Myanmar government has acknowledged losing at least three towns, and the fighting appears to have stopped almost all legal

Afghan women journalists face unemployment challenges

The Afghanistan Women Journalist Association (AWJA) has conducted a survey about the situation of women journalists in Afghanistan within the past two years, wherein a majority of them said that "unemployment is one of their biggest challenges", as reported by the news channel.

Meena Habib, the head of AWJA said, "45 per cent of the participants said that unemployment is the biggest challenge ahead of women journalists.'

"Five per cent of the participants are talking about the poverty of women journalists, while 10 per cent of

the participants said lack of access to information is the biggest challenge for women journalists," she said.

Moreover, some of the media-supporting organisations called on the Taliban to provide women journalists with all-out support, according by the news channel.

"We call on the Islamic Emirate to help women as much as it can in the fields of education, work and facilities," Taj Mohammad Ahmadzada, one of the

members of the AWJA, said. The women journalists in Afghanistan also expressed their concerns about facing an uncertain future and emphasised that they are struggling with the working environment.

"In many conferences, wherever women are invited, we go there but we face double standards. The security forces do not allow women to enter the conference," Hajar Jafari, a journalist, said.

"Females are facing many challenges compared to males. Women cannot get access to proper information in press conferences," said Marriam Madadi, another journalist.

Under the Taliban regime, at least 52 per cent of visual media outlets have ceased operations in Afghanistan over the past two years, the news agency reported.

The Media Support for Afghanistan's Free Media (NAI) recently announced that more than half of the visual media outlets in the country have remained in-

After the Taliban took control of Afghanistan on August 15, 2021, press freedom in the country has taken a backseat, with several restrictions put into place for journalists.

Moreover, according to local media reports, after the political change in the country, 94 per cent of women journalists have become unemployed due to restrictions on their work

PRESIDENT ASSURES CALM AFTER **ARRESTS IN SIERRA LEONE**

Sierra Leone's president said most leaders of attacks on the nation's main military barracks and prisons had been arrested and normalcy had returned across the country after a 24-hour curfew was relaxed to a dusk-to-dawn lockdown.

The attacks early Sunday morning surprised residents and security forces in the West African nation and raised fears of a possible coup in a troubled region.

But "most of the leaders" of the attacks now have been arrested and "calm has been restored," President Julius Maada Bio said in a Sunday night address.

Residents in the capital city

of Freetown were awoken by sounds of heavy gunfire as gunmen tried to break into the key armoury in the country's largest military barracks, located near the presidential

They engaged in sustained gunfire with security forces and targeted major detention centres - including the central prison holding more than

2,000 inmates - and freed or abducted an unconfirmed number of people, authorities said.

Videos on social media appeared to show dozens of inmates pouring into the streets to hurriedly escape around the same time that security forces were engaged in a shootout with the attackers on the outskirts of the city.

The attacks deepened political tension in West and Central Africa where coups have surged, with eight military takeovers since 2020, including in Niger and Gabon this year. West Africa's regional economic bloc ECOWAS - of which Sierra Leone is a member — described the attacks as a plot "to acquire arms and disturb the peace and consti-

tutional order" in the country.

NORTH KOREA RESTORES BORDER POSTS AMID TENSIONS

South Korea said on Monday North Korea is restoring frontline guard posts that it had dismantled during a previous period of inter-Korean rapprochement, deepening tensions that spiked over the North's recent spy satellite launch.

The two Koreas each earlier dismantled or disarmed 11 of their guard posts inside their heavily fortified border under a 2018 deal meant to ease frontline military confrontations. But the deal is now in danger of being scraped, as both Koreas openly threaten to breach it amid rising animosities over the North's satellite launch.

After North Korea claimed to place its first military spy satellite into orbit last Tuesday, South Korea said it would partially suspend the



deal and resume front aerial surveillance in response. South Korea called its

step "a minimum defensive measure" to respond to the launch that it says involved the North's intentions of improving its missile technology as well as establishing a space-based surveillance

North Korea immediately slammed South Korea's decision, saying it would deploy powerful weapons at the border in a tit-for-tat measure. The North said it also won't abide by the 2018 deal any longer.

In a background briefing for local journalists Monday, South Korea's military said it detected North Korea building guard posts and trenches at border sites where its dismantled guard posts once stood. The military said it found North Korea deployed troops and heavy weapons **REPORTS**

Court documents allege Meta designed platforms to hook kids

Facebook parent Meta Platforms deliberately engineered its social platforms to hook kids and knew — but never disclosed - it had received millions of complaints about underage users on Instagram but only disabled a fraction of those accounts, according to a newly unsealed legal complaint described in reports from The Wall Street Journal and The New York Times.

The complaint, originally made public in redacted form, was the opening salvo in a lawsuit filed in late October by the attorneys general of 33 states.

Company documents cited in the complaint described several Meta officials acknowledging the company



designed its products to exploit shortcomings in youthful psychology such as impulsive behavior, susceptibility to peer pressure and the underestimation of risks, according to the reports.

Others acknowledged Facebook and Instagram also were popular with children under age 13 who, per company policy, were not allowed to use the service.

Meta said in a statement to The Associated Press that the complaint misrepresents its work over the past decade to make the online experience safe for teens, noting it has "over 30 tools to support them and their parents."

With respect to barring

younger users from the service, Meta argued age verification is a "complex industry challenge."

Instead, Meta said it favors shifting the burden of policing underage usage to app stores and parents, specifically by supporting federal legislation that would require app stores to obtain parental approval whenever youths under 16 download apps.

One Facebook safety executive alluded to the possibility that cracking down on younger users might hurt the company's business in a 2019 email, according to the Iournal report.

But a year later, the same executive expressed frustration that while Facebook readily studied the usage of underage users for business reasons, it didn't show the same enthusiasm for ways to identify younger kids and remove them from its platforms, the Journal reported.

The complaint noted that at times Meta has a backlog of up to 2.5 million accounts of younger children awaiting action, according to the newspaper reports.

PAKISTAN ELECTION COMMISSION: IMRAN KHAN NOT PRISONER OF CONSCIENCE

Pakistan's election commission has stated that former Prime Minister Imran Khan is not considered a "prisoner of conscience" but is in jail due to being accused in various cases, including the misuse of a diplomatic cable. The Election Commission of Pakistan (ECP) responded to remarks made by Khan's Pakistan Tehreek-e-Insaf

(PTI) party in its 24-point Charter of Demand ahead of the country's general elections on February 8. In the charter sent to the ECP on November 6 by PTI's Secretary General Omar Ayub Khan, Imran Khan, who is also the Chairman of the party, was described as a "prisoner of conscience." The party claimed victimization and persecution as a political entity. However, the ECP dismissed these charges, stating that it has no role in the alleged victimization, as reported by The Express Tribune newspaper. The ECP, in its response to the charter on November 22, clarified, "Former PM and Chairman Imran Khan is in jail in different cases, including [the] cipher case." The term "prisoner of conscience" refers to an individual imprisoned for holding political or religious views not tolerated in their residing state.

Imran Khan, a cricketerturned-politician, has been held in the high-security Adiala jail in Rawalpindi since September 26 on various charges. The ECP reiterated its "no-role" statement in response to PTI's claim that its leaders were coerced into giving interviews and statements against the party. The ECP stated it could not prevent any political leader from joining or leaving any party. Addressing PTI's claim of

not receiving a level-playing field, the ECP mentioned it had issued directions to all caretaker governments to provide a fair playing field to all parties. Responding to PTI's observation that the general elections were not occurring within the constitutionally stipulated 90-day period, the ECP explained that the Supreme Court had deliberated on the matter, and the election date of February 8, 2024, was set in

consultation with the president per the court's order. In response to PTI's allegation of pre-poll rigging by caretaker governments against the party, the ECP reiterated it had issued directions and urged the PTI to present specific and concrete proposals or evidence supporting its claims. The PTI had requested the ECP to instruct relevant authorities to allow the party to conduct political meetings, to which the ECP assured that all political parties would be provided a level-playing field during the forthcoming elections. Without directly naming Pakistan Muslim League-Nawaz (PML-N) supreme leader Nawaz Sharif, PTI objected to a convicted and absconding prisoner receiving unprecedented protocol and permission to hold public meetings. The ECP confirmed that the issue would be addressed.

Regarding PTI's request for the Pakistan Electronic Media Regulatory Authority (PEMRA) to provide equal airtime to Khan and his party compared to PML-N and other parties, the ECP noted that the matter would be taken up with the caretaker federal government. The ECP also stated that the election schedule would be announced after the publication of the final list of constituencies.

I love Todd, I love Zach, I love Ed so much, I probably would," he said during an appearance on "The New Yorker Radio Hour".


The third film in the franchise released in 2013 and opened to largely negative reviews



ADITI SECURES SECOND LET GOLF TITLE IN SPAIN

🕇 tar Indian golfer Aditi Ashok dished out a bogey free final round after a stunning back nine to win the Andalucia Costa del Sol Open de Espana tournament for her second title of the season here.

Aditi's final round of 66 with a back nine of 5-under 31 saw her finish at 17-under as she beat Anne Van Dam (68) of the Netherlands by two shots on Sunday.

It was Aditi's second win of the season and fifth of her career on the Ladies European Tour.

She began the 2023 season with a win in Kenya in the first event of the year and ended it with another trophy here in the last event.

It was an impressive week for Aditi, who had finished



fourth at the Tokyo Olympics, as she shot 69-68-68-66 at Real Club de Golf Las Brisas.

"It started out slow, I was missing a lot of birdies for the first six to eight holes. I hit it close on seven, after that I felt like I still had a chance. Initially, it felt like I was two shots away the whole time. I'm glad it picked up on the back nine," said Aditi.

"It was a great battle. Anne (Van Dam), when she's playing good, she can blow the

field away and win by five to 10 shots. I knew I had to not stop making birdies and to keep trying.

"Her par when she hit the trees on 15 and my long putt, that switched the momentum a little bit. She is a great player and kept me honest out there."

Aditi, who was in a tie for second place overnight, didn't make her first birdie until the seventh but that kickstarted her momentum. She added two more on

her three birdies on the trot on 15, 16 and 17 which sealed her the title.

"On the front nine I wasn't hitting it as good, somewhere on the back on 13 when I hit that 8-iron close I feel I made a good swing and it just picked up from there. I made three or four good swings and all of those were in makeable range. I guess the 16th tee shot was the shot of the day," she said.

"One 18, I have struggled with that tee shot and missed it right almost all four days. It was a weird lie in the rough, I didn't know if it would go left on me, and it did. I was just trying to make sure I had a good look at par."

India's other star Diksha Dagar (67) ended tied-seventh on 10-under-par, along with defending champion Caroline Hedwall, Norway's

Celine Boutier and Spanish amateur Andrea Revuelta.

Diksha improved over the last two rounds after starting with 72-71. She carded 68-67 over the weekend.

Aditi, who played only eight events this season, finished fourth on the Race to Costa del Sol, while Diksha was third.

In the 2023 Race to Costa del Sol, Trichat Cheenglab took the trophy with a tally of 1,966.52 points ahead of Boutier and Dagar.

Cheenglab followed in the footsteps of compatriot Atthaya Thitikul and became the sixth player to win both the Race to Costa del Sol and Rookie of the Year titles in the same season.

Dutch star Anne Van Dam ended the week in second place on 15-under-par after a final round of 68 (-4).

"The organisers can also organize pre-event activities such as school competitions, roadshows, and community events to build excitement and involvement. The IOA president, who has been included in the Coordination Committee for the next Asian Games in Japan, said the need of the hour was to have a robust feedback mechanism from participants, stakeholders and spectators. "This information can be valuable for continuous improvement and for addressing any issues that may arise during the games," said Usha, who spent significant time in Goa looking after the preparation and proper conduct of the Games. The Rajya Sabha MP said the focus of the next edition of the Games to be held in Uttarakhand should be on being environment-friendly. EVERTON FANS PROTEST 10-POINT DEDUCTION MARCH

Everton fans marched in their thousands to Goodison Park ahead of a match against Manchester United, protesting against the decision to dock their team a Premier League-record 10 points for breaching financial rules.

Supporters on the march on Sunday held up pink cards featuring the word "corrupt" and the logo of the Premier League, and chanted "We shall not be moved." On one huge banner read the message: "Where there is power, greed and money ... there is corruption."

There is widespread anger at the Merseyside club at the severity of the sanction handed out by a disciplinary commission after Everton went less than 20 million pounds over the maximum losses allowed of 105 million pounds (\$130 million) across a threeyear period, according to the league's profit and sustainability rules.

This was Everton's first match since the club received a punishment that many in soccer feel doesn't fit the crime. It made for a hostile atmosphere inside Goodison Park as fans jeered the Premier League anthem and waved the pink cards when the players came out of the tunnel before kickoff. There was a huge chant in the

10th minute — marking the 10 points docked — accusing the league of corruption. Everton started the game tied for points with last-place Burnley, five points from safety, and stayed there after losing 3-O to United, despite an encouraging performance

for large parts of the game. Everton manager Sean Dyche said it had been "a tough 10 days to take the news." "Most people think how unjust it is, including our fans, myself and the football club. We have to perform and win games."

Our association with Sandya dates back to the 1974-75 Nationals in Varanasi, where her team emerged triumphant. Over the years, our friendship endured, and Sandya's encouragement became a constant presence. Beyond being an opening



batsman, she served as a selector for West Bengal, contributing significantly to the growth of women's cricket.

During our Kolkata camp, Sandhya's generosity shone through as she and her teammates brought food for evervone. Her camaraderie

with fellow players, including Runadi, Lopamudra, Sharmila, Keya, and Chandana, reflected the discipline and dedication that defined their era. A poignant tribute comes from Fowzeih, the opening batsman and wicketkeeper, expressing deep sorrow at Sandya's passing. Remembered as a good person and devoted cricketer, Fowzeih reminisces about their shadow practice sessions under the watchful eyes of Sunil Da, their coach during the Kolkata camp.

In this time of grief, we collectively honor Sandhya Muzumdar Mukherjee for her significant contributions to Indian cricket and the lasting impact she had on her contemporaries. May her soul rest in peace, and may her spirit continue to inspire generations to come.

Star Australian batter Steve Smith will make a return to the Sydney Sixers for Big Bash League (BBL) season 13, as announced by the club
