The National Investigation Agency (NIA) on Thursday seized several illegal arms and ammunition, along with incriminating documents, digital devices and cash, in a massive multi-state crackdown in three cases relating to conspiracies and activities of the banned Babbar Khalsa International (BKI) and the Lawrence Bishnoi Crime Syndicate, among

As per NIA officials, a total of 32 locations in the States of Punjab, Haryana, Rajasthan, Uttar Pradesh and Delhi, as well as the UT of Chandigarh, were raided today by NIA teams as part of the mega operation that began early this morning.

The seizures in the searches included 2 pistols, 2 magazines and ammunition,

The three cases in which the NIA swooped down today relate to the terror activities being carried out by the BKI, a banned terrorist organisation, and the terrorist-gangster networks operating in the country.

Such activities include smuggling and induction of terrorist hardware, such as arms & ammunition, explosives, IEDs etc., across the borders. The terror hardware is being used by operatives/members of terror outfits and Organized Criminal Syndicates for carrying out bomb explosions, targeted killings, extortions, terror funding of terror outfits, etc. in various parts of the coun-

The Chief of Army Staff, General Manoj Pande, said on Thursday that the security situation on the northern border is stable but sensitive. The Army Chief was speaking at the Annual Press conference ahead of Army Day on January 15.

"The situation on the northern border is stable but sensitive. We continue to talk to find a solution to address and balance issues between the two sides. Operational preparedness is very high, and deployment is both-robust, and balanced..." Chief of Army Staff, Manoj Pande said.

The ruling BJP has Thursday slammed Congress for declining the invitation to attend the 'Pran Pratishtha' ceremony of Ram Lalla in Ayodhya on January 22.

BJP spokesperson Nalin Kohli slammed the grand old party for declining the invitation to attend the 'Pran Pratishtha' ceremony of Ram Lalla in Ayodhya and questioned the Congress for trying to do politics over the grand event in the holy city. "If they don't wish to be there, then why drag the RSS and the BJP, and why are they trying to do politics over Lord Ram Temple's consecration?" lashed out at the BJP leader. Kohli said, "It is for the Congress party's top leadership to decide whether they would like to be present on January 22 for the consecration of Lord Ram and the grand temple opening in Ayodhya." The BJP spokesperson also



criticised Congress for denying the very existence of Lord Ram. "It should come as no surprise because the Congress party when in government, had denied the very existence of Lord Ram in an affidavit that they filed before the honourable Supreme Court," he said.

Kohli took on Congress for blaming the BJP and the RSS and for dragging them over their refusal to attend the "Pran Pratishtha" of the Ram Temple in Ayodhya on January 22.

On January 5, a raiding party of the ED had gone to raid the house of a district Trinamool Congress leader, Sheikh Shahjajan, in Sandeshkhali in connection with alleged irregularities in the state's ration system when its members were beaten up by a mob of 1,000 people and forced to retreat. Sheikh Shahjahan has not been seen



since then

On Thursday, a procession of BJF supporters, led by state president Sukanta Majumdar, was prevented from reaching the local Nyazat police station to record its protest against police inaction and for its failure to arrest Sheikh Shahjahan. The State police enforced prohibitory orders under Section 144 to prevent the BJP supporters from reaching Nyazat police station.

Sukanta Majumdar alleged that the State police which remained inactive when ED officials were being attacked, had set up "three layers of barricades" to prevent BIP supporters from going ahead with their plan to gherao the police station. "Is this Kashmir that the police are stopping members of the world's largest political party from carrying out its scheduled programme?" he asked. He also alleged that the policewomen were deployed to stop the BJP supporters, so that the latter could be booked under non-bailable sections for alleged molestation.

"This is all being done on the orders of Mamata Banerjee. Sheikh Shahjahan is being sheltered by the Trinamool Congress' top leadership because he shared his ill-gotten gains with the Food Minister Jyotipriya Mallick who, in turn, passed it on to his seniors in the party," Majumdar alleged.



GOLD PRICE STABLE AT RS 63,150 PER 10 **GRAMS**

NEW DELHI: Gold prices remained flat at Rs 63,150 per 10 grams in the national capital on Thursday, according to HDFC Securities Silver was also flat at Rs 76,300 per kilogram. HDFC Securities' senior analyst of commodities Saumil Gandhi said, spot gold prices (24 carats) in the Delhi markets are trading flat at Rs 63,150/10 grams unchanged from the previous close. Meanwhile, in the futures trade, February contract of gold rose Rs 164 to Rs 62,160 per 10 grams on the MCX. Also, March contract of silver climbed Rs 120 to Rs 72,089 per kg on the bourse. In the overseas markets, gold is trading marginally higher at USD 2,031 per ounce, while silver is down at USD 22.97 per ounce. Going forward, traders anticipate that gold prices are likely to trade in a choppy range before the outcome of the **US Consumer Price Index** (CPI) data which will be released later on Thursday Gandhi added.

In her order, Judge Alli stated, "Accused produced through video conference. Heard the Special PP under

section 226 Cr.P.C. Charge framing by January 22, 2024. Petition filed under section 91 (2) Cr.P.C. Check and call by then. Remand extended till then. Accused to be produced in person."

During the hearing, Special Public Prosecutor N Ramesh, representing the prosecution, opened the case under section 226 Cr.P.C. He outlined the charges against Balaji and

explained the evidence that would be presented to prove his guilt, involving the examination of 21 witnesses and 77 documents presented in the charge sheet.

Following this, the judge passed the above interim order and posted to January 22, further hearing of the case. The minister was arrested by the Enforcement Directorate in connection with alleged irregularities in the selection of bus conductors, drivers, and junior engineers within the Tamil Nadu Transport Department. These appointments occurred during Balaji's tenure as the Transport Minister in the AIADMK government between 2011

A division bench comprising Justices R Mahadevan and Mohammed Shaffiq dismissed OPS' appeal noting that there existed no grounds for interfering with the single judge's order of November In November 2023, AIAD-

MK General Secretary Edappadi K Palaniswami (EPS), had filed a civil suit seeking OPS from using the party flag, symbol and letterhead as he had been expelled from the AIADMK. ON November 7, a single judge division bench, comprising Justice N Sathish Kumar, had granted this interim injunction and OPS subsequently filed an appeal.

EPS had stated in November that OPS had been expelled from the party and his continued use of the AIADMK symbol, flag and letterhead, was confusing

the voters. He added that the **Election Commission rec**ognized them under clause 15 of the election symbols (reservation and allotments) order, 1968. Since OPS had been expelled from the party, he had no legal rights to use them, was EPS' contention.

EPS won a big battle against OPS in early 2023 when the Election Commission of India (EC) recognised him as general secretary of the AIADMK. The dual leadership held between EPS and OPS was abolished and EPS became the sole leader of an injunction restraining the party. The EC also allotted the two-leaves symbol to AIADMK and stated that all AIADMK candidates were free to use it. At the time, EPS stated, "This journey has been rough for me.

> It was full of thorns. So many tests and betrayals. But we have now overcome all the problems created by traitors. The struggle to protect AIADMK's 1.5 crore cadre went up to the Supreme Court and we won. Now, our victory is that the ECI has recognised us.'

Mirzapur stands as a distinctive parliamentary constituency in Uttar Pradesh, maintaining a perennial presence in the news headlines. Positioned in the northern expanse of the state, it spans across the Sant Ravidas Nagar-Varanasi region, adding to its geographical and cultural significance.

Its boundaries extend towards Chandauli in the east, Sonbhadra in the south, and Pravagraj in the northwest, creating a diverse and vibrant constituency. Presently, the Sone Lal party is represented by Anupriya Patel, adding a dynamic dimension to the political landscape of Mirzapur.

Dasayu Sundari Phoolan Devi played a pivotal role in shaping the political trajectory of Mirzapur. Phoolan Devi, representing the Samajwadi Party, served as a Member of Parliament from this constituency twice. Delving into the parliamentary history of Mirzapur, which commenced in 1957, the region has witnessed 18 Lok Sabha elections since then.

Mirzapur, as a parliamentary constituency, holds considerable significance in terms of tourism. Every year, thousands of visitors are drawn to the region due to its natural beauty and religious ambiance. In addition to the renowned Vindhvachal Dham, the area boasts attractions such as Sita Kund, Lal Bhairav Temple, Chunar Fort, and Tanda Waterfall.





New details have surfaced in the harrowing case of a four-year-old's alleged murder by his mother in Bengaluru. Suchana Seth stands crime in a Goa hotel room. supposedly driven by a bitter custody battle with her estranged husband, Venkat Raman.

Subsequently, frustrated, Raman departed for Indonesia on the same day. Investigations later uncovered that Suchana had allegedly killed her son on January 8, concealing the body in a bag. The post-mortem findings suggested the child was smothered, either with a cloth or a pillow.

Despite the gravity of the situation. Suchana has reportedly displayed no remorse during the ongoing investigation. The 39-yearold was apprehended in Chitradurga, Karnataka,

Navy proactively deploying fleet to keep pirates at bay: Navy chief

Amid the recent spate of attacks on Indian merchant ships in the Arabian Sea, the Chief of Naval Staff, Admiral R Hari Kumar, on Wednesday said the Indian Navy was proactively deploying its fleet to keep pirates at bay.

Addressing media persons after unveiling the first indigenously manufactured Drishti 10 Starliner Unmanned Aerial Vehicle (UAV) in Hyderabad on Wednesday, the Navy chief said, "Over the past 42 days, as many as 35 such attacks (approximately) have taken place, primarily targeting Israeli-owned vessels. However, no India-flagged vessel

has been attacked so far."

We are now, very proactively, deploying our units there to ensure that the pirates at kept at bay. If you look at the last 40-42 days, about 35 such attacks have taken place, largely on Israeli-owned shipping assets. No India-flagged vessel has been attacked so far," the chief of the Naval Staff said.

The Navy chief added that there have only been two incidents, so far, which prompted the marine warriors to conduct anti-piracy operations.

"Both incidents involved non-Indian-flagged vessels. In the second incident, an Indian crew was aboard the vessel, prompting the Navy to respond," he added.

"Anti-piracy operations were conducted in the wake

of only two such incidents. In both cases, the vessels were not India-flagged. However, in the second incident, there were Indian crew members on board the ship because of which we had to respond. We got the necessary consent from the owners of the vessel and rescued the distressed crew," the chief of Naval Staff said.

"We have not yet been able to identify from where all these attacks are being directed. We have collected debris of drones collected from three ships and are analysing it," the Navy chief said.

Recently, the Indian Navy's marine commandos rescued 21 crew members, including 15 Indians, from the hijacked Liberian-flagged vessel MV Lila Norfolk on January 6, 2024. The crew members were rescued in a swift operation in the North Arabian Sea after armed pirates attempted to hijack the vessel.

In a statement posted on X, the Indian Navy on Friday stated, "Indian Navy's Swift Response to the Hijacking Attempt of MV Lila Norfolk in the North Arabian Sea. All 21 crew members (including 15 Indians) onboard were safely evacuated from the

he Hon'ble Supreme Court, in its historic judgement, unanimously upheld the 2019 revocation of Article 370 of the Constitution. The Supreme Court held that Article 370 was a temporary provision and a feature of asymmetric federalism and not sovereignty. This was, indeed, a victory for India and Indians since the abrogation of Article 370 and the formation of two Union Territories of J & K and Ladhak, by a determined and patriotic Modi Government, has been the most momentous achievement of a united India since Independence.

The Home Minister had made a statement, in 2019, inParliament that 41500 people were killed in J & K since 1989. Terrorism had devastated the region leading to untold misery. Invisible enemies fighting unholy proxy wars, had threatened our democracy, to no end.

After the abrogation of

Article 370 and 35A, on the great day of August 5, 2019, PM Modi gave full priority on development for the people, and the two newly created Union Territories and the people have witnessed a spate of unhindered development as never before. This is evident by the initiatives of the government accelerating development, building infrastructure, reinforcing governance, generating employment, broadening social inclusion and promoting growth.

Long years of unrest

had adversely affected the

State's democratic institu-

tions, particularly those at the grass roots level. The absence of elected local bodies not only deprived the people of the power to take their own decisions regarding development and other issues impacting their day to day lives, but also adversely impacted the flow of resources from the Central and the State Government to rural and urban local self-governing institutions. Immediately after the formation of the UT & J&K, Panchayati Raj institutions were established and made functional and Rs. 366 crore was released directly to 4483 Panchavats, which money was always diverted earlier to vested pockets. Work on the 2206 languishing projects was promptly started.

Similarly, after the new UT of J& K came into being, there was a creation of 45000 employment opportunities, vigorous road construction works, flood management and water supply projects, initiation and acceleration of several power generation and transmission projects, enabling achievement of 100 percent household electrification, process of setting up of over 330 schools and colleges and a university, improved medical infrastructure, beginning of a light rail and public transport system, welfare measures for all including housing, disposal of outcome based grievances, implementation of women and child welfare schemes, scholarships for the deserving, support to farmers, orchardists and unorganized workers, expansion of tourism facilities, sports infrastructure and border area development. These and many more, have germinated and blossomed, after the creation of the Union Territories, in greater proportions restoring full confidence of the people.

The people of J & K have the same rights, benefits and prospects as those in the rest of the country. Domicile certificate is now the basic eligibility condition for recruitment. The Indian constitution is fully applicable to J & K; consequently 170 central laws have now become applicable to J&K, guaranteeing justice and fairness to the underprivileged. The repudiation of Articles 370 and 35A has heralded a new dawn of empowerment, equity and development. The rights of women marrying outside



the UT now stand fully protected and gender discrimination has ended. The special status of Article 370 and 35 A had insulated the state from the rest of India leaving it backward as money was siphoned into vested pockets and did not reach the common man. On Nov 7, 2015, the Prime Minister announced a Reconstruction Plan of Rs. 80,068

Accordingly, post 370 has witnessed a new sunrise by reinforcing governance, accelerating development, building infrastructure, generating employment, broadening social inclusion, providing humanitarian relief and promoting growth.

The Prime Minister has transformed the 'Tasveer' of J&K and the 'Tagdeer' of the people by more than fulfilling their aspirations. Innumerable developmental projects stand completed while several projects are scheduled for completion soon. To promote transparency, the Modi Government has got instituted a portal namely the J & K Infrastructure Monitoring Sys-

tem (JKIMS) by which the progress of work is physically monitored on realtime basis and the status of project implementation can accessed by any individual. The Modi government has rationalized reservation rules to give benefit to the marginalised sections which have remained either unrepresented or under represented. Kashmiri migrants have benefited from a series of welfare measures like employment, transit accommodation and monthly financial assistance.

Law and order has dramatically improved. Terrorism and peoples' miseries have nearly come to an end, despite Pakistan's frustrated efforts to activate its "deep state" again to heat up the environment, even in this state of the COVID pandemic. Abrogation of Article 370 has led to exasperation in the ranks of the terrorists; local recruitment of terrorists has dwindled. Pakistan is now encountering triple frustration - first, at the abrogation of Article 370: second, at the snub it has faced in all international for awhere it has raised the Kashmir issue and, third, at the fact that all its efforts to initiate terrorist acts have only resulted in their constant decimation in every encounter.

The formation of the Union Territory of J&K has not only witnessed development but also evoked patriotism and restored confidence of the people in the Constitution of India and our robust democratic system of a united sovereign India with Justice, Liberty, Equality and Fraternity assuring the dignity of the Indian and unity and integrity of the nation.

The pro-active measures being taken by a determined government, under PM Modi, are ushering in a new era of peace, tranquillity and development.

In the words of PM Modi, "the court has strengthened the spirit of "Ek Bharat, Shreshtha Bharat"..... "development, democracy and dignity have replaced and disillusionment and despondency".

India and Maldives need to handle each other with care

India and Maldives share strong historical, cultural, linguistic, ethnic, religious and commercial links. Maldives got freedom from Britain in 1965 and India was among the first to recognise Maldives after its independence. India had extended a helping hand to the Maldives several times through Operation Cactus in 1988 when the Indian Armed Forces helped the government of Maldives in the neutralization of the coup attempt. In 2014 through Operation Neer when Maldives was facing the drinking water crisis and India supplied drinking water to Maldives. During the time of COVID-19 also India supplied 6.2 tonnes of essential medicines to Maldives, under Operation Sanjeevanias assistance.

But India's relations with Maldives like its other neighbours had been subject to the inclination of the government who is in power. In the recent years during the time of Ibrahim

Mohamed Solih, who was in power from 2018-2023, India shared a very cordial relationship with the Maldives. India signed an agreement with the Maldives to "develop, support and maintain" a harbour at Uthuru Thila Falhu naval base. But Abdulla Yameen, the former President of Maldives, who was pro-China started the 'India Out' campaign, setting a narrative against India. Mohamed Muizzu, the current President of Maldives, since he came to power in 2023, the relationship between India and Maldives is going through tough terrain. President Muizzu has visited Turkey, the UAE, and China since assuming office last year, breaking from the tradition of making India the first foreign destination for a newly-elected Maldivian president. He also asked the Indian government to withdraw its troops as well as its hydrographic surveys, the MoU for which was signed in 2019. Muizzu's campaign fanned anti-India sentiments across the island nation. Amid this dismay, a new

imbroglio kicked off after the three Deputy Ministers Maryam Shiuna, Mahzoom Majid and Malsha Shareef made deprecating remarks about India and PM Modi after his recent visit to Lakshadweep recently. They made disparaging remarks on Twitter (now known as X) regarding India's connections with Israel with the assumption that the Indian Prime Minister's visit to Lakshadweep was intended to pose a challenge to Maldivian tourism. Their comment flamed war of words between Indians and Maldivians on social media resulting in #Anti-India and #BoycottMaldives campaigns getting trended on X. The Indian High Commission in Maldives strongly raised this issue and the government of Maldives took immediate action and suspended those ministers as well as issued a statement where the government of Maldives distanced itself from those remarks. But the spike of hate comments on social media is incessant. Maldives is one of the topnotch holiday destinations for Indians. But amid this controversy large number of booked tickets for Mal-

dives are getting cancelled.

Meanwhile, President

cannot be ignored. China's

Muizzu, termed Beijing as the island nation's "closest" ally during his five-day visit to Beijing and has urged China to send more tourists to Maldives. This controversy has strained the relationship between the two nations.

The hyper-nationalism is hovering all around. But India, the regional giant, needs to understand Maldives> strategic location in the Indian Ocean. Maldives is India's key maritime neighbour in the Indian Ocean Region and occupies a distinctive place in the Prime Minister's vision of 'SAGAR' (Security and Growth for All in the Region) and 'Neighhood First policy'. 'China Factor' is one such issue which

growing presence in the Indian Ocean region and the development of Chinesecontrolled ports and military facilities in Sri Lanka and Maldives is a matter of concern for India. If India does not handle Maldives with care it can end up loosing one important strategic partner. ectic activities are going on in the Opposition camp in the run-up to the Lok Sabha elections this year. Two of these activities are more significant than the others. The first one is Rahul Gandhi's Bharat Jodo Nyay Yatra, which will commence on January 14 and conclude on March 20, covering 6,700 kilometres from Mizoram to Mumbai. The second activity is the fast emerging ideological differences within the INDIA grouping of the opposition parties! In such a situation, will Rahul's yatra be able to muster enough support to take on Narendra Modi's powerful BJP? The answer lies in the future but the analysis has

Yatra from Kanyakumari to Kashmir. Immediately after his yatra, the Congress won Assembly elections in Himachal Pradesh, Karnataka and Telangana too -- though the party lost power in Raiasthan and Chhattisgarh. So now the second yatra, quite obviously, is aimed at appropriating gains in the Lok Sabha elections. Rahul Gandhi's yatra will cover 15 states. There are 357 Lok Sabha seats in these states, with the BJP winning 239 of them in the 2019 general elections. Congress' predicament can be gauged from the fact that it was victorious in only 14 of these 357 seats. Congress could not even open its account in the states like Manipur, Nagaland, Arunachal Pradesh, Rajasthan and Gujarat, covered during the Bharat Jodo Yatra. It won only one seat each in Meghalaya, Uttar Pradesh, Bihar, Jharkhand, Odisha, Madhya Pradesh

and Maharashtra. It bagged three seats in Assam and only two seats each in West Bengal and Chhattisgarh. Rahul Gandhi is aware too that Congress is no longer as powerful as it once was. It neither has resources nor

cadre. Once Rahul told me during a conversation that he had no attachment to power and he was aware of his party's strength. "If we start our work today, we will definitely reach our destination one day. If I think of eating ghee today and becoming strong immediately the next day, it is not possible," he told me. In this background, I think he is in no hurry. He is building a base. BJP too has reached the twothird seats' mark from two

seats! Even though Rahul is in the field like a warrior, his opponents do not fail to say that the more challenges Rahul Gandhi throws, the stronger Narendra Modi's BIP grows.

So, does the BJP want the Lok Sabha elections to be a Modi-Rahul contest rather than a BJP versus INDIA bloc fight? This is exactly what the BJP wants because if the INDIA bloc enters the fray unitedly as a unit, the contest will not be easy for the BJP. The problem with the INDIA bloc is that there is no readymade adhesive available to hold it together. The differences are so pronounced that differences appear more than agreement. Each one of them has his or her own justification. There has been no agreement on seat sharing within the INDIA bloc, but the JD(U) has already announced the name of Ruhi Tagung from Arunachal (West) seat. In fact, in the 2019 Assembly elections, the JD(U) had fielded 15 candidates in Arunachal and seven of them emerged victorious. However, all the seven MLAs later joined the BJP.

The ID(U) has announced not just its candidate in Arunachal Pradesh but also in Bihar where the party is projecting Devesh Chandra Thakur as its candidate from Sitamarhi and Sanjay Iha from Darbhanga. Nitish Kumar is thought to have done this to put pressure on the INDIA bloc. He is not saying anything publicly but everyone knows that he wants to be the convenor of INDIA, and if the alliance wins, he wants to see himself in the Prime Minister's chair. Meanwhile, West Bengal chief minister Mamata Banerjee proposed the name of Congress president Mallikarjun Kharge for the post of Prime Minister and the Delhi chief minister Arvind Kejriwal seconded it. Lalu Yaday does not want Nitish's stature to rise. Lalu and Nitish are at loggerheads. They did not greet each other on New Year's day. Moreover, it was Rabri Devi's birthday on the first day of the New Year but Nitish did not even wish her on her birthday!

In West Bengal, there is a war-like situation between Congress and Trinamool. Adhir Ranjan Chowdhury has even stated that Trinamool is trying to please Narendra Modi to dodge the ED and the CBI. It is not serious about alliance. Trinamool even warned that the party may go it alone. On the other hand, the Samajwadi Party in Uttar Pradesh has also started giving a go-ahead to its candidates. There is confusion everywhere. I feel that in spite of all the talk of strengthening the INDIA bloc, it is actually becoming weaker. As for the BJP, it stands to benefit from the Ram temple and the polarisation of Hindu votes. Therefore, INDIA bloc's unity is as important as Rahul's yatra if the Opposition really wants to take on the BJP. In the present situation, seizing power from Narendra Modi's BJP seems to be nothing more than a daydream.

Long Separation Of 11 Years Peppered With False Allegations & Complaints Is Mental Cruelty: Delhi HC

It is most refreshing and most reassuring to note that the Delhi High Court in a most learned. laudable, landmark and latest judgment titled ABC vs XYZ in MAT. APP. (F.C.) 71/2020 and cited in Neutral Citation No.: 2024:DHC:147-DB while most rightly granting divorce to a man held unambiguously that the long separation of 11 years between the parties peppered with false allegations and complaints amounts to mental cruelty. It must be mentioned here that the Delhi High Court was dealing with an appeal that had been filed under Section 19 of the Family Courts Act, 1984 by the husband against the judgment and decree of the Family Court by which his divorce petition was dismissed on the ground of cruelty under Section 13(1) of the Hindu Marriage Act, 1955. A Division Bench comprising of Hon'ble Mr Justice Suresh Kumar Kait and Hon'ble Ms Justice Neena Bansal Krishna minced just no words to observe unequivocally that, "The parties are separated for about 11 years and the adjustment issues started mushrooming within the very first month of their marriage which were of such nature that the marriage could not

even survive for more

than 6 months. There is

fault of the appellant, in itself is an act of cruelty." Very rightly so!

At the very outset,

this recent, remarkable, robust and rational judgment authored by Hon'ble Ms Justice Neena Bansal Krishna for a Division Bench of the Delhi **High Court comprising** of herself and Hon'ble Mr Justice Suresh Kumar Kait sets the ball in motion by first and foremost putting forth in para 1 that, "The appeal under Section 19 of the Family Courts Act, 1984 has been filed against the judgment and decree dated 22.01.2020, passed by the Learned Judge Family Courts, Dwarka, New Delhi in HMA No.566/17 (OLD No. 124/13) titled as 'Prahlad Kumar versus Deepa', dismissing the divorce petition filed by the petitioner/husband, on the ground of cruelty under Section 13(1) (ia) of the Hindu Marriage Act, 1955 (hereinafter referred to as 'HMA, 1955').

As we see, the Division Bench observes in para 2 that, "Briefly stated the parties got married on 30.11.2011 and no child was born from their wed-

As it turned out, the Division Bench lays bare in para 3 that, "The petitioner/appellant claimed that soon after coming back from their honeymoon on 18.12.2011, the respondent started putting pressure upon him to take her to her parental home and extended threats that in case she was not taken, she would commit suicide and falsely get the appellant and his family members implicated in frivolous cases. The appellant was thus compelled to take the respondent to her parental home on 24.12.2011."

To put things in perspective, the Bench then envisages in para 4 that, "Thereafter, he persistently tried to persuade her and even visited the parental home of the respondent on 08.01.2012 to bring her back. Though, she remained adamant but was persuaded by her family members to return to the matrimonial home. The appellant in order to counsel the respondent to remain in the matrimonial home, called her father and brother to his house on O2.O2.2O12 and 29.02.2012, but they started blaming the appellant himself. Because of the pressure, the appellant again took her to the parental home on 15.04.2012, however, despite the humiliation and insults, the appellant brought her back to the matrimonial home. Eventually, the respondent left

the matrimonial home on

15.06.2012 along with all

her belongings and valu-

ables, in the absence of

the appellant. All his efforts to bring her back did not heed any positive result. A Panchayat was also held on 21.06.2012 but the respondent remained adamant in not returning to the matrimonial home."

As things stands, the Bench specifies in para 5 that, "Faced with this adamant attitude, the appellant got served a Legal Notice dated 07.02.2013, calling upon the respondent to join the matrimonial home. A reply was given by the respondent making false allegations of dowry demand."

It cannot be lost on us that the Bench notes in para 6 that, "The respondent made a complaint against the appellant in Aichik Bureau. The appellant along with his uncle, appeared before the Aichik Bureau on 06.06.2013 where they were abused and beaten up by the respondent and her family. The family members of the respondent also tried to malign the reputation of the appellant and his family members by making a telephonic call to PW-4 Sh. Shiv Kumar, fatherin-law of the brother of the appellant."

To be sure, the Bench states in para 7 that, "After filing of the petition, FIR under Sections 498A, 323, 506 of the Indian Penal Code, 1908 was also registered against the apfather and two other family members, on the complaint of the father of the respondent. The appellant thus, sought divorce on the ground of cruelty under Section 13(1) (ia) of the HMA, 1955.'

Truth be told, the Division Bench points out in para 14 that, "The learned Judge, Family Court referred to the rival assertions of both the parties and concluded that the appellant was unable to prove any act of cruelty and observed that the disputes between the two spouses were normal wear and tear of married life, which could be condoned. The divorce petition was therefore. dismissed." Needless to say, the Division Bench states in para 15 that, "Aggrieved by the dismissal of the divorce petition, the present appeal has been preferred."

It cannot be lost sight of that the Division Bench reveals in para 17 that, "The appellant has deposed that soon after the marriage, the respondent insisted on going to her parental home and he was compelled to leave her on 24.12.2011 and was brought back home on 08.01.2012. Again, on her persistence, she was taken back to her parental home on 15.04.2012, wherein again she threatened to commit suicide and implicate the appellant and his family members. However, she was again brought back with great difficulty. The petitioner/appellant deposed that she was largely involved with her own family members with whom she remained engaged on her phone and frequently threatened the appellant and his family members with false implication in multiple cases. She

was supported in her

threats by her father and

brother, who instead of counselling the respondent, always blamed the appellant and his family members.'

Do note, the Bench notes in para 18 that, "In this context, it is significant to observe that though the respondent was asserting that she was not being taken back to the matrimonial home, it has come lant had served a Legal Notice, dated 07.02.2013, requesting the respondent to join the matrimonial home to which she reverted by sending a reply making allegations of dowry demands." Further, the Division Bench states in para 19 that, "He further deposed that she finally left the matrimonial home on 15.06.2012 along with her brother and Bhabhi, in his absence and took all her valuables and belongings

with her." Most significantly, the Division Bench mandates in para 36 that, "The parties are separated for about 11 years and the adjustment issues started mushrooming within the very first month of their marriage which were of such nature that the marriage could not even survive for more than 6 months. There is no chance of reconciliation between the parties and such long separation peppered which false allegations and complaints have become a source of mental cruelty and any insistence to continue this relationship would only be inflicting further cruelty upon both the parties. The marital discord between the parties has pinnacled as there is a complete loss of faith, trust, understanding and love between the parties. Such long separation brings with it deprivation of conjugal relationship

and cohabitation which

is the basic foundation of any matrimonial relationship. The separation for more than eleven years for no fault of the appellant, in itself is an act of

cruelty." While citing the relevant case law, the Bench observes in para 37 that. "In one of the momentous decisions, the Apex Court Kohli v. Neelu Kohli (2006) 4 SCC 558 has held that once the parties have separated and the separation has continued for a sufficient length of time, the consequences of preservation of the unworkable marriage which has long ceased to be effective, is bound to be a source of greater misery for the parties." While citing yet anoth-

er remarkable case law, the Bench then hastens to add in para 38 stating that, "The Apex Court in the case of Samar Ghosh v. Jaya Ghosh (2007) 4 SCC 511 observed that in a marriage where there has been a long period of continuous separation with no possibility of reconciliation, it can be termed as mental cruelty to continue such a dead marriage." What's more, the Bench further points out in para 39 that, "While referring to the case of Samar Ghosh (supra), the Apex Court in the case of Gurbux Singh vs Harminder Kaur (2010) 14 SCC 301, observed by that while trivial irritations, quarrels, normal wear and tear of married life which happens in day to day life in all families would not entitle a party to a decree of divorce on the ground of cruelty; continuing and subsisting unjustifiable and reprehensible conduct which affects the physical and mental health of the other spouse, may lead to mental cruelty."

While citing the most

laws, the Division Bench expounds in para 40 that, "Recently, the Apex court in the case of Rakesh Raman v. Kavita 2023 SCC OnLine SC 497, after relying upon the above referred observations of the Three Judge Bench in Samar Ghosh (supra), looking at the facts of the said in the case of Naveen case where parties were residing separately for almost 25 years; had no cohabitation during this period; no child was born from the said wedlock; and repeated efforts for reconciliation for settlement resulted in failure, concluded that this relationship must end as its continuation is causing cruelty on both the sides. The long separation and absence of cohabitation and the complete breakdown of all meaningful bonds and the existing bitterness between the two, has to be read as cruelty under Section 13(1) (ia) of the 1955 Act." No wonder, the Division

Bench rightly holds in para 41 that, "We therefore conclude from the evidence of the parties that the appellant was subjected to cruelty.'

In addition, the Division Bench directs in para 42 that, "The appeal is, therefore, allowed and the divorce is granted on the ground of cruelty under Section 13(1)(ia) of the HMA, 1955.'

Finally, the Division Bench concludes by holding in para 43 that, "The Decree Sheet be prepared accordingly.'

All told, we thus see that the Delhi High Court after perusing the facts of the case very rightly grants divorce to the husband. It is rightly concluded by the Court that a long separation of 11 years peppered with false allegations and complaints is mental cruelty! No deny-

JAMMU AND KASHMIR AND LADAKH HIGH COURT: ADOPT LIBERAL APPROACH TO AMENDMENTS BEFORE TRIAL UNLESS IT CAUSES **IRREPARABLE PREJUDICE TO OPPOSITE PARTY | 0.6 R.17 CPC**

he Jammu and Kashmir and Ladakh High Court in the case Haja @ Hajira Bano Vs Gh. Mohammad Ahangar observed and has ruled that courts must adopt a liberal approach and allow amendments under Order 6 Rule 17 of the Civil Procedure Code, CPC unless they cause irreparable prejudice to the other party or change the very nature of the suit.

The bench headed by Justice M A Chowdhary in the case observed and has stated that whenever an amendment is sought before the commencement of a trial, a lenient view may be taken keeping in mind that the opposite party would have a chance to meet the case set



up by amendment.

In the present case, the court was hearing the petition moved challenging the order passed by the Court of Sub Judge, Chadoora in terms of which an application seeking leave to amend her civil suit had been re-

The court stated that the issue raised stemmed from a dispute over ancestral property in Budgam district.

Therefore, the plaintiff, Haja Alias Hajira Bano, filed a partition suit against her brother and other family members. Thus, after the initial proceedings, she seeks to amend the plaint to include a newly discovered sale deed involving part of

The Trial Court in the case observed and has rejected the amendment application citing order 2 Rule 2 of the CPC, which bars subsequent suits for claims omitted from the initial suit.

the property.

The bench of Justice Chowdhary while overturning the order passed by trial court clarified that Order 2 Rule 2 applies only to separate suits, not amendments within an existing one.

The court emphasized that the trial court had misdirected itself in rejecting the amendment application, as it did not consider the liberal approach required before the commencement of the

The bench in the case observed that where the amendment is sough before commencement of the trial, which is the position in the present case as well, the Court is required to be liberal in its approach. The said court is required to bear in mind the fact that the opposite party would have a chance to meet the case set up by amendment, as such, where the amendment does not result in any irreparable prejudice to the opposite party or divests the opposite party of an advantage which it had secured as a result of admission by the party seeking amendment, thus, the amendment is required to be allowed.

The court in the case observed that the essentiality of an amendment to deter-

mine the real controversy between the parties the court noted that the Petitioner or plaintiff had sought amendment with regard to mentioning of a sale deed with regard to a portion of the Suit property and, the trial court for amendment of the Plaint was allowed and the Trial Court was directed to take on record the Amended Plaint for further proceedings in the case as per law.

The court while considering the facts and circumstances of the case observed and has allowed the application moved by the Petitioner or plaintiff before the Trial Court wherein the court directed to take on record the Amend Plaint for further proceedings in the case as per the law.

Accordingly, the court allowed the plea.

Delhi High Court Raps Civic Authorities Over Water-Logging, Delhi's Drainage System In 'Very Bad State'

The Delhi High Court in the case Court On Its Own Motion v. Govt Of NCT Of Delhi And Ors observed and has rapped the civic authorities over the issue of waterlogging in the national capital and said that the drainage system here is 'totally pathetic' and is in 'very bad state of affairs.' The Division bench comprising of Acting Chief Justice Manmohan and Justice Manmeet Pritam Singh Arora in the case observed and has stated that the drainage system is in a very bad state of affairs. It had totally collapsed and do we have any system in Delhi or we don't have it? It is absolutely pathetic. In the present case, the suo motu Public Interest Litigation, PIL was initiated in the year 200 over the lack of rainwater harvesting efforts taken by the authorities and huge traffic snarls, especially during monsoon. The court while referring to various areas in the city facing the issue of water-logging remarked that the authorities must treat it as a 'wake up call' and 'start working It has also been informed by the

on the issue now itself.'

court to the authorities that do not wait for April or for the monsoon. To put it mildly, things are very very bad and your agencies cannot be tamed by anyone and everybody is a tiger in his own area, nobody listens to anyone or to any advice. Further, the court stated that the reform on the issue has to come from within the city authorities, while adding that the courts cannot do everything.

The court asked the authorities to get instructions on the issue, the court listed the matter for hearing next on January 16.

The court in the case was hearing the suo motu petition initiated after the court took note of an article published in the Times of India on June 18, 2022. The counsel, Ministry of Urban Development and Ministry of Road Transport, Delhi Government, DDA Commissioner of MCD, Principal Secretary of PWD, Commissioner of Police, Spl. C.P. (Traffic), Delhi Jal Board, Delhi Cantonment Board, NDMC and Flood Irrigation Department represented the respondent.

Delhi High Court: True Love Between Adolescents Cannot Be Controlled Through Police Action

The Delhi High Court in the case observed and has stated that true love between two individuals, one or both of whom may be minor or minors on the verge of majority as the same cannot be controlled through rigours of law or State action.

The bench headed by Justice Swarana Kanta Sharma in the case observed and has stated that the dilemma at times faced by the court can be of trying in order to justify the State or the Police action which is against an adolescent couple, who marry each other and continue to lead a peaceful life and raise a family. and respect for obeying the law of the land.

The court in the case stated that when the scales of justice have to be weighed, they are not always on the basis of mathematical precision or mathematical formulas, but at times, while one side of the scale carries the law, the other side of the scale may carry the entire life, thus, the happiness and future of toddlers, their parents and parents

of their parents

Adding to it, the court stated that the scale that reflects and portrays such pure happiness sans any criminality will definitely equal to the scale carrying law as the application of law which is meant for maintaining rule of law.

The bench headed by Justice Sharma in the case observed while quashing the kidnapping and rape case registered which is against one Arif Khan who eloped with a minor girl and got married as per Muslim rites and ceremonies as they belonged to the same religion.

In the present case, the FIR was registered by the father of girl, thus, when she was recovered, she was five months pregnant. Further, She in the case refused to abort the child while stating that it was born out of her marital union and love for her husband.

Therefore, the court stated that the man was apprehended in June 2015 and remained in jail till April 2018 when he was granted bail.

The court observed that the couple was living together and

another daughter was also born from their wedlock

The bench headed by Justice Sharma in the case observed that the love story of the couple was 'unfortunately interrupted' by the entry of investigating agency which was to work as per existing law.

It has also been informed by the girl to the court that she had voluntarily entered into a consensual relationship with Khan and that she was 18 years of age at the time of incident and the same was disputed by the Delhi Police, since as per school records her age was shown less than 18 years.

The court noted that the girl was pregnant when Khan was arrested and had made a choice to continue pregnancy and give birth to the child.

The court stated that the parties herein had made a choice with themselves, even though law did not permit them to enter into a marital union.

The court observed that she supported the case of the petitioner Mr. Khan, at every stage, and not the case of the State

and the parties have now been

married for about nine years, and have been blessed with two daughters, and they are happily raising their children.

The bench of Justice Sharma in the case observed that the court's role extends beyond a mere application and interpretation of statutes and involves an understanding of the implications of its decisions on individuals and the community at

The court stated that this court must weigh competing interests, while considering the impact of its decisions on the parties involved and the broader implications for justice, fairness, and social order.

The court while considering the facts and circumstances of the case stated that the FIR is not quashed and the same will result in affecting the future of the daughters born from this union which will result in failure of effective and real justice.

DELHI HIGH COURT: STUDENT IS ENTITLED TO FULL MARKS IF EXAMINER FAILS TO AWARD MARK BUT PUTS A TICK AGAINST ANSWER PROVIDED | CBSE BOARD EXAM

The Delhi High Court in the case observed that the students is being entitled to full marks where the examiner fails to award mark in the margin against a particular answer even after entering the tick mark wherein it is indicated that the answer is

The bench headed by Justice C Hari Shankar in the case observed and has stated that consequence of the lapse of the examiner, if any, cannot be visited on the student.

The court in the case stated that even if there is an error at the end of the examiner, so long as the answer sheet does not reflect the examiner's view as being that the answer is incorrect and the student has to be given the benefit of doubt.

The court observed that assuming the examiner is remiss in a particular case with regards to the manner in which he has marked the answer sheet, the student cannot be made to suffer and, unless the said court is satisfied that the examiner has found the answer to be incor-

rect, the student has to get the benefit of marks allotted to the question, against the answer that he has provided. Adding to it, the court statswer.

ed that this court is of the considered view that while the failure to award marks in the margin against a particular answer even after entering a tick() mark may be a lapse on the part of the examiner in order to strictly comply with the instructions issued by the CBSE, thus, the student cannot be made to suffer for that reason. The court made the said

observations while awarding the full marks to a girl against the answer provided by her to a question in Class XIIth Board Examination's Geography paper held in March last year.

In the present case the girl moved the court that the examiner had entered two answer to the question and thus, she was being entitled to full marks against the an-

On the other hand, it has been contended by the CBSE before the court that as the examiner did not enter any mark in the margin alongside the answer to the question, the Board could not have awarded any mark against the answer.

The court in the case observed that as long as the examiner found the answer which are provided by the student to be correct, there can be no question at all of the student being awarded no marks against that answer. The court stated that the decision on whether an answer to a question is relevant, correct, or incorrect, vests in the examiner. Thus, the CBSE cannot sit in appeal over the decision of the examiner. Adding to it, the court

stated that if the answer to a question is correct, the student is being entitled to be awarded marks against that answer. The court in the case ob-

served that if the examiner has not assigned any mark less than the maximum marks which can be awarded against that question, the student is entitled to be awarded the maximum marks. The court is of the opinion that the petitioner is entitled to full marks against the answer which are provided by her to Question 27 of the Geography paper held on March O2, 2O23 in the Class XII Board Examination. The bench headed by Justice Shankar in the case observed and has directed the CBSE to issue a corrected mark sheet to the girl by adding 5 marks against the answer provided to the question. The counsel, Advocate Mr. Musheer Zaidi and Advocate Ms. Zahra Naqvi appeared for the Petitioner.

DELHI HIGH COURT: SCHOOL CANNOT REFUSE ADMISSION IF DOE SATISFIED THAT CHILD IS ENTITLED TO PREFERENTIAL **ADMISSION UNDER EWS/DG CATEGORY**

The Delhi High Court in the case Ojas Satyawali Through His Mother Bhawna Pathak v. Directorate Of Education And Anr observed that once the Directorate of Education, DoE is satisfied that a child is entitled to preferential admission under the Economically Weaker Sections, EWS or Disadvantaged Group, DG category, the school cannot refuse admission to the

The bench headed by Justice C Hari Shankar in the case observed and has stated that it is the child welfare which is paramount and law cannot countenance a situation in which, despite DoE having found the child entitled to admission, school refuses the same.

The court stated that the



authority to grant admission to EWS, DG, CWSN category has been conferred on DoE. Thus, it being the DoE which is required to carry out requisite verification and satisfy itself that child in question is entitled to preferential admission under the said category and if the DoE is satisfied on that count, the respondent-School cannot refuse admission to the

The bench of Justice Shankar in the case was dealing with the petitioner moved by the 7-year-old boy against denial of admission by a school to him under EWS category, despite allotment by DoE.

The court in the case observed and has confirmed the order passed by the coordinate bench on September 15 last year wherein the

court directed the school to grant admission to the minor in Class I in the EWS, DG, CWSN category for 2023-2024 academic session. The court in its order stated

that the child shall continue to receive education in the school in the said category in accordance with law. The court stated that the admission of the petitioner

shall stand regularized accordingly. Accordingly, the court allowed the writ petition.

Punjab and Haryana High Court Pulls Up State Authorities For Not Sending Police Verification In Prescribed Proforma Passport

The Punjab and Haryana High Court in the case Vikramjeet Singh v. Union of India and others has pulled up state authorities for not sending the police verification for issuing passport in the prescribed proforma, despite specific directions issued in different cases repeatedly.

The court in the case observed that in September 2023 that the police authorities are sending incomplete reports which is the 'root cause of denial of passport'.

The court directed the police authorities to disclose complete status of FIR in verification done for issuing of the passport.

It has also been emphasized by the said court that the proforma prepared for

the information to be furnished by the Police Official in the meeting called by the Additional Solicitor General of India, pursuant to the case Mohan Lal @ Mohna vs. Union of India and others, which needs to be followed.

The bench of Justice Jag-

mohan Bansal in the case observed and has stated that despite specific orders passed in Mohan Lal @ Mohna (supra) as well as order dated September 13, 2023, the State authorities have not started sending police verification report in the prescribed proforma.

Therefore, the passport authorities are also not asking the police officials to send their report in the prescribed proforma.

The court stated that the afore-stated orders was passed to avoid undesired litigation wherein neither the passport authorities nor the police authorities are interested to avoid litigation.

The passport authorities were directed to implement the aforesaid orders in letter and spirit and if the authorities in future fail to implement the afore-stated orders, they would be hauled up in contempt proceedings.

The court made the said observations wherein the petition is moved by the applicant denied passport due to 'adverse police verification' and he was being acquitted in a criminal case and appeal against the same was pending before the High Court.

The court noted that the police verification was not done as per the prescribed proforma which is the cause of the rejection of his application, thus, the Court had issued notice to Union government and State.

The counsel, Raman Sharma, Addl. A.G.Haryana, asserted before the court that the order passed by the court in the case Mohan Lal @ Mohan case has not been circulated to field staff, thus, police officials are still sending report as per old proforma.

The counsel, Senior panel counsel for Union of India submitted before the court that the application of the petitioner would be considered and disposed of within six weeks.

Accordingly, the court disposed of the plea.

The counsel, Kushagra Beniwal, Advocate appeared for the petitioner.

The Senior Panel Counsel, Amit Sharma appeared for the Union of India.

The counsel, Raman Sharma represented the Addl. A. G. Haryana.

SOUTH AFRICA LIKENS GAZA STRIP TO CONCEN-TRATION CAMP IN WORLD COURT CASE

A lawyer representing South Africa's legal team has called the Gaza Strip "a concentration camp where genocide is taking place." John Dugard made the remarks while he was laying out a case in front of the International Court of Justice Thursday that South Africa has jurisdiction to take Israel to court over the genocide charge. He was repeating remarks made in 2023 by South African President Cyril Ramaphosa. The genocide charge strikes at the heart of Israel's national identity and such comparisons of Israel's war in Gaza to Nazi concentration camps on a world stage are likely to stir emotions in Israel, which sees itself as a bulwark of security for Jews after 6 million were killed in the Holocaust. International support for Israel's creation in 1948 was deeply rooted in outrage over Nazi atrocities. South Africa wants the court to rule that Israel is committing genocide in its war against Hamas in the Gaza Strip. Israel denies the charges, saying it is fighting a war of self-defense following Hamas' deadly October 7 attack.

TAIWAN PREPARES FOR CYBER AND INVASION THREATS AMID RISING GEOPOLITICAL TENSIONS

In the shadow of looming geopolitical tensions, Taiwan grapples with a multifaceted doomsday scenario, contemplating the prospect of a Chinese invasion coupled with an insidious wave of cyberattacks. Beyond conventional military threats, the island faces persistent and escalating cyber dangers, marked by a daily onslaught of approximately five million attacks, a menacing surge amplified in the lead-up to the presidential election. Fortinet's report of an 80% spike in cyber attacks during the first half of 2023 underscores Taiwan's vulnerability, earning it the dubious

distinction of topping Asia Pacific rankings. The threat landscape extends beyond government and defense entities, reaching the heart of Taiwan's global significance—the semiconductor industry. Ambassadors of Palestine, Egypt, Qatar, the UAE, Libya, Iran, Kuwait, Saudi Arabia, Oman and Iraq attended the meeting. The President was accompanied by Foreign Minister Ali Sabry among others, local media reports said.

"Wickremesinghe ad-

vocated for the establishment of a permanent Palestinian government and emphasised that a twostate solution couldn't be realised with a single state. Terrorist attacks by Hamas shouldn't justify the ongoing bombardment of Gaza," it said.

The development comes days after the Sri Lankan Navy, on the directions of the President, announced that it was preparing to join a US-led coalition to protect merchant vessels sailing in the Red Sea against attacks by Yemen's Houthi rebels. Responding to the criticism by the opposition, the government in parliament defended the decision saying safeguarding shipping lines was important as it would adversely impact shipping costs hurting Sri Lanka's already battered economy. Since November 2023, the Iranian-backed Houthis have been attacking merchant and com-

mercial vessels in the Red Sea impeding global commerce and undermining navigational rights. They have said they launched the attacks with the aim of ending Israel's devastating air-and-ground offensive in the Gaza Strip that has killed more than 23,000 people. The Nepal court has sentenced cricketer Sandeep Lamichhane to eight years of imprisonment in a rape case. A single-judge bench of Sishir Raj Dhakal also imposed a3,00,000 fine on the cricketer, besides ordering him to pay a compensation of 2,00,000 to the victim.

Nepal's cricketer Sandeep Lamichhane had previously been indicted in a rape case by the Kathmandu District Court. The verdict, issued in December last year by Shishir Dhakal's bench, followed the concluding statements of both sides.

Despite the Apex Court's order on February 23 of this year to expedite the case through a fast-track process, the hearing faced delays due to various circumstances.

OPPOSITION IN POLAND PROTESTS AGAINST NEW PRO-EU GOVERNMENT POWER SHIFT

oland's right-wing opposition, frustrated over its recent loss of power, urged its supporters to protest on Thursday against moves by the new pro-European Union government to take control of state broadcasters and the state news agency. The Law and Justice party, which governed for eight years before losing October's parliamentary elections, called for a protest by "Free Poles" outside parliament. It portrayed the protest as a defense of democracy and free media, although during its time in power it was criticized for curbing media freedom.

It was unclear what the response would be, but emotions have been riding high over an escalating standoff between the current and the previous government. About 1,000 special forces troops were on standby to prevent further unrest, Prime Minister James Marape said during a news conference on Thursday as he announced an investigation into the crisis. In addition to David Manning, the commissioner of police, Marape also suspended the heads of the government's finance, treasury and personnel management departments, as per The New York Times.

There were signs that the authorities had been able to regain some control, with the US Embassy in Port Moresby saying in a statement on Thursday that the police and defence forces had returned to work. "However." it added, "tensions remain high--the relative calm can change at a moment's no-

Marape, who has pushed for closer ties with the United States and Australia while also maintaining economic links with China, suggested the unrest had been orchestrated by his political opponents, as per The New York Times.

He said, "You want to change the government, change it on the floor of Parliament. Not using my people to create lawlessness and recklessness."

POWERFUL STORM HITS LARGE PARTS OF **EASTERN US**

A powerful storm has battered large areas of the eastern US. The storm has knocked out power across several states, leading to multiple rescues. It delivered its final blow to New England on Wednesday, CNN reported. On Wednesday, multiple rivers were at major flood stage in the eastern US, most of them in the Northeast and mid-Atlantic. Flooding forced evacuations in New Jersey and Connecticut, where the Yantic River came dam was damaged.

In Alabama, Georgia and North Carolina, as many as four deaths were reported as storms hit the states with fierce winds, rain and tornadoes. An 81-year-old woman was among those killed after her Cottonwood, Alabama, mobile home was flipped multiple times on Tuesday, according to Houston County Commission Chairman Brandon Shoupe. The number of power outages dropped as the storm moved away, but more than 120,000 homes and businesses

were in the dark on Wednesday night in the eastern US, primarily in New York, Pennsylvania, New Jersey, Vermont and Maine, according to PowerOutage.us. And high temperatures in the Northeast were expected to top out only in the 30s and 40s on Wednesday, leaving many without power in frigid weather, as per CNN.

The storm generated 25 tornado reports across Texas, Alabama, Florida, Georgia and South Carolina since Monday. In South Carolina, "significant damage" from a potential perilously close to hitting tornado was reported in a record high level and a the city of Bamberg, 60 miles south of Columbia, where the century-old City Hall building collapsed, according to city clerk-treasurer Robin

A section of Interstate 80 in Iowa had to be closed down on Tuesday afternoon due to whiteout conditions that led to a multi-vehicle crash. In Kansas, around 30 people, including children, got stranded and had to be rescued from vehicles and taken to a high school during blizzard and whiteout conditions on Monday, CNN reported.

EU court adviser recommends multibillion fine for Google in antitrust case

US-INDIAN SATELLITE TO MONITOR EARTH'S FROZEN SURFACES IN ICE, SNOW ENVIRONMENTS

NISAR, the radar satellite Set to be launched in 2024 by ISRO from southern India, NISAR will observe nearly all the planet's land and ice surfaces twice every 12 days, according to NASA Jet Propulsion Laboratory press release.

The satellite's insights into Earth's cryosphere will come from the combined use of two radars: an L-band system with a 10-inch (25-centimeter) wavelength and an S-band system with a 4-inch (10-centimeter) wavelength.

NISAR's orientation in orbit will enable it to collect data from Antarctica's far interior, close to the South Pole. Antarctica's ice sheets hold the planet's largest reservoir of frozen fresh water, and the rate at which it may lose ice represents the greatest uncertainty in sea level rise projections, according to NASA Jet Propulsion Laboratory.

According to the press release, NISAR's increased coverage will be crucial for studying the motion of ice flowing down from central Antarctica's high elevations towards the sea. The measurements will also enable scientists to closely study what happens where ice and ocean meet. Both Antartica and Greenland have ice shelves--masses of ice that extend from land and float on the ocean that are thinning and crumbling as icebergs

IRAN LOOMS LARGE AS UN SECURITY COUNCIL CONDEMNS HOUTHIS

The United Nations Security Council didn't name Iran explicitly, but the message was clear, stating that Yemen's Houthis wouldn't be able to threaten global trade if not for the Islamic Republic's support. On Wednesday, the council voted 11-0, with four abstentions, in favour of a US and Japan-sponsored resolution condemning the Houthis' repeated attacks on ships traversing the Red Sea and demanding an immediate halt to them, along with the release of the crew of a Japanese-operated cargo ship taken hostage on November 19. The ship is affiliated with an Israeli businessman.

The Houthis vowed in early December to target any Israel-bound ship in the Red Sea, regardless of its ownership. Since November 19, they have attacked or harassed 26 ships, according to the US military's Central Command (Cent-

com). This includes the hijacking of the MV Galaxy Leader in November. The cargo ship and its crew of 25 are being held hostage in Yemen's port city of Hodeidah.

From bases along the Yemeni coast, the Iran-backed Houthi rebels have attacked and harassed ships in the Red Sea as they traverse the Bab el-Mandeb Straits, a narrow maritime chokepoint between the Arabian Peninsula and Africa. The majority of the world's oil passes through the strait from the Indian Ocean towards the Suez Canal and the Mediterranean Sea. The attacks have forced some major shipping companies to reroute around Africa, interrupting a crucial global trade route connecting Asia and the Middle East to Europe.

A US-led coalition of countries has set up shop in the Red Sea to ward off further attacks. Undeterred by military action or threats of further consequences, the Houthis fired their largest-ever

German diplomat offers support to de-escalate South China Sea

Germany's top diplomat said on Thursday that China's actions in the South China Sea violate the rights of Asian coastal states like the Philippines and threaten freedom of navigation, but added that territorial disputes have to be resolved peacefully because "the world doesn't need another crisis." Annalena Baerbock, who held talks with Philippine President Ferdinand Marcos Jr. and other top officials while visiting Manila, said Germany was ready to help de-escalate growing tensions and added that it was crucial to set up "mechanisms" to resolve the disputes peacefully and foster dialogue. "There are truly rough winds blowing across the South China Sea and this is happening in the middle of one of the most dynamic economic regions of the world," she told a news conference in Manila, speaking

through an interpreter. "It is now important to set up mechanisms to solve tensions together in a peaceful way," she said without elaborating. "I think we all agree that the world doesn't need another cri**CHINESE OFFICIALS DID NOT IM-MEDIATELY ISSUE A REACTION.**



Swathi's (Konkana Sensharma) dream is to open a restaurant and she makes paya (mutton soup) day after day in this endeavour. Her husband, Prabhakar aka Prabhu Shetty (Manoj Bajpayee)'s dream is to build a fancy resort. But he is in business with his elder brother, Arvind Shetty (Saiyaji Shinde) who calls all the shots where finances are concerned. The husband-and-wife, who reside in a small town in the hilly terrains of Tamil Nadu, are constantly at loggerheads as

Prabhu is conjuring up a way to swindle his brother of crores while Swathi is up to some no good herself. The scheming, loser husband is indulging in exhilarating massages by Umesh Pillai (Manoj Bajpayee), interestingly a Prabhu lookalike, with his brother in an attempt to convince him to part with his money. But foul-mouthed, crass but shrewd Arvind is in no mood to consent. Suddenly comes into the story a private detective,



blackmail and murder, and tremendous chaos ensues. Bodies start dropping like flies and a killer/s are on the loose. Will Inspector Hassan (Nasser), constable Asha (Shilpa Mudbi) and Thupalli (Anbuthasan) crack the case?

Director Abhishek Chaubey's dark comedy, Killer Soup, has everything that is required to spice up this mutton soup i.e. blackmail, shady photos, extra-marital affairs, murderers, private detectives, cover ups and more. Manoj Bajpayee and Konkana Sensharma stand out in their roles and are aided by fine performances by veterans Nasser and Saiyaji Shinde. The effortless chemistry between Manoj Bajpayee and Konkana and their really natural interaction on screen keeps you

invested. Nasser, however, is the one that gets you hooked with the about-to-retire cop character.

The story may be set in Tamil Nadu but the characters speak Hindi, Tamil, Dakhini and English liberally, which makes the series more engaging. The nuances of each language are different and coupled with the desi accents of the diverse character adds tremendous flavour to the story. Kudos to Chaubey for such detailing.

So, how engaging was this first web series by Kaminey and Ishqiya director Abhishek Chaubey? Killer Soup is a good watch for the most part but somewhere one feels that a little more punch was required to make it Michelin-starred. There are clear shades of Chaubey's earlier works in this eight-part series that is streaming on Netflix. In another aspect, this series is a cop drama too, or more accurately, a small-town whodunnit with a plethora of characters flitting in and out to take the story forward.

factured medicines.

Moreover, the government has provided distinct timelines for the implementation of the Revised Schedule-M, allowing both large-scale enterprises and smaller units sufficient time to adapt to the new compliance standards. This strategic approach includes a 12-month grace period for small-scale manufacturers and a six-month window for larger units to obtain WHO-GMP certification, commencing on August 2, 2023.

As industry leaders advocate for a shift towards a Pharmaceutical Quality System (PQS) approach, it is evident that a commitment to innovation and quality will continue to shape the future of India's pharmaceutical landscape. With these concerted efforts and initiatives, India is well on its way to ensuring that the quality of medicines available to its citizens matches the highest global standards, reinforcing its position as a pharmacy for the world and foritsown people.



THE ROLE OF GUT MICROBIOTA IN DIABETES: **EXPLORING THE GUT-BODY CONNECTION**

The human body has been seen as a tightly woven tapestry. with organs playing distinct roles in a grand physiological orchestra. But beneath the surface, a hidden chorus of trillions sings a vital melody: the gut microbiota. These microscopic maestros, residing within our intestines, are not mere bystanders; they are active conductors, influencing our health in ways we are only beginning to understand. And in the complex dance of diabetes, their role is proving to be both profound and intricate.

Diabetes, a metabolic illness defined by elevated blood sugar levels, has long been related to factors such as heredity and lifestyle. Recent study, however, has revealed an unexpected guest player in this drama: the gut flora. Studies have revealed a significant variation in the composition of gut bacteria between those with and without diabetes. This shows that when the microbial symphony is out of tune, it can contribute to the development and progression



tabolism. Beneficial bacteria create short-chain fatty acids (SCFAs), which affect insulin sensitivity and glucose absorp-

of this chronic disease. So, how do these tiny maestros conduct the diabetic dance? Their influence is multifaceted, operating through a series of intricate mechanisms.

1. Metabolic Mayhem: Our gut bacteria are like small factories, producing a variety of substances that affect our me-

tion. However, in diabetes, the generation of these beneficial SCFAs may be interrupted, resulting in poor glucose management.

2. Inflammatory Interlude: Gut bacteria are also important in regulating inflammation. Pro-inflammatory chemicals can be generated when the microbial balance is disrupted, resulting in chronic low-grade inflammation. This inflammation, in turn, can compromise insulin signaling and contribute to diabetes development.

3. Breakdown of the Gut Lining: The gut lining serves as a barrier, preventing dangerous substances from entering the bloodstream. In diabetes, however, this barrier can become leaky, allowing bacterial compounds to enter the body and aggravate inflammation. The gut microbiota can alter the barrier's integrity, providing another layer to the compli-

cated interplay. 4. Hormonal Balance: Gut bacteria also influence hormone production, which regulates hunger, fullness, and digestion. Diabetes can interrupt this hormonal symphony, resulting in weight gain and subsequent metabolic abnormalities.

Understanding the role of the gut microbiota in diabetes opens up exciting avenues for therapeutic interventions. Probiotics, prebiotics, and even fecal microbiota transplantation are being explored as potential ways to modulate the gut orchestra and restore balance. By harmonizing the microbial melody, we may be able to conduct a new kind of dance - one where diabetes loses its grip on our health.

However, it is important to remember that this is still a young field of research. While the evidence is promising, more studies are needed to fully understand the complex interplay between the gut microbiota and diabetes. Nevertheless, the gut symphony is captivating researchers and offering a new perspective on this chronic disease. By listening closely to the chorus of microbes within, we may finally find the key to turning the tide on diabetes and dancing towards a healthier future.


SOME OIL PLEASE: A RELAXING, LUXE NOON AT THE RAFFLES SPA!



CAN SUSPENDS SANDEEP LAMICHHANE FROM NATIONAL, INTERNATIONAL GAMES

Kathmandu: The Cricket Association of Nepal (CAN) suspended rape-convicted former national team captain Sandeep Lamichhane from all national and international games.

In a press release issued on Thursday by the nation's cricket governing body, Chatur Bahadur Chand, Chairman of CAN, announced that the rapeconvicted player has been removed from the national team and will no longer represent the nation in any game format.

The decision of the cricketing body comes a day after the Kathmandu High Court sentenced the spinner to an 8-year jail term after he was proven guilty of rape.

The bench of Shishir Raj Dhakal handed over the verdict of 8 years imprisonment along with compensation and penalties after a hearing on Wednesday. Earlier, the Kathmandu



indicted Lamichhane in the rape case.

The court had paused the hearing time again after Sandeep travelled to Zimbabwe to participate in the World Cup qualifiers. Lamichhane, who stayed behind bars for a few months, was released on bail in January Cricket World Cup League last and later allowed to travel abroad.

The Patan High Court had repelled the order of the Kathmandu District Court to send Lamichhane to juciting a lack of grounds to keep him in custody. He was released on bail of Rs 2 million the next day.

Lamichhane had also moved to the SC, demanding he be allowed to travel with the national team to the UAE to play ICC Men's 2 matches against the UAE and Papua New Guinea at the end of February.

Lamichhane had denied the rape allegation in his statements to police.
