

## CJI to Centre: 'How can you not accept an amendment by Parliament?'

The Supreme Court on Wednesday expressed astonishment at the Centre's assertion that it does not accept the 1981 amendment to the Aligarh Muslim University (AMU) Act, which granted minority status to the institution. The court emphasised that the government must uphold what Parliament has enacted.

A seven-judge Constitution bench led by Chief Justice D Y Chandrachud, along with Justices Sanjiv Khanna, Surya Kant, J B Pardiwala, Dipankar Datta, Manoj Misra, and Satish Chandra Sharma, is deliberating on the contentious issue of AMU's minority status. The bench remarked that Parliament is an "eternal, indestructible body" under the Indian Union.

### **SC TO EXAMINE BAR COUNCIL OF INDIA'S RULES ON LAWYER STRIKES**

The Supreme Court on Wednesday said that it will examine the rules drafted by the Bar Council of India (BCI) to address issues related to strikes by lawyers.

A bench of justices Sudhanshu Dhulia and SVN Bhatti scheduled further hearings on the matter for February.

The BCI had submitted a draft rule to tackle concerns related to lawyer strikes. BCI Chairman Manan Kumar Mishra, a senior advocate, informed the court that the rules were open for examination, and any suggestions from the court would be accepted without conditions.

The court stated, "We will examine these rules. The rules therefore need to be examined in detail."

Chairman Mishra also conveyed to the court that they had considered suggestions from the petitioner's lawyer, Prashant Bhushan, while formulating the rules addressing issues related to lawyer strikes.

Amid the rush of devotees

The court was hearing a contempt petition filed by the NGO Common Cause regarding lawyer strikes. The petitioner sought action against lawyers abstaining from work and urged the BCI to issue directives incorporating rules prohibiting strikes by advocates in the 'Standards for Professional Conduct and Etiquette' framed under Section 49(1) (c) of the Advocates Act, 1961.

During the hearing, Prashant Bhushan proposed that if a requisition for a meeting to consider a strike is received, committee members, a Bar Association. or Bar Council should refuse to call a meeting for that purpose. Additionally, if a strike call is given by any officeholder of the Bar Council or Bar Association, immediate disciplinary action should be initiated against them for professional misconduct by

the concerned Bar Council. BCI Chairman Mishra advocated for practicality, emphasizing that they can't deny a lawyer the right to observe a strike in protest of certain incidents.

In her application before the Varanasi court, rejected on October 21, 2023, Singh argued that surveying the wazukhana, excluding the 'Shivling,' is essential to determine the religious character of the property.

However, the district judge, in his order, noted that the apex court on May 17, 2022, had mandated the proper protection of the area where the 'Shivling' was claimed to be found. Consequently, directing the ASI to survey the area would be in violation of this

On July 21 last year, the Varanasi district court had instructed the ASI to conduct a "detailed scientific survey"—including excavations, where necessary—to establish whether the mosque near the Kashi Vishwanath temple was constructed on a temple site. The survey would exclude the mosque's "wazukhana," where Hindu litigants claimed the existence of a 'Shivling,' in adherence to a previous Supreme Court order protecting that specific spot in the mosque complex.

Hindu activists assert that a temple previously stood at the site, demolished in the 17th century on the orders of Mughal emperor Aurangzeb.

## NDMC APPROVES TECH-DRIVEN EDUCATION AGENDAS IN COUNCIL MEETING

he New Delhi Municipal Council (NDMC) has approved several proposals aimed at benefiting citizens, employees, and advancing technologydriven educational initiatives. During a meeting on Wednesday, January 24, 2024, the NDMC members extended their appreciation to Prime Minister Narendra Modi for inaugurating the Ram temple in Ayodhya.

Among the approved proposals, the NDMC has given the go-ahead for the upgrade of 29 computer labs in NDMC schools. Kuljeet Singh Chahal, a council member, revealed to the

Of these, 8138 tablets are allocated for students, and 628 tablets are designated for teachers for the current academic session (2023-2024). ## NGT directs DDA and Saket SDM for park remediation

The National Green Tribunal has directed the Delhi **Development Authority** and the Saket SDM to take "joint action" for reviving a south Delhi park.

The tribunal was hearing a petition alleging that a park or Delhi Development Authority (DDA) ground in south Delhi was encroached upon by the building of 'jhuggis (temporary hutments)' and polluted by garbage dumping and dairy farming.

Last February, the tribunal directed the authorities concerned to clear the land, fence it and ensure afforestation measures through the Forest Department. It also formed a panel that submitted its inspection report in July.

The DDA is required to take action to remove the garbage dumping. (Official)

In an order passed on Tuesday, a bench of National Green Tribunal Chairperson Justice Prakash Shrivastava and Expert Member A Senthil Vel noted the submissions of the Saket sub-divisional magistrate.

The Saket sub-divisional magistrate said, "The DDA is required to take action to clear the garbage dumping and to ensure that no dairy activity or keeping of buffaloes and cows is done on that land." The tribunal directed the Saket sub-divisional magistrate and the DDA to take "joint action" and ensure compliance with its earlier order.

## **DELHI POLICE IMPLEMENTS ROBUST MEASURES FOR R-DAY SECURITY**

The Delhi Police has intensified security measures for Republic Day, deploying 14,000 personnel and a thousand officers to fortify Kartvya Path and central Delhi. With each person assigned a specific role, continuous CCTV monitoring, and collaboration with central agencies, the police aim to ensure smooth celebrations. SWAT, PCR, traffic, and anti-sabotage teams actively contribute to showcasing a

robust security presence. Special CP Protective Section, Dependra Pathak, in-

formed the media that, in light of the recent Pran Pratistha ceremony at Ayodhya Dham, extra vigilance has been taken to prevent any hindrance during Republic Day. He also mentioned that, considering the parliament security breach, a special check of visitors will occur at entry gates. Monitoring via CCTV cameras and coordination with central agencies will enable real-time monitoring of any mischievous actions.

Special CP Law and Order, Madhup Tiwari, stated that anti-terror measures are in place at busy markets through CCTV and manual monitoring. The north district has been divided into twenty-eight zones, each under a DCP and an additional DCP rank officer. For visitor convenience at Kartvya Path, booths for missing persons, help desks, first aid booths, etc., have been set up. Visitors are advised to arrive by 8 a.m. for smooth seating arrangements.

Special CP Traffic, HGS Dhaliwal, announced that, with existing traffic restrictions in Delhi, the entry of commercial vehicles will be prohibited from 10 p.m. on January 25. Special vehicular checks are underway at the national capital borders and

central Delhi areas. Parking restrictions at railway stations are enforced from 8 p.m. on January 25 to 12 p.m. on January 26, urging commuters to use public transport.

To address aerial threats, the police have banned drones or flying objects in central Delhi. Adequate security measures, including flag marches and patrolling along the Yamuna coast, are implemented to ensure the smooth flow of national celebrations and foster patriotism. ### SC ADJOURNS UMAR KHALID'S BAIL PLEA **IN DELHI RIOTS CASE TILL JANUARY 31**

The Supreme Court has postponed the hearing on former JNU student Umar Khalid's bail plea in a case related to the February 2020 northeast Delhi riots under the anti-terror law UAPA. The bench, comprising Justices Bela M Trivedi and Ujjal Bhuyan, deferred the matter due to time constraints, stating, "List

on January 31. High on board. Senior advocate C U Singh, representing Khalid, expressed readiness to present arguments but acknowledged the bench-s rising after lunch. The case was listed alongside petitions challenging various provisions of the UAPA. It is noteworthy that Justice Prashant Kumar Mishra recused himself from hearing Khalid>s plea on August 9, 2023.

Khalid's petition, challenging the Delhi High Court's October 18, 2022, order rejecting his bail plea, was scheduled for a hearing before a bench of Justices A S Bopanna and Mishra. The high court had denied Khalid>s bail, citing his continuous contact with the co-accused and the prima facie truth of the allegations against him, classifying his actions as a «terrorist act» under the Unlawful Activities (Prevention) Act.

Umar Khalid, along with Sharjeel Imam and others, faces charges under the UAPA and various provisions of the Indian Penal Code, accused of orchestrating the February 2020 riots that resulted in 53 deaths and over 700 injuries during protests against the Citizenship (Amendment) Act (CAA) and the National Register of Citizens (NRC).

Arrested by the Delhi Police in September 2020, Khalid sought bail, asserting his lack of a criminal role in the violence and the absence of a conspiratorial connection with other accused. The Delhi Police opposed Khalid>s bail plea in the high court, emphasising the calculated nature of his speech and addressing contentious issues like Babri Masjid, triple talaq, Kashmir, the alleged suppression of Muslims, and the CAA and NRC.



On Wednesday, the Madras High Court heard a petition filed by Anto Mathiva-

nan and Merlin and directed the lower court to consider a bail petition from the accused. The State police have formed teams to apprehend Anto Mathivanan and Merlin who are still absconding. The issue came to light only when the young girl went home for Pongal. When the girl went to her home in Kallakurichi district for the Pongal holidays, she was taken to a government hospital and examined. An NGO called Evidence released a video of the girl alleging abuse and a case was filed under various sections, including SC/ ST (Prevention of Atrocities) Act 1989, against Anto Mathivanan and his wife. In the video, the young girl said, "I was recruited by the MLA's son and his wife six months back and there is not even a day when they have not physically assaulted me.

My body is full of injury marks. They never treated me properly. When I told them that I don't want to work with them, the couple threatened that they would kill my mother and brother.'

## Cal HC single bench directs CBI to probe, division bench stays order

A division bench of the Calcutta High Court on Wednesday stayed within hours a single bench's direction to the CBI to investigate allegations of irregularities in issuance of certificates of reserved category candidates and use of those for admission in medical colleges in West Bengal.

The stay came after Advocate General Kishore Dutta, representing the West Bengal government, moved the division bench presided by Justice Soumen Sen on the ground that the state was not allowed to rely on documents to show that it had initiated a probe about the issuance of fake caste certificates.

Orally moving the division bench soon after the single bench order, Dutta submitted that there is no prayer for a CBI investigation by the petitioner.

The division bench stayed the order of the single bench for two weeks and directed that the matter will be taken up for hearing on Thursday. Earlier in the day, the sin-

gle bench of Justice Abhijit Gangopadhyay directed that the entire process of issuance of reserved category certificates and admission of candidates with such certificates in medical colleges for the last three years be thoroughly investigated by the CBI.

# CJI to Centre: 'How can you not accept an amendment by Parliament?'

India, Parliament's cause is eternal, indivisible and indestructible and we can't hear the Government of India say that the amendment which the Parliament made is something I don't stand by. You have to stand by it," observed Justice Chandrachud.

The bench highlighted that the government has the option to amend the law again if it disagrees with the 1981 amendment.

"This is an amendment by Parliament (in 1981). Is the government accepting the amendment?" inquired Justice Khanna.

"I am not," responded Mehta.

Mehta clarified that he was not presenting a case of "A versus B" and was addressing constitutional questions before a seven-judge constitution bench "The amendment in ques-

tion was subjected to challenge before the (Allahabad) high court, and there is a judgment declaring that it is unconstitutional for A, B, C, D grounds, and as a law officer, it is my right as well as my entitlement and duty to say that this view appears to

be correct," he asserted.

The Allahabad High Court had invalidated the provision of the AMU (Amendment) Act, 1981 in January 2006 granting minority status to the university.

The CJI expressed concern, stating that it would be "radical" for a law officer to tell the court, "I don't abide by what Parliament has done." "You have to stand by what Parliament has done. Parliament is supreme. Parliament is undoubtedly supreme in its law-making function. Parliament can always amend a statute, in which case a law officer can say I have an amended statute," noted Justice Chandrachud. "Can we hear any organ

of the Union government say that notwithstanding a parliamentary amendment, I don't accept this amendment," added the CJI, emphasizing that Parliament is an eternal, indivisible, and indestructible entity under

democracy. Mehta argued that he was supporting the 2006 high court verdict. "How can you say I don't accept the validity of an amendment?" questioned the bench.

In response, the solicitor



general said, "Would a law officer be expected to say that whatever amendments were made in the Constitution of India during Emergency were true only because they were made by Parliament.

The CJI pointed out that the 44th Amendment Act, 1978, rectified the issues arising during the Emergency.

"The 44th amendment came in only for that. The 44th amendment came to redress the evils which were perpetrated in the name of a constitutional amendment,"

The 44th Amendment Act was enacted by the Janata Party government in response to the Emergency, proposing changes to uphold the Constitution's secu-

lar and democratic character. Mehta referred to the high court verdict and stated that the 1981 Amendment Act was set aside and, therefore, no longer part of the statute book.

"There is an affidavit filed by the government. It's not my stand...," he clarified.

Senior advocate Kapil Sibal, representing one of the parties supporting AMU's minority status, recalled how the then Attorney General defended the Emergency provision.

"I was sitting in the court when the then Attorney General of India Niren De was standing here and arguing what is being done is right. I (attorney general) defend the Emergency provision. Why? Because he could not say otherwise," Sibal said.

Mehta highlighted the distinction, noting that the then attorney general was not in a situation where one high court had invalidated the 1981 amendment, and the provision no longer existed in the statute book.

The arguments in the matter remained inconclusive and are scheduled to resume on January 30.

On February 12, 2019, the top court referred the highly contentious issue to a sevenjudge bench for adjudication. A similar reference was made earlier in the S Azeez Basha versus Union of India case in 1967, where a fivejudge constitution bench held that since AMU was a central university, it could not be considered a minority institution. However, it regained its minority status when Parliament passed the AMU (Amendment) Act in

Currently, the distinguished leader of the Bharatiya Janata Party (BJP), Jayant Sinha, holds the representation of Hazaribagh in the Lok Sabha. In contrast, the BJP has tasted success six times, and the socialist factions have also celebrated triumphs in the electoral arena. This intricate blend of natural allure and political dynamics defines the multifaceted character of Hazaribagh.

The Congress party has faced a drought of success in Hazaribagh since the year 1984. The local electorate of Hazaribagh exhibits a notable openness to accepting external candidates. Adding to the historical significance of the region, Hazaribagh Jail has garnered fame since the British colo-

Originally constructed by the British, this prison served as a facility to incarcerate freedom fighters during the struggle for independence. Notably, Jayaprakash Naravan, a prominent figure in Indian politics, was confined within the confines of Hazaribagh Jail during the period of emergency. Legend has it that it was within these walls that JP crafted the strategy to oust Indira Gandhi from power.

Under JP's guidance, a multitude of revolutionaries managed to evade captivity by digging through the walls during the emergency. The Hazaribagh Lok Sabha constituency comprises a total of 5 assembly seats. With an electorate of around 1.7 million voters, the voter demographic in Hazaribagh is distinctive.

The Kurmi community boasts the highest representation among voters in this region. Additionally, there is a significant presence of Scheduled Castes, Scheduled Tribe, and Other Backward Class populations. In urban areas, Rajputs and Kayasthas are prominent. It is noteworthy that, in Hazaribagh, caste is believed to have a minimal impact on politics, as social harmony and equilibrium are considered influential factors in the political landscape.

# The evolving tapestry of Asian American Hindus

Similar to the general U.S. population, an increasing proportion of Asian Americans do not align with any particular religious affiliation, and there has been a decline in the percentage identifying as Christian, as revealed by a Pew Research Center survey on the religious beliefs of Asian American adults.

However, the survey also indicates that 40% of Asian Americans express a sense of closeness to a religious tradition for reasons unrelated to actual religious beliefs. For instance, while only 11% of Asian American adults claim Buddhism as their religion, 21% feel an affinity to Buddhism for other reasons, such as familial background or cultural ties.

The religious profile of Asian Americans

Currently, 32% of Asian Americans have no religious affiliation, up from 26% in 2012. Christianity remains the largest faith group among Asian Americans, comprising 34%. However, Christianity has experienced the most significant decline, decreasing by 8 percentage points since 2012. Among Asian American Christians. there is an even split between

or altars within their homes. Indian Americans exhibit a distinctive religious profile compared to other major

significant majority identifying as Hindu (48%). However, a notable portion of the Indian American population also follows other faiths, including Christianity (15%), Islam (8%), and Sikhism (8%). Approximately one in ten

Asian Americans currently identify Hinduism as their religion (11%), a figure consistent with the 2012 data (10%). An additional 6% of the Asian American population express a sense of closeness to Hinduism for reasons unrelated to religious beliefs, such as ancestry or culture.

When examining Asian American adults who identify as Indian, approximately

religion is Hinduism (48%), a proportion similar to the 2012 findings (51%). In total, two-thirds of Indian Americans either identify as Hindu or express a close affinity to Hinduism. One-third of Hindus among Asian Americans express that religion holds significant importance in their lives, while an additional 38% consider it somewhat important. A notable 31% mention attending religious services on a monthly or more frequent basis. When comparing Asian

American religious groups analyzed in the survey, Hindus stand out as the most inclined to use an altar, shrine,

or religious symbol for home worship, with 79% engaging in this practice. Among Hindus who emphasize the significance of religion in their lives, this figure rises to 89%. In terms of social circles. 40% of Asian American Hindus state that all or most of

their friends share the same religious beliefs, surpassing the overall Asian American population reporting such uniformity (40% vs. 30%).

Demographically, Asian American Hindus exhibit distinct characteristics. Approximately 77% are under the age of 50, making them one of the youngest Asian American religious groups, with a median age of 40.

'12 Moreover, 92% of Asian American Hindu adults were born in a country other than the United States, marking the highest foreign-born share among Asian American religious groups. Conversely, religiously unaffiliated Asian Americans with a close affinity to Hinduism are more likely to be U.S.born than those who formally identify as Hindu (35% vs. 8%). Socioeconomically, Asian American Hindus excel, with 61% holding postgraduate degrees, compared to 22% of all Asian American adults. Additionally, 44% of Asian American Hindus



## CHINA'S PLAN TO SEND ITS SHIP TO MALE FINALISED AFTER MUIZZU-XI TALKS

At the behest of Xi, Chinese diplomats shared Beijing's final plan about the spy vessel's journey with their counterparts

aldives may have said that it received a diplomatic request from China for necessary clearances for the ship to make a port call for rotation of personnel and replenishment, but the reality is that Beijing's plan to send its spy vessel to India's maritime backyard was finalised during Maldivian President Mohamed Muizu's talks with Chinese President Xi Jinping in the Chinese capital two weeks ago.

"At the behest of Xi, Chinese diplomats shared Beijing's final plan about the spy vessel's journey with their counterparts from Maldivian Foreign Ministry," diplomatic sources following the development in Male and Beijing told The Daily Guardian. "China's

backyard came only after Muizzu's approval for the same during his visit to Beijing itself. There was no process of request being sent by the Chinese foreign ministry for approval of the Maldivian government as is being said by Male now. Such port calls not only enhance bilateral ties between the Maldives and its partner countries, but also demonstrate the centuries old tradition of the Maldivian people welcoming vessels from friendly countries," the Maldivian government statement added.

> Diplomatic sources here say that the second part of the Maldivian government's statement clearly signals that it will be allowing more such vessels from China to dock at Male. "Nothing is hidden in it, as everything

The agenda of the Maldives is clear that China will be allowed to needle India as has been its policy," said a diplomat. So, the diplomatic establishment in India is not happy with the statement from Maldives, saying that Mohamed Muizzu allowed China to dock its research ship in Male with proper planning to foment troubles for India. Experts say that Maldives is playing a role of enabler to China which is aggressively engaged in mapping the Indian Ocean bed and collecting seismic and other significant data to facilitate submarine operations in India's maritime backyard.

Similarly, Maldives' Foreign Ministry statement that the Chinese research vessel would not conduct try's waters in the Indian Ocean can also not be trusted. Experts are of the view that this claim is laughable as Male had no capability to detect such activity. Sources say the Chinese surveillance ship is currently in the South West Indian ocean region and is expected to dock at Male seaport on February 5. India has already expressed its reservations over surveillance activity of the said Chinese spy ship to Sri Lanka and Maldives last year. India renewed its concerns to Male after Mohamed Muizzuled government was sworn in on November 17. It is on the basis of Indian concerns that Sri Lanka on December 22 announced that it will not allow any surveillance ship in its EEZ for the entire 2024.

## SC CANCELS BAIL GRANTED TO WADHAWAN **BROTHERS OF DHFL IN BANK LOAN CASE**

The Supreme Court on Wednesday cancelled the bail granted to former DHFL promoters Kapil Wadhawan and his brother Dheeraj Wadhawan in the multi-crore ru-

pees bank loan scam case.

Justices Bela M Trivedi and S C Sharma opined that both the high court and the trial court erred in granting bail to them. We have no hesitation in holding that the charge sheet having been filed against the respondent accused in the prescribed time limit and the cognizance had been taken by the special court of the offences alleged committed by them, the respondents could not have claimed the statutory right

of default bail under Section 167 (2) of CrPC on the ground that the investigation for other accused was pending stated the bench.

Muizzu has assured the

The court also directed the immediate custody of the Wadhawan brothers. The CBI had previously challenged in the top court the statutory bail granted by the lower courts to Kapil and Dheeraj Wadhawan.

Additional Solicitor General (ASG) S V Raju, representing the CBI, argued that the charge sheet in the case was filed well within the 90 days statutory period, yet statutory bail was granted to the accused. According to the Code of Criminal Procedure (CrPC), an accused is entitled to statutory bail if the probe agency fails to file the charge sheet within 60 or 90 days after concluding the investigation.

In this case, the CBI filed the charge sheet on the 88th day after the registration, and the trial court granted default bail to the accused, a decision upheld by the Delhi High Court. The CBI argued that the probe related to other aspects and against some other accused was ongoing, and the lower courts misunderstood the finality of the charge sheet, leading to the grant of default bail.

On May 30 last year, the Delhi High Court had upheld the statutory bail granted to DHFL promoters in connection with the multi-crore rupees bank loan scam case. The high court dismissed the CBI's petition challenging the trial court order and stated that the decision to grant bail was based on good reasoning. The Wadhawan brothers were arrested on Iuly 19 last year, and the high court clarified that it did not delve into the merits of the case. The charge sheet was filed on October 15, 2022, and cognizance was taken based on a complaint by the Union Bank of India.

## SUPERTECH CHIEF RK ARORA'S BAIL PLEA REJECTED BY PATIALA COURT

On Wednesday, the Patiala House Court in Delhi reiected the bail request of RK Arora, Chairman and Promoter of Supertech, in a money laundering case. Additional Sessions Judge (ASJ) Devender Kumar Jangala dismissed the bail plea of Arora. He sought regular bail in the matter. He was arrested on June 27, 2023. A detailed order on the bail is awaited. The counsel representing the Directorate of Enforce-

Earlier, the court, on January 16, 2024, granted interim bail for 30 days to Supertech's chairman and promoter, RK Arora, on medical and health grounds. Arora had moved for interim bail, citing health grounds that he had lost 10 kg in custody. Earlier, the trial court took cognizance of the prosecution complaint (chargesheet) filed by the ED against him and others and also issued summons to all accused named in the chargesheet and firms through their representatives.

tors Naveen Kumar Matta, Manish Iain and Mohd Faizan had appeared in the matter before the court. The Enforcement Directorate (ED) had filed a prosecution complaint (chargesheet) against Supertech's Chairman, RK Arora, in connection with a money laundering case in Delhi's Patiala House Court. Arora was arrested on June 27 under the criminal sections of the Prevention of Money Laundering Act (PMLA). Earlier, ED apprised the court that 23 FIRs were registered Wing (EOW), Delhi Police, Haryana Police and UP Police against Supertech Limited and its group companies under Section 120B (criminal conspiracy) read with 406 (criminal breach of trust)/420 (cheating)/467/471 of the IPC having allegations of cheating at least 670 home buyers for an amount of Rs 164 crore. ED also alleged that the amount collected by Supertech Ltd. was diverted to their group companies for the purchase of properties, with the company with land having much lesser value.

### HC NOTICE TO CENTRE ON PLEA CHALLENGING COMMERCIAL OPS AT HINDON AIRFORCE STATION

Wednesday issued notice to the Central Government on a plea of Delhi International Airport Limited (DIAL) challenging the continuation of commercial operations at Hindon Air Force Station.

Justice Subramonium Prasad issued notice to the Central Government and others and directed them to file a reply.

The matter has been listed on March 7 for further hearing.

The high court noted the submissions of the petitioner, DIAL, that permitting regular commercial operations at Hindon Air Force Station will affect the petitioner.

The petitioner DIAL moved Milanka Chaudhary, challenging a decision of October 31 last year of the Ministry of Civil Aviation to allow the Airports Authority of India to commence scheduled commercial flight operations at the Indian Air Force Station situated in Hindon, Ghaziabad, Uttar Pradesh.

DIAL has also challenged the note on April 17 last year, wherein the Airport Authority of India (AAI) has proposed the cancellation of the Memorandum of Understanding (MOU) dated November 10, 2017 entered into between the

petitioner, Ministry and Authority, wherein the petitioner consented to use of The Delhi High Court on a petition through Advocate the Hindon Airforce Station for the limited purpose and limited time of operating certain specific flights falling under the Regional Air Connectivity Scheme ('RCS') only as an interim and stopgap arrangement while the upgradation at IGIA was underway.

## MACRON'S VISIT: BILATERAL TIES TO GET AN IMPETUS

As President of France Emmanuel Macron lands in India to be the Chief Guest for the Republic Day celebrations, the visit will be a befitting culmination of a 10-month successive run of economic engagement and gains spanning Aprilto-January period of FY 2023-24 which saw the bilateral relationship cross significant milestones in the 25 years of their strategic partnership.

Building on this strong edifice, the visit is expected to provide an impetus to various domains of mutual interest, ranging from Defence cooperation to economic ties and from energy collaboration to space and nuclear partnerships. The discussions will likely pave the way for new agreements and deepen existing cooperation, reflecting the dynamic and evolving nature of the India-France strategic partnership. Prime Minister Narendra Modi and President Macron are set to discuss Indo-Pacific cooperation, counterterrorism and Defence collaboration, bilateral trade and investment, clean energy and climate change global governance and multilateralism space cooperation and civil nuclear cooperation, according to Ajay Srivastava, Founder, Global Trade Research initiative (GTRI).

A study of economic engagements between April to January of FY24 by the Business Guardian saw an upswing in several areas of the bilateral commercial ties. France was among the top three importers of India's aircrafts and spacecrafts during April-November 2023-24 in India's total global exports of the product. The Vibrant Gujarat Roadshow in Paris held on 31 October, 2023, saw participation of 80 high-profile delegations demonstrating the immense potential of collaboration between the state

Government and France. In November, 2023, Chrysoula



Zacharopoulou, French Minister of State for Development, Francophonie and International Partnerships, announced the opening of two new branches of the Alliance française in Udaipur and Bhu-

In January 2024, the 'Green Indian Financial System (GIFS)' Initiative, founded by SIDBI, Shakti Sustainable Energy Foundation (SSEF) and French Development Agency (AFD), came together to bring MSMEs and stakeholders on a common platform to discuss how the financial system and the MSMEs can find a common ground to ensure a resilient and

low-carbon transition in India. A high priority pillar of the Modi-Macron talks -- post the French President's arrival in India -- is expected to be bilateral trade and investment, especially at a time when France, as India's 8th largest trading partner, is looking to strengthen trade and investment ties. France also has a key stake in India's current negotiations on a free trade agreement with European Union which will also further expand the two-way relationship. Market access, intellectual property rights, investment facilitation are likely top priorities in this discussion. Over 1,000 French companies operate in India across various sectors like manufacturing, services, and technology, while more than 200 Indian companies are established in France. Bilateral trade has expanded in 2023 to reach USD 19.2 billion with India's merchandise exports including diesel worth USD 707.9 million), ATF worth USD 405 million, turbojets worth USD 496 million, apparels worth 850 million, footwear worth USD 157 million, smartphones worth USD 248 million, gold jewellery worth 160.5 million), airplane parts worth USD 158 million, medicines worth USD 447.8 million, organic chemicals worth USD 364.5 million. These constitute a, total of USD 7.6 billion, as per GTRI data.

On the other hand, India imported items worth USD 6.2 billion from France, including planes, helicopters, and/or spacecraft worth USD 2.1 billion, LNG worth USD 400 million, navigation equipment of USD 102 million and turbojets and gas turbines to the tune of USD 442.2 million. In the domain of services, India exported financial, IT, maintenance and repair, travel, transport, and other business services worth USD 3.2 billion to France, while importing services such as other business services, transportation and insurance, amounting to USD 2.2 billion.

## **QUESTION MARK ON FUTURE OF I.N.D.I.A BLOC**

Has the death knell of the I.N.D.I Alliance been sounded? Not that the alliance was in ship-shape even otherwise, but then on Wednesday, Mamata Banerjee shoved it towards a possible painful end by declaring that she would go it alone in West Bengal in the Lok Sabha elections. She thus publicly contradicted Congress' claim that it was discussing seat sharing with the Trinamool Congress (TMC). Alliance woes were aggravated by reports that Punjab Chief Minister Bhagwant Mann of the AAP too had decided to go it alone in Punjab, minus an alliance with the Congress. A while ago, there were media reports that Mamata Banerjee was more than ready to have an alliance with the Congress, possibly because she was worried about an erosion in her Muslim vote-bank. Anti-incumbency against the TMC, Bengal's ruling party, is a fact, because of allegations of misrule and corruption. Apparently, the alleged misrule has started affecting the TMC's Muslim voters as well. Along with this was the drift of the Muslim community in general towards the Congress, post the party's thumping win over the BJP in Karnataka, where the majority of Muslims, many of them by shifting from the JDS, voted for the Congress to ensure the BJP's defeat. In July, when the I.N.D.I.A bloc was formed, there was an air of optimism surrounding it.

But then the optimism of July 2023 turned into gloom in December 2023, once the Assembly elec-

tion results of the Hindi heartland states of Madhya Pradesh, Rajasthan and Chhattisgarh were announced and Congress lost all three. Congress' importance in the I.N.D.I.A grouping fell faster than Delhi's falling mercury in winter. The question now is: has the possible fracture in Mamata Banerjee's Muslim vote bank got repaired post the Congress' loss in the Assembly elections in the three all-important states? Is she more confident of retaining her vote-

bank, now that the Congress may no longer be seen as a potential winner?

Has the shift of her Muslim vote-bank towards the Congress been stalled? Is that the reason why she finally decided to go it alone? If this is the case, the fight in Bengal will likely turn out to be bipolar in nature—a straight BJP vs TMC fight, with voters on either side not willing to let their votes get divided by voting for the I.N.D.I.A partners, Congress and the Left, who are in alliance in the state. This increases the possibility of the I.N.D.I.A bloc, or whatever remains of it, to flop in the state completely.

The fundamental point is, for the regional parties it does not matter if they are in an alliance with the Congress or not in their respective states. What matters to them is protecting their own turf and to reach the Lok Sabha with as many seats as possible. At best, the Congress can contribute a handful of votes to their kitty, because it is weak in their states.

The regional parties' future does not depend on the I.N.D.I.A bloc's performance in the Lok Sabha elections. It is the Congress' future trajectory that depends on the I.N.D.I.A bloc. Hence, in all the states where the regional parties are strong, the Congress is at best a supplicant, and not a party that can decide on how many seats it can fight. If the one-state parties want seats in other states from where they can contest, it is because they want to increase their vote share and be regarded as national parties.

Mamata Banerjee's TMC has lost its national party status, so she wants to get enough votes elsewhere to regain that status. However, she can live with her party being a regional entity for some more time, but cannot afford to lose her home turf to the BJP. This factor will decide her next move on the I.N.D.I.A grouping.

The situation is similar with the AAP, which is on a strong turf in Punjab. If it does not need Congress support to win any seats in the state, why will it share seats with the Congress? It will win those seats on its own. It is only in Delhi that both AAP and Congress may need each other's votes to fight the BJP. But an alliance in Delhi does not necessarily mean an automatic vote transfer between the two parties, because elections are more about chemistry than arithmetic.

Hence, it is in Congress' interest to have the I.N.D.I Alliance, especially in swing and low-margin seats, where, faced with the BJP, a few thousand votes from its allies can make a difference between winning and losing. Given that in states where the allies are strong, the Congress will never be handed as many seats as it wants, what will eventually matter for the party is the direct fight it will have with the BJP in around 200odd seats. Therefore, it would make sense for the party to concentrate on these seats. Whether or not Rahul Gandhi's latest yatra has been designed with this on mind, remains to be seen.

As for the future of the I.N.D.I.A grouping, right now the alliance seems to be all about optics—to give the appearance of a united front mighty enough to take on the BJP. But it is uncertain if it will actually reach a stage where seat sharing is finalized by the parties..



After many deliberations and some modifications, the 308 members of the Assembly signed two handwritten copies of the document (one each in Hindi and English) on January 24, 1950. Two days later, the Constitution of India became the law of all the Indian lands. The constitution of India came into effect only on 26th Janu-

Following the date January 26 ,1950, Rajendra Prasad was elected as the President of India. This was, in fact, a deliberate act signing the Constitution on 26th January, to mark and respect the freedom fighters who wanted 26th January as India's initial Independence Day.

Hence, India finally declared herself as a Republic State on 26th January,1950.



#### Delhi High Court Granted Divorce To Man From 'Non Adjusting Wife' On Grounds Of Cruelty

The Delhi High Court in the case X v. Y observed and has granted divorce to a man on the grounds of cruelty by his wife.

The court in the case observed that she had a 'nonadjusting attitude' and no maturity to

sort out the differences with him without his public humiliation due to which he suffered mental cruelty.

The court stated that the evidence on record makes it abundantly evident that the discord between the parties was not a mere normal wear and the tear of marriage but when viewed comprehensively, were necessarily the acts of cruelty which being towards the appellant making their continuation in matrimonial relationship an act of perpetuation of cruelty. **EX-AMBASSADOR REJECTS MENTION** OF "CONSPIRACY, THREAT'

Pakistan's former ambassador to the US and a key witness has rejected the mention of the words "conspiracy" or "threat" in the secret document at the centre of controversy in the cipher case.

Involving jailed former prime minister Imran Khan and former foreign minister Shah Mahmood Qureshi, who also is a senior leader from his party Pakistan Tehreek-e-Insaaf (PTI), the cipher case pertains to a piece of paper, purported to be a diplomatic cable -- the cipher -- that Khan had waved at a public rally on March 27,

claimed that it was 'evidence' of an "international conspiracy" to topple his government. Khan and Qureshi, accused of mishandling it for political purposes, were indicted in December 2023 and both have pleaded not guilty.

During a hearing on Tuesday at the Adiala Jail in Rawalpindi, former Ambassador Asad Majeed gave a first hand account to the special court Judge Abual Hasnat Zulqarnain about his meeting with a top US government official in March 2022, The News newspaper reported on Wednesday.

Majeed was the ambassador of Pakistan to the United States from January 2019 to March 2022.

Bringing out details about the meeting in public domain for the first time, Majeed said, on March 7, 2022, Assistant Secretary of the US Department of State for South and Central Asian Affairs Donald Lu was invited to a working lunch, which was a pre-arranged meeting hosted at Pakistan House in Washington.

#### Militants attack check post in Pakistan's Khyber Pakhtunkhwa, three killed

Unidentified militants attacked a security check post in Pakistan's restive Khyber Pakhtunkhwa province, killing at least three persons and injuring two, police said.

Two labourers and one security personnel were killed in the attack, police said, adding that the presence of militants was spotted through thermal vision cameras.

The dead bodies were found during a search operation on Wednesday. The two labourers injured have been shifted to Dera district hospital, police said.

No group immediately claimed responsibility for the attack. Pakistan has seen a resurgence of attacks by armed groups since 2022 when a ceasefire between the outlawed group Pakistan Taliban (TTP) and the government broke down.

More than 300 attacks have hit Khyber Pakhtunkhwa province in 2023 alone, according to official data, with a vast majority of them claimed by the TTP, which was founded

However, the PTI has vowed not to boycott the polls and run without its iconic electoral symbol. Since the 'bat' symbol has been taken away, all its candidates will be running with different signs.

#### **NORTH KOREA APPEARS TO DEMOLISH 'REUNIFICATION ARCH' AS KIM JONG UN TURNS AGAINST TIES WITH SOUTH**

SEOUL (SOUTH KOREA)

North Korea appears to have torn down a huge arch in its capital that symbolised reconciliation with South Korea, a week after leader Kim Jong Un dismissed decades of hopes for peaceful reunification with the war-divided peninsula's south, according to satellite photos analysed by a news agency on Wednesday.

South Korea's military also said Wednesday that North Korea fired several cruise missiles into waters off its western coast. North Korean leader Kim Jong Un last week described the Pyongyang monument as an "eyesore" and called for its removal while declaring that the North was abandoning longstanding goals of a peaceful unification with South Korea and ordered a rewriting of the North's constitution to define the South as its most hostile foreign adversary.

Satellite images from Planet Labs PBC appeared to show the destruction of Pyongyang's Monument to the Three Charters for National Reunification, also called the Arch of Reunification. An image Tuesday clearly showed the arch missing along a roadway.

Clouds and snow cover made it difficult to ascertain when North Korea tore down the monument, but it appeared to be within the last few days. NKNews, a website focused on North Korea, first reported on the satellite images.

The arch was a 30-meter (about 100-foot) tall structure that looked over a highway leading to the city of Kaesong near the border with South Korea.

The cruise missile launches were North Korea's second

known launch event of the year, following a Jan. 14 test-firing of the country's first solid-fuel intermediate range ballistic missile, which reflected its efforts to advance its lineup of weapons targeting U.S. military bases in Japan and Guam.

South Korea's Joint Chiefs of Staff said Wednesday that the U.S. and South Korean militaries were analyzing the latest launches. It did not immediately confirm the exact number of missiles fired or their specific flight details.

"Our military has increased surveillance and vigilance and is closely coordinating with the United States while monitoring for further signs and activity from North Korea," the Joint Chiefs of Staff said in a statement.

Tensions on the Korean Peninsula have increased in recent months as Kim continues to accelerate his weapons development and issue provocative threats of nuclear conflict with the United States and its Asian allies.

The United States, South Korea and Japan have been expanding their combined military exercises in response to the North's missiles tests. Kim characterizes these drills as rehearsals for an invasion. In the latest tit-for-tat, North Korea said last week that it conducted a test of a purported nuclear-capable underwater attack drone in response to a combined naval exercise by the United States, South Korea and Japan, as it blamed its rivals for tensions in the region. Cruise missiles are among a broad range of weapons North Korea has been testing in recent years as it attempts to build a viable nuclear threat against the United States and its Asian allies.

### **SAUDI ARABIA PREPARES TO OPEN FIRST ALCOHOL STORE FOR DIPLOMATS**

Saudi Arabia is preparing to open its first alcohol store in the capital Riyadh which will serve exclusively non-Muslim diplomats, a source familiar with the plans and a document showed on Wednesday.

Customers will have to register via a mobile app, get a clearance code from the foreign ministry, and respect monthly quotas with their purchases, the document said.

The move is a milestone in the kingdom's efforts, led by Saudi Crown Prince Mohammed bin Salman, to open the ultra-conservative Muslim country for tourism and business as drinking alcohol is forbidden in Islam.

It is also part of wider plans known as Vision 2030 to build a post-oil economy.

The new store is located in Riyadh's Diplomatic Quarter, a neighbourhood where embassies and diplomats reside and will be "strictly restricted" to non-Muslims, the document said.

It was unclear if other non-Muslim expatriates will have access to the store. Millions of expatriates live in Saudi Arabia but most of them are Muslim workers from Asia and Egypt.

A source familiar with the plans said the store is expected to open in the coming weeks.

Saudi Arabia has strict laws against drinking alcohol which can be punishable by hundreds of lashes, deportation, fines,

or imprisonment and expatriates also face deportation. As part of the reforms, whipping has largely been replaced by jail sentences.

Alcohol has been available only through diplomatic mail or on the black market.

The Saudi government did not respond to a request for comment.

State-controlled media reported this week that the government was imposing new restrictions on alcohol imports within the diplomatic consignments, which may boost demand for the new store.

The new regulation will curb imports to counter "improper exchange of special goods and alcoholic beverages received by the embassies of non-Muslim countries inside Saudi Arabia", Arab News daily reported on Sunday.

Saudi Arabia, which was relatively closed off for decades, has in recent years relaxed strict social codes, such as segregating men and women in public places and requiring women to wear all-covering black robes, or abavas.

Prince Mohammed's tightening grip on power has been accompanied by changes which included opening the country for non-religious tourism, concerts and allowing women to drive, as well as a crackdown on dissent and political rivals.

Vision 2030 also includes developing local industries and logistics hubs, and aims at adding hundreds of thousands of jobs for Saudi nationals.

Earlier on January 18, Pakistan conducted "precision military strikes" against what it called "terrorist hideouts" in Iran's Siestan-Balochistan province that killed 9 people. The attack was seen as retaliation to Iranian missile and drone attacks on January 16 which targeted two bases of the Sunni Baloch militant group Jaish al-Adl in Pakistan's unruly Balochistan province.

Commenting on China's mediation efforts to dial down Iran-Pakistan tensions, Chinese Foreign Ministry spokesperson Wang Wenbin told a media briefing here on Tuesday that "China welcomes the good progress that Iran and Pakistan have made in repairing their ties and supports them in further enhancing mutual trust and deepening cooperation through friendly consultation."

China and Pakistan are all-weather strategic cooperative partners, Sun was quoted as saying by the Chinese Foreign Ministry about his meeting with Pakistan's President Arif Ali on Monday.

Sun is a former Ambassador to Pakistan and India both.

China appreciates Pakistan's firm adherence to the one-China principle and "supports Pakistan in safeguarding its sovereignty, independence and territorial integrity," as well as its unity, stability, development and prosperity, Sun told Alvi.

## TRUMP WINS NEW HAMPSHIRE PRIMARY AGAINST NIKKI HALEY

This puts Trump a step closer to securing nomination and getting a historic 2020 rematch with incumbent Prez Biden

s the counting begins in New Hampshire, early trends have projected former US President Donald Trump to win the New Hampshire GOP primary, The Hill reported, citing Decision Desk HQ.

This comes as a major blow to his rival Nikki Haley and puts Trump one step closer to securing his party's nomination and getting a historic 2020 rematch with incumbent President Joe Biden.

The Hill showed Trump leading with 53.8 per cent votes and Haley trailing at 45.5 per cent with 26 per cent of the votes counted.

According to CNN, after 15 per cent of votes counted, Trump leads with 53.1 per cent votes and 11 delegates, while Haley has 45.4 per cent votes and eight delegates.

The New York Times, on the other hand, has shown Trump winning the primary by securing 52.5 per cent of votes and 11 delegates, while Haley managing 46.6 per cent votes and six delegates.

Trump's win in the Granite State is especially damaging to Haley because she had invested much of her time and resources in the state, even notching the endorsement of popular Governor Chris Sununu, as per The Hill.

Polling at one point showed Haley trailing Trump by just single digits.

Earlier, Florida Governor Ron DeSantis pulled out of the White House race and endorsed Trump -- leaving Haley as Trump's sole remaining major challenger.

The former UN ambassador faced pressure to perform well in New Hampshire after being a close third in Iowa to DeSantis, who dropped out just days before the first-inthe-nation primary.

But polling in recent days showed Haley facing a tough hill to climb in toppling Trump, with a polling average of New Hampshire surveys from Decision Desk HQ and The Hill showing Trump at 51 per cent and Haley at 37 per cent.


# Russian plane with 76 PoWs crashes, all feared dead

A Russian military transport plane with 74 people on board, including 65 Ukrainian Prisoners of War (PoWs), crashed in Belgorod region of Russia on Wednesday, the country's defence ministry said as reported by news agency TASS.

The crash took place at about 8 am GMT and the Russian news agency cited the governor of the region, stating on his Telegram channel that the incident occurred in the Korocha district, situated near the country's border with Ukraine and all aboard the military plane Ilyushin-76 were

"On January 24 this year an Ilyushin-76 transport plane crashed in the Belgorod Region during a scheduled flight at about 11 a.m. Moscow time (8 a.m. GMT). There were 65 Ukrainian prisoners of war who were being moved to the Belgorod Region for an exchange, and three escorts on board," Russia's Defence Ministry said as cited by TASS.

Officials said that Moscow has dispatched a panel of inquiry to probe A video grab of the plane crash



Meanwhile, CNN reported that Ukraine is investigating Russia's claims that the crashed plane was carrying Ukrainian servicemen ahead of a prisoner exchange.

However, the official Ukrainian information service, citing sources in Kiev military claimed that the Soviet-era military plane was carrying missiles for the Russian S-300 air defence system, CNN said that it has not verified either side's claim.

Washington Post quoted senior Russian officials who without, providing evidence said it was shot down by Ukrainian forces using either German or US-made missiles."

According to media outlet RT, Russian MP Andrey Kartapolov said that there were two planes carrving Ukrainian PoWs, and that Moscow had to urgently divert the second IL-76, carrying 80 captured troops, out of the danger zone.

The legislator said that despite Kiev being aware about the flight route, the plane was shot down by three anti-aircraft missiles fired from either US-made Patriot or German-made IRIS-T systems.

## PLANE CARRYING DIAMOND MINE **WORKERS CRASHES IN CANADA**

An unspecified number of people died after a plane crashed in Canada's remote Northwest Territories near the town of Fort Smith while it was headed to a diamond mine, CNN reported, citing officials.

The incident happened on Tuesday, and the Northwest Territories coroner also said that there were fatalities in the crash but did not specify the number.

Some of the passengers on board the plane were employees at Rio Tinto, a global mining company, according to a statement issued by the group.

However, the company did not confirm how many of its workers were on the plane but noted the crash resulted in fatalities while the airplane was on its way to a company diamond

"At this time, we can confirm there are fatalities but we will not be providing any additional information pending next of kin," Northwest Territories Coroner Garth Eggenberger said in a statement.

In response to the crash, Fort Smith Health Centre activated its mass casualty protocol around 8:50 am on Tuesday, according to the Northwest Territories Health and Social Services

Authority. The crash also drew attention from the Royal Canadian Mounted Patrol, the Canadian Rangers and

A spokesperson for the Federal Aviation Administration (FAA) said in a state-

ment that the Boeing 757 plane lost its nose wheel as it was preparing for takeoff just after 11 am to head to Bogota, Colombia.

Following the incident, all passengers were deplaned and bused back to the terminal, the spokesperson added.

Moreover, according to the spokesperson, the FAA will be investigating the incident, The Hill reported.



A Delta spokesperson highlighted that the nose gear tyre "came loose from the landing gear," adding that the company apologises "to our customers for the inconvenience."

This comes as Boeing is

also facing questions over a door plug that blew off an Alaska Airlines Boeing 737 Max 9, promoting the plane to conduct an emergency landing.

This also resulted in an investigation by the FAA and the National Safety Transportation Board, according to The Hill.

Moreover, the FAA later grounded 171 Boeing 737 Max 9 aircraft so they could undergo inspection. Last summer, a Delta Boe-

ing 737 plane's left main gear tires blew and caught fire while landing at the Atlanta airport. The airline further said

that, at the time, 190 passengers needed to be evacuated using emergency slides and at least one customer was injured during the incident, as reported by The

## Turkey okays Sweden's NATO bid

The Turkish Parliament on Tuesday voted to approve Sweden's NATO membership bid, bringing the Nordic country one step closer to joining the military alliance after months of delays, CNN reported. Out of the 346 MPs who voted, 287 were in favour of Sweden's accession and 55 voted to reject it. Four others abstained from voting.

The vote was the second step of Turkey's ratification process after the parliament's Foreign Affairs Commission approved the bid last month. Turkish President Recep Tayyip Erdogan can now sign the protocol into law.

Even after a significant hurdle has been cleared for the Nordic country's accession into the military alliance, Hungary remains the only member state that has not yet ratified Sweden's accession, CNN reported.

However, on Tuesday, Hungarian Prime Minister Victor Orban said he



gotiate the terms of Sweden's accession. Notably, Sweden and Finland applied for NATO membership in May 2022, following Russia's invasion of Ukraine earlier that year. Finland joined NATO in April 2023, doubling the alliance's border with Russia, but Sweden has faced numerous delays in its path to

Erdogan initially objected to Sweden's membership bid, accusing Swedish officials of being "too lenient" on militant groups, including the Kurdistan Workers' Party (PKK). Since applying, Sweden has tightened its anti-terror legislation and agreed to work more closely with Turkey on security concerns, as reported by CNN.

Meanwhile, Erdogan's approval of Sweden's accession bid also rides on a commitment by the United States, with the Turkish president signalling that he won't sign the protocol into law unless the US approves the sale of F-16 fighter jets to Turkey.

US Senate Foreign Relations Committee Chair Ben Cardin said on Tuesday that Congress, however, is waiting to see the accession documents completed before moving forward on the matter.

The United States has carried out airstrikes in Iraq targeting facilities used by "Iranian-backed militias" in the country following repeated attacks on US forces, Defence Secretary Lloyd Austin said in a statement on Tuesday (local time).

The strikes targeted three facilities used by Iranianbacked 'Kataib Hezbollah' and other Tehran-affiliated groups in Iraq.

Austin said that the strikes "are in direct response to a series of escalatory attacks against US and coalition personnel in Iraq and Syria" by Iranian-backed militia groups. US Central Command also released a state-

ment on Tuesday saying US forces "conducted unilateral airstrikes" targeting "KH headquarters, storage, and training locations for rocket, missile, and one-way attack UAV capabilities," CNN reported. According to a US defence official, the strikes were carried out at two sites in western Iraq, including Al-Oa'im near the Syrian border and Jurf al-Sakhar south of Baghdad

"I am grateful for both the skill and professionalism with which our personnel planned and conducted these strikes and the continued efforts of our troops on the ground as they work with regional partners to further dismantle and degrade ISIS," Austin stated.

"The President and I will not hesitate to take the nec-

essary action to defend them and our interests. We do not seek to escalate conflict in the region. We are fully prepared to take further measures to protect our people and our facilities. We call on these groups and their Iranian sponsors to immediately cease these attacks," he added.

The strikes come just days after US personnel at Al-Asad Air Base in Iraq were injured in a ballistic missile and rocket attack on the base. While most missiles and rockets were intercepted by the base's air defences, some projectiles made an impact, CNN reported, citing US Central Command.

As per the initial assessment, Kataib Hezbollah was responsible for the ballistic missile attack, the defence

Pentagon spokesman Maj. Gen. Pat Ryder said Tuesday that a total of four US troops were diagnosed with traumatic brain injury as a result of the attack, and all had since returned to duty. The strikes on Tuesday are

the first in Iraq since the beginning of the month, when the US targeted a member of an Iranian proxy group operating in the country who one US official said had "US blood on his hands."

They also come after multiple strikes against the Iranbacked Houthis in Yemen over the last week and a half, as the US looks to rein in the aggressive actions of Iranianbacked groups in the Middle East amid heightened tensions in the region.

Arnav Banerji is a Los Angeles based 3D artist and animator who has worked at multiple pre- production studios for Hollywood productions. His latest credit is for his work as a previs and postvis artist for the prequel to the Hunger Games franchise - 'A Ballad of Songbirds and Snakes'. He did his schooling in Bangalore and studied Entertainment Technology at Carnegie Mellon University.

Arnav has worked as a visualization artist across the acclaimed pre production studios such as 'The Third Floor', 'Zoic', 'Halon Entertainment' and 'Proof'. Some of his projects include, 'The Marvels', 'Hawkeye', 'The Flash' and 'For All Mankind'.

The movie "Hunger Games" required visualization of the action beats and fight sequences in the Hunger Games arena. Two different teams were formed. One focused on pre-visualization and the other on post-visualization. After the script, early in the pipeline, the previs team worked with

the director, visual effects supervisor and producers to visualize action sequences and complex beats for the movie. Using animation and virtual production tools, the artists animated 3D models for the actors, creatures and props to make rough versions of movie sequences before they were shot on set. This helped creative decisions to be made early in the process with the director fine tuning his vision.

Arnav and other artists on the team, worked on broken up sequences with each artist taking responsibility on one chunk. These underwent revisions as shots were refined and supervisors came up with ideas on how to accentuate the tension and action. The previs supervisor then assembled mini edits that showcased the entire sequence.

These sequences went through numerous iterations during the process to create the best possible version of the movie. Once those sequences were shot with actors on set, the shots were sent to the postvis team where Arnav and the other artists on the team worked on removing the green screens, placing the postvis version of the background assets, creatures and props when necessary. This



peak at what those sequences would look like when the sual effects were completed. Those shots also served as a guide for the final visual effects team to ensure alignment with the director's vision. This step created a blueprint for the lighting on the characters and environment along with creature placement, movement and FX timing.

For 'The Ballad of Songbirds and Snakes', Arnav tackled action filled shots with characters, environment assets, props, effects and creatures.

Elaborating, he recalls, "I

worked on shots involving

characters running, fighting each other, moving props and dodging debris. We also had to use FX in realtime software and tweak lighting to best showcase the characters and the story. For instance the team visualized dust moving when vehicles and prop elements in the arena were destroyed and flashes when weapons fired to make for a more immersive viewing experience. The team came up with unique workflows to tackle the large number and waves of CG elements in the scene. There were custom rigs designed to allow creatures to move along the terrain and characters. The Postvis team added the creatures chasing and attacking the actors through compositing. "We had to make sure the CG elements in the shots looked like they were part of the same environment as the plate and the interaction between the plate elements (footage shot on set) and the CG elements was re-



ata Motors has launched yet another electric car in the market. The Punch.ev is the first product from the brand be based on the allnew made-in-India Pure EV architecture called acti. ev, which stands for Advanced Connected Tech-Intelligent Electric Vehicle. According to the company, it is based on the pillars of Performance, Technology, Modularity, and Space Efficiency and consists of four layers - Powertrain, Chassis, Electrical Architecture and Cloud Architecture.

#### **DESIGN**

The Punch EV is led by the new digital design approach, where the idea is to match EV modernity with an iconic look. Some smart lighting systems are a highlight on the car prominent among them being a smart charging indicator which is useful to indicate the SOC levels while the vehicle is charging. You also get bi-functional LEDs coupled with the central position lamp which come with a welcome and goodbye signature.

#### **INTERIORS**

This latest EV in town is loaded with features. It gets twin 10.25-inch screens, one being the full digital cluster and the other a touchscreen system. The 2-spoke steering wheel gets an illuminated logo like the Nexon SUV. You get wireless Android Auto and Apple CarPlay along with the app suite Arcade.ev which offers 17 apps for gaming, music and media. There are more than 200 voice commands in 6 languages, Alexa, Siri for Apple users and Google Assistant for Android users. The ZConnect Connected Car Technology with smartwatch connectivity is offered as

The Punch.ev comes with two battery pack options. The 25 kWh battery gets a claimed  $range\,of\,315\,km\,while\,the\,big$ ger 35 kWh option offers 421 km range. While the 60 kW Permanent Magnet Synchro-

nous AC Motor in the former makes 114 Nm, the higher version ensures 90 kW with 190 Nm, resulting in a 0 to 100 kmph sprint time of 9.5 sec and an electronically limited top speed of 140 kmph. The battery pack and motor are IP67 rated for protection from dust and water, with a warranty of 8 years or 1,60,000 km.

# **AUSTRALIAN OPEN: MEDVEDEV BATTLES** TO REACH SEMIS, YASTREMSKA CRUISES In the final set, Medvedev broke for a 4-3 lead, and served out to secure the win

n Melbourne, Daniil Medvedev seized the limited opportunities presented by Hubert Hurkacz to secure a spot in the Australian Open semi-finals on Wednesday. Meanwhile, Dayana Yastremska made a significant achievement for the new generation by reaching the last four of a Grand Slam for the first time.

Medvedev, the third seed, who had experienced consecutive losses in the 2021 and 2022 Melbourne Park finals, moved a step closer to returning to the title clash with a 7-6(4) 2-6 6-35-76-4 victory over Polish player Hurkacz. Although he appeared poised to wrap up the match in four sets, Hurkacz gained confidence and forced a decider. In the final set, Medvedev broke for a 4-3 lead, acknowledged the applause, and served out to secure the win.

"I knew how 'Hubi' could play, and he played quite well. I felt like I had a small chance in almost all the games, probably except 2-O in the first set,"



Medvedev said. "I managed to take it, so I'm really happy and proud about that. Because with him, you don't get many chances."

The former U.S. Open champion, who has sometimes struggled to win over the crowd, received great support in Melbourne this year and hopes to ride that momentum when he faces Carlos Alcaraz or Alexander Zverev in the semifinals.

Yastremska ensured things stayed on track with a swift 6-3 6-4 victory over giant-killing Czech Linda Noskova, becoming the first women's qualifier to reach the last four since the 1978 tournament. The Ukrainian world number 93, who had already defeated Grand Slam champions Marketa Vondrousova and Victoria Azarenka, will face either 12th seed Zheng or world number 75 Kalinskaya in the next round.

# Zheng triumphs to reach Australian Open semi-finals

Kalinskaya faced a right leg issue, prompting a medical timeout after falling behind by a double break. Although she attempted a late fightback, Zheng maintained her focus, extending her lead and ultimately securing the victory.

Hyderabad is set to witness the opening clash between India and England in the five-match Test series during the latter's tour of the country. The Men in Blue, after a three-vear hiatus, are hosting the Three Lions for this format, with their last encounter on Indian soil resulting in a 3-1 victory for the host nation in early 2021.

India's formidable dominance at home over the last 12 years faces a unique test as Rohit Sharma's side prepares to take on a trend-defying England in the inaugural match of what promises to be an enthralling five-Test series starting on Thursday. Since their 1-2 defeat against Alastair Cook's Three Lions in 2012, India has been unparalleled at

In the history of bilateral Test series between India and England, 35 have been played, with India winning 11, losing 19, and five ending in a draw. Notably, England has struggled on Indian soil, winning only 14 out of the 64 Test matches played between the two teams in India, while India secured victory in 22 matches, and 28 ended in a draw. Contrary to expectations, the

pitch at the Rajiv Gandhi International Stadium is anticipated to favor fast bowlers rather than spinners. Additionally, it is expected to be a batting-friendly surface, conducive to high scores. In the last Test match held at the venue in 2018 between India and West Indies, both teams posted 300+ scores in their respective first innings, with Umesh Yadav earning the Player of the match award for his remarkable performance with six wickets in the first innings and four in the second. The cricket enthusiasts await an exciting showdown between two formidable teams in the upcoming Test series.

For Ireland, the challenge lies in facing the trio of new ball bowlers—Oliver Riley, Reuben Wilson, and Carson McCullough. Simultaneously, the experienced duo of Arshin Kulkarni and Musheer Khan is eager to make a substantial impact with the bat.

Anticipation builds for the India-Ireland clash as cricket enthusiasts eagerly await the unfolding drama on the field. The younger talents aim to leave a lasting impression on the international stage, ensuring each match becomes a captivating spectacle for fans worldwide.
