## **SONIA GANDHI MAY NOT CONTEST LS POLLS, PARTY EYES RS SEAT FOR HER**

The last session of the 17th Lok Sabha, which is commencing from Wednesday, could also be the last session of former Congress President Sonia Gandhi in the Lower House. Next time, she may be seen in the Rajya Sabha, instead of the Lok Sabha. If sources are to

be believed, in the changed political environment, the party is planning to send her to the Rajya Sabha this time instead of making her contest the Lok Sabha elections.

If Sonia Gandhi gets elected for Rajya Sabha, then Priyanka Gandhi may have to contest elections from Raebareli in place of her mother. Now the question is whether Priyanka Gandhi would like to contest elections from Raebareli. Sources told The Daily Guardian that she is in no mood to contest election as of now.

Raebareli and Amethi were once considered safe seats for the Gandhi family. But in 2019, Rahul Gandhi lost the Lok Sabha election from Amethi. Somehow Sonia Gandhi was able to win the election from Raebareli.

Rahul reached the Lok Sabha from Wayanad in Kerala, but leaving Uttar Pradesh, the country's largest state, was fatal for the party. After he went to Kerala, his sister Priyanka Gandhi took charge and started leading from the front, but she flopped miserably.

The Samajwadi Party (SP) announced on Tuesday the names of 16 candidates to contest the Lok Sabha election, in slated to be held in April-May. The party has released the first list on its official social media platform, X (formally Twitter).

The first list includes the name of the party's chief, Akhilesh Yadav's wife, Dimple Yadav. She will contest from her current Mainpuri seat. SP also fielded sitting MLAs Ravidas Mehrotra and Lalji Verma from Lucknow and Ambedkar Nagar seats, respectively.

The candidates' list in-

cludes the names of Devesh Shakya from Etah, Utkarsh Verma from Kheri, Anand Bhadauria from Dhaurahra, Anu Tandon from Unnao, Naval Kishore Shakya from Farrukhabad, Rajaram Pal from Akbarpur, Shivshankar Singh Patel from Banda, Awadhesh Prasad from Faizabad, Ramprasad Chaudhary from Basti, and Kajal Nishad from Gorakhpur.

The party has also fielded Akshay Yaday, son of senior SP leader Ramgopal Yaday, from Firozabad, while Dharmendra Yadav is from Budaun parliamentary constituency. The party has also named 93-year-old Shafiqur Rahman Barq to contest the election from the Sambhal





### **3 CRPF PERSONNEL KILLED IN ENCOUNTER WITH NAXALITES**

SUKMA (CHHATTISGARH) Three personnel of the Force (CRPF) were killed and 14 others injured in the exchange of fire with naxals in Chhattisgarh's Bijapur district on Tuesday, an official said.



According to Inspector General of Police (Bastar Range) P. Sundarraj, the incident occurred near Tekalgudem village when a joint team of security personnel was out on a search operation. The injured are now out of danger and are undergoing treatment in Raipur.

The village is located along the border of Bijapur and Sukma districts A team from the 201 battalion of the CoBRA and the 150 battalion of the CRPF was working in the area to establish a Forward Operating Base (FOB) when the exchange of fire began around 1 pm An FOB is a remote camp meant to facilitate security forces operating in core

Notably, as many as 22 iawans were killed in the encounter with Naxals in Chhattisgarh in 2021 during an encounter along the Sukma-Bijapur border.

## Elon Musk's startup implants first human brain chip

Elon Musk, the billionaire founder of Neuralink, announced on Monday that the first human recipient of an implant from the brainchip startup underwent the procedure on Sunday and is recovering well.

Taking to social media, X, Musk posted, "The first human received an implant from @Neuralink yesterday and is recovering well." Neuralink was given

clearance by the US Food and Drug Administration last year to conduct its first trial to test its implant on humans.

"Initial results show promising neuron spike detection," Musk's post added.

According to Neuralink's website, it has received approval from the independent institutional review

terface) - an investigational medical device trial for fullyimplantable, wireless braincomputer interface (BCI) - aims to evaluate the safety of our implant (N1) and surgical robot (R1) and assess the initial functionality of our BCI for enabling people

with paralysis to control external devices with their thoughts, according to the company's website.

During the study, the R1 Robot will be used to surgically place the N1 Implant's ultra-fine and flexible threads in a region of the brain that controls movement intention. Once in place, the N1 Implant is cosmetically invisible and is intended to record and transmit brain signals wirelessly to an app that decodes movement intention. The initial goal of our BCI is to grant people the ability to control a computer cursor or keyboard using their thoughts alone, it also said.

The PRIME Study is being conducted under the investigational device exemption (IDE) awarded by the FDA in May 2023 and represents an important step in our mission to create a generalised brain interface to restore autonomy to those with unmet medical needs,

## TO 15 PFI MEN FOR MURDER OF BJP LEADER

The Alappuzha sessions court in Kerala handed down a death sentence to 15 individuals associated with the now-prohibited Islamist organization Popular Front of India (PFI) on Tuesday. This ruling is in connection with the murder of BJP OBC wing leader Ranjith Sreenivasan in December 2021.

Mavelikkara Additional District Judge V G Sreedevi pronounced the sentence. The prosecution pressed for the maximum punishment, asserting that the convicts constituted a "trained killer squad," and the brutal manner in which the victim was murdered in front of his mother, infant, and wife classified it as among the "rarest of the rare" crimes.

The 15 individuals convicted include Naisam, Ajmal, Anoop, Mohammed Aslam, Abdul Kalam alias Salam, Saffaruddin, Manshad, Jaseeb Raja, Navas, Sameer, Nazir, Abdul Kalam, Zakir

Hussain, Shaji, and Shernas Ashraf.

According to the prosecution, Ranjith Sreenivasan, the State secretary of BJP's OBC Morcha and a lawyer, was brutally hacked to death by the accused at his residence in Vellakinar, Alappuzha municipality. The assailants had forcibly entered his house on the morning of December 19, 2021.

The murder of the BJP leader was considered an act of retaliation, responding to the killing of SDPI's State secretary K S Shan

at Mannancherry's Kuppezham Junction in Kerala, which occurred just the night before.

All 15 accused were found guilty by the court on January 20

The first eight accused,--Nizam, Ajmal, Anoop, Muhammad Aslam, Salam Ponnad, Abdul Salam, Safaruddin and Manshad-- were found guilty of murder.

Ranjith Sreenivasan, the BJP OBC Morcha state secretary, was brutally attacked and killed in his home on December 19, 2021, in front of his family

## **BIHAR: ED QUESTIONS TEJASHWI FOR EIGHT HOURS** IN 'LAND-FOR-JOBS' SCAM

Former deputy chief minister of Bihar and Rashtriya Janata Dal (RJD) leader Tejashwi Yadav left the Enforcement Directorate office after eight hours of questioning in the money laundering probe into the alleged land-for-job scam.

The former Bihar Deputy Chief Minister was seen waving to his supporters outside the ED office.

Tejashwi Yadav arrived at **Enforcement Directorate** office around 11.35 am amid heavy security deployment and a large number of RID members and supporters who raised slogans in his support.

He appeared before the probe agency a day after his father and RJD chief Lalu Prasad Yadav was questioned for nearly ten hours by the central agency in the

The central probe agency had on January 19 issued a fresh summons for questioning Prasad and Yadav.

Earlier in the day, RJD MP Manoj Jha asserted that the BJP's top leadership is afraid of opposition parties, and it is targeting them by misusing central investigation agencies. "The BJP is using the ED, CBI and IT Depart-

ment against those it is afraid of. That is why it is trying to break (opposition parties) through these central agencies," he said.

Shakti Singh, RJD's Member of Legislative Council (MLC), said, "It's a known fact that Tejashwi Yadav was a minor at the time when the alleged scam took place. BJP leaders are ruffled as he provided a large number of jobs to people in the previous 'Mahagathbandhan' government in Bihar."

The RJD was a key constituent of the 'Mahagathbandhan'.

Reacting to the RJD's allegations, Bihar Deputy Chief Minister and BIP leader Samrat Choudhary told reporters, "When Lalu Prasad was the CM, he was involved in the fodder scam. When he was the Railways Minister, the land-for-jobs scam took place. The ED will certainly investigate the case."

Lalu is being quizzed for his alleged involvement in the Land for Jobs scam. The alleged scam occurred when Lalu Yadav was Railway Minister between 2004 and 2009. Apart from the RJD national president, the chargesheet also includes the name of the then-Railway General Manager.

In lieu of getting them appointed in the Railways, Lalu Prasad Yadav allegedly got lands transferred owned by candidates and their family members in the names of his wife Rabri Devi and daughter Misa Bharti for sale consideration, which was much less than the prevailing circle rates as well as the prevailing

### WILL FILE SUPPLEMENTARY CHARGESHEET AGAINST LALU: CBI IN DELHI COURT

The Central Bureau of Investigation (CBI) informed Delhi's Rouse Avenue court on Tuesday that it will file a supplementary charge sheet within a month in connection with an allegedland-for-job scam in the Railways against RJD chief Lalu Prasad and his family members.

The central probe agency made this statement before Special Judge Vishal Gogne, indicating that the final report will be filed by the end of February. The Central Bureau of Investigation (CBI) shared this information while responding to an application by RJD leader Ahmed Ashfaq Karim, seeking the release of Rs 13 lakh cash seized during the investigation.

The court has kept the application pending until the filing of the supplementary charge sheet.

The matter is scheduled for a hearing on February 27,

Previously, the court had summoned Lalu Prasad, his wife Rabri Devi, their son Tejashwi Yadav, and others in connection with the case. The case revolves around 'Group D' appointments made in the West Central Zone of the Railways during Lalu Prasados tenure as the railway minister from 2004 to 2009.

These appointments were allegedly made in exchangeforlandparcels gifted or transferred by the recruits to the RJD supremo's family or associates. The CBI registered thecaseon May 18, 2022, against Lalu Prasad and 15 others, including his wife, two daughters, and unidentified public servants and private individuals.

The CBI filed the chargesheet in October last year against former Bihar chief ministers Lalu Prasad, Rabri Devi, their daughter Misa Bharti, and 13 others in the land-for-jobs scam.

According to the CBI, the people were first recruited as

## LETTER PETITION SENDS TO THE SUPREME COURT FOR PERMISSION TO WORSHIP IN GYANVAPI

Advocate Vineet Jindal, the National General Secretary of Hindu Singh Vahini Sena, has submitted a petition to the Supreme Court, urging the prohibition of Namaz in Varanasi's Gyanvapi complex and seeking the restoration of worship rights for Hindus.

In a letter addressed to the Chief Justice of the Supreme Court, Advocate Iindal referred to a scientific survey report on the Gyanvapi complex, asserting the existence of a Hindu temple at the site before the construction of the current structure. The report highlighted a stone inscription indicating that the mosque was built between 1676 and 1677 during the rule of Mughal emperor Aurangzeb, with subsequent repairs in 1792-93. The report also featured a photograph from 1965-66 depicting a stone on which

the mosque was constructed, revealing that the pillars used in the mosque's corridor were originally part of a pre-existing temple

During mosque construction, attempts were made to distort lotus medallions and Hindu mythological creature figures, known as Vyala, present on the pillars. The ASI report noted the presence of similar pillars with Hindu symbols on the northern and southern walls of the western chamber. In the 'Sculptural remains in the basement' section, the report detailed the reuse of columns from a pre-existing temple in the construction of a basement on the eastern side of the platform.

The basement and platform, designed to accommodate prayer attendees, contained a pillar adorned with bells and spaces for lamps - features uncommon in Muslim religious places. The report also highlighted the discovery of fragmentary inscriptions in various languages and sculptures of Hindu deities buried in the basement.

The letter petition mentioned a Civil Court's stay order on May 17, 2023, allowing Muslims to offer Namaz in the Gyanvapi complex, a decision contested in the Supreme Court. Following the ASI report, it has been established that the Gyanvapi complex is a Hindu temple, and the mosque structure above it is deemed illegal. Advocate Vineet Jindal concluded the petition by urging the Supreme Court to issue an order halting Namaz in Gyanvapi, citing the evidence presented. Additionally, based on the ASI report, the petition emphasized the well-established right of Hindus to perform worship and rituals at Gyanvapi, urging the court to grant permission for Hindus to worship in the sacred

### SHAHI IDGAH CASE: ALLAHABAD HC TO HEAR PLEA CHALLENGING **MAINTAINABILITY OF SUIT ON FEB 22**

The Allahabad High Court on Tuesday fixed February 22 for hearing a plea regarding maintainability of a suit seeking removal of Shahi Idgah mosque in Mathura which it claims has been built on 13.37 acre land of Katra Keshav Deo temple. The high court passed the order after the Hindu side failed to file its reply on the plea challenging maintainability of the suit.

Justice Mayank Kumar Jain said that the application regarding maintainability of the suit has to be filed in between and the court will hear the issue on February 22.

On January 17, the court had given time to the Hindu side to file its reply on the application of the Muslim side moved regarding maintainability of the suit. A copy of the Supreme Court order was submitted on that day by which an earlier order of the high court dated December 14 last year regarding the survey of the mosque complex adjoining the Sri Krishna Janmabhoomi temple was stayed. On December 14, 2023, the high court allowed a court-monitored survey of the Shahi Idgah complex and agreed to the appointment of an advocate commissioner to oversee the survey of the mosque premises, which the petitioners claim holds signs suggesting that it was a Hindu temple once. The mosque management

committee had challenged the high court's survey order in the top court.

The Supreme Court stayed the implementation of the high court's December 14 order. However, the apex court made it clear that proceedings before the high court in the dispute including the maintainability of the suit under Order 7 Rule 11 of the Civil Procedure Code will continue.

### Politics: Karnataka Deputy CM Shivakumar TDG NETWORK

## JNU Vice Chancellor calls UGC de-reservation draft a 'mistake' TDG NETWORK

Jawaharlal Nehru University (JNU) Vice Chancellor Santishree D Pandit on Tuesday opposed the University Grants Commission (UGC) draft Guidelines for Implementation of Reservation Policy in Higher Education Institutes and said that it must be a "mistake."

She emphasised that there are enough Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC) and Economically Weaker Section (EWS) candidates for reserved faculty positions in universities.

This comes after UGC suggested de-reserving faculty positions, meant for SC, ST and OBC aspirants if sufficient reserved candidates are unavailable.

Speaking to the new agency, the VC asserted that JNU



follows the government of India's policy for the recruitment of teachers and that the "Modi government has not given any document on the reservation.".

Recently, the University Grants Commission's draft on Reservation Policy in Higher Education caused furore as it suggested dereserving faculty positions meant for SC, ST, and OBC aspirants if sufficient reserved candidates are unavailable. "I don't think UGC has the power to make

such changes... So I think this must have been a mistake; I don't know. But in INU, we are very clear that there was no de reservation of any post, and let me also reiterate that in JNU, since I came in the last two years, the highest number of reserved category faculty have been recruited," she said.

"I would not agree with this saving that candidates are not available. I think the way to resolve that would be rather to either broaden the specialisation for professorship; yes, we are not getting people in every category, including the open category," she added.

### 2020 DELHI RIOTS: HC ASKS TRIAL **COURT TO DECIDE ON SHARJEEL IMAM'S BAIL PLEA IN FEB**

The Delhi High Court on Tuesday directed the trial court to decide by next month a plea by student activist Sharjeel Imam in connection with a 2020 communal riots case involving allegations of sedition and unlawful activi-

A bench of Justices Suresh Kumar Kait and Manoj Jain was informed by Imam's counsel that his plea before the trial court is scheduled for February.

In response, the bench directed the trial court to decide and pronounce the judgement on the application within 10 days from the next date of hearing in the trial court, which is listed for February 7. Imam, seeking bail under Section 436A of the CrPC, argued that he has been in custody for the last four years and that the maximum sentence for the offence under Section 13 of the Unlawful Activities (Prevention) Act is seven years if convicted.

According to Section 436-A of the CrPC, a person can be released from custody if they have served more than half of the maximum sentence prescribed for the offense. The high court, while disposing of Imam's plea challenging the trial court's January 24, 2022, order denying him bail, stat-

During the hearing, Imam's counsel informed the court that out of a total of 43 prosecution witnesses in the case, 22 have been examined so far. The high court had previously emphasised that, since Section 124A (sedition) of the IPC has been kept in abeyance on the directions of the Supreme Court, it must examine the trial court's bail rejection order considering the other penal sections applied against Imam.

In 2022, the trial court had framed charges against Imam under Sections 124A (sedition), 153A (promoting enmity), 153B (imputations prejudicial to national integration), 505 (statements conducing to public mischief) of the IPC, and Section 13 (punishment for unlawful activities) of the Unlawful Activities Prevention Act. The prosecution alleges that Imam made speeches at Jamia Millia Islamia on December 13, 2019, and at the Aligarh Muslim University on December 16, 2019, where he threatened to cut off Assam and the rest of the Northeast from the coun-

Every Bharatiya is aware that for the BJP, the Nation comes first, the Party next and the Self last.

They are also aware that CONgress will not blink an eye to sacrifice Bharat and its interests for the sake of power. CONgis who cannot think beyond Appeasement and Vote Bank politics should look within before finding fault with others," he posted on X.

day accused the BJP leaders and their "masters" in the RSS of placing religion and the party above the nation. 

While Indian security agencies are on a high alert, diplomats are also taking regular updates on the development from different foreign embassies and high commissions, sources said, adding, "Several senior envoys from India are constantly keeping a close eye on political activities in Pakistan."

According to sources, Pakistan and China may resume joint efforts to expand the CPEC projects under Belt and Road Initiative (BRI) which India is opposed to.

lished under the Official Secrets Act sentenced Pakistan Tehreeke-e-Insaf (PTI) leader Khan and former Pakistan's foreign minister Shah Mahmood Qureshi handed out the 10-year jail sentence in the cypher case, Dawn reported.

The verdict was announced by special court Judge Abul Hasnat Zulqarnain during the hearing held at Adiala Jail in Rawalpindi.

The special court had begun the cipher trial afresh last month at the Adiala district jail after Imran and Qureshi were indicted for a second time in the case on December 13, Dawn News reported. The former premier and Qureshi, who is also behind bars, were first indicted in the case in October. Both had pleaded not guilty. The IHC had termed the government's notification for a jail trial "erroneous" and scrapped the entire proceedings.

Taking to social media platform X, Khan said, "This is not a trial but a fixed match whose outcome was predetermined by the characters and planners of the London Plan and their seals. That is why I already know the decision of this case.

He added, "Remember that Cipher is a case which has been declared null and void twice by the Islamabad High Court and ordered to be retried because both times the case was tried to be run in violation of the constitution and the law. Then the Supreme Court has also given me bail in this case because the whole building of this case has been built on lies. bullying, conspiracy and de-

The former Pakistan PM also alleged that "these people want to provoke you by giving me a harsh sentence in this case so that you go out on the streets and protest, then add your unknowns to it and do another false flag operation in the style of May 9 to get those results. Earlier this month, Pakistan's caretaker federal government challenged the Islamabad High Court's (IHC) decision to declare its notification regarding the jail trial of Pakistan Tehreek-e-Insaf (PTI) leader in the cypher case as null and void

It reported that the government filed a petition in the apex court to overturn the High Court's decision saving that the High Court did not evaluate the facts of the case properly.

It contended that the IHC did not have the authority to declare a special court formed to hold cypher trial of the former premier invalid.

As per Geo News, in November last year, the IHC nullified the notification for conducting PTI founder Imran Khan's jail trial in the cypher case registered on charges of leaking state secrets.

An IHC division bench, comprising Justice Miangul Hassan Aurangzeb and Justice Saman Rafat Imtiaz, announced the verdict on November 21, 2023 on Imran's intra-court appeal against a single-member bench's decision to approve his jail trial in the cypher case under the Official Secrets Act, 1923.

Earlier, allowing Khan's intra-court appeal, the division bench declared the law ministry's notification "to be without lawful authority and no legal effect"

The IHC stated in the threepage short order that the jail trial can be conducted in exceptional circumstances". "In exceptional circumstances and where it is conducive to justice, a trial can be conducted in jail in a manner that fulfills the requirements of an open trial or a trial in camera, provided it is in accordance with the procedure provided by law.

On Monday, the Indian Navy warship INS Sumitra thwarted the piracy attempt on an Iranian-flagged fishing vessel, Al Naeemi sailing

off the East Coast of Somalia and successfully rescued 19 Pakistani nationals.

This operation came shortly after the INS Sumitra saved another Iranianflagged fishing vessel, FV Iman, from Somali pirates, which had 17 crew members onboard in its anti-piracy operations along the east coast of Somalia and the Gulf of Aden.

"INS Sumitra, over the course of less than 36 hours, through swift, persistent and relentless efforts has rescued two hijacked Fishing Vessels along with 36 Crew (17 Iranian and 19

Pakistani) in the Southern Arabian Sea approximately 850 nm West of Kochi, and prevented misuse of these Fishing Vessels as Mother Ships for further acts of Piracy on Merchant Vessels," the Indian Navy said in a statement.

Tourism stands as one of the world's largest economic ber 2022. However, when sectors, fostering job cre- compared to November ation, driving exports, and promoting prosperity on a global scale. Its potential to contribute significantly to local economies is evident. particularly in a diverse country like India, celebrated for its landscapes, cuisines, heritage, adventure, wildlife, and rich culture. Over recent years, India has gained recognition as a prominent destination for both international and domestic travellers.

Recognizing tourism's integral role in the economy, the Ministry of Tourism, Government of India, has undertaken various development initiatives. The importance of tourism statistics cannot be overstated in this context. Timely, comprehensive, accurate, and reliable statistics play a crucial role in shaping sound economic development policies. They serve as an essential ingredient for the formulation of government decisions and development

In 2023, the global number of international tourist arrivals witnessed an increase compared to the previous year. However, it remained below the 2019 figures, predating the impact of the CO-VID-19 pandemic. The initial decline to approximately 407 million in the first year of the health crisis marked the lowest figure recorded since 1989. Subsequently, global inbound tourist arrivals exhibited robust signs of recovery in the following years, reaching just under 1.3 billion in 2023.

### **TOURISM STATISTICS** IN INDIA

In November 2023, the For-

eign Tourist Arrivals (FTAs) reached 9,22,265, showcasing a notable increase from 7,89,330 recorded in Novem-2019, which saw 10,92,440 FTAs, there was a decrease of -15.6%. The growth rate between November 2022 and November 2023 stood at 16.8% For the cumulative period of


January to November 2023, the FTAs totalled 81,65,945. This marked a substantial growth of 50.0% compared to the same period in 2022, which recorded 54,44,490 FTAs. However, in comparison to the January to November period in 2019, with 97,03,957 FTAs, there was a decline of -15.8%. The data reflects the dynamic nature of international tourist arrivals over these specified periods.

### **EUROPE IS THE MOST POPULAR DESTINATION FOR** INTERNATIONAL **TOURISM**

Since 2005, Europe has consistently emerged as the leading global region in terms of attracting the highest number of international tourists. In 2022, there was a notable increase in inbound tourist arrivals to Europe compared to the previous year. However, the numbers had not yet reached the levels observed before the onset of the global COVID-19 pandemic.

Within Europe, Southern and Mediterranean Europe stood out as the most soughtafter destination for international tourism, recording approximately 265 million arrivals in 2022. Despite the recovery, the region was still working towards matching the pre-pandemic levels of tourist activity. This underscores the resilience and

### **COVID-19 IMPACT** ON THE GLOBAL TRAVEL AND TOURISM **MARKET**

The travel and tourism industries bore a significant brunt during the health crisis, facing substantial setbacks as countries globally imposed restrictions on non-essential travel to curb the spread of the virus. According to Statista's Mobility Market Insights, the global travel and tourism market experienced a sharp contraction in revenue in 2020, witnessing a decline of approximately 55 per cent compared to the previous vear.

In particular, segments such as cruises and package holidays reported some of the most substantial drops in revenue in 2020. The restrictions and uncertainties surrounding travel during the pandemic profoundly impacted these sectors, highlighting the challenges faced by industries heavily dependent on global mobility and tourism.

### **2020 BECAME THE WORST YEAR FOR THE TOURISM SECTOR**

The year 2020 marked a profound global crisis with the advent of the COVID-19 pandemic, impacting health, society, and economies worldwide. Commencing in March 2020, the pandemic triggered an unparalleled disruption to the tourism sector, witnessing a substantial decline in international travel following widespread lockdowns and diminished demand due to extensive travel restrictions implemented to curb the virus's spread.

International tourist arrivals, encompassing overnight visitors, plummeted drastically from 1.5 billion in 2019 to a mere 400 million in 2020, representing a staggering 72% drop. This unprecedented decline translated to 1.1 billion fewer international tourists, making 2020 the worst year on record.

The scale of this contraction far surpassed the 4%

reduction witnessed during the global economic crisis in 2009, returning cross-border travel numbers to levels reminiscent of three decades ago.

In 2020, both international tourism receipts and total export revenues from tourism, inclusive of passenger transport, experienced a severe 63% decline. The financial impact amounted to a loss of USD 1.1 trillion. The implementation of various travel restrictions, including border closures, quarantines, curfews, and mandatory testing, was widespread across destinations.

These measures severely disrupted cross-border mobility, exacerbated by the absence of a COVID-19 vaccine. The lack of coordination among countries regarding health safety protocols and restrictions further contributed to the uncertainty and weakened demand. Tourism emerged as one of the sectors most profoundly affected by the pandemic, with businesses, employment, and livelihoods globally suffering severe consequences.

In 2023, international tourist arrivals worldwide displayed an increase across all regions compared to the previous year. However, with the exception of the Middle East, inbound arrivals remained below the figures reported in 2019, pre-dating the impact of the COVID-19 pandemic. Europe, overall, reported the highest volume of inbound travellers during this period, with around 700 million arrivals in 2023.

### **ECONOMIC IMPACT OF** THE PANDEMIC

The impact of the COVID-19 pandemic on international tourism revenues has been significant. In 2020, export revenues from international tourism, which include international tourism receipts and passenger transport fares, saw a substantial decline compared to 2019. to 0.6 trillion. This marked a staggering loss of USD 1.1 trillion, reflecting a 63% decline in real terms, measured in lo-

cal currencies and constant

prices. While there was an 8% growth in revenues from international tourism in 2021, reaching USD 739 billion, it remained 60% below the levels recorded in 2019. These revenues encompass the 'travel' and 'passenger transport' items in the Balance of Payments.

With the reopening of many destinations in 2022, travel experienced a rebound, and revenues climbed to USD 1.3 trillion, reflecting a substantial 77% increase from 2021. However, despite this recovery, the figures remained 24% below the levels observed in 2019.

The cumulative loss in international tourism revenues is estimated at USD 2.5 trillion for the years 2020, 2021, and 2022. Specifically, international tourism receipts, which exclude passenger transport fares, followed a similar trajectory, dropping from USD 1.5 trillion in 2019 to USD 0.6 trillion in 2020, reflecting a 63% decline. Receipts remained 60% below pre-pandemic levels in 2021 and 26% in 2022.

### **TOURISM IN VARIOUS REGIONS**

The impact of the pandemic on international tourist arrivals varied across regions. In 2020, Asia and the Pacific, being the first region affected by the pandemic and having stringent travel restrictions, experienced the largest relative decline, with an 84% de-

crease in international arrivals. This translated to about 300 million fewer arrivals

from USD 1.7 trillion in 2019 Europe recorded a 68% decrease in arrivals in 2020. despite a brief revival in the summer. It suffered the most significant drop in absolute terms, with over 500 million fewer international tourists.

Arrivals in the Americas also declined by 68%, representing 150 million fewer international tourists. Both the Middle East and Africa saw a 73% decrease in arrivals.

All subregions worldwide witnessed substantial drops in arrivals ranging from 70% to 90%, except for Western Europe, North America, and the Caribbean, where the decline was less than 70% in 2020. Europe and the Americas saw a strong rebound in 2021.

In 2021, the Middle East and Europe recorded the best results by region compared to 2020, with arrivals up by 56% and 26%, respectively, although they remained almost 60% below 2019 levels.

The Americas saw a 17% increase in 2021 compared to 2020 but remained 63% below 2019 levels. Arrivals in Africa grew by 5% versus 2020 but were still 72%lower compared to 2019. In Asia and the Pacific, arrivals dropped 58% from 2020 levels and 93% compared to pre-pandemic values, as many destinations remained

By subregion, the Caribbean showed the best performance in 2021 relative to 2019, with international arrivals reaching 55% of pre-pandemic levels (-45% compared to 2019), and some island destinations even surpassing 2019 levels. Southern Mediterranean Europe also experienced a significant rebound.

art and culture of Kutch. "It is a matter of great pride for all of us that the tableau from Gujarat has bagged the first position in the people's choice category for the second year in a row. Hon'ble Prime Minister Narendrabhai Modi had dreamt years ago that the white desert of Dhordo would become a global tourism hub," Patel wrote. Patel also said, "Thanks to the development of Kutch under the guidance of the prime minister, Dhordo was recently adjudged as the "Best Tourism Village" by UNWTO" and also added that the tableau reflected various cultural aspects of Kutch, such as Rann Utsav, traditional mud house called as Bhunga and handicrafts. The Supreme Court on Tuesday extended the interim protection from arrest to the Vice-Chancellor and other higher officials of Sam Higginbottom University of Agriculture Technology and Science (SHUATS), accused of persuading a woman to adopt Christianity by offering her job and other allurements. A bench of Justices Aniruddha Bose and Sanjay Kumar also directed the State of Uttar Pradesh to file an affidavit within one week.

The apex court has now posted the matter for hearing after three weeks. In December 2023, the top court upheld the Allahabad High Court order, which had refused to stay the FIR registered against the VC and other senior officials. The High Court, while declining to quash the FIR, in order to falsely imhad asked them to surrender before the competent court on or before December 20 and seek regular

Challenging the High Court order, they approached the apex court, seeking protection from arrest and stay on the High Court order.

The FIR was registered at Bewar in Hamirpur district of Uttar Pradesh against Rajendra Bihari Lal, Vice-Chancellor of SHUATS, its Director Vinod Bihari Lal, and five other officials of the Christian minority institution in a case concerning an attempt to convert people to Christianity.

The appeal before the top court stated that the FIR contains "baseless and unsubstantiated allegations." "The present impugned FIR has been lodged with malafide intention just plicate, harass, and malign the petitioners and the university," it added. The incident so mentioned in the impugned FIR dates back to 2005, and the present FIR was registered on November 4, 2023, for which there is no plausible justification coming forward to explain this inordinate delay, the petitioners contended. The High Court on December 11, 2023, refused to quash the FIR and observed that no true religion would approve of malpractices of religious conversion by undue force by a priest or godmen. The allegations are that they persuaded a woman to adopt Christianity by offering her a job and other allurements.

In an FIR registered on November 4, 2023, lodged under Section 376D (gang rape) and other IPC sections and relevant sections of the UP Prohibition of Unlawful Conversion of Religion Act, 2021, and the Immoral Traffic Prevention Act, 1956, in Bewar, the woman alleged that she belonged to a lower middle-class family and was trapped by another woman who took her regularly to a church. In the FIR, she also alleged that she was regularly subjected to sexual exploitation by the accused petitioners, and she was persuaded and pressured to bring other women for conversion and other illegal work. However, petitioners have submitted that the victim was offered a job at SH-UATS, and when she was sacked from her service in 2022, she tailored a story, as mentioned in the FIR, just to rope in all the higher officials of SHUATS, including the Vice-Chancellor.

# Empowering women through digital financial inclusion

Efforts must be made to ensure that technologies eliminate digital gender gap.

mpowering underprivileged people remains key to bringing about financial inclusion. They have been out of the mainstream economy due to lack of financial inclusion and access to the banking system in the digital era. As exemplified by Prime Minister Shri Narendra Modi's comment that his government aims to "put our Nari Shakti at the forefront of India's development journey," the Digital Literacy Initiative is expected to enable especially women to have savings accounts, access to credit, insurance and digital payments which are need of the hour. He further added that "these efforts will continue with even greater vigour in the coming times.'

It will further give opportunities for generating income, improving livelihood, accumulating assets, and participating in economic activities, and household decisionmaking that help in promoting social and economic empowerment.

The mission of Digital India, launched in 2015, is to connect and integrate an unbanked population and bring them into the financial net with use of technology at affordable cost. The launch of JAM Trinity services - Jan Dhan, Aadhaar, and Mobile and the Unified Payments Interface (UPI) - helped lay the groundwork for Digital India. The unique identification process of Aadhaar is linked with the Direct Benefit Transfer (DBT) scheme, as a result, there has been a significant improvement in terms of accurate payments. This has been made very easy and people-friendly electronics mode of payments by replacing the dependence on cash-mode payments that has helped in weeding out fake welfare scheme beneficiaries. Today, access to banking and digital transactions is one of the remarkable success

As part of his development agenda, Shri Modi has launched a series of national schemes for financial inclusion. His aim is to extend formal credit and savings opportunities to the weak and marginalized as well as to get rid of moneylenders. These schemes include Direct Benefit Transfers (DBT), issuance

of RuPay cards, Aadhaarenabled unified payment interface for universal access to banking facilities, etc. The biggest fillip to the efforts of financial inclusion has come from Pradhan Mantri Jan Dhan Yojana (PMJDY) in 2015. Until 2014, the World Bank estimated that there was 21 percent adult population without a bank account.

As per the Ministry of Finance, as on 28 August 2023, more than 50 crore bank accounts have been opened. As of 2023, among these accounts, about 56 percent belong to women, and 67 percent have been opened in rural and semi-urban areas. The PMJDY accounts have enormously grown from 14.72 crore in March 2015 to 50.09 crore in 2023. Total deposits under PMJDY Accounts stand at Rs. 2,03,505 crores. It is also estimated that 33.98 crore RuPay cards have been issued to PMJDY accountholders. Similarly, the 'Mudra Yojana' scheme has reached out to 390 million small and micro women entrepreneurs through institutional credit and about 74 percent of them belong to marginalized sec-

A large number of accounts are active with zero balance. Average deposits in such accounts also increased from Rs 1,279 in 2015 to Rs 2,783 in 2019 and Rs 4,076 in 2023. Altogether, the Jan Dhan accounts hold a deposit of over Rs 2 lakh crore. With similar focus, the Reserve Bank of India (RBI) has been striving to extend the banking network and outreach by set-



ting up new banks, branches, ATMs and new payment banks. Banking infrastructure in rural India has been increased over the years; the public sector banks opened 316 branches in rural areas, out of the total 927 branches during 2022-23.

### **DIGITAL EMPOWERMENT**

Over the years, the digital technology infrastructure has been geared to focus on enabling a unique biometric identification number, low

cost payments with UPI, an instant real-time payment system through various easy and convenient modes of digital payments including BHIM, Paytm, Google Pay, PhonePe, and data sharing and security through DigiLocker, which aims at ensuring the goal of a secured, insured, digitalised empowered society. As per the Ministry of Finance, BHIM UPI has emerged one of the most preferred payment modes in the country. In 2017-18 the total number of digital transactions was 2,071 crore, in 2020-21 it reached to 5,554 crore and till 31st December, 2022 it was 9,192 crore. The value of digital transactions in 2017-18 was 1,962 lakh crore and in 2020-21 it touched 3,000 lakh crore and till 31st December, 2022 it was 2,050 lakh crore. The user base and number of transactions have significantly grown since the Demonetization and the COVID 19 pandemic.

The number of mobile users in India is continuously rising. According to the Internet and Mobile Association of India and KANTAR report 2022, out of 759 million active users in the country, 360 million are from urban India and 399 million from rural India. Urban India witnessed a 6 percent growth in internet penetration, while rural India experienced a 14 percent increase. Of all the internet users, 54 percent are male and 57 percent are female in 2022. It is also projected that by 2025 the female users will to 65 percent.

Undoubtedly, over the years, India has significantly

improved the financial inclusion of the marginalised sections and enabled digital services to rural communities across the country. With the ubiquitous nature of digital technology, access to different productive resources for rural women can easily be ensured.

Despite such a huge progress, the major challenges include how to bring everyone to banking system, sustaining regular transaction by the users and providing them financial awareness. Similarly, rural women and girls suffer the costs of limited access to digital resources and opportunities due to lack of availability, adaptability as well as skills to use digital services. The affordability of internet and access to smartphones are still low in rural areas. The digital network connectivity to the most remote rural locations in India can empower and help to create large-scale employment opportunities for rural women. The government has to pay equal attention to digital literacy and its security and privacy for a better financial inclusion as well as prioritizing gender equality in the digital space. With the increase in cyberfraud, mere digital literacy would not uphold financial inclusion of women, especially underprivileged, unless the cheating and fraudulent practices are impeded at the highest level to achieve the desired outcome.

## **GOING BEYOND** THE U-TURN

Nitish Kumar has done yet another U-turn and is back in the BJP fold. The key question is not so much about the Bihar Chief Minister's political trajectory as it is about the larger political landscape.

First let's talk about what this tells us about the BJP's strategy for 2024. Given the fact that the move to woo Nitish Kumar happened post the great Ram Mandir Pran Prathistha ceremony tells us that the BJP is not going to rest on the Kamandal plank alone. It is going to be seeking out votes on mandal as well and for that, who better to rope in than the person who recently resuscitated the caste survey. Apart from which the JD(U)-BJP combine complements each other's vote banks. Also it kind of takes away the steam from Rahul Gandhi espousing the cause for a caste survey, when the posterboy for the same has jumped ship.

More worrying is what Nitish Kumar's desertion signifies for the I.N.D.I.A block. One, its clear that he feels the opposition has nothing to offer him, both at the state level and at the centre. Two this is also coming at the heels of other allies acting tough with the Congress. Mamata Bannerjee has almost ruled out an alliance with the Congress, the Aam Admi Party has said okay to one in Delhi but is expecting a guid pro guo in Harvana and Guiarat and is not keen to go in for an alliance in Punjab. While in Uttar Pradesh, Akhilesh Yadav has unilaterally announced 11 seats for the Congress while the latter clearly wants a whole lot more. But can the Congress afford to talk tough at a time when its own winnability quotient is at an all time low. Indeed there are those who are wondering if the Congress tally would fall even lower in the next round of General Elections. On top of that you have a continuous high profile exodus of leaders once considered part of Rahul Gandhi's `Camelot' former union minister Milind Deora being the latest on that list.

Moreover apart from leadership there is still the question of ideology. Post the Ram Mandir Pran Prathistha there has been a huge wave of hindu consolidation in the BJP's favour. The Prime Minister has delivered on a much longed for yearning not just by hardline Hindus but even the moderate ones who felt sidelined in their own country. While it is still too early to pronounce India as a theocratic state it would be stupid to deny that Narendra Modi is clearly the Hindu Hriday Samrat who has reached out to the majority community in a way no politician before him has. And that is going to be the Congress party's toughest narrative to counter in the coming polls.

### **SUPREME COURT OBSERVES 2 - MINUTE SILENCE ON MARTYRS' DAY**

The Supreme Court observed a two-minute silence on Tuesday in honor of those who sacrificed their lives in the struggle for India's freedom. A seven-judge Constitution bench of Chief Justice of India D Y Chandrachud, along with Justices Sanjiv Khanna, Surya Kant, J B Pardiwala, Dipankar Datta, Manoj Misra, and Satish Chandra Sharma were in the midst of hearing arguments regarding the minority status of the Aligarh Muslim University (AMU). At 10.59 am, the bench rose and observed a two-minute silence. Following this, all benches resumed their proceedings for the day. January 30 is commemorated as Martyrs' Day, marking the death anniversary of Mahatma Gandhi (2nd October 1869-30th January 1948). In accordance with the annual tradition, a circular issued by the apex court on January 25 stated, "As per practice followed every year, two minutes" silence will be observed at 11.00 am on Tuesday, January 30, 2024, in the memory of those who laid down their lives in the struggle for India's freedom."

# DELHI HIGH COURT DISMISSED PIL TO INCLUDE AYURVEDA, YOGA IN AYUSHMAN BHARAT PMJAY SCHEME

he Delhi High Court in the case Ashwini Kumar Upadhyay v. Union of India and Others observed and has dismissed the public interest litigation, PIL moved seeking inclusion of Ayurveda, Yoga and Naturopathy in Union Government's public health insurance scheme Ayushman Bharat Pradhan Mantri Jan Arogya Yojana, PM-JAY.

The Division bench comprising of Acting Chief Justice Manmohan and Justice Manmeet Pritam Singh Arora in the case observed and has rejected the petition filed by the BJP leader and Advocate Ashwini Kumar Upadhyay in default due to non-prosecution.

The court stated that even after the Passover, none is present for the petitioner. Dismissed in default.

The petitioner was also ordered not to contact the victims or their families, and shall not influence or intimidate them, either directly or in-

directly. Therefore, the petitioner in the case shall not influence or intimidate the witnesses and shall not tamper with the investigation in the case.

The Supreme Court in the case Vinoj v. Union of India and Ors. observed wherein it has been assured by the Tamil Nadu government last week that there was no ban on live screening of the Ram Mandir pran pratistha or other religious ceremonies to mark the oc-

The Tamil Nadu government informed the court that out of 288 applications for various ceremonies and processions, 252 were granted. The Tamil Nadu Additional Advocate General Amit Anand Tiwari said that only in 36 areas, such permission was not granted by the state government in view of potential law and order issues.

The bench comprising of Justice Sanjiv Khanna and Justice Dipankar Datta in the case was hearing the writ petition filed by the Tamil Nadu Bharatiya Janata Party, BJP leader alleging that the state government has prohibited live screenings and special poojas in connection with the Ram Mandir consecration ceremony in Uttar Pradesh's Ayodhya on January 22.

Therefore, on the last occasions, the bench had not only recorded the state government's statement refuting this claim, but had also

categorically stated that permission for live screenings and special poojas could not be denied solely based on the presence of other religious communities in any given area.

The court in the case observed and has issued the notice on the BJP member's petition.

The bench in the case also instructed the state to maintain a record of received applications and mandated that speaking orders, elucidating reasons for approval or denial, must be provided in all cases.

The Supreme Court in its order stated that this court believe and trust that the authorities will act in accordance with the law and not on the basis of any oral instructions.

The counsel, AAG Tiwari sought time to file an affidavit, but orally apprised the bench of the number of applications that were denied.

It has also been argued by the counsel, AAG that the court to drop the proceedings, pointing to contemporaneous litigation pending in both Madurai and Madras benches of the high court over the same issue. Therefore, the law officer stated that, 'Let the high court consider all

### MADRAS HIGH COURT: RECKONING DATE FOR LIMITATION IS THE DATE OF FILING FINAL REPORT, NOT REGISTRATION OF FIR | S.468 CRPC **TDG NETWORK** The bench headed by Justice Anand NEW DELHI

The Madras High Court in the case A. Kaliyaperumal v. The Superintendent of Police observed and has held that the reckoning date for calculating the limitation period under Section 469 of the Code of Criminal Procedure, CrPC would be from the date of filing of the final report and not the date of registration of FIR.

The bench headed by Justice Anand Venkatesh in the case observed and has noted that in a case emanating from the FIR, cognizance is taken by the Magistrate upon the filing of the final report.

Adding to it, the court stated that the basis of the FIR is only information received by the police authorities and not a 'complaint' of which cognizance is taken.

Therefore, the said court went on the discussion while hearing the petition moved seeking to transfer an investigation on the ground that police had not taken steps to complete the

Venkatesh in the case observed and has noted that in a case emanating from the FIR, cognizance is taken by the Magistrate upon the filing of the final report.

investigation.

The court observed that in another case, the petition was moved for quashing the FIR as the final report had not been filed to date thus contending that there was a bar in taking cogni-

The counsel, Additional Public Prosecutor informed the court that in the first case, the final report had been filed but since the final report was filed much beyond the period of limitation, the court had not taken cognizance of the same and issued notice to the accused.

The court in the case observed and has relied upon the decision of the Madras High Court in the case Kishore v. State, wherein it is contended that there was no requirement for condoning since the complaint was lodged with the police within the period of limitation.

The bench headed by single judge in the case observed that the relevant date for Section 468 CrPC was the date of filing the complaint or the date of institution of prosecution.

The bench headed by Justice Venkatesh in the case observed and has opined that the single judge had misunderstood information given to the police under Section 154 CrPC as a complaint under Section 9(d). The court in the case observed that as per section 154 of the Code of Criminal Procedure, the registration of FIR was based on 'information' and the same could not be equated to a

'complaint'. It has also been noted by the said court that a complaint could be made only to the court and not to a police officer.

The court also discussed the decision of the Apex Court in the case Sarah Mathew v Institute of Cardio Vascular Disease, wherein it has been held by the Apex Court that the relevant date was the date of filing of the complaint.

The court also noted that Sarah Mathew arose from a complaint made to the magistrate under Section 190(1) (a) and was not based on a police report.

The court in the case also looked into the decision in the case Arun Vyas v Anita Vyas, wherein the court held that cut-off date as the date on which the final report was filed and not the date of filing of the FIR. The court also noted that this decision was upheld by a three-judge bench in the case State of H.P. v. Tara Dutt and a two-judge bench

in Ramesh v. State of T.N. Further, the court noted that the earlier decision of the single judge had wrongly relied on the decision of the Apex Court in Sarah Mathew which was based on a complaint and thus did not subscribe to the view taken therein.

The court in the case observed and has directed the Magistrate to grant the opportunity of hearing to the accused and dispose of the petition within six weeks. In the second case, it has

been noted by the said court that though the crime was registered in 2015, no final report had been filed till date even though it should have been filed within 3 years. It has been opined by the said court that keeping the FIR pending would not serve any purpose and thus quashed the FIR.

### TAIWAN'S FIRST LUNAR MISSION READY FOR LAUNCH LATE THIS YEAR

TAIPEI: Taiwan's National Central University announced the country's first lunar mission on Monday, revealing that a Deep Space Radiation Probe (DSRP) developed by its faculty and students is scheduled to launch in Japan as early as the fourth quarter of this year, Central News Agency Taiwan reported on Monday. Deep space, over 2,000 kilometres from Earth, presents harsh radiation conditions, impacting both life forms and technological products, according to Loren Chang, chair of the Department of Space Science and Engineering at National Central University.

### JORDANIAN SUPPORT FOR HAMAS GROWS AMIDST SYMBOLIC DISPLAYS

TEL AVIV: In a noticeable surge of solidarity, the streets of Jordan are witnessing a growing trend of support for Hamas and the ongoing conflict in the Gaza Strip. Recent developments reveal a striking manifestation of this backing through various businesses adopting names and symbols associated with the Palestinian cause The controversially named restaurant "Seventh of October," which initially apologised for its overt homage to Hamas, turns out to be just the tip of the iceberg.

### BALOCH LIBERATION ARMY LAUNCHES OP 'DARA-E-BOLAN'

QUETTA: The Baloch has initiated 'Operation Dara-e-Bolan' in the Mach and Bolan regions of Balochistan in alliance with the BLA's elite units, including the Majeed Brigade, Special Tactical Operations Squad, Fateh Squad, and Intelligence Wing, The Balochistan Post reported. The Balochistan Post cited Jeeyand Baloch, the spokesperson for the BLA who advised residents in Mach city and the surrounding areas to stay indoors and avoid highways due to ongoing activities. Initial reports from Mach city indicated a massive explosion followed by intense gunfire.

### ISRAELI SOLDIER WOUNDED IN ATTACK STABLE AFTER SURGERY

TEL AVIV: The Israeli soldier wounded in a carramming terrorist attack Monday morning is now in stable condition after completing eight hours of

surgery.
A spokesman for Rambam Hospital in Haifa, where the soldier was taken for treatment, said he underwent a series of orthopaedic surgeries conducted by three different teams from the hospital's orthopaedic department to treat injuries to his limbs.

The soldier was transferred to the hospital's intensive care unit for observation.

# ISRAELI UNDERCOVER FORCES DRESSED AS WOMEN AND MEDICS STORM WEST BANK HOSPITAL, KILLING THREE MILITANTS

The military said the militants were using the hospital as a hideout. It alleged that one of those targeted in the raid had transferred weapons and ammunition to others for a planned attack.

Israeli forces disguised as civilian women and medical workers stormed a hospital on Tuesday in the occupied West Bank, killing three Palestinian militants in a dramatic raid that underscored how deadly violence has spilled into the territory from the war in Gaza.

The Palestinian Health Ministry said Israeli forces opened fire inside the wards of the Ibn Sina Hospital in the town of Jenin. The ministry condemned the raid and called on the international community to pressure Israel's military to halt such operations in hospitals. A hospital spokesperson said there was no exchange of fire, indicating that it was a targeted killing.

The military said the militants were using the hospital as a hideout, without providing evidence. It

forces, most of them armed, dressed as women with Muslim headscarves or hospital staff in scrubs or white doctor's coats. One in a surgical mask carried a rifle in one arm and a folded wheelchair in the other. The forces were seen patting down one man who kneeled against a wall, his arms raised.

Israel has come under heavy criticism for its raids on hospitals in Gaza, which have acted as a shelter for displaced people and also as a critical yet struggling lifeline for the tens of thousands of Palestinians wounded in the war. Gaza's health care system, which was already feeble before the war, has been on the verge of collapse, buckling under the scores of patients, the lack of resources - including fuel and medical necessities blocked by Israeli restrictions — and the repeated fighting surrounding and inside hospitals.

Israel says militants use hospitals, especially in Gaza, to hide out or to launch operations from. The military has found underground tunnels in the vicinity of hospitals, and says it has located weapons and vehicles used in the October 7 attack on hospital grounds.

The war was triggered by Hamas' attack, when hundreds of militants stormed across the border, killing about 1,200 people, mostly civilians, and abducting about 250 others.

The attack set off a blistering air, sea and ground offensive that has killed more than 26,000 people in Gaza and wounded more than 65,000, according to the Health Ministry in Hamas-run Gaza. The ministry count does not distinguish between fighters and noncombatants, but it says about two-thirds of the dead are women and minors.

The fighting has sparked a humanitarian catastrophe, displacing 85 per cent of the tiny coastal enclave's population, leveling vast swaths of it, and pushing a quarter of residents to starvation, according to the United Nations. That crisis may soon be exacerbated, the UN has warned, over a spate of funding freezes to the main aid provider to Palestinians in Gaza following Israeli claims that a dozen of its workers participated in the October 7 assault.

First Lady Herzog said: "As a woman to a woman, I want to thank

you very much for coming to Israel with an open heart and open mind to listen and to see, and to help the survivors"

Under-Secretary Patten said: "I'm here to express my solidarity with the Government of Israel, the people of Israel, the survivors, the families of victims, and the families of hostages."

She added, "Sexual Violence used as a tactic of terrorism, as a tactic of war, is intended to destabilize, to instil fear, to humiliate, to dehumanize not only the victims, but also the families, the societies, the nation, or the perceived enemy."

The First Lady and Under-Secretary then went on to meet a range of leading Israeli civil society, legal, and medical experts in the field of women's rights. The meeting was also attended by Israel's Ambassador to the United Nations, Gilad Erdan, and representatives of the Ministry of Foreign Affairs.

# PRINTING OF BALLOT PAPERS FOR PAKISTAN'S FEB 8 ELECTIONS TO BE COMPLETED BY FRIDAY

Pakistan's election authorities have said that printing of ballot papers for the February 8 general elections would be complete by Friday, according to a media report on Tuesday.

Pakistan is going to the polls for the National Assembly and four provincial legislatures next Thursday and the election campaigning is going on in full swing.

The Election Commission of Pakistan (ECP) said the delivery of ballot papers with the help of security personnel was underway simultaneously in the four provinces as the printing of ballot papers would be completed by February 2, The News International reported.

The printing of ballot papers, which is being done in three government presses, is going on satisfactorily, the report said.

"The printing work, which started on January 16 after the allotment of election symbols by returning officers (ROs),



will be completed in the next four days, i.e. by February 2," the newspaper quoted an ECP spokesman as saying.

He said that at the same time, with the help of security agencies, ROs and district administrations, the delivery of ballot papers has started for the four provinces. These deliveries are being done both by road and air. The spokesman also pointed out that from January 29, people have been provided 8300 SMS services to get information about their polling station among other information. Voters will have to send their identity card number to 8300 to get their vote information.

All voters have been requested to get details of their and their family's vote on

time so that they do not face any problems in polling stations.

Meanwhile, the commission has so far completed the training of 970,000 polling staff out of 976,000 required polling staff, which is 96 per cent of the total required number. The training of the remaining 6,000 polling personnel will be completed in the next four days.

Separately, taking immediate notice of the news circulating in some sections of the media that a group of Ulemas in Kohistan has allegedly issued a fatwa banning women from campaigning, the commission immediately sought a report from the district monitoring officer of Kohistan Upper.

# CARETAKER PAK PM SAYS POLITICAL PARTIES POLL MANIFESTOS 'LACK ECONOMIC FORESIGHT'

Pakistan caretaker Prime Minister Anwaar ul Haq Kakar expressed dissatisfaction over the manifestos released by the political parties for general elections and said that no political party has presented a plan to fix the economy, Dawn News reported.

It reported that PM Kakar also reassured that there was no reason to justify any delay in general elections.

He stated in an interview that political parties' candidates were canvassing, and all rumours regarding the delay in general elections would fall to rest on the evening of February 8.

PM Kakar underscored that the parties should focus on improving the economy but added that, unfortunately, no political party had yet come up with an agenda to fix the chronic economic issues

## 'SHORTAGE OF HANDS': ISRAELI FARMERS PRAISE HIGHER QUOTA FOR FOREIGN WORKERS

Leading figures in Israel's agricultural sector expressed their support for the government increasing the

quota of foreign workers.
Addressing a severe agricultural labour shortage, the Israeli Cabinet on Sunday increased the quota of foreign workers in agriculture by 10,000.

"This decision aims to support farmers who previously relied on Palestinian workers and to solve the problem of a shortage of working hands. The Farmers Federation supports this solution," Uri Dorman, Secretary General of the Israel Farmers Federation told Tazpit Press Service.

Active farmers and the processing companies to whom active farmers delegated their rights can now request foreign workers to fill the void left by the absence of Palestinian labor. This allocation is available to farmers engaged in agri-

culture in 2024, who held permits to employ Palestinian workers in 2023. "The government's deci-

"The government's decision will let us fill the lack created by the non-employment of Palestinian workers in Israel, and end the upcoming season with minimal impact on agricultural production and the current harvest season," Agriculture Minister Avi Dichter said.

Israeli agriculture is facing staggering losses in production and manpower.

China proclaims

China proclaims itself to be a responsible global player. The truth is, despite insistent proclamations of neutrality, it is biased in the way it relates to international crises such as the current Israel-Hamas conflict. Furthermore, this war is exposing the self-interested, mercantile qualities that China brings to all its foreign relations.

China is charting a careful path, simultaneously seeking to undermine the USA and curry favour with Arab states. Its risk-avoidance strategy can perhaps best be described as anti-Western neutrality. Approximately one million Chinese work in the Mid-

dle East, while the majority of China's oil imports originate from the Middle East - 87.5 million tonnes in 2022, with Saudi Arabia being the largest supplier of crude.

GAZA CONFLICT EXPOSES CHINA'S WEAKNESS IN MIDDLE EAST

On January, 26-27, Foreign Minister Wang Yi met US National Security Advisor Jake Sullivan in Bangkok. China's readout briefly stated that regional issues like the Middle East were "discussed". That was the limit of it. No mention of the Red Sea or Gaza.

In contrast, the USA said it attempted to persuade Beijing to pressure Iran to stop Houthi attacks on Red Sea shipping. According to a White House official, China agreed to "raise this with the Iranians." Nonetheless, an American official pondered, whether China

"chooses to use that leverage in that way, I think that remains to be seen".

China has done nothing to curb North Korea's nuclear aspirations, plus it has offered tacit support for Russia's invasion of Ukraine. Relying on China for anything substantive is a vain hope. China mediated a diplomatic deal between Saudi Arabia and Iran in March 2023, but Beijing has no real leverage over Teheran and certainly it cannot get it to reign in Hamas.

Interestingly, showing which side China really is on, the Houthis said Russian and Chinese ships will not be targeted in the Red Sea. The People's Liberation Army Navy has had antipiracy task forces in the Gulf of Aden

The announcement by the US Department of State on the pilot program for incountry renewal of certain petition-based temporary work visas, including for Indian nationals, was made in June 2023, during Prime Minister Narendra Modi's visit to the US.

During the visit, PM Modi announced at an Indian American community event in Washington that the H-1B visa renewal stamping was being conducted in the US.

The joint statement released by the White House following the visit mentioned this development, indicating the commitment of both nations to streamline visa processes and facilitate the lives of temporary visa holders.

A total of 20,000 participants will be accepted for the



A total of 20,000 participants will be accepted for the pilot over the next five weeks, split equally between workers who recently received their H-1B specialty occupation visas at consulates in India and Canada.

A website released by the State Department ahead of the pilot's launch allowed visa holders to confirm their eligibility. Applicants could fill out a visa application form on the agency's website last week, although they couldn't be submitted until Monday.

"I am thrilled to see the announcement that the State

Department has officially launched the Visa Stamping initiative in the USA today. This endeavor aims to streamline and improve the visa process for legal immigrants, making it more efficient and less burdensome. This would eliminate the need for these applicants to travel abroad to renew visas," ANI quoted Ajay Bhutoria, a prominent advocate for immigration issues as saying.

"I believe this positive change will benefit thousands of the individuals invited to work in the US and contribute to the growth of our nation's companies and economy," Bhaturia added. This pilot is one of the recommendations presented by Bhutoria of the President's Advisory Commission on Asian Americans, Native Hawaiians, and Pacific Islanders, which is now implemented by the State Department.

The initiative for now is limited to only H-1B workers who meet the criteria outlined in December and excludes dependent visa holders like spouses and children on H-4 visas--a source of frustration that many workers expressed when eligibility details emerged.

Bhutoria is also advocating for other important immigration reforms, including reducing the green card

n Indian student studying at Purdue University who was reported missing since Sunday has been confirmed dead, according to the Tippecanoe County Coroner.

According to the Tippecanoe County Coroner's Office, officials were called around 11:30 am. Sunday to 500 Allison Road in West Lafayette for a possible dead body. Upon arrival, a "college-aged male" was found deceased on Purdue's cam-

The deceased student has been identified as Neel Acharva by the authorities. On Sunday, Gaury Acharya, mother of the deceased student, in a post on X, appealed, "Our son Neel Acharya is missing since yesterday Jan 28 (12:30 AM EST) He is studying in Purdue University in the US. He was last seen by the Uber driver who dropped him off in Purdue university. We are looking for any info on him. Please help us if you know anything."

The Consulate General of India in Chicago replied to

her post on X, saying, "Consulate is in touch with Purdue University authorities and also with Neel's family. Consulate will extend all

possible support and help." According to Purdue Exponent, a multimedia agency independent of the university, in an email written to the university's computer science department on Monday, interim CS head Chris Clifton confirmed students and faculty of Neel Acharya's death.

Earlier this week, another Indian student was brutally killed with repeated blows from a hammer by a homeless man inside a store in Lithonia, Georgia,

A video of the incident went viral on social media, but the date of the incident can't be confirmed.

The man seen attacking Saini is reportedly a homeless person. A person familiar with the case told ANI that police authorities acted firmly on the visual evidence of the case, and arrests were made promptly.

The mortal remains of the victim, being an Indian citizen, were sent back to Vivek's family in India on January 24, the person added.

## Man who stole, leaked Trump's tax records sentenced to 5 years in jail

The man who stole and leaked former US President Donald Trump's and thousands of others' tax records has been sentenced to five years in prison, CNN reported on Tuesday.

It reported that 38-yearold Charles Littlejohn pleaded guilty to one count of unauthorized disclosure of income tax returns. According to his plea agreement, he stole Trump's tax returns along with the tax data of "thousands of the nation's wealthiest people" while working for a consulting firm with contracts with the Internal Revenue Service.

Littlejohn leaked the information to two news outlets, deleted the documents from his IRS-assigned laptop before returning it and covered the rest of his digital tracks by deleting places where he initially stored the informa-

CNN reported that Judge Ana Reyes highlighted the gravity of the crime, saying multiple times that it amounted to an attack against the US and its legal foundation.

"The fact that he did what he did and he's facing one felony count, I have no words for," the judge said. Prosecutors argued that the one count covers the multitude of Littlejohn's thefts and leaks.

"A free press and public engagement with the media are critical to any healthy democracy, but stealing and leaking private, personal tax information strips individuals of the legal protection of their most sensitive data," prosecutors wrote in a court filing recommending Littlejohn be sentenced to the maximum of five years in

## **US SAYS NOT LOOKING FOR WAR WITH IRAN**

In response to a drone attack in Jordan that claimed the lives of three US Army soldiers and left 40 injured, the White House emphasised that it is not actively seeking war with Iran but did not rule out the possibility of strikes within Iran.

In a White House press briefing, National Security Council spokesperson John Kirby said, "We are not looking for war with Iran; we are not seeking a conflict with the regime in a military way. We're not looking to escalate here. This attack over the weekend was escalatory; make no mistake about it -and it requires a response, make no mistake about that. I will not get ahead of the president's decision-making."

CNN reported the incident as a significant escalation in the already precarious situation in the Middle East, with officials suggesting the drone was fired by Iranbacked militants from Syria. The specific militia group responsible is still under investigation.

President Joe Biden pledged a response, stating from South Carolina, "The United States shall respond."

The Defence Department has also released the names of the soldiers killed in the attack, allegedly by Iranbacked militias: Sgt William Rivers, 46, of Carrollton, Georgia; Specialist Kennedy Sanders, 24, of Waycross, Georgia; Specialist Breonna Moffett, 23, of Savannah,

Georgia, according to CNN. They were assigned to the 718th Engineer Company, a US Army Reserve unit based out of Fort Moore, Georgia.

More than 40 US service members were injured in the attack, with the number expected to fluctuate as symptoms of Traumatic Brain Injury (TBI) may be reported later. Pentagon Deputy Press

Secretary Sabrina Singh said, "We do expect that number to continue to fluctuate as our service members, as you know with TBI, report symptoms later on, so that number could continue to grow." US Central Command had initially reported 34 injuries on Sunday.

Kirby insisted that the US would "continue to look at the options available" for a response but did not confirm if the administration believes the Iranian regime directly ordered the attack. The situation remains tense as the US weighs its response in the aftermath of the tragic incident.

A day ago, Iran's Foreign Ministry refuted the claims of Tehran's involvement in the attack on a US base in Jordan and said resistance groups decide and work on their own principles and priorities as well as the interests of their country and people, Iran's state news agency, IRNA reported.

The drone attack on US outpost in Jordan marks the first instance of US troops being killed by enemy fire in the Middle East since the commencement of the Gaza

The attack targeted Tower 22 in Jordan, near the Syrian border, escalating an already precarious situation in the region. According to US officials, the drone responsible was launched by Iran-backed militants and seemed to originate from Syria, according to CNN.







## **RUGBY WORLD CUP 2023 REWRITES HISTORY** WITH UNPRECEDENTED VIEWERSHIP

The 2023 Rugby World Cup, hosted in France, witnessed a remarkable 19% increase in viewership compared to the 2019 edition, establishing itself as the most-watched rugby event in history, according to World Rugby (WR). Held in September and October, the tournament amassed an impressive 1.33 billion viewing hours across both linear and non-linear broadcast platforms, marking a substantial 30% growth from the previous Europeanheld World Cup in 2015 in England.

Of the total viewership, a significant 85% was attributed to free-to-air TV broadcasters, while streaming platforms contributed 5% to the overall viewership. World Rugby, in a statement released on Tuesday, highlighted their collaboration with free-toair broadcast partners in most markets, aiming to

In a stunning comeback, Australia's women's cricket team secured a series-deciding win against South Africa in the T20 clash at Blundstone Arena in Hobart on Tuesday. After shockingly defeating the

Proteas at Manuka Oval on Sunday, Australia claimed victory with a five-wicket final-over win, taking the three-match series 2-1.

Despite facing a challenging total of 7-162 set by South Africa, Australia successfully chased down the target with four balls to spare. Opener Beth Mooney played a crucial role, scoring 82 runs off 55 balls. Captain Alyssa Healy and Ellyse Perry fell early in the in-

performance, her second half-century of the series, guided Australia to victory.

Winning the toss once

again, Australia chose to bowl first, and their decision seemed wise as South Africa found themselves at 3-28 after the initial five overs. However, a resilient 80-run partnership between Marizanne Kapp (75 off 48) and Anneke Bosch (21 off 24) helped South Africa recover, setting their highest-ever T20I score against Austra-

Marizanne Kapp, who played her 100th T20I for the Proteas, delivered a career-best T20 innings, scoring 75 off 48 balls, including 10 fours and a six. Despite surviving a dropped catch, Kapp's impactful innings ended with a Talia McGrath yorker. Chloe Tryon contributed 26 off 16, and Sune Luus added an unbeaten 20 off 11, propelling South Africa to a competitive total of

## MUSHEER KHAN'S HEROICS PROPEL INDIA U19 TO VICTORY IN WORLD CUP SUPER SIX CLASH

In a spectacular performance, Musheer Khan, following his elder brother Sarfaraz Khan's maiden India call-up, delivered a stunning

century for the India U19 cricket team in their ICC Under-19 Cricket

World Cup Super Six match against New Zealand in Bloemfontein on Tuesday. With this accomplishment, Musheer joins the ranks of Shikhar Dhawan as only the second Indian to score multiple centuries in the Under-19 World Cup.

In an exclusive interview with TDG, Musheer's father, Naushad Khan, shared insights into his coaching philosophy, stating, "I don't talk or guide him... a good coach should know when to keep quiet... this is the time for both to perform on what they have learned."

This marks Musheer's second century in the ongoing World Cup,

following his impressive knock of 118 against Ireland on January 25. Shikhar Dhawan achieved a similar feat with three centuries in the 2004 edition.

Musheer Khan dominated New Zealand's bowling attack with his second century of the ICC U-19 World Cup, contributing to India's formidable total of 296 runs in their Super Six contest on Tuesday. Opening

batsman Adarsh Singh added to the challenge for New Zealand with a solid 52. On the Mangaung Oval's ideal batting wicket, Musheer showcased his skills, becoming the first player in the current competition to breach the 300-run mark, surpassing Pakistan's Shahzaib Khan.

His remarkable innings of 131 included 13 fours and three sixes off just 125 balls, demonstrat-

ing admirable temperament and strategic acceleration. Musheer's innings featured fine running between the wickets and

concluded in the death overs as he aimed to accelerate further.

The young cricketer's achievement makes him the second Indian batter

ever to score two centuries in the U-19 World Cup, following in the footsteps of Shikhar Dhawan's three centuries in 2004. Sarfaraz Khan, Musheer's elder brother, had represented India in the 2014 and

U19 World Cup editions. In Tuesday's match, Musheer reached a score of 131 before being

dismissed by Mason Clarke in the 48th over. His stellar performance led India to a total of 295/8 in 50 overs after being asked to bat. Musheer currently leads the run-getters list of the 2024 U19 World

runs from four matches, including 28 fours and 8

sixes. Notably, he has scored two centuries and one half-century in the tournament.

Musheer's century against New Zealand saw him surpass West Indies' Jewel Andrew as the leading run-scorer in this U19 World Cup. With 325 runs at an average of 81.25, Musheer holds the seventhhighest individual total by an Indian batter at a single U19 World Cup edition. Shikhar Dhawan remains at the top of the chart with his tally of 505 runs in 2004. This century also makes Musheer the second Indian batter after Dhawan to achieve multiple tons in a single U19 World Cup edition. Dhawan had three such scores during his memorable 2004 campaign. ## West Indies pacer Shamar Joseph sidelined from ILT20 with toe injury

West Indies pacer Shamar Joseph has been forced to withdraw from his upcoming ILT20 stint with Dubai Capitals due to a toe injury he sustained during the second Test match against

Australia at the Gabba.

Although scans revealed no fracture after being clattered on the shoe by a Mitchell Starc yorker, Joseph overcame pain on the fourth day to produce one of the greatest Test spells in history, taking 7 for 68 to inspire the West Indies to a magical eight-run victory - their first

in Australia since 1997. He did not expect to play at the start of the day until the team physio dosed him with painkillers. Joseph bowled unaltered after being brought into the attack, ripping through Australia's batting line and maintaining a pace of 150kph late in
