AZAM KHAN GETS 7 YEARS IN PRISON

NEW DELHI: Uttar Pradesh's Rampur Court on Monday sentenced Senior Samajwadi Party (SP) leader Azam Khan to seven years in prison and also imposed a fine of Rs 8 lakh on him over the forced demolition of a house in Dungarpur in 2016. The Special MP-MLA court also sentenced three others to five years in prison and imposed a fine of Rs 2.5 lakh on each of them in the case. Senior prosecution officer Amarnath Tiwari told Legally Speaking that Judge Vijay Kumar convicted Azam Khan, a former Uttar Pradesh minister, Azhar Ahmed Khan, a former chairperson of the municipal corporation, Ale Hasan, a former police circle officer and Barkat Ali, he added. Three other accused -- Jibran, Farman and Omendra Chauhan -- in the case were acquitted by the court, the further said.

No stay on disqualification TN moves SC as Governor of 6 Himachal MLAs

PM MODI HOLDS ROADSHOW IN COIMBATORE

Pays tributes to victims of 1998 bomb blast during BJP's first such grand scale road show in Tamil Nadu, which witnessed a good turnout.

Prime Minister Narendra Modi held a roadshow here on Monday, amid non-stop chants of 'Modi, Modi' by BJP workers and he paid floral tributes to portraits of 58 people killed here in 1998 serial bomb blast.

The roadshow, amid tight police security, comes days after the Madras High Court green-flagged the event, directing the police to allow it with reasonable conditions. The police had initially refused permission citing reasons, including the "communally sensitive" nature of the area, and the ongoing public exams in schools.

As Modi began his roadshow in an open, flowerdecked vehicle, people who gathered on both sides of the road showered flower petals on him, chanted slogans hailing him. While traditional music was played to welcome him, several of

them danced and waved at him enthusiastically.

This is the first time such a road show, on a grand scale, has been organised by the BJP in Tamil Nadu, which witnessed a good turnout.

"Meendum Modi, Vendum Modi," (Once again Modi, we want Modi) was one of the slogans raised by BJP supporters. Many people who lined up on the roads held lotus flowers in their hands to welcome Modi and raised "Bharat Mata Ki Jai" slogans. Clad in a spotless white kurta, Modi sported a colourful BJP shawl and often raised both his hands to wave at people who took vantage positions in buildings to take a glimpse of

At the end of the road show, Modi paid floral tributes to the portraits of people who were killed in the bomb blast that rocked this textile city in 1998, hours before iconic BJP leader LK Advani was to address a poll meeting on February 14 that year. Fifty eight people were killed and over a 100 injured. The portraits were placed in a small, makeshift memorial square.The lights and festoons and the Prime Minister waved and cheered saffron party workers who were waiting for over an hour to take a look at him. Performances of folk dance and traditional music energised the cadres who sung songs and danced.

This is the first time Modi has held a roadshow here and also this is the first political engagement of the PM following announcement of schedule for the Lok Sabha polls by the Election Commission. BJP Tamil Nadu president K Annamalai, Union Minister of State L Murugan, Coimbatore MLA and BJP Mahila Morcha national president, Vanathi Srinivasan were the three leaders who accompanied the Prime Minister in his vehicle. COMPLAINT AGAINST MODI FOR 'VIOLATING' **POLL CODE**

NEW DELHI: Trinamool Congress MP Saket Gokhale on Monday filed a complaint against Prime Minister Narendra Modi alleging that he violated the poll code by using an Indian Air Force helicopter to attend an election rally in Andhra Pradesh.

In a letter to Andhra Pradesh chief electoral officer Gokhale referred to Modi's visit to Chilakaluripet in Palnadu district on Sunday, where PM addressed a National Democratic Alliance (NDA) rally along with TDP chief N Chandrababu Naidu.

"This is to bring to your urgent notice and to file a formal complaint for violation of the Model Code of Conduct (MCC) by Hon'ble Prime Minister Narendra Modi on 17.03.2024 in the **Assembly Constituency** of 96-Chilakaluripet in Palnadu District of Andhra Pradesh," Gokhale said in his letter

Congress leader Jairam Ramesh said the I.N.D.I.A bloc was not against Electronic Voting Machines (EVMs) but demanded that there should be 100 percent matching of the Voter Verified Paper Audit Trail (VVPAT).

Speaking to reporters here on Sunday, the Congress leader said, "During the INDIA meeting held on December 192023, all parties concurred that we are not against EVMs but against manipulation of EVMs. We are not asking to go back to paper ballot but are only calling for the VVPAT to be matched 100%."

Earlier, on March 15, the Supreme Court refused to entertain a petition urging a return to paper ballot, alleging irregularities in the functioning of electronic voting machines (EVMs).

The court declined to entertain the petition filed by petitioner Nandini Sharma. saying that every method has some positive and negative points. The court also expressed its inability to entertain these many petitions related to similar 'concerns' about EVMs.

Ramesh's statement marked a departure from the position

AgustaWestland case: SC declines to hear Michel's bail plea

The Supreme Court, on Monday, declined to entertain a fresh bail plea of Christian Michel James, an alleged middleman being investigated by the CBI and the ED in the alleged Rs 3,600-crore AgustaWestland chopper scam cases related to the purchase of 12 VVIP helicopters. It was argued that James cannot be charged under any other offenses apart from those mentioned in the extradition decree and should be granted the benefit of the doctrine of specialty. He was arrested in December 2018 after being extradited from Dubai.

"How can you file the Article 32 petition in this case?" questioned a bench comprising Chief Justice D Y Chandrachud and justices I B Pardiwala and Manoj Misra. Addressing the submission that James cannot be charged for other offenses not part of the extradition decree, the bench stated this had been previously addressed and it cannot go "ad nauseum."

The counsel for the extradited accused highlighted that he has been in jail for the last five years, which could be the maximum sentence

upon conviction.

On February 7 last year, the top court denied bail to James, rejecting the submission that he be released on the grounds of completing half of the maximum sentence in the cases.

The CJI, while writing the judgment, had stated James may pursue his remedy of regular bail before the trial court in the case.

James had sought bail under section 436A of the Code of Criminal Procedure (CrPC), which allows a person to be released on bail upon completing half of the maximum sentence prescribed for the offense.

The accused had challenged the Delhi High Court order dated March 11, 2022,.

Dismissing the bail pleas in both the CBI and ED cases in 2021, a trial court had determined it was not a fit case for bail considering the overall facts and circumstances.

The CBI, in its charge sheet, alleged an estimated loss of 398.21 million euros (about Rs 2,666 crore) to the exchequer due to the deal signed on February 8, 2010, for the supply of 12 VVIP helicopters worth 556.262 million euros (around Rs 3,600

However, coming out in defence of the scheme, Union Minister of State for Health and Family Welfare, SP Singh Baghel, said the Opposition was hurling unfounded allegations at the BJP over the electoral bond scheme.

Scheme was launched to extort firms using central agencies. Under their regimes, even transfer postings or handing of contracts were listed under party fund."

Earlier, Election Commission made public fresh data on electoral bonds, which was previously submitted to the Supreme Court in sealed covers, following a directive from the apex court to make it available to the public.

"The Election Commission of India has today uploaded the data received in digitized form from the registry of the Supreme Court on electoral

Big blow to AAP leader Satyendar Jain, SC dismisses bail plea

On January 8, the apex court had extended the interim bail granted to Jain until further notice, citing medical grounds.

The initial interim bail had been granted on May 26. 2023, and had been subsequently extended on multiple occasions.

4 arrested for duping Delhi man of Rs 16 lakh in gold trading scam

Four people have been arrested for allegedly duping a Delhi-based businessman of Rs 16 lakh in an online "gold trading" scam, said police on Monday. According to Delhi police, "The 4 scammers were arrested after raids were conducted in Delhi, Gujarat and Punjab by the Cyber Police, Outer North District."

The scammers were arrested in connection with a pan-India online gold trading scam run by cybercriminals under a criminal conspiracy to cheat people. "In this module, the scamsters allured the complainant on a WhatsApp group to invest in gold trading through an application called "GBL Gold" that was being operated by scammers outside the country," said police. The police further said that the fictitious website of the GBL Gold application used in the scam was designed by

crooks operating from China and was shared through WhatsApp and Telegram IDs whose IP addresses were those of Huwai, China. The module was formed and modulated in China. "The money obtained from the scam was being transferred into accounts handled by the fraudsters and then siphoned using USDT, Crypto and other such apps to evade agencies, " said the police. The police said that the Indian Cybercrime Coordination Centre (I4C) is in the process of tracing all India-related links related to the fraud and is determining the exact amount of the scam.

The Indian Cybercrime Coordination Centre (I4C) was established by MHA in New Delhi to provide a framework and eco-system for law enforcement agencies (LEAs) to deal with cybercrime in a coordinated and comprehensive manner. Further details on the matter are awaited.

Delhi excise policy case: BRS MLC Kavitha moves SC challenging her arrest

DEATH TOLL RISES TO 8 IN KOLKATA **BUILDING COLLAPSE**

KOLKATA: Death toll in collapse of under-construction building in South Kolkata has risen to eight, an official said on Monday. Kerala Govt moves SC seeking stay on CAA implementation

Kerala government has filed a fresh plea in the Supreme Court, seeking a stay on the implementation of the Citizenship (Amendment) Rules, 2024, arguing that they are discriminatory, arbitrary, and violate the principles of secularism.

On March 11, the Centre cleared the path for the enforcement of the Citizenship (Amendment) Act, 2019, by notifying the relevant rules, four years after the controversial law was passed by Parliament. The aim was to expedite Indian citizenship for undocumented non-Muslim migrants from Pakistan, Bangladesh, and Afghanistan who arrived in India before December 31, 2014. Labeling the CAA Rules as 'unconstitutional', the state government stated that classi-

fications based on religion and country are discriminatory, arbitrary, unreasonable, and contrary to the principles of secularism.

"The fact that the defendant (Union) itself has no urgency in the implementation of the 2019 Act is a sufficient cause for staying the 2024 rules," the plea mentioned.

Kerala government, which had previously filed an original suit against the validity of the Citizenship Amendment Act (CAA), asserted that the Amendment Act, Rules, and Orders lack any standard principle or norm in discriminating migrants from other countries like Sri Lanka, Myanmar, and Bhutan, which share international borders with India and witness trans-border migration.Arguing that the CAA was "arbitrary", Kerala stated that the Rules constitute a "class legislation" facilitating the expedited process for granting Indian citizenship to members of Hindu, Sikh, Buddhist, Jain, Parsi, or Christian communities who entered India on or before December 31, 2014, from Afghanistan, Bangladesh, or Pakistan.

"Classifications based on re-

ligion and country are manifestly discriminatory. It is trite and settled law that legislation discriminating based on an intrinsic and core trait of an individual cannot form a reasonable classification based on an intelligible differentia," the plea contended. The apex court had agreed on Friday to hear on March 19 the pleas seeking a direction to the Centre to suspend the implementation of the Citizenship Amendment Rules, 2024, until the disposal of petitions challenging the constitutional validity of the Citizenship (Amendment)

EC banks on AI for trouble-free polls in WB

In a bid to ensure trouble-free elections in West Bengal, the **Election Commission is firming** up plans to use the power of Artificial Intelligence (AI) in this year's Lok Sabha elections in the State.

Election Commission sources in Kolkata said the use of AI would make it possible for the poll panel to detect irregularities in sensitive booths during the poll process.

"Various AI tools will be used to monitor polling processes, analyse data, and ensure election integrity through machine learning algorithms and help us take preventive measures promptly," a senior poll panel official told The Daily Guardian.

He explained that with the number of sensitive booths in the State running into a few thousands, the use of Artificial Intelligence (AI) to spot and act on electoral malpractices at such booths in this year's Lok Sabha elections would go a long way in controlling election improprieties.

"AI tools have been programmed to recognise the polling process in a booth and trigger alerts whenever it spots any discrepancy, such as an absence of poll officials or the presence of more than the usual number of people in a booth," he added.

He explained that AI-based analyses of audio and video footage obtained from each polling station's webcast would trigger a process of auto-selection if any sort of irregularity was noticed. This "auto-selection" would ensure early alerts to EC officials. There are also plans to keep track of queue management through AI-based webcasting.

For example, if the footage recorded any instance of commotion or high-decibel sounds in booths, these booths would get "auto-selected" by AI. Alerts would then simultaneously go out to officials at the EC's office in Delhi, the CEO's office in Kolkata and the District Election Officer (DEO) at the district headquarters for them to verify and act on the

situation with field officers, the official added.

"Even if a voter is present in the voting compartment for a longerthan-usual period, it will trigger an alert and the voter's facial image will be captured,"" the official

Polling data will also be analysed to look at discrepancies - such as more-than-usual votes cast in a very short time.

"Machine learning algorithms can also be used to analyse election data from previous elections

to identify patterns that could indicate election fraud and prevent it from happening in the future. AI technology may also be used to monitor voting machines to detect any attempts at hacking or tampering," an EC official added. Sources said AI monitoring would be deployed at all sensitive and vulnerable booths, so that all data was properly captured, analysed and forwarded to returning officers and observers, so that proper preventive measures can be adopted.

Exporters need to follow new British rules to avail duty benefits: DGFT

Exporters seeking to avail duty concessions on shipments to the UK will have to adhere to the new British rules under the Developing **Countries Trading Scheme** (DCTS).

In a trade notice, the Directorate General of Foreign Trade said that the United Kingdom (UK) has replaced its existing origin declaration process under Generalized Scheme of Preferences (GSP) with the UK DCTS effective from June 19, 2023.

The transition period for this change was extended until December 31, 2023.

"Starting from January 1, 2024, onwards, Indian exporters to the UK are required to adhere to the new rules under DCTS to avail concessions on their exports to the UK," the trade notice to the exporters community said.

It added that goods that meet the UK DCTS Rules of Origin (RoO) requirements would be eligible to claim a concessional rate of import duty for exports to the UK.

"Consequently, the origin

criteria necessary for satisfying the Rules of Origin to avail tariff concessions on exports from India to the UK must be filled in through self-certification,"

it added.

Accordingly, it said, Indian exporters are directed to use origin declaration wording under DCTS scheme, in place of origin declaration wording under GSP.

Certain labour-intensive sectors such as leather, carpets, chemicals, iron amd steel and textiles were the major beneficiaries of the

The US, European Union (EU), Australia, Japan and many other developed countries grant unilateral import duty concessions to developing countries under their GSP schemes.

As per estimates, India's exports worth USD 2.5 billion were entitled for the GSP benefit in the UK. India and the UK have

been negotiating a free trade agreement since January 13, 2021. As many as 14 rounds of talks have been completed and both sides are aiming to conclude the negotiations at the earliest.

Of the nine seats allotted to Congress, Cuddalore, Mayiladuthurai and Tirunelveli are currently held by the DMK in the 17th Lok Sabha and the remaining seats were won by the Congress in 2019 as an ally of the Dravidian party.

In the 2019 LS polls, barring the Theni LS seat which was won by the AIADMK, the Congress won the other eight constituencies it contested.

The DMK has now completed the exercise of seat alloca-

tion, which began over a month ago. Madurai and Dindigul have been allotted to CPI(M), Nagapattinam and Tiruppur to CPI and the reserved seats of Chidambaram and Villupuram to VCK. 

On Saturday, the Election Commission of India announced that the 2024 Lok Sabha elections will be conducted in seven phases, scheduled from April 19 to June 1. The results will be announced on June 4, marking the commencement of the Model Code of Conduct.

The voting process will commence with the first phase on April 19, followed by the second phase on April 26, the third phase on May 7, the fourth phase on May 13, the fifth phase on May 20, the sixth phase on May 25, and concluding with the seventh phase on June 1. The counting of votes is scheduled for June 4.

Chief Election Commissioner Rajiv Kumar explained that the decision to conduct the polls in seven phases was made considering various factors such as geographic conditions, festivals, and examination schedules.

Approximately 96.8 crore individuals are eligible to exercise their voting rights in the forthcoming elections across over 12 lakh polling stations.

In the 2019 Lok Sabha elections in India, the Bharatiya Janata Party (BJP), under the leadership of Prime Minister Narendra Modi, secured a resounding victory by winning 303 seats out of the total 542 contested seats. The party's ex-

Amid the Opposition furore over the notification of rules for the implementation of the CAA last week, the JD(U) leader sought to dispel fears of loss of citizenship, saying that the law merely intended to give permanent residentship to religious

Case for legislative guarantee of minimum support prices

The price of guarantee will be less than the higher interest rate and cost of capital





n 2023, government procurement achieved 26 million tons against a target of 35 million tons. These two years saw more than MSP being paid by market prices. Farmers have returned to their streets. This time, there isn't an instant trigger like there was the previous time they marched to Delhi to protest the adoption of the three controversial farm regulations. The farmers have many requests, but the main one is a legislative guarantee for Minimum Support Prices (MSP). Although this has long been demanded, its exact meaning is not entirely clear.

Fear mongering with inflated assertions about fiscal expenses, monopolization of agricultural commerce, and missing markets has clearly resulted from the lack of clarification. The National Food Security Act (NFSA) and the National Rural Employment Guarantee Act were both preceded by similar scare tactics. In reality, the government has not become insolvent as a result of either of these pieces of law. Rather, they turned out to be a vital resource for individuals within the pandemic. MSP is an easy-to-use system that guarantees the price stability of vital agricultural products. Other nations' farmers have access to such methods. By actively intervening in the market when prices fall below the

MSP, the government hopes

to protect farmers from price

In India, it has been around for more than 50 vears. So why are farmers requesting a formal guarantee? Prior to the sowing season, the government releases the MSP for 23 crops each year. However, the government does not act on the MSP announcement for the majority of crops. In actuality, it is only used for the two main crops, rice and wheat, and sporadically for other crops like pulses. However, even in these situations, the government's market intervention serves to fulfill legal requirements and fulfill its commitments under the NFSA rather than to assist farmers. Farmers are merely asking that the MSP program be carried out as planned by the government. The majority of political parties and labor organizations support a legislative guarantee of this kind, but despite this consensus, successive governments have been slow to legitimize this system. The main cause has been the worry that the costs of providing such a guarantee would be too high. Large sums of money, between Rs. 10 and 18 lakh crores, have been proposed as the guarantee's cost. The majority of these presumptions stem from a lack of knowledge about agricultural markets and MSP's function in price stabilization. There are two reasons why it is false to as-

will have to purchase all agricultural products if MSP implementation is guaranteed. Firstly, what is commonly called the marketable surplus is the portion of the produce that is available in the market. Second, government intervention is only necessary when the market price of a commodity is lower than the MSP, even in the situation of marketable surplus. However, even in this instance, action is only required to the degree that it generates surplus demand and drives up market rates.

Usually, it might only represent a small portion of the market's arrivals. Years with greater market prices will require no intervention from the government. Furthermore, farmers are unlikely to sell at prices below market rates, even in the event that the government steps in. For wheat, this occurred throughout the previous two years. Government purchases accounted for just 19 million tons, compared to the 44 million tons objective set for

Against a target of 35 million tons, government procurement came in at 26 million tons in 2023. Market prices exceeded MSP in each of these two years. On the other hand, it is unfair to consider the price of obtaining rice and wheat to be the same as the price of the MSP program. Actually, the majority of it is a consumer subsidy rather than a farmer subsidy. But regardless of the MSP guarantee, this is a government commitment made under the NFSA and is required. Farmers simply receive the bare minimum in exchange for their laborintensive produce—nothing

Unless the government offers a subsidy, the cost of government purchase for the remaining crops that are not included in the NFSA bundle is not incurred. The only amount the government must pay is the discrepancy between the issue price and the economic cost of grain procurement. The cost is zero and all of the expenses are recovered for the remaining crops, which the government does not sell by

providing subsidies. In rare cases, when market prices are higher, the government can also profit by selling the produce it has purchased at a little markup on both domestic and foreign markets. This will assist stabilize market pricing as well as lower domestic prices during spikes in inflation. The government has been exporting stocks to take advantage of higher foreign prices for a number of years in addition to open-market activities

The farmers' issues might not be resolved by a guaranteed MSP. However, it presents a favorable chance the MSP and procurement system. These days, procurement is restricted to specific regions and can only include wheat and rice. To address the regional disparities in agricultural productivity, an enlarged and regionally diversified MSP covering a wider range of crops is required. Additionally, it will guarantee crop diversification and investment in, strengthening, and expanding storage management all essential for the management of natural resources.

Farmers' and their need for an overhaul of the MSP system are, in large part, the result of years of disregard for the agrarian economy, which has resulted in falling real wages and incomes. Although the cost of such a guarantee is impossible to calculate, it will undoubtedly be less than the higher interest rates and increased cost of capital that the economy must bear as a result of managing inflation. Additionally, price stability will shield the typical consumer from the whims of inflation. More crucially, safeguarding farmers' incomes will support the recovery of the rural sector during a period when it is beset by weak demand and rising inflation.

Action against Left-wing extremism in its final leg

Left-Wing Extremists (LWE) have a long history of daring democracy through violence. This alleged "ideological war" not only stalled development in the affected areas but has also led to the burnt of lives of 16.652 security personnel and civilians in the furnace of violence in the last four decades. The irony is that the militants have obstructed development works and prevented the construction of schools, hospitals and roads under the cover of fighting for water, forest and land. Consignments of foreign weapons have been delivered to these militants with the help of NGOs and some urban Naxalites who are growing with foreign financial assistance, who talk about the rights of tribals.

When the war is between Kauravas and Pandavas, Krishna can choose his camp very easily, but when the Kauravas stand in the guise of Pandavas on one side and Pandavas on the other, then Krishna can also be confused in choosing his side. Because tribals were and still are used as shields, the Government has to think many times before using force. For decades, the Congress Government's sympathy for the Left, the resulting failure and exploitation has resulted in the success of misguiding the tribal community to the Left Wing Extremism for so many years.

This situation has undergone radical changes since 2014. Due to the tough and impactful decisions of Prime Minister Narendra Modi and Home Minister Amit Shah, the impact of Left-Wing Extremism has been greatly limited and contained today and the fight has now reached the final leg. With the message of development and peace in self-reliant new Bharat, the Ministry of Home Affairs has formulated a three-pronged strategy to deal with Left-Wing Extremism:»Better strategy to rein in militants», «better Centre-state coordination» and «People's participation through development».

THREE-PRONGED

STRATEGY This three-pronged strategy has achieved historic success in containing LWE in the last 10 years, which is reflected in the data. The lowest number of LWE violence in the last 35 years and the lowest number of deaths in 40 years were reported this year. Violent incidents decreased by 76% compared to the high in 2010 and the number of civilians and security personnel killed decreased by 90% from the peak of 1005 in 2010 to 98 in 2022. The geographical spread of Left Wing Extremism has also steadily

declined. Last year, incidents of violence were reported from 176 police stations in 45 districts alone, while in 2010, incidents of violence were reported in 465 police stations in 96 districts. The also reflected in the fact that 72% of violence last year was reported from only 10 districts. At the police station level, 50% of the violence has been reported from only 30 police stations. For the first time after several decades, the number of civilian and security forces deaths was less than 100 in 2021.

The reach of good governance to the affected remote areas has created a bridge of trust in the government in the hearts of the people today. Left Wing Extremism has historically flourished in areas where poverty has taken roots. In his view, the groups affected by poverty had sowed the seeds of militancy by using the discontent of the people affected by poverty as manure and water. Due to the local support these groups received, the security institutions had to face many problems. But the situation changed after 2014. The Modi Government's schemes for the welfare of the poor spread in these areas as well and people came to believe that the Government was their true benefactor, not the extremists! Under the leadership of PM Modi and under the guidance of HM Amit Shah, the Vikas Se Jan Bhagidari has ensured people's participation in the efforts of security agencies by putting additional emphasis on schemes for poor welfare and development in the affected areas.

As part of the strategy

to contain the militants, all efforts have been made to reduce the security vacuum and core area. Since 2019, 195 new camps have been opened, which have reduced the security shrinking scope of LWE is vacuum to almost zero in the affected areas, barring a few areas. The strategy is showing positive results and has succeeded in completely eliminating the security vacuum by setting up its camps in Maoist strongholds like Barmasia and Chakarbanda in Bihar and Budha Pahar and Parasnath in Jharkhand. The result is that the LWEs have shrunk to a few regions. The leaders of the 14 Politburo and Central Committee members have been neutralised through intelligence-based operations, creating a major vacuum in the senior Maoist

> leadership. The security forces surrounded the Naxalites by adopting an offensive strategy against the militants and under this policy, the 13day joint operation using the newly established security camps in Lohardaga district of Jharkhand in February 2022 had many successes. In the direction of financial choking, a total of Rs 68.57 crore cash and assets have been seized by the States, ED and NIA. Setting up of separate verticals in NIA, special operations teams in central and state police forces with the help of expertise and knowledge sharing of Special Task Force has been used to weaken Left Wing Extremism with technical and tactical support using latest technology. Special funds have been provided for early construction of major night landing helipads for air

support.

Under better Centre-State coordination, the Centre provided non-discriminatory assistance to the affected state governments for Central Armed Police Forces battalions, helicopters, training, funds for modernization of state police forces, equipment and weapons, intelligence, construction of fortified police stations etc. 2606 crore released to affected States in last O9 years for capacity building of States (about 124% increase in 9 years). The Special Forces and Special Intelligence Branches of the states have received projects worth Rs 1724 crore in the last five years. 536 Fortified Police Stations were constructed and 102 Fortified Police Stations are being built. Under the scheme of assistance to central agencies, Rs 106 crore was given for camp infrastructure and Rs 12.06 crore for upgradation of 6 hospitals.

INITIATIVES, INFRA AND INROADS

To improve road connectivity, 12100 km of roads have been sanctioned in the last 9 years and about 10350 km of roads have been constructed. Department of Posts opened 4903 new post offices with banking services in the last 9 years in the affected districts. Since April 2015, 955 new bank branches and 839 ATMs have been set up in 30 most affected districts. In order to speed up communication, 2343 mobile towers were installed at a cost of Rs 4080 crore in the first phase and 2542 mobile towers are being installed at a cost of Rs 2210 crore in the second phase. 214 Eklavya Schools have been sanctioned

after 2014, out of which 163

Eklavya Schools have been sanctioned in the last 4 years. 11 Kendriya Vidyalayas and 6 Navodaya Vidyalayas have been opened. Under the skill development scheme, 48 Industrial Training Institutes and 68 Skill Development Centres were approved at a cost of Rs 495 crore. Activities like health camps, drinking water, solar lights, distribution of medicines, skill development, farm equipment, seeds etc. are being conducted for the local population by the companies of Central Armed Para Military Forces deployed in the affected areas in which works worth Rs 140 crore have been done since May, 2014. Under the Tribal Youth Exchange programme, some 22, 000 youth have been taken for a tour of large and developed areas of the country with an expenditure of Rs 26.5 crore. The objective is to make these youth aware of technological/industrial advancement so as to wean them away from the impact of LWE.

The initiative to take the benefits of the government's development schemes to the general public has been successful and this is feeling the pressure in the structure of the Naxalites. People's self-confidence towards assimilation of the poor and tribals in society and socioeconomic development is increasing. Opposition and difference of opinion have been accepted with full respect in the Indian Constitution. It would be unimaginable that in India, with a population of over 125 crore and more than 10,000 dialects and the richest in culture, it would be unimaginable for all views to agree with each other.

tion is plain ignorant in its foreign policy dealings, specifically when it comes to India, or just duplicitous. Or is it actually a case of US government departments and individuals working in silos, running their own agendas, without caring for the fallout of their actions and utterances—one of the fallouts being offending allies and partners, including India. The US Justice Department, for one, has been pursuing the supposed assassination attempt allegedly by the Indian government of known Khalistani extremist Gurpatwant Singh Pannun, even though the Indian government has been clear that assassinations are not part of its policy. And now Justice is investigating an Indian entity to find out if it indulged in any bribery of any Indians on Indian soil, apparently because there is some US investment in that entity. That this is direct interference in a nation's internal matters, does not bother this department of the US administration.

The latest trouble is with India's Citizenship Amendment Act—now that the rules have been notified. The State Department is particularly concerned that the CAA has been notified and says that it is monitoring how the Indian government is implementing it, as, "respect for religious freedom and equal treatment under the law for all communities are fundamental democratic principles.' This resulted in a sharp rebuttal from the Ministry of External Affairs, which called the statement, "misplaced, misinformed and unwarranted." After that, US ambassador to India, Eric Garcetti went a step further by saying that the US opposition to the CAA was based on principles—that a democracy must follow the principles of religious freedom and equality. It is not known how, by expediting the process of granting citizenship to persecuted minorities coming from Muslim-majority countries such as Bangladesh, Pakistan and Afghanistan, any principle of democracy or human rights has been violated. It is not that Muslims coming from the neighbouring countries cannot apply for Indian citizenship or will not be granted citizenship under the Citizenship Act of 1955, if they have a valid case. In the normal course of things, following all the rules, they too can become Indian citizens.

As External Affairs Minister S. Jaishankar mentioned, the US too has fast-tracked the citizenships of specific groups of people based on their faith and ethnicity. The Lautenberg Amendment fasttracked the citizenship of persecuted Christians and Jews from Russia; the Spectre Amendment extended this to persecuted minorities from Iran. How is it that the US fast-tracking the citizenship of persecuted minorities is upholding democracy, but India doing something similar is muzzling human rights? Moreover, as it is being mentioned, the CAA cannot be seen in isolation. It has to be seen in the historical context of the partition, when some people belonging to certain faiths did not or could not come to India. Over time, as they were systematically oppressed, where would they find refuge, if not in India? Also, what principle is Ambassador Garcetti talking about—the principle that cannot see the deliberate extermination of the minority communities in three of India's neighbouring countries, so much so the minorities have more or less disappeared from Afghanistan, are about to disappear from Pakistan and will eventually disappear from Bangladesh? Shouldn't Mr Garcetti's lectures on democracy and principles be directed at India's

In fact, in India-US relations, it seems that the Defence and Commerce departments of the US government are serious about ensuring that this partnership lives up to the potential of being the most consequential of this century. But that is definitely not the case with departments such as State and now Justice. At a time when the US has placed India at the centre of its Indo-Pacific strategy, the State Department has been railing against India on imaginary violations of human rights, apart from delaying visas for Indian citizens for hundreds of days. The Pakistani-influenced United States Commission on International Religious Freedom (USCIRF) has been trying to get India blacklisted and sanctioned for being a "country of particular concern" for religious minorities. The State Department reports on religious freedom take substantial inputs—a majority of them distorted and fake from the USCIRF, including on India. But let us not impute any sinister motive to the State when it comes to India. Maybe its "concerns" about India are stemming from both ignorance and its own "wokeness". However, what State needs to realise is that its mishandling of the India desk may impact India-US relations negatively, which is not in the interest of either country. The whole of government approach is missing in this and raises serious questions about the interests and agendas that are often working at cross purposes in the Joe Biden administration.

So who does this help? China, of course.

As for Mr Garcetti, he has been very closely linked to China for decades—this is reported and well known. As the US ambassador to India he should know the importance of not making statements that offend Indians and gladden the Chinese. It is the India-US relationship that is at stake here.

The counterpart of the Speaker in the Rajya Sabha (Council of the States) is its Chairperson; the Vice-President of India is the ex-officio chairperson of the Rajya Sabha. he Allahabad High Court in the case observed and has dismissed the challenge made to the cancellation of the lease of Maulana Mohamad Ali Jauhar University's land in the state's Rampur District.

In the present case, the writ petition has been moved challenging the Ut-

tar Pradesh government's move to seize the land by voiding the lease deed associated with the University.

The State Government

in the case cancelled a 3.24-acre land lease to Maulana Mohammed Ali Jauhar Trust, led by former UP minister Azam Khan, citing lease condition violations alleging that originally allocated for a research institute, a school was running on the

property. As per the rules, after the cancellation of the lease, the possession of land automatically goes to the government.

The Division bench comprising of Justice Manoj Kumar Gupta and Justice Kshitij Shailendra in the case observed and has reserved its verdict in the matter after hearing both parties days after it listed Jauhar University Trust's plea for 'urgent admission'

The bench in the case observed and has directed the State government to keep the helpline for children of Rampur Public School operative till the end of the academic year 2023-24.

The court noted that during the hearing in the case, the Advocate General had defended the cancellation of the lease without show cause notice on grounds that public interest is of

paramount consideration.

Adding to it, the court stated that it being not the case of the petitioner that the law has been erroneously interpreted by the respondent No.7. The said court in exercise of its power as stated under Article 226 of the Constitution of India, cannot sit as an Appellate Authority over the order passed under Section 70 of the Act. Thus, it cannot delve into a disputed question of facts.

The court observed while considering the facts and circumstances of the case observed and has held that it being the case of the petitioner that the facts have not been properly appreciated by the Appellate Authority i.e., respondent No.7 and that respondent No.1 is liable to pay amounts to the petitioner as alleged. Thus, the said allegation has reached finality by the order passed by respondents No.7 and this Court in exercise of its powers as stated under Article 226 of the Constitution of India cannot examine the same. Accordingly, the court dismissed the petition.

The Delhi High Court in the case X v. Y observed that the court must scrutinize the complaint or FIR filed by the wife against the husband and his family members in order to determine whether the allegations are a 'case of cheer drafting' or have some element of truth.

The bench headed by Justice Navin Chawla in the case observed that where the wife is set to implicate the entire family of the husband in a criminal case and it is to be expected that she would get a complaint properly drafted through $her \, lawyer \, making \, specific$ allegations against each one of them.

DRAFTING' OR HAVE SOME ELEMENTS OF TRUTH

The court stated that the said court must scrutinise the complaint or FIR to determine whether the allegations are a case of clever drafting or have at least some elements of truth in the same. Adding to it, the court stat-

ed that though the Court is not expected to conduct a mini-trial, it also cannot be a mere spectator and refuse to exercise the power of quashing the case that is vested in it under Section 482 of Code of Criminal Procedure, CrPC, where it finds that continuation of such proceedings would defeat the ends of the justice and would amount to insurmountable harassment, agony and pain to the accused and be an abuse of the criminal process.

The court in the case observed and has quashed the

FIR registered by a wife in 2017 against the maternal uncle and aunt of the husband for the offences under Section 498A, 406 and 34 of the Indian Penal Code,

> In the present case, the FIR was filed against other accused persons as well, the wife alleged that right from the date of marriage, the husband and his relatives were harassing her for dowry and beat her. While the marriage happened in the year 1997, the FIR was registered in 2017, i.e. after 23 years.

The petition was filed by the husband's maternal uncle and aunt wherein it seeks to quash of the FIR on the ground that they were residing separately from the husband and wife and were dragged in the case only because they were the husband's family members.

The bench headed by Justice Chawla in the case observed that mostly general and vague allegations were made against the husband's family members, thereby naming his entire family.

The court while considering the facts and circumstances of the case stated that the FIR and even the consequential charge-sheet are based only on the averment made by the respondent no.2 in her complaint. Thus, barring her statement or complaint, there being no other material placed on record by the respondent no.2 against the petitioners.

Putin returns as President of Russia with over 87% votes

ussian President Vladimir Putin won the presidential elections, receiving 87.17 per cent of the votes based on the result of processing 70 per cent of the electoral protocols, Russia-based TASS reported, citing data from the Central Election Commission of the Russian Federation.

The Communist Party of the Russian Federation candidate Nikolai Kharitonov secured the second spot with 4.1 per cent of the votes while New People Party candidate Vladislav Davankov stood third with 4.8 per cent votes.

The Liberal Democratic Party of Russia (LDPR) candidate, Leonid Slutsky, received a mere 3.15 per cent of the votes counted.

According to preliminary data as of 6 pm (Moscow time) on Sunday, the voter turnout in the presidential elections, which for the first time took place over three days from March 15-17, stood at 74.22 per cent. Voter turnout for the elections held in 2018 was 67.54 per cent. Putin received more votes in

comparison to the 2018 elections where he bagged 76.69 per cent of the total votes counted. The performance of the other candidates was lower than that of the previous competitors of Russian President Vladimir Putin in 2018, according to reports.

In 2018, Pavel Grudinin, who was the candidate for the Communist Party of the Rus $sian\,Federation, received\,11.77$ per cent of the votes while LDPR candidate Vladimir Zhirinovsky (LDPR) bagged



5.65 per cent votes.

All three parties that nominated candidates for the 2024 elections can count on receiving funds from the federal budget, TASS reported, adding that as per law, all parties have the right to funding even if their candidate vying for the post of head of state overcomes the three per cent barrier. For each vote, the party will renoted.

This was the first time, remote electronic voting was used for the presidential elections in Russia. Residents used the federal platform in 28 regions while people in Moscow cast votes on their own platform.

The final turnout for online voting on the federal platform stood at 94 per cent, meaning that 4.4 million people cast their votes online.

In Moscow, almost 3.7 million electronic ballots were issued, including voters who used special terminals at polling stations.

According to the results of remote electronic voting on the federal platform, Putin secured the first spot with 87.41 per cent of the votes while Davankov stood in second place with 6.28 votes.

Friends and allies hail Putin's victory, Western leaders condemn

President Xi Jinping said the result "fully reflects the support of the Russian people", Chinese state media reported.

Iran's President Ebrahim Raisi hailed Putin's "decisive victory", state news agency IRNA reported. Chad's President Mahamat Idriss

Deby Itno, son of the country's late longtime leader Idriss Deby, congratulated Putin in a Facebook post. He said the result was "proof of the Russian people's trust" in

VENEZUELA: 'BODES

In Latin America, Venezuelan President Nicolas Maduro said: "Our older brother Vladimir Putin has triumphed, which bodes well for the world".

Cuba's Miguel Diaz-Canel said the official result was "a credible indication that the Russian population supports (Putin's) management of the country".

ZELENSKYY: 'EVIL'

In Europe, however, the election met with condemnation. Ukrainian President Volodymyr Zelenskyy dismissed it as illegitimate. "Everyone in the world understands that this person, like many others throughout history, has be-

come sick with power and will stop at nothing to rule forever," he said. "There is no evil he would not do

to maintain his personal power." **EU: 'REPRESSION'**

The European Union said Russians had been denied a "real choice" after all candidates opposed to the war in Ukraine were excluded.

EU foreign policy chief Josep Borrell said the vote was "based on repression and intimidation".

The 27-nation bloc said it would "never recognise" the result of polling staged in regions of Ukraine occupied by Moscow. But it did not heed a call from the widow of leading Kremlin foe Alexei Navalny not to recognise Putin as the legitimate president of Russia.

GERMANY: 'HEINOUS'

Germany's foreign minister, Annalena Baerbock, said the vote "without choice" demonstrated "Putin's heinous behaviour against his own people".

France's foreign ministry said "the conditions for a free, pluralist and democratic election were not

It said the vote was held amid "increasing repression of civil society and all forms of opposition to the regime" and saluted "the courage of the many Russian citizens who have peacefully demonstrated their opposition to this attack on their fundamental political rights".

BRITAIN: 'ILLEGAL'

British Foreign Minister David Cameron said the "illegal" election "starkly underline the depth of repression under President Putin's regime, which seeks to silence any opposition to his illegal war (in Ukraine)".

"Putin removes his political opponents, controls the media and then crowns himself the winner. This is not democracy.'

CZECH REPUBLIC: 'FARCE' Czech Foreign Minister Jan

Lipavsky called the vote a "farce". Moldova's President, Maia Sandu, said: "We cannot talk about free and fair elections when the real opponents are removed from the race, some are sent to jail, others are expelled from the country; when reprisals are so great that people are afraid to speak out; when nothing remains of the free

She added: "This is not the conscious and free choice of citizens." Italian Foreign Minister Antonio Tajani condemned the vote as "neither free nor fair", adding: "We are continuing to work for a just peace that will bring Russia to put an end to the war of aggression against Ukraine."

NORWAY: 'VIOLATION'

Norway, which shares a border with Russia, said the fact that the Kremlin had organised voting in parts of Ukraine "illegally occupied" by Moscow was "a serious violation of international law".

Russia-NATO conflict is 'one step away' from World War III: Putin

Russian President Vladimir Putin on Monday warned the Western powers that any direct conflict between Russia and the NATO alliance, led by the US, would mean the world will be "one step away" from a full-scale World War III, TASS reported.

However, he also said that it is "unlikely" that anyone is interested in this.

The Russia-Ukraine war has sparked the most severe strain in Moscow's relations with the West since the Cuban Missile Crisis of 1962. Putin has frequently highlighted the dangers of nuclear warfare but asserted that he has never deemed it necessary to employ nuclear weapons in Ukraine, according to TASS.

Speaking to reporters, here, after emerging victorious in the post-Soviet Russian history, Putin said that in the future, a direct conflict between Russia and NATO cannot be ruled out. although no one is interested

"I think that everything is possible in the modern world. But <...> it will be one step away from a fullscale third world war. I think

it's unlikely Is anyone interested in this?" TASS quotes Putin as saying.

Before Russia's March 15-17 elections, Ukraine had ramped up its attacks against Russia.

Iceland's largest volcanic eruption turns sky orange with corner', PM Rishi Sunak massive plumes of smoke

The volcanic eruption in Iceland's Reykjanes Peninsula is the largest of the four recent ones in the area and has left the sky with plumes of smoke and orange hues, according to The Washington Post.

According to the initial assessments, the eruption was the largest of the four recent ones since swarms of earthquakes caused the Svartsengi volcanic system to awaken for the first time in almost 800 years.

The orange hues and the smoke were seen from the Icelandic capital, Reykjavik, according to photos.

The volcano that erupted on Saturday in southwestern Iceland has been recorded for the fourth time in three months, reported The Washington Post.

The eruption led to destructive lava flowing towards the town of Grindavik, prompting the evacuation of the Blue Lagoon geothermal spa resort and the nearby town of Grindavik, amid emergency warnings.

Moreover, it quickly formed a 1.8-mile-long fissure in the ground, the Icelandic Meteorological Office said.

Lava was still flowing early Sunday, and footage of the eruption was being livestreamed by RUV, Iceland's national broadcaster, according to The Washington Post.

However, there was no such information available about the scale of damage or possible casualties.

The sky around Mount Hagafell and Mount Stora Skogfell was captured, turning a molten orange as people watched and emergency services prepared to respond.

Early Sunday, lava was flowing towards the south and southeast at a pace of about 0.62 mph, the Meteorological Office said.

If that pace continues, it said, lava could reach the ocean -- which can send steam flying and, in some cases, cause explosions of lava fragments that can be dangerous to anyone nearby, it added.

According to the local media, following the alert, authorities moved to evacuate people from the area, including the Blue Lagoon, one of the country's most popular tourist attractions.

In an indirect message for the rebels, he stressed that it was important to stick with the plan for the economy that was working after a tough couple of years.

he believed abortions should be banned, saying that "in a number of weeks I'll be coming out with a recommendation."

"I think the recommendation will be accepted," Trump said, adding he was proud that his three Supreme Court nominations had shifted the court's balance rightward, allowing it in 2022 to end federally guaranteed abortion rights.

The Supreme Court's shock ruling left it to states to establish their own abortion laws. Some have enacted near-total bans; others, like Maryland, passed laws to enshrine abortion rights.




Everyone found the sage to be right in saving the poor deer. 'He was compassionate, and that makes his action right.'



IOA DISSOLVES AD-HOC COMMITTEE FOR WRESTLING, WFI TO TAKE CHARGE

The Indian Olympic Association (IOA) on Monday dissolved the ad-hoc committee which was appointed to handle the day-to-day activities of the Wrestling Federation of India (WFI), saying that there is no need for the body following lifting of the ban on the federation by United World Wrestling (UWW) and the successful completion of selection trials for future competitions.

UWW lifted the ban on WFI in February with immediate effect. The UWW had placed the WFI under provisional suspension on August 23 last year after the federation failed to hold an election in the stipulated time following accusations of sexual harassment and protests against ex-president Brij Bhushan Singh by top wrestlers Bajrang Punia,



Vinesh Phogat and Sakshi Malik. An ad hoc committee was put in place.

In late December, elections were held and Sanjay Singh was elected as the new president of WFI. However, the wrestlers protested against his election, saying he was an aide of ex-president Brij Bhushan. Days after the elections, the Ministry suspended the federation again, a decision that came after Sanjay had announced the hosting of the U-15 and U-20 nationals at Nandini Nagar in the Gond district of Uttar Pradesh by the end of the year. An ad-hoc committee of IOA was put in place once again to handle the day-to-day affairs of the federation.

The trials for men's and women's wrestlers were

held from March 10-11. The Asian Wrestling Championships will be held from April 11 to 16, while, Asian Olympic Qualifiers will be held from April 19 to 21.

IOA said in an office order that the decision to dissolve the Adhoc Committee comes "in light of the lifting of the ban on the Wrestling Federation of India (WFI) by

(UVVW) and the successful completion of selection trials by the ad-hoc committee appointed by the IOA as per the directives of the High Court of Delhi".

"Consequent upon the aforementioned developments, there is no further need for running the activities of the WFI through an ad-hoc committee," it said.

IOA noted that it is imperative that WFI, on the advice of UWW, appoints a safeguarding committee or officer to address concerns of abuse and harrassment of athletes and to make sure that all rules, regulations and guidelines set by UWW and other authorities are followed.

"The WFI is also directed to conduct the elections of the Athletes Commission in a time-bound manner, in accordance with the established procedures and
