## **NOT A ROUTINE JUDGEMENT: SHAH** ON SC GRANTING BAIL TO KEJRIWAL

Hits back at Delhi CM saying "Modiji is our leader even after 2029".

Inion Home Minister Amit Shah on Wednesday said that many people feel the Supreme Court's decision granting interim bail to Delhi Chief Minister Arvind Kejriwal in the excise policy case is akin to him getting special treatment.

He said that the judgement in the case was not a routine judicial order.

"Supreme Court has the right to interpret the law, I believe this is not a routine judgement. A lot of people in this country believe that special treatment has been given," Shah told ANI.

Responding to a query about Kejriwal campaigning for the Aam Aadmi Party and the Congress in the 2024 Lok Sabha election, the Home Minister took a dig at the Delhi Chief Min-

"Right now he (Arvind Kejriwal) is stuck in another issue (alleged assault on Swati Maliwal by CM's aide), let him get free from that then let's see what happens," Shah said.

Dismissing Arvind Kejriwal's claims that the central government installed cameras in Tihar jail to keep a watch on him, the Union Home Minister said that the Tihar jail administration is with the Delhi government.

"Tihar is with them (Delhi government), not with us. They are lying continuously. Jail administration is with the Delhi government, it's with Kejriwal. Not with the Home Ministry," Shah

laundering case linked to Delhi's excise policy.

The Delhi CM spent over 50 days in Tihar Jail after he was arrested on March 21 this year by the Enforcement Directorate. As per court order, the bail is applicable till June 1 and Kejriwal has to surrender to the jail authorities on June 2. The Delhi CM can participate in poll campaigning but cannot attend office as Chief

Minister.

Responding to Arvind Kejriwal's recent announcement of ten guarantees to the people, Amit Shah said the AAP leader's comments need not be taken seriously as the party is contesting only 22 Lok Sabha seats.

"Don't take him so seriously, he (AAP) is only fighting 22 seats. And he is giving the guarantee for the entire

## NewsClick editor's arrest invalid, rules SC

**ASHISH SINHA NEW DELHI** 

The Supreme Court in its significant judgement on Wednesday declared the arrest of NewsClick founder and editor-in-chief Prabir Purkavastha in a case under the anti-terror law UAPA as "invalid in the eyes of law."

The top court noted that a copy of the remand application, outlining the grounds of arrest in writing, was not provided to Purkayastha or his counsel before the remand order dated October 4, 2023, which "vitiates" his arrest and subsequent remand.

A bench of Justices BR Gavai and Sandeep Mehta stated, that "there is no hesitation in the mind of the Court to reach to a conclusion that the copy of the remand application in the purported exercise of communication of the grounds of arrest in writing was not provided to the accused appellant or his counsel before passing of the

order of remand dated 4th October, 2023 which vitiates the arrest and subsequent remand of the appellant."

As a result, the appellant is entitled to a direction for release from custody by applying the ratio of the judgment rendered by this court in the case of Pankaj Bansal (supra), the bench added

The bench further stated that the arrest of the appellant followed by remand order dated 4th October, 2023 and so also the impugned order passed by the High Court of Delhi dated 13th October, 2023 are hereby declared to be invalid in the eyes of law and are quashed

"Though we would have been persuaded to direct the release of the appellant without requiring him to furnish bonds or security but since the chargesheet has been filed, we feel it appropriate to direct that the appellant shall be released from custody on furnishing bail and bonds to the satisfaction of

the trial court." The bench also stated that the court makes it abundantly clear that none of the observations made above shall be treated as a comment on the merits of the case.

## Unemployment rate dips to 6.7% in March quarter

The unemployment rate for people aged 15 years and above in urban areas declined to 6.7 per cent in the January-March period from 6.8 per cent a year ago, according to the National Sample Survey Survey (NSSO).

Joblessness, or unemployment rate, is defined as the percentage of unemployed people in the labour force.

The unemployment rate in the March quarter of FY23 was 6.8 per cent, while it was 6.6 per cent in April-June as well as in the third quarter (July-September 2023) of the previous fiscal. It was 6.5 per cent in October-December 2023. The unemployment rate for people aged 15 years and above in January-March 2024 was 6.7 per cent in urban areas, the 22nd Periodic Labour Force Survey showed.

### SC: Child in womb has fundamental right to live

The Supreme Court on Wednesday refused to entertain a petition from a 20-year-old unmarried woman seeking termination of her pregnancy, which had exceeded 27 weeks. The foetus in the womb also possesses a fundamental right to life, the bench said.

A bench of Justice B R Gavai along with Justices SVN Bhatti and Sandeep Mehta issued this ruling while hearing the woman's plea challenging the Delhi High Court's decision on May 3, which denied her request for termination.

"We cannot issue any directive contradictory to the statute," the bench informed the woman's counsel. "The child in the womb also holds a fundamental right to live. What is your response to that?" the bench inquired.

"I am shocked. Who told you that whenever one talks of people with more children, the inference is they are Muslims? Why are you so unjust towards Muslims? This is the situation in poor families too. Where there is poverty, there are more children, irrespective

of their social circle. I didn't mention either Hindu or Muslim, I have said that one should have as many children as you can take care of. Don't let a situation arise where the government has to take care of your children," the Prime Minister said on Tuesday.

Referring to the post-Godhra riots in Gujarat when he was the Chief Minister of the state, PM Modi said that his opponents "tarnished" his image among the Muslims after 2002 (the Godhra riots).

"This issue is not about

world. Even today, many of my friends are Muslims. After 2002 (Godhra), my image was tarnished," he added.

Asked whether Muslims would vote for him in this Lok Sabha election, he said that the "people of the country will vote for me."

### EC summons Andhra Pradesh DGP, Chief Secretary over post-poll violence in state

The Election Commission of India (ECI) on Wednesday summoned the Chief Secretary and the Director General of Police (DGP) of Andhra Pradesh to New Delhi tomorrow to "personally explain" the recent surge in post-poll violence in the state, sources said.

According to the sources, the Commission has demanded a detailed explanation from the officials regarding the lapses in maintaining law and order and the preemptive measures being implemented to prevent further incidents. The ECI

emphasised the continued enforcement of the Model Code of Conduct and the necessity for stringent actions to ensure peace.

The ECI has repeatedly emphasised that there is no place for violence in a democracy and since the announcement of Lok Sabha elections. Chief Election Commissioner Rajiv Kumar has been personally monitoring the election space to ensure peaceful and violence-free conduct of polls.

Post-poll violence was reported in parts of Andhra Pradesh on, Monday.

for the first 12 weeks.

Participants are then supported by clinicians and coaches to reintroduce healthy, nutritious food into their diet to maintain weight loss, with their progress being monitored. During the programme, participants are able to choose how they are supported through oneto-one in-person sessions or digitally online with the

Analysis shows that the programme is effective and can work successfully to improve people's diabetes control and support weight loss, with participants typically losing 7.2kg on average after one month, and an average of 13kg in three months.

This, according to the NHS, is similar to the outcomes seen in clinical trials. showing early promise that the programme will lead to remission of type 2 diabetes in up to half of those who complete it.

"Weight loss can lead to significant health benefits. including for some, remission of type 2 diabetes, and it's important the NHS offers a wide range of services that are easy to access and tailored to those looking to manage their condition," said NHS National Clinical Director for Diabetes and Obesity Dr Clare Hambling.

"Type 2 diabetes is caused by a range of factors from genetics to where the body stores fat, with our food environment also playing a significant role.

pointed out that the Medical Termination of Pregnancy Act primarily addresses the mother. "It is crafted for the mother," he argued. However, the bench emphasized that the pregnancy had progressed beyond seven months. "How do you address the child's right to survival?" the bench queried.

The counsel reiterated that until the child is delivered, the rights primarily belong to the mother. "The petitioner is currently experiencing severe trauma. She is unable to leave her residence and is even attending NEET exam classes. She is in a highly distressing situation and cannot face society at this juncture," he stated.

The lawyer stressed the importance of considering her mental and physi-



cal well-being. However, the bench remained firm in its decision. "Sorry," it responded.

In its May 3 ruling, the high court observed that on April 25, it had instructed the All India Institute of Medical Sciences to establish a medical board to evaluate the condition of both the foetus and the petitioner. "Upon review of the report, it is evident that there are no congenital abnormalities in the foetus, and there is no risk to the mother that

would necessitate termina-

tion of the pregnancy," the high court had stated "As the foetus is viable

and healthy, and there is no threat to the petitioner's well-being, termination would neither be ethical nor legally permissible," the high court concluded. Previously, before the high

court, the petitioner had mentioned experiencing discomfort in the abdomen on April 16, prompting her to undergo an ultrasound scan, which revealed she was 27 weeks pregnant beyond the legally permissible limit of 24 weeks.

Under the MTP Act, termination of a pregnancy exceeding 24 weeks can be permitted in cases of substantial foetal abnormalities diagnosed by a medical board or if there is a good faith opinion to save the pregnant woman's life.

## Monsoon to keep date with Kerala

"This is not early; it's close to the normal date," IMD Director General Mrutyunjay Mohapatra said.

The date of monsoon onset over Kerala has varied widely over the last 150 years, the earliest being May 11, 1918, and the most delayed being June 18, 1972, according to IMD data.

The rain-bearing system arrived in the southern state on June 8 last year, May 29 in 2022, June 3 in 2021 and June 1 in 2020

Last month, the IMD had forecast above-normal rain in the monsoon season in India with favourable La NiÃffla conditions expected to set in by August-Septem-

Parts of the country battled brutal heat in April, with maximum temperatures shattering records in several states and severely impacting health and livelihoods.

The crippling heat is straining power grids and drying up water bodies triggering drought-like conditions in parts of the country. A prediction of above-normal monsoonal rainfall, therefore, comes as a huge relief to the fast-developing South Asian nation.

The monsoon is critical for India's agricultural landscape, with 52 per cent of the net cultivated area relying on it. It is also crucial for replenishing reservoirs critical for drinking water, apart from power generation across the country.

June and July are considered the most important monsoon months for agriculture because most of the sowing for the Kharif crop takes place during this pe-

El Nino conditions are prevailing at present, and La Nina may set in by AugustSeptember, scientists say.

El Nino - the periodic warming of surface waters in the central Pacific Ocean - is associated with weaker monsoon winds and drier conditions in India. La Nina - the antithesis of El Ninoleads to plentiful rainfall during the monsoon sea-

The IMD is also anticipating the development of a positive Indian Ocean Dipole (IOD) or cooler-thannormal Indian Ocean in the east compared to the west, which helps bring rain to several states in southern India. The IOD is currently 'neutral' and is expected to

turn positive by August. Another factor is belownormal snow cover in the northern hemisphere and Eurasia. Historically, there has been an "inverse relationship" between the levels of snow here and the mon-

## **UNEMPLOYMENT RATE DIPS TO 6.7% IN MARCH QUARTER: SURVEY**

he unemployment rate for people aged 15 years and above in urban areas declined to 6.7 per cent in the January-March period from 6.8 per cent a year ago, according to the National Sample Survey Survey (NSSO).

Joblessness, or unemployment rate, is defined as the percentage of unemployed people in the labour force.

The unemployment rate in the March quarter of FY23 was 6.8 per cent, while it was 6.6 per cent in AprilJune as well as in the third quarter (July-September 2023) of the previous fiscal. It was 6.5 per cent in October-December 2023.

The unemployment rate for people aged 15 years and above in January-March 2024 was 6.7 per cent in urban areas, the 22nd Periodic Labour Force Survey (PLFS) showed.

It also showed that the unemployment rate among females (aged 15 years and above) in urban areas declined to 8.5 per cent in January-March 2024 from 9.2 per cent in the same quarter a year ago.

It was 9.1 per cent in April-June 2023, 8.6 per cent in July-September 2023, and 8.6 per cent in October-December 2023.

Among males, the unemployment rate in urban areas rose to 6.1 per cent in January-March 2024 compared to 6 per cent in the year-ago period. It was 5.9 per cent in April-June 2023, 6 per cent in July-September 2023, and 5.8 per cent in October-December 2023.

Labour force participation rate in Current Weekly Status (CWS) in urban areas for people aged 15 years and above increased to 50.2 per cent in the January-March 2024, from 48.5 per cent in the same period a year ago.

# CAA GETS ROLLING, FIRST SET OF 14 PEOPLE GRANTED CITIZENSHIP

he first set of citizenship certificates under the Citizenship (Amendment) Act was issued Wednesday here to 14 people, nearly two months after rules under the contentious law were notified to grant Indian nationality to persecuted non-Muslim migrants from three neighbouring countries.

Sources said 14 people were handed over the certificates symbolically at a special function held here while digitally signed certificates are also being sent to a "few hundred" other applicants through email.

Union Home Minister Amit Shah termed it a "historic day", saying the decades-



Home Secretary Ajay Kumar Bhalla handed over the certificates to the 14 people after their applications were processed online through a designated portal, an official spokesperson said.

This comes in the midst of the general elections which started on April 19. The last phase of polling will be held on June 1 while the counting will take place on June 4.

The CAA was enacted in December 2019 for granting Indian nationality to persecuted Hindu, Sikh, Jain, Buddhist, Parsi and Christian migrants from Bangladesh, Pakistan and Afghanistan who came to India on or before December 31, 2014.

## Avoid narrow view, says EAM on US warning Chabahar Port

On being asked about the US' remarks, Jaishankar said, "I did see some of the remarks which were made, but I think it's a question of communicating, convincing and getting people to understand, that this is actually for everyone's benefit. I don't think people should take a narrow view of it."

"They (US) have not done so in the past. So, if you look at the US' own attitude towards the port in Chabahar, the US has been appreciative of the fact that Chabahar has a larger relevance...we will work at it," he added.

Earlier on Tuesday, the United States warned that



"anyone" considering business deals with Tehran needs to be aware of the "potential risk of sanctions."

"I would just say...US sanctions on Iran remain in place and we will continue to enforce them," the US State Department Principal Deputy Spokesperson, Vedant Patel said at the press briefing.

"Any entity, anyone considering business deals with Iran, they need to be aware of the potential risk they are opening themselves up to, potential risk of sanctions," he added.

## Protests in Uttarkashi over Chardham Yatra mismanagement

Hoteliers and traders staged protests in Uttarkashi in Uttarakhand on Wednesday against alleged mismanagement of the Chardham yatra. They took out a procession along the highway in the Paligad area of the district under the banner of Yamuna Ghati Mahasangh and raised slogans against the state government for alleged chaos prevailing along the Yatra route and causing inconvenience to the pilgrims.

"Pilgrims are being made to wait inside their vehicles for 10-12 hours on an average at various points along the route to Yamunotri. After the long wait, they are being told not to proceed further due to traffic jams on the route. This is disturbing the schedule of their journey and many pilgrims are returning without darshan in Yamunotri, "Yamuna Ghati Hotel Association president Soban Singh Rana said.

The number of pilgrims visiting Yamunotri and Gangotri this time has broken the previous year's records within less than a week since the beginning of the Chardham yatra on May 10.

# CAA: Comprehending its consequences and controversies

rior to the General Elections in 2024, the government officially announced the regulations for enforcing the controversial Citizenship (Amendment) Act (CAA) 2019. This development has facilitated the process of providing citizenship to illegal migrants from Pakistan, Bangladesh, and Afghanistan who are not of the Muslim faith. The government lead by Prime Minister Modi will now start conferring Indian citizenship to non-Muslim migrants who have faced persecution in the mentioned countries and arrived in India before December 31, 2014, as a result of the implementation of the rules of the CAA. These groups Buddhists, Jains, Sikhs, and

The Act, an amendment in

the 1955 Citizenship Act,

#### **WHAT IS CAA?**

was initially presented in parliament in July 2016 and approved in December 2019. Prior to the implementation of the CAA, any non-Indian individual who wished to acquire Indian citizenship through the process of naturalization was required to have resided in India for a period of 11 years in order to meet the eligibility criteria. The CAA accelerates the process of granting Indian citizenship to individuals belonging to the Hindu, Parsi, Sikh, Buddhist, Jain, and Christian communities. These individuals sought refuge in India due to religious persecution in Afghanistan, Bangladesh, and Pakistan, which have Muslim-majority populations. The CAA applies to anyone who arrived in India before December 31, 2014. They attain eligibility for citizenship after a period of five years. Applicants gions are eligible, regardless of their existing residence in India without valid visas or other necessary documenta-

The primary objective of the CAA is to safeguard those who have sought asylum in India as a result of religious persecution. It provides them with protection from unlawful immigration procedures. The proposed amendment further has a clause for the revocation of Overseas Citizen of India (OCI) registration in the event that the OCI cardholder contravenes any provision of the Citizenship Act or any other relevant legislation.

#### **WHOM DOES CAA**

**EXCLUDE?** Prior to the implementation of the CAA, religion was not considered a factor in determining an individual's eligibility for an Indian passport. Individuals desiring naturalization were required to provide evidence of their lawful presence in India and were subject to an 11-year waiting period before becoming eligible for citizenship. The CAA revisions introduce, for the first time in the history of independent India, a religious criterion for citizenship. Muslim individuals who have been subjected to religious persecution in countries like Pakistan (such as the Ahmadiyya community), Afghanistan (specifically the Hazara people), or other nearby nations (such the Robingya in Myanmar), would still have to endure an 11-year waiting period before they are able to qualify for Indian citizenship. In contrast to Hindus, Parsis, Sikhs, Buddhists, Jains, and Christians, individuals belonging to this group are required to possess appropriate documents in order to legitimize their presence in India.

There is no provision within it that revokes anyone's citizenship. The issue with the CAA lies in its discriminatory provision that designates some religious communities as eligible for citizenship. It is assumed that individuals belonging to these six religions in these three nations have escaped persecution. Individuals who do not fit into this classification, either because they arrived in the nation after the specified period or because of their religious affiliation, will still be regarded as unauthorized immigrants.

#### WHAT IS THE **REASON FOR STRONG**

**OPPOSITION?** Since 2019, the primary contention of the principal opposition parties has been that the law is discriminatory since it specifically focuses on Muslims, who constitute around 15% of the nation's population. The government clarifies that due to the fact that Pakistan, Afghanistan, and Bangladesh are Islamic countries with a Muslim majority, Muslims cannot be classified as persecuted minority. Nevertheless, they guarantee that proposals from other communities will be evaluated individually. The contentious CAA, enacted in December 2019, has encountered widespread resistance and protests around the nation. The bill has faced criticism from several opposition groups, which have labelled it as "discriminatory". The Congress party has expressed apprehensions over the timing of the rule notice, asserting that it is designed to create divisions in the next Lok Sabha elections in West Bengal and Assam. Chief Minister Vijayan of Kerala has said that the implementation of the CAA would not take place in the state, as he believes it to be a legislation

that fosters sectarian dis-When considered with the projected all-India National Register of Indian Citizens (NRIC), the CAA has the capacity to disproportionately affect Muslims living in India by denying them citizenship. Non-Muslims who are excluded from the NCR. will have the chance to recover their citizenship under the CAA. However, Muslims will not have the same possibility. In 2021, a National record of Citizens was conducted in Assam under the supervision of the Supreme Court. This process resulted

in the exclusion of more than 1.9 million individuals from the citizenship record.

On May 28, 2021, the Union government issued an order applying Section 16 of the 1955 Act, which bestowed District Collectors in five States with significant migrant populations the authority to confer citizenship upon specific groups designated in the 2019 amendment. The MHA's 2021-22 Annual Report disclosed that a total of 1,414 citizenship certificates were conferred in 2021, in accordance with the terms of the CAA.

Ultimately, the enactment of the CAA 2019 has ignited fervent discussion and prompted crucial inquiries regarding its impact on India's secular framework and its dedication to inclusiveness. Although the government's decision to offer sanctuary to persecuted minority from surrounding nations is praiseworthy, the act's discriminatory nature has drawn condemnation from many observers. The actual consequences of the CAA, however, will depend on how it is executed. The government must guarantee that the implementation is equitable, transparent, and in accordance with the ideals of equality and justice entrenched in the Indian Constitution. The CAA can only fully achieve its intended goal by upholding the core

## **KASHMIR IS NOT** PROTESTING, IT'S VOTING

One of the many high points of the ongoing general elections is the voting in Kashmir valley, which started in the fourth phase of the elections, with Srinagar going to the polls last Monday. The constituency saw its highest turnout since 1996-38.49%according to the latest figures given by the Election Commission of India. In 1996, it was 40.94%. Stone pelting has disappeared from downtown Srinagar. Tourists are pouring into the valley. Incomes are skyrocketing. All this is testament of the great work that is happening in the val-

There were no election boycott calls by the separatists, no protests, no violence this time. This was a huge contrast to the time when the separatists used to issue a hartal and protests calendar, which brought the whole valley to a standstill, sometimes for months. Fear for their lives wouldn't allow the Kashmiris to step out for voting. It was believed that those who stepped out were party workers who were voting for their respective party candidates. With a near-40 voting percentage, Kashmir has proved that it is the common Kashmiri who has voted this time, which shows that if the right conditions are created, even people in Kashmir are more than eager to participate in India's biggest festival of democracy.

Amidst all this, visuals of voters in the valley thronging the polling stations has unnerved a section of activists and journalists, who have turned the narrative of "oppressed Kashmiris" into an art form. Many such people who make a living out of taking the "broken tales" of "conflict zone" Kashmir to foreign shores at the invitation of rights groups, and indulge in anti-India propaganda in front of foreigners, are trying to explain the large turnout by saying this was a mark of protest. Apparently, people have come out in large numbers because they are protesting the removal of Article 370; that they are voting for National Conference and People' Democratic Party (PDP) because these parties are for the restoration of status quo. When the truth is that, like in the rest of the country, Kashmir's voters are voting for issues such as development, progress, education and employment. By calling these "protest votes" the activists are trying to peddle their fake narrative of Kashmir being another Palestine, to their global audience. Moreover, what a disappointment such a voting trend must have been for Pakistan, which has destroyed its economy and society, while trying to take Kashmir from India.

In fact, this narrative about the vote in Kashmir being a "protest vote" has been picked up, as if on cue, by many analysts and opinion makers known to be opposed to Prime Minister Narendra Modi, and is being repeated ad nauseam. It is surprising that none of these narrative-spinners realise that Article 370 is history. No political party will ever be able to bring 370 back, whichever side of the spectrum that party may belong to. There is a reason why Rahul Gandhi is avoiding commenting on Article 370. While as an Opposition politician he cannot praise the abrogation, as that would amount to praising Narendra Modi, he cannot even oppose it, for that would be a vote killer for him. Any suggestion of bringing back 370 will be political suicide.

This is not to say that everything is normal in Kashmir. Things can still get derailed if Kashmir is not nurtured. This is to say that a lot has happened in the last five years. Development has come to Kashmir. Industry and investments are coming to a place that, according to locals, had got stuck in a time warp. Generations of Kashmiri politicians did nothing for the people, but continued to thrive under the benevolent protection of New Delhi. Much of the alienation and radicalisation of a section of the valley population has its roots in this. Now that Kashmir has a future, it must not be allowed to return to the sinkhole from where it's emerging. It's for this future that Kashmiris stepped out to vote.

as the 18th Chief Minister of Madhya Pradesh for approximately 15 months and resigned after a political crisis. He was the Leader of the Opposition in the Madhya Pradesh Legislative Assembly from March 2020 to April 2022. As a leader of the Indian National Congress he has served as the Minister of Urban Development. He is one of the longest serving and most senior members of the Lok Sabha, the lower house of India's bicameral Parliament. ## SUPREME COURT: STRANGER WHO PURCHASED PROPERTY KNOWING ABOUT APPEAL PENDENCY CANNOT RESIST RESTITUTION AS BONA FIDE PURCHASER | SECTION 144 CPC

of 'restitution' under Section 144 of the Code of Civil Procedure, 1908, CPC.

The bench comprising of Justice Hrishikesh Roy and Justice Prashant Kumar Mishra while reserving the findings of the High Court stated that if the person who has purchased the suit property from the decreeholder despite having full knowledge of pending appeal proceedings which are initiated against the decree, then the purchaser of the suit property from the decree-holder in the case is not entitled to object restitution which being on the ground that he is a bona fide purchaser.

The Judgement authored by the bench of Justice Prashant Kumar Mishra drew its strength from the

case of Chinnamal and Ors. Vs. Arumugham and Anr., wherein the said court distinguished between the decree-holder who purchased

the property in execution of his own decree, which is afterward modified or is reversed and a person who is not a party to the decree i.e., the stranger who purchases the property from the decree-holder.

However, the court in Chinnamal case laid down the test for ascertaining whether the stranger purchaser would be entitled to retain the property by the principle of restitution.

The court stated that the true question in each case is that, it is whether the stranger auction purchaser knew of the pending litigation about the decree under execution.

The court answered in Chinnamal that if the evidence indicates that he had no such knowledge he would be entitled to retain the property purchased, thus, being a bona fide purchaser and his title to the property remains unaffected by subsequent reversal of the decree. Therefore, the court by all means should protect his purchase. Although, in the evidence, it is shown that he was aware of the pending appeal against the decree when he purchased the property, it would be inappropriate to term him as a bona fide purchase. Further, the court stated that in such kind of cases the court also cannot assume that he was a bona

for giving him protection against restitution and no assumption could be made which being contrary to the facts and circumstances of the case and any such assumption would be wrong and uncalled for.

In the present case, the stranger purchasers protested against the applicability of the principle of restitution before the court. The court observed that despite having knowledge of the pending challenge to the decree, he purchased the suit property from the decree holder.

The court while considering the facts and circumstances of the case held that the auction purchasers cannot object to the restitution of property to the judgment debtors on the reversal of the

#### Supreme Court Refused To Quash Cases Against BJP's H Raja For Comments On Periyar, Karunanidhi: 'Politicians Must Be Circumspect About Utterances'

The Supreme Court in the case H. Raja vs. State Rep. By Inspector Of Police in the case observed and has refused to quash the criminal cases against the Bharatiya Janata Party's National Secretary H Raja for his alleged derogatory remarks made against Dravidian movement leader Periyar, former TN Minister M Karunanidhi, DMK party leaders etc.

The bench comprising of Justice Hrishikesh Roy and **Justice Prashant Kumar** Mishra was hearing an SLP against the order of Madras High Court.

The bench in the case orally commented about the need for politicians to be circumspect about their public comments.

The bench headed by Justice Roy stated that people in politics have to be circumspect about what they utter; somehow we are reducing the level of discourse.

The High Court in the case had refused to quash the criminal cases as stated under Section 153, Wantonly giving provocation with intent to cause riot, Section 504, Intentional insult with intent to provoke breach of the peace and Section 509, Word gesture or act intended to insult the modesty of a woman against Raja.

Further, the trial of these offences is being conducted by the Additional Special Court for Trial of Criminal Cases which relates to MP/ MLA's.

The High Court in the case had refused to grant any relief observing that that Raja had a habit of making such irresponsible and damaging comments.

The Court in the case observed that the said court must necessarily take judicial notice of the fact that the petitioner has the proclivity to make irresponsible and damaging comments and that is the reason why he gets into trouble. Thus, the said court is reminded of the sagacious words of Thiruvalluvar and to put it in simple English- Whatever besides you leave unguarded, guard your tongue; otherwise, errors of speech and the consequent misery will ensue.

1. The Advocates are generally perceived to be their client's agents and owe fiduciary duties to their

2. The Advocates are fastened with all the traditional duties that agents owe to their principals. For example, the Advocates have to respect the client's autonomy to make decisions at a minimum, as to the objectives of the repre-

3. The Advocates are not entitled to make concessions or give any undertakpress instructions from the Client.

4. It being the solemn duty of an Advocate not to transgress the authority conferred on him by his Client.

5. An advocate is bound to seek appropriate instructions from the Client or his authorized agent before taking any action or making any statement or concession which may, directly or remotely, affect the legal rights of the Client.

6. The Advocate represents the client before the Court and conducts proceedings on behalf of the client. The Advocate is the only link between the court and the client. The responsibility of him is onerous. He is expected to follow the instructions of his client rather than substitute his judgment.

It has also been held by the Division bench while deciding an appeal that raised the issue of whether advocates can be held liable under the Consumer Protection Act for deficiency

The Division bench in the case had heard the matter at length before reserving its judgment on February

Therefore, the instant appeal had emanated from the decision of the National Consumer Disputes Redressal Commission, NC-DRC in the year 2007. The Commission had held that if there was any deficiency in service rendered by the Advocates or Lawyers, a complaint under the Consumer Act would be maintainable.

The issue raised before the court was as to whether advocates can be held liable under the Consumer Protection Act 1986 as enacted in 2019 for deficiency of services. The court in the case ob-

served that the definition of 'Service' and noticed that it clearly excludes Services rendered under a contract of personal service. The said court went on to decide whether the Services provided by the advocates can be classified under 'a contract of personal service.' The court also referred to the case

wherein the court held that the correct method of approach, therefore, would be to consider whether having regard to the nature of the work there was due control and supervision by the employer. Therefore, in order to assess whether the client exercises direct control over the Advocate, the Court cited several provisions of the Civil Procedure Code and one such concerned provision was Order III Rule 4, as per which a pleader cannot act in the Court for any person unless he or she is appointed by such person. Now, the document for appointing a pleader. Therefore, the said document used for the appointment of a pleader is known as 'Vakalatnama'.

The Court in the case noted that by virtue of such 'Vakalatnama,' advocates have certain duties, including the one to their client.

The court noted that 'a considerable amount of direct control is exercised by the Client over the manner in which an Advocate renders his services during the Dharangadhra Chemi- course of his employment.' For Deficiency Of Services.

The court concluded that Services of an advocate would come under the contract 'of personal service' thus, the same would stand excluded from the definition of Service as provided under section 2(42) of the Act.

The court stated that it has been alleged in the complaint 'deficiency in service' against Advocates practising Legal Profession would not be maintainable under the CP Act, 2019.

In an age where technology seems to blur the lines between reality and fiction, voice cloning emerges as a potent example of our evolving digital landscape. Voice cloning, the process of replicating a person's voice using advanced algorithms, has garnered both fascination and concern worldwide.

There are very diverse applications of AI voice cloning such as preserving legacy by keeping the voices of your loved ones alive for the generations to come, it feels like they never left. Also, considering medical implications, it provides voice for those who are losing it due to illness or disability, Apple's iOS 17 introduced voice cloning to aid such people. Its creativity has no limit, it provides people with an immersive experience through cloning whichever voice they want to narrate them a bedtime story or in audio games, custom virtual assistants

provide an immersive digital interaction. Even, song producers clone the voice of actors or singers in order to use them, YouTube's Dream Track is a feature which creates song clips featuring AI vocals with the permission from the pop stars.

It is very fascinating to use such kind of technological magic to innovate using your creativity. But, the freely accessible Software's like these, eventually lead to great modern day Cyber-

All it Takes is- Few Dangerous Seconds. THAT'S IT! (a) Imagine your child crying on the phone and asking for help, any parent would panic and do as the daughter say, but in actual it is not the daughter on the phone, instead it's the cloned voice which is being heard by the parent, similar case happened with Sarita Khanna, the middle-aged wife of a businessman from MP's Khargone, she got a call from an unknown number saying her daughter is kidnapped and demanded for Rs. 3 lakhs, and the daughter was heard crying on the phone, she was tricked in sending the money. Whereas, her daughter was safe and sound at her hostel.

(b) In another example, a Lucknow-based government official received a call from an unknown number claiming that his son, who is studying in Bengaluru, had been caught with narcotics and was in police custody, demanding Rs.1 lakh to release him; the boy's voice could be heard saying "papa mujhe bacha lo". After hearing his son's voice, he sent the money without thinking twice.

(c) Another example is retired Coal India officer PS Radhakrishnan, who was duped into paying 40,000 rupees in response to a call from his old buddy of 40 years, Venu Kumar, who had contacted him after nearly a year of no communication to beg his assistance with an urgent financial transaction. Radhakrishnan stated the voice on the phone sounded exactly like him, and they talked for a long time, leading him to assume it was Venu Kumar himself; in reality, it was another AI-cloned voice working its intellect.

(d) An unusual matter of fraud used an AI generated cloned audio to defraud a United Kingdom based energy firm of \$243,000. According to the report from the Wall Street Journal, in March 2019, the fraudsters utilized a voice-cloning AI software to impersonate the voice of the chief executive of the firm's Germany-based parent company in order to effectuate an illegal fund transfer. The Cybercriminals called the U.K. firm's CEO posing as the CEO of the parent company. Then the attackers demanded for an urgent wire transfer to be made to a Hungarybased supplier and the U.K. firm's CEO was guaranteed a reimbursement. After the money was transferred, it was forwarded to an account in Mexico and then other locations, making it difficult to identify the fraudsters

How to protect yourself? If bad actors are using voice cloning to mimic voices and commit crimes, it is important for us to stay vigilant. There are some common signs and red flags that you can look out for:

1. If you are answering a call from an unknown number, let the caller speak first, if you say as much as "Hello? Who is this?" They could use that audio sample to impersonate you.

2. If you receive a call or message from someone you know, but they make unusual or out-of-character requests, it could be a sign of voice cloning. For example, if a friend or family member suddenly asks for sensitive information or money, proceed with caution and verify their identity through other

means. 3. Voice cloning technology may not perfectly replicate the original voice, leading to subtle inconsistencies. Pay attention to any noticeable changes in tone, pitch, or pronunciation that are out of character for the person you're communicating with.

4. Cloned voices may have lower audio quality or exhibit artifacts. If the voice on the other end of the call sounds distorted, robotic, or unnatural, it could be a sign of voice cloning.

5. If the background noise during a call seems inconsistent with the expected environment of the caller, it could indicate a cloned voice. For example, if you hear noises that don't match the typical sounds of a workplace or home, it may be a cause for suspicion.

6. Voice cloning scammers may try to create a sense of urgency or pressure to manipulate you into providing

sensitive information or taking immediate action. Be cautious if the caller insists on quick decisions, especially if it involves financial matters.

7. Voice cloning scammers

often use caller ID spoofing techniques to make it appear as if the call is coming from a trusted source or a legitimate organization. If you receive a call from a known number but the voice or the content of the conversation seems suspicious, consider contacting the person or organization directly using a verified contact method to confirm the call's legitimacy.

8. Voice cloning attempts may involve the use of pre-recorded responses or scripts. If the person on the other end of the call consistently provides robotic or repetitive responses that do not directly address your questions or concerns, it could be an indication of a cloned voice.

If someone becomes a victim of such a scam, they may find recourse under the following sections among oth-

#### **UNDER THE INFOR-MATION TECHNOLOGY ACT, 2000:**

• Section 66C: Identity theft and can be applicable if the fraud involves the deceptive use of someone's voice identity.

• Section 66D: Cheating by personation using a computer resource and can be relevant if the fraudster impersonates another person using technology.

#### **WAY FORWARD**

Law enforcement agencies, technology companies, telcos and research institutions need to collaborate to develop advanced voice authentication and anti-spoofing techniques. These techniques should aim to identify synthesized or cloned voices and differentiate them from genuine human voices.

As for integrating these technologies into phones or communication platforms, some progress has been made in implementing call authentication frameworks. For example, the STIR/ SHAKEN framework has been introduced in some countries to verify the authenticity of caller IDs and

detect spoofed calls. While these frameworks primarily focus on verifying caller ID information, they can indirectly help in identifying potential voice cloning attempts. India too is working towards adopting a multi-pronged approach by introducing the Calling Name Presentation (CNAP) service which will notify call receivers about the identity proof linked with a SIM card being used by the caller. Another such approach

is the vision of establishing the National Cyber Security Agency (NCSA) which will serve as a centralized organization responsible for addressing digital frauds. NCSA, shall also invest into developing such voice analysis algorithms and machine learning models that can analyze voice patterns, acoustic characteristics and linguistic markers to detect anomalies that may indicate AI voice cloning. These technologies can be integrated into communication platforms or phone apps to provide real-time detection and alerts for suspicious

## **ISLAMABAD HIGH COURT APPROVES** IMRAN KHAN'S BAIL APPLICATION

ISLAMABAD

he Islamabad High Court (IHC) on Wednesday approved former Pakistan Prime Minister Imran Khan's bail application in the Pound 190 million corruption case, Pakistan-based Dawn reported.

A two-member bench, comprising IHC Chief Justice Aamer Farooq and Justice Tariq Mehmood Jahangiri, had rv eserved the verdict on Tuesday after the National Accountability Bureau's (NAB) prosecution team and Imran Khan's lawyer, Sardar Latif Khan Khosa, concluded their arguments.

The court set Imran Khan's bail at Pakistani Rupees (PKR) 1 million. Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan will not be released from prison



as he is still serving out his sentences in the cypher case and the iddat case. His sentences in two separate Toshakhana cases were suspended by the IHC.

In his concluding arguments in the court, NAB Special Prosecutor Amjad Pervaiz said that the trial of Imran Khan and his spouse was about to conclude, according to Dawn report.

Pervaiz said that out of 59 prosecution witnesses, 30 have testified so far, and the prosecution would reduce the number of remaining witnesses by 10 to 15 and produce the rest for record-

Amjad Pervaiz cited a Supreme Court judgement where bail petitions were rejected in such situations. In his arguments, Imran

ing statements.

Khan's lawyer, Khosa, termed the case baseless and added that there was no allegation of money laundering

by the accused. UK's National Crime Agency seized the money for a suspicious transaction, which was returned to Pakistan under an out-of-court settlement.

Khosa stated that the money could have been retrieved through UK courts. However, it would have taken time to complete the process. Khan's lawyer said that the government only facilitated the expeditious return of the seized amount.

Imran and his wife, Bushra Bibi, were indicted in the case by a Rawalpindi accountability court in Febru-

In December, the National Accountability Bureau (NAB) filed a corruption reference against Imran and seven others, including his

wife, in connection with Al-Qadir University.

The case alleges that Imran Khan and his wife obtained billions of rupees and land worth hundreds of kanals from Bahria Town Ltd for legalising PKR 50 billion that was identified and returned to Pakistan by the UK during the previous PTI government, according to Dawn report.

The case filed by NAB alleged that Imran Khan, who is currently incarcerated in Adiala Jail, played a "pivotal role in the illicit transfer of funds meant for the state of Pakistan into an account designated for the payment of land by Bahria Town, Karachi."

It also claimed that despite being given multiple opportunities to provide information, the accused deliberately, with mala fide intention, did not give information on one pretext or another.

## Palestinian gunmen spotted in UNRWA Rafah facility

The Israeli military released photos and footage of Palestinian gunmen inside a UNRWA logistics facility in eastern Rafah alongside UN vehicles.

Footage released by the Israel Defence Forces showed several terrorists milling around UN vehicles arriving at the compound. The IDF said at one point, it detected one of the gunmen firing at civilians.

The warehouse compound in question is a central point for distributing humanitarian aid in the Rafah area.

"Gunmen, likely Hamas terrorists, hanging out at UNRWA warehouse in eastern Rafah a few days ago and identified by an IDF drone," spokesperson Lt. Col. (ret.) Peter Lerner wrote on X, formerly called Twitter. "The U.N. needs to answer some serious questions. Imagine what would've happened if we were to target them? The



hypocrisy is astounding."

Following the incident, representatives of the Coordinator of Government Activities in the Territories (COGAT) conveyed the findings to senior officials in the international community and called on the UN to urgently investigate the incident. CO-GAT is a unit within the Defense Ministry responsible for overseeing humanitarian aid

deliveries. Israeli forces took control of the Palestinian side of Gaza's border with Egypt, including the Rafah border crossing, on May 7 in a move making it harder for Hamas to hijack humanitarian aid trucks arriving from Egypt.

In a related development, an Israeli airstrike killed 15 terrorists inside a Hamas war room located in a UNRWA school compound in the central Gaza area of Nuseirat. Among the 15 killed were members of Hamas's elite Nukhba force, which played a leading role in the October 7 attacks on Israeli communities.

At least 1,200 people were killed and 240 Israelis and foreigners were taken hostage in Hamas's attacks on Israeli communities near the Gaza border on October 7. Around 30 of the remaining 132 hostages are believed dead.

## Israel kills 15 terrorists in Hamas command centre

Israeli aircraft killed 15 terrorists in a strike on a Hamas command center located inside a UNRWA school on Saturday, the Israel Defense Forces said.

The war room was embedded in a UN Relief and Works Agency school in the central Gaza area of Nuseirat. According to the IDF, at least 10 of the terror operatives killed were members of Hamas with the rest being members of other terror groups. The Hamas terrorists included members of the elite Nukhba force, which played a leading role in the October 7 attacks on Israeli communities.

The IDF's announcement included a map of the school compound along with the location of the Hamas war

"The Hamas war room had been used by the terrorist organisation to plan multiple attacks against IDF troops in central Gaza in recent weeks. The Hamas terrorist organisation systematically exploits the civilian popula-

Reports released by IMPACT-SE and UN Watch documented UNRWA employees expressing support for the attacks on social media.



## Protests quell in PoJK as Islamabad responds

As violent protests and a shutter-down strike in Pakistanoccupied Jammu Kashmir (PoJK) came to a halt following Islamabad's announcement of an immediate grant of PKR 23 billion to address demands for fair electricity pricing and subsidised wheat flour, the UK based-United Kashmir People's National Party (UKPNP) issued a statement reaffirming the region's long-standing grievances.

In the statement, the UKPNP highlighted the decades-long denial of fundamental human rights, citing injustice, inequality, and systematic plundering of natural resources as enduring issues.



The party condemned the eruption of violence, attributing it to the deployment of para-military forces such as the Punjab Constabulary and Frontier Constabulary, notorious for their alleged inhumane actions.

Reports emerged of three civilian deaths and over 100 injuries during firing by Pakistan Rangers and local police, as peaceful protests escalated following a crackdown on local

UKPNP expressed concern over the re-deployment of paramilitary forces, fearing further suppression of the people's movement. The party voiced full endorsement of the peaceful struggle led by the Awami Action Committee, asserting its pro-people and pro-peace stance.

## China cries foul after new US tariffs; vows to defend its interests

"Firmly opposing" the new US tariffs, China warned that the trade barriers would affect the wider relationship between the two economic superpowers and Beijing will "resolutely work" to defend its interests, CNN reported.

China's Commerce Ministry also said that the move is against US President Joe Biden's earlier stand of not seeking to 'contain' or 'decouple' with Beijing.

This comes hours after Biden announced that tariffs on USD 18 billion worth of imports of Chinese electric vehicles and an array of other products would soar over the next two

The White House said the measures were designed to protect American workers and businesses in the face of China's unfair trade practices, including "flooding global markets with artificially low-priced exports."

China "firmly opposes" the new tariffs, the country's Commerce Ministry said in a statement. "The increase in...tariffs by the United States contradicts President Joe Biden's commitment to 'not seek to suppress and contain China's development' and 'not to seek to decouple and break links with China," it said. "This action will seriously impact the atmosphere of bilateral cooperation."

The Chinese Ministry further said Beijing would take "resolute measures" to defend its rights and interests and urged the Biden administration to "correct its wrongdoing." Following this move, EVs imported from



China will see their tariffs more than quadrupled from 27.5 per cent to 100 per cent.

According to CNN, this policy lever is meant to challenge Beijing's practice of encouraging aggressively low pricing by domestic EV manufacturers while levying a 40 per cent tariff on US car imports.

In addition to EVs, increased tariffs will apply to imports of Chinese steel and aluminium, legacy semiconductors, battery components, critical minerals, solar cells, cranes, and medi-

Tariffs on solar cells and semiconductors will double to 50 per cent, while the remainder of the targeted imports will attract tariffs of

"China opposes the unilateral imposition of tariffs which violate (World Trade Organization) rules, and will take all necessary actions to protect its legitimate rights," Chinese foreign ministry spokesperson Wang Wenbin told reporters shortly before the announce-

# Armed men ambush prison convoy to free inmate in France

A major manhunt was launched by the French authorities on Tuesday (local time) after a group of hooded armed men ambushed a prison convoy in Normandy to free an inmate, killing two guards and leaving three others injured, CNN reported.

The incident, took place as the vehicle was transporting a prisoner from court to a nearby prison, French Justice Minister Eric Dupond-Moretti said.

Video from the scene showed a black SUV in flames that appeared to have crashed into a prison van near a motorway toll booth. Two hooded individuals could be purportedly seen carrying long rifles.

Notably, such violent in-



tremely rare for that part of northern France, according to CNN.

Dupond-Moretti told reporters that the incident was the first time a French prison employee had died while working since 1992. He added that two of those hurt sustained life-threatening injuries.

French President Emmanuel Macron condemned the incident and said in a post on X that "every effort is being made to find the perpetrators of this crime so that justice can be done in the name of

the French people."

"Everything, and I mean everything, will be done to find the perpetrators of this heinous crime. These are people for whom life means nothing. They will be arrested. They will be tried. And they will be punished.

ted," Dupond-Moretti said. The national police informed in a statement on X that the gunmen are still at

A manhunt is underway to find suspects and the inmate. Interior Minister Gerald Darmanin said on X he has mobilized the national gendarmerie and "several hundred" police officers for the manhunt. Authorities on the scene are setting up roadblocks and establishing a perimeter, CNN reported citing BFMTV.

The escaped inmate has been identified as Mohamed Amra. According to the Paris state prosecutor Laure Beccuau, he is "very well known to the justice system," having sustained a total of 13 convictions, most of which were related to incidences of theft with aggravated offenses.

# TRUMP'S FORMER LAWYER WANTS HIM CONVICTED IN 'HUSH MONEY' CASE

day after Michael Cohen, the erst-while lawyer of ex-President Donald Trump testified against his former boss, he faced an intense cross-examination by the defence lawyers in the hush money trial on Tuesday (local time), CNN reported.

In one of the major takeaways, Cohen admitted that he wants Trump to be convicted in the case.

As the fiery cross-examination started, Trump's attorney Todd Blanche asked Cohen about comments he made on social media, including one in which he said 'Trump belongs in a cage'.

On being asked if he wanted Trump to be convicted,

Cohen answered "sure", according to CNN.

The former Trump aide admitted that he continued to pressure people like attorney Keith Davidson in 2018 to lie about the deals with Karen McDougal and adult film actress Stormy Daniels. He said he continued to lie "out of loyalty and in order to protect him (Trump)."

Recalling being raided by the FBI in 2018, Cohen said he was "concerned, despondent, angry". He claimed when he spoke to Trump about the case, he reassured him after which Cohen continued to be in Trump's camp Trump said, "'Don't wor-

ry. I'm the president of the United States," according to Cohen.

Speaking about Trump

Speaking about Trump, Cohen said he "admired



him tremendously." But, he later acknowledged that he changed his views about his former boss when Trump's attorney pointed out Cohen's 2019 comments to Congress that Trump had potentially committed a variety of financial crimes.

Describing his fallout, Cohen said he pleaded guilty after talking to his family and deciding he "would not lie for President Trump anymore."

Meanwhile, Cohen will be the last witness to testify for the prosecution, CNN reported citing the court transcript.

Blanche said he expects the cross-examination of Cohen "will continue until the end of the day Thursday," according to the transcript. Blanche also said it is not clear if Trump would testify.

Earlier on Monday, Cohen, while testifying in the case, admitted that he "lied and bullied" on behalf of his former boss. He also said that Trump authorised the payment of 'hush money'.

Notably, Trump wanted to end the gag order against him in the hush money criminal trial, but it was denied by a New York appeals court.

# Slovak PM wounded in shooting incident

## Blinken jams with Ukrainian band in basement bar

Neil Young's "Rockin' in the Free World" is a popular rock anthem released in 1989 just before the fall of the Berlin Wall.

"The United States is with you. So much of the world is with you. And they're fighting, not just for a free



Ukraine, but for the free world. And the free world is with you too," Blinken said before launching into the song alongside 19.99, a punk band based in Kyiv, according to The Washington Post.

The impromptu concert, held at Barman Dictat, a music bar in central Kyiv designed to double as a bunker in case of war, drew a diverse crowd, including locals and US diplomats. Applause erupted as Blinken belted out the chorus, "Keep on rockin' in the free world."

Blinken's visit to the club capped off a day filled with meetings and a speech outlining his vision for Ukraine's victory, which he described as securing a firm place in the free world.

Despite not having played music since the conflict between Hamas and Israel in October, Blinken's musical performance served as a poignant reminder of the Biden administration's unwavering support for Ukraine amidst escalating tensions with Russia.

# Biden administration initiates process for \$1 bn arms deal with Israel

The Joe Biden administration has initiated the initial stages of a process to advance a new USD1 billion arms deal for Israel, confirmed two congressional sources as reported by CNN on Wednesday.

Discussions have commenced between the State De-

partment and the House Foreign Affairs and Senate Foreign Relations committees regarding the potential sale, following an informal notification on Tuesday.

While no specific timeline has been set for official notification to Congress, the process has begun, setting in motion the eventual approval process.

This move comes amidst a temporary halt in the shipment of 2,000-pound bombs and 500-pound bombs to Israel, with concerns raised about their use in densely populated areas such as Rafah, as reported by CNN

The proposed arms deal, valued at USD 1 billion, could include the transfer of USD 700 million in tank ammunition, USD 500 million in tactical vehicles, and USD 60 million in mortar rounds, as confirmed by one of the congressional sources.

The Wall Street Journal initially reported on the administration's discussions with Congress regarding this potential sale.

"We are outraged by this cowardly and hateful act, regardless of the perpetrators and the meaning of these red hands," said the Shoah Memorial.

Director of the Shoah Memorial Jacques Fredj stated that the act demonstrated



the increased need for historical and educational in-"We are acting against intolerance and ignorance in a moment of confusion and exploitation of the history of the Shoah and genocides," The Jerusalem Post quoted Fredj as saying.

"We will continue to deploy and amplify our work in education and pedagogy against barbarism, against antisemitism and all forms of intolerance," he said.

Following the incident, the French President, Emmanuel Macron, in a post

on X on Wednesday wrote, "Degrading the Wall of the Righteous Among the Nations, the barrier of Enlightenment against Nazism, is to undermine the memory of these heroes as well as that of the victims of the Shoah."

"The Republic, as always, will remain inflexible in the face of odious anti-Semi-

tism," he said. The incident of vandalism comes at a time when there are anti-Israel protests going across the world amid the ongoing war between Israel and Hamas, and the invasion of Gaza by the Israeli military. Meanwhile, the World

Jewish Congress said that the vandalism was "shameful." "Our societies need to

wake up and understand the meaning and intentions behind these actions," said WJC.

## **BAJAJ PULSAR NS400 FIRST RIDE REVIEW**

This motorcycle is actually called the NS400Z, but I've deliberately removed the "Z" because its presence wasn't making any sense. The bike should've been called just "NS400" and that's how it's going to be in this article.

I need to also set the record straight here with respect to what everyone has reported about its design and technical bits. Almost every analyst, reviewer, YouTuber, enthusiast, their uncles, and their nephews and nieces, who believe that this Pulsar should've looked different than the NS200, are absolutely wrong. Bajaj already has a differently designed Pulsar 400. It's called the Dominar. An NS has to look like an NS, so full marks to the designers for not diluting its identity.

However, there are more reasons for the similarity in appearance. The NS200 is the company's most popular "Pulsar" not only in India, but globally too. Therefore, it was sheer common sense for Bajaj to make an NS400 and not, say, an N400. It's another matter altogether that people would've still said the same thing (that it looks like the N250), and they'd still be



wrong. Why? Because that's not how design works. A motorcycle has to con-

## **MARUTI SUZUKI LAUNCHES THE NEW SWIFT!**

Maruti Suzuki has launched the new Swift in India, and, like our earlier stories, even this won't be a press-release copy-paste but a careful overview, including a few crucial bits of information you won't get anywhere else.

#### **EXTERIOR**

All the body panels are new and so are the bumpers, front grille, and alloy wheels. The headlights are LED projector units; and the boomerang shaped DRLs under the smoked glass are obviously LEDs too. Maruti savs the rear gets LED combination lamps. What they mean by "combination" here is anyone's guess (LEDhalogen combination or dual-function lights?). I shall address this when I review the car.

My favourite change on the outside has to be the rear-door handles returning to their "normal" position. Thank you, Maruti. Another thoughtful touch is the provision of a request sensor (for keyless entry) on the front passenger door as well.

There are six colour options: Blue, Orange, Red, White, Grey, and Silver. Plus, you may have your Blue, Red, or White Swift with a black roof.

#### **INTERIORS**

Maruti says the cabin has a fresh layout with 'centre floating design' for

the dashboard. There's a SION lot of piano-black finish (high time manufacturers got rid of it!) as well along with satin matt silver inserts. The instrument-cluster dials are asymmetrical and Maruti claims that the driveroriented dashboard has an 8-degree tilt. That's one thing I can take their word for without even seeing the car as the Swift has always been a sporty hatchback.

There's cruise control; Maruti's 9-inch Smartplay Pro+ infotainment system with wireless connectivity for both Apple and Android phones, wireless charging, and fast charging ports for rear seat occupants, who now get their AC vents

#### **ENGINE & SUSPEN-**

The new Swift now gets a three-pot 1197 cc Z-Series motor with a claimed output of 60 kW (81.58 PS) @5700 rpm and 111.7 Nm @4300 rpm. Maruti says that there's now an electric water pump for optimal engine cooling and a Lambda air-flow sensor for up to 12% lower CO2 emissions, leading to a fuel efficiency figure of up to  $25.75 \,\mathrm{km/l}$ , which is an improvement of 14%

over its predecessor. Maruti haven't specified if the gearboxes (manual and AGS) are the same or new, but they have mentioned that the clutch operation is now hydraulic. For those not in the know, while the erstwhile Swift diesel had a hydraulically operated clutch, the

Swift petrol was still running on a cable-operated clutch.

The company states that the suspension is all-new but doesn't mention the changes.

#### **SAFETY**

This is the best part. Now, all Swift variants come with six airbags, Hill Hold, ESP, ABS with EBD and Brake Assist, and 3-point seat belts for all seats with reminders. Maruti also claims that the reverse camera now provides a wider view.

#### **PRICE**

The price of the new Swift starts at INR 6,49,000 and goes up to INR 9,64,500 (all prices, ex-showroom). The deliveries have already started.




