## Remains of 4 persons found nearly 6 decades after crash of an IAF plane

In a major development, the search operations to recover the remains of personnel from the ill-fated Indian Air Force (IAF) AN-12 aircraft that crashed on Rohtang Pass in 1968 have achieved significant breakthrough with the recovery of the remains of four more indi-

The mission, led by the Dogra Scouts of the Indian

Army in collaboration with an IAF AN-12 aircraft, representatives of Tiranga Mountain Rescue, is a part of the larger Chandra Bhaga Mountain Expedition.

According to the a statement from the Indian Army, the joint team has recovered the remains of four more individuals from the site, marking a significant success in one of India's longest-running search and recovery operations.

The tragedy dates back to February 7, 1968, when

# SC on laddu row: Keep gods out of politics

"We are prime facie of the view that when investigation is under process, it was not appropriate on the part of a higher constitutional functionary to go in public to make a statement

which can affect the sentiments of crores of people," it said.

The bench asked Solicitor General Tushar Mehta to assist it in deciding whether the investigation by the state-appointed SIT should continue or the probe should be conducted by an independent agency.

While posting the matter for hearing on October 3, the apex court asked the top law officer to ponder over the issue and assist it

# J&K polls: 23 govt officials suspended for MCC violation, Rs 130 crore seized

The Jammu-Kashmir State **Election Commission sus**pended 23 government officials and seized a total of Rs 130 crores through enforcement agencies in violation of the Model Code of Conduct (MCC) guidelines during the Jammu-Kashmir assembly

As per the state election commission office, 20 employees had also been transferred from their incumbent tehsils and districts against whom complaints were registered for acting in favour of a political party.

Besides these, the commission had also disengaged six contractual and ad hoc employees for the violation of MCC guidelines.

Meanwhile, the election office had further informed that a total of Rs 130 crore Pole further stated that out of 1263 **MCC** violations reported to date, 600 stands closed after the probe and appropriate action was taken against them.

Pole further stated that out of 1263 MCC violations reported to date, 600 stands closed after the probe and appropriate action was taken against them.

Meanwhile, 364 cases are still under investigation, which will also be disposed of soon, the CEO said.

## Bengal BJP MP seeks HM's intervention on illegal immigrants from Bangladesh

BJP West Bengal state general secretary and Purulia MP Jyotirmoy Singh Mahato has written to the Centre highlighting the problem of illegal immigration from Bangladesh into West Bengal over the past few years. This, he said, has significantly altered the demographic landscape, leading to a host of security, economic, and social challenges. He also blamed the ruling Trinamool Congress for actively encouraging the influx of illegal immigrants

from Bangladesh. In a letter to Union Home Minister Amit Shah on Monday, Mahato said that the Jungle Mahal region, which spans Bankura, Purulia, Jhargram, and parts of West Midnapore, has long been a cultural and economic hub for indigenous communities. However, the influx of illegal Bangladeshi immigrants has drastically shifted the region's demographic balance, he said.

Mahato, referring to Amit Shah's recent speech in Sahibganj, Jharkhand, where he had said that "unchecked infiltration" could lead to a demographic takeover within the next few decades, Mahato wrote that this issue was not limited to Jharkhand; it was deeply af-

fecting West Bengal as well. "In Jungle Mahal, this demographic shift is creating profound challenges for local Hindus and tribal populations, who find themselves outnumbered in many areas. Illegal land acquisitions, fake marriages, and identity fraud facilitated by illegal migrants are eroding the economic and social stability of the re-

gion," Mahato wrote. He said that the indigenous population was facing rising unemployment, as job opportunities were being increasingly seized by illegal immigrants, and tribal communities are being displaced from their ancestral lands.

Mahato wrote: "It is deeply concerning that this crisis is not only being ignored by certain political parties but is actively being facilitated by the Trinamool Congress (TMC) and its allies in the I.N.D.I. alliance. West Bengal Chief Minister Mamata Banerjee has openly invited Bangladeshi nationals to seek refuge in the State, effectively creating a vote bank of illegal immigrants."

He alleged that the ruling political party in West Bengal was actively working to naturalize illegal immigrants by providing them with ration cards, voter IDs, and other official documents, allowing them to settle permanently in the

A day ahead of third and final phase of Jammu and Kashmir Assembly elections, over 400 voters from Seemari village, home to India's "first polling booth" along Line of Control (LoC), demand basic necessities such as better road access, free electricity, immediate healthcare services, increased ration supplies and mobile network.

Residents are urging political parties and local authorities to address these urgent issues to improve their quality of life. They express concern that leaders forget about them after elections, noting that the only support they receive in times of need--whether for employment, food, medicine, or other essentials--comes from the Indian Army deployed along the LoC.

In Seemari village, a total of 443 voters will participate, comprising 226 men and 217 women.

Mohammad Sharif, a resident of the village, said, "This is Seemari village, the last one on the India-Pakistan border, and it has India's first polling booth. We continue to vote, but we lack roads, hospitals, electricity, and stores. We have

been facing many challenges. Voting is our right, and while we participate, the government needs to address our needs. Leaders come to seek our votes but often forget us after elections. Although the government support us, the funds rarely reach us; these funds seem to disappear along the way. Some leaders have visited and spoken with us, but they haven't made any commitments to meet our demands.

Another local Ali Asgar said that the village lacks road facilities, and three nearby villages--Phagwan, Trutihaji, and Kadhama--also have no road connec-

"When someone falls ill, they are carried on a cot to reach a nearby road to avail vehicle since it can't access the area. The sick person has to pay Rs 1,500 for a reserved vehicle from

the nearest road to get to the Tangdhar hospital. Although there is a clinic here, it has no medicine, and the roads are in poor condition. We spend over Rs 500 on electricity (monthly), but we only receive four hours of supply each day. During elections, we exercise our right to vote, yet we see no benefits from it. Leaders promise us roads and electricity, but nothing materializes. We receive a 5 kg ration on a monthly basis, which isn't enough to last a month. This is the last remote village with over 400 voters, and we also lack a mobile network and job opportunities," he said.

# SC DIRECTS TO MAINTAIN STATUS QUO ON **ASSAM'S SONAPUR DEMOLITION DRIVE**

The Supreme Court on Monday directed to maintain status quo on Assam's Sonapur demolition drive and issued notice to authorities concerned.

This development comes after over 40 residents of the Sonapur area of Assam filed a contempt petition alleging wilful violation of the top court's interim order dated September 17 pausing the demolition practice across the country without prior permission.

Senior advocate Huzefa Ahmadi appeared for the petitioners in the matter. A bench of justices BR Gavai and KV Viswanathan issued notice to the Assam government and others on the petition seeking contempt proceedings against the local authorities for violating the top court's earlier order.

"Issue notice. In the meantime, parties to maintain the status quo," the top court



Over 40 residents of Assam's Sonapur area moved the top court, alleging wilful violation of the court's interim order dated September 17, 2024, directing that no demolition should take place across the country without prior permission as the local authorities have begun an eviction drive in the

state's Kachutoli village. In the plea filed through advocate Adeel Ahmed, the petitioners sought to initiate contempt proceedings against the alleged contemnors for committing gross deliberate and wilful contempt of the top court for deliberate and wilful violation of the top court's earlier

On September 17, the top court, in an interim measure, ordered that till the next date of hearing, it is directed that there shall be no demolition anywhere across the country without seeking permission of this Court. The top court also clarified that the order would not be applicable if there is an unauthorised structure in any public place, such as a road, street, footpath, abutting railway line, or any river body or water bodies, and also to cases where there is an order for demolition made by a court of law.

The petitioner said that concerned authorities have

not followed the order passed by the court for the event of eviction and have flagged or put up red coloured stickers on the walls of the petitioners without sending any kind of notice or letter stating the issue of eviction or demolition.

The petitioners, including Faruk Ahmed, along with others, said that they have been residing in the said villages of Kachutoli Pathar, Kachutoli, and Kachutoli revenue village under Sonapur mouza in the district of Kamrup Metro for many years.

Further, the petitioners stated that they have been residing in the said lands by virtue of a deed of power of attorney that has been executed in their name by the original pattadars of the said lands. The petitioners said that they are not the owners of the said lands, and they do not have any ownership rights but are enjoying occupation and residing over the said lands by virtue of the power of attorney document, which is a legally valid process, the petitioner said. They cited Gauhati High Court's order dated September 20, 2024, whereby Advocate General gives an undertaking to that effect that no action would be taken against the petitioners till the representations are disposed of in the manner directed by the Supreme Court in the order dated February 3, 2020.

"However, here in the present case, the respondent-authorities have not followed the order passed by the court for event of eviction and have flagged or put up red sticker on the walls of the petitioners without sending any kind of notice or letter stating issue of eviction or demolition," the petitioner said.

The petitioners claimed that they have been residing in the said scheduled lands for around last seven, eight decades since generations, but they have never engaged in any disputes or clash with the tribal or protected people living in the adjoining

## SC grants interim protection to actor Siddique in rape case

The Supreme Court on Monday granted interim protection from arrest to Malayalam actor Siddique in connection with the ongoing investigation into a case related to the rape of a young actor.

A bench of justices Bela M Trivedi and Satish Chandra Sharma granted interim protection from arrest to Siddique on the conditions set by the trial court and subject to his joining in the investigation.

The top court granted the interim protection while hearing the actor's petition seeking anticipatory bail. The apex court also issued notice to the Kerala government and victim in this re-

Siddique had approached the Supreme Court seeking anticipatory bail in the case after it was dismissed by the Kerala High Court earlier this month. Senior Advocate Mukul Rohatgi and Advocate Ranjeeta Rohatgi represented Siddique in the

Appearing for Siddique, Senior Advocate Mukul Rohatgi said that the complaint was lodged in 2024 after 8 years of the alleged incident. The advocate also said that the actor will present himself for investigation. The court questioned what the state had been doing for eight years.

Additional Solicitor General Aishwarya Bhati appearing for Kerala said that Siddique has acted in 365 Malayalam movies and it is not possible to talk about such alleged perpetrators. Advocate Vrinda Grover for the victim took the court through the case and apprised that the actor approached the victim in 2014 through Facebook.

Earlier, Kerala Police issued a lookout notice against

## MP govt recognises heat waves as natural disasters

In a significant decision, the Madhya Pradesh government has included heat waves in its list of natural disasters.

This means that individuals who suffer fatalities due to heatwaves will now receive compensation similar to that provided for other natural calamities.

Following directives from the central Ministry of Home Affairs, the state government has officially notified heatwaves as a local disaster under the Madhya Pradesh Disaster Management Act of 2005. The new regulation is set to take effect in the summer of 2025.

As a result, individuals affected by heatwaves will be eligible for the same financial assistance that is currently available for those impacted by floods, earthquakes, and lightning

"The State Government

hereby notifies heatwave (hyperthermia) as a local disaster as per clause 3.2 of the Disaster Management Act, 2005, and the Guidelines on the constitution and administration of the State Disaster Response Fund issued by letter No. 33-O3-2O21-NDM-I, dated 12th January 2022, from the Government of India, Ministry of Home Affairs (Disaster Management)," the Madhya Pradesh government said in an official statement

Notably, a number of deaths were reported from the Northern India during the summers, as temperature rose significantly.

The heatwave in large parts of the country claimed 114 lives and more than 40,000 suspected heatstroke cases were reported between March 1 and June 19 this year, according to sources from the Union Health Ministry.

The maximum number of deaths due to heatstroke, till June 192024, were reported from Uttar Pradesh (37), Bihar (17), Rajasthan (16), and Odisha (13).

Heatwaves are intense periods of excessively high temperatures, often accompanied by high humidity. They typically occur from April to June and can lead to serious health risks, including heatstroke and dehydration.

The impact is especially severe in northern and central regions, where temperatures can exceed 45°C (113°F). The effects can be devastating, affecting agriculture, water supply, and overall public health.

nce the undisputed powerhouse of Haryana politics, the Chatuala or Devi Lal clan, which has produced a deputy prime minister, two chief ministers who together ruled the state six times, numerous ministers, and several MLAs, now finds itself battling for political survival and the family members fighting each other to protect their fading political strongholds.

With eight members of the Chautala family contesting in Haryana Assembly elections, five of them are directly pitted against each other. This infighting is emblematic of the clan's decline  $from\,ab solute\,power\,to\,mere$ players in a fragmented electoral battle..



In the rural Rania constituency, Abhay Chautala's son Arjun, representing the Indian National Lok Dal (INLD), faces his granduncle, former cabinet minister Ranjit Singh Chautala. This generational face-off is particularly symbolic as it encapsulates the larger struggle within the family.

Ranjit Singh, once a stal-

wart of the Congress and a former ally of the BJP, is now contesting as an independent after being denied a ticket by the ruling party. The 79-year-old veteran politician is locked in a fierce battle with 31-year-old Arjun, with both the BJP and Congress fielding candidates from the Kamboj community, threatening to split the crucial Jat vote and further complicate the outcome.

"I am confident the people



of Rania will again support me. My term as a BJP minister was successful, and I delivered development projects for my constituency," Ranjit Singh confidently asserts in his election rallies.

However, Ariun Chautala. the younger face among the Chatuala family contenders, appeals to voters through the family legacy of his greatgrandfather Devi Lal, in an attempt to reignite the emotional connection with the grassroots. Arjun Chautala attempts to bridge generational divides by appealing to younger voters, while Ranjit Singh leans heavily on his decades-long political experience and personal rapport with the electorate.

Dabwali, the Chautala family's traditional stronghold, presents an even more convoluted picture. Three members of the clan are fighting for dominance

in this assembly segment, connections to the electorturning the election into a family feud.

Ajay Chautala's younger son, Digvijay Chautala, represents the Jannayak Janta Party (JJP), a breakaway faction of the INLD. He is locked in a contest with his cousin Aditya Devi Lal, who recently defected from the BJP to join the INLD, after being denied a ticket by the saffron party. Adding further complexity, Congress candidate Amit Sihag, son of Dr. KV Singh, a distant cousin of Om Prakash Chautala, is also in the race, making it a true family showdown.

The Dabwali seat holds significant political value for the Chautalas, as it was once represented by Ajay Chautala and his wife, Naina Chautala, in successive terms. With all three Chautala candidates banking on family loyalty and personal ate, the contest has become a litmus test for the family's dwindling influence.

"The people of Dabwali know my family's contribution to the region. We have been here for decades, and I will restore our legacy," says Digvijay, staking his claim to the constituency that has long been a bastion of the Chautalas.

The Chautalas' decline mirrors the fortunes of the two main political factions of the family — the INLD and the JJP. Both parties failed to secure any seats in the last Lok Sabha elections, with the INLD securing only 1.84% of the vote and the JJP just 0.87%. In 2019, Devi Lal's great-grandson, Dushyant Chautala, managed to secure a brief victory by becoming Haryana's Deputy Chief Minister after his JJP allied with the BJP.

# Drug smuggling gang busted

228 kg marijuana worth Rs 1.4 cr seized

In a major anti-narcotics operation, Delhi Police have dismantled an interstate drug smuggling network, seizing 228 kg of marijuana (ganja) worth approximately Rs 1.4 crore.

The illegal consignment was being trafficked from Andhra Pradesh -Odisha border to the Delhi/NCR region.

Police arrested two accused identified as drug supplier Jeevan Sunar who is a resident of Gaziabad, Uttar Pradesh along with the receiver in Delhi named Parmanand, a resident of Badli, Delhi.

They were caught by the Delhi Police officials on the basis of the secret intelligence.

Both accused were engaged in supply/peddling narcotic substance in Delhi after procuring from the border area of Orissa-Andhra Pradesh.

# Green war room launched executing Winter Action Plan

Delhi Environment Minister Gopal Rai on Monday launched Green War Room at the Delhi Secretariat for better implementation of the Winter Action Plan against pollution.

He said due to the steps taken by the Delhi government, a huge reduction in pollution has been recorded. While the number of polluted days was 243 in

2016, it has come down to 159 in 2023.

Delhi's air pollution has reduced by 34.6 per cent. As part of the public awareness campaign, a "Harit Kalash Yatra" will be taken out in Connaught Place on October 1, added the Delhi **Environment Minister.** 

Addressing the media, Rai said, "Winter is round the corner in Delhi. With the onset of winter, the environment in Delhi becomes increasingly unfavourable.



The wind speed is going to decrease gradually, the rain will stop, and the temperature is going to fall.

Under such unfavourable conditions, the level of pollution in Delhi starts going up. Owing to these three factors, the gases that otherwise get dissolved reach the ground, and because of that, the level of air pollution starts increasing.'

The Environment Minister said, "The additional feature of the Green War Room this year is to analyse data with drone mapping. Secondly, the data of the Real Time Source Apportionment Study, which is done at our centre at Deendayal Upadhyay Marg, will also be analysed from the Green War Room. Thirdly, analysis of the satellite data on the smoke produced from stubble burning at various places will also be done on a daily basis in the war room." Gopal Rai added, like the previous years, the entire

through the Green Delhi

app. Through the Green

Delhi app, the whole of Delhi becomes a participant in the fight against pollution. The theme "Milkar Chalen, Pradooshan se Laden"

(Let's fight pollution together) can be made meaningful with public participation. Through the Green Delhi app, people in Delhi can see any activity that causes pollution anywhere. "Join the fight against pollution by downloading the Green Delhi app from the Play Store today. And in this entire fight, you too become a green warrior," he said.

Gopal Rai said the work that is done from the war room is the monitoring of hotspots because hotspots are the biggest hurdle in the pollution level of Delhi in winters as they increase the total AQI of Delhi. When the AQI of Delhi is 200, the AQI at 13 hotspots is 125 to 150 more than normal. This makes the AQI level of the whole of Delhi jump.

The Environment Min-

ister further said, the data of 24-hour monitoring stations that have been set up at different places in Delhi from where we monitor PM10 and PM2.5 will be analysed at the Green War Room. Also, the air pollution that we used to measure in terms of PM10 and PM2.5 earlier will now be analysed in terms of the Air Quality Index to know the actual position. So, AQI monitoring will also start today on a daily basis.

# Three nabbed for supplying ganja from Shillong to Delhi

The police said that the victims were rushed to a nearby hospital but were pronounced dead on arrival. The bodies have been stored for post-mortem while one of the five is hospitalised and is currently being treated for his injuries, they added.

A case has been registered in this regard, and the tractor involved in the crash has been taken into custody, the police added.

Uttar Pradesh Chief Minister Yogi offered condolences to the families of the deceased and also wished for the speedy recovery of the injured. The Chief Minister has also instructed officials to ensure proper treatment of the injured person. He said that the Chief Minister's office is actively coordinating with the local administration to ensure that necessary steps are taken to assist the victims' families and address any further safety concerns on the roads. # Singhu Border blockade removal: HC asks petitioner to approach Delhi Police

Monday allowed a petitioner to make a representation to the Delhi Police Commissioner regarding the removal of the extensive blockade at the Singhu border (NH-44).

The petitioner had sought a directive for the blockade's removal, arguing that it had caused significant inconvenience by hindering the smooth flow of traffic without providing alternative routes for commuters.

After issuing directions to the petitioner to approach the police commissioner, the Delhi High Court bench led by Chief Justice Manmohan and Justice Tushar Rao Gedela disposed of the plea, concluding the matter at this

The three petitioners --Shankar Mor from Lateef Garden, Sachin Aneja from Aggarsain Colony, and Shivam Dhamija from Rair Kalan -- have filed the public interest litigation (PIL) through their advocates Mohit Gupta,

Sachin Miglani, and others in the Delhi High Court.

The petition highlighted the extensive roadblock at the reaching their destinations Singhu border, placed as part of the security arrangements by the Delhi Police prevent farmers from reaching Delhi during a protest earlier this year, after failed talks between farmers' organizations and the Union Government.

The petitioners argued that the Singhu border has remained blocked for several months without providing alternative routes for safe and smooth travel between Delhi and Haryana. As a result, commuters have been forced to use nearby ancillary roads through villages, many of which are in poor condition, making travel hazardous. The blockade has caused significant disruption, including massive traffic jams, and has severely impacted public movement, particularly those traveling for medical treatment. The petitioners, who work in Delhi and Gurugram and commute to Panipat for

work, have stated that the

blockade has caused them to regularly experience delays, preventing them from on time.

The petitioner highlighted in the plea that even after more than seven months, despite the absence of any ongoing farmers' protest at the Singhu border, the authorities have continued to block the road. This prolonged blockade has led to massive traffic jams, causing significant inconvenience to the public. The plea further emphasized that many residents of Haryana rely on Delhi's superior healthcare infrastructure for medical treatment.

Due to the blockade, patients, ambulances, school buses, and commuters traveling for work are facing severe delays, with some being stuck for hours. The petitioner argued that this ongoing road closure is unnecessarily affecting the lives of many, particularly those needing timely medical care and essential services, and sought immediate relief.

# Section 163 of BNSS imposed in Delhi for 6 days

In view of inputs regarding calls for holding protests, demonstrations, and campaigns in the national capital during the first week of October, the Office of Commissioner of Police, Delhi, on Monday announced to enforce Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS) at several locations in Delhi. isoners office stated, "The general atmosphere in Delhi is sensitive from a law and order point of view due to various current issues like prevailing communal atmosphere in view of the proposed Waqf Amendment Bill and issue of Shahi Idgah in Sadar Bazaar area, politically surcharged issue of MCD Standing Committee elections and, pending declaration of results of DUSU Elections, etc.

Further, the Jammu, Kashmir, and Harvana legislative assembly elections are underway, and, thus, there is a need to have a continuous check on the movement of persons and vehicles



"In view of the above, I, Sanjay Arora, Commissioner of Police, Delhi in exercise of the powers conferred to undersigned by virtue of section \*163 Bharatiya Nagarik Suraksha Sanhita, 2023 (BNSS) read with Govt. of India, Ministry of Law and Justice (Legislative Department), New Delhi's Notification No.2654 dated 16.07.2024, do hereby make this written order in the Districts of New Delhi, North and Central apart from all Police Stations having territorial jurisdiction over the State borders of Delhi for a period of 6 days w.e.f. 30/09/2024 to O5/10/2024 (both days inclusive) to prohibit, (i) assembly of five or more unauthorized persons, (ii) carrying of fire-arms, banners, placards, lathis, spears, swords, sticks, brickbats etc (iii) pocketing or dharnas in any public area etc. and doing so shall be punishable under Section 223 of the Bharatiya Nyaya Sanhita 2023," the Commissioner's office

# RBI flags irregularities in gold loan practices

Reserve Bank of India has found irregular practices in the grant of loans against pledges of gold ornaments and jewellery by some entities. It has thus advised all "supervised entities" to comprehensively review their policies, processes, and practices on gold loans to identify gaps.

They have been asked to initiate appropriate remedial measures in a timebound manner.

RBI recently reviewed loans pledged against gold ornaments and jewellery.

The review, as well as the findings of the onsite examination of select supervised entities, indicate several ir-



regular practices.

The major deficiencies include shortcomings in the use of third parties for sourcing and appraisal of loans; valuation of gold without the presence of the customer; inadequate due diligence and lack of end-use monitoring of gold loans; lack of transparency during an auction of gold ornaments and jewellery on default by the customer;

weaknesses in the monitor-

ing of loan to value (LTV); and incorrect application of risk-weights.

Against that backdrop, RBI said that the gold loan portfolio should be closely monitored, especially in light of significant growth in the portfolio in certain



In 2017, Jyoti Bansal sold his software startup AppDynamics to Cisco for a whopping \$3.7 billion, a dream deal for most. However, Bansal quickly realised the decision came with emotional costs. AppDynamics was a labour of love, born from his own struggles as a software engineer, and its sale left him feeling lost. What should have been a triumph became a moment of reflection.

Bansal's initial reaction was one of celebration, but after the party subsided, he felt empty. The acquisition was a sudden conclusion





to his nine-year journey of building the company from the ground up. It wasn't



Jvoti Bansal just about the money for him; it was about solving problems and creating something meaningful. While the deal financially transformed him and hundreds of his employees, Bansal realized that the joy of entrepreneurship was more fulfilling than the fi-

nancial windfall. Despite the hard decision to sell, he reflected

on the sleepless nights spent weighing the pros and cons. The offer arrived just as AppDynamics was preparing to go public, which added pressure. The decision was far from easy-Bansal had to consider factors like Cisco's vision, the cultural fit, and the financial impact on employees, many of whom became millionaires overnight. Still, Bansal couldn't shake the feeling that the company had more potential left untapped.

After the sale, Bansal took time off to travel and explore the world, but the brief escape wasn't enough. In just six months, he had crossed off everything on

king the Himalayas to hiking Machu Picchu. He soon realized that retirement wasn't for him, and the joy of building businesses pulled him back into the startup world. Harness, his new venture, launched soon after, targeting software developers with new tools. Interestingly, in 2022, Harness was valued at \$3.7 billion, the same amount for which AppDynamics was sold. However, this time, Bansal's outlook has changed. While he might consider acquisition offers for Harness, the emotional weight of the AppDynamics sale has made him more cautious.

ecently, Bengaluru has experienced a notable increase in language conflicts, which has been intensified by a recent social media post. A woman expressed disapproval of Swiggy's failure to employ delivery personnel who speak Kannada, therefore igniting a renewed contentious discussion over language preferences in Karnataka. Her comments have intensified the continuing debate between insiders and outsiders, as many local residents advocate for giving preferential treatment to Kannadigas in terms of employment opportunities. Although language pride is permissible, such occurrences give rise to apprehensions regarding discriminatory attitudes, particularly in a multicultural metropolis such as Bengaluru. The current article examines the consequences of such intolerance, underscoring

the need of fostering inclu-


siveness and cohesion in India's heterogeneous social structure

Intolerance based on language has been a concern in Karnataka for some time. A similar dynamic existed in the past with many people who are not native Kannada speakers, and the criticism they faced for failing to blend into the local language and culture. The topic of regional languages has also become delicate in the southern states, where similar emotions have been observed. The locals' need for linguistic conformity is a symptom of a bigger problem with exclusion and separation, as these incidents repeatedly demonstrate. These kinds of thinking make India a less friendly place for foreigners and go against the multicultural and multilingual identity's unifying principles.

Another incident of such **kind** is the opposition to the metro line between Tamil

Nadu and Bengaluru. The Bengaluru-Hosur Metro extension development issue exemplifies the perils of intolerance in an ever more globalised society. Resistance to such a scheme based on concerns about migration not only impedes regional growth but also obstructs national advancement. Infrastructure initiatives of this nature promote economic expansion, generate employment opportunities, and improve connectivity, therefore benefiting both Karnataka and Tamil Nadu. Resistance stemming from language and geographical disparities, however, weakens the cooperative mindset necessary for economic advancement. Through the promotion of inclusiveness, India may fully accept and exploit its variety for the purpose of economic expansion. Conversely, intolerance restricts possibilities, suppresses creativity, and undermines the nation's potential in the in-

ternational arena. There is a grave danger to India's national harmony from intolerance based on language. Communities become more fragmented when native speakers push for linguistic uniformity and marginalize people who do not share their language. The very idea of federalism—that different regions and states should be able to live together peacefully—is threatened by this kind of bigotry. It causes societal disintegration by making it harder for people to move about the nation for work or to settle down. Such exclusive views have the potential to drive a wedge between individuals, diminish national pride, and impede India's



progress toward unity and diversity.

**Encouraging a Welcom**ing and Inclusive Attitude is important in a diverse country like India. Inclusive language involves employing terminology that acknowledges and honours individuals from diverse backgrounds, abilities, genders, and cultures. The Preamble of our Indian Constitution grants freedom of expression to everyone. Restricting someone with language can hinder their ability to express themselves openly. Communication is essential in creating bonds and nurturing relationships between individuals. When individuals converse in a language that isn't universally comprehended, it can establish a barrier to effective communication. When individuals communicate solely in their native tongue in the presence of those who speak different languages, it can inadvertently leave others out of discussions, decision-making, and social engagements.

Fostering an environment

that welcomes diversity necessitates a commitment to cultural awareness and the assurance that every person is appreciated, respected, and part of the society. It is essential to consider language differences and modify communication approaches to guarantee that all parties understand each

other clearly. Language is one of the important aspects of National Unity. The Cultural Unity in India transcends mere rhetoric; it embodies a tangible reality that captures the very spirit of this remarkable nation. Language, frequently perceived as an obstacle, serves a distinctive purpose in promoting cultural unity in India. India is a land of hundred of languages and thousands of dialects, that is a beauty of India's diversity. It is a famous saying that "कोस-कोस पर बदले पानी, चार कोस पर वाणी" (The water changes every mile, and the language changes every four miles). It clearly shows that how diverse India is. The use of multiple languages is prevalent, as

people frequently communicate in their native language alongside Hindi or English, fostering connections across linguistic barriers and enhancing national unity.

This begs a crucial question: Why are we so terrified of judgment and the scrutiny of the outside world that we suppress our deepest passions and talents, resigning ourselves to roles and identities that felt ill-fitting? The implications are both sobering and thoughtprovoking, for in our collective fear of vulnerability, we may have sacrificed the very essence of who we are.

One such event truly provoked me to ponder the stifling weight of societal expectations and how they can so often suppress our real, authentic selves. A friend confided in me about a significant transformation in his lifehis newfound courage to embrace his sexual orientation. My heart went out to him, for I knew all too well the immense difficulties facing those with non-heteronormative

identities in our society. Having met his parents, simple individuals, like my parents, consumed by the daily grind of financial obligations and traditional concerns like making the next home loan instalment or saving enough to secure a decent dowry for their daughter; I could only imagine the intense pressure and judgment he might face from them and they in turn might face from society. His homemaker mother, whose entire sense of self-worth and social standing was likely tied to the perceived "achievements" of her offspring, would undoubtedly be devastated by such a "deviation" from the norm. In that moment, I extended my unwavering support to my friend, yet I also cautioned him that the path ahead would be arduous. To be one's true self in the face of such entrenched societal prejudices requires immense courage - a quality I knew one may not always possess. I did not weave grand narratives of defiant rebellion, for I recognized that sometimes, self-preservation and acceptance of one's limitations are acts of wisdom, not weakness. The simple truth is that the weight of societal expectations can be Herculean, and we must tread carefully, honouring both our authentic selves and the realities we confront. The quest for selfactualization is rarely a straight, unimpeded path, but rather a winding, often

precarious route that de-

mands immense fortitude

and self-compassion. Being our authentic

selves is not just about our sexual orientation. The homemaker, the doctor, the law professor would have harboured unexplored feelings of being something more- each must undoubtedly been supressed by "what was expected of them". During a recent lecture, an incident occurred that sparked reflection. While taking attendance, one student responded to my call with a loud salute instead of the customary "present, Ma'am." His classmates reacted with smirks and mockery, but I intervened, emphasizing the importance of respecting individuals who are courageous enough to embrace authenticity. I pointed out that living one's truth, particularly in today's environment of intense societal pressure, is a challenge few of us can truly face; and those of us who do must be celebrated and not mocked.

The unspoken rules, the invisible cages we construct around ourselves and one another, are meant to guide us towards a perceived notion of respectability and success. But in doing so, are we truly creating a society of happy, fulfilled individuals? Or are we simply forging gilded prisons, trapping the authentic self behind bars of conformity?

As the legendary Pink Floyd, a legendary British rock band metaphorically observed about choices and the trade-offs people make in life, "Did You Exchange A Walk On Part In The War For A Lead Role In A Cage?"- where "walk-on part in the war" represents participating authentically, even if in a small or less recognized way, in important or meaningful endeavours. By contrast, the "lead role in a cage" suggests achieving a prominent position that seems desirable but ultimately traps and confines us. This choice reflects how we sometimes give up our true identity and genuine contributions to conform to societal expectations and seek validation, trading authenticity for acceptance and recognition that may feel restricting and unfulfill-

Kafka's quote also resonates deeply because it speaks to a common human experience - the realization that in our efforts to fit in, to be accepted, or to avoid judgment, we may have inadvertently sacrificed the very essence of who we are. It's a chilling wake-up call, reminding us that a life lived inauthentically is hardly a life lived at all.

## **NASRALLAH WAS A** TERRORIST IDEOLOGUE, **NOT A SAINT**

In one of the most daring anti-terror operations the world has ever seen, Israel under Benjamin Netanyahu wiped out the entire top leadership of the Hezbollah, including Hassan Nasrallah, the terrorist body's secretary general, last Friday, on 27 February. However much the efforts to normalise and legitimize Nasrallah as a spiritual leader and the ideologue of the Hezbollah "militia", the fact is that it was under Nasrallah that the group became a major force of terror, targeting the Jewish community as well as Americans in significant terror attacks all over the world. To give just two instances, in Argentina in 1994, Hezbollah targeted a Jewish community centre in a suicide bombing that killed 85 Jews and injured 300. While in 1996, in Saudi Arabia's Khobar Tower bombing, it killed 19 US Air Force personnel, injuring 372. Prior to Nasrallah taking charge of the Hezbollah in 1992, the group-Nasrallah was one of the founders of Hezbollah and therefore complicit—the group carried out major terror attacks against western forces, killing hundreds of soldiers and civilians. Two of the biggest such attacks was the April 1983 suicide bombing of the US embassy in Beirut, that killed a total of 63 people, including 19 Americans; and the



October 1983 terror bombing of the US and French

marine barracks in Beirut that killed 299 soldiers. The Hezbollah's charter mentions destruction of Israel as its main goal, hence the intention is to cause another Holocaust of the Jewish people. No wonder the worst of Hezbollah's attacks have been directed at Israel—not just soldiers, but civilians. Incessant rocket attacks, kidnaps, assassinations—all have been part of Hezbollah's playbook. Its kidnapping of two Israeli soldiers in July 2006 resulted in a war with Israel. The UN Security Council Resolution 1701 of 11 August 2006, which ended the Israel-Lebanon war, speaks of the creation of a demilitarised zone between the Blue Line, which is the Israel-Lebanon border, and the Litani river. It was Hezbollah that violated the demilitarized zone, by not only bearing arms but also by setting up rocket and missile launch pads there. Over a period of time, the Lebanon government was hijacked by the Hezbollah, which started controlling the levers of power in Lebanon by calling itself a political party, even though it had assassinated Lebanese Prime Minister Rafik Hariri. Hezbollah's terrorist activities extended abroad, where the Jews in particular were targeted. Hezbollah has had huge caches of weapons hidden even in civilian homes and on UN compound. One day after the horrific massacre of Israelis by Hamas on 7 October 2023, Hezbollah declared war on Israel and has ever since fired thousands of rockets and even ballistic missiles on Israel, which has displaced over 70,000 Israelis from the northern areas. It was actively planning to carry out a Hamas like massacre in northern Israel. Nasrallah ran the Hezbollah with an iron hand. He was very much a dictator, and his influence extended on other terrorist groups of the region. Nasrallah ran a reign of fear and terror and under him Hezbollah committed several atrocities against civilians, even against the Lebanese population. Whatever Nasrallah said were cues to the Hezbollah fighters to unleash mayhem on their enemies and adversaries.

The short point is that Nasrallah, if he is to be considered a spiritual guide of the Hezbollah, their ideologue, then he had a singular ideology—that of the destruction of Israel, and he worked hand in hand with Tehran in trying to get this objective fulfilled. That this would result in mass murder, was not a problem for him. In fact he supported the worst kind of torture, brutalities and massacre that the Hamas committed. That this would result in Israeli retaliation and heavy civilian casualty in Lebanon, did not worry him. Lebanese citizens were "cannon fodder" for him. All this shows a complete lack of moral compass. How is such a man worthy of respect? Hence, it's strange to see rallies even in India supporting him. Why should Nasrallah become an election issue in Kashmir? What kind of radicalistaion has been spread, what kind of brainwashing has taken place that thousands of people would come out to mourn his death? What relevance does Nasrallah have for India that he is to be mourned as if he is a martyr? These are serious questions that may even have security implications for India. And even if some people mistakenly believe that Nasrallah was a saint, the least they can do is not to demonstrate on the streets in his support. It raises many doubts in the minds of onlookers.

# MOUNTING WORK PRESSURE CLAIMS MORE LIVES IN INDIA

Close on the heels of a young EY employee ending her life, two more people have committed suicide citing work pressure. We take a deep dive into modern-day work demands to examine if tech advancements have eased the pressure or compounded it.

The tragic suicide of Tarun Saxena, a 42-year-old area manager at Bajaj Finance, has sparked a nationwide conversation about the growing pressure at workplaces, particularly in India's corporate and financial sectors. Tarun's death, following an intense period of overwork and mental strain from unachievable targets, highlights a disturbing trend in the modern workplace where expectations often surpass human endurance. Saxena's case is one of several recent incidents, including the suicide of 26-year-old Anna Sebastian Perayil, a chartered accountant at Ernst & Young, both of which shine a light on toxic workplace cultures pushing employees to the

In just ten days, three employees in India have taken their own lives, each leaving behind notes that point to one common cause—unbearable work pressure. As technology drives productivity to new heights, it also demands more from workers, sometimes with deadly consequences.

According to the WHO, burnout is now recognised as an occupational phenomenon. Employees who suffer from it are at a higher risk of mental health issues such as anxiety and depression.

According to the **National Crime Records** Bureau (NCRB), workplace-related suicides in India have been rising, with 1,362 suicides reported in 2021, a 16% increase from 2020. This alarming trend highlights the mounting pressure employees face, especially in highstress sectors like finance and IT.

#### **HOW TECHNOLOGY IS TRANSFORMING MODERN WORKPLACES**

With the rapid rise of technology, the workplace has evolved dramatically. Automation, AI, and digital platforms have reshaped industries, particularly in sectors like BFSI (Banking, Financial Services, and Insurance), where employees are now tasked with not only traditional roles but also managing complex software systems, data analytics, and tech-based operations. While this evolution increases efficiency, it often leads to a blurring of boundaries between work and personal life, especially as digital tools enable employees to stay connected 24/7. This creates a continuous work cycle that leaves little room for mental or physical recovery.

Tech-driven expectations are increasing, especially in sectors like BFSI, IT, and consulting, where performance metrics are tightly linked to sales, target achievement, and client retention. Many employees feel trapped between unrelenting digital surveillance and the constant pressure to deliver results, which can escalate stress levels.

#### WHAT IS THE 'ALWAYS-ON' **CULTURE?**

In the tech sector, the "always-on" work culture has become a pervasive issue, significantly contributing to employee stress and burnout. As technology enables constant connectivity, many workers in tech feel pressured to remain available at all hours, leading to a blurred line between work and personal life. This

development, IT services, and product management, where tight deadlines, rapid innovation cycles, and global collaboration add to the strain.

A McKinsey Health Institute survey found that approximately 25% of employees globally experience burnout symptoms, with tech workers particularly affected due to their industry's demand for long work hours and high performance. The disconnect between employee needs and employer understanding exacerbates the problem, as 22% of workers feel that employers often underestimate the impact on their mental health.

**Gartner** also highlights that managers are increasingly under pressure to balance employee well-being with corporate productivity in hybrid and remote work environments. They note that low- and mid-level managers feel "squeezed" by competing expectations, adding to the stress levels in tech-driven workplaces.

Companies like Tata Consultancy Services (TCS), Infosys and Wipro are starting to realise that this model is unsustainable, and some are implementing measures like flexible work hours, mandatory time off, and mental health resources. However, more systemic changes are needed to address the root causes of burnout in the tech sector.

This always-on culture not only impacts mental health but also leads to reduced productivity over time, as chronic burnout results in disengagement, higher turnover, and decreased organisational loyalty. Tech companies are beginning to adopt proactive measures

such as no-meeting Fridays and encouraging proactive rest rather than reactive breaks after high-stress periods. However, these practices are still not widespread across the industry



#### Results of evolved workplaces:

As a result, employees in Sweden and Denmark report significantly lower levels of stress and burnout compared to those in countries like India. In fact, Denmark consistentlv ranks as one of the happiest countries globally, with a focus on "hygge", a cultural concept emphasizing comfort, work-life balance, and well-being.

#### **COMPARATIVE ANALYSIS: WHAT CAN INDIA LEARN?**

The comparison underscores that India's workplace culture while evolving, has yet to fully embrace a balanced approach to work and well-being. Swedish and Danish workplaces show that a focus on flexible hours, mental health support, and personal well-being does not come at the cost of productivity. It can lead to greater engagement, higher retention, and improved long-term performance.

For India to move in this direction, companies would need to implement stronger work-life balance policies, such as flexible hours, remote work options, and mandated mental health programs. Moreover, shifting the focus from purely performancedriven metrics to employee satisfaction and well-being could create more sustainable and productive workplaces in the long run.

# **ALLAHABAD HIGH COURT ADJOURNED HEARING ON PIL FOR CBI** PROBE INTO LOP RAHUL GANDHI'S CITIZENSHIP TILL OCTOBER 24

he Allahabad High Court in the case observed and has adjourned the hearing wherein the Public Interest Litigation, PIL is filed seeking a Central Bureau Investigation, CBI probe into Congress leader and LoP in LokSabha Rahul Gandhi's alleged British Citizenship.

The counsel, Deputy Solicitor General of India, Surya Bhan Pandey, sought time to receive written instructions from the Union Home Ministry with regards to the status of the representation-cumcomplaint, received by the Ministry, seeking cancellation of Gandhi's citizenship. The Deputy Solicitor

General of India, Surya Bhan Pandey informed the bench comprising of Justice Rajan Roy and Justice Om Prakash Shukla that he has received verbal instructions from the Union Home Ministry that it is in receipt of a representation from PIL petitioner S. Vignesh Shishir wherein requesting the cancellation of Gandhi's Indian citizenship.

Earlier, the court asked the Union of India whether it had received the representation-cum-complaint sent by the Public Interest Litigation, PIL petitioner to the competent authority and, if it had, what its status was.

The Division bench in the case has passed the said order wherein the court



noted that a a similar PIL plea (by the same petitioner) had been moved earlier, which was dismissed as withdrawn, with a liberty to the petitioner to the petitioner to approach the competent authority under Section 9(2) of the Citizenship Act, 1955, as far as it is permissible in law.

#### **AVERMENTS MADE IN** THE PIL PLEA

In his Public Interest Litigation, PIL plea, Petitioner Vignesh claims that after the HC dismissed his earlier PIL plea, he moved a detailed representation before the Ministry of Home Affairs, Government of In-

dia, which is still pending. The PIL plea filed by him states that he made a detailed enquiries into the issue, got several 'new inputs', and sent emails to

ing details about Gandhi's citizenship records.

Further, the petition states that he learned that the UK government has already received a request from one VSS Sarma (respondent no. 14) seeking the details in 2022. After that, he (PIL petitioner-Vignesh) contacted Sarma, who agreed to share the 'confidential' emails he received from the UK Government.

It has been alleged by the PIL petition that in those 'confidential' emails (of 2022), the UK Government has indicated that it has records of Rahul Gandhi's British Nationality, and such 'personal data' is governed by the UK General Data Protection ReguData Protection Act. 2018.

Adding to it, the PIL plea states that the Government can't provide information about Gandhi unless the UK Govt gets a signed letter of authority from Gan-

Further, the PIL plea claims that the alleged mail from the UK Government is an 'outright admission' that Gandhi is a citizen of the United Kingdom.

The PIL plea states that the Central Bureau Investigation, CBI conduct a detailed probe into the matter, get a Letter of Rogatory from a competent court in India and extract all the Government records and information available with the Government of the UK/ Britain regarding Gandhi's

The plea filed also prays for a direction to the Chief Election Commissioner, Chief Electoral Officer UP, and Returning Officer, Raebareli, to cancel Gandhi's electoral certificate.

The court noted that Bhartiya Janata Party, BJP leader Subramanian Swamy has also filed a petition in the Delhi High Court regarding Congress leader Rahul Gandhi's citizenship.

The Delhi High Court in the case asked the counsel appearing for Union Government's to obtain a copy of the petition pending before the Allahabad High Courton theis sue.

Accordingly, the court listed the matter for further consideration on October 24, 2024.

## CBFC Informs Bombay High Court On Emergency Film's Release: Kangana Ranaut Has Agreed To Cuts Suggested By Revising Committee

The Bombay High Court was informed by the Central Board for Film Certification, CBFC that Kangana Ranaut, the producer and lead actor in the controversial film 'Emergency', has agreed to the cuts or changes as suggested by the Censor Board's revising committee. The Division bench comprising of Justice Burgess Colabawalla and Justice Firdosh Pooniwalla was hearing the present matter. The bench in the case was hearing the petition filed by Zee Studios, the co-producer of the film, seeking certificate for the film's release.

Earlier, the Central Board for Film Certification, CBFC through its counsel Dr Abhinav Chandrachud had informed the bench that the revising committee has suggested certain cuts in the film after which it can be re-

Therefore, the co-producers sought time to figure out if the changes can be made. When the matter was taken up for hearing, the counsel, senior advocate Sharan Jagtiani appearing for Zee Studios informed the bench that Ranaut had a meeting with the CBFC and has agreed with the suggestions with regards to certain cuts to the film.

The counsel submitted that, bench was hearing the pe-

She i.e., Kangana has informed us through an email that she met CBFC and has agreed with the cuts.

The counsel submitted that. she has said that the matter is now between her and the censor board.

The Senior Advocate stated that time is required for deciding as to how the cuts are to be implemented.

The bench of CJI DY Chandrachud informed the bench that the cuts would hardly affect even a minute of the film as these are related to some words here and there. The court asked the senior counsel to take proper instructionsn on the same. In the present case, the tition filed by Zee Studios, seeking a direction to the CBFC to issue a certificate for the release of the film. It has been contended by

the co-producer that the censor board has initially granted an e-certificate and had also intimated Ranaut about the same through emails. However, it refused to hand over the hard copy of the certificate citing various objections to the film, raised particularly by Sikh Community.

On the other hand, the CBFC has maintained that it never issued an e-certificate and that the emails, which are being relied upon by Ranaut and Zee, were autogenerated mails. The bench in the case ordered that BFC to consider the objections, if any, to the film and take a decision by September 18. In a previous hearing, the bench was irked to know that the CBFC has now referred the matter to its revising committee. Meanwhile, before the bench, the Ze e Studios alleged, that the CBFC was acting on behalf of the Central Government and was thus purposely delaying the film's release as the BJP, which is in power, doesn't want the film to impact the upcoming elections in Haryana, since it is being seenas'Anti-sikh.'

Accordingly, the court listed the matter for further consideration till Thursday.

The counsel stated, 'Others got bai but I am refused.' Siddique also sought bail on grounds of delay.

A complaint was lodged in 2024, after 8 years. There are some Facebook posts. Just because I am a wellknown actor...

On the other hand, the Advocate Vrindra Gover appearing for the complainant stated that, 'See his conduct. In 2014, she [complainant] was only 19 years old. He approached her on Facebook and liked her picture. In 2016, she was invited to a preview by a superstar. I have said in detail what happened in the hotel[where the

alleged incident took place].' Adding to it, she stated that, 'This is what happens when voice is raised against Harvey Weinstein-like persons.'

She also informed the court that the delay in filing the complaint is justified and one has to look at the revelations in the Justice Hema Committee report from a larger context.

The Additional Solicitor General, Aishwarya Bhatti appearing for the State opposed the grant of anticipatory bail.

Adding to it, she stated that there are cases, where there being no cases, where there is no sunlight, and no sanitation.

She stated: "He acted in 365 Malayalam movies. It is not possible to talk about such perpetrators."

On September 24, Justice C.S. Dias of the Kerala High Court dismissed the petition filed by him seeking anticipatory bail, observing that the materials on record indicated the prima facie involvement of Siddique in

the crime. While challenging the High Court order, he filed a Special Leave Petition in the Supreme Court. The State and the victim have filed caveats. Following the publication of the Justice Hema Committee report regarding the exploitations faced by women in Malayalam cinema, the woman made public allegations that Siddique sexually exploited her in 2016 when she met him in a hotel room after he offered her opportunities in the film industry.

Following her public allegations, she lodged an FIR under Sections 376 (rape) and 506 (criminal intimidation) of the Indian Penal Code, IPC.

The Kerala High Court in the case observed and has rejected the contention of Siddique that the delay in the registration of FIR was fatal.

The High Court observed that, 'whether the survivor's above explanation is plausi ble will have to be ultimately evaluated and decided after a full-fledged trial. Nevertheless, the contention that the above delay vitiates the entire prosecution case is not a ground for scraping the complaint, particularly while considering a bail application. The victims of sexual abuse and assault may experience psychologic cal, emotional and social barriers that feed the delay in reporting the matter, which necessarily has to be understood in the context of the trauma.' The High Court while considering the facts and circumstances of the case also held that the acts alleged against Siddique would come within the ambit of the expanded definition of "rape".

## Punjab And Haryana High Court Directs Not To Deploy Punjab Police For Security Of Judge Known For Exposing "Large-Scale Lapses Of Punjab Police": Security Breach

The Punjab and Haryana High Court in the case observed and has directed not to deploy Punjab Police for security of a sitting High Court judge who exposed 'large-scale lapses which being on the part of investigating agencies' of Punjab and whose security was compromised in a recent incident.

The Division bench comprising of Chief Justice Sheel Nagu and Justice Anil Kshetarpal was hearing the present matter.

The bench in the case observed and has ordered deployment of officers of a 'neutral' police force and not Punjab Police, for securing the movement of the Judge.

The court in the case observed that it is well known that large-scale lapses on the part of investigating agencies in the State of Punjab were exposed by various judicial orders passed by the learned Judge since last 12/24 months. The said court deems it appropriate that the security per-



rity of the learned Judge ought not to be members of Punjab police force, but either of UT Administration or of State of Haryana. The deployment of a neutral police force but not of State of Punjab in order to secure the movement of the learned Judge shall certainly assuage the feeling of insecurity perceived by the learned Judge.

The said development comes in light of a September 22 incident where a man pulled out the gun of Judge's Personal Security Officer, PSO at Golden Temple and ran towards entrance of the Golden Temple 'with possible intent to harm the Judge'.

shot himself in the head. Further, the bench in the case directed that, 'the personnel manning security of the learned Judge within and outside Chandigarh shall immediately be changed from Punjab Police to police personnel which belongs to either UT Administration or the State of Haryana.'

The report has been submitted by the Punjab Government with regards to the nature and stage of investigation being conducted into the incident. Therefore, the UT administration, Chandigarh also

apprised the Court on enhancement of security of the Judge.

The court in the case observed that, 'From the stand taken by the State of Punjab with regard to progress in investigation, the said court finds that the same though lies within the exclusive domain of the State, but the threat perception has to be assessed as perceived by the learned Judge.

The court in the case observed and has sought suggestion from UT Administration and Haryana Government for appropriate investigating officers not below the rank of Superintendent of Police of a district to conduct investigation in the incident.

However, the court also impleaded Union of India through Secretary, Home Affairs and State of Haryana through its Home Secretary as parties to the petition.

## CJI DY Chandrachud To Litigant: 'You Can't Seek In-House Inquiry Against Judge For Denying Relief'

The Chief Justice of India DY Chandrachud on September 30, 2024 took exception to a litigant seeking in-house enquiry against a judge for not granting him relief.

The litigant, a party-in-person mentioned the petition before the CJI in which the litigant added retired Chief Justice of India Justice Ranjan Gogoi as a respondent. The litigant stated that the petition was filed in May

The bench of Chief Justice of India, CJI DY Chandrachud, while expressing surprise and dismay at the petition told the party:

"How can you file a Public Interest Litigation, PIL with the judge as a respondent? There has to be some dignity. You cannot just say I want an in-house inquiry

against a judge. Justice Ranjan Gogoi was a former judge of the Supreme Court. Gogoi retired as the Chief Justice of India, CJI. You cannot say I want an in-house inquiry against a iudge because vou did not succeed before the bench. Sorry, this court cannot tolerate this.

The Litigant stated that Justice Gogoi had wrongfully dismissed the petition filed by him, challenging his termination from service, relying on an illegal statement and that there were 'gross errors of law' in the judgment. The bench of Chief Justice of India told the litigant that, 'Right or wrong, there is a final judgment by the Supreme Court. Your review has been dismissed. Now you have to file a curative. But you say you do not want to file a curative.'

The bench of CJI explained that, 'When the litigant, who said he hailed from Pune, started making submissions in Marathi, the bench of CJI also started replying in the same language. In Marathi, CJI tried to make the party understand that a petition cannot be filed against a judge merely for denying him relief. When a High Court judgment is challenged in the Supreme Court, the High Court judge who decided the matter is not made a party. The bench of Chief Justice

of India DY Chandrachud told the litigant that if he deleted the name of Justice Gogoi's from the array of respondents, then the Registry would consider processing it. The party agreed to do so.

# **ISRAEL AIRSTRIKES HIT POWER** PLANTS, SEAPORT IN YEMEN

distances, according to a report by Times of Israel.

"This isn't a message, it's an action," the IDF chief said after strikes on Houthis in Yemen

He added, "We know how to reach very far, we know how to reach even farther, and we know how to strike there accurately," Halevi

Israel Defence Minister Yoav Gallant following the strikes by the IAF on Yemen said, "I visited the IAF command and control center, where I followed the strike conducted today against the Houthi terrorist organization. Our message is clear - for us, no place is too far."

Meanwhile, tensions also escalated in the Middle East after Hezbollah launched missile strikes targeting Haifa and northern Israel.

# SpaceX Crew-9 docks at ISS to bring back NASA's Sunita Williams, Butch Wilmore

After months of uncertainty, NASA astronaut Nick Hague and Roscosmos cosmonaut Aleksandr Gorbunov, travelling in the SpaceX Dragon capsule, successfully docked with the International Space Station (ISS) on Sunday to bring back Sunita Williams and Butch Wilmore, who had been stuck there since June 2024.

As they stepped aboard, they were greeted by the Expedition 72 crew, NASA astronauts Sunita Williams and Butch Wilmore. SpaceX launched the rescue mission on Saturday that will bring them home next year. Hague and Gorbunov entered the ISS after opening



the hatch between the space station and the pressurised mating adapter at 7:04 p.m. EDT before opening the hatch to Dragon, NASA said in a statement.

Hague and Gorbunov were welcomed by the space station's Expedition 72 crew, including NASA astronauts Matthew Dominick, Michael Barratt, Jeanette Epps, Don Petitt, Butch Wilmore, and Sunita Williams, as well as Roscosmos cosmonauts Alexander Grebenkin, Alexey Ovchinin, and Ivan Vagner. In a post on X, NASA's Johnson Space Center wrote, "The official wel-

The Expedition 72 crew welcomed Crew 9, NASA astronauts Nick Hague, the Crew 9 commander and cosmonaut Aleksandr Gorbunov, the Crew 9 mission specialist, after their flight aboard the SpaceX Dragon spacecraft."

Notably, for a short time, the number of crew aboard the space station will increase to 11 people until Crew-8 members Dominick, Barratt, Epps, and Grebenkin return to Earth in early October.

On Saturday, SpaceX had launched a reduced two-man crew to the ISS, carrying supplies and two empty seats for Starliner astronauts awaiting a return home in February after an unplanned eightand-a-half-month stay in orbit, CBS News reported. The launch was delayed by two days due to high winds, rain, and clouds associated with Hurricane Helene. The SpaceX Falcon 9 rocket finally ignited and lifted off from pad 40 at Cape

Canaveral Space Force Station at 1:17 pm EDT, following a north-easterly trajectory directly aligned with the ISS's orbital plane. Inside the Crew Dragon "Freedom," Hague monitored the automated ascent alongside Gorbunov, who was on his maiden flight. Typically, Crew Dragons launch with four crew members; however, two Crew 9 astronauts--Stephanie Wilson and Zena Cardman--were removed from the mission in August to accommodate seats for Starliner commander Barry "Butch" Wilmore and pilot Sunita Williams when Crew Dragon returns to Earth in February. Notably, Sunita Williams and Butch Willmore have been at the ISS since June.

# **DIABETES AND DNA: HOW GENETICS INFLUENCE RISK AND DISEASE PROGRESSION**

MEDICALLY SPEAKING

iabetes (commonly used to refer to type 2 diabetes mellitus), is a chronic condition that affects how the body processes glucose, has long been understood to have a genetic component. The risk of developing diabetes is influenced by a blend of genetic predispositions and environmental factors, including diet and lifestyle choices. The other forms of diabetes such as type 1 diabetes, MODY (mature-onset diabetes in young), gestational diabetes etc. are also influenced by genetic factors, though there are specific mechanisms and risks vary. The relationship between genetics and diabetes is multigenic and complex.

The recent ICMR (Indian Council of Medical Research) report indicates that the prevalence of diabetes in India has increased by nearly 50% over the past decade, with an estimated 90 million people expected to be living with diabetes by 2030. Over half of these individuals are unaware of their diabetic condition, which could lead to serious health issues if not identified and treated.



#### THE ROLE OF GE-**NETICS IN DIABE-**

Type 1 Diabetes typi-

cally manifests in childhood or early adulthood and is characterized by an autoimmune attack on the insulin-producing beta cells in the pancreas. While Type 1 diabetes was previously known as juvenile diabetes, it can develop at any age. Genetics play a significant role, but the exact cause can be multifaceted. Certain genetic markers, particularly within the HLA (human leukocyte antigen) gene complex, are associated with an increased risk. However, having the genetic predisposition does not guarantee the development of the disease. Autoantibodies that target pancreatic cells can be present years before symptoms arise, but not everyone with these autoantibodies will develop

who have type 2 diabetes are more likely to develop the condition themselves. Lifestyle factors, such as obesity and sedentary lifestyle, interact with these genetic predispositions to increase risk. With urbanization and the rise of digital technology, many young people lead in-

Influence of Genetics on Diabetes Risk and Progression

Type 1 diabetes. Environmental factors, such as viral infections and infant nutrition, also contribute.

Type 2 Diabetes, which usually develops in adults over 45 but increasingly affects younger individuals, is primarily linked to insulin resistance. Variants in several genes, including TCF7L2 KCNQ1 etc. have been strongly associated with an increased risk of type 2 diabetes. Family history is a significant risk factor, as individuals with relatives

creasingly sedentary lives, spending long hours in front of screens with little physical activity. This lack of exercise contributes to weight gain and insulin resistance, key factors in the development of type 2

diabetes. Gestational Diabetes occurs during pregnancy and is characterized by high blood sugar levels that can affect both the mother and the baby. Women who develop gestational diabetes often have a family history of diabetes, either Type 2 or gestational diabetes itself. This condition is associated with complications such as high birth weight and an increased risk of developing type 2 diabetes later in life. The prevalence of gestational diabetes is rising, influenced by increasing maternal age and weight.

#### **PERSONALIZED TESTING AND AWARENESS**

By identifying specific genetic markers and variations, healthcare providers can develop customized management plans. Polygenic Risk Score (PRS) based screening tests analyze millions of genetic markers to determine an individual's susceptibility to type 2 Diabetes and is typically a once in a lifetime screening test that can guide long-term lifestyle choices. Such screening tests provide information on one's genetic predisposition to diabetes and empower individuals to make informed lifestyle and health decisions.





Monday turned out to be an entertaining affair for cricket fans all over the world. Despite losing more than two days of play due to rain and a wet outfield, India showed intent and tried to push for the result.

In 85 overs that were bowled in the entire day, a total of 437 runs were scored, and 18 wickets were scythed, summing up the actionpacked play that was on offer in

After India declared and managed to take a 52-run lead, Bangladesh openers Zakir Hasan and Shadman Islam stepped up at the crease, looking to see off the day with minimum damage.

However, skipper Rohit Sharma didn't waste time and brought his ace spinner Ravichandran Ashwin straight into the attack. He imme-

Virat Kohli and KL Rahul provided much-needed stability while keeping the run rate in check. With some classic drives and strokeplay, India maintained their aim of putting runs on the board at a brisk pace. Rahul used switch hits to effective use, while Kohli put conventional shots on display effortlessly during their 87-run partnership. Kohli tried to play Shakib Al Hasan across the line and lost his wicket for a score of 47(35), falling three runs shy of a fifty.

Rahul stayed on the crease and continued to rely on sweep and reverse sweeps to accumulate runs by rotating the strike and picking the boundary rope.

On the other end, Akash Deep went straight and flawlessly executed back-to-back towering maximums, leaving Shakib Al Hasan clueless and Rohit Sharma as well as Virat all smiles.

India continued to lose wickets as batters tried to go relentlessly for the boundaries. Rahul lost his wicket after he came down the track and attempted to adjust and play a cut shot. He missed the line of the skidding delivery and departed with a score of 68. Following Rahul's dismissal, India decided to declare 285/9 with a 52-run lead.

At Tea, India stood at 138/2, with Shubman Gill (37) and Rishabh Pant (4) unbeaten on the crease. Bangladesh lost quick wickets in the second session of day four and ended their first inning at 233.

Jasprit Bumrah, Mohammed Siraj, and Ravindra Jadeja picked up the final four wickets in Bangladesh's first inning and let India come and bat. The India skipper and Jaiswal displayed a fiery knock in the second session to overpower the Bangladesh score before the end of the day's play.

# Kohli becomes fastest to hit 27,000 international runs

India's stalwart batter Virat Kohli etched his name in the history books by becoming the fastest player to cross the 27,000 international run mark on Day 4 of the second Test against Bangladesh in Kanpur.

He surpassed 'Master Blaster' Sachin Tendulkar's record as he raced to the elusive feat with elegance on a sunny day in Kanpur on Monday.

Kohli achieved the feat in 594 innings, 29 less than the batting maestro. During his illustrious career, Sachin slammed 27,000 international runs in 623 innings.

Sri Lanka's decorated wicketkeeper batter Kumar Sangakkara achieved the feat in 648 innings. Australia's celebrated skipper Ricky Ponting amassed 27,000 international runs in 650 innings.

As Kohli continued to pull off his effortless drives and eye-catching stroke play, he looked destined for an ex-

tended stay on the crease. But his attempt to play across the line led to his downfall. Shakib Al Hasan's ball kept low and sneaked past the wide gap between Kohli's bat and pad. After hitting the historic milestone, Kohli walked back for a score of 47(35). Kohli now boasts 27,012 international runs, the fastest by any player in

After witnessing two days of rain, the people in Kanpur witnessed boundaries pelting down relentlessly. The mayhem of boundaries in Kanpur was started by Yashasvi Jaiswal and skipper Rohit Sharma. The quickfire stand of 55 runs between the opening duo ended in 3.5 overs, with spinner Mehidy Hasan Miraz cleaning up Rohit for a quickfire 23 in 11 balls, with a sole four and three sixes. During Rohit's dismissal, the scoring rate of these two was 14.34 runs per over, the highest scoring rate in a Test partnership with a minimum of 50 runs, outdoing the England duo of Ben Stokes and Ben Duckett, who stitched a stand of 87 in just 44 balls against the West Indies at Edgbaston this year, scoring at a rate of 11.86 runs per over. Temperatures of 10 degrees and a track that was still damp in places greeted the drivers for the first qualifying session at the Red Bull Ring. Many drivers initially took to the 4.318-kilometre circuit on wet-weather tyres, before then switching to the Pirelli slicks. The lead seemingly changed hands every second, with the Mercedes-AMG drivers always there or thereabouts. Shortly be-



fore the end, Lamborghini racer Paul moved to the top of the timings sheet and looked set to secure pole, before Maini posted the fastest time on his final lap.

The DTM grid is a highly competitive grid of 20 drivers representing all the manufacturers of Mercedes AMG, BMW, Audi, McLaren, Ferrari, Porshe and Lamborghini. Most of these drivers also drive in the GT3 World Endurance Championships across the Globe as well as the 24 hours of Nurburgring.

The races are held across Europe over eight rounds comprising of two qualifying sessions and two races over each round.

# ICC Women's T20 WC warm-up: India, New Zealand, Australia secure wins

On the second day of warm-up action ahead of the ICC Women's T2O World Cup 2024, New Zealand, Australia, and India recorded comfortable wins against South Africa, England, and the West Indies, on Sunday, respectively.

India began their warm-ups for the Women's T20 World Cup with a 20-run win over the West Indies.

The West Indies put India under pressure early, dismissing the top three batters within the Powerplay. Captain Hayley Matthews (4/17) was instrumental in this, taking the key wickets of Harmanpreet Kaur and Smriti Mandhana in back-toback overs.

However, Jemimah Rodrigues and Yastika Bhatia (24 in 25 balls, with a four and six) steadied the ship for India with a crucial 50-run partnership. Rodrigues was particularly impressive, reaching a well-crafted half-century, finishing with 52 off 40 balls, with five fours.

Deepti Sharma and Pooja Vastrakar provided a late surge to take India past the 140-run mark.

In their chase, the West Indies encountered a similar fate as India, losing three early wickets, including that of captain Matthews.



Shemaine Campbelle (20 in 38 balls, with two fours) and Chinelle Henry managed to stabilise the innings with a solid 57-run partnership. However, India retaliated by taking three wickets in the span of just seven balls, shifting the momentum firmly in their favour.

Asha Sobhana (1/7) ended the half-century partnership by taking a crucial wicket, and Deepti Sharma (2/11) followed up with two wickets in three balls, leaving the West Indies in a precarious position at 71/6.

Henry fought valiantly, remaining unbeaten on 59 in 48 balls with six fours and two sixes, but the West Indies struggled to find the firepower in the latter stages of their innings. Ultimately, they finished at 121/8 in their 20 overs, falling 20 runs short of the target. Pooja Vastrakar was the top wicket-taker with 3/20 in four overs. Amelia Kerr delivered a stellar all-round display, leading New Zealand to a commanding victory over South Africa in their opening warm-up match.

# Junior World Championship: India win medal in rifle, pistol mixed team events
