# 10 NAXALITES GUNNED DOWN IN C'GARH FOREST ENCOUNTER

en Naxalites, three of them women, were gunned down in an encounter with security personnel in Chhattisgarh's Sukma district on Friday, a senior police official said.

Chief Minister Vishnu Deo Sai hailed the security forces and said the era of peace and progress has returned to the Bastar region.

The gunfight broke out in the morning in a forest near Bhandarpadar village in the jurisdiction of the Bhejji police station, where a joint team of security personnel was out on an anti-Naxalite operation, said Sundarraj P, inspector general of police (Bastar range).

The Supreme Court on Friday said that it would pass an order on November 25 on a batch of petitions seeking to delete the words 'secular' and 'socialist' from the Preamble of the Indian Constitution.

A bench of Chief Justice of India Sanjiv Khanna and Justice Sanjay Kumar, while hearing the petitions, observed that being socialist in the Indian sense is understood only to be a "welfare state.'

The bench said secularism is part of the basic structure of the Constitution and the 42nd Amendment had been examined by the Supreme Court earlier as well.

otesting against the Union government for not fulfilling demands made to farmers during 2020-21 protests, the farmers associated with the Samyukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha have decided to intensify their agitation by launching fast unto death from November 26--the anniversary of 2020-21 farmers agitation.

Farmer leaders, who jointly announced this decision in Delhi to Friday, said the Samvukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha announced that decision was taken following no response from the government on their pending demands including legal guarantee for **Minimum Support Price** (MSP) and a Loan Waiver.

The SKM (NP) leader Jagjit Singh Dallewal to himself start an indefinite hunger strike at the Khanauri border. The leaders said that farmers and labourers from Punjab, Haryana, Rajasthan, Uttar Pradesh, Himachal Pradesh, and other states will gather at the Khanauri Border to support the hunger strike. The farmers are demanding legal guarantee for MSP, Implementation of Swaminathan Commission recommendations, Pensions for farmers and farm labourers, no hike in electricity tariffs, Withdrawal of police cases against farmers, Justice for victims of the 2021 Lakhimpur Kheri violence, Reinstatement of the Land Acquisition Act, 2013 and Compensation for families of farmers who died during the 2020-21 protests.

"On November 26, Dallewal will begin a fast unto death at the Khanauri border. Despite farmers sitting in protest at the Shambhu, Khanauri, and Ratanpura borders for the past nine months, the government has not paid any attention to their demands. This drastic step is being taken to awaken this deaf and blind government from its deep slumber", said farmer leader Abhimanyu Kohar.

The press conference saw participation from prominent leaders like Sarwan Singh Pandher, Sukhjinder Singh Khosa, Tejveer Singh (Haryana), Abhimanyu Kohar, and representatives from Uttar Pradesh, including Rajinder Yadav and Jatinder Sharma. # Gyanvapi ASI survey: SC seeks response of Masjid Committee

The Supreme Court on Friday sought the response of the Gyanvapi Masjid Committee on an application filed by some Hindu worshippers seeking an Archaeological Survey of India (ASI) survey of the sealed area of the mosque, where a "Shivlinga" was claimed to have been found in Varanasi.

A bench of Justices Surya Kant and Ujjal Bhuyan issued notice to the Committee of Management Anjuman Intezamia Masjid, which manages the mosque in the Gyanvapi complex and others on the application filed by some worship-

The bench posted for hearing the matter on December 17. The bench said it will also hear same-day other petitions relating to the case, including an application to consolidate all suits and transfer them from the Varanasi district court to the Allahabad High

The application said that since a part of the building was sealed by an interim order of May 20, 2022 and confirmed by order November 11, 2022, the ASI could not make a survey of the sealed area of the property in question.

"It is submitted that there are important evidence and material relating to the temple within the sealed area and same are importance pieces of evidence for decision of the case. The portion of the building in question is also required to be sur-

It would be expedient in the interests of justice to direct ASI to conduct a scientific survey of the sealed area by adopting the latest methods of investigation, survey and submit a report within such time as may be provided before this court and the interim order of November 11, 2022, may be modified to that extent, said the petitioners

"Pass an order directing ASI to conduct survey using all possible scientific methods of the sealed area of the property in question and submit report within time provided by the court. Suitably modify the order dated November 11, 2022 permitting ASI to conduct survey within sealed area of the property in question," they urged the apex court.

Earlier, the top court had put on hold the carbon dating of the "Shivling," saying that the implementation of the directions contained in the Allahabad High Court's order shall stand deferred till the next date of hearing.

Allahabad High Court had allowed the scientific survey of the "Shivaling" in the premises of the Gyanvapi complex under the supervision and direction of District Judge Varanasi.

The apex court had deferred the "scientific survey," saying, "Since the implications of the impugned order merit closet scrutiny, the implementation of the directions concerned in the order shall stand deferred

# Manipur violence claimed 258 lives since May last year

The ethnic violence between Meitei and Kuki communities in Manipur has claimed 258 lives since May last year, the state government's Security Advisor Kuldiep Singh said on Friday.

He said that the state would get around 90 companies of the Central Armed Police Force (CAPF), over and above the 198 companies that are already in Manipur.


"The total number of deaths is 258 including militants," Singh while addressing a press conference after holding a security review meeting here.

The security advisor said that 32 people were arrested in connection with vandalism and torching of properties of ministers and MLAs while around 3,000 looted weapons have been recovered.

"We are getting approximately 90 companies of CAPF, over and above the 198 companies which were earlier sent to the state. A sizeable number of them have already reached Imphal. We are distributing forces to protect the lives and properties of the citizens and vulnerable points,"

Singh said. The authorities would set up coordination cells and ioint control rooms in each district, he said after the meeting which was attended by representatives of the Army, BSF, CRPF, Assam Rifles, SSB, ITBP and the

said. It will be found out whether the abduction happened in presence of the security forces, he said.

No information is available if the militants involved in the abduction belonged to Suspension of Operations (SoO) groups but it will be checked, Singh said adding that NIA is looking into the cases. The SoO pact was signed by the Centre, the Manipur government and two conglomerates of Kuki militant outfits – Kuki National Organisation (KNO) and United People's Front (UPF). The pact was signed in 2008 and extended periodically thereafter.

The violence between Imphal Valley-based Meiteis and adjoining hills-based Kuki-Zo groups, besides inflicting heavy casualties, rendered thousands of people homeless since May last year.

#### Over 100 monkeys die of toxic chemical, buried in pit to hide carnage

Hathras (UP): More than 100 monkeys perished after inhaling a pesticide sprayed in a food godown and were stealthily buried in a pit, police on Friday said. On Friday, the bodies of monkeys, buried in a pit, were taken out for a postmortem by a team of veterinarians.

Circle Officer Yogendra Krishna Narayan said police came to know about the deaths on Wednesday. Police have registered a case against the employees of Food Corporation of India and started an investigation.

According to police, the chemical in question was aluminium phosphide sprayed on wheat sacks to protect it from insects and rodents in an FCI warehouse on November

7. A troop of monkeys entered the warehouse through a broken window of the godown on the night of November 7 and ended up inhaling the gas. When the workers opened the warehouse on November 9, they saw several monkeys dead. They allegedly chose not to inform their seniors about deaths and buried the bodies in a pit.

The CO said the bodies were exhumed when some Vishv Hindu Parishad leaders came to know about the incident.

The poorest among us suffer the most, unable to escape the toxic air that surrounds them. Families are gasping for clean air, children are falling sick, and millions of lives are being cut short," Gandhi said on X. The Leader of the Opposifect on India's global reputation, further calling for a collective response to the pollution crisis and urging governments, companies. experts, and citizens to work together to address the issue.

"Tourism is declining and our global reputation is crumbling. The cloud of pollution covers hundreds of kilometres. Cleaning it up will need major changes and decisive action--from governments, companies, experts and citizens. We need a collective national response, not political blame games," he said.

With the winter session of the Parliament to begin in a few days, he reminded the parliamentarians of the urgent need to address the issue "once and for all."

However, several places in Delhi are still in the 'severe' category for air pollution, with Anand Vihar recording an AQI of 410, Bawana 411, Mundka 402, and Wazirpur at 413.


# Naidu introduces SwarnaAndhra@2047 vision

the CM, the vision document was drafted following widespread consultations and grassroots-level engagement such as conducting workshops at mandal and municipality level and covering over 1.18 crore households, among others. # Vote counting for bypolls today, Priyanka fate to be decided

The counting of votes for the bypolls to 46 Assembly seats in 13 states and in the Lok Sabha segments of Nanded in Maharashtra and Wayanad in Kerala, a crucial electoral exercise since the parliamentary polls in April-May, will begin at 8 am on Saturday.

Congress general secretary Priyanka Gandhi Vadra is making her poll debut from Wayanad, a seat that was earlier represented in the Lok Sabha by her brother, Rahul Gandhi.

Elaborate arrangements have been made for the counting of the votes polled in the three bypolls in Kerala -- Wayanad Lok Sabha and the Palakkad and Chelakkara Assembly seats. In Wayanad, Priyanka Gandhi was pitted against Communist Party of India (CPI) veteran Sathyan Mokeri and BJP's Navya Haridas.

The Assembly bypolls were held in nine seats in Uttar Pradesh, seven seats in Rajasthan, six seats in West Bengal, five seats in Assam, four seats each in Punjab and Bihar, three seats in Karnataka, two seats each in Madhya Pradesh and Kerala and one seat each in Chhattisgarh,



Gujarat, Uttarakhand and Meghalaya.

The Meerapur, Kundarki, Sisamau, Katehari, Phulpur, Majhawan, Ghaziabad, Karhal and Khair seats went to bypolls in the crucial political battleground of Uttar Pradesh on November 20. While the results will not directly impact the composition of the 403-member state Assembly, the contest is being seen as the first major face-off between the ruling Bharatiya Janata Party (BJP) and its political rivals since the Lok Sabha election.

The BJP and the opposition parties have accused each other of election malprac-

While Samajwadi Party (SP) president Akhilesh Yaday has exuded confidence that the bypoll results will be favourable for his party, Deputy Chief Minister Keshav Prasad Maurya has asserted that the BJP will emerge as a clear winner.

In the 2022 Uttar Pradesh Assembly polls, the BJP won the Phulpur, Ghaziabad, Majhawan and Khair seats, while the SP secured victories in Sisamau, Katehari, Karhal and Kundarki. The Rashtriya Lok Dal (RLD), which was an SP ally then, won the Meerapur seat. The party has since switched sides and is now a part of the BJP-led NDA.

While the Congress did not contest the bypolls, it extended support to the SP. The Bahujan Samaj Party (BSP) contested all nine seats independently, while Asaduddin Owaisi's All India Majlis-e-Ittehadul Muslimeen (AIMIM) fielded candidates in Ghaziabad, Kundarki and Meerapur. The Aazad Samaj Party (Kanshi Ram), led by Chandrashekhar Azad, also contested all seats except Sisamau. A three-tier security arrangement has been put in place for the counting of the votes cast in the seven Assembly bypolls in Rajasthan, an official said on Friday. The

Jhunjhunu, Ramgarh, Dausa, Deoli-Uniara, Khinvsar, Salumbar and Chaurasi seats went to bypolls in the desert state on November 13.

Bypolls were held in the Gidderbaha, Dera Baba Nanak, Chabbewal (reserved for Scheduled Caste candidates) and Barnala Assembly seats in Punjab on Wednesday. The bypolls were necessitated after the incumbent legislators were elected to the Lok Sabha.

The contest in Punjab is being seen as a litmus test for the ruling Aam Aadmi Party (AAP) and Chief Minister Bhagwant Mann, whose government has completed two years and a half in office. The Congress and the BJP are the two other main contenders.

Karnataka witnessed a fierce fight between the ruling Congress and a combative BJP-JD(S) alliance in the bypolls to the Sandur, Shiggaon and Channapatna Assembly segments on November 13.A good show by the Congress will be seen as an endorsement for both Chief Minister Siddaramaiah and his deputy D K Shivakumar, while a solid performance by the BJP would mean the silencing of its state president B Y Vijayendra's critics within the saffron organisation fold.

# WHY ALLOW TRUCKS? SC FLAGS DELHI **GOVT'S FAILURE ON GRAP-4 CURBS**

he Supreme Court on Friday directed the Delhi government and Police to immediately set up checkpoints on all 113 entry points to Delhi to check the entry of trucks in the national capital.

A bench of Justices Abhay S Oka and Augustine George Masih said the personnel who are going to man the entry points must be clearly informed about the accepted items to enter in trucks under essential commodities.

It appointed 13 members of the Bar as court commissioners to visit the entry points to Delhi and verify whether entry of trucks is being stopped.

The order of the apex court came after it was told that there are 113 entry points and the vigil is maintained primarily at 13 major entry points.

The bench said that this

meant that for the other 100 points there is no restriction on vehicles which is banned under GRAP stage IV.

The apex court expressed dissatisfaction with the compliance of GRAP IV measures saying despite orders passed by the apex court and CAQM, there is a failure on the part of the Delhi government and Police to comply with clauses under GRAP stage IV.

"So far as complaince is concerned, we are not satisfied. Government has not stated clearly as to at how many entry points there are officers present to comply with measures of GRAP IV," it said.

"We direct the Delhi Government and Delhi Police to

ensure that checkposts are immediately set up at all 113 entry points," the bench ordered.

While appointing 13 advocates as court commissioners, the bench asked the Additional Solicitor General to forward their names to the Delhi Police Commissioner to facilitate their visit to the entry

### Smog blankets Delhi, air quality remains 'very poor'

A thick layer of smog engulfed the national capital on Friday while the air quality index in Delhi remained in the 'very poor' category, according to the **Central Pollution Control** Board (CPCB).

At 7 am on Friday, the CPCB recorded Delhi's AQI at 371, which placed it in the 'very poor' category.

According to the CPCB data, the AQI measured at Chandni Chowk till 7 am was 359, IGI Airport (T3) 357, ITO 344, Jawaharlal Nehru Stadium 342, RK Puram 372, Okhla Phase 2 374, Patparganj 379, Sonia Vihar 400 and Aya Nagar

However, several places in Delhi are still in the 'severe' category for air pollution, with Anand Vihar recording an AOI of 410. Bawana 411, Mundka 402, and Wazirpur at 413.

An AQI between 0-50 is considered good, 51-100 is satisfactory, 101-200 is moderate, 201-300 is poor, 301-400 is very poor and 401-500 is severe.

At 7 am on Friday, the CPCB recorded Delhi's AQI at 371, which placed it in the 'very poor' category.

### HC directs Centre, Delhi govt action on fake medical signatures

The Delhi High Court on Friday directed the Central and Delhi governments to consider a representation calling for clear guidelines to prevent the illegal use of fake and scanned signatures (such as jpeg, bmp, png files) being misrepresented as digital signatures.

The petition highlighted their use in authenticating medical reports, prescriptions, certificates, and other documents in medical labs, hospitals, clinics, and healthcare facilities.

It was submitted that despite the petitioner submitting representations to the Health Department, GNCTD via email on August 4, and to other respondents via email on August 13, the respondents have neither acknowledged nor addressed the representation.

The matter was heard on

It stated that the issue raised in this petition concerns the unauthorized use of scanned images or JPG files of an individual's inked signature, facsimile seals, or hand signatures (made on a tablet using a finger or stylus) for authenticating lab reports, prescriptions, medical certificates, notifications, and similar documents in medical diagnostic laboratories, hospitals, clinics, and other clinical establishments

# HC orders GNCTD, PWD to act on foot overbridge near Delhi Zoo

Plea stated that previously, a red light at the location helped regulate pedestrian crossings, allowing people to cross the road safely during high-traffic hours. However, when the signal was re-

moved during the 2023 G20 Summit, pedestrians began crossing while vehicles were speeding, leading to safety concerns. The petitioner further emphasized the adage, "Prevention is better than cure," pointing out that, on a daily basis, both advocates and court staff are forced to risk their safety by crossing the road due to the absence of a foot overbridge or underpass. With no safe crossing options, pedestrians are left with no choice but to take the risk of crossing a busy road, putting them in danger of accidents.3

The petitioner also highlighted that residents of Delhi pay heavy taxes to the government, and cannot remain silent in the face of such safety risks.

The situation worsens during the winter months, particularly from December to January, when dense fog significantly reduces visibility at the Zoo red light on Mathura Road.

The bench referred to Section 7(b) of the 1994 Act which says the tree authority shall be responsible for carrying out the census of existing trees and obtaining, whenever considered necessary, declarations from all owners or occupants about the number of trees in their

"Whether this activity has been undertaken? This is the duty of the tree authority. This has to be undertaken first," asked the bench.

While one of the lawyers appearing in the matter said from 1994 till now, such an activity had never been carried out, another advocate said the tree census was a

"Now we have to examine how the tree authority is functioning. What is the procedure followed for grant of permission," the bench said.

Another issue the bench wanted to examine in the light of the diminishing tree cover was whether a body experts could be constituted to look into the permission granted for tree felling and without whose permission nobody would fell trees.

The bench said a similar order was passed for Bengaluru, where if the tree authority granted permission for felling trees, it went to a body of experts to look into it.

The hearing will take place

on November 29 when the bench is likely to examine the affidavit filed by the tree authority and issue directions for the strict implementation of the provisions of the 1994 Act.

The application, which stated that five trees are felled in Delhi every hour, also sought to restrain the Union Ministry of Environment, Forest and Climate Change from permitting diversion of forests in Delhi without the top court's nod.

On Friday, the apex court also dealt with another application, which raised a grievance that several trees were sought to be cut for the construction of a foot over bridge.

The bench agreed to hear the application and said the respondent authorities would ensure no tree was felled for the purpose of construction of the foot over bridge.

# SEBI probes Adani bribery disclosures

India's Securities and Exchange Board (SEBI) is scrutinizing Adani Green Energy Ltd. for potential disclosure lapses concerning a U.S. Department of Justice (DOJ) bribery investigation. The probe focuses on whether Adani Green adequately informed investors about the DOJ's inquiry, especially regarding the involvement of individuals associated with the Adani Group.

SEBI has approached stock exchange officials to determine if Adani Green failed to properly disclose the DOJ's investigation into bribery allegations. This fact-finding mission is expected to continue for two weeks, after which SEBI may decide on initiating a formal investigation.

The inquiry stems from a March 15 Bloomberg News report indicating that U.S. prosecutors were investigating whether an Adani entity or individuals linked to the company, including its billionaire chairman Gautam Adani, were involved in bribing Indian officials for favorable treatment on an energy project. In response, the Adani Group stated it was not "aware of any investigation against our

chairman" and affirmed its compliance with antibribery laws in India and elsewhere. Subsequently, on March 19, Adani Green filed a statement to stock exchanges acknowledging awareness of an investigation into potential violations of American anti-corruption laws by an unrelated third party.

On November 20, U.S. prosecutors charged Gautam Adani with orchestrating a \$250 million bribery scheme to secure solar energy contracts in India, alleging that the conglomerate concealed

this plan while seeking funds from U.S. investors. A spokesperson for the Adani Group denied these allegations.

The indictment also

claims that Adani's denial to Bloomberg in March was a false statement intended to further the alleged fraud, noting that Adani's nephew, Sagar Adani, had received a grand jury subpoena and search warrant a year earlier. Sagar Adani serves as the executive director of Adani Green, India's largest renewable energy developer.

In response to the U.S. indictment, shares of Adani's flagship firm plummeted by as much as 23% on Thursday before recovering some losses on Friday.

SEBI, which can act on complaints from stock exchanges, has previously investigated the Adani Group for issues such as disclosure norms, including following allegations by short-seller Hindenburg Research last year, though findings have yet to be disclosed. SEBI's authority allows it to file civil charges, with disclosure violations typically resulting in monetary penalties.

Neither SEBI, the Bombay Stock Exchange Ltd., nor the National Stock Exchange Ltd. responded to requests for comment.

Collaborative research initiatives can help document traditional practices while respecting the rights and interests of indigenous communities. Such partnerships can also facilitate the integration of traditional knowledge into modern scientific research, leading to innovative solutions for pressing global challenges. Furthermore, promoting

awareness about the value of traditional knowledge among consumers can drive demand for products that are ethically sourced and produced using traditional methods. This can create economic opportunities for Indigenous communities while encouraging sustainable practices that respect cultural heritage. For instance, promoting organic products cultivated through traditional agricultural methods can appeal to environmentally conscious consumers. The role of technology in protecting TK should not be overlooked. Digital platforms can serve as repositories for documenting traditional knowledge, making it accessible while ensuring that proper credit is given to its custodians. However, careful consideration must be given to how this information is shared to prevent misuse or appropriation by entities seeking to exploit it for profit.In conclu-

Knowledge in India is not iust about safeguarding cultural heritage; it is about recognizing the rights of Indigenous communities and ensuring their voices are heard in discussions about their future. The Human Development Index (HDI) and Sustainable Development Goals (SDGs) represent global benchmarks for human progress, emphasizing equality, sustainability, and individual wellbeing alongside economic growth. However, these aspirations remain elusive in Eastern Nagaland, a region characterized by systemic neglect and governance failures despite being part of a sovereign state under India's federal structure. The glaring underdevelopment in this region, evident in persistent poverty, inadequate infrastructure, and poor access to essential services, underscores deeper constitutional and developmental injustices that violate the principles of equity and justice enshrined in the

# **AAP AIMS FOR THE** HAT-TRICK

Aiming for a hattrick in Delhi, the Aam Aadmi Party has made its intentions clear by declaring its first list of nominees for the Assembly polls, thus sending a clear signal to its opponents that it was fully prepared to take them on. The first AAP list has mostly the names of those who joined the party and were being fielded against their former colleagues. There is a two-fold objective behind this early declaration, the first being that the AAP is conscious of the BJP's Operation Lotus plans and thus has shielded its top leaders while giving tickets to new entrants, who have no other place to go. It is most unlikely that anyone of the nominees shall defect to any other party at this stage, and the list includes the son of former Congress strongman, Chaudhury Matin, who shall be the AAP candidate from Seelampur, a pre-dominant Muslim seat. Most political pundits had believed that the minority dominated seats would be won by the Congress since going by the voting pattern of the Parliamentary elections, the Muslims had voted for the grand old party. However, by inducting Matin's son, the AAP is now going to be a serious challenger and could even win.

The Muslims by and large have been of the view that it was important to beat the Saffron brigade and whichever party was most suitable in achieving this objective, they would support it. Although things have changed over the past few months, the Muslim votes cannot be taken for granted by anyone, particularly the Congress whose Delhi president Devendra Yadav seems busy with his padyatras rather than focusing on the strategy. The Congress should have ensured that defections to AAP should have been prevented. It is a costly mistake which would influence the outcome, if strong remedial measures are not taken on time. The AAP has been wary of BJP's designs, after Kailash Gehlot, a minister in the city government recently resigned from the party and joined the BJP, the following day. This kind of activity concerning other key leaders is also not ruled out, and therefore, the AAP leadership has to be extremely cautious from now onwards. The BJP has expressed surprise that the AAP list does not include the names of known leaders including Chief Minister Atishi Singh and some others. The exclusion of sure shot names has given rise to speculation that some of the top functionaries of the party could be changing their constituencies. For instance, Atishi had won by a small margin from Kalkaji in 2020 and needs to win big to send a message across the parties. Manish Sisodia, is a key player in AAP and may find the going tough in Patparganj where the BJP is quite strong. There is no such issue with Arvind Kejriwal who shall represent the New Delhi seat and is likely to sail home comfortably. However, there is a question mark over the winnability of some other leaders and the party shall have to take a view on the seats which would be most suitable for them. While the general opinion is that the AAP was in a pole position to once again form the government, notwithstanding the scams that have rocked its government and impacted its image, it is to be seen whether it can repeat its outstanding performances during the past two elections.

down, particularly since the BJP is all geared up to take the AAP on in order to overcome the jinx of defeats since its victory in 1993. The Congress which had collapsed after it supported Arvind Kejriwal during his brief stint as the CM in 2013, is also hoping to bounce back and open its tally which was nil both in 2015 and 2020. In the triangular contest that is likely to take place, the AAP's chances would be dependent on the performance of the Congress. If the Congress is not able to catch the imagination of the people, it would help AAP win easily. However, if the Congress does well, the BJP shall be the ultimate gainer. Unfortunately for the BJP, there is no clear face who can be projected for the Chief Ministership. There are many leaders, but no one is charismatic enough and who can take on the AAP challenge head on. Same is the case with the Congress which has tired functionaries seeking tickets for either themselves or their sons or daughters. The current party chief is working hard but the party may have to think clearly on whether he can be projected as the CM face. Congress treasurer Ajay Maken, is from a known political family and could have been the face. However, he is the treasurer and now has his ambitions nationally rather than in Delhi. In the BJP, it would have been a good idea to showcase Arvinder Singh Lovely, who had defected from the Congress to the Saffron Brigade during the parliamentary elections. But he is a reluctant participant in day to day activities and has been maintaining a low profile. Lovely is a Punjabi face who can click with both Hindus and Sikhs. It is a complex situation that has emerged and the contest is likely to be fought on the issue of statehood of Delhi, a demand supported by the BJP earlier and could be the main plank of the AAP. The question would be on whether the elected representatives should be subservient to those who are appointees of the central government. The elections are eagerly awaited.

# EXPLAINER

n Intercontinental Ballistic Missile (ICBM) is a powerful weapon system designed to deliver nuclear or conventional warheads over extremely long distances, typically exceeding 5,500 kilometers. These missiles are central to the strategic defense and deterrence policies of nations with nuclear capabilities. Here's an indepth look at their history, design, and strategic role.

#### **HISTORY AND DE-VELOPMENT**

ICBMs trace their origins to the V-2 rockets developed by Nazi Germany during World War II. After the war, advancements in rocket technology by both the United States and the Soviet Union during the Cold War led to the development of the first ICBMs. The Soviet Union's R-7 Semyorka, deployed in 1957, was the world's first operational ICBM. This was closely followed by the United States' Atlas missile.

#### **ORESHNIK-**INTERMEDIATE-**RANGE BALLISTIC**

MISSILE (IRBM) On November 21, 2024, Russia conducted a significant military operation by launching the previously undisclosed "Oreshnik" intermediate-range ballistic missile (IRBM) at the PA Pivdenmash facility in Dnipro, eastern Ukraine, This event marked the missile's first known operational deployment, introducing a new element into the ongoing conflict.

#### **Advance notification and** international communication

Prior to the missile launch, Russia provided the United States with a brief advance warning through established nuclear risk reduction channels. Defense Department Deputy Spokesperson Sabrina Singh confirmed this communication, stating, "The United States was prenotified briefly before the launch through nuclear risk reduction channels." Kremlin spokesperson Dmitry Peskov corroborated this, noting that the warning was issued approximately 30 minutes before the missile's launch. This preemptive notification aligns with international protocols aimed at preventing unintended escalations during military operations.

#### Missile specifications and capabilities

The Oreshnik missile



IRBM with an estimated range between 2,500 and 5,500 kilometers. It is equipped with Multiple **Independently Targetable** Reentry Vehicles (MIRVs) capable of traveling at hypersonic speeds, reportedly reaching up to Mach 10. #### Oreshnik is based on the RS-26 Rubezh design, a solid-fueled intercontinental ballistic missile (ICBM) derived from the RS-24

Yars ICBM. The RS-26 underwent a series of tests between 2011 and 2015 but was excluded from Russia's 2018-2027 State Armament Program. The current status of the RS-26 was previously uncertain, but its apparent evolution into the Oreshnik suggests a renewed focus on intermediate-range ca-

treaty implications The development and deployment of the Oreshnik occur against the backdrop of the dissolution of the Intermediate-Range Nuclear Forces (INF) Treaty. Signed in 1987, the INF Treaty eliminated all ground-launched ballistic and cruise missiles with ranges between 500 and 5,500 kilometers. However, both the United States and Russia withdrew from the treaty in 2019, each accusing the other of violaon the development of intermediate-range missile systems, potentially paving the way for the introduction of weapons like the Oreshnik.

#### Strategic implications

The deployment of the Oreshnik has significant ment considerations strategic implications. Its range enables it to target a wide array of locations across Europe and parts of Asia, extending Russia's strategic reach. The missile's hypersonic speed and maneuverability render existing missile defense systems less effective, potentially altering the strategic balance in the region.

In response to the missile launch, Ukrainian President Volodymyr Zelensky condemned the attack, labeling it a severe escalation. The United States, while acknowledging the advance notification, expressed concern over the introduction

into the conflict. NATO allies have also voiced apprehension, with some member states calling for increased defensive measures to counter potential threats posed by hypersonic missiles.

### Production and deploy-

While President Putin referred to the November 21 missile strike as a test, U.S. officials have suggested that Russia likely possesses only a limited number of these experimental missiles. However, reports from the International Institute for Strategic Studies (IISS) indicate that over the past six months. Russia has significantly expanded its capacity to produce solid-propellant rocket motors. Satellite imagery analysis suggests increased activity at multiple facilities related to the production of solid rocket fuel, indicating a potential scaling up of missile production capabilities.

#### **Development and design**

The Oreshnik missile is believed to be derived from the RS-26 Rubezh intercontinental ballistic missile (ICBM) program. The RS-26 was a modification of the Topol ICBM, intended to provide a more versatile and mobile missile system. However, development of the RS-26 was reportedly frozen in 2018 to prioritize other systems, such as the Avangard hypersonic glide vehicle. The Oreshnik appears to have revitalized aspects of the RS-26 design, incorporating modern technologies to enhance its capa-

The missile is a two-stage, solid-fueled system, allowing for rapid deployment and reduced maintenance compared to liquid-fueled counterparts. Its design enables it to carry multiple independently targetable reentry vehicles (MIRVs), each capable of being directed toward separate targets. This feature significantly increases the missile's effectiveness against dispersed or hardened targets.

#### **Capabilities**

One of the most notable features of the Oreshnik is its hypersonic speed Traveling at Mach 10, or approximately 12,350 kilometers per hour, it can reach targets swiftly, reducing the window for interception. This speed, combined with its ability to maneuver during flight, makes it a formidable challenge for existing missile defense systems.

The missile's range is estimated to be between 3,000 to 5,000 kilometers, classifying it as an intermediaterange ballistic missile. This range allows it to target a wide array of locations across Europe and parts of Asia, extending Russia's strategic reach.

#### Operational use

The Oreshnik was first used in combat on November 21, 2024, during the Russo-Ukrainian War. It targeted the PA Pivdenmash facility in Dnipro, Ukraine, marking the first combat use of an intermediaterange missile by Russia. The missile was launched from the Astrakhan Oblast, likely from the Kapustin Yar training ground. Unverified footage of the attack suggests the use of MIRV payloads, indicating the missile's capability to strike multiple targets simultaneously.

The Oreshnik missile represents a significant advancement in Russia's missile technology, combining speed, range, and versatility. Its development underscores Russia's commitment to enhancing its strategic capabilities in the face of evolving global security dynamics.

# DELHI AIR POLLUTION: SUPREME COURT EXPRESSES DISSATISFACTION WITH ENFORCEMENT OF BAN ON TRUCKS, APPOINTS 13 LAWYERS TO INSPECT ENTRY POINTS

he Supreme Court in the case appointed 13 members of the Bar as court commissioners to visit the entry points to Delhi and verify whether entry of trucks is being stopped on November 22, 2024.

The court observed that as per the GRAP-IV restrictions imposed by the Commission for Air Quality Management, the entry of trucks is prohibited to Delhi-NCR to combat air pollution.

The court in the case expressed dissatisfaction with the compliance.

The bench comprising of Justice Abhay S Oka and Justice Augustine George

Masih in the case stated that, 'So far as complaince is concerned, we are not satisfied. Government has not stated clearly as to at how many entry points there are officers present to comply with measures of STAGE IV.'

# **42 DEAD AS GUNMEN OPEN FIRE ON VEHICLE IN NORTHWESTERN PAKISTAN**

Thousands of Shiite Muslims protest on the streets in various cities of Pakistan

unmen have opened fire on convoys of Shia pilgrims in northwestern Pakistan, killing at least 42 people, according to authorities in the restive province of Khyber Pakhtunkhwa.

Women and children were among the fatalities in the attacks in the Kurram tribal district on Thursday, police said on Friday.

Sectarian violence has escalated since July in Kurram, a region bordering Afghanistan, between Shia and Sunni tribes over land disputes.

Gunmen opened fire on two separate convoys of Shia pilgrims travelling with police escorts in Kurram. No group has claimed responsibility for the attacks.

Javedullah Mehsud, the deputy commissioner of Kurram, said the attacks



took place when the convoys were on their way from the district headquarters of Parachinar to Peshawar.

Mehsud told Al Jazeera on Friday that all the bodies had been recovered and burials would be conducted later in the day.

Police said 20 people were wounded.

"We also managed to recover 26 people belonging to the Shia community last night, including women and children, who were kept hostage by Sunni groups," Mehsud said.

Ajmeer Hussain, 28, survived the attack.

"Gunfire suddenly erupted and I started reciting my prayers, thinking these were my final moments," Hussain told the AFP news agency.

"I lay down at the feet of the two passengers sitting next to me. Both of them were struck by multiple bullets and died instantly," he said.

### China expands visa-free entry for 9 more nations

China announced Friday that it would expand visafree entry to citizens of nine more countries as it seeks to boost tourism and business travel to help revive a sluggish economy. Starting Nov 30, travelers from Bulgaria, Romania, Malta, Croatia, Montenegro, North Macedonia, Estonia, Latvia, and Japan will be able to enter China for up to 30 days without a visa, Foreign Ministry spokesperson Lin lian said. That will bring to 38 the number of countries that have been granted visafree access since last year. Only three countries had visa-free access previously, and theirs had been eliminated during the COVID-19 pandemic.

The permitted length of stay for visa-free entry is being increased from the previous 15 days, Lin said,

# Aid workers death high in 2024 amid West Asia crisis

More aid workers, health care staffers, delivery personnel and other humanitarians have been killed in 2024 than in any other single year, the United Nations reported Friday.

Bloodshed in the Middle East has been the single-biggest cause of the 281 deaths among humanitarians globally this year, according to the UN Office for the Coordination of Humanitarian Affairs.

"Before the year is even

the deadliest on record for humanitarian personnel worldwide, OCHA spokesman Jens Laerke said. He told reporters in Geneva the figure surpassed the previous record of 280 deaths for the whole of last year. Humanitarians "are work-

ing courageously and selflessly in places like Gaza, Sudan, Lebanon, Ukraine and so on. They show the best humanity has to offer, and they are getting killed in return" in record numbers, he said

"These numbers will send shockwaves around the humanitarian community, especially on the front lines of the response," he added.

The UN said the figures come from the Aid Worker Security Database, a USfunded project run by a Britain-based group called

OCHA said a total of 333 humanitarians have been killed since the latest conflict between Israel and the militant Hamas group erupted when the militants stormed into southern Israel on October 7, 2023, killing

The death toll in the Gaza Strip from the 13-monthold war has surpassed 44,000, local health officials said Thursday. The Gaza Health Ministry does not distinguish between civilians and combatants in its count, but it has said that more than half of the fatalities are women and children.

Intermediate-range missiles typically have a reach of up to 5,500 kilometres (3,400 miles) -- enough to make good on Putin's threat of striking the West.

the nation, Russia's president railed at Ukraine's allies granting permission for Kyiv to use Westernsupplied weapons to strike targets on Russian territory, warning of retaliation.

# NARENDRA MODI'S HISTORIC THREE-NATION TOUR; RUSSIA LAUNCHES A BALLISTIC MISSILE ATTACK ON UKRAINE

s the G-20 Summit unfolded in Brazil and the Indian Prime Minister embarked on a diplomatic journey through Nigeria, Brazil, and Guyana, this week, Russia made headlines by launching a new intermediate-range ballistic missile at Ukraine. This action was reportedly a reaction to Ukraine's deployment of British and American missiles, which have the capability to reach deeper into Russian territory, according to statements made by President Putin. On one side, India is inspiring hope within the international community by advocating for dialogue and cooperation to address various global challenges, on the other hand, the escalating conflict between Russia and Ukraine presents a significant obstacle to achieving global peace and security, complicating efforts to foster sustainable solutions.

This week, Russia launched a new intermediate-range ballistic missile targeting Ukraine, a move attributed to Kyiv's recent deployment of American and British missiles that have the capability to reach deeper into Russian territory, as stated by President Vladimir Putin. He stated that the missile, launched this week, successfully targeted a prominent missile manufacturing facility in Dnipro. He further indicated that Russia would provide advance notifications for any future strikes using the missile against Ukraine, allowing civilians the opportunity to evacuate to safety, an approach that has not been previously adopted by Moscow during earlier aerial assaults.

lized to strike any Ukrainian ally that employs missiles to attack Russia. This development underscores the escalating tensions between the two nations and highlights the ongoing military exchanges that have characterized the conflict.

Ukrainian President Volodymyr Zelenskyy characterized the missile's deployment as a "clear and significant escalation in the scale and brutality of this war, representing a cynical breach of the UN Charter," in a post on Telegram. This escalation occurs amid a period of heightened tensions, marked by the US relaxing its restrictions on Ukraine's deployment of Americanmade long-range missiles within Russian territory, while President Putin has simultaneously reduced

the criteria for the potential

use of nuclear weapons. According to a statement from the Ukrainian air force, the attack on Dnipro originated from Russia's Astrakhan region, located by the Caspian Sea. This attack highlights the ongoing volatility in the region and highlights the psychological dimensions of the conflict, as both leaders navigate the complexities of military engagement and international diplomacy. The situation remains precarious, with both sides poised to respond to the evolving dynamics of the conflict.

While the world is shocked at this new intensification of Russia-Ukraine war, Prime Minister Narendra Modi successfully completed his three-nation tour, departing from Georgetown, Guyana, on Thursday en route to Delhi. This journey represented the concluding segment of a

significant diplomatic mission that commenced in Nigeria, proceeded to Brazil for the 19th G2O Summit, and culminated in a landmark State visit to Guyana. During the G2O summit hosted by Brazil, India emphasized the principle of 'Vadudhaiv Kutumbakam'—the idea of the world as one family-while advocating for the themes of 'one earth, one family, one future' during its presidency the previous year. On the other hand, Brazil's focus during the summit was on creating a more equitable and sustainable planet, concentrating on three primary areas: the eradication of poverty, hunger, and inequality; the promotion of sustainability across economic, social, and political dimensions: and the reform of multilateral platforms. The alignment of Brazil's objectives with India's philosophical approach was evident, as both nations underscored the importance of these critical goals in their discussions.

At the conclusion of the

G20, Brazil Leaders' Summit held on November 19 in Rio de Janeiro, in which President Luiz Inácio Lula da Silva presented a summary of the significant accomplishments achieved during Brazil's presidency of the forum. Among the notable achievements he emphasized were the establishment of the G2O Social Summit, the development of a strategic framework for enhancing the Multilateral Development Banks (MDBs), discussions surrounding Africa and its external debt, the formation of the Women's Empowerment Working Group, and the incorporation of Sustainable Development Goal 18, which focuses on ethnic-racial equality. Furthermore, President

Lula highlighted the formulation of principles related to trade and sustainable development, alongside a pledge to boost renewable energy production by the year 2023. He also commended the coalition for the local and regional production of

vaccines and medicines, as well as the initiatives aimed at fostering investments in public policies designed to enhance access to water and sanitation services.

Following his participation in a notable summit, the Prime Minister of India arrived in Guyana, marking the first visit by an Indian leader to the South American country in over half a century. During this visit, he addressed the Guyanese parliament, which represented his 14th address to a national congress worldwide. In recognition of his significant contributions to the global community, he was honoured with the highest award from the Guyanese government. This visit was particularly important as India not only entered into more than ten strategic agreements with Guyana but also enhanced its relationship with Nigeria and engaged with other nations, including Brazil, during the G-20 summit. India reaffirmed its commitment to bolstering cooperation among the Global South and contributing to global welfare, peace, economic growth, sustainable development, and effective governance. This three-nation tour highlighted India's expanding global presence, featuring crucial discussions in Nigeria, active involvement in the G2O Summit in Brazil, and the strengthening of ties with the Caribbean during this historic visit to Guyana.

During his time in Guyana, PM Modi co-chaired the second India-CARI-COM Summit, engaging with leaders from the Caribbean region to strengthen India's relations with CARICOM nations. The Prime Minister participated in various cultural and diplomatic engagements during his Guyana visit.

I always look forward to happy endings. I hope the world engages and collaborates for positive developments to accomplish global objectives.

Encountering severe ailments and ill health of anyone in the family and having instilled the fear of death by the doctors is not very uncommon. Here is a story of sheer grit and survival, which is interwoven pretty well with a father-daughter relationship that evolves after an emotionally painful divorce of the parents.

Written by Ritesh Shah and directed by Shoojit Sircar, "I Want to Talk" captures the pain and trauma, both physical and mental, undergone by patients suffering from severe ailments. Arjun Sen (Abhishek Bachchan) is living his Great American Dream, but now his married life is shattered via an ugly divorce. He can only spend Tuesdays, Thursdays, and alternate weekends with his daughter Reya (Naivedhi Pearle Dey), who sees him only in the 8th circle in her life.

He is diagnosed with Laryngeal cancer along with a few tumours, cancer through the colon and rectal parts, and is advised an immediate surgery, without which he is told that he has only 110 days left to live. Death stares in the face of this brilliant marketing man, and the threat of death keeps looming again and again and again all through the film.

Initially, Arjun is frustrated and sends Goodbye Gifts to all his friends, wellwishers, and acquaintances and plans suicide, however, his caregiver Nancy figures this out and motivates him to choose to live. While he turns around, life brings him more and more serious health issues including a heart attack, leading him to have as many as 20 surgeries.

He survives every surgery, but never tells his daughter about it and only says good-

bye to her every time he visits the hospital for any procedure. Reya keeps coming closer to her father Arjun but never has the courage or an opportunity to speak up openly. In a flash, one would see the transformation of little subdued Reya, who decides to come and be with her father for good to the grown-up Reya (Ahilya

Bamroo). The emotions of the sufferings that come in handy being a child of divorce are very well presented by Ahilya Bamroo, as good as the physical pain being made visible by Abhishek Bachchan.

Dr. Deb (Javant Kri-

palani), his doctor often manipulated by him in his fight for survival becomes a good friend more and less a doctor for him. The film shows an interesting way for Arjun to shed his fear by understanding the surgical cuts on a diagram via his surgeon, something any audience will appreciate and relate well to. And what an irony, his caregiver Nancy, who had once saved him from committing suicide, succumbs herself to suicide. Arjun's sheer grit is fabulous as he prepares himself for a Marathon even after having gone 20 surgeries, and in the course of this he shares with his daughter that he is running it for Nancy. When he is almost about to give up before the finishing line, Reya comes in and supports him by encouraging him to reach the finishing line.

Abhishek and Ahilya exhibit an excellent fatherdaughter chemistry helping you remain attached to the characters of this beautiful film based on a real-life cancer survivor, who even ativity is enhanced when makes a guest appearance on the screen just before the film ends.



Many of us think that strong emotions, the highs and lows, are all part of being alive and show that we care. Once we have experienced the real depth of feeling that lies at the core of our being; the feelings of stillness, peace, love, and a sense of joy, everything changes. This springs from the recognition that we are eternal spiritual beings – and that we will always survive whatever happens to us in the physical and emotional realms.

Once we have tasted this depth of feeling, everything changes, and we constantly want to return to that place of stillness. We begin to enjoy life without all the drama and emotional exhaustion, and the old patterns of thinking stop running our lives. This requires us

to be open and learn about ourselves and what it is that brings up, or triggers, all the emotional reactions. Even well into the journey of spiritual awakening, we can be travelling along quite well and then suddenly, a strong emotion is triggered. This is an excellent opportunity to have a close look at what is really going on.

The spiritual journey is a little like the transformation of a caterpillar into a butterfly.

First of all, we need to consume more and more spiritual knowledge. The most important understanding is that I am a being of light, having a human experience. # Three keys to inner calmness

It must be obvious to most, that life has become complicated, noisy and full of more information that we can take in. It should be clear then, that a state of calmness will not be found out there - but needs to come from within. It is our inner calmness that refreshes us and helps us to enjoy each moment. Even though a

state of peace is a quality that is intrinsic to the soul, we need some practical help to rediscover that. There are three keys that may help us unlock that inner state of peace and calm. The first key is - recog-

**nise** that peacelessness is of the mind. I am the creator of my thoughts – not the victim. It is a very simple thing to understand but it is in realisation that we are then able to re-educate our own minds to think in a more peaceful way. We have to observe the self and the thoughts we have. Habits of criticising, analysing, and judging play out automatically in our minds, and we can learn how to change these habits. Meditation, of course, is a key practise to focus and train our mind. It is one of the ways, but we also need to take hold of the

reins of the mind and learn how to guide the mind, and change the direction it is taking. We need to slow down during the day and even stop completely for a few seconds. A very useful practice, and something we can do anytime during the day, is simply say to the mind - 'stop'! Then we can do this simple exercise - As we breath we can inhale with the thought, 'peace', and then exhale, and think 'silence'. Our thoughts immediately slow down.

The second key is - address the source of agitation - find out where the peacelessness is coming from. The two main sources are attachments and desires. Those desires that concern the outer world, based on the idea that the desires will make me internally fulfilled, will always cause agitation.



Distancing the self from the 'noise' of the mind brings deep inner calm.

For example, engaging sensual pleasures, or trying to gain emotional satisfaction through recognition, praise, appreciation - these desires will fill the mind with peacelessness, depending on how strong the desire is. Living a simpler life, while counterproductive for the consumerist society, brings a sense of calm, because we

have fewer desires. **The third key** is - inner strength and power. This comes from deep meditation. Through connecting with the deeper spiritual self that I am, and my innate inner qualities, I become deeply peaceful. We also need to connect to the source of all spiritual power and strength, the Supreme Soul. To be able to open the mind to the stream of that supreme spiritual energy and power, gives us the capacity to practice the first two keys with success.

It is the power of silence that can be achieved by deep meditation, distancing the self from the 'noise' of the mind, that brings deep inner calm. Silence does not mean a blank mind but in meditation, all the noise of mundane external thoughts is discarded and the focus is on very powerful, elevated, spiritual thoughts that nurture the inner self. For example, the thought that 'I am a spiritual being of light and peace', is a thought for contemplation, not for analysis but for experiencing, and experiencing this brings powerful inner calm.

# Navigating menstrual stigma: Is menstrual leave really required for the new age workforce



As the healthcare ecosystem and awareness for women health expands, new policies for women are taking shape across workspaces. One of the most debatable policy is the period leave which has garnered mix opinions. While some agree to offer period leaves, some disregard it from the productivity lens. Largely, the sole purpose of menstrual leave is to allow a person to take time from work when period symptoms make it impossible to complete job tasks. Pelvic pain can be severe for some people and have an impact on their productivity at work. As per multiple research analysis, significant discomfort prohibits 5-20% of menstruators from performing

work-related activities, reducing their productivity significantly. Taking a day or two off work during one's menstrual period may help them recuperate physically and emotionally during a period of reduced productivity at work. Menstrual leave can provide time for recovery, but it also has the potential to reinforce sexist views and contribute to menstrual stigma.

#### **MENSTRUAL STIGMA** & WORKPLACE

DISCRIMINATION: Discussions regarding menstruation in the workplace contradict cultural norms that encourage nondisclosure. As a result, some people believe that increased transparency may exacerbate stigma rather than eliminate it. Menstruation is often a private topic, so some people may object to non-private references to it in the workplace. If someone wishes to take menstrual leave, they must at the very least notify their manager that they are menstruating. They may be uncomfortable with this admission, which could result



in implicit, if not outright, discrimination.

stand that menstrual health and hygiene are improving in India. It has reached the point where the debate is largely on menstrual hygiene, sustainable quality products and accessibility. Workplaces can potentially compensate for menstrual leave needs by improving infrastructure and management tools in the workplace and public spaces.

**IDENTIFYING HEALTH ISSUES VIA PERIODS:** While periods are generally painful, the severity varies from person to person, subject to their eating habits, health measures etc. Painless periods are an indicator of a woman's overall health: if the woman expe-

riences pain during every menstrual cycle, she should It is important to under-check her iron, calcium, or overall health. In the long run, the ignorance can lead to health-related issues. Menstrual pain is caused by a variety of factors that must be addressed by medical professionals as and when required.

# SIDE EFFECT OF

**MENSTRUAL LEAVE:** Menstrual leave is likely to violate women's reproductive health privacy and may lead to workplace harassment. This will result in inappropriate debate and harassment during menstruation leave by other staff. Furthermore, having periods twice a month might have a negative impact on a woman's mental health at work.

#### **DEEPAK HOODA'S BOWLING ACTION UNDER SCRUTINY**

In a surprising development ahead of the auction, Indian all-rounder Deepak Hooda has been placed on the Board of Control for Cricket in India's (BCCI) suspected bowlers' list due to concerns over his bowling action. This inclusion raises the possibility of Hooda facing a ban from bowling in future matches. According to a report by

Cricbuzz, Hooda, along with Saurabh Dubey and KC Cariappa, has been flagged by the BCCI for potentially illegal bowling actions. The report states: "Manish Pandey (KSCA, 157) and Shrijith Krishnan (KSCA, 281) have been banned from bowling while Deepak Hooda, an off-spinner from Rajasthan Cricket Association (RCA), is in the suspect bowling list. Saurabh Dubey (344, VCA) and KC Cariappa (381, CAM)

are also in the suspect list." Hooda, who represented the Lucknow Super Giants (LSG) in the IPL 2024 season, was released by the franchise ahead of the upcoming auction. His perfor-



mance in the previous season was modest, scoring 145 runs in 11 matches without claiming any wickets.
