he last rites of former Prime Minister Manmohan Singh are to be performed at the Nigambodh Ghat in the national capital on Saturday afternoon.

"Dr Manmohan Singh, former Prime Minister passed away at 9.51 PM on December 26, 2024 at AllMS Hospital, New Delhi. It has been decided by the Government that State funeral will be accorded to Dr Manmohan Singh. The funeral will take place at 11:45 AM on December 28, 2024 at Nigambodh Ghat, New Delhi. The Ministry of Defence is requested to make arrangements for State funeral will full military honours," the Ministry of Home Affairs stated.

Manmohan Singh passed away at AIIMS, Delhi, on Thursday evening at the age of 92 due to age-related medical conditions. He had a sudden loss of consciousness at home after which he was rushed to the AIIMS Delhi.

Eight dead in Bathinda bus crash Condolences to those who

Eight people lost their lives on Friday when a bus plunged off a bridge without railings into a nullah amid heavy rainfall. The tragic accident occurred on the route from Talwandi Sabo to Bathinda. The vehicle was carrying over 20 passengers. Local residents, police, and administrative teams swiftly reached the site to carry out rescue operations. The injured passengers were

rushed to the hospital for treatment.

Officials confirmed the fatalities and stated that investigations are underway to determine if the heavy rain contributed to the driver losing control of the bus. Concerns have been raised about the lack of railings on the bridge, which might have prevented the accident. Prime Minister Narendra Modi expressed grief over the incident. Favourable weather conditions, including continuous rainfall, have brought the Air Quality Index (AQI) down to 334 as of 7 PM on December 27.

"Delhi's air quality has shifted from the 'severe' category to the 'poor' range. As a result, measures under Stage III, implemented earlier, are now being with-

China plans world's biggest dam on Brahmaputra river in Tibet

AGENCIES BEIJING

China on Friday defended its plan to build the world's largest dam on the Brahmaputra River in Tibet, saying the project will not "negatively affect" lower riparian states and that safety issues have been addressed through decades of studies. Chinese Foreign Ministry spokesperson Mao Ning played down apprehensions about the massive project to dam the Brahmaputra River, which is called Yarlung Zangbo in Tibet. The project estimated to cost around USD 137 billion is located in the ecologically fragile Himalayan region, along a tectonic plate boundary where earthquakes occur

frequently. Mao said China carried out in-depth studies for decades and took safeguard measures.

China has always been responsible for the development of cross-border rivers, Mao told a media briefing here in response to a question on the concerns related to the dam.

ormer Prime Minister Manmohan Singh's remarkable political journey took him to Assam, which unexpectedly became his second home. As a Congress Rajya Sabha member from Assam, he started as an 'outsider' but came to be the northeastern state's very own prime minister.

In 1991, when then Prime Minister PV Narasimha Rao chose him as his finance minister, Manmohan Singh became a Rajya Sabha member from Assam, which was ruled by a Congress government at the time. House no. 3989, Nandan Nagar, Sarumtria, Guwahati, remained his address until his fifth Rajya Sabha term ended in 2019. After that, he was nominated from Rajasthan until he retired earlier this year.



The 84-year-old went on to share interesting anecdotes on the former prime minister, who died at 92 on Thursday evening. For one, she revealed, he was particular about rent payments. "He always used to pay the rent in time and by cheques. Once, when he was prime

minister, he sent the rent by cheque but we forgot to encash it, so he wrote a letter and attached a fresh cheque, asking us to encash immediately. Even as a prime minister he was diligent as a tenant. There are a lot of things for politicians of this generation to learn from Dr Singh," Ms Saikia further remarked.



The dam will be built at a huge gorge in the Himalavan reaches where the Brahmaputra River makes a huge U-turn to flow into Arunachal Pradesh and then to Bangladesh.

A dissent note signed by members Mithuraj Dhusiya, Biswajit Mohanty, and another representative

highlighted concerns over the outcomes of dissertation writing, academic projects, and entrepreneurship under the fourth year of the Undergraduate Curriculum Framework 2022 (UGCF 2022). They argued that inadequate infrastructure, insufficient time for self-study, and the absence of a minimum CGPA requirement for entry into the fourth year would make achieving these outcomes nearly impossible. At the beginning of the meeting, members observed two minutes of silence to pay tribute to former Prime Minister Dr Manmohan Singh.

In a significant administrative move, the Vice-Chancellor directed all college principals to resolve pending faculty promotion cases by February 28, 2025, through their respective Internal Quality Assurance Cells (IQACs). Colleges unable to meet the deadline will require explicit approval from the Vice-Chancellor for extensions.

he Reserve Bank of India (RBI) has highlighted the need for Non-Banking Financial Companies (NBFCs) to diversify their sources of funding as a key risk mitigation strategy.

In its latest report, the RBI noted that while the dependency of NBFCs on banks has moderated slightly, it remains significantly high.

It said "The dependence of NBFCs on banks remain high, notwithstanding some moderation; NBFCs need to further diversify their sources of funds as a risk mitigation strategy".

The report emphasized that NBFCs must broaden their funding sources to reduce concentration risks. It also pointed out that the sector faces emerging chal-



DR. MANMOHAN SINGH

PERSPECTIVE

A PERSONAL TRIBUTE TO THE GENTLE MANMOHAN SINGH, THE DESIGNATED SURVIVOR OF CONGRESS POLITICS Dr Manmohan Singh would go down in history as a great

visionary and the architect of Liberalization, who besides being a distinguished academic was also a pragmatic

leader familiar with the circumstances of his times. There

are a number of accounts which would put him on top as an economist and a reformer and some would rate his navigation of the Indo-US nuclear treaty as one of the highlights of his glorious innings. However, he was a designated survivor, who managed to retain his position and cool despite the most diabolic political maneuvers by some of his erstwhile colleagues. He was a humble man who empathized with the ground level reality and his story is about a person who had very modest beginnings before being pushed to a fame which made him a household name both in India and abroad. There are many untold stories concerning him and it would be worthwhile to recall some of them. The general belief is that he was picked up by Sonia Gandhi to be the Prime Minister in 2004 after she decided to withdraw herself from the race on account of multiple reasons, the security concerns of her children, being one of them. The fact is that when the Atal Behari Vajpayee government was toppled by one vote on the floor of the House in 1999, and Sonia was shown on the TV screens stating ``that we have the numbers, 272" to form the government following her visit to the Rashtrapati Bhawan, she had recommended his name for the Prime Minister's post to President KR Narayanan. It was a closely guarded secret. Madhav Rao Scindia, who was considered close to the then Congress president had figured that he would be the obvious choice and when he somehow learnt that it was Manmohan Singh, who was the preferred choice, he was very upset. He summoned his close friend Amar Singh and asked him to convince Mulayam Singh Yaday, to withdraw the Samajwadi Party from the proposed alliance. Rest is history and the Congress was unable to lead the formation of an alternative government leading to elections which brought back Vajpayee. What transpired during the elections which followed in 1999 had also a story which is not there in public domain. Manmohan Singh was granted the nomination from South Delhi and it was a foregone conclusion that he would win by defeating Vijay Kumar Malhotra of the BJP. However, certain Congress leaders in order to prevent him from entering the Lok Sabha, ensured that he was defeated. While covering the polls, I had predicted that Manmohan Singh would lose, though no one believed me including my colleagues in the Hindustan Times, since I could see the sabotage of his election by Congressmen themselves. Sonia Gandhi who was aware of what was happening was unforgiving and was determined to deal with the saboteurs.

In 2004, after she declined the post, there were multiple aspirants including Pranab Mukherjee, Arjun Singh, ND Tewari and P. Chidambaram. However, Sonia Gandhi had made up her mind and was not bothered about what others in the party thought of the decision. She first released a letter declining the position and then opted for Dr Manmohan Singh. The letter was drafted by my former Editor Vir Sanghvi who was on a vacation to either Thailand or Singapore and was contacted by me after receiving a call from Ten Janpath. First Madhavan and later Ambika Soni called me to trace Vir and get the draft, which finally arrived and was sent to a specific email at 10 Janpath from Vir's of fice. Sonia had wanted Singh to be elected as the leader of the Congress Parliamentary Party but on the insistence of Makhan Lal Fotedar, she first allowed herself to be chosen, and after being empowered by the CPP, nominated Manmohan Singh for the post. Several attempts by Congressmen to dislodge Manmohan Singh did not succeed and the closest was when in 2006 during the Congress Chief Minister's conclave in Nainital, a move was initiated to make Pranab Mukherjee as the deputy PM. Ms Gandhi's political adviser Ahmed Patel was privy to this and the plan would have been silently executed. However, at the press conference which marked the culmination of the conclave, I had asked Manmohan Singh whether he was in the process of appointing a deputy PM. Before he could answer, Sonia Gandhi sitting next to him, took the mike and categorically stated that this was never going to happen, thus putting to rest all speculation over the matter. Manmohan Singh survived and also ensured that his government did not fall when there was voting on the Indo-US nuclear treaty. During the 2009 Lok Sabha polls, LK Advani, the BJP prime ministerial face, ridiculed Manmohan Singh by describing him as the ``Nikamma PM" (useless PM). This boomeranged on the Saffron Brigade and the middle classes, which held Singh in high esteem, voted for the Congress instead of the BJP. This resulted in the Congress winning in most Urban areas including Mumbai and Delhi. The tally went up from 145 in 2004 to 205 in 2009, an increase of 60 seats. Sycophants tried to give the credit for the Congress performance to Rahul Gandhi but the reality was that this was due to Dr Manmohan Singh. Political intrigue had already commenced in the Congress and an effort was on to dislodge him from his chair. The 2G scam and the controversial report of the then CAG, Vinod Rai, followed. And it was evident that a section of the party wanted to force Singh to quit so a new PM could take over. Fortunately, these designs never succeeded and instead unfortunately for his rivals, the entire game resulted in the Congress losing power at the Centre. In people's perception, the Congress was seen as corrupt but not Manmohan Singh, who politically managed to personally survive.

His pro-China stance was solidified further when his party secured a parliamentary majority in

April 2024.

In Taiwan, elections in January saw Vice President William Lai of the Democratic Progressive Party (DPP) emerge victorious, despite increasing pressure from China. Beijing's growing military and political tactics aimed at asserting its claim over Taiwan loomed large over the election, as the island's future sovereignty remained uncertain.

DELHI HIGH COURT BARS NON-ADVOCATES FROM APPEARING BEFORE CONSUMER COURTS

he Delhi High Court in the case Anuj Kumar Chauhan And Anr Versus Lieutenant Governor NCT Of Delhi And Ors observed and has barred the practise of permitting non-Advocates or agents to appear before the Consumer Courts here on the basis of authority letters issued by lawyers, with immediate effect.

The bench headed by Justice Sanjeev Narula directed all Consumer Commissions in Delhi to ensure that the parties are represented by Advocates or by the agents or representatives or non-advocates strictly in terms of the Consumer Protection

(Procedure for Regulation of Allowing Appearance of Agents or Representatives or Non-Advocates or Voluntary Organizations before the Consumer Forum), Regulations, 2014. However, the regulations permits parties to be represented through non-Advocates or Agents or **Representatives or Social** Organizations in an individual complaint case, appeal or revision. This being subject to a duly authenticated authorisation made by a party in their favour. The court in the case stated that, 'This practise of permitting non-Advocates or agents to appear on the

He prays before the court to direct the MoRTH to issue a comprehensive legal mandate to all ride-hailing service providers, directing them to adopt accessible service standards in line

with the RPwD Act and other relevant laws, including specific provisions on accessible vehicles, driver training and app accessibility with a suitable grievance redressal mechanism. The bench headed by Justice Sanjeev Narula in the case observed and has issued notices to Uber and MoRTH and asked them to file counter affidavits. However, it asked Uber to provide a specific response to the grounds raised by

the petitioner that it must ensure certain accessibility features on its platforms.

Further, it asked the MoRTH to respond to the petitioner's contention that the advisory issued by it 'Advisory for Licensing, Compliance and Liability of On-demand Information Technology based Transportation Aggregator' is silent on certain aspects. Therefore, these include specifications pertaining to the technical and physical accessibility features, a mandate for regular and comprehensive training and sensitization for drivers and specific steps for timely redressal and accountability.

The bench headed by Justice Ajit Kumar in the case held that revision is to be treated as an appeal where remedy of appeal is not specifically available

District and Sessions Judge it is expected that he would not only apply his judicial mind to issues raised but also be dealing with the arguments advanced on behalf of the respective parties very meticulously to arrive at findings which would be reflecting a sound judicial approach of a varied and wide experience of such a

The court in the case observed that the judge was bound to adjudicate on the lis, which was not done.

C yria's new authorities on Thursday Vlaunched a security crackdown in a coastal region where 14 policemen were killed a day before, vowing to pursue "remnants" of the ousted Bashar al-Assad government accused of the attack, state media reported.

The violence in Tartous province, part of the coastal region that is home to many members of Assad's Alawite sect, has marked the deadliest challenge yet to the Sunni Islamist-led authorities which swept him from power on Dec. 8.

Members of the Alawite minority, an offshoot of Shi'ite Islam, wielded huge sway in Assad-led Syria, dominating security forces he used against his opponents during the 13-yearlong civil war, and to crush dissent during decades of bloody oppression by his police state.

The security forces launched the Tartous operation to "control security, stability, and civil peace, and to pursue the remnants of Assad's militias in the woods and hills", state news sites.

Israel claims it has killed 5 terrorists posing as journos

The Israel Defence Forces on Thursday claimed they killed Islamic Jihad terrorists posing as journalists.

The IDF stated that they found a key source, which was a list of Islamic Jihad operatives discovered during operations in Gaza.

In a post on X, the IDF said, "Overnight, with the direction of IDF and ISA intelligence, the IAF conducted a precise strike on an Islamic Jihad terrorist cell inside of a vehicle in the area of Nuseirat. A number of Islamic Jihad terrorists were eliminated in the strike. Intelligence from multiple sources confirmed that these individuals were Islamic Jihad operatives posing as journalists. One key source was a list of Islamic Jihad operatives discovered by the IDF during operations in Gaza. This list explicitly identified four of the eliminated individuals as members of the Islamic Iihad terrorist organization." A day earlier, CNN reported, citing a hospital and their news outlet statement

that five journalists were killed in an Israeli strike that hit their vehicle in Gaza.

According to the hospital, the vehicle, belonging to Al-Quds Today Television, was parked outside Al-Awda Hospital when it was hit. The television channel, based in Gaza, is affiliated with the Palestine Islamic Jihad group.

Other journalists at the spot said Ayman Al-Jadi, Faisal Abu Al-Qumsan, Mohammed Al-Lada'a, Ibrahim Al-Sheikh Ali, and Fadi Hassouna were all sleeping in the vehicle when the strike hit, the report said.

Footage of the aftermath showed the vehicles in flames with the words "TV" and "PRESS" in large alphabets visible on the backdoors. Another video seen showed that it completely

engulfed by flames, CNN reported.

Al-Quds Today Television condemned the attack and said that the five people were killed "while performing their journalistic and humanitarian duty."

In a statement, the Israeli military said it conducted strike on what it called an "Islamic Jihad terrorist cell inside in the area of Nuseirat." However, it did not provide any proof for its allegations.

The Committee to Protect Journalists (CPJ), a USbased non-profit group, has said at least 141 journalists and media workers have been killed in Gaza, Israel, the West Bank and Lebanon since October 7 last year. "making it the deadliest period for journalists since CPJ began gathering data in 1992."



Narendra Modi visited the US for the Quad Leaders' Summit, where he addressed the Indian American community and delivered a significant address at the UN's 'Summit

and introduced the Quad Cancer Moonshot initiative, focusing on cervical cancer in the Indo-Pacific region. Modi also engaged in discussions with Nepali Prime Minister, Ukrainian President Zelenskyy, Armenian Prime Minister Nikol Pashinyan, and Vietnamese President.

In the month of October, Narendra Modi visited Laos to participate in the India-ASEAN and East Asia summits. Modi highlighted the importance of India-ASEAN relations and the 10th anniversary of India's Act East Policy. India-Canada relations strained due to Canadian Prime Minister Trudeau's political ambitions. India recalled its High Commissioner from Canada and accused Trudeau of allowing violent extremists to target Indian diplomats and community leaders. India made a significant impact on global politics by setting the roadmap for the future of the BRICS alliance in Kazan, Russia. The summit, attended by representatives from 36 countries, aimed to counter Western-centric global frameworks and promote sustainable development. In the month of November, India and China successfully completed the disengagement process in the Depsang and Demchok areas of Eastern Ladakh, with patrolling set to commence shortly. 



WHEN EMPOWERMENT TURNS TO ENTITLEMENT: **EXPLORING MISUSE OF WOMEN'S RIGHTS**

judge friend of mine who sits on Adowry cases told me some ten years back-"I feel sorry for Indian men who are often the victim of dowry cases." I was quite surprised at her statement but she opened another dimension to this law. And pointed out how women are weaponizing legal provisions and leveraging protective laws as tools for extortion or harassment.

Section 498A IPC was meant to be a "shield" and not a "weapon" protecting the rights of women. However, over time, there have been instances of this provision being misused. The Supreme Court of India has acknowledged this issue, emphasizing the need for caution to prevent unnecessary harassment of innocent individuals.

WOMEN

The recent demise of Atul Subhash underscores the complexities surrounding the misuse of protective legal provisions. Atul Subhash was found dead in his Bengaluru apartment on December 9, 2024. He left behind a 24-page suicide note and a 90-minute video alleging harassment by his estranged wife, Nikita Singhania, and her family. Subhash claimed that false cases, including those under Section 498A, were filed against him, accompanied by demands for substantial financial settlements. The deceased techie alleged that his estranged wife and her



family falsely implicated him under these laws, leading to severe mental trauma, ultimately driving him to take his own life. His suicide note and video brings attention to the devastating effects of such misuse, not just on individuals but also on the credibility of protective legal frameworks.

With every right comes a whole lot of responsibility. We must spend a minute to examine this issue and call out the bluff where women are abusing these rights. Yes, there have been reported cases in India where Section 498A of the Indian Penal Code (IPC), which is intended to protect women from cruelty by

their husband or relatives (often related to dowry demands), has been misused. In Preeti Gupta vs State of Iharkhand (2010), the Supreme Court acknowledged the misuse of Section 498A, stating that frivolous complaints can lead to harassment of innocent family members, including elderly parents and even distant relatives. In Arnesh Kumar vs State of Bihar (2014), the Supreme Court issued guidelines to prevent the automatic arrest of individuals in cases filed under Section 498A after realizing that the law was being used as a weapon rather than a shield. In Ramgopal vs State of Madhya Pradesh (2020), the court noted that false complaints under Section 498A often stem from marital discord unrelated to dowry demands, leading to harassment of the husband and his family. My friend who is a Judge shared with me how many times women opt for aggressive legal action instead of seeking reconciliation or amicable solutions, even when disputes are minor. In child custody cases, there are instances where mothers have manipulated the legal framework to alienate the father from the child, often leveraging false abuse allegations. And the worst of the lot is sexual harassment laws where the crime cannot be proved. These harassment laws are sometimes weaponized at workplace and domestic situations to settle professional rivalries or personal scores.

Anybody can be a victim of harassment, emotional abuse, or legal manipulation. It is essential to ensure that men are not unfairly vilified or victimized. True progress comes when society supports all victims of injustice and justice needs to be gender-neutral. Feminism is all about fairness, where both men and women are protected from false accusations and abuse. After all feminism at its core is not a battle of sexes, but a fight against injustice.

The alarming spike in air pollution and smog blanketing Delhi is not just a visible haze, but a silent threat to the children's health. As particulate matter (pm) toxic gases from vehicle emissions and industrial activities accumulate in the air, there's a disturbing rise in respiratory illnesses and skin problems among children.



"The air pollution and smog engulfing Delhi is wreaking havoc on the child's health, by raising the risk of respiratory and skin ailments. Viral infections like RSV, influenza, and pneumonia are rampant, manifesting as runny noses, persistent coughs, and fevers in children aged 6-13. Allergy-related issues are skyrocketing, affecting both the skin and respiratory systems. Most concerning is the spikes in asthma exacerbations, leaving children gasping for breath. Children are complaining of decreased appetite, incessant sneezing, body aches, cough with phlegm, fatigue, and sore throats. Skin problems include dry skin, rashes, and allergies that will also require timely intervention. While the recent school closures have slightly decreased the number of cases, we're still treating 2-3 patients daily for these conditions," said Dr Sanjay Wazir, Medical Director (NCR)- Neonatology and Paediatrics, Motherhood Hospitals, Gurgaon Dr Sanjay added, "It is essential for parents to follow the treatment plan recommended by the doctor, avoid self-medication, ensure their children practice good hygiene, maintain a balanced diet rich in vitamins, and

get adequate sleep. Likewise, regular hand washing, wearing masks in crowded places, and keeping children home when they show symptoms are crucial preventive measures. Moreover, children should avoid crowded places, and being around sick people. Parents should stick to the vaccination schedule by giving the child pneumococcal and influenza vaccines and opt for air purifiers at home to help children breathe freely. Those children with pre-existing asthma should keep the medication and inhaler handy. In case of skin problems, it is essential to use doctor-approved products. Children should stay indoors when the air quality outside is poor."



Spiritual teachings assert that purity is one of the greatest powers one can have. What does this mean?

Power is generally understood as the ability to exert control over others or shape circumstances according to one's will. Such power is typically derived from sources such as wealth, status, political or social influence, or physical strength. Those who possess this power tend to have more security, success, and recognition. They can influence societies, corporations, and governments. Purity does not figure anywhere in this picture, so how

does it count as a power? Purity is a spiritual quality and it operates subtly, so it is not easily recognised as a power. Complete purity includes pure intentions, feelings, thoughts, and actions. When there is such purity, our behaviour is informed by it.

A pure mind is free from the influence of weaknesses such as greed, ego, anger, and selfishness. Decisions

taken by one with a pure mind would, therefore, not be tainted by any of these flaws: they will be reasonable, and not meant to harm anyone's interests. There are situations where people must compromise and give up or share resources or privileges in the best interest of everyone. But if the motive is pure, it fosters trust, and there is willingness to cooperate and collaborate. It is in the absence of purity that problems arise. If someone's intentions are suspect, others do not trust them, and are unwilling to cooperate. This creates ten-

sion in relationships which,

AUSTRALIA IN COMMANDING POSITION AT MELBOURNE

A comeback spell from pacer Scott Boland put a screeching halt to India's rebuilding efforts by Yashasvi Jaiswal and Virat Kohli as the visitors were left five wickets down at the end of the second day's play of fourth Test against Australia at Melbourne Cricket Ground (MCG) on Friday.

At the end of the day's play, India stood at 164/5, with Ravindra Jadeja (6*) and Rishabh Pant (4*) unbeaten at the crease, facing a mounting task of trailing 310 runs.

India started the final session at 51/2, with Yashasvi Jaiswal (23*) being joined by Virat Kohli.

Jaiswal and Virat started to build a partnership, reaching the 100-run mark in 28.5 overs, thanks to a cracking boundary from Jaiswal.

Jaiswal reached his halfcentury, his ninth in Tests, in 81 balls, with seven fours.

Jaiswal upped the scoring rate after reaching his halfcentury and even Virat was looking in nice touch.

The century stand between the duo ended with a horrible mixup leading to Jaiswal being run out for 82 in 118 balls, with 11 fours and a six. India was 153/3 in 41 overs.

After that. India lost two quick wickets, with Virat falling to Scott Boland for 36 in 86 balls, with four boundaries. Once again the outside off-stump ball came into effect. Akash Deep, who came as a nightwatchman, was also dismissed for a duck, leaving India reeling at 159/5 in 44.3 overs.

Bumrah bowls his most expensive spell of Test career

In a rare bad day at work, Indian pace spearhead Jasprit Bumrah delivered the most expensive over of his Test career during the second day of the fourth Test against Australia at Melbourne Cricket Ground (MCG) on Friday.

During the match, Bumrah, known for his pin-point yorkers and troubling line and lengths, was dominated like never seen before by Aussie batters. It all started with the debutant 19-year-old Sam Konstas playing some audacious shots, including a reverse ramp against Bumrah. Perhaps it was the surprise element that led to Bumrah conceding sixes against Konstas, for the first time ever after over 4,400 balls and since 2021.



But the rest of the Australian batting line-up took some notes from Konstas' carnage and a total of four sixes were hit against Bumrah, including one each by Steve Smith and Mitchell Starc. He ended with four wickets for 99 runs in 28.4 overs, his most expensive spell in terms of runs. His economy rate was 3.45. His previous most expen-

sive spell in terms of runs was against New Zealand in February 2020 at Wellington, where he took 1/88 in 26.5 overs at an economy rate of 3.38.


