# **BADAL ESCAPES BID ON** LIFE AT GOLDEN TEMPLE

Narain Singh Chaura, a former terrorist, fires at former Deputy CM performing sewadar's duty

🦳 hiromani Akali Dal leader Sukhbir Singh Badal escaped a bid on his life on Wednesday when a former Khalistani terrorist fired from a close range at Punjab's ex deputy chief minister at the Golden Temple's entrance here but missed as plainclothes policemen overpowered him.

The audacious attack, which occurred at around 9:30 am, was captured on cameras by media persons who had gathered to cover the second day of Badal performing the duty of 'sewadar' at the main gate of the Sikh shrine as religious penance for "mistakes" committed by the SAD government in Punjab from 2007 to 2017.

As other devotees were entering, the shooter, identified as former terrorist ly walked towards Badal (62), a Z+ protectee who was sitting in a wheelchair due to a fractured leg, and pulled out a gun from his pocket.

# Fadnavis to take oath as Maha CM today

Ajit Pawar Deputy CM; no clarity on Shinde

Devendra Fadnavis is set to be sworn-in as the new Chief Minister of Maharashtra on Thursday at a grand ceremony in Azad Maidan here, with Prime Minister Narendra Modi in attendance.

In addition to Fadnavis, two deputy chief ministers, including NCP leader Ajit Pawar, will also take their oaths during the event in south Mumbai.

While the formation of the government under Fadnavis is confirmed, uncertainty remains regarding whether outgoing chief minister Eknath Shinde will be included in the new ministry.

Fadnavis, 54, emerged as the frontrunner for the coveted post following the

BJP's strong showing in the recent assembly elections, securing 132 seats in the 288-member house.

On Wednesday, Fadnavis, joined by Shinde and Pawar, met with state Governor CP Radhakrishnan to formally stake claim to form the government, presenting letters of support from coalition partners, including the Shiv Sena and the NCP.

Following this meeting, the governor extended an invitation for Fadnavis to lead the new government.

This is for the third time that the BJP leader, an MLA from Nagpur, will be swornin as chief minister of Maharashtra.

Fadnavis expressed his hope for Shinde's participation, stating he had requested that Shinde join the government. However, Shinde indicated that updates on his role would be provided to the media later on Wednesday.



### **71,231 NEW POSTS** CREATED IN CAPFS, **RS INFORMED**

NEW DELHI: Union Minister for state Home Affairs Nityanand Rai on Wednesday informed Rajya Sabha in a written reply that 71,231 new posts have been created in Central Armed Police Forces (CAPFs) & Assam Rifles (AR) in the last five years from 2020 to 2024. MoS Home Nityanand Rai in a written reply informed Rajya Sabha that there are 100,204 vacancies in Central Armed Police Forces (CAPF) & Assam Rifles (AR) as on October 30, 2024 Minister Rai stated that 3,377 vacancies in Assam Rifles, 12,808 vacancies in BSF, CISF 31782 vacancies, CRPF 33,730 Vacancies, 9,861 vacancies in ITBP, 8,646 vacancies in SSB are available.

### 75 PROJECTS IN **MAJOR PORTS AWARDED**

**NEW DELHI:** Union Minister of Ports, Shipping, and Waterways, Sarbananda Sonowal on Tuesday informed the Parliament that the government has awarded around 75 port development projects in major ports in the last three years. Under the Maritime India Vision (MIV) 2030, the number of major port capacity increased from 1598 MMTPA in Financial Year 2022 to 1630 MMTPA in Financial Year 2024, Sonowal said in a written reply to Rajya Sabha.

### 730 SUICIDES AMONG CAPFs, NSG **AND ASSAM RIFLES**

**NEW DELHI: Union** Minister of state or Home Affairs. Nityanand Rai on Wednesday informed the Rajya Sabha in a written reply that there have been 730 suicides amongst Central Armed Police Forces (CAPFs), National Security Guard (NSG) and Assam Rifles (AR) from 2020 to 2024. MoS Home Nityanand informed the Upper House that there have been 47891 Voluntary Retirement, 7664 Resignation and 730 suicides amongst the security forces from 2020 to 2024. Rai further said in a written reply that generally, "the working hours in the Central Armed Police Forces are 8 hours shifts.

### SPEAKER CAUTIONS **AGAINST PROTESTS AT ENTRY GATE**

# Opposition not divided on floor of 'Peace at border areas vital for India-China ties' Parliament: Derek O'Brien

Opposition parties are united in their strategy to corner the BJP in Parliament, but they have different tactics, Trinamool Congress Parliamentary Party leader in Rajya Sabha Derek O'Brien said on Wednesday.

O'Brien's remarks came amid speculations over rift in the INDIA bloc after the TMC kept away from the protest on the Adani issue held in Parliament complex by the Congress and other opposition parties.

"The opposition is united, not divided on the floor of Parliament," O'Brien told reporters.

"We are united in Parliament on the strategy to corner the BJP, different par-



ties use different tactics,"

O'Brien added that every party wants to raise their issues in Parliament.

The TMC has maintained since the beginning of the session that they want Parliament to function and have kept away from the Congress' demand for a Joint Parliamentary Committee (IPC) probe into allegations of bribery against industrialist Gautam Adani.

Explaining the party's

stand on the issue of JPC in a blogpost on Tuesday, O'Brien had said the JPC was bound to be dominated by the ruling party MPs.

"A JPC only looks good on paper. Its very structure and track record suggests that it is most unlikely to deliver meaningful results, especially when the ruling dispensation enjoys a dominant majority in Parliament,"

O'Brien said in his blogpost. The TMC has said it will raise "people's issues" in Parliament, which include the issue of deprivation of central funds to West Bengal, Manipur crisis, and Aparajita Bill passed by the West Bengal Assembly, along with issues like inflation, unemployment and fertilizer shortage.

External Affairs Minister S Jaishankar briefed the Lok Sabha on the disengagement updates in Eastern Ladakh and the improvement of border infrastructure along the India-China border, as part of his statement regarding 'recent developments in India's relations with China'.

EAM Jaishankar said, "Through you I would like to inform the House, that disengagement has now been achieved in full in Eastern Ladakh through a step-bystep process, culminating in Depsang and Demchok. With the task of disengagement completed, it is now our expectation that discussions would commence in regard to the remaining issues that we had placed on the agenda".

He brought to attention the previous positions articulated by the Government of India in the Parliament earlier on this issue.

"On 15 September 2020, Raksha Mantri ji made a detailed statement on Chinese attempts to transgress the LAC and the appropriate response given by our armed forces. On 11 February 2021, Raksha Mantri ji again briefed the House about our disengagement agreement on the North and South banks of the Pangong Lake. Thereafter, in August

the area of Gogra, whereby troops would henceforth be in their respective bases. The next step took place in September 2022, pertaining to the Hot Springs area. Again, forward deployments ceased in a phased, coordinated and verified manner, resulting in the return of troops to their respective areas. The most recent October 21, 2024 agreement comes in the wake of the earlier ones. It completes the first phase of what we had agreed to in Moscow in September 2020', EAM Jaishankar explained. Jaishankar said, "There is a long history of frictions, transgressions and faceoffs in several sectors of the India-China border. This goes back to Barahoti from 1954 to Longju in 1959, to

Sumdorong Chu from 1986

to 1995 and Depsang in 2013, amongst others. In the past, earlier Governments have agreed to a range of steps to defuse situations that have arisen at different times, including offers on our side to create de-militarized zones, limited non-patrolling zones, relocation or withdrawal of posts, disengagement of troops and dismantlement of structures. Different locations have seen different solutions being examined".

Notably, the EAM said, "Where the October 21 understanding is concerned, our objective has been to ensure patrolling as in the past to the relevant patrolling points, as well as the resumption of grazing by our civilians as per longstanding practice. This is indeed what we have agreed upon in regard to Depsang and Demchok".

# India's fish production increased to all-time record of 175.45 lakh tonnes

Minister of fisheries, animal husbandry and dairying Rajiv Ranjan Singh told Rajya Sabah that annual fish production in the country during the last 5 years has increased from 141.64 lakh tonne during 2019-20 to an all-time record of 175.45 lakh tonne in 2022-23. He also said that fisheries export has risen from Rs.46662.85 crore in 2019-20 to Rs.60524.89 crore in 2023-24.

In a reply to the questions by Rajya Sabha MP Kartikeya Sharma, the minister further said that govt efforts under Pradhan Mantri Matsya Sampada Yojana (PMMSY) have led to creation of direct and

indirect employment opportunities to about 58 lakh persons in fishing and aquaculture related activities on account of the fisheries development projects.

that enhanced per capita To address the cold chain fish consumption has increased from 5-6 kg to 12-13 kg with enhanced aquaculture productivity to 4.7 tonne per hectare.

He said that during the last four financial years (FY 2020- 21 to 2023-24) and current financial year (2024-25), the Centre has approved fisheries developmental proposals at a total cost of Rs.20864.29 crore with central share of Rs. 8871.45 crore under the PMMSY.

# Migrant students' issues: Government intervention crucial

The intervention of government to address the issues faced by migrant students is crucial, Rajya Sabha MP Kartikeya Sharma said on Wedneday. In a special motion, he noted that the coaching industry in India, vital for competitive exam preparation, generates an estimated revenue of Rs. 58,088 crores, projected to reach Rs. 1,33,995 crores by 2028.

However, this success conceals challenges such as exorbitant fees, inadequate teaching standards, and lack of personalized attention, he added. "Thousands of aspirants flock annually to Delhi, particularly Old Rajinder Nagar, Karol Bagh, and North Campus, for UPSC and other coaching. Many are housed in private

hostels and PGs, as Delhi University alone accommodates over 60,000 outstation students annually, yet offers only 20,000-30,000 hostel seats, he said.

This gap forces students into unregulated private housing, often plagued by overcrowded rooms, high fees, poor sanitation, and inadequate safety measures. Substandard food, unhygienic kitchens, and irregular meal timings further compromise students' physical and mental wellbeing. Educational hubs like Kota, Allahabad, Pune, and


Indore face similar distressing conditions.

To address these issues, Government intervention is crucial, the MP said. "Regulations for hostels and coaching centres, enforced through safety audits and holistic guidelines, can improve living standards and meal quality. Specially designated zones for educational institutions, akin to Special Economic Zones, could include rent ceilings and other controls to ensure affordability and accountability, he added. A 24/7 helpline for student grievances would provide timely redressal and support. Such measures would safeguard the well-being of students, ensuring their focus remains on education while addressing the inequities and challenges of India's booming coaching industry. I urge the Government to look





Chaura, 68, was seen at the

shrine on Tuesday as well. **Assistant Sub-Inspector** (ASI) Jasbir Singh, who was standing close to Badal in plainclothes, sensed the threat to the senior Akali leader and pounced on the shooter, grabbed his hands and pushed them upwards after which the attacker was overpowered with the help of other security personnel

and Shiromani Gurdwara Parbandhak Committee (SGPC) task force members.

In the melee, the gun fired and the bullet hit the entrance wall of the shrine behind Sukhbir Badal, who escaped unhurt.

Additional Deputy Comnissioner Harpal Singh said the police had been keeping an eye on Chaura, who was at the Golden Temple on Tuesday as well.

Special Director General of Police Arpit Shukla said more than 20 cases including under the Unlawful Activities (Prevention) Act are registered against Chaura.

Amritsar Police Commissioner Gurpreet Singh Bhullar said the attack on Badal was foiled because of the alertness of police and

the motive behind it will be ascertained after Chaura's questioning.

The shooter came alone to the Golden Temple, he said, adding that the case will be investigated from all angles. Sukhbir Singh Badal is

chief minister of Punjab Parkash Singh Badal and had recently announced his decision to step down as SAD president. He was the deputy chief minister of Punjab from August 2009 to March 2017.

Responding to a question, Bhullar said the security deployment at the shrine was sufficient. Police cannot carry out frisking because religious sentiments are involved, he said.

"Around 175 police per-

sonnel led by an assistant inspector general have been deployed at the complex," he said.

Devotees are not frisked at the entrance of the Golden Temple, one of the most revered Sikh shrines. It has the son of five-time former four entry points. No metal detector has been installed at any entrance. However, the Shiromani Gurdwara Parbandhak Committee deploys its task force members who keep an eye on suspicious persons. If they find anyone suspicious, they can check the person.

The Golden Temple has seen violent incidents in the 1980s, including Operation Bluestar in June 1984 when the Army had flushed out armed militants from the

Operation Black Thunder-1 was conducted by the National Security Guard in April 1986 against extremists and terrorists holed up in the shrine while Operation Black Thunder-II was conducted in May 1988.

Pro-Khalistan terrorists have been involved in many attacks in the state, including the assassination of chief minister Beant Singh in 1995. He questioned the role of

the police, asking why no action was taken when they were aware of Chaura's presence. "If the police were so alert, why didn't they arrest him? Instead, the police gave him VIP treatment and were probably waiting for the bullet to be fired," Majithia claimed.

Whereas, the figures of paddy procurement during the Kharif Marketing Season 2023-24, recorded a decline and the total procurement remained 782.20 lakh MT against 846.45 lakh MT procured in KMS 2022-23. As per the figures, 782.20 lakh MT was the lowest level since 2019-20, when the government agencies could procure 770.93 lakh MT in KMS 2019-20. Moreover, the number of beneficiary farmers also reported a decline as only 1.06 crore farmers managed to sell their produce on the **Minimum Support Price** this year against 1.24 crores of the KMS 2022-23.

Farmer Leader and Haryana President of Bharatiya Kisan Union (BKU) Tikait, Ratan Mann said that in the

yield, especially in Haryana remained unpredictable due to prevailing weather conditions, for example the average wheat yeild reached to around 22 quintals, against the normal average of 18 to 20 quintal, due to longer winter spell. But the paddy yeild, especially the parmal varieties, have witnessed a fall of around 2 to 5 quintals per acre, because of uneven rainfall from August to October.

The decline in the paddy procurement was attributed due to fall in production in several states. As in Telangana the procurement declined to 95 lakh MT against 131.86 lakh MT of the last year and in Andhra Pradesh the government agencies could procure only 30.80 lakh MT against 42.05 lakh MT of the last year, while in Bihar the procurement remained only 30.80 lakh MT against 42.05 lakh Mt of the last year. Similarly in UP the procurement remained only 53.80 lakh MT while it was 65.50 lakh MT last year. Meanwhile, in Punjab procurement has witnessed a surge and reached 185.53 lakh MT against 182.29 lakh MT of the last year.

Moreover, there are reports that the paddy procurement may also decline this year again as during the ongoing KMS 2024-25; around 172 LMT of paddy has been procured from farmers in Punjab against 185 lakh MT of the last year. Even in Haryana the paddy procurement is likely to remain below 55 lakh MT against the average 60 lakh MT. This is despite the area under paddy in the country witnessed an increase and reached to 410 lakh hectares (By September 13), against 393 lakh hectares of the last year during the same period.

# Blast outside Majitha police station in Amritsar

Less than 12 hours after Shiromani Akali Dal (SAD) chief Sukhbir Singh Badal was attacked near the Golden Temple, a powerful explosion was reported outside the Majitha Police Station in Amritsar Rural Police District around 10:00 PM on Wednesday.

This marks the second explosion in Amritsar within a week. Earlier a blast at the deserted Gurbaksh Nagar Police Chowki in Ajnala was reported. The latest incident has intensified security concerns, prompting an immediate response from law enforcement agencies to address the growing tension in the region.

Amritsar Rural Senior Superintendent of Police (SSP) Charanjit Singh, along with senior officials, arrived at the blast site to assess the situation. Investigators

## Alert ASI thwarted 'murder' bid

Prompt action by an alert Punjab Police ASI on Wednesday helped thwart a bid on Shiromani Akali Dal leader Sukhbir Singh Badal's life outside the Golden Temple in Amritsar. Assistant Sub-Inspector (ASI) Jasbir Singh, who was standing close to Sukhbir Badal at the entrance of the Golden Temple in plainclothes, swung into action the moment he sensed a threat to the senior Akali leader. Television footage showed Narain Singh Chaura, a former terrorist, slowly moving towards Sukhbir Badal, who was sitting on a wheelchair due to a fractured leg, and suddenly pulling out a gun from his pocket.

As Chaura tried to pull the trigger, an alert Singh pounced on him, grabbed his hands, pushed them upwards and whisked him away. In the melee, the gun fired but fortunately the bullet hit the entrance wall of the shrine behind Sukhbir Badal, who escaped unhurt. Other security personnel present on the spot along with members of the Shiromani Gurdwara Parbandhak Committee (SGPC) task force

immediately intervened and snatched the weapon from Chaura. Speaking to reporters in Amritsar, ASI Singh said he was just performing his duty. "I was alert when he (Chaura)

When he took out his pistol, we overpowered him and snatched his weapon," Singh said. The audacious attack. which took place at around 9:30 am, was captured by mediapersons camping outside the Golden Temple to cover Day 2 of Sukhbir Badal's penance for the "mistakes" committed 2017. Amritsar Police Commissioner Gurpreet Singh Bhullar, meanwhile, lauded the policemen for their role in foiling the murder bid on Sukhbir Badal. # Spotlight on rising Khalistani sentiment an aider to prisoners trying

In a chilling incident that has shaken the entire Punjab and the worldwide Sikh community, Sukhbir Singh Badal, former Deputy Chief Minister of Punjab and current president Shiromani Akali Dal, was attacked with an assassination plot at the revered Golden Temple in Amritsar. The attack happened when Badal was performing sewa, or voluntary service, at the Sikh shrine, an act mandated by the Akal Takht, the highest temporal seat of the Sikhs, as part of his penance for the sacrilege incidents that Chaura, an individual with deep roots in the Khalistani movement and an infamous militant past, was promptly arrested after he opened fire at Badal. Chaura, born in the village of Chaura near Dera Baba Nanak, Gurdaspur, and educated at the Sikh Missionary College in Amritsar, has a notorious history. He crossed into Pakistan during the high tide of militancy in Punjab in the 1980s when he was allegedly engaged in smuggling arms and explosives to India to fuel the insurgency. His arrest is consequent upon a spate of criminal activities that had seen him implicated in the Burail jailbreak case wherein he was involved as

to escape. The attack has not only raised immediate security concerns about one of Sikhism's holiest sites but has also brought to the forefront the simmering issues of political accountability, communal harmony, and historical grievances in Punjab. Security at the Golden Temple has been an ongoing concern, particularly given its history as a focal point for both spiritual reverence and political activism.

Political leaders belonging to different parties have been condemning the attack, where many have sought a proper investigation about how such an incident may happen at a place like this, with strict security protocols. Akal Takht has issued a statement expressing deep concern over the event, urging calmness and unity in the Sikh community while emphasizing the sanctity of the Golden Temple. The attack has again brought the handling of sacrilege cases under Badal's leadership under debate. As it is already known, sacrilege of the Sikh holy scripture had started protesting all over and brought a political damage to the SAD. Badal's penance was widely viewed as a bid to mend the relationship with Sikh Panth and redress the grievances that alienated a fair portion of his voter base.

# Get Delhi police nod: Haryana to farmers

back in a few days, they will let us go. This is actually against the right of the leader of opposition in Lok Sabha. I should be allowed to go," he told reporters. 

# Complex robotic surgery saves life of five-month-old child

In a groundbreaking medical achievement, paediatric surgeons at Mahatma Gandhi Hospital successfully saved the life of a fivemonth-old baby through a complex robotic surgery. The baby was born with a congenital diaphragmatic hernia, a serious condition where a hole in the diaphragm allows organs like the stomach, kidney, spleen, and parts of the intestines to shift into the chest cavity. This displaced the baby's lungs and heart, causing breathing problems and se-

vere weakness The parents consulted senior paediatric surgeon Dr Siddharth Singh Rathore, who recommended surgery as the only solution. The hospital's advanced robotic surgery facility was used to perform the operation, offering a minimally invasive approach. The procedure was conducted through three small incisions in the chest, significantly reducing the risks associated with



This surgery, which employed robotic transthoracic technology, is believed to be the first of its kind in Rajasthan.

conventional surgery. The baby was discharged just two days later, completely healthy. This surgery, which employed robotic transthoracic technology, is believed to be the first of its kind in Rajasthan. Dr Rathore explained the complexity of the procedure, emphasising the limited space in an infant's chest and the challenges posed by the continuous movement of the lungs and heart. Advanced tools

like robotic 3D vision were essential for the success of the operation, which was completed without blood loss. Dr Rathore also acknowledged the contributions of anaesthesiologists Dr Kalpana and Dr Tanmay, whose efforts were crucial to the operation's success. Mahatma Gandhi Hospital now offers state-of-the-art robotic paediatric surgery services, making it a leader in advanced paediatric care.

In a major revelation in the bone-chilling triple murder case in Delhi's Neb Sarai, the Delhi Police on Wednesday said that the son, who is also the complainant in the case is the main accused in the killing of his mother, father and sister.

Joint Commissioner of Police, Southern range, SK Jain, said that accused Arjun's relations was not good with his family members, and the motive behind the accused's crime was be feeling "humiliated" by his father's scolding and "sibling rivalry."

A man, his wife and their daughter were stabbed to death at their residence in Delhi's Neb Sarai on Wednesday. Earlier, it was believed that the fourth member of the family, the son was out for a walk at the time of the incident.

Addressing a press conference, Jain said, "At the



# Grenade attack by terrorists on Army post in J&K's Poonch

In a terrorist attack on the Indian Army in Jammu and Kashmir's Poonch district, two grenades were hurled at a military post in the Surankote area early Wednesday morning. Officials reported that one grenade exploded while the other was defused by experts, and fortunately, no casualties were reported in the incident. The attack took place at an army post located behind the main camp.

Following the explosion, security forces launched an im-



mediate search operation to trace the assailants. During the operation, the safety pin of the exploded grenade was recovered near the perimeter wall of the Army camp, providing a potential lead in identifying the attackers. Despite the setback, the terrorists managed to flee the scene, prompting a massive search operation by the Army and local police in the region to track them down.

This grenade attack came on the heels of a significant operation conducted by security forces in Srinagar's Harwan area. On Tuesday, a joint search and cordon operation in the upper reaches of Dachigam forest resulted in the neutralization of one terrorist. Identified as Junaid Ahmed Bhat, a member of the Lashkar-e-Taiba (LeT), the terrorist had been involved in multiple civilian killings, including one in Gagangir, Ganderbal. Bhat was also linked to several other terror attacks in the region.

# BJP poised for key changes in Rajasthan, cabinet reshuffle likely soon



Following the formation of the new government in ranks in Delhi. Maharashtra on Thursday. the Bharatiya Janata Party (BJP) high command is now poised to implement key decisions in Rajasthan. State President Madan Rathore is expected to form a new team, with new district and division presidents are likely to be appointed by the end of the month during the organizational elections. Additionally, significant changes could take place within the state government. With Chief Minister Bhajan Lal Sharma's one-year tenure approaching, a cabinet reshuffle is anticipated soon. Sources suggest that Sharma may soon travel to Delhi for discussions, as the high command is reportedly dissatisfied with the performance of some ministers. Furthermore, there are rumors of potential surprising ap-

pointments at the top levels of the bureaucracy, amidst growing reports of tensions within the administrative

Since the formation of the Bhajan Lal government, there has been ongoing discussion about the influence of bureaucracy. Former Chief Minister Ashok Gehlot has claimed that the bureaucracy is effectively running the government. Many believe that this dominance played a significant role in the disappointing results of the Lok Sabha elections, leading to frustration among workers and leaders. However, there has been some improvement recently, with ministers and MLAs starting to be heard. Despite this, reports of tensions within the bureaucracy continue to affect the government's operation.

Chief Minister Bhajan Lal Sharma is working hard to ensure that these internal issues don't disrupt the functioning of the government.

He has managed to bring the situation under control by directly communicating with ministers and MLAs. However, there is still a concern that ministers are not working at the desired pace. The high command is receiving detailed reports on this matter. Sharma, known to be a trusted ally of Union Home Minister Amit Shah, receives these reports directly, allowing him to stay well-informed.

The first year of Sharma's tenure is considered to have been satisfactory, especially given that his opponents did not offer the level of cooperation he had hoped for. The upcoming cabinet reshuffle is expected to strengthen his position, as it will be carried out based on his recommendations. Additionally, the central high command may bring in new faces in the bureaucracy to create a fresh perception of the Rajasthan government among the public.

Currently, the central leadership and state government are focusing on the Rising Rajasthan Global Investment Summit and the foundation stone laying of ERCP, both scheduled for this month. The Prime Minister is expected to attend both events. As a result, the government's attention is primarily on these two programs. However, after December 17, significant decisions are expected to be made in the state.

The country has observed a maximum peak demand of around 250 GW in May 2024 during the current year (2024-25). The peak demand has grown at a CAGR of 16 per cent from 2013-14 to 2023-24 while Energy Requirement has grown at a rate of 5 per cent during 2013-'14 to 2023-24.

The peak not met and energy not supplied by the country is observed to be very minimal over the last five years and was on account of factors other than lack of generation capacity in the country. As per the 20th EPS report published by the Central Electricity Authority (CEA), the peak demand and energy requirement is around 366 GW and 2474 BU by 2031-32.

The projected electrical energy requirement and peak electricity demand on the all-India basis are estimated as 1908 BU and 277 GW for the year 2026-27 respectively.

Energy Storage capacity is an important aspect in achieving the targets of NEP. Energy storage capacity of 16.13 GW/82.37 GWh with PSP-based storage of 7.45 GW capacity and 47.65 GWh storage and BESS-based storage of 8.68 GW/34.72 GWh is required by the year

# JanMGNREGA app will be revamped to boost feedback mechanism

The JanMANREGA app will be revamped to enhance the active disclosure of information and introduce a feedback mechanism for citizens regarding the implementation of MGNREGA, said Union Minister for Rural Development and Agriculture and Farmers' Welfare Shivraj Singh Chouhan on Wednesday, according to a release by the Ministry of

Rural Development. Addressing the media on the ministry's achievements, he stated that a training module has been developed to enhance the capacity of field workers under MGNREGA. focusing on training village employment assistants.

Union Minister Chouhan noted that this year, the ministry's budget was Rs1.84 lakh crore, of which Rs1.03 lakh crore has been utilised.

While responding to media queries, Chouhan reaffirmed the government's commitment, stating that action would be taken if any state identified shortcomings in

MNREGA or the PM Awas Yojana. He emphasised that schemes like MNREGA are demand-based, and additional funds are sought from the Finance Ministry when the allocated budget falls short, with continuous revi-

sions made as needed. Chouhan also highlighted that under the Pradhan Mantri Awas Yojana - Gramin, a target of constructing 2.95 crore houses was set for completion by March 2024. Nearly all houses have been sanctioned, with 2.67 crore already constructed.

The Reserve Bank of India on Wednesday revised the wallet limit for the UPI Lite from Rs 2,000 to Rs 5,000.

As per the new rules introduced today, the upper transaction limit for UPI Lite under offline framework has been increased from Rs 500 to Rs 1,000 per transaction.

"The offline framework has been updated and the enhanced limits for UPI Lite shall be Rs 1,000 per transaction, with Rs 5,000 being the total limit at any point in time," the RBI circular added.

The framework earlier prescribed an upper limit of Rs 500 for digital payment transaction under offline framework and a total limit of Rs 2,000 for a payment instrument at any point in time.

The enhanced transaction and total limits for UPI Lite are set to take effect immediately, providing a significant boost to users who rely on this mode of payment for day-to-day purchases. The RBI has emphasized that this update aims to further streamline digital payment solutions while ensuring security and ease of use for



consumers.

The circular has been issued under the authority of Section 18 read with Section 10(2) of the Payment and Settlement Systems Act, 2007, and is expected to create a more robust and inclusive digital payment ecosystem in India.

The GSEC in Hyderabad will be the first of its kind in the APAC region after Tokyo and only the fifth curity capabilities in India, globally, with similar facilities in Dublin, Munich, and Malaga, according to a statement

This GSEC is a specialised international cybersecurity hub designed to play a crucial role in developing advanced security and online safety products tailored for the Indian context. The centre will focus on cuttingedge research, AI-driven security solutions, and creat-



ing a collaborative platform for leading experts and researchers in cybersecurity. It also aims to foster skill development, boost employment, and enhance cybersethe Telangana CMO stated.

The release further highlighted that Google, which already has its largest employee base in Hyderabad, is currently constructing its biggest office globally outside its headquarters in the city. The GSEC was first announced on October 3, 2024, during the Google for India 2024 Conclave, sparking intense competition among states to secure this investment.

"We are very proud that Google has chosen Hyderabad for setting up the GSEC. This partnership is a testament to Hyderabad's position as a leading IT and innovation hub in the country and the world," said Telangana Chief Minister Revanth Reddy after the partnership was formalised.

Welcoming Royal Hansen, CIO of Google, Revanth Reddy remarked, "Telangana has always been at the forefront of digital skill development. Hyderabad has been the epicentre of IT/ ITES development globally. Our city is already home

## Delhi leads India in EV adoption: Report **TDG NETWORK** NEW DELHI

The adoption of electric vehicles (EVs) in India is surging, with Delhi emerging as the leader in EV penetration, according to a report by FICCI and Yes Bank.

The report highlighted that Delhi has achieved an EV penetration rate of 11.5 per cent, driven by its adoption across multiple segments.

The report urged a doubling of the current EV penetration rate to meet national targets by 2030. It called for states to renew their EV policies until 2030. emphasizing the need to mandate EV adoption in

public transport and fleet operations.

With many states' EV policies nearing their expiration, the report stressed the importance of providing a stable and long-term policy environment to attract investors and accelerate EV adoption.

The report provided a roadmap to bridge the gap between ambition and execution, offering actionable recommendations to enhance Zero Emission Vehicle (ZEV) penetration across the country.

It highlighted the need for states to support industry development and charging infrastructure through sustainable fiscal measures. Establish well-defined institutional mechanisms and focused policies and Foster collaboration between central and state governments to fast-track ZEV adoption.

# Religious tourism driving residential demand in tier-2 cities: Report

Tier-2 cities with strong religious tourism appeal, such as Prayagraj, Varanasi, Puri, and Shirdi, are witnessing a sharp rise in residential demand, according to a report by Magicbricks.

Driven by a combination of self-use and investment motivations, these cities are emerging as residential hotspots, leveraging their cultural and spiritual significance.

Prayagraj has seen a remarkable 28 per cent yearon-year (YoY) increase in demand, while Varanasi recorded an 18 per cent surge.

Puri, a popular destination for devotees of Lord Jagannath, posted a 52 per cent growth, and Shirdi, home to the revered Sai Baba shrine, topped the list with a 67 per cent rise in buyer interest.

The demand extends beyond the permanent residence, with buyers eyeing opportunities for long-term



gains, holiday homes, and short-term accommodations such as bed-andbreakfasts (BnBs) to cater to the influx of tourists.

While residential prices in Varanasi have reduced by 5.15 per cent in the past year due to increasing supply, the market remains attractive with an average rate of Rs 6,128 per square foot (psf). Similarly, Prayagraj saw a dramatic price escalation of 122 per cent between January and March 2024 due to high demand, but rates have

since stabilized at Rs 6.645

In contrast, Puri has experienced a 30 per cent price appreciation over the last year, with rates reaching Rs 6,114 psf. Shirdi offers one of the most compelling value propositions, with an average price of Rs 4,028 psf, making it a lucrative option

The surge in residential demand in these cities can be attributed to several factors, including the growing popularity of religious tourism, improved infrastructure, and the potential for rental income from holiday homes.

# Antler fuels 30 startups

Venture capital firm Antler has expanded its India portfolio by backing 30 startups in 2024 through its maiden \$75 million (around Rs 635.1 crore)

Through its residency programmes, Antler India helps entrepreneurs find cofounders, develop business ideas, and form teams, while providing funding and mentorship.

The next Residency cohort, scheduled to commence in February 2025, will support pre- and post-idea stage solo founders through an 8-12 week programme. Participants can receive up to \$500K in funding through Antler's standard deal. "Through hands-on sessions by domain experts and office hours, we support founders in co-creating and building alongside other ambitious individuals," Sharma said.

The first task assigned to this committee is to find out how data protection can be given to companies bringing pesticides to India whose patent has expired for 20 years so that they can make huge profits by selling their agrochemicals to the Indian market and farmers at many times the price and exploit Indian farmers. that giving any kind of data It should be known that protection is illegal which

will give license for looting in the last several years, many attempts have been the farmers by MNCs and made by multinational companies and Indian industries associated with them to change the rules related to the Insecticides Act 1968. The only objective of all these efforts has been to

capture the Indian market in some way or the other and exploit the farmers. On this subject, Bharatiya Krishak Samaj has always been of the opinion that those Global Off-Patented Molecules whose patent period of 20 years has been completed in any country of the world should not be given any data protection in India. Imported Acetamiprid was sold at around Rs, 6,400 per kg in the year 2001-2002. Today, Indian companies are making it available to farmers at Rs. 800 per kg, which is 87 per cent less.

Cypermethrin which was imported about 30 years ago at \$80 -100 per kg, today the Indian company is

making it available to the farmers of India at \$8 per kg and exporting it to the world market at \$10 per kg. India is the largest producer of Cypermethrin in the world.

# 'Reimagining the Middle East': Embracing change in a world where power shifts and new alliances emerge

The Middle East is a region where geopolitical dynamics can shift unexpectedly. While the Israel-Palestine conflict is often seen as emblematic of regional tensions, its duration of about a century is relatively short compared to other global conflicts. This article will explore the evolving alliances within the Middle East, the realignment of key regional and global powers, and potential pathways to-

ward peace.

Since the end of the Cold War, the United States has held significant sway over global affairs. The collapse of the Soviet Union did not diminish the perception of international relations as zero-sum games. The "War on Terror," failures in Iraq and Afghanistan, and the rise of groups like al-Qaeda and ISIS reinforced this view. Meanwhile, China emerged as a secondary global power in the 1990s, altering the balance of international influence. This article will examine China's growing role in reshaping the Middle East's geopolitics, the shift toward a multipolar world, and how

the U.S. can adapt to these changes.

### **POST-COLD WAR DYNAMICS: U.S. DOMINANCE AND SHIFTING ALLIANCES**

Following the Cold War, the U.S. became the primary power in the Middle East, shaping the region's political landscape with policies rooted in Cold War thinking. The Abraham Accords. which normalized relations between Israel and several Arab nations, were part of U.S. efforts to curb Iran's influence. However, as regional dynamics became more complex, the U.S.'s reliance on military intervention and bloc-based politics showed diminish-

The aftermath of 9/11 shifted U.S. focus to the "War on Terror," resulting in interventions that, while aimed at combating terrorism, deepened regional divides. This prompted a reevaluation of U.S. foreign policy as rising global and regional powers began challenging its dominance.

### **CHINA'S STRATEGIC APPROACH TO THE** MIDDLE EAST

China's approach to the Middle East contrasts with the U.S., focusing on economic relationships rather than military intervention. Beijing has built strong trade ties with both U.S. allies like Israel and adversaries such as Iran. By mediating between Saudi Arabia and Iran, China has played

a pivotal role in regional diplomacy. Unlike the U.S., which often emphasizes confrontation, China seeks stability to secure energy supplies and expand its global economic influence through diplomacy and soft power. By strengthening its ties with Iran, China has helped Tehran circumvent Western sanctions while ensuring continued access to essential oil supplies.

### **RUSSIA'S ROLE IN** THE REGION

Though economically weaker than China, Russia has positioned itself as a major player in the Middle East. Moscow's military involvement in Syria demonstrated its readiness to counter Western influence and assert its interests. Through security partnerships, Russia has secured a key role in the region, further contributing to the shift toward multipolarity.

### THE ISRAEL-**PALESTINE CONFLICT: A PERSISTENT BARRIER**

The Israel-Palestine conflict remains a core issue in Middle Eastern geopolitics, contributing to regional instability. Despite multiple peace attempts, including the Oslo Accords, a lasting resolution remains elusive. Events like the October 7 attacks highlight the urgency of addressing deep-seated grievances. For the U.S., resolving this conflict is crucial for maintaining influence in the region.

- Achieving progress could:
- Strengthen relationships with Arab nations by demonstrating a commitment to Palestinian justice.
- Limit Iran's leverage by reducing its ability to exploit the conflict.
- · Enhance global percep-

tions of U.S. foreign policy by promoting fairness and peace.

### **IMPACT OF THE ARAB SPRING AND SHIFTING REGIONAL DYNAMICS**

The Arab Spring significantly affected Palestinian dynamics, with Egypt's General Al-Sisi designating Hamas as a terrorist organization while Oatar continued to support it as a resistance movement. Saudi Arabia, meanwhile, backed the Palestinian Authority, further fragmenting the Palestinian cause. However, Egypt played a crucial role in mediating between Hamas and the Palestinian Authority in 2017.

North African nations are also facing significant challenges. Libya is mired in internal conflict, effectively divided between two governments. Algeria, though buoyed by oil wealth, struggles with protests and the decline in oil prices. Morocco is undergoing gradual reforms but faces major challenges like unemployment, social disparities, and regional imbalances. Tunisia, while making progress in its political transition, is threatened by economic difficulties, particularly the lack of job opportunities.

The Maghreb region, while generally performing slightly better than the Mashrek, remains highly fragmented and the least integrated region globally. In contrast, non-Arab countries like Iran and Turkey have benefitted from the region's turmoil, with Iran increasing its regional influence and Turkey's role solidified after the success of the Muslim Brotherhood in Egypt, although tensions emerged following the military ousting of President Morsi.

### THE SHIFTING **GLOBAL LANDSCAPE: A MULTIPOLAR MIDDLE EAST**

The geopolitical shift in the Middle East is increasingly shaped by a multipolar environment, with global powers like the U.S., China, and Russia vying for influence. Regional actors such as Saudi Arabia, Turkey, and Israel are adapting to these changing dynamics. New alliances, such as the I2U2 (Israel, UAE, and India), highlight the shifting geopolitical realities. This new multipolarity presents both opportunities for cooperation and increased potential for conflict.

### TRUMP'S RETURN **AND ITS POTENTIAL IMPACT ON MIDDLE EASTERN DYNAMICS**

Should Donald Trump returning to the presidency, his approach is likely to mirror his previous term, with bold and unconventional strategies. Policies like recognizing Jerusalem as Israel's capital, withdrawing from the Iran nuclear deal, and expanding the Abraham Accords are expected to be revisited.

### **REWORKING U.S. ALLIANCES:**

**Strengthening Relations** with Israel: Trump is likely to continue prioritizing Israel's interests, expanding security cooperation and facilitating further normalization agreements with Arab nations.

**Expanding the Abraham Accords:** Trump may push for more Arab countries to normalize relations with Israel, potentially sidelining Palestinian demands.

Renewing Gulf Partner**ships:** Expect continued focus on arms sales, counterterrorism, and energy cooperation with Gulf states, though this could strain re-

lationships with Qatar and Turkey.

### **RUSSIA'S INVOLVE-MENT AND A SOFTER** APPROACH TO IRAN

The crisis in Ukraine has spurred Russia to deepen its involvement in Middle Eastern conflicts, adopting both geostrategic confrontation and limited counterterrorism cooperation. A more balanced approach to Iran, combining diplomatic engagement with pressure, could stabilize the region and address key security concerns.

### **U.S.-CHINA RIVALRY AND ITS IMPACT**

Trump's stance on China could spill over into the Middle East, particularly in the realms of technology and energy. As Saudi Arabia strengthens ties with China, this could complicate U.S.-Saudi relations, adding another layer to the region's already complex dynamics.

### **CONCLUSION: TOWARDS A STABLE** MIDDLE EAST

The Middle East is undergoing a profound geopolitical transformation, shifting toward multipolarity. Global powers must recalibrate their strategies to maintain influence while fostering stability. A comprehensive strategy involving diplomatic engagement, economic cooperation, and security partnerships will be essential for achieving long-term peace. As the U.S. navigates these challenges, balancing firmness with flexibility in dealing with Iran and other regional actors will be key to shaping a stable and prosperous future for the region.



What is even more problematic is that there are allegations that Rahul Gandhi has been working with Soros' people to destabilise the incumbent government in India. Whether this is true or not, the fact is that the Congress under Rahul Gandhi has been picking up the issues peddled by OCCRP. This is bound to raise questions if some of the Congress' actions have been dictated by the American deep state. India's grand old party needs to come clean on this and nip all such claims in the bud. This is serious because it amounts to foreign interference in a sovereign country's internal affairs. It is hoped for Congress' sake that the party has not played into the hands of external forces in its desperate attempt to return to power and that all such claims being made about Rahul Gandhi and his party are false.

ndia's population growth and its man-Lagement have been subjects of significant political, social, and economic debate. Recently, Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat reignited discussions by urging Indian families to have at least three children to maintain societal survival. His remarks in Nagpur were grounded in demographic science, which suggests that societies with fertility rates below 2.1 risk extinction. Bhagwat emphasized that India must not let its fertility rate dip below this critical threshold.

"A decline in population is a matter of concern. Modern demographic studies indicate that when the population of a community falls below a fertility rate of 2.1, that society faces extinction," he said. He added that societies facing such declines "do not need external threats to vanish; they disappear on their own."

Bhagwat's statement has triggered a broader dialogue on population management, raising questions about India's demographic trajectory, the effectiveness of past policies, and the best way forward in addressing population-related chal-

Mohan Bhagwat's relies to have at least three children sparked strong political reactions across the country, particularly in states like Bihar, where population policies and caste-based issues are politically charged. Opposition parties criticized Bhagwat's stance, accusing the RSS and the ruling BJP of adopting contradictory narratives on population control.

In Bihar, the Rashtriya Janata Dal (RJD) was quick to question the internal inconsistencies between the BJP's population control advocacy and Bhagwat's call for larger families. RJD spokesperson Mrityunjay Tiwari remarked, "Leaders of the BJP often speak about population control, and now the RSS chief is advocating for more children. The BJP and RSS should first resolve

their own contradictions." Similarly, the Janata Dal (United) criticized Bhagwat's statement, emphasizing the importance of education, particularly for women, as a means to address population issues. JD(U) spokesperson Arvind Nishad said, "Before

Critics argue that such remarks can polarize communities along religious and ideological lines, distracting from the broader goal of equitable development.

The reactions underscore a larger issue: the need for coherence in India's population policies. On one hand,



of the National Family

Health Survey (NFHS-5) conducted in 2019-21, India's Total Fertility Rate (TFR) declined to 2.0 children per woman, achieving the replacement level of fertility, which is 2.1 children per woman.

This decline in TFR reemphasize education and access to family planning services. However, the outcomes have been mixed across different regions and communities, indicating that while progress has been made, challenges remain in uniformly implementing these strategies nationwide.

### **FERTILITY TRENDS ACROSS RELIGIOUS** COMMUNITIES

Data from the National Family Health Survey (NFHS) highlights a consistent decline in fertility rates among all major religious groups:

• **Muslims:** The TFR decreased from 4.4 in 1992-93 to 2.6 in 2015-16.

• **Hindus:** The TFR reduced from 3.3 to 2.1 during the same period. • **Jains:** Reported the

lowest TFR at 1.2. These trends indicate a convergence in fertility rates across communities, driven by improved access to edu-



# Supreme Court: Plaintiff seeking specific performance of agreement to sell must also show availability of funds

The Supreme Court in the case R. Shama Naik Versus G. Srinivasiah observed and has upheld the decision of High Court, wherein the court denied Specific Relief to the plaintiff because he was not able to prove his readiness and willingness to perform the contract.

The bench comprising of Justice JB Pardiwala and Iustice R Mahadevan was hearing the present matter.

The bench in the case observed that for the contract to be concluded, the plaintiff shall not only aver about his readiness and willingness to perform the contract but, 'It is also obliged to adduce necessary oral and documentary evidence in order to show the availability of funds to make payment in terms of the contract in time.

In the present case, the petitioner-plaintiff sought a specific performance of the agreement to sell, wherein it is contended that the Respondent was not performing his part of the contract despite taking earnest money of Rs. 12.5 lacs out of a total consideration of Rs. 30 Lacs.



# Hamas Fatah near agreement on who will oversee post-war Gaza

Palestinian officials say Fatah and Hamas are closing in on an agreement to appoint a committee of politically independent technocrats to administer the Gaza Strip after the war. It would effectively end Hamas' rule and could help advance ceasefire talks with Israel.

The rival factions have made several failed attempts to reconcile since Hamas seized power in Gaza in 2007. Israel has meanwhile ruled out any postwar role in Gaza for either Hamas or Fatah, which dominates the Western-backed Palestinian Authority.

A Palestinian Authority official on Tuesday confirmed that a preliminary agreement had been reached following weeks of negotiations in Cairo. The official said the committee would have 12-15 members, most of them from Gaza.

# South Korea's martial law lifted

The lifting of the controversial martial decree in South Korea may have prevented the country from falling into chaos, but the political turmoil over the now-rescinded order by President Yoon Suk Yeol shows no signs

of abating immediately. Late on Tuesday, Yoon Suk Yeol imposed the martial law in a bid to "eliminate anti-state forces". The move came to push his and the ruling party's agenda in the opposition-dominated

parliament. The military and armed police officers surrounded the parliament soon after the order was passed. Helicopters were also employed as protesters gathered outside the parliament. However, the martial law prevailed for only a few hours as the National Assembly voted against it, following which Yoon Suk Yeol formally lifted it around 4:30am during a Cabinet meeting. Secu-



rity forces left the ground of the National Assembly soon after the vote.

While announcing his plan to lift martial law, Yoon Suk Yeol, who has after he found it difficult accused the opposition and a grave violation of of sympathising with North Korea, slammed parliament's attempts to impeach key government officials and senior prosecutors. He also accused the lawmakers of "unscrupulous acts of legislative and budgetary manipulation".

Hours after the martial law was lifted, the liberal opposition Democratic Party, which holds a majority in the 300-seat parliament, urged Yoon Suk Yeol to resign immediately or face impeachment. "President Yoon Suk Yeol's martial law

declaration was a clear violation of the constitution. It didn't abide by any requirements to declare it," the Democratic Party said in a statement.

"His martial law declaration was originally invalid the constitution. It was a grave act of rebellion and provides perfect grounds for his impeachment."

According to South Korean media, Yoon Suk Yeol's chief of staff, advisers and senior secretaries have offered to resign.

Impeaching Yoon Suk Yeol would seem difficult if one looks at the numbers. It would need the support from two-thirds of the parliament or 200 of the 300 lawmakers.

The opposition parties, including the Democratic Party, together have 192

seats. However, the opposition seems to have been emboldened by the fact that when the National Assembly voted 190-0 for the rejection of the martial law, around 10 members of his ruling People Power Party voted in favour of the rejection, according to AP. In fact, ruling People Power Party leader Han Dong-hun asked Yoon to explain his decision to impose martial law, and urged him to fire Defence Minister Kim Yong Hyun, who, he said, recommended the martial law. Prime Minister Han Duck-soo would take over the presidential duties if Yoon Suk Yeol is impeached. The latter will also be stripped of his constitutional powers until the Constitutional Court decides

# No plan to ban ISKCON, says aide to B'desh interim govt

ndia voted in favour of a **UN General Assembly** resolution that called for the withdrawal of Israel from the Palestinian territory occupied since 1967, including East Jerusalem, and reiterated the call for achieving a comprehensive, just and lasting peace in West Asia.

The draft resolution 'Peaceful settlement of the question of Palestine' tabled by Senegal was overwhelmingly adopted in the 193-member General Assembly on Tuesday.

India was among the 157 nations that voted in favour, while eight Member States -Argentina, Hungary, Israel, Micronesia, Nauru, Palau, Papua New Guinea and the United States voted against

Cameroon, Czechia, Ecuador, Georgia, Paraguay, Ukraine and Uruguay abstained.

The resolution, adopted as orally revised, reiterated its call for the "achievement, without delay, of a comprehensive, just and lasting peace in the Middle East (West Asia)" on the basis of the relevant United Nations resolutions and an end to the Israeli occupation that began in 1967, including of East Jerusalem.

The resolution called for the "withdrawal of Israel from the Palestinian territory occupied since 1967.

It also demanded that Israel, "the occupying Power, comply strictly with its obligations under international law, including as reflected in the advisory opinion of the International Court of 19 July 2024, including to bring an end to its unlawful presence in the Occupied Palestinian Territory, as rapidly as possible, to cease immediately all new settlement activities and to evacuate all settlers from the Occupied Palestinian Territory, and to put an end to its unlawful acts, including by repealing all legislation and measures creating or maintaining the unlawful situation."

It rejected any attempt at demographic or territorial change in the Gaza Strip, including any actions that reduce the territory of Gaza.

The resolution further stressed that the Gaza Strip constitutes an integral part of the Palestinian territory occupied in 1967, and "reaffirms the vision of the twostate solution, with the Gaza Strip as part of the Palestinian State."

The resolution further stressed the need for an immediate and complete cessation of all acts of violence, including military attacks, destruction and acts of terror, as well as all acts of provocation and incitement.

India also voted in favour of a resolution in the General Assembly that demanded that Israel withdraw from all the occupied Syrian Golan to the line of June 1967 in the implementation of the relevant Security Council resolutions.

# Biden in Africa pledges \$600 million more for rail project

President Joe Biden on his visit to sub-Saharan Africa pledged another USD 600 million for a cross-continent rail corridor project Wednesday, telling regional leaders that "Africa has been left behind for much too long. But not anymore. Africa is the future." Biden used the third and final day of his visit to Angola to showcase the Lobito Corridor railway, where the US and allies are investing heavily to refurbish 800 miles (1,300 kilometres) of train lines in Zambia, Congo and Angola.

The project aims to advance the US presence in a region rich in cobalt, copper



and other critical minerals used in batteries for electric vehicles, electronic devices and clean energy technologies. By the end of the decade, the rail line could even go a long way toward linking southern Africa's west and east coasts. "It's a game changer," Biden said, and cited the transformational effect of building the transcontinental railroad in

the United States. Cargo that once took 45 days to get to the United States — usually involving trucks to South Africa — will now take less than 45 hours, he said. He also predicted the project could transform the region from a food importer to exporter. Altogether, Biden said the US has invested USD 4 billion along the Lo-

The EU exception for the Czechs to get Russia's oil expires on Thursday. The government previously said it was not planning to seek an extension.

# Hungarian official says there is 'no consensus' on inviting Ukraine to join NATO

Hungary's foreign minister said a meeting of his counterparts from NATO member countries in Brussels on Wednesday had produced "no consensus" on the prospect of inviting Ukraine to join the transatlantic military alliance, a step Kyiv sees as an essential condition for bringing an end to Russia's war. Péter Szijjártó, a fervent critic of Ukraine with close ties to Russian President Vladimir Putin's government, criticised some Western countries that have increased military support to Kyiv following Donald Trump's election to the White House, claiming such



He warned that bringing Ukraine into NATO's ranks 'would be tantamount to initiating World War III." "We believe that Ukraine would not be able to add to European security in its present situation, but rather, as a country at war, inviting Ukraine into NATO

we would risk ... the threat of war, namely, the threat of a NATO-Russian war," Szijjártó told a news conference. The meeting of NATO foreign ministers came as Russia makes advances on the battlefield in Ukraine while Kyiv's Western supporters seek to improve its position before Trump takes office in January. Trump has criticized the billions the Biden administration has spent in supporting Ukraine and has said he could end the war in 24 hours, comments that appear to suggest he would press Ukraine to surrender territory that Russia now occupies. Leaders of the 32 NATO member countries have declared that Ukraine is on an "irreversible" path to membership.

# Controversial presidential front-runner wants Romania to be 'self-sufficient power'

Sitting at his desk in an isolated compound north of Bucharest, presidential front-runner and far-right populist Calin Georgescu says Romania's Western alliances remain secure providing they "serve the sovereignty of the country and nothing else." Georgescu unexpectedly topped the polls in the first round of the Romanian presidential vote on November 24, despite being a huge outsider, plunging the European Union and NATO country into unprecedented turmoil.

On Sunday, he will face reformist Elena Lasconi of the Save Romania Union party in a final vote. "I am interested in us being a sovereign and self-sufficient power,"



the 62-year-old independent candidate told The Associated Press on Wednesday. "Freedom and independence come from the ability to finance yourself, not from being financed by others."

His vision for his country's future lies in a series of Romania-first policies in a push to become self-reliant in areas such as energy, food, and water. Other key

issues he wants to address if he wins the presidency, he said, span tackling high poverty rates, organised crime, and drug use in schools.

Georgescu unexpectedly topped the polls in

the first round of the Romanian presidential

vote on November 24, despite being a huge

outsider, plunging the European Union and

NATO country into unprecedented turmoil.

"Our children are dying from drug use," he said. "It's unimaginable." Georgescu is also a self-professed Donald Trump supporter and says the incoming US president "knows what he wants. he loves his people, he put America first, just like I put Romania first ... we have the same ideology.'

His success has left Western allies on edge. In the past, Georgescu — who declared zero campaign spending - praised Russian President Vladimir Putin as "a man who loves his country" and called Ukraine "an invented state." Still, he claims not to be pro-Russian. He has also courted controversy for describing Romanian fascist and nationalist leaders from the 1930s and 1940s as national





# FACT-CHECK: Is Ultraviolette F99 really the Fastest Indian? Or is it a Marketing Gimmick?

Is Ultraviolette's, or even TVS Racing's, bettering local tuners' drag race times even worth celebrating?

Itraviolette, an electric motorcycle maker in India, shared a press release today stating that its F99 superbike (yet to be launched) has broken the previous official (approved/certified by FMSCI) "Fastest Quarter Mile for an Indian Motorcycle" record at The Valley Run, held at Aamby Valley on the 1st of December this year. The release mentions that the Ultraviolette F99 achieved a time of 10.712 seconds for the quarter mile "to better the previous record set in 2022" [sic]. However, it didn't mention anything about that previous record.

The release also mentions that this (its quarter mile record) is the first of two records that Ultraviolette intends to set in the next few weeks. The second one would be an attempt to break the 'Highest Top Speed for an Indian Motorcycle' record. But, there is a problem with these claimsthe FMSCI regulations.

### **FMSCI TWO-WHEELER TECHNICAL REGULA-**TIONS, DRAG RACING, 2024

The Federation of Motor Sports Clubs of India (FM-SCI), in its Two-Wheeler Technical Regulations for Drag Racing, 2024 (clause number 2.1.3) mentions an "Indian Two-Wheeler" as "a two-wheeler manufactured in India and is available for sale to the public through the normal commercial outlets of the manufacturer in a minimum of two hundred (200) numbers of identical examples within a period of twelve (12) consecutive months. The two-wheeler may be wholly or partially manufactured and/or assembled in India from Indian and/or imported components.'

However, forget selling 200 units, the Ultraviolette F99 hasn't even been launched yet. Therefore, it the aforementioned FMSCI clause. I asked the Ultraviolette's PR agency about it, but didn't get a proper clarification from them at the time of filing this story. I will, of course, follow up with a second story with Ultraviolette's clarification, if I receive any.

The Pakistan Cricket Board (PCB) has accepted the hybrid model for the ICC Champions Trophy 2025 to be hosted by them, but has put forward a condition to let them play their games under a hybrid model as well whenever a global International Cricket Council (ICC) tournament is held in India, reported ESPNCricinfo.

Though discussions on the matter are ongoing and the situation stays fluid, as per ESPNCricinfo, PCB put forward their proposal during the weekends in meetings with ICC and the Board of Control for Cricket in India (BCCI) in Dubai.

PCB was seeking a long-term agreement that would go beyond the 2025 CT, with provisions for Pakistan to play outside India during ICC tournaments. However, it is yet to be decided if such provisions are for the next three years or till 2031, which will mark the end of the current rights cycle

Till 2031, India is supposed to host three major men's tournaments, the 2026 T20 World Cup with Sri Lanka

seeks similar ICC terms for India in February, the 2029 ICC Champions Trophy in October and the 2031 ICC Cricket World Cup along with Bangladesh from October-November. In women's cricket, they will host the 50-over women's World Cup next year.

The next Asia Cup, scheduled for October 2025, is also scheduled to be held in

> Previously on Sunday, PCB chairman Mohsin Naqvi said that, "We will do what's best for cricket. It is definitely not a hybrid formula, but if a new formula is formed, it will be an equal one," Naqvi told reporters, as quoted from a video posted by PCB media on X.

"A one-sided arrangement is no longer acceptable. It cannot be the case that we continue to go to India, but they do not visit Pakistan. Whatever happens must be on the basis of equality," he added.

Though BCCI stays tight-lipped, there are indications that it would not accept a hybrid model for the tournaments hosted by the

Pakistan named its playing XI on the eve of the third T20I of the series with a couple of changes. Along with other changes, Haris Rauf, Abrar Ahmed and Irfan Khan Niazi have also been rested for the final T20I of the series.

Qasim Akram, Arafat Minhas and Mohammad Hasnain have been included as their replacements for the third T2OI against Zimbabwe. Qasim, 22, has represented Pakistan in three T2OIs and has yet to make a major impact in the international circuit.



Saim Ayub, Haris Rauf, Abrar Ahmed and Irfan Khan Niazi have been rested for the final T20I of the series.

Arafat, a 19-year-old leftarm spinner, also has three T20I appearances to his name, with four scalps to his name.

Mohammad Hasnain holds a fair amount of experience, with 27 T2OI appearances under his belt and 25 wickets in his kitty.

Salman Ali Agha will continue to lead Pakistan in the absence of Mohammad Rizwan. Omair Yousuf, Usman Khan, Tayyab Tahir, Jahandad Khan, Abbas Afridi and Sufivan Mugeem have retained their spots in the playing XI.

Pakistan took an unassail able 2-0 lead in the series after sealing a thumping 10-wicket win in the second T20I on Tuesday. Zimbabwe succumbed to

a meagre total of 57, their lowest T20I total. Young ball tweaker Muqeem was the architect behind Zimbabwe's downfall, which left the hosts "hurting."

Muqeem's success was attributed to his exceptional pace variation, along with his effective use of top spin and googly, which left Zimbabwe's batting line-up in crumbles.

In his remarkable 2.4-over spell, Muqeem claimed a five-wicket haul, giving away just three runs.

Pakistan's tour of Zimbabwe will conclude on Thursday, and after that, they will shift their focus to the South Africa tour, which will begin on December 10.

# India reach final with 3-1 win over Malaysia in Men's Junior Asia Cup

The Indian Junior Men's Hockey Team took on Malaysia in the semi-final of the Men's Junior Asia Cup on Tuesday in Muscat and defeated them 3-2 to advance to the Final, as per a release from Hockey India.

Dilraj Singh (10'), Rohit (45') and Sharda Nand Tiwari (52') found the back of the net for India in the tie while Kamaruddin Azimuddin(57') scored a consolation goal for Malaysia towards the end of



the game.

Malaysia started the game on the front foot, quickly earning a penalty corner. However, the Indian defence stood firm. Moments later, Captain

Che Nur Aqilrullah forced India's goalkeeper Bikramjeet into action with a powerful shot.

The growing pressure resulted in another penalty corner for Malaysia, but once again, Kamaruddin Azimuddin's flick was saved. India looked to transition quickly from defence, and in the 10th minute, Araijeet Singh Hundal found Dilraj Singh in the shooting circle. Dilraj turned around and, while off balance, bypassed the Malaysian goalkeeper Mohamad Rafaizul with a powerful shot to grant India the lead.

Malaysia didn't show any signs of discouragement as they took the pitch in the second quarter and maintained their grip in the game, earning a couple of penalty corners but India bayed their advances and continued to threaten Malaysia with frequent counterattacks. Indian forwards Araijeet and Gurjot Singh were at the end of significant goalscoring opportunities but failed to capitalise and the first half ended 1-0 for India.

India pushed forward to double their lead in the third quarter but Malaysia closely marked all Indian players and fought for every loose ball to keep the tie within their reach.

# Shreyas Gopal registers joint-most hat-tricks by Indian bowler in T2Os

Karnataka spinner Shreyas Gopal levelled with compatriot Amit Mishra to register the most hat-tricks by an Indian bowler in T20 cricket.

Gopal reached this accomplishment during his side's Syed Mushtaq Ali Trophy match against Baroda on Tuesday.

During the game, while defending a total of 170 runs set on the back of a fine half-century from Abhinav Manohar (56 in 34 balls, with six sixes), Karnataka seemed to be in trouble with Baroda at 102/1 in 10 overs. Gopal, bowling his second over, turned the game on its head by removing Shashwat Rawat for 63



in 37 balls, with seven fours and two sixes. It was followed by him getting scalps of Pandya brothers, Hardik and Krunal for golden ducks, which earned him a hat-trick and his team a chance to win the game.

Gopal's figures of 4/19 ultimately went in vain as wicketkeeper-batter Vishnu

Solanki remained unbeaten on 28 to guide his team to a four-wicket win with seven balls left. Gopal now has the secondmost hat-tricks by any bowler in T20 cricket, tying with Mishra. One of his hat-tricks was during the 2019 edition of the Indian Premier League

(IPL) when playing for Rajasthan Royals (RR) against Royal Challengers Bengaluru (RCB), he removed Virat Kohli, Marcus Stoinis, and AB de Villiers. He also has a hat-trick against Haryana from the 2018-19 season.

The most hat-tricks by a bowler in T2Os are by star Afghanistan spinner Rashid Khan, who has a total of four hat-tricks in T2Os.
