# MANIPUR CM SAYS SORRY FOR ETHNIC STRIFE, HOPEFUL OF PEACE

"We now have to forget past mistakes and have to start a new life: I hope with the New Year, normalcy and peace will be restored in state"

"Apologising" for the ongoing crisis in the state in which around 200 people have died and many left their homes, Chief Minister N Biren Singh on Tuesday asked people to "forget the past" and start a new life for peaceful and prosperous Manipur.

The violence in Manipur between the Meitei and the Kuki communities erupted after a rally by the All Tribal Students Union of Manipur (ATSUM) on May 3, 2023, following the Manipur High Court order directing the state to consider the inclusion of the Meitei community in the Scheduled Tribes list.

Reflecting on the crisis, the Manipur CM said, "This entire year has been very unfortunate. I feel regret and I want to say sorry to the

people of the state for what is happening till today, since last May 3."

"Many people lost their loved ones. Many people left their homes. I really feel regret. I would like to apologise," he added.

Singh further appealed to the various communities in the state to "forget past mistakes and start a new life".

"Now, I hope after seeing the last 3-4 months' progress towards peace, I hope that with the New Year 2025, normalcy and peace will be restored in the state. I want to appeal to all the communities of the state that whatever happened has happened. We now have to forget past

Manipur Chief Minister further said that till date about 200 people have died and around 12,247 FIRs have been registered in the state. Addressing a press conference, Singh noted that 625 accused were arrested and around 5600 arms and weapons were also recovered.

He further stated that the central government has provided funds to construct new houses for the displaced persons.

"Till now, altogether roughly 200 people have died, and around 12,247 FIRs were registered, and 625 accused were arrested, and around 5,600 arms and weapons were included, and around 35,000 ammunitions were recovered. Good progress is there in tackling the issues. The central government has provided enough security personnel and enough funds to help the displaced families and enough funds to construct new houses for the displaced persons," the Manipur CM stated.

## Bhagat Singh Gallery in Lahore's Poonch House opened

The Punjab government in Pakistan has inaugurated the Bhagat Singh Gallery in the historic Poonch House, Lahore, where the iconic freedom fighter's trial took place 93 years ago. The gallery, which opened to tourists on Monday, was inaugurated by Punjab Chief Secretary Zahid Akhtar Zaman.

The gallery features an extensive collection of historical artifacts, including photographs, letters,

newspapers, trial details, and other memorabilia related to Bhagat Singh's life and struggle for independence. Zaman highlighted that the gallery was made accessible through collaboration between the Punjab government's departments of industry, commerce, and tourism. He added that the Poonch House building has been restored to its original state to honor its historical significance.

Earlier in 2018, the Punjab Archives Department displayed key records,



including his execution certificate, letters, photo-

graphs, and newspaper clippings. The new gallery expands on these exhibits, offering visitors a deeper insight into Singh's life and his fight against British colonial rule.

Bhagat Singh, along with his associates Sukhdev and Rajguru, was tried and convicted for the assassination of British police officer John P. Saunders. He was executed on March 23, 1931, at the age of 23, in Lahore's district jail. Documents in the gallery reveal details of his petitions, including

requests for court orders, interviews with his father, and access to newspapers and books during his imprisonment.

One notable document,

one notable document, signed by the jail superintendent, certifies Singh's execution, confirming that all procedures were followed, and no errors occurred. The revolutionary's applications notably ended with the phrase "Yours etc. etc." instead of conventional closings, reflecting his defiance against oppression.

# Uniform Civil Code BJP's manifesto, pending with law panel: Law Min Meghwal

Expressing the government's intent to work towards bringing Uniform Civil Code, Law Minister Arjun Ram Meghwal on Tuesday said that UCC figured in the BJP manifesto for 2024 Lok Sabha polls and the party makes such a mention when it feels that the proposal can be implemented.

Meghwal said that UCC was being implemented in Goa and Uttarakhand has enacted a law for its implementation.

"The UCC was a part of BJP's manifesto, no doubt about it. We take up things in the manifesto when we think it is possible. States also worked on it. It was already implemented in Goa and Uttarakhand passed the act. The matter is pending with the Law Commission of India, other states are also interested," he said.

The terms of reference of the 23rd Law Commission, which was constituted earlier this year, included the Uniform Civil Code.



Prime Minister Narendra Modi had said earlier this month in Parliament that the government was exerting its force to have a "secular civil code". He made the remarks in Lok Sabha during his speech in a debate marking 75 years of India's constitution.

"There is a burning issue I wish to discuss, and that is the Uniform Civil Code! This topic was not overlooked by the Constituent Assembly either. The Constituent Assembly engaged in lengthy and in-depth discussions about the Uniform Civil Code. After rigorous debates, they decided that it would be better for whichever government is elected

in the future to take a decision on this matter and implement the Uniform Civil Code in the country. This was a directive from the Constituent Assembly, and Dr. Babasaheb Ambedkar himself had said so. However, those who neither understand the Constitution nor the country, and have read nothing beyond their hunger for power, are unaware of what Babasaheb had actually said. Dr Babasaheb Ambedkar had strongly advocated for the abolition of personal laws that were based on religious grounds," PM Modi had said.

"During the debates of that era, K.M. Munshi, a prominent member of the Constituent Assembly, emphasized that the Uniform Civil Code was essential for the unity and modernity of the nation. The Supreme Court, too, on multiple occasions, has stated the necessity of implementing a Uniform Civil Code in the country at the earliest and has even directed governments to work towards it.

## Glad Amit Shah has declared Wayanad tragedy as 'disaster of severe nature': Priyanka

In a communication, the Union Ministry of Home Affairs stated, "Keeping in view the intensity and magnitude of the Meppadi landslide disaster in Wayanad district, it has been considered by the Inter-Ministerial Central Team (IMCT) as a disaster of severe nature for all practical purposes."

The communication was shared by the Congress unit of Kerala on its official social media account on December 30.

"Following a request sub-

mitted by the delegation led by Wayanad MP Smt. @ priyankagandhi, the Centre has classified the Mundakkai-Chooralmala landslide in Wayanad as a disaster of 'severe nature,'" Kerala Congress wrote on X.

On December 5, Priyanka Gandhi Vadra and MPs from Kerala met Union Home Minister Amit Shah, urging the Centre to provide immediate relief to the landslide-affected people of Wayanad.

"We have given representation to the PM and Home Minister. The devastation in the area (in Wayanad) is complete. The people who are affected have lost absolutely everything.

## CBI court sends 5 accused to 3 years in prison in Telgi Bogus Stamp Scam

The Special Judge for CBI Cases on December 30 sentenced 5 accused persons namely Falguni Ben Babubhai Patel; Kishore Kumar Purshottambhai Patel; Prashant Nangappa Patil; Amzad Ali and Shailh Zakir Hussain to 3 years' Imprisonment with a total fine of Rs 2.5 lakh in Telgi Bogus Stamp Scam, the CBI said in a press release on Tuesday.

These individuals were found guilty under various sections of the Indian Penal Code (IPC), for offences of criminal conspiracy, forgery of stamps, cheating, forgery and making or possess-



ing forged documents, etc.

The case was registered by CBI on transfer of investigation of the case of CID Crime, Gandhi Nagar Zone, Gujarat. It was alleged that the accused persons (license & unlicense vendors) knowingly utilized/sold forged stamp papers, Court fee stamps, Share transfer stamps, etc. of various denominations in

the Ahmedabad and Surat area of Gujarat. The scam, which was uncov-

ered in 2001, involved the circulation of counterfeit stamps, a significant offence that had wide-reaching consequences for both the economy and the integrity of the public administration. The fraudulent activities were discovered during a raid on stamp vendors in Surat and Ahmadabad, where authorities seized a large number of bogus stamps. "The operation was traced to two offices operating under the names "Sadguru Services" and "Sahay Services."

In this case, the CBI had charge-sheeted a total of 16 accused. Out of these, two ac-

cused persons passed away during the course of the trial, while nine others were convicted earlier. The Court vide Judgment dt.

August 20, 2008, sentenced 5 accused namely, Shabbir Ahmed Sheikh, Shivaji, Khalid Ahmed, Vijay Solanki and Jacob Chako to undergo imprisonment for a term of five years and a fine of Rs 25000 each.

Later, vide Judgment dated March 19, 2009 the Court had sentenced 3 accused namely, Sadiq Ibrahim Hudli & AKL Telgi to imprisonment of 7 years and fine of Rs 35000 each and accused Sidharth @ Sidhu to undergo imprisonment for 5 years and a fine of Rs 30000.

### Former CBI inspector Rahul Raj stripped of Medal for Excellence

The central government has cancelled the Union Home Minister's Medal for Excellence in Investigation-2023 awarded to Rahul Raj, a former inspector of the Central Bureau of Investigation, following his arrest in an alleged bribery case in exchange for manipulating inspection reports for nursing colleges in Madhya Pradesh.

The decision to forfeit the prestigious medal comes after Raj was accused of accepting a bribe in exchange for manipulating inspection reports for nursing colleges in Madhya Pradesh. The Union Home Minister's Medal for Excellence in Investigation was awarded to Raj in 2023. This prestigious



upon Raj and 14 other CBI officers for their exceptional contributions to investigative work.

However, in May 2024, Raj was arrested by the CBI's Internal Vigilance Unit for allegedly accepting a bribe of Rs 10 lakh from Anil Bhaskaran, the chairman of Malay College of Nursing in Madhya Pradesh's Indore. The bribe was reportedly solicited in exchange for pro-

viding favourable inspection reports to nursing colleges affiliated with the Nursing Council of Madhya Pradesh. Following the arrest, the CBI terminated Inspector Raj's services on May 21, 2024, and initiated a comprehensive investigation into the matter. The agency's swift action underscored its commitment to maintaining integrity within its ranks.

In light of these developments, the Union Home Minister's Medal for Excellence in Investigation, which had been awarded to Raj in 2023, was subsequently cancelled.

## conviction rate in 2024 As per the agency, a total man

The National Investigation Agency (NIA) on Tuesday announced a record-breaking achievement for 2024, boasting a 100 per cent conviction rate with the conviction of 68 accused in 25 cases, a feat that underscores the agency's commitment to delivering justice and strengthening national security.

Officials attributed this success to rigorous investigations and meticulous legal strategies. The achievement marks a significant milestone for the NIA, further solidifying its reputation as one of the country's most effective investigative agencies.

As per the agency, a total of 210 accused were arrested across key categories of crimes in 80 cases registered by the NIA in 2024. Of these cases, Left Wing Extremism (LWE) and North East insurgency topped the list at 28 and 18 cases respectively.

Seven Jammu and Kashmir Jihadi cases were followed by six explosive substances and five human trafficking cases.

NIA further registered four other Jihadi cases, four Khalistan and two ISIS Jihadi cases, and one case each in gangsters, cyber terrorism, Fake Indian Currency Notes and others categories. Besides convictions of 68 accused in 25 cases, NIA said its impressive performance for 2024 was marked by charge sheeting of 408 accused.

A total of 137 properties worth Rs 19.57 crore were attached during the year as part of the agency's sustained efforts to dismantle the various terrorist, gangster and other criminal net-

works.
Left Wing Extremism (LWE) remained under NIA's scanner throughout the year, leading to a maximum of 69 arrests of the total 210 arrests reported in 2024.

Twenty-eight cases of LWE were registered, and 12 chargesheets filed against 64 accused in this category. North-east insurgency was also high on NIA's radar with 15 arrests.

Somanath. Speaking about the upcoming mission, Somanath added that this mission is just one of many planned for the upcoming year.

"In 2025, we have many missions. To start with, we have the mission of GSLV launching the NVS-O2 in the month of January," Somanath said.

Earlier, on May 29, 2023, the GSLV-F12 rocket successfully launched the NVS-01 satellite, weighing 2,232 kg, into Geosynchronous Transfer Orbit (GTO). According to an ISRO statement, the NVS-01 satellite featured an indigenous atomic clock and was designed to enhance the capabilities of NavIC, including L1 band signals for broader service coverage.

The NVS-O2 mission is likely to continue this progress, further strengthening the NavIC system with advanced fea-

The announcement was made by Somanath after the successful launch of PSLV-C60, which carried the SpaDeX and other payloads. Following the launch, Somanath highlighted the importance of docking for the Chandrayaan-4 mission, confirming that the final docking is expected to occur around January 7, 2025. "Chandrayaan-4 has multiple modules, five in total, which will be launched at

different times and integrated into two

separate modules. These modules need to reach orbit and then dock both in Earth orbit and Moon orbit. Docking is essential for Chandrayaan-4. This mission aims to go to the Moon, land there, return to Earth, and complete the journey successfully," Somanath explained.

He further added, "This is one of the proving grounds for Chandravaan-4 Docking will begin tomorrow, and many processes will take place, but the final docking will likely happen by January 7."

Somanath also celebrated ISRO's 99th launch, saying, "For us, this is the 99th launch of any launch vehicle from the Satish Dhawan Space Centre. It's a very significant milestone. We're preparing for the 100th launch at the start of next year. In this 99th launch, PSLV-C60 successfully placed two SpaDeX satellites, weighing 220 kilograms, into a circular orbit of 475 kilometers.'

He further explained that SpaDeX would undergo various operations starting tomorrow, working towards its docking condition, with the final docking expected by January 7, 2025. "This is not the first SpaDeX; there will be more varieties, including demonstrations of bigger and more complex versions of docking systems in the coming days," he added.

The SpaDeX mission, ISRO's year-end project, is historic as it aims to achieve the rare feat of docking or merging two satellites in space. The project is a cost-effective technology demonstration mission for inspace docking using two small spacecraft launched by PSLV.

The primary objective of the SpaDeX mission is to develop and demonstrate the technology required for the rendezvous, docking, and undocking of two small spacecraft (SDXO1, the Chaser, and SDXO2, the Target) in low-Earth circular orbit. Docking technology is crucial for long-term missions like Chandrayaan-4, the planned Indian space station, and the eventual manned Gaganyaan mission.

In 2015, Mahdi accompanied Nimisha Priya to Kerala when she came for a month-long holiday. During the visit, he stole a wedding photograph of Nimisha, which he later

manipulated to claim that he was married to her.

A plea moved by mother of Nimisha Priya had stated, "After a while, Nimisha's clinic began, Mahdi manipulated the ownership documents of the clinic. He also began to take money out of her monthly earnings after telling everyone that Nimisha was his wife Nimisha had alleged that Mahdi had been harassing her and her family for years. Mahdi also seized her passport. This was done to ensure that she would not leave Yemen. He tortured her under the influence of drugs. He threatened her at gunpoint several times. He took all the money from the clinic and her ornaments."

The plea further alleged

that unable to cope with the torture. Nimisha complained to the police in Sana but instead of taking action against Mahdi, the police arrested her and put her in jail for six days. It was further alleged that on her return from jail, the severity of the torture increased manifold.

After a long wait of four decades, the 'toxic waste' materials at Union Carbide factory located in Madhya Pradesh's capital Bhopal would be disposed of following the order of the MP High Court, an official said.

The process of packing the waste materials at the factory in the state capital began with full protection on Tuesday. The whole procedure was being done under the supervision of the officials of the Pollution Control Board. A tragic incident, touted as the world's worst industrial disaster, "Bhopal gas tragedy" had claimed the lives of several thousand people after deadly

gas leaked from the Union



40 years after Bhopal gas tragedy, 'toxic waste'

Meanwhile, an activist who works with survivors of the Union Carbide disaster, Rachna Dhingra alleged that the 337 MT waste was just one percent of the entire waste material and the waste (underground) which infected groundwater of around 40 settlements of Bhopal was still lying in the factory.

Carbide India Limited pesticide plant on the intervening night of December 2 and 3, 1984. 40 years after the tragic

incident, a total of 337 metric tons of waste materials at the factory will be transported to Pithampur in Dhar dis-

trict for its safe disposal. On the disposal of waste materials, Director of Bhopal Gas Relief and Rehabilitation Directorate, Swatantra Pratap Singh said, "Today, a procedure to dispose of the toxic waste of 337 metric tons lying on the premises of Union Carbide factory is underway in accordance with the order of principal bench of MP High Court Iabalpur dated December 3. It was instructed in the order that the 337 metric tonnes of waste should be disposed of in Pithampur within 4 weeks, where 10 tonnes of waste sample was already disposed of in 2015 on a trial basis." The reports of waste disposed there have been favourable and there has not been any adverse impact of it to the environment.

The plummeting temperature in Delhi has raised power demand to newer heights with December clocking a peak of 5,213 MW, the highest ever for the month, discom officials on Monday said. For the first time in Delhi's history, the peak power demand in December has crossed the 5,000 MW-mark.

As per the State Load Dispatch Centre (SLDC), power demand stood at 5,213 MW at 10:50 am on Tuesday, after touching 5,046 MW on Monday.

Delhi's peak power demand in December was 4,884 MW in 2023, and 4,964 MW in 2022, discom officials said.

stakeholders round the year have further helped to improve the general air quality in Delhi," CAQM said, highlighting the record achievement.

While the overall air quality saw improvement, January 2024 witnessed its worstever AOI at 355 due to still wind conditions.

### Shallow fog envelops city, minimum temperature drops

## Constable killed for rebuking drunk drivers: Chargesheet filed

An on-duty constable was killed in September allegedly for rebuking two people for drinking on the road in outer Delhi, according to a 400-page chargesheet filed by the Delhi Police.

According to the chargesheet, Sandeep Malik (30) was performing his night duty in civil clothes on September 29 when he spotted Dharmender (39) and Rajnish (25) drinking in a car in the Nangloi area.

An official, citing the chargesheet, said when Malik rebuked the accused, an argument broke out between them. They rammed their vehicle into Malik's bike, dragging it for 10 meters.

Following this, Sandeep suffered critical head injuries and was rushed to a hospital by the other policemen. Doctors declared him dead on arrival, officials said. The incident was captured on the CCTV camera, around 2.15 am.

A 400-page chargesheet was filed at Tis Hazari court on December 27. The police in



its chargesheet have made two people - Dharmender and Rajnish the main accused while two others - Jitender alias Jeetu and Manoj Shareman -- were named for harbouring Dharmender. A senior officer said that the police have made a watertight chargesheet to ensure justice for the constable and his family. Delhi Police had registered an FIR under sections 221 (obstructing public servant in discharge of his public functions, 132 (Assault or criminal force to deter public servant from discharge of his duty), 103 (murder), 249 (harbouring offender) and 3(5) (acts done by several persons in furtherance of common intention) of Bharativa Nyava Sanhita at Nangloi police station.

## Police detains 12 Bangladeshis living without identifications

She also noted that pensions for over

300,000 elderly citizens



have not been provided since 2015.

The BJP leader accused the Kejriwal government of failing to deliver on promises such as introducing 11,000 buses, building 500 schools, and establishing

20 universities. Instead, the city's transportation system is being supported by 940 e-buses provided by the central government. She also claimed that the metro expansion in Delhi has been unnecessarily stalled under

Sehrawat questioned the government's claims of installing 1.5 million CCTV cameras across Delhi, alleging a lack of transparency on the actual numbers. She highlighted the plight of contract workers, including guest teachers, municipal staff, and civil defense personnel, who are yet to be regularized. Farmers in rural areas of Delhi, she said, have been overlooked and denied official recognition under the AAP government.

Addressing issues related to electricity tariffs, she credit-

ed the Lieutenant Governor with curbing exploitation under PPAC charges, which eased the financial burden on citizens. Sehrawat criticized the Kejriwal government for the deteriorating state of the Yamuna River, calling it a drain within Delhi's borders. She also cited the poor state of health infrastructure, particularly in mohalla clinics within her constituency, which she described as being overrun by garbage and stray animals. She further criticized the condition of hospitals like Rawatula Rao and Indira

Gandhi, stating that they

to seek care at DDU Hospital. In education, she pointed out shortcomings such as only 700 out of 1,068 schools offering science education, the lack of principals in many schools, and the absence of the promised sports university.

On waste management, Sehrawat condemned the delay in clearing "garbage mountains," stating that Delhi has become increasingly polluted. She also criticized the Delhi Jal Board for failing to manage sewage and water supplies, with Dwarka experiencing sewage entering homes. ## **GOVT KEEPS SMALL SAVINGS RATES STEADY FOR JAN-MAR 2025**

The government has retained small savings scheme interest rates for January-March 2025, ensuring consistent returns for investors.

The central government has kept the interest rates unchanged on various small savings schemes for the January-March quarter of Financial year 2024-25, according to an official notification from the Ministry of Finance.

"The rates of interest on various Small Savings Scheme for the second quarter of FY 2024-25 starting from 1st January 2025 and ending on 31th march 2025 shall remain unchanged from those notified for the first quarter (1st October 2024 to 31st December 2024) of FY 2024-25," said the Finance Ministry in the notification.

### 'Decline in migrant workforce raising concerns on ruralisation'

The decline in migrant population to the workforce is raising concerns on ruralization as against urbanisation says a report by Systematix Institutional Equities.

The report says the decline in rural-urban migration has contributed to rising ruralization, with an increasing share of the population and workforce remaining in

rural areas. This shift has led to higher food demand, narrowing urban supplies, and persistent food inflation. The dependence on agriculture for employment has also grown, with 46.1 per cent of the workforce engaged in the sector in 2023-24, up from 42.5 per cent in 2017a rise in disguised unemployment and stagnation in rural wages, particularly among women, whose real wages declined by 2.3 per cent annually over the last five years. ## Indian startups hit a funding dip in 2024, but unicorns still shine bright

The Indian startup ecosystem experienced a rollercoaster ride in 2024, characterised by a slightyet-concerning decline in funding activity and a shift in investor sentiment, alongside a silver lining with several startups achieving unicorn status.

Despite facing global economic challenges, India's startups showcased remarkable resilience, adeptly navigating changing market conditions, while continuing to attract investments

According to data from Tracxn, Indian startups raised a total of USD 30.4 billion in funding throughout 2024, a 6.5 per cent decline from the USD 32.5 billion secured in 2023.

Despite this dip, the Indian startup ecosystem





demonstrated resilience, with several companies achieving unicorn status this year. Noteworthy entrants to the unicorn club include Rapido, Ather, Perfios, Porter, and Money View, highlighting ongoing innovation and investment interest in the sector.

The overall funding trend reflects a cautious-yetoptimistic approach from investors, as they navigate a more selective funding environment, while still recognising the potential of high-growth startups in

A slight shift towards early-stage investments was evident during the year, with seed and Series A rounds gaining traction, as investors sought to back innovative ideas with longterm potential.

"Businesses that could demonstrate robust underlying unit economics found greater favour this year," Dushyant Singh, Managing Partner at Playbook Partners, noted.

Gig economy, retail, and enterprise applications stood out as top-performing sectors, according to Traxcn.

Quick commerce emerged as a high-growth sector, with 40 active companies, including unicorns Zepto, Blinkit, and Swiggy Instamart, and promising newcomers Dunzo, Swish, and Farmako.

In July, the government announced the abolishment of the angel tax on investments in startups to provide a more conducive environment for growth.

"By eliminating this tax, the government has provided a much-needed boost to investors and entrepreneurs, enabling greater liquidity and more flexible funding options for startups. However, fewer funding rounds, high operational costs, and infrastructure challenges remain ongoing factors that need attention," said Jeenendra

Incubation and Innovation Foundation (JIIF).

There was an encouraging rise in women entrepreneurs and founders from Tier 2 and 3 towns. Ninad Karpe from 100X. VC said the entrepreneurial culture has transcended its traditional boundaries.

"The entrepreneurial culture has transcended its traditional boundaries, seeping into colleges. schools, and even Tier 2 and 3 towns. Founders from these regions are bringing fresh perspectives, solving hyperlocal problems, and creating opportunities that were previously untapped.

"There's a noticeable rise in women entrepreneurs, signalling a positive shift in inclusivity and diversity within the startup ecosystem," he said.

data, India has more than 73,000 startups with at least one woman director that have been recognised under the Startup India Initiative. Despite the positive

trends, challenges persist. Global economic uncertainties have a direct impact on investor sentiment and funding availability. "While the number of deals has seen a quarterly increase of 10-20 per cent... deal values have declined significantly. This reflects a cautious investment climate, with most funding rounds being either follow-ons by existing investors or bridge rounds aimed at extending the runway rather than driving growth. The focus has shifted from valuationdriven funding to sustainability and profitability," FAAD Capital CEO Aditya

A marker of Modi's hold over the BJP would be the election/selection of the new BJP chief as JP Nadda's term ends in January (end). Will he be able to appoint a person of his choice, or will the RSS hold sway. If you recall in the last few state elections, specially Haryana and Maharashtra it was the RSS that did the bulk of campaigning. It is also the RSS that has taken credit for the wins, leading to speculation that it had begun to assert itself within the BJP.

Kejriwal has refused to ally with the Congress in Delhi and Tejashwi Yadav is also not willing to cede too many seats to the Congress in Bihar.

Given that the INDIA bloc was formed for the Lok Sabha, it may survive these regional contradictions. But if it has to give a comprehensive challenge to the BJP in the next elections, now is the time to get its act together and come up with a common minimum program as well as a convenor. No use leaving these issues for the last minute.

inconsistencies. These words aptly describe the hypocrisy of being an empath and a human being including myself. Words like "take care", "I will call you soon", "I am here for you" mean nothing for the simple reason that it is difficult to think about others before thinking about yourself. Imagine having a heartbreak not out of lack of love or reciprocation of love but due to the lack of empathy. The phrase "acche logon k sath sabse zada bura hota hai" is true in today's time since a person who feels the emotions too deeply is already running in negative on the barometers of pragmatism. They are constantly reminded by the malevolent experiences that they must build their

boundaries, must think about themselves first and let people suffer for it's not your job to fix them. But a person who chooses to be empathetic everyday has done so because for him or her the world is not just a place to move mechanically or robotically. They have chosen to accept the many "hypocrisies" of being a human and still move forward with kindness and empathy in their hearts. And maybe they will lose again but not without spreading the happiness which at the end of day we all are craving for. As it has been beautifully portrayed in these words by Henri Nouwen-

The friend who can be silent with us in a moment of despair or confusion, who can stay with us in an hour of grief and bereavement, who can tolerate not knowing, not curing, not healing and face with us the reality of our powerlessness, that is a friend who cares." 

## TRIPURA HIGH COURT: PREVENTION OF ANIMAL CRUELTY ACT NEEDS TO BE SCRUPULOUSLY IMPLEMENTED

he Tripura High Court in the case Ms. Paramita Sen v. The State of Tripura & Ors observed and has remarked that the Prevention of Cruelty to Animals Act, 1960, Rules framed thereunder and the guidelines issued from time to time by the statutory authorities do need to be observed scrupulously at all levels by the concerned State authorities.

The Division bench comprising of Chief Justice Aparesh Kumar Singh and Justice Biswajit Palit was hearing the present matter.

The bench in the case directed the State authorities to ensure that such guidelines be once again circulat-

ed to the officers in the field so that cases of non-compliance of the provisions of the Prevention of Cruelty to Animals Act, 1960 (Act of 1960) and Rules framed thereunder by the officers at the ground level are not repeated again.

In the present matter, the court was hearing the Public Interest Litigation, PIL filed by an Advocate and an animal right activist working in the field of animal welfare activities as a member of the NGO, 'Society for Welfare of Animal and Nature, SWAN.'

The petitioner in the case drew the attention of the High Court to an incidence which occurred on July 25, 2024 at about 03:00 pm at Kamrangabari, Kailashahar,

en in future to ensure that the letter of the law in this regard is duly complied

The petitioner submitted before the court that the direction may be issued to the respondent-authorities to ensure that in future strict compliance of the provisions of the Act of  $1960\,and\,the\,Rules\,framed$ thereunder be carried out in matters of seizure and release of such seized animals.

ing the facts and circumstances of the case stated that, 'This court is of the view that the Act of 1960, the Rules framed thereunder and the guidelines issued from time to time by the statutory authorities do need to be observed scrupulously at all levels by the concerned authorities and the concerned respondents would also ensure that such guidelines be once again circulated to the officers in the field so that cases of non-compliance of the provisions of the Act of 1960 and Rules framed thereunder by the officers at the ground level are not repeated again.

## Punjab and Haryana High Court acquits man in rape case: Untorn clothes of alleged victim denotes consent

The Punjab and Haryana High Court in the case XXXX v. AXXX acquitted a man in rape case wherein the court observed that the discrepancy in the prosecutrix's testimony and that the alleged sexual intercourse was consensual as the clothes of the prosecutrix were not torn at the crime

The bench comprising of Justice Sureshwar Thakur and Justice Kirti Singh was hearing the present matter.

The bench in the case stated that, 'The existence of untorn clothes of the prosecutrix, at the crime site, also is magnificatory that, as such, the prosecutrix was a consensual partner to hers allegedly becoming subjected to sexual intercourse(s) at

the instance of the accused Arjun Singh, especially if she was a non-consensual partner to the sexual assault, thus, her clothes would have been torn, rather than her clothes being found in an untorn condition at the crime site.

In the present matter, the court was hearing an appeal filed against the man who is being convicted under section 376 (2) (g) of Indian Penal Code, IPC and has sentenced to undergo rigorous imprisonment for life. Another accused was also convicted under section

The bench noted in her previous statement she had stated she was wearing jeans and top and later she stated she was wearing suit.

376s (2) (g).

The court acquitted him wherein noting that the victim had turned hostile.

Further, the bench in the case noted that the prosecutrix deposed that she made hue and cry but 'went unnoticed on account of the accused bolting the doors of the room from inside, thus obviously becomes falsi-

The court also observed that the prosecutrix did not disclose about the event to anyone while coming back to her home from the place of incident 'thus naturally

bespeaks about hers being a consensual partner to the sexual assault, if any, as became perpetrated upon her person by the accused.'

The bench noted in her previous statement she had stated she was wearing ieans and top and later she stated she was wearing suit. The bench while consid-

ering the facts and circumstances of the case stated that the improvement or embellishment, as made by the prosecutrix during hers recording her testification before the learned trial Judge concerned, thus from

her previously recorded statement in writing before the police officer concerned. but leads to an inference that her rendered testification in Court, thus become unamenable for assigning of any credence thereto. In sequitur, the benefit thereof is to be assigned to the accused.

Accordingly, the court set aside the conviction.

### Allahabad High Court: 'Free-willed' wife meeting civil society members sans forming a illegal relation is not cruelty against husband TDG NETWORK

The Allahabad High Court in the case Mahendra Prasad vs. Smt. Bindu Devi observed that a 'free-willed' wife's acts of travelling alone or interacting with members of civil society without engaging in any illegal or immoral relationships cannot be considered an act of

cruelty against her husband. The bench comprising of Justice Saumitra Dayal Singh and Justice Donadi Ramesh was hearing the present matter.

The bench in the case stated that a conduct of wife of only seeking to keep alive a legal fiction of her marriage, without any reason to keep alive that relationship, and refusing to cohabit with her husband may amount to cruelty against the husband.

The court in the case observed and has allowed the lenge a family court's judgment and order wherein the court dismissed the divorce suit he had instituted.

However, the husband had pressed for a divorce decree on two grounds: mental cruelty and desertion by the wife.

It being the case of the appellant-husband that the parties got married in February 1990, and in Decem-

ber 1995, a male child was born to the parties.

The parties resided intermittently for a total of only 8 months and they last cohabited together in December 2001 (as per the wife).

The court observed that both the parties admitted that 23 years have passed since they last cohabited, and now they live separately.

It has been alleged by the husband before the court that his wife was in an adulterous relationship with another man, and she, being a appeal of husband to chalfree-willed person, would go out of her own to the market and other places and did not observe 'Parda'.

> It has also been submitted by him before the court that his wife used to pass on verbal insults to him due to his

poor economic status. Further, he claimed that such acts and other acts constituted cruelty against him. The High Court in its order

noted that the act of the wife,

being free-willed or a person who would travel on her own or meet up with other members of the civil society without forming any illegal or immoral relationship, may not be described as an act of cruelty committed.

The court noted that it was being disputed that the parties' marriage was arranged and the husband's family status was known to the wife, and still, the marriage was solemnised.

The court also observed that the normal relations have also existed between the parties and the act of insults that were allegedly caused by the respondent have neither been described with details of time or place of occurrence, nor such acts have been proven before the learned Court below. To that extent, this court find no error in the order of the learned Court below in not acting on the plea of insults caused by the respondent.

## Calcutta High Court: Employer cannot deduct excess amount from retiral benefits paid to employee on erroneous fixation of pay scale

The Calcutta High Court in the case observed and has held that the employer cannot deduct or adjust the excess amount paid to the employee on erroneous fixation of pay scale from the retiral benefits.

The Division bench comprising of Justice Harish Tandon and Justice Prasenjit Biswas was hearing the present matter.

#### **BACKGROUND OF THE FACTS**

On March 26, 1996, the respondent employee was

being appointed as a lecturer in Ramkrishna Mission Shilpapitha, Belgharia, Kolkata. From December 21, 2013, he attained superan-

The employee was allowed Career Advancement Scheme, CAS benefit from March 26, 2001 and the second CAS from March 26, 2006. It has been observed by the

appellant authorities that at the time of joining the post, the employee did not have the M. Tech. degree which was obtained on March 25, 1996. In view of the order dated October 24, 2007, the

employee was entitled to a first CAS only after successfully completing 6 years of service and accordingly, the second CAS should have been awarded after lapse of further period provided. The appellant noticed the erroneous fixation of scale of pay by the extending benefit under the CAS. The authorities asked for the refund of the excess amount

paid to the employee after he retired from the service. Aggrieved with the same, the employee filed the writ petition.

The single judge ruled in favour of the employee by

holding that the authorities cannot recover excess amount paid to the em-

Aggrieved with the same, the authorities filed an appeal against the order of the single judge

It was contended by the appellant before the court that the service book was not forwarded to the authority before the superannuation of employee and as soon as the discrepancy was detected, it was immediately notified.

Further, the court contended that the lecturer must have possessed the

M.Tech. degree as on January 01, 1996 to avail the benefits of the Career Advancement Scheme but it was absent as the employee obtained the M.Tech degree on March 25, 1996 and therefore, was not entitled to the benefits of CAS.

On the other hand, it was contended before the court that the employee that while awarding the second CAS, a meeting was held on January 25, 2008 in presence of an Additional Director of the Department and 'no objection' was raised therein while extending the second

### The Allahabad High Court in the case observed that

a relationship between brother-in-law and sisterin-law (jija and sali) is immoral. The court stated that if

a woman is a major, the said relationship does not attract the offence of rape. The bench headed by Justice Sameer Jain in the case observed and has granted bail to an accused

i.e., Iiia who was booked under section 366, section 376, section 506 of the Indian Penal Code, IPC on the allegation that he enticed away his sisterin-law i.e., the wife's sister or saali under the false promise to perform marriage with her.

The counsel appearing for him argued before the single judge that his client had been falsely accused in the present matter.

It has also been submitted by him before the court

that an illicit relationship had developed between the sister-in-law i.e., the alleged victim and brotherin-law i.e., applicant, and when this fact came to the knowledge of the informant, he lodged the FIR of the present case.

Further, it was submitted before the court that the alleged victim is a major who had earlier denied the allegations in her Section 161 of Code of Criminal Procedure, CrPc statement.

Later, she changed the statement under Section 164 of Code of Criminal Procedure, CrPC and supported the prosecution's

On the other hand, the AGA though opposed to the prayer for bail, could not dispute the fact that the alleged victim is a maior and from the record, it could not be reflected that she was not the consenting party. The court in the case took into account the allegations made against the accused, the arguments advanced by both parties and the fact that the alleged victim initially denied the allegations against the applicant but later on supported the prosecution's case, wherein it is stated that she had developed a relationship with the applicant and married him. The court also emphasized that though their relationship was immoral, the relationship would not attract the offence of rape as the alleged victim is a major.

The court in the case considered the counsel appearing for the applicant had admitted that an illicit relationship was developed between the applicant and the victim.

The court noted that the accused applicant was arrested in July 2024 and has no criminal history.

Accordingly, the court allowed his petition and granted him bail.

## Punjab and Haryana High Court: Holding multiple inquiries on same allegations amount to violation of Article 21 of Constitution

The bench headed by Justice Sandeep Moudgil in the case stated that, 'The multiple inquires on same set of allegations would amount to violation of Article 21 of the Constitution of India added with the fact that the petitioner has

stipulated period.' It was alleged before the court that the petitioner Ajay Kumar along with

others was involved in committing embezzlement for an amount of Rs. 3.17 lakhs by floating tender of Rs. 4.20 lakhs.

The Senior counsel appearing on behalf of the petitioner argued before the court that multiple inquiry on the same set of allegations levelled by

## Court issues warrant to detain impeached President Yoon

A Seoul court on Tuesday approved a warrant to detain former South Korean President Yoon Suk Yeol. who was impeached over his failed attempt to impose martial law, according to a report by Yonhap News Agency.

Notably, this marks the first instance of a sitting president in the country facing arrest.

The report stated citing sources, that the Seoul Western District Court granted the Corruption Investigation Office for Highranking Officials (CIO) permission to issue the warrant.

Yoon was impeached by the National Assembly over his attempt to impose martial law in the country on December 3.

The court also authorized a warrant to search Yoon's presidential residence in Yongsan, Seoul, as part of the ongoing investigation. The CIO sought the detention warrant after Yoon failed to comply with three separate summonses for questioning regarding the brief martial law enact-



CIO officials are expected to execute the warrant soon. Once detained, the agency will have 48 hours to decide whether to request an arrest warrant for extended detention or release him. Detention warrants are typically valid for seven days.

While issuing the warrants, the court rejected Yoon's claims that the CIO lacks jurisdiction over insurrection cases and that the warrant request was therefore illegal. The court also dismissed Yoon's claims that he couldn't attend questioning sessions because arrangements for his personal safety and security detail, as the president, had not been made, Yonhap reported.

### Taliban orders all NGOs to stop employing women or face closure

### Berlin police arrests man after knife attack injures 2

Two people were wounded in a knife attack in western Berlin, police in Germany's capital said Tuesday.

The New Year's Eve stabbing took place in the western district of Charlottenburg, a police spokeswoman

Emergency services were alerted shortly before 12 p.m. local time (11:00 UTC/

The Berliner Morgenpost newspaper reported that the attack began inside a supermarket on the corner of Quedlinburger Strasse and Sömmeringstrasse. Police said the knifeman then moved outside to the sidewalk close to a nearby hotel.

The suspect, a Syrian national who lives in Sweden, is said to have stabbed his victims with a knife he stole from the supermarket, police said in a statement.

The Berliner Zeitung (BZ) reported that several passers-by pounced on the attacker and overpowered him until the police arrived. The paper described how the suspect had apparently "stabbed wildly."

Two people were hospitalized and the suspect was later arrested.

Police later said one of the victims remains in hospital, the other was released after outpatient treatment.

"Initial findings indicate that the suspect may have signs of mental illness and that there is no indication for a terrorist motivation," police spokeswoman Jane Berndt told The Associated

## RUSSIAN MISSILE, DRONE ATTACK ON **UKRAINE HITS MULTIPLE TARGETS**

Russia launched an aerial attack on Ukraine on Tuesday, striking the capital and other regions with multiple missiles and drones.

Ukraine's air force reported a ballistic missile threat at 3:00 a.m. (0100 GMT), with at least two explosions heard in Kyiv minutes later. Another missile alert was issued at 8:00 a.m. followed by at least one explosion in the city. Missile debris fell in the Darnytskyi district of the capital with no reports of casualties or damage, the local administration said.

Authorities in the northeastern Sumy region reported strikes near the city of Shostka, where the mayor, Mykola Noha, said 12 residential buildings had been damaged as well as two educational facilities. He said some "social infrastructure objects" were destroyed, without providing detail.

The air force also reported missiles and drones targeting several other regions of Ukraine.

In Moscow, the Russian Defense Ministry said that its forces successfully struck a Ukrainian air base and a gunpowder factory.

Around half of Ukraine's energy infrastructure has been destroyed during the war, and rolling electricity blackouts are common and widespread.

Kyiv's Western allies have provided air defense systems to help Ukraine protect critical infrastructure, but Russia has sought to overwhelm its air defenses with combined strikes involving

Trinidad and Tobago declares emergency

The decision came after several people were killed in the gun violence during the weekend, taking the murder toll in Trinidad and Tobago in 2024 to 623 - the highest level in police records dating back to 2013, according to CNN report.

According to the US Government Accountability Office (GAO), Trinidad and Tobago which has a population of 1.5 million has one of the highest murder rates in the Caribbean, along with Jamaica and Haiti, while violent deaths in the region are nearly three times the global average. Police has warned they expect the amount of gang-related violent crime involving powerful assault weapons to rise.

While addressing a briefing on Monday, Acting

Attorney General Stuart Young said that there had been 61 homicides so far in the month of December, according to CNN report. These included a shooting incident on Saturday, which involved a high caliber automatic weapon outside a police station that claimed the life of one person and an incident less than 24 hours later in which five people were killed and one injured in the Port of Spain area.


