### Delhi liquor scam: ED gets MHA grant to prosecute Kejriwal, Sisodia

The Union Ministry of Home Affairs (MHA) has authorised the Enforcement Directorate (ED) to initiate prosecution against former Delhi Chief Minister Arvind Kejriwal and former Deputy CM Manish Sisodia under the Prevention of Money Laundering Act (PMLA) for their alleged involvement in money laundering linked to the liquor scam case, official sources said on Wednesday.

The sanction order against these Aam Aadmi Party (AAP) leaders were received earlier this month in a fresh development to the case per-



tains to the alleged irregularities in the now-scrapped Delhi liquor policy for 2021-22.

The move comes as the two leaders are out on bail in the case as the Supreme Court in September last year ordered Arvind Kejriwal to be released on regular bail as well as Manish Sisodia a month ago in August in cases linked to the alleged Delhi liquor policy scam.

The development is significant as a special PMLA court in Delhi had delayed the framing of charges against Arvind Kejriwal after he challenged the trial court's decision to take cognizance of the chargesheet in the ab-



# FARMERS' PROTEST: SC QUESTIONS PUNJAB'S CLAIM ON DALLEWAL'S HEALTH

The apex court directed the Punjab government's chief secretary to submit Dallewal's latest health reports to the court registrar by the end of the day.

xpressing concerns over the deteriorating health of farmer leader Jagjit Singh Dallewal, who has been on an indefinite hunger strike for over 49 days, the Supreme Court has sought his medical reports to be evaluated by the AIIMS medical board.

During the hearing a bench comprising Justices Surva Kant and N Kotiswar Singh questioned the Punjab government's submission that Dallewal's health is "improving," despite his prolonged fast. "How can someone's health parameters improve after nearly 50 days of fasting? Where are the latest test results?," the bench remarked. The apex court directed the

The inauguration was attended by key figures, including current National President Mallikarjun Kharge, Leader of Opposition in the Lok Sabha Rahul Gandhi, his sister Privanka Gandhi, and several other

The advisory came as a thick layer of fog covered parts of Delhi early in the morning, significantly reducing visibility across the city. The city is experiencing cold waves, which are contributing to elevated levels of air pollution.

The Air quality in the national capital plummeted to the 'very poor' category. According to the Central Pollution Control Board (CPCB),

the AQI was recorded at 344 in Delhi today at 7 am. Yesterday, at the same time, it was 252. According to CPCB data, Lodhi Road recorded an AOI

of 287 (IITM) and 291 (IMD). Major Dhyan Chand National Stadium reported 368, Mandir Marg 378, Mundka 372, and NSIT Dwarka 242. Najafgarh recorded 255, Narela 377, Nehru Nagar 394, and North Campus, DU 382 (IMD). Okhla Phase-2 reported an AQI of 380, Patparganj 390, and Pusa recorded 355. RK Puram reported an AQI of 373, Rohini 399, Shadipur 313, and Sirifort 360.

Attorney General Asaduzzaman has called for removing "secularism" from the Constitution, citing Bangladesh's 90% Muslim population.

The Centre recently amended the Conduct of Election Rules, 1961, based on the recommendations of the poll panel.

The Central government amended Rule 93 of the Conduct of Election Rules, 1961, to limit public access to certain electronic documents with the purported aim of preventing the misuse of electronic election records. It amended Rule 93(2)(a) of the Conduct of Election Rules, 1961, to restrict the type of "papers" or documents open to public inspection.

According to Rule 93, which has now been amended, all "papers" related to elections shall be open to public inspection. However, the amendment inserts "as specified in these rules" after "papers".



As chief minister, Narendra Modi brought water to the parched regions of Gujarat by implementing various schemes, Union Home Minister Amit Shah said on Wednesday.

He was speaking after inaugurating or laying foundation stones of various projects worth Rs 241 crore at Ambod village in Mansa taluka of Gandhinagar district.

The schemes launched by Prime Minister Modi during his tenure as Gujarat CM helped raise groundwater levels and improve the quality of drinking water in north Gujarat, Shah

Among the projects launched on Wednesday was an artificial lake at Mahakali Mata temple at Ambod, a check dam and a barrage.

"After becoming Gujarat chief minister, Narendra bhai worked to quench the thirst of Gujarat. When I became MLA for the first time in 1997, all the



would seek permission for borewells, which was not granted because of the region being a dark zone where groundwater levels had dropped below 1,200 feet," he said.

Modi also successfully

dealt with the obstacles created by Congress in the completion of the Narmada dam project, Shah claimed. The check dam at Ambod will bring about a change in the lives of local farmers and children who suffer due to high fluoride levels in drinking water, the Union minister said.

The Gujarat government will also develop the 550-year-old temple at Ambod to give a boost to tourism in the region, he said.

# BJP-RSS did not have any role in freedom struggle: KC Venugopal on 'Indian state' remark the martyrs of the Indian

A political slugfest has broken out between the leaders of the BJP and the Congress over the "Indian state" remarks of the leader of the Opposition Rahul Gandhi in the run-up to the Delhi assembly elections.

All the 54 passengers who were hours ago rescued by the Indian Coast Guard (ICG) have been handed over to the Lakshadweep Administration authorities at Kavaratti Island, as per an official statement.

As per the release, on 14 January, at about 1430hrs, Indian Coast Guard (Lakshadweep), Kavaratti, received distress alert from the Lakshadweep Administration about a missing boat with about 54 passengers and 03 crew.

The vessel had departed Kavaratti at 12:15 AM on Wednesday for Suhelipar Island and was expected to reach by 9 AM.

Upon receiving the information, the Indian Coast Guard promptly launched

mission for the overdue boat through the Remote Operating Station (ROS) at Kavaratti and located the missing boat. It was ascertained that the boat had suffered engine failure and was stranded mid-ocean. Communication was successfully established with the stranded boat and the details were relayed to Indian Coast Guard ship, which was diverted to the

boat's position at maxi-

mum speed to assess the

situation and provide as-

sistance, it added. At approximately 4.30 pm, ICG ship reached the adrift boat, located about four nautical miles off Suhelipar Island. The ship's boarding team assessed the situation and safely embarked all 54 passengers onboard for further transfer to Kavaratti Island. The passengers were reassured and were provided with emergency care. At around 9 AM on January 15, the passengers

# GRAP 4 curbs imposed in Delhi-NCR as AQI dips

The Centre's panel on Delhi-NCR's air quality on Wednesday invoked curbs under stage 4 of the Graded Response Action Plan (GRAP) amid a sharp dip in air quality due to unfavourable meteorological conditions, according to an official order. Calm winds, low temperatures and foggy conditions allowed accumulation of pollutants in the region, with the air quality index soaring from 275 on Tuesday to 396 at 6 pm on Wednesday.

The India Meteorologi-

cal Department and the Indian Institute of Tropical Meteorology predicted that AQI may breach the 400 mark soon. Accordingly, the Commission for Air Quality Management (CAQM) directed authorities in Delhi-NCR to "straightway invoke" all actions under stages 3 and 4 with immediate effect.

Stage 4 curbs include a ban on all construction activities, entry of non-essential polluting trucks into Delhi, and mandatory shifting of school classes, except for classes 10 and 12, to hybrid mode.

Non-essential diesel trucks are prohibited from entering Delhi, while Delhi-registered BS-IV and older dieselrun heavy goods vehicles are banned, except for essential services under Stage 4.

During winters, the Delhi-NCR region enforces restrictions under GRAP, which categorizes air quality into four stages Stage 1 (Poor, AQI 201-300), Stage 2 (Very Poor, AQI 301-400), Stage 3 (Severe, AQI 401-450), and Stage 4 (Severe Plus, AQI above 450).

Unfavourable meteorological conditions, combined with vehicle emissions, paddy-straw burning, firecrackers, and other local pollution sources, lead to hazardous air quality levels in Delhi-NCR during

### fog spell, IMD issues orange alert TDG NETWORK

Dense fog engulfed parts of the national capital on Wednesday, marking the season's first intense fog spell lasting three hours, which disrupted the schedules of over 100 flights and 26 trains due to low visibil-

The fog significantly reduced visibility during the morning hours, improved slightly in between and then once again shrouded the city as evening approached.

"Delhi experienced very dense fog on the morning of January 15, with visibility dropping to zero at Safdar-

jung and IGI Airport from 8:30 am, persisting until 11:30 am," the IMD stated.

"This was the season's first instance of dense fog, and CAT-III operations extended beyond 9:30 am, with RVR at IGI Airport runways ranging between 75-300 meters during the peak fog period," it added.

By 12:30 pm, visibility had slightly improved to 250 meters at Safdarjung andd 400 meters at IGI Airport (Palam), with moderate fog prevailing at that time. The India Meteorological

Department (IMD) issued an orange alert for Delhi, with dense to very dense fog reported in several areas.

An orange alert is issued for bad weather that can disrupt rail and road services.

The minimum temperature dropped to 6 degrees Celsius, 1.4 degrees below normal, while the maximum temperature was recorded at 18.1 degrees Celsius, 1.8 degrees below normal.

# **US-INDIA TAX FORUM'S BUDGET REFORMS**

Rationalizing TDS, concessional tax rates, GIFT City to boost growth

s India gears up for the Union Budget 2025-26, the US-India Tax Forum--a specialized Tax Policy Forum under the US-India Strategic Partnership Forum (USISPF)--has presented an ambitious set of recommendations aimed at bolstering the nation's global economic standing.

Comprising around 200 member companies, the Forum serves as a platform for dialogue on critical tax policy issues, connecting Government of India policymakers, global tax experts, and the business community to champion innovative and forwardthinking tax reforms.

In response to invitations from the Ministry of Finance, the Tax Forum conducted multiple consultations and presented its recommendations on three occasions. These proposals are designed to attract fresh investments, simplify tax structures, and position India as a global growth

Tarun Bajaj, Chairperson of the US-India Tax Forum and former Revenue Secretary, said, "The Union Budget 2025-26 comes at a

critical juncture for India's economic trajectory. As global headwinds persist, it is imperative for India to prioritize reforms that foster investor confidence, simplify the tax regime, and provide targeted incentives for sectors with transformative potential.'

He added, "Recommendations like rationalizing TDS structures, extending concessional tax rates for greenfield manufacturing, and supporting GIFT City as a global financial hub address systemic challenges while opening avenues for sustainable growth."

One of the central recommendations focuses on rev-

olutionizing direct taxation. The Forum suggests simplifying the Tax Deduction at Source (TDS) structure to just two or three rates, reducing compliance burdens and enabling businesses to prioritize growth.

To enhance India's competitiveness, it proposes aligning tax rates for foreign bank branches with domestic banks and introducing a concessional 10 per cent tax rate on dividend income for Foreign

Portfolio Investors (FPIs) to attract capital inflows.

Furthermore, the Forum advocates for tax exemptions on dividends and financial transactions within GIFT City to transform it into a global financial hub.

The expansion of Safe Harbor Regulations (SHR) and a more efficient Advance Pricing Agreement (APA) process were also highlighted as critical measures for creating a predictable and transparent tax

environment. Sectoral growth is another priority area. The recommendations include extending concessional tax rates for greenfield manufacturing projects beyond March 2024, targeting high-growth sectors like renewable energy, semiconductors, and electric vehicles.

To strengthen the industrial ecosystem, the Forum also proposes introducing a reduced 15 per cent tax rate for Maintenance, Repair, and Overhaul (MRO) firms.

In the healthcare sector, reducing tariffs on critical life-saving drugs and extending exemptions for certain medicines under Patient Assistance Programs (PAP) are emphasized to ensure equitable access to essential treatments.

Additionally, targeted incentives for renewable energy manufacturers and measures to facilitate electric vehicle adoption were recommended to drive sustainability and innovation.

The Forum also suggests overhauling indirect taxation by simplifying the customs tariff structure to a three-tier system with rates of Oper cent, 5 per cent, and 10 per cent.

This alignment with international standards is expected to attract investments in key sectors such as electronics manufacturing. Recognizing the growing significance of digital economies, the Forum proposes introducing refund mechanisms for the Equalisation Levy (EL) in cases of revised tax liabilities and simplifying tax return forms for foreign companies without permanent establishments.

The USISPF's recommendations are not limited to immediate reforms but also chart a roadmap for India's sustained economic

growth. Simplifying tax structures, fostering sectoral advancements, and reducing compliance hurdles are seen as vital steps toward achieving the government's vision of becoming a USD 5 trillion economy. With the world's fastest-growing major economy, India is poised to leverage these reforms to solidify its position as a global leader.

Macquarie anticipates that the upcoming Union Budget may provide further impetus to the sector.



# High manufacturing cost led to surge in WPI inflation in Dec: Report

The reason for the surge in wholesale inflation in the country in December is due to an increase in manufacturing inflation, according to a report by ICICI Bank.

The report highlighted that inflation in manufactured products reached a 23-month high of 2.14 per cent YoY in December. Out components, 18 recorded positive inflation, while only three categories reported negative inflation. Core WPI, which excludes volatile food and fuel prices, also edged up slightly to 0.65 per cent YoY.

The report said, "Wholesale inflation rises led by manufacturing, December marks the third consecutive month of 9 per cent+ manufactured food inflation. Manufactured food inflation is now at a 32-month high of 9.7 per cent YoY". The Wholesale Price Index (WPI) inflation rose to 2.37 per cent year-on-year (YoY), higher than market estimates of 2.18 per cent. This marks a significant jump from November 2024's WPI inflation of 1.89 per cent.

On the other hand, the report pointed out that the lowest inflation levels were observed in non-metallic mineral products (-3.0 per of 22 manufacturing sub-cent YoY), basic metals (-1.4 per cent YoY), and fabricated metal products (-1.3 per cent YoY).

> Within non-metallic mineral products, the decline was mainly due to cement, which recorded negative inflation of -6.8 per cent YoY. In the basic metals category, inputs for steelmaking, steel products, and metallic iron contributed significantly to the decline.

> The report also warned of potential upward risks to inflation in the coming months.

# UNITY IN DIVERSITY MUST CONTINUE TO **BLOOM IN BHARAT**

tional discourse is privy to multiple instances signifying unity and togetherness of not only humans but of other creatures as well. A wellknown English idiom 'birds of a feather flock together' signifies this. The phrase has been originally attributed to the ancient Greek storyteller Aesop, both directly in his fable "The Four Oxen and the Lion" and indirectly in "The Bundle of Sticks". Plato's Republic mentions that "Men of my age flock together". Many other cultures, namely, Russian, Japanese, Swedish, German and Chinese have proverbs having similar intent. The implication of these idioms may mean that people befriend those with whom they can serve common purpose or cherish common values of life. Unity amongst tiny ants and fishes, depicted during their movement, are also excellent examples for hu-

mans to emulate. Similarly, the phrase 'Unitfall' finds its reference in the biblical phrase from New Testament translated into English from the historic Greek as "And if a house be divided against itself, that house cannot stand". This implies that every kingdom or house divided against itself cannot withstand the complexities of the prevailing world order. This phrase is extensively used by many politicians in many different contexts, most often to promote unity, collaboration and cooperation. The proverb was also commonly used in India to garner support during freedom struggle, especially by A.C. Majumdar at the 1916 Lucknow session of Congress. The core concept of this proverb lies in the collective notion that if individual members of a certain group with common life values become selfish and work at the cross purposes at the cost of national interest, they are bound to fail as a civilization and will liable to be doomed.

The history of India's freedom struggle, both with the Mughals and the British imperialism, is plagued with several instances where disunity amongst Indians have either led to the defeat of the Kings attenuated the impact of the freedom struggle. Disunity amongst various Kingdoms, especially during the latter part of ancient India and in entire medieval period, has taken toll not only to the territorial integrity of Indian Subcontinent but also to its economy, social fabric, education and value system and helped ed we stand and divided we develop a western culture alien to its roots.

The lack of a united front against the Mughals and Britishers helped foreign powers to exploit disjunc-

ture and prevented a strong and focussed resistance. It is worthwhile to cite a few instances to corroborate this view. Ambhi Kumar, the King of Taxila in the 3rd Century AD is considered one of the biggest betrayers in the ancient history of India as he welcomed Alexander to India and gave up his territory to him. Had he kept the personal rivalry aside and joined forces with other kingdoms, Alexander would not have even dared to enter the Indian Subcontinent. Vijayanagar King lost to Mughal invaders in the battle because of the treachery of the two Muslim generals. Gilani brothers, who backstabbed and defected to the enemy camp with the army commanded by them. Prithviraj Chauhan, betrayed by his own father-in-law, Jaichand, lost to Mohammad Ghori at the battle of Terrain whom he had defeated several times in previous wars. Prithviraj Chauhan's defeat led to the establishment of the Sultanate in India. Mir Jafar, the commander of Siraj-ud Duhla, the last Nawab of Bengal, is considered the biggest traitor in the Indian history. He betrayed Sirajud Daulah, in the battle of Plassey, as he sided with Robert Clive for the greed of power. His betrayal led to the beginning of British imperialism in India. Robert Clive succeeded at the battle of Plassey, because Mir Jaffar betrayed his master Siraj-Ud-Daulah in the lure to become the Nawab. The fate had it and Mir Jaffar was replaced by Mir Qasim. Mansingh, a prominent Rajput king of the Kachwaha clan from Amber (presentday Jaipur, Rajasthan), was a trusted general in the Mughal Empire under Akbar and played a significant role in the defeat of Maharana Pratap in the battle of Haldighati that led to the expansion of Mughal influence in Rajasthan

and beyond. Mir Sadiq, betrayed Tipu Sultan during the Siege of Srirangapatana in 1999, paving the way for a British victory. Although the invading English troops were starving during the siege, Mir Sadiq withdrew his troops, facilitating British to launch a fresh attack on the fort. He also engineered the trapping of Tipu Sultan behind locked doors and subsequently to his capturing and killing.

Britishers used divide and rule policy, a political strategy, both for gaining and retaining power by capitalising on the disunity among potential opponents in India, most often by favouring individuals or groups while punishing those who succumb to their pressure. Terrified by the unity among the Indians during the revolt of 1857, and sensing that their dominance on Indian Subcontinent is at stake, Britishers used divide and rule policy to create gulf amongst the Indians on the basis of identities and sub-identities, and lured them with power and wealth. Besides, they incited identity sentiments amongst various communities to create gulf and to keep them separated, and even fuelled quarrels between them for ensuring longevity of their rule over

dispute out of its purview. They only have the support of long arm of law in civil courts based on the terms

of employment agreement which are dictated by the employer - being in position of dominance.

India Inc is in more anxious situation than before post Covid period since this was the time when Govt intervened and stipulated norms for Work From Home and this has shaken the typical Lala Baniya mindset of Indian Inc which is obsessed by quantity and control over quality and flexibility. As soon as the country recovered from ripples of Covid, most India corporates mandated five day physical office not realizing that going forward we need to have flexi work hours and hybrid office culture considering the traffic and climate rigours in present and future.

Right To Disconnect: Contrary to India Inc work culture, countries like France, Portugal, Ireland, Spain, Australia, Germany etc have some or the other form of Right to Disconbosses to send mails and seek work after closing hours, saving emergency situations. Most of these countries passed these laws post Covid. In India, however, even during Covid and the slump during 2009-10, the corporate world's profit may have gone down but it didn't take a cut on profit margin and pink slipped employees heartlessly. Such is the greed! While the world is moving towards work-life balance, it must lie well with India Inc to think about its sadistic work culture and coercive policies of requiring employees to work beyond 48 hours without additional pay.

Still, if India Inc finds it tough to deal with the work pressure, hire more employees and redistribute the work. Don't we have a great unemployment crisis? Let India Inc contribute to "Rashtra Nirman" by employing more people if there's abundant work requiring one to work beyond 48 hours a week.



# SUPREME COURT ISSUES NOTICE ON PLEA TO INCLUDE RAJASTHANI LANGUAGE AS MEDIUM OF INSTRUCTION IN RAJASTHAN SCHOOLS

he Supreme Court in the case Padam Mehta and another v. The State of Raiasthan and others observed and has issued notice wherein the petition is filed seeking to include Rajasthani as a language to impart education to children in schools. The petition filed also seek directions to include Rajasthani Language in the examination syllabus of Rajasthan Eligibility Examination for Teacher.

The bench comprising of Justice Vikram Nath and Justice Sandeep Mehta was hearing the present matter. The bench in the case observed and has issued notice to the State of Rajasthan, the Principal Secretary of the Education Department and the Co-

ordinator of REET returnable within four weeks. In the present matter, the Special Leave Petition was

filed against the judgment of the Rajasthan High Court which rejection the petition of petitioners. The High Court in the case

held that it cannot issue a writ of mandamus to include Rajasthani as a language for education since it was an educational policy matter. The court observed that

although the official language of the State is Hindi as per the Rajasthan Official Language Act of 1956, the petitioners point out that Rajasthani is widely spoken by about 4.36 Crores people as per the 2011 census

In 2021, the State Board of Education issued a notification stating that the medium of instruction



in schools will be Hindi/ English /Sanskrit /Urdu / Punjabi/Gujarati.

The petitioners in the case are aggrieved by the exclusion of Rajasthani. They also refer to Article 350A of the Constitution of India which impose an obligation on the State to provide adequate facilities for instruction in the mother tongue at the primary stage of education to children belonging to linguistic minorities.

It has also been argued before the court that 'Rajasthani' speaking people constitute a 'linguistic minority' in terms of Article 350A of Constitution of

The court also referred to Section 29(2))(f) of the Right of Children for Free and Compulsory Education Act, 2009 which state that the "medium of instructions shall, as far as practicable, be in child's mother tongue.'

The petitioners also emphasised that the issue is also a matter of preservation of cultural rights. It has also been highlighted before the court that the Rajasthani language has a rich literary and cultural heritage which needs protection.

Further, the National Education Policy also states that the medium of instructions for the children at least till Grade-V or preferably till Grade-VIII will be the mother tongue or local language wherever possible.

The petitioner in the plea also points out that the High Court had, in May 2024, directed the State to explore the possibility of inclusion of Rajasthani

in the forthcoming REET Examination.

In November 2024, the notification was issued for REET, Rajasthani was not included.

The petitioners also emphasised that the issue is also a matter of preservation of cultural rights.

It has also been highlighted before the court that the Rajasthani language has a rich literary and cultural heritage which needs pro-

It has also been argued before the court that the children speaking 'Rajasthani' as 'mother tongue' are suffering from discrimination in as much as the languages which are spoken far less spoken as 'mother tongue' are included in the REET Examination whilst the predominant language of 'Rajasthani' is not included in the REET Examination.

The petitioner in the plea argue that the High Court erred in not issuing a mandamus to the State when there was a failure on its part to discharge its obligations under Article 350A of the Constitution of India and when there was a clear case of discrimination against Rajasthani speaking population, the High Court ought to have intervened, the petition-

ers argue. The freedom of speech and expression under Article 19(1)(a) of the Constitution of India would include the right of a child to be educated in medium of instructions of her choice, and the medium of instruction till the Age of 14 (middle school) should normally be in 'mother tongue'.

It was also argued before the court that the State being a duty bound to impart education in the mother tongue of the child, especially when the imparting education till 14 years is the duty enjoined on the State by virtue of Article 21-A of the Constitution of India.

The counsel, Dr. Manish Singhvi, Senior Advocate and Advocates Apurv Singhvi, Shalini Haldar and DK Devesh, AOR appeared for the Petitioners.

# Section 113B of Evidence Act application: Supreme Court says dowry death cannot be presumed without clear evidence of incessant harassment

The Supreme Court in the case Ram Pyarey Versus The State Of Uttar Pradesh acquitted an accused of cruelty and abetment of suicide, wherein observed that to apply Section 113B (Presumption as to dowry death) of the Indian Evidence Act, clear evidence for incessant harassment is essential.

The court in the case stressed that in the absence of such evidence, it cannot straightaway invoke the said provision.

The concerned portion of section 113 B read as:

'Section 113B: The presumption as to dowry death - When the question is whether a person has rassment at the end of the Thus, the present appeal. of a woman and it is shown

such woman had been subjected by such person to cruelty or harassment for, or in connection with, any demand for dowry, the Court shall presume that such person had caused the dowry death.

The present appellant was the brother-in-law of the deceased.

The Court also drew a distinction between Section 113 A (presumption as to abetment of suicide by a married woman) and Section 113 B of the Evidence Act. The court while considering the facts and circumstances of the case stated that, 'It being relevant to note that under Section 113B, the Court may presume unlike Section 113A where the statute says that Court shall presume. This is a vital difference between the two provisions which raises presumption

the condition precedent is that there has to be first some cogent evidence as regards incessant harassment. In the absence of any cogent evidence as regards harassment or abetment in any form like aiding or instigating, the court cannot straightaway invoke Section 113B and presume that the accused abetted the commission of suicide.'

Accordingly, the court allowed the present appeal and has set aside the impugned orders.

The bench comprising of Justice JB Pardiwala and Iustice R Mahadevan was hearing the present matter. The bench in the case pronounced the judgement wherein the writ petition is filed by Rajeeb Kalita in

The bench headed by Justice Mahadevan orally pronounced the operative part that, 'This court have given enough number directions for the construction and maintenance of toilets and all other facilities for women, physically disabled persons, transgen-

The bench in the case pronounced the judgement wherein the writ petition is filed by Rajeeb Kalita in 2023.

der persons, etc. thus, the State Governments and of toilets and Union Territories shall allocate sufficient funds for the construction. maintenance and cleanliness of toilet facilities within the court premises. which shall be periodically reviewed in consultation with a committee constituted by the High Courts and a status report shall be filed by all the States, UTs and High Courts within a period of four months.

The copy of the judgment has been directed to be forwarded to the Chief Secretaries of all States or UTs and Registrar Generals of High Courts for strict compliance.

The bench headed by Justice Pardiwala orally remarked that contempt action will be taken in case of any default.

The bench reserved the judgement in November 2024, and has expressed disappointment at the fact that even lady judicial officers were not having private washrooms in many courts. The Supreme Court through an order dated May 08 sought the following directions from the

**High Courts:** 1. The availability of toilets for men, women, and transgenders;

2. The steps which need to be taken for maintenance of toilets;

3. Whether separate toilet facilities are made available to litigants, lawyers and judicial officers; and

4. Whether adequate facili-

ties for sanitary napkins dispensers are made available in women's toilets.

# Delhi High Court rejects PIL against CM Atishi for allowing Manish Sisodia to use govt bungalow

rejected the Public Interest Litigation, PIL filed by Sanjeev Jain, wherein he claimed to be a social worker and an RTI activist. The court stated that if any of the Rules are violated in the matter, the authorities are fully competent to take action as and when required. The court stated that, 'This court do not consider it apposite to pass any orders in the petition. If any Rules are violated, the concerned authorities are fully competent to take action as and when required. Dismissed.'

The petition filed refers to the government bungalow which was allotted to Manish Sisodia but was later in March 2023, it was allotted to Atishi after the former was arrested in relation to the liquor policy case. The Public Interest Litigation, PIL filed alleged that Manish Sisodia was sent behind jail in March 2023, yet his entire family continued to reside in the government bungalow, even after he resigned from his post.

The plea filed states, 'That it is also very surprised that when the above-mentioned bungalow has been allotted to Ms. Aathishi Merlena in the Month of March, 2023 and she was living in the area of Jangpura, New Delhi and she

never raised any objection of living Mr. Manshi Sisodia's family in the above mentioned bungalow.' It was also alleged before

the court that the action of the Chief Minister in allowing Sisodia to reside in her Government Bungalow is a 'clear-cut misuse of Government Property'. The PIL states that the same was a "sharp violation" of settled Rules and Regulation for allotment and vacation of the Government Property.

# GAZA CEASEFIRE STILL ELUSIVE AS **NEGOTIATORS TRY TO HAMMER OUT DEAL**

Officials from mediators Qatar, Egypt, US, Israel and Hamas said that the truce pact in the besieged Palestinian enclave and the release of hostages was closer than ever.

Tegotiators were trying to hammer out the final details of a complex, phased ceasefire in Gaza on Wednesday after marathon talks in Qatar aiming to end a conflict that has inflicted widespread death and destruction and upended the Middle East.

More than eight hours of talks in Doha had fuelled optimism. Officials from mediators Oatar, Egypt and the U.S. as well as Israel and Hamas said on Tuesday that an agreement for a truce in the besieged Palestinian enclave and the release of hostages was closer than ever.

But a senior Hamas official told Reuters late on Tuesday that the Palestinian group had not yet delivered its response because it was still waiting for Israel to submit maps showing how its forces would withdraw from Gaza.

During months of on-off talks to achieve a truce in the devastating 15-month-old war both sides have previously said they were close to a ceasefire only to hit lastminute obstacles. The broad outlines of the current deal have been in place since mid-2024.

over in Washington. Iwaya's visit follows a virtual call between Japanese Prime Minister Shigeru Ishiba, Philippine President Ferdinand Marcos Jr. and outgoing U.S. President Joe Biden where the three leaders affirmed their "trilateral arrangement" in deepening economic, security and technology cooperation in the face of growing tensions in the region.

# Graft case: Bangladesh's court acquits former PM Khaleda

Bangladesh's Supreme Court acquitted former Prime Minister Khaleda Zia in a 2008 corruption case on Wednesday, clearing the way for the ailing leader to fight parliamentary elections in the troubled South Asian country.

The verdict is the latest judicial victory for Khaleda and her family, one of two main groups that have dominated the country's politics.

A five-judge panel led by Chief Justice Syed Refaat Ahmed acquitted Khaleda, her son Tarique Rahman and others, overturning jail sentences handed down by the high court in 2018.

At the time Bangladesh was ruled by Khaleda's rival, Sheikh Hasina, who was ousted as prime minister in August, when mass protests forced her to resign and flee to neighbouring In-

The case, dating from 2008, accused Khaleda and others of stealing 21 million taka (\$173.000) in foreign donations for an orphanage trust set up when she was last prime minister, from 2001 to 2006.

Since August, Bangladesh has been ruled by an interim government led by Nobel Peace laureate Muhammad Yunus.

The BNP has called for general elections to be held by August in the greater interest of the country, citing growing political and economic instability.

Ukrainians use natural gas mainly for heating homes and cooking. The country uses gas stored over the summer months to use in winter, when daily production does not cover consumption.

Ukraine's underground gas storage facilities are located in the western part of the country, including in the Stryi area. Their role has grown since Kyiv refused to extend a gas transit agreement with Russia. Russia has stepped up its

bombardments of Ukraine's power sector and other energy infrastructure since March 2024, knocking out half of the available generating capacity and forcing long, rolling blackouts across the country.

Ukrainian cities, businesses, and residents rushed to install new generating capacities, including solar panels, batteries, generators, and other equipment to increase their energy independence and survive the critical cold months.

Zelenskiy, who visits neighbouring Poland on Wednesday, reiterated his pleas to Kyiv's Western allies to strengthen Ukraine's air defence.

"We have also discussed licenses for the production of air defence systems and missiles for them, which could serve as one of the effective security guarantees for Ukraine. This is both realistic and necessary to implement."

#### LA braces for more fire evacuations

As forecasters warn of another "particularly dangerous weather situation' across northern Los Angeles, residents braced for new wildfire evacuation orders, even as the official death toll from last week's fires in Altadena and the Pacific Palisades was expected to rise.

Los Angeles, and parts of Ventura county to the north, faced "extreme fire risk" warnings through Wednesday, with officials warning of "significant risk of rapid fire spread" due to the Santa Ana winds - which have gusts of up to 75mph - . The "particularly dangerous weather situation" designation is used very rarely, and was designed by meteorologists to signal "the extreme of the extremes". The winds were predicted to reach near hurricane-force in some ar-

"I don't want people to start thinking everything's OK now. Everything's not OK yet," the Los Angeles county sheriff, Robert Luna, said in a Tuesday morning press conference. "It is still very dangerous for the next 24 hours.'

As of Tuesday morning, 84,800 people had been warned they might be ordered to evacuate because of fire risk, while another 88,000 people remained under current evacuation orders. In the afternoon, officials said at least 25 people had died from the fires. More than 12,000 structures had been destroyed. Estimates put the cost of damage at about \$250bn, which could make it the costliest fire in American history.

### Zelenskyy visits Poland after progress in World War II dispute

# CITROEN BASALT TURBO PETROL MANUAL & AT REVIEW | TESTED OVER 1000 KM

SYED SHIRAZ SHAH

**T**es, as mentioned in the heading above, I did test the manual and automatic versions of the Citroen Basalt for over 500 km each. And I concluded that the majority of reviewers have got almost everything wrong about the car. In fact, not just the reviewers, even Citroen has gotten a few things wrong, especially with the categorisation of the car as you'll learn below.

#### **DESIGN AND CAT-**EGORISATION/PLACE-

A journalist's job is to ask questions. A journalist, who's also a reviewer, needs to ask those questions a bit more sternly. Therefore, I wonder why no one is even asking Citroen that why call the Basalt an "SUV Coupe" when it's actually a sedan, and the C4 a sedan when it's actually an SUV Coupe? Yes, you may check their international website where the C4 has been described as "a new generation sedan"; "a reinvented aesthetic, and an eco-responsible vehicle"; and as a car "with a raised posture on large wheels..." Those descriptions (minus the large wheels) suit the Ba-

salt more than the C4. So, yes, while the C4 (and even the C4 X) is indeed an SUV Coupe, the Basalt is more of a sedan with a bit of coupe/fastback design, and as such design-wise it's not competing with the Tata Curvv as has been incorrectly mentioned by almost every reviewer in the last few months. The C4 and C4 X would have. but not the Basalt. In fact, overall its only direct competitor would have been the



erstwhile Maruti Suzuki SX4 had it still been around. In its absence, the Basalt, design-wise, is closer to the new Amaze and Dzire than anything else, while pricewise it should be seen as an alternative to a lot of cars including the Nexon, Amaze, Dzire, Ciaz, Virtus (1.0), Slavia (1.0), Sonet, Venue, Kushaq (1.0), Taigun (1.0), and even the starting variants of the Creta, Seltos, Hyryder, Grand Vitara, Elevate, and Curvv. I won't get into the nitty-gritties of Basalt's design as a lot has been said about it already, and it's something you can see for yourself anyway. But I shall still tell you that it looks best in White, and also that Citroen should have given it bigger wheels...

#### **INTERIORS**

The Basalt, just like the C3 and C3 Aircross gets nononsense, simple, but functional interiors. In fact, the interiors here are ergonomically better than the other two, and I am obviously referring to the correct placement of the power window switches. Hopefully, the C3 and C3 Aircross will see that change sometime soon

The Basalt also gets auto climate control now, although like I had mentioned in my C3 Aircross review, I was absolutely okay with the manual HVAC system too. Nevertheless, it's a nice addition. The air-conditioning is as brilliant as ever and it's one of those few cars that could actually do without the rear vents. Yes, it's that

Speaking of comfort, the

Basalt's party trick is the adjustable under-thigh support at the rear, but it's quite intriguing that you get that feature only in the Automat- ter perspective. ic and not in the Manual. However, the biggest miss still is the lack of cruise control. Otherwise, overall, it's a cabin that will appeal to most who value comfortable seats, sorted ergonomics, great air-conditioning, and lots of storage space.

#### **PERFORMANCE**

This is where things start to get more interesting. The Basalt is available with a naturally aspirated petrol engine as well, but, for now, Citroen is providing only

Photos: Aairah Khan & Arina Haiden the turbo-petrol cars to the media. However, since I had sampled the former at the C3 media drive in 2022, I am certain that it will do a fine job in the Basalt as well, and you must take a test drive of it if you're contemplating

buying a Dzire or an Amaze.

Coming back to the turbocharged Basalts, both the manual and automatic have enough performance to keep you happy. And this is something I haven't seen the majority of other reviewers talking about. But, like always, you may trust me to give you a clearer picture. The best coincidence this time around was that I had the VW Vento 1.2 TSI DSG as well at the shoot, and I did the acceleration runs of the three cars to give you a bet-

to see the results. The Vento accomplished the O-100 km/h run in 10.1 seconds; the Basalt automatic did it in 10.3 seconds, and I could achieve a time of 10.2 seconds in the Basalt manual. The O-140 km/h times were, 19.9, 21.3, and 18.9 seconds, respectively. I will have to reiterate that it's the Basalt manual that decimated the other two here by posting the quickest (18.9 seconds) O-140 km/h time. Even more impressive

was the braking test from 150 km/h. The Volkswagen came to a complete halt in 4.6 seconds, whereas the Basalt Automatic and Manual took just 3.8 and 4.0 seconds, respectively. That's phenomenal braking, ladies and gentlemen.

#### **RIDE QUALITY**

This is where the Citroen Basalt just demolishes every other unibody vehicle available right now under 20-lakh rupees. The ride quality is simply outstanding. For perspective, let me share a real world example here as well.

On the way to our photoshoot location, there is a broken stretch (between Greater Noida and Noida Extension) of around 300 meters or so, and it has been like that for over ten years now. Honestly, I really pray it remains like that forever because it gives me a good opportunity to assess the suspension over bad roads of almost every vehicle I review, except the ones with low ground clearance and/ or promiscuous front over-

I fly over this section on adventure motorcycles, and even the ladder-frame vehicles are shown little mercy. but, I don't try to emulate Sebastien Loeb while driv-

this stretch. However, with the Basalt, I was able to train any other unibody vehicle lately. I of course didn't gun it, because testing and breaking are two different a lot further than any of its



wo-time Australian Open champion Naomi Osaka staged an impressive comeback to defeat 20th seed Karolina Muchova 1-6, 6-1, 6-3 in the second round on Wednesday. After a thrilling openinground victory over Caroline Garcia, Osaka overcame a sluggish start to topple last year's US Open semifinalist, advancing to the third round of a Grand Slam for the first time since her return from maternity leave.

"It means a lot," Osaka said on court, as per the official website of WTA.

"She's an incredibly difficult opponent for me to play. She crushed me at the US Open when I had my best outfit ever. I was so disappointed. I was so mad," she added.

"I'm glad I got my revenge. It's not a bad thing, revenge is competitive. She's one of the toughest opponents out there," she said

Osaka began her 2025 WTA season at the ASB



Classic in Auckland, where she reached her first tournament final since Miami 2022. Reflecting on her journey, she emphasized the importance of understanding her game better to produce consistent results in major tournaments. So far, her performance in Melbourne is living up to her determination.

"I've said this for years," Osaka said in Auckland, as quoted from the official website of WTA."I'm not the most talented player but I feel like

she noted. "Last year it was really difficult for me to get that mindset and you could see that in a lot of my matches. "If you were to say 'turning the page', I would probably say that was in Auckland because I played really tough matches there in really tough conditions," Osaka said, as per quoted from the official website of WTA.

"I felt like even though the tennis wasn't necessarily the cleanest, I think it was like the mental side that got me through into the final. I was really happy about that. I think it continued on to this match because I don't feel like I played the cleanest tonight either," she said.

"Mentally I just really wanted to win a lot," she added.

# Mandhana smashes fastest ODI ton

Indian batter and stand-in captain Smriti Mandhana made history on Wednesday, smashing the fastest ODI century by an Indian women's batter and becoming the first-ever Asian to smash 10 ODI centuries.

Mandhana reached these milestones during the third and final ODI against Ireland at Rajkot. She scored an explosive 135 runs in 80 deliveries with 12 fours and seven sixes. Her runs came at a strike rate of 168.75.

Her century in 70 balls is the fastest by an Indian doing her regular skipper Harmanpreet Kaur's 87-ball century against South Africa at Bengaluru last year. In men's cricket, the fastest ODI ton by an Indian is in the hands of star batter Virat Kohli, who reached there in just 52 balls against Australia in 2013.

Also, this is Smriti's 10th ton, making her first-ever Asian batter to reach this mark, with Sri Lanka's Chamari Athapaththu (nine centuries) behind her.



Ahead of Mandhana are Australia's Meg Lanning (15 centuries), New Zealand's Suzie Bates (13 centuries) Beaumont (10 centuries).

7 sixes hit by Smriti Mandhana today is the joint-most by an India Women batter in an ODI innings, alongside Harmanpreet Kaur, who had hit as many during her 171\* off 115 against Australia Women in the 2017 World Cup semi-final. Mandhana has also equalled Harmanpreet for most sixes for India

in the format (52). Since 2024, Mandhana has smashed 996 runs in 16 ODIs at an average of 62.25,

with a strike rate of above 105.06, with four centuries and five fifties. His best score is 136. No other batter has women's batter in ODIs, out- and England's Tammy aggregated 700 runs in this timeframe in the format.

> Overall in ODIs, Smriti has made 4.209 runs in 97 matches and 97 innings at an average of 46.25, with 10 centuries and 30 fifties. Her best score is 136.

Coming to the match, India won the toss and opted to bat first. A partnership of 233 runs between Mandhana (135 in 80 balls, with 12 fours and seven sixes) and Pratika Rawal (154 in 129 balls, with 20 fours and a six), a half-century from

This is India's highest score across both men's and women's ODIs, outdoing men's total of 418/5 against West Indies in 2011 in which Virender Sehwag hit 219 runs and total of 370/5 by India women in the second ODI of this ongoing series against Ireland, where they made 370/5 thanks to a century from Jemimah Rodrigues and fifties from Mandhana, Rawal and
