Concerned about the declining sex ratio in Haryana, Chief Minister Nayab Singh Saini has taken a major step to address the issue by appointing all women sarpanches (village heads) as ambassadors for their villages under the Beti Bachao-Beti Padhao campaign. dropped to 910 girls per 1,000 boys in 2024, the lowest since 2016. Five districts reported a sex ratio below 900, with Charkhi Dadri at 869, the worst in the state. Faridabad and Gurugram both recorded an SRB of 899, followed by Rewari (873) and Rohtak (888).

Some districts, however, showed improvement. Yamunanagar reported the highest SRB at 939, followed by Sirsa (936) and Fatehabad (925). Yamunanagar and Karnal saw an 18-point increase. while Sirsa and Bhiwani improved by 11 and 12 points, respectively. The Chief Minister revealed plans to upgrade

Haryana govt's massive crackdown against corruption, hundreds of officials charged

Taking a strict step to root out corruption from the revenue department, the Haryana government has identified 370 patwaris (revenue officials) and 170 middlemen accused of indulging in bribery and misconduct. As per a notice issued by

the the Additional Chief Secretary (Revenue) Anurag Rastogi has instructed all deputy commissioners to take strict action against the identified individuals and submit a report to the government within 15 days. The government's confidential report, compiled with inputs from intelligence agencies accessed by TDG, outlines the modus operandi of the accused patwaris and their associates. The report also details bribe amounts demanded for various routine tasks such as land mutation, demarcation, record rectification, and issuing land maps. The highest number of tainted patwaris were reported in Kaithal (46), followed by Sonipat (41) and Mahendragarh (36). While, Gurgaon district led in terms of middlemen, with

26 identified, while Mahendragarh reported 20, and Palwal, Rewari, and Sonipat accounted for 15 each.

As per the orders the Patwaries and their assistants harass the public by repeatedly raising objections to delay routine work unless bribes were paid. For instance, a patwari posted at Ambala Cantt allegedly harassed citizens for land mutation and other tasks, with bribes being collected by a local middleman. As per the letter the bribe rates varied across districts, with Gurgaon emerging as the costliest, where identified patwaris charged Rs 3.000 to Rs 5,000 for land mutation and related tasks. In contrast, patwarias in Faridabad charged Rs 500 to Rs 700 to locate old revenue files.The report suggests

that most tainted officials are posted in rural areas, where land dealings are more frequent. However, high-value corruption cases were also reported in urbanized regions. Some patwaris allegedly tampered with land records, while others left critical tasks pending for months in the absence of bribes.

The revenue department currently has 1,378 patwaris, with 1,313 positions vacant. However, the shortage is expected to be addressed once 2,600 newly recruited patwaris complete their training.Sources reveal that the state CID conducted extensive fieldwork to prepare the list of corrupt officials. Apart from naming the patwaris and middlemen, the report includes their caste, tenure, mobile numbers, and even native villages, offering granular details to aid the crackdown.

"The common man often suffers due to the corrupt practices of patwaris, which tarnishes the government's image. This decisive action aims to rebuild public trust," reads the letter written by Rastogi to the deputy commissioners.

ED, Raipur Zone, arrests MLA Lakhma in liquor scam case

The Directorate of Enforcement (ED), Raipur Zonal Office arrested Kawasi Lakhma (MLA) on Wednesday under the provisions of the Prevention of Money Laundering Act (PMLA), 2002 in the Liquor scam case in Chhattisgarh. He was produced before the Special Court (PMLA), Raipur and the Court granted ED custody of Kawasi Lakhma for six days i.e. till 21.01.2025. Kawasi Lakhma was the Excise Minister in the state of Chhattisgarh during the material period of the liquor scam, said a press release on Friday. ED initiated an investigation based on an FIR registered by ACB/EOW Chhattisgarh under various sections of IPC, 1860 and Prevention of Corruption Act, 1988 in the said Liquor scam in the State of Chhattisgarh, added the

ED investigation has restatement. ED investigation revealed that Kawasi Lakhma was allegedly aware of the complete affairs of the Excise Department including liquor scan, yet he did nothing to stop the illegal and unauthorized operations. He played an important role in policy change which led to the introduction of the FL-10A license in the state of Chhattisgarh. He was an integral part of the syndicate and actively assisted the syndicate by manoeuvring processes and procedures as per their direction. Investigation conducted has revealed that Kawasi Lakhma

vealed that the corruption in the liquor scam (which took place between 2019 to 2022) was resorted to in multiple ways: PART-A Commission: Bribe was collected from the "various distillers" on the basis of "each Case of liquor procured from them by the CSMCL (State body for purchase and sale of liquor)". PART-B Kacha liquor sale: Sale of unaccounted kacha off-the-books Country Liquor. In this case, not even a single rupee reached the State Exchequer, and all the sale proceeds were pocketed by the Syndicate.

The illegal liquor was sold from State-run shops only. PART-C commission: Bribes taken from distillers to allow them to make a cartel and have a fixed market share. Commission from FL-10A License Holders who were introduced to earn in the foreign liquor segment also, added the release.

GRAP 3 CURBS REVOKED IN DELHI-NCR AMID DIP IN POLLUTION

New Delhi: The Centre's panel on Delhi-NCR's air quality on Friday revoked curbs under stage 3 of the Graded Response Action Plan (GRAP) amid a dip in pollution due to favourable meteorological conditions, according to an official order.Calm winds, low temperatures and foggy conditions had allowed accumulation of pollutants in the region earlier this week, promoting the Commission for Air Quality Management (CAQM) to implement strictest curbs under stage 3 and 4 of GRAP.

The panel decided to revoke stage 4 curbs on Thursday amid a dip in pollution levels following a spell of rain in the region. On Friday, air pollution level declined further amid strong winds, leading to revocation of stage 3 curbs. GRAP Stage 3 entails a ban on non-essential construction work. EXPERTS WARN 8TH PAY COMMISSION'S ADVERSE IMPACT ON FISCAL DEFICIT

India Ratings' DK Pant noted the Eighth Pay Commission's impact hinges on salary revisions and may influence inflation, wage costs.

he suggestions of the eighth Central Pay Commission, which will be effective from January 2026, are unlikely to weigh on the government's finances in the next fiscal year but they would potentially impact inflation and support private consumption once the government starts releasing enhanced wages, economists said on Thursday.

This would require the central government to stick to the fiscal consolidation course beyond 2025-26, they said. The government aims to reduce its fiscal deficit to less than 4.5% of

gross domestic product by 2025-26, against the budget estimate of 4.9% for the current fiscal. The government on Thursday approved the setting up of the panel, which will submit its report on the pay revision for central government employees and pensioners.

The government may start releasing the revised wages from July 2026 with arrears. ICRA chief economist Aditi Navar said: "While the award related to the 8th Pay Commission is unlikely to affect fiscal metrics in FY26, the potential impact of the same should be built into the new medium-term fiscal consolidation path as

SWAMI VIVEKANANDA: THE SPIRITUAL FOUNDATION OF NETAJI'S MISSION

anuary marks the birth of two of India's great-• J est sons, whose contributions ignited the flame of patriotism in the hearts and minds of the Indian people. Swami Vivekananda, born on January 12, 1863, is one of the most towering personalities in modern Indian history. Just a few days after Swami Vivekananda's return from his first visit to the West, Netaji Subhas Chandra Bose was born on January 23, 1897. Netaji was a leader who brought the colonial government to its knees with his unwavering determination and leadership.

Today, millions of Indians are familiar with the name of the great Netaji Subhas Chandra Bose. However, few truly understand the pivotal role he played in India's freedom movement. despite being one of its most key figures. Even fewer are aware of the influence that Swami Vivekananda had on his life. The story of how the patriotic saint, Swami Vivekananda, became the inspiration behind the phy and Collected Letters a spiritual life could not be

revolutionary Netaji Bose is a remarkable tale of spiritual foundations leading to a powerful surge of patriotism. It was through Swami Vivekananda's teachings that Bose found the deeprooted spiritual strength that fuelled his commitment to India's liberation. This connection between spiritual awakening and patriotic fervour highlights

the impact of Swami Vivekananda's ideals on the freedom struggle, shaping Netaji Bose's revolutionary vision.

The common thread between these two great souls is that both lived and died for their motherland, India. Every moment of their lives was dedicated to freeing India from British rule. It could be said that Netaji Subhas Chandra Bose's life stands as one of the finest examples of how Swami Vivekananda's teachings and life could impact an individual. The extent to which Vivekananda's message inspired and shaped Bose's actions is remarkable. It is a testament to the power of Swami Vivekananda's philosophy-how it could fuel a person's passion, drive, and commitment to work tirelessly for India and its people.

To understand the relationship, impact, and association between Netaji Subhas Chandra Bose and Swami Vivekananda, one can turn to Netaji's autobiography, An Indian Pilgrim: An Unfinished Autobiogra-



(1897-1921), and Netaji's Life and Writings - Part Two: The Indian Struggle 1920-34. These works provide a clear view into how Swamiji influenced Netaji's life, with Netaji considering him nothing less than a guru.

According to Netaji Bose, he was just fifteen when he was introduced to Swami Vivekananda through his literature, particularly the book Colombo to Almora, which is a compilation of Swamiji's lectures delivered in India after his first visit to the West. Netaji mentions that while studying Swamiji's works, he found ideals to which he could dedicate his entire being.1

Netaji writes, "For days, weeks, and months, I pored over his works. His letters, as well as his speeches from Colombo to Almora, replete with practical advice for his countrymen, inspired me deeply. From this study, I emerged with a vivid understanding of the essence of his teachings: 'Atmano Mokshartham Jagaddhitaya'-for your own salva-

tion and for the service of humanity-that was to be life's goal."² Netaji also believed that

it was Swamiji's teachings that made him realize that

led through personal yoga practice alone; it required engaging in social work as well. He began working for society after drawing inspiration from Swami Vivekananda, who emphasized the concept that serving humanity is serving God. From Swamiji's teachings, Netaji felt that "for spiritual development, social service was necessary."3Netaji Bose was so deeply aligned with the mission of Swami Vivekananda that in school he found inspiration only in those teachers who were followers of Swami Vivekananda and his Guru, Sri Ramakrishna.⁴ By the time he finished school, Netaji had resolved to follow the examples of Sri Ramakrishna and Swami Vivekananda in his own life, choosing not to pursue a conventional career.⁵ Netaji writes, "The philosophy which I found in Vivekananda and in Ramakrishna came nearest to meeting my requirements and offered a basis on which to reconstruct my moral and practical life. It equipped me with certain principles with which to determine my conduct or line of action whenever any problem or crisis arose before my eyes."6

In another instance, Netaji mentions that since child-



hood, he has always held deep respect for Swami Vivekananda and Jagadish Chandra Bose, drawn to them through their pictures and the stories shared by others. He writes, "I do not know why, but since my childhood, I have always had the deepest respect for two persons—Jagadish Chandra and Vivekananda. I was attracted to them through the pictures I saw and what I learned about them from others."7

Swami Vivekananda served as a central figure of inspiration for Netaji throughout his life, whether during his school and college years, after he cleared the ICS exam yet chose to decline the position, or later when he actively participated and led the struggle against British colonial rule in India. The spiritual force of Swami Vivekananda provided a foundational strength and guidance that influenced Netaji's decisions and actions. Netaji Subhas Chan-

dra Bose's admiration for Swami Vivekananda is reflected in his powerful words, which capture the influence Swamiji had on the Indian consciousness. Netaji writes about Swamiji that, "He tried to infuse into the new generation a sense of pride in India's past, of faith in India's future, and a spirit of self-confidence and self-respect. Though the Swami never gave any political message, everyone who came into contact with him or his writings developed a spirit of patriotism and a political mentality. So far, at least as Bengal is concerned, Swami Vivekananda may be regarded as the spiritual father of the modern nationalist movement. He died very young in 1902, but since his death, his influence has been even greater."8

The impact of Swami Vivekananda's message, according to Netaji, was not confined to the spiritual realm alone but had a tangible effect on India's freedom struggle against the British. Swamiji's teachings provided the moral and intellectual foundation that inspired many freedom fighters, including Netaji himself, to continue the struggle for independence with renewed Vigor and determination.

INDIRA BHAWAN, A TRIBUTE TO THE FORMER PRIME MINISTER

The new Congress headquarters, Indira Bhawan, was inaugurated on the Kotla Road in the capital, amidst an unnecessary controversy precipitated by the Bharatiya Janata Party, on why it was not named after Dr Manmohan Singh, who passed away recently. It was also the failure of the communication department of the Congress not to adequately project the shifting of the office in the media, given that it was perhaps for the first time in its 140 years history, the party was shifting to the premises which were owned by it. There was no preview or highlighting of the various facilities offered at the Indira Bhawan, something which was unexplainable. In addition, the current leadership which thrives because it has inherited the legacy of Indira Gandhi, the greatest mass leader of the last century, also did not delve on the historic significance of the new address and structure. For most people who cover politics, the Congress Headquarters is synonymous with 24, Akbar Road, the placewhere it shifted after the second split of 1978. Between the first split and the second one, the Congress office of the Indira Gandhi faction was located on 5, Rajendra Prasad Road. In fact, it was at the meeting of the Working Committee of the party then headed by K.Brahmananda Reddy, an appointee of Indira Gandhi, who later joined hands with her detractors like YB Chavan and others, that the former Prime Minister was expelled following high drama. I as a student of Delhi University, was present in the lawns of 5, Raiendra Prasad road, when the drama unfolded. Mohammad Shamim, of the Times of India, who later became my mentor so far as political reporting was concerned, was covering the event and was also seated in the lawn outside soaking the winter sun. Much before the arrival of Indira Gandhi, a hostile atmosphere was sought to be created and a small crowd which had been brought in was already chanting slogans, `Indira Gandhi Murdabad". FM Khan, Rajya Sabha MP from Karnataka dressed in a red-coloured shirt was standing near the porch with a handful of her supporters, awaiting her arrival. As Indira Gandhi's Ambassador drover towards the main entrance of the building after entering the gate, the sloganeering against her gathered momentum. The former Prime Minister while alighting from the vehicle, gave a stern look at the protestors, who suddenly froze and folded their hands as if to welcome her. Her charisma had taken over and she was escorted inside by Khan though it was abundantly clear that she was going to be thrown out of the party that evening. Rest is history, and some days later, she formed the Congress (I) at a function which amongst others was attended by Kamlapati Tripathi who stood by her at that juncture. Buta Singh was made the sole general secretary and the new chapter in the party's history had been ushered in with Sanjay Gandhi and his team, on the threshold of taking over the party. The Indira faction later shifted to 24, Akbar Road. However, it is important to point out that during the emergency, Indira Gandhi had laid the foundation stone of the new Headquarters at3, Raisina Road. In fact, the stone marking this was there for a long time. This was the place that subsequently was allotted to Jawahar Bhawan which has its entrance now on Rajendra Prasad Marg, opposite the Shastri Bhawan. It needs to be recalled that during the Janata Party period, multiple attempts were made to take over the 3, Raisina Road office but did not succeed and the premises were occupied by a faction of the party which was later opposed to Indira Gandhi, but never allowed others to take over. Supporters of Babu Jagjiwan Ram made an unsuccessful attempt to wrest control and the first working committee meeting of the group led by Sharad Pawar subsequently was also held there. While the party was in control of Suresh Kalmadi, Pawar's key lieutenant then, largely because of the efforts of Prem Swarup Nayyar and others, a deal was struck by him and Arun Nehru, who wanted the area for the proposed Jawahar Bhavan. In what is in public domain but could never be substantiated through official sources, the premises were handed over to the Congress (Indira) and in return, Kalmadi was given the Maruti agency for Bombay and some other cities in Maharashtra. This enabled the construction of the Jawahar Bhawan. The Congress is now to be located at Kotla Road, close to the fleet street, New Delhi's Bahadur Shah Zafar Marg which was where most newspaper offices were located at one time. It is also near the Headquarters of the BJP and the AAP on the Deen Dayal Upadhyaya Marg. Some Congress supporters are trying to give a spin that to avoid the Marg named after the former Bhartiya Jana Sangh president and Idealogue, the party has its main entrance towards Kotla Marg. Wonder how does the road matter since both these boulevards are in the area once known as the Rouse Avenue. The Congress has to understand that a change of address does not necessarily signify a change of fortune. It should use the opportunity to focus on making the organization stronger and reconstitute the AICC with lesser number of office bearers than it has now. The party should be effective and not unwieldy and bulky. It needs to be clarified that the Bhawan is named after Indira Gandhi and not Dr Manmohan Singh, who was an icon but had little to do with the party. It is fine if the Library gets his name.

The consequences of this interference are stark: rising greenhouse gas concentrations lead to global warming, ocean acidification, and a staggering loss of biodiversity due to habitat destruction. To effectively combat climate change, it is imperative to adopt a holistic approach that transcends traditional linear models focused solely on reducing emissions. Earth System Science (ESS) emerges as a vital framework for understanding the complex interconnections between Earth's physical, chemical, and biological processes. Earth System Science (ESS) is an emerging transdisciplinary endeavour to understand the Earth's structure and functioning as a complex, adaptive system. The term "Earth system" refers to

Earth's interacting physical, chemical, and biological processes that operate across, and link, the atmo-

land, ocean and lithosphere. It includes the planet's natural cycles-the carbon, water, nitrogen, phosphorus, sulphur, and other cyclesand deep Earth processes. These interact with each other through interconnected processes and cycles that store, transfer, or transform matter and energy throughout the Earth's system over time. This transdisciplinary approach recognizes that the planet operates as an integrated system, where natural cycles-such as carbon, water, nitrogen, and phosphorus-interact dynamically. The recent quantification of nine planetary boundaries by a group of renowned scientists emphasizes the necessity of operating within these limits to ensure a sustainable future for humanity. Among these boundaries, climate change is paramount. It stems from an imbalance in the energy exchange between incoming solar radiation and outgoing heat. Human activities exacerbate this imbalance by increasing concentrations of greenhouse gases and aerosols in the atmosphere, leading to more trapped heat and altered climate patterns. Additionally, the introduction of novel entities-substances created or

released into the environment through human intervention—poses significant risks. These include microplastics, persistent organic pollutants like PFOA and PFAS, and even genetically modified organisms. Another critical boundary is stratospheric ozone depletion. The thinning of the ozone layer, primarily due to chlorofluorocarbons (CFCs), garnered global attention in the early 1980s. The successful international response through the Montreal Protocol serves as a testament to what can be achieved when nations unite against environmental threats. This treaty effectively banned substances responsible for ozone depletion and has since led to a gradual recovery of the ozone layer. However, not all planetary boundaries have been respected. Atmospheric aerosol loading has increased due to both natural processes and human activities, significantly impacting climate by altering precipitation patterns and temperatures. Ocean acidification-a direct consequence of increased atmospheric CO2 absorption-threatens marine ecosystems and global food security by disrupting marine life cycles.Moreover, human interference has disrupted biogeochemical flows essential for maintaining ecological balance. The industrial fixation of nitrogen and excessive phosphorus runoff into oceans have led to nutrient cycle disruptions that affect soil health and aquatic environments alike. Freshwater systems have also suffered due to alterations in both blue water (rivers and lakes) and green water (soil moisture) cycles. impacting biodiversity and precipitation patterns.Land system changes driven by deforestation, urbanization, and agricultural expansion further exacerbate these issues by disrupting natural processes such as carbon sequestration and moisture recycling. The loss of biodiversity-termed biosphere integrity-compounds these challenges by destabilizing energy flows and chemical cycles essential for life on Earth.Alarmingly, six out of nine planetary boundaries have already been transgressed. These boundaries are interconnected; transgressing one can trigger cascading effects across others, potentially leading to irreversible changes on a global scale. This interconnectedness underscores the need for a paradigm shift in how we perceive climate change

and sustainability. Decisionmaking must consider all planetary boundary concerns simultaneously rather than in isolation. From local governance to global initiatives, it is crucial that we operate within these planetary limits if we wish to sustain human civilization for future generations. This requires collaborative efforts across nations, sectors, and communities to implement policies that prioritize environmental health alongside economic growth.In conclusion, addressing climate change is not merely an environmental challenge; it is an existential imperative that demands immediate action. By embracing an Earth System perspective, we can better understand our place within this intricate web of life and take meaningful steps toward ensuring a sustainable future for all inhabitants of our planet. As we move forward, let us commit to fostering resilience through informed decision-making that respects the delicate balance of Earth's systems. 

China's economy hits 5% growth target

China's economy grew by 5% in 2024, in line with government targets but at the slowest rate since 1990 outside the Covid pandemic, according to official data.

Growth accelerated through the year, with an expansion of 5.4% in the final quarter, up from 4.6% in the third quarter, according to Beijing's National Bureau of Statistics.

The bureau reported "steady progress amid stability" but pointed to a "complicated and severe environment with increasing external pressures and internal difficulties".

Beijing has been attempting to rebalance growth away from a heavy dependence on exports, towards domestic consumption. However, a property downturn, and the after-effects of the Covid pandemic, appear to have continued to weigh on sentiment.

Lynn Song, a China economist at ING, said: "The key question is if we can see consumer confidence bottom out and begin a meaningful recovery.

RUBIO OUTLINES FOREIGN POLICY ENVISIONED FOR TRUMP 2.0 ADMINISTRATION

his week presented a complex landscape in global affairs and international relations. Amid the ongoing violence between Israel and Hamas, as well as the persistent conflict between Russia and Ukraine, Marco Rubio, the Republican senator from Florida, outlined the foreign policy strategy envisioned for a potential second Trump administration during his confirmation hearing for the Secretary of State position. Meanwhile, Bangladesh is poised to remove the core tenets of secularism, socialism, and nationalism from its constitution, marking a critical shift in its political framework.

This week, Marco Rubio, the Republican senator representing Florida, articulated the foreign policy framework for the second Trump administration during his confirmation hearing for the position of Secretary of State. In a dialogue facili-

tated by the Senate Foreign Relations Committee, Rubio highlighted an 'America First' strategy that emphasizes prioritizing US interests, minimizing reliance on foreign countries, and tightening fiscal allocations for international assistance. As Rubio approaches confirmation as Secretary of State, his agenda reflects the Trump administration's emphasis on domestic issues and a reassessment of international obligations. He highlighted the im-

portance of ensuring that American taxpayer funds are directed exclusively towards promoting US interests. He also recognized the existence of global humanitarian challenges but advocated for a more rigorous examination of foreign aid. This indicates a shift towards a more domestically-oriented foreign policy, as expected from Trump. During his address, Rubio also characterized China as the foremost challenge



confronting the US, highlighting its supremacy in global supply chains, advancements in technology, and military strength. He cautioned that the US needs to address this 'near-peer adversary' by revitalizing its domestic industrial base and decreasing dependence on foreign countries for es-

sential supply chains. In addressing the situation in Ukraine, he advocated for a more practical approach. He characterized the current conflict as a 'war of attrition' and emphasized that the primary objective of Trump administration would be to secure a ceasefire. While he reiterated the US' commitment to NATO, he also explained the significance of European partners tak-

ing on a greater share of the financial burden. However, his remarks indicated a potential change in US policy, suggesting a role as a friend rather than being the main security guarantor for Europe. It was also clear from his address that Trump administration would uphold robust relations with Israel while taking a firmer approach towards Iran. He highlighted the possibility of significant advancements in the West Asia, particularly mentioning the ongoing initiatives aimed at normalizing relations between Saudi Arabia and Israel. On the other hand, Ban-

gladesh continues to grapple with the repercussions of the recent ousting of its longest-serving Prime Minister. Commission chairman Ali Riaz stated in a video message that they are advocating for five state principles: equality, human dignity, social justice, pluralism, and democracy, which aim to embody the aspirations of the people during the anticipated mass upsurge in 2024. However, there are

concerns regarding the appropriateness and legality of a temporary administration's power to implement such extensive modifications, which would change the social fabric and nature of Bangladesh.

India is already surrounded by politically fragile countries like Sri Lanka, Pakistan and Nepal. Afghanistan is already under the control of a terrorist organisation. Entire Europe is under one or the other kind of crisis situation. Russia-Ukraine war does not seem to be ending any sooner. Israel-Hamas conflict is intensifying every week. The potential demise of democracy in Bangladesh at the hands

of extremists would have far-reaching consequences, not only undermining global peace and security but also casting significant doubt on the effectiveness of major international organizations.

In today's multipolar world, various entities, driven by their unique priorities and intricate interdependencies, establish distinct centres of power. This diversity of power dynamics transforms global politics into a complex labyrinth. As individual actors attempt to navigate this landscape independently, they increase their risk of failure. Rather than focusing on solitary pursuits, nations should prioritize engagement and collaboration, following the example set by India. 'Indira is Kangana, and Kangana is Indira,' is something that would be a more apt line for this well-made biography of the late prime minister of India, which often mentions 'Indira is India and India is Indira.'

Directed and Co-Produced by Actor Kangana Ranaut, Emergency is a film depicting the life and times of Indira Gandhi from a political perspective but narrated in almost an apolitical manner barely highlights the times of emergency deployed by the ex-prime minister in 1975. The film's name could have been 'Indira' instead of 'Emergency,' which seems to be a pretty misnomer since the content around emergency only appears before intermission and carries forward post intermission just a little bit.

Emergency is a film with an impressive cast with Kangana Ranaut (as Indira Gandhi), Anupam Kher (as Jayaprakash Narayan), Shreyas Talpade (as Atal Bihari Vajpayee), Milind Soman (as Field Marshal Sam Manekshaw), Late Satish Kaushik (as Jagjivan Ram), Ashok Chhabra (as Morarji Desai), Vishak Nair (as Sanjay Gandhi), and Mahima Chaudhry (as Pupul Jayakar) among others.

Kangana gave a stellar performance and imbibed the character of India Gandhi beyond excellence. Her look and feel certainly complement her acting nuances, emotions, presentation, dialogue delivery, style, courage, and boldness, which make her come across strongly similar to the protagonist of the film. Though sometimes deliberate facial twitches and voice delivery of Kangana may sound a bit artificial, overall, she has played the character very well. As a Director, Kangana shines too by making the co-actors perform and adapt to their roles perfectly. Milind Soman delivers a strong performance and plays his character with absolute

perfection. Shreyas Talpade and Anupam Kher are as natural as they can be seeping fully into their characters, while Vishak Nair attempts more to portray eccentricities rather than the normal sides of the character.

While the film is based on two novels, most of the script seems to rely upon publicly available information, knowledge, and gossip too sometimes. While it was expected to be a completely one-sided narrative focusing only on the emergency times, it is not. It tries to balance out the ideologies of right, left, and centre and creates a narrative of patriotism and nationalism of the Iron Lady, Mrs. Gandhi. However, in the name of

creative freedom, showing the cursed lady in the mirror as a reflection of Mrs. Gandhi's remorse for the emergency might have been uncalled for as it doesn't re-

flect anything. Kangana makes an impact in many scenes like her meeting with the philosopher J. Krishnamurthi (played by Avijit Ghosh), her interaction with US President Nixon and telling him "You have weaponry, we have courage," her visit to Belchi village in Bihar riding an Elephant, and reacting to the merciless murder of Bangladesh founder, Sheikh Mujibur Rahman, known as Bangabandhu on India's Independence Day. 



If we liken the emergence and development of various religious traditions over the course of history to the growth of a tree, we find that Christianity, Islam, and Buddhism are the main branches of the human family's tree. The adherents of these religions make up the major chunk of the world's population.

While Christianity began with Jesus Christ about 2,000 years ago, the origin of Buddhism dates back 2,250 years to Gautam Buddha, and the roots of Islam can

be traced back about 2,500 years to Abraham.

The parents of the founders of these religions obviously belonged to religious traditions that existed earlier. The Adi Sanatan deity religion is the trunk of the tree of humanity from which the branches mentioned above have emerged.

The Adi Sanatan deity religion was the religion practised in India originally. This religion originates with Prajapita Brahma, who is known by the names Adam and Adinath in different religious traditions and is recognised as the first human, or the originator of humanity. Brahma is said to have started a 'yagya' or sacrificial fire from which emerged the deities. It is by this process that humans metamorphose into deities. This practice, and the traditions and rituals of the people who engage in it, later come to be known as Hinduism.

The other religions are established in due course, as the tree of humanity grows new branches. This process continues, and various sects, sub-sects, creeds, and cults are born, giving rise to the bewildering variety of religious traditions and beliefs we see in the world today.

His most notable pupil, Avani became the first-ever



Gukesh received India's highest sporting honour, the Major Dhyan Chand Khel Ratna, in Delhi this morning from President Droupadi Murmu and left for the Dutch city immediately after the ceremony. The five-player Indian contingent will see an all-Indian duel as early as round one as Arjun Erigaisi will face lastminute-replacement Pentala Harikrishna in the opener. Arjun, known for his ability to complicate any position, will



have an arduous task against Harikrishna who is supersolid with white pieces. Interestingly, Harikrishna came in the mix of things as another Indian Vidit Gujrathi withdrew due to personal reasons.

The most interesting battle of the first round is likely to be between R Praggnanandhaa who takes on Nodirbek Abdusattorov of Uzbekistan.

Praggnanandhaa did not have a great 2024 and would like to make amends by starting the year on a positive note. The fifth Indian in the fray made it to the elite group after winning the challengers in 2024. Leon Luke Mendonca may not have the credentials of other four compatriots in fray but the youngster is certainly the dark horse, who can put anyone in a difficulty position on his day.Mendonca will take on German Vincent Kevmer. who is fast improving and

BCCI issues new policy guidelines for Team India

The Board of Control for Cricket in India (BCCI) has issued strict guidelines for the Senior Men's Cricket Team, aiming to enhance discipline, streamline logistics, and promote team unity during domestic and international tours.

The new guidelines include travel, baggage limits, family visits, and team dynamics. Players are expected to trav-

el with the team for all matches and practice sessions. Separate travel arrangements with and 2 kit bags) or up to 120 families are discouraged to kg, and support staff are almaintain discipline and team cohesion. Any exceptions must be pre-approved by the head coach and chairman of the selection committee. "All players are expected to travel with the team to and from matches and practice sessions. Two-time Olympic medallist PV Sindhu bowed out of the India Open 2025 after a hard-fought quarterfinal loss to Paris Olympics bronze medallist Gregoria Mariska Tunjung on Friday. In a closely contested match, Sindhu lost 9-21, 21-19, 17-21 to the World No. 5 Indonesian shuttler in a 62-minute encounter at the Super 750 tournament in Delhi.

Sindhu, playing her first competitive event since her marriage in December 2024, showcased resilience by forcing a decider after dropping the opening game. Trailing 3-9 in the second set, she staged a re-
