India open to 'legitimate return' of Indians 'illegally' living in US: Jaishankar

Clarifying India's stance, External Affairs Minister S Jaishankar has said New Delhi is open to the "legitimate return" of Indian nationals living 'illegally' abroad, including in the United States.

He affirmed that India's position on the issue has been "consistent" and "principled," and he did clearly convey this to US Secretary of State Marco Rubio.

"We have always taken the view that if there are any of our citizens who are not that they are our citizens. we have always been open to their legitimate return to India. So it's not a position unique to the United States," Jaishankar said at a



ington DC, on Wednesday (local time).

"I understand right now that there is a certain debate going on and a resulting sensitivity which is there. But we have been consistent; we have been very here legally, if we are sure principled about it, and that remains our position, and I conveyed that very clearly to US State Secretary Marco Rubio," he added.

> Jaishankar, however, also emphasised that India is

very much supportive of 'legal mobility' between two countries and wants Indian skills and talent to have great opportunities at the global level.

He added that India is firmly opposed to illegal migration, adding it is not "reputationally good" and also leads to several illegal activities.

"As a government, we obviously are very much supportive of legal mobility because we do believe in a global workplace. We want Indian talent and Indian skills to have the maximum opportunity at a global level." the EAM said.

The Legal Metrology Division of the Department of Consumer Affairs, Government of India, has notified the Rules for Radar Equipment for the measurement of speed of vehicles under the Legal Metrology (General) Rules, 2011.

According to an official release, these rules will come into force from July 1, 2025, to give enough time to in- Indian Institute of Legal dustries to comply with the provisions of the rules.

For framing the draft rules, a committee was formed under the Chairmanship of the Director,



Metrology (IILM), Ranchi, which submitted the initial draft based on OIML R 91. Presentation on the draft rules was made for State Le-

gal Metrology Departments,

RRSL officers, manufacturers and VCOs to explain the requirements of the rules.

The rules were published on the website of the Department for public consultation before finalization under the Legal Metrology (General) Rules, 2011 and were finalized after considering the inputs provided by stakeholders.

The Rules provide that all such equipment shall be verified and stamped to the protection of human beings.

Staff of Cong old HQ stare at job losses after opening of new HQ

After the inauguration of the new Congress headquarters on Kotla Road, hundreds of employees who have worked at the old headquarters on 24 Akbar Road for years are now facing uncertainty about their jobs. Many of these employees have served as party staff for generations. However, with the new headquarters now operational, reports suggest that only a select few of the old staff will be retained, while the majority may be offered voluntary retirement schemes (VRS). Although party spokespeople have denied these reports, the rumours have sparked growing concern among the employees, with many feeling increasingly anxious about their future. The staff members have been kept away from the new headquarters so far, with little clarity regarding their roles in the new setup. Amidst these tensions, one individual, Manish Chatrath, has emerged in the spotlight. Previously sidelined at 24 Akbar Road, Chatrath is now seen as a key figure at the new headquarters. There are rumors that he has earned the favor of Priyanka Gandhi, who is gradually

forming her own team, which could increase her influence in the new headquarters. Chatrath's political journey began under the mentorship

of Ahmed Patel. Manish Chatrath, once considered a central figure in Congress' war room at 15 GRG, has seen a significant shift in his role within the party. During Rahul Gandhi's tenure and after the passing of senior leader Ahmed Patel. Congress underwent a transformation, with Chatrath's influence waning. His absence from key roles in the new party executive marked a downturn in his political prominence. However, Chatrath's fortunes seemed to change with the construction of the party's new headquarters. Tasked with overseeing the headquarters' development, Chatrath took charge as the building neared completion. It was during this period that Priyanka Gandhi, Congress's second most influential leader, took personal interest in the office's design and opera-

This attention from Priyanka led to Chatrath regaining prominence, and he was seen playing a major role during the inauguration of the new headquarters.

Amid this leadership shift, rumors have begun circulating about the recruitment process for the new headquarters. It is speculated that the Congress may hire staff in a manner similar to corporate offices, potentially outsourcing many positions. This prospect has caused significant concern among the longstanding employees, who fear job insecurity. Many of the staff members, some of whom have worked at the headquarters for years, are in their later years and worry that they will be unable to find employment elsewhere. In 2012, the party had offered voluntary retirement schemes (BRS) to its employees, with about 50 staff members taking the offer. Back then, the compensation was considerable, but now, employees feel the situation has changed drastically. The introduction of young-

er, new-age staff members, including personal aides to Rahul and Priyanka Gandhi, has further heightened concerns about job replacement. While the Congress' official retirement age for headquarters staff is 65, some loyal employees are allowed to continue working beyond that age, but this policy might not be applicable to everyone.

The Indian Navy is looking to buy six advanced submarines with the ability to stay underwater for three weeks under Project 75 India. The proposal of the L&T in partnership with Spanish Navantia has been rejected by the Ministry for not being compliant with Indian Navy requirements.







Kulkarni, along with six

others, including BJP MP Pragya Singh Thakur and Lieutenant Colonel Prasad Purohit, is facing trial for the Malegaon blast.

Additionally, the Delhi Police have seized 270 unlicensed arms and 372 cartridges along with the seizure of 44,256 litres liquor, worth more than Rs 1.3 crores.

The police have also seized 110.53 kilograms of drugs and more than 1200 injections valued at more than Rs 20 crores.

Since the enforcement of the MCC, the police also seized around Rs 4.5 crores (Rs 4,56,03,745) in the form of cash and around 0.850 kilograms of Gold metal and 37.39 kilograms of Silver met-A total of 17,879 per-

sons have been arrested by the Delhi Police under provisions of preventive actions and other acts from January 7 to



January 19. The Delhi Police has

been busting several criminals and seizing cash, illicit liquor and firearms as the assembly elections in the national capital are inching closer.

Earlier on January 20, Delhi Police busted an interstate gang of illegal firearm suppliers with the arrest of its three members and recovery of several firearms.

The operation was carried out by the team of Special Staff of Delhi Police of North district. The recovered items included five semi-automatic pistols, six countrymade pistols (desi kata) and 28 live cartridges.

According to the Delhi Police, the accused were also involved in supplying firearms to criminals involved in the infamous Pragati Maidan Tunnel Robbery case of 2023.

Among the three ac-

cused, two of them have been involved in the supplying of illegal firearms for the past 20 years. On January 19, Delhi

Dikshit alleges 'scam' in AAP's COVID medical procurement

Congress candidate for the upcoming Delhi Assembly Polls Sandeep Dikshit on Thursday raised serious allegations against the Aam Aadmi Party-led Delhi government, accusing it of a massive scam in the procurement of essential medical supplies during the CO-VID-19 pandemic.

The most disturbing part is that during COVID, 80-90 per cent of the budget allocated for purchasing medicines went

"In this, the Delhi government purchased 4,000 oxygen concentrators from one company. During the COVID crisis, when patients couldn't be shifted to ventilators, oxygen concentrators were used to provide relief. The government ordered 4.000 concentrators and made the payment, but only 500 were supplied. Due to the shortage of 3,500 concentrators, if 200 people died, AAP's

Delhi cyber criminals siphoned off Rs 4,900 cr abroad, says ED

The Enforcement Directorate Thursday said two Delhi-based "cyber criminals" siphoned off more than Rs 4,900 crore abroad by "misusing" special economic zone (SEZ) facilities. The two accused -- Punit Kumar alias Puneet Maheshwari alias John, a resident of Moti Nagar area, and Ashish Kakkar alias Pablo, a resident of Greater Kailash -- were arrested by the federal agency last year as part of this investigation.

On January 17, ED in a statement said a provisional or-



der was issued to attach nine residential flats in Delhi and a parcel of agricultural land in Rewari, Haryana, in the name of the two people and their families.

The ED said it got on to the case after taking cognisance of multiple police FIRs registered across the country against people involved in crimes like online gaming fraud, multi-level marketing schemes and investment scams, including part-time job

frauds, online shopping and

through mobile apps. These "scams" were perpetrated through various

fake loans disbursal frauds

"fraud" websites and apps like upbitro.com (instead of original upbit.com) and a betting website www.taj777.com created by companies based in island nations like Curacao, Malta, and Cyprus, as per the agency. It said more than 200 companies, registered in the names of the two accused, were used for "layering" the proceeds of crime. These firms were also registered in the name of their employees like office boys, drivers, and

Donald Trump is coming back to Davos. This time, virtually. The freshly reinaugurated U.S. president is to speak Thursday to an international audience for the first time after returning to the White House three days earlier, with a speech and questionand-answer by video conference at the World Economic Forum's annual event. The fourth day of the annual gathering also has featured Javier Milei, the brash Argentine president, and Muhammad Yunus, the Nobel Peace Prize laureate who became interim leader of Bangladesh after the longtime president was driven from power during a public uprising.



The Navigating Global Financial System Fragmentation report estimated that fragmentation resulting from statecraft policies could cost the global economy USD 0.6 trillion to USD 5.7 trillion – up to 5 per cent of global GDP due to reduced trade and cross-border capital flows as well as lost economic ef-

It could also increase global inflation by more than 5 per

- evidenced by a 370 per cent rise in sanctions since 2017, along with subsidies, industrial policies and discussions about the creation of parallel financial architectures.

The report called on policy-makers to adopt economic statecraft that fosters cooperation, sustainable development and resilience in the global economy.

The impact of fragmentation on inflation rates and GDP growth depends heavily on the policies adopted by global leaders, WEF said. With a principled approach, policymakers can advance appropriate policies for their economies and societies while mitigating unintended effects on areas like cost of living and GDP growth, it added.

In the most extreme fragmentation scenario, a full economic decoupling between Eastern and Western blocs would force unaligned countries to trade exclusively with their most significant economic partner, it cautioned.

These nations could see GDP growth drop by over 10 per cent – nearly double the global average – with India, Brazil, Turkiye, and emerging economies in Latin America, Africa and South-East Asia bearing the greatest burden.

"Fragmentation not only fuels inflation but also negatively impacts economic growth prospects, particularly in emerging markets and developing economies that depend on an integrated financial system for their continued development," said Matt Strahan, Private Markets Lead, World Economic Forum.

Countries show interest in Vande Bharat trains: Vaishnaw

Railways Minister Ashwini Vaishnaw has said that many countries have shown interest in importing semihigh-speed Vande Bharat trains from India.

The minister, who is in Davos as part of India's delegation for the World Economic Forum meeting, said there is a great interest in investment in India across sectors such as semiconductors, food processing, industrial goods, capital goods and clean energy

"Many countries have shown interest in Vande Bharat," Vaishnaw told ANI when asked if there were queries for the import of the train manufactured in India.

"And there is one interesting thing that some participants, who are of Indian origin, say that when they were in India, their children say that they want to sit in Vande Bharat," he added. Indian Railways launched



semi-high-speed train Vande Bharat Express and it is regarded as a 'Make in India' success story.

The first Vande Bharat Express train was flagged off on February 15, 2019, on the New Delhi-Kanpur-Allahabad-Varanasi route, running at a speed of 160 kilometres per hour.

During the financial year 2022-23, approximately 31.84 lakh were booked to travel on Vande Bharat trains. The overall occupancy of Vande Bharat trains during this period has been 96.62 per cent.

These trains are equipped with top-tier amenities and advanced safety features, such as Kavach technology, accessible toilets for India's first indigenous Divyangjan, and integrated Braille signages.

In India, there are four new types of trains -- Vande Bharat Chair Car, Vande Bharat Sleeper, Namo Bharat Train, and Amrit Bharat Train.

"With the constellation of these four trains, the passengers in our country will get good quality services," Vaishnaw said.

Testing of Vande Bharat Sleeper is almost complete, and the data is being analysed, before the actual production at Integral Coach Factory, the Minister said. Answering another query, Vaishnaw said MoUs worth about Rs 20 lakh crore have been signed. "There is a lot of interest in investment from Davos, whether it is semiconductor, food processing, industrial goods, capital goods, clean energy, all are super interest," he said.

Adani Green Energy Q3 profit up 85% to Rs 474 cr

Adani Green Energy Ltd (AGEL) on Thursday posted over 85 per cent rise in consolidated net profit to Rs 474 crore for December quarter on the back of higher revenues from power supply. The company had logged a net profit of Rs 256 crore in the year-ago period, according to a BSE filing.

Revenue from power supply rose to Rs 1,993 crore in the quarter from Rs 1,765 crore in the same period vear ago.

"We are steadily developing the world's largest RE plant in Khavda, Gujarat as well as large-scale plants in Rajasthan and other sites, supported by well-aligned transmission planning." "Our updated strategy now includes largescale deployment of Battery Energy Storage Systems (BESS), given



significant cost declines in last few quarters," CEO Amit Singh said in a statement. BESS can be deployed relatively quickly and will be crucial in grid integration, supporting rapid renewable growth and complementing the company's existing solar, wind and hydro pumped storage projects, Singh said. 'Private investment to GDP in FY24 set to hit 8-year high since FY16'

NEW DELHI: Domestic investment announcements in India have seen a remarkable surge, crossing Rs 37 lakh crore in the last two fiscal years (FY23 and FY24), according to a report by the State Bank of India (SBI). This represents a significant jump from the Rs 10 lakh crore recorded in FY21 driven by robust contributions from both the government and private sectors. It said "Domestic Investment Announcements - Crossed Rs 37 lakh crore in last two years". The report highlighted that during the first nine months of FY25 (9MFY25), investments worth over Rs 32 lakh crore were announced, marking an increase from Rs 23 lakh crore during the same period in the previous year. This growth highlights the sustained momentum in investment activities across the

ernment investments also reached a significant milestone, touching 4.1 per cent of GDP in FY23, the highest since FY12.

A notable surge in investment announcements by Indian companies has been observed in the first nine months of FY25 (April to December 2024). To tighten the reins on China, controlling Mexico is essential for Trump, as China uses factories in Mexico to manufacture goods and openly sell them in the US. Biting the bullet: Why India must adopt stringent food regulations

"Excessive sugar and salt are silent architects of our nation's health crisis, constructing a future burdened by preventable

India is standing at a crucial juncture in its fight against non-communicable diseases (NCDs). The nation faces an alarming rise in lifestyle-related ailments, with cardiovascular diseases, diabetes, and hypertension becoming increasingly common. These conditions, often exacerbated by excessive sugar and salt consumption, are not merely health challenges but also substantial economic burdens. According to the World Health Organisation (WHO), NCDs account for 63% of all deaths in India, with dietary risks playing a significant role. This calls for urgent regulatory action to curb the excessive consumption of these dietary villains.

LEARNING FROM SINGAPORE

Singapore's approach provides a blueprint for India. In 2020, the city-state introduced stringent measures to combat sugar-laden beverages, mandating "Nutri-Grade" labeling and banning advertisements for high-sugar drinks. This policy aims to reduce the consumption of highcalorie, low-nutrient products, nudging consumers towards healthier choices. Early evidence suggests that such interventions can significantly influence public behavior, prompting manufacturers to reformulate products to meet healthier standards.

India, too, must consider similar regulations tailored to its unique challenges. The Indian market is flooded with ultra-processed foods and sugary beverages, with children and adolescents being the primary targets of aggressive advertising campaigns. According to a 2023 report by the Centre for Science and Environment (CSE), the average Indian consumes approximately 19 grams of added sugar per day, well above the WHO's recommended limit of 10% of total caloric intake. Salt consumption paints a graver picture, with Indians consuming an average of 10.98 grams daily, more than double the WHO's recom-

mended intake of 5 grams.

The health implications of excessive sugar and salt are profound. A 2022 Lancet study estimated that high sodium intake contributes to over 1.6 million deaths annually in India. Similarly, diabetes has reached epidemic proportions, with the International Diabetes Federation projecting 134 million cases in India by 2045 if current trends persist. These conditions impose a staggering economic burden. The World Economic Forum estimates that India could lose \$4.58 trillion between 2012 and 2030 due to NCDs, underscoring the need for immediate action.

THE CASE FOR REGULATION

Voluntary industry initiatives have proven insufficient in India, necessitating stronger regulatory frameworks. Policies restricting the advertisement and sales of high-sugar and high-salt products, especially to vulnerable groups like children, can yield significant health benefits. A multi-pronged approach, including mandatory front-of-pack labeling, advertising restrictions, and taxation on unhealthy products, can effectively address the issue.

Brazil's success with frontof-pack warning labels and Mexico's implementation of a sugar tax offer compelling evidence of the efficacy of such measures. Post-implementation, Brazil witnessed a 14% decline in the sales of high-calorie products, while Mexico reported a 7.6% reduction in sugary drink consumption in the first year of its sugar tax.

THE WAY FORWARD

For India, the first step is to draft a comprehensive policy framework inspired by global best practices but adapted to local contexts. Public awareness campaigns, akin to those for tobacco control, can play a crucial role in changing consumption patterns. Simultaneously, incentivising manufacturers to innovate healthier alternatives through subsidies or tax breaks can drive industrywide change.

Legislation targeting excessive sugar and salt must also be backed by robust enforcement mechanisms. Collaborating with state governments, healthcare professionals, and civil society organisations can ensure widespread compliance and public acceptance.

CONCLUSION

India's battle against excessive sugar and salt consumption is not just a health imperative but a socio-economic necessity. Learning from Singapore and other countries, India must act decisively to protect its population from the dual threats of sugar and salt. Enacting stringent laws, coupled with public education and industry engagement, can pave the way for a healthier future. More than forty years ago, in 1982 the film director Richard Attenborough made a film called 'Gandhi'. The film garnered multiple Oscars for itself besides being a huge success at the global box office. Indians were proud that one of their own great leaders had been showcased, but they also felt a twinge of sadness that it was a Britisher who had made the film, not an Indian. The actor Naseeruddin Shah, understanding how securing the lead role could be the opportunity of a lifetime and could set his career on a different trajectory altogether, auditioned for it. Unfortunately for him, that role went to the British actor Ben Kingsley who, as it happened, performed brilliantly and received the Oscar that

vear for best actor. Sixteen years later, in 1998,

India had cinematic revenge when an Indian film maker Shekhar Kapur directed 'Elizabeth' which secured multiple nominations and awards at the Academy Awards including an Oscar for its lead actress Cate Blanchett, Indians could now console themselves by saying that if a British film director had made a film on an Indian icon, Shekhar Kapur, an Indian film director had made a brilliant, awardwinning film on a British

How did Shekhar Kapur get the opportunity to direct Elizabeth in the first place? It was because four years previously, in 1994, he directed a film called 'Bandit Queen' based on the life story of Phoolan Devi. It caught the imagination of people across the world. A female bandit, taking revenge against landlords that had paraded her naked, gripped the public imagination. That the bandit happened to be from India made it all the more fascinating. The New York Times described it as 'an actionadventure film that defied credibility despite its truth.' The film garnered multiple awards and cemented Shekhar Kapoor's reputation as a

film maker.



Despite the accolades, Bandit Queen did not, however, set the box office on fire in India although it did excellent business in the US and Canada. This was not entirely unexpected. Furthermore, as a bandit, the character Phoolan Devi could not serve as a role model for Indian girls. This did not, however, mean that role models for girls did not exist in India. Possibly the biggest role model was Indira Gandhi a female prime minister of one of the most populous nations in the world. Across South Asia there were other female leaders who served as role models: Benazir Bhutto as the Prime Minister of Pakistan, and both Sheikh Hasina and Begum Khaleda Zia as prime ministers of Bangladesh during different periods in that troubled nation's life.

SUPREME COURT: EXTRA-JUDICIAL CONFESSION IS A 'WEAK TYPE' OF EVIDENCE, REQUIRES A GREAT DEAL OF CARE AND CAUTION

he Supreme Court in the case Sadashiv Dhondiram Patil Versus The State Of Maharashtra observed and has reiterated that an extra-judicial confession is a 'weak type' of evidence and thus it requires a great deal of care and caution.

The court also placed reliance upon Balwinder Singh vs. State of Punjab, wherein the court stated that when extra-judicial confession is being surrounded by suspicious circumstances, its credibility becomes doubtful and would lose its im-

The bench comprising of Justice J.B. Pardiwala and Justice R. Mahadevan was hearing the present matter. The bench in the case observed while overturning a judgment of the Bombay

court reserved the acquittal of the present appellant or accused for the offence of murder and to summarise, the prosecution alleged that the deceased was married to the appellant and their marital life was not very happy. One day all of a sudden, the deceased went missing and her body was recovered from the house.

The Trial Court in the case held that the prosecution in the case had failed to prove its case beyond reasonable doubt, the High Court reserved this finding.

The Trial Court in the case is of the view that a Village Police Patil is not a Police Officer and thus the confession made before him would be admissible as an extra-judicial confession.

Aggrieved with the same, the appellant preferred the

The Apex Court in the



case stated that even if the evidence is admissible, the same should be true and trustworthy in order to hold the accused guilty.

Adding to it, the court stated that the above extra-judicial confession should also be found to be free of any inducement, coercion etc. and it should be shown to have been made by the accused

on his own free will and volition.

The court stated that the same was vague and ambiguous and it could not be counted as an extra-judicial confession.

The court while considering the facts and circumstances of the case stated that, 'This court is of the view that the High Court fell in error in relying upon the extrajudicial confession even while rightly holding that the same was admissible in evidence as Village Police Patil cannot be said to be a Police Officer.'

Further, the court addressed the issue of concealment of the weapon, which was seized in the presence of the

The court also placed reliance upon Balwinder Singh vs. State of Punjab, wherein the court stated that when extra-judicial confession is being surrounded by suspicious circumstances, its credibility becomes doubtful and would lose its importance.

The court reiterated that even if the panch witnesses are turned hostile, the oral evidence of an Investigating Officer can be relied upon if it inspires confidence.

The court held that the I.O. did was to depose that he had drawn the panchnama and in the end identified his signature on the same and that of the panch witnesses. Thus, the same cannot be said to be proving the

contents of the panchnama in accordance with law. In such kind of circumstances, the circumstance of discovery also cannot be relied upon.

The court also opined that the prosecution can invoke Section 106 of the Evidence Act, only when it proves that its case is beyond reasonable doubt and as per the provision of Section 106 of Eviin the special knowledge of a person, the burden of proving that fact is on him and if the prosecution has failed to establish the same, it cannot throw the entire burden on the accused to establish his innocence. Further, the court stated

that, 'The initial burden of proof is always on the prosecution. Thus, In cases where husband is alleged to have killed his wife in the night hours and that too within the residential house, then undoubtedly the husband has to offer some explanation as to what had actually happened and if he fails to offer any plausible explanation, this can go against him. Therefore, Section 106 of the Evidence Act is subject to one well-settled principle of law and the prosecution

Supreme Court: Prosecution must establish contraband was seized from 'conscious possession' of accused to prove offence under NDPS Act

The Supreme Court in the case Rakesh Kumar Raghuvanshi v. The State of Madhya Pradesh observed and has reiterated that to prove offences under the Narcotic Drugs and Psychotropic Substances Act, NDPS Act, the prosecution must establish that the contraband was seized from the 'conscious possession' of the accused.

The court in the case stated that, 'Conscious possession refers to a scenario where an individual not only physically possesses a narcotic drug or psychotropic substance but is also aware of its presence and nature. Thus, it requires both physical control and mental awareness.'

The court in the case stated that, 'The Conscious possession implies that the person knew that he had

CHINA AIMS TO WORK WITH NETHERLANDS

QATAR'S NEW LAWS FOR FOREIGN INVESTMENT

DOHA: Qatar plans to introduce three new laws as part of a sweeping review of legislation designed to make the Gulf Arab state more attractive to foreign investors, the new minister of commerce and economy told Reuters. Sheikh Faisal bin Thani Al Thani said in an interview that Qatar plans to introduce new legislation including a bankruptcy law, a public private partnership law

and a new commercial registration law. "We're looking at 27 laws and regulations across 17 government ministries that affect 500-plus activities," he said, describing the legislative review. Sheikh Faisal said he expects the new bankruptcy and public private partnership laws to be drafted before the

TAIWAN FINDS 35 CHINESE PLANES IN ITS AREA

Taipei: Taiwan's Ministry of National Defence (MND) has detected 35 Chinese aircraft and 6 naval vessels around the island as of 6 am (UTC+8) on Thursday Among them, 27 aircraft crossed the median line and entered Taiwan's northern, southwestern and eastern Air Defense Identification Zone (ADIZ). Sharing a post on X, MND wrote, "35 PLA aircraft and 6 PLAN vessels operating around Taiwan were detected up until 6 a.m. (UTC+8) today. 27 of the aircraft crossed the median line and entered Taiwan's northern, southwestern and eastern ADIZ. We have monitored the situation and responded accordingly.

AIR INDIA TO RESUME TEL AVIV-DELHI FLIGHTS

JERUSALEM: With ceasefire holding up in the north and south of Israel, several major international airlines, including Air India, have announced plans to resume flights to Israel expanding connectivity to the war-torn region. "It's official now. We are resuming flights from March 2, 2025," a representative for Air India in Israel told PTI. A magnitude 5.4 earthquake followed four hours later that hit Siocon town in the southern Mindanao region. The agency had recorded at least 68 aftershocks from the Visayas tremor. There were no immediate reports of injuries from either tremor.

Trump announces potential tariffs on Chinese imports soon

US President Donald Trump on Tuesday announced that the first phase of US tariffs on Chinese imports could be implemented as soon as next week, as reported by Radio Free Asia

According to Radio Free Asia, Trump had initially threatened to impose a 10 per cent tariff on Chinese imports on his first day in office, following his campaign pledge the previous year that tariffs on Chinese goods could potentially exceed 60 per cent.

The tariffs were not included in the series of executive orders the new president signed on his first day back in the White House on Mon-



day. However, on Tuesday, Trump indicated that February 1 could mark the day the tariffs are imposed, emphasising that they are necessary to strengthen domestic industry, the Radio Free Asia reported.

"We're talking about a tariff of 10 per cent on China based

on the fact that they're sending fentanyl to Mexico and Canada," Trump said, following the announcement of an USD 500 billion AI infrastructure investment by Oracle, OpenAI, and SoftBank.

According to Radio Free Asia, Trump mentioned that he had discussed the issue with Chinese President Xi Jinping during a phone call on Friday, prior to his return to power. "I told him, we don't want that crap in our country," Trump recalled.

Efforts to curb the flow of fentanyl precursors from China were a key focus of former US President Joe Biden's diplomatic efforts with Beijing. One of the main outcomes of the 2023 summit between Biden and Xi in

San Francisco was Xi's pledge to crack down on precursor exports.

In the months following that meeting, Biden administration officials largely acknowledged that China had made progress on its commitments. However, Trump argued that insufficient action had been taken, RFA reported.

Fentanyl is an extremely potent synthetic opioid that US authorities hold responsible for the deaths of tens of thousands of Americans annually. The drug's precursors are manufactured in China and then converted into fentanyl by Mexican transnational drug trafficking organisations, who smuggle it into the United States.

'MUSK WORKED RAMASWAMY OUT OF DOGE FOLLOWING DIFFERENCES'

s Indian-origin entrepreneur and Republican leader Vivek Ramaswamy pulled out of the Department of Government Efficiency (DOGE), just 69 days after he was announced the cohead of the team along with tech billionaire Elon Musk, a report has revealed that it was the Tesla CEO who wanted Ramaswamy 'out' of the team.

Politico reported citing three people with Elon Musk's preference said the billionaire made it known that he wanted Ramaswamy out of DOGE in recent days.

Hours after Trump's inauguration as the 47th US President, Ramaswamy announced that he would not co-head DOGE.

Musk's ability to ice out Ramaswamy, who for a variety of reasons had irked some Republicans in Trump's circle, is the latest sign of his influence in the incoming administration. It presages an encore of all of the infighting that

marked Trump's first term. Ramaswamy "just burned through the bridges and he finally burned Elon," said a Republican strategist close to Trump advisers. "Everyone wants him out of Mara-Lago, out of DC."

According to the report, Ramaswamy's comments on X during a discussion of H-1B visas were the 'main reason' for some Republicans' getting frustrated with him.

In December last year, the Indian-origin leader criticised American cul-

Ramaswamy is planning to announce a run for Ohio Governor next week, as reported by Politico. A person close to DOGE said Musk did not think it was feasible for him to campaign for office while working on DOGE.

Meanwhile, Trump transition spokesperson Anna Kelly lauded Ramaswamy and said that he "played a

critical role in helping us create DOGE" and that his plan to run for governor "requires him to remain outside of DOGE based on the structure that we an-

Politico reported citing sources, that Ramaswamy maintained to confidants as late as Saturday evening that he was actively involved in DOGE, saying he was at work writing executive orders. However, a person familiar with the arrangement informed that he had done almost no DOGE-related work since early December.

NATO chief Rutte says Europe will pay for US arms for Ukraine

His comments came after U.S. President Donald Trump said earlier this week that the European Union should be doing more to support Ukraine.

"On Ukraine, we need the U.S. also to stay involved," Rutte said.

"If this new Trump administration is willing to keep on supplying Ukraine from its defence industrial base, the bill will be paid by the Europeans, I'm absolutely convinced of this, we have to be willing to do that," he added.

UK warns of 'action' as Russian spy ship detected in its area

The UK has warned of "robust action" after the Royal Navy tracked Russian spy ships in the English Channel just weeks after it claimed to have caught it "loitering over" critical undersea infrastructure in Britain's waters.

Defence Secretary John Donald Trump's Ukraine deal vs Putin's concern over Russia's economy

President Vladimir Putin has grown increasingly concerned about distortions in Russia's wartime economy, just as Donald Trump pushes for an end to the Ukraine conflict, five sources with knowledge of the situation told Reuters.

Russia's economy, driven by exports of oil, gas and minerals, grew robustly over the past two years despite multiple rounds of



Western sanctions imposed after its invasion of Ukraine in 2022.

But domestic activity has become strained in recent months by labour shortages and high interest rates introduced to tackle inflation, which has accelerated under record military spending.

That has contributed to the view within a section of the Russian elite that a negotiated settlement to the war is desirable, according to two of the sources familiar with thinking in the Kremlin.

Trump, who returned to office on Monday, has vowed to swiftly resolve the Ukraine conflict. Europe's biggest since World War Two.

This week he has said more sanctions, as well as tariffs, on Russia are likely unless Putin negotiates, adding that Russia was heading for "big trouble" in the economy. A senior Kremlin aide said on Tuesday that Russia had so far received no specific propos-

als for talks. "Russia, of course, is economically interested in negotiating a diplomatic end to the conflict," Oleg Vyugin, former deputy chairman of the Central Bank of Russia said in an interview, citing the risk of growing economic distortions as Russia turbo-charges military and defence spending.

Vyugin was not one of the five sources, who all spoke on condition of anonymity due to the sensitivity of the situation in Russia. The extent of Putin's concerns about the economy, described by the sources, and the influence of that on views within the Kremlin about the war, are documented here for the first

Media has previously reported that Putin is ready to discuss ceasefire options with Trump but that Russia's territorial gains in Ukraine must be accepted and that Ukraine must drop its bid to join the U.Sled NATO military alliance.

Kremlin spokesman Dmitry Peskov, when asked

about the Reuters reporting, acknowledged "problematic factors" in the economy, but said it was developing at a high rate and was able to meet "all military requirements incrementally" as well as all welfare and social needs.

Filmmaker and screenwriter Ram Gopal Varma has been sentenced to three months in jail in the old cheque bounce case. Ram Gopal Varma was sentenced today, on January 23, by a Mumbai court. A non-bailable warrant has also been issued against him for execution of the sentence as per the Code of Criminal Procedure (CrPC) as Ram Gopal Varma failed to present himself before the court.

Judicial Magistrate (First Class) in Andheri, YP Pujari, had convicted Ram Gopal Varma for the offence punishable under the provisions of the Negotiable Instruments Act on Tuesday, January 21.

Apart from a jail sentence, Ram Gopal Varma has also been ordered to pay Rs.3.72 lakh in compensation to the complainant. The filmmaker has been directed to pay the amount within three months. If Ram Gopal Varma fails to pay Rs.3.72 lakh to the complainant, he will have to face an additional three months of imprisonment.





West Indies crush Malaysia to secure Super Six spot

West Indies secured their place in the Super Six stage of the Women's Under-19 T20 World Cup 2025 with a commanding 53-run victory over hosts Malaysia in Kuala Lumpur on Thursday. Despite posting a modest total of 112 for 7 in their 20 overs, the West Indies bowlers dismantled Malaysia's batting lineup, bowling them out for just 59 runs and finishing third in Group A.

The loss marked Malaysia's exit from the tournament, as they ended at the bottom of the group with three consecutive defeats.

West Indies captain and allrounder Samara Ramnath was the standout performer in this virtual knockout clash. Although she scored only 5 runs at the top of the

order, she made a significant impact with the ball, claiming 4 wickets for just 6 runs. Her figures are the third-best in this edition of the tournament, behind the five-wicket hauls of Vaishnavi Sharma (India) and Maisie Maceira (Scotland).

Malaysia appeared steady at 38 for 2 after 10 overs while chasing a target of 113, but Ramnath triggered a dramatic collapse. She took four crucial wickets, all either bowled

or lbw, reducing Malaysia to 59 all out as they lost their last eight wickets for just 21 runs. Ramnath struck in her second over, dismissing her counterpart, Nur Daniya Syuhada, who had earlier taken her wicket. In the same over, she trapped Nur Izzatul Syafiga lbw. Returning for her next spell, she clean-bowled Suabika Manivannan before sealing the demolition in the 18th over.

MCA achieves a unique record

The Mumbai Cricket Association (MCA) on Thursday achieved the Guinness World Record for the largest cricket ball sentence using 14,505 red and white varieties of the ball here at the Wankhede Stadium.

The feat came as a part of MCA's grand celebrations for the completion of 50 years of one of India's iconic cricket venues, the Wankhede Stadium here, which has been home to some of Indian cricket's superstars. It was also the venue where India achieved their second 50-over World Cup title in 2011 under the legendary



"We are thrilled to announce that the Mumbai Cricket Association has achieved a Guinness World Record for the largest cricket ball sentence at Wankhede Stadium, using 14,505 red & white cricket balls," said MCA president Ajinkya Naik.

"This incredible feat, commemorating the 50th anniversary of the first Test match at Wankhede, is dedicated

to the memory of Late Shri Eknath Solkar and other former Mumbai players who have served Mumbai cricket and are no longer with us," he added.

The record was created on the anniversary of the first international match at the Wankhede Stadium played in 1975 from January 23-29 between India and the West Indies. Solkar had scored a century in that contest.

"MCA will give the balls, which were used to achieve this record, to the aspiring cricketers of schools, clubs and NGOs in the city, encouraging them to take inspiration from this record and achieve greater milestones in their careers," the governing body said in a

In Eden Gardens on Wednesday, out of Abhishek's 79 runs, 68 came in the form of boundaries. With his repertoire of shots, he reeled away five

bashing English bowl- fours and a whopping eight maximums while striking at 232.35.

> He certainly had luck on his side after being dropped twice in the game. He unleashed a flurry of boundaries during his swashbuckling performance and brought dazzling six.

After being dropped for the second time, his luck eventually ran out. He attempted to loft a delivery from Adil Rashid but was caught by Harry Brook at longoff, ending his explosive knock of 79 (34 balls). Abhishek's efforts saw India chase down a paltry 133-run target with 43 balls to spare. This is the fastest successful chase for India against England in men's T2OIs with the most balls remaining.

Before the record-shattering display in Kolkata, India's fastest successful chase with most balls to spare dates back to 2012. When India set out to chase 158 in Pune, the hosts managed to achieve the feat with 13 balls left.

Rohit's struggles continue with a 3-run knock in Ranji

Team India captain Rohit Sharma's poor form with the bat continued as he was dismissed for just 3 runs on the opening day of the Ranji Trophy match against Jammu &

Kashmir at Mumbai on Thursday. Rohit faced 19 deliveries before falling to pacer Umar Nazir Mir, extending his run of disappointing perfor-

Rohit's last Ranji Trophy appearance for Mumbai was in November 2015 when he scored a blazing 113 off 140 balls against Uttar Pradesh in a match that ended in a draw.

In Test cricket, Rohit's recent performances have raised concerns about his form. During India's tour of Australia, the seasoned opener managed just 31 runs in five innings across three Tests. The 2024-25 Test season, in particular, was disappointing for Rohit. He accumulated only 164 runs in eight matches and 15 innings at an average of 10.93, with his highest score being 52, a solitary half-century against Bangladesh.

As captain, Rohit faced some significant challenges. Before the Test series against Australia, India suffered their first home Test series

defeat in 12 years, losing O-3 to New Zealand. This was also India's first-ever whitewash in a home Test series since 2000.

After India's 295-run victory in the first Test against Australia at Perth under the leadership of Jasprit Bumrah, Rohit rejoined the team following the birth of his second child.

The Mumbai Cricket Association (MCA) announced the senior selection committee's decision regarding Rohit's inclusion on January 20.

Young southpaw Yashasvi Jaiswal who is Rohit's batting partner in red-ball cricket for India was dismissed early as well, he managed only 4 runs before being trapped LBW by Augib Nabi.

Two-time champion Aryna Sabalenka reached her third successive Australian Open final, defeating 11th seed Paula Badosa in the semifinal on Thursday.

Beating Badosa 6-4, 6-2, the defending champion now has a chance to win her third Australian Open title. She also extended her winning streak at Melbourne Park to 20 matches.

The star player remains undefeated in 2025, extending her win streak to 11 matches. Sabalenka, 26, is the first woman to reach three Australian Open finals since Serena Williams and the youngest since Martina Hingis.
