# RUCKUS AT WAQF JPC MEET. OPPOSITION MPs SUSPENDED

JPC chief accuses TMC MP of using unparliamentary language

**T**agdambika Pal, chairman of the Joint Par-J liamentary Committee (JPC) on the Waqf (Amendment) Bill, 2024, accused Trinamool Congress (TMC) MP Kalyan Banerjee of using "unparliamentary" language against him. He said that the House was adjourned twice due to the alleged ruckus created by the opposition leaders, who have been suspended from the JPC meeting.

Pal said that BJP MP Nishikant Dubey moved a motion to suspend the opposition MPs for creating a "ruckus" after they resorted to "shouting" and "sloganeering" while not allowing the meeting to continue.

"We adjourned the House twice. We had given time to Mirwaiz Umar Farooq on the suggestions of the opposition only. Kalyan Banerjee used unparliamentary words against me and abused me. I kept requesting him to let the invitees speak. However, they were adamant about creating a ruckus. We adjourned the house again and again but they (opposition MPs) did not want the meeting to

## Blast in ordnance factory kills 8 in Maharashtra

BHANDARA (MAHARASHTRA)

The death toll in the ordnance factory blast in the Jawahar Nagar area of Bhandara district, has risen to eight, according to officials on Friday.

The blast incident claimed the lives of eight, while 13

people have been rescued from the site of the incident and five people are currently undergoing treatment. Nagpur Range Inspector

General Dilip Patil Bhujbal also shared the development and said, "Today, at around 11 am, a huge explosion took place at the Ordnance factory in Bhan-



dara. The officials reached the spot immediately.

The search and rescue operations were completed within 8 hours. It was a unit to make low-temperature plastic explosives."

"13 people were working at the unit. 8 lost their lives and 5 were injured. Two of the injured have

been shifted to Nagpur and 3 are in Bhandara. Five tonnes of RDX is still there under debris. The process of removing it safely will begin in phase 2. An SOP would be created so that such an incident does not happen again," said the official.

## SC declines PIL seeking to scrap TDS system

The Supreme Court on Friday refused to entertain a PIL seeking to declare that the Tax Deducted at Source (TDS) system is "manifestly arbitrary, irrational and violative of various fundamental rights".

A bench of Chief Justice of India Sanjiv Khanna and Justice Sanjay Kumar declined the plea filed by advocate petitioner advocate Ashwini Upadhyay and said he may approach High Court with his plea.

"Sorry, we will not entertain. It is very badly drafted. You can move the High Court. Some judgments have upheld it. We will not entertain. Dismissed," said the bench.

The petition contended that the TDS system disproportionately burdens assesses with significant administrative expenses.



"Declare the TDS system manifestly arbitrary, irrational and against Articles 14 (right to equality), 19 (right to practice profession) and 21 (right to life and personal liberty) of the Constitution, hence void and inoperative," the plea stated.

The petition made the Centre, Ministry of Law and Justice. Law Commission, and NITI Aayog as parties in the case.The plea urged the apex court to direct the NITI Ayog to consider contentions raised in the plea and suggest necessary changes in TDS system.

Law Commission should examine the legality of the TDS system and prepare a report within three months, it sought. The petition said the system

violated Article 14 by disproportionately burdening economically weaker sections and small earners who lack the capacity to navigate its technical requirements.

The plea while referring to Article 23 said the imposition of tax collection duties on private citizens amounted to forced labour.

"The regulatory and procedural framework surrounding TDS is excessively technical, often requiring specialised legal and financial expertise, which most assessees lack The result is an unjust shifting of sovereign responsibilities from the government to private citizens without adequate compensation, resources, or legal safeguards," it said.

The Congress MLAs in Haryana are now fed up with the ongoing internal strife within the party. The ruling BJP is leaving no opportunity to capitalize on the infighting among Congress leaders.

Meanwhile, Chief Minister Nayab Singh Saini is gradually moving forward in gaining the trust of Congress MLAs. Due to the Chief Minister's generosity and his approach of respecting opposition MLAs, Congress MLAs are increasingly sharing the BJP's political platform.

It has only been three months since Haryana's Chief Minister Nayab Singh Saini returned to power, and once again, there is upheaval within Congress. There is speculation that two Congress MLAs may leave the party to join the BJP. In the 90seat assembly, the BJP won 48 seats to secure power. By forming the government for the third consecutive term, the BJP has created history in the state. Recently, Congress MLAs Shailee Chaudhary and Gokul Setia praised Saini, calling him a hardworking CM. One of them even went as far as saying, "I applaud such a personality."

Additionally, they expressed heartfelt thanks for the funds provided for the development of their areas

MLA from Narayangarh constituency in Ambala, while Gokul Setia is the MLA from Sirsa. Over the past few days, these two MLAs have been at the center of political discussions in Haryana, though neither Congress nor BIP leaders have confirmed anything so far. On January 20, Nayab Singh Saini had a program in Narayangarh. During the event, MLA Shailee Chaudhary was also on the stage. Her remarks

about the CM have caught everyone's attention. She said, "It is our good fortune to have such a hardworking Chief Shailee Chaudhary is the Minister. We are proud that he is one of us. Not just Narayangarh, but the entire state is praising him. Our area has been lagging politically and in terms of development. The CM has removed the political backwardness. Now, I urge him to work on development as well.'

During this event, Shailee Chaudhary raised several demands, including a trauma centre and a medical college, and also referred to the CM as the "son of Narayangarh." She expressed confidence that he would understand Narayangarh's problems and make every effort to address them. On the same day, CM Saini announced projects worth Rs 43 crores for the area.







## HC refuses to direct sitting of assembly for tabling CAG reports

TDG NETWORK

The Delhi High Court on Friday said there was an "inordinate delay" by the AAP government in tabling the CAG reports in the state assembly but refused to direct a special sitting of the legislature, saying it was "impractical" to hold a special sitting a few days before elections. Justice Sachin Datta underlined the tabling of the audit reports was mandatory under the Constitution and directed the reports to be placed in the assembly by Delhi government after the elections as expeditiously as possible.

"It is quite evide there has been an inordinate delay on the part of the respondents/Government of NCT of Delhi in taking requisite steps for laying the CAG Reports before the Legislative Assembly," the court



said. It went on, "In such a situation (when the current legislative assembly is about to expire), it would be impractical to hold a special sitting of the assembly... Given is at the fag end of its current term, the examination and scrutiny by the PAC (public accounts committee) will now take place only after the newly-elected assembly is re-

The court is not inclined to

accept the prayers of the petitioners for a mandamus to the speaker for summoning a special session of the legislative assembly at this stage, it added. Opposition leader Vithat the legislative assembly jender Gupta and BJP MLAs -- Mohan Singh Bisht, Om Prakash Sharma, Ajay Kumar Mahawar, Abhay Verma, Anil Kumar Bajpai and Jitendra Mahajan -- filed the petition last year and sought a direction to the speaker to

for tabling the CAG reports. In a 31-page judgement, Justice Datta observed the timeline revealed the government's "disdainful disregard" of its constitutional obligations as it failed to act with alacrity in laying all the 14 CAG reports before the legislative assembly in the present session even after the LG approval. The court therefore said once the legislative assembly was constituted and summoned pursuant to the elections, steps should be taken by Delhi government under the procedural rules for tabling the CAG reports as expeditiously as possible.

The court said laying the reports before the legislature comprising elected representatives was in the "nature of a mandatory constitutional imperative" and aimed to hold the government of the day accountable in the field of financial administration.

## Centre, Delhi Police conspiring to kill Kejriwal: AAP with utmost urgency and

The Aam Aadmi Party (AAP) on Friday accused the BJP-led Centre and the Delhi Police of conspiring to "kill" its supremo Arvind Keiriwal and urged the Election Commission (EC) to restore his security cover provided by the Punjab Police that was withdrawn.There was no immediate reaction from the BJP or the Delhi Police to the allegation.

Addressing a press conference here, Delhi Chief Minister Atishi and her Punjab counterpart, Bhagwant Mann, said they have written to the EC demanding "fair grounds" for the AAP in the February 5 Delhi Assembly polls and the restoration of Keiriwal's security cover given by the Punjab Police, along with an audit of "life-threatening" attacks

They alleged that the Delhi Police, which comes under the Centre, has turned a

Attacks have been attempted on him one after the other. In October (last year), an attack was made on Kejriwal. Upon investigation by us, it was found that the attackers were BIP workers, but police took no action," Atishi alleged.

The day will conclude with a second public meeting at DDA Park in Netaji Subhash Palace, within the Trinagar Assembly constituency, scheduled for the evening. This event will serve as another platform for Shah to connect with the public and discuss future initiatives for Delhiites if the Bharativa Ianata Party comes into power after the Assembly polls.

Delhi has a total of 70 assembly constituencies -- 58 general seats and 12 constituencies reserved for scheduled castes (SC).

The voting will take place in a single phase across 70 constituencies on February 5 and the counting of votes will be conducted on February 8. The term of the Delhi legislative assembly ends on February 23, 2025.

# DALIT VOTES MAY SPLIT BETWEEN AAP, BJP, CONG

**AAP** faces disillusionment over unmet promises on manual scavenging and municipal laborissues.

s the Aam Aadmi Party (AAP) battles Lto protect its main turf, the Dalit voters of Delhi are in focus in the upcoming Assembly polls in the capital, with both the Congress and BJP challenging the ruling party, leading to the possibility of a split in the Dalit votes between the three parties, experts say. Kejriwal, whose AAP is eveing a third straight term in power in Delhi, has enjoyed the support of the Dalit voters in the past, even as the experts say that some disillusionment has crept in. On the other hand, the Bharatiya Janata Party (BJP) has come up with a slew of promises for the Dalits and is holding

Congress is making a late push to attract Dalit votes, but experts believe it may be too late to rival the efforts of AAP and BJP.

extensive reach-out programmes in Dalit-majority constituencies.

Union Home Minister Amit Shah's remarks in the Raiva Sabha on BR Ambedkar, which had triggered a sharp attack from opposition parties, including the AAP and Congress, added fuel to the war of narratives ahead of the February 5 polls. However, the BJP has countered it aggressively.

In the 2020 Delhi polls, the AAP won all 12 seats reserved for the Scheduled Castes (SCs) and a large chunk of Dalit votes, which helped the party secure its

second term in the capital. This time, however, the votes may split three-way, the experts say.

"While Dalit voters have a presence in all constituencies, there are at least 30-35 seats in Delhi where they can sway the election results. The AAP is likely to lose some support and the Dalit votes are likely to be split among the three major parties," independent political analyst and founder and

director of Subaltern Media

Foundation Kush Ambed-

karwadi said.

"The two photos that Keiriwal has in his office are of BR Ambedkar and Bhagat Singh, because Dalits are in large numbers in Delhi as well as Punjab. The AAP's election symbol -- broom -also resonates with the Dalit voters and they can feel a connection. A huge chunk of Dalit votes had gone to the party. But today, the Dalit community is not as happy

with Kejriwal because there

has not been much change in their lives," Ambedkarwadi told PTI.

"The Dalit community, which has been supporting the AAP, is unhappy this time. Like the Valmiki community, it thought that the AAP has broom as its symbol, so it will work for them. However, one of the main concerns of the Valmiki community is the contractual labour in the municipal corporation. Nothing has been done about it," he said.

"Tall promises were made that people will not have to go down sewage drains to clean those anymore and there will be no manual scavenging. But that has not happened either," Ambedkarwadi said.

"A lot of votes of the Ravidassia community and the Jatavs have shifted from the BSP and gone to the AAP. But all prominent AAP leaders from these communities have quit the party,"

he added. According to data compiled by Subaltern Media Foundation, there are around 1.23 crore Dalit voters in Delhi. The Chamar community, which includes Jatavs, has more than 24 lakh members and presence in all Delhi districts. The number of Valmikis is more than 12 lakh, while the other major Dalit groups include Mallahs, who are over two lakh in numbers, more than 4.82 lakh Khatiks and over 4.18 lakh Kolis.

Other prominent Dalit caste groups include Chohra, Bazigar, Banjara, Dhobi, Julaha, Madari, Pasi, Sapera and Nat.

Former Delhi minister Rajendra Pal Gautam, who was one of the prominent Dalit faces of the AAP till he quit the party and joined the Congress last year, also said the ruling party has not fulfilled its core promises to the community.

"There is a reason why Dalits are in focus this time. The upper-caste voters are mostly supporting the BJP. Among the OBCs, there are some groups that are with the BJP. Dalit votes may, however, split three-way between the BJP, AAP and Congress," Gautam told PTI.

## SC appoints SIT to probe illegal compensation in NOIDA

Dissatisfied with a UP government-appointed panel probing the issue of illegal compensation to land owners paid by NOIDA officials, the Supreme Court has appointed an SIT to look into it.

A bench of Justices Surva Kant and N Kotiswar Singh ruled while hearing the anticipatory bail pleas of the legal advisor and one of the law officers of NOIDA who were accused of corruption.

It said the allegations related to the release of huge amounts of compensation in favour of some landowners, who were allegedly not entitled to seek such a higher compensation for their acquired land.

The top court constituted the special investigation team (SIT) comprising IPS officer and Additional General of Police, Lucknow zone S B Shiradkar, Inspector General CBCID Modak Rajesh D Rao and Hemant Kutiyal, Commandant of UP Special Range Security Battalion.

"The special investigation team shall, inter alia, look into the issues (i) whether the quantum of compensation paid to the land owners was higher than they are entitled to in terms of the judgments passed by the courts from time to time; (ii) if so, who were the officers/officials responsible for such exorbitant



payment; (iii) whether there was any collusion or connivance between the beneficiaries and officers/officials of NOIDA: and (iv) whether the overall functioning of NOIDA lacks transparency, fairness and commitment to the cause of public interest," it said on January 23.

Directing the SIT to file its report in a sealed cover within two months, the bench said the team was free to look into any other allied issue during the investigation.

The bench however protected the beneficiaries, farmers and landowners, who were paid the extra compensation from any coercive or penal action without its permission.

It observed on September 14, 2023, when the matter was heard, it was learnt that the FIR in the case was not a solitary instance of alleged excess payment of compensation to the land owners but there were numerous instances of such payments, prima facie, for extraneous considerations and on quid pro quo basis.

"It was consequently desired that an independent agency should hold a deeper probe into the functioning of NOIDA as a statutory authority," the bench noted.

On October 5, 2023, the state government informed the top court that it had constituted a fact-finding committee comprising three officers, including the additional director general of police, Meerut Zone, to examine the cases where NOIDA might have paid illegal compensation in collusion and connivance with the officers of the authority and the beneficiaries.

It said, "Keeping in view the limited mandate given to that committee and the manner in which the proceedings were conducted, we were not satisfied with its outcome, especially when it was brought to our notice on November 22, 2023 that under the garb of investigation, the committee was trying to question the grant of higher compensation to the landowners under the court orders."

The bench went on, "It was

## Delhi's maximum temp settles at 23.7°C with moderate AQI

Delhi recorded a maximum temperature of 23.7 degrees Celsius with moderate air quality on Friday, the India Meteorological Department (IMD) said. The 24-hour average Air Quality Index (AQI) was recorded in the moderate' category at 199, according to the Central Pollution Control Board (CPCB).

An AOI between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500

Meanwhile, the minimum temperature stood at 9.8 degrees Celsius, 2.3 degrees above average, with humidity levels fluctuating between 90 and 58 percent during the day, the IMD said.



The weather department has forecast clear skies for Saturday with predominant surface winds expected from the northwest direction.

The wind speed is likely to be less than 8 kmph during the morning hours with shallow fog or mist expected during the early morning, it said.

Wind speed is expected to gradually increase to 12 to 14 kmph by the afternoon, again from the northwest direction, it added.

By evening and night, the speed will decrease to less than 10 kmph, and smog or mist is likely to develop, the IMD said.

The maximum and minimum temperatures for Saturday are expected to settle around 22 degrees Celsius and 8 degrees Celsius, respectively.

## Court exempts Kejriwal, Sisodia from appearing in excise case during campaigning

A Delhi court on Friday exempted former chief minister Arvind Kejriwal and AAP leaders Manish Sisodia and Durgesh Pathak from personally appearing in a excise case as they were campaigning for upcoming assembly elections. Special judge Kaveri Baweja allowed the reprieve after the three AAP leaders said they were unable to personally appear in court as they were "actively engaged" in campaigning for the elec-

tions "In view of the above said submissions, personal appearance of the applicants are exempted for today only through counsel... The case is adjourned to February 3, 2025," the judge said.

The money laundering case stems from a CBI case lodged after Delhi Lieutenant Governor V K Saxena recommended a probe into the alleged irregularities in the implementation of the excise policy.

According to the CBI and the ED, irregularities were committed while modifying the excise policy and undue favours were extended to the licence holders.

The Delhi government implemented the policy on November 17, 2021, and scrapped it by the end of September 2022 amid allegations of corruption.

## Delhi Police nabs man in Rs 15 cr Covid-19 vaccine scam

The Economic Offences Wing (EOW) of the Delhi Police has arrested a man who had been absconding for nearly three years in a Rs 15 crore fraud case, an



official said on Friday.The accused, Prafulla Kumar Nayak, who impersonated an officer from the Ministry of Health and Family Welfare, played a key role in duping victims by promising work orders related to Covid-19 vaccine transportation during the pandemic, the EOW statement read.

The case originated in 2022 following a complaint by one Sunil Kaushik, who alleged that he was defrauded of Rs 4 crore under the pretext of securing government contracts for vaccine transportation.

"Four additional complaints revealed a similar modus operandi, with the accused collectively duping victims of over Rs 15 crore.' Additional Commissioner of Police (EOW) Amrutha Guguloth said in the state-

Investigations revealed that in May 2021, the accused lured victims by arranging meetings within the premises of Nirman Bhawan, the Ministry of Health and Family Welfare's headquarters.

# **NEED TO ADDRESS JUDICIAL DELAYS IN INDIA:** CHALLENGES AND REFORMS

The Preamble of the Indian Constitution provides for social, economic, and political justice which is effectuated through various constitutional articles.





e legal maxim of 'Justice delayed is justice denied" which means justice is not served if there is a delay in resolving a case specifically fits the situation of the judiciary in India. Recently, the Supreme Court had expressed "shock" to learn that a murder case accused's bail application was pending before the Allahabad High Court for the last four years. Such is the situation that the Indian judiciary currently faces, which impedes the timely delivery of justice. Such inefficiency and consequent judicial delay due to procedural complexities and a lack of technological integration incur substantial economic costs affecting litigants adversely. Thus, addressing these issues requires a comprefor speedy trials and the impartiality in legal prosystemic challenges that undermine judicial efficiency including identifying challenges in providing

speedy trials and legal aid,

and discussing proposed reforms to mitigate these issues from a constitutional perspective.

The Preamble of the In-


dian Constitution provides for social, economic, and political justice which is effectuated through various constitutional articles. Article 14, which deals with equality before the law and equal protection of the law; Article 21, which protects life and personal liberty; and Article 323A which provides for the establishment of an administrative tribunal. Among these provisions, the right to a speedy trial is implicitly included within the ambit of the right to a fair trial, which forms part of the right to life and liberty guaranteed by Article 21. The judiciary is designed to be an independent organ, ceedings.

The Indian Constitution places significant emphasis on the right to speedy justice. However, the prevalent

culture of adjournments in Indian courts has resulted in delayed and prolonged trials, thereby creating substantial challenges in delivering efficient legal aid. The Indian judicial system is plagued by inefficiencies stemming from the high volume of cases filed daily and the significant number of vacancies in the lower judiciary. Addressing these inefficiencies requires the recruitment of additional judicial personnel and the optimal allocation of resources to manage caseloads more effectively. Various other institutional and legal complexities and a lack of technological integration also contribute to judicial delays, causing immense loss of productivity and rising litigation costs.

The Law Commission of India, in its 77th report, had observed that "Long delay in the disposal of cases has resulted in huge arrears and a heavy backlog of pending files in various courts in the country. A bare glance at the statements of the various types of cases pending in different courts and the duration for which those cases have been pending is enough to show the enormity of the problem".

In this background, the essence of access to justice could be understood to include four main facets that constitute the essence of access to justice including but not limited to the need for an adjudicatory mechanism; the mechanism must be conveniently accessible hensive understanding of crucial for maintaining the in terms of justice; the prothe constitutional mandate rule of law and ensuring cess of adjudication must be speedy, and the process of adjudication must be affordable to the disputants. These aspects were also emphasized in the case of Hussainara Khatoon v.



The right to a speedy trial is recognized internationally as a fundamental human right enshrined in international human rights law. In Europe, the right to a speedy trial has been recognized by the European Court of Human Rights (ECHR) in the case of Delcourt v. Belgium, wherein it opined that access to justice was a valuable human and fundamental right which parallels Article 21 of the Indian Constitution.

It also pointed out that Article 39 A, which guarantees free legal aid and equal justice to all citizens, is an inalienable part of ensuring speedy justice. Amendment) Act 1976. Despite the existing le-

gal framework, the issue of judicial delays, primarily caused by unwarranted adjournments, remains a persistent challenge. These delays not only lead to substantial economic losses but also hinder access to justice.. Adopting modern technologies, increased use of alternative dispute resolution mechanisms, simplifying legal procedures, and implementing Active Case Management (ACM). where judges take a proac-

tive role in managing cases by organizing pre-trial conferences and setting deadlines, will help reduce adjournments and improve the speed and quality of legal processes in ensuring access to justice.

The right to a speedy trial is recognized internationally as a fundamental human right enshrined in international human rights law. In Europe, the right to a speedy trial has been recognized by the European

Court of Human Rights (ECHR) in the case of Delcourt v. Belgium, wherein it opined that access to justice was a valuable human and fundamental right which parallels Article 21 of the Indian Constitution. This right underscores the importance of timely ate Professor at O.P. Jindal adjudication as a critical component of the broader framework of justice.

In the Indian context, future litigation policies must integrate the advancements established during the CO-VID-19 pandemic, such as e-courts and online dispute resolution (ODR), to streamline dispute resolution mechanisms, as the computerization of courts has helped in reducing the "Backlog of Cases" in the past. However, mere computerization of court would not serve any further purpose in the present times, and there exists a need for electronic courts to facilitate the speedy disposal of cases. Additionally, there is an urgent need to incentivize the prosecutors and government officials who handle cases to prevent delays in hearings, impacting the applicants who have to testify repeatedly before the court. The applicants experience social and economic issues in appearing before the judges repeatedly, violating the constitutional rights of speedy trial under Article 21.

Ultimately, upholding the right to a speedy trial is integral to the broader protection of the right to life and personal liberty envisioned by the framers of the Constitution. Only by safeguarding this right can the justice system effectively fulfil its role as a protector of individual rights and liberties, thereby fostering public confidence in the rule of law.

We are now fighting the BJP, RSS and the Indian state itself". BJP was prompt to call his words coming from George Soros playbook. Section 152 pertains to Acts endangering sovereignty, unity and integrity of India and section 197 Imputations, assertions prejudicial to national integrity. Both the sections are cognizable and nonbailable - meaning the accused can be arrested without a warrant and can't be given bail by police as matter of right – it's the discretion of the court. # CITIZENSHIP NOT THE ONLY SCARE FOR PRETERM BABIES IN US

As President Trump's executive order on U.S. citizenship takes effect, preterm births among NRI expectant mothers are rising significantly.

ecent developments in U.S. immigration policy have led to significant concerns among expectant parents, particularly within the Indian community residing in the United States. On January 20, 2025, President Donald Trump issued an executive order aiming to end automatic citizenship for children born in the U.S. to non-permanent residents. This policy was set to take effect on February 20, 2025.

In response, there has been a notable increase in requests for preterm caesarean section (C-section) deliveries among Indian women in the U.S., especially in states like New Jersey. These expectant mothers are seeking to ensure their children are born before the policy's implementation date to secure U.S. citizenship for them.

However, medical professionals have expressed concerns about the health implications of elective preterm deliveries. Preterm births can pose significant health risks for newborns, including respiratory issues, developmental delays, and increased susceptibility to infections. Obstetricians are advising against scheduling early deliveries solely for the purpose of securing citizenship, emphasizing the importance of prioritizing the health and well-being of both mother and child.

It's important to note that on January 23, 2025, a federal judge in Seattle temporarily blocked President Trump's executive order, citing potential violations of the 14th



Amendment's citizenship clause. This ruling prevents the policy's enforcement for 14 days while further legal arguments are considered. The Justice Department has indicated plans to appeal the decision.

Given the evolving legal situation and the health risks associated with preterm deliveries, expectant parents are encouraged to consult with their healthcare providers and stay informed about the latest developments in immigration policy.

#### **WHAT IS A PRETERM BIRTH?**

About 1 out of every 10 births in the U.S. is premature. A baby born before 37 weeks of pregnancy is considered a premature or preterm baby. The earlier the birth, the greater the

possibility of serious health risks to the baby. These risks include breathing problems and trouble maintaining temperature. Preterm infants may need special care in a NICU.

A preterm baby may have underdeveloped organs like the brain, lungs, and liver. They may have trouble staying warm or feeding and may be at risk for developmental delays later in life.

As per the World Health Organization, prematurity is the leading cause of death in children under the age of 5 years around the world. In low-income settings, half of the babies born at or below 32 weeks (2 months early) die due to a lack of feasible, cost-effective care such as warmth, breastfeeding support, and basic care for infections and breathing difficulties.

Babies may be born preterm because of spontaneous preterm labor or because there is a medical indication to plan an induction of labor or caesarean birth early.

the health of the mother or baby. Preterm delivery can have significant short-term and long-term consequences for the baby," says Dr. Astha Dayal, Director - Obstetrics and Gynaecology, CK Birla Hospital, Gurugram.

In some cases, preterm delivery may be medically indicated, such as in preeclampsia or high blood pressure of the mother during pregnancy, placental abruption-a condition where the placenta separates from the uterus, depriving the baby of oxygen and nutrients. It can also happen in cases of fetal distress where the baby is not receiving enough oxygen and nutrients, requiring immediate delivery. Sometimes, in cases of twins or multiple pregnancies, the risk of preterm delivery may increase.

"For most other conditions, we try to prolong pregnancy at least up to 37 weeks," says Dr. Dayal.

"Preterm babies, born before 37 weeks of gestation, are at risk of various health challenges due to their underdeveloped organs and systems. The severity of these risks depends on how early the baby is born, with extremely preterm infants (born before 28 weeks) facing the highest risks," says Dr. Abhishek Chopra, Consultant Pediatrician and Neonatologist at Cloudnine Group of Hospitals, New Delhi Punjabi Bagh.

"Preterm and low birth weight babies are at a higher risk of SIDS, especially in the first year of life. Safe sleep practices, such as sleeping on their back and using a firm mattress, are crucial," adds Dr. Chopra. Preterm babies, born before

37 weeks of gestation, are at a higher risk for various health complications. These risks can be categorized into



## **SUPREME COURT: PLAINT WITH MULTIPLE RELIEFS CANNOT BE REJECTED JUST BECAUSE SOME RELIEFS** ARE BARRED UNDER ORDER VII RULE 11 OF CPC

he Supreme Court in the case Central Bank Of India And Anr. Versus Smt. Prabha Jain And Ors observed that when a Plaint includes multiple reliefs, it cannot be rejected solely because one of the reliefs is being barred by law, as long as the other reliefs remain valid.

The court stated that the plaint cannot be partially rejected under Order VII Rule 11 of Civil Procedure Code, CPC.

The court in the case observed that, 'If the civil court is of the view that one relief (say relief A) is not barred by law but is of the view that Relief B is barred by law, the civil court must not make any observations to the effect that relief B is barred by law and must leave that issue undecided in an Order VII, Rule 11 application. Therefore, this being because if the civil court cannot reject a plaint partially, then by the same logic, it ought not to make any adverse observations against relief B.'

The bench comprising of Justice JB Pardiwala and



Justice R Mahadevan was hearing the present matter.

The bench in the case was hearing a case under the SARFAESI Act in which the plaintiff sought three reliefs in a suit filed before the Civil Court. Thus, two of the reliefs, concerning ownership and title over the suit property used as collateral for a banksanctioned loan, were not barred by law, and the Civil Court had jurisdiction to decide on them therefore, the third relief, which pertained to the restoration of possession under Section 17 of the SARFAESI Act, was barred by law, as such an application must be filed before the Debt Recovery Tribunal, DRT, not the Civil Court.

The court in the case stated that while the Civil Court's jurisdiction could not be invoked to grant the third relief, the same would not prevent the Civil Court from addressing the first two reliefs. In other words, the plaint cannot be rejected under Order VII Rule 11(d) of the Civil Procedure Code, CPC merely because the third relief is

barred by law, as long as the other reliefs remain within the court's jurisdiction for adjudication.

The court while considering the facts and circumstances of the case observed that, 'Even if one relief survives, the plaint cannot be rejected under Order VII, Rule 11 of the Code of Civil Procedure, CPC. In the case on hand, the first and second reliefs as prayed for are clearly not barred by Section 34 of the SARFAESI ACT and are within the civil court's ju-

## Supreme Court reserves treasurer post for women in Bengaluru Advocates' Association; suggests 30% women reservation in General Council

The Supreme Court in the case Kavitha H.C. Versus The State Of Karnataka And Ors and connected cases observed and has directed that the post of Treasurer be exclusively earmarked for women candidates.

The court in the case stated that the High-Powered Committee and the Chief Returning Officer may consider desirability of reserving atleast 30% of other Governing Council posts for women lawyers, to ensure their adequate representa-

The bench comprising of Justice Surya Kant and Justice N Kotiswar Singh was hearing the present matter.

The bench in the case passed the order wherein the court noted that the concerned Regulations do not expressly bar reservation

of posts for women lawyers. The court invoked its powers under Article 142 of Constitution of India and has issued directions similar to those passed in the case of Delhi High Court and District Bar Associa-



The court in its order stated that:

'This court deem it appropriate to invoke our powers under Article 142 of Constitution of India and direct as follows -

1.The post of Treasurer shall be exclusively earmarked for women candidates.

2. For this purpose, the High Powered Committee and the Chief Returning Officer shall extend the date for inviting nominations and if so required, the date of election can also be deferred for a few days. However, such a decision shall be to the entire discretion of the HPC and the CRO.

3.The High-Powered Com-

mittee and the Chief Returning Officer may also consider desirability of ensuring adequate representation to the women advocates in the Governing Council of Advocates' Association Beng-

The counsel, Senior Advocate Lakshmy Iyengar, appearing for the petitioner beseeched the Court to issue a clarification, as in the case of Delhi Bar Associations, that the age criteria (which requires10 yrs or more experience) would not be considered. Pursuant to this, thus, the bench said that the directions passed in Delhi Bar Associations' case shall apply mutatis mutandis to the case of Advocates' Association Bengaluru, AAB.

The instant petitions were filed after the Karnataka High Court, though supportive of reservation for women lawyers in the AAB, took a view that only the Supreme Court could pass the relevant order. Thus, the term Advocates' Association Bengaluru, AAB's Governing Council came to an end on December 19, 2024 and it remained unrepresented during today's proceedings.

Last Year, the court in the case directed for the reservation of 3 posts for women lawyers in the (then upcoming) Delhi High Court Bar Association elections.

The court also directed that in District Bar Associations, the post of Treasurer plus 30% of other Executive Committee posts shall stand reserved for women lawyers (which includes those already reserved for women). Recently, the application of this order was extended to Delhi's NGT Bar Association, Tax Bar Association and Sales Tax

## SUPREME COURT ASKS SIT TO PROBE: DID NOIDA AUTHORITIES PAY EXCESS COMPENSATION TO LANDOWNERS? WHETHER NOIDA LACKS TRANSPARENCY?


The Supreme Court in the case Virendra Singh Nagar v. State of Uttar Pradesh and another constituted a Special Investigation Team, SIT to investigate whether the officers of the New Okhla Industrial Development Authority. NOIDA paid excess land acquisition compensation to certain land owners.

The court in the case asked the SIT to examine 'whether the overall functioning of NOIDA lacks transparency, fairness and commitment to the cause of public interest."

The bench comprising of Justice Surya Kant and Justice NK Singh was hearing the present matter.

The bench in the case passed the order wherein the court was hearing the petition filed by a Law Adviser and Legal Officer of New Okhla Industrial Development Authority, NOIDA seeking anticipatory bail in a corruption case which was registered over the allegation that huge amount of compensation was released in favour of some land owners over and above their legal entitlement.

In September 2023, the court noticed that it was not a solitary instance as there were several other cases where the compensation released, prima facie, appeared to be exorbitant, for extraneous considerations and on quid pro quo basis. Thus, a Fact

Mandate of the SIT The court directed that the Special Investigation Team shall, inter alia, look into the issues:

1.Whether the quantum of compensation paid to the land owners was higher than they are entitled to in terms of the judgments passed by the courts from time to time;

2.If so, who were the officers or officials responsible for such exorbitant payment;

collusion or connivance between the beneficiaries and officers or officials of New Okhla Industrial Development Authority, NOIDA; and

4.whether the overall functioning of New Okhla **Industrial Development** Authority, NOIDA lacks transparency, fairness and commitment to the cause of public interest. The SIT will be free to

look into any other allied issue that may arise for its consideration during the course of investigation.

The Court ordered that the SIT should submit a report to the Court within two months.

## Residents leave homes in Jenin as Israeli West Bank raid continues

"There are dozens of camp residents who have begun to leave," Jenin resident Salim Saadi told AFP. "The army is in front of my house. They could enter at any moment."

# JUDGE BLOCKS TRUMP'S EXECUTIVE ORDER STOPPING BIRTHRIGHT CITIZENSHIP

The Judge granted an emergency request to halt the executive order for next 14 days while the legal challenge continues.

federal judge ruled Thursday that President Donald Trump's executive order to end birthright citizenship is "blatantly unconstitutional" and issued a temporary restraining order to block the policy from taking effect, CNN reported. Judge John Coughenour, a Ronald Reagan appointee based in Seattle, granted an emergency request from Washington State Attorney General Nick Brown and three other Democratic-led states to halt the executive order for the next 14 days while the legal challenge continues. "I have been on the bench for over four decades. I can't remember another case whether the question presented was as clear," Coughenour said. "Where were the lawyers" when the decision to sign the executive order was made, the judge asked. He said that it "boggled" his mind that a member of the bar would claim the order was constitutional. Notably, the Democratic-led states are seeking a temporary restraining order, as they argue that Trump's executive order is a blatant violation of the Constitution's 14th Amendment, which guarantees citizenship to all children born on US soil and subject to the jurisdiction thereof, as reported by CNN. ## 'Canada is not for sale'

experiencing here," said Mooney, co-founder of business consultancy Jackpine Dynamic Branding.

Over the last few weeks, the duo approached several players in the apparel sector to help them and mostly heard the same refrain: they don't manufacture hats fully in Canada because the cost is so high and the demand isn't there.

Mooney and Cochrane have since found some hats completely made in the country but haven't settled on a long-term solution, so they are mostly relying on ball caps imported from Vietnam, Bangladesh and China and toques from the U.S., which then get embroidered in Canada.

The difficulty in making apparel or accessories completely in Canada stems from years of blows to the country's textile industry, which lost much of the clothing manufacturing capacity it developed in the 19th century as industrialists migrated to Canada and took advantage of the introduction of the sewing machine.

"They started the apparel industry in Canada in large cities, so Toronto, Montreal, Winnipeg ... but what happened by the 1980s was these industries started to go overseas," said Henry Navarro Delgado, an associate professor of fashion at Toronto Metropolitan Uni-

## TRUMP 2.0 BEGINS; A WAVE OF HIS EXECUTIVE ORDERS LEAVES THE WORLD IN WONDER

This week, Donald Trump was inaugurated for a second term as President of the US. The ceremony saw the attendance of numerous international leaders, technology executives, and celebrities, including India>s external affairs minister. Due to adverse weather conditions, the event was held indoors at the US Capitol, marking the first indoor inauguration since Ronald Reagan's in 1985. Following the ceremony, Trump delivered an extensive and unconventional speech that emphasized his domestic priorities and related foreign policy. He announced a significant decision to secure the Southern borders to address illegal immigration from Mexico and also stated that the US had entrusted the management of the Panama Canal to Panama, not to China, which provoked strong re-

actions from Panama and other countries. Trump also took the opportunity to criticize the previous administration, proclaiming that a «golden era» for the US began with his inauguration. His demeanour and remarks indicated a readiness to swiftly implement critical decisions, which he did the very next day. Contrary to expectations for a more measured approach, Trump reignited debates with announcements such as the withdrawal of the US from the Paris Agreement and the World Health Organization.

As expected though, he has enacted a series of executive orders aimed at overturning the policies established by the Biden administration while advancing his own agenda. In his address itself, he proclaimed a National



concerning the Southern Border. This declaration was made to tackle what he characterizes as a crisis at the US-Mexico border, which facilitates military deployment and emphasizes the enforcement of immigration laws. He has also directed that Drug Cartels be classified as Terrorist Organizations, a measure that aims to bolster law enforcement's capacity to tackle drug trafficking. This was a commitment he made during his electoral campaign, so the decision did not come as a surprise to anyone. Nevertheless, his other orders have caused considerable concern Emergency Declaration among many nations as

well as organisations.

Trump declared the US' exit from WHO, expressing dissatisfaction with its management of international health emergencies and perceived partiality towards the US. This decision has sparked concerns regarding the potential impact on global health collaboration and the ability to effectively address future pandemics. Trump has also enacted an executive order that formally commenced the US withdrawal from Paris agreement. He condemned the accord for placing disproportionate economic strains on the US and sought to reduce financial commitments to

overseas climate projects. However, this decision will undoubtedly influence global cooperation and collaboration aimed at achieving the prioritized goal of mitigating climate change. As indicated by Rubio

last week, Trump has also declared a cessation of foreign aid, implementing a 90-day pause on US foreign aid programs for evaluation, which has raised concerns among international partners and humanitarian organisations that depend on American support. Additionally, he has issued a significant order that reverses many policies concerning immigration, climate change, and racial equity that were put in place by the previous administration. He has also proposed the termination of Birthright Citizenship, aiming to remove the automatic citizenship granted

US to undocumented immigrants, a move likely to encounter legal challenges due to its potential violation of the 14th Amendment. Furthermore, he has reinstated capital punishment at the federal level, instructing the Attorney General to seek death penalties for serious offenses. The suspension of refugee admissions has also been announced, temporarily blocking the entry of refugees into the US.

The enforcement of the TikTok ban has also been postponed by Trump, who signed an order granting a 75-day grace period for the app>s parent company to pursue divestiture, thereby temporarily suspending the federal prohibition on the application. Additionally, Trump granted pardons to around 1,500 individuals connected to the Janu-

to children born in the ary 6 Capitol riots, leaving many in shock. Furthermore, Trump has enacted an executive order that officially recognizes only male and female genders within federal policies and programs, reversing earlier policies that acknowledged a broader range of gender identities.

Easingthe concerns regarding his critical stance on the H-1B visa program, Trump conveyed his endorsement of the program during a news conference at the White House this week. He underscored the significance of attracting talented individuals to the US, pointing out the high demand for skilled professionals across multiple industries, particularly in technology.

Trump also made remarks concerning the neutrality of the South China Sea and the resolution of the Russia-Ukraine conflict. He has cautioned Putin to either bring the war to a close or face potential sanctions from the US. It will be intriguing to observe Putin's reaction, especially since he previously congratulated Trump on his electoral victory. I hope Trump remains

committed to his promises of fostering global peace and stability and helping in putting an end to conflicts, as he pledged during his campaign. My perspective on him is nuanced rather than binary; I view him through a grey lens. It is important to remember that at his core, he is a businessman. Therefore, despite some concerning decisions, I maintain a sense of optimism that the US will strive towards the Indian principle of 'Sarve Bhavantu Sukhinah'during Trump's administration.



We should choose only one or two, or maybe three, virtues and qualities, otherwise there will be too much going on and we will

**Vision:** Then we can jump forward in our mind's eye to 31 December 2025 and visualise ourselves in the stage of having

achieved great success in our development, grown to become the embodiment of a virtue we set out to imbibe. The important thing is to have focus, intention,

tual goals. There are a couple of tools to help us navigate the way forward, gracefully.

The Stoics were a group of Greek philosophers who believed that being virtuous was the key to a welllived life. One of the tools they used was 'negative

visualisation'. Although the term is 'negative', it is in fact an extremely positive exercise, especially in two ways: i) It requires us to visualise our coming task, any task or project, and imagine what might be the challenges that could appear. Then we can discern what we need to develop to face those challenges; ii) We immediately begin to appreciate and have gratitude for the present time, because those challenges do not need to be faced right now. So, gratitude is increased, detachment is developed, and while still having determination to achieve the goals, we remain aware that things may not work out exactly as we imagine.

The second tool to help us navigate is simplification. We all need energy. The more we have, the better our mind and brain work. the more energetic and resourceful we become. To save energy it is better to look at possible areas of wastage; time spent on devices, wasteful conversations, most importantly. wasteful thinking and wasteful inner dialogues. We need to make sure that we are more present and connected to our stated intentions, values, and vision. We need to make sure we do not spend time deviating from the goal we set for ourselves.

Finally, and very importantly, harmonious relationships are vital to graceful navigation. The art of interacting with others with more wisdom, more understanding, and more harmony requires many virtues and qualities that we need to develop. The need to be more flexible, for example, and have more humility; letting go of stubbornness, stopping holding on to my opinions and the ideas I have of how things should be done. # **DJOKOVIC QUITS MID-MATCH; ZVEREV** REACHES AUSTRALIAN OPEN FINAL

pectators booed an injured Novak Djokovic as he left the court in Rod Laver Arena after quitting one set into his Australian Open semifinal against Alexander Zverev on Friday.

Dealing with what he said was a torn muscle, Djokovic lost the opening set 7-6 (5) when he put a forehand volley into the net, then began shaking his head and immediately walked over to tell Zverev the match was over. The 37-yearold Djokovic packed up his equipment and walked off toward the locker room, pausing to respond to the jeers by giving two thumbs-up.

At his news conference, Djokovic said the pain in his taped left leg was "getting worse and worse." He hurt it during his quarterfinal victory over Carlos Alcaraz on Tues-

"I knew," Djokovic said, "even if I won the first set, it was going to be a huge uphill battle for me.

He was bidding for an 11th championship at the Australian Open and record 25th Grand Slam title overall. Instead, it will be No. 1 seed and defending champion Jannik Sinner facing No. 2 Alexander Zverev in Sunday's final.

Zverev is 0-2 in major finals; this will be his first at Mel-

"Everything can happen," said Sinner, who is on a 20-match unbeaten run. "He's

an incredible player." For Djokovic, this is the

The first four games alone lasted 31 minutes, slowed both by the lengthy baseline exchanges and Djokovic's deliberate pacing between points, taking the 25-second serve clock down to — and occasionally slightly beyond — the full allotment.The match was grueling — and would have been even without dealing with a leg problem that initially became an issue late in the first

"I didn't hit the ball (from

after the) Alcaraz match until like an hour before today's match," Djokovic said.

"I did everything I possibly can to basically manage the muscle tear that I had. Medications and, I guess, the (tape) and the physio work helped to some extent today," he added. "But towards the end of that first set, I just started feeling more and more pain and it was too much for me to handle. Unfortunate ending, but I tried."Zverev said he could sense "some dents" on the other side of the net in the tiebreaker and noticed that Djokovic was struggling "maybe a bit more."Two years ago at Melbourne Park, Djokovic hurt his left hamstring but still managed to depart with the trophy. Against Alcaraz, he was down a set against someone who is 16 years his junior but won.

This time, Djokovic could not pull off a similar escape.

And afterward, there was a lot Djokovic was unsure about.

Might this have been his last appearance at Melbourne

"There is a chance. Who knows?" Djokovic replied. "I'll just have to see how the season goes. I want to keep going."He said it's too soon to know how long he might be sidelined. He said he isn't sure yet what will happen to his coaching arrangement with former oncourt rival Andy Murray.What Djokovic did make clear: His focus and goals will not waver.

## Jannik Sinner tops Ben Shelton to return to Australian Open final

Defending champion Jannik Sinner continued his sizzling Australian Open run with a 7-6(2) 6-2 6-2 victory over American 21st seed Ben Shelton on Friday to reach a second straight final at Melbourne Park and book a meeting with Alexander Zverev.

Sinner's victory made the 23-year-old the youngest man to make multiple finals at the Australian Open since Jim Courier in 1992-93 and kept alive his dream of becoming the first Italian to lift three Grand Slam singles trophies.

"I'm happy to be back in the final again," said Sinner, who had to overcome cramp in the third set.

"Sundays are special days in tournaments and I'm hoping I can enjoy it."

Sinner entered the match on Rod Laver Arena having won four of his five meetings with left-hander Shelton but found himself in trouble early on as a thunderous forehand winner handed the American a break, which he followed

up with a tight hold. The top seed shrugged off a tentative start to draw level at 2-2 and attacked Shelton's powerful serve at every opportunity, but a lapse on his own delivery in the 11th game left him in a spot of bother again before he saved two set points.

Shelton bounced his racket off the court after going behind 4-0 in the ensuing tiebreak as his accuracy



cruelly deserted him and Sinner gleefully accepted the first set when his frustrated opponent sent a forehand wide.

"It was a very tough first set but crucial," said Sinner.

"He wasn't serving at his best, not where he wanted to. We both returned better than we served. First sets can often give you confidence and it was tense. I'm happy how I handled it.

"I'm happy to be back in the final here."

After a breathless start to the second set, Sinner released the handbrake to win the opening four games without response and soon left a dejected Shelton in the rear view mirror to double his advantage in the match.

Sinner felt a problem in his left leg during a tense third set and had it worked on by the trainer after breaking to go 3-2 up, betook him to the finish line and back-to-back major finals after his triumphant U.S. Open run.

"There was a lot of tension today, I was slightly cramping. He was suffering on his legs too so I tried to move him around," added Sinner.

"These matches can go long. Playing three sets for 2-1/2 hours is a long time, so I'm happy to finish it in three, I'm happy to be back in the final again."

Second seed Zverev reached his first Australian Open final and third at the majors after 24-times Grand Slam champion Novak Djokovic retired due to a left thigh injury after losing the opening set 7-6(5).

"We've had some tough matches in the past," Sinner said of Zverev, who leads their head-to-head

Mumbai had squandered an ideal start after Rohit Sharma (28) and Yashasvi Jaiswal (26) put on 54 for the opening wicket at a brisk rate.

The Indian Test openers, pairing up for the first time in Ranji Trophy, looked to take on the Jammu and Kashmir bowlers and got some success too.

While Rohit hit a trademark six over deep square leg and lofted two more deliveries for a similar result, Jaiswal, who looked to come down the wicket, also played positively during his



brief stay.
