Punjab and Haryana High Court's visa fraud orders gain relevance amid US deportations

A series of judicial orders issued by the Punjab and Haryana High Court since April 2003-aimed at curbing visa fraud and regulating overseas recruitment-has gained renewed significance in light of the ongoing deportation of illegal immigrants from the United States to India.

On February 5, a US mili-

tary aircraft carrying 104 Justice Dutt had instructed the chief secretaries of Punjab and Haryana to act proactively to prevent a recurrence of tragedies like the Malta boat disaster, where 283 young Indians lost their lives while attempting to migrate. The court stressed that government intervention should prioritize safeguarding aspiring migrants from exploitation rather than fo-

cusing solely on well-settled NRIs.

The directives urged authorities to collaborate with the Ministry of External Affairs and the Ministry of Labour to educate the public about safe migration pathways and curb unscrupulous middlemen's influence. Measures were also suggested to regulate recruitment practices and ensure transparency regarding foreign labour demands.

In December 2024, Justice Chitkara reiterated the need to protect India's global reputation by sensitizing the system to visa fraud risks. The **Directors-General of Police** in Punjab, Haryana, and Chandigarh were instructed to issue guidelines to shield victims of fraudulent visa schemes. Citing an "alarming escalation" of such cases,

Justice Chitkara warned that unchecked fraud could revive organized crime networks



Previous court rulings also underscored the urgency of tackling visa fraud. In November 2022, Justice Ashok Kumar Verma highlighted rampant cheating by fraudulent agents, while in 2011 and 2009, the court demanded stricter oversight of travel agencies. Justices Rajan Gupta and Lalit Batra had also repeatedly called for stronger regulatory mechanisms to protect innocent citizens.

As deportations continue under the stringent US immigration policies, these long-standing High Court directives underscore the critical need for a well-regulated migration system to prevent further exploitation of aspiring overseas workers.

very healthy this year, and we expect yields to be around 22 to 24 quintals per acre. This could help farmers earn an additional Rs 5,000 to Rs 8,000 per acre," said Raghubir Singh, a wheat farmer from Karnal.

In the first week of February farmers in Punjab and Haryana were concerned about warm temperatures, fearing that early ripening could reduce yields. However, timely rainfall has brought a relief as the showers have not only lowered temperatures but also protected crops from pests and diseases like aphids and yellow rust.

The development has come as major relief for the government as the bumper produce may help to ease soaring wheat prices. Despite last year's record wheat harvest of 113.29 million tonnes, wheat and flour prices remained high in the open market. According to the Department of Food and Consumer Affairs, India had ample wheat stocks during Rabi 2024, yet prices soared above Rs 3,000 per quintal. This forced the central government to revise stock limits on wheat to stabilize the market. Dr. Virender Lather, Former Principal Scientist at ICAR-IARI New Delhi, said, "As of now, the wheat crop is in good health, and the weather remains favorable. However, the

final yield will largely depend on climatic conditions over the next three weeks. If the current weather pattern continues, the average wheat yield in Haryana is expected to be around 26 quintals per acre, or over 6 tonnes per hectare."

Scientists at the Indian Institute of Wheat and Barley Research in Karnal highlight that over 60% of the wheat acreage is now covered with high-yielding and climateresilient varieties such as DBW 296, DBW 327, DBW 332, DBW 303, DBW 187, DBW 222, WH1270, and PBW 771. These varieties have not only boosted production but also helped reduce input costs by resisting diseases like vellow rust. With favorable conditions and better seed varieties, farmers remain hopeful for a strong harvest, which could ease supply concerns and bring some relief to consumers in the coming months.

The Prime Minister identified textiles, tourism, and technology as three highpotential sectors poised to generate significant employment and economic growth. He praised MP's strong position in organic cotton production, which accounts for 25 percent of India's supply, and its leadership in silk production. 

GRAP 2 curbs revoked amid

The Centre's panel on Delhi-NCR's air quality on Monday revoked the Stage 2 curbs under the Graded Response Action Plan (GRAP) following a dip in pollution levels due to favourable meteorological conditions. Delhi's 24-hour average air quality index stood at 186 at 4 pm, significantly below the 300-mark that triggers Stage 2 restrictions.

The India Meteorological Department and Indian Institute of Tropical Meteorology predict that the AQI will likely remain in the moderate to poor category.

The Commission for Air Quality Management in NCR and adjoining areas attributes the improved air quality to better mixing height, ventilation coefficient, and "much favourable conditions for dispersion of pollutants".

With the revocation of Stage 2 curbs, inter-state buses from NCR states are now permitted to enter Delhi.

During winters, the Delhi-NCR region enforces restrictions under GRAP, which categorizes air quality into four stages Stage I (Poor, AQI 201-300), Stage II (Very Poor, AQI 301-

400), Stage III (Severe, AQI 401-450), and Stage IV (Severe Plus, AQI above 450). Unfavourable meteorological conditions, combined with vehicle emissions, paddy-straw burning, firecrackers, and other local pollution sources, lead to hazardous air quality levels in Delhi-NCR during winters.



NHAI to monetise 24 road assets

State-owned National Highways Authority of India (NHAI) on Monday said it has identified a tentative list of 24 road assets which will be monetised in 2025-26.

The total length of the roads assets to be monetised





in the next financial year is 1,472 km with cumulative annual revenue from these assets pegged at Rs 1,863 crore in 2023-24.

"All stakeholders may give their feedbacks on these assets and or may suggest additional assets, for revising the list to make it more inclusive.

"These assets are preferably to be monetised through TOT mode unless not revised at later stage for any other mode of monetization," NHAI said in an office order dated February 24.2025

According to the order, out of the 24 projects, five road projects are in Maharashtra, four in Jharkhand, three in Uttar Pradesh, two each in West Bengal, Bihar and Telangana and one each in

#METOOMARITALRAPE: THE MOVEMENT INDIA DESPERATELY NEEDS

🔪 ometimes, I am surprised by our position **D**as women in society. Is it necessary to always have a man in our lives to protect us? And even if we do, is there any guarantee that he-whether a father, brother, friend, or husband—will always safeguard us with the utmost care? What if the protector turns into a monster? In such cases, should society remain silent, or should we hold the perpetrator accountable? No one has the right to harm or kill a woman-whether she is a daughter, sister, or wife.

A recent judgment by the Chhattisgarh High Court has reignited a critical debate: Does marriage grant a man the license to rape? However, this question has now evolved. The more pressing issue is-does marriage give a husband the right to engage in unnatural sex, even if it results in his wife's death?

In recent years, crimes against women have es-

This raises a serious concern: Even when a 30-yearold woman loses her life due to forced unnatural sex, does the law still fail to recognize her suffering? Does our judiciary and legislature truly value women's lives? This judgment is deeply distressing for every woman. It is truly shameful to witness a man who caused his wife's death in the pursuit of his unnatural desires now walking free.

How many more cases do we need before we acknowledge the gravity of this issue? How many women must lose their lives due to such heinous acts? Today, I am not writing this article as a lawyer or an academician-I am writing as a woman first. Before my roles in family and society, I am a woman. Our devotion to goddesses becomes meaningless when we are tortured by those meant to protect us. Marital rape has long

been a contentious issue in India. Several petitions are still pending before the Supreme Court, seeking its criminalization. While marriage is considered a sacred institution, and sex is an integral part of it, it should be based on mutual comfort and respect. It should not be an act where one partner enjoys while the other suffers mentally and physically. Every sexual act between a husband and wife should be founded on mutual understanding-only then can a marriage truly succeed.

Spousal sexual violence within marriage causes the same trauma as other forms of rape. In a landmark judgment, the Supreme Court of India, in Independent Thought v. Union of India, amended Section 375 of the IPC to align with the Constitution and child protection laws. The new interpretation states: "Sexual intercourse or sexual acts by a man with his wife, if she is not below eighteen years of age, is not rape." However, despite this change, the Central Government informed the Supreme Court that it does not recognize marital rape as an offense. Despite years of advocacy,

our government has failed to provide legal protection against marital rape. It has failed to acknowledge the trauma and pain suffered by married women. Numerous national and international studies highlight the severe impact of marital rape, with some victims requiring medical intervention. The recent Chhattisgarh case is just one of many examples.

How many more women must endure violence behind closed doors? How many must sacrifice their lives to satisfy their husbands? In many Indian families, newlywed brides are still taught by their inlaws or elder sisters that they must "surrender" to their husbands-physically and emotionally-because it is their duty. Many women, even if they dislike it or feel pain, continue to endure it due to societal and familial pressure. Shockingly, the law interprets this forced submission as consent.

However, consent and free consent are not the same, and it is time our lawmakers understood this distinction. What they consider "consent" may not be *free* consent.

Isn't it high time we initiate another movement one beyond #MeToo? This time, it should be *#MeTooMaritalRape.* As a signatory to the Con-

vention on the Elimination of All Forms of Discrimination Against Women (CEDAW), India has failed its married women by refusing to recognize marital rape as a crime. We strongly urge the Indian government to implement CEDAW in its true spirit. One of the key reasons for its ineffective implementation is that CEDAW, as a soft law, is not legally enforceable in India. The rising cases of violence against women highlight the urgent need for its robust enforcement. To address this, a new Optional Protocol to CEDAW is essential-one that would serve as a binding treaty.

The new Optional Protocol to CEDAW will reinforce state accountability in preventing and responding to all forms of violence against women and girls. It will compel states to strengthen their protection and prevention measures, ensuring greater safety for women and girls. Additionally, it will support states in achieving Sustainable **Development Goal (SDG)** No. 5 on gender equality by working towards the complete elimination of violence against women and girls.

I believe this case from Chhattisgarh, India will spark a sense of sisterhood among women and ignite a feminist movement in India-one that brings about meaningful change, ensuring that no woman loses her life to such brutality again.

WHEN THE MINDSET **BECOMES A PROBLEM**

As if the tales of bestiality by the Hamas terrorists on 7 October 2023-when they attacked and killed over 1,200 Israelis and other nationalities in the most horrific manner and took 251 people hostage-were not enough, another chapter in this blood curdling horror story unfolded last week when news broke about how two toddlers, one a five-year-old and another two years old, were murdered in captivity. Ariel and Kfir Bibas were kidnapped with their mother Shiri by the Mujahideen Brigades, a Palestinian terror group, which was one of the several groups that joined hands with Hamas to carry out the atrocities of 7 October 2023. As their remains were returned to Israel by the Hamas, the two children were found to have been strangled bare-handed to death and disfigured to show that they had been killed in an Israeli strike. What was thought to be the body of their mother, turned out to be that of a woman from Gaza, which the Hamas, in an act of incalculable cruelty, had passed off as Shiri. It was only two days later that Hamas released Shiri's body. The Hamas also made a huge show of returning the bodies, parading them around and turning it into a celebration, with Gazans, young and old revelling in the inhumanity on display. Even otherwise, Hamas has been parading around the hostages before releasing them, forcing them to wave and smile at the Gazans. As shock and horror rippled through Israel, and much of the civilised world, Prime Minister Benjamin Netanyahu stated that Israel had decided "to delay the release of terrorists that was planned for yesterday (Saturday) until the release of the next hostages is ensured, without the humiliating ceremonies." Around 600 terrorists were scheduled to be released on Saturday, but now it is indefinitely postponed. According to the Israelis, over 60 more hostages, including five Americans, are yet to be released, but it's not known how many of them are still alive.



Amid this, Netanyahu has started intensifying operations inside the West Bank, with three refugee camps emptied of around 40,000 people. Israeli troops are expected to stay there for at least a vear. These camps are a hotbed of terrorist activity. In the meanwhile, three parked buses were blown up by Palestinian terrorists, with explosives found in two more. While mass casualties were avoided, Israel is being reminded once again that the terrorist threat remains and has not been eradicated with the crippling of Hamas. While the missiles and rockets from Gaza may have stopped, the Hamas and other similar groups have resorted to carrying out terror attacks targeting civilians, which too cause huge damage and mental trauma. The biggest problem here is the radicalisation of a whole population—the Palestinians in this case. They have been completely radicalised and see Hamas as their sole representative. As a result of which, it increasingly appears that inhumanity comes naturally to them as they indulge in a peculiar dance of death where the line between civilised behaviour and savagery gets blurred. This is trademark Hamas. This is also what 7 October 2023 saw—the wilful and gleeful participation of Palestinian civilians in Hamas' terror attack. While supporters of the Palestinian cause are saying that the murder of the two Israeli children has to be seen in the context of the thousands of Palestinian children killed in Israel's attack on Gaza, the fact is there is no moral equivalence. While the death of children is always unacceptable and tragic, in this case, the Palestinian terror groups have inflicted unimaginable, and deliberate horror on Israeli children-from roasting them in ovens to killing them with bare hands, as they did in the case of Ariel and Kfir. In contrast, the Palestinian children are the unintended victims of an unnecessary war thrust on them by their own people. This is the fundamental difference between the two situations. Hence, while the death of the Palestinian children should be mourned, but not to condemn, or to try and normalise what the Palestinians have done to Israeli children, and to Israelis, young and old, shows a complete lack of moral compass. Sadly, a large section of the Palestinian population is guilty of this, as well as many of their co-religionists and people who believe in the so-called Palestinian cause. It is simply not right to try and consign the suffering of the Jewish people as a footnote of history-what happened on 7 October was too painful for them and will reverberate through generations. To dismiss what was inflicted on them as a justified response to the suffering of the Palestinians, or to indulge in whataboutery amounts to a lack of humanity. It is this mindset that needs to change, as else, sooner or later Palestinians will lose the sympathy of a large part of the world. JOYEETA BASU



Bimal da died relatively voung at the age of 57 of cancer leaving behind a body of work which has immortalized him - Parinita, Do Bigha Zameen, Biraj -Bahu, Sujata, Parakh, Madhumati, Devdas, Bandani are his renowned works in Hindi . His greatness could be ascertained from the fact that these films were both, commercially and critically successful and received many Filmfare and National awards.

However; the subject of the article is 'Faith' Bimal da had in 'Poorna Kumbh' Mela rituals . This is revealed in a Book Chapter titled 'Bimal da' written by Gulzar who was his assistant at that time . This is part of the book by name -'The Man who spoke in pictures- Bimal Roy', edited by his daughter Rinki Roy Bhattacharya.

Here Gulzar narrates his days spent with Bimal da when he was working on a film script titled , 'Amrita Kumbha', with the background of the 'Kumbha Mela' at Prayagraj. In 1954 during Kumbha Mela at Prayag there occurred a stampede and thousands of people died . Inadequate administrative arrangements and crowd control were causes reported. The

the 'Kumbh Mela' of 1954. Bimal da had read the book when it was serialised in Anand Bazaar Patrika and

was very enthusiastic about it. The book was his prized possession, kept by his bedside. It was heavily marked with pencil in between the printed lines and on the margins. Numerous small paper notes were inserted and pinned in it . It had become bulky and seemed as if there was another book in the belly of the original. Bimal da had a clear vision of the screenplay and he had mastered the sequence and characterization. It is be-

lieved that if one takes bath at the confluence of Ganga . Iamuna and Saraswati at Sangam in Prayagraj on the auspicious 'Jog Snan' (derived from 'Yog') day during 'Poorna Kumbh' when the early golden sunrays are touching the water you are cured of all sins and diseases and live for one hundred years . Gulzar had asked Bimal da if he believed in it and Bimal da replied that it was a matter of faith and written in 'Shastras'.

The 'Shahi Snan' of Kumbha is called 'Jog Snan' by Bengali devotees. The ninth day of 'Poorna Kumbha' brought out in the book by the writer was being followed in the film making by Bimal da. Traditionally and in practice the auspicious days of 'Poorna Kumbha' are -Makar Sankranti, Mauni Amavasya, Bas-

'Poorna Kumbh' to be cured of his disease! As the people were rushing out of the train at Allahabad he gets crushed in the stampede and dies. Bimal da would repeatedly point out that the writer has killed him too early and insisted that it should die later in the film. Gulzar argued that the writer perhaps has shown his death in the beginning so as to indicate of the tragedy (stampede in Mela) in the end and to create a balance of the narrative, but Bimal da was adamant.

Once he was detected with cancer, which was not disclosed to him, he was confined to his home but his commitment and perseverance for this film never waned . He was to go with his team and take shots of the Annual Magh Mela in Prayagraj but since he fell ill he directed Gulzar and his team to take the shots and gave them detailed instructions . The main shooting was to take place during the 'Poorna Kumbh' in December 1965.

Gulzar did visit 'Magh Mela' in Allahabad and took some shots , but his mind was occupied by the illness of his master. The team also knew that the film was unlikely be completed. The following conversation between Gulzar and Kamal da (Cameraman,) brings out the reason behind Bimal Roy's obsession with the film :

"One evening after returning from shooting, Kamalda asked 'Why is Bimal da making this film

'I had asked him once ,' I answered.

'What did he say?'

'I told him of a feeling that I am the writer who had gone in search of amrit which makes man live for a hundred years . Surrounded by the cigarette smoke he had coughed. His face had turned red and after he recovered his breath , he added, 'I too have been searching for that amrit'.

'Confused, I had asked. 'Do you really wish to live for a hundred years ?' 'Hmm.

'That day, the topic ended at that point. On another occasion, 'he said, ' A hundred vears do not literally mean that many years. It means that a man attains immortality through this amrit.'

'What amrit is that?' 'Bimal da had stared far into space for a long time."

it was being pushed forward by slow degrees. One day Bimal da said happily -" I have finally discovered the right place for that scene. On the day of the Jog Snan, at the crack of dawn as the first ray of sun falls on water ..' he coughed excitedly . His whole body racked by the cough, but he continued, 'that is when the death occurs. This first death would balance the stampede in the climax. Balram would die on the day of the Jog Snan."

As the fatal day neared all his family members and colleagues would expect the tragic hour to arrive. However when Gulzar would meet him he would talk of the film . As it was December 1965 and the 'Poorna Kumbh' had commenced he told Gulzar that they would shoot after the culmination. Seeing the fast deteriorating condition of Bimal da Gulzar stopped visiting him as he could not see his suffering.

Finally the tragic day arrived and Gulzar states: " I got the news in the morning and it was as if the sword of Domacles hanging over my head had been removed. The moment I recovered my breath , tears poured out of my eyes. It was 8 January 1966, the day of the Jog Snan"

As the 'Maha Kumbh' of 2025 culminates in Sangam at Prayagraj , Bimal da would be smiling watching the proceedings from above; having attained immortality!



AgustaWestland chopper case. The ED sought to begin the trial against individuals who received summons and participated in the investigation separately from those who have not been served summons or have evaded investigation. Special Judge Sanjeev Aggarwal noted that separating the trials would be in the interest of justice and ensure a fair and speedy trial, as per Article 21 of the Constitution of India. Consequently, files

of the accused persons who have yet to be served will be separated from those who have already been served or are currently facing inquiry before the court.

The case, investigated under the Prevention of Money Laundering Act, involves a total of 60 accused, 21 of whom have neither joined the investigation nor been served summons by the ED to date. The court observed that the first prosecution complaint was filed on November 24, 2014, while the latest, dated November 21, 2024, represents the 12th supplementary prosecution complaint, highlighting a decade-long gap.

Judge Aggarwal expressed concern over the significant time lapse and the uncertainty about when the trial will commence, which prejudices the rights of other accused persons awaiting a speedy inquiry/trial, a fundamental right under Article 21 of the Constitution.

SUPREME COURT SETS ASIDE HIGH COURT ORDER **CANCELLING BAIL: COURTS SHOULD NOT LIGHTLY INTERFERE WITH PERSONAL LIBERTY**

he Supreme Court in the case Kailash Kumar And State Of Himachal Pradesh And Anr observed and has set aside the ruling cancelling bail of an accused under an attempt to murder charge.

The court in the case observed that an individual's liberty is a precious right under the Constitution, and courts should be cautious before interfering with it. The court stated that since

there being no evidence showing that the accused's conduct after bail warranted deprivation of his liberty, thus, the High Court had no valid reason to cancel the bail.

The bench comprising of Justice Dipankar Datta and Iustice Manmohan was hearing the present matter.

The bench in the case observed that, 'Suffice to observe, liberty of an individual being a precious right under the Constitution of India, thus, the Courts ought to be wary that such liberty is not lightly interfered. This court is satisfied that there being no valid reason for the High Court to

cancel the bail without there being any material to show, even prima facie, that conduct of the appellant post grant of bail has been such that he should be deprived of his liberty. There are also no allegations of influence being exerted or threat extended to the witnesses or of tampering the evidence. Material to demonstrate that dilatory tactics have been adopted to procrastinate the trial is also conspicuous by its absence.

In the present matter, the appellant-accused was charged under section 307, the attempt to murder under the Indian Penal Code,

IPC and since the trial was ongoing and out of 43 witnesses, 17 witnesses had been examined by the prosecution and the appellant was in jail for two years, he applied for bail. The same was granted; however, in appeal, the High Court cancelled the bail.

Aggrieved with the same, the appellant approached the Apex Court.

The court referred to the case of Ajwar v. Waseem and Anr., wherein the court had discussed certain factors to consider, while cancelling the bail. This included misusing liberty, influencing the witnesses, tampering with evidence, resorting to delaying tactics or if the order granting bail is perverse or illegal. The court also noted that the High Court did not consider any of these factors. The court stated that what the High Court did was to embark upon conducting sort of a mini-trial at the stage of considering whether the bail should be cancelled or not. As per the High Court, presence of the appellant and the co-accused at the scene of occurrence and causing of injury to the complainant-PW1 by the appellant being undisputed and notwithstanding that the injury caused

by him is simple, there was common intention for which Section 34 of the Indian Penal Code, IPC is attracted.

The court while considering the facts and circumstances of the case noted that the High Court erred and was unjustified in cancelling the bail. The court set aside the impugned judgment and has restored the order gr anting bail to the appellant. Further, the court made it

clear that it has not gone into the case's merits. The court stated that the

appellant is required to appear before the Trial Court on the dates fixed. Therefore, any failure on the appellant's part will lead to the cancellation of his bail. Accordingly, the court

SC Summons Rajasthan Chief Secretary: 'How A City Can Become Smart Without Protecting Water Bodies/Wetlands?

The Supreme Court in the case the State Of Rajasthan And Ors Versus Ashok Malik And Ors observed and has expressed the displeasure with the State of Rajasthan's failure to comply with its earlier order with regards to the restoration of wetlands in Ajmer City as part of the Union's Smart City Development Mission and warned of potential contempt proceedings if the orders remain unfulfilled.

The court in the case observed that in view of noncompliance with the order dated December 01, 2023, before we consider of initiating action under the Contempt of Courts Act, 1971, this court direct the Chief Secretary of State of Rajasthan to appear before the Court through video conferencing on Monday i.e., March 17, 2025.

The bench comprising of Justice Abhay S Oka and Justice Ujjal Bhuyan was hearing

The court stated that the direction issued under the impugned order dated Dec. 1, 2023 was for restoration of wetlands, and the Court also directed the authorities to report compliance.

However, the court observed that instead of showing compliance with the impugned order, the authorities reported defiance of the order. attracted the criticism of Court. he bench after noting defiance of the Court's order stated that, 'This court wonder how a city can become smart without protecting the water bodies or wetlands in the city and how cities will become smarter by making encroachments on the water bodies or wetlands.

The court observed that, 'Instead of filing an affidavit indicating the extent to which

the State can comply with directions contained in the impugned orders and the time span within which the same are proposed to be complied with, an affidavit has been filed by Mr. T. "Putin is trying harder than ever to win this war on the ground. His goal remains Ukraine's capitulation," she said.

Bangladeshi security forces have arrested more than 8,600 individuals following a two-week crackdown targeting gangs allegedly linked to the ousted government of Sheikh Hasina, the interim government announced Monday.

The arrests come amid growing concern over rising crime levels in the capital, with police reporting that robberies have doubled since January of last year. Jahangir Alam Chowdhury, head of the Interior Ministry in the interim government that assumed power after Hasina's ouster in the August 2024 studentled revolution, ordered officers to intensify "Operation Devil Hunt.'

Since the operation began



on Feb. 8, security forces have detained over 8,600 people, according to police. Chowdhury blamed members of Hasina's Awami League party for the surge in crime, accusing them of attempting to "destabilize" the country.

"Operation Devil Hunt will continue, and we won't allow the perpetrators to rest," Chowdhury told reporters early Monday after an emergency security briefing. "I have ordered the

forces to increase patrols." The crackdown has sparked protests from students frustrated by the surge in violent crime, with many demanding Chowdhury's resignation.

CONSERVATIVES WIN GERMAN ELECTION, AFD SURGES TO SECOND SPOT

ermany's mainstream conservatives led by Friedrich Merz won Germany's national election, ensuring that Ukraine has an even stronger supporter in the European Union's largest country and creating hopes for renewal in an economic powerhouse that has been badly battered in recent years.

The far-right, anti-immigrant Alternative for Germany (AfD) surged to become the nation's second-largest political force, gaining from a backlash against the high numbers of migrants and refugees the nation has absorbed over the past decade and a string of extremist attacks that has shaken its sense of security.

His first comments Monday after his party became the highest votegetter in national elections were words of support for Ukraine, which is marking the third anniversary of Russia's fullscale invasion.

"Europe stands unwaveringly by Ukraine's side," Merz posted on X. "Now more than ever, it holds true: We must put Ukraine in a position of strength." "For a just peace, the

Merz calls for 'independence' from US

Germany's Friedrich Merz has pledged to achieve "independence" from the United States after his centre-right alliance won parliamentary elections held amid doubts about US President Donald Trump's commitment to Europe's security.

Merz, who faces complex negotiations with his party's traditional centre-left rival to form a coalition government after ruling out the second-placed hard-right Alternative for Germany (AfD), said on Sunday that it would be his "absolute priority" to strengthen Europe so it does not have to rely on Washington for its defence.

"I never thought I would have to say something like that on a TV programme, but after Donald Trump's latest comments in the last week, it is clear that the Americans, or at least this portion of the Americans, this government, care very little about the fate of Europe," the chancellorin-waiting told a televised roundtable of political leaders.

Merz said he was not sure that NATO would exist in its "current form" by the time of the next meeting of the transatlantic military alliance in June, "or whether we will have to establish an independent European defence capability much more quickly".

has traditionally alternated between partnering with the CDU/CSU alliance and the SDP, failed to win a seat after falling short of the 5 percent threshold to enter the 630-member Bundestag, the German parliament.

The election result in the European Union's most populous country, and its biggest economy, comes as the Trump administration's efforts to negotiate an end to the war in Ukraine with Russia have prompted concerns that Washington is moving closer to Moscow at the expense of the transatlantic alliance.

Trump has stoked concerns that he is inclined towards a peace deal that is favourable to Russia with his comments in recent days, including suggesting that Ukraine had started the conflict and labelling its President Volodymyr Zelenskyy a "dictator".

The US president earlier on Sunday welcomed the election outcome as a "great day" for Germany and the US, and said it was proof that the German public "got tired of the no common sense agenda, especially on energy and immigration, that has prevailed for so many years".

Merz, a longtime supporter of transatlantic ties, campaigned on a conservative platform promising to curb unauthorised migration and slash taxes and red tape amid widespread discontent with immigration and the economy.

Merz, who is promising to unite Europe in the face of challenges from both Russia and the United States, is expected to become the country's next leader.

"That is my absolute priority, I have no illusions at all about what will come out of America," Merz said.

He also took aim at tech billionaire Elon Musk, Trump's close ally and head of the newly created Department of Government Efficiency, for intervening in the election campaign to support the AfD, which secured its best-ever result in a national poll.

"The interventions from Washington were no less dramatic and impertinent than the interventions we have seen from Moscow, so we are under massive pressure from two sides." Merz said.

Merz's Christian Democratic Union-Christian Social Union (CDU/CSU) alliance won 208 seats with 28.6 percent of the vote in Sunday's election, preliminary results showed, followed by the AfD with 152 seats and 20.8 percent of the vote, doubling what it polled in the last election.

Outgoing Chancellor Olaf Scholz's centreleft Social Democratic Party (SDP), which had governed in a widely unpopular threeparty coalition, took 120 seats, its worst result since the end of World World II.

The Greens won 85 seats, followed by the democratic socialist Die Linke, or The Left, with 64 seats and left-wing populist Bundnis Sahra Wagenknecht (BSW) with one seat.

The pro-business Free Democratic Party, a member of the outgoing coalition that

Merz, a longtime rival of former Chancellor Angela Merkel who has led the CDU in a more conservative and pro-business direction, will need the help of the SDP to form a governing majority in the Bundestag.

"If we have one partner, it will be easier; if we need two partners, it will be harder, but even in that case, it will have to be successful." Merz said.

"The main thing is to create a government in Germany that is capable of acting as quickly as possible, with a good parliamentary majority. Because, dear friends, the world out there is not waiting for us and it is not waiting for lengthy coalition talks and negotiations.

In a speech hailing her party's "magnificent campaign", AfD leader Alice Weidel, who has been shunned by the mainstream parties as part of a "firewall" against the resurgence of far-right politics, suggested it would only be a matter of time before her party holds power.

"Our hand remains outstretched to form a government," she told supporters, adding that it would be tantamount to "electoral fraud" if the first-placed conservatives chose to govern with left-wing parties rather than them.

If that happened, Weidel said, "next time, we'll come first".

Rudraksha: Divine tears of Lord Shiva

The Origin of Sacred Beads of Rudraksha: As Described in Shrimad Devi Bhagavat Purana





Rudraksha as sacred beads, are believed to carry the divine energy of Lord Shiva. Rudraksha, the name itself tells a tale—"Rudra" means Shiva and "Aksha" means

Brahmin type; Red one as Kshatriya; Mixed-colored one as Vaishya and Black one as Shudra type. The face of a Rudraksha is called Brahma and its upper part (the dot) represents Rudra, lower part or tail, rep-

resents Vishnu. Rudraksha grants both material benefits (bhoga) and spiritual liberation (moksha). While stringing mala,

the face of one bead should connect with the face of the next and the tail of one bead should link with that of the next. Sumeru bead's face should be positioned upward, with the Nagapasha placed above it.


