# 'Make in India' has failed to revive production: Rahul

ray - both in terms of poll strategy, campaign style and party's long-term objectives as a national level party. In this context, Rahul's "hands-off" policy towards AAP comes as a belated attempt to find some foothold in Delhi polls.

The Congress' Delhi strategy effectively marks an end of the I.N.D.I.A bloc and reduces the office of the Congress president, a piece of ornament. The 88th president of the AICC, Mapanna Mallikarjun Kharge, may not be a great vote catcher in the national capital but his absence from the party's campaign video is a glaring omission. The campaign video also had a fleeting reference to Sheila Dixit who was Delhi chief minister for three consecutive terms.

Kharge had painstakingly contributed in building the I.N.D.I.A bloc since 2022 after assuming the office of the Congress president. Using his acumen and conciliation skills to a hilt, he had managed to rope in Nitish Kumar, Mamata Banerjee, Sharad Pawar, Arvind Kejriwal, Tejaswi Yadav, Uddhav Thackeray and range of maverick, mercurial regional satraps to

shape I.N.D.I.A bloc. The alliance did reasonably well in 2024 General Elections in spite of Nitish Kumar switching sides at a crucial juncture. The sight of Samajwadi Party leader Akhilesh Yadav canvassing support for Arvind Kejriwal and almost every member of I.N.D.I.A bloc siding with AAP in Delhi polls must have saddened and dismayed Kharge.

After June 4, 2024 when Kharge planned to shape the I.N.D.I.A bloc as a permanent and proactive forum, something happened internally. Suddenly, there was a buzz of consolidating a 'Congress story' instead of combining the opposition's rainbow alliance following up its pre-poll efforts with a shadow cabinet, president and convenor of INDIA alliance and a full-time secretariat in Delhi. Subsequently, the Congress

exuberance for Haryana caught Kharge in a bind, weakening and eroding I.N.D.I.A unity. Post Maharashtra electoral setback, Kharge could sense growing disillusionment and disquiet within the I.N.D.I.A Parivar. However, internal party dynamics were such that Kharge could not save I.N.D.I.A bloc disintegration. What is more intriguing and perhaps bizarre is the fact that while he continues to enjoy the confidence of both Sonja and Rahul Gandhi, machinations of some senior Congress functionaries are giving him little opportunity to save the alliance.

Rahul Gandhi is said to have bought party treasurer Ajay Makan's recipe to target and isolate the Aam Admi Party even if it means BJP winning Delhi assembly polls. In Makan's scheme of things, the Congress revival in Delhi now or in 2030 can only take place at the expense of AAP's downfall. While agreeing to Makan's line, many Congress stalwarts are unsure of the efficacy of such an adventurous course. According to them, the Congress may fall between the two stools if AAP, under Kejriwal's leadership manages to retain Delhi with a reduced margin.

Rahul's camp is, however, buoyed by an internal survey conducted by poll strategist Sunil Kanugolu that predicts ten assembly seats for the party and eight per cent of votes. Both in terms of political logic, statistical analysis and ground situation, the prospects of Congress netting ten seats appears a bit far-fetched.

Moreover, if Congress indeed manages to live up to Kanugolu's expectations, the vote percentage would certainly go up, much more than his prediction. In 2013, the Congress had bagged 24.6% votes while winning eight assembly seats. By 2020, the Congress vote share in Delhi assembly polls had come down to 4% in 2020 polls.

Makan's growing stature and proximity to Rahul has rattled a section of the Congress. Party leaders claim that Makan has directly approached leading TV news channels and given them election campaign ads without consulting the AICC's communication department consisting of Jairam Ramesh, Pawan Khera and Supriya





# BJP makes Delhi polls harder for AAP AJIT MAINDOLA

In the final days of the election campaign, the Bharatiya Janata Party (BJP) appeared to gain the upper hand over the Aam Aadmi Party (AAP). Prime Minister Narendra Modi, Union Minister Amit Shah, and other BJP leaders put in significant efforts to ensure their victory, bringing the race to a tight contest. Experts believe that this could lead to a shift in the results, with BJP possibly surpassing the majority mark on its own. If this happens, Congress will play a key role in the final outcome.

There are clear signs of a potential shift in the Delhi elections. While the ac-



tual results will only be revealed on election day, the political landscape in Delhi seems to be evolving in the final days of campaigning. # EC bans exit polls on Feb 5

The notification issued on January 22, also made it clear that under the provisions of the Representation of the People Act, displaying any election matter, including results of any opinion poll or any other poll survey, in any electronic media would be prohibited during the 48-hour period ending with the time fixed for the conclusion of the poll.



# GRAP stage-III curbs revoked as AQI improves

As the Air Quality Index (AQI) in the national capital shows improvement, the Commission for Air Quality Management (CAQM) has decided to lift the restrictions imposed under Stage-III of the Graded Response Action Plan (GRAP) with immediate effect in Delhi and surrounding National Capital Region (NCR).

The CAQM's decision comes as the AQI in Delhi was recorded at 286 on February 3, 2025, which is 64 points below the 350



mark required to implement Stage-III measures, as per the Supreme Court's

"The AQI of Delhi has been recorded as 286 for 03.02.2025 which is 64

points below the 350 mark to implement Stage-III as per the extant directives of the Supreme Court. Further, the forecast by IMD predicts very light rain/ drizzle and favourable wind conditions in the days to come," the order signed by the Director (Technical) RK Agrawal, who is also the member convenor of the sub-committee on GRAP,

"Owing to improvement in mixing height and ventilation coefficient and much favourable meteorological conditions for dispersion of pollutants, the AQI of Delhi has shown a significant improvement," the order further read.

However, the actions under stages I and II of the extant schedule of GRAP shall remain invoked and be implemented. All implementing agencies have been asked to keep strict vigil and intensify measures under the two stages of the extant schedule of GRAP.

Moreover, construction and demolition project sites etc. which have been issued specific closure orders on account of non-compliance with various statutory directions, rules, and guidelines under no circumstances shall resume their operations without any specific order to this effect from the commission.

Azhar Mehboob, a political science scholar at Jamia Millia Islamia, said whatever image people make of a politician when he or she is jailed, is not always linked to voting patterns.

"Irrespective of any political party, the way people perceive political candidates going to jail has been somewhat similar in the past. Some politicians gain sympathy while some outrage but votes are polled mostly on the basis of other factors," he said.

# **RUPEE HITS RECORD LOW OF 87.29 AGAINST \$**

The rupee hit 87.29 per dollar before RBI intervention, as US tariffs fuelled its slide.

ndian rupee fell to a record low of 87.29 per dollar on Monday, weighed down by concerns over trade tariffs imposed by US President Donald Trump and global market uncertainties.

The rupee has already depreciated more than 1.5 per cent this year, and the latest decline is seen as a reaction to tariff measures imposed by the US government.

The rupee opened with a sharp gap-down of 43 paise and touched a low of 87.29 before recovering slightly to 87.13 following the Reserve Bank of India (RBI) intervention. Analysts believe this sharp fall is primarily due to the tariff war initiated by the US against Canada, Mexico, and China.

The central government stuck to the fiscal consolidation path in the first full budget of its third term. It targeted fiscal deficit

at 4.4 per cent of GDP in 2025-26 from the revised estimate of 4.8 per cent in 2024-25

The difference between total revenue and total expenditure of the government is termed as the fiscal deficit. It is an indication of the total borrowings that may be needed by the government.

Further, capex allocation to states has been raised substantially this year. Goldman Sachs said this likely indicates that the government is passing the capex baton on to states.

According to the report, the Budget 2025 delivered three key messages -- government sticking to its fiscal consolidation path, commitment to keep the central government public debt on a declining path, and the readjusted income tax slabs.

The overall preference of Indian policymakers in recent years has been macroeconomic resilience over chasing short-term spurts of growth, Goldman Sachs reiterated.

# Manufacturing PMI at 6-month high on robust demand

Following a moderation in growth during December, Indian goods producers kicked off year 2025 on a robust note.

With new orders rising at the quickest pace since last July, fuelled by the steepest upturn in exports in nearly 14 years, there was a stronger expansion in output, showed **HSBC India Manufacturing** PMI for January.

"India's final manufacturing PMI marked a six-month high in January. Domestic

and export demand were both strong, supporting new orders growth. The employment PMI suggested robust iob creation in the manufacturing industry, as the index increased to its highest level since the series was created. Input cost inflation eased for a second month, relieving pressure on manufacturers to raise final output prices," said Pranjul Bhandari, Chief India Economist at HSBC.

Pressures emanating from costs retreated to their weakest in 11 months, but selling prices rose solidly amid buoyant demand and



business confidence having strengthened, the monthly PMI report said.

Rising from December's one-year low of 56.4 to 57.7 in January, the Purchasing Managers Index signalled a robust improvement in the

health of the sector. The rate of expansion was the quickest since last July and outpaced its long-run average

The indices vary between O and 100, with a reading above 50 indicating an overall increase compared to the previous month, and below 50 an overall decrease.

Goods producers welcomed another substantial increase in new orders, which they attributed to better domestic demand and a pick-up in international sales. Total new business expanded at the fastest rate in six months.

International demand for Indian goods strengthened in January, with panellists noting gains from across the globe. Notably, the rate of expansion in new export orders was the best seen in just under 14 years, the PMI report

Subsequently, manufacturers in India continued to scale up production volumes. The latest increase was substantial and the fastest since October 2024.

Companies turned more optimistic about output prospects, with nearly 32 per cent of firms forecasting growth and just 1 per cent expecting a reduction, the monthly survey found.

Robust sales gains and upbeat forecasts prompted companies to recruit additional workers at the start of the fourth fiscal quarter (January-March), it asserted.

tors such as global economic slowdown, geopolitical tensions, and trade disruptions could impact India's exports and foreign investments. These risks need to be closely monitored to ensure that they do not derail the country's growth momentum.

It said "India's economic growth is expected to moderate to 6.4 per cent in financial year (FY) 2025 compared to 8.2 per cent growth in FY24, mainly due to slowdown in urban consumption, high food inflation, slow growth in capital formation and global headwinds".

On the inflation front, the report added that price pressures are expected to ease in the coming years. Inflation is projected to average 4.5% in FY26, aided by a favorable food inflation scenario, a good harvest, normal monsoon expectations, and lower global commodity prices.

Additionally, the exchange rate, which has been under pressure, is expected to stabilize as Foreign Portfolio In $vestor (FPI) \, flows \, become \, less$ volatile and crude oil prices soften, reducing India's im-

port costs. Despite these challenges, India is expected to retain its position as the fastest-growing major economy in 2025. While external risks remain a concern, factors like rural demand recovery, easing inflation, and continued government spending could help sustain growth in the coming

But has it fully learnt from some of the avoidable debacles the country has experienced is a moot question. That South Asian nations are riven by religious considerations is an unfortunate truth which India

needs to factor in its policies

towards its neighbourhood. Among the many factors which, since the beginning of time, has contributed to turmoil and conflicts in myriad forms is religion apart from in the same region multiplicity in languages, cultures, castes and creeds. That India is marked by mind boggling differences among its people is a unique characteristic of this ancient civilization albeit politically a young nation. That this unique diversity can be a source of conflict or a strength depends on how a nation, its people and, importantly, its government in power handles these wide differences. An aspect which any nation can forget only at its peril is that uni-

son in nation building, is sine

qua non for the well being and growth of a nation. All those countries which have attempted to sow divisions among their citizenry, for whatever reason, have had to pay dearly for practicing divisiveness. India has been known for its inclusiveness and secularism since its freedom struggle and its people understand that divisiveness will only harm its political integrity and development. The world does look up to India for its universal out-

look and a sense of tolerance towards all religions and we have to live up to these ideals for the good of humanity and ourselves. However, even some of our friendly nations have, in recent times, questioned India's current stance---- some of their apprehensions and allegations are exaggerated--- but we need to take cognizance of these observations nevertheless and ensure that India remains on the path of tolerance and equal respect for all religions.

The Centre and all state governments must sincerely observe the provisions of Section 4 of the Places of Worship Act 1991 which states that the religious nature of any place of worship as it was on August 15, 1947, will remain unchanged. With neighbouring Myanmar politically unstable and Bangladesh displaying a clear anti-India orientation, India cannot afford any internal disharmony in its border states. Since decades India has

endeavoured to harmonize its South Asian neighbourhood but with mixed results. As it continues to re-energise its "Neighbourhood First" policy, internal harmony within the nation is a prerequisite. As India yearns to be a "Vishwa Guru", all of us Indians must never forget the fact that every faith in India and abroad is a thread in the beautiful tapestry of humanity. And as we strengthen our collective identity as Indians, respecting all cultures equally, we will only then transcend to become true global citizens. Let us all thus embrace diversity as our eternal strength.

# THE DISMANTLING OF USAID AND NED

Who would have thought that in less than two weeks of Donald Trump becoming the President of the United States, he would ensure the opening of a can of worms when it comes to agencies like the USAID-and NED-long considered arms of the deep state? USAID, established by President John F. Kennedy in 1961, had a clear cut mandate—to deliver civilian foreign aid and development assistance to the world. It is a different matter that it has been accused of using its work as a cover to interfere in the matters of sovereign countries and conduct regime change operations. This has been a long-standing accusation. But now it is becoming public that even domestically USAID's deeds read like that of a history-sheeter's-full of corruption, including graft, unethical practices and even funding bioweapons research. In fact, Elon Musk, who is in charge of the Department of Government Efficiency (DOGE), and is fulfilling Trump's order of downsizing government, has called USAID a "criminal organization" and asserted that "it's time for it to die". He said this after two USAID officers refused to share some top secret files with DOGE. Ever since, USAID's website has gone "bad" and its social media handles have disappeared. It's as good as dead, while wild tales of its misdeeds are flooding cyberspace. Confirmation of USAID being shut down came from Elon Musk on Monday, who said that Trump has agreed to shut USAID down: "You've got to basically get rid of the whole thing. It's beyond repair ... We're shutting it down."

The other organisation on the Trump administration's crosshairs is the National Endowment for Democracy (NED), which Musk has described as a "scam". Along with USAID, the NED has been actively involved in regime change operations internationally. In fact, the latest of its success stories is believed to be Bangladesh, where the government of Sheikh Hasina was overthrown by a so called students' revolution. The protests against Hasina were funded and engineered by NED. To give an instance, Dhaka University professors with close links with NED were part of the NED-funded project, Confronting Misinformation in Bangladesh, which was used to brainwash the students against Hasina. Among many such activities, reports say that it is NED that has been in the forefront of creating a misperception about Indian democracy by funding the "Journal of Democracy", which has been carrying articles against India under the Narendra Modi government, thus triggering the narrative of the backsliding of democracy in India. It also should not come as a surprise that regime change specialist Victoria Nuland is a part of the NED board of directors. This has to be seen in the context of what Robert F. The Organized Crime and Corruption Reporting Project (OCCRP), for instance, received funding from Soros' Open Society Foundations, from the US State Department, and as well as from the USAID and NED. It was OCCRP that was in the forefront of all the reports attacking the Indian government, including on Pegasus. Curiously, all these reports would make an appearance just ahead of every Parliament session, giving ammunition to Rahul Gandhi in particular to stall Parliament almost every day. As many would have noticed, no such international reports on India made an appearance ahead of the budget session of Parliament this year. Prime Minister Narendra Modi has noticed this and mentioned as much. It cannot be a coincidence that such controversial reports vanished as soon as Trump became President. It goes without saying that this sudden "normalization" of the situation has everything to do with bodies like that USAID and NED falling victim to Trump's determination to dismantle the deep state—the deep state that tried to "cancel" him by sending him to prison. Trump is dealing the deep state a body-blow from which it will find it difficult to recover.

The obvious question is, why have some of our Opposition parties been working with the OC-CRP and Soros' organisations, and hence with the US deep state? From initial skepticism and strict regulations to an ongoing reassessment of its position, India is now reviewing its cryptocurrency stance in light of shifting global attitudes, particularly following the United States' recent pro-crypto policy announcements.

This article explores India's evolving stance on cryptocurrencies, examining the influence of global regulatory changes, economic and technological considerations, and potential future scenarios for the country's digital asset landscape.



### **RBI'S CRYPTO BAN**

India's approach to cryptocurrency has undergone significant shifts over the years. In 2018, the Reserve Bank of India (RBI) imposed a blanket ban on cryptocurrency transactions, citing concerns over financial stability, money laundering, and fraud. The move was met with resistance from industry stakeholders and investors, leading to legal battles that culminated in the Supreme Court of India overturning the ban in 2020. This marked a crucial turning point, allowing cryptocurrency exchanges and traders to operate legally once again.

### **CRYPTO TAXATION**

In 2022, India took a decisive step towards regulating digital assets by introducing a 30% tax on cryptocurrency gains and a 1% Tax Deducted at Source (TDS) on crypto transactions. Despite this, the country witnessed continued interest in digital assets, with blockchain startups and Web3 projects growing in prominence.

The government's regulatory concerns have been reflected in recent enforcement actions. In December 2023, India's Financial Intelligence Unit (FIU) issued show-cause notices to nine offshore cryptocurrency exchanges, including Binance, for non-compliance with local financial laws. Binance was subsequently fined 188.2 million rupees (\$2.25 million) in June 2024, reinforcing India's firm stance on compliance.

### **GLOBAL INFLUENCES Policy Shift Under Donald Trump**

One of the primary catalysts for India's reassessment of its crypto policy is the recent shift in U.S. regulations. In January

2025, U.S. President Donald Trump signed an executive order titled "Strengthening American Leadership in Digital Financial Technology." This policy aims to regulate and promote the cryptocurrency industry while protecting individuals' rights to access blockchain networks, develop software, and participate in mining activities. Additionally, it prohibits the establishment of a Central Bank Digital Currency (CBDC) in the U.S. and promotes dollar-backed stablecoins globally.

The executive order also establishes the President's Working Group on Digital Asset Markets, tasked with proposing regulatory reforms and exploring the creation of a national cryptocurrency stockpile. These developments indicate a major shift in the U.S. government's approach, transitioning from regulatory framework supporting digi-

A more optimistic scenario envisions India fully embracing digital assets, promoting blockchain innovation, and even considering the use of Bitcoin or stablecoins in certain financial transactions. This approach would require a shift in the RBI's perspec-

# ALLAHABAD HIGH COURT: HUSBAND'S RELATIVES WHO DO NOT EVEN LIVE IN SHARED HOUSEHOLD ARE IMPLICATED IN **CASES FOR HARASSMENT**

he Allahabad High Court in the case Krishnawati Devi And O6 Others vs. State of U.P. and Another observed that in many cases, to harass the family of husband or the person in a domestic relationship, the aggrieved party implicates relatives who have never lived with them in the shared household

The bench headed by Justice Arun Kumar Deshwal in the case issued notice under section 12 of the Domestic Violence Act, thus, the courts must look into whether the person who is being implicated is living or ever lived with the aggrieved person in a shared household.

It has also been observed by the court that before issuing notice to individuals named as respondents in an application under the Domestic Violence Act, the concerned court needs to ensure that the following



conditions are satisfied:

'The respondent must be related to the aggrieved person in the manner as mentioned in Section 2(f) and he lived or has been living together with aggrieved person in a shared household and then commits domestic violence in the manner mentioned in Section 3 of Domestic Violence Act.'

The single judge made the said observations wherein the court quashed the proceedings or complaints under Section 12 of the Domestic Violence Act against five accused (the married

sisters of the husband and the husband of one of the sisters), noting that they had not lived with the opposite party no. 2 (wife) in a shared household.

However, the court in the case refused to quash the case against applicant no.1 i.e., the mother-in-law, noting that she had been residing in a shared household and thus would fall within the definition of the respon-

It was also alleged before the court that she harassed the wife for the demand of dowry and extended a threat to evict her from the shared household.

The court also stressed that the proceedings initiated under the Domestic Violence Act can be initiated when the domestic violence, as mentioned in Section 3 of the Domestic Violence Act, is committed by the respondent who is living in a domestic relationship with the aggrieved person.

The court in the case noted that in the instant case, applicants nos. 2 to 6 are relatives of applicant no. 7 (husband) and they have been residing separately, 2(q) of the Domestic Violence Act, they cannot be termed as respondents as they have not been residing in a shared household with the opposite party no. 2. Thus, quashing the case against applicants 2 to 6, the Court emphasized that in many cases, the aggrieved parties falsely implicate the husband's relatives, who had never lived with them in the shared household, merely to harass them.

therefore, as per Section

The court stated that before issuing a notice under Section 12 of the DV Act, courts must verify whether the person being implicated actually lived with the aggrieved party in a shared household.

The court while considering the facts and circumstances of the case clarified that the below would be free to proceed against applicants nos. 1 i.e., mother-in-law and 7 (husband) and decide the case against them expeditiously within a period of 60 days.

# SC rejects refund claim for private out-ofcourt settlement: 'Court fee refund only if case settled through adr mechanism'

The Supreme Court in the case Jaga Ram Versus Ved Kaur And Ors observed and has held that the litigants who resolve their disputes privately outside of court are not entitled to a refund of court fees.

The court in the case stated that the refund of the court fees is permissible only 'if the present matter is being referred to Arbitration, Conciliation, judicial settlement, including through Lok Adalat or mediation for settlement and the case is decided in terms of such a settlement and not otherwise.

It has been assailed that Section 2, Section 3, Section 4 and Section 8A of the Dowry Prohibition Act which deal with definition of dowry (Section 2), penalty for giving or taking dowdemanding dowry (Section 4) and burden of proof in certain cases (Section 8A).

The court observed that as the criteria excludes single mothers from OBC category - divorced

women, widows, women who have adopted - from applying for an OBC certificate for their children based on their own certificate, the petitioner asserts, it is discriminatory and violative of Article 14 and Article 21 of the Constitution of India.

The petitioner in the plea highlighted that the children of single mothers belonging to Scheduled Castes or Scheduled Tribes category are allowed to obtain caste certificates of their mothers, but not children belonging to OBCs. It has been contended

with regards to the violation of Article 21 of Constitution of India that the denial of OBC certificates on the above basis affects children of single mothers from OBC category socially and financially.

The court in the case also observed that because insistence on the OBC certificate of the father or paternal side by the respondents for issuing OBC certificate to the children of Single Mother (which includes Divorced mother, widow etc) belonging to OBC Category is totally against the rights of the children brought up by a single mother and also against the provisions of the Constitution of India.

The petition has been filed by AoR Vipin Kumar.

One official from the Palestinian Authority estimated immediate funding needs of \$6.5 billion for temporary housing for Gaza's population of more than two million, even before the huge task of long-term reconstruction begins.

# Car bomb kills 15 in northern Syria, deadliest since Assad toppled

A car bomb killed at least 15 people in the northern Syrian city of Manbij on Monday, the second attack there in three days and Syria's deadliest since Bashar al-Assad was toppled from power in December.

There were no immediate claims of responsibility for the attack in Manbij, located some 30 km (19 miles) from the Turkish border. The civil defence rescue service identified the dead as 14 women and one man, and said another 15 women were wounded.

The Kurdish-led Syrian Democratic Forces (SDF) condemned the car bombing, accusing Turkey-backed factions of using such bombings and violence to intimidate local residents. The victims

were agricultural workers and the death toll was likely to increase, a civil defence official said.

Manbij has changed hands numerous times during Syria's 13-year civil war, most recently in December when Turkish-backed groups captured it from the U.S.-backed SDF, which is led by the Kurdish YPG militia.

The SDF had taken Manbij from Islamic State militants in 2016. On Saturday, a car bomb in Manbij killed four civilians and wounded nine others, including children, the Syrian state news agency SANA reported. Assad was ousted from power on Dec. 8 after a lightning offensive by the Islamist Hayat Tahrir al-Sham (HTS) group, whose leader, Ahmed al-Sharaa, was declared Syria's transitional president last week

# North Korea unlikely to respond to Trump's overture soon

In its first direct criticism of the Trump administration, North Korea lashed out at U.S. Secretary of State Marco Rubio for calling it a "rogue" state and warned Monday that such "coarse and nonsensical remarks" will never contribute to U.S. interests.

The statement is the latest in a series of North Korean signals that it's not interested in resuming diplomacy with the United States anytime soon, though Trump has said he'll reach out to its leader Kim Jong Un.

Many experts say that Kim, preoccupied with his deployment of troops to Russia, is likely concentrat-

ing on developments in the Russia-Ukraine war for now. But they say Kim would eventually seriously consider Trump's overture if he assessed he cannot maintain the current solid partnership with Russia after the war

The mission in Ukraine said it had received reports of 79 executions in 24 separate incidents since the end of August last year. International humanitarian law prohibits the execution of prisoners of war and the wounded, and regards it as a war crime.

"Many Ukrainian soldiers who surrendered or were in physical custody of the Russian armed forces were shot dead on the spot. Witness accounts also described the killings of unarmed and injured Ukrainian soldiers," the mission said in a statement.

Commenting on the report, Ukraine's Foreign Minister Andrii Sybiha said the Russian atrocities demanded urgent international action.

"Russia's horrific executions of Ukrainian prisoners of war demonstrate that Ukraine confronts true beasts," he said on X. "We

Rubio made it clear that the current situation is "unacceptable" and in the case of "absent immediate changes, it would require the United States to take measures necessary to protect its rights under the Treaty," concerning the Permanent Neutrality and Operation of the Panama Canal.

Rubio arrived in Panama on Saturday, marking his first trip since holding the job as US top diplomat.

Rubio's choice to visit Central America - Panama, El Salvador, Costa Rica, Guatemala, and the Dominican Republic - is intentional and meant to drive forward the Trump agenda by "paying closer attention to our own neighbourhood," CNN reported.

Trump in his inaugural address on January 20, claimed that China is "operating" the Panama Canal and US is going to "take it back" as the US has been treated 'unfairly."

After being sworn in as the 47th US President at the US Capitol in Washington, DC, he said, "The United States, I mean, think of this, spent more money than ever spent on a project before and lost 38 lives in the building of the Panama Canal.

# Australia imposes sanctions on rightwing online network 'Terrorgram'

Australia on Monday imposed sanctions on extreme right-wing online network "Terrorgram" as part of its efforts to combat a rise in antisemitism and online extremism, following similar moves by Britain and the

Foreign Minister Penny Wong said the government's action would make it a criminal offence to engage with "Terrorgram" and help prevent children from becoming caught up in farright extremism.

"Terrorgram is an online network that promotes white supremacy and racially-motivated violence," Wong said in a statement.

"It is the first time any Australian Government has imposed counterterrorism financing sanctions on an entity based entirely online." Offenders will face up to 10 years in jail and heavy fines, she said.

The Australian government also renewed sanctions on four right-wing groups: the

If Bayrou uses the 49.3 to push through the bill, opponents have 24 hours to lodge a censure motion that must be voted on within 48 hours. If it succeeds. the bills are rejected, the government collapses and France returns to a political impasse.

The current deadlock was caused by the decision off the president, Emmanuel Macron, to dissolve parliament and hold a snap general election in June after his governing centrist party was defeated in European

elections.

In the subsequent general election, the Nouveau Front Populaire (NFP), a coalition of left-wing parties including the PS, LFI, PCF and EELV, won the highest number of seats.

The result left the lower house of parliament divided into three roughly equal blocs - left, centre and far right - none of which has an absolute majority. A new legislative election cannot be held until Iune.

On Monday, the governor of

the Bank of France, François Villeroy de Galhau, told FranceInfo radio that adopting the budget bill would be "a first step in the right direction" to end economic uncertainty.

"To begin to reduce that uncertainty, France needs a budget ... one that reduces the deficit,' Villeroy de Galhau said adding that the priority was to get a grip on public spending.

If the budget bill is passed, it will come into effect in the second half of the month.

The lyrics and video of this celebrated song capture the raw essence of India. The elements portrayed, thirsty souls flooded with life, elephants, sadhus, the celebration of colors, and the magic of India's dance forms, all carry a common thread of deep spiritual awakening. ### **COGNITIVE AND EMO-TIONAL CHALLENGES**



Celestial energy and auras are expected to be at their peak during this time, and these three rivers are considered particularly sacred. They are not just physical elements of nature, but are believed to represent stronger forces that connect the devotee to the divine. Purifying and uplifting the people who choose to bathe

ing of this energy that emanates from the rivers, we can turn to the teachings of Shri Krishna Charit Manas (Rasavan Mahakavva). written by Jagadguru Shri Priyadarshi Ji Maharaj.

First, the Ganga. One of the most famous rivers in the world, it is revered as the purifier of all sins. A dip in the Ganga can give one moksha, or freedom from rebirth. Second, the Yamuna holds a sacred place as the river where Lord Krishna spent his childhood. The Yamuna is enriched through his divine love and joy. Last but not the least, the Saraswati is the physical embodiment of knowledge and wisdom, flowing in and out through the conscious and the divine from the holy dips that sadhus and saints take.

Maha Kumbh 2025: Cosmically Aligned

The Maha Kumbh itself only comes around once in 144 years. It embodies a devotee's shared quest for renewal, self-discovery, and spiritual growth. It symbolises the victory of good over evil, resulting in a convergence of spiriin these holy waters. To tual energies. According



to Hindu mythology, the four most important places for the Kumbh Mela are Allahabad (Prayagraj), Haridwar, Nashik, and Ujjain. These were places where drops from the pot, or kumbh, containing the elixir of immortality fell during the Samudra Manthan, or churning of the ocean. These are now the sites of the Kumbh Mela. The divine waters of the sacred rivers, at the precise moment of the Mela, are believed to hold the celestial nectar-imbued with the power to cleanse the soul and connect the devotee with divine consciousness. As per Shri Krishna Charit Manas, Lord Krish-

na's childhood stories and youth spent at the Yamuna reflect his deep connection with the river. It is the place he played his divine leelas (pastimes) on the banks of the Yamuna, allowing it to imbibe his sense of divine love and joy, which is said

to even carry on to today. The river Yamuna, where Krishna's divine play unfolded, symbolizes the flow of Bhakti (devotion) that takes one toward the realization of the Supreme.

During the Kumbh Mela, the Yamuna's waters are believed to carry this same flow of divine love and devotion. Bathing in these waters during the Mela is said to evoke the bliss and love of Krishna's presence, allowing the devotee to ex-

perience the ultimate union with God, just as the Gopis (the cowherd girls) experienced Krishna's love.

The river Ganga is the most sacred and is central to the Hindu understanding of purification. In Shri Krishna's Charit Manas, Jagadguru Shri Priyadarshi Ji Maharaj emphasizes the importance of Sankirtan (chanting the name of God) and the purifying power of water in a symbolic sense. The Ganga, in this context,

represents the grace of God that purifies the heart and soul of the devotee, washing away sins and worldly attachments.

Although the Saraswati River is no longer physically present at the Kumbh Mela sites, its spiritual essence remains deeply woven into the experience. In the Shri Krishna's Charit Manas, wisdom and knowledge are often portrayed as sacred pathways leading to the divine. Saraswati, as both the goddess of learning and the river of spiritual wisdom, plays a vital role in the journey of enlightenment. She represents the continuous flow of Jnana, or divine knowledge. During the Kumbh Mela, great saints and sadhusimbued with spiritual power—immerse themselves in the sacred waters, and their Jnana flows into the river, becoming one with Saraswati. This sacred act symbolizes the transfer of wisdom from the divine to the seeker, creating a powerful channel of spiritual awakening. Its presence at the Maha Kumbh represent the awakening of spiritual wisdom. It is believed by pilgrims that meditating on the sacred waters of the confluence of the Saraswati. that one can gain access to higher knowledge and a clearer understanding of the nature of reality, leading them to the ultimate realisation of the Supreme

truth. The sacred rivers of Saraswati, Yamuna, and Ganga during the Kumbh Mela provide a tangible connection to the divine energies described in Shri Krishna's Charit Manas. The waters of these rivers serve as channels for divine purification, love, and wisdom-an embodiment of the qualities of Lord Krishna himself.
