

nterest rate on retail loans, including home and auto, is likely fall soon as the Reserve Bank of India under a new Governor on Friday cut the key benchmark rate for the first time in almost five years to spur a sluggish economy.

The Monetary Policy Committee, headed by RBI Governor Sanjay Malhotra, slashed the repo rate by 25 basis points to 6.25 per cent. This was the first reduction since May 2020.

Repo rate is the rate at which the RBI lends to other banks.

In his first Monetary Policy announcement on Friday, Reserve Bank of India (RBI) Governor Sanjay Malhotra stated that the Monetary Policy Committee (MPC)

### had unanimously decided to reduce the policy rate by 25 basis points (bps) from





## India moving towards self-reliance in fertiliser production: Nadda

The country is making significant progress toward self-reliance in fertilizer production, reducing its dependence on costly imports, Union Minister for **Chemicals and Fertilizers** and Health and Family Welfare Jagat Prakash Nadda informed the Lok Sabha on Friday. In a written reply in a response to a question the minister told the House that a series of government policies and new investments have led to a substantial increase in both urea and

The minister said that due to the government's New Investment Policy (NIP) for urea, introduced in 2012 and amended in 2014, has

As a result, India's indigenous urea production capacity increased from 207.54 LMTPA in 2014-15 to 283.74 LMTPA in 2023-24. He said that the government approved a Greenfield urea plant with a capacity of 12.7 LMTPA at Talcher, Odisha, based on coal gasification technology. The New Urea Policy (NUP) 2015 further boosted production by maximizing output from 25 existing gas-based units, annually. As a result of these efforts, urea production soared from 225 lakh metric tonnes (LMT) in 2014-15 to a record 314.07 LMT in2O23-24. For P&K (Phosphatic and Potassic) fertilizers, the government implemented the Nutrient-Based Subsidy (NBS) Policy in 2010. This policy provides a fixed subsidy based on the nutrient content of fertilizers, encouraging manufacturers to produce or import fertilizers according to market demand.

## '20% judicial posts vacant in lower courts' Among the states, Bihar ernments and High Courts.

India's lower judiciary is facing a serious shortage of judicial officers, with nearly 20 per cent of the sanctioned posts lying vacant. In a written reply to a question in the Rajya Sabha, Union Minister of State for Law and Justice Arjun Ram Meghwal revealed that out of the total sanctioned strength of 25,771 judicial officers, only 20,478 are in place, leaving 5,293 posts unfilled.

est number of vacancies 483 posts out of 2,019 sanctioned positions remain vacant. Uttar Pradesh follows with 996 vacancies out of 3,870 sanctioned posts. Other states facing notable shortages include Maharashtra (250), Odisha (200), and West Bengal (230, including Andaman & Nicobar).

Minister Meghwal clarified that filling these vacancies is the responsibility of the respective State Gov-

tops the list with the high-As per the Constitution, Articles 233, 234, and 309 provide the framework for states to frame rules for appointing judicial officers in consultation with their High Courts.

## Kartikeya Sharma introduces 'The Release of Mortal Remains by Clinical Establishments Bill, 2024' in RS

Rajya Sabha Member of Parliament Kartikeya Sharma on Friday introduced 'The **Release of Mortal Remains** by Clinical Establishments Bill, 2024' in the Upper House.

In what would be a significant move to protect the rights of bereaved families, the landmark legislation addresses the critical issue of hospitals and clinicial establishments withholding bodies of patients due to pending medical bills.

The bill prohibits clinical establishments from detaining mortal remains or making their release conditional upon payment of outstanding dues. It ensures that the next of kin or authorized representatives can claim and receive the deceased's



body with undue delay or harassment.

Key provisions of the bill include mandatory immediate release of mortal remains upon completion of medical and legal formalities, separation of billing disputes from the release process, establishment of grievance redressal mechanisms, and penalties for non-compliance by clinical establishments

Ever since his election to the Rajya Sabha in 2022, Sharma has been raising this issue in the Parliament

seeking relief for the thousands of families who are refused repatriation with the mortal bodies of their dear ones due to pending bills and disputes.

While speaking in the Rajya Sabha and raising this issue on Friday, Sharma said, "A report by Lancet commission on the value of death published in the year 2022, states that in a situation when the family is unable to pay hospital bills, hospital staff will often refuse to release the body until the payment is made. The Geneva convention and UN commission for Human rights make it legally bind-

ing to provide for explicit provisions relating to the proper management, dignified treatment and disposal of dead bodies as well as respect for the need of families.'





Chinese company involved in a "Digital Arrest" scam

Gopal had received a call from the scammers, claiming he was involved in a money laundering case and would be arrested unless he transferred Rs. 15 lakhs to a DBS bank account.

The investigation revealed that the scammers operated from Jhansi, opening multiple bank accounts in unsuspecting individuals' names.

The accused - Imran Qureshi, Asad Qureshi, Dev Sagar, Javed, and Ab-





# **A GENTLE NUDGE TO BORROW**

RBI's reporte cut may lower lending rates, making loans cheaper for consumers and businesses, boosting housing and auto credit.

n February 7, 2025, the Reserve Bank of India (RBI) announced a 25 basis points reduction in the repo rate, bringing it down to 6.25%. This decision marks the first rate cut in nearly five years, with the previous reduction occurring in May 2020. The Monetary Policy Committee (MPC) unanimously voted for this adjustment while maintaining a 'neutral' monetary policy stance. The RBI also projected a GDP growth rate of 6.7% for the fiscal year 2025-26 (FY26) and anticipates a decline in inflation to 4.2% in FY26 from 4.8% in FY25. Additionally, the central bank introduced measures such as exclusive internet domain names for banks and non-bank financial entities and highlighted the challenging global economic backdrop. Despite external challenges, the RBI emphasized the resilience of the Indian economy, noting that the current account deficit (CAD) is expected to remain within sustainable levels. As of January 31, India's foreign exchange reserves stood at \$630.6 billion, providing an import cover of over ten months. The next MPC meeting is scheduled for April 7-9, 2025.

## **RATIONALE BEHIND** THE RATE CUT

The RBI's decision to reduce the repo rate is primarily driven by the need to stimulate economic growth amid easing inflationary pressures. India's GDP growth has been on a downward trajectory, with the government forecasting a growth rate of 6.4% for the fiscal year ending in March 2025, marking the slowest pace in four years. Factors contributing to this slowdown turing sector and subdued corporate investments. The central bank's move aims to provide a boost to the economy by making borrowing more affordable, thereby encouraging spending and investment. Inflation has shown signs of moderation, reaching a four-month low of 5.22% in December 2024. The RBI projects that inflation will average 4.8% in the current financial year and decline further to 4.2% in FY26. This downward trend in inflation provides the central bank with the leeway to adopt a more accommodative monetary policy stance without jeopardizing its inflation targets.







# **SUPREME COURT ASKS CENTRE: HOW MANY PERSONS DECLARED AS FOREIGNERS DEPORTED SO FAR?**

## Supreme Court criticises Uttar Pradesh govt for non-compliance with order to investigate illegal filling of water bodies

The Supreme Court in the case Mirza Abid Beg versus. State of UP And Ors. observed and has expressed displeasure over the noncompliance by the State of Uttar Pradesh with the direction of Court to investigate and submit a report on instances of illegal filling of water bodies in Bijnor District.

The bench comprising of Justice Abhay Oka and Justice Ujjal Bhuyan was hearing the present matter.

The bench in the case noted that despite the orders passed dated July 16, 2024, and November 22, 2024, thus, the Committee failed to comply with the directions.

The court in the case directed the Secretary of the Ministry of Environment of Uttar Pradesh to submit a personal

affidavit detailing the progress made in compliance with the order dated July 16, 2024. The order states:

The Supreme Court disqualified with the NGT's handling of the matter directed comprehensive investigation by a committee comprising of senior officials from the Revenue Department, Environment Department, and State Pollution Control Board.

Further, the Court mandated that the committee review old revenue records, conduct site visits, and propose measures for restoration and the copies of the committee's findings were required to be submitted to the Court, with the first report initially due by November 15, 2024.

The court in its order dated November 22, 2024 granted the State an extension of one month to file the report in compliance with the Supreme Court's order dated July 16, 2024.

The counsel appearing for the State had assured the court that the report would be submitted within the extended period.

Further, the state failed to submit the report within the stipulated time.

# **BANGLADESH SLAMS SHEIKH HASINA'S REMARKS, URGES INDIA TO INTERVENE**

Bangladesh on Thursday lodged a strong protest against what it said were "false and fabricated" statements by former premier Sheikh Hasina,.

angladesh on Thursday lodged a strong protest against what it said were "false and fabricated" statements by former premier Sheikh Hasina, currently in self-exile in New Delhi, and sought "appropriate measures" to stop her from making "incendiary' remarks on social media.

Bangladesh's foreign ministry handed over a protest note to India's acting high commissioner in Dhaka a day after Hasina made a speech on her Awami League party's social media channels during which she accused interim government chief Muhammad Yunus of conspiring to kill her and her sister Sheikh Rehana.

There was no official word from the Indian side on the development.

After stepping down in the face of nationwide protests last August, Hasina fled to India. Her presence in the country has emerged as an irritant in bilateral ties and the interim government in Dhaka has often bristled

The report says that the Chinese government's relentless suppression



The International Criminal Court on Friday called on member states to stand up against sanctions imposed by U.S. President Donald Trump, describing the move as an attempt to "harm its independent and impartial iudicial work."

The embattled court has received support in Europe from traditional allies of the U.S.

"Sanctioning the ICC threatens the court's independence and undermines the international criminal justice system as a whole." said European Council President António Costa, who heads the summits of the European Union's 27 leaders. It was the toughest direct criticism by a senior EU official to a decision by Trump since his return to office last month.

## **RUSSIA CLAIMS CAPTURE OF EASTERN UKRAINE TOWN; KYIV SILENT**

ussia's Defense Ministry claimed on Fri-Lday that its forces had captured the coal mining town of Toretsk in their latest breakthrough in eastern Ukraine's Donetsk region, where Ukrainian defenses are creaking.

Ukrainian officials did not immediately make any comments on the Russian claim. A Ukrainian officer in a brigade on the outskirts of Toretsk cast doubt on the Russian statement. Yevhen Alkhimov, the press officer of the 28th Brigade, told The Associated Press by phone that his unit had not been moved from its position, which he said likely would have happened if Toretsk had fallen.

Russia's much larger army has conducted a sustained yearlong campaign along the eastern front, gradually loosening the short-handed and weary Ukrainian forces' grip on its strongholds as the war approaches its fourth year later this month.

The losses coincide with uncertainty over whether the United States will keep providing vital military aid. U.S. President Donald Trump, who says he is making American interests his priority, has said he wants to end the war, although his plans for securing peace are

Russia seeks to take control of all parts of Donetsk and neighboring Luhansk, which together make up Ukraine's Donbas industrial region.

Russia accelerated its destruction of Ukraine's frontline cities in 2024 to a scale previously unseen in the war, using the glide bombs and an expanding network of airstrips, according to an Associated Press analysis last year of drone footage, satellite imagery, Ukrainian documents and Russian photos.

Meanwhile, the head of the U.N. atomic watchdog met Friday in Moscow with the chief of Russia's state-owned nuclear energy provider Rosatom to discuss security around southern Ukraine's Zaporizhzhia Nuclear Power Plant.

It appears that Trump will continue to generate significant upheaval in both American and international political landscapes through his bold and controversial choices. This week, President

Trump enacted an executive order that has initiated a comprehensive assessment of the US' financial contributions and participation in the UN, thereby introducing uncertainty regarding the

US' longstanding role as the primary benefactor of the global organization. Prior to signing the order,

Trump expressed his belief in the UN's significant potential, while oxymoronically criticizing its current performance as failing to meet that potential.

Additionally, he announced the withdrawal of the US from the UN Human

sation of funding to the UN **Relief and Works Agency** for Palestine Refugees (UNRWA), which is vital for providing humanitarian aid to millions affected by conflict in Gaza. Though these actions were anticipated, given Trump's previous decisions to disengage from both entities during his initial presidential term. This shift may disrupt ongoing efforts to address humanitarian crises and could hinder the effectiveness of initiatives designed to support vulnerable populations during times of conflict and natural disasters. The US not only hosts the UN headquarters in New York City but also stands as the largest financial supporter of the organization,

contributing around 22 percent of its overall budget. Following the US, China contributes approximately 15 percent, making it the

second largest contributor. Also, the US plays a significant role as a donor to numerous agencies and supports the annual global humanitarian appeal aimed at assisting populations affected by conflicts and natural disasters. Trump's decisions are going to impact these programs as well.

While making the critical accouchements, Trump expressed his discontent with the UN, characterizing it as ineffective in resolving ongoing global conflicts, which he claimed his administration was actively working to mitigate. The UN has faced significant criticism for failing to meet its responsibilities in mediating disputes and maintaining peace in various regions worldwide. Trump's remarks also highlighted a broader sentiment re-

garding the UN's perceived shortcomings in fulfilling its peacekeeping mandate. Many observers have pointed out that the organization's inability to effectively address these pressing issues undermines its credibility and purpose on the international stage.

However, at least, the decisions made by Trump regarding UNRWA and the **UN Human Rights** 

Council may not yield significant immediate consequences. This is largely due to the Biden Administration's cessation of funding for UNRWA, which followed allegations from Israel that the agency had been extensively compromised by Hamas. Trump has also declared this week that there is "no place" for the LG-BTQ community within the armed forces, sports, and employment sectors, igniting a global discussion on the implications of such a stance. This decision can be attributed to his alignment with his domestic base and an anti- woke ideology. Additionally, he has initiated the deportation of foreign nationals residing illegally in the US, with a recent operation resulting in the repatriation of over 100 Indian nationals to Amritsar via a special flight.

While the Indian government has confirmed that these individuals were living in the US without legal status, the procedures employed by the US administration during the deportation process have also raised questions and sparked controversy.



# **ALONE IN THE CITY: SILENT STRUGGLES OF SMALL-TOWN WOMEN**

journalist from Indore moves to Delhi to work with a leading media house in New Delhi. A classically trained female musician from Kanpur finds it difficult to pursue her unconventional career in a non-metro, and moves to Mumbai in search of name, fame, money. A fashion designer from Jaipur relocates to Delhi to intern with top designers. A fresh engineering graduate based out of Bikaner moves to Gurgaon because the "pay is significantly higher in metros and opportunities for growth are also there. Here I may earn Rs 20,000 as against a good Rs 60,000- Rs 1,00,000 in a metro. My town has no MNCs, corporate hubs and no exposure to big opportunities. Staying in my cocoon means goodbye to growth."

Beyond finances, young women from Tier-2 and Tier-3 cities



are migrating to metros for freedom. They want financial independence, away from family control. It's an escape from the small-town patriarchy -no curfews on timings and dress codes and more importantly, no pressure to "settle down." The city gives them space to explore life, delay marriage, and find love on their own terms. Here, they make choices—what to wear, where to go, how to live. But the fact is this freedom- both financial and mental- comes at a cost. Life

in general is tough for women because they must prove themselves at every point. But more so when you are away from home in a strange land. The journey is often riddled with socio-economic and emotional security challenges.

The biggest hurdle? Housing. Skyrocketing rents in Mumbai, Delhi, and Bangalore eat up most of their earnings. But finding a place is even tougher many landlords refuse single women, fearing "unwanted social elements" or "lifestyle

concerns.

Sujata Roy, a top-tier corporate professional who moved from Kolkata to Delhi, recalls her toughest lesson: "Never confide in anybody, esp men, that you live alone. In fact this advice was reiterated later by a male colleague of mine." It took Sujata almost a decade of struggle—mentally, physically, emotionally, and financially-to finally feel settled.

"Society sees single women as easy prey. When you're still climbing the ladder, even

spending Rs 2,500-3,000 on a maid feels like a big expense. And we barely find help because we leave early, return late, and end up surviving on packaged food. You come back to a cold house... and that's how India's migratory single women become the biggest brand ambassadors of Maggi. Calling your parents and siblings back home is a mandatory task assigned. Your break-ups become ten times tougher as your emotional anchors are back home," she says.



Work-life balance? A myth. Many live paycheck to paycheck, forced to return home if they lose their jobs—some battling depression, others too ashamed to go back as "failures." For many, the only way out is co-living spaces-cheaper rent, better security, and a sense of community.

Unlike men, women in new cities lack strong networks, making adjustment tougher. They battle catcalling, stalking, and workplace harassment, all taking a mental toll. Society questions their independence, adding pressure and self-doubt. The key to survival? Finding support-women's groups, online forums, and like-minded allies to combat loneliness and stand strong.

The workplace has its own challenges - contractual jobs and gig work further add to financial instability. Gender bias in hiring, promotions, and pay structure remains an issue in male-dominated sectors.

It is true that metro life offers career growth, financial freedom, and independence-but at a cost. Loneliness, safety risks, and workplace bias test their strength. Yet, those who can somehow endure the five to ten-year grind, emerge stronger. They redefine themselves, carve their own path, and take charge of their future. If they can persevere, they find their sweet spot and are successful in creating a new identity for themselves- come to know who they are, where they are going and what they want to do in the future.

With resilience, networks, and smart finances, small-town women aren't just survivingthey're shattering barriers and owning their space. Often, they outshine city natives. Their risks are higher—but so are their rewards.



Tokyo medallist boxer beats Rathore, Asian champion loses to Vansha

okyo Olympic bronze medalist Lovlina Borgohain clinched the women's 75kg gold, while six-time Asian champion Shiva Thapa signed off with a silver medal in the men's 63.5kg category at the National Games here on Friday.

Playing her first tournament since the Paris Olympics, Assam's Lovlina dominated her younger opponent Pranshu Rathore from Chandigarh across all three rounds to register a convincing 5-0 win.

The 27-year-old Indian boxer had also won the gold medal in the same weight category in the 2022 National Games held in Gujarat.

In the men's light welterweight (63.5kg) division, Thapa lost in a close bout to Services Sports Control Board boxer Vanshaj, with a 3-4 scoreline.

In other bouts of the day, Services' Mandengbam Singh defeated Chandigarh's Anshul Punia in the men's flyweight (51kg) division by a 4-1 split decision. Commonwealth Games

Local boxer Nivedita Karki showed precision

and agility as she overpowered Haryana's Kalpana to claim the top spot in the women's flyweight (50kg) event.

Former youth world champion Assam's Ankushita Boro reigned supreme in the women's welterweight (66kg) event, outclassing Uttarakhand's Kajal by a unanimous decision.

MANJREKAR ALL PRAISE FOR GILL, IYER Manjrekar calls Gill 'lambi race ka ghoda', rates Iyer's knock '10/10'

Former cricketer Sanjay Manjrekar picked Shubman Gill as the player who will be around for a long time in Indian cricket. Apart from Gill's masterclass, Manjrekar was also impressed by Shreyas Iyer's "flawless" stroke play and rated his belligerent 59(36) 10/10 on "quality."

Gill and Shreyas were in the vanguard of India's fourwicket triumph in the first ODI against England. When skipper Rohit Sharma and debutant Yashasvi Jaiswal left India in a mess at 19/2while chasing 249, Gill and Iver dug deep to keep the innings from falling apart.

With flawless technique and an unorthodox nature in their shots, Gill and Iyer raised a 94-run partnership to steer India out of a position when they walked on thin ice. While Gill, in course of his 87 (96), relied on his defensive prowess, Shreyas took



the brunt of scoring runs on his shoulders. With a wide array of shots and pictureperfect strokeplay, he maintained a healthy run flow. His swift expedition was brought to an end by Jacob Bethell, who pinned him right in front of the stumps at 59(36). For Manjrekar, it was the best inning that he saw from Shreyas. "I know it's just 58 for now. But that has to be Shrevas Iyer's best innings! Because of the sheer flawless nature of stroke play, the range of shots played & the relative orthodoxy of all his shots. On quality it was 10/10,"

Manjrekar wrote on X.

After Shrevas returned to the dressing room, Gill took the mantle to take India past the finishing line.

He perfectly blended defence and attack in his 87(96), leaving India a couple of steps away from victory.

"We had a term in the team 'Lambi race ka Ghoda' for certain players. Meaning someone who will be around for a long time in Indian cricket. That's what Shubman Gill is!" Manjrekar wrote on X. After sealing a 4-wicket win in the series opener, India will look to take an unassailable lead in Cuttack on Sunday.
