ongress Parliamentary Party Chairperson Sonia Gandhi's reaction to President Droupadi Murmu's address to the Joint session of the Parliament on Friday stoked a controversy. Her comments promoted to the Rashtrapati Bhawan to issue a rare statement which without naming Sonia Gandhi said the remarks were unacceptable.

The senior Congress leader said that the President "could hardly speak, poor thing."

"The President was getting very tired by the end... She could hardly speak, poor thing," Sonia Gandhi told reporters.

President Murmu's address kickstarted the Budget Session. Emphasising that the government is working on all-round development, President Murmu said that the country has only one aim which is to become a Vikshit Bharat (developed India) and the government is working with a "saturation approach" so nobody is left in the journey.

The BJP launched an allout attack on the Congress over its former chief Sonia Gandhi's remarks on Presi-

dent Droupadi Murmu's Parliament address, saying they were "deeply disrespectful" and underscored the opposition's "continued disregard" for the dignity of the highest constitutional office.

The Congress hit back and said every person in India has respect and empathy for President Murmu but BJP leaders cannot digest Sonia Gandhi's "empathy" for her

Will the BJP answer for the disrespect shown to President Murmu when she was not invited to the inauguration of Parliament or Ram temple in Ayodhya, the Congress asked.

In response to senior Sonia Gandhi's remarks, the Rashtrapati Bhavan, without mentioning her name called it "unacceptable"

and said it "clearly hurt the dignity of the high office."

The Rashtrapati Bhavan also clarified that President Droupadi Murmu was "not tired at any point", adding that President believes speaking up for the marginalised communities, for women and farmers can "never be tiring".

"While reacting to the media on the Hon'ble President's Address to the Parliament, some prominent leaders of the Congress party have made comments that clearly hurt the dignity of the high office, and therefore are unacceptable. These leaders have said that the President was getting very tired by the end and she could hardly speak," the Rashtrapati Bhavan

Finance Minister Nirmala Sitharaman on Friday tabled the government's pre-**Budget Economic Survey** that projected economic growth of 6.3-6.8 per cent in the coming fiscal.

Experts said the estimated expansion in economy is much lower than what is needed to become a developed country and the government needed to deregulate and implement reform in areas like land and labour to stimulate growth.

The state of the economy document, tabled in Parliament by indicated that India's growth is moderating and more needs to be done to achieve the near 8 per cent annual rate needed to achieve the Viksit Bharat target by 2047.

nakulam Rural district, a raid was conducted jointly by police and Anti-Terrorism Squad. As a part of that raid, 54 people were taken into custody from one lodge. They were brought to the police station and interrogated in detail. Finally, we could understand that 27 out of them were Bangladeshis.

He further said that arrested individuals hold Bangladeshi ID cards, birth certificates and passports. He informed that an FIR had been registered against them.







# 'Should not be falsely equated': MEA on report on rising extremism in UK

AGENCIES NEW DELHI

The Ministry of External Affairs, in response to the **UK Home Office Report** on rising extremism in the United Kingdom, has said that the nature of "separatist and extremism threat" in UK is "well known" and the report should not be "condoned and falsely equated".

This comes after UK media reports claimed a report mentioning about 'Hindu nationalism', 'Islamist extremism' and 'Khalistani extremism' regarding rising extremism in UK.

"Regarding UK we have some seen some reports on this particular matter. The nature of the separatist and extremist threat out of UK is well known I should not it

should not be condoned and falsely equated so that is our response," Randhir Jaiswal said in a press conference.

Talking about pending extradition requests of terrorists in Canada, Jaiswal said that there were approximately 26 pending extradition requests which have no update from their side.

"On the extradition request we have... 26 extradition requests pending which are pending there has been I don't have any update to share with you," he said.

weakest since the pandemic - and 8.2 per cent in the past 2023-24 financial year.

"Rural demand backed by a rebound in agricultural production, an anticipated easing of food inflation and a stable macro-economic environment provide an upside to near-term growth," said Chief Economic Adviser V Anantha Nageswaran, who along with his team in the finance ministry, authored the report.

The risks to India's economic prospects next year are balanced, he added.

Geopolitical and trade uncertainties, along with possible commodity price shocks, pose headwinds to the economy, said Nageswaran, who had last year predicted a 6.5-7 per cent GDP growth in the 2024-25 fiscal.

The survey said India needs to

grow at nearly 8 per cent over the next decade or two, and the investment rate must rise to 35 per cent of GDP from the current 31 per cent to meet the longer-term economic goal of a developed nation by 2047.

The IMF projects India to be a USD 5 trillion economy by FY28 and USD 6.3 trillion by FY3O, with an annual nominal growth rate of 10.2 per cent in USD terms.

Calling for reinvigorating the

internal engines of growth by enhancing economic freedom through deregulation, the report called for states to reduce the cost of compliance by liberalising standards and controls on businesses as well as cutting tariffs and feeds.

"Systematic deregulation is as critical, if not more, as investments in infrastructure and incentives to encourage innovation and create a viable Mittelstand i.e. India's SME sector," it added.

Earlier, Health and Family Welfare Department Principal Secretary to Government Harish Gupta said, "Supreme Court of India has recognised that the right to life under Article 21 of the Indian Constitution encompasses the right to die with dignity. To enable a dignified death, it has been held that life-sustaining treatment may be withheld or withdrawn (WLST) where the patient is terminally ill with no hope of recovery or is in a persistent vegetative state, and where the patient no longer benefits from lifesustaining treatment."

It has laid down guidelines to govern WLST, Additionally, the Supreme Court has recognised advance medical directives (AMDs) and laid down a procedure for execut-

ing and implementing them. "Supreme Court has held that if a patient is terminally ill and is undergoing prolonged medical treatment with no hope of recovery and cure of the ailment, and does not have decision-making capacity, then WLST may be appropriate, in accordance with the prescribed procedure. This may also be the case for those who are in a persistent vegetative state and when certain kinds of medical treatment may no longer provide any reasonable possibility of benefit, and may instead, have a greater potential to cause harm to the patient," Principal Secretary to Government stated. The order stated that the procedure for WLST laid down by the Supreme Court requires approval by the treating doctor.

The hospital where the patient is being treated must also set up the Primary and Secondary Medical Boards, comprising three registered medical practitioners each.

In a very rare incident, a pregnant woman's sonography revealed that a baby was discovered inside the stomach of an unborn child in the Buldhana district of Mahrashtra.

This is a case of a 'fetus in fetu', a condition where a parasitic twin develops inside its identical twin. It's characterized by a mass in the abdomen that resembles a fetus.

The case has been detected at a government hospital when a nine-month pregnant 32-year-old woman underwent a sonography in the hospital.

This detection was missed

the rarity of the case, said Dr Prasad Aggarwal, Gynecologist and Sonography Specialist at the District Women's Hospital in Buldhana.

"Two days ago, a 32-yearold woman came here for a regular checkup. She is 9 months pregnant. While doing sonography, I found that her unborn child was also carrying a child. We missed this in her earlier sonographies since this is the rarest of rare conditions," he said.

The condition is so rare that the total number of such cases in the world is only 100-200 while India hardly reports 10-15 such cases, the doctor said.

The woman has been re-

ferred to Chhatrapati Sambhaji Nagar for treatment, the doctor added. "After doing a detailed study and discussing it with other doctors, it was confirmed. The embryo inside her unborn child is not growing. She has been referred to Chhatrapati Sambhaji Nagar for treatment. There have been 100-200 of such cases in the world which came to light only after the birth of the child... In India, there are hardly 10-15 such cases...""Fetus in fetu" is a very rare medical condition where a malformed fetus develops inside the body of its twin. It's considered a parasitic twin where the "parasitic" fetus grows inside the body of the "host" twin.

# SC rejects plea for 'Urs' at demolished Dargah site in Gir Somnath

The Supreme Court on Friday rejected a plea seeking permission to conduct a religious procession (Urs) between February 1-3 at the site of a demolished Dargah said to be located at Guiarat's Gir Somnath.

A bench of Justices BR Gavai and Augustine George Masih took into consideration the submission of Gujarat authorities' that the land belonged to the government and unauthorised constructions, including the temples, were demolished.

Solicitor General Tushar Mehta, representing the



unauthorised constructions, including temples on the land belonging to the government, were demolished.

He said no activities, including Hindu religious rituals, were allowed on the land which was encroached upon earlier.

The petitioner's counsel said that the "Urs" festival was held at the site of the razed Dargah for many years but authorities on January 30 denied permission.

The counsel further said it was a structure made before 1299 AD. To this bench asked, "Is there a structure now?

The counsel mentioned that the structure was demolished and contended it was a protected monument.

"Whatever was unauthorised, is demolished. This is undisputedly a government land," the Solicitor General said, adding that the demolition drive applied to all religions. The apex court is seized of petitions, including a contempt petition, against the Gujarat authorities for allegedly demolishing residential and religious structures in Gir Somnath district without its prior nod. The petition was filed against a Gujarat High Court order by which a status quo on demolitions of Muslim religious structures was declined.

# SC asks Centre, Delhi govt stand over plea to amend OBC certificate rules

The Supreme Court on Friday sought replies from the Centre and the Delhi government on a plea seeking directions to amend rules for issuing OBC certificates to children of single mothers. A bench of Justices B R Gavai and Augustine George Masih passed the order on a plea filed by a Delhi-based

The plea said as per the guidelines issued by the re-

spondent authorities, an OBC certificate couldn't be granted on the basis of an OBC certificate of a single mother and an applicant had to produce such a certificate from the paternal

The petitioner claimed such an action by the respondents was clearly against the Constitutional provisions.

"The inaction on the part of respondents to issue OBC certificates to children of single mother on the basis of the Other Backward Class certificate

of their single mother are also in contravention of the rights of the children who belong to the Other Backward Class," said the plea, filed through advocate Vipin Kumar. The plea said it was also vio-

lative of the provision of the Constitution as the children of a single mother belonging to the SC or ST category were granted caste certificates on the basis of her certificate.

The plea said insistence on the father's OBC certificate or the paternal side by the authorities for issuing OBC certificates to children of single mothers was totally against the rights of children brought up by her.

The plea referred to the Delhi government's guidelines for issuance of OBC certificate.

It said as per the guidelines, any person residing in Delhi and wanting to apply for an OBC certificate, had to produce an OBC certificate of any paternal blood relative which included father, grandfather

Alice Vaz said.To facilitate voting, 13,766 polling stations have been set up across 2,969 polling premises. Of these, 733 polling stations are designated for persons with disabilities, Vaz said.

including 83.76 lakh men, 72.36 lakh women, and 1,267 individuals from the third gender will cast their ballot on February 5.

The Delhi Election Office has introduced several voter-friendly measures to ensure a smooth polling process. These include ramps, wheelchairs, medical teams, cr che services, themed polling stations, a queue management mobile application and a home voting option for senior citizens and persons with disabili-

Vaz emphasised that over 1 lakh polling personnel have been deployed, and all polling stations will have essential amenities under the Assured Minimum Facility (AMF) policy. These include waiting areas, drinking water, toilets, ramps, and wheelchairs. Paramedical staff with basic medical kits will also be stationed at polling centres.

To enhance voter experience, 210 polling stations will be set up as Theme-Based Model Polling Stations with additional facilities, she said.



Moreover, 70 polling stations -- one in each assembly constituency -- will be fully managed by women staff. Another 70 polling stations

will be operated entirely by persons with disabilities to promote inclusivity and an equal number of youth-centric polling stations will be voters, the CEO said.

# Gadkari pledges rapid development for Delhi under BJP



Union minister Nitin Gadkari on Friday vowed to transform Delhi's landscape if the BJP assumed power in the national capital after the February 5 polls.

Addressing a public meeting in Shalimar Bagh, the senior BJP leader claimed the saffron party did not seek to merely change the government but to transform the national capital.

"We don't just want to change the government ... We want to change the picture of Delhi ... Only the BJP can do this," he asserted.

Gadkari compared BJP-led governance to high-speed progress, asserting that Delhi's development would accelerate like a bullet train if the saffron party assumed



"If the BJP's engine is installed in Delhi, development will happen at bullet-train speeds," he remarked.

Addressing the issue of pollution, Gadkari pledged to make the city free from toxic air in five years.

"Delhi is not just the country's capital but also the heart of the people. This heart has developed an infection," he said, referring to the national capital's severe air pollution

Citing global rankings, he noted that 42 of the world's 50 most polluted cities were in India, with Delhi being the worst hit.

Gadkari -- the Union minister of road transport and highways -- acknowledged transportation as a significant contributor to the problem, with fossil fuels accounting for about 40 per cent of the city's pollution. "I accept that 40 per cent of the pollution happens because of my department." He also highlighted the Centre's waste management efforts, claiming that 20 lakh tons of garbage from the Ghazipur landfill had been used for road construction, reducing the height of the mound by

seven metres. "Can this situation not be changed?" he asked, asserting that the Centre had been actively working on addressing these challenges.

Discussing infrastructure development, Gadkari noted that since Prime Minister Narendra Modi took office in 2014, road projects worth Rs 65,000 crore had been approved for Delhi.

"We have completed work worth Rs 33,000 crore and, by December, work worth Rs 1 lakh crore will be done in NCR," he said.

The Union minister said key expressways, including the Delhi-Katra Expressway, would significantly ease congestion and expressed confidence that the Delhi-Mumbai Expressway would be completed before Republic Day next year.

Gadkari also emphasised efforts to clean the Yamuna, revealing that the Centre had provided Rs 6.000 crore to the Delhi government for the river's rejuvenation.

# SC asks NGO to identify Rohingya settlements in Delhi

The Supreme Court on Friday asked an NGO to tell the places of Rohingya settlement in Delhi and the facilities accessible to them.A bench of Justices Surya Kant and N Kotiswar Singh asked senior advocate Colin Gonsalves, appearing for NGO Rohingya Human Rights Initiative to file an affidavit indicating their plac-

es of settlement in Delhi. Gonsalves said the NGO

sought access to public schools and hospitals to Rohingya refugees as they were denied the access due to lack of Aadhaar cards.

"They are refugees having **UNHCR** (United Nations High Commissioner for Refugees) cards and therefore they can't have Aadhaar cards. But, for want of Aadhaar they are not being granted access to public schools and hospitals," he submitted.

The bench said since there were no aggrieved parties

At the end of the trading, the Nifty 50 was up 258.90 points or 1.11 per cent, at 23,508.40; on the other hand, the BSE Sensex was up 740.76 points or 0.97 per cent, at 77,500.57.

According to the market experts, the investor's sentiments will be influenced by the budget announcements in the coming days. The experts noted that the investors will be keenly watching the growth-stimulating initiatives like cuts in personal income tax, etc., in the budget announcements.

"The market is strongly reacting to results with good results being rewarded and poor results getting punished. This has spiked the market volatility. Fairly valued, highquality, large-cap financials

continue to be a safe sector for investors," said V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services.

"The budget--expectations and actuals--will influence the market today and tomorrow. Since we are going into the budget without a prebudget rally, the probability of a rally post-budget will be high if the budget delivers on growth-stimulating initiatives like cuts in personal income tax. But it is important to understand that the impact of the budget will last only for a few days, at best," said Vijayakumar.

Experts also highlighted that the medium- to longterm trend of the market will be dictated by GDP and earnings growth.

This reduction is attributed to lower planned capital investment spending and a higherthan-anticipated dividend from the Reserve Bank of India. The government aims to keep the budget deficit within 4.5% for the next fiscal year. # Govt's Rs 54 lakh cr capex yields weak private investment

The Indian government has spent over Rs 54 lakh crore on capital expenditure in the past 11 years, according to a report by Systematix Institutional Equities.

This includes the budgeted allocation of Rs 11.11 lakh crore for FY25. Despite this massive spending, the report added that the concerns over weak private investment and unemployment persist.

The report also highlighted that Rs 38 lakh crore of the total capital expenditure was allocated after the COVID-19 pandemic. In FY25, capital expenditure will account for 23 per cent of total government spending, reaching levels last seen in FYO4. Back then, India experienced one of its strongest nine-year private investment cycles.

However, the current situation is different, as private investment has not picked up, despite the govern-

# Gold hits record high

Gold prices soared to an all-time high of \$2,859 per ounce, surging 37% in a year, as investors flock to the metal amid economic uncertainties.

The rally follows a drop in US Treasury bond yields and concerns over former US President Donald Trump's tariff proposals, which could disrupt global trade. Lower bond yields make gold more attractive as a non-interestbearing asset, while trade fears drive investors toward safe-haven assets

Ajay Kedia, Director of Kedia Advisory, attributed the surge to declining bond vields and rising fears over future trade policies. Expectations of US interest rate cuts have further boosted gold's appeal, with Trump urging the Federal Reserve to lower rates.

In India, domestic gold prices rose Rs 500 to Rs 81,400 per 10g on MCX, with Rs 79,500 as key support and Rs 82.000 as resistance, said Jateen Trivedi, VP Research Analyst at LKP Securities.

# Core industries grow by 4 pc in December

The combined Index of Eight Core Industries (ICI) increased by 4.0 per cent (provisional) in December, 2024 as compared to the Index in the same period last year, according to a release by the Ministry of Commerce and Industry.

Aaccording to the Ministry, the production of Coal, Electricity, Steel, Cement, Refinery Products, Fertilizers and Crude Oil recorded positive growth in December 2024.

The ICI measures the combined and individual performance of the production of eight core industries viz. Coal, Crude Oil, Natural Gas, Refinery Products, Fertilizers, Steel, Cement and Electricity. The Eight Core Industries comprise 40.27 per cent of the weight of items included in the Index of Industrial Production

The final growth rate of the Index of Eight Core Industries for September 2024 in-



creased by 2.4 per cent. The cumulative growth rate of ICI during April to December, 2024-25 is 4.2 per cent (provisional) as compared to the corresponding period of last year.

Coal production increased by 5.3 per cent in December. 2024 from the last year same period. Its cumulative index increased by 6.2 per cent during April to December, 2024-25 over corresponding period of the previous year.

# Lower Brent prices to support margins for Indian fuel refiners: Fitch

Indian oil marketing companies' EBITDA will rise in the next financial year - 2025-26 -- as demand growth remains steady and Brent crude oil prices fall -- to USD 70 a barrel in 2025 and USD65 a barrel in 2026, said Fitch Ratings. EBITDA is earnings before interest, taxes, depreciation, and amortisation.

The global rating agency expects the oil companies' gross refining margins to hover around USD 5 per barrel to USD 6.8 per barrel and for marketing margins to remain healthy in 2025-26.

Brent crude is currently trading at USD 75.76 per barrel, publicly available data showed. The refining margins would be aided by lower crude oil prices, improving demand and slower net capacity growth. India Oil Corporation Ltd, Bharat Petroleum Corporation Limited, and Hindustan Petroleum Corporation Limited reported gross refining

margins of USD 3.7 per barrel to USD 6.0 per barrel in the first nine months of 2024-25, compared to the unusually high levels of USD 9.1 per barrel to USD12.1 per barrel in 2023-24. Fitch's Brent price assump-

tions reflect the impact of OPEC+'s large spare capacity, increasing global production and moderating demand growth. However, heightened volatility in crude prices given geo-political considerations, and uncertainties around how the US's future energy and tariff policies may have an impact on energy demand. Soon after assuming office, US President Donald Trump laid out an aggressive plan to maximize oil and gas production, including filling the strategic reserves. Besides, he declared a national energy emergency, besides withdrew from the international pact to fight climate change. Addressing virtually the World Economic Forum Davos, Trump called on Saudi Arabia and OPEC countries to lower oil prices.

# CHINA ARMS PAK'S SSG IN BALOCHISTAN RAISING ALARMS FOR INDIA'S SECURITY

t a practical, ground-level view, the recent reports suggesting that China is providing military and financial assistance to Pakistan's Special Services Group (SSG) in Balochistan and Khyber Pakhtunkhwa (KP) have far-reaching consequences. These regions, which are key to China's Belt and Road Initiative (BRI) through the China-Pakistan Economic Corridor (CPEC), have witnessed growing insurgency and instability. The local security forces in these areas, particularly Pakistan's SSG, have been struggling to manage the violence and unrest from groups like the **Baloch Liberation Army** (BLA), Tehrik-i-Taliban Pakistan (TTP), and other armed factions.

On the ground, this assistance translates into a much-needed boost for Pakistan's ability to conduct counter-insurgency operations. However, the bigger picture reveals complex geopolitical shifts—espefor the security dynamics in Pakistan, China, and India, with a focus on their local and immediate impacts.

### **CPEC SECURITY: GROUND-LEVEL REALITIES**

The China-Pakistan Economic Corridor (CPEC) has become the backbone of China's interests in the region, amounting to approximately \$62 billion in infrastructure investments aimed at connecting China's western Xiniiang region to Pakistan's Gwadar Port. On the ground in Balochistan, CPEC has brought both development and controversy. While the province holds immense natural resource potential and a critical maritime outlet at Gwadar, it is also plagued by ethnic separatism, insurgency, and political instability.

For local people, particularly the Baloch, CPEC is often viewed as a project that benefits China and Pakistan at their expense. The local insurgents, such as the BLA, regularly target CPEC infrastructure, foreign workers, and Pakistani military installations in an effort to disrupt the project. In the past few years, there have been several highprofile attacks, including the 2021 bombing targeting Chinese engineers working in Gwadar, which killed two Chinese nationals. On the ground, these at-

tacks are a clear indicator

of the fragility of security in Balochistan. With China's increased investment in Pakistan's security forces, especially the SSG, Beijing aims to protect its interests in CPEC. For example, the SSG is responsible for securing key infrastructure projects, but they often lack the advanced technologies and equipment necessary to deal with sophisticated insurgent tactics. Therefore, China's proposed support such as drones, surveillance cially for India. This analy- equipment, and advanced sis will break down what communication systems these developments mean—aims to give Pakistan the tools needed to keep these critical routes secure.

### **IMPACT OF CHINA'S SUPPORT ON THE SSG: TACTICAL AND OPERATIONAL CHANGES**

From a ground-level perspective, the SSG—Pakistan's elite special forces—are expected to see significant improvements in their operational capacity with Chinese assistance. The SSG already operates in some of Pakistan's most

difficult terrains, including the rugged mountains of Balochistan and KP. These are areas heavily affected by insurgent activity, including the TTP in KP and the BLA in Balochistan. Both groups have been using tactics like IEDs (improvised explosive devices) and guerrilla warfare to disrupt Pakistani security forces and foreign nationals.

On the ground, this translates into a difficult operational environment for the SSG. In the absence of modern equipment, the SSG has often struggled to track insurgents or effectively neutralize threats from the air or ground. However, with Chinese assistance, the SSG is set to receive technologies such as drones (e.g., Wing Loong II), which have the ability to conduct precision strikes in remote areas, and advanced surveillance systems for monitoring and tracking insurgent movegreater control over their resources and more autonomy from Islamabad. The increasing involvement of China in CPEC has only intensified these sentiments, as many Baloch believe that their land and resources are being used for the benefit of Pakistan and China, without their consent.

On the ground, this could mean an escalation in insurgent attacks. Local populations in regions like Gwadar or Quetta, who already feel marginalized, may see China's military support to Pakistan as a form of foreign occupation. This could lead to further radicalization and recruitment into insurgent groups like the BLA. In turn, Pakistan's increased reliance on SSG forcessupported by China-could lead to more confrontations with local insurgents.

The TTP, operating mainly in KP, is also likely to increase its activities. Historically, the TTP has had



At the local level, this will enhance the SSG's capability to gather real-time intelligence and execute surgical strikes against insurgents. For example, the use of drones will allow them to patrol vast, difficult-toreach areas without putting ground troops at risk. Additionally, Chinese support for infrastructure development will likely result in more secure military outposts and operational bases, giving the SSG a stronger presence in insurgent-dominated zones.

### **INSURGENT AND LOCAL REACTIONS**

The situation on the ground is not just about military strategies; it also involves the local populations and insurgent groups that have been fighting for autonomy or against what they see as foreign exploitation. In Balochistan, ethnic Baloch groups have long fought for

a cross-border presence in Afghanistan, and since the Taliban's return to power in Afghanistan in 2021, the group has regained strength. The TTP sees itself as a continuation of the broader Taliban insurgency in the region and has used the mountainous terrain of KP to conduct deadly attacks. For local civilians caught in the crossfire, the increased presence of the SSG could either stabilize or escalate tensions, depending on how the operations are conducted.

### INDIA'S **PERSPECTIVE:** SECURITY

**IMPLICATIONS** From India's standpoint, the ground-level implications of this increased Sino-Pakistani military cooperation are worrying. India has long viewed Pakistan's military collaboration with

China with suspicion, and the prospect of the SSGalready one of Pakistan's most elite units—receiving advanced military support from China is seen as a direct challenge to India's se-

### **INCREASED MILITARY CAPABILITIES FOR**

**PAKISTAN:** • For India, the enhanced capabilities of Pakistan's military, especially in counter-insurgency operations, could create new challenges along the Line of Control (LoC) in Jammu and Kashmir. The use of drones and surveillance systems by the SSG could be applied not just for internal operations but also for cross-border monitoring and intelligence gathering.

• On the ground, this means that Pakistan could potentially increase its monitoring and military presence along the LoC, which might heighten tensions in the disputed Kashmir region. The use of drones by Pakistan for surveillance or even targeted strikes could have significant implications for India, both in terms of border security and potential escalation.

### **AFGHANISTAN AND TALIBAN'S ROLE:**

• India is particularly concerned about the Taliban's growing ties with Pakistan and the possibility of the Taliban aligning with China. Afghanistan's position as a neighbor to India has always been crucial for Indian strategic interests, especially in terms of trade routes and

regional influence. • With the Taliban back in power, there is a real fear in India that Afghanistan could become a source of ban were to shift toward closer cooperation with India's adversaries—Pakistan and China—it could impact India's efforts to maintain security along its western frontier.

• On the ground in Afghanistan, this could lead to the Taliban becoming a conduit for supporting insurgent groups in Jammu and Kashmir or other regions in India. The prospect of a "proxy war" involving Taliban elements, Pakistan, and China is increasingly possible, and it would exacerbate on India's western border.

### **PROXY WARFARE IN KASHMIR:**

• Locally, in Kashmir, where insurgency has been simmering for decades, the possibility of Pakistan's enhanced military capabilities being used for proxy warfare or infiltration is a significant concern. The increasing presence of highly trained, better-equipped Pakistani forces in KP and Balochistan could be used to further infiltrate militants into Indian territory.

· This would make counterinsurgency operations even more challenging for India, as Pakistan could use its enhanced technological and military capabilities, funded by China, to launch more sophisticated and well-coordinated cross-border strikes.

### **CONCLUSION: A COMPLEX FUTURE AHEAD**

On the ground, China's support to Pakistan's Special Services Group represents a major shift in the military capabilities of the region. For Pakistan, this means better-equipped security forces capable of securing critical infrastructure and combating insurgency more effectively. However, this shift also has major consequences for regional security, particularly for India. For local populations in

areas like Balochistan and Khyber Pakhtunkhwa, the situation is one of increased militarization, with a higher likelihood of confrontations between insurgents and the SSG. The resulting escalation could destabilize the region further, while providing a larger strategic and military foothold for China destabilization. If the Tali- in South Asia. India's national security concerns are also at the forefront, with the potential for heightened border tensions and the spread of proxy warfare, especially in Kashmir. India will need to closely monitor these developments, adjust its security strategies, and bolster its own defense capabilities in response to this shifting balance of power. There is an ancient tradition of Kumbh Mela in Bharat. It is a little difficult to say when the organization of Kumbh Mela started, but it can certainly be said that it has a long and rich tradition. Currently, the Maha Kumbh organized in Prayagraj is the world's largest spiritual fair, in which about 50 crore people are expected to come. When

modern means of communication like TV, radio, newspapers, internet etc. did not even exist, even then lakhs of people from all over the country used to reach to participate in Kumbh on a fixed year and date. This is a symbol of the religious faith, spiritual vision and national unity of the Bharatiya people. Taking a bath in Kumbh, meeting sages and saints and getting their blessings and guidance, this has been a natural tendency in our country. But, Adi Shankaracharva gave the vision that there should be discussion and deliberation on knowledge in religious, spiritual events like Kumbh. In such events, saints and sages used to brainstorm and guide the citizens of the country from religious, spiritual and cultural point of view and used to show the path to strengthen the character and moral values of the society. Kumbh Mela was not just a gathering from spiritual and religious point of view, but it was also a collective event of reorganizing and rethinking the rules and codes to make new regulations according to the times to run the progress of the society and the nation smoothly after every twelve years and here new knowledge was also created from knowledge discussions. Similarly, in Gyan Maha Kumbh, people from the edu-

cation world of the country can gather and work to give direction to the education sector of the country to re-establish the Bharatiya knowledge tradition in accordance with modern requirements. With this goal in mind, Gyan Maha Kumbh is being organized by Shiksha Sanskriti Utthan Nyas. Just as Kumbh is organized at four holy places of the country (Haridwar, Prayag, Ujjain and Nashik), on the same format, before the Gyan Maha Kumbh, Gyan Kumbh was successfully organized in the four directions of the country, Haridwar, Nalanda, Puducherry and Karnavati (Ahmedabad). Getting inspired from those great men, this subject should be first made popular among the people of the education sector and later it should become a movement of the general public, this is the basic concept of Gyan Maha Kumbh.

It is a matter of joy that today the country has become the fifth economy of the world by striving towards material progress in many fields like information technology, space technology etc. However, this is only one dimension of development. But even today we are struggling with environment, moral values and character crisis etc. As a result of this, along with casteism, linguistic discrimination, malefemale, untouchability etc., we are also facing the challenge of problems like oppression of women, violence, communal tension etc., which are yet to be conquered. That is, only with the balanced coordination of both material development and spiritual development, the above problems can be resolved and steps can be taken towards becoming a world leader. In this way, the basis of balanced and holistic development of the country can be possible only by acquiring knowledge. The most powerful medium of acquiring knowledge is education. Education is the foundation of development of any country.

The 'Gyan Maha Kumbh' organised at Prayagraj Maha Kumbh is an initiative in this direction. It is said in the Bhagavad Gita that '\_na hi gyanen sadrisham pavitramih vidyate'\_i.e. there is nothing as sacred as knowledge in this

Kumbh is a small form of taking a step in this direction. In Kumbh, millions of people from the country and the world take bath together. They take prasad, food etc. together in the camps of saints and social organizations, then the problems of the country visible on the surface do not seem to exist there. This is the symbol of practical spirituality. Also, due to Kumbh, economic development of that area and its people is also seen. We can see and experience this coordination of materialism and spirituality in the Maha Kumbh organised at the Triveni Sangam of Prayagraj. What else can be the medium of coordinated and holistic development of the country by reestablishing Bharatiyaness through the organisation of Gyan Maha Kumbh? With this vision, along with crores of people taking a holy dip in the Ganga, people from the world of education should join the Gyan Maha Kumbh, take a dip in the Ganga of knowledge and pledge to revive the education in the country and together in their respective educational institutions, take forward the campaign from local to nationwide; this is the future direction of organizing the Gyan Maha Kumbh. 

# **ECONOMIC SURVEY 2024-25: GROWTH, WAGES, AND MARKETS**

Government schemes boosted household incomes, reduced inequality, and increased spending. Rural-urban consumption gap narrowed, benefiting lower-income groups through subsidies and welfare programs.



he Economic Survey 2024-25, presented in Parliament by Finance Minister Nirmala Sitharaman, highlights India's significant strides in economic and social development. The report emphasizes the government's dedication to empowering citizens through substantial investments in education, healthcare, skill development, and social infrastruc-

### **ENHANCED SOCIAL SECTOR INVESTMENTS**

Government expenditure on social services has risen from 23.3% in FY21 to 26.2% in FY25 (BE), marking a compound annual growth rate (CAGR) of 15%. The combined outlay by the Centre and States increased from Rs. 14.8 lakh crore in FY21 to Rs. 25.7 lakh crore in FY25 (BE). Notably, spending on education grew at a CAGR of 12% to reach Rs. 9.2 lakh crore, while health sector expenditure expanded at an 18% CAGR, totaling Rs. 6.1 lakh crore in FY25.

### LIFESTYLE FACTORS **AFFECTING PRODUCTIVITY**

The Survey raises concerns about the economic impact of long working hours and unhealthy lifestyle choices. Data indicates that individuals working over 12 hours a day report lower mental well-being, leading to productivity losses. The report also cautions against excessive junk food consumption, social media addiction, and sedentary lifestyles, recommending improvements in workplace culture and family-based interventions

to enhance mental health. Workplace stress, poor management relationships, and lack of job satisfaction contribute to increased absenteeism. With India's growing workforce, addressing these issues is crucial for sustained economic growth. The report references a WHO study estimating that 12 billion workdays are lost annually worldwide

due to mental health issues, translating into a \$1 trillion financial loss.

### **SURGE IN RETAIL MARKET PARTICIPATION**

The Survey highlights increased retail investor participation in equity markets, with the number of investors rising from 4.9 crore in FY2O to 13.2 crore by December 2024. The decoupling of the Indian stock market from global indices indicates resilience, with domestic institutional and retail investors providing market stability despite Foreign Portfolio Investors' (FPI) outflows.

However, the document warns of potential market corrections in 2025 due to high valuations and external uncertainties. Historical data suggests Indian markets remain susceptible to U.S. market fluctuations. emphasizing the need for investor caution.

### **NAVIGATING** AI'S IMPACT ON **EMPLOYMENT**

The Survey explores the evolving role of Artificial Intelligence (AI) in employment. While acknowledging concerns about AI-induced job displacement, it argues that proactive skill development can mitigate risks and enhance workforce productivity. India must create an average of 7.85 million nonfarm jobs annually by 2030 to sustain its workforce ex-

Corporate profitability reached a 15-year high in FY24, with profits soaring by 22.3%. However, wage growth lagged significantly, with employment rising by just 1.5%. The Survey raises concerns over income disparity and stagnant wages, especially in IT and entry-level positions. Chief Economic Advisor V. Anantha Nageswaran urged corporations to boost wages, emphasizing that wage stagnation could dampen domestic consumption and economic momen-

### **INFLATION TRENDS**

Retail inflation moderated from 5.4% in FY24 to 4.9% in April-December 2024, aided by monetary policies and government interventions. The Reserve Bank of India (RBI) projects inflation aligning with the 4% target in FY26. The financial sector remains stable, with commercial banks' gross non-performing asset (GNPA) ratio declining to 2.6% in September 2024.

### **GOVERNMENT AND OPPOSITION PERSPECTIVES**

Prime Minister Narendra Modi praised the Survey's findings, stating, "India's growth story is a testament

ple and the effectiveness of our policies. Our focus remains on inclusive and sustainable growth."

Finance Minister Nirmala Sitharaman reiterated the government's commitment to economic reforms and fiscal responsibility. "This Survey showcases India's economic resilience and long-term growth trajectory. Structural reforms and targeted social investments will continue to drive our economy forward," she said.

Opposition leaders, however, voiced concerns over wage stagnation and income inequality. Leader of Opposition in the Rajya Sabha, Mallikarjun Kharge, criticized the government's policies, stating, "Corporate profits have soared while wages remain stagnant. This is an unsustainable growth model."

In the Lok Sabha, Congress leader Rahul Gandhi echoed similar sentiments, arguing that "economic growth must translate into better wages and living conditions for all Indians, not just corporations."

### **EXPERTS' REACTIONS**

Industry leaders welcomed the positive outlook but stressed the need for sustainable wage growth. Sanjiv Puri, Chairman of

ITC Limited, remarked, "While corporate profitability is crucial, linking wages to profitability is not always feasible."

Economists offered mixed reactions, Suriit Bhalla noted the disparity in wage growth, while Rathin Roy emphasized the need for long-term policy interventions.

The survey also highlighted that while India Inc. has been reporting substantial profits, there is a reluctance to reinvest these earnings into the economy. This hesitation is seen as a barrier to achieving sustained economic growth.


Furthermore, the survey pointed out that despite a significant rise in patent filings and improvements in innovation rankings, India's investment in research and development (R&D)


remains low, particularly from the private sector. This underinvestment in R&D is identified as a critical area needing attention to bolster the country's innovation

As the Union Budget 2025-26 approaches, policymakers will need to balance fiscal prudence with measures that ensure equitable economic progress for all.

### **GOVERNMENT INITIATIVES**

The Survey underscores the positive impact of government schemes such as free or subsidized food grains, subsidized cooking fuel, insurance coverage, and Direct Benefit Transfers (DBT) on household incomes. These initiatives have contributed to reduced inequality and increased consumption spending. The Gini coefficient, a measure of inequality, declined in both rural and urban areas in 2023-24.

The Household Consumption Expenditure Survey (HCES) 2023-24 reveals a narrowing urban-rural consumption gap, with the Monthly Per Capita Expenditure (MPCE) growth being highest among the bottom 5-10% of the population. The urbanrural MPCE gap decreased to 70% in 2023-24, indicating improved rural spending ca-

Food subsidies under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) accounted for 6.5% of the Union budget in 2022-23, benefiting 84% of households with ration cards. The progressive subsidy pattern ensures greater benefits for lowerincome groups, strengthening food security and poverty alleviation efforts.

# **DELHI HIGH COURT: TRIAL COURTS MUST NOT MECHANICALLY** ADJOURN BAIL PLEAS OF UNDERTRIALS WHO COMPLETED **ONE-HALF OF MAXIMUM IMPRISONMENT | SECTION 479 BNSS**

he Delhi High Court in the case Suleman Samad Versus State Of NCT Of Delhi observed and has ruled that the trial courts must promptly pass orders and must not mechanically adjourn bail applications moved in cases covered by Section 479 of Bharatiya Nagarik Suraksha Sanhita, 2023, wherein the undertrial prisoners have already undergone one half of the maximum imprisonment.

The bench headed by Justice Swarana Kanta Sharma in the case stated that if in case a judge proceeds on leave, it must be brought to the notice of the concerned Link Judge that such cases are to be taken up on priority, either on the next date or

at the shortest possible date. The section 479 of Bharatiya Nagarik Suraksha Sanhita, 2023, states that where a person has, during the period of investigation, inquiry or trial, for offences not punishable with death or life imprisonment, has undergone detention for a period extending up to one-half of the maximum period of imprison- POCSO case.



The bench headed by Justice Swarana Kanta Sharma in the case stated that if in case a judge proceeds on leave, it must be brought to the notice of the concerned Link Judge that such cases are to be taken up on priority, either on the next date or at the shortest possible date.

The said proviso stated that where such person is a first-time offender, he shall be released on bail if he has undergone detention for the period extending up to one-third of the maximum period of imprisonment.

The court in the present matter was hearing the bail petition filed by a 60 year old man accused in a

The FIR was lodged which being on the basis of the complaint filed by victim's mother.

Last Year, the first and second bail applications of the accused were dismissed by the trial court.

It being the case of him that due to old age, he was suffering from various health ailments and had already undergone more than one and half years in jail. The court was also inpetition of the accused remains un-adjudicated before the Trial Court till date. The court also stated

that, 'It being discouraging to note that despite the mandate of Section 479 of Bharatiya Nagarik Suraksha Sanhita, 2023, BNSS, as noted above, and a report in this regard having already been sent by the Jail authorities and a bail application having also been moved, the learned Trial Court had adjourned the matter on several occasions in a mechanical manner, and even after recording on January 08, 2025 that the report qua the previous involvement of the accused had been received, a date of almost 20 days was given in the present case.

The bench headed by Justice Sharma directed the Trial Court to decide the bail application of the accused, in terms of Section 479 of Bharatiya Nagarik Suraksha Sanhita, 2023, BNSS, within seven days.

# Supreme Court sets aside judgement allowing Jharkhand residents who cleared CTET/TET from neighbouring states to apply for 2023 teacher recruitment

The Supreme Court in the case Parimal Kumar and Ors. v. State of Jharkhand and Ors observed and has set aside the judgement of Jharkhand High Court, wherein the court permitted the Jharkhand residents who had cleared the Central Teacher Eligibility Test, CTET or Teacher Eligibility Test, TET from neighbouring states to participate in the recruitment process for Assistant Teacher positions in Iharkhand.

The bench comprising of Justice JK Maheshwari and Justice Rajesh Bindal pronounced the judgement.

The court in the case stated that the impugned judgment based on the concession of the Jharkhand Advocate General amounts to changing the rules of the game after the commencement of the recruitment process in July 2023.

The court pronounced that, 'This court make it clear that CTET holders and state TET holders who applied after the judgement of the High Court or after the amendment of the Rules would not be eligible for the nize CTET as an equivalent

recruitment process of 2023. Background of the Case:

The Jharkhand High Court's ruling came in multiple writ petitions, which includes a Public Interest Litigation, PIL filed by Jharkhandi CTET Utteern Abhiyarthi Sangh and other qualified candidates seeking directions to the State Government to conduct the State TET, STET, which had not

been held since 2016. The petitioner in the plea contended before the court that the State's inaction had prevented approximately 3-4 lakh aspirants from participating in the recruitment process, as they did not possess a valid STET qualifica-

The petitioner argued before the court that the failure of the State to conduct the examination or recogqualification had led to the exclusion of many eligible candidates.

The attention of High Court was drawn to clause 10 of the Guidelines for conducting TET, which allows a state to consider the eligibility of candidates holding a TET certificate from another State or UT.

The court in the case noted that the State of Jharkhand had not conducted the STET for several years and directed the State to hold the exam annually.

The State Government, through an affidavit, raised concerns about regional language requirements, wherein it argued that the recruitment process should include stipulations ensuring that teachers are qualified to teach in local and tribal languages spoken in

# Supreme Court denies bail to Jharkhand-Based journalist Rupesh Kumar Singh in UAPA case

The Supreme Court in the case Rupesh Kumar Singh Versus State Of Jharkhand observed and has dismissed a Special Leave Petition filed against the order of Jharkhand High Court dated December 6, 2023, whereby the High Court denied bail to journalist Rupesh Kumar Singh in a case under the Unlawful Activities (Prevention) Act, 1967 over alleged links to the proscribed Communist Party of India (Maoist).

The bench comprising of Justice M.M. Sundresh and Justice Rajesh Bindal was hearing the present matter.

The bench in the case stated that this court was not inclined to interfere with the order of the High Court.

The petitioner in the plea stated before the court that he was an independent journalist and has been reporting on various social issues such as the protests of the displaced people, encounters by security forces

# Supreme Court reiterates: Magistrate's summoning order must reflect reasons the evidence brought on re-

The Supreme Court in the case M/S. JM Laboratories And Others Versus State Of Andhra Pradesh And Another observed and has quashed a non-speaking summoning order issued by a Judicial Magistrate against a drug manufacturer, wherein reiterating that a summoning order cannot be issued without recording valid reasons.

The bench comprising of Justice BR Gavai and Justice AG Masih was hearing the present matter.

The bench in the case was hearing an appeal filed by drug manufacturers assailing the correctness of the decision of Andhra Pradesh High Court, wherein the court refused to quash the summoning order issued against them in connection with the case registered under the Drugs and Cosmetics Act, 1940, hereinafter, 'DC Act' after a declaration by the government analyst that one of their drug samples namely MOXIGOLD-CV 625 was 'Not of Standard Quality'.

fore the court that a nonspeaking summoning order cannot be issued against them and that the summons should reflect a judicial application of mind, along with the recording of compelling reasons for issuing it.

The judgement authored by Justice Gavai, while setting aside the decision of High Court held the summoning order issued against the Appellants to be invalid due to the magistrate's failure to record reasons before issuing the summons

The court in the case emphasized that the issuance of the summon is a serious matter and it should not be issued unless the magistrate applied its mind to find out whether a prima facie case is made out against the accused.

The court referred to the case of Pepsi Foods Ltd. and Another v. Special Judicial Magistrate and Others and another case of Lalankumar Singh and Others v. State of Maharashtra, to hold that an order of issuance of process is not an empty formality. The Magistrate is required to apply

Foods Ltd. and Another v. Special Iudicial Magistrate and Others held that, 'Summoning of an accused in a criminal case is a serious matter. Criminal law cannot be set into motion as a matter of course. It being not that the complainant has to bring only two witnesses to support his allegations in the complaint to have the criminal law set into motion. The order of the Magistrate summoning the accused must reflect that he has applied his mind to the facts of the case and the law applicable thereto. Thus, he has to examine the nature of allegations made in the complaint and the evidence both oral and documentary in support thereof and would that be sufficient for the complainant to succeed in bringing charge home to the accused. It is not that the Magistrate is a silent spectator at the time of recording of preliminary evidence before summoning of the accused. The Magistrate has to carefully scrutinise

cord and may even himself put questions to the complainant and his witnesses to elicit answers to find out the truthfulness of the allegations or otherwise and then examine if any offence is prima facie committed by all or any of the accused.'

The court while considering the facts and circumstances of the case allowed the appeal and has set aside the summoning order along with the pending criminal case because the prosecution's case was barred by limitation as stated under Section 468 (2) of Code of Criminal Procedure, CrPC as the complaint was filed beyond the stipulated period of three years.

Accordingly, the court allowed the appeal.

# Supreme Court allows temporary allocation of fixed spot for meat vendors in Panjim

The Supreme Court in the case The Corporation Of The City Of Panaji Versus Mushtak Hussain Khatib observed and has allowed displaced meat vendors which is to be allotted fixed spots in a temporary fish market in Panjim, Goa after City Corporation's demolition of the building where the vendors were lessees for over 30 years.

The bench comprising of Justice BV Nagarathna and Justice SC Sharma was hearing the present matter.

The bench in the case was hearing the challenge to the Bombay High Court order, wherein the court directed

the Corporation of the City of Panaji, CCP to construct and maintain public markets and slaughterhouses, and to regulate all markets and slaughterhouses in the interim period, in the public interest.

The court issued the said directions in light of the demolition of the building where the respondents were carrying out trade operations.

The demolition was being carried out due to the dangerous and dilapidated condition of the building. Thus, here the shops of meat vendors were affected.

The CCP challenged the order, wherein it is contended that the direction is beyond the statutory ambit of the CCP under section 59 of The City of Panaji Corporation Act, 2002.

The section 59 (1) of The City of Panaji Corporation Act, 2002 states the CCP to take adequate measures for 'the construction and maintenance of public markets and slaughter-houses and the regulation of all markets and slaughter-houses.'

Before the court, the CCP submitted that as per its latest resolution of January 24, it has agreed to provide a fixed spot in the southeastern part of the temporary fish market to 6 meat ven-

The counsel appearing for the vendors argued before the court that the vendors be additionally permitted to install fridges, mincers, and mincing machines with electricity and water and that the area allotted be enclosed and secured.

The court while considering the facts and circumstances of the case observed and has permitted the same and clarified that such an allotment would be purely on a temporary basis.

The court in the case refused to interfere in the issues raised by non-meat vendors, thus, the court directed that the other vendors seeking to enforce their lease rights may file a civil suit.

The counsel, Sr Adv. Atmaram NS Nadkarni, and advocates Rohit Braz D'sa, S.S Rebello appeared for Meat Vendors.

The Supreme Court on January 30, 2025 relaxed the conditions to appoint ad hoc judges in High Courts.

The Supreme Court kept in abeyance the condition in its judgement dated April 2021 that ad hoc judges as per Article 224 of the Constitution of India can be appointed only if the vacancies are more than 20% of the sanctioned strength.

The Article 224A of the Constitution of India stated that the retired High Court judges can be appointed as High Court Judges.

The bench comprising of

Chief Justice of India Sanjiv Khanna, Justice BR Gavai and Justice Surya Kant was hearing the present matter.

need not be more than 20%

The bench in the case passed the said directions so as to ease the appointment of ad-hoc judges considering the high rise in the pendency of cases, especially criminal appeals.

In April 2021, in Lok Prahari through its General Secretary V N Shukla IAS (Retd) vs Union of India, the Supreme Court had issued directions for the appointment of ad-hoc judges in High Courts as per Article 224A of Constitution of India.

The Judgement stipulated that recourse to the appointment of ad-hoc judges under

Article 244A should not be made unless 80% of the sanctioned strength is already either recommended or working.

Last week, the bench headed by Chief Justice of India, CJI Khanna had posted the Lok Prahari case to revisit the con-

Further, the bench suggested that ad-hoc judges could be appointed as puisne judges in the 2-judge benches of the High Courts which deal with criminal appeals.

The bench in the case noted that the pendency in High Court cases has increased a lot. Thus, more than 62 lakh cases are pending in High Court, of which more than 18 lakh are criminal cases and 44 lakh are civil cases.

The court in its order stated: 'Having regard to the situation, this court is inclined to keep the observations from the conditions stipulated in paragraphs 43, 54 and 55 of the order and judgement dated April 28, 2021 that recourse to the appointment of ad hoc judges under Article 244A should not be made unless 80% of the sanctioned strength is already either recommended or working. In other words, the requirement that vacancies should not be more than 20% of the sanctioned strength for the time being shall be kept in abeyance.'

### **MANILA ARRESTS CHINESE SPIES**

MANILA: Suspected Chinese spies posing as Taiwanese tourists were arrested in the Philippines after allegedly taking photographs of Philippine Coast Guard ships, Taipei Times reported.

According to local media, the two suspects had been staying at a resort in Palawan, where they discreetly used their phones from a secluded location to record the comings and goings of coast guard vessels.Palawan is located near the Spratly Islands, a key area of dispute in the South China Sea, and tensions between China and the Philippines have escalated in recent years over territorial claims. The arrested suspects are also accused of using drones without authorisation and installing cameras on coconut trees at the resort to monitor the ships' activities.

Yarden Bibas, 35, was taken hostage separately from his wife, Shiri, and their children, Ariel and Kfir, who were also abducted from Kibbutz Nir Oz.

Hamas has claimed that Shiri and the two boys died while in captivity. While Israel has not officially confirmed their deaths, the officials have voiced "grave concern" for their safety. Yarden was reportedly injured at the time of his abduction, according to Times of Israel reported. According to Israeli

In August of last year, Israel announced that it had killed Mohammed Dief in a July 13 air strike in the Khan Younis area.In a post on X, IDF stated, "We can now confirm: Mohammed Deif

# Myanmar junta extends state of emergency on coup's fourth anniversary

Myanmar's military has prolonged its state of emergency for another six months as the country continues to struggle in maintaining control, with intense fighting continuing across the country, according to a report by Al Jazeera.

The military-led National Defence and Security Council decided to extend emergency rule during a meeting in Naypyidaw on Friday, just a day before the coup's fourth anniversary.

According to an official statement, all council members, including the commander-in-chief and the acting president, unanimously agreed to prolong emergency rule under Section 425 of the 2008 constitution."All members of National Defence and Security Council including the commander in chief as well

as acting president decided in unison for the extension of the state of emergency for another six months according to section 425 of the 2008 constitution," the statement said.

"There are still more tasks to be done to hold the general election successfully. Especially for a free and fair election, stability and peace is still needed," state-run MRTV said on its Telegram channel in announcing the extension of emergency rule, Al Jazeera reported.

Notably, on February 1, 2021, the military junta seized power in a coup ousting the elected government of Aung San Suu Kyi, a Nobel laureate.

Meanwhile, Amnesty International has urged the international community to take "urgent action" to ensure accountability for atrocities in Myanmar, ahead of the four-year anniversary of the 2021 military coup. According to Amnesty International, since the 2021 coup, Myanmar's military junta has killed more than 6,000 people, arbitrarily detained more than 20,000, and renewed judicial executions. Over 3.5 million people are internally displaced. Human rights groups have documented the military's torture and other ill-treatment of detainees, indiscriminate attacks, and the denial of humanitarian aid, which may amount to crimes against humanity and war crimes. "Myanmar's military junta

has carried out widespread and systematic attacks against the civilian population nationwide, bombing schools, hospitals, and religious buildings with total impunity. Armed groups fighting the military have also committed human rights violations.

According to Al Jazeera, Israel released the Palestinian prisoners after Israeli military confirmed the release of three Israelis, one male and two female, and five Thailand nationals. Israel had delayed the re-

lease of Palestinian prisoners and had asserted that the prisoners won't be freed until the "safe passage" of the hostages is "guaranteed in the next releases." "Prime Minister Benjamin Netanyahu, together with Defense Minister Israel Katz, has ordered that the release of the terrorists slated to be released today be delayed until the safe exit of our hostages in the next phases is assured. Israel demands that the mediators see to this," the Israel PM Office said in a statement.

Philippine President Ferdinand Marcos Jr. has proposed returning US Typhon missiles stationed in the Philippines if China ceases its aggressive actions in the South China Sea, Taiwan News reported.

Speaking ahead of a meeting with US President Donald Trump, Marcos made it clear that the Philippines' stance on the missile system is tied to China's behaviour in the disputed waters. Marcos' statement follows repeated calls from China for the Philippines to withdraw the Typhon missile system. Marcos questioned China's stance, saying, "I don't understand the comments on the Typhon missile system.

# German party could rely on far-right again for immigration vote

The man tipped to be Germany's next leader could rely on support from the far-right Alternative for Germany (AfD) party for the second time in a week, a move that has been widely condemned.

Friedrich Merz, the leader of the conservative CDU party, may need AfD votes to pass legislation toughening immigration laws.

Former chancellor Angela Merkel has accused him of turning his back on a previous pledge not to work with AfD in the Bundestag.

Merz has defended his actions as "necessary" and said that he had not sought

The White House said the intention was to modernise an outdated system and address a "catastrophic threat" that had become more complex as U.S. adversaries developed new delivery systems.

But Russian Foreign Ministry spokeswoman Maria Zakharova said the plan was aimed at undermining the ability of both Russia and China to exercise nuclear deterrence.

In the sharpest Russian criticism so far of a policy announced by Trump's new administration, she said that the planned U.S. move would hinder the prospects for talks on nuclear arms control - something that both Trump and Russian President Vladimir Putin have said

"The Iron Dome will further the goals of peace through strength. By empowering the United States with a second-strike capability, the Iron Dome will deter adversaries from attacks on the homeland."

Trump and Putin have both said they would like to meet face-to-face to discuss a range of issues, including the Ukraine war, but Moscow says it has yet to receive any signals from the U.S. on when and where such an encounter could take place.

# Canada and Mexico face 25% tariffs today, Trump says

US President Donald Trump has said he will follow through with his threat to hit imports from Canada and Mexico with 25% border taxes, known as tariffs, on 1 February.

But he added that a decision about whether this would include oil from those countries had not yet been made.

Speaking to reporters in the Oval Office, Trump said the move was aimed to address the large amounts of undocumented migrants and the fentanyl that come across US borders as well as trade deficits with its neighbours.

# CANADIAN REPORT FINDS NO PROOF OF INDIA'S LINK IN NIJJAR'S KILLING

This week, two significant funding in Canada creating news from Americas have sparked debates in the realms of global politics. On one hand, The US has placed a temporary hold on foreign aid to Pakistan for the purpose of reassessment, following an executive order from President Trump. This decision has led to an immediate cessation of several significant projects under the US Agency for International Development (USAID) in Pakistan, notably including the Ambassadors Fund for Cultural Preservation (AFCP), which serves as the primary initiative aimed at fostering the preservation and protection of cultural heritage. On the other hand, a report from a Canadian commission set by Trudeau himself has made shocking revelations as in how Trudeau's government is involved in promoting pro-Khalistani activities including

serious security challenges for India. Also, the report has again alleged India of interfering in Canada's elections inviting sharp reactions from Indian government.

This week, as previously mentioned by Rubio, the US has suspended foreign assistance to Pakistan for a reassessment in accordance with the executive order issued by Trump. Consequently, five initiatives in the energy sector have been halted. These initiatives include the Power Sector Improvement Activity, Pakistan Private Sector Energy Activity, Energy Sector Advisory Services Project, Clean Energy Loan Program, and Pakistan Climate Financing Activity. Additionally, four projects related to economic growth have also been affected.

mains uncertain, primarily due to the lack of clarity regarding the annual assistance the US is currently providing to Pakistan. Recently, Secretary of State Marco Rubio, while refraining from specifying any particular nation, had articulated while presenting the foreign policy roadmap under Trump 2.0 regime that the US would dechannelize international aid that it is providing to various countries presently towards its own people in the US. He had also asserted that "every dollar the US spends, every programme the US funds, and every policy the country pursues must be justified with the answer to three simple questions: Does it make America safer? Does it make America stronger? Does it make America more prosperous?" It could be made from here itself that the US would soon be suspending its financial aids that it provides to various countries. I think there will be more such announcements made in near future.

On the other hand, in a significant development, A Canadian commission report, initiated by Justin Trudeau, has presented some startling findings, notably indicating that there is no evidence connecting any foreign state to the assassination of Khalistani terrorist Hardeep Singh Nijjar. This conclu-

to previous claims made by Trudeau regarding India's involvement in the matter. Also, the report implied that the Trudeau administration has actively supported the Khalistan movement, including providing financial backing, which has contributed to challenges concerning India's internal security. This comprehensive report from Canada's Foreign Interference Commission spans seven volumes. Notably, on page 98 of the fourth volume, it acknowledges the validity of India's concerns regarding Khalistani terrorists, as cited by the Canadian intelligence agency. The report confirms that certain individuals residing in Canada are implicated in terrorist activities within India. Furthermore, it highlights that some of these individuals are financing terrorism from Canada, with funds being transferred to terrorists operating in India. Additionally, Canada has recognized that the presence of these Khalistani terrorists has contributed to the deterioration of relations between India and Canada.

However, the report also alleged India of interfering in Canada's elections. India has dismissed all such unfounded accusations. The Ministry of External Affairs (MEA) stated on Wednesday this week that it is, in reality, Canada that has been persistently meddling in India's domestic matters. The Canadian Commission's report claimed that following China, India was involved in meddling with Canada's electoral process. In response, MEA has asserted that it is, in fact, Canada that has consistently intruded into India's domestic affairs. Such interference has created an environment that enables

illegal migration and organized crime. The Indian government firmly rejected the allegations presented in the report regarding India's involvement and expressed its expectation that the systems allowing for illegal migration will no longer be accepted.

However, it is not difficult to comprehend the motivations behind the allegations made by the Trudeau government. This report references the elections of 2019 and 2021 as pivotal moments, marking the decline in Trudeau's political standing. In 2015, he successfully established a government with a full majority; however, by 2019, his popularity had waned, compelling him to govern as a minority. The situation deteriorated further in 2021, necessitating reliance on parties such as the NDP for critical legislative support. Subsequently, it appears that Trudeau has become increasingly fixated on appealing to the Khalistani vote bank. Currently, there is significant opposition to Trudeau within Canada, and the likelihood of his re-election appears minimal. This context may explain why he seems to be seeking justifications for a potential defeat even prior to the elections, invoking the names of various countries, including India, in his rhetoric.

Power can be a compelling force. When leaders lose sight of the fundamental purpose of their authority, they risk making critical errors that could ultimately jeopardize their position. I can only hope that this week serves as a reminder for leaders to focus on the responsibilities for which they are

Often you get to see the city of Mumbai in its real avatar, the streets, the chawls, the slums, the skyscrapers, the normal Mumbaikars, the good guys, the bad guys, and the Mumbai Police

tokeep you safe. Deva, a crime suspense thriller directed by Rosshan Andrrews, a wellknown Malayalam filmmaker with his Bollywood debut, opens with this very feel of Mumbai and keeps the audience fully engaged throughout

The film starts with an accident met by Inspector Dev Ambre (Shahid Kapoor), where he loses his memory bringing an investigation



to a halt he was leading to a halt. Believing him to be dead, the underworld and the rogues celebrate the event like Mumbaikars celebrate their festivals with drum and dance on the streets.

In the flashback now... Dev, a Mumbai cop known for his defiant hooligan style and always going beyond the law to ensure the law is dreaded by the bad guys. His senior DCP Farhan (Pravesh Rana),

and also a good friend and his brother-in-law hides this memory loss issue from the whole world and tries to uncover the truth behind the last words (he has solved the case) that he heard from Dev before the accident.

A dreaded gangster, Prabhat Jadhav, aka Prabhat Dada (Manish Wadhwa), always escapes from the clutches of Mumbai Police, gets arrested easily at rallies, and then conveniently escapes from jail, bluffing the cops again. This pattern is discovered by the crime reporter Diya Sathaye (Pooja Hegde). This theory

leads to a mole in the department that baffles everyone. In a bid to capture the crook,

many times many lives are lost from the Mumbai cops team that includes Diya's father, a constable in Mumbai Police too. The hunt for the capture of Prabhat Dada becomes intense and this time he is gunned down by Dev, and Dev gives the credit for the encounter to his best friend ACP Rohan D'Silva (Pavail Gulatie). On Maharashtra day, while receiving the medal, Rohan is shot dead, and Dev vows to catch the culprit and asks for a free hand while leading the investigation. While investigating and narrowing down to solving the case Dev meets with the accident, which leaves

It is said that a daily consumption of > 300 mg of caffeine has been associated with shorter menstrual cycle length. These women are more likely to ovaries from releasing eggs regularly.

• Pregnancy: Caffeine readily crosses the placental barrier in pregnant women and the baby inside is exposed to the same caffeine levels as the mother. Exposure to excess caffeine has also been shown to have an impact on placental blood flow. Both factors may increase the risk of miscarriage, premature delivery. low birth weight, small for gestational age and even still birth. The Royal College of Obstetricians & Gynecologists U.K. recommend that you limit your caffeine intake to as little as possible during pregnancy to less than 200 milligrams (mg) per day. This means two mugs of instant coffee per day as an average cup of coffee contains approximately 100 mg of caffeine.

• Fertility treatment : Caffeine may reduce the chance of assisted reproduction procedures (such as IVF) being successful though it is not very clear as yet.

### • Lower sperm quality in men: Caffeinated beverages can reduce sperm motility. and count. This can impair their ability to fertilize an egg. Poor sperm health can make conception a challenging process for the couple.

Thus, it is imperative to recognize and understand the potential side effects of high consumption of caffeine on fertility and make necessary adjustments in your dietary choices to protect your reproductive

### Caffeine does more harm to your body than good.

The European Food Safety Authority (EFSA) recommends pregnant women and those desiring to conceive to keep their daily caffeine consumption below 200 mg, while WHO recommends a daily caffeine intake below 300 mg.

Couples who are trying to conceive are advised to limit their caffeine intake for the betterment of their chances of conception. Moderation is the key.

In the Bhagavad Gita, Krishna and Arjuna have a spiritual dialogue on the battlefield of Kurukshetra. At the end of Krishna's sermonising, Arjuna, who was hitherto reluctant to fight his own kin, realises the true nature of things and picks up his bow to fight the Kaurava army.

They forget that the Mahabharata, of which the Gita is a part, extols abstention from violence as the highest form of religion, the greatest penance, the best sacrifice, and the supreme truth.

The question of whether it is right to use any means, including violence, for what one considers a noble cause has exercised human minds for long. There may be many situations which present a moral dilemma, wherein one has to choose between employing the wrong means for the right cause, and seeing one's cause suffer.

When we think about it. we realise that violence, which is evil, can never be justified. Violence may appear to be an immediate or easy solution to a problem, but it ends up sowing the seeds of bigger problems. How the

# INDIA STORM INTO FINAL, DEFEAT ENGLAND BY 9 WICKETS first-ever final

n a stunning display of controlled bowling and clinical batting, India emerged victorious over England by 9 wickets in the second semi-final of the ICC Women's U19 T20 World Cup 2025 at the Bayuemas Oval in Kuala Lumpur on Friday, sealing their spot in the final.

The Indian team, defending champions in the tournament, chased down a modest target of 114 with five overs to spare, showcasing their dominance throughout the match.

England, after winning the toss and opting to bat, got off to a promising start with their openers. Davina Perrin played an aggressive knock, top-scoring with 45 runs. Alongside her, Jemina Spence contributed 9 runs. However, the tide turned quickly when the Indian bowlers, led by Parunika Sisodia and Vaishnavi Sharma, picked up quick wickets and reduced England to a total of just 113 runs.

Sisodia was the standout bowler for India, taking 3 wickets for 21 runs, while Sharma supported well with 3 wickets for 23 runs. Aayushi Shukla also played a key role, dismissing England's captain, Abi



Norgrove, and leaving the opposition in trouble.

The Indian batting chase began solidly, thanks to openers G Kamalini and Gongadi Trisha. Kamalini, who remained unbeaten on 56, steered India towards victory, while Trisha contributed with a steady 35 runs. Despite the loss of Trisha, India was never in doubt, and Sanika Chalke joined Kamalini to finish off

the target with composure. India's bowlers had their task cut out from the beginning, as they were up against a resilient English lineup. However, the spin attack, led by Sisodia and Sharma, was too much for England to handle. The English team struggled to build partnerships and were continuously under
