S President Donald Trump has paused military aid to Ukraine after the Oval Office clash with Ukrainian President Volodymyr Zelenskyy last week, Fox News has reported.

According to Fox News, the Trump administration is pausing all aid to Ukraine, including weapons in transit or in Poland, until Ukrainian leaders show more appreciation for the US support and a commitment to peace.

A senior Trump administration official told Fox News that military aid will remain on hold until Ukrainian leaders show a commitment to good faith peace negotiations.

"This is not permanent termination of aid, it's a pause," a senior Trump administration official emphasized. "The orders are going out

SKM CONDEMNS PUNJAB POLICE ACTIONS ON FARMERS, CALLS MOVE 'DICTATORIAL' Demands immediate release of leaders, calls for massive protest on March 5

The Samyukt Kisan Morcha (SKM) has condemned the Punjab government's midnight crackdown on farmer leaders, calling it a dictatorial move to suppress their democratic right to protest.

The farmers' body has even warned Prime Minister Narendra Modi and Chief Ministers following authoritarian practices that police action will not weaken their struggle for key demands like legal guarantee of Minimum Support Price (MSP) and repeal of National Policy Framework on Agricultural Marketing (NPFAM) and a comprehensive loan waiver. Several farmer leaders were "detained" or put under "house arrest" after early Tuesday morning "raids" at their residences by the Punjab police ahead of their planned protest in Chandigarh on March 5.

According to farmer leaders the police also raided the residences of senior farmer leaders Joginder Singh Ugrahan, Raminder Singh Patiala, Buta Singh Burjgill, Harinder Singh Lokhowal, Satnam Singh Ajnala, Gurmeet Singh Mehma, and Rajinder Singh Deep Singh

The raids were followed as a meeting between Chief Minister Bhagwant Mann and farmer leaders associated with the SKM remained inconclusive and the farmer leaders appreciated Punjab government for passing a resolution in the Punjab Assembly against the NPFAM. However, when farmer leaders insisted on their long-standing demandsincluding legal MSP and a loan waiver—the CM abruptly ended the meeting and walked out.

Following the police crackdown, SKM has called upon farmers across Punjab to participate in the "Pakka Morcha" in Chandigarh on March 5 and to organize massive village-level campaigns against the Punjab government's actions.

SAD slams Mann govt over pre-dawn swoop on farmers

Senior Shiromani Akali Dal (SAD) leader Bikram Singh Majithia today demanded the immediate release of farmer leaders who had been arrested at the instance of chief minister Bhagwant Mann besides asking the chief minister to apologize to the leaders for threatening and misbehaving with them during an official meeting yesterday.

Expressing shock at the

manner in which leaders of

the Samyukt Kisan Morcha, who had been invited for talks by the chief minister yesterday were being treated, Mr Bikram Majithia said "Mr Bhagwant Mann threatened the Kisan leaders with dire consequences when he was reminded of the promises he had made to farmers before assuming charge as chief minister in 2022". He said this was followed up with raids and arrests of Kisan leaders in a pre-dawn swoop today in a bid to foil the March 5 Andolan announced by them.



Asserting that the chief minister's consistent erratic behaviour was spoiling the image of Punjab and Punjabis, Mr Majithia said "recently during a visit to Hoshiarpur the chief minister misbehaved with an IPS officer besides speaking rudely with the Deputy Commissioner. His earlier acts of instability are well documented including his drunken antics onboard a Lufthansa plane from which he was deboarded".

Reminding Mann about the promises made by him to farmers, the Akali leader said "Mann assured farmers and farm labourers that the Aam Aadmi Party (AAP) would remodel farm policies to ensure no farm suicide occurred in the State. He also assured farmers that farm income would be doubled and that his government would implement the Swaminathan Report whether the centre did that or not. Farmers were also assured that every crop would be procured by the State on minimum support price". Asserting that the chief minister had reneged on each and every promise made to the farmers, Mr Majithia said "when he was reminded of these promises he started threatening the farmers and walked out of the meeting rather than face them".

BJP set to announce new national president after April 18

The Maha Kumbh in Prayagraj has also impacted the election of the BJP's National President. Due to the Kumbh, the organizational elections in Uttar Pradesh were delayed, and now it is expected that a decision regarding the new Uttar Pradesh President will be made after Holi this month. Meanwhile, the election for the state president in Bihar was completed on Tuesday, with Dilip Jaiswal elected as the new president. So far, only 14 states have completed their BJP organizational elections. With 36 states needing to elect their state presidents, there is still

a long way to go. The election of the national president will begin only after are concluded. BJP has announced that the National Executive and National Council meetings will take place in



Bengaluru, Karnataka, between April 18th and 20th. During this time, the election for the new national president will be held, replacing current president JP Nadda. Before this, Prime Minister Narendra Modi and RSS chief Mohan Bhagwat will have a final meeting to decide on the new president, which is likely to occur after Holi.

An important meeting of the RSS is also scheduled for the third week of this month. which may help finalize the decision. Several prominent names are being discussed for the post of national presi-

dent, including Union Minister Dharmendra Pradhan, Bhupendra Yadav, Shivraj Singh Chauhan, Manohar Lal Khattar, G Kishan Reddy, and D Purandeswari from the South. However, the name for the president will only be announced after the completion of the state elec-

The BJP had originally planned to complete its or-Ianuary, but they were repeatedly postponed. Even in Hindi-speaking states, like Uttar Pradesh, elections were delayed, and this has caused

confusion within the party. The election in Bihar was finally held on Tuesday, but the situation remains unclear in states like Madhya Pradesh. The delay in Uttar Pradesh is particularly significant because it would have sent the wrong message if the national president election proceeded without completing the state elections, especially in such an important state. The delay in Uttar Pradesh's elections was mainly due to the Maha Kumbh, which had been a major focus for Chief Minister Yogi Adityanath. The Kumbh was completed successfully with minimal issues, earning praise worldwide for its organization. Now that the Kumbh has concluded, the party's focus has shifted back to completganizational elections in ing the organizational elections, and it is expected that all remaining state elections, including those in Uttar

the unemployed, youth, farmers and women. The budget has been announced keeping elections in the mind."

CEC directs officials to hold all-party meet regularly to resolve issues

Chief Election Commissioner (CEC) Gyanesh Kumar on Tuesday directed officials to be approachable and responsive to political parties, and all-party meetings at all statutory levels be held regularly to resolve any issues within the existing statutory framework by the concerned competent authority.

The Election Commission on Tuesday kicked off a twoday conference of CEOs of all States and Union Territories at New Delhi. This is the first such conference to be held since Gyanesh Kumar assumed charge as CEC.

ECI in an official statement said that CEC and ECs Sukhbir Singh Sandhu and Vivek Joshi interacted with CEOs on a series of topics that will pave the way for improvements in election management in the country within the established legal framework. In his address, CEC Gyanesh Kumar exhorted all officials including all CEOs, DEOs, EROs, BLOs across the country to work transparently and fulfill all statutory obligations diligently and as per the existing legal framework i.e. the RP Act 1950 and 1951; Registration of Elector Rules 1960, Conduct of Election Rules 1961



and the instructions issued by ECI from time to time.

He directed officials to be approachable and responsive to political parties. He added that all party meetings at all statutory levels be held regularly to resolve any issues within the existing statutory framework by the concerned competent authority, i.e. ERO or DEO, or CEO. The issue-wise action taken report by each CEO is to be submitted by March 31, 2025, to their concerned DEC, it said. He emphasized that all CEOs, DEOs, ROs, EROs, should be thorough with their roles and responsibilities, as clearly delineated within the statute and ECI instructions. He added that officials should ensure that all citizens of India who are above 18 years of age are registered as electors as per Article 325 and Article 326 of the Constitution.



The upcoming AICC meeting of Congress, scheduled for April 8th and 9th in Ahmedabad, is being viewed as crucial for the party. The meeting is taking place at a time when the Congress faces questions about its organizational strength af-

ter several setbacks in state elections. The party's recent defeats in Haryana, Maharashtra, and Delhi, where it failed to improve its position for the third consecutive time, have raised concerns. These losses came after the party had seemed to make a comeback by securing 99 seats in the 2024 general elections, but the subsequent defeats returned it to its previous position.

In response to these setbacks, the party held a meeting of general secretaries last month, where it was decided that the AICC meeting would be convened after discussing strategies to strengthen the

organization. The official announcement for the upcoming meeting was made by Organization General Secretary KC Venugopal on Tuesday.

The Congress is facing a tough challenge, especially with important state elections coming up. Bihar is set to hold elections later this vear, and states like Kerala and Assam will go to the polls next year. In light of these challenges, the party has started a series of meetings to strategize for these elections. However, the bigger concern remains how to win with a weak organizational structure and ongoing factionalism.

China slaps reciprocal duty

be imposed on US chicken, wheat, corn, and cotton, plus 10 per cent tariff on soybeans, pork, beef, and dairy from March 10.

A spokesperson from the Chinese Commerce Ministry said that Beijing "will take countermeasures to firmly safeguard its own rights and interests," Chinese state news agency Xinhua reported.

The spokesperson said US' "typical act of unilateralism and bullying in disregard of facts, international trade rules and the voices of all parties.'

As per a report in the New York Times, China's Ministry of Commerce has also singled out 15 companies from the United States, including the drone maker Skydio, for punitive trade measures to "safeguard national security and interests."

The NYT reported that Beijing has has

added 10 other American companies to what it calls an "unreliable entities list," preventing them from doing business in China.

The steps include levies on US food imports and halting the sale of Chinese goods to 15 American companies.

Xinhua cited a Chinese government spokesperson as saying "We hope the US can work in the same direction as China and find a solution through equal-footed consultation." A 25 per cent US tariff on goods imported from Canada and Mexico took effect just after midnight on Tuesday, along with an additional 10 per cent tariff on goods from China.

On Monday (local time) Canadian Prime Minister Justin Trudeau had announced that retaliatory tariffs on US goods will go into force at midnight on Tuesday if the US tariffs on Canadian imports take effect.

CM Gupta slams AAP's health model, calls it 'zero'

Delhi Chief Minister Rekha Gupta on Tuesday attack the previous Aam Aadmi Party (AAP) government's health model, calling it "zero" and alleging large-scale mismanagement at government hospitals during AAP's tenure. During a visit to the Guru Teg Bahadur (GTB) Hospital, Gupta claimed the facility has turned into a "dumping ground" with unused medical equipment and incomplete hospital infrastructure.

"Since the Covid-19 pandemic, the warehouse here has been completely filled. Even today, 458 oxygen concentrators, 146 ventilators, 36,000 PPE kits, multipara monitors, masks, and other medical supplies are lying unused. This is not just the case with GTB Hospital, but with many hospitals across Delhi," Gupta alleged.

She also claimed that

hospital buildings were proper planning, leading to wasteful expenditure.

"AAP built seven structures inside hospitals, turning parking lots and sports grounds into buildings that do not meet the medical facility parameters. These so-called 'semipermanent structures' are only 60 per cent complete, and they will not be of any use even if Rs 2,500 crore more is spent on them." she said

The chief minister also alleged that hospital staff had not been paid their salaries for six months.



RBI will have to cut CRR to ease banking liquidity: SBI Report

The Reserve Bank of India (RBI) will have to cut the Cash Reserve Ratio (CRR) to ease the prevailing liquidity pressure in the banking sector, according to a report by State Bank of India (SBI) research.

The report highlighted that with unchanged ownership in government securities (G-secs) in the financial year 2025-26 (FY26), the Open Market Operations (OMO) gap could still be around Rs 1.7 trillion. This suggests that additional liquidity measures may be required on a sustained basis. It said "Liquidity Estima-

tion; CRR cut is necessary to ease the pressure, RBI could look into using CRR more as a regulatory intervention tool / countercyclical liquidity buffer rather than as a liquidity tool in future". According to the report, RBI should explore using CRR more as a regulatory



intervention tool or a countercyclical liquidity buffer, rather than relying on it as a liquidity tool in future.

The current liquidity conditions, combined with the projected OMO gap, underline the necessity of proactive measures to maintain stability in the financial system. The report also called for a reassessment of RBI's existing liquidity management framework. It suggested replacing the Weighted Average Call Rate (WACR) as the policy rate, arguing that it does not effectively serve its intended purpose.

The current framework, according to the report, may need modifications to align with evolving market conditions and liquidity requirements.

The Indian banking system's liquidity has seen its worst liquidity crunch of more than a decade. The system liquidity moved from a surplus of Rs 1.35 lakh crore in November to a deficit of Rs 0.65 lakh crore in December, further to Rs 2.07 lakh crore deficit in January and Rs 1.59 lakh crore in February.

Unchecked freebies are a luxury India can no longer afford: Experts

A surprisingly candid consensus emerged at this year's Anil Agarwal Dialogue (AAD) 2025, where top policymakers warned that India's decades-old practice of providing free water and electricity - especially in agriculture - is economically unsustainable and environmentally perilous. In a panel discussion that flew under the national news radar, former NITI Aayog CEO Amitabh Kant and ex-Planning Commission Deputy Chair Montek Singh Ahluwalia urged a radical policy shift: start pricing these precious resources realistically, or risk irreversible crises. Their rare bluntness at an environmental journalism conclave has spotlighted an underreported economic trend with far-reaching implications for India's future.

During a high-profile panel on "Anti-environmentalism in a Climate-risked, Deglobalised World" at AAD 2025, Amitabh Kant openly

luwalia's contention that water must no longer be treated as a free infinite good. "I entirely agree with Mr. Ahluwalia when he said that water needs to be priced," Kant remarked. He rattled off stark facts to support this stance: India holds 17% of the world's population but just 4% of its water resources, and a staggering 90% of India's water is consumed by agriculture, much of it squandered on water-intensive crops grown with little oversight. "Rice and sugarcane is consuming all your water," Kant noted, adding that India is effectively "exporting virtual water in the name of Basmati rice" through its agricultural exports.

Currently, many state governments supply farmers with electricity at no cost to pump groundwater, and urban populist schemes promise free water and power to households. These policies, while politically popular, have encouraged over-extraction of groundwater and fiscal stress. Kant

"Everybody's got used to free dose (freebies)... if you keep getting free dose, you will make the country go bust," he cautioned, using an colloquial Hindi-inflected term for handouts. or power has long been a vote-winning formula in India, and few in power openly question it. That's what made the AAD dialogue stand out: two of India's veteran policymakers essentially urged leaders to reverse course on freebies, even if it's politically difficult. This viewpoint

remains rarely reported in mainstream coverage, which often skirts around the long-term costs of populist subsidies.

Yet the evidence is mounting that the status quo is untenable. Insiders have known the truth for years - a senior Haryana Irrigation Department engineer admitted almost a decade ago that while giving farmers free water and power "makes sense" to help the poor, "it's also not sustainWhat's new is the level of

urgency and profile of voices calling for change. Ahluwalia and Kant's comments highlight an underappreciated economic fault line: India's water and power giveaway is undermining both environmental security and public finances, a story often overshadowed by flashier headlines.

At AAD 2025, the experts provided context that makes this reality hard to ignore. Kant pointed out that many Indian states are effectively on the brink of a water bankruptcy aquifers are depleted and utilities drowning in debt - even as the public remains addicted to freebies. In Punjab, for instance, the cost of "free" power for irrigation has piled up enormous bills. In 2020, Punjab owed over \$1 billion to electricity providers just to subsidize farm power for groundwater pumping - an amount twice the state's health budget and four times its transportation budget.

Such hidden liabilities, replicated across multiple states, threaten to crowd out essential development spending. This is the creeping crisis that rarely makes front-page news.

As Kant noted, when states give agriculture essentially free electricity. they often compensate by charging higher rates to industry and commercial users, or by accumulating debt. Indian manufacturers consequently face some of the highest electricity tariffs in the world, undermining competitiveness. Unreliable supply (due to rationing power for farms) further hobbles productivity. Water-intensive industries and investors in sectors like food, beverage, textiles. and power generation are similarly exposed. Today's "free" water policies mask the true risk and value of water. If aquifers run dry or governments abruptly enforce usage curbs, companies could face operational crises. Conversely, if India heeds the experts'

advice and moves toward pricing water and electricity, it could unlock new opportunities. Speakers at the event stressed that some success models exist. Cities like Indore and Surat have shown that better waste and resource management is possible with committed local governance (both cities dramatically improved sanitation and water management in recent years). Internationally, Singapore is a shining example frequently cited by Kant: decades ago it instituted steep water pricing tied to consumption - those who use more, pay more - and invested heavily in recycling and desalination. The result is a city-state that leapt from water insecurity to water adequacy while its per capita income soared from \$600 in the 1960s to \$90,000 today.

"That's not been done on populism, that's been done on very solid political governance, including pricing of water," Kant observed, implying India could learn from this template.

THE CONTROVERSY OVER CHINA'S PROPOSED EMBASSY IN LONDON

LEGAL, SECURITY, AND HUMAN RIGHTS IMPLICATIONS

The proposed establishment of the largest Chinese embassy in Europe, located in London, has sparked significant controversy. Protesters and policymakers have raised concerns regarding national security, human rights, and surveillance risks associated with the project. In this light, this article examines the legal and diplomatic implications of fortifying embassies, the obligations of host states under international law, and the broader geopolitical ramifications of China's expanding diplomatic footprint in Europe. By analyzing key international legal instruments such as the Vienna Convention on Diplomatic Relations (VCDR) and the

International Covenant on

Civil and Political Rights



(ICCPR), the authors explore the tension between diplomatic privileges and state sovereignty in an era of increasing international surveillance.

Embassies serve as critical links for international diplomacy, facilitating communication between nations while ensuring the protection of diplomatic personnel. However, the size and security of embassies have become contentious issues, especially considering global political tensions. The proposed Chinese embassy in London, if approved, would be the largest of its kind in Europe. While China argues that the new facility is necessary to manage its growing diplomatic responsibilities, critics warn that the embassy's scale and


potential for intelligencegathering pose significant risks to national security and civil liberties.

THE LEGAL **FRAMEWORK GOVERNING DIPLOMATIC MISSIONS**

International law provides a framework for the establishment and protection of diplomatic missions. The Vienna Convention on Diplomatic Relations (VCDR), 1961 mandates host states to protect foreign embassies and their personnel. However, it does not prescribe specific standards regarding embassy size, infrastructure, or reciprocal obligations between states. The absence of clear legal guidelines has led to increasing tensions as some states seek to expand their diplomatic missions beyond traditional consular functions.

Under Article 22 of the VCDR, the host state must ensure the security of foreign embassies, preventing attacks or unauthorized intrusions. However, the growing role of embassies in intelligence and cybersecurity operations has blurred the lines between diplomatic and security concerns. The Chinese embassy project raises questions about whether existing legal frameworks are sufficient to address modern geopolitical challenges.

FORTIFICATION OF EMBASSIES:



SECURITY VS. SOVEREIGNTY

The fortification of embassies refers to the physical and structural measures taken to secure diplomatic premises. These measures. while essential for the safety of diplomats, can also raise sovereignty concerns if they exceed reasonable security requirements. The planned embassy in London is expected to be heavily fortified, reflecting both the geopolitical sensitivities surrounding China's global influence and the increasing threats faced by diplomatic

In past cases, heavily fortified embassies have been criticized for functioning as intelligence hubs rather than purely diplomatic spaces. Critics argue that China's increased engagement in Europe has led to concerns over surveillance and cyber espionage. Given the lack of international legal standards on embassy infrastructure, host states must balance their obliga-

tions to protect diplomatic missions with their duty to safeguard national security and civil liberties.

HUMAN RIGHTS AND PRIVACY CONCERNS: THE ICCPR

PERSPECTIVE The expansion of diplomatic premises has implications beyond state security; it also affects individual rights and privacy. The International Covenant on Civil and Political Rights (ICCPR) establishes fundamental protections against arbitrary surveillance. Article 17 of the ICCPR states that "No one shall be subjected to arbitrary or unlawful interference with his privacy, family, home or correspondence." This provision underscores the risks posed by large-scale foreign surveillance operations conducted under the guise of diplomatic functions.

WAY FORWARD

The controversy surrounding the proposed Chinese

embassy in London highlights the evolving role of embassies in international affairs. While diplomatic missions are protected under international law, their increasing fortification and potential intelligence-gathering functions raise critical legal and security questions. The Vienna Convention on Diplomatic Relations provides foundational protections for embassies, but it remains silent on embassy size and infrastructure. Likewise, international human rights law, particularly the ICCPR, emphasizes privacy rights that may be jeopardized by unchecked foreign surveillance.

As global power dynamics shift, host states must carefully navigate the balance between diplomatic obligations and national security. The debate over China's embassy project serves as a crucial test case for the future of international law, highlighting the need for updated legal frameworks to address the complex intersection of diplomacy, security, and human rights in the modern world.

In the wake of the ongoing Gaza ceasefire, the precise bombing of southern Lebanon just hours before the funeral of Hezbollah Chief Hasan Nasrallah, who was killed in an Israeli airstrike last September, sends a clear message from the Israeli Defence Forces to its enemies that this ceasefire is very much temporary. Israel is committed to eradicating all its enemies sooner or later.

CONTEXT

The fall of more than two decades-long dictatorships in Syria is marked by a major geopolitical shift in the war-driven Middle East. Although the journey of the Assad family-led autocracy in Syria started in 1963, its climax reached under Basar Assad, a second-generation dictator of the Assad family, in December 2024.

Though Basar Assad came to power after succeeding his father, Hafeez Assad, in early 2000, his brutal and despotic rule in actual sense mainly started right from the beginning of the prodemocracy protest in 2011 during the Arab Spring.

His autocratic rule in Svria has not only devasted the whole country economically but also played a significant role in making the country a breeding ground for terrorism while pushing the country into the mouth of civil war, which further led to mass migration, displacement and refugee crisis in

GEOPOLITICAL SHIFT AND ITS MAJOR OUTCOMES:

After the collapse of the Syrian dictatorship, Israel continues to advance towards western Syria, intending to create 400km of buffer zone in the western Syrian region beyond the Golan Heights. The idea is probably to help Israel cut off the Syrian corridor connecting Lebanon with Iran and stop it from trafficking arms and ammunition into the Levant region through this Syrian

corridor. The capability of Iran to

project power in the Levant region has certainly weakened in post-Assad Syria due to the disruption of this corridor. Hence, the significant investment previously made in Syria by Iran will greatly be impacted, further giving an economic shock to its GDP, as the Iranian government is already heavily sanctioned by the Western allies. This will, for sure, pose a new challenge in front of the Iranian government to back pro-Iranian non-state actors (Hezbollah and Hamas) existing in the region. The overthrow of Assad

from power has given a significant geopolitical setback to one of the most important players from the Syrian side in this conflict, that is none other than Russia. Using Syria as a platform to project its interest against the West, Russia had already established itself as a major player in the Middle East. But, following the dramatic fall of the Assad regime, Russia's extra-regional geopolitical image and its geostrategic influence in this region have significantly suffered. Therefore, without any delay, Moscow has already started looking for alternatives that could strategically help Russia continue making its image as a net security provider in the region. As a result, the Kremlin has recently passed a bill seeking to remove the Taliban from the list of terrorists.

There is a possibility that the USA-backed and anti-Iran Arab states of this re-

gion may be seeing the collapse of Assad's regime in Syria as a geopolitical win over Russia & Iran. There is also a possibility that the anti-Iranian Arab states may side with Israel to offset the remaining Iranian strategic influences in Syria. In the wake of PM Netanyahu's scheduled meeting with Donald Trump, Syria's recent official visit to Saudi Arabia has grabbed attention from around the world. In response to that, the chief of Iran's Islamic Revolutionary Guard Corps(IRGC) has warned Syria's new leadership as well as Saudi Arabia, stating that "Our missile can

strike any enemy target in the region and overcome the enemy's anti-missile defences". This statement by the chief of IRGC shows how significant the Syrian corridor is for Iran to operate its proxy forces. This is all happening at a time when Trump 2.0 is taking a very tight diplomatic stance

for his Middle East policies. The resulting instability in Syria has cleared a path for Israel to have a strategic advantage in the region. Israel is, therefore, expected to emerge as a very crucial friend of the pro-US Arab states in the resulting instability, promising to become

a net security provider and combat terrorism while gradually promoting its own agenda in the region. This probable outcome will additionally increase the significance of Israeli defence capability in the rapidly changing geopolitical dynamics of West Asia

KURDISH ASPECT IN THE SHIFTING **GEOPOLITICS OF WEST ASIA:**

In post-Assad Syria, the People's Defence Unit(PDU), a US-backed Kurdish militia which was also a party to the anti-Assad forces, is eying a separate independent rule in the post-Assad regime.

The HTS, being a main rebel group of the anti-Assad forces, has a great influence of Turkey politically and militarily. As Turkey is well aware of the fact that the creation of a Kurdish independent state in the region will be a direct threat to Turkey's territorial integ-

ish state. Turkev also argues that the creation of an independent Kurdish state in Syria would trigger a domino effect for the demand for a separate Kurdish state in the neighbouring states, too. Henceforth, Turkey will probably be the most affected state by this demand, as Turkey already has great hostility with the PKK, the most notorious Kurdish militia group in the region. As HTS-led Syria has recently held a National Dialogue Conference regarding the framing of the constitution, the Turkey-backed Syrian interim government did not invite the US-backed Kurdish militia group(PDU) to the conference. Failing to include the Kurdish rival in this conference will certainly escalate the regional conflict in the future. It also proves to be right that the instability in Syria and the continuous demand for a separate state for Kurds is not over yet. Henceforth, the prevailing conflicts in post-Assad Syria have potentially proved to be a good recipe for Israel from its geostrategic point of view.

SPARK IN THE KASHMIR VALLEY

In the UN, India has always voted in favour of the Syrian claim to Golan Heights for decades in exchange for Syria not making any provocative comments against India as well as not being supportive of militancy in Kashmir at all. However,

the anti-Assad rebel groups rity, it would never let PDU achieve their dream of creof Syria, such as ISIS and ating an independent Kurd- Al-Qaida, have always been vocal and supportive of militancy in Kashmir valley.-In the Julani-led regime in Syria, India may witness a spark in the Kashmir valley, as the militancy in Kashmir has a direct link with anti-Assad Syrian rebel groups. The reason behind anti-Assad forces supporting militancy in Kashmir is probably because India al-

ways indirectly supported the Assad regime in Syria and always maintained its strategic silence over the Syrian civil war. Now, the HTS-led post-Assad regime and the increasing instability in Syria may give a spark in the Kashmir valley sooner or later. As Al Julani-led HTS is backed by Turkey, Turkey's growing ties with Pakistan in recent times are additionally quite concerning for the anticipated instability in the Kashmir Valley. Therefore, the Indian government must be well-prepared to respond to any activity challenging Indian sovereignty in the valley. However, India's strengthening ties with the West Asian countries (particularly Qatar and the Taliban) is a smart strategy to indirectly discourage and counter the negative influence of militancy in the Kashmir valley.

n February 2025, an unexpected controversy erupted on X (formerly Twitter) when Ola CEO Bhavish Aggarwal praised a podcast titled "Sati - Fact or Fiction?" by author Amish Tripathi. Aggarwal, known for his strong opinions, compared the scarcity of evidence on sati to the widespread historical documentation of

witch burnings in medieval Europe. His comment triggered comedian Kunal Kamra, who responded with a sharp retort:

"Raja Ram Mohan Roy fought against the practice of Sati; it was abolished in 1829. The last documented case of Sati in India was as recent as 1987. Please focus on your automobiles being immobile."

Tripathi, celebrated for his mythological retellings, entered the fray, urging Kamra to read the 1829 Sati Abolishment Act, which, he argued, explicitly stated that sati was "not enjoined" by Hindu scriptures and was nearly nonexistent at the time. The debate quickly spiraled, with supporters and detractors dissecting history, religious interpretations, and colonial narratives. The controversy underscored an uncomfortable truth: even in the digital age, the embers of sati still burn in India's collective consciousness

THE MYTH AND THE **REALITY**

The word sati derives from Sanskrit, meaning "a virtuous woman." The roots of the practice can be traced to Hindu mythology, particularly the tale of Goddess Sati, who immolated herself in protest against her father's humiliation of Lord Shiva. However, in this narrative, Sati's act was one of defiance and divine retribution—not widow immolation.

Historically, the earliest mentions of sati appear in the Mahabharata (compiled around 400 CE) and Tamil Sangam literature from the 2nd or 3rd century CE. Greek historian Diodorus Siculus recorded instances of sati in Punjab in the 4th century BCE, suggesting that it was known but not widely practiced. The prevalence of sati surged in the medieval period, particularly in Rajput communities, where it evolved into jau*bar*—mass self-immolation by women to avoid capture and dishonor by invaders.

THE BRITISH INTERVENTION

By the early 19th century, British colonial administrators were documenting sati cases, particularly in Bengal, where 500-600 instances were recorded annually. While the British framed their intervention as a humanitarian effort, their motives were not entirely altruistic.

Social reformer Raja Ram Mohan Roy played a pivotal role in advocating for the abolition of sati, arguing that it was neither a religious obligation nor a widespread practice. His efforts culminated in the Bengal Sati Regulation of 1829, criminalizing the act. However, this legislative victory also served British interests, allowing them to

portray themselves as civilizing rulers while reinforcing their control over Indian customs and laws.

The Commission of Sati (Prevention) Act, 1987, not only banned sati but also criminalized its glorification. However, enforcement has been inconsistent.

THE ROOP KANWAR

CASE Despite its prohibition, sati did not vanish overnight. The most infamous modern case occurred in 1987, when 18-year-old Roop Kanwar was burned alive on her husband's pyre in Deorala, Rajasthan. Rather than being condemned, her death was glorified by some sections of society, with temples erected in her honor. The incident led to the Commission of Sati

eradicating it completely.

case (1987) is covered in detail, there have been lesserknown incidents of attempted or glorified sati post-1987. Reports suggest that temples dedicated to "sati" figures still exist, like, the Kalighat Kali Temple in Kolkata, the Chamundeshwari Temple in Karnataka and Rani Sati Temple is a temple located in Jhunjhunu, Jhunjhunu district, in the state of Rajasthan. And some rituals, though unofficial, continue. These occurrences suggest that sati is not entirely erased and still holds a symbolic

SATI IN POPULAR

CULTURE The ghost of sati has found new life in cinema and literature. In 1989, Aparna Sen's film Sati, starring Shabana Azmi, depicted a mute woman forced into a symbolic marriage with a tree, shedding light on oppressive traditions. More controversially, Sanjay Leela Bhansali's *Padmaavat* (2018) reignited debates when its climactic *jauhar* scene was perceived as glorifying selfimmolation. While Bhansali defended the depiction as historically accurate, critics argued that cinematic portrayals of sati continue to romanticize oppression under the guise of honor.

Sati occasionally resurfaces in Indian politics, often weaponized for ideological battles. In 2023, BJP MP Chandra Prakash Joshi invoked *jauhar* in Parliament, triggering protests from opposition leaders who accused him of glorifying sati. Similar controversies have played out in legal battles, as seen in the Supreme Court's dismissal of petitions against Padmaavat, reflecting the iudiciary's cautious stance on balancing historical representation with potential endorsement of outlawed practices.

WHY DOES THE TOPIC PERSIST?

The periodic resurgence of sati in public discourse can be attributed to several fac-

1. Cultural Legacy: Deeply embedded in India's historical and religious consciousness, sati continues to be referenced in myths, rituals, and folklore.

2. Colonial Narratives: The British abolition of sati is often invoked in debates over cultural imperialism versus social reform.

3. Gender and Patriarchy: Sati remains a stark symbol of patriarchal control over women's bodies and choices. 4. Media and Cinema: Films and literature keep the discussion alive, sometimes sparking controversy over artistic freedom versus glorification.

5. Legal and Political Manipulation: Politicians and activists selectively invoke sati to serve ideological agendas, ensuring it remains in the public eye.

Post-1987, global human rights organizations and UN bodies condemned the practice, urging India to strengthen enforcement. Sati is often compared to other widowhood rituals worldwide, such as seppuku in Japan and suttee-like practices in Southeast Asia, where widows were historically expected to follow their husbands in death. Examining these comparisons would provide a broader perspective on the ways patriarchal societies have controlled women's lives through rituals of sacrifice.

Sati was not uniformly practiced across India. The practice was more prevalent in Rajasthan, Bengal, and Madhya Pradesh, where historical instances were recorded. While Rajput jauhar was often an act of collective self-immolation, Bengal's instances were largely individual cases, often rooted in social pressures and upper-caste traditions. Understanding these regional nuances provides a more accurate historical picture

of sati's presence and decline.

Though sati was abolished, did the oppression of widows simply take another form? Cities like Vrindavan and Varanasi are known as 'cities of widows', where thousands of women-ostracized by their families—live in extreme poverty. Many are left to beg or perform religious rituals for survival. The stigma surrounding widowhood, though not as extreme as sati, continues to deny women agency, property rights, and social dignity. Addressing these ongoing issues is crucial in ensuring that the spirit of sati does not persist in subtler ways.

A LEGACY THAT LINGERS

Despite its legal abolition, the idea of sati refuses to fade, morphing into new forms of oppression—be it honor killings, domestic violence, or societal expectations of widowhood. The question remains: Has India truly buried the flames of Sati, or does it smolder beneath the surface, waiting for another spark?

The fight against sati was never just about stopping widow immolation; it was about challenging an entire system that dictated a woman's worth based on her marital status. As long as patriarchy exists, the ghost of sati will never be entirely exorcised. It is up to society to decide whether it wants to keep revisiting this practice as a relic of the past—or finally put its ashes to rest.

While Raja Ram Mohan Roy is credited with sati abolition, movements like Arya Samaj and Brahmo Samaj took strong stands against sati and widow oppression, while modern Hindu nationalist factions have had varied perspectives, sometimes invoking sati in cultural rhetoric.

From heated Twitter debates to Supreme Court cases, Sati refuses to be just a relic of the past. Even in the digital age, its embers still glow in political speeches, Bollywood films, and legal controversies.

he Supreme Court in the case Madras Bar Association Versus Union Of India observed and has orally flagged two issues which relates to the tribunals across the country that require immediate attention namely: the appointment of staff and the service conditions.

before the court that, 'One important issue, probably in respect of all tribunals is that we are providing them the basic infrastructure-the judgment writers...I am Chairperson of the committee for one of these tribunals that deals with mat-



ter involving millions and thousands of crores. Now, the entire deputation came to me, met me, pointing out that we are permitted to engage staff on a contract basis. If tomorrow, someone takes away file of the case, who is going to protect us? So, I suggested one of your

ministers that why don't you go for taking people on deputation while on Government service. They will be responsible people.'

On August 25, 2022, the bench headed by CJI Ramana-led bench orally observed that at least two conclusions of the judgment required relook - first, that the copy of the Enforcement Case Information Report, ECIR; equivalent of FIR in money laundering cases need not be given to the accused, and second, the upholding of the reversal of presumption of innocence. The counsel, Senior Advocate Colin Gonsalves appearing for petitioner submitted before the court that the varsity had resorted to the action which was highly disproportionate to the protest being undertaken by the

Senior Advocate Colin Gonsalves also submitted that the petitioners have a clean track record and had assembled outside the can-

teen for their protest. Gonsalves also stated that the varsity, instead of guiding the students, sided with the Delhi Police and made them arrested.

The Gonsalves stated that the action of Jamia was totally against its academic regulations and that no such chance was given to the petitioners to defend themselves.

Before the court, Chimni submitted that the suspension of the students cannot be more than two weeks as per the varsity's ordinances.

On the other hand, Advocate Amit Sahni appearing for Jamia submitted before the court that the varsity had given sufficient opportunity to the students and that the protest was nowhere related to academics and that no permission was sought from the university.

BEIJING: China on Tuesday hinted at increasing its defence budget, the second largest after the US, saying peace and sovereignty can only be "safeguarded with strength". Fighting in Gaza has been halted since January 19 under a truce arranged with U.S. support and Qatari and Egyptian mediators, and Hamas has exchanged 33 Israeli hostages and five Thais for some 2,000 Palestinian prisoners and detainees.

But the initial 42-day truce has expired and Hamas and Israel, which has blocked the entry of aid trucks into Gaza, remain far apart on broader issues including the postwar governance of Gaza and the future of Hamas itself.

"We are ready to continue to phase two," Saar told reporters in Jerusalem as Arab leaders prepared to meet in Cairo to discuss a plan for ending the war permanently.

"But in order to extend the time or the framework, we need an agreement to release more hostages."

Overnight clashes between Pakistani and Afghan security forces at the main border crossing between the countries caused thousands of people to flee their homes but the situation had calmed down by Tuesday morning, residents and officials said. The conflict started on

Monday, the first working day of Ramadan, when food imports from Pakistan usually peak in Afghanistan.

Around 15,000 local residents fled to Landi Kotal due to the clashes, an official said. Afghan border guards had opened fire without warning, targeting government

buildings and civilians, and causing widespread panic.

"The tensions between the two countries and continuous closure of the border has been causing multiple problems to the people of the border area. People are very poor and dependent on their businesses related to the border," Ali Shinwari, who lives in the border town, told Reuters. Relatives and tribesmen in a nearby town have been hosting dozens of relatives since the border closure, he added.

The Torkham crossing has been shut since February 21 due to a dispute over the construction of a border-area outpost by Afghanistan, Pakistani officials said on condition of anonymity.

Pakistan's Ministry of Foreign Affairs did not immediately respond to a request for a comment.

The Taliban-run Afghan Interior Ministry said on Monday one Taliban fighter was killed and two injured, while Pakistani security officials reported that members of their forces had also been wounded.

Imran rejects decision to rename stadium after him

Jailed former prime minister Imran Khan disapproved the Khyber Pakhtunkhwa government's decision to rename Arbab Niaz Cricket Stadium after the cricketerturned-politician's name, his sister said on Tuesday.

Aleema Khan, the Pakistan Tehreek-e-Insaf (PTI) party founder's sister, told the media after meeting her brother in jail that Khan, 72, did not like the provincial government's decision to rename the cricket stadium in Peshawar after him.

"I don't like anything to be named after me. So the stadium's name should be reverted to the original,' Khan told Aleema.

Khan said he did not favour such changes and that national assets should be preserved with their original identity. The Khyber Pakhtunkhwa government has been reviewing the matter following Khan's disapproval.

Arbab Khizar Hayat, a Pakistan Muslim League-Nawaz (PML-N) party leader in the province, said Khan took a good step by ordering Chief Minister Ali Amin Gandapur through his sister to restore the Arbab Niaz Stadium's original name.

"Political differences aside, we see Imran Khan's decision in a positive light. Truth has prevailed, and it is a victory for all political parties and the people of Peshawar," Hayat said.

"Two bronchoscopies were therefore performed, with the need to remove

large secretions," it added. It further said that noninvasive mechanical ventilation was resumed in the afternoon. According to the statement, Pope Francis remained alert, oriented and cooperative at all times.

In a statement, the Holy See Press Office said, "In the afternoon, non-invasive mechanical ventilation was resumed. The Holy Father remained alert, oriented and cooperative at all times," Vatican News reported.

"The prognosis remains guarded," it added.

Pope Francis's test values are unchanged, suggesting that he does not have leukocytosis (a high white blood cell count). This, in turn, suggests that there is no new infection, and the accumulation of mucus is merely the consequence of the pontiff's pre-existing pneumonia.



Sleep patterns may reveal comatose patients with hidden consciousness: Study

everal studies conducted over the last decade have found that up to a quarter of unresponsive patients with recent brain injuries may have a level of consciousness that is generally hidden from their families and physicians.


New research from Columbia University and New York-Presbyterian may soon help physicians identify unresponsive brain-injury patients with hidden consciousness who are likely to achieve longterm recovery by looking for brain waves that are indicative of normal sleep patterns.

"We're at an exciting crossroad in neurocritical care where we know that many patients appear to be unconscious, but some are recovering without our knowledge. We're starting to lift the lid a little bit and find some signs of recovery as it's happening," says Jan Claassen, associate professor of neurology at Columbia University Vagelos College of Physicians and Surgeons, who led the

"Families of my patients ask me all the time, will my mother wake up? How is my mother going to look in three, six, or 12 months? Very often we cannot guide them very precisely, and it's crucial that we improve our predictions to guide their decision making."

Claassen, who is also chief of critical care and hospitalist neurology at NewYork-Presbyterian/ Columbia University Irving Medical Center, has previously developed sophisticated techniques to identify patients with hidden consciousness by analyzing a patient's EEG recordings as they are presented with a command in the neurocritical care unit. The techniques detect EEG brain wave activity, indicating that the patient can hear and understand their physicians' instructions (to open and close their hand, for example) even though the patients do not physi-

cally respond. But the techniques can be



difficult to implement and can vield false-negative re-

Claassen decided to focus on sleep, as brain circuits that are fundamental for consciousness, including cognitive motor dissociation, are also critical to control sleep.

"I'm always thinking about how my work can be best implemented and used in the real world,

and looking at sleep made sense practically and scientifically," Claassen says. "Sleep brain waves are easy to record and do not require intervention from

"The electrical activity during sleep looks relatively chaotic, and then occasionally in some patients, these very organized, fast frequencies appear," Claassen says.

These bursts--called sleep spindles--often preceded the detection of cognitive motor dissociation with the more complex method, the return of con-

"Spindles happen normally during sleep and they're showing some level of organization in the brain, suggesting circuits between the thalamus and cortex needed for consciousness are intact."



Key protein identified for treating Alzheimer's disease: Study

A team of researchers from the University of Cologne has made an important contribution to understanding the role of the tau protein in Alzheimer's dis-

Using human induced pluripotent stem cells (iP-SCs), the international team demonstrated that a specific variant of the tau protein, known as the 1N4R isoform, mediates the harmful effects of protein clumping in human brain cells.

The study was led by Dr. Hans Zempel from the Institute of Human Genetics, who is also a group leader in the Career Advancement Program (CAP) at the Center for Molecular Medicine Cologne (CMMC) of the University of Cologne and University Hospital Cologne.

If a person suffers from Alzheimer's disease, certain proteins accumulate in brain cells, forming clumps that restrict normal cell function or even cause the cell to die.

Dr Buchholz and Dr Zem-

pel's team have used stateof-the-art techniques such as CRISPR/Cas9 gene editing and live-cell imaging in human induced pluripotent stem cells (iPSCs) to demonstrate that the 1N4R tau isoform is responsible

for the pathological effects on the cell. iPSCs are human stem cells that are generated from other cells.

For example, skin cells

can be reprogrammed into iPSCs and then transformed into brain cells (neurons). The researchers tested different forms of the tau protein by expressing them specifically in nerve cells. This allowed them to analyse how each protein isoform

affects the cell. According to Dr Sarah Buchholz, first author of

the study, "this study represents a significant advance in helping us to understand the mechanisms of Alzheimer's disease. By identifying 1N4R tau as a key protein, we have discovered a potential new target for future treatments."

The study's interdisciplinary approach not only helps to better understand Alzheimer's disease but

also demonstrates the importance of human cell models in neurodegenerative research. Further studies are needed to translate the results of this study into clinical application, in particular to validate the results in adequate animal models and to develop specific therapeutics that will intervene in this process.





KOHLI'S MASTERCLASS CHASE PLACES INDIA IN FINAL

irat Kohli delivered a chase masterclass to knock Australia out of the tournament and send India to the final with a fourwicket win in the first semifinal of the Champions Trophy on Tuesday in Dubai.

India finally savoured the sweet taste of revenge of the 2023 ODI World Cup heartbreak, which now became a distant memory as India relished its four-wicket victory in the semi-final.

By chasing down a competitive 265-run target, India toppled the record by completing its highest-successful run chase against Australia in an ICC event, bettering the previous best chase of 261 in the 2011 World Cup quarter-final.

India began its pursuit of the 265-run target with a touch of caution. Shubman Gill looked jittery in his approach, while India's captain, Rohit Sharma, remained undaunted and stuck to his early blitzkrieg approach

In his policy of playing fearless cricket, Rohit received his first lifelines when Cooper Connolly dropped a sitter. He received a second chance after Marnus Labuschagne sprinted towards the ball and got hold of it but eventually fluffed it as he landed on the ground.

With India showing signs of nerves getting the better of them, Australia saw the opening and capitalised on the opportunity. Ben Dwarshuis drew the first blood with a delivery angling into the righthanded star. Gill tried to dab it to third man and dragged the ball straight into the stumps. Rohit soon followed in his

Indian Olympic Association (IOA) chief P T Usha on Tuesday defended her decision to appoint an adhoc committee for boxing, saying the national federation failed to fulfil its "fundamental responsibilities" in the last one year and her action was necessary to "restore order and ensure proper governance".

Her statement came in response to IOA vice president Gagan Narang's letter on February 28 in which the former Olympic bronzewinner accused her of issuing "arbitrary" orders and undermining athletes' wel-

Usha's steadfast position is despite the Delhi High Court's stay on the IOA's order. The court issued notice, seeking IOA's response to a petition filed by the Boxing Federation of India (BFI).

"...there is no truth in your



athletes are suffering due to this decision or any alleged arbitrary actions on my part. The decision to appoint an ad-hoc Committee was not arbitrary but a necessary step to restore order, ensure proper governance, and prioritize athlete development," Usha said in her reply to Narang, who is also a member of the IOA's **Executive Council.**

"The unfortunate reality is that BFI has failed in fulfilling its fundamental responsibilities, including conduct-(Narang) assertion that ing national championships in the last year.

"With the 2026 Asian Games fast approaching, there has been little to no effort to identify fresh talent, select promising boxers, and implement structured training programs to enhance India's medal prospects." Usha, who has been at loggerheads with the Executive Council members over several issues, accused them of showing "disproportionate preoccupation" with issues of "personal preferences" rather than the overall good of Indian sports.
