# INDIA-US TRADE PACT IN THE WORKS TO CUT TARIFFS

Talks on Bilateral Trade Agreement are in advanced stage

ndia and the US are gearing up to negotiate a landmark Bilateral Trade Agreement (BTA) that could potentially boost trade between the two nations amid US President Donald Trump's plans to impose reciprocal tariffs on US trading partners, including India.

In a weekly briefing, MEA spokesperson Randhir Jaiswal said the agreement aims to strengthen and deepen India-US two-way trade in goods and services, increase market access, and reduce tariff and non-tariff barriers.

"The two governments are in the process of advancing discussions on a multi-sector Bilateral Trade Agreement. Through the BTA, our objective is to strengthen and deepen India-US two-way trade in the goods and services sector, increase market access, reduce tariff and non-tariff barriers, and deepen supply chain integration between the two countries," said Jaiswal.

The announcement comes after Prime Minister Narendra Modi's visit to the US in February 2025, where both sides expressed interest in negotiating a mutually ben-

# Open up agri market, says US

The US on Friday pitched for a macro, large and grand trade agreement with India, and not 'product-by-product' arrangement to boost bilateral ties between the two countries.

US Commerce Secretary Howard Lutnick said India needs to open its agriculture market, emphasising that it can not be 'off the table' when with its largest trading

partner.

"Because India is so gigantic, and the US is so gigantic, the right way to do it (trade pact) is a macro, and that's why we think we can get it done. The US is interested in doing a macro, large-scale, broadbased trade agreement with India that takes everything into account and that I think it can be done.

# Delimitation: Stalin ups the ante, writes to CMs

# Jaguar fighter jet crashes in Panchkula

An Indian Air Force (IAF) fighter jet crashed in Mandalay village near Raipur Rani of Haryana's Panchkula, on Friday. The pilot survived the incident as he ejected safely using a parachute before the crash.

As per the information, Jaguar fighter aircraft had taken off from the Ambala airbase for a routine training sortie but crashed at



around 3:45 PM.

"A Jaguar aircraft of the IAF crashed at Ambala, during a routine training sortie today, after encountering system malfunction. The pilot manoeuvred the aircraft away from any habitation on ground, before ejecting safely. An inquiry has been ordered by the IAF, to ascertain the cause of the accident," the Indian Air Force (IAF) posted on X.

## ECI forced to admit its voter lists flawed: Cong

Amid the debate on the voter duplication row in electoral rolls, the Congress on Friday hit back at the Election Commission of India saying that the panel has issued a duplicitous response on the issue of same voter IDs being allotted to multiple voters and it has been forced to admit that its voter lists are flawed and not trustworthy.

Congress' Empowered Action Group of Leaders and Experts (EAGLE) consisting of Ajay Maken, Digvijaya Singh, Abhishek Manu Singhvi, Nitin Raut, Praveen Chakravorty, Pawan Khera, Gurdeep Singh Sappal and Vamshi Chandra Reddy made a detailed response to the poll panel.

The Congress' EAGLE in its response stated, "The Election Commission has issued a duplicitous response on the issue of same voter IDs being allotted to multiple voters. The ECI, in its response, hides behind its processes to offer a feeble explanation.



Shockingly but not surprisingly, the ECI has been forced to admit that its voter lists are flawed and not trustworthy."

It said that the Commission, in a letter issued on September 18, 2008 to Chief Electoral Officers of all States, had said that 'voter-IDs are unique'.

"However, the ECI today

says, the issue of duplicate voter-IDs is a 'decades long issue'. Firing salvos at the Commission, it asked, "Which statement of the ECI should the citizens of India average Indian voter today trust the Election Commission?" Targeting the ECI, the EAGLE said, "Further, how is it that 17 years later, ECI speaks of constituting a body to clean up this process

"The data privacy related to phones and computers covers most of these," the

Congress leader said. Citing the details of the Supreme Court judgement, he said that it also lays down triple test if any law requires overriding of fundamental

right to privacy by the state/

government. "The test includes: (a) There must be a law to justify encroachment of privacy. (b) Test of reasonableness mandated by Article 14, which is a guarantee against arbitrary state action and (c) The action is proportional to object and need of the law," he said.

Sappal said that the fundamental rights are granted as a guarantee against the state protection of life and personal liberty. "The Supreme Court had already held that has ruled that the right to privacy is an intrinsic part of the right to life and liberty,"

## Five arrested by police as fake job gang busted in Haryana

A gang that cheated job seekers by offering fake government jobs—just like in the famous Bollywood movie Special 26—has been caught by the police. The gang operated by creating a fake website, conducting exams and interviews, and even issuing fake appointment letters to unsuspecting candidates.

According to the police, the fraudsters appointed 25 people for fake positions like Area Inspector, Field Supervisor, and



MPS. However, their scam was exposed when one of the selected candidates became suspicious and reported the The gang used to charge be-

tween Rs 2 lakh to Rs 4 lakh per candidate for these fake job offers. They had set up an organization called Shagun Gramin Health and Family Council to make the scheme look real, said Cyber Cell Inspector Vikas.

Sub-Inspector Vikas of the Bhiwani Cyber Police Station stated that five individuals have been arrested in this case. The police have recovered Rs 1.57 lakh in cash, frozen Rs 1.21 lakh in their bank accounts, and seized two silver coins, two rings, a computer, 13 mobile phones, 11 passbooks, 11 ATMs, 43 registers, 8 payment slips, and various office supplies from them. These accused acted as a government department under the name Shagun Gramin Health and










The Karnataka High Court on Friday quashed the summons issued by the Enforcement Directorate (ED) to CM Siddaramiah's wife, Parvathi, and Urban Development Minister Byrathi Suresh in connection with the Mysore Urban Development Authority (MUDA) case.

The judgement pronounced by High Court Justice M Nagaprasanna comes as a huge relief to Karnataka Chief Minister Siddaramaiah.

Parvathi and Minister By-

rathi Suresh had approached the High Court to appeal for cancelling ED summons in connection with the MUDA

The petition demanding a Central Bureau of Investigation (CBI) probe was also dismissed by the High Court, saving that it was not required given that another agency (Lokayukta) was conducting an enquiry.

This development follows after Karnataka Lokayukta SP Udesh submitted an interim 8,000-page B Report on Thursday in connection with the MUDA scam case. The notice, issued by Udesh, declares the case "not actionable," leading to the submission of a final report to the competent court.

The Lokayukta concluded that the allegations against the four accused individuals were either civil in nature. outside the scope of a criminal investigation, or based on misinterpretations of legal provisions. Earlier, the Karnataka Lokayukta Police had issued a notice to complainant Snehamayi Krishna stating that the allegations in the MUDA scam case could not be substantiated due to a lack of evidence.

On February 20, Karnataka Deputy Chief Minister DK Shivakumar lashed out at the BIP and IDS for conspiring on the MUDA issue and said that their conspiracy can't go on forever. Speaking to reporters at his Sadashivanagar residence, he said, "I had said long back when BJP and JDS took out a padayatra from Bengaluru to Mysuru that it is a politically motivated ploy. When there is no signature of CM Siddaramaiah in any of the documents, where is the question of his involvement?' Karnataka Minister Priyank Kharge had said, "Lokayukta is an independent investigative agency...if they

have given a clean chit to CM, I welcome that. The freeze was extended in 2002 until the census after 2026. However, with the 2021 Census delayed, the delimitation process might happen earlier

than expected, potentially affecting states that have controlled their population and achieved better governance. The CM stated that if the exercise is based on population after 2026, states with better population control would face a reduction in parliamentary representation, which he called unjust.

Police received a PCR call about the incident at 6.20 am from the security guard of the residential complex. The officer was taken to a hospital, where he was declared dead.

"His wife and children are staying in Dehradun. They have been informed about the incident and the family members are on their way to Delhi," said the source, adding that the family were living in Dehradun because his children were studying

"The officer had no family dispute and had been battling depression since he came back from his posting in Belgium 10 months ago. Rawat has been residing in Delhi for 10 months," a police source said.

A witness said that he was outside the complex when he heard a noise. "We rushed inside the building and saw the officer's body lying on the ground," he said.

The MEA said, "An officer of the Ministry of External Affairs passed away on the morning of March 7 in New Delhi."

"The ministry stands with the family in this hour of grief and difficulty. Further details are not being released bearing in mind the need to respect the family's privacy in this time of bereavement,' the MEA added.

# CCTV cameras to send SOS by women in Delhi soon

Waving in front of a surveillance camera may soon help save a woman's life, as the Delhi Police prepares to launch a one-of-a-kind proj-

ect in the coming months, an officer said on Friday. The 'Safe City' project, currently in pipeline, aims to install high-resolution cameras across Delhi, with live feeds beamed at local

police stations, the offices of

Deputy Commissioners of Police (DCPs), and the Police Headquarters.

"This will be the first such initiative in the country," the officer said.

The project will involve the use of facial recognition technology, alerting police immediately if a woman in distress waves her hand in front of these cameras.

Initially, there were discussions about integrating panic buttons into the camera poles, but the idea was dropped amid concerns of misuse and unnecessary resource deployment, said the officer involved in the project.

"If any incident of crime against women occurs on the streets of Delhi, police will be immediately alerted and can intervene before the situation escalates. This will be a significant step in crime prevention," he added. The project is still under development, with weekly review meetings every Tuesday, attended by the heads of various departments. The multi-crore initiative

is expected to be launched this year by Prime Minister Narendra Modi and Union Home Minister Amit Shah. Lower-level officers have been instructed to identify high-crime areas or "black spots" where there is a great-

er need for surveillance.

The solar industry will continue to face a demandsupply mismatch, despite a significant surge in cell manufacturing capacity over the next two years, according to a report by Share India.

The production of solar

modules is expected to rise from 8 gigawatts (GW) to 50 GW by the financial year 2027. The report adds that the demand-supply mismatch in the sector is likely to widen. Despite the sharp rise in cell production, the report highlights that the demand-supply gap is likely to remain wide as incremental cell capacity additions are expected to be concentrated toward the latter part of the two years

According to the report, a major factor contributing to this imbalance is the introduction of ALMM-II

regulations in June 2026 (FY27), which will restrict the use of imported cells in government projects.

The anticipated changes in import regulations due to ALMM-II further complicate the situation, as domestic manufacturers will struggle to meet government project needs without the flexibility to rely on imported cells.

This regulation will impact the solar value chain by limiting the availability of cells for use in governmentbacked initiatives, leading to a potential supply crunch in the domestic market.

While manufacturers are rapidly expanding capacity, the restrictions on cell imports will significantly affect the ability to meet demand for solar modules, especially in government projects.

The report outlines four key concerns of the industry over a potential oversupply of solar modules and cells.

It says aggressive planned production expansions could exert downward pressure on prices and lead to margin compression across the value chain but the demand-supply gap will persist.

The report noted that the market is also grappling with several additional issues, like the surge in cell capacity, the potential oversupply of modules, the impact of import duty cuts on cells and PV modules, and the threat of tariffs on exports to the USA, which could create domestic overcapacity in the short term.

## Banking liquidity will come into strong surplus by March end: UBI

The liquidity situation in India's banking sector is expected to improve significantly by the end of March 2025, with a shift towards a strong surplus, according to a research report by Union Bank of India.

The report also indicated that the overall system liquidity is likely to end the financial year in neutral to surplus territory.

It said "we may potentially see a shift in core liquidity (ex-government balance) towards a strong surplus by end-Mar'25 while system liquidity is also estimated to end the year at neutral to surplus levels". The report highlighted the Reserve Bank of India's (RBI) recent liquidity measures, announced on expectations by a significant margin, suggesting that the central bank is taking proactive steps to ensure adequate liquidity in the financial sys-

The report also added that despite the expected improvement in liquidity by March-end, the banking system may face some shortterm challenges.

Seasonal tax outflows, such as Goods and Services Tax (GST) payments and advance tax payments, along with currency leakage, could temporarily tighten liquidity conditions.

It said "While in the near term, overall banking system liquidity may face pressures from seasonal tax outflows (GST, advance tax etc) along with currency leakage, assuming FX related outflows do not play spoilsport".

However, assuming that foreign exchange-related outflows remain under control, the overall liquidity situation should improve as the financial year concludes.

Interestingly, the market reaction to the RBI's liquidity measures has been relatively subdued. The report attributes this muted response March 5, 2025, amounting to several factors, including to Rs 1.9 lakh crore. These year-end liquidity pressures, measures exceeded market an increase in the supply of State Development Loans (SDLs), and a sharp rise in global bond yields.

> The global financial landscape has also influenced market sentiment. The report notes that concerns over a slowdown in the U.S. economy have been growing, particularly due to the potential impact of trade tariffs.

## Retail inflation may ease to 4.1% in Feb: Report

India's consumer price inflation (CPI) is expected to decline to 4.1 per cent for February 2025, according to a report by the Bank of Baroda (BoB).

However, the report cautioned that certain factors could keep food prices elevated, such as rising global edible oil prices, inflationary tariff policies, and an anticipated hotter summer.

It said "We expect CPI to settle at 4.1 per cent in Feb'25. However, we completely do not rule out any upside pressure on food prices arising from stickier edible oil prices globally".

The BoB Essential Commodity Index (BoB ECI), which tracks key household goods, also showed a slowdown in February, moderating to 2.4 per cent year-on-year. This decline was driven mainly by falling prices of vegetables like tomatoes and potatoes.

Additionally, inflation in pulses remained under control due to improved supply conditions. A recent



reduction in milk prices further contributed to the downward trend in overall inflation.

Despite the easing of inflation in some categories, certain risks persist. Global asset price volatility, particularly in gold and base metals, has not yet significantly impacted inflation, as energy prices have remained relatively low.

However, tariffs on metals could drive up prices in the coming months. In February, increased demand led to higher prices for metals such as copper and zinc.

A major concern highlighted in the report is the persistence of high edible oil prices, which could continue to push food inflation **#SheBuildsBharat**

could ignore a leader like Tharoor. With a speaker of his calibre, the party could make a strong impact. From 2014 to 2019, Mallikarjun Kharge was made the leader of the parliamentary party, and from 2019 to 2024, Adhir Ranjan Chowdhury was given that role — when actually a powerful orator like Shashi Tharoor was present in the House! Just recall the moment when Tharoor



stood at Oxford and delivered a fact-based speech on Britain's exploitation of India — the entire nation applauded! That's because he speaks with solid facts.

In the past few years, Congress has made many internal changes. Recently, two new general secretaries were appointed, and several state in-charges were reshuffled. Yet, there was neither a place for Tharoor, nor was it contemplated. In fact, the All India Professionals' Congress (AIPC), which was entirely his creation, was taken away from him!

Shashi Tharoor praised Prime Minister Narendra Modi's visit to the US recently, calling it a success. He wrote, "Prime Minister Modi's meeting with US President Donald Trump has resulted in some important outcomes that are beneficial for the people of our country. I believe something positive has been achieved, and as an Indian,

I appreciate it. I have spoken entirely in the national interest in this matter."

Earlier, he had also praised Kerala Chief Minister Pinarayi Vijayan. In one of his articles, he commended Kerala's leftist government, stating that the state was well-positioned to lead India's technological and

industrial transformation. These statements caused outrage within the Congress. Amid this controversy, Tharoor responded, saying, "I am with Congress, but if the party does not need me, I also have options." Tharoor speaks with such confidence because of his strong grassroot support. His victory from the Thiruvananthapuram parliamentary seat, even during the Modi wave, proves his strong connection with the electorate. He wants Congress to contest next year's Kerala Assembly elections under his leadership to ensure victory. But does the party care?

I keep wondering as to why the Congress, which was once the heartbeat of the nation, has not returned to power in Tamil Nadu for 58 years, in West Bengal for 48 years, in Kerala for 41 years, in Uttar Pradesh for 36 years, in Bihar for 35 years, in Gujarat for 30 years, and in Odisha for 25 years! In Delhi, the party has been wiped out. It is out of power in Punjab. In Maharashtra, the party is in shambles. What has happened to the Congress? Millions of party workers are asking the same question. But does the top leadership ever reflect on this? Answering this question is difficult! For now, pay heed to what Shashi Tharoor recently posted on X (formerly Twitter), "Where ignorance is bliss, 'Tis folly to be wise."

These devices surround us in our daily lives, offering a plethora of advantages, from instant communication to endless access to information. However, alongside these benefits, there are serious concerns that arise,

particularly regarding social interaction and human relationships. The transformation of our communication landscape has created a phenomenon that can be aptly described as a generation of "digital zombies."

Among the most pronounced impacts of excessive screen usage is the gradual erosion of communication abilities and a significant reduction in actual human interaction. The nuances of online communication—while convenient—cannot replicate the sophistication and subtleties inherent in face-to-face conversations, which include non-verbal signals like facial expressions, tone of voice, and demeanor. Without these essential cues, individuals often struggle to convey their thoughts and emotions effectively through mere text or images. This challenge is particularly pronounced in teenagers, who are at a crucial stage of development where learning interpersonal skills is vital. As higher screen dependence increases, so does social unease, with many finding themselves increasingly uncomfortable in face-to-face interactions.

Empirical observations of daily life provide ample evidence of this troubling trend. It is not uncommon to see children engrossed in their electronic devices, largely oblivious to the conversations happening around them. This behavior is not confined to younger generations; adults exhibit similar habits. Commuters on public transport are frequently seen absorbed in their phones, creating a bubble of isolation despite the physical proximity to others. Public spaces such as railway stations, bus stops, and waiting lounges reflect this same disconnection from the surrounding world. Even in domestic environments, family members often share meals in silence, each preoccupied with their own devices. This trend extends into the home, where members retreat into different rooms, each absorbed in their personal screens. Traditional pastimes such as board games and outdoor sports are fading into obscurity, replaced by the allure of digital entertainment, while genuine conversations have become increasingly rare.

Beyond the confines of the home, the excessive use of screens has significantly impacted social participation and community engagement. As individuals become more engrossed in their devices, their involvement in local events, volunteer activities, and social gatherings has diminished. This disengagement from societal interaction weakens social bonds and erodes the sense of belonging that is essential to community life. In the past, social participation was seamlessly integrated into daily routines. For instance, shopping trips served not only as opportunities for procuring goods but also as moments for exchanging greetings and sharing experiences with others. Religious gatherings, such as bhajan sessions in temples, provided a space for both spiritual connection and social interaction. In earlier decades, the limited range of television programming encouraged outdoor play, which was essential for children's development, allowing them to explore, make friends, and build relationships. The landscape of social interactions has been dramatically transformed by technology. Worship practices have shifted from communal gatherings to solitary viewing of services on television, stripping away the intimacy and personal connections that come from shared experiences. The rise of OTT platforms, social media reels, and video games has further contributed to the shift away from real-life interactions toward virtual engagements. This transition has left little room for the simple joys of togetherness, as individuals prioritize screen time over meaningful face-to-face connections.

Moreover, the correlation between excessive screen use and mental health issues is becoming increasingly evident. A growing body of empirical evidence indicates that prolonged exposure to screens—especially through social media—has been linked to higher rates of depression, anxiety, and diminished self-esteem. The constant barrage of notifications and the pressure to remain perpetually connected exacerbate these negative emotional states, creating a cycle that prevents individuals from engaging with others in the physical realm. Despite these challenges, the role of screens in fostering social connectivity cannot be entirely dismissed. Technology allows for instant communication, enabling relationships to flourish even when physical proximity is lacking.

To combat the adverse effects of screen overuse, it is crucial to cultivate awareness of its negative consequences and to actively pursue opportunities for interpersonal connection. Initiatives aimed at fostering face-to-face communication can help restore the essential human connections. Detaching from electronic screens and actively engaging with the immediate environment represents a significant step toward restoring authentic social interactions. The declaration highlights that women's empowerment and sustainable development of a country would be possible when there is equal participation of women in the

economic decision-making process and they get recognition for their contribution to the economic development of a country.

Looking at the scenario in India, the Constitution of India promotes the economic empowerment of women. Articles 14 and 15 which are Fundamental Rights ensure the right to equality, equal opportunities, and non-discrimination and Articles 39(a), 39 (d), and 42 which are part of Directive Principles of State Policy direct the State to make law and policy to

hood, ensure equal pay for equal work and, just and humane conditions of work, and maternity relief.

Thus, to strengthen women's capacities and drive the nation towards holistic economic development, the Government of India has taken significant central policy initiatives. There have been various initiatives ranging from Pradhan Mantri Jan Dhan Yojana (PMJDY), Direct Benefits Transfer (DBT), Pradhan Mantri Mudra Yojana (PMMY), Lakhpati Didi scheme.

The recent statistics by the Government of India on the statistics of PMJDY reveal that a total of 54.58 crore Jan Dhan accounts have been opened till 15.01.2025 of which 30.37 crore (55.7%) belongs to women. This means that a significant section of wom-

adequate means of livelien are still excluded from is between 50000 to 5 sector for developing congetting access to bank accounts which hinders their financial security and also access to social security and welfare schemes. In a report, SEBI reveals that women have 42 percent of inactive bank accounts as compared to 30 percent in the case of men. The PMMY is also a significant policy initiative to promote financial inclusion and entrepreneurship across India. It has sanctioned loans worth 32.36 lakh crore, benefiting over 51.41 crore loan accounts, Out of the total loans sanctioned, 68 percent belong to women entrepreneurs. However, the majority of women's accounts are in the Shishu category (loan amount is 50000/-) which is 79 percent out of which the percentage of sanctioned amount is 54 percent. In the Kishore category (loan

is 21 percent and the sanctioned amount is 42 percent. There are no women's accounts in the tarun category (loan amount is between 5-10 lakhs). The recent report by NITI AAyog in 2025 reveals that more women in India are using credit and actively monitoring their credit scores. There has been a growth of 27 million women in December 2024 monitoring their credit which means that there is a 42 per cent increase from the previous year. There is a significant rise in the share of women from the non-metro areas which is 48 percent as compared to 30 percent in the metro areas. Lakhpati Didi Yojana has empowered 1.15 crore women to achieve an annual household income of 1 lakh. A major catalyst for empowering women is their integration into the digital payments ecosystem. The report on **Enabling Digital Payments** for Women in India reveals that as of 2024 only 25 percent of digital payment users were women and only 23 percent of women have financial literacy.

Furthermore, utilizing alternative credit scoring systems can empower women to make independent financial decisions. Lastly, it needs to ensure the 'full, effective, and meaningful participation' of all women so that no one is left behind.



# SUPREME COURT ASKS HIGH COURTS: DIRECT COURTS TO DISPOSE OF EXECUTION PETITIONS WITHIN 6 MONTHS, HOLD PRESIDING OFFICER LIABLE ON FAILURE

he Supreme Court in the case Periyammal (Dead Thr. Lrs.) Anr Ors Versus Rajamani And Anr. observed and has directed all High Courts to call for information on all pending execution petitions in the district judi-

The Supreme Court passed the directions wherein the court observed that the executing Courts are taking three to four years to pass appropriate orders, thereby, frustrating

the entire decree which is in the favour of the decreeholder.

The court also directed the High Courts to issue an administrative circular asking the trial courts in order to ensure that pending execution petitions are decided within six months.

On failure to do so, the Presiding Officer will be answerable to the High Court on the administrative side.

The bench comprising of Justice JB Pardiwala and Justice R. Mahadevan was hearing the present matter. The court in its order

# Supreme Court grants interim bail to UP MLA Abbas Ansari in Gangsters Act case

The Supreme Court in the case Abbas Ansari Versus State Of Uttar Pradesh observed and has granted interim bail to Uttar Pradesh MLA Abbas Ansari in a criminal case registered against him under the Uttar Pradesh Gangsters and Anti-Social Activities (Prevention) Act, 1986.

The bench comprising of Justice Surya Kant and Justice N Kotiswar Singh was hearing the present matter.

The bench in the case observed and has imposed stringent bail conditions wherein the court granted interim relief to Ansari, including that he cannot leave Uttar Pradesh without prior permission of the Special Judge, Trial Court.

The bench directed to Ansari to stay at his official



The bench directed to Ansari to stay at his official residence in Lucknow and if *he intends to travel to his constituency* in Mau, prior permission from the Trial Court and district police will be required.

residence in Lucknow and if he intends to travel to his constituency in Mau, prior permission from the Trial Court and district police will be required.

The Court has also directed Ansari to not make any public statement in respect of the sub-judice cases. Further, the court asked for a status report on the progress of the trial.

The counsel, Senior Advocate Kapil Sibal appearing for Ansari submitted before the court that he has been granted bail in other cases.

The Senior Advocate Kapil Sibal stated that the FIR raising similar allegations against him was quashed by the Allahabad High Court but the Court granted liberty to file another FIR if required. Further, Senior Advocate Kapil Sibal stated that in the present case, the witnesses are all police officers. Thus, it cannot be a case where he will threaten the witnesses

On the other hand, the counsel, Additional Solicitor General KM Nataraj, appearing for the State, opposed the bail petition which being on the ground that he is a very influential person and his influence can go to any extent.

In the present matter, the special leave petition is filed against the order of Allahabad High Court wherein the court dismissed his bail

The High Court in the case rejected his bail plea on grounds that there is evidence that he is part of a gang operating at the district level, he has criminal antecedents against him, and there are chances that he would tamper with the evidence and threaten the witnesses. Prior to the said order, Ansari had first

The plea of Ansari was not entertained and Ansari was directed to approach the High Court first.

## Pakistan inks deal with banks to slash power sector debt

Pakistan's government sealed a Rs1.25 trillion loan deal with commercial banks at under 11% interest, 3-5% below past rates, to wipe out the power sector's circular

Sources confirmed that this cornerstone of a threepronged strategy, finalized Thursday in the Finance Ministry with civil-military input, aims to bolster the sector's viability. The Pakistan Power Debt plan, briefed to the IMF a day prior, promises stock elimination, though flow issues linger.

The loan, pegged at 1% below the Karachi Interbank Offered Rate (KIBOR) around 10.8% outshines the 14% on prior bank loans and 16% penalties to Independent Power Producers (IPPs). Logged under the Central Power Purchasing Agency (CPPA), it sidesteps public debt tallies. Of the Rs2.4 trillion circular debt,

## Sri Lankan Navy arrests 14 Indian fishermen from Pamban

The Sri Lankan Navy arrested 14 fishermen from the Pamban area for fishing across the border and took them to the Mannar Naval Base for investigation, according to the Rameswaram Fishermen Association.

The Sri Lankan Navy patrolling the area arrested the fishermen belonging to Salalanga and the 14 fishermen on board for fishing across the border. They have been taken to the Mannar Naval Base for investigation.

Earlier on February 27, a group of 25 Indian fishermen who were sent back from Sri Lanka arrived at the Chennai International

Visuals showed the fishermen arriving at the Chennai Airport. The fishermen were arrested by the Sri Lankan Navy on charges of crossing the International Maritime Boundary Line



(IMBL) and were released from prison.

A total of 32 fishermen were arrested on February 23, and their boats were seized. On February 23, fishermen in 440 boats went to sea from Rameswaram. the Palk Bay sea area, Sri to the issue. Lankan marines came to the area in a patrol boat. They caught 5 boats and apprehended 32 fishermen claiming that they were fishing across the border.

## Taiwan fends off Chinese cyber attack as U.S. indicts Beijing-linked hackers

The Ministry of Foreign Affairs (MOFA) confirmed yesterday that it was targeted by hackers from China but assured that no data was compromised. This follows a Wednesday indictment in the US of a group of alleged Chinese hackers who supposedly aimed at US government agencies, MOFA, and several other foreign governments, according to a report by Taipei Times.

US federal authorities have charged 10 individuals with collaborating to illegally access data from their targets and have imposed sanctions on a Chinese tech firm due to what they described as a prolonged espionage campaign that resulted in the theft of information both in the US and globally, as reported by

As per the Taipei Times, eight of the indicted individuals were employed by Anxun Information Technology, commonly referred

As per the Taipei Times, eight of the indicted individuals were employed by Anxun Information Technology, commonly referred to as i-Soon, while two were affiliated with the Chinese Ministry of Public Security.

The indictment, along with a separate announcement from the Manhattan District Attorney's office, indicated that i-Soon is recognized as "a significant player in the PRC's [People's Republic of China's hacker-for-hire ecosystem," as cited by Taipei Times.

These cyberattacks targeted the US Defense Intelligence Agency, the US Department ministries of Taiwan, South Korea, India, and Indonesia, as well as news outlets critical of China and the New York State Assembly, according to the report from Taipei Times.

The ministry stated that it has consistently been a target of Chinese cyberattacks due to the sensitive nature of its operations. It confirmed awareness of these hacking attempts and mentioned that a comprehensive investigation had been initiated, concluding that none of the attempts to breach its system were successful, as highlighted by Taipei Times.

According to the Taipei Times report, the internahacking attempts. The ministry added in a statement that it recognized the recent US indictment as a move to bring the accused hackers to iustice.

## South Korea halts Air Force training after accidental bombing of civilian area

The incident complicates the upcoming Freedom Shield military exercise with the US, raising concerns about operational capabilities and North Korea's

response South Korea suspended the training flights of air force aircraft and all live-fire drills following its fighter jets' accidental bombing of a civilian area, officials said

Friday, posing a potential setback to its upcoming annual military training with the United States.

South Korea has stopped their Air Force's joint livefiring drills with the Army.

On Thursday, two South Korean KF-16 fighter jets mistakenly released four MK-82 bombs each on a civilian area in Pocheon, a city near the tense border with North Korea. The bombing,

which injured nearly 30 people, two of them seri $ously, occurred \, when \, South \,$ Korean and U.S. forces were engaging in a live-fire drill in connection with their broader Freedom Shield command post exercise set to begin Monday.

This year's Freedom Shield exercise is the allies' first major joint training since President Donald Trump returned to office in January and comes amid

concerns about North Korea's booming military cooperation with Russia.

South Korea and the U.S. announced details of the exercises on Thursday, but it was overshadowed by the news of bombing which drew intense public criticism in South Korea.

Both the South Korean and U.S. militaries halted all live-fire exercises across South Korea. Military officials said that South Korea's air force also stopped the flights of its entire aircrafts except surveillance planes and others needed for emergency situations.

Military officials said the Freedom Shield training will proceed as scheduled and they plan to restart livefire and flight training after they find the exact cause of the bombing and formulate preventative steps.

But if they fail to resume the paused training by

Monday when they kick off the Freedom Shield exercise with the U.S. military, that will hurt the workings of the early parts of the exercise, observers say.

Lee Illwoo, an expert with the Korea Defense Network in South Korea, said the suspension of flight training would particularly cause "really a big problem in examining the two countries' operational plans." He said flying warplanes would

be essential to determining their actual capabilities, discussing the size of reinforcements of U.S. aircraft from abroad and modifying the allies' operational plans.

Initial investigations found the pilot of one of the KF-16s entered wrong coordinates for a bombing site. Officials said the pilots of two KF-16s had more than 200-400 hours of flying time. Lee said they likely piloted KF-16s only two to three years.

The South Korean and U.S. militaries have already begun field exercises in connection with the Freedom Shield, and Thursday's livefire drill was one of them. Col. Ryan Donald, spokesperson for the U.S. military in South Korea, confirmed that American servicemembers were participating in Thursday's live-fire training but no U.S. air force aircraft was still involved.

# SpaceX loses Starship in test

SpaceX launched the eighth test of its Starship rocket on Thursday, successfully conducting and completing the "catch" of the Super Heavy booster. However, the Starship broke apart less than ten minutes into the flight, New York Post reported.

Engineers from Space X said that the 400-foot-tall ship, launched from the company's Starbase facility near Boca Chica Beach in Texas, lost altitude control after several engines stopped working 20 seconds before

the end of the ascent burn. In a post on X, SpaceX stated, "During Starship's ascent burn, the vehicle experienced a rapid unscheduled disassembly and contact was lost. Our team immediately began coordination with safety officials to implement

According to the Federal Aviation Administration, flights at several Florida airports were temporarily grounded on Thursday due to "space launch debris."

## Russia strikes Ukraine's energy grid with missiles, drones

Russia attacked Ukrainian energy facilities with dozens of missiles and drones during the night, officials said Friday, hobbling the country's ability to deliver heat and light to its citizens and to power weapons factories vital to its defenses.

The overnight barragewhich also pounded residences and wounded at least 10 people - came days after the U.S. suspended military aid and intelligence to Ukraine to pressure it into accepting a peace deal being pushed by the Trump administration.

Without U.S. intelligence, Ukraine's ability to strike inside Russia and defend itself from bombardment is significantly diminished. Air-defense systems supplied by the West are cru-U.S. help is uncertain under President Donald Trump,

who says he's determined to end the war. European Union leaders, mindful they may need to shoulder more of the burden for arming Ukraine and strengthen their own defenses, agreed on a plan Thursday to significantly build up their military spending. Ukraine is having a tough

time on the battlefield. An onslaught by Russia's bigger army is straining shorthanded Ukrainian forces at places along the 1,000-kilometer (600-mile) front line. Officials from the U.S. and Ukraine will meet in Saudi Arabia next week to discuss ending the war, which began more than three years ago when Russia launched a full-scale invasion. On Friday, President Trump said on social media he was "strongly considering" placing addicial for Ukraine, but further tional sanctions on Russia to force it into peace talks with Ukraine.

Agreement (USMCA)eligible goods from existing tariffs. As per CNN, the USMCA was negotiated by Trump during his first term, which makes the three North American countries a free trade zone. Explaining the modifica-

## US Supreme Court rejects 26/11 accused Rana's plea for stay on extradition

The US Supreme Court has

rejected the plea of the 26/11 Mumbai attack accused, Tahawwur Rana, seeking a stay on his extradition to Justice Elena Kagan on

Thursday (local time) denied Rana's application, requesting a stay on his extradition to India. Tahawwur Rana had ap-

proached the United States Supreme Court seeking an emergency stay on his extradition to India. In his application, Rana argued that he would not survive long enough to be tried in India due to various reasons.

Rana, through an appeal, stated, "If a stay is not entered, there will be no review at all, and the US courts will lose jurisdiction, and the petitioner will soon be dead." The accused in the 26/11terror attacks claimed that if extradited to India, the likeli-

hood is very high that he will be subjected to torture as he is a Muslim of Pakistani origin. He stated that because of his Muslim religion, his Pakistani origin, his status as a former member of the Pakistani Army, the relation

of the putative charges to the 2008 Mumbai attacks, and his chronic health conditions, he is even more likely to be tortured than otherwise would be the case, and that torture is very likely to kill

him in short order.

He cited the Human Rights Watch 2023 World Report, which documents the BJPled government's systematic discrimination and stigmatization of religious minorities, particularly Muslims. Rana further argued that the Government in India is increasingly autocratic, and there are substantial grounds for believing that he would be in danger of torture if he surrendered to Indian authorities.

In addition to these concerns, Rana highlighted his deteriorating health. He suffers from a 3.5 cm abdominal aortic aneurysm at immediate risk of rupture, Parkinson's disease with cognitive decline, and a mass suggestive of bladder cancer. He asserts that he cannot be sent into a "hornet's nest" where he will be targeted due to national, religious, and cultural animosity.

derivative products, and increase the aluminium tariff rate from 10 percent to 25 percent, effective

from the second week of March. In addition to these measures, Trump also intends to implement tariffs on automobile imports

starting April 2, 2025, indicating that the rate for autos will be approximately 25 percent. He also mentioned that tariffs on

semiconductors and pharmaceuticals would be set at 25 percent or higher, although the specific authority for these tariffs has

not been disclosed. Notably,

he is expected to announce additional tariffs on computer chips, semiconductors, and pharmaceuticals, reinforcing

the anticipated impact of these trade policies on various sectors. These announcements have ignited a significant debate and elicit-

ed varied reactions globally and have also triggered a global stock market decline. In response, China swiftly declared the imposition of additional tariffs ranging from 10 to 15 percent on select imports from the US, effective March 2025, alongside a set of new export restrictions targeting specific US entities. Subsequently, Chinese government has also lodged complaints regarding the US tariffs with the World Trade Organization (WTO). The Chinese foreign affairs ministry issued a bold statement, asserting, If war is what the US wants, be it a tariff war, a trade war, or any other type of war, we're prepared to fight until the end. Indeed, this will take the US-China rivalry to the next level. On the other hand, Canadian Prime Minister Justin Trudeau has openly criticized the tariffs as "a

very dumb thing to do." He further stated that Canada would impose tariffs on the US goods if Trump's tariffs remained in effect. Canada also plans to challenge the US tariffs under the regulations of the WTO and the US-Mexico-Canada Agreement. Meanwhile, Mexican President Claudia Sheinbaum guaranteed retaliation, although she did not provide specific details, indicating that Mexico response would be announced soon. In the light of elevated tariffs imposed by nations including Brazil, India, and China, Trump has also announced that his strategy for implementing reciprocal tariffs would take effect on April 2. As a result, India is experiencing apprehension regarding the matter. However, Indian officials remain optimistic about reaching a resolution, highlighting ongoing trade

discussions between India and the US. The Indian delegation is set to engage in deliberations concerning trade issues, guided by the joint statement that was established during the meeting between President Trump and Prime Minister Modi on February 13. Further discussions are also expected to address key trade concerns and foster a more balanced economic relationship between the two countries. While it is clear that Trump is primarily concerned with domestic issues within the US, it is essential

for him to recognize that his decisions must not undermine the stability of other countries or the global economy. I hope he understands and strives towards the Indian principle of Sarve Bhavantu Sukhinah.

Occult and paranormal themes often make good cinema and there is a large audience available for this across the world. However, the problem with most horror films is that they often turn gory and thereby lose the aesthetics of a thriller. But then there are many exceptions that keep you hooked and spellbound throughout. Daphne Schmon directed film, The Eye, which is one such British psychological thriller had its India Premier a few days back at WENCH Film Festival, in Mumbai.

Shruti Hassan and Mark Rowley in the lead roles in the film, which plays with the idea of 'Evil Eye' and popular beliefs around it. Diana (Shruti Hassan) travels to a remote island to immerse the ashes of her husband Felix

coming into her life and she takes you on a roller coaster ride of her emotional upheavals all through the film. Her emotional expressions and impeccable acting skills while dealing with the supernatural are well supported by the breathtaking natural visuals of the landscapes, sea, and mountains. With the vase of ashes of her husband Diana lands back into the same homestay where she'd once stayed earlier with her husband Felix. She still cherishes

James Chegwyn's cinematography is simply outstanding in many ways including the aerial shots, interesting camera angles, and exemplary wide-angle shots. The Eye is a beautiful film that explores human emotions like no other, using the narrative of the mysterious supernatural in a very classy manner.



Every year on International Women's Day, brands offer discounts on clothing, spas, and makeup, commercialising a day meant to honour women's achievements. This year's theme, Accelerate Action, reminds us that true change requires urgency. accountability, and collective effort.

#### WHY WE NEED TO **AMPLIFY DIFFERENT VOICES**

Equality is not experienced the same way by all women. A woman without sight navigates different barriers than one fighting for equal pay. A trans woman facing violence will likely have a different experience with the legal system than an upper-caste, cisgender woman.

Even where laws exist, cultural biases and inadequate infrastructure keep many women and girls trapped in unsafe environments. If we want true progress, we must address how gender inequality intersects with caste, class, disability, and sexuality.

#### **WHAT CAN WE CHANGE?**

Change happens through legislation and collective action. Consider the 1992 reservation of one-third of Panchayat seats for women. Initially, many women were proxies for male family members. Over time, however, they took charge, creating meaningful change. The abolition of sati and child marriage followed similar patterns—resisted at first, but ultimately unstoppable.

Demanding our rights whether for bodily autonomy, protection from genderbased violence, healthcare access, or workplace equity—must be intersectional. Recognising our different struggles makes our collective fight stronger.

#### THE RIGHT TO WORK: **BREAKING THE MYTH** OF 'LUCKY' WOMEN

Some men claim women are "lucky" because they don't have to work. Yet many women wish they were allowed to. Those who do often face discrimination—denied jobs due to potential maternity leave, unsafe working hours, or the need for separate workplace infrastructure. These barriers are even higher for disabled women, whose workplaces are rarely designed with accessibility



in mind.

#### **WHO NEEDS TO BE ACCOUNTABLE?**

We all do. India has laws protecting women's rights, but they are meaningless without enforcement. Institutions, governments, workplaces, and communities must be held accountable. We must also protect those who challenge inequality. Workplace equity, legal accountability, and gender and caste sensitisation in education are essential

#### **FROM EQUALITY TO EMPOWERMENT**

Equality offers the same opportunities to everyone, but equity ensures those opportunities are accessible to all. Two women with the same salary may experience vastly different realities—one may have private transport and paid childcare, while another struggles with overcrowded buses and unpaid domestic labour. True empowerment requires acknowledging and addressing these disparities.

#### **ME? ADDRESSING INTERNALISED MISOGYNY**

We've all absorbed patriarchal conditioning. Women are judged at every life stage-whether for not marrying, prioritising their careers, or seeking independence. We also dismiss the struggles of trans women, Dalit women, and those from different economic and religious backgrounds, assuming they "don't know any better."

Change starts with us. While we can't force others to shift their views, we can challenge perceptions—our own and those around us.

#### **HOW WE CAN ACCELERATE ACTION**

 Question our biases and listen when they're pointed

 Support marginalised women-Dalit, Bahujan, Adivasi, disabled, trans, and economically disadvantaged.

 Share feminist values equality, respect, and con-

# THE ILLUSION OF TIME





The idea of time has occupied the minds of philosophers for centuries. We believe time is an entity in itself, because we look at our wristwatch or our clock and it apparently tells us 'what time it is'. But wait, the train does not arrive at the station at 7 pm – it arrives at the same moment the little hand reaches 7. So, time is simply an attempt to *measure* the space between two events, in this case leavonly time we use our watches and clocks, to measure these spaces, but only in the physical world. It does not work when in the realm of consciousness

The reason for this is that no one knows what you, or anyone else, is thinking thinking takes place in the consciousness. The space between one thought and another cannot be measured. Only one person is creating that event, that thought, and the next, and so there is no point in measuring them. So, there is no time in consciousness. There is time in the world, time is the measurement we agree upon, using our clocks and watches, but not in consciousness.

So, in the world, time management is really event management. Event management is response management, because we have to create a response to an event. When we raise the quality of our consciousness, we can be fully in the present and live a life unfettered by time machines.

Intention sits behind everything we think, decide, and even our feelings. This requires some kind of attention in order to manage it. Time management is, therefore, attention management. People who attend time management seminars are people who are pretty miserable. They want someone to tell them what to do next or first, what to prioritise. In fact, it is up to them to decide what to give their attention to next. They would do that quite happily IF they 'enjoyed' what they were doing. We naturally give attention to what brings us joy, what we enjoy. That is the principle of creativity. All that is required is clarity of mind. Clarity only comes when there is joy in what we do. If, however, we become time conscious, e.g. deadline conscious, and therefore believe we might run out of time, then fear and panic - in other words, stress - are always just around the corner.

be more time! In reality, there is only now, the present. We spend 'time' thinking about the past or the future which are total illusions. The past is past - it is over, it happened. Yet, we spend time in remembering, in nostalgia. Some of us are deeply attached to the past. What we do not realise is that we are making the past the present. This is a waste of energy. When we think about the future, it is simply speculation. It is also a waste of energy and an illusion because the future can never be real. I can only live in 'the now' when I am free from the regrets of the past and the worries of the future. This is a challenge for most, because our habits are conditioned by past and future. When things get too challenging in the present, we try to escape into the past or the future. Time is our master through the day. When some do not have the

consciousness of time - they seem more relaxed, together and joyful. They do not obsess about 'time' factors their lives are not ruled by the devices that measure time.

In the epic Mahabharata, non-violence has been declared the highest duty of an individual. However, in real life, most people think that it is not feasible to be completely non-violent. Is it so?

When we decide to be non-violent in every situation, it influences our behaviour. Someone who wishes to be non-violent will not do anything that may get him into a situation that involves violence, be it emotional, verbal or, in an extreme case, physical violence. Such a person is likely to be affable, humble, and tolerant. When someone's behaviour is informed by the above qualities, they are unlikely to offend or hurt

anyone, or trigger feelings in others that may cause them to be aggressive. The result would be harmonious relations in which there is no probability of violence of any kind.

**PRANAV VENKATESH** WINS WORLD JUNIOR **CHESS CHAMPIONSHIP** 

ndian Grandmaster Pranav Venkatesh won the prestigious World Junior Championship in classical chess in Petrovac. a coastal town in Montenegro, on Friday, March 7. The 18-year-old claimed the title in the open section, finishing unbeaten with an impressive score of 9/11 points in a field of 157 participants. Pranav secured the championship after drawing with the white pieces against Slovenia's Matic Lavrencic in the eleventh and final round.

Pranav Venkatesh's triumph comes just months after Dommaraju Gukesh made history by becoming only the second Indian after Viswanathan Anand to win the FIDE World Championship crown. Like Gukesh, Pranav hails from Chen-

nai and is a mentee at the WestBridge-Anand Chess Academy, founded by the legendary Anand.

Pranav is also a student of the renowned Velammal Vidyalaya, a school known for producing a steady stream of top chess players.

Viswanathan Anand was among the first to congratulate Pranav on his momentous achievement, lauding his meticulous approach to the game.

"Congratulations to the World Junior Champion Pranav Venkatesh.He has been in great form lately. Our @WacaChess mentee," Anand said.

"He is very meticulous in his work and constantly analyses his own games, comes back with suggestions and takes feedback. You join a very prestigious line of World Junior Champions!

Pranav became the first

Indian since Abhijeet Gupta in 2008 to win the world junior championship. He joined an elite list of Indians, including Viswanathan Anand (1987) and Pentala Harikrishna (2004), to win the top junior prize in classical chess.

Pranav became India's 75th Grandmaster at just 15 years old in 2022, joining an elite list of Indian prodigies. Pranav has made a steady rise to the top. In 2024, he won a sensational double gold at IDE World Youth Under-18 Open Rapid and Blitz Championships in Slovenia.

It has nearly been a 17-year-old wait for the open title to come back to India.

More recently, Divva Deshmukh had won the girls' section when it was held in Ahmedabad in 2024. Before Divya, D Harika had won in 2008 and Koneru Humpy in 2001

# India in top form ahead of Champions Trophy 2025 final

India enters the Champions Trophy 2025 Final in Dubai on Sunday in excellent form, having secured four wins in the tournament, as per the official website of

India's tournament opener saw them prevail in a tight contest against Bangladesh in Dubai, registering a sizzling six-wicket victory to begin their campaign on a winning note.

Pacer Mohammed Shami's impressive 5/53, combined with three scalps from Harshit Rana and two from Axar Patel, restricted Bangladesh to 228.

Shubman Gill's unbeaten 101\*, combined with stylish knocks from Rohit Sharma and KL Rahul, ensured smooth sailing for India as they reached the Tigers' total with 21 balls to spare.

In their high-voltage clash against arch-rivals Pakistan, India displayed their all-round prowess by chasing down 241 runs with six wickets in hand.

Kuldeep Yadav weaved his magic for the Indian side by taking three crucial wickets to bundle out Pakistan for 241 in 49.4 overs.

Shubman Gill (46) and Shreyas Iyer (56) came up

with some crucial knocks, but the age-old rivalry was marked primarily by a Virat Kohli masterclass that saw him score an unbeaten 100

A different challenge for Rohit Sharma's side in the form of New Zealand, with the winner staying unbeaten at the tournament and earning the top spot in Group A. Though when these two sides met, they had both already qualified for the semi-final stage.

to steer India to victory.

New Zealand's bowlers did well to restrict India's batting line-up, with Shreyas Iyer (79) and Hardik Pandya (45) leading the way as the Asian side posted a competitive total of 249/9 after they were sent in to bat first.

It was the Varun Chakravarthy show in reply, with the spinner claiming an impressive five-wicket haul to help bowl New Zealand out for just 205, as India progressed through to the final four with their unbeaten record intact.

India qualified for the Champions Trophy final by taking down another of their top rivals, Australia.

The bowlers applied pressure throughout the Aussies' batting innings, restricting them to 264 all out in the 50th over, consistently finding key wickets throughout. Mohammed Shami chipped in with three big wickets, while spinners Axar Patel and Ravindra Jadeja grabbed a couple.

Once again, it was Kohli who anchored the bulk of India's successful chase, with a poised 84 off 98 balls. The crisp hitting of Axar Patel, KL Rahul and Hardik Pandya saw them home safely, reaching their target with 11 deliveries to

# Gill nominated for ICC 'Player of the Month' for Feb

Riding on his superb performance in the ODI series against England last month, ace India toporder batter Shubman Gill has been nominated along with Australia's Steve Smith and New Zealand's Glenn Phillips for the ICC 'Player of the Month' for February. Gill, who is currently in Dubai with the Indian team for the ongoing Champions Trophy, scored 406 runs, averaging 101.50 at a strike-rate of 94.19 in the five ODIs that he had played in February. Gill hit a purple patch in the three-match



series against England, 60 (in Cuttack), and 112 scoring 87 (in Nagpur), (in Ahmedabad) as he was

adjudged the 'Player of the Series' in the hosts' 3-0 clean sweep.

Gill then went on to score an unbeaten 101 against Bangladesh in the Champions Trophy, followed by a valuable 46 against Pakistan as India secured a place in the semifinals of the ICC's showpiece event.

Australia skipper for the Champions Trophy, Smith shone during the Test series against Sri Lanka, scoring 141 and 131 in the two matches his side played there, with a strike-rate of 136.00. He was named 'Player of the Series' in recognition of those efforts.

In the one-day series, he

scored 12 and 29.

Black Caps' Phillips scored scored 236 in five ODIs at a strike-rate of 124.21. His three unbeaten knocks helped New Zealand win the tri-series in Pakistan, also involving South Africa. They comprised 106 against Pakistan in Lahore, 28 against South Africa at the same venue, and then 20 against Pakistan in Karachi in the final.

He carried that momentum into the Champions Trophy, beginning with 61 against Pakistan in Karachi, and then another unbeaten innings of 21 against Bangladesh in Rawalpindi.

## We'll be putting our thinking caps on: New Zealand coach

Ahead of the ICC Champions Trophy final against India at Dubai, New Zealand head coach Gary Stead said that the team will be putting their "thinking caps" on to tackle spinner Varun Charkavarthy, highlighting the difficulties of facing him under the lights.

India will be playing New Zealand in the final of the ICC Champions Trophy on March 9 at the Dubai International Stadium. With India being undefeated in the tournament so far and the Kiwis having looked rock solid with bat and ball under the captaincy of Mitchell Santner, the clash promises to be an epic sequel to their 2000 ICC Champions Trophy final, when New Zealand won. Men in Blue would like to avenge losses to the Blackcaps in the 2019 ICC Cricket World Cup semifinal and 2021 ICC World Test Championship final.

One of the biggest troubles Kiwis will face will be Varun. who took a five-wicket haul (5/42) that derailed NZ's chase of 250 runs and dismantled their middle order, including scalps of Glenn Phillips, Michael Brace-



well, skipper Mitchell Santner, all of those batters who could have helped NZ from position of 151/3 to reach the target. His spell triggered a collapse, which bundled out Kiwis for 205 in 45.3 overs.

Speaking to the media ahead of the match, Stead said. "Varun Chakaravarthy is a big threat in the game. He is a very good bowler. We will have a look at the pitch conditions and what effects he could have on the game. We certainly expect him to play after getting a fifer. We will be putting our thinking caps around on how we will nulify him and score runs against him. When you have such a wrist spinner bowling, you are looking for cues, and it is much easier in daylight to see those cues.'

Stead also said that Kiwis expect India to field four spinners against them, but

they have a capable fourspinner lineup led by skipper Santner, with Bracewell and all-rounders Glenn Phillips and Rachin Ravindra capable of delivering powerful assists to their lead spinner.

"We have four spinners as well and think we are pretty balanced. But there is always a challenge (against Indian spin). I mean, they are all very good spinners in their own right. So for us, it is just being nice and clear on our plans and working it out, be it a match-up or other sort of things we will read through the match. They (Indian spinners) could also have an off-day as well, that could be in our advantage," he added.

Varun is the leading wicket-taker among spinners in this competition, with seven scalps in two matches at an average of 13.00. Also, Axar Patel and Kuldeep Yadav (five wickets each at an average of 33.40 and 36.60 respectively) and Ravindra Jadeja (four wickets at an average of 38.25) have delivered crucial wickets as well.

For Kiwis, their spinners, Santner (seven wickets in four matches at an average of 27.71) and Bracewell (six wickets in four matches at an average of 28.83) have been among the leading acts.

Sunil Dabas became India's first eve coach to get both Padma Shri in 2014 and Dronacharya Award (To honour eminent coaches who have successfully trained sportsperson or teams and enable them to achieve outstanding results in international competitions) in 2012.
