Small merchants will get incentives at the rate of 0.15% per transaction, value capped at Rs 2,000

The government on Wednesday approved a Rs 1,500 crore incentive for the

promotion of small-value BHIM-UPI (P2M) transactions up to Rs 2,000, a move aimed at benefiting common people and small merchants

The 'Incentive Scheme for promotion of low-value **BHIM-UPI transactions** Person to Merchant (P2M)' for the financial year 2024-25 was approved by the Cabinet chaired by Prime Minister Narendra Modi, Information and Broadcasting Minister Ashwini Vaishnaw told reporters

In a post on social media platform X, the Prime Minister said, "The incentive scheme on promoting lowvalue UPI transactions, which has been approved by the Cabinet will encourage digital payments and further 'Ease of Living'".

The scheme will cover 55 per cent of the total merchant transactions, an of-

ficial release said.

An incentive at the rate of 0.15 per cent per transaction value will be provided for transactions up to Rs 2,000 pertaining to the category of small merchants. For all the quarters of the scheme, 80 per cent of the admitted claim amount by the acquiring banks will be disbursed without any conditions.

Wife, lover kill husband, body sealed inside drum with cement

A merchant navy officer was allegedly stabbed to death by his wife and her lover, his body dismembered and sealed inside a drum with cement, police said. His remains have been recovered and the two accused arrested. The incident took place in the Indira Nagar area here, police said on Tuesday.

The victim, Saurabh Rajput (29) from Brahmpuri's Indra Nagar Phase 2, went missing on March 4 and an investigation was launched after receiving information about the matter, Additional Superintendent of Police (ASP) Ayush Vikram Singh said.

On the basis of suspicion, police detained Rajput's wife Muskan (27) and her lover Sahil (25), he said.

During interrogation, the two confessed to having stabbed Rajput to death on March 4. The two then chopped up his body, put the remains inside a drum and sealed it with cement. They have been arrested, he added.



The remains have been sent for post-mortem and a case has been registered based on a complaint lodged by Rajput's family, police said. According to Rajput's family, Muskan attempted to mislead them by sending messages from his phone.

After committing the crime, Muskan and Sahil went on a vacation to a hill station, the

Police said Rajput and Muskan, from Gauripura, had a love marriage in 2016.

Their families were unhappy with their relationship and the couple lived separately in a rented house in Indira Nagar Phase 1 with their three-year-old daughter, police said.

Niti Aayog report says 70 per cent of water supplied in country is contaminated: Cong MP

pposition members on Wednesday said there were gaps in the implementation of the government's various drinking water schemes and flagged concerns of water contamination in several parts of the country.

Participating in the discussion in Lok Sabha on the demands for grants of the Jal Shakti Ministry, opposition members also claimed under utilization of funds allocated to the ministry and said its assertions of the success of the Jal Jeevan Mission remained only on paper.

BJP and NDA members praised the government for providing piped water supply across remote corners of the country and questioned why opposition-ruled states of Jharkhand, Kerala, and West Bengal were lagging in providing clean drinking water to rural households.

Initiating the discussion, BJP member Jagdambika Pal also questioned the opposition's commitment to ensuring safe drinking wa- tunate that he was elected



ter for all.

According to official data, Kerala has the lowest coverage under the Jal Jeevan Mission at 54.41 per cent, followed by Jharkhand at 54.77 and West Bengal at 55.01 per cent.

BJP member Rajkumar Chahar from Uttar Pradesh said in the 16th century, Mughal emperor Akbar decided to shift the capital of his empire from Fatehpur Sikri to Delhi because of water scarcity.

"He shifted the capital from Fatehpur Sikri because of water shortage and high levels of salinity in water," he said.

Chahar said he was for-

as Lok Sabha member from Fatehpur Sikri in 2019 and the same year Prime Minister Narendra Modi announced the Jal Jeevan Mission from the ramparts of the Red Fort.

"A 440-year old problem was was solved in 2019 when the people of Fatehpur Sikri, Agra district, Mathura and Firozabad were allotted funds from the Rs 4.000 crore scheme by the Prime Minister and work is on to supply Ganga water in every household," Chahar said.

Congress member Mohamed Jawed said a Niti Ayog report had claimed that nearly 70 per cent of water supplied in the country was contaminated.

"This index has 122 countries and India ranks 120th," Jawed claimed.

AIMIM leader Asaduddin Owaisi expressed concerns about the ministry's alleged "severe" underutilisation of the allocated

Arguing this to be part of a prevailing trend, Owaisi said the ministry utilised 74 per cent of their allocation in 2021, 72 per cent in 2022, 88 per cent in 2023 and 31.4 per cent in 2024-25.

"The programme may declare victory on paper, but the reality is different,"

Owaisi said reports from Solapur, Aurangand and Palghar districts in Maharashtra reveal persistent water shortages. In drought-stricken Bundelkhand in Uttar Pradesh, people across multiple districts are still desperately searching for water.

DMK member T R Baalu urged the Centre to prioritise connecting northern and southern Indian rivers, highlighting the economic and logistical benefits of such initiatives.

He claimed that the government was moving slowly on the inter-state river-linking projects, particularly in peninsular India.

Baalu said despite promises made during the 2014 elections, substantial steps toward connecting watersurplus Himalayan rivers with water-deficient peninsular rivers remain unfulfilled.

"In 2014, Modi ji had promised to prioritise inter-state river connections, including Himalayan and Peninsular reservoirs. However, as far as peninsular rivers are concerned. not even a detailed project report (DPR) has been developed," he said.

Terrorists will either go to jail or to hell: MoS Home

Union Minister of State (MoS) Home Affairs Nityanand Rai, on Wednesday, sent a strong message to terrorists in the Rajya Sabha, stating that they will either face jail time or meet their demise.

This assertion comes amid the government's zero-tolerance policy towards terrorism, which has led to a significant 71% decrease in terrorist activities.

Replying during the question hour in Rajya Sabha on the issue of terrorism, MoS Home Nityanand Rai said, "Earlier, the terrorists used to be glorified, they were even given great food. But now, under Prime Minister Narendra Modi and its zero tolerance towards terrorism, there have been zero terrorist incidents in the hinterland... Terrorists will either go to jail or hell."

"The Modi government has a policy of zero-tolerance towards terrorism. The government is taking all steps to end terrorism. As a result, there has been a 71 per cent decrease in terrorist activities." Rai added.

Since its inception, the NIA has registered 652 cases, charge-sheeted 516 cases, and arrested 4,232 accused, with 625 convictions.

Include heatwaves in disaster plans: Parl panel to Centre



Rai, in a written reply to Rajya Sabha, said that as of 12.03.2025, the NIA had registered 652 cases since its inception, and 516 cases had been charge-sheeted. The NIA has arrested 4232 accused so far, and 625 have been convicted. Out of a total of 157 decided cases, 150 have resulted in convictions.

Rai emphasised that the National Investigation Agency (NIA) has been instrumental in combating terrorism, with a conviction rate of 95.54% in cases investigated by the agency

"The conviction rate of NIA investigated cases is 95.54 per cent. NIA has seized/attached a total of 551 (movable and immovable) properties under UA(P) Act, worth 116.27 crore rupees," Rai added.

The minister also highlighted the NIA's expanded reach, which includes 21 branch of-

fices across the country, its headquarters in New Delhi, and zonal offices in Guwahati and Jammu.

Prior to 2019, the NIA had eight branch offices. Since then, the Government has opened 13 branch offices and two zonal offices, out of which nine new branch offices and the two zonal offices have been sanctioned and made functional during the last three years only.

Over the last three years, the government has created 625 new posts in the NIA, including technical experts and senior officers.

"The NIA has a total of 1901 sanctioned posts at present, out of which 625 posts (including one post of ADG, six posts of IG rank officers and 105 posts of technical experts) have been created during the last three years,'

Amit Shah counters TMC member over CBI references in RS

Home Minister Amit Shah on Wednesday hit out at Trinamool Congress member Saket Gokhale over remarks in the Rajya Sabha during a discussion on the working of his ministry and said that if the opposition member wants to expand the scope of discussion, everything will be answered.

Gokhale, who initiated the discussion, made references to CBI. Amit Shah said that due to anyone's favour and CBI does not fall under his ministry, but if the scope of discussion is sought to be expanded, "there will be a reply for everything".

Gokhale claimed that as he began interpreting, the Home Minister "dar gaye" (got



scared). Amit Shah strongly countered him and said the question of getting scared does not arise. Amit Shah said he is not in Parliament has won elections repeatedly.

He said the CBI is probing cases on directions of the High Court and spoke of post-poll violence in West Bengal and alleged "inaction" by the Trinamool Congress government. He said no special CBI court had been set up in West Bengal.

A parliamentary panel has suggested that the Centre include "new and emerging" disasters, such as heatwaves, in its disaster management plans. The Department-related

Parliamentary Standing Committee on Home Affairs, in a report tabled in the Rajya Sabha last week, also recommended setting up a system to regularly review and update the official list of disasters.

"The committ mends that the ministry may include new and emerging disasters in its disaster management plans, such as those caused by heatwaves etc. It further recommends establishing

a formal mechanism for the periodic review and update of the Notified Disasters list to ensure the Act remains relevant and responsive to emerging disaster risks through consultation with experts, stakeholders and affected communities," the report read.

The 31-member committee, headed by BJP's Rajya Sabha MP Radha Mohan Das Agrawal, also urged the ministry to study and plan for long-term disaster preparedness, considering climate change and the increasing frequency of disasters.

It recommended greater investment in disaster-resistant infrastructure, including hospitals, schools and transport systems, to reduce damage and speed up recovery.

Amruta S Nair, Climate Campaigner at Greenpeace India, said the parliamentary committee's recommendation to include heatwaves in the notified disasters list is a welcome and long-overdue step that highlights the growing severity of the heat crisis.

"It ensures heatwaves are prioritized in disaster management and response, covering prevention, mitigation and recovery. However, for this move to be truly effective, we must cyclones, droughts, earthensure there are no gaps in the financial aspects and execution as well," she said.

Nair called for a dedicated "heat budget" for heat action plans, along with legally binding and timebound goals for accountability.

She also recommended setting up a specialised body to oversee these efforts and ensure coordination across departments for a unified response. "We need a holistic approach from policy to action to make this move both effective and fruitful."

Currently, the notified list of disasters eligible for National Disaster Response Fund (NDRF) and State Disaster Response Fund (SDRF) assistance includes quakes, fires, floods, tsunamis, hailstorms, landslides, avalanches, cloudbursts, pest attacks, frost and cold waves. However, state governments can use up to 10 per cent of their annual SDRF allocation, subject to

certain conditions, to provide immediate relief for natural disasters they consider significant within the local context, even if they are not included in the centrally notified list. States have previously requested the Centre to add incidents such as elephant attacks, lightning, heatwaves, river and coastal erosion, and public health emergencies like Japanese encephalitis, Nipah and the COVID-19 pandemic to the eligible list for SDRF and NDRF funding. Union Earth Sciences Minister Jitendra Singh recently told the Lok Sabha that the 15th Finance Commission had examined states' requests to expand the list of notified disasters to include heatwaves but did not find merit in it.

Haryana farmers' debt: 27 lakh owe Rs 60,060 crore in loans

Nearly 27.71 lakh farmers of Haryana owe Rs 60,060 crore agricultural loan to the state cooperative banks for several years adding to the financial distress of the state.

The figures were provided by the Cooperation Minister Arvind Sharma in reply of a question by Indian National Lok Dal MLA Aditya Devi

As of December 31, 2024, the unpaid farm loans total Rs 60,060 crore, and 27.71 lakh armers owe this money. As per the figures Sirsa district leading the tally with a total 2.07 lakh farmers owe Rs 6,102 crore followed by in Hisar where 2.68 lakh farmers owe Rs 5873 crore. Even in the urban areas like Gurugram and Faridabad, the amounts are smaller Rs 842 crore and Rs 533 crore, reads the reply the of the Cooperation Minister. On what the government has done in the last 11 years to help farmers clear their debts and how many of the 27 lakh farmers have benefited from government

schemes, Chief Minister Nayab Singh Saini intervened and explained that farmers can take crop loans up to Rs 1.5 lakh from Harvana State Co-Operative Apex Bank (HARCO Bank) and other cooperative banks at a low interest rate of 7%. The Haryana government pays 4% of this interest, and the central government pays 3%, making it easier for farmers to borrow.

Saini said farmers regularly borrow money from banks for their needs and repay it on time. They use the loans to buy things like tractors, harvesters, and other farming tools, which they pay back through medium-term loans. The chief minister informed the house that besides the centre government's welfare schemes introduced for the farmers, the state government also helping farmers in other ways and Under the 'Mera Pani Meri Virasat' scheme, farmers who switch from growing paddy to other crops will now get Rs 8,000 per acre, up from Rs 7,000 earlier, to encourage better farming practices.

Fair polls possible in Bengal only after Prez rule: Suvendu

Suvendu Adhikari, the Bharatiya Janata Party's Leader of the Opposition in the West Bengal Assembly has asserted that free and fair elections can only be held in the State if President's rule is imposed.

He made the comments while leading protests in Baruipur, on the outskirts of Kolkata, which is represented by Assembly Speaker Biman Banerjee. Adhikari led a group of BJP legislators who have been protesting against the Assembly Speaker Biman Banerjee, elected from Baruipur West, over his "undemocratic behaviour" on the floor of the House.. "The Election Commission should take note without imposing President's rule, holding elections in Bengal is impossible." Adhikari remarked at South 24-Parganas Baruipur where a convoy of BJP lawmakers led by Adhikari faced fierce resistance from the Trinamool workers.

On Wednesday afternoon Adhikari, who was suspended from attending the Budget session in the State Assem-

had disallowed a discussion on an adjournment motion brought by the BJP lawmakers, to condemn alleged incidents of violence in different parts of the State during Holi celebrations. "He only does what Mamata Banerjee tells him to do. No one can get justice from such a person," said one of the legislators who had gone to Baruipur.

"Singh was first strangled with an oxygen pipe and his wife was hit with an iron rod on her head," a police source said. Another officer said that a PCR call was received on Tuesday at Subhash Place Police Station regarding a foul smell emanating from a house.

"Upon reaching House No 317 in Kohat Enclave, police found the bodies of the elderly couple lying in separate rooms on the third floor of the building," the officer said.

The state of decomposition suggested they had been dead for about two or three days, he said. Mohinder Singh was last seen alive around 8 pm on Sunday. Exploiting his government job and official vehicle, he gained the trust of unsuspecting job seekers by posing as a well-connected official with links to railway authorities, they said. From the NAFED office in Ashram, New Delhi, he operated a fake recruitment racket, providing counterfeit medical certificates, training sessions, and appointment letters to make the scam appear authentic, the officer said.

NO SUBSTITUTE FOR BOOTS ON THE GROUND: CDS GEN CHAUHAN

There is no substitute for "boots on the ground" as technology can only be an enabler which cannot replace people, Chief of Defence Staff Gen Anil Chauhan said on Wednesday, highlighting ways to deal with new-age conflicts. The chief of defence staff also identified cyber space, disinformation, and economic coercion as essential elements of contemporary warfare.

I think the global security environment is marked by two challenges -- one is uncertainty and other is rapid amount of change, he said.

"The biggest challenge that we face is to train people for reference to Pakistan.

"We have always called it a sub conventional kind of a conflict. We invented this particular term much before the West invented terms like global war on terror or asymmetric warfare or fourth generation warfare or hyper conflicts," he said.

"We have called it conflict below the threshold of conventional conflict and the lesson is that there is no substitute for boots on the ground," he said.

Gen Chauhan said tech-

nology can only be an enabler but it cannot replace people. "I think that is very important."

The CDS also talked about new-age combat zones.

"In conventional conflicts, you shape the battlefield with fire. Over here, we are looking at shaping the mindscape not the landscape. The battle of the mind becomes important as far as hybrid warfare is concerned," he said.

The Union Cabinet, chaired by Prime Minister Narendra Modi, on Wednesday approved the Revised National Program for Dairy Development (NPDD), an official statement said

The Revised NPDD, a Central Sector Scheme, has been enhanced with an additional Rs1000 crore, bringing the total budget to Rs 2790 crore for the 15th Finance Commission cycle (2021-22 to 2025-26).

This initiative focuses on modernizing and expanding dairy infrastructure, ensuring the sector's sustained growth and productivity, it

The revised NPDD will impetus the dairy sector by creating infrastructure for milk procurement, processing capacity, and better quality control.

It is intended to help farmers gain better access to markets, ensure better pricing through value addition, and improve the efficiency of the supply chain, leading to higher incomes and greater rural development.

The scheme consists of two key components: Component A is dedicated to improving essential dairy infrastructure, such as milk chilling plants, advanced milk testing laboratories, and certification systems

It also supports the formation of new village dairy cooperative societies and strengthens milk procurement and processing in the North Eastern Region (NER), hilly regions, and Union Territories (UTs), especially in remote and backward areas. As per the statement, Component A also supports the formation of 2 Milk Producer Companies (MPCs) with dedicated grant

support.

Component B, known as "Dairy through Cooperatives (DTC)," will continue to foster dairy development through cooperation with the Government of Japan and the Japan International Cooperation Agency (JICA), as per the agreements signed.

The release said this component focuses on the sustainable development of dairy cooperatives and improving production, processing, and marketing infrastructure in the nine States (Andhra Pradesh, Bihar, Madhya Pradesh, Punjab, Rajasthan, Telangana, Uttarakhand, Uttar Pradesh, and West Bengal). The implementation of NPDD has made a huge socio-economic impact. It has already benefitted over 18.74 lakh farmers, created over 30,000 direct and indirect jobs, and increased milk procurement capacity by an additional 100.95 lakh litres per day. The NPDD has also supported the promotion of cutting-edge technology for better milk testing and quality control.

Over 51,777 village-level milk testing laboratories have been strengthened. while 5,123 bulk milk coolers with a combined capacity of 123.33 lakh litres have been installed. In addition, 169 labs have been upgraded with Fourier Transform Infrared (FTIR) milk analysers, and 232 dairy plants now have advanced systems for detecting adulteration, as per the statement. It further added that the Revised NPDD is expected to establish 10,000 new Dairy Cooperative Societies, processing in the NER, and the formation of 2 Milk Producer Companies (MPCs) with dedicated grant support in addition to the ongoing projects of NPDD, to generate an additional 3.2 lakh direct and indirect employment oppor-

in India, 77 per cent of fraud decision-makers acknowledge that partnering with external entities is essential for effective fraud prevention. Additionally, 61 per cent agree that sharing fraud data through a consortium is an effective

ing in such consortia, highlighting the benefits of collaborative efforts.

The report highlights that about 48 Indian companies face challenges in implementing ML models due to insufficient training data, and 60 per cent report a lack of quality data.

According to Shail Deep, Chief Operating Officer (COO), Experian EMEA & APAC, as we look ahead, the integration of ML-based fraud prevention is a necessity for businesses to fight back against today's sophisticated fraud threat.

"Our research indicates that 85 per cent of Fraud experts believe the fraud landscape has been dramatically changed by Generative AI. As a result, over 52 per cent have seen an increase in losses from fraud attacks in the past year," she added.

Govt push will lead to municipal bond issuances to exceed Rs 1,500 crore: ICRA

Municipal bond issuances in India are expected to raise more than Rs 1,500 crore in the Financial Year (FY) 2025-FY2026, primarily driven by the Government's push, according to a report by ICRA.

The report added that the share of Green/pooled bonds is also likely to increase, led by a growing focus on Environmental, Social, and Governance (ESG) initiatives and enhancement in the credit profile of Urban Local Bodies (ULBs).

The municipal bond market in India has gained significant traction in recent years, especially since FY2018, largely due to fiscal incentives introduced by the Government of India (GoI).

Since FY2018, the total amount raised in municipal bonds has exceeded Rs 2,600 crore, a substantial increase compared to the period between FY1998-FY2005 when less than Rs 1,000 crore was

Furthermore, in FY2018, the GoI initiated an incentive scheme, offering approximately Rs 13 crore for every Rs 100 crore bond issuance, providing a strong impetus for Urban Local Bodies (ULBs) to use this financing mode.

The report added that despite the positive growth, there are several key challenges that continue to affect the municipal

These include ULBs' high dependence on government grants, lack of adequate and timely financial disclosures, illiquidity, the absence of a secondary market for bonds, high compliance requirements, and relatively weak credit quality of ULBs in accessing capital markets

All municipal bond issuances since FY2018 have been supported by strong structured payment mechanisms.

These mechanisms have been instrumental in enhancing the credit ratings of the bonds, with all issuances receiving an AA rating, despite the diverse credit profiles of the underlying issuer ULBs.

Moving forward, most of the upcoming issuances are expected to follow similar structures and terms, the report added.

Since FY2018, approximately 17 municipal bonds worth about Rs 2,600 crore have been issued, with an average size of Rs 150 crore, as per the report.

ICRA also highlights that persistent challenges, such as improving the ULBs' own credit quality and addressing the lack of adequate disclosure and information systems.

TULSI SPEAKS ON BANGLADESH, **GIVES YUNUS A REALITY CHECK** US Director of National Intelligence (DNI), Tulsi

Gabbard was categorical about Bangladesh during a media interview she gave while visiting India. She spoke of how the "long-time unfortunate persecution, killing, and abuse of religious minorities like Hindus, Buddhists, Christians, and others has been a major area of concern" for the United States. This was validation for the hundreds of thousands of Bangladeshi minorities, particularly Hindus, who have experienced the worst kind of violence unleashed against them by radical jihadi elements, with most of them belonging to the radical Jamaa-e-Islami, which has been ruling Bangladesh's streets ever since 5 August 2024, when Prime Minister Sheikh Hasina was forced to flee. It has been sheer mayhem in the last seven-odd months, where Hindus have faced the worst kind of persecution—from being murdered, raped, to being strung up on poles and tortured to death, their houses burnt to ashes, to their gods and temples razed to the ground. The only term that can be used for such jihadi "students", who have been roaming Bangladesh's streets and meting out instant justice, is death squad. And it is not just the minorities, Awami League leaders and cadre are also being hounded and killed, with their only crime being they belong to Sheikh Hasina's party. Moreover, when power goes to the radicals, they try to impose their ideology on society as a whole, so Bangladesh is witnessing an extreme form of moral policing as radical groups multiply and tighten their grip on the country. Bangladesh is descending into complete chaos, with Muhammad Yuns coming across as losing control of the situation, allowing the jihadis a free pass. At the most he is a figurehead. Just because he won a Nobel Prize does not make him the best person to govern Bangladesh. He was installed in his position because he is close to a particular section of the American political landscape, the reason why he got the Nobel Prize. Leaving that aside, the duty of the so-called caretaker of Bangladesh is to take care of the country, without any discrimination—a duty in which he has failed.





Yunus and the people surrounding him have been trying to paint all the pogrom and mayhem as Indian propaganda, as exaggeration, apart from stating that whatever little bit of violence has taken place is political in nature and not communalas if that justifies the killing. But in reality, he is speaking untruths. Hindus are being targeted not just because they were seen as largely Awami supporters, but also because of their religion. Bangladesh has had a long history of persecuting Hindus, the reason why from around 30% at the time of Partition in 1947, when East Pakistan took birth, the population has dwindled to around 7-8%. Persecution took place even when Hasina was Prime Minister, it was just that she was willing to pay heed to India's concerns and take better care of the minorities. Yunus does not even pretend to do that, allowing the country to slide into complete lawlessness.

Reacting to Gabbard's statement, Yunus said that his country was not going the ISIS way and that Bangladesh was inclusive and moderate—which is anything but the truth. The big mistake he has made is that he has aligned himself with a particular shade of western politics—specifically, the left-liberal sort, which has turned a blind eye to the happenings in Bangladesh ever since he has been installed as caretaker of the interim government. But times have changed, with senior US government personnel more willing to pay heed to other voices too. If he does not realise that, then all his boast about being an international player—he has been saying that—will remain just that, a boast. While no one is denying that Yunus is internationally connected, but he also needs to factor in India's views about him and his country. By trying to play the Pakistani tune, or by aligning himself with Pakistan, if he tries to bypass India's concerns, then he is making a mistake. He is forgetting that his is a puny country, surrounded by India on three sides and with an economy the size of one of India's larger states. He also seems to be forgetting that he is an unelected leader, who does not have the constitutional standing to be called even a head of government. Bangladesh needs a democratically elected government, so Yunus, instead of holding on to power with the help of the jihadis, should quickly facilitate the holding of elections and allow a democratic government to be installed. Meanwhile, he should stop acting as the front man of the jihadis and instead let the minorities live in peace.

Commodifying ranking & accreditation in higher education

Education has always remained the path to evolution and amelioration of society as a whole. In the contemporary competitive Indian job sector, education is what structures a student's career colossally. Parents nurture the silent desire to send their progeny to the best institutes, colleges and universities, aspiring to secure their bright future ambitiously. Hence, the reputation of a college, institute or university effectively determines the

professional standing, code

of conduct, ethics and quality of education, objective and outcome of education, access to cross-disciplinary and inter-disciplinary internationalization, research oppotunities, employment and career prospects. Therefore, the need arose to rank and accredit the colleges and universities across various spectrums of Indian higher education based on quality, competency, infrastructure, research, resource utilization, diversity and gender equality.

Data verification and validation for any university or institute must be handed out to industry personnel, not external agencies who often have a limited professional and tactical knowledge to make a fair and conceptual assessment. The assessment process must be more transparent and digitalized, objectified to weed out unethical practices and peer and monitoring results are to be critically evaluated by multiple stake-holders. A game changer would be to bring in Artificial Intelligence assisted Analysis Mechanism for ranking & accreditation on various revamped NAAC parameters. Periodic audits and snap inspections are a must to ensure compliance with academic and infrastructural standards India's intellectual and

conceptual growth depends on the integrity of her higher education. Financial superiority and interests should not and cannot take any precedence over academic excellence and innovation. The intense competitive rivalry among universities has seen its ramification in duplicitous institutional self-assessment reports and clandestine expert peer review visits. If education becomes another commodity, ranking and accreditation becomes purely transactional.





SUPREME COURT ASKS HIGH COURTS/TRIBUNALS TO DIRECT TRANSFER OF COMPENSATION TO CLAIMANTS' BANK ACCOUNTS

he Supreme Court in the case Parminder Singh Versus Honey Goyal And Others observed and has emphasized the need for the direct transfer of motor accident claim compensation to claimants' bank accounts in order to minimize the delays and also for ensuring timely payments.

The bench comprising of Justice JK Maheshwari and Justice Rajesh Bindal was hearing the present matter. The bench in the case ob-

served that, 'The general practice which is followed by the insurance companies, where the compensation is not disputed, is to deposit the same before the Tribunal. However, a direction can always be issued to transfer the amount into the bank account(s) of the claimant(s) with intimation to the Tribunal.' The bench in the case ob-

served and has streamlined the process for the transfer of the claim amount to the claimant's bank account in relation to motor accident

The bench stated that the



claimants should provide bank account details at the initial stage of the claim process so that tribunals can issue directions for direct transfers after the passing of awards and for minors or cases which requires fixed deposits, the banks should

ensure compliance and report to the Tribunal.

The court observed that, 'For the said purpose, the Tribunals at the initial stage of pleadings or at the stage of leading evidence may require the claimant(s) in order to furnish their bank

account particulars to the Tribunal along with the requisite proof, so that at the stage of passing of the award the Tribunal may direct that the amount of compensation be transferred in the account of the claimant and if there are more than one then in their respective accounts. Therefore, if there being no bank account, then they should be required to open the bank account either individually or jointly with family members only. Thus, it should also be mandated that, in case there is any change in the bank account par-

ticulars of the claimant(s) during the pendency of the claim petition they should update the same before the Tribunal. The same needs to be ensured before passing of the final award. It may be ensured that the bank account should be in the name of the claimant(s) and if minor, through guardian(s) and in no case it should be a joint account with any person, who is not a family member. The transfer of the amount in the bank account, particulars of which have been furnished by the claimant(s), as mentioned in the award, shall be treated

as satisfaction of the award. Intimation of compliance should be furnished to the Tribunal.'

The court also urged all

the High Courts and Tribunals to adopt the said practice in order to ensure timely and efficient disbursement of compensation.

The court directed the Registry to send the order copy to:

1. The Registrars General of all the High Courts for placing the same before the Chief Justice of the High Court for further circulation and compliance by the concerned Tribunals or

2. The Directors of the National Judicial Academy and the State Judicial Academies.

In the present matter, the court was hearing an appeal filed seeking enhancement of compensation for the 100% disability suffered by a claimant due to a motor vehicle accident in 2006, when the claimant was aged 21 years. The court while considering the facts and circumstances of the case stated that it needed to make certain observations in relation to the mode of payments.

Supreme Court to hear pleas challenging CEC (Appointment) Act on April 16

The Supreme Court in the case Dr Jaya Thakur & Ors. v. Union of India & Anr. and connected cases observed and has scheduled the hearing of petitions filed challenging the constitutionality of the Chief Election Commissioner and Other **Election Commissioners** (Appointment, Conditions of Service, and Term of Office) Act, 2023, for April 16.

The petition filed is listed before the bench comprising of bench comprising of Justice Surya Kant and Justice NK Singh for the removal of the Chief Justice of India, CJI from the selection panel responsible for appointing Election Commissioners, ECs.

It has been observed that. the Election Commissioners, ECs are to be selected by a panel comprising the Prime Minister, a Cabinet Minister and the Leader of the Opposition.

The counsel, Advocate Prashant Bhushan, appear-Democratic Reforms, mentioned the present matter on March 19, 2025.

The counsel, Advocate Prashant Bhushan requested for a priority listing on another day since the matter - listed as item 38 today - was not likely to be taken up due to the Court's packed schedule.

The Supreme Court in the case Leelawati (Dead) Thr. Lrs. Versus State Of U.P. And Ors criticized a litigant for filing multiple petitions filed before the High Court wherein the applicant hides the dismissal of an earlier petition

The court in the case observed and has imposed of cost and increased the penalty for an amount to Rs 50,000, wherein the court emphasized that such measures are essential to deter frivolous and vexatious litigation.

The court stated that, 'If the parties misuse the process and attempt to obtain an order by 'trick and stratagem.'

The court observed that, 'The court would be justified in imposing the costs for igniting such vexatious litigation.

The bench comprising of Justice JK Maheshwari and Justice Aravind Kumar was hearing the present matter.

She filed another petitioner, when no action followed i.e., the third one which was dismissed with a cost of 20,000 for concealing the previous dismissal and misleading the court by relying on the expired 2006 interim

Aggrieved with the same, she approached the Supreme Court.

The court in the case noted that the appellant had mis-

used the judicial process by filing multiple petitions and concealing material facts.

The Court also observed that the interim order of 2006 had merged with the final order of dismissal and could no longer be relied upon to file another writ petition seeking a direction to the authorities for eviction with police assistance.

The court in the case reasoned that once the Petition in which the interim order of 2006 was passed was dismissed then another petition cannot be filed seeking compliance of the interim order because the interim order lacks enforceability after the dismissal of writ petition.

The court also held that the filing of third petition was not necessitated and was only a vexatious and frivolous litigation just to mislead the court to gain a favourable order upon suppressing material fact about the dismissal of the first Writ Petition.

It has been held by the court that such kind of conduct amounted to abuse of the judicial process and justified the imposition of exemplary costs. The court observed that, 'This court is compelled to observe that, on dismissal of the writ petition, interim order if any, passed in the proceedings would merge with the final order. In other words, on dismissal of the writ petition on December 05, 2012, the interim order dated September 22, 2006 had merged in the final order and lost its efficacy. As such, the action of the appellant persuading the Court by filing the writ petition does not seem bona fide. The High Court, in our view, has 7 rightly deprecated the action of the appellant to approach High Court again and again for implementation of the interim order passed in the dismissed writ petition lacks bona fides of petitioner and imposition of cost is fully justified. The court while consider-

ing the facts and circumstances of the case stated that, 'It being necessary to observe that the proceedings initiated in the Court of law are initiated for adjudication of disputes and to provide iustice to the parties, by which trust and confidence of the litigants reposed on this great institution can be maintained.

The Delhi High Court in the case The Indian Hotels Company Limited Versus Gaurav Roy Bhatt And Anr. observed and has declared 'Taj' a well-known trademark in respect of hotels and other related services in the hospitality industry.

The bench headed by Justice Amit Bansal stated that, 'The long duration for which the TAJ marks have been in use by the plaintiff, wide geographical area of their use, their knowledge among the general public and their goodwill and reputation due to the extensive promotion, publicity and extensive revenue generated by the plaintiff, in India as well as other countries, the TAJ marks have achieved the status of well-known trademarks.

The court stated that the

Indian Hotels Company Limited, which operates hotels under the name of 'Taj', fulfilled all the criteria as stated under Section 11(6) read with Section 11(7) of the Trademarks Act for declaring 'TAJ' marks as well-known trademarks.

In the present matter, the suit is filed by the Indian Hotels Company Limited, who being a part of TATA Group of Companies, against various individuals for allegedly infringing its registered trademarks as well as for copyright and passing off

of their services. The counsel appearing for the Indian Hotels Company Limited referred to various data and documents in order to satisfy the factors relevant in deciding whether the TAJ marks were eligible to be declared as well-known trademarks.

The court in the case

observed that the Hotels Company Limited established well beyond doubt that the TAJ marks have acquired the status of wellknown trademarks which being within the meaning and scope of Section 2(1) (zg) of the Trademarks

It has also been noted by the said court that another mark of the Indian Hotels Company Limited- VIVANTA, which is also used in relation to hotels, has already been declared as a well-known trade mark by a coordinate bench in September 2022.

The court while considering the facts and circumstances of the case stated that, 'In terms of prayer clause contained in paragraph no.79(vii) of the plaint, a decree of declaration is passed declaring the TAJ marks as well-known trademarks within the meaning of Section 2(1)(zg) of the Act.'

Their mission was supposed to last only one week but ended up being extended due to technical delays. The crew, aboard SpaceX's Dragon Freedom capsule, safely splashed down off the coast of Tallahassee, Florida, marking the end of a lengthy and complex journey in space. As they returned, their physical and psychological health will now be under scrutiny due to the challenges astronauts face after prolonged space travel.

THE RETURN JOURNEY **AND SPLASHDOWN**

The four astronauts began their return journey after a 17-hour trek back to Earth, starting at the International Space Station (ISS). The splashdown occurred on Tuesday, at 5:57 pm ET (3:27 am IST), off the coast of Tallahassee, in the Gulf of Mexico. After landing, the crew was taken out of their capsule and placed on reclining stretchers, immediately whisked away for routine medical checks.

While the splashdown was a major milestone, the health challenges faced by the astronauts as they readjust to Earth's gravity are far from over. Their return journey has sparked interest in both the challenges of longduration spaceflight and the health implications for astronauts who spend extended periods in microgravity.

WHY WERE THEY CARRIED AWAY ON STRETCHERS?

After spending nearly nine months in space, Sunita Williams, Butch Wilmore, and

the other astronauts were carried away on stretchers, which immediately raised questions. The reason for this is tied to the physical toll of space travel. In microgravity, the human body undergoes significant changes due to the lack of gravitational forces. Astronauts often suffer from muscle atrophy, bone density loss, and fluid shifts during their time in space.

When astronauts return

to Earth after such long missions, they face several challenges in readjusting to gravity. The body has to reorient itself to the gravitational pull, which can affect balance, muscle strength, and cardiovascular function. The stretching of muscles, the loss of calcium in bones, and the redistribution of bodily fluids (especially to the head) are common effects. As a result, astronauts are often assisted by medical professionals and monitored closely as they undergo the post-mission rehabilitation program designed to help them recover from these effects. The reclining stretchers are part of the health protocols to ensure that astronauts are not put at risk due to possible dizziness, weakness, or other complications that can arise after spending long periods

THE ROLE OF SPACEX AND NASA IN THE MIS-SION

This mission also underscored the growing collaboration between private companies like SpaceX and government agencies like NASA. The crew's extended stay was due to technical failures in Boeing's Starliner spacecraft, which had been meant to return them to Earth. With Starliner capacity of private companies to participate in crew rescue operations, a task previously handled solely by government agencies.

The successful operation raised new questions about public-private partnerships in space travel, with many experts noting that such collaborations could be vital for future missions to the Moon and Mars.

This marked a significant moment in space exploration, as it demonstrated the When they are in space for such extended periods, the human body experiences various challenges, particularly related to bone loss, muscle atrophy, fluid shifts, and cardiovascular changes.

Upon returning to Earth,

astronauts must undergo a post-mission rehabilitation program designed by NASA to help their bodies readjust.

Muscle Atrophy: In the absence of gravity, astronauts do not use their muscles as much as they do on Earth. This results in muscle wasting, which can take time to correct once back on Earth.

Bone Density Loss: The absence of gravity also affects bone health, leading to a significant decrease in bone density. Astronauts on long missions are at increased risk of fractures and other bone-related issues after they return.

Fluid Shift: The redistribution of bodily fluids in microgravity can lead to fluid buildup in the upper body, especially in the head. This can increase intracranial pressure, which can alter the shape of the eyes and even lead to vision problems known as Spaceflight-Associated Neuro-Ocular Syndrome (SANS). Astronauts often experience mild-tomoderate vision impairments due to this condition.

Cardiovascular Effects:

Spaceflight affects the cardiovascular system. Upon return, astronauts may experience orthostatic hypotension, a condition where the heart struggles to pump blood efficiently when standing. This can cause dizziness and fainting.

NASA'S 45-DAY REHA-**BILITATION PROGRAM**

NASA's post-mission rehabilitation program is designed to help astronauts recover from the physical effects of their missions. The 45-day program includes medical assessments, physical therapy, and other treatments aimed at restoring the astronauts' strength and balance. However, full recovery can take longer, especially in cases of bone density loss and other long-term effects of spaceflight.

Astronauts will undergo physical exams, including tests for muscle strength, bone health, and cardiovascular function. They will also receive support for psychological well-being, as longduration space missions can take a toll on an astronaut's mental health due to the isolation, confinement, and psychological stress of space travel.

POST-MISSION HEALTH AND PSYCHO-



LOGICAL EFFECTS

While the physical challenges are significant, astronauts also face psychological issues after long-duration space missions. The isolation, uncertainty, and lack of natural environmental cues (such as the sun setting or rising) can lead to stress, anxiety, and depression. NASA addresses these issues by providing astronauts with regular communication with family members and psychologists, as well as entertainment such as films, books, and music to alleviate boredom.

In addition to these psychological concerns, astronauts face the risk of radiation exposure, which increases the likelihood of developing cardiovascular diseases and certain types of cancer. Postmission health monitoring is crucial to ensure that the astronauts recover fully and mitigate any long-term risks

from their extended time in

The return of Sunita Williams, Butch Wilmore, and their colleagues marks the successful completion of a challenging and unexpected mission. Their resilience in space, despite facing unforeseen delays, showcases the strength and dedication required to explore space. As they begin their recovery process, their health will be carefully monitored, providing valuable data for future space missions, particularly those to the Moon and Mars. The collaboration between NASA and SpaceX, as well as the global recognition of their achievement, underscores the importance of continued investment in space exploration and the potential for further advancements in human spaceflight.

Putin maintains control in Ukraine peace talks, offering little to Trump

n a recent phone call with Donald Trump, Vladimir Putin furthered his strategic ambitions, edging closer to repairing Russia's relations with the U.S. while driving a wedge between Washington and Europe. However, analysts note that he offered minimal concessions regarding Trump's efforts to broker peace in Ukraine.


Ahead of the Tuesday conversation, the U.S. had proposed a 30-day ceasefire as a preliminary step toward a broader peace agreement, with Ukraine in principle agreeing to the plan. Instead, Putin consented only to a narrow ceasefire focusing solely on halting attacks on energy infrastructure for a month.

Though the White House hailed the agreement as a significant step forward, marking the first time in over three years of conflict that both sides agreed to scale back hostilities, it remains limited. The ceasefire applies only to energy strikes and extends to the Black Sea, where discussions on a maritime ceasefire will also proceed. These measures would curtail Ukraine's ability to target Russia's oil infrastructure, a crucial funding source for the war, as well as constrain its naval operations.

Halting strikes on Ukraine's energy grid would offer Russia relief from damaging drone attacks targeting its

oil refineries, which have significantly undermined its refining capacity.

Kozyrev suggested that the ceasefire's vague terms amounted to little more than a strategic maneuver by Putin to maintain leverage. "This selective ceasefire is far from what Trump had demanded—a comprehensive halt to hostilities," he said.

The Kremlin's official readout of the call highlighted that the two leaders agreed to continue bilateral efforts to end the war, a diplomatic approach that has raised concerns among Ukraine and its European allies. They fear that Trump may seek a deal with Putin that excludes them, leaving them vulnerable in the long term.

Putin's goal appears to be to elevate Russia to an equal footing with the U.S. in global diplomacy, seeking to reverse years of isolation and sanctions. Political analyst Tatiana Stanovaya noted that the Russian president is working to sideline the Ukrainian conflict from direct U.S.-Russia relations, furthering his broader diplomatic agenda.

Gould-Davies added that Putin is using this engagement with the U.S. to drive a wedge between Washington and its NATO allies, potentially forcing Europe to act alone to strengthen its own defenses while attempting to limit the decoupling from the U.S.

In sum, while Putin's calculated moves continue to chip away at U.S.-European unity, his offers toward Trump remain cautiously limited and strategically self-serving.



Rakesh Roshan shares fears of being killed by his security guards



Shortly after the release of the film, he was shot by assailants, an incident that left his family shaken.

While speaking to the media, the actor shared that soon after the attack, he was assigned armed security guards for protection. However, instead of feeling safe, Roshan was constantly scared that the guards themselves might "harm" him and accidentally shoot him.

"No matter how many security personnel are around you, you are still an open target. If someone wants to harm you, security personnel won't be able to do anything. If someone wants to do something, these security guards can't help you," said Rakesh.

olvo launched the latest iteration of their flagship SUV, the XC90, in India just a couple of weeks ago at the Embassy of Sweden. It was a gala event, completely befitting a vehicle that costs Rs 1,02,89,000, ex-showroom. However, thankfully, they didn't choose the usual method of first drives for the new XC90 where auto journalists are flown to another city and given just a few hours to drive the vehicle. Instead,

XC90 was one such vehicle. It looked perfect and, honestly, it didn't need any changes in its design. However, Volvo said at the launch that they wanted to bring it closer to the EX90's design to bring a sense of familiarity throughout the range. I disagree despite knowing the company's commitment of going fully electric sooner than all others. In my opinion, the XC90 and EX90 are two different vehicles, and as

your money wisely. The material quality, fit-andfinish, and ergonomics are absolutely faultless.





he charming chirping of sparrows, a melody ingrained in our childhood memories, has been slowly fading from our lives. For years, these small, social birds filled our mornings with their delightful songs, hopping from branch to parapet. Their presence was an essential part of our everyday experience, so much so that sparrows were often associated with childhood lullabies and the soft, welcoming chirping that woke us from

sleep each morning. However, this serene picture of sparrows, often found flitting about our gardens and rooftops, is becoming increasingly rare. Where Has the Pride of Our Homes Gone... The Little Bird?

The little bird that once chirped and hopped around in the courtyards of our homes was more than just a creature; it was the pride of every household. The sight of sparrows building their nests from straw between the tiles of kutcha houses, in the cracks of walls, behind pictures, in the corners of girders, under tin roofs, and even in water pipes on the roof, was common in every home. Even abandoned homes, left empty for years, were given a new life and a sense of warmth because of their chirping. From small children to the elderly, everyone was happy to take care of these little creatures, feeding them and offering them water

The sparrow, a symbol of culture, freedom, joy, and tradition, has been a part of our lives for centuries. Unfortunately, in today's world, it seems as if this beloved bird is on the brink of extinction. With the rapid development of our cities and villages, the once-vibrant natural spaces where sparrows thrived have been replaced with concrete jungles. Electricity towers and mobile phone towers have replaced trees, causing a dramatic decline in the sparrow population.

THE SPARROW: A FRIEND OF FARMERS

Sparrows are small-sized

birds with grey or black wings and a length of about 14-18 cm. Their round heads, small tails, and pyramid-shaped beaks make them easily recognizable. Sparrows prefer nesting in cavities, such as those found in trees, rocks, buildings, and even the nooks and crannies of houses. They usually breed from April to August, but nests have been observed throughout the year. A typical sparrow nest contains 4-5 eggs, which are white or lightcolored. The incubation period lasts between 11-14 days, and after 14-16 days, the chicks are ready to take their first flight.

Sparrows have long been considered a friend of farmers. These birds are insectivores, meaning they feed on pests such as insects, flies, mosquitoes, spiders, and caterpillars. For centuries, sparrows have helped maintain ecological balance by controlling the insect population, particularly those that damage crops. They also feed their chicks on these pests, making them valuable allies in agricultural ecosystems. In this way, sparrows play an important role as bio-indicators of a healthy environment.

WHY ARE SPARROWS DISAPPEARING?

Despite the important role they play, sparrows are increasingly disappearing from our homes and fields. Several factors contribute to their declining numbers. The most significant issue is the rapid urbanization and

the construction of concrete housing, which has left sparrows with fewer places to nest. Traditional tiled roofs, which once provided perfect nesting sites, have been replaced by cemented roofs that offer no nesting opportunities. Similarly, with the installation of nets on windows and ventilators, sparrows no longer have easy access to the interior of houses, which was once a popular place for them to make their homes.

Additionally, the reckless cutting down of trees and bushes has destroyed the

natural habitats of sparrows, leaving them with fewer places to breed. Furthermore, the widespread use of pesticides in agriculture has severely impacted the insect population, which is the primary food source for sparrows. The lack of insects has led to a decline in the sparrow population, as they struggle to find enough food to survive. Some studies also suggest that mobile phone tower radiation may be affecting sparrow reproductive capabilities, further exacerbating their decline.


