# **CASH ROW: PROBE IN CRUCIAL STAGE; BURNT NOTES SEEN IN GARBAGE**

Findings of the committee will decide the fate of the Delhi High Cout Justice Yashwant Varma.

ith Chief Justice of India Sanjiv Khanna constituting a three-member panel to probe the discovery of "four to five semi-burnt sacks" of Indian currency notes after a fire incident at the residence of Delhi High Court judge Yashwant Varma, the in-house procedure has entered the crucial second-stage whose findings will decide the fate of the judge.

The fire incident at the storeroom of the official residence of Justice Varma on March 14 purportedly led to the discovery of the cash by firefighters and police personnel.

The CJI constituted the three-member panel after the Delhi High Court Chief Justice Devendra Kumar Upadhyaya in his report dated March 21 and made public on Saturday evening called for a "deeper probe" into the allegations.

appear as an accident. However, forensic reports and a detailed investigation confirmed it was a deliberate act of murder. The police also recovered a 12-page suicide note from the house. In the letter, Harpal blamed his sister and brother-in-law, accusing them of fraudulently taking ownership of his house. "I am tired of fighting. I tried to protect my children by moving to Bahadurgarh with a false identity, he wrote in the note. He had planned to die along with his family, but later backed out due to fear, the police said.

The police arrested Harpal after he was discharged from the hospital. His property dispute and financial troubles are being investigated as possible motives.

"This is a clear case of cold-blooded murder, and we have collected all necessary evidence. The accused has confessed to the crime,' said DCP Mishra.

He said that deliberate amnated state government officers on matters related to disputes concerning waqf properties as well as their registration. Officers of the state governments will now have the powers to derecognise any waqf on anyone's complaint or on a mere allegation of the waqf property being a government property till a final decision

is taken," he said. The Waqf Act of 1995, enacted to regulate Waqf properties, has long been criticised for issues such as mismanagement, corruption, and encroachments.

The Waqf (Amendment) Bill, 2024, aims to address these challenges by introducing reforms such as digitisation, enhanced audits, improved transparency, and legal mechanisms to reclaim illegally occupied properties.



# FCRA certificate by MHA in 2025 TDG NETWORK NEW DELHI

Shriram College of Commerce (SRCC) in Delhi is among 160 associations across India that have been granted the Foreign Contribution (Regulation) Act (FCRA) certificate in 2025, allowing them to legally receive foreign funding.

The Ministry of Home Affairs (MHA) has issued these approvals after scrutinizing the applications under the FCRA, which governs the acceptance and utilization of foreign contributions by NGOs, educational institutions, and other organizations.

## According to official data, Maharashtra tops the list with 25 associations receiving the certificate, followed by Tamil Nadu with 21. Delhi and Karnataka each have 13

# Punjab jail as NSA detention ends deaths at Maha

Khalistan supporter and Punjab MP Amritpal Singh, currently lodged in Assam's Dibrugarh Jail, may be shifted to a Punjab prison in a coming month. The Punjab government has not issued any orders extending his detention under the National Security Act (NSA), which expired on April 22.

Along with Amritpal Singh, NSA could also be revoked for his two associates, Pappalpreet Singh and Varinder Vicky. Recently, seven of Amritpal's associates were transferred from Dibrugarh Jail to Punjab.

A senior Punjab government official confirmed that no decision has been taken regarding extending the NSA period or issuing any related orders. This suggests that the Punjab government is preparing to tighten its grip on Amritpal Singh. Authorities may bring Amritpal Singh and his two



associates to Amritsar for interrogation regarding the 2023 Ajnala police station attack.

On March 20, seven of Amritpal Singh's associates were shifted from Dibrugarh Jail to Amritsar. The Punjab government presented them in court on March 21 and secured a three-day remand, while Amritpal Singh's case remained pending. Due to this, no immediate decision was made regarding Amritpal, Pappalpreet Singh, and Varinder Vicky.

The Punjab government is expected to clarify its stand on Amritpal and his two

associates in the upcoming High Court hearing on March 25 instead of issuing immediate orders.

On February 23, 2023, thousands of supporters

of the pro-Khalistan organization 'Waris Punjab De,' led by Amritpal Singh, stormed the Ajnala police station in Amritsar. Armed

with guns and swords, they were protesting the arrest of Amritpal's close aide, Lovepreet Singh Toofan. Under pressure, Punjab Police announced Toofan's release. The mob broke through police barricades, injuring

six officers. Punjab Police plans to arrest and investigate Amritpal Singh, Pappalpreet Singh, and Varinder Vicky in connection with this attack.

On February 15, 2023, a man named Varinder Singh from Chamkaur Sahib was allegedly kidnapped and assaulted near Jandiala Guru. Amritpal Singh was reportedly present at the scene.

# **COUPLE FOUND HANGING FROM TREE AT DEER PARK IN HAUZ KHAS**

Police have initiated inquest proceedings in the case. They had earlier said that the duo were supposedly aged 17.

This is condemnable and scary we people also come to this park, we are of age but sometimes people come in here and do things, so we are scared,' Ashok said, a regular visi-





# **INDIA TO SECURE THIRD PLACE BEHIND US, CHINA IN NEXT FIVE YEARS: REPORT**

India will make a significant strides in the global trade over the next five years, contributing about 6 per cent in the world's trade growth.

India will make a signifi-

cant strides in the global trade over the next five years, contributing about 6 per cent in the world's trade growth, just behind China at 12 per cent and the United States at 10 per cent, as per a joint report by DHL and the New York University Stern School of Business.

The latest DHL Trade Atlas 2025 anticipates that in five years, India will retain its third-place rank on the scale dimension as well as jump 15 spots to the 17th position on the speed dimension as its compound annual trade volume growth rate rises from 5.2 per cent to 7.2 per cent.

The report highlighted that India was only the 13th largest participant in international trade in 2024, but its trade volume grew at a 5.2 per cent compound annual rate from 2019 to 2024, while global trade grew at only a 2.0per cent rate.

- India to drive 6% of global trade growth - Ranks third after China (12%) and US (10%) in next five years.
- Trade volume to grow at 7.2% annually - Rank to rise from 13th to 17th on speed dimension.

"India's rapid trade growth reflected both its swift macroeconomic growth and its increasing participation in international trade," the re-

port added. "The Trade Atlas underlines India's rapid expansion in global trade, positioning the country as a critical hub connecting the east and west. While we anticipate trade volume growth and an increase in global trade share, we remain cautiously optimistic about the future given the global economy's general

# Two decades of bonds of Bhagat Singh and Sukhdev Thapar

3rd March every year is the most sentimental day especially for we Punjabis and also for whole of our nation when young trio Bhagat Singh, Sukhdev and Rajguru were executed to death by Britishers in Lahore jail this day in the year 1931. They were in their twenties. Nation wept and anguish was widespread then.

But, today even after 94 years of their martyrdom the towering message of communal harmony, justice and economic liberty given by their struggle stands as tall and conspicuous as it was then. Rather it is more relevant as country is facing complex socio-politicaleconomic shackles which are accentuated by global free economy. We lament them martyrdom even more today.

Sukhdev was born on 15th May,1907 in Naughara Mohalla in Ludhiana and Bhagat Singh, born on 27th Sep.1907 in a village Banga, District Lyallpur (Chack No.105 RB) which is now where Punjab Kesri Lala part of Pakistan after our Punjab's unfortunate partition in 1947 at the time of independence. Due to death of his father when Sukhdev was at tender age of 4, his mother moved family to Lyallpur to live in the care of Lala Chint Ram Thapar, pa-

ternal uncle at Lyallpur who was a respected nationalist. S. Ajit Singh, a prominent freedom fighter (Bhagat Singh's paternal uncle) had proximity with Shere-e-Punjab Lala Lajpat Rai as both were foremost in the then Undivided Punjab's agitations against the British

rulers' dictates of excessive land revenues and irrigation rates, particularly protests in the year beginning 2007. Lala Chint Ram was also their trusted compatriot as he supported them and also collected funds for many a meeting.

Thus, martyrs' families knew each other and these children ever since their early childhood and school days watched the freedom movement activities of elders. Bhagat Singh as a child was often taken to many a conferences and rallies in which other senior freedom fighters addressed. Sukhdev, had studied in a Lyallpur school where once he refused to give Salami (Salute) to a British inspector. He often collected Rani Laxmi Bai (of 1857 fame Gadar Movement) portraits.

shifted to Nawankot near Lahore where it had some land. He was admitted first in Khalsa High School but later his father preferred DAV School, Lahore from where he completed his Matriculation Examination. He then joined the National College at Lahore

Lajpat Rai was one among prominent in the management. Sukhdev meanwhile had completed his education from Sanatan Dharm High School in Layalpur in 1922. This city had no college then. Sukhdev prevailed upon his uncle for admission in National College, Lahore where Bhagat Singh had got admitted. In fact, this college had wards of all the nationalists who were in the fore front in the then Non-Cooperation Movement of Mahatma Gandhi

against the Britishers. They read and discussed literature of other countries freedom movements hours together. The librarian of Dwarka Das Library at Lahore provided all such books as were asked for by these ardent revolutionary students. Bhagat Singh, Sukhdev and Bhagwati

Charan formed a study circle with other likeminded students. Bhagat Singh was an avid reader ahead of his companions. National College teachers too influenced them in their inclinations to join freedom struggle fullfledged. The backdrop of the 1915 Lahore Conspiracy Case (Ist) in which Kartar Singh Sarabha, a key figure in the Ghadar Party, was executed for his role in the conspiracy has shaken the young minds. Further, the teenage anguish which these young men were nurs-



ing against the firing incident of Jallianbagh Targedy on 13th April,1919 at Amritsar earlier changed their future course of life completely later. Thus, the year 1925 and 1926 in the college shaped them to play a bigger role. The families of martyrs could not resist hem and they refused to marry too. Bhagat Singh secretly came in support of Kakori Conspiracy Case's young prisoners of Hindustan Republican Association (HRA) of train robbery of government cash that took place at Kakori, near Lucknow in 1925 as they wanted to fund their struggle. He spent time at Kanpur and Lucknow. Back to Lahore he with other young men formed The Naujawan Bharat Sabha at Lahore with the main aim of awakening political consciousness in the people of Punjab and mobilized the youth, peasants and workers towards the nationalist movement. They distributed literature of their activities. The British CID too kept eye on them but, they operated secretly.

sion from UK visited Lahore on 30th October 1928, Lajpat Rai in a non-violent march gave the slogan "Simon Go Back!". The police superintendent in Lahore, James A. Scott, ordered lathi charge and personally assaulted Rai to which Bhagat Singh and Sukhdev were a witness to that incident. Later Lajpat Rai had died. The youth in this group pledged to avenge. The revolutionaries' group of Rajguru, Sukhdev, Bhagat Singh and Chandra Shekhar Azad plotted to kill Scott to send a message to the British government However, in a case of mistaken identity, Bhagat Singh was signaled to shoot John P. Saunders, an assistant superintendent of the Lahore Police. He was shot by Rajguru and Singh while leaving the District Police Headquarters in Lahore on 17 December 1928. All these young men hoodwinked police and left in the evening train to Calcutta the next day in disguising and could not be caught. In the year 1929, the Brit-

For years, global markets have questioned the impact of China's competitive strategies-often aided by state support-across industries ranging from consumer electronics to heavy machinery. Yet, beneath the surface of traditional exports lies an equally formidable engine: a domestic cybersecurity ecosystem with growing regional influence. Nowhere is this more evident than in India, where Beijing's technological reach increasingly shapes digital governance frameworks.

In India, this highlights citizens' awareness of digital regulations, particularly following the 2008 amendment to the IT Act, which governs online content and cybersecurity. This amendment to the 2000 law allows central and state governments to punish or censor people for publishing or messaging unwanted or inflammatory content.

Unlike typical software export stories, Sentinel-Labs recently revealed how Chinese tech firms offer legitimate services to civilians while providing Censorshipas-a-Service (CaaS) to governments, raising critical concerns about transparency and market fairness. If a cybersecurity firm can deliver standard Endpoint Detection & Response (EDR) solutions to private customers while enabling government content-monitoring platforms, it significantly alters the risk landscape for businesses operating in In-

n March 23, 1931, Bhagat Singh, Sukhdev Thapar, and Shivaram Rajguru were hanged by the British in Lahore Central Jail for their involvement in the Lahore Conspiracy Case, specifically the assassination of British police officer John Saunders. Their martyrdom sparked a nationwide awakening and strengthened the Indian freedom movement, inspiring countless revolutionaries.

While not formally declared by a government decree, the date of their execution became a focal point for remembering their sacrifices and the broader struggle for India's independence.

The day is now observed as Shaheed Diwas, a day to honor the courage and sacrifice of the three revolutionaries and other freedom fighters.

On this day, various events are held across India to honor the sacrifices of Bhagat Singh, Sukhdev Thapar, and Shivaram Rajguru, including wreath-laying ceremonies, patriotic rallies, and school programs.

Bhagat Singh, Rajguru, and Sukhdev's 1931 execution transformed them from condemned revolutionaries into enduring symbols of India's independence struggle, igniting nationwide fervor.

# **BHAGAT SINGH**

Bhagat Singh did not have any children. He remained unmarried and dedicated his life to the cause of the Indian independence movement. On the morning of his execution, Bhagat Singh was reading the book "Reminiscences of Lenin" by Clara Zetkin. When asked what his last wish was, Bhagat Singh replied that he was studying the life of Lenin and wanted to finish reading the book before his death.

# FAMILY

After Bhagat Singh's execution in 1931, his family faced immense hardships and persecution from the British authorities. They were subjected to constant surveillance and harassment. Bhagat Singh's father, Kishan Singh, was arrested in connection with his son's activities and spent several years in jail.

He was married to Vidyavati, who was the mother of Bhagat Singh. Durgawati Devi was his wife. He had done his education in Dayanand Anglo Vedic High School at Lahore and National College at Lahore. He strictly believes in nationalism, communism, socialism and anarchism.



# **SECTION 148 OF NI ACT: CONDITION OF 20% DEPOSIT OF COMPENSATION MUST NOT BE UNJUST OR DEPRIVE RIGHT TO APPEAL, SAYS ALLAHABAD HIGH COURT**

he Allahabad High Court in the case Rajesh Kumar Gupta v. State of U.P. and Another observed and has reiterated that while passing an order imposing the condition of depositing 20% of the compensation amount under Section 148 of the Negotiable Instruments Act, the court has to consider that such a condition won't be unjust or would deprive the individual's right of appeal.

The court in the case stated that the imposition of the condition is not mandatory and the court has the discretion to reduce or exempt it in appropriate cases.

The section 148(1) provides that notwithstanding anything contained in the Code of Criminal Procedure, CrPC when an appeal is to be filed against conviction for cheque dishonour under Section 138 NI Act, the Appellate Court may order the appellant to deposit a minimum of 20% of the compensation awarded in proceedings under Section 138.

The Supreme Court referred to the case Jamboo

State of Punjab and Another, Justice Arun Kumar Singh Deshwal stated that, 'It being correct in view of the law laid down by the Apex Court...that while passing order under section148 of the Act, 1881, direction for awarding compensation should not be excessive or unjust and it is not manda-Bhandari vs M.P. State In- tory to impose condition of of the Act, 1881, court can

deposit, 20% of compensation and court has discretion to reduce or exempt in appropriate cases. Therefore, while passing order under section 148 of the Act, 1881, court has to consider that condition of deposit of 20% will not be unjust but also, the fact whether the imposing condition would amount to deprivation of the right of the appeal of the appellant. Therefore, for passing final order under section 148

gather the required facts regarding financial condition of the appellant.'

On the other hand, the Opposite party no.2 filed a complaint against the applicant under Section 138 of the NI Act. Applicant was convicted and filed an appeal against the conviction. The Trial Court directed the applicant to deposit 20% of the compensation awarded to the opposite party.

The Applicant challenged that order under Section 482 of CrPC where the order was set aside and case was remanded back to the appellate court to pass fresh order subject to deposit of 10% of the fine.

The applicant filed an application seeking waiver for depositing 20% of the compensation as the amount was huge and unjust for stay the conviction order. In the present matter, the

application filed by the petitioner was rejected and the applicant was directed

to file his ITR and source of income for the last 5 years for consideration as an exception to the 20% deposit rule. Applicant challenged this order on relying on the judgment of the Apex Court in Muskan Enterprises and Another Vs. State of Punjab and Another, where filing sources of income was irrelevant and the Trial Court ought to have decided whether the 20% deposit was unjust or not.

The bench headed by Justice Deshwal observed that though 10% of the compensation had been deposited by the applicant, for determine the application of exception, the Trial Court has asked his to file his source of income, ITR for the last 5 years. It held that the order of the Trial Court was right in view of the decisions of the Apex Court.

The court while considering the facts and circumstances of the held that while passing final order under Section 148 of the NI Act, the Court must consider whether the condition of 20% deposit is unjust or not. The counsel, Naman Agarwal, Nipun Singh appeared for the Applicant.

# **BOMBAY HIGH COURT: POLICE CONSTABLE HAD ARRESTED** A DRUG PEDDLER, COURT SAYS IT WAS AGAINST THE RULES AND GRANTED BAIL TO THE ACCUSED

The Bombay High Court in the case observed and has granted bail to an accused arrested under the provisions of Narcotics Drugs and Psychotropic Substances, NDPS Act as he was arrested by a constable, which was against the rules. In the present matter, the accused, Rajesh Srinivas Kukan alias Raju Anna, was arrested by the DN Nagar police station in Mumbai on November 08, 2023 as he was found in possession of a commercial quantity of contraband. The court charged the accused under section 8 (c) and Section 22 (c) of the NDPS Act and section 142 of Maharashtra Police Act. As per the case of prosecution, on November 08, 2023, when the policeman was on patrol, they apprehended the accused on the basis of suspicious and he disclosed that he was in possession of mephedrone. MD. Allegedly, 53 grams of mephedrone was seized from him. The bench headed by Justice Milind N. Jadhav in the case found that the search was conducted by a police constable, which violates section 42 of NDPS Act. The court while considering the facts and circumstances of the

case observed and has granted him bail on a bond of Rs 50,000 with certain conditions, which includes regular reporting to the police and a ban on leaving Maharashtra.

# **NGAD FIGHTER UNVEILED: F-47 TO REDEFINE AIR SUPERIORITY**

Boeing's victory in the NGAD contract underscores its strategic resurgence in the defence sector.

air superiority fighter at the White House on March 21 marked a significant moment in the history of military aviation. Shrouded in secrecy for years, the new aircraft was introduced by President Trump, who described it as "something the likes of which nobody has ever seen before." Present at the announcement in the Oval Office were Defense Secretary Pete Hegseth, Air Force Chief of Staff Gen. David Allvin, and Lt. Gen. Dale White, the Air Force's military deputy for acquisition, technology, and logistics.

"In terms of all the attributes of a fighter jet, there's never been anything even close to it, from speed to maneuverability to what it can have as payload. And this has been in the works for a long period of time. America's enemies will never see it coming," Trump said.

The newly christened Boeing F-47 will surpass the Lockheed F-22 and F-35 in technology and combat capability. It is designed to eventually replace the F-22 Raptor. Despite claims from China, American officials insist that the F-47 is truly the world's first crewed sixth-generation fighter. The aircraft has already made several unannounced flights since 2020.

The F-47 will join the Northrop Grumman B-21 Raider bomber in the US Air Force's (USAF) sixth-generation fleet. "The aircraft will have next-generation stealth, sensor fusion, and long-range strike capabilities to counter the most sophisticated adversaries in contested environments," General Allvin said.



## **DISMANTLING THE DEPARTMENT OF EDUCATION**



At least four people were killed, six people were injured and some 1,500 people were evacuated as wildfires fueled by strong winds have scorched areas of the nation's southeastern region, disaster authorities said Sunday.

The fire began in Sancheong County, about 250 kilometres southeast of Seoul, on Friday and spread to other parts.

Of the six people who were injured, five were seriously harmed. All victims were found in Sancheong, accord-

ing to the Central Disaster and Safety Countermeasures Headquarters.

Lee Han-kyung, deputy chief of the disaster control tower, instructed fire authorities to mobilize all available resources to promptly bring the wildfires under control. "Wildfires are rapidly spreading to broader regions due to dry weather, threatening people's lives," Lee said in a disaster response meet-

ing, vowing all-out efforts to put out the fires Firefighters have been

struggling to contain the fires, with about 30 helicopters mobilizing to put out them. Authorities said the

The fire began in Sancheong County, about 250 kilometres southeast of Seoul, on Friday and spread to other parts.

fire in Sancheong had been some 30 percent contained as of early Sunday.

A total of 3,286.11 hectares of land - equivalent to approximately 4,600 football fields - has been burned so far, with more than 1,000 hectares destroyed in Euiseong in North Gyeongsang Province and Sancheong, respectively.

About 1,500 residents have been evacuated to temporary shelters as authorities continue efforts to contain the fires.

As of 8 am, firefighters were working to extinguish wildfires in four areas across the southeastern region.

Pradipkumar Patel, 56, and his daughter were working at a relative's store on Lankford highway in Accomack County, Virginia, when the incident took place, according to news

agency PTI. The county sheriff's office received a call about the shooting after 5:30 am on March 20. When they arrived they discovered that Patel was suffering from gunshot wounds and was unresponsive.

They also found his daughter on the scene, who had been shot as well, while they searched the building.

Patel was pronounced dead on the scene, however, the daughter, who had not been

identified at that point, had been sent to the Sentara Norfolk General Hospital. She later succumbed to her injuries.

Suspect arrested The police on Thursday also announced that they had arrested a man in connection to

the shooting. The 44-year-old man, George Frazier Devon White, from Onancock was kept in custody without a bond, the county sheriff W Todd Wessells said.

The suspect was charged with first-degree murder, attempted first-degree murder, possession of a firearm by a felon and two counts of use of a firearm in the commission of a felony.

The motive behind the shooting was not revealed.

"301 Hospital", where senior Chinese officials and military officers receive treatment and highly sensitive personal data is believed to be stored.

Earlier, the PLA, which is investing heavily in modernisation, cautioned its armed forces against banking heavily on artificial intelligence, saying that AI should be a tool to guide but not a replacement for human

decision-making on the battlefield because it lacks selfawareness capability.

"As AI evolves, it must remain a tool guided by human judgment, ensuring accountability, creativity, and strategic adaptability remain at the forefront of military decision-making," an article published in the People's Liberation Army Daily, the official media of the Chinese military, said in January.

Sunrisers Hyderabad (SRH), last season's runners-up, made a powerful start to their IPL 2025 campaign by defeating defending champions Rajasthan Royals (RR) by 44 runs in a high-scoring thriller.

Opting to bowl first after winning the toss, RR skipper Riyan Parag's decision backfired as SRH posted the second-highest total in IPL history. Openers Abhishek Sharma and Travis Head provided a flying start, adding 45 runs in just 3.1 overs. Abhishek departed after scoring 24, while Head smashed 67 runs before getting dismissed.

The real onslaught came from Ishan Kishan, who dominated Rajasthan's bowlers, bringing up his maiden IPL century in just 45 balls. Heinrich Klaasen contributed with a blistering 34 off 14 balls, while Nitish Kumar Reddy added a quick 30 off 15 deliveries. Among RR's bowlers, Tushar Deshpande was the most successful, taking three wickets, but Jofra Archer had a forgettable outing, conceding 76 runs in his four-over spell.
