elhi Chief Minister Rekha Gupta on Tuesday presented Rs one lakh crore FY26 Budget with ten focus areas, including Yamuna cleaning, economic empowerment of women. infrastructure, water, and connectivity, asserting that it is a roadmap for making the national capital selfreliant.

In her 138-minute speech, Gupta, who also holds the finance portfolio, called the maiden Budget of the BJPled Delhi government "historic", emphasising that the era of "corruption and inefficiency" was over.

This is the first Budget presented by a BJP-led government in Delhi in over 26 years, following the party's victory over the Aam Aadmi Party (AAP) in last month's Assembly elections.

on infrastructure development in the city, the chief minister announced that the government has doubled capital expenditure to Rs 28,000 crore in its 2025-26 Budget.

To combat pollution in Delhi, Rs 300 crore has been set aside by the BJP

Taking a dig at the AAP which ruled the city for over 10 years, CM Gupta recited lines of renowned poet Bashir Badr, "Dil ki basti puraani dilli hai, jo bhi guzra hai usne lootaa hai" (The locality of my

heart is old Delhi, whoever has passed through it has looted it).

Gupta said that the Budget is the first step to develop the national capital.

"Delhi went down in every aspect of development in the past decade. The previous government ruined the economic health of the national capital like termites," she said.

A major focus of the Budget is the cleaning and rejuvenation of the Yamuna River, inspired by the Sabarmati river-front project.

The government has allocated Rs 500 crore for Yamuna cleaning, ensuring that only treated water enters the river through the decentralization of 40 sewage treatment plants (STPs).

Additionally, Rs 500 crore has been earmarked for the repair and upgradation of STPs, and Rs 250 crore for replacing

Parliament approves changes in Disaster Management Act

NEW DELHI

Parliament on Tuesday passed amendments to the Disaster Management Act, 2024, with Home Minister Amit Shah asserting that there will be no centralisation of powers or discrimination with states in handling

Replying to the debate on the bill in the Rajya Sabha, Shah launched a sharp attack on the Congress party's past management of the Prime Minister's Relief Fund, alleging a lack of accountability and transparency during the previous UPA regime.

"This bill ensures transparency, trust credibility and accountability," he said and asserted that the amendments to the Act take forward the fight against disaster from a "reactive approach to proactive and innovative approach".

Listing various initiatives, he said that India is now well regarded in handling disasters and the world is recognising its capabilities.

The amendment bill, which was passed in the Lok Sabha in December 2024, was cleared by voice vote in the Rajya Sabha, with several opposition-moved amendments being negated by the Upper House. About 24 members participated in the debate on the amendment bill.

Shah assured the Upper House and the state governments that there would not



BUDGET AIMS TO PROVIDE TAX CERTAINTY: FM

LS passes Finance Bill 2025 with 35 amendments as Sitharaman announces reduction in tariff slabs from 21 to just eight

inance Minister Nirmala Sitharaman, on Tuesday, underscored the Union government's commitment to providing tax certainty and streamlining business regulations as part of the broader vision to build a Viksit Bharat by 2047.

"The Budget aims to do reforms to build Viksit Bharat by 2047. It aims to provide tax certainty, reforms on ease of doing business also we will have a new Income Tax Bill which is currently with a special Committee. This Bill is not brought as part of Finance Bill," Sitharaman stated speaking at the discussion on Finance Bill 2025.

The lower house on Tuesday passed the Finance Bill, 2025 with 35 government amendments.

Elaborating on tax reforms, she announced a reduction in customs tariff

cutting the number of tariff slabs from 21 to just eight. Additionally, she clarified that either cess or surcharge--not both--can be levied on an item under direct tax provisions.

"We have removed seven custom tariff rates on industrial goods, reducing tariff from 21 to 8 per cent. We have ensured that no rates on industrial goods, one item is cess and a sur-

charge can be applied. Only one can be levied," says FM Sitharaman while speaking on direct taxes.

"Time given to exporters who import some components to produce goods to export has been increased from six months to one vear." she added.

Addressing concerns over indirect taxation, the Finance Minister assured that prasadams from temples, mosques, churches, and gurudwaras would remain exempt from GST.

She also mentioned that a Group of Ministers (GoM) is evaluating GST reductions on ingredients used in preparing these prasadams. Furthermore, she announced that imported drugs for rare diseases--whether by individual patients or research organisations--have been exempted from Integrated GST (IGST).

In a move to support exporters, Sitharaman declared that businesses importing components for export production will now have one year instead of six months to use those inputs, providing them greater flexibility.

On the issue of GST compensation, Sitharaman categorically stated that no pending dues remain for

"When states submitted auditor-certified claims, all payments were made. The law clearly states that GST compensation cess ended on June 30, 2022," she affirmed.

Clarifying the ongoing collection of cess, she explained that the government is currently repaying loans taken during the COVID-19 pandemic and that this repayment process will conclude by early 2026.

He further added, "Additionally, dedicated State-Level Steering Committees periodically review the progress of border works along the India-Pakistan and India-Bangladesh borders to facilitate smooth execution.'

A second question posed to the Mos Home asked, "The manner in which the Ministry plans to address these vulnerabilities which compromise national security?" In his written reply the MoS stated, "A comprehensive and multi-pronged approach has been adopted to strengthen border security and address potential challenges. This includes detailed vulnerability mapping, deployment of additional manpower, and the use of specialized surveillance equipment which have been installed at strategic locations."

"Apart from the above, measures such as round-the-clock patrolling, anti-tunneling exercises, and installation of border floodlights and security fences ensure robust security mechanisms at international borders," the MoS

Manish Tewari files motion to discuss alleged aberrations in judiciary in LS

Parliament, being the supreme legislative body that exercises oversight on both the executive and even an independent judiciary, must rise to the occasion," Tewari stated in his motion.

The Congress MP called on the government to provide a comprehensive statement on the floor of the House regarding the incidents in question, as they have raised concerns about the integrity, impartiality, and fairness of the judicial system. 

Consumer protection, empowerment being ensured with progressive legislations: MoS

The Minister of State for Consumer Affairs, Food and Public Distribution BL Verma said that the department of consumer affairs said is continuously working for consumer protection and empowerment of consumers by enactment of progressive legislations.

The Minister informed the House in reply to the question by Rajya Sabha MP Kartikeya Sharma that with a view to modernise the framework governing the consumer protection in the new era of globalization, technologies, ecommerce markets Consumer Protection Act, 1986 was repealed and Consumer Protection Act, 2019 was enacted.

The Consumer Protection Act, 2019 provides for a three tier quasi-judicial machinery at District, State and Central levels com-



monly known as "Consumer Commissions" for protection of the rights of consumers and to provide simple and speedy redressal of consumer disputes including those related with unfair trade practices.

The Consumer Commissions are empowered to give relief of a specific nature and award compensation to consumers, wherever appropriate. The National Consumer Helpline (NCH) administered by the Department of Consumer Affairs has emerged as a single point of access to consumers across the country for their grievance redressal at a pre-litigation stage.

To safeguard the interests of consumers from unfair trade practices in e-commerce, the Department of Consumer Affairs has notified the Consumer Protection (E-commerce) Rules, 2020 under the provisions of the Consumer Protection Act, 2019.

No proposal to integrate AI, IoT into PDS: MoS to Rajya Sabha

Minister of State for Consumer Affairs, Food & Public distribution Nimuben Jayantibhai Bambhaniya said that at present there is no proposal to integrate Artificial Intelligence (AI) and Internet of Things (loT) into **Public Distribution System** (PDS).

In a reply to the question raised in the Rajya Sabha by MP Kartikeya Sharma, the Minister further informed the House, the government is implementing 'Scheme for Modernization and Reforms through Technology in Public Distribution System (SMART-PDS)' for the development and implementation of advanced integrated supply chain software in States/UTs. 2024 and the application is expected to be launched in phases from April 2025 onwards

old sewer lines.

A major focus has also been placed on clean drinking water and sanitation, with Rs 9,000 crore allocated for related projects.

The health sector has been allocated Rs 6,874 crore, with a focus on setting up health and wellness centres and expanding the Ayushman Arogya Mandir initiative. The Delhi government has also allocated Rs 210 crore for providing nutrient kits and an allowance of Rs 21.000 to expecting mothers.

The Delhi government has allocated Rs 1,000 crore for improved transport links connecting NCR and a total of Rs 12,952 crore for the transport sec-

To curb corruption in the free-bus ride scheme for women, the government will replace pink tickets with cards.

For women's welfare, Rs 5,100 crore has been earmarked to provide Rs 2,500 per month to eligible women. Additionally, the government will install 50,000 CCTV cameras across the city to enhance women's safety.

Gupta announced that the government aims to make Delhi an investmentand innovation-friendly city. To achieve this, a new industrial policy and a new warehouse policy will be introduced. A Traders' Welfare Board will also be established.

Furthermore, Delhi will host its first-ever 'Global Investment Summit'. which will be held every two years. To support small-scale industries. Rs 50 crore has been earmarked for skill development programs, including bee-keeping.

In a major cultural initiative, the Delhi government will host an 'International Film Festival' with a budget allocation of Rs 30 crore.

The government has also allocated Rs 696 crore for the development in slum clusters and Rs 100 crore has been set aside for opening 100 Atal Canteens across the national capital.

"There is a lot of difference between us and them (AAP). You (AAP) made 'Sheesh Mahal' for yourself, we will build houses for the poor. You installed pot toilets worth lakhs, we

will make toilets for the people in slum areas," she said

On education, Gupta attacked the previous AAP government, accusing it of misleading people about the quality of education. "The AAP government has failed many students in 9th and 11th standard so that their 10th and 12th results appear better," she alleged.

To reform the education system, the government will set up 'CM SHRI Schools', inspired by 'PM SHRI Schools' and aligned with the New Education Policy 2020. The FY26 Budget has allocated Rs 100 crore for these schools.

Additionally, the Delhi government will provide free laptops to 1.200 students passing class 10th and has allocated Rs 7.5 crore for this

CM Gupta also announced a new education hub in the Narela area. The government has allocated Rs 100 crore for a pilot project to remove overhead electrical lines and shift high-tension power lines.

The environment and forest department will receive Rs 506 crore.

"Due to climate change, the nature and scale of disasters have changed. With that, we have to change the way we tackle them. ... To address these problems in an effective manner, we have to make our institutions accountable and provide powers also,"

The amendments have been discussed with all stakeholders and the government accepted 89 per cent of the suggestions it received and incorporated them in the bill, he added.

Highlighting key amendments, Shah said both National Disaster Management Authority (NDMA) and State Disaster Management Authorities (SDMAs) will become "more effective", bringing more clarity and convergence among stakeholders working in the field of disaster management.





Tharoor optimistic for constructive India-US trade talks

Congress MP Shashi Tharoor has expressed optimism ahead of the visit of an American delegation which wil hold talks on the contours of a proposed bilateral agreeement on the India-US trade ties.

RBI BARS EXCESSIVE CHARGES ON **SMALL PRIORITY LOANS**

RBI excludes gold loans from NBFCs from PSL status starting April 1, 2025.

he Reserve Bank of . India (RBI) has made it clear that banks cannot impose excessive charges, particularly on smaller loan amounts under the priority sector lending (PSL) category.

The central bank stated that no loan-related and ad hoc service charges or inspection charges shall be levied on priority sector loans up to Rs 50,000. This step aims to protect small borrowers from unnecessary financial burdens and ensure fair lending practices.

It said "No loan related and ad hoc service charges/ inspection charges shall be levied on priority sector loans up to Rs 50.000".

The Reserve Bank of India (RBI) has issued new Master Directions on Priority Sector Lending (PSL), which will come into effect on April 1, 2025. The updated guidelines are set to replace the

TO SUM IT UP

- Banks cannot impose loan-related or inspection charges on priority sector loans up to Rs 50,000 from April 1, 2025.
- Loans against gold jewellery acquired from NBFCs won't qualify as priority sector lend-
- Banks must report PSL data quarterly and annually; failure to meet targets will require contributions to NABARD's Rural Infrastructure Development Fund (RIDF).
- Existing loans under COVID-19 relief measures will continue to be classified as priority sector lending.

As per the ministry, initiatives such as Make in India, which has enabled the development of advanced military platforms including the Dhanush Artillery Gun System, Advanced Towed Artillery Gun System (ATAGS), Main Battle Tank (MBT) Arjun, Light Specialist Vehicles, High Mobility Vehicles, Light Combat Aircraft (LCA) Tejas have bolstered the growth in the defence production.

The growth has also been bolstered by Advanced Light Helicopter (ALH), Light Utility Helicopter (LUH), Akash Missile System, Weapon Locating Radar, 3D Tactical Control Radar, and Software Defined Radio (SDR), as well as naval assets like destroy-



ers, indigenous aircraft carriers, submarines, frigates, corvettes, fast patrol vessels, fast attack craft, and offshore patrol vessels

The release added that once dependent on foreign suppliers, the country now stands as a rising force in indigenous manufacturing, shaping its military strength through homegrown capabilities. The ministry said that the strategic policies have fuelled this momentum, encouraging private participation, technological innovation, and the development of advanced military platforms. The surge in the defence budget, from Rs 2.53 lakh crore in 2013-14 to Rs 6.81 lakh crore in 2025-26, underlines the nation's determination to strengthen its military infrastructure. According to the ministry,

65 per cent of defence equip ment is now manufactured domestically, a significant shift from the earlier 65-70 per cent import dependency, showcasing India's self-reliance in defence.

A robust defence industrial base includes 16 DPSUs, over 430 licensed companies, and approximately 16,000 MSMEs, strengthening indigenous production capa-

As per the ministry, the private sector plays a crucial role, contributing 21 per cent to total defence production, fostering innovation and efficiency.

The Defence Ministry further added that India targets Rs 3 lakh crore in defence production by 2029, reinforcing its position as a global defence manufacturing hub.

India's semiconductor industry faces supply chain, limited talent challenges: Report

India's semiconductor industry is growing but faces significant challenges such as an underdeveloped supply chain, a shortage of specialized manufacturing talent, global competition, and rapidly evolving technology, according to a report by Jefferies.

The report highlighted that while India has several key advantages, including a strong engineering talent pool and government support, it must overcome hurdles to establish a competitive semiconductor ecosystem.

It said, "The industry also needs to navigate through the challenges of an undeveloped supply chain, limited specialized manufacturing talent, stiff global competition, and rapidly evolving technology." One of the biggest challenges

is the limited availability of



wafers, high-purity gases, specialty chemicals, and ultrapure water, which are essential for chip manufacturing.

While India has a welldeveloped chemical and gas manufacturing sector, particularly in regions like Dahej in Gujarat, companies still need to enhance their capabilities to produce semiconductorgrade raw materials. The government has prioritized the development of the full semiconductor supply chain, including chemicals, gases, and equipment, to reduce dependency on imports.

India is home to nearly 20 per cent of the global semiconductor design workforce, demonstrating its strength in chip design. However, there is a gap in specialized skills required for semiconductor fabrication and testing.

To address this, the report stated that companies are working on skill development and the government is collaborating with industries and universities to create courses tailored to semiconductor manufacturing, assembly, and testing.

Auto ancillaries looking for new markets: Report

Samsung Co-CEO Han Jong-hee dies of heart attack

Samsung Electronics said on Tuesday that co-CEO Han Jong-hee had died of a heart attack, leaving newlyappointed boss Jun Younghyun solely in charge of the tech giant as it revamps its underperforming chip business and navigates trade

uncertainties. Han, 63, became chief executive officer of South Korea's biggest company in 2022 and was also in charge of its consumer electronics and mobile devices division. Jun was appointed as Samsung's (005930.KS) co-CEO just last week at its annual shareholders meeting following his promotion in 2024 to lead its semiconductor division, which has been lagging rivals like SK Hynix (000660.KS) and TSMC (2330.TW) in the global artificial intelligence chip market.

Samsung said in a stock exchange filing that Jun would be the sole CEO of the company after Han's

Samsung shares were down 0.5% in line with the broader South Korean market (.KS11)

The world's biggest mem-



fering from weak earnings and a sagging share price in recent quarters after falling behind rivals in advanced memory chips and contract chip manufacturing, which have enjoyed strong demand from AI projects. VOTER SENSITISATION IS THE NEED OF THE HOUR

ne rising cost of politics in India is preventing candidature of women and young candidates in elections due to various structural and procedural challenges and oligarchization of electoral

India's 2024 general election was billed as the most expensive ever.

According to a study by Centre for Media Studies (CMS), a staggering INR 1.35 lakh crore (US\$16 billion)

was spent by political parties and candidates in 2024 polls. Money power is making a huge adverse impact on democratic integrity and Unregulated institutional design of political parties too.

These are some of the major and pathbreaking findings of a study conducted by the Observer Research Foundation [ORF] Fellows, Niranjan Sahoo and Ambar Kumar Ghosh titled, "The Cost of Politics in India" for Westminster Foundation for Democracy, [WFD] United Kingdom. Some Key highlights of the study are:

Exponential Rise in Costs associated with routine political activities: While most analysts link rising costs to the election campaigns, the study found an equal if not more cost is involved for political aspirants seeking to nurture their constituencies, and more importantly for securing nominations from

politician's routine requirements to carry out sociocultural outreach activities in their prospective constituency can start months, or even years, before an election bid.. An estimated Rs 3-4 lakhs per month as the minimum expenditure that goes toward this routine mobilizational work in a Lok Sabha constituency. Thus, by the time a candidate secures party ticket, he/she would have spent several crores in routine political activities and these are largely borne by the candidates not parties. In richer southern states such as Telangana and Andhra Pradesh, some of the political candidates shared that parties and/or candidates exchanged Rs 5,000-7,000

Many interviewees (particularly from regional parties) confessed that as aspiring candidates they not only have to demonstrate theirmonetary clout to the party leadership, they are expected to fund their campaigns and generously donate to party coffers or fund certain candidates' campaigns. Some candidates particularly from South shared that they had to donate 3-4 crore to secure party nomination. Given these realities, leading parties tend to opt for wellresourced (moneyed) candidates in internal selection

Escalating Campaign Costs: The cumulative costs of election campaigns in India have increased exponentially in recent years.

Based on the interviews conducted for this study, an average Rs 5-10 crore has become the expenditure norm for candidates (major parties) fighting for a Lok Sabha seat. However, these costs can vary greatly depending on a number of factors. For instance, if the contest takes place in a constituency in which political heavyweights are contesting, significantly more resources are likely to

Heightened expenditure was also recorded in cash rich states such as Tamil Nadu, Telangana, Andhra Pradesh and Maharashtra, where the money spent by individual candidates can sometimes reach, or even exceed, Rs 100 crores.

The increasing dominance of business in politics: With skyrocketing costs and most candidates/parties unable to arrange the sum on their own, they are increasingly relying on friends/private businesses to fund their political activities. The end result is this growing dependency on money has paved ways for influx of 'interested

money' into the demo-

cratic processes. Thus, the regionally dominant mining, coal or real estate barons and contractors have emerged as major funders of elections. Beyond funding selective candidates/ parties, people with wealth have found it easy to secure nominations from political parties or often contest as independent candidates. Respondents contented that this trend has dramatically

unbalanced the playing field as traditional politicians without comparable financial support are at a major disadvantage.

Social Media Spend: What has added to escalation in costs is the arrival of digital/ social media requiring candidates to hire tech experts/ buy out social media influences, create and maintain social media profiles, spend on digital political advertisements, etc.

Growing Salience of Vote

Buying: Although votebuying (cash distributed at the level of candidates and parties, mainly takes place in the run up to polling day) is a persistent feature of Indian elections in the past, the scale of vote-buying has increased at an unprecedented level. Nearly all political aspirants interviewed agreed that even if they are not in a position to distribute money for votes, the actions of rival candidates/ parties force them to do so. Some of them confessed that while in earlier times they used to exchange small denominations among their core voters, now they distribute much bigger sums - Rs 2,000-3,000. Sahoo and Ghosh recommend a robust regulation and enforcement of political finance regimes, plugging legal loopholes, Strengthening of disclosure requirements for political parties and individual candidates and stringent enforcement of regulation.

On more substantial terms, the country needs to reform and democratise functioning of political parties. Structurally, the leadership hierarchy of most parties in India are extremely top-down - some are ostensibly family run enterprises - and often intra-party elections for party posts are not conducted for years or are controlled by power wielders within the party. A similarly centralised ticket distribution procedure with limited transparency or laid down procedures for determining the eligibility of the chosen candidates are also common features. This paves the way for clandestine connections between power holders and vested interests within the party, to the detriment of less well connected or female and vouth aspirants.

Sahoo and Ghosh make a strong case for public funding of political parties. Pub-

lic subsidies or state funding for legitimate political activities and campaign expenses can help level the playing

When designed and executed well, public funding to political parties can help stem the influence of 'interest money.' Furthermore, public funding can support the emergence of smaller and newer political entrants.

We also need civic education and voter sensitisation. The growing culture of vote buying and open exchange of gifts, liquor and other material goods for votes has negative impacts for the legitimacy of representative democracy as it erodes the trust-based relationship between a voter and the aspirant and replaces it with a new 'transactional' one.

The situation needs both state and societal efforts to mitigate. ECI, police, federal and state level enforcement agencies need to intensify preventive measures as well as punishing violators. Voter sensitisation by civil society organisations, media and ECI should receive priority building on the successful approaches to improve voters' participation in recent years, conclude Sahoo and Ghosh.

INDIA'S HIDDEN WAR

The Naxalite-Maoist insurgency, ignited by deep-rooted socio-economic inequalities, remains one of India's most complex and enduring internal security battles.

n the dense forests of Chhattisgarh, a gunshot echoed through the night — a chilling reminder that India's longest-running internal conflict was far from over. The Naxalite-Maoist insurgency, spanning over five decades, has claimed thousands of lives, displaced countless families, and left deep scars on the nation's social and political fabric. How did a small uprising in a remote village spiral into one of India's most complex security challenges — and what might finally bring peace?

HOW A VILLAGE SPARKED A **REVOLUTION**

The genesis of the Naxalite movement traces back to 1967 in the village of Naxalbari, West Bengal. A faction of the Communist Party of India (Marxist), led by Charu Majumdar, Kanu Sanyal, and Jangal Santhal, initiated an armed uprising calling for radical land redistribution and the overthrow of oppressive feudal

This uprising, known as the Naxalbari movement, was inspired by Maoist ideology, which advocated for agrarian revolution through state infrastructure, and ment quickly gained traction among marginalized communities, particularly landless peasants and tribal populations who had suffered generations of exploitation and neglect.

"They came to our homes, demanding food and money," recalls an elderly villager from Naxalbari. "But this time, the farmers were ready. They fought back."

The movement symbolized a direct challenge to the entrenched socio-economic hierarchies of rural India. It wasn't just about land — it was about reclaiming dignity.

RISE, FALL, **AND REBIRTH** (19705-19905)

The early 1970s saw brutal suppression of the Naxalite

ties. In 1972, Charu Majumdar was captured and died in police custody, dealing a severe blow to the movement's leadership. However, the ideological fire was far from extinguished.

By the 1980s, the movement had re-emerged with renewed strength, spreading across states like Andhra Pradesh, Bihar,

movement by state authorialites had established a sprawling influence across the so-called Red Corridor - a swath of Maoist-controlled territory stretching from Andhra Pradesh to Jharkhand.

Odisha, and Maharashtra. A major turning point came in 1980 with the formation of the People's War Group (PWG) in Andhra Pradesh. Led by Kondapalli Seetharamaiah, the PWG adopted guerrilla warfare tactics, targeting police stations, government officials.

The Naxalite agenda also expanded beyond land rights to include caste oppression, displacement from development projects, and the rights of indigenous communities.

Entire villages in Maoistcontrolled areas began to function under parallel administrations, with Naxalite groups enforcing their own laws and holding "people's courts" to deliver swift justice — often through violent means. The insurgents' ability to provide protection and settle disputes gained them support among communities neglected by the state.

"The government wasn't helping us," said a tribal elder in Bastar. "At least the Naxals gave us justice even if it was harsh."

By the 1990s, the Nax-

surgency's history came in 2004 with the merger of the People's War Group (PWG) and the Maoist Communist Centre (MCC). This merger resulted in the formation of the Communist Party of India (Maoist), consolidating the movement's strength and leading to an escalation in violent activities.

The newly formed CPI (Maoist) unleashed a series of high-profile attacks on security forces, politicians, and infrastructure projects. In 2010, a deadly ambush in Chhattisgarh claimed the lives of 76 CRPF personnel — one of the deadliest attacks in the insurgency's history.

The Red Corridor expanded across central and eastern India, encompassing areas rich in mineral resources but plagued by poverty and underdevelopment. CPI (Maoist) cadres used the region's dense forests and rugged terrain to their strategic advantage, establishing training camps and launching hit-and-run attacks on government

forces. "We were always one step behind them," admitted a senior police officer who served in Chhattisgarh. "They knew the terrain better than we did."

BETWEEN FORCE AND REFORM

The Indian government's response to the insurgency tary operations and developmental initiatives.

In the early stages, state governments implemented special laws allowing for the detention of suspected Naxalites without trial. Specialized police units such as the Greyhounds in Andhra Pradesh were created to counter guerrilla tactics. However, these measures often resulted in allegations of human rights violations, further alienating local populations.

In 2009, the central government launched Operation Green Hunt — a largescale paramilitary offensive involving 40,000 personnel aimed at dismantling Maoist strongholds. The operation weakened the insurgents' operational capabilities but at a heavy hu-

man cost. Reports of torture, displacement, and extrajudicial killings fueled further resentment among affected communities.

Concurrently, the government introduced the Integrated Action Plan (IAP) in 2010, focusing on development projects in Maoist-affected areas to address underlying socio-economic grievances. While security operations curtailed insurgent activity, the lack of sustained development and continued state excesses hindered long-term success.

"They build a school, but there's no teacher," said a villager in Jharkhand. "They build a road, but it leads nowhere."

FADING INFLUENCE,

LINGERING THREAT In recent years, the insurgency has declined in intensity, largely due to improved counterinsurgency measures and increased surrenders. The number of Naxal-affected districts has decreased from 223 in 2010 to 46 in 2024.

However, sporadic attacks persist. In October 2024, Indian security forces killed 28 suspected Maoist rebels in Chhattisgarh, highlight-

HUMANITARIAN IMPACT From 2000 to 2024, the insurgency has claimed over 4,000 civilian lives and approximately 2,500 security personnel. The Mao-

ists have also suffered significant losses, with around 4,500 insurgents killed. Beyond fatalities, the con-

flict has led to widespread displacement, disrupted livelihoods, and a pervasive climate of fear in affected regions. "We've lost an entire gen-

eration to this war," said a social worker in Odisha. "And the scars will last for generations more."

WHY THE CONFLICT HAS ENDURED

Several factors have contributed to the insurgency's persistence:

• Socio-economic disparities – Endemic poverty and landlessness provided fertile ground for insurgent recruitment.

 Governance failures -Weak state presence and corruption allowed insurgents to fill the vacuum.

• Strategic terrain -Dense forests and difficult terrains provided Maoists with cover and

strategic advantages. • Ideological resonance - The Maoist narrative of class struggle continues to appeal to marginalized communities.

PATHWAYS TO PEACE

Achieving lasting peace in Naxalite-affected regions will require a balanced approach:

OInclusive Development -Infrastructure, education, and healthcare investments are crucial.

CHINA

O Political Engagement - Dialogue with insurgent factions is essential.

O Strengthening Governance - Empowering local institutions builds trust.

O Security Reforms - Military operations must be conducted with respect for human rights.

O Reintegration – Surrender and rehabilitation programs can help reintegrate former insurgents.

THE ROAD AHEAD

The Naxalite-Maoist insurgency is fading — but the scars remain. India stands at a crossroads. A rare opportunity exists to heal the wounds of the past through development and dialogue — but the window is closing fast.

Will India finally seize this chance — or will the embers of rebellion reignite into flames?

SUPREME COURT: CONCEALING DRINKING HABIT JUSTIFIES REJECTION OF HEALTH INSURANCE CLAIM FOR ALCOHOL-RELATED HOSPITALISATION

The Supreme Court in the case Life Insurance Corporation vs Sunita and others observed and has ruled that the insurers can reject health claims which relates to alcoholism if the policyholder concealed alcohol drinking habit while buying the policy.

The Supreme Court in the case approved the decision of the Life Insurance Corporation, LIC to repudiate a claim over the hospitalisation of a policyholder under the 'Jeevan Arogya' scheme since he gave false information regarding his habit of alcohol consumption.

The bench comprising of Justice Vikram Nath and Justice Sandeep Mehta was hearing the present matter.

An appeal was filed by the LIC against the order of the National Consumer Disputes Redressal Commission, NCDRC which upheld the decisions of the State and District fora to pay an amount of 5,21,650 and costs to the claimant.

In the present matter, the claimant's husband, Mahipal, took LIC's "Jeevan Arogya"



vided hospital cash benefits, entitling the insured to daily cash payments of 1,000 for non-ICU hospitalization and

2,000 for ICU hospitalization. Almost a year after taking the policy, the policyholder was admitted to the hospital due to severe abdominal pain. He dies, after a month's hosnitalisation.

On the other hand, the claim was made by the widow of the policyholder which the LIC rejected on the ground that the deceased had concealed material information regarding his chronic alcoholism.

The LIC cited the exclusion clause of the Jeevan Arogya Plan, specifically Clause 7(xi), which excludes coverage for: 'Self- afflicted injuries or condipolicy in 2013. The policy protions (attempted suicide) and/

or the use or misuse of any drugs or alcohol and complications arising from it.

However, the claimant then approached the Consumer Forum, wherein it directed the LIC to reimburse the medical expenses.

The Supreme Court in the case disapproved of the approach taken by the NCDRC and the Consumer Fora.

The court noted that the Consumer Fora misconstrued the policy as a medical reimbursement policy and even if the claim was upheld, the claimant was entitled only to the specified cash benefits.

The court also examined the medical records, wherein it is clearly stated that the patient had a history of "chronic alcohol intake." In the proposal

a specific question - "Does the Life Insured consume Alcohol/Cigarettes/Bidis or tobacco in any form?". The answer given to this question by the policyholder was "No."

Therefore, the SCDRC rejected the hospital note regarding chronic alcohol intake on the ground that it was issued a year after the policy was taken.

The Supreme Court disagreed with the said approach, wherein it is stated that chronic liver disease, caused by prolonged alcohol consumption, does not develop overnight.

The court observed that, 'The deceased's alcoholism was a long- standing condition, which he knowingly suppressed while subscribing to the policy. Given this suppression of material facts, the appellant was justified in repudiating the claim under the exclusion clause.'

The NCDRC had relied on the Supreme Court's judgment in the case Sulbha Prakash Motegaoneker & Ors. v. Life Insurance Corporation, wherein the court held that mere suppression of a preexisting disease was not a ground to reject a claim. However, the Court distinguished Sulbha Prakash Motegaoneker on facts, noting that in that case, the suppressed disease was not the cause of the death. Though the cause of death was cardiac arrest in the instant case, it was related to his chronic liver disease, which was developed due to alcoholism.

The court observed that, The record shows that he was hospitalized for severe abdominal pain and vomitingcomplications commonly associated with chronic liver disease. He remained hospitalized for nearly a month before succumbing to a cardiac arrest. Given the said medical history, it cannot be said that the cardiac arrest was an isolated event, unrelated to the pre-existing chronic liver disease.'

The court also referred to the case of Bajaj Allianz Life Insurance Co. Ltd. v. Balbir Kaur, wherein the court stated that when the pre-existing disease was the cause of death, its suppression would justify the repudiation of the claim.

The court stated that, 'Sulbha Prakash Motegaoneker does not establish a general principle of law applicable to all cases of non-disclosure. Instead, each case must be assessed based on its specific

Supreme Court reserves Treasurer and 30% Executive Committee posts for women lawyers in all Karnataka District **Bar Associations**

The Supreme Court in the case Deeksha N Amruthesh Versus State Of Karnataka And Ors and connected cases observed and has reserved the post of Treasurer and 30% of the Executive Committee or Governing Council posts for women lawyers across all district bar associations in the State of Karnataka.

The bench comprising of Justice Surya Kant and Justice N Kotiswar Singh was hearing the present matter.

The bench in the case observed and has passed an order, after a prayer was being made that the order reserving posts for women lawyers in the case of Advocates' Association Bengaluru may be extended to all district bar associations in the state.

The bench headed by Justice Kant dictated that:

'This court directed that the directions contained in our order dated January 28, 2025 in respect of Advocates' Association Bengaluru, shall apply mutatis mutandis in the matter of elections of the district bar associations in the entire state of Karnataka. There-

made that the order reserving posts for women lawyers in the case of Advocates' Association Bengaluru may be extended to all district bar associations in the state. fore, all the district bar are

The bench in the case observed and has

passed an order, after a prayer was being

directed to earmark the post of Treasurer exclusively for women candidates and reserve 30% post of Councilors or members of Executive Committee exclusively for women candidates as was directed in the case of Advocates' Association Bengaluru.'

Further, the court in its order stated that each bar association, after holding its election, shall submit a compliance report to the Registrar General of the High Court, who shall then collate and submit a comprehensive compliance re-

port to the Supreme Court. One of the counsel appearing before the court appraised the Court about an order passed today by a single bench of the Karnataka High Court whereby Tumakuru District Advocates Association was directed to create one post of Treasurer and two posts for Executive Committee Members for women, in view of a submission by the Association that it would reserve the said posts for women in the upcoming elections.

The bench of Justice Kant enquired as to when the elections in the High Court Bar and District Bar were scheduled in the state, Senior Advocate Jayna Kothari, appearing for the Karnataka Federation of Women Lawvers, informed that women lawyers had secured Treasurer plus 30% EC posts in the High Court Bar. The said issue only remained with respect to district bar associations, Kothari said, of which elections are upcoming.

Law College tells Bombay High Court in plea opposing inspection: Legal education rules framed by BCI not in consonance with **Advocates Act**

The Bombay High Court in the case Nathibai Damodar Thackersey Women's University Law School vs. State Of Maharashtra & Ors observed and has reserved its judgment wherein the petition is filed by a law school against an inspection notice issued by the Bar Council of India, BCI.

The Division bench co ing of Chief Justice Alok Aradhe and Justice MS Karnik was hearing the present matter.

In the present matter, the petition is filed in 2019 by Nathibai Damodar Thackersey Women's University Law School challenging the notice issued by the BCI for inspec-

tion of the college The petitioner in the plea objected to the notice and argued that BCI does not have the power to inspect the college.

The petitioner argued before the court that the Legal Education Rules framed by the BCI itself are not in consonance with the Advocates Act.

The petitioner also argued that the BCI broadened the scope of its authority in the Rules and thus, the BCI could not have made rules on inspection when it was absent in the Advocates Act.

The counsel appearing for the petitioner before the court that colleges and universities are distinct entities and that maintained. the BCI cannot inspect col-

The counsel appearing for the petitioner also submitted that the authority to conduct such inspections of the college lies with the university as the college is affiliated with it.

The petitioner stated that a committee constituted by the UGC and the university has the authority to inspect the law college.

The court in the case then asked if a committee formed by the UGC would have expertise in legal education.

In response, the petitioner stated that the BCI, being

composed of lawyers, lacks the requisite expertise to carry out inspections of legal education institutions.

> On the other hand, the Bar Council Of India, BCI argued before the court that it has a statutory duty to carry out the inspection of the law schools to ensure that standard of education in the institutions is

Milind Sathe as the amicus to the case.

Before the court, the amicus elaborated on various powers available to the BCI.

It has been submitted by him before the court that the BCI has a major role in maintaining legal education and that the fundamental powers of BCI with respect to legal education include ancillary powers such as inspection of law colleges.

The amicus referred to Section 7 of the Advocates Act, which deals with the function of the BCI. Specifically, he referred to Section 7(h) which provides that BCI's function is to promote legal education and to lay down standards of such education in consultation with the Universities and the State Bar Councils. Additionally, he referred to Section 7(i) which states that BCI's functions include recognizing universities whose degree in law shall be a qualification for enrolment as an advocate and for that purpose to visit and inspect Universities.

However, reference was also made to Section 49(d) of the Advocates Act which provides that the BCI may make rules for the standards of legal education to be observed by universities in India and the inspection of universities for that purpose.

The amicus also relied on the Legal Education Rules 2008 and submitted that the BCI can inspect law colleges as per the rules.

Accordingly, the court reserved the orders.

Supreme Court flags absence of Punjab govt lawyers, shares concerns with AG

The bench comprising of Justice K. Maheshwari and Justice Aravind Kumar was hearing the present matter.

The bench in the case was hearing an appeal filed by the Punjab Police against the order of the High Court, wherein the court granted bail to Shiromani Akali Dal leader Bikram Singh Maji-

On March O4, the court passed an interim order, wherein the court directed Majithia to appear before the Punjab Police on March 17 for interrogation in a drugs case.

The bench headed by Justice Maheshwari stated, 'Mr. Advocate General of Pun-



jab...in your State, even after service of notice, your panel advocates in the Supreme Court are not appearing. This court have already referred in two orders. This is everyday drama...Everyday, we cannot go at your home and knock the doors. Then, you will say the Supreme Court is not allowing me to sleep...Notice has been served, summons has been served to your officers and what is your State doing?' In Response, the bench of Justice Kumar also stated that, 'State of Puniab means absent. Not only in criminal cases, in civil cases also nobody is appearing...If it's in one case, [inaudible]but not every next case.

Adding to it, Singh responded that this was the first time he was informed about this and that 'he will take care' that this never happens again.

Singh also responded that, 'This should not happen, My lords. I will check. This is the first time it has come to my notice and I will make sure it never happens again.'

The court with regards to the case of Majithia stated that since he is cooperating with the investigation.

The counsel, Senior Advocate S. Muralidhar appearing for Majithia submitted before the court that Majithia has already answered 150 written questions given to him by the State police.

Majithia also raised concern over the Police holding oress conferences every day

in this case. It has been stated by AG Gurminder Singh before the court that the investigation has revealed certain 'star-

tling facts' and said that an affidavit would be filed. Muralidhar informed, 'Every day, press conference is being held. It is disclosed to the press what answers are

given; it cannot be misused.' However, Advocate General Singh denied holding a press conference.

Accordingly, the court listed the matter for further consideration after 2 weeks.

Supreme Court slams Uttarakhand govt for not paying promised ex-gratia for doctor shot dead in hospital, orders Rs 1 crore compensation

Justice Abhay S Oka, Justice Ahsanudding Amanullah, and Justice AG Masih was hearing the present matter. The bench in the case re-

fused to interfere with the conviction of the appellants who challenged their conviction under Section 302 (murder) read with Section 34 (common intention) of the Indian Penal Code, IPC. The appellants raised

a ground that the eyewitnesses examination was conducted after 3/4 delays of the incident.

The bench referred to the case of Ganesh Bhavan Patel v State of Maharashtra, wherein the court to argue that the delay caused in their examination is always fatal to the prosecution's

On the other hand, the Respondent-State argued before the court that the delay in recording the eyewitness's testimony was due to the involvement of investigating officer's in maintaining the law and order of the affected area, where the violence took place.

The State argued before the court that the delay caused was sufficiently explained, hence the accused cannot claim benefit.

The judgement authored

by Justice Amanullah observed that when the delay occurred in recording an examination of an eyewitnesses was sufficiently explained than no adverse inference would be drawn against the prosecution's

Supreme Court: Delay in recording witness statements under

Section 161/164 of CrPC not fatal if there is adequate explanation

The court observed that, 'Insofar as the delay of 2/3days in recording the statements of the eye-witnesses under Section 161(5) of the Code of Criminal Procedure, 1973 (hereinafter referred to as the 'Code') is concerned, the said delay has been thoroughly explained by the witnesses, including the Investigating Officer, to the effect that there were riots in the area. On this score, the Investigating Officer was being involved in maintaining law

and order in the affected

area. In the attendant facts

and circumstances, the course of action adopted by the police cannot be termed unjustified and no adverse inference can be drawn on this count.'

Adding to it, the court stated that the delay caused in recoding witness statements, more so when the said delay is explained, will not aid an accused. Of course, no hard-and fast principle in this regard ought to be or can be laid down, as delay, if any, in recording statements will have to be examined by the Court concerned in conjunction with the peculiar facts of the case before it. Our reading of the above shall apply on all fours to delays in the context of Section 164 of the Code of Criminal Procedure, CrPC. The court also referred

to the case of Lal Bahadur

v. State (NCT of Delhi), wherein a delay is being caused of 27 days in recording the witness's statement was held to be non-fatal to the prosecution's case due to break out of communal violence. The court while consider-

ing the facts and circumstances of the case noted that the decision passed by the co-ordinate bench in the case of Ganesh Bhavan Patel's case cannot be said to be authority on the point because in that case 'the delay caused in recording statements of the material witnesses was accompanied by a delay in registering of the FIR and the surrounding circumstances, which led the Court to hold that there was a 'a cloud of suspicion on the credibility of the entire warp and woof of the prosecution story.'

IRAN OPEN TO UNCONDITIONAL TALKS WITH US: WHAT'S BEHIND THE SHIFT?

RISING TENSIONS & STRATEGIC SHIFTS

Iran's willingness to consider dialogue comes at a time of heightened tensions and shifting regional dynamics. The Middle East has witnessed a dramatic series of events that have put Iran on the defensive. The Israel-Gaza conflict and the weakening of Hezbollah's position in Lebanon have strained Tehran's influence in the region. Moreover, the fall of former Syrian President Bashar al-Assad, once a close ally of Iran, has significantly reduced Tehran's leverage over strategic regional actors. As a result, Iran is facing growing challenges both domestically and abroad, leading to a reconsideration of its longstanding policies, including its stance toward the U.S. In light of these regional shifts, Iran finds itself in a position where reevaluating its relationship with the U.S. might become an imperative for securing its future in a rapidly changing Middle East.

U.S. PROPOSES A NEW NUCLEAR DEAL

In March 2025, a significant diplomatic development unfolded when President Donald Trump sent a letter to Iran's Supreme Leader, Ayatollah Ali Khamenei. In the letter, Trump proposed a new framework for direct negotiations aimed at resolving the longstanding nuclear dispute. This initiative set a two-month deadline for Iran to respond, warning of possible alternative measures such as intensified sanctions and the consideration of military options—if Iran rejected the proposal.

The U.S. hopes that by increasing pressure on Tehran, it can secure a more comprehensive nuclear agreement, one that demands Iran dismantle its nuclear program entirely. Trump's administration believes that Iran's nuclear ambitions pose a threat to regional stability and international security, and that pushing Tehran to comply with tougher terms is the best course of action.

IRAN'S RESPONSE: CAUTIOUSNESS

Despite the U.S. offer, Iran's response has been less than enthusiastic. Ayatollah Khamenei quickly rejected the proposal, emphasizing deep-rooted skepticism regarding the U.S. intentions.

He warned that Tehran would not engage in negotiations under pressure, viewing Washington's diplomatic overtures as part of an ongoing strategy to force compliance rather than pursue genuine dialogue. Foreign Minister Abbas Araqchi echoed this sentiment, insisting that for negotiations to move forward, the U.S. must change its approach, particularly its reliance on coercion and sanctions. This rejection highlights the entrenched mistrust between the two nations. Iran views the U.S. as using diplomacy as a cover for its continued pressure tactics, which Tehran sees as counterproductive and ultimately detrimental to any lasting peace agreement.

U.S. MILITARY POSTURE

While the U.S. position has been characterized by a mix of diplomatic outreach and military readiness, the overall strategy remains aggressive. U.S. Special Envoy Steve Witkoff has emphasized that the goal of the diplomatic overtures is to avoid military confrontation, underscoring Washington's desire for a peaceful resolution. However, National Security Advisor Mike Waltz has reiterated the U.S. hardline stance, demanding that Iran completely dismantle its nuclear program, a condition Tehran is unlikely to accept. The tension between diplomacy and military preparedness remains a central theme in U.S.-Iran relations. The U.S. aims to pressure Iran into a position of compliance, yet Iran's refusal to fully dismantle its nuclear program suggests that a compromise may be difficult to reach.

In 1953, the U.S. and the United Kingdom orchestrated a coup to oust Iran's democratically elected Prime Minister Mohammad Mossadegh. Mossadegh's decision to nationalize Iran's oil industry angered Western powers, and the coup reinstated the Shah, Mohammad Reza Pahlavi, who was a pro-Western ruler. The events of 1953 sowed the seeds of deep resentment in Iran, which has since viewed the U.S. as an imperialist power undermining Iranian sovereignty.

1979 REVOLUTION & **HOSTAGE CRISIS**

In 1979, Iran experienced a revolution that overthrew the Shah, replacing his regime with an Islamic republic led by Ayatollah Khomeini. The new government's hostility toward the U.S. reached a peak when Iranian militants seized the U.S. Embassy in Tehran, taking 52 American diplomats hostage for 444 days. The crisis shattered diplomatic relations, and the U.S. imposed sanctions on Iran. setting the stage for decades of animosity.

1980S: U.S. BACKS **IRAQ AGAINST IRAN**

During the Iran-Iraq War (1980-1988), the U.S. supported Saddam Hussein's Iraq with intelligence, weapons, and financial aid, further deepening Iran's distrust of Washington. The situation escalated in 1988, when a U.S. Navy warship mistakenly shot down Iran Air Flight 655, killing 290 civilians, a tragedy that intensified anti-American sentiment.

In the early 2000s, Iran's nuclear ambitions led to accusations from the U.S. and its allies that Tehran was pursuing nuclear weapons tivities. He frequently links undocumented immigration to rising crime rates and job shortages, despite statistical evidence that contradicts this narrative.

The social media disclosure requirement is another step in the administration's efforts to create a more stringent immigration framework. The move reflects a growing pattern of surveillance and control, which critics argue disproportionately affects legal immigrants, particularly those from countries with politically active communities. Immigrants who are vocal in their support of political causes in their home countries may be seen as risks by the government, even if their political views are unrelated to their immigration applications.

This proposal also raises questions about whether the U.S. is selectively targeting certain immigrant populations.

With the Indian community being one of the largest groups of legal immigrants in the U.S., the policy could have farreaching consequences for many individuals, particularly those who engage with political issues in both the U.S. and their home country.

CONCERNS OVER PRIVACY

The proposed policy has sparked significant back-

lash from civil rights organizations and privacy advocates who argue that it represents an unsigned an executive order justifiable intrusion into instructing federal agen- individuals' private lives. By requiring green card holders to disclose their social media accounts, the government could be violating the fundamental rights to privacy and free speech that are enshrined in the U.S. Constitution. A major concern is that the policy could lead to self-censorship. Immigrants might avoid posting their political opinions or engaging in public discourse out of fear that their online activities could be scrutinized and negatively impact their immigration status. This fear could be especially potent for individuals with politically sensitive views or affiliations.

THE ROAD AHEAD: WHAT'S NEXT?

As the Trump administration seeks public comments on the proposal, the debate continues over how to balance national security with personal freedoms.

The policy is still in the proposal stage, and it remains to be seen whether it will be implemented in its current form. However, if the policy moves forward, it could have farreaching consequences for immigrants living in the U.S., particularly those from politically active communities such as the Indian diaspora.

Balochistan CM orders strict action against anti-state activities

Balochistan Chief Minister Mir Sarfraz Bugti has ordered strict action against government employees and officers involved in anti-state activities, according to a media report on Tuesday.

Chairing a high-level meeting, the chief minister ordered divisional and deputy commissioners to identify and act against the officials engaged in activities that go against the state's interests, The Express Tribune newspaper reported.

The chief minister said that no government employee would be allowed to undermine state policies, warning in Quetta, reported the paper. that violators would be dealt with accordingly.

Meanwhile, an FIR has been registered against Mahrang Baloch, leader of the

Meanwhile, protests continue across Balochistan against the arrests of Mahrang Baloch and other BYC leaders.

On Sunday, a shutter-down strike was observed for the second consecutive day in several cities, including Turbat, Mastung, Kalat, Kharan, Chagai, and Panjgur.

During the meeting, officials provided a detailed briefing on the law-and-order situation and service delivery across the province. The chief minister reiterated that maintaining security and upholding the state's authority were top priorities and emphasised that no road would be allowed to be blocked, and every district officer was responsible for ensuring law enforcement in his jurisdiction.

Trump dismisses Yemen war plan leak as 'Glitch'

Donald Trump downplayed a security breach involving a leaked Yemen war plan, calling it a "glitch" and offering strong support for his senior national security team. In a phone interview with NBC, Trump referred to the incident as "the only glitch in two months" and assured that it wasn't a significant issue. He defended National Security Advisor Mike Waltz, stating that he "has learned a lesson" from the situation and

praised him as "a good man." The leak stemmed from an accidental inclusion of journalist Jeffrey Goldberg in a Signal messaging group discussing sensitive military plans. Goldberg, editor-inchief of The Atlantic, revealed

Khorev identified ISIS as the greatest threat to Russia's national and regional security, stating that Moscow is closely monitoring the situation and working with regional partners under the 'Quartet' format to counter terrorism.

Khorev also highlighted Russia's collaboration with regional countries under the Collective Security Treaty Organisation (CSTO) to eliminate militancy.

He reaffirmed Moscow's support for Pakistan, Afghanistan, and other regional states in tackling militant threats, The Express Tribune reported. Khorev also dismissed media reports alleging that Russia has found evidence of Pakistan supplying arms to Ukraine. "We have not found any proof of Pakistani arms supplies in the Ukraine-Russia conflict. All such claims are baseless," the paper quoted Khorev as saving.

Prashant Yaduvanshi: From JEE topper to global tattoo artist

In an age where career paths often follow predictable blueprints, Prashant Yaduvanshi stands as a bold exception. Once a JEE topper and on track for a thriving engineering career, he made the audacious decision to leave the security of conventional success behind, venturing into the world of body art. Today, he is one of the most recognized names in realism tattooing, with Shaman Ink studios flourishing in both India and the Netherlands.

In this candid Q&A, he opens up about moments of doubt, how realism became his signature, and the emotional stories behind some of his most transformative cover-ups. He also talks about how tattoo culture differs between India and Europe, why he's passionate about mentoring new artists, and where he sees the future of ink in a techdriven world.



From JEE topper to internationally recognized tattoo artist, your career shift defies conventional wisdom. Did you experience moments of doubt, and how did you reconcile intellectual rigor with artistic instinct in your work? Yes, there was always

doubt during the shift and for quite some time after because I had no exposure to the industry and was leaving behind a very promising career without knowing where this new venture would take me. However, once I made up my mind and let go of all the safety nets, it became an all-or-

nothing situation—which, I think, is a very powerful space to be in.

Your expertise in realism tattoos extends beyond conventional inkwork to hyper-detailed textures like sticker tattoos, origami, and thread patchwork. How do you approach realism differently from other artists, and what role does engineering precision play in vour artistry?

I think my unique approach to black and grey realism lies in my choice

of a distinct palette of solid true grey tones instead of the traditional grey wash technique. This makes my work stand out and has become something of a signature style in India. However, when it comes to color realism, I'm still in the process of exploring and evolving.

Cover-up tattoos require more than technical mastery-they demand an emotional and psychological understanding of the client's journey. Can you

share a particularly moving transformation you've facilitated through your work?

There have been quite a few, but one in particular stands out. A client from a well-to-do background, who held an important position and regularly presented himself in high-level business meetings with industrialists and capitalists, had a large, poorly done tattoo on his arm. It severely impacted his confidence and self-image. Despite the difficulty, we managed to cover it up, and it turned out to be a life-changing experience for him. He couldn't stop thanking me and shared how much he had given up on the idea that it could ever be fixed.

You've expanded Shaman Ink across continents, with studios in India and the Netherlands. How do cultural influences shape the way people perceive body art in these two regions, and how do you adapt your artistry accordingly?

Unified educational identity: Moving from prestige to purpose

A Radical Approach to Demolishing the New Caste System in Indian Education

Education, a tool for empowerment and social mobility, has effectively been reduced to a status symbol. The "branding" of educational institutions—where a student's identity, worth, and future are often iudged by the name of the school or college they attended—has created a deeply entrenched hierarchy. This phenomenon is particularly alarming in India, where the focus on democratizing education risks being undermined by the elitism propagated by these brands.

As the founder of a well-known chain of schools, I recall our early efforts to create a brand that people would aspire to. We focused heavily on logos, public relations, color schemes, advertising, and brand language. A decade later, The Millennium Schools have become a recognized name. Yet, despite this success. I receive more calls seeking admission recommendations for "legacy brands"—even if these schools are far away, expensive, or unsuitable for the child. Parents are willing to compromise everything because they believe their child needs the "brand tattoo" for life. This is a familiar and unfortunate story that highlights one of the most dysfunctional aspects of Indian education. We're all complicit in perpetuating the magnetic pull of becoming "elite."

ELITE SCHOOL BRANDS: A NEW-AGE CASTE SYSTEM

ECONOMIC AND BUREAUCRATIC DOMINANCE.

Graduates from elite schools and colleges such as the Indian Institutes of Technology (IITs), Indian Institutes of Management (IIMs), and prestigious private schools dominate high-paying corporate roles, policymaking, and bureaucracy. Their alumni networks become exclusive clubs dictating access to power and influence.

For example, a disproportionate number of IAS officers and corporate CEOs—over 60%, according to recent studies-hail from these institutions. This creates a feedback

loop where these schools become gateways to privilege rather than centers for democratized learning.

Exorbitant fees charged by elite private schools (often exceeding Rs 15 lakhs annually) and international curriculums make them accessible only to the affluent, excluding millions of capable but underprivileged students. Institutions such as Doon School and Mayo College replicate a culture of exclusivity reminiscent of colonialera privileges.

Employers and society at large prioritize institutional brands over individual merit. A degree from a branded institution eclipses actual skills, creativity, or passion, sidelining those without access to such

The focus on elite branding undermines the value of government schools and state universities, perpetuating the myth that quality education is synonymous with private institutions alone.

THE BRANDING DIVIDE

Educational branding, akin to corporate branding, highlights an institution's distinctiveness by promising superior facilities, distinguished faculty, and exceptional extracurricular opportunities. However, this branding comes at a price—one that only a select few can afford.

The emphasis on branding can overshadow the core mission of education. Schools invest heavily in marketing and infrastructural grandeur, often at the expense of educational quality. The glitzy image can mask underlying inadequacies in teaching methods and curriculum development. Just open any airline magazine today—over 70% of the advertising is related to education.

The branding race exacerbates resource allocation disparities. Prestigious schools attract more investment, donations, and sponsorships, leaving public schools and lesser-known institutions grappling with limited funds. This unequal distribution perpetuates a cycle of privilege where affluent students receive better education while others are left behind.

PRIVILEGE IN NUMBERS

A significant proportion of India's power structures—including bureaucracy and politics—is dominated by individuals from elite educational backgrounds. Studies reveal that nearly 60% of top bureaucrats and 50% of politicians attended

elite schools. If we allow important positions in government and bureaucracy to be monopolized by the educational elite, we move further away from an equal society.

Envisioning a world where schools operate without branding pressures opens the door to a more equitable educational landscape. Schools could simply be identified

by a number, for example, N-329. This idea envisions a transformative shift in India's education system by creating a unified national brand that fosters inclusivity and removes class barriers, allowing talent to shine irrespective of privilege. It emphasizes equitable distribution of resources, ensuring rural and public schools receive the same level of support as urban private institutions. The focus would shift towards holistic education, prioritizing all-round development rather than a market-driven image. By eliminating branding pressures, students would experience reduced

stress, leading to better mental health. Additionally, it encourages a culture of collaboration, where schools share resources, knowledge, and best practices, fostering community-driven growth and

improvement. Implementing change in India's education system could start with promoting neighborhood schools, encouraging a "walk-to-school" culture to reduce long commutes and strengthen community bonds. Policy reforms are crucial, focusing on equitable resource distribution and standardized quality assurance across all schools, with increased funding and accountability measures for both public and private institutions. Educational quality could be incentivized by rewarding schools for outcomes and innovative teaching methods rather than branding prestige. Targeted public awareness campaigns could shift the focus of parents and communities towards learning outcomes over brand value. Additionally, fostering public-private partnerships can help bridge resource gaps and enhance infrastructure, driving systemic improvement.

EDUCATION AS AN

EQUALIZER By removing the branding of educational institutions, India can move closer to democratizing education and dismantling systemic inequalities. A student's worth should derive from their capabilities, knowledge, and character—not the logo on their degree. Transitioning "from prestige to purpose," a unified, universal education brand system can lay the foundation for a truly equitable society.

His aggressive stroke play ensured Punjab Kings crossed the 240-run mark, ending at 243/5 in their allotted 20 overs. Gujarat's bowling unit struggled to contain the onslaught, with Rashid Khan (2/35) and Kagiso Rabada (1/41) being the pick of the bowlers.

Despite a brief cameo from Shahrukh Khan (12* off 5), PBKS emerged victorious by 11 runs.

2026 FIFA World Cup: Japan, New Zealand secure their spots

Japan made history by becoming the first nation, outside of the host countries, to qualify for the 2026 World Cup.
