# Mehul Choksi arrested in Belgium

The Belgian government has arrested fugitive Mehul Choksi who had fled in January 2018 just days before the Rs 13,500 crore Punjab National Bank scam became came to the light.

Official sources in the Belgian federal public service of Justice confirmed to the Daily Guardian that Choksi was arrested on Saturday "in anticipation of further judicial proceedings". The authorities also told this newspaper that the Indian government has introduced an extradition request for Choksi, who along with his nephew Niray Modi, is the prime accused in the PNB scam.

The Sunday Guardian, the sister publication of the Daily Guardian, was the first to report in December last year that "Mehul Choksi is suing GOI in the UK to delay extra-

dition" that the fugitive was currently based in Antwerp, Belgium, and receiving treatment at ZNA (Ziekenhuis Netwerk Antwerpen), a public hospital network in Belgium for multiple ailments that he has been suffering for a long time now.

Choksi, the youngest of six siblings, has a brother in Belgium. His brotherin-law, Hani, remarried after his sister's death and is also settled in Belgium. His brother, Chetan Chinu Bhai Choksi, also resides in Antwerp.

Choksi has already filed a case in the UK courts to sue India and five other individuals seeking a damage of Rs 3.60 crore for what he will allege was mental, physical, and psychological trauma caused due to Government of India's action.



Declaring 2025 as the Year of Artificial Intelligence, 'AICTE has launched several initiatives to promote AI in education. According to reports, the initiative aims to integrate AI across 14,000 colleges and empower 40 million

Key elements include AI awareness campaigns, faculty development, and partnerships with leading tech companies.

AICTE currently revises its curriculum every two years through a structured process involving expert consultation.

#### Global expert bats for India's permanent UNSC seat, calls it vital for new multipolar world

Jeffrey Sachs, a significant voice in global economics and policy, has issued a resounding call for India to be granted a permanent seat on the United Nations Security Council (UNSC), arguing that its inclusion is pivotal to the birth of a new, multipolar world order.

In his article 'Giving birth to the new international order', Sachs contends that the current global system, rooted in a U.S.-led hegemony, is fading, and India's rise—marked by its economic power, demographic weight, and diplomatic triumphs—makes it an indispensable player in reshaping international governance and without India being made a part of UNSC,

Sachs highlights India's unmatched credentials: it is the world's most populous nation, having surpassed China in 2024 with over 1.4 billion people, and its economy, valued at \$17 trillion in purchasing power parity terms, stands as the third largest globally, trailing only China's \$40 trillion and the U.S.'s \$30 trillion. Citing official numbers, Sachs has said that India is growing at a brisk rate of 6% annually, and is poised to overtake the U.S. by mid-centurv. Its nuclear arsenal, cutting-edge digital innovations. and ambitious space program further cement its status as a great power, capable of contributing to global stability and progress, Sach contends.


The Waqf (Amendment) Act, 2025, was passed by Parliament and has received the President's assent. The Act amends the Waqf Act, 1995, allowing the government to regulate Waqf properties and settle related disputes.

West Bengal Leader of Opposition and BJP leader Suvendu Adhikari on Monday demanded that elections be held under President's Rule in areas where Hindus are in the minority, citing concerns over voting rights after the Murshidabad violence.

Adhikari has petitioned the Calcutta High Court, seeking the deployment of



central forces in Murshidabad due to escalating violence. The violence erupted over protests against the Waqf Amendment Act, resulting in three deaths and multiple injuries.

Speaking to ANI, he said,

"I have this in my petition that after such explosions and firing incidents, the NIA should investigate (in Murshidabad) as these are anti-national activities... Wherever Hindus are in the minority, they don't let Hindus vote, and hence, the Elections must be held under president rule for the sake of democracy..."

# Modi slams Cong for blackouts during its reign, says country now exporting power

Prime Minister Narendra Modi on Monday said there were blackouts under the Congress rule before 2014 but India's power production has doubled in the last decade and it is now exporting electricity.

Addressing a gathering after laying the foundation stone of an 800-MW ultra-supercritical modern thermal power unit at the

Deenbandhu Chhotu Ram Thermal Power Plant here, the prime minister said Haryana is seeing "double speed" of the BJP's doubleengine government.

The thermal power unit, spread across 233 acres and worth around Rs 8,470 crore, is expected to become operational by March 2029. It will significantly boost Haryana's energy self-sufficiency and provide uninterrupted power supply across

Earlier, state-owned BHEL had bagged the order to set up an 800 MW plant which will be Haryana's first ultra-supercritical tech-

nology-based power project. The unit shall be established adjacent to the existing 2x300 MW units, currently operational at Yamunanagar.

Taking forward the vision of 'Gobardhan' (Galvanising Organic Bio-Agro Resources Dhan), Modi also laid the foundation stone of



a compressed biogas plant in Mukarabpur here.

The plant, slated for completion by 2027, will have an annual production capacity of 2,600 metric tonnes and

will help in effective organic waste management while contributing to clean energy production and environmental conservation, a statement said. Modi also digitally inaugurated the 14.4-km Rewari Bypass project, worth around Rs 1,070 crore under the Bharatmala Pariyojana. It will decongest Rewari City, reduce Delhi-Narnaul travel time by an hour, and boost economic activity in the region. Before reaching

Yamunanagar, Modi addressed a public gathering in Hisar after he flagged off a commercial flight from Maharaja Agrasen Airport in Hisar to Ayodhya and also laid the foundation stone of the new terminal building at the airport. With this, the prime minister launched several development initiatives worth Rs 10.000 crore in the state on Monday to mark the birth anniversary of Bhim Rao Ambedkar, an iconic figure known for his

avoid his extradition to India by invoking the UK courts and unleashing a media blitzkrieg in his favour by using psychiatric evaluation reports, backed by a well-funded PR campaign and bringing in lawvers and law firms who have a track record of first delaying and then completely denying the extradition of their clients.

However, his arrest by Belgian authorities has likely

thwarted this. It is pertinent to mention that India and Belgium have an active extradition treaty, signed and ratified in March 2020, which replaced a pre-independence treaty from 1901 (extended to India in 1958). The treaty provides a legal framework for extraditing individu-

The ISF - the only non-Trinamool, non-BJP party to have a member in the State Assembly - blocked the Basanti expressway when cops stopped their vehicles coming from Bhangar from proceeding towards Ramlila Maidan in

Nawshad Siddique, the ISF legislator, accused the Trinamool Congress Government of "intentionally provoking" his supporters to divert attention from the jobs-for-cash scandal. "We have not forgotten the sins committed by the Mamata Banerjee Government however much it tries to cover up the crimes. From selling jobs to the RG Kar rape and murder of our sister, we shall not forgive or forget."

Reacting to the news of the fresh violence, Chief Minister Mamata Baneriee said: "We live once and die once. So, why is there a riot? Every caste and religion has the right to protest, but do not take law into your hands...Some people are trying to mislead you, do not pay attention to them."

Even as the BSF patrolled Murshidabad district to maintain peace, the Trinamool Congress mouthpiece, Jagobangla, blamed the BSF for smuggling in trouble-makers from across the borders.

"The situation is getting normal now. Since last Friday, we, the BSF, have been working closely with the local police and doing whatever is required to normalise the situation. Now the CRPF has also come. Yesterday also, the situation was relatively very peaceful, and wherever we are getting any input about any tension or trouble, we are responding effectively. So I am very sure that soon the situation will get normal and we are working closely with the local police and other sister agencies," ADG Eastern Command of BSF, Ravi Kumar Gandhi.

Addressing the media, Jawed Shamim, Additional Director General (Law and Order), West Bengal Police, said that both the Malda and Murshidabad administrations are working in coordination to ensure peace and facilitate the safe return of those who had fled their homes.

"So far, 19 families have returned. Shops are opening and people are slowly resuming their normal routine," Shamim said, adding that law enforcement agencies are focused on restoring calm in the affected regions

Emphasising the need to curb misinformation, Shamim warned residents against spreading or acting on unverified news. "We've arrested 210 individuals so far. Rumours can reignite tensions - I urge everyone to stay calm and check facts before reacting," he said.

# **TELANGANA BECOMES FIRST STATE TO** IMPLEMENT SC SUB-CATEGORISATION

Comes into force on April 14, aims equitable quota benefits among SC sub castes

elangana government on Monday issued a notification, officially enforcing Scheduled Caste (SC) subcategorization for all future recruitment and educationrelated decisions, following a detailed legal and administrative process.

The Act comes into force on April 14, making Telangana the first state in the country to implement SC sub-categorisation after the Supreme Court's green signal.

Telangana Minister for Irrigation, Food & Civil Supplies Uttam Kumar Reddy, who also heads the cabinet subcommittee on the matter, said the policy aims to equitable distribute reservation benefits among SC

a meeting is scheduled for Tuesday to compile all departmental vacancies, "We are also having a meeting tomorrow to call for all the vacancies in all the departments, and we will give a notification in the next few days. In all of them, SC categorization will be applicable," he said. Supporting the move, Telangana Minister Damodar Raja Narasimha stated, "We are committed to social justice. This classification or categorisation is not against any community. It is for those communities among the Dalits who are most backward."

Meanwhile, on Sunday, chairing the final meeting of the Cabinet Sub-Committee on SC Categorisation at the Secretariat, Uttam Kumar Reddy confirmed that a Government Order outlining the modalities of the Act will be issued on Ambedkar Iavanthi.

A suspended police subinspector from Beed on Monday claimed some persons had offered him to carry out an "encounter" of Walmik Karad, accused in sarpanch Santosh Deshmukh murder case. Ranjeet Kasle, the sus-

pended cop, also said he had mentioned the names of the persons who made the offer in a local police station diary.

A senior police official from Beed, however, dismissed Kasle's claims as baseless and said he should submit a proof of his statements.

Kasle was suspended earlier when he was a subinspector in the local cyber crime department.

Deshmukh, the sarpanch of Massajog village in Maharashtra's Beed district, was abducted and tortured to death on December 9 last year allegedly for attempt-

ing to stop an extortion bid targeting an energy company.

Karad is among the eight persons arrested so far and booked under the stringent Maharashtra Control of Organised Crime Act (MCOCA).

The state Crime Investigation Department (CID) last month filed a more than 1,200 pages chargesheet at a court in Beed in Deshmukh's murder and two related cases.

Talking to a regional news channel, Kasle claimed some persons had approached him with an offer to carry out the "encounter"

# Got offer to do 'encounter' Bihar migrant rapes, murders 5-year-old girl, killed in police encounter in K'taka's Hubbali

A 35-year-old Bihar migrant man accused of raping and murdering a five-year-old girl in Karnataka's Hubhalli was shot dead in an encounter with the police on Sunday, officials said. The accused, identified as Nitesh Kumar, allegedly attacked the police team when they attempted to apprehend him.

Despite a warning shot, he tried to flee, prompting police to open fire. He was later declared dead at KMC-IR Hospital, police said, adding that three police personnel were injured during the operation. The incident occurred hours after the child was allegedly kidnapped and killed in Hubballi's Vijayanagar area. Her body was found in an abandoned building. Outraged by the incident, a



large number of residents from the locality gathered in front of the Ashok Nagar police station on Sunday morning and staged a protest, demanding justice for the victim's family. Later, Karnataka govern-

ment's Chief Whip Saleem Ahmed stated that the police firing in Hubballi, which resulted in the death of an accused in a POCSO and murder case, was carried out in self-defence after the man tried to assault a woman police officer. Clarifying that there was no lapse in law and order, Ahmed said the police handled the situation efficiently.

"The commissioner has given me the information that the accused tried to hit the lady inspector, and in self-defence, she had to fire at him. It is not a failure of law and order.

Our police are competent enough to take action, so have they," he said. "In the Ashok Nagar PS area, a 5-year-old girl was found in one of the abandoned buildings. She was shifted to a hospital but was declared dead on arrival...we have taken up the complaint of the girl's parents, legal action will be taken...the mother of the girl works as a housemaid.

The Delhi government will set up six new air monitoring stations at key locations, including JNU, IGNOU and Delhi Cantt, Environment Minister Manjinder Singh Sirsa has said. With this, the number of such stations will rise to 46. The move is part of the newly formed BJP government's strategy to expand its air monitoring infrastructure to ensure better preparedness to battle yearly smog and overall poor air quality.

The stations will come up at the Jawaharlal Nehru University (JNU), Indira Gandhi National



Open University (IGNOU), Delhi Cantonment, Netaji Subhash University (West Campus), and the Commonwealth Games Sports Complex, Sirsa told PTI.

"These new stations will help us track pollution patterns more accurately and guide our response with

real-time data. The installation process is underway and we are targeting completion by June 30," the minister said.

He said the government is addressing pollution at every level from large-scale industrial emissions to localised sources.

Last month, Sirsa in an interview said that the city government will ensure that Delhi sees more clean air days in winter.

"We will not wait until winter to take action. Our work to purify Delhi has already started, and as part of this, we will also add new ambient air quality monitoring stations," Sirsa told

# Trial run of Namo Bharat trains begins

The National Capital Region Transport Corporation (NCRTC) initiated trial runs between New Ashok Nagar and Sarai Kale Khan Namo Bharat stations, according to a statement. This marks a significant milestone in the effort to operationalise the entire Delhi-Ghaziabad-Meerut Namo Bharat corri-

The NCRTC team brought the Namo Bharat train from New Ashok Nagar to Sarai Kale Khan on the downline at a minimal speed.

As part of the trial, the Namo Bharat train was operated manually to test

the compatibility of the signalling system. As the trials progress, NCRTC will conduct a comprehensive evaluation to assess the train's integration and coordination with various subsystems, including the track, platform screen doors (PSDs), and the overhead power supply system. In the coming days, extensive trial runs featuring high-speed tests will also be carried out. During this trial, the Namo

Bharat train crossed the Yamuna River for the first time, continuing its journey over the Barapullah flyover and the Ring Road before entering Sarai Kale Khan station. Constructing this 1.3 km long bridge over the Yamuna River to enable



this crossing was a complex and challenging task, but NCRTC overcame all challenges and completed the construction of this bridge as per the scheduled timelines. Supported by 32 pillars, about 626 metres of this bridge lies directly over

the Yamuna River and the remaining portion extends into the floodplain areas on both sides. This bridge has been built parallel to the existing DND Yamuna Bridge.

# BJP's 'double-engine' govt fails on power, city faces long cuts: Atishi

Aam Aadmi Party leader and Leader of Opposition (LoP) in Delhi Assembly, Atishi, attacked the Delhi government regarding power outages in the national capital and said that the BJP government and its Power Minister continue to deny the existence of electricity cuts in Delhi.

On Monday, Delhi Assembly LoP Atishi visited the Madhu Vihar area in Vishwas Nagar Assembly and interacted with residents struggling with daily power cuts. "The BJP's double-engine government has completely failed to ensure uninterrupted electricity supply in the nation's capital. Under had become a city with 24x7 electricity. Now, the same city is suffering from prolonged and frequent power cuts," Atishi said.

Residents in Vishwas Nagar expressed their frus-



tration to Atishi, stating that power cuts have become a daily ordeal--multiple outages lasting for hours.

"Shops are unable to function, children's studies are disrupted, and elderly citizens are suffering in this sweltering heat. If this is the state of power supply in early summer, what will happen in May and June?" the AAP government, Delhi Atishi asked. During her visit. Atishi encountered citizens deeply agitated by the worsening power situation. At a local flour mill. a worker recounted how power cuts lasting for hours have become routine. "This

hasn't happened in the last 10 years. Earlier, electricity was stable. Now, the power goes every day, multiple times. Our business is suffering, and it's hard to run our households," he said.

Another resident shared, "The BJP has destroyed a perfectly functioning system. We didn't vote for them to bring back these dark days. Every day, the electricity is gone for 2-3 hours."

Multiple residents voiced concern about their children's education. "Due to these frequent outages, it's impossible for children to study. They can't focus in the heat and darkness," one resident said. Several residents lamented that after 2015. uninterrupted power supply had become the norm in Delhi--even in the peak summer months. "We sold our inverters because they were no longer needed. But now, after two months of non-stop outages, we're being forced to buy them again," a resi-

### Couple held for Rs 2.70 cr property fraud

Delhi Police's Economic Offences Wing (EOW) arrested a couple for allegedly duping a businessman of Rs 2.70 crore on the pretext of promising commercial space in an unbuilt project, an official said on Monday. Those arrested have been identified as Vinay Jain (55) and his wife Asha Jain (52), they said.

According to the statement, the couple lured the complainant, Virender Kathuria, into booking three shops in the proposed commercial complex.

They falsely claimed that the Delhi Development Authority (DDA) had handed over vacant possession of the land for development. Trusting their representations, Kathuria paid Rs 2.70 crore on January 1, 2016, with an agreement to pay the balance of Rs 74.6 lakh upon getting possession, it said. "However, it later emerged that the accused



had mortgaged the property to a finance company on April 8, 2016. After they defaulted on loan repayments, the property was auctioned and eventually demolished, resulting in massive financial loss to the complainant," the statement said.

Despite repeated summons, the accused never cooperated with the investigation and were declared Proclaimed Offenders by a Delhi court on April 25, 2023. After sustained efforts, the couple was arrest-

ed on April 7, the police said. Vinay is a Class 8 grade dropout, while Asha is a graduate. They got married in 1993 and have allegedly been running several companies. They are said to be repeat offenders in multiple cases of financial fraud, the statement said.

### Police busts interstate gang stealing telecom equipment; 4 held

The Delhi Police busted an organized interstate gang which was involved in the theft and illegal trade of critical telecom infrastructure.

The Central Range of the Crime Branch, Delhi Police, has busted a sophisticated racket operating across

The operation, a result of continuous surveillance and covert ground intelligence, led to the arrest of four accused, including a key receiver, and the recoverv of 12 high-value RRUs. tools and equipment used for the thefts, and a taxi used for transportation.

A Remote Radio Unit (RRU), commonly referred to as a Remote Radio Head

Ambedkar brought fundamental changes

(RRH), is a transceiver installed on wireless base stations or mobile Towers. These transceivers connect wireless devices with wireless networks, making it possible to send and receive text messages, among other things. A Base Band Unit (BBU) receives a signal from Mobile users via an Antenna, which transfers the signal to RRUs for further processing of voice calls and data services like internet, etc.

Any site going down due to the theft of RRU or BBU impacts the nearby Mobile users' services, including emergency services like 112, 102, etc. As a result, customers suffer both when making calls and when using Internet services. Once RRU and BBU are stolen,

the Mobile Operator has to reinstall this equipment to resume services, and a huge loss is incurred. These articles are vital components required for a mobile network tower.

Delhi being a transit/ storage location for stolen RRUs/BBUs, it was a great challenge for Delhi Police to apprehend these receivers/middlemen, as these gang members never used to stay in one place and also changed their locations and storage facilities frequently. To unearth the syndicates involved, various teams from the Crime Branch were deployed. Many operations were carried out by various teams of Crime Branch throughout the country, and huge success

#### Woman, her son held for attacking live-in partner with knife

More than a month after a woman's body was found in a wheat field in a village here, police arrested her live-in partner on Monday for allegedly killing her over suspicion that she was having an affair, officials said.

In his complaint, the father said Rita got married 11 years ago and about five years ago, his daughter and her husband came to Naharpur village and rented a place.

Due to a rift between them, the husband left her. After this, his daughter started living with Sharma, he added. "I last spoke to Rita

on February 23 when I came to Naharpur to meet her," he said.

Police said Sharma was

arrested on Monday and confessed to killing Rita over suspicion that she was having an affair. "During interrogation, he revealed that he and Rita were in a live-in relationship. He used to work as a labourer and Rita worked in a company in IMT, Manesar," a Gurugram Police spokesperson said.

"We will take the accused on police remand after being produced in a city court tomorrow," the spokesperson said.

# NIFTY EARNINGS MAY SEE FURTHER **CUT AMID TARIFF TENSION: REPORT**

Expected earnings growth for FY25 to FY27 is 12.7% annually

The earnings targets of the Nifty index in the first half of FY26 are expected to be reduced further amid the ongoing trade tensions due to the US tariff policy, according to a report by PL Capital.

The report has further lowered the targets after cutting Nifty's expected earnings per share (EPS) for FY26 and FY27 by 6.2 per cent and 5.6 per cent respectively since October 2024. It stated, "NIFTY EPS has seen a cut in EPS by 6.2% and 5.6% for FY26/27 since Oct 24, and tariff wars and the uncertain environment can result in further cuts in 1H26.

The report now values the Nifty at a 7.5 per cent discount to its 15-year average price-to-earnings (PE) ratio of 18.9 times. Based on an expected EPS of Rs 1,460 for March 2027, it has set a 12-month target for the Nifty

# 'Lower inflation, healthy rabi output to boost demand'

India's domestic demand is showing signs of recovery, supported by several positive developments, according to a recent report by Crisil.

The report highlighted

that healthy rabi output and easing inflation in the fourth quarter of fiscal 2025 are likely to boost consumption demand further. It said "Improved growth in capital, infrastructure and construction goods' output in the second half points to a gradual pickup in construction /capital expenditure activity in the latter part of the fiscal. Finally, other high-frequency indicators show growth prospects improving in the fourth quarter".

One of the key contributors to the improving demand is the better performance of the Index of Industrial Production (IIP) for manufacturing.

The report noted that IIP manufacturing showed stronger growth in the second half of the fiscal year. This improvement helped lift production in sectors such as petroleum products, machinery, and tex-

Additionally, the output of capital goods, infrastructure goods, and construction goods also increased in the second half. According to the report, this indicates a gradual pick-up in construction activities and capital expenditure by businesses, which are crucial for long-term economic growth.

It also noted, "All these factors corroborate recovery in domestic demand. Healthy rabi output and easing inflation in the fourth quarter also bode well for consumption demand".

High-frequency indicators are also showing positive signs, especially in the fourth quarter. These indicators suggest that the economy is gradually gaining momentum and that the outlook for demand is improving.

The report also pointed to findings from the Reserve Bank of India's latest surveys. The RBI's Ouarterly Industrial Outlook

survey shows a sequential strengthening of demand in the fourth quarter.

Meanwhile, the Consumer Confidence Survey conducted in March suggestsedimprovement in sentiment among consumers in both rural and urban areas. Putting together all these indicators, the report said that the domestic demand is on the path of recovery. The combination of strong rabi crop output and falling inflation is expected to support consumer spending going forward.

However, the report also highlighted risks to India's growth outlook.

One major concern is the increase in tariffs by the United States.

The report warned that slower global growth and possible reciprocal tariffs on Indian goods, expected in the next three months, could impact exports. Moreover, the uncertainty around the duration and frequent changes in tariffs could discourage investments. Overall, while the domestic side of the economy is improving, external

## Despite fluctuations, 11.3 lakh investors joined market in Feb

Despite the recent decline seen by Indian stock markets in tune with global trends, the number of registered investors has continued to grow.

According to a National Stock Exchange (NSE) report, the total number of registered investors crossed 11.2 crore by the end of February 2025. This includes 11.3 lakh new investors who joined during the month alone. "The registered investor base stood at 11.2 crore in Feb'25, with 11.3 lakh new investors added during the month. The total number of client codes registered with the exchange stood at 21.9 crore (219 million), reflecting all client registrations to date, as

investors can register with multiple trading members," the report said.

This participation rise reflects strong investor interest growth over the past year. The investor base crossed nine crore in February 2024 and reached 10 crore just five months later in August 2024. By January 20, 2025, it had already crossed the 11-crore mark. In terms of regions, North India had the highest number of registered investors at 4.1 crore, followed by West India with 3.4 crore, South India with 2.3 crore, and East India with 1.3 crore. In the last year, North and East India saw the highest growth, with increases of 27.7 per cent and 27.3 per cent respectively. South India registered a 23.7 per cent rise, while West In-

Looking at changes over the past five years, North India's share of the total investor base has grown significantly--from 28.7 per cent in 2020 to 36.3 per cent in February 2025, a rise of 7.5 percentage points. The

### 'Domestic jewellery market to surge to \$145 bn by 2028' **TDG NETWORK**

India's domestic jewellery market is projected to grow at a strong compound annual growth rate (CAGR) of 16 per cent between FY24 and FY28, reaching a market size of USD 145 billion by FY28, according to a report by Minerva Capital Research.

The report highlighted that the Indian jewellery industry is undergoing a significant transformation, with a steady shift from unorganized to organized players. It said, "India's domestic jewellery market expected to register a 16 per cent CAGR from FY24E to FY28E." Currently, the unorganized

sector holds around 62 per cent of the market share. However, this is expected to drop to 57 per cent by FY28, while the share of organized



jewellers will rise to 43 per cent. This transition is driven by increasing consumer preference for transparency, quality, and branded products.

Region-wise, the southern states dominate the Indian gold jewellery market, contributing about 40 per cent to the total demand in FY23. This is followed by the western region, which accounts for 25 per cent of the market. The average jew-

ellery demand during weddings across India stands at around 225-250 grams.

The report also noted a difference in consumer preferences across regions. Southern consumers largely prefer traditional plain gold jewellery, while the northern and western parts of the country show a higher demand for lightweight and diamond-studded jewellery, particularly in 14k and 18k categories.

report mentioned that the gross margins range between 10 per cent to 14 per cent for plain gold jewellery and 30 per cent to 35 per cent for diamond-studded jewellery.In FY23, fine jewellery made up nearly 90 per cent of the total jewellery market, valued at approximately USD 63 billion. This includes both gold and non-gold segments. Several government initia-

In terms of profitability, the

tives are supporting the growth of the organized jewellery sector and promoting exports. These include the reduction in customs duties--on gold and silver from 15 per cent to 6 per cent, and on platinum from 15.4 per cent to 6.4 per cent--as announced in the Union Budget 2024. Additionally, gold hallmark-

ing was made mandatory from April 1, 2023, and PAN

cards are now required for jewellery purchases over Rs 2 lakhs. These measures are aimed at enhancing transparency and domestic value addition.

The jewellery industry is also seeing increasing participation from organized players in rural areas, which account for 58 per cent of the total jewellery demand. Demand patterns re-

main seasonal, peaking during wedding seasons (May-June and September-January), harvest periods (September-November and January-March), and festive occasions such as Diwali, Dhanteras, Akshaya Tritiya, and Ugadi.

Another advantage of the gold retail industry is the absence of inventory obsolescence, as old jewellery can be melted and reshaped into new designs, making it a sustainable business model.

### Edible oil industry body flags trade distortions from Nepal under SAFTA

The Indian Vegetable Oil Producers' Association (IVPA), an industry body representing India's edible oil refining industry, has submitted a formal representation to the central government departments, highlighting their concerns around the surge in duty-free edible oil imports from Nepal under the South Asian Free Trade Area (SAFTA) framework.

According to IVPA, imports from Nepal rose sharply in early 2025, reaching over 1.80 lakh metric tons between January and March--up from 1.25 lakh tons in the whole of



IVPA said most of the 1.25 lakh tons of imports in 2024 arrived in India only during the October-December quarter, following a hike in Indian duties, possibly due to the rerouted soya imports to India via Nepal. Under the SAFTA Agreement and the India-Nepal Trade Treaty, vegetable oil imports from Nepal enjoy duty-free access to the Indian

In September 2024, India reportedly imposed a 20 per cent basic customs duty on crude and refined vegetable

"This growth, which is not backed by Nepal's own oilseed production capacity, raises serious questions around the effective enforcement of Rules of Origin and the risk of third-country routing," the edible oil industry body said in a statement Monday.

IVPA believes that the surge in edible oil exports to India from Nepal proves that all exporting countries are routing exports to India through Nepal to avail themselves of the zero-duty benefit.

The Association has noted that this surge is distorting the domestic edible oil market by creating an uneven playing field for Indian processors and refiners, impacting farm-gate oilseed prices and leading to underutilisation of domestic capacity.

Due to the prevailing fear of further zero-duty inflows, market sentiment around oilseed prices has also weakened, resulting in farmers receiving significantly lower prices--despite the sharp increase in import duties and other corrective measures. the industry body said.

"The trend also has broader fiscal implications, including the potential loss of revenue and erosion of the intended benefits of duties such as the Agriculture Infrastructure and Development Cess (AIDC)," it added.

Against this backdrop, IVPA has submitted a detailed proposal to the Union agriculture ministry outlining actionable recommendations to ensure that SAFTA provisions are implemented in both letter and spirit, without adversely impacting India's farmers, processors, or its agricultural economic interests.

India is the world's secondlargest consumer and number one vegetable oil importer, and it meets 60 per cent of its needs through imports.

#### Consumer protection: Govt says testing mandatory for gas meters

The Department of Consumer Affairs has taken a significant step towards strengthening consumer protection, promoting fair trade practices, and ensuring accurate gas usage measurement by framing draft rules for Gas Meters under the Legal Metrology (General) Rules, 2011. The Ministry of Consumer Affairs, Food and Public Distribution said in a statement Monday that these rules make it mandatory for all gas meters used for domestic, commercial, and industrial purposes to undergo testing, verification, and stamping before their use in trade and commerce.

The re-verification of these gas meters is also prescribed under the rules to ensure their correctness when they

The primary objective of these new rules is to ensure accuracy, transparency, and reliability in gas measurement. Verified and stamped gas meters will prevent overcharging or under-measurement, reduce disputes, and provide guaranteed protection to consumers against faulty or manipulated devices. Consumers stand to benefit directly from standardised and compliant equipment through fair billing, improved energy efficiency, and reduced maintenance costs. In addition to consumer benefits, the rules provide a structured compliance framework for manufacturers and gas distribution companies, aligned with international best practices and OIML (International Organization of Legal Metrology) standards. This alignment strengthens India's commitment to global standards, boosts credibility in international trade and encourages innovation and quality assurance within the domestic manufacturing ecosystem.

# UP economy: Per capita income doubled, says Yogi Adityanath



# **BRIDGING DIVIDES: AMBEDKAR'S LEGACY** AND THE PURSUIT OF SOCIAL HARMONY

r. Bhimrao Ramji Ambedkar's life and work remain a powerful testament to the struggle for social justice in India. While his experiences with the caste system deeply shaped his perspective, a closer look reveals a complex figure whose legacy can inspire unity and collaboration in the ongoing pursuit of equality.

Dr. Bhimrao Ramji Ambedkar, born on April 14, 1891, in Mhow (now Dr. Ambedkar Nagar), Madhya Pradesh, experienced a childhood marked by the social stigma of the Mahar caste, considered "untouchable" at the time.

#### **CHILDHOOD AND** SURNAME

- Born as Bhimrao Ramji Sakpal, his family hailed from Ambadawe town in Ratnagiri district, Maharashtra.
- His father, Ramji Maloji Sakpal, was a Subedar in the British Indian Army.
- Bhimrao faced severe discrimination in school due to his caste. He and other "untouchable" children were segregated, not allowed to sit inside the classroom, and often denied necessities like water.
- His original surname was Ambavadekar, reflecting his ancestral village.

However, his Brahmin teacher, Krishnaji Keshav Ambedkar, who was fond of him, changed his surname to Ambedkar in the school records.

#### **EDUCATION AND SUPPORT**

- After completing his matriculation, he attended Elphinstone College in Bombay (now Mumbai), becoming the first from his community to do so.
- A significant turning point came when Maharaja Sayajirao Gaikwad III of Baroda recognized his potential and awarded him a scholarship in 1913 to pursue higher studies in the United States at Columbia University.
- He excelled at Columbia University, earning his M.A. and Ph.D. degrees in Economics.
- Further support came from the Maharaja of Kolhapur, Chhatrapati Shahuji Maharaj, who also provided financial assistance for Ambedkar's further studies in London at the London School of Economics and Gray's Inn for law.
- While the primary financial support for his higher education abroad came from Maharaja Sayajirao Gaikwad and later the Maharaja of Kolhapur, it's important to note that his initial schooling and progress were also supported by his father's efforts and as mentioned, the kindness of his Ambedkar, who gave him his surname. The Mahar community also celebrated his academic achievements, signifying their collective aspiration.

It is crucial to acknowledge the profound impact of caste discrimination Ambedkar faced throughout his early life and education. While individuals like Maharaja Sayajirao Gaikwad and his teacher played a vital role in facilitating his access to education, their support arose in a context of widespread social prejudice that Ambedkar had to constantly overcome. His journey to becoming a towering figure was marked by both the generosity of some and the systemic oppression he fought against.

#### **CHAIRPERSON OF** THE CONSTITUENT **ASSEMBLY DRAFTING** COMMITTEE

Ambedkar's appointment to chair the Drafting Committee of the Constituent Assembly, a body dominated by upper-caste members, stands as a significant moment. It demonstrates a willingness to engage with his experience, expertise and vision for marginalised, acknowledging his unique understanding of social inequalities. This act of inclusion contradicts the narrative of a monolithic, anti-Dalit upper caste Hindu Society, suggesting a more nuanced reality.

The Dalit movements and their patriarchs are often seen ranting against RSS and their leadership of being Brahmanical and pro upper caste, but the fact of the matter is- The Rastriya Swayamsevak Sangh (RSS) has also articulated a commitment to eradicating the caste system. There is no caste mention in a Shakha, every senior worker visit home of a SC/ST Swavamsevak each year with family and vis a versa. ### **MAMATA GOVERNMENT'S FAULT** Assam Chief Minister Himanta Biswa Sarma made

a very valid point when he posted on X that in spite of having a higher percentage of Muslim population than Bengal's, his state saw barely any protests over the passage of the Waqf Amendment Bill in Parliament. This was in context of the violence unleashed by the radicalised members of the minority community over the majority population in Bengal's Murshidabad district, where the so-called majority, the Hindus are actually in a minority. Things are so bad in the violence-torn areas that the local Hindu population has started fleeing to neighbouring districts, with open threats being issued against them by the marauding mobs. Some of the slogans are eerily similar to those issued by the jihadis to the Kashmiri Pandit community before they fled the Valley in 1990. The question is if Assam can control the situation, why cannot Bengal? The answer, sadly, is simple: it is because the Chief Minister and her administration are either inefficient, or unwilling to control the situation, or both. The serious charge that the BJP is hurling at Mamata Banerjee is that the anti-Waqf violence has her blessings. Even if that is not the case, she is anyway being belligerent and claiming that an Act passed by Indian Parliament will not be implemented in Bengal-it is as if she is the potentate of her own kingdom. In fact, one of her ministers, who is at the forefront of the Waqf protests, Siddiqullah Chowdhury, went to the extent of claiming that the Chief Minister was happy that members of the Muslim community had gathered in such large numbers to protest against the amended Waqf Act. Meanwhile, trouble started in the interiors of Murshidabad district, with mayhem unleashed on Hindus. But the administration did nothing about it. It was only intervention by the Calcutta High Court that led to the deployment of Central forces in the violence hit areas, bringing the situation under control. With the state failing to do its duty, it is being alleged that the violence suits the interests of the Trinmaool Congress, for it diverts attention from one the biggest jobs scams that the country has seen, where 26,000 teachers have lost their jobs because of corruption by the ruling party in the hiring process. With the teachers' protest getting relegated to the background, it is but natural that questions will arise on the role the state played in the violence getting out of hand. The larger point is about the radicalisation of a

particular community, and the attendant muscle flexing, with open calls being given for conversion convert or die. Nightmarish situations like this exist in Pakistan and Bangladesh. That this can take place in West Bengal, a mainstream Indian state, is a matter of concern. In fact, there is no justification for this in a secular country. Every Muslim is treated equally as every Hindu by the Indian state. There is no state-mandated discrimination against them, unlike in Muslim countries, where minorities are often treated as second class citizens. So where is the angst coming from? Obviously, it is a case of brainwashing by painting pictures of imagined horrors. What is anti-Muslim about the Waqf Amendment Bill/Act? It is actually about streamlining the administrative process to close the loopholes that make the usurpation of Waqf properties easy. The amended Act has support from many Muslim individuals and groups. But, from all accounts, in Bengal at least the amended Waqf Act has been identified as an attempt to obliterate Muslim identity and existence. But then this suits the state's ruling party, for it enables it to paint itself as the only saviour of the community, in the face of a supposedly "communal" BJP. Hence, even if Muslims are angry with Mamata's party—which many of them are, with the rampant corruption and lawlessness on the ground—they do not have any option but to band together behind the Trinamool. Appeasement too has been another tool in the arsenal of Bengal's political parties—the Left, the TMC and the Congress—to keep the Muslim community happy. It is well known that Mamata Banerjee has prioritised this community over Hindus in more occasions that one. Hence, today, when they turn around and say that Mamata Banerjee is in power because of them, and would dare not take any action against them, it is case of her appeasement policy coming back to haunt her. In the process, it is increasingly looking like that Mamata Banerjee is losing control of the ground to criminals, who run their writ in their respective areas of influence, where even the state apparatus bends to them. This was seen with the now jailed muscleman Sheikh Shajahan during the Sandeshkhali case. Then there is the problem of infiltration from Bangladesh, which is changing the demography of Bengal's border areas, with the full backing of local politicians. Given the radicalisation that has resurfaced in Bangladesh with the rise of Muhammad Yunus and his band of Jamaatis, the possibility of jihadi elements coming into India to cause trouble has increased manifold. It would not be wrong to say that Bengal is sitting on a powder keg. The present violence is a curtain raiser to what may come if the situation is not brought under control. Worse, the situation in Bengal might endanger the whole country. Mamata Banerjee may be ruling West Bengal, but she cannot treat the state as her personal fiefdom, with zero accountability. She cannot be allowed to play politics with the security of the country.

The rain outside my window pattered like old memories, pulling me back to Pakistan's crowded alleys, where fear chased me like a stray dog. My name is Shayan Ali Krishna, and I'm writing today because something stirs in me—a fire kindled by the Waqf Amendment Act 2025. This isn't just a law to me. It's a lifeline for the Pasmandas, the Ajlafs, the forgotten Muslims of India, and it sings of justice in a voice I can't ignore. I know what it's like to be silenced. In Pakistan, I watched a handful of Punjabi Sunnis hold the country like a tightly

wound kite string, while Baloch, Sindhi, and Pashtun dreams fluttered out of reach. I was a social media influencer then, young and stubborn, posting truths that pricked the wrong egos. The ISI didn't like that. They cornered me, called me a Jewish agent, an Indian spy, demanded I spin their story about Kashmir into a song. I said no. That one word cost me everything. By 2019, I was running-heart pounding, bag slung over my shoulder, leaving behind a life I'd barely begun. Exile tastes like ash, let me tell you, but it sharpens your eyes. I saw the same pattern here in India, among Muslims, where Ashraf elites-Syeds, Sheikhs, barely a fifth of the community—clutch Waqf boards like their birthright.

mosques, orchards, schools—are meant for all Muslims. They're treasures, holding crores in value, promising homes for the poor, books for the young. But too often, they're locked away, their profits trickling into Ashraf pockets while Pasmandas—tailors, potters, sweepers—watch their kids go to bed hungry. I heard about a Pasmanda man once, standing outside a grand mosque, told to pray in the back because his caste wasn't "pure" enough for the front. That story hit me like a stone. It was my story, too-pushed to the edges in Pakistan for daring to be me. The Waqf Amendment Act 2025 feels like a shout against that shame, a chance to smash the old hierarchy.

This law's got guts. It says Waqf boards can't be Ashraf-only clubs anymore. It pulls in Shias, Sunnis, Bohras, andhere's the part that makes my heart leap—backward Muslims like the Ajlaf and Arzal. Pasmandas, the 85% who've carried the weight of labor and scorn, get to

eyes and see it: a Pasmanda weaver, fingers cracked from work, voting on funds to build a clinic. An Arzal girl, bright as dawn, knowing Waqf money might send her to school. The act even lets non-Muslims

help manage things—not to meddle, but to keep an eye out, to stop the land sharks and elite games that've drained Waqf for too long.

Not everyone's clapping, though. I've seen the protests, heard the whispers calling this law a betrayal, a grab at Muslim rights. I get the fear—change is scary. But I've lived real betrayal. In Pakistan, they said I'd turned my back on faith when I only wanted honesty. Here, I see the Ashrafs doing the same dance,

every sect, every caste, a

Krishna's with me as I write this. I found Him in my darkest days, when Pakistan's shadows nearly swallowed me. Not in a temple's glow, but in the stubborn beat of my own heart, in a stranger's smile when I had nothing. His flute plays for everyone highborn, lowborn, Muslim, Hindu. This law's like that flute, calling us to lift the weak, to share the load. I don't hate the Ashrafs.

spoke of its rivers, its chaos, its heart. This act makes me believe in that India—a place where a Pasmanda boy can climb without being kicked down. It guards Waqflands from greed, sets up courts to settle fights, opens ledgers for all to see. Pakistan taught me how a

minority can crush a ma-

jority. India's got a chance

to choose better.

I've spent my life hunting for home-not walls, but warmth. The Waqf Amendment Act 2025 offers that warmth to Pasmandas, a place to stand tall. To them, I say: speak loud. To the Ashrafs, I say: make room. To everyone, I say: let's walk in Krishna's light, toward a Muslim world where no one's left behind. This law's a seed. Let's plant it deep.



# SANKARAN NAIR'S SILENT REBELLION ECHOES AGAIN

Nair hailed from Kerala and the Jallianwala Bagh massacre took place in Punjab. Nairfought to bring the British perpetrators to court - exemplifying India's unity across regions.

rime Minister Narendra Modi brought Sir Chettur Sankaran Nair into the spotlight during an address on April 13, 2025 - the 106th anniversary of the Jallianwala Bagh massacre. Speaking at a public event in Haryana, he highlighted Nair as an "unsung hero" of India's freedom struggle and praised Nair's bold stand against the British in the massacre's aftermath. Modi recounted that Nair, "a prominent lawyer holding a high post in the British government... could have enjoyed all the perks and luxuries, but he chose to give it all up" in protest of colonial atrocities. He noted that although Nair hailed from Kerala and the atrocity took place in Punjab, Nair fought to bring the British perpetrators to court - exemplifying India's unity across regions.

Modi urged that "every adult and child" in states like Punjab, Haryana, and Himachal Pradesh should know of Nair's contributions. The Prime Minister's tribute not only honoured Nair's legacy but also carried political overtones. He accused the long-ruling Congress party of having "abandoned a brave nationalist because he didn't fit their narrative," suggesting that leaders like Nair (and even B.R. Ambedkar) were deliberately sidelined in favour of the Nehru-Gandhi family's prominence. Modi asserted that the contributions of figures like Nair had been "buried" in official history. #### **NAIR'S SHORT BIOGRAPHY**

Nair began practising law in 1880 at the High Court of Madras and quickly made a In one notable judgment, risen to become the Advocate-General of Madras, the first Indian to hold that

as Advocate-General from 1906 to 1908, during which time he was occasionally appointed an acting judge. In 1908, Nair was elevated as a permanent Justice of the High Court of Madras, again breaking barriers as one of the first Indian judges on that court. He served on the bench until 1915, earning respect for his jurisprudence. not be treated as outcastes, a progressive decision for its time that underscored his reformist instincts. He also founded and edited legal journals (the Madras Law Journal and Madras Review), contributing to intellectual and social debates in the Madras Presidency.

Parallel to his legal career, Nair was active in politics. He joined the Indian National Congress (INC) and quickly rose in influence due to his intellect and oratory. In 1897, he was elected President of the Indian National Congress at its annual session in Amaravati - becoming the first person from Kerala (and at age 40, one of the youngest) to preside over the Congress. In his presidential address, Nair spoke boldly against the "high-handedness" of colonial administration and advocated for reforms, including self-government for India on par with the rights British citizens enjoyed in England. This constitutionalist approach defined Nair's political phicivil rights and incremental self-rule (Dominion Status within the Empire, at least as a start) through legal and legislative means, rather than mass agitation.

Nair's legal acumen and moderate nationalist credentials earned him respect even among the British. He was appointed to several important posts and committees aimed at reforms. Notably, in 1902 Viceroy Lord Curzon picked him as Secretary to the Raleigh University Commission, which was set up to evaluate higher education in India. For his services, Nair was honoured by the British Crown - made a Companion of the Indian Empire (CIE) in 1904, and knighted in 1912, henceforth being known as Sir C. Sankaran Nair. In 1915, he reached one of the highest positions an Indian could attain under the Raj: he was appointed to the Viceroy's Executive Council, the small governing cabinet of the Governor-General. There, he was given charge of the Education portfolio, effectively serving as British India's education

minister. This appointment made Nair the sole Indian representative in the top echelons of the colonial government at that time.

While in the Viceroy's Council (1915-1919), Nair continued to push for progressive changes. He authored two influential "Minutes of Dissent" in 1919, critiquing the proposed Montagu-Chelmsford reforms for not going far enough in giving Indians a say in governance. In these minutes, Nair pointed out systemic defects in British rule and recommended substantive constitutional reforms – many of which were eventually accepted by the British government. His work helped shape the Government of India Act 1919, which introduced a limited measure of self-governance (dyarchy) in provinces. Despite being part of the establishment, Nair did not hesitate to speak truth to power. This balancing act between minded colonial authorities and voicing nationalist critique defined his political career up to 1919.


#### **ROLE IN THE INDEPENDENCE**

**MOVEMENT** As both a jurist and an activist, C. Sankaran Nair played a unique role in India's freedom movement. Within the Indian National Congress, he represented the liberal, moderate strand of nationalism that sought to achieve self-rule through constitutional means and negotiations. His tenure as INC President in 1897 was marked by calls for expanding Indians' political rights and for holding the colonial government accountable. Even after he entered judicial service (which required a degree of political neutrality), Nair remained sympathetic to the national cause. He briefly served in the Madras Legislative Council around 1900, and later, after leaving the Viceroy's Council, he re-engaged in nationalist politics in the 1920s.

It was not a mere token gesture: by giving up his powerful seat, Nair publicly aligned himself with the Indian people's anguish. Upon returning to Madras, he received a hero's welcome from the public for his stand. The Viceroy, Lord Chelmsford, reportedly asked Nair to suggest his own successor on the Council – in a display of defiance, Nair cheekily nominated his personal servant for the job, as if to say that any common Indian would do, since Indians were treated with such disdain by the regime. This anecdote became legendary and underscored Nair's dis-

dain for British hubris. Determined to expose the Raj's brutality, Nair turned to writing. In 1922 he published a book titled "Gandhi and Anarchy." While the title seemed to criticize Mahatma Gandhi, the book's content also held colonial officials to task. Nair used the book to excoriate O'Dwyer (the Puniab administrator) for his role in fomenting the violence at Jallianwala Bagh . He argued that responsibility for the massacre did not lie with General Dyer alone, but just as much with O'Dwyer's repressive regime in Punjab. Nair's forthright accusations did not go unanswered: Sir Michael O'Dwyer filed a defamation (libel) suit against him in Britain, taking exception to

Nair's claims. Instead of backtracking or apologizing, Nair accepted the challenge and went to England in 1924 to fight the case in the King's Bench - a remarkable instance of an Indian nationalist directly challenging a top British of-

ficial in a British court. The trial of O'Dwyer v. Nair in 1924 became a sensation. For five weeks, a London courtroom heard testimonies about the Punjab atrocities. Nair stood firm, defending his remarks as truth. The odds of an Indian winning a case of this nature in the imperial heartland were slim, and indeed the deck was stacked against him - contemporary accounts noted the judge's bias in favor of O'Dwyer. In the end, the jury was not unanimous, but the verdict went against Nair. He was ordered to either tender a formal apology or pay a fine of £500 as damages. Unwilling to apologize for telling the truth, Nair paid the £500 fine - effectively a symbolic price for bringing the horrors of Jallianwala Bagh to the world's notice. "If all the judges of the King's Bench together were to hold me guilty, my reputation will still not suffer," Nair reportedly said, asserting that an unjust verdict in an imperial court could not tarnish his integrity.

Although he "lost" the

libel suit on paper, Nair achieved his broader objective. The trial garnered extensive press coverage, airing details of the Jallianwala massacre before an international audience. British public opinion was divided - some defended Dyer and O'Dwyer, but many in Britain were appalled at the revelations, with even Winston Churchill condemning the massacre as "monstrous" in Parliament . In India, Nair's stance was celebrated; newspapers praised his courage for standing up to the British establishment despite the legal defeat. Historian Sir Alfred Draper later noted that through this case, "the world [became] aware of what had happened in the Bagh", underscoring how "Sankaran Nair ensured - a nearly unprecedented conscience in India's independence movement.

#### STAND AGAINST **BRITISH RULE AFTER JALLIANWALA BAGH**

(1919) The narrow passage leading into Jallianwala Bagh in Amritsar (pictured) became a death trap on April 13, 1919, when British troops blocked the exit and opened fire on unarmed civilians . The ensuing Jallianwala Bagh massacre was a turning point for many Indian leaders, including C. San-

1922: Publishes Gandhi and Anarchy, a book criticizing British policies (and expressing misgivings about some of Gandhi's methods) while highlighting the truth of Jallianwala Bagh. The book triggers a libel suit from Sir Michael O'Dwyer.

1924: The O'Dwyer vs. Nair libel trial takes place in London. Nair boldly fights the case but the British court rules against him; he pays £500 rather than apologise. The trial publicizes British atrocities in Punjab globally.

1928: Leads the Indian Central Committee to cooperate with the Simon Commission, and as its president submits a report demanding Dominion Status for India.

1934: Passes away on April 22 (or 24), 1934, in Madras at the age of 76.

2001: The Government of India releases a commemorative stamp in his honour, acknowledging his contributions to the freedom struggle.

2025: A Bollywood biographical film (Kesari: Chapter 2) and public tributes (including by the Prime Minister) bring Nair's story back into national conscious-

#### Depression and Social Comparison

The curated and idealized lives shown on social media can lead users to compare themselves unfavorably, fostering feelings of inadequacy, loneliness, and low self-esteem.

Over time, this pattern may contribute to depressive symptoms, especially among teenagers and young adults.

#### Sleep Disorders

The blue light emitted by



screens suppresses melatonin, a hormone that regulates sleep. Late-night gadget use disturbs circadian rhythms, leading to insomnia or poor-quality sleep.

Sleep deprivation has cascading effects, contributing to fatigue, mood swings, and reduced cognitive performance.

#### Physical Health Issues

Eye Strain and Vision Problems (Digital Eye Strain)

Long hours of screen time can cause dry eyes, blurred vision, headaches, and eye fatigue—a condition known as Computer Vision Syndrome.

Children are especially vulnerable, as their eyes are still developing, and excessive gadget use can lead to early onset of myopia (nearsightedness).

#### Text Neck and Posture Is-

Continuously bending the neck to look at screens leads to muscular strain and



stiffness—a condition often termed "text neck."

#### GADGETS AND CHILDREN: A SPECIAL CONCERN

# PREVENTIVE MEASURES AND INTERVENTIONS

While gadgets are here to stay, responsible use and mindful habits can help prevent health problems. Here are some strategies:

# LABOUR MP VS BANGLADESH ACC: A LEGAL **AND DIPLOMATIC FLASHPOINT**

Siddiq denies all allegations and condemns the move as politically motivated.

ritish Labour MP Γulip Siddiq faces an arrest warrant issued by a Bangladeshi court. The country's Anti-Corruption Commission (ACC) accuses her of illegally obtaining land while her aunt Sheikh Hasina, the former Prime Minister, was in power. The warrant targets Siddiq and over 50 others, including her mother and Hasina. After Hasina resigned in August 2024 and left Bangladesh, the government broadened its investigation into corruption during her

Siddiq denies all allegations and condemns the move as politically motivated. However, the case has raised complex diplomatic and legal issues. Since Bangladesh and the UK lack a formal extradition treaty, any potential legal action faces significant obstacles. As tensions grow, observers closely monitor Siddiq's political future and the UK government's response.

Tulip Siddiq, a member of the British Labour Party, has represented Hampstead and Highgate in Parliament since 2015. Born in London in 1982, she is the daughter of Sheikh Rehana and the niece of Sheikh Hasina, Bangladesh's former Prime Minister. Her grandfather, Sheikh Mujibur Rahman, was the founding

Siddiq studied at University College London and King's College London before beginning her political career as a Camden councillor. She later became a Member of Parliament and served as Economic Secretary to the Treasury and City Minister from July 2024 until January 2025. She resigned amid the corruption investigation involving her family in Ban-

Siddiq faces corruption charges in Bangladesh. She allegedly participated in land transactions during her aunt Sheikh Hasina's rule. The ACC claims that father and first president of Siddig and her relatives

acquired valuable plots of land in Dhaka illegally.

According to the ACC, Hasina and her family received a half-acre plot in Purbachal, a proposed township near Dhaka, without proper documentation. Siddiq has also been accused of using her political influence to secure three plots of land in Dhaka's diplomatic area for her mother Sheikh Rehana, brother Radwan, and sister Azmina, all of whom reside in the UK.

These allegations form part of a broader investigation into Hasina's government. The ACC is also investigating the alleged embezzlement of £3.9 billion (Rs 44,148 crore) from

On April 13, 2025, Dhaka Metropolitan Senior Special Judge Zakir Hossain Galib issued the arrest warrant after reviewing three ACC cases. The warrant targets Siddiq, her aunt Hasina, her mother Rehana, and other individuals connected to the previous government.

The ACC asserts that it has gathered substantial documentary evidence to support its case. ACC chairman Mohammad Abdul Momen told the BBC that the corruption charges are serious and that Siddiq must face legal proceedings in Bangladesh.

deny any wrongdoing. They argue that the ACC has not contacted her nor provided any evidence to support the charges. Siddiq's legal team points out that she does not own property in Bangladesh and has never used her political influence to secure land.

The case presents significant legal and diplomatic challenges. Siddiq is a British citizen and a sitting MP, and Bangladesh and the UK lack an extradition agreement, making it unlikely that Bangladesh can force her to return for trial.

The UK classifies Bangladesh as a 2B extradition country, meaning any request for extradition would require approval from UK

ministers and judges. To proceed, Bangladesh would need to present credible evidence.

Siddiq's lawyers argue that she has not received formal notification of the arrest warrant and contend that the charges are part of a political strategy aimed at damaging her reputation and distracting from Bangladesh's internal problems following Hasina's depar-

The arrest warrant has sparked strong political reactions in the UK. Siddiq, who served as anti-corruption minister under Keir Starmer, resigned in January 2025 amid the Bangladesh corruption probe.

# Murder, extremism, and a Presidential What April 14 attack on Sumy hit list: The Casap case explodes

Nikita Casap, a Wisconsin teenager, has been charged with the brutal murder of his parents and is now accused of plotting to assassinate US President Donald Trump. Federal court documents have revealed disturbing plans for political violence, making this case one of the most shocking to emerge recently. Here's a breakdown of the case and its alarming details.

#### THE CRIME: DOUBLE **HOMICIDE**

In February 2025, Nikita Casap allegedly killed his mother, Tatiana Casap, and stepfather, Donald Mayer. Their bodies were discovered nearly two weeks later, decomposing in their home after a welfare check was requested due to Casap's extended absence from school. According to investigators, the mother's body was found under a pile of clothes and blankets, while Mayer's body was discovered in the home office. Both had sustained gunshot wounds, and authorities suspect the killings were part of a larger, more sinister plan.

Federal affidavits detail that Casap's actions weren't just about the double homicide. Instead, they were the first step in a much larger plot involving political violence. Law enforcement believes the teenager intended to gain financial resources and autonomy to fund his eventual assassination of

# **EXPLAINER**

President Trump. Text messages, handwritten notes, and images found during the investigation further illustrated his intent to destabilize the gov-

Casap allegedly joined a neo-Nazi extremist group called "The Order of Nine Angles," which espouses racially motivated violence and terrorism. A manifesto found by the FBI reportedly included disturbing references to Adolf Hitler, calls for the assassination of the president, and plans for terrorist attacks.

#### THE ASSASSINATION **PLOT**

Documents obtained from Casap's phone outlined plans to assassinate President Trump. The motive, according to a chilling manifesto, was to spark a political revolution and "save the white race." Casap believed that eliminating Trump and possibly the vice president would cause widespread chaos, aligning with his extremist views.

Authorities also discovered that Casap was in the process of acquiring explosives and a drone to carry out the assassination. He had reportedly begun financing these purchases, using his stepfather's financial resources.

Casap's alarming intentions were not kept secret. A classmate revealed that Casap had shared disturbing "gore edit" videos via

Snapchat, featuring violent war imagery and references to political violence. The classmate also disclosed that Casap had previously confided in him about his plans to kill his parents and the larger conspiracy to overthrow the US government. Casap allegedly told him that if there were news of ten coordinated attacks, it would have been his doing.

Casap has been charged with multiple felonies, including two counts of firstdegree intentional homicide and charges related to hiding a corpse. Federal authorities are also pursuing charges related to attempting to assassinate a US president, conspiracy, and the use of weapons of mass destruction. Casap is facing a long road ahead, with his next court hearing scheduled for May 7, 2025.

The question on many people's minds is: why President Trump? According to Casap's manifesto, he intended to create chaos and initiate a political revolution by targeting the leader of the United States. He believed that killing Trump would accelerate his desired revolution, drawing from his extremist beliefs. The Nikita Casap case has shocked many with its chilling details, including plans for assassination and political violence. As the legal process continues, the case remains a significant example of how extremist ideologies can drive disturbing actions. Casap's next court date is expected to provide further insights into the extent of his intentions and the motivations behind his

# signals about Russia's war strategy

Russia launched a deadly missile strike on the Ukrainian city of Sumy on April 14, 2025. This attack killed at least 10 civilians and injured over 25 others. Ukrainian officials said the strike damaged several residential buildings, a school, and key power infrastructure. The scale of destruction and civilian deaths has raised fresh questions about Russia's changing strategy in its war against Ukraine. While Sumy had previously been spared from frequent attacks, this strike indicates a deliberate attempt to expand the scope of war beyond the heavily targeted eastern and southern re-

#### **WHY DID RUSSIA TARGET SUMY?**

Sumy lies just 30 kilometres from the Russian border in northeastern Ukraine. Although not a central part of the ongoing front-line battles, the city plays a strategic role in Ukraine's defence and supply networks. It is part of the transportation route used for moving humanitarian aid and military supplies. Moreover, its railway connections link northern cities to other key areas in Ukraine. By hitting Sumy, Russia seems to be trying to disrupt these supply routes and create panic in border areas that were previously considered relatively safe. The attack may also be an attempt to divert Ukrainian military attention from the eastern and southern battlefronts by opening pressure

points in the north.

The Sumv strike is not an isolated incident. It is part of a larger trend where Russia has begun attacking Ukrainian cities outside the main conflict zones. In recent weeks, missile and drone attacks have hit Kharkiv, Chernihiv, and other border areas. This shows that Russia is e

**CIVILIAN SUFFERING** The April 14 missile strike caused serious damage to homes, schools, and energy systems in Sumy. One of the hardest-hit areas was a residential apartment building, where several families were either killed or left homeless. A local school was also damaged, forcing students to halt in-person learning. Additionally, the strike knocked out a key electricity substation, plunging parts of the city into darkness.

According to the Ukrainian military, the missile used

in the attack was likely an Iskander short-range ballistic missile, which is known for its destructive power. Emergency crews described the aftermath as "devastating." Many residents had to be rescued from beneath the rubble, and hospitals became overwhelmed with injured victims.

#### **PATTERN OF ESCALA-TION IN 2025**

The Sumy attack adds to a growing list of Russian strikes targeting Ukrainian cities far from the front lines. Earlier this year, a drone attack hit Kharkiv's train station, injuring dozens of civilians. Russia also attacked Odesa's grain export facilities, affecting Ukraine's agricultural trade. In Chernihiv, a missile destroyed a part of a hospital. These attacks suggest that Russia's strategy now includes creating chaos across Ukraine, not just gaining



territory in the east.

Military experts say that this expansion of the war zone is meant to complicate Ukraine's military planning. If Ukraine has to defend more cities across a wider area, it becomes harder to organize strong counteroffensives in the east and south. This could help Russia slow down Ukrainian advances and buy time on the battlefield.

The missile strike on Sumy on April 14 could signify a major change in the trajectory of the Russia-Ukraine conflict. Several key developments are likely to follow in the coming months. In response to the strike, Ukraine may need to strengthen its defences in the northern regions, which would require significant resources and military personnel. This could divert valuable troops and equipment from other fronts, weakening its overall defence strategy.

Russia may attempt to carry out more limited ground attacks near border areas like Sumy. These strikes could force Ukraine to stretch its defences even further. This could also be part of a broader Russian strategy to gain political leverage in future peace talks or negotiations. As attacks on cities far from active combat zones increase, the risk to civilians in areas once thought to be safe rises. This will place immense pressure on Ukraine's emergency services, heightening concerns over civilian morale and safety.

# XI PLEDGES STABLE NEIGHBOURHOOD POLICY

Xi highlighted Asia as a new centre for global cooperation and development.

Visiting Vietnam to enhance political and trade ties amid a major tariff row with the US, Chinese President Xi Jinping Monday said that China will ensure continuity and stability in its neighbourhood diplomacy and jointly advance the modernisation of Asia.

Xi arrived in Hanoi on his first visit abroad after US **President Donald Trump** slapped steep tariffs against China while pausing levies on a host of other countries, including Vietnam, Malaysia and Cambodia - the three countries on the Chinese president's current itiner-

In an article published in Vietnam's Nhan Dan newspaper ahead of his visit, Xi said China would deepen friendly cooperation with neighbouring countries by ensuring continuity and stability of its neighbourhood diplomacy.

"We will stay committed to the principle of amity, sincerity, mutual benefit and inclusiveness," he wrote. "We will continue to pursue the policy of forging friendship and partnership with our neighbours," he added.

Amid the tariff war with the US, Xi is visiting the three Southeast Asian countries which are part of the ASEAN bloc with which Beijing has its largest foreign trade, totalling over USD 962 billion.

The ASEAN countries, Vietnam in particular also faced a major crisis as the US tariffs targeted the country which prospered by reshoring Chinese industries and products and exporting them to the US, benefiting from Trump's tariffs against China in his previous term.

Vietnam became the

biggest beneficiary of the China Plus One strategy of several multinational firms like Apple besides Chinese companies moving their investments there to escape the US tariffs, becoming one of the key trade routes for exports to America.

Last year alone, Vietnam's exports to the US amounted to over USD 142 billion.

Trump last week hit Vietnam with 46 per cent tariffs, one of the highest besides China, in an apparent bid to target Hanoi's reshoring

After fervent appeals from Vietnam, Trump agreed to negotiate a new tariff deal during the 90-day pause in the levies on many countries except China.

Before the key visit to three Southeast nations, Xi pledged to strengthen strategic bonds with neighbouring nations by "appropriately" managing differences and enhanced supply chain ties as the tariff war with the US escalated.

In his first public speech after Trump's tariffs, Xi called for breaking new ground for China's neighbourhood diplomacy at a meeting of the ruling Communist Party of China in Beijing on April 9.

China sought to improve ties with several countries in its fraught neighbourhood. Beijing in recent months winded down border tensions with India and sought to improve its relations with other major neighbours like Japan and South Korea, bracing for tough times under

# 10 terrorists including two Sikh men arrested in Pakistan's Punjab

Two Sikhs are among 10 terrorists arrested by the law enforcers in Pakistan's Punjab province, police said on Monday.

According to a spokesperson of the Counter-Terrorism Department (CTD) of Punjab police, it foiled a major terrorist plan by arresting 10 terrorists during operations in different areas of Punjab.

"Among the arrested terrorists are two Pakistani Sikhs -- Suraj Singh and Badal Singh. Both Sikhs have been arrested from Rawalpindi. They hail from Nankana Sahib district of Punjab and are active members of Jaey Sindh Muttahida Mahaz, a separatist political party advocating separation of Sindh province from Pakistan."

The spokesperson further said it conducted 189 intelligence-based operations in different districts of the province last week and arrested the 10 terrorists and recovered weapons, explosives and other prohibited materials. He said the other eight arrested terrorists are from banned Tehreeke-Taliban Pakistan (TTP).

### EU unveils multiannual Euro 1.6 billion support programme for Palestine

Most EU disbursements will be linked to the Palestinian Authority's progress on key reforms in fiscal



Monday stated, "Today, at the occasion of the firstever High-Level Political Dialogue between the European Union and the Palestinian Authority, the Commission is proposing a multiannual Comprehensive Support Programme worth up to EUR1.6 billion to foster Palestinian recovery and resilience. With this Programme, the EU reiterates its unwavering support for the Palestinian people and its commitment to a lasting and sustainable peace based on the Two-State solution."

### China's major ports stalled as tariffs disrupt trade flow

engaged in foreign trade in China are beginning to show the initial effects of the ongoing tariff conflict between the two biggest economies in the world, as reported by Radio Free

By Thursday, hardly any cargo ships were headed to the US from the once-bustling ports of Shanghai and Guangdong, while export factories in provinces vital to China's export economy have largely come to a standstill, according to sources within the country, as highlighted by RFA.

Local business owners stated that stacks of shipping containers, which did not make it onto ships bound for the US by the April 9 deadline, are now accumulating at the ports of Shanghai and Guangdong, as per RFA re-

Inside warehouses, goods that were originally planned for export to the US are left unattended, while factory production has halted in Zhejiang and Guangdong, which are the two provinces contributing the most to China's exports in 2024, the RFA report emphasized.

On Wednesday, US ident Donald Trump declared he would increase "reciprocal tariffs" on China to 125 per cent, stating that this would take effect immediately. The White House subsequently clarified that the total tariffs on Chinese imports amount to 145%, factoring in a prior 20% tariff placed on Beijing regarding fentanyl trade, as reported by RFA.

The back-and-forth tariff exchange that has occurred between Washington and Beijing over the past two months was instigated when Trump enforced a 10% tariff on China on February 4, pointing to its involvement in the fentanyl trade, a potent opioid contributing to a significant number of deaths in America, according to the RFA report.

Just days prior, Shanghai's Yangshan and Waigaoqiao terminals were bustling with activity as ships hurried to load containers in a frantic attempt to finish shipments and depart before the new tariffs took effect, as noted in the RFA report.

ronmental samples have been reported in Pakistan in 2025, with new districts also impacted by the wild poliovirus The active circulation of the YB3A4A B-cluster of the poliovirus in Pakistan, especially in the Khyber Pakhtunkhwa, Sindh, and Balochistan provinces, remains a concern. Karachi, Peshawar, and Quetta have

become hotspots for the wild poliovirus type 1 (WPV1), which continues to spread in central parts of Pakistan and southern Khyber Pakhtunkhwa.

The WHO voiced concern over the spread of WPV1 in both Pakistan and Afghanistan, stressing that the virus is now confined to two nations globally.




The massacre occurred in Amritsar, Punjab, where thousands had gathered at Jallianwala Bagh during the festival of Baisakhi.

# WHAT CAUSES WARTS AND HOW TO GET RID OF THEM?

n unpleasant and unattractive skin condition is warts. Skin warts typically seem like little blister-like growths on a person's hands or feet. It might also manifest in other areas of the body. The human papillomavirus, or HPV, which is what causes it, is an infection. More than 15,000 viruses make up the HPV virus category. Actually an STD/STI, HPV is a sexually transmitted infection or disease. Anyone who engages in sexual activity has the risk of contracting HPV if their partner has the virus. Skin-to-skin contact is how it is spread. Warts can appear in different body parts or on the genital areas of those who have HPV.

Dr. Karuna Malhotra, Aesthetic Physician and Cosmetologist at Cosmetic Skin and Homeo Clinic, Rajouri Garden, New Delhi explains that "the distinctions between warts, moles, and skin tags are often unclear. Despite the fact that each of the three of them is unique in nature and arises for distinct reasons. Warts

are typically little blisters or skin lesions that are the same colour as the person's skin."

#### **HOW IS IT TRANSMITTED?**

Apart from HPV which is sexually transmitted infection warts are also spread through skin contact by shaking hands, turning door knobs or typing on keyboards used by many; sharing common shoes or towels also causes warts. Yes, people do get warts from other people with warts; they don't get them from anywhere else. If you

have any type of skin wart, it means that you came in contact with a wart-causing virus sometime in the past, though it could have been months ago

#### **WHO ARE AT RISK?**

Any person who has very sensitive or damaged or wet skin is more prone to catch the infection. Apart from this person being sexually active, having weak immune system, under prolonged stress, having hormonal disorders and being exposed to external effects such as radiation, chemical emissions of industrial cities,

oily or junk food is at risk to get warts once in a lifetime. Also, the wart virus is transmitted most rapidly in areas having warm and humid air like spas, saunas, swimming pools, gyms or clubs.

#### **PRECAUTIONS**

- The first and foremost way to prevent skin warts is to avoid coming into contact with the virus.
- Make sure you wash your hands properly each time before you touch anything.
- Do not share your shoes or towels with anybody, also do not use anybody else's towels or shoes.
- Keep your skin healthy and well moisturized in all seasons be it winter or summer; do not keep your skin dry for long.
- Do not bite your fingernails; also while shaving make sure that you use a sharp razor that won't tear or cut your skin.

#### **TREATMENT FOR WARTS**

Dr. Malhotra stated that some warts need not to be medically treated; it may go on their own. If your warts cause bleeding or pain then do see the good dermatologist. Options of removing warts are:

 Chemical treatment where warts are removed with acids, alkalis or medications containing salicylic acid which works by removing layers of the wart a little

#### Key Nutraceuticals for Diabetic Retinopathy 1. Omega-3 Polyunsaturated

Fatty Acids (PUFAs)

Omega-3 PUFAs, particularly docosahexaenoic acid (DHA) and eicosapentaenoic acid (EPA) play a crucial role in retinal structure and function. Studies suggest that DHA supplementation can help lower oxidative stress





and inflammation, potentially reducing the severity of DR. Natural sources include fatty fish, flaxseeds, and walnuts. 2. Carotenoids (Lutein and

Zeaxanthin)

These powerful antioxidants accumulate in the retina, protecting against oxidative stress and light-induced damage. Lutein and zeaxanthin have shown promise in reducing retinal inflammation and improving vascular integrity in DR. Foods rich in these carotenoids include spinach, kale, and egg yolks.

#### 3. Polyphenols

Polyphenols are potent anti-inflammatory and neuro-

Resveratrol, present in grapes and red wine, supports vascular health and reduces oxidative stress.

Quercetin, abundant in onions and apples, aids in stabilizing blood sugar levels while protecting retinal capillaries from degeneration.

4. Anthocyanins

Anthocyanins, found in blueberries, blackberries, and black currants, possess anti-angiogenic properties, meaning they help prevent abnormal blood vessel growth a key issue in advanced DR.

5. Saponins Ginsenosides, the active compounds in ginseng, have been shown to reduce inflammation, prevent vascular leakage, and support retinal cell survival.

Nutraceuticals offer a promising adjunctive strategy for preventing and managing diabetic retinopathy by reducing oxidative stress, inflammation, and vascular damage. While more clinical trials are needed to confirm their longterm benefits, incorporating nutrient-rich foods into the diet may help support retinal health and delay DR progression. However, individuals with diabetes should consult a doctor before adding nutraceutical supplements to their regimen.


