# GOVT WILL NOT DENOTIFY Judiciary cannot direct President: V-P WAQF ASSETS TILL MAY 5

The Supreme Court grants a week to the Centre to file response to pleas challenging the Waqf Act

he Centre on Thurs-'day assured the Supreme Court that it will neither denotify Waqf properties, including "Waqf by user", nor make any appointments to the Central Waqf Council and Boards till May 5.

The assurance of solicitor general Tushar Mehta came when he informed a bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan that the Waqf law was passed by Parliament with "due deliberations" and it should not be stayed without hearing the government.

The Centre also strongly opposed the apex court's proposal to pass an interim order against the denotification of Waqf properties, including 'Waqf by user', aside from staying a provision allowing the inclusion of non-Muslims in the Central Waqf Councils and Boards.

"During the course of hearing, the solicitor general states that the respondent (Union of India) would like to put in a short response within seven days. He fur-

# India slams Pak Army Chief's comments on Kashmir

The Ministry of External Affairs (MEA) on Thursday responded to Pakistan Army Chief Asim Munir's comments on Kashmir, emphasising that the view of Kashmir being a "jugular

vein" is baseless.

While addressing a press briefing on Thursday in New Delhi, on the comments by Pakistan Army chief terming Kashmir as a jugular vein, MEA spokesperson Randhir Jaiswal said, "How can anything foreign be in a jugular vein? This is a Union territory of India. It's only relationship with Pakistan is the vacation of illegally occupied territories by that coun-

Jammu and Kashmir's only relationship with Pakistan is that of Islamabad vacating the illegally occupied part of the Union Territory, India said on Thursday.

In his address at an event in Islamabad this week, Gen Munir described Kashmir as the "jugular vein" of Pakistan and asserted that no one would be able to separate Kashmir from his country.

On Pakistan's attempts to wash its hands off the 26/11 terror accused Tahawwur Rana, Jaiswal said: "Pakistan may try very hard but its reputation as the epicentre of global terrorism will not diminish."


"The extradition of Rana serves as a reminder to Pakistan that it needs to bring to justice other perpetrators of the Mumbai attacks whom it continues to shield," he

Rana, 64, was brought to India on April 10 after all hurdles for his extradition

He further said that the reputation of Pakistan as the epicentre of global terrorism will not decrease.

"Pakistan may try very hard, but its reputation as the epicentre of global terrorism will not diminish. The extradition of Rana serves as a reminder to Pakistan that it needs to bring to justice other perpetrators of the Mumbai terror attacks, whom it continues to shield," Jaiswal said.

### Naveen files nomination paper for BJD chief's post added. Patnaik filed the

Odisha's former Chief Minister and Biju Janata Dal (BJD) supremo Naveen Patnaik on Thursday filed his nomination for the post of BJD president, marking his bid for a ninth consecutive term. Speaking at a press con-

ference, BJD State Returning Officer (SRO) and party MLA Pratap Keshari Deb confirmed that Patnaik was the sole nominee for the top post.

"We are currently in the process of conducting the party's organisational

elections. Today, Naveen Patnaik filed his nomination between 10 AM and 1 PM, the designated time slot. Since there is only one nomination, he will be declared the next party president," Deb said.

The official announcement of Patnaik's unopposed election is expected the day after tomorrow, following completion of procedural formalities. He has been elected as the BJD president eight times consecutively since the party's inception in 1997, with his most recent election being in February 2020.



Deb also informed that the lists of district presidents and state council members have been finalised. "The next step will be the selection of the state executive members," he

The BJD secured 51 seats, losing power after 24 years. Three independent MLAs later joined the BJP, increasing its tally to 81 seats. The Indian National Congress (INC) won 14 seats.

# Robert Vadra's entry into politics looks more 'definite' after ED grilling

Robert Vadra, husband of Congress General Secretary Priyanka Gandhi Vadra, has once again hinted at joining active politics, even as he remains under investigation in an alleged land scam case in

After three days of continu-"definitely enter politics" and work for the Congress party, with the support and blessings of his family.

Vadra is being investigated in connection with land deals, where he is accused of buying land in violation of certain legal and procedural norms. The probe, which has put him under intense scrutiny, appears to be getting deeper.

Despite this, Vadra maintains that such inquiries are not new to him and are often used as pressure tactics. He

stated that he is not afraid of summons and will continue

working for the people. Although Priyanka Gandhi and Vadra are handling the situation personally, the Congress party has kept a distance from the matter. The focus within the party currently remains on senior leaders like Sonia Gandhi and Rahul Gandhi.

There is no official party support or public statement regarding Vadra's case, and no significant political movement has emerged from it either.

Vadra has long expressed a desire to enter politics and was even speculated to be a potential candidate from Amethi during previous elections.

However, reports suggest

that his political entry was not fully supported within the family. He has repeatedly said that he is ready to take up political responsibilities but has not received a clear opportunity yet.







# Opposition leaders gather at RJD office in Patna for key talks

eaders of the Communist Party of India (Marxist-Leninist) Liberation and other opposition parties convened at the Rashtriya Janata Dal (RJD) headquarters in Patna on Thursday to begin discussions within the Mahagathbandhan alliance.

The meeting involves more formal deliberations, focusing primarily on seatsharing arrangements and the formulation of a Common Minimum Programme ahead of the upcoming assembly elections in Bihar.

Speaking to the reporters, Kunal, Communist Party of India (Marxist-Leninist) Liberation leader, said, "These are preliminary discussions (on seat sharing). We will have to talk about forming a Common Minimum Programme and set an agenda.'

Kunal further added," There are several issues across the country, across the state, for which we will have to think about together...Tejashwi is the leader of the biggest party...A Mahagathbandhan government will be formed..."

Meanwhile, BJP leader Shahnawaz Hussain launched a sharp attack on the Mahagathbandhan, calling it a "complete flop show" and predicting a big defeat for the alliance in the upcoming Bihar elections.

He claimed that there is an internal conflict between Congress and the Rashtriya Janata Dal (RJD), and that Tejashwi Yadav was engaged in corrupt, dynasty-based politics. He also criticised Congress for promoting Kanhaiya Kumar, referring to him as a leader of what he termed the "Bharat Tere Tukde

Honge" group.

"It is the meeting of the 'Ghamandia' alliance. There is a clash between Tejashwi Yadav and Congress. Tejashwi Yadav is leading an extremely corrupt political dynasty. Kanhaiya Kumar, promoted by the Congress, is the leader of the 'Bharat Tere Tukde honge' gang," Rai said.

A high-stakes battle is expected to take place in Bihar, with the National Democratic Alliance (NDA), comprising Janata Dal (United) led by Bihar Chief Minister Nitish Kumar, and the Bharatiya Janata Party, competing against the Mahagathbandhan, comprising the Congress, Rashtriya Janata Dal (RJD), and left parties. The Governor's decision comes after State BJP president Sukanta Majumdar and former MP Roopa Ganguli took a number of men, women and children who were victims of the riot to meet the Governor.

Meanwhile, the West Bengal Police announced the formation of a ninemember Special Investigation Team (SIT) to probe the recent outbreak of violence in the minority-dominated Murshidabad district, where the protest against the Waqf Amendment Act,

more than a week, became violent.

The SIT comprises an Additional Superintendent of Police (Intelligence Branch), two Deputy Superintendents -- one from the Counter Insurgency Force (CIF) and the other from the Criminal Investigation Department (CID) -- five inspectors (including four from the CID and one from Traffic Police), and the in-charge officer of the Cyber Crime Police Station under Sundarban Police District.

In another development, the Calcutta High Court on Thursday instructed Central forces to remain stationed in Murshidabad district. The court also called for restraint, asking all parties to avoid provocative statements amid ongoing tensions.

The directive came from a division Bench comprising Justices Soumen Sen and Raja Basu Chowdhury, which also told the Trinamool Congress-led State administration to constitute

which has been going on for a team for the rehabilitation and resettlement of those who fled the district to escape the violence.

The court suggested that a three-member panel, comprising one member each from the National Human Rights Commission, the West Bengal State Human Rights Commission and State Legal Services Authority, should visit the affected pockets of the district to oversee the restoration of peace and rehabilitation of people displaced due to the violence.

This came after the West Bengal Government told the High Court that the State police were up against a crowd of around 10,000 people as violence broke

The 34-page report details out the scale of violence that ripped through Jangipur in Murshidabad district last week, starting on April 11. The report highlighted that an unruly mob of 4000-5000 people had attacked the police and even snatched away the service revolver of a senior officer.

# HC asks police to register case against TN minister for his controversial remarks

The Madras High Court on Thursday directed the Tamil Nadu police to file a case against state Forest Minister K Ponmudy, following his recent controversial remarks and warned of contempt if they failed to do so.

The judge, Justice N Anand Venkatesh, made the observations orally.

Ponmudy created a controversy recently with his Shaivism-Vaishnavism remarks made in the context of a sex worker at a public meeting, drawing widespread criticism, including from his own party MP Kanimozhi.

On Thursday, the Court cautioned the police that if they do not register the FIR against the DMK leader, it will initiate suo motu (on its own) contempt against them.

When the suo motu revision case



against Ponmudy relating to a disproportionate wealth case came up for hearing, Justice Anand Venkatesh expressed concern over the remarks made by the DMK leader.

Earlier in the day, the judge asked the Advocate General to get instructions from DGP as to whether any FIR was registered against Ponmudy and posted the case to this evening.

When the case was taken up for hearing in the evening, the judge asked AG "where is the FIR". Can this court take that FIR has been registered.

Advocate general PS Raman submitted that the police have received five complaints and that they will investigate and register FIR.

The judge said, "If they don't register FIR, I will initiate suo motu contempt". "Now, the court has taken cognizance

of the matter. Even If they do not have a complaint, register a case and proceed with the investigation," the judge added.

## NHRC expresses concern over health dept's inaction in MP's 'fake doctor' case

The National Human Rights Commission (NHRC) Member Priyank Kanungo on Wednesday raised serious concerns over the response of the health department in the case of a fake doctor who operated in Madhya Pradesh's Damoh district, and who allegedly caused deaths of at least seven patients at a Hospital there.

Kanungo said the actions--or lack thereof--by health officials following the revelation of the doctor's forged documents were deeply troubling.

He further questioned the findings and approach of the Chief Medical and Health Of-

Kanungo said the actions--or lack thereof--by health officials following the revelation of the doctor's forged documents were deeply troubling

ficer (CMHO) in the investigation, stating that it resulted in inaction, despite clear indications of fraud.

"The kind of action taken by the health department is concerning. The doctor's fake documents are prima facie information," said Kanungo.

"The investigation by CMHO has led them to inaction... When it is clear that someone has fake documents, then whether the surgery done by the person is right or not is no longer a matter of investigation. This was negligence on their part in the investigation," he said.

Earlier, Damoh Child Welfare Committee chairman Deepak Tiwari called for a full investigation into the matter after police arrested the man accused in the case.

On April 7, Madhya Pradesh Chief Minister Mohan Yadav said that his government will take strict action in the case and highlighted that the State government would not make any delay in taking action against such cases and instructed that if there is any other such case in the State, the health department should take strict action against

### Customs search was held in violation of Customs Act: Ranya to High Court

Kannada film actress Ranya Rao, also known as Harshavardhini Ranya, who was arrested in a high-profile gold smuggling case, told the Karnataka High Court on Thursday that the search and seizure carried out by the Directorate of Revenue Intelligence (DRI) violated provisions of the Customs

Appearing before Justice S Vishwajith Shetty, senior

advocate Sandesh J Chouta, representing Ranya, argued that the search was conducted in violation of Section 102 of the Customs Act, which mandates that any person being searched has the right to be taken before a magistrate or a gazetted customs officer.

He claimed that failure to

comply with this provision rendered the entire seizure invalid

Chouta also highlighted procedural irregularities in the search and arrest, citing discrepancies in the mahazar and the notices issued before the operation.

He pointed out that the officer who led the search and arrest was merely stated to be a gazetted officer, raising doubts about the legality of



the entire operation.

In addition, Chouta told the court that the grounds of arrest were not formally communicated to Ranya's family members in writing, as required under the law.

residence led to the recovery of gold jewellery worth Rs 2.06 crore and Rs 2.67 crore in cash. She faces charges under

multiple provisions of Sections 135 and 104 of the Customs Act.

# 'Garbage mountains will disappear like dinosaurs in 5 years', says Sirsa

Delhi Environment Minister Manjinder Singh Sirsa on Thursday said the government was exploring the possibility of hiring an additional agency to expedite the waste processing and asserted the city's garbage mounds would "disappear just like dinosaurs" in the next five years.

He also stressed monitoring the progress of the work and said, "The CM's office and our department will monitor all dumps and landfills continuously."

In the future, every vehicle entering Delhi will be monitored, and every construction site over 500 square meters will be under surveillance, he highlighted. All data will be uploaded daily to a government dashboard, including pollution levels and waste removal statistics, and those who fail to meet deadlines will face penalties, he as-

# Eight Bangladeshi nationals living illegally in city detained

In a major crackdown on illegal immigration, the staff of Police Station South Campus, South West District, Delhi, has detained eight Bangladeshi nationals found residing unlawfully in various areas of

The operation was executed on April 15, 2025, following a tip-off regarding the presence of illegal migrants near Satya Niketan Market. Following their detention, the deportation process was promptly initiated with the assistance of the Foreigners Regional

Registration Office (FRRO), Delhi, and all eight individuals were transferred to the designated deportation centre on April 16. Investigations revealed that most of them had entered India illegally between 2007 and 2023 through various borders, including Tripura, Ghoja Donga, and Benapole, with some using the help of brokers. Several were found working in Delhi as domestic help or enrolled in the vocational training program. # DJB GETS RS 3,000 CR BOOST FOR 27 **NEW SEWAGE PLANTS**

DJB aimed to build 40 DSTPs since 2023, but progress stalled due to funding delays.

NEW DELH

n a significant development to clean the Ya-Lmuna river, the Delhi Jal Board (DJB), grappling with a severe financial crunch, has received a much-needed boost with the approval of over Rs 3,000 crore to set up 27 DSTPs across the national capital. Although the DJB initiated the decentralised sewage treatment plants (DSTP) plan in 2023 with a target of constructing 40 such units, progress had stalled due to the delay in funding approval.

"This is the first major (financial) push we have received," a DJB official said.

The funds, sanctioned by the Expenditure and Finance Committee headed by Chief Minister Rekha Gupta, will be used to set up 27 DSTPs across the city. Work on these projects has already begun, the official added.

Industrial waste, which these plants aren't designed to treat, continues to be a major problem,Rs said water activist Varun Gulati.

The newly approved 10 MGD plant at Delhi Gate is also seen as critical. Initially slated for completion by March 2025, work on it is yet to start, another official said. "This plant will handle sewage from the Walled City and nearby areas that currently flows untreated into the river near the Raighat power plant," the official added.

# Delhi govt's excise revenue rises to Rs 7,766 cr in 2024-25

TDG NETWORK NEW DELHI

The Delhi government's excise revenue in 2024-25 rose to around Rs 7,766 crore as compared to Rs 6,762 crore three years ago, showing signs of recovery from the disruptions caused due to allegations of irregularities related to the excise policy for 2021-22, officials said on Thursday. The excise revenue of the government in 2021-22, including excise duty and Value Added Tax (VAT) on liquor, was Rs 6,762.61 crore, a growth of more than 15 per cent, they added.

It rose to Rs 6,830 crore in 2022-23, Rs 7,430.97 crore in 2023-24 and Rs 7,765.97 crore in 2024-25, the officials said.

The figure for 2024-25 is likely to go up slightly as the data on excise duty and VAT is available only till February. The Delhi government last month extended the existing excise policy for three more months as it is yet to frame a new version of it.

The extended policy, also known as the old excise policy, came into operation in September 2022 after the then Aam Aadmi Party (AAP) government scrapped its reformative policy (2021-22) that ran into rough weather amid allegations of irregularities in its formulation and imple-

The old policy has since been extended for varying periods as the Delhi government is yet to come up with a new policy.

Chief Minister Rekha Gupta recently said that her government is working on a new, foolproof and transparent excise policy to augment revenue. She said the new policy will be prepared on the basis of the best practices followed in other

Additional Public Prosecutor Yogita Kaushik Dahiva said the convict did not deserve any leniency for his abominable act of kidnapping, committing repeated penetrative sexual assault and threatening the girl in March 2021.

In its verdict dated April 15, the court cited a 2015 Supreme Court verdict, according to which, "Undue sympathy by imposing an inadequate sentence would do more harm to the justice system by undermining the public confidence in the efficacy of the law.'

It also cited another 2006 apex court verdict that said the quantum of sentence must depend upon the conduct of the accused, the state and age of the sexually-assaulted female and the gravity of the criminal act, and that crimes of violence upon women need to be severely dealt with. The court said, "Taking into consideration the aggravating and mitigating circumstances, including the gravity of the offence, the age of the victim and the convict, the family condition of the convict and the child, social and economic factors governing them, the convict is sentenced to 20 years' rigorous imprisonment (RI) under Section 6 of the POCSO

# Not defamation if homebuyers peacefully protest against builders, SC holds

The Supreme Court on Thursday held homebuyers have a right to protest peacefully against builders for their grievances and it doesn't amount to defama-

A bench of Justices K V Viswanathan and N Kotiswar Singh said any attempt to portray it as a criminal offence, sans necessary ingredients, would be a clear abuse of process and ought

to be "nipped in the bud".

"A right to protest peacefully without falling foul of the law is a corresponding right, which the consumers ought to possess just as the seller enjoys his right to commercial speech," the bench said.

The observation came when the bench quashed a criminal defamation case against homebuyers for erecting banners being dissatisfied with the services of the developer

"We find that the manner

of the protest resorted to by the appellants was peaceful and orderly and without in any manner using offensive or abusive language. It could not be said that the appellants crossed the lakshman rekha and transgressed into the offending zone," the bench said.

The top court observed "no foul" or intemperate language used by the homebuyers against the developer.

"There is no reference to any expression like 'fraud, cheating, misappropriation',



etc. In mild and temperate language, certain issues, which the appellants perceived as their grievances have been aired...," it noted.

In a business relationship like that of a builder and homebuyer, the court said, certain allowances in the use of phraseology in communication should be provided as long as the deployment of the phraseology in question was based on good faith.

The top court observed language is the vehicle through which thoughts are conveyed and said, "Had the appellants exceeded their privilege in erecting the banner? We do not think so. As set out earlier, all that the banner depicts is what they thought were their grievances against the respondent with whom they had a business relationship."

The bench added, "The banner sets out that one of the issues was "ignoring grievances" implying thereby that there have been running issues between the two - something which is bound to occur in a builder-buyer relationship."

The top court said the careful choice of the words, conscious avoidance of intemperate, rude or abusive language and the peaceful manner of protest, points that banners were erected to protect the legitimate interests of the homeowners.

"Their case wholly falls within the sweep, scope and ambit of exception 9 to Section 499. Their peaceful protest is protected by Article 19(1)(a) (b) and (c) of the Constitution of India. The criminal proceedings levelled against them, if allowed to continue, will be a clear abuse of process," it

In the top court, homebuyers challenged the summons in the defamation case filed by the builder.

The defamation case was filed against homebuvers for erecting banners with "false and defamatory statements' against the builder.

The Borivali magisterial court in Mumbai on October 4, 2016, after examining the complaint and verifying the complainant's tatement, issued summons against the homebuyers.



dani Ports and SEZ Ltd, India's biggest private port operator, announced on Thursday a USD 2.4 billion noncash acquisition of a coal export terminal in Australia from a group company to strengthen its presence in the Asia-Pacific region.

The Board of APSEZ "approved the acquisition of Abbot Point Port Holdings Pte Ltd (APPH), Singapore, from Carmichael Rail and Port Singapore Holdings Pte Ltd, Singapore (CRPSHPL)", the company said in a statement.

CRPSHPL is a related party. APPH owns the entities which own and operate the North Queensland Export Terminal, a dedicated export terminal with a current nameplate capacity of 50 million tonnes per annum (MTPA). The terminal is located at the Port of Abbot Point, approximately 25 km north of Bowen in North Oueensland on Australia's east coast.

APSEZ had originally, in 2011, acquired the North Queensland Export Termi-

for USD 2 billion. Two years later, in 2013, the Adani family purchased the asset from APSEZ for the same amount, along with the capital invested, enabling the company to concentrate on expanding its domestic operations.

Now, with a strengthened balance sheet and a dominant position in India, APSEZ is reacquiring the terminal as part of its global growth strategy.

"The transaction will be completed on a non-cash basis. APSEZ will issue 14.38 crore new equity shares to nal (NQXT) at Abbott Point CRPSHPL in exchange for the acquisition of 100 per cent interest in APPH. This is based on an enterprise value of NOXT of Australian Dollar 3.975 billion (about USD 2.4 billion)," the statement said.

The acquisition is valued at almost similar levels to the transfer done in 2013. This valuation is despite capital investments, growth and inflation of the past 12 years and at slightly discounted multiples to the recent deals in the re-

The acquisition will accelerate the APSEZ's target of doubling its volumes to 1 billion tonnes per annum by FY30, with a potential to near quadruple its volume - from 35 million tonnes in FY25 to

This is the fourth overseas acquisition for India's largest port developer in the past two vears. With this, the company will have a portfolio of 19 ports and terminals - 15 domestic and 4 overseas. A port in Israel, terminals in Tanzania and Sri Lanka are the other three international locations where APSEZ has its operations.

NQXT has a contract with Bravus Mining and Resources (formerly Adani Mining, fully owned by Adani Enterprises) for the export of 9.3 million tonnes of thermal coal from the Adani Carmichael coal mine.

The move by APSEZ comes at a time when the global ports industry is gaining strong prominence amid rising trade tensions, particularly between the US and China.

US investment giant Black-Rock is reportedly seeking to acquire Panama Ports from Hong Kong-based conglomerate CK Hutchison for USD 23 billion but has faced resistance from Chinese stake-

## Infosys misses growth target, forecasts weak fiscal start

Infosys Ltd, India's second biggest IT services company, missed its revenue growth target for fiscal year FY25 and slipped on profit, despite besting analyst estimates on both fronts. The company also projected its slowest growth for the fiscal at the start of the year in a decade.

The Bengaluru-headquartered company ended the 12 months through March 2025 with \$19.28 billion in revenue, beating a Bloomberg estimate by 46 analysts of \$19.16 billion. But its 4.2% year-on-year (y-o-y) revenue growth in constant currency terms (not taking currency fluctuations into account) missed the guidance of 4.5-5% that it had outlined in January 2025.

On the profit front, Infosys's net profit for the year fell 0.28% to \$3.16 billion. A survey of 44 analysts by Bloomberg had pegged net profit at \$3.09 billion.

Alongside, the company projected flat to 3% revenue growth for the current fiscal (FY26) in constant currency terms, its slowest guidance since April 2009, when it had projected a revenue decline of 6.7-3.1%

Peer Wipro Ltd also expects to grow its topline at its slowest pace in the first three months of FY26. On



On the profit front, Infosys's net profit for the year fell 0.28% to \$3.16 billion. A survey of 44 analysts by Bloomberg had pegged net profit at \$3.09 billion.

Wednesday, Wipro outlined a quarterly revenue decline between 3.5% and 1.5% in constant currency terms. Wipro gives guidance for the following quarter whereas Infosys gives guidance for the full year.

"At the bottom end of the guidance, we have baked in some deterioration in the environment, some heightened uncertainties," said Jayesh Sanghrajka, chief financial officer of Infosys, in the company's postearnings media briefing on Thursday.

The company's chief executive officer Salil Parekh, though, said clients have not paused and things could change quickly. "Things can change in a short period in terms of what can happen with the economic outlook," said Parekh in the media briefing.

TCS and Wipro have also called out their clients' slow decision making and pause on tech projects. All of this could mean lower job opportunities in the largest IT service providers for the country's 2.5 million college

# EXTRADITING JUSTICE: RANA'S CASE AND THE NEED FOR DEEPER INDIA-US LEGAL TIES

ahawwur Rana's extradition to India represents a significant milestone in increasing collaboration between India and the United States in combating terrorism but also conveys a powerful message that those involved in serious crimes cannot evade justice by crossing international borders. Nonetheless, numerous high-profile cases are still unresolved, underscoring the existing delays and bureaucratic obstacles in the extradition process between the two countries. To ensure justice is served promptly, it is crucial to establish a more efficient. transparent, and timesensitive extradition framework. Both nations should work to strengthen legal collaboration, tackle procedural issues, and foster



outcomes of extradition efforts. While this case marks a positive start, ongoing commitment is necessary to ensure that all offenders face justice.

The Extradition Treaty between India and the United States was signed on June 25, 1997, and became effective on July 21, 1999. This treaty establishes a legal basis for the extradition of fugitives between the two nations, allowing either country to request the return of individuals who are charged with or have been convicted of criminal offences.

tions. The offence should be an extraditable offence which is defined as those crimes that carry a minimum penalty of one year in prison. Nonetheless, extradition may be refused under the political offense exception, which safeguards individuals who are sought for political motives. Additionally, the death penalty clause permits the U.S. to deny extradition if the case involves capital punishment, unless India offers specific assurances. The rule of specialty ensures that prosecution is limited to the particular offense for which extradition was granted, thereby providing legal protections for the accused.

Tahawwur Rana's extradition to India represents a notable diplomatic achievement in India's quest for justice for the victims of the 2008 Mumbai terror attacks. Rana, who is closely linked to David Coleman Headley-responsible for conducting reconnaissance for the attacks who thought to have played a significant role in planning and facilitating the assault that resulted in the deaths of more than 200 individuals.

Securing Rana's presence in India is essential for further exposing the intricate network of conspirators behind the attacks. His questioning and subsequent trial could yield valuable information regarding the operational relationships among Lashkar-e-Taiba, David Headley, and other entities, potentially including the involvement of Pak-

istani intelligence agencies. His appearance in an Indian courtroom could bolster the evidentiary foundation and reinforce India's long-standing assertions regarding Pakistan's role in supporting terrorism. Additionally, this extradition enhances the credibility of India's legal and investigative framework on the international stage and propels India's ongoing efforts to ensure that all those

responsible for the 26/11 attacks are held accountable,

regardless of their location. However, with this diplomatic achievement, yet its practical implications for revealing new insights or achieving justice may be limited. This is largely due to the fact that David Headley, the principal figure behind the 2008 Mumbai terror attacks, has already provided extensive testimony and is currently serv-

ing a 35-year sentence in the United States. Consequently, Rana's involvement may be viewed as secondary. His extradition is unlikely to substantially enhance the investigation or prosecution of other individuals implicated, especially since vital evidence has already been gathered and presented during Headley's testimony.

True justice for the victims of the Mumbai attacks hinges on securing the extradition of David Headley himself. As the main conspirator who conducted thorough reconnaissance of the targeted locations and worked closely with Lashkar-e-Taiba and ISI operatives, Headley has direct knowledge of the attacks' planning and execution. His trial in India would not only bring closure to

the families of the victims but also represent a significant step toward holding all accountable parties responsible within Indian jurisdiction. However, the complexities surrounding Headley's cooperation with U.S. authorities and his plea agreement make his extradition a challenging endeavour. Nonetheless, India must persist in its efforts to secure his custody as a matter of justice and national integrity.

India has submitted over 65 extradition requests to the United States, but only 11 have led to successful extraditions. This statistic underscores the considerable obstacles faced in the extradition process between the two countries. Many requests have been stalled for years or denied due to discrepancies in legal stan-

dards, procedural holdups, or issues related to human rights, prison conditions, and the death penalty in India. With nearly one-third of India's total extradition requests worldwide aimed at the U.S., this slow progress raises significant concerns regarding the efficacy of current legal cooperation between the two nations.

This scenario highlights the urgent need for India and the United States to enhance their extradition framework through stronger diplomatic and legal collaboration. Addressing gaps in mutual legal understanding, aligning procedural requirements, and fostering clear communication between law enforcement agencies are vital steps to move forward. Furthermore, a strong political commitment, supported by strategic diplomatic efforts and timely follow-ups, can facilitate the swift resolution of outstanding cases.

Building stronger bilateral relations cantered on mutual legal assistance and trust is essential to prevent fugitives from taking advantage of legal discrepancies or differences in judicial systems. Only through ongoing efforts and a shared commitment can both countries ensure that justice is delivered promptly and effectively.

# The underrepresented queens in Indian curriculum

To the question of what history is, it is the study of past events, particularly human affairs. It is otherwise the whole series of past events connected with a particular person. So history is the study and documentation of the past. History is an umbrella term comprising past events as well as the memory, discovery, presentation and interpretation of these events.

India's struggle for independence was really a saga of courage, resilience, and sacrifice deeply rooted in the love and patriotism of its people. The successive governments too paid little attention to the valiant queens and their long lasting contribution.

Who then are the traitors? Indians themselves are to take the blame. Under the magic spell of Western taste

to attract readers, they glorified the colonial rulers and the Mughul rulers thus ignoring the sacrifices of native Indian Queens.

Moghul India attracted the historians whereas the Rajput Rebellion (1708-1710) was hardly a subject of national interest. They deliberately avoided the coverage of such great milestones in textbooks or research books. They just concentrated on the glorification of the alien rulers thus ignoring the great sacrifices by the queens.

Is this national spirit? Such books were recommended for curriculum in UPCS exams and Universities. The native queens were ignored in their research while the aliens were projected in historical theses and books.

ndia boasts a rich and multifaceted history of traditional medicine, a legacy stretching back thousands of years, deeply interwoven with its culture, philosophy, and spiritual beliefs. These ancient systems of healing, developed through generations of observation, experimentation, and intuitive understanding of the natural world, continue to play a significant role in the healthcare of a large segment of the Indian population and are increasingly gaining global recognition for their holistic approach to well-being.

The earliest roots of Indian traditional medicine can be traced to the Vedic period (circa 1500-500 BCE). The Rigveda, one of the four sacred texts, contains hymns that mention medicinal plants and concepts related to health and disease. The Atharvaveda, in particular, is considered a primary source for early medical knowledge, detailing various ailments, their causes (often attributed to supernatural forces alongside physical factors), and remedies involving herbs, rituals, and incantations. This period marks the nascent stage where empirical observations began to merge with metaphysical explanations of health.

The subsequent era, often referred to as the Classical period of Ayurveda (circa 800 BCE - 1000 CE), witnessed the systematic codification and flourishing of medical knowledge. This era produced the foundawidely practiced traditional system in India. The Charaka Samhita, attributed to Charaka, primarily focuses on internal medicine, detailing the principles of Tridosha (the three fundamental energies: Vata, Pitta, and Kapha), diagnosis, prognosis, and a vast pharmacopoeia of plant-based remedies. The Sushruta Samhita, attributed to Sushruta, is renowned for its advancements in surgery, describing intricate surgical procedures, instruments, and classifications of diseases. The Ashtanga Hridaya and Ashtanga Sangraha by Vagbhata represent a concise synthesis of the principles laid down in the Charaka and Sushruta


Samhitas. These texts not only documented existing knowledge but also contributed significantly to the theoretical understanding of physiology, pathology, and therapeutics. The establishment of early medical universities like those at Taxila and Nalanda during this period facilitated the dissemination and advancement of Ayurvedic knowledge. Parallel to the develop-

ment of Ayurveda, another

significant indigenous

system, Siddha medicine, evolved predominantly in South India, particularly in the Tamil-speaking regions. Its origins are deeply intertwined with the ancient Tamil civilization and spiritual traditions. The term "Siddha" translates to "perfection" or "attainment," and its practitiotional texts of Ayurveda, ners, the Siddhars, were the most prominent and revered as spiritual masters who possessed profound medical wisdom and often alchemical knowledge. While sharing some fundamental principles with Ayurveda, such as the concept of five basic elements, Siddha developed its unique theories, diagnostic methods (including pulse diagnosis - Naadi pariksha), and a rich pharmacopoeia that includes not only herbs but also minerals and metals, often prepared through complex alchemical processes. The literature of Siddha is primarily in Tamil, with key texts attributed to the eighteen Siddhars, with Agasthya being considered the founding father of the system.

The arrival of Unani med-



icine in India around the 12th century CE marked a significant confluence of medical traditions. Originating in Greece with Hippocrates and Galen, the Unani system was further developed and enriched by Arab and Persian scholars before being introduced to the Indian subcontinent by Arab rulers and physicians. The Delhi Sultanate, the Khiljis, the Tughlaqs, and the Mughal emperors provided significant patronage to Unani scholars, leading to its widespread adoption and integration into the Indian medical landscape. Unani medicine is based on the concept of four humors (blood, phlegm, yellow bile, and black bile) and emphasizes maintaining their balance for good health. It utilizes a wide range of herbal remedies, dietary modifications, and physical therapies. Over centuries, Unani practitioners in India adapted the system, incorporating local knowledge and medicinal plants into their practice, leading to a distinct Indo-Unani tradition.

Beyond these three major codified systems, India has a vast and diverse array of local and tribal medical traditions. These often orally transmitted systems are deeply rooted in the specific ecological knowledge and cultural practices of individual communities. They utilize locally available

plants, animal products, and traditional healing rituals to address health concerns. While not always formally documented, these traditions represent an invaluable repository of indigenous knowledge about the medicinal properties of the local flora and fauna and often provide primary healthcare in remote and underserved

The period of British colonial rule in India brought about a significant shift in the healthcare landscape. Western medicine, with its emphasis on empirical evidence and scientific methodology, was

introduced and gradually gained prominence, particularly in urban centers. Traditional systems faced periods of neglect and even suppression. However, they continued to be practiced by a large segment of the population who often found them more cultural-

ly relevant, accessible, and

affordable.

Following India's independence in 1947, there was a renewed focus on recognizing and promoting the indigenous systems of medicine. The governframeworks to support the development and standardization of Ayurveda, Siddha, and Unani, collectively often referred to as AYUSH (Ayurveda, Yoga & Naturopathy, Unani, Siddha, and Homoeopathy with Homoeopathy being a system adopted from the West but widely integrated into Indian healthcare). This period witnessed efforts to integrate traditional medicine into the national healthcare system, alongside modern medicine, to provide a more comprehensive and culturally sensitive approach to healthcare delivery.

The late 20th and early 21st centuries have seen a resurgence of inter-

# FRAGRANCE OF ROYALS: ITRA TRADITIONS OF RAJASTHAN'S KINGS AND QUEENS

n the majestic courts of Rajasthan, where Lheritage dripped from every carved arch and jeweled turban, itra—the natural, alcohol-free perfume-was more than just a scent. It was an identity. It was tradition bottled in fragrance. Among the many symbols of royaltyembroidered silks, swords in gold sheaths, palaces of marble—itra held a unique and intimate place in the daily life of Rajasthani kings and queens.

#### **A SYMBOL OF ROYALTY AND** REFINEMENT

The royal families of Rajasthan, especially the Rajput clans, were renowned for their courage, grace, and highly refined aesthetic sensibilities. From the way they dressed to the rituals they followed, every detail reflected sophistication and discipline. In this world, fragrance was a silent yet powerful emblem of elegance. Itra, made through delicate distillation of flowers, roots, and herbs, was considered the purest form of perfume—fit only for royalty.

The use of itra was often ritualistic. It was applied before court appearances, religious ceremonies, and especially during festivals and matrimonial alliances. The application of itra marked the beginning of something auspicious. It was believed to purify the body, calm the mind, and prepare the spirit. In a desert land where dust and heat prevailed, fragrance was a kind of oasis—comforting,



cooling, and majestic.

### THE ART OF MAKING

Unlike modern perfumes, which are typically alcohol-based and synthetically enhanced, traditional itra is a result of patience, purity, and craftsmanship. The process begins with the careful plucking of flowers such as rose (gulab), jasmine (chameli), and kewra in the early morning when the blossoms are most fragrant. These are then subjected to a process called deg bhapka, a hydro-distillation method using copper cauldrons, clay seals, and bamboo pipes.

This method is slow and labor-intensive, often taking several days to complete a single batch. Sandalwood oil is typically used as the base, not only for its own rich, woody aroma but also because it acts as a natural preservative. The final product is a deeply concentrated essence, a drop of which can linger on fabric or skin for days

patronized this craft extensively. Each royal court had its own attarwala (perfume master), who would curate blends specific to seasons, events, and even moods. Some itras were cooling and floral, used in summer. Others were spicy and warm,

occasions.

For queens and princesses, itra was part of their beauty regimen. Mixed with oils, applied after baths, or dabbed gently behind the ears and on wrists, it created an aura of timeless grace. For kings, itra was also a statement of authority and mystique. Historical anecdotes suggest that kings would often use muskbased itras before battle, believing it strengthened their resolve and heightened their presence among soldiers.

The use of itra also extended to textiles and furnishings. Royal garments were stored in perfumed chests or lightly scented before wearing. Pillowcases, bedsheets, and even tents for travel were sometimes infused with itra. Walking into a roval chamber was as much an olfactory experience as a visual one-aromas mingled with velvet and gold, leaving lasting impressions.

#### **RITUAL AND SPIRITUAL USE**

Itra's role was not limited to adornment-it had deep spiritual connotations. Temples within palace complexes would use floral itras during aarti (prayer rituals), especially on idols of deities. Itra was seen as an offering of purity and devotion. During royal pujas (prayer ceremonies), priests would anoint kings and queens with drops of sacred itra on

On occasions like Rakhi, Teej, and Diwali, gifting itra was a common custom. Nobles would present intricately bottled itras as tokens of goodwill, diplomacy, or love. These bottles were often made of colored glass, sometimes hand-painted, sealed with silk threads or wax, and stored in carved wooden boxes—luxurious from start to finish.

#### **GENDERED FRAGRANCES: SCENT AS IDENTITY**

Interestingly, the choice of itra often followed the rules of gendered scent preferences. Queens preferred floral itras—rose, champa, mogra, and jasmine. These evoked femininity, grace, and serenity. Kings leaned toward bolder profilesmusk (kasturi), amber (ambar), oud, vetiver (khus), and saffron (kesar). These were earthy, smoky, and powerful, meant to convey strength and masculinity.

However, scent was also seen as an extension of one's personality and not just gender. A philosophical echo of the royal past.

#### **REVIVAL AND MODERN INTERPRETATIONS**

In recent years, as interest in slow, sustainable, and organic products has grown. itra has found a new audience. Boutique brands, often inspired by Rajasthani heritage, are now working with traditional artisans to create handcrafted itras that stay true to old methods.

Tourists visiting palacesturned-hotels in Jaipur, Udaipur, and Jodhpur often find themselves enchanted by the lingering scent of rose or sandalwood in the air. Some heritage hotels have even curated scent experiences—where guests can learn about and blend their own itras, experiencing a slice of royal life.

The government of Rajasthan, too, has shown interest in preserving this intangible cultural heritage by supporting local distillers and encouraging the documentation of traditional perfume recipes.

#### **THE BOTTLED LEGACY**

Itra, for the royals of Rajasthan, was far more than a perfume. It was identity, ritual, diplomacy, and luxury-bottled. It whispered tales of moonlit palace corridors, perfumed gardens, and velvet-clad courtiers. In every drop was a memory of a bygone era-rich with scent, symbolism, and style.

Today, as Rajasthan continues to blend tradition with modernity, the story of itra lives on—not just as a fragrance but as a heritage that refuses to fade.

Court's recent unanimous ruling on the definition of "woman" within the context of the Equality Act 2010 has ignited a significant debate with far-reaching implications for the application of equality law across Scotland, England, and Wales. The court's decision clarifies that the terms "woman" and "sex" in the Act refer to biological sex and do not inherently include transgender women, even those holding Gender Recognition Certificates (GRCs). This judgment, stemming from a legal challenge brought by the gendercritical campaign group For Women Scotland (FWS), has the potential to reshape how single-sex spaces, services, and regulations are interpreted and applied.

#### **UNDERSTANDING THE** CORE OF THE RULING

At its heart, the Supreme Court's ruling addresses a fundamental question: what constitutes the legal definition of "woman" under the Equality Act, a piece of legislation designed to protect individuals from discrimination in various aspects of life, including employment and wider society. The specific point of contention was whether this definition encompasses transgender women who have obtained a Gender Recognition Certificate, a legal document that recognizes their affirmed

gender in the UK. The court unequivocally stated that the terms "woman" and "sex" within the Equality Act are to be understood as referring to

biological sex. This means that for the purposes of the Act, a "woman" is defined he UK Supreme as a female person based on their biological characteristics at birth. The ruling explicitly excludes transgender women, even those with a GRC, from this inherent definition.

The 88-page judgment emphasized the binary nature of sex as understood by the law, stating that "the concept of sex is binary, a person is either a woman or a man." The court reasoned that interpreting "sex" to include "certificated sex" (i.e., the gender recognized on a GRC) would create inconsistencies and undermine the clear definitions of "man" and "woman" as protected characteristics within the

#### THE PATH TO THE **SUPREME COURT**

The case that culminated in this landmark ruling originated from a legal challenge initiated by For Women Scotland (FWS) against the Scottish government. This challenge was specifically directed at the Gender Representation on Public Boards (Scotland) Act 2018, legislation aimed at improving gender balance on public sector boards in Scotland.

The initial point of conten-

tion arose when an amendment to the Scottish government's bill broadened the scope of the legislation's definition of "woman" to include all transgender women, irrespective of whether they held a Gender Recognition Certificate. FWS, a group holding gender-critical views, launched a judicial review, arguing that this inclusive definition would have broader ramifications



for single-sex spaces and groups, such as hospital wards and prisons. Their concern was that treating transgender women as legally equivalent to biological women would compromise the purpose and safety of these spaces.

In response to the initial judicial review, Scottish ministers revised the statutory guidance to align with the Equality Act, limiting the definition of "woman" for the purpose of the public boards legislation to include only transgender women who possessed a GRC. However, FWS pursued a further judicial review, arguing that even this revised definition was too broad. This second judicial review was dismissed, leading FWS to escalate the case to the UK Supreme Court, the highest court in the land for matters of significant public or constitutional importance.

### THE EQUALITY ACT

It is crucial to understand that the Equality Act itself already contains provisions that allow for the exclusion of transgender women (including those with a GRC) from single-sex groups and services under specific circumstances. Section 7(2)(f) of the Act states that a person is not to be treated as the same sex as another person if they are a transsexual person. Schedule 3, Part 1, Paragraph 26 of the Act further elaborates on this, permitting the exclusion of transgender individuals

from single-sex services if it

is "a proportionate means of

achieving a legitimate aim." FWS argued that if they lost their case and the legal definition of "woman" was deemed to inherently include transgender women with GRCs, the application of these exemptions would become significantly more complex. They contended that a transgender woman legally recognized as a woman would then be able to claim sex discrimination if excluded from a womenonly space, potentially undermining the ability of such groups to maintain their single-sex nature for their intended beneficiaries.

The Supreme Court's decision has several significant implications:

Clarity on the Definition of "Woman" in the Equality Act: The ruling provides a definitive interpretation that "woman" and "sex" in the Equality Act refer to biological sex. This offers a clearer legal framework for understanding these terms within the context of antidiscrimination law.

No Change to Existing **Exclusion Provisions: The** ruling does not alter the existing provisions within the Equality Act that allow for the exclusion of transgender women from single-sex spaces and services if such exclusion is a "proportionate means of achieving a legitimate aim." However, the clarity on the definition of "woman" may influence how these provisions are applied and interpreted in future cases

Potential Calls for Legislative Reform: Despite the court's interpretation, the ruling is likely to fuel further debate and calls for potential revisions to the Equality Act. The Equality and Human Rights Commission (EHRC), the body responsible for enforcing the Act, had intervened in the case, suggesting that Parliament may not have fully appreciated the implications for women if transgender women with GRCs were legally considered female for all purposes under the law. This suggests a potential divergence between the legal interpretation and the intended scope of inclusivity.

Impact on Policy and Guidance: The ruling will likely necessitate a review and potential revision of policies and guidance across various sectors concerning singlesex spaces and services to ensure they align with the Supreme Court's interpretation of the Equality Act.

#### **PERSPECTIVES ON** TRANS RIGHTS

Lord Hodge, the Deputy President of the Supreme Court, explicitly urged against viewing the decision as a victory for one group at the expense of another. He emphasized that all transgender individuals retain clear legal protections against discrimination and harassment under the Equality Act, specifically under the protected characteristic of "gender reassignment." This highlights that while the ruling clarifies the definition of "woman," it does not diminish the legal rights and protections afforded to transgender people.

#### **REACTIONS TO THE RULING**

The ruling has elicited diverse reactions from different communities and campaign groups: Transgender Community: Campaign groups like Scottish Trans expressed concern and urged calm within the trans community. Stonewall, a prominent LGBTQ+ charity, described the ruling as "incredibly worrying." These reactions underscore the potential impact of the decision on the sense of inclusion and legal recognition for transgender women.

Gender-Critical Campaigners: Groups like Sex Matters, who actively participated in the case, welcomed the ruling. Maya Forstater, the group's chief executive, stated that the court had provided "the right answer" by affirming that "sex - male and female - refers to reality, not to paperwork." This perspective emphasizes the importance of biological sex in the context of equality law and single-sex provisions.

#### THE PATH FORWARD

Following the Supreme Court's judgment, the immediate next steps involve understanding and implementing the implications of the ruling across various sectors. Scotland's First Minister, John Swinney, stated that the Scottish government accepts the ruling and that "protecting the rights of all" will guide its response.

This suggests a commitment to navigating the complexities arising from the judgment while upholding the rights of both women and transgender individuals. The ruling has brought to the forefront the intricate balancing act required in equality law to protect individuals from discrimination while also addressing the specific needs and concerns related to sexbased provisions. The debate surrounding the definition of "woman" and its implications for single-sex spaces is likely to continue, potentially leading to further discussions about legislative reform.

# Bangladesh vs India: Can Dhaka afford a trade war?

Tensions between Bangladesh and India have reached a boiling point, raising serious concerns about the future of their economic partnership. With India suspending crucial transshipment facilities and Bangladesh halting yarn imports through key land ports, the already fragile trade relations between the two neighbors are under immense pressure. The fallout could have wide-reaching implications—not only for the two countries but also for landlocked neighbors like Bhutan and Nepal, who rely on these corridors.

#### **INDIA HALTS TRANSSHIPMENT**

In April, India made the strategic decision to suspend its transshipment facility for export cargo bound for Bangladesh. This facility had served as a vital trade link not only between the two countries but also for Nepal and Bhutan, which depend on Indian routes to access Bangladeshi ports. Soon after, Bangladesh retaliated by suspending the import of yarn through maior land ports including Benapole, Bhomra, Sonamasjid, Banglabandha, and

Burimari The impact of these deci-

sions is already being felt across the region.

#### **POLITICAL STRAINS & ECONOMIC FALLOUT**

The deteriorating political relationship between India and Bangladesh is central to this trade standoff. The political upheaval in Bangladesh that saw the exit of long-time Prime Minister Sheikh Hasina led to a rise in anti-Hindu attacks, drawing sharp condemnation from Indian political leaders. As nationalist sentiments flared on both sides, diplomatic engagements lost their effectiveness.

Although Indian Prime Minister Narendra Modi and Bangladesh's interim leader, Chief Adviser Muhammad Yunus, met recently to ease tensions, their discussions failed to yield any tangible progress. The aftermath saw both countries taking increasingly

#### **B'DESH'S PIVOT TOWARDS PAKISTAN**

Amid souring relations with India, Bangladesh is seemingly warming up to Pakistan. In a notable development, Bangladesh has initiated efforts to enhance direct shipping links with Islamabad. Pakistan's Foreign Secretary, Amna Baloch, recently visited Dhaka for the Foreign Office Consultation (FOC), signaling renewed diplomatic and trade engagement between the two countries.

#### **NUMBERS BEHIND** THE TRADE TIES

Despite current tensions, India remains Bangladesh's most significant trade partner. According to the India Brand Equity Foundation (IBEF), bilat-

eral trade between the two countries reached \$12.9 billion in FY24. India exports a wide range of products to Bangladesh-over 5,620 in total—including cotton, mineral fuels, automobiles, food industry by-products, and various machinery and electronics.

#### **TEXTILE SECTOR IN** THE CROSSHAIRS

Perhaps the most vulnerable area of Bangladesh's economy amid this escalating trade tension is the textile sector. As the backbone of the country's industrial output, textiles contribute around 11 percent to Bangladesh's GDP and employ millions across the country. The sector is heavily reliant on Indian cotton imports— India supplies approximately 35 percent of Bangladesh's cotton needs.

#### **CAN B'DESH AFFORD** A TRADE WAR?

The unfolding scenario begs a pressing question: Can Bangladesh risk a fullblown trade war with India? The answer is complicat-

ed. On one hand, asserting economic sovereignty and exploring new partnerships—such as with Pakistan-could diversify Dhaka's trade portfolio.

In 2025, the return of President Donald Trump to the White House has reignited global economic tensions, as his administration aggressively implements a sweeping tariff strategy aimed at reasserting U.S. economic independence. However, rather than bolstering domestic industry, these measures have triggered widespread disruption in international trade, raised fears of a global recession, and exposed cracks in the foundations of Western economic leadership.

#### **TARIFFS AND TENSIONS**

The Trump administration's decision to introduce a 10% across-the-board tariff-along with even higher rates targeting strategic sectors such as automotive. electronics, and steel—has provoked significant backlash from some of America's most important trading partners. Canada, Mexico, China, and the European Union have responded in kind, imposing retaliatory tariffs on American exports ranging from agricultural goods to manufactured products. This tit-for-tat escalation has had a chilling effect on global trade. According to the World

Trade Organization (WTO),



Trump's tariffs and the decline of

international trade volumes are expected to fall by 0.2% in 2025, a drop that could deepen if further tariffs are enacted. For an interconnected global economy still reeling from post-pandemic disruptions and inflationary pressures, this decline is more than symbolic—it signals a retreat from decades of trade liberalization.

### **ECONOMIC IMPACT**

Markets have responded nervously. A recent Bank of America survey reveals that investor confidence has plummeted to its lowest level in 30 years. The S&P 500 has experienced significant declines amid fears of stagflation—where inflation persists even as economic growth stalls. Businesses and investors alike are grappling with the uncertainty of a trade environment that appears increasingly politicized and unpredictable.

The specter of a U.S. recession looms large. Rising input costs due to tariffs, particularly on imported

components and raw materials, have increased operational expenses for American companies. In response, many have scaled back investment and hiring. Consumers, facing higher prices on everyday goods from electronics to groceries, have also tightened their spending.

#### **DISRUPTIONS TO SUPPLY CHAINS**

One of the clearest consequences of the tariff strategy has been a disruption to global supply chains. Earlier this year, importers rushed to bring goods into the U.S. ahead of the new tariffs. But these efforts provided only temporary relief. Forecasts now predict a 20% decline in containerized imports in the second half of 2025, threatening inventory shortages and pushing up consumer prices.

Industries heavily dependent on global supply chains, such as electronics, automotive, and retail, have been especially hard-hit.

# EXPLAINER

As companies scramble to reconfigure their logistics and sourcing strategies, the result has been delays, rising production costs, and fewer choices for consumers—all of which feed into broader inflationary trends.

#### **LONG-TERM IMPLICATIONS** The United States—and the

West more broadly-has long championed free trade as a pillar of its global influence. By taking a protectionist turn, the Trump administration risks unraveling the very structures that enabled the rise of Western economic dominance in the 20th and early 21st centuries. If the current trajectory continues, the global economy could shift toward a more multipolar model, with trade and economic power more evenly distributed among a broader group of nations. This transformation could have far-reaching consequences. The erosion of Western leadership in trade could embolden alternative economic models and ideologies, diminish the role of Western financial institutions, and complicate international cooperation on major global issues like climate change and digital regulation.

# SPACEX LEADS BID FOR TRUMP'S **GOLDEN DOME MISSILE DEFENSE**

n 2025, Elon Musk's SpaceX, along with technology startups Palantir and Anduril, emerged as a leading contender to build a critical component of President Donald Trump's ambitious missile defense initiative, dubbed the "Golden Dome." This development marks a significant moment in the intersection of Silicon Valley's burgeoning tech sector and traditional defense contracting, highlighting the increasing role of private companies in national defense programs.

The Golden Dome is envisioned as a massive missile defense system designed to protect the United States from missile attacks, seen as one of the most catastrophic threats by President Trump, according to his January 2025 executive order. SpaceX and its partners are

traditional defense contractors like Boeing and Lockheed Martin.

bidding to play a central role in this project, which would involve constructing a network of satellites to detect and track missiles. SpaceX's proposed plan includes launching between 400 and 1,000 satellites that would be part of a larger system aimed at preventing missile attacks on U.S. soil. A separate fleet of 200 attack satel-

lites, capable of intercepting missiles through missiles or lasers, would complete the system, although SpaceX itself would not be involved in the weaponization aspect.

The significance of this proposal lies not only in its technological ambition but also in its approach. SpaceX has proposed a subscription-based model for the Pentagon, offering the government access to missile defense technology without the need to outright own the system. This subscription service model could expedite the deployment process by circumventing traditional Pentagon procurement protocols, potentially allowing

for quicker rollouts of the

necessary technologies. However, the subscription approach has raised concerns within some parts of the Pentagon, with critics questioning the long-term implications of relying on private companies to manage critical national defense

SpaceX's entry into the defense contracting arena is not surprising given the company's track record with space exploration and satellite technology. Musk's company already operates a large fleet of rockets, including the Falcon 9, and has launched numerous satellites for various purposes, including military applica-

This infrastructure gives SpaceX a clear advantage over other bidders, as the company already possesses the technological know-how and logistical capabilities to deploy large constellations of satellites.

# US accuses Beijing of tariff evasion

The administration of US President Donald Trump is preparing to urge countries to reduce trade with China as part of negotiations over US tariffs, according to a report from The Japan Times.

The US plans to request that they take measures to limit China's manufacturing capabilities, to prevent Beijing from finding ways to circumvent Trump's tariffs. Trump's chief economic advisers are contemplating the proposal of asking officials from other nations to impose what are referred to as secondary tariffs, essentially monetary penalties, on imports from countries that have close ties with China. The US also seeks to encourage trading partners to avoid taking on excess goods from China, according to other sources cited by The Japan Times.

This initiative represents an attempt by Trump's team to rally traditional allies to surround China and increase pressure on Beijing to alter its economic behaviours, as highlighted in The Japan Times report.

China has consistently been a focus of criticism from Trump and previous administrations regarding its trade surplus, alleged theft of intellectual property, and government subsidies that the US claims

undermine competition with American firms, The Japan Times report indicated.

Peter Navarro, Trump's trade advisor, has mentioned that China uses Vietnam to ship products in order to evade tariffs, a practice known as transhipment, characterising Vietnam as "a colony of communist China," as quoted by The Japan

The discussions between the European Union and the U.S. this week vielded little progress in addressing trade disagreements, with Trump's advisers signalling that most of the 20% tariff imposed on the EU will likely remain, according to The Japan Times.

# UK alarmed by Chinese drones in its soil

UK government officials have expressed private worries that drones manufactured in China are being utilised to capture high-resolution imagery of essential national infrastructure locations in the UK, contrary to guidance provided by the nation's security services, as

per media reports.

National Grid Plc, which manages the country's electricity and gas distribution networks, employs drones produced by Shenzhenbased SZ DJI Technology Co. to record videos, take photographs, and capture thermal images of its electricity substations, according to details shared on its website as recently as Sep-



The reports also indicated that DJI drones have been utilized for surveying the construction of Electricite de France SA's Hinkley Point C nuclear power plant, inspecting solar energy facilities, and by Thames Water for overseeing reservoirs and water supplies. The use of these drones oc-

curs despite a 2023 warning from the UK's National Protective Security Authority (NPSA), a division of the domestic security service MI5, advising British organizations responsible for sensitive sites to exercise caution when employing drones "produced in countries with coercive data sharing prac-

Furthermore, in 2022, the US Department of Defense placed DJI on a blacklist of Chinese companies with military connections.

The US Federal Bureau of Investigation has cautioned that drones manufactured in China "present a considerable risk to critical infrastructure," given that they "may exhibit vulnerabilities that could allow data theft or enable network breaches.

Meanwhile, the advisory from the UK's NPSA to British firms states: "The foremost defense for organisations intending to utilise unmanned aerial systems (UAS) might be to limit UAS and their corresponding component procurement from nations that pose a security threat."

## Russian apex court temporarily suspends ban on Taliban

Russia's Supreme Court on Thursday suspended the over two decades old ban on Afghanistan's ruling Taliban, paving the way for the establishment of fullfledged relations between Moscow and Kabul.

Russia had proscribed the Taliban movement as a terrorist outfit in 2003. However, since the hasty withdrawal of the US troops in August 2021, the Taliban has gained control over Afghanistan.

"By decision of the Russian Supreme Court, the previously established ban on the activities of the Taliban movement, included in the

### Temporary tariff pause mitigates trade contraction: WTO

The volume of world merchandise trade is expected to decline by 0.2 per cent in 2025 under current conditions, nearly three percentage points lower than what would have been expected under a "low tariff" baseline scenario, according to the WTO Secretariat's latest Global Trade Outlook and Statistics report released on April 16.

"This is premised on the tariff situation as of 14 April. Trade could shrink even further, to -1.5 per cent in 2025, if the situation deteriorates," said the report. "Services trade, though not directly subject to tariffs, is also expected to be adversely affected, with the global volume of commercial services trade now forecast to grow by 4.0 per cent, slower than expected."

Director-General Ngozi Okonjo-Iweala said, "I am deeply concerned by the



uncertainty surrounding trade policy, including the US-China stand-off. The recent de-escalation of tariff tensions has temporarily relieved some of the pressure on global trade. However, the enduring uncertainty threatens to act as a brake on global growth, with severe negative consequences for the world, the most vulnerable economies in particular. In the face of this crisis, WTO members have the unprecedented opportunity to inject dynamism into the organization, foster a level-playing field, streamline decision-making, and adapt our agreements to

better meet today's global

At the start of the year, the WTO Secretariat expected to see continued expansion of world trade in 2025 and 2026, with merchandise trade growing in line with world GDP and commercial services trade increasing at a faster pace. However, the large number of new tariffs introduced since January prompted WTO economists to reassess the trade situation, resulting in a substantial downgrade to their forecast for merchandise trade and a smaller reduction in their outlook for services

### No amnesty for heinous crimes committed during surge and strategic realignment Maoist conflict: Nepal

Prime Minister K P Sharma Oli on Thursday asserted that individuals responsible for heinous and inhuman crimes committed during Nepal's decade-long Maoist insurgency will not be granted amnesty, as he emphasised the need to uphold justice and expedite the transitional justice process.

Inaugurating the Sixth National Convention of the National Ex-Army and Police Organisation of Nepal (NEAPON) here, Oli, who also chairs the ruling Communist Party of Nepal-Unified Marxist-Leninist (CPN-UML), said transitional justice mechanisms must ensure justice for victims of the conflict that lasted from 1996 to 2006. Oli emphasised the importance of two transitional justice bodies — the



Commission (TRC) and the Commission of Investigation on Enforced Disappeared Persons (CIEDP) — in investigating conflict-era crimes and delivering justice. He acknowledged the delay in their effective functioning but asserted that further postponement would not be tolerated. He reiterated that such crimes are incompatible with the democratic system Nepal has embraced after years of political struggle and the fall of authoritarian rule.

# AGENCIES Political tremors continue

to ripple across South Asia following Bangladesh's dramatic leadership change last August, when mass protests led by a wide-ranging coalition of student groups, civil society activists, and radical Islamists forced Prime Minister Sheikh Hasina to resign.

In her place emerged Nobel Peace Prize winner Mohammed Yunus, widely hailed for his work in microfinance, who was appointed as interim leader amid high hopes for reform and unity. But those early hopes are now giving way to growing unease, both at home and abroad. Yunus's apparent tolerance of Islamist forces and a sharp pivot in foreign policy toward China and Pakistan have raised fears about Bangladesh's internal cohesion and its regional alliances--especially its historically close ties with India.

### B'desh seeks apology from Pak over 1971 atrocities

# Pakistan Army Chief describes Kashmir as 'jugular vein'

The ties between the two countries nosedived after India abrogated Article 370 of the Constitution, revoking the special status of Jammu and Kashmir, and bifurcating the State into two Union Territories on August 5, 2019.

In the same address, the powerful general urged the diaspora to preserve the val-

ues and vision for which Pakistan was created and share its story with their "You have to tell Pakistan's

story to your children so that they don't forget that our forefathers thought we were different from Hindus in every possible aspect of life," he said, evoking the two-nation theory propagated by Pakistan's founder M A Jinnah.

"Our religions are different, our customs are different, our traditions are different, our thoughts are different, our ambitions are different. That was the foundation of the twonation theory that was laid

there. We are two nations,

we are not one nation," he

The general tried to present the case of a country that had a great past and a promising future.

"No matter where you live, remember - your roots lie in a high civilisation, noble ideology, and proud identity," he said. "We have never bowed down before adversity, and we never will."

The complaint has been submitted to both the Kerala Film Chamber of Commerce and the Malayalam film industry's internal complaints committee. Vincy, who is known for her roles in films like 'Rekha', 'Vikruthi', and 'Jana Gana Mana', revealed her discomfort in an Instagram video, sharing that the ac-



tor's behaviour, particularly on the sets of 'Soothravakyam', was inappropriate and unprofessional.

In the video, Vincy shared her experience and expressed that she would no longer work with individuals who misuse substances such as alcohol or drugs. The actress clarified her position after her earlier statements at an anti-drug awareness campaign garnered mixed reactions on-

In the video, she explained that her decision to avoid working with drug users stemmed from an unpleasant experience with a coactor. While she did not initially name the actor, she later filed the complaint following support from the office bearers of AMMA (Association of Malayalam Movie Artists).

In the video, Vincy said, "Some days back, at an anti-drug campaign, I made a statement that I will not work with people I know use drugs. After that, there were several comments questioning my statement, and I felt the need to clarify why I made it. I am making this video to make my stand clear."

Vincy went on to describe specific incidents that made her feel uncomfortable during the shoot. She alleged that the actor, who was the lead artiste in the film, misbehaved with her and a fellow colleague under the influence of drugs. One such incident, she said, involved the actor offering to accompany her to fix a wardrobe malfunction in front of the entire crew. Vincy found the offer inappropriate and difficult to accept.

## Anurag Kashyap slams censorship of 'Phule', questions denial of casteism



sprightly Mumbai Indians continued their ascent in the Indian Premier League with a four-wicket victory over Sunrisers Hyderabad in a one-sided contest on a tricky wicket here on Thursday

Led by Will Jacks who played a decisive role with a fine 36 (26 balls, 3x4s, 3x6s) after a crucial spell of 3-O-14-2, Mumbai Indians executed an all-round show to record their second consecutive win.

The home side came on top for having assessed the Wankhede Stadium pitch accurately and adapting quickly to the conditions it presented, with each of the

pieces falling in place for the five-time winners.

MI's fast bowlers used the short and slower balls well throughout the first innings and nailed their yorkers perfectly. In the run chase, the MI batters showed a clear plan to keep finding the boundaries which kept them on top.

Chasing 163 on a pitch which had grip and turn, MI were also benefited by SRH's reluctance to bring on spin in the powerplay, as the home side made 166/6 in 18.1 overs to record their third win of the season.

Even though Rohit Sharma endured another failure after a promising start in which he made 26 off 16 balls with three sixes, he gave MI the momentum with the bat and the others

capitalised on it.

Opener Rvan Rickelton made a fluent 31 while Survakumar Yaday hammered two sixes and as many fours to make 26 (off 15 balls) to provide a strong support to Jacks.

Captain Hardik Pandya played a crucial cameo of 21 off just nine balls to take MI to the threshold of victory. Tilak Varma (21 not out) then took MI over the line after a late minor hiccup as the home side reached 166 for 6 in 18.1 overs.

In the first half, Sunrisers Hyderabad found late momentum with the bat to fight their way through and post 162 for 5.

With the surface at the Wankhede Stadium providing grip and turn for the spinners and slower

when the two SRH openers got a reprieve each off Deepak Chahar.

Abhishek went down the wicket, swinging his bat on the first delivery. The ball shaped away slightly to take the edge but Jacks failed to get hold of it.

On the fourth delivery, Travis Head played one straight to Karn Sharma at midwicket where he failed to pluck a low catch as the ball fell just short of him.

Abhishek looked to be hitting his strides when he smacked three fours off Chahar in the fifth over but there was just no momentum gained.

# Suruchi, Saurabh pair strike gold as a team in Lima

The pair of Suruchi and Saurabh Chaudhary struck gold at the International **Shooting Sport Federation** (ISSF) World Cup Rifle/Pistol/Shotgun in Lima, Peru, winning the 10m air pistol mixed team title 17-9 over the Chinese pairing of Yao Qianxun and Hu Kai. It was the teenager Suruchi's third ISSF World Cup gold and Saurabh's ninth, including his fifth mixed team gold to go with a mixed team World Cup silver.

The pair made the gold medal match at the Las Palmas range with a combined 580 in qualification, with Suruchi outscoring Saurabh by a couple of points. The Chinese pair topped with 585.

In the decider as well, the Chinese pair got a head-start shooting off to a 2-6 and 4-8 advantage, before a timeout called by coach Samaresh Jung brought a change in the momentum of the match.

Suruchi shot splendidly throughout and the couple of times she missed the 10ring, her Tokyo Olympian partner made up with high 10s including a 10.9 for his first hit of the match. The pair regained the lead

they had lost after the first series of single shots, in the 10th series, going ahead 11-9 after a tied eighth series had levelled the scores at 9-9. They did not look back thereafter and needed just the next three series to wrap up the win as the Chinese misfired first under pressure.



### Raiza Dhillon finishes fifth in women's skeet in Lima

Paris Olympian Raiza Dhillon made it to a first World Cup final, finishing a credible fifth in the Skeet women's event, as India ended competition day two of the second leg of the International Shooting Sport Federation (ISSF) World Cup Rifle/Pistol/Shotgun, with a tally of two golds, one silver and one bronze medal. second behind China in the standings.

Raiza, a former junior world championship silver medalist and a bronze winner at the Asian Championships last year, shot a solid final for a debutant in an awe-inspiring field, bowing out at the 30-shot stage of the 60-shot decider, with 26 hits to her name.

She could not get the better of fourth place finisher Jiang Yiting of China, a Paris Olympics mixed team bronze medalist, whom she had to beat given the disad-



vantage of having the highest bib number. She had shot 19 out of the first 20 to fend off the second Chinese finalist Che Yufei.

Shotgun legend Kimberly Rhode, a three-time Olympic champion and six-time Olympic medalist, won gold with 56 hits, leading an American 1-2-3 in the event, as Samantha Simonton went down 1-2 in a shootoff with Rhode for gold and former world champion Dania Jo Vizzi won bronze.

Kimberly's effort at the Las Palmas range on Wednesday evening gave her a 19th individual World Cup gold and a staggering 26th gold across events, including Double Trap and Mixed Team Skeet.

# BCCI removes assistant coach Abhishek Nayar

The Indian cricket team's assistant coach Abhishek Nayar has been sacked just eight months into the assignment amid speculation of a rift with a high-profile member of the support staff even though Test debacles against New Zealand and Australia are being cited as the reason for his ouster.

Fielding coach T Dilip and Strength and Conditioning coach Soham Desai have also been removed as they have ended their three-year contract with the national team.

India conceded a disappointing 3-1 defeat to Australia in the Border-Gavaskar Trophy 2024-25 and lost the opportunity to qualify for the World Test Championship (WTC) 2023-25 final at Lord's.

As per reports, after the completion of the Melbourne Test, team India head coach Gautam Gambhir was not too happy with the performance of the players in the fourth Test and let them know so.



"While India's recent Test debacles (against New Zealand and Australia) has led to the churning but there is also a feeling in the BCCI that Nayar became a scapegoat in the turf war between an important member of the support staff and a senior star player," a BCCI said.

Speaking at the press conference before the start of the Sydney Test, Gambhir broke the silence on the reports and said that there were some honest words inside the dressing room. He weighed in, calling "honesty" extremely important for the team to achieve great things.

"Those are just reports, that's not the truth and I don't think so I need to answer to any reports, to be honest. And there are some honest words. That's all I can say. And honesty is very important. Honesty is extremely important if you want to go on and achieve some great things," Gambhir told reporters.

According to a source from the BCCI, Abhishek Nayar and another assistant coach. Rvan ten Doeschate, were under scrutiny earlier at the start of 2025, as the BCCI wasn't happy with the apparent 'Kolkata Knight Riders touch' in team management.

# Doping: India becomes 17th country to have Athlete Passport Management Unit

Sports Minister Mansukh Mandaviya inaugurated an Athlete Passport Management Unit (APMU) at the National Dope Testing Laboratory (NDTL) in New Delhi on Thursday, making India the 17th country in the world to have a dedicated system for tracking blood and steroidal profiles of athletes over a period of time.

The APMU will serve as a specialised body responsible for monitoring and managing biological pass-



A biological passport compiles data on an athlete's variables such as blood parameters, hormonal levels, and other physiological markers to detect doping.

The APMU keeps a tab on "anomalies or trends indicative of doping" without directly identifying banned substances.

"APMU is a key milestone in India's fight against doping, enabling the longitudinal tracking of Athletes Biological profiles through the Athlete Biological Passport (ABP) system. This innovative mechanism will help in detecting doping patterns and protect the fairness of sports by identifying unethical practices," Mandaviya said at the inauguration.

Mandaviya said India's APMU will also help neighbouring countries that don't have enough resources to set up similar systems.

The NDTL's APMU aligns with the World Anti-Doping Agency (WADA)

guidelines, strengthening anti-doping programme globally. India joins countries like

China, the USA, Germany, France, Australia and Japan among others to have an APMU at its WADAaccredited dope testing fa-

The inauguration was also attended by Sujata Chaturvedi, Secretary (Sports), Kunal, Joint Secretary (Sports), and other officers of the Ministry of Youth Affairs and Sports including Dr P L Sahu, Director and CEO, NDTL.
