

His journey aboard the Axiom-4 mission is expected to provide critical handson experience in spaceflight operations, launch protocols, microgravity adaptation, and emergency preparedness - all essential for India's crewed space ambitions, an official statement said. "What sets Shukla's mission apart is its strategic importance. 





Agents from the FBI's Legal Attache office in New Delhi informed Sacramento that Passi was wanted in connection with multiple terror attacks across Punjab, FBI Sacramento said.

"He had been evading capture by using untraceable burner phones and encrypted applications. This case reinforces the importance of international cooperation in apprehending those who threaten global security," it said.

Official sources in Punjab said Passia is wanted for orchestrating 16 terror attacks, including 14 grenade strikes in the state and is also suspected to have collaborated with Khalistani terrorist group Babbar Khalsa International (BKI).

In January, the National Investigation Agency (NIA) had announced a cash reward of Rs 5 lakh on Passia in connection with a hand grenade attack on a house in Chandigarh in September last year.

# SC seeks report from HC on non-listing of plea for stay on Nashik Dargah demolition

The Supreme Court has put an interim stay on the Nashik Municipal Corporation's April 1 demolition notice to the Hazrat Saatpeer Sayed Baba dargah in the city, and sought an explanation from the Bombay High Court Registrar General as to why a plea challenging a demolition notice was not listed for hearing urgently.

A bench of Justices PS Narasimha and Joymalya Bagchi noted that there was urgency in the matter as the religious structure could be demolished.

The apex court, in its April 16 order, noted that, according to the senior lawyer representing the Dargah, the plea was filed before the High Court on April 7 and had been sought for listing since April 8.

"We are unable to understand what



transpired from April 9 till today (April 16). Counsel submits that they have been attempting to list the matter every day.

As per the reports, the structure was razed by a civic squad hours before the apex court hearing amid violence.

The bench stated that it has taken "extraordinary measures" in light of the specific statement made by senior advocate Navin Pahwa, who was representing the Dargah management, that efforts were made every day to get the matter listed in the High

Thus, it directed the Registrar General of the High Court to send a report about the listing of the petition and posted the matter for hearing before it on April 21.

'We are unsure of the statement made and that the High Court would not have listed the case despite repeated requests. This is a serious statement and the counsel shall take and feel responsibility for the consequences of such a statement," the bench stated in its order.

While staying the demolition of the Dargah, the bench said, "In the meanwhile, there shall be a stay of notice dated April 1, 2025, issued by the respondent number 1 - Nashik Municipal Corporation as prayed for."

# SC rejects plea for CBI probe into death of Kerala's ADM Babu

The Supreme Court has declined the plea filed by Manjusha, wife of Naveen Babu, who was an Additional District Magistrate in Kerala, seeking a CBI probe into his death.

A bench of Justices Sudhanshu Dhulia and K Vinod Chandran refused to interfere with the Kerala High Court order, which had declined to order a CBI investigation into his death.

A division bench of the High Court had on March 3 dismissed her plea seeking a CBI probe, observing that investigations cannot be transferred to CBI based on personal feelings of the victim and there must be reasonable apprehension based on concrete facts.

Babu's wife then approached the Supreme Court, which on Thursday dismissed her plea.

On October 15, 2024, Naveen

Babu was found hanging in his official quarters. PP Divya, a member of the Communist Party of India (Marxist), which currently forms the government in Kerala, was accused of abetting his suicide by levelling public allegations of corruption at his farewell.

His wife alleged a homicidal angle to the incident and claimed that due to Divya's political influence, the investigation must be carried out by an impartial and independent agency like the CBI or Crime Branch.

She alleged that Babu was disturbed before his death by Divya's remarks at the public event.

# TEEN'S KILLING SPARKS PROTEST IN SEELAMPUR, POLICE TO PROBE

NEW DELHI

elhi Police is probing the role of a woman, who worked as a bouncer for jailed gangster Hashim Baba's wife, after the fatal stabbing of a 17-year-old boy in north-east Delhi's Seelampur area, an official said on Friday.

Kunal was stabbed on Thursday evening in New Seelampur, and police have identified two suspects -- Sahil and Rehan -- after scanning CCTV camera footage from the area, Joint Commissioner of Police (Eastern Range), Pushpendra Kumar, said.

"It is suspected that Kunal was also involved in the stabbing of Sahil. Although Sahil did not die, he, along with Zikra, hatched a plan to take revenge for the attack," a family source said.

Parveen, the mother of the deceased, told reporters, "Zikra used to roam around in the area with a pistol. An incident happened with her cousin Sahil but my son was not involved in it. Yet they killed him. They brutally stabbed him multiple times."

Zikra was previously arrested under the Arms Act

"The murder of a 17-yearold youth in Seelampur is another example of the deteriorating law and order situation in Delhi," Atishi posted on X.

"What is Delhi Police doing? What is Home Minister Amit Shah doing? What is the double-engine government doing?" she asked, referring to the BJP government at the Centre which controls Delhi Police.



# ED arrests Noida realty company promoter

During an inspection in West Delhi's Rajouri Garden assembly constituency, Sirsa highlighted widespread civic violations and pollution concerns, stressing that unauthorised commercial activities in residential localities would not be tolerated.

"In a single lane, there are over 40-50 illegal dhabas and meat shops running without permission. These

pose a serious threat to public health and cause inconvenience to residents," Sirsa told PTI.

"I have instructed the district commissioner and the additional commissioner to take immediate action. Such units will be sealed and their utilities disconnected," he said.

He also said tandoors, dyeing units, denim factories and other polluting industrial activities were operating illegally in the residential colonies, contributing to environmental degradation and affecting the quality of

"Thousands of illegal meat shops and dhabas have come up in the residential areas. They not only cause pollution but also lead to congestion and safety concerns, especially for women and senior citizens. This sit-

uation will not be allowed to continue," he said.

Sirsa emphasised that meat shops must be licensed, hygienic and confined to designated commercial zones.

"Polluting and illegal establishments cannot function within residential colo-

This endangers public health and the well-being of citizens," he added.

He also directed the officials to address waterlogging issues urgently and ensure cleaner roads to pre-

vent the spread of disease. Besides, Sirsa flagged noise pollution and illegal parking as concerns and reiterated the importance of adhering to Supreme Court guidelines on loudspeakers.

With this, Delhi has become the 35th state/Union Territory to implement the health insurance scheme. The Ayushman Bharat scheme provides free and cashless treatment for 1,961 medical procedures across 27 specialties, covering the costs of medicines, diagnostic services, hospitali-

sation, ICU care, surgeries

and more.

Under the scheme, eligible families in Delhi will receive annual health coverage of up to Rs 10 lakh -- Rs 5 lakh from the Centre and an additional Rs 5 lakh as a top-up from the Delhi government

# Hospital technician held in flight attendant sexual assault case

A technician allegedly working at Medanta Hospital here was arrested on Friday in connection with the sexual assault on a flight attendant who was on a ventilator in the hospital, police said.

A senior police officer said that during the interrogation, the accused revealed that he joined Medanta five months ago after completing his bachelor's in Operation Theatre Technology at a private university here. Police said they identified the accused after examining CCTV footage, interrogating the hospital staff and investigating various facts.

"Over 50 employees of the hospital and some doctors were questioned, and footage from 800 CCTV cameras was examined. After multiple analyses, we finally identified the accused and arrested him today. He has confessed to the crime," said Dr Arpit Jain, DCP (headquarters), who led the special investigation team in the case.

The accused will be produced before the court on Saturday for further proceedings, and the probe is still underway, police

# **DELHI GOVT DIRECTS SCHOOLS TO FRAME** SMARTPHONE USAGE POLICY AFTER HC RULING

HC allowed students to carry smartphones but emphasized the need for regulated use to avoid disruption.

ollowing a recent Delhi High Court judgment, the Delhi Government has directed schools to formulate policies regarding students' use of smartphones.

The Delhi High Court has outlined guiding principles to strike a balance between the advantages and potential drawbacks of allowing students to use smartphones while in school.

Accordingly, the Education Department of the Delhi Government has instructed all heads of government, government-aided, and unaided recognised private schools in Delhi to develop and implement a school-level policy on this matter

The Directorate of Education, in its circular dated April 17, 2025, states, "The Hon'ble court has drawn up guiding principles to balance the beneficial and deleterious effect of permit-



ting the use of smartphones in the hands of students while attending the school. Accordingly, all the Heads of Govt., Govt. Aided & Unaided Recognised Private Schools of Delhi are hereby directed to develop a policy on the above said matter on school level and implement

Recently, the Delhi High Court, in a significant ruling, has refused to ban children from bringing smartphones to school. The court clarified in its decision that the use of smartphones does not have a negative impact on teaching, discipline, or the overall educational environment in the classroom.

The judgment passed by Justice Anup Jairam Bhambhani came during the hearing of a petition filed by a student, which sought the issuance of guidelines regarding the use of mobile phones in schools. A minor student represented by Advocate Ashu Bidhuri stated that during the hearing, the parties involved, particularly the Kendriya Vidyalaya Sangathan (KVS), requested the court to establish guidelines for the use of smartphones in schools.

The court noted that its intent was to establish guiding principles to balance the positive and negative effects of allowing students to use smartphones while attending school. As a policy, students should not be barred from carrying smartphones to school, but the use of smartphones must be regulated and monitored, it said.

Where possible, arrangements should be made for the safekeeping of smartphones. Students should be required to deposit their smartphones when they enwhen returning home, the

Smartphones should not disrupt classroom teaching, discipline, or the overall educational atmosphere. Thus, the use of smartphones in class must be prohibited. Additionally, the use of cameras and recording facilities on smartphones should be barred in common areas of the school as well as in school vehicles.

Schools must educate students on responsible online behaviour, digital manners, and the ethical use of smartphones. Students should be counselled that high levels of screen time and social media engagement can lead to anxiety, diminished attention spans, and cyberbully-

The policy should permit the use of smartphones for connectivity for purposes of safety and co-ordination but disallow the use of smartphones for entertainment/ recreational use.

Finding the situation on the ground level remained largely unchanged, the judge said, "The intent to expedite and streamline the process for termination of a pregnancy conceived as a result of sexual assault has, regrettably, not translated into effective and timesensitive action."

'Unfortunate': HC laments ordeal

of rape survivors seeking abortion

The matter before it surrounded a 15-year-old minor survivor's ordeal of wanting to abort her over 27-week pregnancy--beyond the 24-week permissible timeframe. The issue stemmed from the condition set out by the Delhi government's LNJP Hospital when the parents of the minor survivor went there to get her pregnancy terminated.

They parents were asked to obtain a court order as the gestational age of the foetus had crossed the permissible duration under the Medical Termination of Pregnancy Act. The high court lamented the noncompliance of its directions and said the permanent medical boards constituted in eight government and five private hospitals in the capital were expected to not wait for a court order before examining the survi-

vor and prepare the report. Despite the fact that two years had passed since the directions, the court expressed regret and questioned how a survivor, pregnant owing to the assault, was left for days altogether awaiting a court's order and the same was of no solace to her.

The court, as a result, passed a new set of guidelines to provide prompt and appropriate legal guidance aside from medical support to minor rape survivors seeking the medical termination of pregnancy.

# AAP seeks transparency in audit of Delhi private schools

The Aam Aadmi Party on Friday accused the BJP-led Delhi government of misleading public over the auditing of private school accounts

Alleging that the government's claim of auditing over 650 schools was a "blatant lie", AAP's Delhi unit chief Saurabh Bharadwaj demanded that the audit reports be made public.

"Delhi ministers are constantly misleading," Bharadwaj said at a press conference, "Education Minister Ashish Sood claimed on Thursday that he had got more than 650 schools audited. This is a blatant lie. I say with full confidence that the government has not even



appointed an auditor vet." Challenging the veracity of the government's claims, Bharadwai asked, "If the government has conducted an audit, then it should keep its promise and make the audit report public. The education minister is claiming that he has got 650 schools audited, so at least one school must have been found to be wrong? Has the government taken any action against this

"Children were exploited in many private schools under the protection of the BJP government. Even after the district magistrate's visit, the situation did not change in a private school and children continued to be made to sit in the library," Bharadwaj said, referring to one such case.

"Upset over this, the parents went to Delhi High Court. When the court asked the government, the government informed that a notice has been issued to the school. The court made a strict comment on this reply and asked why did you not take action on time?" Bharadwaj said.

The AAP leader's remarks come a day after Delhi Education Minister Ashish Sood announced that with the help of sub-divisional magistrates, the Rekha Gupta-led administration had audited the accounts of 650 schools.

## Delhi to include 'third gender' option in welfare schemes forms

road during the night. We saw him at 5 am on the same bike which he had snatched. When stopped by the police, he started firing at the police team," Gupta added.

In response, police returned fire, injuring Akshay in the left foot. "He was shot in the left foot during retaliatory fire by the police. He is admitted to the hospital for treatment," Gupta said.

According to police records, the accused has 13 cases registered against him. Meanwhile, according to an official statement, Rohini District Police registered multiple cases and made over 300 arrests from April 1 to April 15, 2025, as part of a 15-day special drive against organised crime and street criminals.

# Froth returns to Yamuna, highlighting persistent pollution issue in the river

A layer of froth was seen covering the Yamuna River surface near Kalindi Kunj on Friday, bringing back the focus on heavy pollution in the river. Experts said that the froth on the river surface was a recurring issue due to the toxic chemicals present in the sewage and industrial wastewater flowing unchecked into it.

The frothing happens due to pollutants in the water getting accumulated with the dissolved organic matter

like water hyacinth, leaves and other such wild grass, a Delhi Jal Board (DJB) official in the quality control wing, informed.

"Currently, we do not have any direction to carry out anti-frothing measures at Kalindi Kunj,'

At many places including Kalindi Kunj and ITO, water hyacinths have appeared in the Yamuna water.

Experts stated that the cause of the white foam over the river stretch is a combination of several factors and more concrete efforts towards stopping waste from entering the river and cleaning it have to be taken. "The frothing problem

in the Yamuna appears to have become a perennial issue, largely due to the deficit monsoon in the river's upper basin last year and the lack of rainfall during the winter and pre-monsoon seasons this year," said an environmental activist Bhim Singh Rawat.

"Untreated effluents continue to enter the Yamuna, not just from drains in Delhi but also from major discharge points in Haryana like the Dhanaura escape



in Karnal, Drain No. 2 in Panipat, and the Najafgarh drain," he said.

Rekha Gupta government in Delhi Thursday sanctioned over Rs 3,000 crore for the laying of sewer lines and construction of 27 decentralised sewage treatment plants (STPs) under the ongoing efforts to rejuvenate the Yamuna.

The problem of froth in the river is more aggravated during the winters when the Delhi Jal Board (DJB) uses defoaming agents to remove it.

"The reason behind foam

formation in the river is surfactants like phosphates in the effluents flowing into the river. When the surfactant-mixed water produces foam, which accumulates and floats on the water surface," said Sanjay Sharma, a member Indian Water Quality Association. Last year to tackle the

problem more efficiently, large nets were tied underneath the Kalindi Kunj bridge to arrest the foam before it reaches further down the river length, where scores of devotees gather to offer prayers.

# **GOVT RULES OUT LEVYING GST ON UPI PAYMENT OF ABOVE RS 2,000**

To support and sustain the growth of UPI, an Incentive Scheme has been operational from 2021-22.

The claims that the government is considering levying Goods and Services Tax (GST) on UPI transactions over Rs 2,000 are completely false, misleading, and without any basis, said the Ministry of Finance in a statement Friday.

Currently, there is no such proposal before the government, the Finance Ministry clarified.

GST is levied on charges, such as the Merchant Discount Rate (MDR), relating to payments made using certain instruments.

Effective January 2020, the Central Board of Direct Taxes (CBDT) removed the Merchant Discount Rate (MDR) on Person-to-Merchant (P2M) UPI transactions through a Gazette Notification dated December 30, 2019.

Since no MDR is currently charged on UPI transactions, there is consequently no GST applicable.

The Zonal Principal Chief Commissioner/Chief Commissioners have been advised to devise a mechanism to closely monitor and issue suitable trade notices, wherever required.

It has also been advised that strict action should be taken against the officers who deviate from these instructions.

This will further facilitate the process of getting GST registration, ease compliance burden, and promote ease of doing business.

# FASTag-based road toll collection system to remain, Govt clarifies

The central government has clarified that the satellitebased tolling system will not be launched from May 1, 2025, in replacement of the existing FASTag-based toll collection system.

The clarification comes after reports emerged stating satellite-based toll systems will replace FASTag toll collection starting in May.

"This is to clarify that no such decision has been taken by the Ministry of Road Transport and Highways or National Highways Authority of India (NHAI) regarding the nationwide implementation of satellite-based tolling from 1st May 2025," said the Ministry of Road Transport and Highways in a statement.

To enable seamless, barrier-free movement of vehicles through toll plazas and reduce travel time, an AN-PR-FASTag-based Barrier-Less Tolling System will be implemented at selected toll plazas, the ministry has supplemented.

The advanced tolling system will combine 'Automatic Number Plate Recognition' (ANPR) technology, which identifies vehicles by reading their number plates, with the existing 'FASTag system' that utilises Radio-Frequency Identification (RFID) for toll deduction. Under this system, vehitravel time, an ANPR-FASTag-based Barrier-Less Tolling System will be implemented at selected toll plazas, the ministry has supplemented.

To enable seamless, barrier-free movement

of vehicles through toll plazas and reduce

on their identification through high-performance ANPR cameras and FASTag Readers, eliminating the need to stop at toll plazas.

In the event of noncompliance, E-Notices will be served to the violators, and non-payment may result in the suspension of FASTag and other VAHAN-related penalties. The ministry stated that NHAI has invited bids for the implementation of the 'ANPR-FASTag-based Barrier-Less Tolling System,' which will be installed at selected toll plazas.

# ARANMULA KANNADI: A REFLECTION OF ANCIENT INDIAN SCIENCE

estled in the tranquil temple town of Aranmula in Kerala, a mysterious mirror has silently reflected the brilliance of Indian metallurgy, spiritual symbolism, and artisanal heritage for over five centuries. Known as the Aranmula Kannadi, or Aranmula Mirror, this rare artefact is no ordinary mirror — it is a masterpiece of ancient science and sacred tradition, and its making remains one of India's bestkept artisanal secrets.

The Aranmula Kannadi is a front-surface reflective mirror, a rarity even by today's industrial standards. While modern mirrors rely on a glass base coated with metallic films, the Aranmula mirror eliminates the glass. It is crafted entirely from a special high-tin bronze alloy, resulting in a unique, distortion-free reflection that doesn't suffer from the secondary images seen in typical back-coated

glass mirrors. Scientific studies have confirmed that this mirror is made of a delta phase bronze — an intermetallic compound of copper and tin (Cu31Sn38) - with atin composition of about 32.6%. This precision alloy, referred to as high-tin 'delta' bronze, is metallurgically complex to reproduce, even with modern technology. What's astounding is that the exact formulation and process remain guarded within a single lineage of artisans in Aranmula, passed down from generation to generation as an oral family

#### **BORN OF LEGEND, ROOTED IN RITUAL**

The origins of the Aranmula Kannadi are woven into the mythos of the Aranmula Parthasarathy Temple, dedicated to Lord Krishna. Legend tells of skilled artisans summoned construction who offered a gleaming crown fitted with a metal mirror to the deity. Impressed, the king asked them to settle in Aranmula, where the mirror-making legacy took root.

Locals believe a woman from one of these families received the secret formula in a divine dream. Since then, the tradition has stayed within the Vishwakarma community — a testament to both spiritual calling and metallurgical

More than a decorative object, the mirror holds ceremonial weight. It is an essential element of the Ashtamangalyam — the eight auspicious items used in Hindu rituals and weddings in Kerala. It symbolises purity, clarity, and good fortune. During Vishu, the Kerala New Year, the mirror takes center stage in the Vishukkani — a visual offering that believers view upon waking to ensure prosperity.

#### **A LABOUR OF LOVE AND PRECISION**

Creating the Aranmula mirror is a labor-intensive process involving two primary stages — alloy casting and extensive polishing. The mirrors come in three basic forms: hand-held (valkannadi), backstand, and fixedstand models. Each begins with a mould, often made from local clay mixed with flax to achieve just the right adhesion and strength. Artisans historically sourced this mud from specific paddy fields near the Pampa River — until the 2018 Kerala floods disrupted availability and forced sourcing from nearby villages like Mannar.

Once the alloy is poured and cooled, the surface is polished for several weeks using a paste made of fine abrasives and oils, until the metal takes on a flawless, glass-like sheen. The polishing alone can take up to two months. The process is



ror can render the mirror unusable.

Each mirror is then framed in ornately handcrafted metal casings — traditionally in brass or bronze — transforming it from a scientific marvel into a symbol of grace and reverence.

#### WHEN FLOODWATERS **ROSE, SO DID THE** MIRROR MAKERS

In August 2018, devastating floods submerged most of Aranmula and brought production of the mirror to a standstill. Fourteen of the 25 known mirror-making units (alas) around the Parthasarathy Temple were underwater for days. Hundreds of moulds were destroyed, copper and tin supplies washed away, and countless finished mirrors scratched beyond

"The industry came to a complete halt for nearly two months," recalled K. P. Ashokan, president of the Vishwabrahmana Aranmula Metal Mirror Nirman Society. The loss was not merely financial — estimated at Rs.10-15 lakh per unit - but spiritual and cultural. The flood had hit just before Onam, the festival season that brings in the largest orders.


Yet, like the metal they mould, the artisans proved resilient. Aid came from across the world, spurred by media coverage. Volunteers helped clean out the mudclogged alas, donations poured in, and the global demand for authentic mirrors surged. Within six months, production resumed — a phoenix-like revival from the mud and waters.

Though the mirror's documented history dates back edge it embodies echoes practices from the Vedic period. The Vedas and ancient texts like Rasa Ratna Samuccaya and Samarangana Sutradhara reveal an intricate understanding of metals, alloys, and casting techniques. The precision required to form a deltaphase alloy — stable only in a narrow range of copper-



authenticity. Prices range from Rs.1,000 for small models to over Rs.1 lakh for large, ornamental pieces.

At home, the mirror is often placed near a puja altar, in the living room, or as part of a ceremonial ashtamangalya set. It should be kept at room temperature, cleaned delicately in one direction, and never stored in kitchens or bathrooms reflecting not just faces but auspicious intent.



# TRAINS, TALES, AND TIME: 172 YEARS OF INDIAN RAILWAYS

ven as we congratulate Indian Railways (IR) on completing 172 years, I reflected on recent news. And although one is aware that IR is increasingly caught in the gravitational pull of grandstanding, the experience bordered on the surreal.

In a brisk 10-minute scan, one came across news gems like the Mumbai-Pune and Delhi-Jaipur Hyperloop projects that would allegedly slash travel time to 25 minutes and better still, a Chennai-Bengaluru corridor was under consideration to bring the cities just 15 minutes apart. Never mind that the all that is on ground is a student level scaled down experimental model at IIT Madras. Another report claimed that a Delhi-Varanasi high-speed rail would complete the journey in 3.5 hours with a 15-km tunnel under construction. Reality check: no such project has even been sanctioned.

Laudatory headlines celebrated record earnings in FY 25 but the annual growth in revenue is a paltry 1.7%, salvaged largely by increased carriage of polluting coal. On the passenger front, IR announced the rollout of 50 Amrit Bharat trains with ergonomic seats and fancy pantry designs but completely silent on the plight of General Class passengers who still travel standing in appalling conditions.

One might argue that these are media exaggerations. Yet, most reports quote official railway no clarifications or retrac-

Take the recent Fevicol advertisement featuring passengers clinging to the door of a Mumbai local. IR took umbrage and had it pulled down. But while the ad may have nudged the boundaries of taste, the image it portrayed is sadly all too familiar.

#### **A LEGACY THAT ECHOES ON THE TRACKS**

But first, a toast to the birthday. At 172, IR remains India's most ambitious social experiment on wheels. It's far more than a transportation network—it's an emotional map, a mobile tapestry of the nation's lives. To call it an organisation is like calling the Himalayas a hill station. It's a parallel universe, connecting dusty hamlets to megacities, carrying not just freight and passengers but livelihood, memories, frustrations, and dreams. The romance of Indian

Railways lies not merely in nostalgia but in its living, breathing poetry. Ask any Indian and they'll have a train story: the thrill of the window seat, the lullaby of wheels on track, the intrigue of foil-packed meals, or the chaos and charm of a packed compartment. For more than a century and a half, IR has been a great leveller. From pilgrims to politicians, schoolchildren to soldiers, everyone has ridden in its belly, sharing benches and stories. There is no parallel to the shared humanity of a train journey-raw, unfiltered India, crawling mostly below 100 kmph, occasionally sprinting at 160.

The imagery is iconic: Gandhi riding lower class to connect with the people for awakening of its people to aspire for freedom; red-shirted porters defying physics with a tower of luggage on their heads; vendors chanting "chai-









gions split by Partition. The launch of the Rajdhani Express in 1969 brought cities closer, in spirit and in time. In 1982, MS Gujral's introduction of unit rake freight transformed freight logistics with increased revenues. The late 1980s saw Madhavrao Scindia usher in Shatabdi Express, catering upgrades, and computerized reservations.

E. Sreedharan's execution of the Konkan Railway remains a gold standard for infrastructure delivery, laying the groundwork for urban metros. As India went digital, serpentine queues gave way to online bookings. Freight reforms under Lalu Prasad Yadav-controversial but effective—boosted revenue significantly. The 2013–18 green shift introduced biotoilets, and 2019 saw the long-overdue removal of unmanned level crossings. Today, the USBRL project connecting Kashmir to the national grid stands as both a civil engineering triumph and a statement of true national integration.

Major changes like complete gauge conversion,

plers, and powerful locomotives, though impactful, unfolded too gradually to mark true tipping points. The Vande Bharat story, however, deserves a separate mention. It sparked rare engineering pride and demonstrated the power of leadership and conviction. But what began as a movement risks devolving into tokenism.

#### **THE HYPE**

Which brings us to the present. There's no doubt IR enjoys massive capital support. Over the past decade, it has received 17 lakh croreseven times the previous decade. This should have translated into a quantum leap in performance. Yet, freight growth this year barely reached 1.9%. The Operating Ratio, stubbornly hovering around 98-99, is propped up more by accounting acrobatics than efficiency. The Dedicated Freight Corridors—once touted as transformativeare physically complete but commercially underwhelming. Freight speeds linger at 25 kmph, undercutting the potential.

Worse is the culture of announcements. No waiting list by 2027—without a roadmap. Kavach safety system coverage remains static despite loud promises. "400 Vande Bharats by 2025"—but we have not seen even 100. Mumbai-Ahmedabad bullet train by 2022? Now drifting to 2030. Hydrogen trains bizarrely proposed on already electrified routes. And the Vande Bharat sleeper version remains a prototype in purgatory.

The PR engine hums smoothly. But is storytelling replacing story-making? Grand declarations far outpace delivery. The IR Amendment Bill of 2024, merging two acts, was hyped as "historic," but does little to address autonomy, innovation, staffing,

saga of the botched Indian Railway Management Service adds to the confusion rather than resolving it.

Even the climate narrative feels hollow. Electrification is cited as a green triumph, but it is mostly powered by coal-based electricity and even, ironically, freight loading is being sustained by transporting more coal. The Fevicol fiasco was perhaps the clearest sign of misplaced priorities-an overreaction that betrayed a fragile ego rather than introspection. Great institutions can laugh at themselves. Mediocre ones censor the mirror.

#### THE RAIL AHEAD

Let this not be mistaken for cvnicism. Indian Railways has achieved tremendous, often thankless feats-rare but some of them worldclass. But we must acknowledge the dissonance: between investment and outcome, promise and performance, volume and value.

IR is the nation's lifeline, ferrying hopes, dreams, and necessities across a billion lives. To thrive, it needs empathy, purpose, innovation, and passion to deliver - virtues that go beyond budgets. Patronage may come from necessity, lack of choice or even novelty politics may fund initiatives. But sustainable progress comes only through meaningful execution, integrity, and accountability.

It is time to move beyond applause-driven hype. Less noise, more nuance. Fewer declarations, more delivery. Let genuine reforms, thoughtful innovations, and a culture of responsibility be the locomotive that pulls Indian Railways into its next century, with soul and substance.

In terms of its legal framework, the MoI demonstrates flexibility in its signing process, allowing for signing in multiple counterparts. The MoI anticipates the signing of a final, more detailed agreement shortly after April 26, 2025, contingent upon ongoing technical negotiations and parliamentary ratification in Ukraine. Beyond the specific provisions, the document carries significant strategic implications, particularly concerning economic and strategic interests. The agreement is widely interpreted as a strategic move by the United States to secure enhanced access to Ukraine's substantial reserves of critical minerals, vital for various industries. Ukraine's mineral wealth positions it as a potentially crucial partner in global supply chains, aligning with the US desire to diversify sources. This access could also have significant implications for the defense industry. The MoI also carries considerable diplomatic weight, emerging after a period of reported strain in bilateral relations, signaling a renewed commitment to a durable partnership.

#### **DOMESTIC CONSIDERATIONS**

Domestically within Ukraine, the MoI has elicited a range of reactions, with ongoing debates regarding specific terms, particularly the valuation of past US military aid. President Zelenskyy has emphasized that previous aid was grants, not loans. Looking ahead, Prime Minister Denys Shmyhal is scheduled to visit Washington to finalize discussions, with the aim of concluding the agreement by April 26. The final agreement will require ratification by Ukraine's parliament to become fully effective. This ratification process will involve parliamentary debate and a vote, reflecting democratic oversight.

#### **SHAPING FUTURE RELATIONSHIP**

In conclusion, the US-Ukraine Memorandum of Intent marks a significant step toward a comprehensive economic partnership focused on mineral development and reconstruction. # Stagflation: Powell's warning and the Fed's dilemma

Federal Reserve Chair Jerome Powell has raised alarm bells, warning that President Trump's tariff policies could trigger stagflation, a dreaded economic condition characterized by rising prices and slowing economic growth. This scenario, reminiscent of the 1970s, poses a significant challenge for central bank-

### **THREAT OF TARIFFS**

Powell's concern stems from the potential for tariffs to simultaneously inflate consumer prices and stifle economic activity. He argued that the "significantly larger than anticipated" tariffs are likely to generate at least a temporary rise in inflation, with the potential for prolonged price pressures as costs pass through to consumers. This directly contradicts Trump's pledge to lower prices for Americans.

#### **CENTRAL BANKER'S NIGHTMARE**

Stagflation presents a unique policy dilemma. Traditionally, the Fed combats inflation by raising interest rates, which can slow economic growth and increase unemployment. Conversely, lowering rates to stimulate

growth can exacerbate inflation. This catch-22 situation puts the Fed's dual mandate-maximizing employment and maintaining price stability—in direct conflict. Powell acknowledged this, stating, "We may find ourselves in the challenging scenario in which our dualmandate goals are in ten-

## **ECHOES OF 1970S**

The 1970s serve as a stark reminder of stagflation's devastating impact. The Arab oil embargo triggered a surge in oil prices, leading to high inflation and stag-

nant growth. The Fed's attempts to navigate this crisis through fluctuating interest rates ultimately resulted in a prolonged and painful recession. This historical context underscores the severity of Powell's warning.

#### **CURRENT VS. PAST CRISIS**

While Powell's warnings are serious, he emphasized that the U.S. is not currently experiencing stagflation. He contrasted today's economic indicators with the 1970s, which saw double-digit unemployment and high single-digit inflation.

However, he cautioned that the current policy path, driven by tariffs, could lead the economy down a dangerous path.

# The core of the issue lies in the Fed's delicate balancing

**FED'S BALANCING ACT** 

act. Traditionally, low unemployment supports moderate inflation as consumers can absorb price increases. However, stagflation disrupts this dynamic. When inflation rises amidst

economic stagnation and job losses, businesses struggle to pass on costs, suppressing profits and deepening the economic malaise.

Powell fears that the current tariff-driven policy could create this unfavorable environment, forcing the Fed to make difficult choices between combating inflation and supporting growth.

**FORMULA** Morena's triumph, initially seen with Andrés Manuel López Obrador's historic 2018 victory and reinforced by Claudia Sheinbaum's recent win, hinges on a powerful populist narrative. López Obrador effectively framed the nation's problems as a consequence of corrupt elites, encompassing traditional political parties and their business allies. This message resonated deeply in a country where income inequality is stark, with a significant portion of wealth concentrated at the very top. López Obrador's charisma and long political career lent credibility to his promises of change. His extensive outreach through national tours and daily press conferences ("mañaneras") allowed him to directly communicate his government's achievements and critique his opponents, shaping the media landscape. This message was

further amplified through state and social media, fostering a strong personal following.

Crucially, Morena delivered on some key promises. The minimum wage was doubled in real terms, social programs and cash transfers were expanded, and measures were taken to regulate worker outsourcing and democratize union contracts. Infrastructure projects were also prioritized in historically marginalized southern regions. These policies contributed to a notable decrease in the poverty rate between 2018 and 2022.

## **FAR-RIGHT'S FAILURE**

**TO LAUNCH** In stark contrast to Morena's success, the far right in Mexico failed to gain any significant traction. Eduardo Verástegui, a figure attempting to import a Trumpian brand of politics centered on religious conservatism, gun rights, and individualism, couldn't even gather the necessary signatures to appear on the ballot. This suggests that a direct transplantation of American far-right ideology did not resonate within the Mexican context.

#### **CAVEATS FOR GLOBAL** LEFT

While Morena's focus on socioeconomic justice offers valuable lessons, progressives elsewhere should approach replicating their model with caution. López Obrador's government, while achieving some progressive goals, also made pragmatic shifts to the right. These included making deals with big business, sidestepping significant tax reform, maintaining fiscal austerity, and adopting a tough stance on USbound migrants for political leverage. The party also avoided taking clear stances on issues like gay marriage and abortion, seemingly to maintain broader appeal. Furthermore, López Obrador embraced the military, a popular but controversial institution, to implement his agenda, overlooking its history of human rights abuses.

This pragmatism, while contributing to electoral success, has alienated some on the Mexican left, including feminists,

environmentalists, and victims of violence. The influx of politicians with questionable backgrounds into Morena, driven by electoral expediency, has also created internal tensions.

## **MEXICO'S UNIQUE**

LANDSCAPE Ultimately, the extent to which the global left can learn from Mexico is limited by the country's unique historical and social context. Mexico's colonial past, prolonged one-party rule, the significant influence of organized crime, and its deep economic dependence on the United States have shaped a distinct political landscape. The strong sense of injustice stemming from this history serves as a powerful mobilizing force.

## **A COMPLEX PICTURE**

Mexico's political trajectory under Morena is not a simple story of the left triumphing over the right. It is a more nuanced narrative of a left-leaning party achieving significant electoral success by prioritizing socioeconomic justice and effectively mobilizing a populist base. However, this success has been intertwined with pragmatic, and at times right-leaning, compromises. Progressives outside Mexico must carefully consider which aspects of Morena's approach align with their values and contexts, recognizing that electoral victories can sometimes come at the cost of ideological purity.

irstrikes conducted by the United States military on Yemen's Ras Isa fuel port have resulted in a devastating toll, with at least 74 people, including civilians and rescue workers, reportedly killed. According to the Houthi-run health ministry, an additional 171 individuals sustained injuries in what is being described as the deadliest attack since Washington initiated its campaign against the Iran-backed militants.

Anees al-Asbahi, the health ministry spokesperson, conveyed the grim figures, emphasizing that the count of "martyrs" and wounded individuals was not yet final as search efforts continued at the site.

Some analysts interpret the scale of the US operation and the choice of target - a significant economic hub in Yemen - as a deliberate message directed towards Tehran. This action comes amidst escalating pressure from the Trump administration on Iran concerning its nuclear program.

Despite President Trump's previous threats to "annihilate" Yemen's Houthi rebels, the group has demonstrated resilience, remaining intact despite the ongoing US air

present at the site. Video footage purportedly from the port, disseminated by the Houthiaffiliated al-Masirah TV via social media in the early hours of Friday, depicted massive explosions and numerous bodies scattered across the area.

The TV station later broadcast interviews with survivors receiving treatment, including a man with severe burns. One individual who identified himself as a port worker recounted, "We ran away. The strikes came one after the other, then everything was on fire."

The Ras Isa terminal, with a storage capacity of 3 million barrels, holds historical significance as the first port constructed for oil exports from Yemen approximately four decades ago.

Satellite data from a NASA fire monitoring system detected an intense blaze at the port location, situated just off Kamaran Island, early on Friday morning.

In a statement released on social media, US Central Command justified the strikes by stating that "US forces took action to eliminate this source of fuel for the Iran-backed Houthi terrorists and deprive them of illegal revenue that has funded Houthi efforts to terrorise the entire region for over 10 years."

The statement further asserted, "This strike was not intended to harm the people of Yemen, who rightly want to throw off the yoke of Houthi subjugation and live peacefully."

The US has declared its intention to continue its attacks on Yemen's Houthis - its most substantial military operation in the Middle East since Trump assumed office in January – unless the group ceases its attacks on Red Sea shipping.

When questioned about the Houthi casualty figures and its own assessment, US Central Command indicated that it had no additional information beyond the initial announcement of the strikes.

# 'US could withdraw Ukraine peace efforts within days'

US Secretary of State Marco Rubio on Friday warned that America may abandon its peace efforts in Ukraine within "days" if it is not possible to end the war between Russia and Ukraine, CNN reported.

Speaking in Paris after high-level talks with European, Ukrainian, and Russian officials, Rubio emphasised the urgency of determining whether the war can be ended or not.

"We need to determine very quickly now, and I'm talking about a matter of days, whether or not this is doable," he told reporters before departing Paris.

The comments came a day after he and special envoy Steve Witkoff met with the European and Ukrainian allies as US President Donald Trump's administration pushes for an end to Russia's war in Ukraine, CNN reported.

"If it's not possible, if we're so far apart that this is not going to happen, then I think the president is probably at a point where he's going to say we're done. It's not our war. We didn't start it. The United States has been helping Ukraine for the past three years and we want it to end, but it's not our war. President Trump has spent 87 days at the highest level of this government, repeatedly making efforts to bring this war to an end. We are now reaching a point where we need to decide and determine whether this is even possible or not. Which is why

we're engaging both sides,' Rubio told reporters.

Marco Rubio met with Russian Foreign Minister Sergey Lavrov on Friday, where he outlined a proposed peace framework, which received an "encouraging" response in Paris. The US Department of

State in a readout said. "Secretary of State Marco Rubio spoke today with Russian Foreign Minister Sergev Lavrov. The Secretary conveyed to his Russian counterpart the same message the US team communicated to the Ukrainian delegation and our European allies in Paris: President Trump and the United States want this war to end, and have now presented to all parties the outlines of a durable and lasting peace. The encouraging reception in Paris to the US framework shows that peace is possible if all parties commit to reaching an agreement."

Earlier, Rubio had said that President Trump has been clear about ending the war between Russia and Ukraine "now."

The political ties between the United States and Ukraine have evolved

significantly, particularly since Ukraine gained independence from the Soviet Union in 1991. Over the years, the relationship has been characterized by mutual support, particularly in the face of Russian aggression. The U.S. has been a staunch ally, providing military, economic, and diplomatic support to Ukraine, especially after the 2014 annexation of Crimea by Russia and the subsequent conflict in Eastern Ukraine.

In recent years, particularly after the Russian invasion of Ukraine in 2022, the U.S. has ramped up its involvement, supplying Ukraine with advanced weapons, training, and financial assistance to bolster its defense against Russian forces. U.S. sanctions on Russia have been a significant component of this support, aimed at isolating Moscow internationally.

Ukraine, on the other hand, has sought closer ties with the West, including its aspiration to join NATO and the European Union. The U.S. has supported these ambitions, though the path to membership in these organizations remains uncertain. The bilateral relationship has also seen political complexities, particularly surrounding issues of military aid, corruption, and democratic reforms in Ukraine. However, the overall partnership remains strong, with both countries committed to Ukraine's sovereignty and security in the face of Russian aggression.

# Pakistan bans accommodation for 'illegal' Afghan immigrants

Pakistan has banned offering accommodation, jobs, business property on rent, or hotel stays to Afghan nationals living in the country without proper documents, according to a report by ARY News.

Minister of State for Interior Talal Chaudhry announced the decision at a press briefing in Islamabad. He warned that strict action would be taken against anyone found helping undocumented Afghan migrants.

"There will be no extension of stay for Afghan immigrants without a valid passport and visa. There is now zero tolerance for undocumented Afghan nationals," Chaudhry said.

He shared data showing that since April 1, 2025, a total of 84,869 Afghan nation-

## China opposes US shipping fees, claims move will harm US consumers

In response to the United States' recent announceing in US ports, China expressed strong opposition and said that such measures would not only harm the US economy but also have consequences for global shipping, disrupt supply chains and increase inflationary pressures.

The nation further stated that the move will also hurt the interests of American consumers and businesses. During a regular press conference on Friday, Chinese spokesperson Lin Jian said, "We've stated our position on relevant questions. Let me reiterate that measures such as imposing port fees and levying tariffs



on cargo handling facilities harm the US itself as well as others. The move not only hikes global maritime shipping costs and disrupts the stability of global industrial and supply chains, but also increases inflationary pressures in the US and hurts the interests of American consumers and businesses."

He added, "The practice will ultimately fail to revitalise the US shipbuilding industry. We urge the US to respect facts and multilateral rules, and immediately stop its wrongdoings. China will take necessary measures to defend its lawful rights and interests."

According to a report by CNN, a Federal Register notice posted by the US Trade Representative (USTR) on Thursday stated that the US government will charge fees on all Chinese-built and -owned ships docking in US ports, based on net tonnage or goods carried on each voyage.

# Intensified US-China trade war leaves the world in shock

This week, the Trump administration has announced that China will face a staggering 245 percent tariff on all imports from the US. It is announced as a response to Beijing's countermeasures in the ongoing trade dispute that has adversely affected global markets and shaken investor confidence. This decision, confirmed in a fact sheet released by the White House this week, marks a significant escalation in the already heightened tensions between the two countries. The official statement revealed that on Liberation Day, President Trump implemented a 10 percent tariff on all nations that impose high tariffs on American products. However, these tariffs were later put on hold as over 75 countries entered negotiations with the US to establish new

trade agreements. The tariffs imposed on China

and other countries on Liberation Day are seen as a continuation of Donald Trump's unwavering 'America First' trade policy. This action has elicited a strong backlash from China, which is resolute in its intention to retaliate against the US. In light of the recent introduction of a 245 percent tariff by the US, Lin Jian, a representative of China's Foreign Ministry, reaffirmed the government's steadfast position on tariffs, claiming that the trade dispute was initiated by the US. This underscores China's perspective on the trade conflict and highlights the ongoing tensions between the two nations regarding trade practices and tariffs.

The US previously imposed a 145 percent tariff on Chinese **WORLD RECAP ANSHU JOSHI** 

imports, prompting China to respond with a 125 percent tariff on American goods. This exchange escalated tensions between the two countries and contributed to instability in global stock markets. Additionally, Beijing took further action by prohibiting the export of specific products utilized by aerospace manufacturers and military contractors further es-

In addition to exploring various aspects of the strategic partnership between India and the US, Vance's official meetings are anticipated to cover topics such as the new tariffs implemented during the Trump administration and ongoing negotiations regarding a bilateral trade agreement between the two nations.

Though US National Security Advisor Mike Waltz was also anticipated to visit India during the final week of April; however, his trip has been cancelled amid some controversy. He was slated to engage in the India-US Forum, a private discussion supported by the external affairs ministry, and to co-chair the inaugural meeting of TRUST (Transforming the Relationship Utilizing Strategic Technology) alongside his Indian counterpart. This initiative was introduced during a meeting between President Donald Trump and Prime Minister Modi in Washington in February and represents a rebranded effort of the Initiative on Critical and Emerging Technologies (iCET).

The cancellation of Waltz's visit marks a significant shift in the planned diplomatic engagements between the two nations. The TRUST initiative aims to enhance collaboration in strategic technology, reflecting the evolving nature of US-India relations. The forum was expected to serve as a platform for discussing critical issues and fostering deeper ties, but the recent developments have cast uncertainty on these diplomatic

Amid all these developments, keeping a focus on the bilateral trade agreement, Indian officials express hope for a favourable outcome, emphasizing the ongoing trade negotiations between India and the US. The Indian delegation is preparing to discuss trade matters, following the joint statement made during the meeting between President Trump and Prime Minister Modi on February 13. Additional talks are anticipated to tackle significant trade issues and promote a more equitable economic partnership between the two nations. It is crucial for Trump to

acknowledge that his actions should not jeopardize the stability of other nations or the global economy. It is hoped that he will embrace and work towards the Indian principle of 'Sarve Bhavantu Sukhinah', which advocates for the well-being of all.

'Urvashi'," she said.




# **DROP**

Meghann Fahy starrer, DROP is a cellphone thriller explained in two words but keeps you fully hooked through one hour and forty minutes of runtime. The dark side of technology, cloning of the phone, and dangers of dating all lead to making the life miserable of a single mother one fine evening, who had come out

of an abusive relationship and trying to find love and life. It happened to a single mother who unknowingly and unwillingly became a target for committing a murderous crime with all evidence going against her.

Violet (Meghann Fahy), a psychological counsellor by profession is on a date night with the photographer Henry (Brandon Sklenar). The date is set up by her sister Jen (Violett Beane) who drops



in at home to look after her son Toby (Jacob Robinson), while she is on the night out. Henry is running late, and Violet decides to hang in at the Bar before joining him at the table with a great night view of tall buildings, with their heights and depths speaking for themselves.

She encounters a few characters here, including Cara (Gabrielle Ryan), Phil (Ed Weeks), Richard (Reed Diamond), and Matt (Jeffery Self), who add their bit of funny things, drama and intrigue beautifully to the story as it unfolds. Almost the whole film is completed with two settings: the restaurant and Violet's home. Henry arrives and as

they start a conversation,

Violet's phone comes into action with notifications and alerts of airdropped messages by someone unknown to her. Initially, she shows it to Henry, and they pass it off as some prank, but things turn out murky for Violet who is now fully cyber-hijacked. She starts receiving instructions via airdrops like a handler instructing the team members to criminals for executing a

To her utter disgust, Violet discovers that she is under full watch, not only in the restaurant where her every move is tracked but also be-

cause her son and sister are held hostage at her home. Her efforts to seek help from 911, fellow guests, the front office desk, the bartender, the piano player, and the server all hit a roadblock, and she's confronted with tough threats by the handler. She is being used for destroying the criminal evidence available in the SD card of Henry's camera and then murdering him by poisoning his drink.

Violet survives an abusive relationship, has a great presence of mind and a never-say-die attitude while pretending to fall into the trap of the handler, and is always looking for an opportunity to fight back and destroy the malicious mission of the handler.

Meghann Fahy as Violet exhibits her terrific acting skills, she pretends to be normal and shows extreme stress at the same time while striking a great balance of frequently changing and visible moods, emotions, and facial expressions. Eventually, she discovers and confronts the handler sitting among the guests while mistaking a few others to be the culprits earlier.

The suspense, the thrill,

the intrigue, the anxiety, the tension, and the excitement are well-woven throughout the story unfolding at the perfect timing, and you don't feel for a moment any kind of stagnancy or slowdown in the flow of storytelling.

Directed by Christopher Landon and written by Jillian Jacobs and Chris Roach, DROP is a fantastic crimesuspense-thriller to watch, and you're bound to be glued throughout.

Being honest and truthful brings several psychological benefits that influence our personal growth and shape our character in meaningful ways. 

# Arsenal's Kai Havertz Could Return For Champions League Final

Arsenal boss Mikel Arteta said he would bet on Kai Havertz returning before the end of the season as his recovery from a hamstring injury is ahead of schedule. Arsenal's European run has softened the blow of seeing their Premier League title challenge peter out.

The Gunners are on course

to finish second for a third consecutive season.

But they trail Liverpool by 13 points with just six games remaining.

The title could be sealed as early as Sunday should Liverpool beat Leicester and Arsenal lose at struggling Ipswich.

Arteta is keen to avoid that scenario and warned against easing up in the league with Champions League qualification for next season not yet confirmed.

"We'll make sure that we win the game and that doesn't happen," added the Spaniard on the possibility of Liverpool winning the league on Sunday.
