FLASH FLOODS, LANDSLIDES LEAVE 3 PEOPLE DEAD IN J&K

More than 100 people rescued, many houses and roads damaged


eavy rainfall due to cloudbursts triggered flash floods and landslides in several areas of Jammu and Kashmir's Ramban district early Sunday, leaving three people dead and damaging scores of houses and roads, while more than 100 people were rescued.

Traffic on the strategic Jammu-Srinagar National Highway was suspended as the road was blocked at nearly a dozen places between Nashri and Banihal due to landslides and mudslides, officials said.

Hundreds of commuters were left stranded on the 250-kilometre highway, the only all-weather road linking Kashmir with the rest of the country.

A cloudburst struck the Seri Bagna village, resulting in the deaths of three persons, including brothers Aqib Ahmad and Mohd Saqib. The rescue operation in the village was continuing when the last reports were received, officials said.

With the latest fatalities, five people have lost their lives in rain-related inci-

dents in the Jammu region in two days. Two people, including a woman, were killed and another woman was injured when they were struck by lightning in the Arnas area of Reasi district late

The officials said about 40 residential houses were damaged after a flash flood hit Dharam Kund village.

We are in touch with the local administration to ensure immediate rescue efforts....For now, the focus remains on managing the situation on the ground. Citizens are advised to follow travel advisories and avoid non-essential movement in vulnerable areas.

Farmers left in lurch as standing wheat crop in acres gutted

High-speed and short circuits in electric lines spark a series of fires

A series of devastating fire incidents have gutted thousands of acres of standing wheat crop across Punjab and Haryana over the past week, leaving hundreds of farmers in distress. The initial reports suggest that most of the fires were triggered by high-velocity winds and short circuits in electric lines destroying months of hard labour just days before harvest.

Exact figures are not available for the gutted fields but the reports suggest that thousands of acres of standing wheat crop and crop residue were reduced to ashes in

the past one week in both the leading agrarian sates. In Punjab, the worst-hit districts include Bathinda, Mansa, Sangrur, Barnala, Muktsar and Fazilka. Unconfirmed reports said in Bathinda and Mansa alone over 1.00 acres have been destroyed in a span of three days, while Sangrur and Barnala districts each reported damage to around 500 acres.

Punjab unveils Rs 500-cr plan to banish stubble-burning

Aiming to bring the stubbleburning cases to zero in the state, the Punjab Government has formulated an action plan worth Rs 500 crore. The scheme aims to provide farmers with latest CRM machinery on subsidy and implement other strategies to manage the paddy straw efficiently.

Disclosing this here today, Punjab Agriculture and Farmers Welfare Minister Gurmeet Singh Khudian said that the Agriculture and Farmers Welfare Department has invited online applications from the farmers to avail subsidies on the procurement of crop residue management (CRM) machines. The applications can be submitted through online portal agrimachinerypb.com from April 22 to May 12, 2025.



Encouraging the farmers to take advantage of the scheme, Gurmeet Singh Khudian said that Punjab Government has been offering a 50% subsidy to individual farmers and an 80% subsidy to farmer groups, cooperative societies and gram panchavats for the purchase of CRM machines. This initiative aims to make CRM machinery more accessible to farmers, promoting its adoption and ultimately contributing to a cleaner environment, he added.

The minister said that the subsidy would be available on CRM machinery include

Super SMS, Happy Seeder, Super Seeder, Surface Seeder, Smart Seeder, Zero Till Drill, Baler, Rake, Shrub Master/ Rotary Slasher, Paddy straw chopper/Shreder/Mulcher, Crop Reaper, Hydraulic Reversible Mould Board Plough.

Dr. Basant Garg, administrative secretary in the Agriculture department, said Punjab witnessed significant progress in crop residue management. The state government distributed 17,600 subsidised CRM machines to individual farmers, cooperative societies, and panchayats during previous season. Additionally, 1,331 Custom Hiring Centres (CHCs) were also established to facilitate CRM practices. These efforts resulted in a 70% decrease in fire incidents during the previous season compared to 2023, with only 10,909 incidents recorded compared

CONG SLAMS BJP AFTER IT DISTANCES ITSELF FROM MPs' CRITICISM OF SC

Questions why no action has been taken by BJP against their two MPs

The Congress on Sunday described the BJP disassociating itself from the criticism of the Supreme Court by its MPs Nishikant Dubey and Dinesh Sharma as "damage control" and asserted that the minimum action against them should be their expulsion from the party. The opposition party also asked why no action had been taken against the two MPs and why no showcause notices were issued to them. Congress general secretary in-charge communications Jairam Ramesh said the distancing of the "outgoing BJP president" from the "atrocious remarks" made by two MPs on the chief justice of India (CJI) carried little

Congress general secretary Mukul Wasnik tagged Ramesh's remarks on X and said the minimum action called for against the BJP MPs who made the "most atrocious comments" against the CJI and the Supreme Court was expelling them from the party. "But will the BJP's outgoing president go beyond merely warning the MPs? We know that no action will be taken," Wasnik said.

Congress deputy leader in the Lok Sabha Gaurav Gogoi said on X, "I have my doubt regarding the statement of BJP President Shri J P Nadda ji. The BJP ecosystem especially those who are close to Prime Minister Modi and Home Minister Amit Shah are hell bent on tarnishing the position of Chief Justice of the Supreme Court of India." They are unhappy with the direction of the Court in recent decisions related to Tamil Nadu and Waqf Amendment Act, he claimed. "The RSS-BJP want to turn India into North Korea-Iraq," Gogoi alleged. Congress' media and publicity department head Pawan Khera also slammed the BJP over the remarks of its two MPs. "Nothing will happen by just distancing from the statement. What Nishikant Dubey said, is a direct attack on the Constitution.

Cong Sirsa MLA Setia opens fire at party, hails BJP again

In a fresh blow to the Congress party in Haryana, its MLA from Sirsa, Gokul Setia, has launched a scathing attack on his own party's high command while showering praise on BJP yet

Setia, who had joined Congress just before the 2024 Assembly elections and won from Sirsa defeating Gopal Kanda in a direct contest, posted a strongly worded note on Facebook expressing deep disappointment with the party leadership. He alleged that Congress is ignoring elected MLAs like him and favouring only leaders with "old and big names.'

"Even after winning the election against all odds, I was never invited to any major party meeting. In Gujarat's convention too, there was no invite. Why are grassroots leaders ignored?" Setia questioned, demanding recognition and respect for first-time MLAs.

Setia didn't stop there. He called out senior Congress leaders in Haryana, alleging that many of them worked against official party candidates during the elections. "Some Congressmen in words of warmth coming

Sirsa openly opposed me, but today they roam around with top leaders. This weakens the party from within," he said.

His most striking comments, however, were aimed at drawing comparisons between BJP and Congress. "When BJP mayors win, they are taken to meet the Prime Minister. But in Congress, even winning MLAs don't get to meet the high command," he said. "This crushes morale and discourages leaders who work hard on the ground."

With the Congress party in Haryana reeling under the internal differences. Setia's remarks further reflect deeper discontent within the party's state unit, throwing a new challenge for the party's central leadership forcing it to confront the growing divide between Delhi-based decision makers and grassroots workers.

J&K CM fumes at Delhi airport as his Delhi flight diverted to Jaipur

A Delhi-bound IndiGo flight carrying Jammu and Kashmir (J-K) Chief Minister Omar Abdullah was reportedly diverted to Jaipur on Saturday night, prompting sharp criticism from the CM over what he described as 'operational chaos' at Delhi airport.

In a late-night post on X, Abdullah expressed frustration over the ordeal. "Delhi airport is a bloody shit show (excuse my French but I'm in no mood to be polite). 3 hours in the air after we left Jammu we get diverted to Jaipur & so here I am at 1 in the morning on the steps of the plane getting some fresh air. I've no idea what time we will leave from here," he wrote.

Abdullah also shared a selfie standing on the aircraft's steps after deplaning briefly for fresh air. Passengers on the flight, including Abdullah, were left stranded aboard the aircraft at Jaipur past midnight. IndiGo had not issued an official statement till the time of filing

this report. Earlier in the day, Jammu airport also witnessed chaotic scenes, with hundreds of passengers complaining of inconvenience due to flight delays and cancellations. Bad weather conditions in Srinagar disrupted flight



operations, affecting several connecting flights. In a post on X on Friday

"It is being heard that during the Maha Kumbh, it was their plan to announce his (CM Yogi Adityanath) name as the Prime Minister's face," he further said.

The Mahakumbh 2025 concluded on Maha Shivratri, February 26, with over 66 crore 21 lakh devotees taking a holy dip in the Triveni Sangam. Earlier in the day, Yadav also launched a sharp



attack on the Bharatiya Janata Party (BJP), accusing it of ignoring real issues faced by the public.

"This government has two achievements, pakora and bhagoda (fugitive). Anyone who wants employment, they ask them to make pakora, and you know about the fugitive who ran away with the country's money," Yadav said. He also criticised the recently passed Waqf Act, questioning its relevance to the problems faced by farmers. "Will the income of farmers be doubled after the Waqf Bill is passed? These people want to create trouble. If you see a riot anywhere, the Bharatiya Janata Party is behind it...This army is Yogi Army, Yogi Ji is hell-bent on destroying Uttar Pradesh,' he added. The SP leader also said that

the opposition INDIA coali-

tion will continue in the 2027 Uttar Pradesh Assembly elections. He attacked the Bharatiya Janata Party (BJP), alleging it was trying to grab land like the mafia through the Waqf (Amendment) Bill. 



Fatehabad, and Jind districts have damaged close to 2,000 acres of ripe wheat crop and crop resi-

The fires are believed to have started from short circuits in overloaded or loose electric wires, which, under strong winds, ignited dry crop residues and quickly spread through fields. Farmers say the blaze travels at lightning speed during high wind, giving them no time to control it.

"This is our only livelihood. The fire has snatched away everything," said Hakam Singh, a farmer from Mansa, whose seven-acre wheat field was reduced to ash. "There is no compensation policy for fire-affected crops unless it happens due to natural calamities. We are helpless," he add-

In lack of proper compensation policy for burnt crop the aggrieved farmers were left without compensation as the PM Kisan Fasal Bima Yojana does not cover fire incidents.

Despite repeated appeals by farmer unions and local representatives,

neither the Punjab nor Haryana government has a specific policy to compensate farmers whose crops are damaged in fires caused by electrical faults. Under the current norms, only disasters notified under the State Disaster to detect stubble burning Relief Fund (SDRF) are eligible for compensation.

The absence of a support mechanism has further angered farmer organisations, with BKU (Ugrahan) and BKU (Ekta Sidhupur) staging protests demanding immediate compensation and insurance coverage for fire-related damages.

"The governments must wake up. Farmers are losing their entire harvest, yet there is no accountability from power departments or relief for affected families," said Joginder Singh Ugrahan, president of BKU (Ugrahan). All India Kisan Khet

Mazdoor Sangathan's state secretary Jaikaran Mandouthi and president Anoop Singh Matanhail stated that due to a powerful storm that struck on Friday evening, standing wheat crops spread across nearly 900 acres in 25 villages across five districts of the state were reduced

Vance's first visit comes weeks after US President Donald Trump imposed and then paused a sweeping tariff regime against about 60 countries, including India.

New Delhi and Washington are now holding negotiations to seal a bilateral trade agreement that is expected to address a variety of issues, including tariff and market access.

The Vances will be welcomed on their arrival at the Palam airbase by a senior Union Cabinet minister.

Besides Delhi, Vance and his family will travel to Jaipur and Agra.

Nine, including women, minors held in Seelampur murder case

Nine people, including women and minors, have been held by the Delhi Police in connection with the murder of a 17-year-old boy in the Seelampur area.

According to Delhi Police, the main accused, 'Lady Don' Zikra, along with Sahil (18), Zahida (42), Nafish (32), Sohaib (35), Aneesh (19), Vikas (29) and two minors aged about 17 and 15 years, have been taken into custody.

Police teams from the North-East District carried out raids across Delhi-NCR, including Ghaziabad, Meerut, Moradabad, and Amroha in Uttar Pradesh. Based on technical surveillance, clues, and local inputs, the suspects were arrested on April 20.

During the investigation, evidence was collected against Zikra, Sahil, and two minors referred to as "Children in Conflict with Law" (CCLs). Police allege that

these individuals planned the attack on the victim, Kunal.

The police said, "Relevant evidence was collected, which confirmed the involvement of the accused in this heinous crime during the probe."

It was revealed that Sahil had an old rivalry with Kunal. On April 17, the group allegedly caught Kunal and stabbed him multiple times. Giving more details, police said, "On April 17, at about

7:38 PM, information regarding the stabbing of a person in J-Block, Jhuggi Seelampur, was received at the Seelampur Police Station." When the police team reached the location, they found the victim had already been taken to JPC Hospital by his family, where doctors declared him dead.

The victim was identified as Kunal, a 17-year-old boy from the New Seelampur area in Delhi.

Delhi sees 2-fold rise in drug related cases

Delhi witnessed a two-fold increase in drug-related offences in the first three months of 2025 as compared to 2024, while offences under the Excise Act saw a jump of more than 80 per cent, as per the data shared by the police on

According to the data, between January 1 and March 31, 2025, Delhi registered a total of 2,496 cases under the Excise Act while a total of 1,382 cases were registered in 2024 during the same period.

Similarly, Narcotics Drugs & Psychotropic Substances Act violations climbed from 257 to 544 cases, averaging around six drug-related cases every day, the data read.

Cases under the Arms Act also increased, from 957 last year to 1,049 this year, while those under the Gambling



Act rose to 1,018 from 677 in 2024.

The spike is attributed to increased enforcement and crackdown operations across Delhi, a senior police officer said. Crimes registered under different acts, including the Arms Act and Gambling, also shot up significantly with 6,836 cases registered in the first three months of 2025 - a steep rise from 4,143 cases in 2024 and 4,080 in 2023 for the same period.

"The rise in Excise and NDPS cases reflected proactive policing efforts and targeted operations against bootlegging and drug peddling networks. Police are also using surveillance tools and informant networks to track syndicates across the city," the officer said.

In contrast, overall cases under the Indian Penal Code and Bharatiya Nyaya Sanhita crimes saw a slight decline. Delhi recorded 63,898 such cases in the first quarter of 2025. about 710 cases a day, as compared to 64,256 last year and 82,534 in 2023.

Burglaries also dropped to 1,725 from 2,017, house thefts dropped to 3,578 from 3,644. Motor vehicle thefts remained largely unchanged, with 9,070 cases in 2025 compared to 9,080 in 2024, the data revealed.

However, "other theft" cases saw an uptick, rising to 27,066 in 2025 from 24,226 last year, nearly 300 cases per day.

These speeches cover a wide range of cultural contexts -- from sacred shrines like Kedarnath, Ram Janmabhoomi, Kashi Vishwanath Dham and Omkareshwar to occasions such as the launch of various editions of the 'Bhagavad Gita', Guru Nanak Jayanti, the Global Buddhist Conference, the birth anniversary of Acharya Vijay Vallabh Surishwar Maharaj and the World Sufi Conference, the IGNCA said.

The IGNCA is an autonomous institution under the Ministry of Culture.

"These speeches reflect a quest to identify the Indianness in various religious traditions. The appendix contains reflections by Acharya Shri Pragya Sagar Ji Maharaj and Shankaracharya Shri Shankar Vijayendra Saraswati Swami Ji of Kanchi Kamakoti. Both appear to affirm the cultural vision espoused by the prime minister," it said in a statement.

Vehicles not displaying colour-coded stickers to be penalised, city govt

The Delhi transport department is set to crack down on vehicles that do not display colour-coded stickers indicating their fuel type, officials said on Sunday. According to a public notice, non-compliance will attract penalties under the Motor Vehicle Act. The stickers are part of the High Security Registration Plates (HSRP) mandate, introduced in 2012-13 and made compulsory for all vehicles by 2019.

"The Motor Vehicles (High Security Registration Plates) order, 2018 for displaying colour-coded stickers/third registration mark on the windshield of the vehicle. Non-compliance with the above order will also attract the provisions of Section 192(1) of the Motor Vehicle Act 1988," said the public notice issued by the department on Sunday.

Section 192(1) of the Motor Vehicles Act states the pun-



ishment for those who drive or cause or allow a motor vehicle to be driven in contravention of Section 39 (which relates to registration).

"The vehicle owners are advised to ensure strict compliance with the aforesaid order," the notice said further. In 2020, the transport department decided to launch a special drive against violations of the High-Security Number Plates (HSRP), under which there was a provision of a fine of Rs 5000 on any vehicle found plying without HSRP and stickers pasted

on number plates. According to officials, the HSRP number plate was introduced in the year 2012-13 and was made mandatory for all new vehicles in April 2019. The government made it compulsory for all old vehicles in Delhi to get the HSRP affixed. According to rules, colour-coded stickers for diesel vehicles are orange, for petrol and CNG vehicles it is light blue and

grey for all other vehicles. Vehicle owners who do not comply with the order will not get Pollution Under Control (PUC) Certificates.

The two cheetahs will be shifted to the Gandhi Sagar Sanctuary, located more than 250 km from Kuno where the ambitious intercontinental translocation of the big cats was launched nearly three vears ago. Additional Principal Chief Conservator of Forests Uttam Kumar Sharma on Saturday said preparations were completed for shifting of the two male cheetahs.

Prabhash and Pavak would be taken by road to the Gandhi Sagar Sanctuary, which straddles Mandsaur and Neemuch districts, where Chief Minister Mohan Yadav will release them in the evening, he said.

Harassment in insurance claims no ground for criminal offence: HC

Harassment faced by a client during the approval of insurance claims in a hospital can be a ground for seeking compensation but does not amount to a criminal offence, the Delhi High Court has said.

The court, at the same time, said patients frequently suffered harassment in the set-

tlement of final bills and the issue of smoothening settlement of bills and discharge of patients should be taken up by authorities.

Justice Neena Bansal Krishna made the observations while dealing with a lawyer's plea against a sessions court order refusing to uphold the summons issued to a private hospital here by a magisterial court on his complaint.

The lawyer, who had undergone surgery at the private hospital in 2013, accused it of cheating, misappropriation of funds and wrongful restraint.

He alleged that despite having the authorisation under the cashless insurance scheme offered by a private insurance company, he was made to deposit the entire estimated amount before surgery, and he was



subsequently not discharged until the entire payment was cleared under the policy.

The court, in the judgement passed on April 17, said although there was procedural delay, no offence, as alleged by the petitioner, was made out and refused to interfere with the sessions court's decision.

The hospital submitted that it committed no offence as the initial authorisation was only for a limited amount and for a lower category room, and according to the norms of

the Insurance Regulatory and Development Authority (IRDA), the difference in price approved and the actual charges were required to be taken from the patient before his discharge.

The court said the condition to pre-deposit the balance amount might seem onerous, but could neither be said to be extraction of money nor could any dishonesty or fraudulent intention be attached to the hospital, in this regard.

In the order, the court nonetheless acknowledged the harassment and trauma experienced by patients in setting their bills with the insurance companies, saying that is "riddled with delays".

"Much angst has been expressed on this system of getting the approvals from the insurance company at many forums and by the courts, but such situation may be a ground for seeking compensation for mental harassment but does not tantamount to any criminal offence," the court said. "Though many a times courts have recommended that there may be some regulatory policy and even a Charter of Patients' Rights has been proposed by NHRC, but unfortunately no final redressal to this aspect has been worked out till date.

"Central banks, especially in emerging markets like China, have been steadily increasing their gold reserves, further bolstering demand and price stability," MOFSL said.The Federal Reserve's monetary policy has also influenced market sentiment. After three interest rate cuts in 2024, the Fed has taken a "wait and watch" approach in 2025 to assess the economic fallout from ongoing trade policies.

While President Trump has openly advocated for further rate reductions to stimulate growth, Fed Chair Jerome Powell has maintained a cautious stance, citing inflationary risks from tariffs and broader economic uncertainties."However, the broader global macroeconomic environment continues to favour gold and other safe-haven assets. Unless a meaningful resolution to global trade disputes is reached, the upward trajectory for bullion prices appears well-supported in the medium to long term," MOFSL added.

Foreign exchange reserves climb to \$678 billion

India's foreign exchange reserves (Forex) rose USD 1.567 billion to USD 677.835 billion in the week that ended on April 4, extending gains for the sixth straight week, according to the official data released by the Reserve Bank of India

According to the data released by the RBI, for the week ended April 11, the foreign currency assets rose by USD 892 million to USD 574.98 billion. The foreign currency assets are the major constituents of forex reserves.

The gold reserve also saw an uptick as it surged by USD 638 million to USD 79.997 billion during the week, suggests the RBI

However, the Special Drawing Rights (SDRS) saw a decrease by USD 6 million to USD 18.356 billion, the data shows.

According to the RBI estimates, India's foreign exchange reserves are sufficient to cover approximately 10-11 months of projected



In 2023, India added around \$58 billion to its foreign exchange reserves, contrasting with a cumulative decline of \$71 billion in 2022.

imports.

India's foreign exchange (forex) market has seen strong growth in recent years, with average daily turnover nearly doubling from USD 32 billion in 2020 to USD 60 billion in 2024

In 2023, India added around USD 58 billion to its foreign exchange reserves, contrasting with a cumulative decline of USD 71 billion in 2022. In 2024, the reserves rose by a little over USD 20 billion. For-

eign exchange reserves, or FX reserves, are assets held by a nation's central bank or monetary authority, primarily in reserve currencies such as the US Dollar, with smaller portions in the Euro, Japanese Yen, and Pound Sterling.

The RBI often intervenes by managing liquidity, including selling dollars, to prevent steep Rupee depreciation. The RBI strategically buys dollars when the Rupee is strong and sells

We would start payment for using the IBS network with prospective effect only from the date of signing of the agreement," the companies said in a letter, which is a continuation of the February 21 letter sent to the MMRCL's MD.

Currently, India imports USD 12-13 billion worth of non-mobile electronics. Almost USD 5-6 billion of PCB (printed circuit board) are being imported from elsewhere for assembling here, he said."Now, the industry is being encouraged. We should start to populate those aggregated components... the heat sinks, the passive components, the capacitors, the resistors, etc," Sharma told PTI on the sidelines of the launch of the company's first smart home experience centre.

According to Sharma, if India has to "genuinely' embark on a journey to in the country, it needs to produce more PCB boards in the country only."Then we will be able to aggregate the demand for components. If these are coming in from elsewhere, populated elsewhere, then it would be very difficult for us to do local manufacturing and make it viable," Sharma, who also chairs industry body FICCI's committee on 'Electronics & White Goods Manufacturing', said. However, he acknowledged that semiconductor is still a big game.

Earlier this year, industry body CEAMA had asked for another round of PLI for air conditioners, which will help the industry to have domestic value addition bevond 70 per cent.

Asked about it, Sharma said, "I very strongly support it. That is the need of the hour.

"The air conditioner industry, in particular, has demonstrated... (it) has aggregated the demand. That's why such a catalysing effect could happen and at a fast speed," he added.

King Charles III wrote a personal letter to India's iconic social worker Bunker Roy, in the last week of March, almost regretting the gap of two years in remaining in touch. This is Charles' first letter to Roy after taking over as the king of the United Kingdom and 14 other Commonwealth realms in 2022.

Responding to Mr. Roy's letter of December 2024, King Charles wrote in his reply of March 23, 2025: It was great joy to receive your December letter... Your letter reminded me of all the years I have known and admired all your heroic efforts in Rajasthan...

Now, Bunker Roy, who founded the Barefoot College (Also known as the Social Work and Research Centre, Tilonia) in Rajasthan's Ajmer district along with his equally illustrious wife, Aruna Roy, had seemingly almost given up on hearing again from the King who had been very pally with him as Prince Charles!

"This is from a friend to a friend," Bunker Roy, now in Tilonia convalescing after Covid-19 and other ailments which followed. "This time the gap had been big,' Bunker Roy, a member of the former Planning Commission and Padmashri awardee, said conceding that Charles' silence appeared unusual going by the past association.


The communication from King Charles, who is also a patron of the Barefoot College which caught the world's imagination pioneering the concept of Barefoot-Barefoot solar engineers, Barefoot doctors, Barefoot teachers and the like-- conceded the gap and attributed it to the changed life style and the time constraints of the

person with a challenging assignment in hand. "... finally! I cannot imagine what happened to your earlier one (communication), but I fear I have been somewhat overwhelmed in the last two years".

The King, as Prince Charles in the past, had visited Tilonia village in Kishengarh tehsil of Ajmer more than once. As Prince, King Charles' itineraries in India in the past included a trip to Tilonia and a photo session

with Bunker Roy. Perhaps making up for the gap this time the British king lavished praise on Bunker Roy who was a path breaker in developmental perspectives in the seventies and eighties at the global level.

"You have clearly become a phenomenon—in fact a 'National Treasure'—and I am constantly singing your praises whenever I can, especially in Africa," King Charles, who was diagnosed with cancer in Feb-

ruary 2024 and is presently undergoing treatment even while maintaining a full schedule of engagements, said. Only recently King Charles made a state visit to Italy to send a message across on the UK's "soft power" and its interest in things abroad.

While King Charles did not indicate any immediate plans to visit India and Tilonia he invited Bunker Roy to meet him whenever he happens to be in the UK next. "There is much to discuss as I have many initiatives going on around the world and long for an opportunity to see you, if you ever come to the United Kingdom at any stage".

"Yours most sincerely" signed off his letter with the words, "In the meantime I send you countless thoughts and kindest possible wishes".

WAS JINNAH RIGHT? THE TWO-NATION THEORY RE-EXAMINED

What began as an ideological response to colonial politics became the basis for the bloodiest Partition in modern history—and continues to shape India-Pakistan relations today.



he "Two-Nation Theory" was the idea that the Hindus and Muslims of the Indian subcontinent were not just two religious communities, but two distinct nations with their own identities. This theory became the ideological basis for the partition of British India in 1947, which led to the creation of Pakistan as a separate homeland for Muslims. Over time, the Two-Nation Theory has been both championed and challenged, from its 19thcentury origins and its role in independence, to how it has been interpreted in Pakistan and India since Partition. Even today, it sparks debate and was recently reaffirmed by Paki-

ORIGINS OF THE TWO-NATION THEORY (PRE-1947)

stan's leadership.

The roots of the Two-Nation Theory go back to the late 19th and early 20th centuries, when some Muslim thinkers in British India began emphasising the distinct identity of Indian Muslims. Sir Syed Ahmed **Khan (1817-1898)** is often credited as an early proponent. Initially, Sir Syed was a strong advocate of Hindu-Muslim unity - famously stating that he saw Hindus and Muslims as "two eyes of a bride", two vital parts of one body. However, events like the **Hindi-Urdu lan**guage controversy of 1867 hammad Iqbal (1877changed his perspective. When Hindu activists in north India pushed to replace Urdu (written in Persian script) with Hindi (in Devanagari script) as an official language, Sir Syed was dismayed. He warned that if even language could become a source of division, then "when even the language of a nation is not safe in the hands of other nations in a region, it would be unwise to continue living with them.". By the late 1860s, Sir Syed had openly concluded that Hindus and Muslims had irreconcilable differences, saying he was "convinced that the Hindus and Muslims could never become one nation as their religion and way of life [were] quite distinct from one another.". This marked



idea that Indian Muslims constituted a separate "nation" within India.

In the early 20th century, this sense of a distinct Muslim identity led to political organisation. The All-India Muslim League was founded in 1906 with the aim of advocating for the interests of Muslims in British India. Over the next few decades, several Muslim leaders and intellectuals debated how Hindu-Muslim differences should be managed. Many still hoped for cooperation within a united India, but others began to imagine a separate Muslim polity.

A major ideological leap came from Allama Mu-**1938)**, the poet-philosopher who presided over the Muslim League's session in Allahabad in 1930. In his famous Allahabad Address, Iqbal explicitly proposed the idea of autonomous Muslim regions. He argued that India was not a homogeneous nation

peoples and religions, and that "the principle of European democracy cannot be applied to India without recognising the fact of communal groups" . Iqbal envisioned a reorganisation where Muslims could develop to their full potential. He declared, for instance, "I would like to see the Punjab, North-**West Frontier Province,** Sind, and Baluchistan amalgamated into a single state. ... the formation of a consolidated North-West Indian Muslim State appears to me to be the final destiny of the Muslims". In other words, Iqbal proposed a "Muslim India within India", a foreteller of what would later become Pakistan. His idea was that Muslim-majority areas in the northwest (and even perhaps in the east) should be grouped into a self-governing unit to protect Muslim interests. Iqbal's vision was a philosophical justification for Muslim nationhood,

the exact mechanics of Partition. Importantly, he did **not** call for expelling Hindus or creating a theocracy; he imagined a state where Muslims would govern themselves within a federal India or even outside it, without harming minorities. Iqbal's address electrified Muslim political thought and laid the intellectual groundwork for the demand for a separate

Another key figure was Muhammad Ali Jinnah (1876-1948), who would later be known as the "Qaid-e-Azam" (Great Leader) of Pakistan. Jinnah initially worked for Hindu-Muslim unity – he was a member of the Indian National Congress and helped broker the 1916 Lucknow Pact between Congress and the Muslim League. But by the 1930s, politics had polarised. After witnessing communal riots and feeling that Muslim rights were neglected under Indian National Congress

In the early 20th century, this sense of a distinct Muslim identity led to political organisation. The All-India Muslim League was founded in 1906 with the aim of advocating for the interests of Muslims in British India. Over the next few decades, several Muslim leaders and intellectuals debated how Hindu-Muslim differences should be managed.

THE ROAD TO **PARTITION AND THE CREATION OF PAKISTAN**

Muhammad Ali Jinnah (seated center) and his colleagues formalized the demand for a separate homeland - a key step driven by the Two-Nation Theory. The Labore Resolution's principles laid the groundwork for the creation of Pakistan

By 1940, the idea of carving out a Muslim state had entered mainstream politics. At the **Lahore session** of the All-India Muslim League in March 1940, Jinnah gave a landmark address and the party passed what came to be known as the Lahore Resolu**tion** (later often called the Pakistan Resolution). In his speech, Jinnah forcefully articulated the Two-Nation Theory. He argued that Hindus and Muslims were two separate nations that could not be simply blended into one country. "It is a dream that the **Hindus and Muslims can** ever evolve a common nationality," Jinnah said, describing Islam and Hinduism as not merely religions but "different and distinct **social orders.**" He noted that the two communities "belong to two different **civilizations**", with values and social customs so divergent that "they neither intermarry nor interdine **together**". Because their outlook on life was so different, Jinnah warned, "to yoke together two such nations under a single state... must lead to grow-

ric that may be so built".

core of the Two-Nation Theory - that Hindus and Muslims were separate nations by every measurable standard, and that any constitutional plan for India had to acknowledge this reality.

The Lahore Resolution, approved on 23 March 1940, formally demanded "independent states" in the Muslim-majority areas of India (in the northwest and northeast). While it did not explicitly use the name "Pakistan", it essentially called for sovereign regions where Muslims would be dominant and could live according to their ethos. This was a political manifestation of the Two-Nation Theory. The resolution galvanised Muslims across British India: Pakistan as an idea had moved from poetry and theory into a concrete political goal. Over the next few years, especially as World War II unfolded, the Muslim League grew in strength, rallying masses under the slogan of Pakistan. Jinnah emerged as the voice of Indian Muslims demanding nationhood, countering the Indian National Congress's insistence on a unified In-

When World War II ended, the British government began making plans to leave India. Despite last-ditch efforts (like the Cabinet Mission Plan of 1946) to keep India united in a federated structure, Jinnah and the Muslim League were adamant that Muslims needed a sepa-

sions reached a peak in 1946, with incidents like the Direct Action Day riots in Calcutta, which tragically underscored how Hindu-Muslim distrust had grown. Faced with the prospect of civil war, British leaders - and Congress leaders like Jawaharlal Nehru and Sardar Patel eventually agreed to a partition of the country along religious lines. The Indian **Independence Act** was passed in July 1947, and it was decided that two dominions would be created: a Hindu-majority India and a Muslim-majority

Pakistan. A crowded train of refugees leaves Punjab during the Partition of India in 1947. The creation of Pakistan - and the corresponding independence of India - triggered the largest mass migration in history. Between 12 and 20 million people were displaced along religious lines as Hindus, Muslims, and Sikhs migrated to what they hoped was the safety of their majority community's new country. This upheaval was accompanied by horrific communal violence that left hundreds of thousands dead.

The Partition of India **in August 1947** turned the Two-Nation Theory into reality - but at an immense human cost. British India was split into the Dominion of Pakistan (comprised of two wings on either side of India: West Pakistan and East Pakistan, which is today's Bangladesh) and the Union of India. As the new borders were drawn, mil-

These words echoed the rate state. Communal ten-lions of Muslims fled from India into Pakistan, while millions of Hindus and Sikhs fled from Pakistan into India. It was a chaotic and traumatic transfer of populations. Historically, some 12 to 20 million people were uprooted during Partition, making it the largest forced migration in recorded history. Communal massacres broke out in Punjab, Bengal, and elsewhere; estimates of the death toll range from **200,000 to 2 million** lives lost in the carnage. Communities that had lived together for centuries were torn apart in a matter of months. The violence was a stark reminder that while the Two-Nation Theory had been presented as a solution to Hindu-Muslim friction, the process of separating the nations unleashed even more hatred and bloodshed in the short

On 14-15 August 1947, Pakistan and India achieved independence as sovereign states. Jinnah became the first Governor-General of Pakistan. In Pakistan's eyes, its birth validated the Two-Nation Theory: the Muslims of South Asia had their own homeland where they would not be dominated by a Hindu majority. In India's eyes, Partition was a painful price to pay - a tragedy of division, even if it resolved the deadlock. The two new nations embarked on very different paths, influenced in no small part by how they viewed the events that created them.



Shamsuzzaman Dudu's accusations against Sheikh Hasina fuel growing political tensions over Bangladesh's sovereignty.



BNP leader from Bangladesh's main opposition party, blamed the country's former PM Sheikh Hasina for selling out Bangladesh's sovereignty by becoming too friendly with India.

He alleged that, if Hasina were still in power, she could have even united Bangladesh with India. These are indications of increasing political tensions in Bangladesh as Dudu blamed Hasina for eroding the nation's independence and democratic system.

WHO IS SHAMSUZ-ZAMAN DUDU?

Shamsuzzaman Dudu is a prominent BNP leader and a close ally of party chairperson Khaleda Zia. He has long been a vocal critic of Sheikh Hasina's government. Having been a former parliamentarian and political activist, he has on many occasions

ing Awami League (AL) for compromising the democratic credentials of Bangladesh. His remarks on April 19 were not the first time he had made scathing attacks on Hasina. Indeed, Shamsuzzaman Dudu has persisted in arguing that her policies endanger the sovereignty and independence of the country.

In his address, Shamsuzzaman Dudu declared that Hasina's "true address" is India and hinted that her alignment with India was a betrayal of Bangladesh's national interests. In Dudu's view, if Hasina had been in office longer, she would have integrated Bangladesh into India completely. These assertions are important because they draw on deep-seated nationalist feelings within the BNP and other opposition parties that blame Hasina for compromising Bangladesh's sovereignty by aligning too closely with

Shamsuzzaman Dudu's criticism of Sheikh Hasina extends beyond individual criticism. He has alleged that Hasina's government has put Bangladesh too much in the hands of India. Dudu says that such dependency has undermined Bangladesh's sovereignty. Dudu's remarks follow an era of increased political tensions between Bangladesh and India. The nations have long had a history of cooperation, but the recent assassination of a Hindu leader in Bangladesh has put the two nations at odds. Dudu's statements reflect increasing anxieties within Bangladesh over its sovereignty against what some perceive as undue Indian influence.

Role of India in Bangladesh's politics

India's involvement in Bangladesh politics has been controversial for years. On the positive side, India has been a close friend of Bangladesh, especially regarding regional security as well as

dently, free from excessive external control. Dudu contends that Hasina has enabled Bangladesh to be overly dependent on India, something he thinks undermines the country's sovereignty.

At the centre of this contention is the fact that Hasina has eroded the democratic institutions of Bangladesh. Dudu asserts that Hasina has undermined the democratic system by weakening the election process, stifling opposition political par-



protecting Bangladesh's independence. This, for Dudu, is a betrayal of the nationalism ideals cherished by the BNP.

WHAT ARE THE **CONCERNS ABOUT BANGLADESH'S SOVEREIGNTY?**

Dudu's allegations point to a larger issue of Bangladesh's sovereignty during Hasina's rule. Sovereignty, in this sense, is Bangladesh's capacity to govern itself indepenties, and amassing power for herself. These actions, to Dudu, have rendered it hard for Bangladesh to operate as an independent and democratic state.

By too closely following India, Dudu contends, Hasina has undercut Bangladesh's capacity to decide without foreign pressures. In his opinion, it has exposed the nation to pressures from outside and compromised its independence in domestic as well as foreign policy.

Explained: US Supreme Court Halts Deportations Under Alien Enemies Act — What Happens Next?



WHAT IS THE ALIEN

ENEMIES ACT? The Alien Enemies Act is part of the Alien and Sedition Acts of 1798, allowing the president to detain or deport non-citizens from hostile nations during times of war or national emergency.

President Donald Trump invoked the law to deport migrants, citing national security concerns, particularly linking detainees to the Venezuelan gang Tren de Aragua, the US media reported.

HOW DID THE SU-PREME COURT IN-TERVENE?

In a rare overnight order early Saturday, the Supreme Court blocked the administration from deporting a group of Venezuelan migrants detained in Texas.

According to CNN, the court stated, "The government is directed not to remove any member of the putative class of detainees from the United States until further order of this court."

Justices Clarence Thomas and Samuel Alito reportedly dissented, but the court did not elaborate on



its reasoning.

WHY IS THIS IMPOR-TANT?

Reports suggest this is the second time in two weeks that the Supreme Court has been asked to intervene in the litigation over the use of the Alien Enemies Act.

The court's earlier 5-4 ruling, the report said, was "opaque" and allowed both sides to claim victory, which in turn led to legal confusion and another urgent appeal.

The current order prevents deportations temporarily, giving the court more time to decide on broader questions about due process and legal standards for deportation under the Act, the report

HOW HAS THE TRUMP ADMINISTRA-TION RESPONDED?

In its reply to the court Saturday, the Justice Department reportedly requested permission to deport some migrants under alternative immigration laws instead of the Alien Enemies Act.

According to CNN, U.S. Solicitor General D. John Sauer wrote, "The government has agreed not to remove pursuant the AEA those AEA detainees who do file habeas claims.'

He also urged the court to let lower courts handle the matter, reportedly saying the case moved too quickly for facts to be properly es-

WHAT IS THE GOV-ERNMENT ARGUING?

The Trump administration has contended that even if the Alien Enemies Act is paused, it should retain the authority to deport the same individuals under existing immigration statutes, the report said.

WHAT ARE THE **LEGAL ISSUES AT** STAKE?

Due process: Critics have argued that the Alien Enemies Act allows the government to circumvent normal legal protections, such as notice and the right to challenge deportation. Evidence concerns: The administration, reports suggest, has relied on tattoos and clothing to justify gang affiliations evidence that legal experts have called "tenuous".

Jurisdictional clarity: Multiple cases are unfolding in New York, Texas and Colorado, and the Supreme Court's intervention points towards potential implications for immigration law and executive power.

WHAT HAPPENS NEXT?

The Supreme Court will likely issue further guidance in the coming days or weeks, the report said, adding that Justice Alito is expected to explain his dissent soon.

The White House, for now, appears focussed on defending its stance, with White House press secretary Karoline Leavitt reportedly saying, "President Trump promised the American people to use all lawful measures to remove the threat of terrorist illegal aliens. We are confident in the lawfulness of the administration's actions."

Ukrainian President Volodymyr Zelenskyy has blamed Russian troops for breaking the Easter ceasefire announced by President Vladimir Putin, terming it a "sham" as fighting went on along the frontline. On Saturday evening, Putin had called for a temporary ceasefire until midnight on Sunday in celebration of Orthodox Easter. But Zelenskyy said Russian forces were still launching attacks and shelling Ukrainian positions.

"Even attempting to fake a ceasefire, Russia continued to conduct offensive operations in certain directions," Zelenskyy wrote in a social media update on Sunday morning. He added that there were hundreds of shelling incidents last night, followed by 59 shelling episodes and five attempts at assault early Sunday.

The military of Ukraine acknowledged a slowdown in front-line operations but stressed that the combat had not completely ceased. "It's more silent, but not calm," declared Viktor Trehubov, an Eastern Front spokes-



In addition, at least three explosions were heard in Russian-occupied Donetsk early Sunday morning, according to Russian news outlets. The reports remain unverified.

The ceasefire effort came after new US pressure for peace negotiations, as President Donald Trump threatened to back out of negotiations if both parties were not serious. Trump also indicated a shift in policy that is more friendly to Moscow.

Zelenskyy reaffirmed Ukraine's willingness to accept a 30-day ceasefire but cautioned that Kyiv would retaliate in kind against further Russian aggression. The European Union cautiously welcomed the ceasefire, and the United Nations reiterated its support for a peaceful resolution concerning Ukraine's sovereignty. In his Easter message, Zelenskyy called on Ukrainians to remain hopeful and united. "We

"As of Easter morning, we can say that the Russian army is trying to create a general impression of a ceasefire, but in some places, it does not abandon individual attempts to advance and inflict losses on Ukraine," Zelenskyy said in a post on X.

Despite Putin's declaration of an Easter ceasefire, Zelenskyy said Sunday morning that Ukrainian forces had recorded 59 instances of Russian shelling and five assaults by units along the front line,

Khalsa Diwan Society Gurdwara, also known as the Ross Street Gurdwara, was desecrated with pro-Khalistan and anti-India graffiti. The management of the Gurdwara in Canada's Vancouver has accused "extremist forces" of the vandalism. They claimed that it was an attempt to instil fear within the Sikh community in Canada. The miscreants used spray paint to desecrate the Gurdwara.

The management issued a statement that was published on their Instagram account. Calling for unity and reflection amidst extremism, the management said that the community was shocked to



witness the act of vandalism at the Gurdwara. "A small group of Sikh separatists, advocating for Khalistan, defaced our sacred walls with divisive slogans like 'Khalistan Zindabad'. This act is part of an ongoing campaign by extremist forces that seek to instil fear and division within the Canadian Sikh community," the statement

The management further noted that such actions undermine the values of inclusivity, respect and mutual support that are "foundational to both Sikhism and Canadian society". They added, "What occurred on April 19th is not only an attack on our Gurdwara but also an assault on the legacy our ancestors built - a legacy grounded in hard work, uni-

ty, and peaceful coexistence." They further called on all Canadians, Sikhs and people of goodwill to stand together in the face of extremism. "We must denounce these acts and reaffirm our shared commitment to the values of peace, unity, and respect. This attack is an attack on all of us - on the very unity that makes Canada strong. Let us unite against division and extremism, for the future we all share," the management concluded in the press release.

Speaking to Hindustan Times, Joginder Sunner, a member of the Gurdwara management, said the incident occurred between midnight and 3 AM on 19th April and described it as a painful moment in the history of the community.

Hong Kong's oldest pro-democracy party shuts down

Canadian Prime Minister Mark Carney has identified China as the country's foremost national security threat, citing foreign interference, cyber activity, and strategic ambitions in the Arctic, as reported by Express Tribune. Carney made the stark declaration during a televised leaders' debate on Thursday evening, marking one of his most direct statements yet on Canada-China relations as the federal election campaign enters its final week.

"China," Carney said bluntly when asked to name the greatest geopolitical threat to Canada. The statement drew sharp reactions domestically and abroad and underscored a growing shift in Canada's foreign policy

Speaking the following day during a campaign stop in Niagara Falls, Carney expanded on his comments, warning that Chinese interference poses a direct challenge to Canada's democratic institutions. "China is the biggest threat from a geopolitical sense. We're taking action to address it," he told supporters. He added that safeguarding Canadian sovereignty -- particularly in the Arctic -- would remain a cornerstone of his national security agenda if re-elected, as reported by Express Tribune.

The Chinese Embassy in Ottawa has yet to respond to Carney's statements. However, a Beijing-based foreign affairs expert suggested the rhetoric was politically motivated.

"Carney's remarks seem to be driven more by election dynamics than long-term strategy," the expert said, urging Canada to pursue a "rational and pragmatic" relationship with China, especially amid global uncertainty, as cited by Global Times.

Carney's Liberal Party remains in the lead in most national polls, though foreign policy and economic anxieties are shaping the final stretch of the campaign. In addition to geopolitical tensions with China, Canada is also grappling with a simmering trade dispute with the United States. Ottawa recently imposed retaliatory tariffs after Washington introduced duties on Canadian autos, aluminum, and steel -- a move that has strained relations with Canada's closest ally.

Caribbean descendants demand reparations at UN gathering

The great-great-grandson of 19th-century British Prime Minister William Gladstone said he was horrified to learn seven years ago that his ancestors were slave owners in

Jamaica and Guyana. And former BBC journalist Laura Trevelvan said she learned after records of Britain's Slave Compensation Commission were put online in 2013 that one of her ancestors, Sir John Trevelyan, owned sugar cane plantations in Grenada and about 1,000 enslaved people. They spoke at a meeting at

U.N. headquarters in New York this past week where, for the first time, descendants of slave owners and enslaved people in former British colonies in the Caribbean sat at the same table with diplomats and experts from those nations discussing the contentious issue of reparations.

"This was a historic event." said Trevelyan, who moderated



the meeting on the sidelines of the U.N. Permanent Forum on People of African Descent's week long session

From about the year 1500, millions of West Africans were sent to work mainly on plantations in the Caribbean and the Americas, including the southern United States. U.N. human rights chief Volker Türk told the forum that an estimated 25 million to 30 million Africans were uprooted for the purpose of slavery.

The Geneva-based Human

Rights Council has called for global action for years, including reparations, apologies and educational reforms to make amends for racism against people of African descent.

The 15-nation Caribbean Community, known as CARI-COM, has a 10-point plan for reparatory justice, starting with demands for European countries where enslaved people were kept and traded to issue

formal apologies. Türk noted a European Union statement in 2023 profoundly

regretting the "untold suffering" caused by the trans-Atlantic slave trade and the African Union's designation of 2025 as the "Year of Justice for Africans and People of African Descent Through Reparations."

At the meeting of descendants of enslaved people and slave owners on Tuesday, Trevelyan spoke of her family's decision to apologize to Grenada and to make a contribution of 100,000 British pounds (about \$133,000) toward education in the Caribbean island nation.

In addition to content and audience engagement, Bhatt touched on the importance of understanding the financial ecosystem of the industry. He suggested that instead of focusing primarily on star power, filmmakers should invest in strong content and storytelling.

"This problem can be solved if music, digital, and satellite companies step up and say, 'We need good songs, we need good films," he explained.

Drawings, Animations, and Tapestries by Tilak Samarawickrema

allery Ragini is roud to present "Not Just a Doodle", a landmark exhibition that brings together for the first time in India the intricate and multidisciplinary oeuvre of Sri Lankan artist and designer Tilak Samarawickrema. Curated by the distinguished writer and cultural archivist Ina Puri, the exhibition showcases Samarawickrema's prolific five-decade journey across mediums - drawing, etching, animation, and handwoven textile -revealing the deeply personal and philosophical core of his artistic practice.

Though trained as an architect at the University of Melbourne and deeply influenced by the design vision of Geoffrey Bawa, Samarawickrema's practice has never been confined by disciplinary boundaries. In-

stead, it radiates outward intertwining the sacred and the sensual, the folk and the modern, the ritual and the dreamlike—into a language that is unmistakably his own. As the exhibition's title playfully suggests, these are "not just doodles" but the result of decades of meditation through mark-making, storytelling, and collaboration. At the heart of the exhibition are Samarawickrema's drawings and etchings, many of which date back to his early years in Milan in the 1970s, where he was first introduced to the European avant-garde. These

works are intimate, ges-

tural, and psychologically

charged -archetypal forms emerge from seemingly spontaneous lines. Some figures appear genderless, others divine, erotic, playful, or wounded. There is both restraint and abandon in his strokes.

"In these drawings," curator Ina Puri notes, "we see the birth of a language - a vocabulary of line that breathes, stutters, dances, trembles. There's rhythm here. And above all, there's listening—the line is listening to itself as it moves. That's what makes it sacred."

For Samarawickrema, the act of drawing is almost trance-like, a release of memory and myth, "I never plan a drawing," he shares. "I start, and the line takes me somewhere. The moment I try to control it, it dies. So I follow."

A rare gem of the exhibition is the screening of Samarawickrema's animated short film Andaré of Sri Lanka - a in collaboration with the stylised tribute to the legendary 18th-century court jester of the Kandyan Kingdom, Andaré. Rendered entirely in his line-drawing style and produced in Italy, the film was commissioned by the Italian Ministry of Cultural Affairs and won critical acclaim at international festivals. Its inclusion in the exhibition offers a rare window into the artist's experimentation with motion, sound, and folklore, showing how traditional South Asian storytelling can be reimagined through contemporary forms. Also on view are his origi-

nal storyboards, concept sketches, and drafts - a treasure trove for those interested in the process of animation, as well as the crossover between art, film. and oral tradition. Perhaps the most visually arresting works in the exhibition are his monumental handwoven tapestries, created master weavers of Thalagune village in Sri Lanka's Central Highlands. In the 1980s, Samarawickrema returned to Sri Lanka and began a lifelong engagement with these artisans, working closely to transform his drawings into thread-based narratives. These tapestries are not reproductions, but reinterpretations—infusing local weaving traditions with modernist aesthetics and symbolic storytelling. Drawing from Buddhist temple murals, Sinhala scripts, ritual architecture, and cosmological diagrams, they pulse with a radiant energy, connecting land,

people, and memory. "The threads are not decorative," Samarawickrema explains. "They are like veins—carrying blood, history, and the warmth of the human hand. I wanted to make work that could be touched, that could belong to a house, a temple, a body." Gallery Ragini, long known for showcasing artists who blur the boundaries between art, craft, and design, considers these tapestries a vital part of the global textile-art movement. "At a time when handwork is disappearing or being commodified, Tilak's collaboration with artisans stands as a beacon of what

slow, sustainable, ethical

artmaking can look like,"

the gallery writes in its note. Curator Ina Puri has envisioned the exhibition not as a chronological retrospective, but as a constellation of experiences. Visitors are invited to move freely between intimate drawings and vast textile surfaces, between black-and-white linework and bursts of colour. Quotes from the artist, photographs from his workshops, and materials from his archives are woven into the gallery

space, offering both intellec-

tual context and emotional texture.

"This is an exhibition that must be felt," says Puri. "There is philosophy here, yes. But more importantly, there is humanness—desire, devotion, humour, solitude. And it is expressed not in grand statements, but in small, precise, powerful gestures. Each line is a breath."

Tilak Samarawickrema's work has been exhibited and collected internationally-from Milan to Melbourne, from Tokyo to Colombo-and has been featured in major design and textile biennales. Yet his commitment has remained local and intimate. A strong advocate for the preservation of Sri Lankan craft traditions, Samarawickrema has also worked with NGOs, educational institutions, and rural design initiatives to empower artisan communities through design innovation.

Climate and Music – a few decades ago, one wouldn't imagine a musician talking of climate. Can you tell us more about the 'sangam' or confluence of climate meeting composition? Actually, this confluence was always there. In school, one of the biggest mistakes we make is we create separate sections- arts and sci-

ence. I don't think it's correct. There is so much art in science and science in art.

Also, I feel that music is

a gift. You have to work on it and hone your skill with experience but primarily it's a gift. But then what are we doing with this gift? I feel that Technology is great - but we have to use technology with responsibility, and that is the biggest crisis we are facing at the moment.

Today if a person goes to a forest, he asks his guide - "Tiger dikhega. If you are not able to show me one, then I will not pay you money." Now look at the ecosystem. He has no interest in the other species. He feels his trip would have been a big failure if he did not see the tiger. This has all come from the communication we have created in the world.

kipper Rohit Sharma (76 not out) and Suryakumar Yadav (68 not out) tore apart Chennai Super Kings to hand Mumbai Indians a commanding nine-wicket win in an one-sided Indian Premier League match here on Sunday.

Chasing a below-par target, the hosts faced absolutely no difficulties on a batting-friendly surface in swatting away the challenge as they went over the line making 177 for one to win by more than four overs to spare, and take a leap to sixth spot in the points table.

The iconic Eden Gardens in Kolkata is all set to host a blockbuster IPL 2025 clash as the Kolkata Knight Riders (KKR) lock horns with the Gujarat Titans (GT) in Match No. 39 of the tournament. While Gujarat sits comfortably at the top of the points table with 10 points, KKR finds itself in a tricky spot with just 6 points from 7 games, currently placed sixth. For Kolkata, this isn't just another game-it could be a turning point to keep their playoff dreams alive.

Both teams have played 7 matches each so far this season. Gujarat has looked solid, winning 5 of them, while Kolkata has managed victories in just 3. GT enters this contest on the back of a clinical win against the Delhi Capitals, whereas KKR will be desperate to bounce back after a loss to the Punjab Kings in their last outing.



When it comes to head-tohead stats, the scales slightly tilt in Gujarat's favour. Out of 4 encounters between these two sides in IPL history, GT has won 2, KKR has claimed 1 victory, and 1 match ended as a washout. Interestingly, the only match played between these two at Eden Gardens also saw GT emerge victorious by 7 wickets under the leadership of Shubman Gill.

The Eden Gardens surface is known for its good bounce and true pace, making it a paradise for batters. However, early swing with the new ball keeps pacers in the game during the first few overs. As the match progresses, spin-



ners come into play-especially under lights. The average first-innings score here hovers between 160 and 170, but totals often go well beyond that. No wonder most captains prefer to bowl first on this pitch.

Cricket analyst Taus Rizvi, speaking on a special segment of Cricket Predicta presented by 1XBAT, weighed in on the contest. "Right now, Gujarat Ti-

tans look like the most balanced and in-form team in the league. But KKR has the home advantage. If they strike early with the ball, this match could swing dramatically.

Arya 5th in Women's Air Rifle; India second in medal tally

Arya Borse finished a good fifth in the 10m Air Rifle Women event, shooting a first-ever final of an International Shooting Sport Federation (ISSF) World Cup stage in her rookie international season. At the Las Palmas range in Lima, Peru, where the second leg of the ISSF World Cup circuit is being held, Arya shot a superb 633.9 on Saturday, to qualify for the final, finishing only behind the reigning junior world champion and eventual gold medalist Wang Zifei of China, who set three world records on the day.

Arya bowed out after the 18th shot of the 24-shot final, her score reading 188.1, just 0.1 behind silver-winning reigning world champion Han Jiayu of China, who was fourth at that stage.



Wang also led a Chinese sweep of the medals in the event as another upcoming young talent Fan Xinyi, took bronze. She set a new junior qualification record (635.9) as well as the new junior and senior final world records (254.8) in a stunning display of air rifle shooting throughout the day.

That consolidated China's position at the top of the charts with three gold, three silver and four bronze med-

als. India, with Arjun Babuta's silver earlier in the day, is in third with two golds, two silvers and one bronze, putting them a gold behind the USA, who are in second.

Till she shot a 9.9 for her 17th shot, Arya had shot almost the perfect final, doing ever so well to maintain second position despite a rampaging Wang and strong challenges posed by world class shooters like Han, Jeanette Hegg Dues-

Junior National Athletics coach suspended for aiding dope test evasion

A slew of dope cases rocked Indian athletics with junior national team chief coach Ramesh Nagpuri suspended by the NADA for "complicity" in doping while seven athletes were also in dock for "evading" tests.

Two more coaches --Karamveer Singh and Rakesh -- were also suspended for "complicity" and "administration of prohibited substances" respectively.

The seven athletes suspended for "evasion" in the latest list of dope offenders



published by the National Anti-Doping Agency (NADA) were Paras Singhal, Pooja Rani, Nalubothu Shanmuga Sreenivas, Chelimi Pratusha, Shubham Mahara, Kiran and Jyoti.

The 19-year-old Singhal had won the boys 2,000m steeplechase for Haryana at the Khelo India Youth Games in 2024. Sreenivas won a silver each in 200m in the Federation Cup, National Inter-State Championships and National Open in 2024. Nagpuri, based at the

Sports Authority of India Centre in Hyderabad and appointed junior chief coach by Athletics Federation of India (AFI) in 2023, is a renowned Dronacharya Awardee coach.

He has been suspended under Article 2.9 of the NADA Anti-Doping Rules of 2021, which deals with 'Complicity or attempted complicity by an athlete or other Person'.
