# Stalwart of India's nuclear power sector, MR Srinivasan dies

Former Atomic Energy Commission Chairman MR Srinivasan passed away at the age of 95 on Tuesday. The Padma Vibhusan recipient had played a key role in the development of India's nuclear power programme.

"We are deeply saddened to announce the passing of Dr M R Srinivasan, former Chairman of the Atomic **Energy Commission and** Secretary, Department of Atomic Energy (DAE)," the

family said in a statement. It said Srinivasan joined the DAE in September 1955 and began his distinguished career working alongside Dr Homi Bhabha on the construction of the country's first nuclear research reactor, Apsara, which achieved criticality a year later.

Prime Minister Narendra Modi today condoled the passing of Dr. MR Srinivasan, a stalwart of India's nuclear energy program.

He wrote in a post on X: "Deeply saddened by the passing of Dr. MR Srini-

# 'Incumbent upon govt to call Parliament session': Congress' Karti Chidambaram

The Congress continues to raise doubts over the chain of events leading to cessation of hostilities between India and Pakistan following Operation Sindoor, launched in response to the Pahalgam terror attack. Congress MP Karti Chidambaram on Tuesday demanded a special parliamentary session to be convened to brief the nation about the "security failure"

during the recent terrorist attack that killed 26 civilians.

"We support Operation Sindoor unconditionally. We understand that all the facts can't be laid out on the table immediately because of issues of national security. However, it is incumbent upon the government to call for a short session of the Parliament and to inform the nation through the house about the events post-Pahalgam, including what led to the security failure (in Pahalgam)," Chidambaram told ANI.

He further stated that asking questions was natural in a functioning parliamentary democracy while acknowledging that some questions may not be answered openly due to national security issues. Chidambaram asserted that it was necessary for the centre to make a statement in the Parliament.

"Some legitimate ques-

tions will be asked. We understand that some can be answered openly, and some can't be. However, questions will be asked, and that's natural in a functioning parliamentary democracy. It is necessary that the government comes and makes a statement on the floor of the house...A two-day session can be held where the Prime Minister and Defence Minister can take the house into confidence," he added.

# AAP's protest nears end at Nangal Dam amid Punjab-Haryana water row

The Punjab Government and Aam Aadmi Party's (AAP) protest at the Nangal Dam against the Bhakra Beas Management Board's (BBMB) move to release extra water from Punjab's quota to Haryana entered its final day on 20 May. Information and Public Relations Minister Harjot Singh Bains announced that the dharna, which began on May 1, will conclude tomorrow with a large rally in Nangal, to be addressed by Punjab Chief Minister Bhagwant Mann.

The protest began when CM Mann made a sudden visit to the Nangal Dam and directed officials not to release additional wa-

technical committee, will be carried out through the Bhakra Mainline Canal and will benefit Punjab, Haryana, and Rajasthan, The timing coincides with the end of the Bhakra Dam's annual depletion period (September 20-May 20), with the upcoming monsoon and snowmelt expected to replenish storage levels.

Deadlock and Legal Tussle The situation escalated into a full-fledged deadlock when Punjab deployed police to block the release of additional water, defying BBMB's orders. The board responded by approaching the Punjab and Haryana High Court, which directed the Punjab government not to interfere in BBMB's functioning and to abide by its technical decisions. While the court's direction was viewed as a setback to Punjab's stance, AAP leaders presented it as a moral and political win, claiming they had prevented misuse of Puniab's share.

Punjab officials argued that Haryana had already consumed its allocated share and that the state

couldn't afford further depletion of its own supply, especially when groundwater levels are already under stress BBMB, on the other hand,

defended the release citing collective decisions taken at the technical committee level, where Punjab was outvoted by other states.

Historical Background: How Consensus Gave Way to Confrontation

The Bhakra-Nangal project, one of India's earliest multipurpose river valley projects, was conceived to serve the states of undivided Punjab. After the reorganization of Punjab in 1966, the BBMB was created to manage water and power distribution among Punjab, Haryana, Rajasthan, Himachal Pradesh, and Delhi. The current situation at Nangal, therefore, reflects not only a recent administrative decision but the deep and unresolved conflict between upper and lower riparian states.

This development comes after the Supreme Court directed the Madhya Pradesh government to form an SIT, comprising three IPS officers, including a lady officer, while coming down heavily on Shah for his remarks against Colonel Sofiya Qureshi, referring to her as "sister of terrorists".

A bench of Justices Surya Kant and N Kotiswar Singh directed that the SIT must consist of three senior IPS officers from the Madhya Pradesh cadre, who are currently serving in the

### Tamil Nadu: Three dead after wall collapses amid heavy rain in Madurai

Three people, including two women and a 10-year-old boy, died after a wall collapsed during heavy rain in Valaiyangulam village near Thirupparankundram in Madurai district on Monday evening, officials said.

According to Madurai District Superintendent of Police Arvind, the deceased have been identified as Ammappillai (65), her grandson Veeramani (10), and their neighbour Vengatti (55).

The incident occurred around 7 p.m. on Muthalamman Kovil Street, where the victims were sitting near the entrance of Ammappillai's house amid a power outage that had begun around 6 p.m. While it was raining, a portion of

All three sustained severe injuries. Neighbours immediately alerted the 108 ambulance service, and the injured were taken to Valaiyangulam Government Hospital for first aid.

Despite medical efforts, Vengatti succumbed to her injuries at the hospital. Ammappillai and Veeramani were referred to the Government Rajaji Hospital in Madurai for further treatment, where they too died.

"In pursuance of Cabinet Decision No. 3187 dated O2.O5.2O25, the allocation of fund under MLALAD Scheme has been kept at Rs 5 crore per assembly constituency per year from financial year 2025-26 onwards," said the order.

# sanitation, dust control: CM

Delhi Chief Minister Rekha Gupta on Tuesday said the cabinet has approved a comprehensive sanitation and dust control plan for the Public Works Department (PWD). Under this plan, the cabinet has approved the procurement of advanced cleaning machines to reduce pollution on Delhi roads.

In a statement, she said under this initiative, a range of equipment will be deployed on PWD-maintained roads to combat dust pollution. They include 250 water sprinkler machines integrated with antismog guns and 70 Mechanical Road Sweeping (MRS) machines integrated with 210



water sprinkler machines and anti-smog guns, 18 dump vehicles and 18 water tankers.

All these machines are expected to be fully operational on Delhi roads before the onset of winter. The Environment Department will provide the necessary budget to the PWD under the 'Pollution Control and Emergency Measures' scheme for the deployment of the machines, she said. These machines will

be used exclusively for dust cleaning on roads and can be deployed across Delhi as needed with the goal of improving overall air quality.

Gupta said the cabinet also approved the proposal of Directorate of Education to reinstate the name of the scheme namely 'Lal Bahadur Shastri Scholarship to Meritorious Students' in place of 'Chief Minister Scholarship for Meritorious Students'.

"In 2019-20, the 'Lal Bahadur Shastri Scholarship for Meritorious Students (LBS)' scheme was discontinued and restructured under a new name -- Chief Minister Scholarship for Meritorious Students -- by the previous government.

# Rs 30,000 subsidy for 3 kW solar panels approved

# 82-km Delhi-Meerut RRTS corridor to be ready by June

# **DELHI HC NOTICE: THAROOR ASKED TO RESPOND** TO CHANDRASEKHAR'S DEFAMATION COMPLAINT

he Delhi High Court on Tuesday issued notice to Congress leader and Thiruvananthapuram MP Shashi Tharoor in a petition filed by BJP leader and former Union Minister Rajeev Chandrasekhar. The appeal challenges a trial court's decision to dismiss Chandrasekhar's criminal defamation complaint against Tharoor.

The bench of Justice Ravinder Dudeja sought a response from Shashi Tharoor after hearing detailed submissions by senior advocate Mahesh Jethmalani, who appeared on behalf of Rajeev Chandrasekhar. The matter has been listed for hearing on September 15, 2025.

Senior Advocate Mahesh Jethmalani argued that the trial court had issued a grossly erroneous order in dismissing the Revisionist's (Rajeev Chandrasekhar's) defamation complaint. He contended that the Revisionist had sought the prosecution of the Respondent (Shashi Tharoor ) for criminal defamation under Section 203 of the Code of Criminal Procedure, 1973. However, the court exercised judicial discretion perversely and overlooked material evidence on record.

Furthermore, Jethmalani submitted that the Additional Chief Judicial Magistrate, in delivering the impugned order, had failed to recognize the Respondent's attempt to



gain an unfair advantage in the election by making false statements right before the polls. He argued that these statements not only severely damaged the credibility and reputation of the Revisionist--leading to his defeat by a narrow margin--but also undermined the principles of free and fair elections, which form the cornerstone

evidence presented by the complainant's counsel, ruling that the case did not establish defamation against the proposed accused.

Earlier, on September 21, 2024, the court had taken cognisance of the defamation complaint and directed the complainant to present pre-summoning evidence.

Chandrashekhar alleged that Tharoor falsely claimed in an interview that he had bribed voters in the Thiruvananthapuram constituency. He argued that this statement damaged his reputation and contributed to his loss in the 2024 Lok Sabha elections.

In its September 21 order, the Additional Chief Judicial Magistrate stated: "Based on the submissions and material placed on record, which prima facie disclose the ingredients of the offence, I take cognisance of the offences under Sections 500 IPC and 171G IPC."

The complaint further alleged that Tharoor defamed Chandrashekhar by making false and derogatory statements on national television, knowingly misrepresenting facts with the intent to harm his reputation and influence the election outcome.

Additionally, it was claimed that the interview was widely circulated by various news channels and social media platforms at the behest of the proposed accused, leading to reputational damage and ultimately contributing to Chandrashekhar's electoral defeat in 2024.

'When shelling occurred, my uncle (Mohammad) and his family members were inside the house. The shelling has caused massive losses to them. They have worked as labour to educate their daughters. Everyone in the house fainted when the shells hit the house. As soon as they regained consciousness, they tended to my uncle's injuries. We appeal to the government to help them," she said.

# RBI may change its liquidity management approach: Report

> India's banking system remained in a liquidity surplus during the week ending May 16, 2025, with average surplus funds amounting to Rs 2.04 lakh crore, according to a recent report by Union Bank of

> Despite tighter liquidity conditions in recent months, the weighted average call rate (WACR) stood at 5.69 per cent, which is lower than the current repo rate. This indicates the presence of excess funds in the system.

> The report said, "The banking system remained in surplus for most of the week, averaging Rs. 2.04 lakh crore".

It also added that as of May 2, 2025, total bank credit rose by 9.9 per cent on a year-onyear basis, while deposits grew slightly faster at 10.0 per cent. This has led to a narrowing of the gap between credit and deposit growth. The difference has turned slightly negative, moving from a positive gap of 13 basis points in the previous fortnight to a



negative 6 basis points.

The report stated this reflects banks' active efforts to mobilise more deposits in response to earlier tight liquidity conditions

Meanwhile, the domestic bond market saw a fall in yields. The yield on the 10-year government security (6.79 per cent GS 2034) dropped by 6 basis points over the week to 6.26 per cent. It had earlier risen to 6.3449 per cent before falling to a low of 6.2525 per cent.

The decline in yields is largely due to expectations of a higher dividend transfer from the Reserve Bank of India (RBI), estimated at around Rs 2.5-3.0 lakh crore, and easing consumer price inflation (CPI), which opens up the possibility of future rate cuts.

The RBI recently reviewed its economic capital framework (ECF) and has sought the government's approval to expand the range of its contingent risk buffer (CRB), which could impact the final dividend amount.

Markets are now closely watching for the RBI's dividend announcement, scheduled for May 23, 2025.

The report said that a higher-than-expected dividend could push system liquidity above Rs 6.0 lakh crore. In that case, the likelihood of further open market operations (OMOs) would reduce, as most have already been front-loaded.

Meanwhile, the RBI has called a meeting this week to discuss its liquidity management framework. The current framework largely revolves around 14-day repo and reverse repo operations, supported by shorter-tenor tools.

However, recent weeks have seen a consistent omission of the 14-day operations, possibly indicating a shift in the central bank's liquidity management approach.

## Govt likely to bring IBC amendment bill in Parliament's monsoon session: Sources

The central government is likely to bring an amendment in the Insolvency and Bankruptcy Code (IBC) in the upcoming monsoon session of Parliament, sources said.

The apex court had noted that the resolution was unsustainable without CCI approval. The Supreme Court had re-

portedly observed in Januarv 2025 that AGI Greenpac Ltd's bid for the acquisition of insolvent Hindustan National Glass (HNG) Ltd without the Competition Commission of India's (CCI) approval is unsustainable and must be set

"AGI Greenpac's resolution plan is unsustainable as it failed to secure prior approval from the CCI, as mandated under the proviso to Section 31(4) of the Insolvency and Bankruptcy Code (IBC). Consequently, the approval granted by the Committee of Creditors (CoC) to the resolution plan dated October 28.

## cybersecurity ready: Cisco TDG NETWORK

Cybersecurity readiness remains alarmingly low in Indian companies, with only 7 per cent of firms in India achieving a mature level of readiness by 2025, according to a recent report by global technology firm Cisco.

This is an increase from last year's (2024) Index, in which 4 per cent of Indian organisations were designated as mature, the Cisco 2025 Cybersecurity Readiness Index observed.

This demonstrates that despite an improvement from



last year, cybersecurity preparedness remains low as hyper-connectivity and AI introduce new complexities for security practitioners.

The report added that artificial intelligence (AI) is revolutionising security and escalating threat levels, with 9 in 10 organisations (95 per cent) facing AI-related security incidents last year.

However, only 66 per cent of respondents are confident that their employees fully understand AI-related threats.

The report further observed that more than half of Indian organisations (57 per cent) suffered cyberattacks, hindered by complex security frameworks with disparate point solutions in the previous year.

Cybersecurity Readiness Index adds that the industry respondents view external threats like malicious actors and state-affiliated groups (46 per cent) as more significant to their organisations than internal threats (54 per cent).

# **CORRECTING PAK'S FAKE NARRATIVE**

India is sending a team of seven all party delegations to the rest of the world to explain India's stand on Operation Sindoor, which were carried out in response to the dastardly attack in Pahalgam. The delegations will have both BJP and Opposition MPs along with some seasoned former diplomats and experts. There is a feeling that while India has won the war militarily, it is losing the global narrative. This move is to correct that narrative and nail some of Pakistan's fake propaganda. The delegations will send out a strong message underlining India's zero tolerance to terrorism and reiterate that Operation Sindoor was a precision response whose mission was to take out the terrorist infrastructure in Pakistan and PoK. The targets of the nine strikes carried out on the early morning of 7th May were civilian and non military. It was Pakistan that escalated the conflict with its response. It should be noted that Pakistan is also sending out its own delegation headed by former Pakistan foreign minister Bilawal Bhutto.

"The delegations are set to visit key partner countries, including members of the UN Security Council later this month. The All-Party delegations will project India's national consensus and resolute approach to combating terrorism in all forms and manifestations. They would carry forth to the world the country's strong message of zero-tolerance against terrorism," the government said, announcing the names of leaders who will head the seven

Meanwhile the Parliamentary Standing committee on external affairs has been briefed on Operation Sindoor by foreign secretary Vikram Misri. The committee was told in no uncertain terms that it was Pakistan that reached out to India for a ceasefire, after the precision strikes carried out by the Indian armed forces hit Pak military installations, including a China-made missile defence system in Lahore and the strategically important Nur Khan air base.

Internal politics has broken out over the inclusion of some of the names. When asked by the Parliamentary Affairs minister Kiiren Rijiju to give a list of names, the Congress handed a list of four names but only one of these was included by the government in the final list. Instead names that were left out were added, the most notable being that of Shashi Tharoor. The COngress leader and former external affairs minister of state played a key role articulating India's stand to the foreign media post 7th May. His eloquent defence of India's actions which willy nilly ended up defending the current government as well, did not go down well with his party colleagues even though Tharoor said he was speaking as an Indian and not as a member of any political party. Another eloquent Congress leader Manish Tewari has also been included in the delegation level talks, though Tewari's hyphenation with Tharoor has not irked his party leadership as much. Incidentally, Salman Khursheed is another Congress name who has been included. The only name who made it from the list given by the Congress leadership is that of Anand

The political ramifications of Tharoor being projected by the BIP is still to be played out though there is speculation that he may be asked to leave the Congress. If that happens, then there is little doubt that the BJP will happily find a role for him because what the party lacks is the kind of talent and bench strength that Tharoor brings to the table.

### THE REALITY CHECK Irregular and Unpredictable Judicial Examinations

Judicial service exams across Indian states are far from regular. Many states notify vacancies only once every 4-5 years. By mandating an additional three years of practice, the Court has inadvertently created a

situation where aspirants may have to wait nearly a decade from graduation before becoming eligible. The result? An entire generation of brilliant legal minds may be discouraged from pursuing the judiciary at all.

### **Disruption for Thousands** of Law Students

In their final year, thousands of law students begin intensive preparation for judicial services, committing years of effort and spending substantial amounts on coaching and study re-

### A Setback for Women in

This ruling delivers a particularly harsh blow to women. In a society where women are still under societal pressure to marry young and shoulder disproportionate family responsibilities, asking them to spend five years studying, three years practicing, and then wait several more vears for exam cycles to turn is a formula that will push many women out of the race entirely. Just when women were beginning to make significant inroads in judicial appointments, this decision threatens to undo that progress.

### **The Door to Corruption Swings Wide Open**

The Supreme Court's requirement that experiences certificates be signed by a senior advocate and endorsed

seem like a step towards accountability. However, this opens the floodgates to nepotism, favouritism, and corruption. For those with the right connections or the means to "influence" the process, obtaining a certificate will be no big deal. Meanwhile, genuine aspirants who strictly adhere to ethics may find themselves sidelined—yet another injustice in the name of justice.

Who will protect these honest aspirants? Who will ensure that the "verification" of legal practice doesn't become another bureaucratic hurdle riddled with underhanded dealings?

# A NEW FRAMEWORK FOR GLOBAL HEALTH: THE 2025 PANDEMIC ACCORD

The accord aims to strengthen global cooperation, improve pathogen sharing, and ensure equitable access to vaccines during future pandemics addressing COVID-19-era failures.

n May 20, 2025, the World Health Assembly (WHA) in Geneva adopted a historic global pandemic accord. This accord marks a transformative moment in international public health diplomacy, as it formalises a multilateral commitment to enhance global preparedness, response, and equity in managing infectious disease outbreaks. It was widely seen as a direct response to the systemic shortcomings exposed by the COVID-19 pandemic, and its adoption could represent the most significant restructuring of global health governance since the founding of the World Health Organization (WHO) in 1948.

The COVID-19 catalyst: The COVID-19 pandemic (2019-2023) laid bare the deficiencies of existing global health mechanisms. Delays in sharing epidemiological data, unequal access to vaccines and treatments, and the absence of a cohesive international response all contributed to the pandemic's severity. Countries closed borders, hoarded supplies, and pursued unilateral solutions in a time when global cooperation was sorely needed. The resulting loss of life and socioeconomic disruption created an impetus for reform.

Calls for a new pandemic treaty began as early as 2021, with multiple countries and civil society organisations emphasiscommitments to transparency, equitable distribution of medical tools, and improved surveillance systems. The WHO, under the leadership of Dr. Tedros Adhanom Ghebreyesus, became the focal point for these efforts.

### THE 2025 ACCORD:

The newly adopted pandemic accord outlines a comprehensive framework addressing preparedness, early detection, transparent reporting, research cooperation, equitable access, and accountability. Its most prominent features include:

International Surveillance and Reporting Obligations: Countries are required to strengthen disease surveillance systems and report potential outbreaks within 72 hours of detection. The WHO will oversee a global early warning system, integrating real-time data from member states to identify potential threats.

Pathogen Access and **Benefit Sharing (PABS):** One of the most contentious yet groundbreaking elements is the Pathogen Access and Benefit Sharing system. PABS mandates that member states share pathogen samples and genetic sequence data with the WHO in exchange for guaranteed equitable access to resulting vaccines, diagnostics, and treatments. This aims to avoid the vac-

The United States' Withdrawal: Despite broad international support, the United States did not participate in the adoption of the accord. The U.S. had exited the WHO under President Donald Trump during his second term, citing national sovereignty concerns and criticisms of WHO's alleged deference to China during the early stages of the CO-VID-19 outbreak. The U.S. absence from the accord casts a shadow over its universality and raises questions about

The 2025 Pandemic Accord can be compared to post-World War II institutions like the United Nations and the WHO itself. Just as those institutions were born from the ashes of war, this accord arises from the global trauma of COVID-19.

The failure of the International Health Regulations (IHR) during COVID-19 was a catalyst. Although the IHR required countries to report outbreaks, there was no enforcement mechanism. The new accord aims to fill that gap with mandatory reporting and regular evaluations.

Past attempts at global health cooperation, such as the 2009 influenza vaccine sharing agreement, faltered due to a lack of trust and political will. The 2025 accord appears more robust, with stronger financial and legal scaffolding.

Looking Ahead: Challenges and ProspectsWhile the accord is a historic milestone, its success will depend on implementation. Key challenges include: Political Commitment: Countries must remain engaged beyond the adoption phase. Regime changes and shifting priorities could derail progress.



Global Response and Ratification: Over 110 of the 194 WHO member states expressed intent to sign the accord following its adoption. However, the accord will only come into effect once at least 60 countries ratify it, along with the annexe, which includes implementation details on PABS and intellectual property.

Several African, South Asian, and Latin American countries have welcomed the accord, citing its emphasis on equity. Civil society groups, especially those advocating for health as a human right, have lauded the inclusion of mandatory benefit-sharing. Still, some developing nations remain cautious, wary of whether commitments from pharmaceutical companies and high-income countries will materialise.



# IS CHINA TRYING TO REVIVE BANGLADESH'S LALMONIRHAT AIRBASE NEAR INDIA'S BORDER?

In 2019, the Bangladesh government, led by Prime Minister Sheikh Hasina, proposed establishing an aviation and aerospace university at the site.

Bangladesh, located just a few kilometres from the Indian border, is drawing renewed attention following reports of increased Chinese activity at the site.

### **CHINESE INTEREST**

The Lalmonirhat airbase once a strategic Allied hub during World War II - has resurfaced in regional discourse after Chinese officials were seen visiting the site, and activity around the area reportedly increased.

Located in the Rangpur division of Bangladesh, the airfield lies merely 12-20 km from the Indian border and is around 135 km from the strategically critical Siliguri Corridor. This has raised concerns among Indian defence and strategic circles, particularly given the sensitive nature of the region.

The proximity of the airfield to India's narrow Siliguri Corridor, which connects the country's northeastern states to the mainland, makes any for-

eign involvement in the area especially sensitive for New Delhi. The Indian military's eastern command is said to be closely monitoring developments around the site.

### **WARTIME LEGACY OF LALMONIRHAT AIRBASE**

Built in 1931 by British authorities, the Lalmonirhat airfield played a crucial role during World War II as a forward operating base for

missions across Southeast Asia, including Myanmar.

The facility once spanned approximately 1,166 acres and featured a four-kilometre-long runway along with substantial tarmac space. After the Partition, Pakistan briefly reactivated the airfield for civilian use in 1958, but the site eventually fell into disuse and remained dormant for

Now under the jurisdiction of the Bangladesh Air Force, the site is officially recognised as BAF Station Lalmonirhat (ICAO code VGLM) and is one of nine active air bases in the country. During its prime, it was regarded as the second-largest airport in Asia.

In 2019, the Bangladesh government, led by Prime Minister Sheikh Hasina, proposed establishing an aviation and aerospace university at the site. That institution is now operational and functions under the command of the Bangladesh Air Force.

### **A BROADER REVIVAL PLAN OF LALMONIRHAT AIRBASE**

The recent uptick in interest in Lalmonirhat is part of a broader initiative by Bangladesh's interim government, led by Mohammed Yunus, to revive six British-era airports across the country as part of an economic development strategy.

According to TOI, the other airfields included in the plan are Thakurgaon, Ishwardi, Shamshernagar, Comilla, and Bogra. While the stated purpose of these redevelopments is economic, the reported involvement of Chinese officials has intensified scrutiny of the program.

### **INDIA'S 'CHICKEN'S NECK' UNDER FOCUS**

At the core of India's concern is the airfield's proximity to the Siliguri Corridor - a narrow,22-kilometre-wide strip in northern West Bengal that connects India's northeastern states to the rest of the country. The corridor is of immense strategic importance for both civilian and military logistics.

Any perceived threat to this corridor has the potential to disrupt access to the eight northeastern states: Arunachal Pradesh, Assam, Nagaland, Manipur, Mizoram, Tripura, Meghalaya, and Sikkim.

# What is temporary protected status, and why is Trump targeting it?

emporary Protected Status is a humanitarian immigration provision that allows individuals already in the U.S. to remain and work legally if their home countries are deemed unsafe due to war, natural disasters, or other extraordinary events. Created by Congress in 1990, TPS is granted in six- to 18-month increments by the U.S. Secretary of Homeland Security. While it does not offer a path to citizenship, many beneficiaries have lived in the U.S. for decades due to repeated renewals.

### **HOW DID TRUMP HANDLE TPS IN HIS FIRST TERM?**

During his first term, Trump attempted to end TPS protections for approximately 400,000 people from countries including El Salvador, Haiti, Honduras and Sudan as part of an immigration crackdown, according to Reuters. Federal courts blocked those efforts, leaving the program intact through the end of his presidency in 2021.

### **WHAT CHANGED UNDER BIDEN?**

President Joe Biden expanded TPS, granting new protections to nationals from Afghanistan, Ukraine, Venezuela and several other countries. Venezuelans became the largest group under TPS, with over 600,000 eligible



by the end of Biden's term. In a last-minute move before leaving office, then-Homeland Security Secretary Alejandro Mayorkas extended TPS for Venezuelans and several other groups.

### **WHAT HAS TRUMP DONE SINCE**

**RETURNING?** Trump's current Homeland Security Secretary, Kristi Noem, has rolled back Biden-era TPS extensions. In early February, she rescinded protections for 348,000 Venezuelans, arguing the decision was

needed to avoid binding the administration to prior policy and to combat gang violence. Protections for Haitian, Afghan and Cameroonian nationals have also been slated for termination in the coming months. A Homeland Security

notice states TPS for Afghans will end in July and for Cameroonians in June, the report said, adding that Haitian protections are set to expire in August unless extended. Further decisions on remaining Venezuelans-over 250,000—are expected in July.

### WHAT IS THE LEGAL STATUS?

While lower courts initially blocked the terminations, the Supreme Court's order on Monday allows the Venezuelan TPS rollbacks to proceed during ongoing litigation. The decision could signal a judicial shift in favour of allowing terminations, even if challenged.

A San Francisco judge had previously blocked the Venezuela decision, calling the administration's characterisation of TPS recipients as criminals a depiction that "smacks of racism," as reported by Reuters.

A Homeland Security notice states TPS for Afghans will end in July and for Cameroonians in June, the report said, adding that Haitian protections are set to expire in August unless extended. Further decisions on remaining Venezuelans—over 250,000—are expected in July.

# What is the Take It Down Act? Trump signs first federal law

criminalises the distribution of explicit images without a subject's consent, including those generated or altered by artificial intelligence (AI).

"This will be the first-ever federal law to combat the distribution of explicit imagery posted without subjects' consent," President Trump declared during a signing ceremony at the White House. "We will not tolerate online sexual exploitation," he added.

Following the formal signing, Trump handed the legislation to First Lady Melania Trump, who added her signature in symbolic support.

### **BIPARTISAN BACKING AND FIRST LADY'S ADVOCACY**

The bill, which garnered strong bipartisan support, was publicly championed by Melania Trump. Initially introduced last year by Senators Ted Cruz and Amy Klobuchar, it passed the Senate in February and the House in March, before making its way to the president's desk.

Calling the law a "national victory", Melania Trump said it would help parents and families safeguard their children from digital exploitation.

Speaking during the bill's introduction in March, the First Lady underscored the growing threat to young people: "It's heartbreak-

ing to witness young teens, especially girls, grappling with the overwhelming challenges posed by malicious online content like deep fakes. This toxic environment can be severely damaging."

She further warned about the potentially harmful effects of emerging technologies: "Artificial intelligence and social media are the digital candy for the next generation — sweet, addictive and engineered to have an impact on the cognitive development of our children," she said. "These technologies can be weap-

onised, shape beliefs and,

sadly, affect emotions and even be deadly."

### **KEY PROVISIONS OF**

**TAKE IT DOWN ACT** Under the Take It Down Act, websites and social media platforms are now legally obligated to remove explicit content — including AI-generated images — within 48 hours of a victim's request. The law imposes criminal penalties on individuals who knowingly share such content without permission.

For the first time, federal law extends protections to adults affected by manipulated or non-consensual explicit imagery. Previous

legal frameworks focused primarily on safeguarding children.

The legislation also holds tech companies accountable for failing to act swiftly on removal requests. Major digital platforms including Meta, TikTok, and Snapchat have expressed their support for the bill.

### **TAKE IT DOWN ACT: BALANCING PROTECTION AND** FREE EXPRESSION

Despite broad support, some digital rights advocacy groups have voiced concerns. Critics argue that the legislation may lead to the removal of lawful content and lacks robust safeguards to prevent misuse of takedown requests.

Nonetheless, the law's passage follows a surge in high-profile incidents involving the unauthorized use of deepfake technology to create explicit images of public figures and minors. Victims have included celebrities like Taylor Swift and Representative Alexandria Ocasio-Cortez, as well as ordinary teenage girls.

# TRUMP SAYS RUSSIA, UKRAINE AGREE TO IMMEDIATE CEASEFIRE TALKS

## EU agrees to lift all economic sanctions on Syria: Diplomats

Syria's foreign minister said on Tuesday that the lifting of sanctions on his country shows an "international will" to support his country, after EU countries agreed to end most of its sanctions.

In a press conference in Damascus alongside his Jordanian counterpart, Asaad Al-Shaibani said that "lifting sanctions expresses the regional and international will to support Syria," adding that "the Syrian people today have a very important and historic opportunity to rebuild their country."

EU countries gave a green light to lifting all economic sanctions on Syria in a bid to help the war-torn country recover after the ouster of Bashar Assad, diplomats

Ambassadors from the EU's 27 member states struck a preliminary agreement for the move, which should be formally unveiled by foreign ministers meeting in Brussels later in the day, diplomats said.

The decision from the European Union comes after US President Donald Trump announced last week that Washington was lifting its sanctions against

The country's new rulers have been clamouring for relief from the crushing international punishment imposed after Assad's crackdown on opponents spiralled into civil war.

EU diplomats said the



tions cutting Syrian banks off from the global system and freezing central bank assets lifted.

# Zelenskyy accuses Russia of buying time to stall peace talks

Ukrainian President Volodymyr Zelenskyy on Tuesday accused Russia of delaying peace talks in a bid to press on with its threeyear invasion, even as US President Donald Trump pushes for an immediate

Trump spoke by phone Monday with Zelensky and Russian leader Vladimir Putin, while Russian and Ukrainian officials met in Istanbul Friday for their first direct talks on the conflict in more than three

But they failed to yield a truce, and Zelenskyy ac-



cused Putin of sending "empty heads" to the negotiating table.

"It is obvious that Russia is trying to buy time in order to continue its war and occupation," Zelenskyy said in a post on social media.

Trump framed his twohour conversation with Putin, the third so far this year, as a breakthrough.

The Republican is seeking an elusive deal to end the war that he had promised on the campaign trail to solve in 24 hours.

But Putin again rebuffed the call for a full, immediate and unconditional ceasefire, instead saying only that he was ready to work with Ukraine on a "memorandum" outlining a possible roadmap and different positions on ending the war.

Moscow is feeling confident with its troops advancing on the battlefield and Trump having resumed dialogue with Putin after almost three years of the West shunning the Kremlin chief.

## Trump signs bill making 'revenge porn' a federal crime

**United States President** Donald Trump has signed a bill outlawing so-called "revenge porn", including images created using artificial intelligence.

The Take It Down Act, signed on Monday, makes it a federal crime to publish intimate images of a person without their consent, and obligates social media platforms to remove such images within 48 hours when requested by vic-

The legislation, which passed the US Congress earlier this year with nearunanimous support, applies to realistic-looking AI-created images, known as "deepfakes", as well as genuine photos.

"With the rise of AI image generation, countless women have been harassed with deepfakes and other explicit images distributed against their will. This is ... wrong ... just so horribly wrong," Trump said at a signing ceremony at the White House in Washington, DC.

"It's a very abusive situation ... And today we're the law as a "powerful abused".

Israel pressed ahead Tuesday with its new military offensive in Gaza despite mounting international criticism, launching airstrikes that health officials said killed at least 85 Palestinians. Israeli officials said they also allowed in dozens more trucks carrying aid.

It was not immediately clear whether the desperately needed supplies were reaching any of the over 2 million people in Gaza, which has been under an Israeli blockade for nearly three months. Experts have warned about the high risk of famine. Under pressure, Israel agreed this week to allow a "minimal" amount of aid into the Palestinian territory after preventing the entry of food, medicine and fuel in an attempt to pressure the Hamas militant group.



### 'UN has clearance for 100 more aid trucks to enter Gaza'

GENEVA: The United Nations has received permission from Israel for about 100 more aid trucks to enter Gaza on Tuesday, a spokesperson for its humanitarian office said, as international pressure mounted on the government to take immediate steps to alleviate the effects of an 11-week blockade that ended Monday. Israel had blocked all aid from entering Gaza since March 1, arguing that sufficient humanitarian assistance had entered the Strip during a six-week ceasefire and that Hamas was stealing aid, with the blockade necessary to pressure the terror group to release the dozens of hostages it is holding. In recent weeks, however, some officials in the IDF have begun warning the political leadership that the enclave was on the brink of starvation.



or many years, the conventional education model has put strong focus on degrees as the final score of a student's potential and employability. But the employment landscape is evolving—and at lightning speed. Employers today are less concerned with paper qualification and more with what someone can do. With a wave of automation, AI, and fluid job descriptions reshaping the working world, skills have become the real differentia-

While degrees remain a starting point, they're no longer a destination they're merely the gateway. The world of work now requires flexibility, crossfunctional proficiency, and moment-by-moment problem-solving. A programmer can be asked to know UI/ UX, a mechanical engineer to collaborate with data

pro to operate AI software. Because boundaries are breaking down, students no longer only need knowledge but also agility—the kind that flows from experiential learning and ongoing upskilling. This change has also been



of Jobs Report 2025. It esti-

mates that by 2030, about

22% of existing jobs will

be dramatically changed because of automation, AI, and other forces of transformation. Although 92 million jobs will be lost, about 170 million new jobs will be created, leading to a net increase of 78 million jobs. The report also points out that almost 40% of job competencies will be altered by the year 2030, with a focus on the increasing relevance of technological skills as well as human skills such as creative thinking and flexibility. cation industry-focused and solution-oriented towards real-world challenges.

However, the implementation is most important.

Whereas most educational institutions still depend very much on the traditional classroom lectures and theoretical examinations, an increasing number are adopting production-based and action learning frameworks. These extend beyond mockup labs to cover functional manufacturing centres and live project centres where students are trained under real-time situations. From digital design and precision machining to renewable energy systems and food technology, such centres give students hands-on, immersive learning experiences that cannot be provided in any textbook.

This method doesn't only develop technical competencies—it fosters problem-solving skills, critical thinking, and responsibility. Consistent with the suggestions in NEP 2020, flexible academic paths such as lateral entry into degrees are picking up speed. With flexibility, holders of diplomas or working professionals can leverage learning done earlier and join higher programmes without duplication. It also echoes a larger transformation: appreciating what a student knows and is able to do, as opposed to how long they have stayed in formal studies.

The result of such an ability-integrated model of education is obviousgraduates are industryready, assured, and better employable. They have the theoretical grounding and practical proficiency to be immediately effective. Such a two-fold ability is exactly what employers want more and more: individuals with the ability to adjust, to contribute, and to lead in fastchanging workplaces.

As the distinction between workplace preparedness and academic education further blurs, it's increasingly apparent that the degree itself no longer assures success. Skills-demonstrable, usable, and relevant—are the actual game-changers in today's competitive landscape.
