he Directorate General of Civil Aviation (DGCA) on Friday confirmed that an IndiGo flight from Delhi to Srinagar that was caught in a hailstorm on Wednesday was denied entry into Pakistani airspace which was sought by the pilot to avoid turbulence.

In a detailed statement about the incident, the Directorate General of Civil Aviation (DGCA) said there was no injury to any passengers who were on the flight and that the aircraft's "nose radome" was damaged.

The incident of the aircraft encountering turbulence is being probed by the DGCA.

No one has supported the military regime and undermined democracy in Pakistan in so many ways as much as the West, External Affairs Minister S Jaishankar has said.He described the threat of terrorism as a major "collective challenge" facing the world alongside climate change and growing poverty.

In an interview to Danish daily Politiken, Jaishankar criticised Europe for backing Pakistan when it was under military dictator-

"Our borders have been



violated by Pakistan in Kashmir ever since our independence in 1947. And what have we seen in the eight decades since then," he asked.

"That large, democratic Europe, to use your own term, has stood side by side with military dictatorships in the region."

The North-eastern region, once synonymous with "bombs, guns and blockades", is now witnessing unprecedented progress, with the government determined to accelerate its growth story, Prime Minister Narendra Modi said on Friday.

Addressing the Rising North East Investors Summit here, the PM Modi said diversity of the North-East is its biggest strength, and every state in the region is declaring its readiness for investment and leadership. "The North-East is emerging as a key destination for two strategic sectors -- energy and semiconductors," he said and added that the role of Assam is growing in strengthening India's semiconductor ecosystem.

He said the first Made in India chip from a Northeastbased semiconductor plant will soon be introduced, signalling a major milestone for the region that will unlock

The Prime Minister said the government has made extensive investments in hydropower and solar power across all Northeastern states, with several thousand crore worth of projects already approved.

India to push for bringing Pak on FATF grey list

India is expected to approach the Financial Action Task Force, global money laundering and terrorist financing watchdog, to add Pakistan to its grey list during its next meeting, Reuters reported, citing a top government

The 'grey list' of the FATF accounts for jurisdictions that are under increased monitoring. When a country is placed under this list, it means that it has "committed to resolve swiftly the identified strategic deficiencies within agreed timeframes and is subject to increased monitoring". At present, as many as 25 countries are listed under FATF's "jurisdictions under increased monitoring",

i.e., "grey list". In 2022, Pakistan was taken off the FATF grey list, boosting the country's reputation among its lenders, a position necessary for a crisishit economy. The source reportedly also said that India will oppose the upcoming World Bank funding for Pakistan.

The move comes in the backdrop of the recently heightened tensions between the two nuclear-armed neighbours.

Meanwhile, the International Monetary Fund (IMF) justified its \$1 billion bailout to Pakistan and said that Islamabad "met all the required targets" to receive the latest loan instalment.

Under the Extended Fund Facility programme, which was approved in September 2024, Pakistan has received around \$2.1 billion.

Earlier, Army officials confirmed that additional troops have been deployed to the region to support the ongoing counter-terrorism operation, which aims to neutralise the hiding militants.

Other office bearers picked in the meeting are: Gurmeet Singh Mitta as Senior Vice President, Gurbir Singh as Vice President, Angrez Singh as General Secretary, and Balwinder Singh as Ioint Secretary.

Apart from them, Karnail Singh, Palwinder Singh, Kuldeep Singh Multani, Rupinder Singh, Jagtar Singh Maan, and T.P. Singh were chosen as members of the committee. However, a section of Sikh community leaders objected to Jhinda's election, alleging government interference, as leaders Uttaradhikar Singh Navi, Baldev Singh Kampura, and Prakash Singh Sahuvala opposed Jhinda's appointment, calling it a "murder of democ-

The opposing leaders claimed that interim president Sardar Jog Singh received an anonymous phone call, after which Jhinda was forcibly declared president without holding any elections.

The meeting started around 12 noon in the Diwan Hall of the Gurdwara and went on for nearly two hours. All present members discussed the appointments, and a consensus was reached in fa vour of Jagdish Singh Jhinda. Joga Singh was elected as the Protem Chairman to lead the session.

WAR WITH PAK FAR FROM OVER: FORMER NSA NARAYANAN

he former National Security Adviser (NSA) MK Narayanan says the war with Pakistan has only just begun. "Our war with Pakistan is far from over. It is only the beginning," Narayanan said at an event organised by the Indian Chamber of Commerce in Kolkata. "Operation Sindoor was an example of what we can do. It was not the end."

He further expressed confidence in the Indian armed forces, saying that India could have "done many more things" than just targeting terror bases. "We could have done many more things, lots of lives could have been lost, but what we are demonstrating

is that we are a responsible and big power, and we are not frightened, and we will hit back," he said.

Earlier in the day, Narayanan attended an ICC event, titled "Global and Regional Geopolitics, Security and Economics-in a World of Uncertainty".

The 91-year old Narayanan, who had served as the NSA from 2005 to 2010 and as the Governor of West Bengal (2010-14), said India should be cautious about the rise of Asim Munir, Pakistan's chief of army staff.

"Pakistan is a country which is at war with itself. Troubles in Balochistan and elsewhere are getting stronger while new flash-points are emerging. The spectre of military rule in the country again is looming. The political strength in the country is with the army. The military influence has been Pakistan's bane for several decades." Narayanan said.

A week before the attack in Pahalgam, Munir had stressed on the differences between India and Pakistan at a speech in Islamabad, which Narayanan believes should set the alarm bells ringing in India.

"He had said, our religion is different, our customs are different and our traditions are different. He poses a direct threat to us. Pakistan is an implacable foe for India. No everlasting peace is possible in the region. The army chief who is the de facto leader of the country is expressing his views in no uncertain terms. We cannot lower our guards," Narayanan said.

Reminding of India's prin-



cipled stand on "No first use" of nuclear arsenal, Narayanan said: "Any nuclear confrontation with Pakistan would be catastrophic, unleashing devastation on a scale that would transcend borders and generations."

The former NSA believes China is more of a civilisational threat for India.

"We are two great civilisations. We can't afford a war

with China. I believe China does not want a war. Rather it wants acknowledgment as the major civilisation in this part of the world. We can manage that situation," he said. "China, propelled by civilizational imperatives, engages in calibrated provocation rather than overt hostility. India needs a diplomatic strategy that blends resolve, prudence,

and confidence in the depth of our civilizational ethos. Narayanan feels Sheikh

Hasina's forced ouster from Bangladesh was a setback for India.

"The eclipse of Sheikh Ha-

sina's regime is a major setback. I believe Bangladesh is an integral part of India. Bangladesh is a microcosm of India. We cannot afford to lose Bangladesh. In whatever way we can, we have to keep Bangladesh. That side has a more vibrant history than this part of Bengal. Their voice needs to be attended to. Everyone has problems with neighbours, and it is for the bigger countries like India to show a degree of magnitude," he said.

Hasina fled Bangladesh last August and has been in exile in India, while Bangladesh is administered by an interim Government. The chief adviser Mohammad Yunus, according to reports in Bangladesh media, has expressed his desire to quit. Yunus and the interim Government is under pressure from both the political parties and the Bangladesh Army to hold national elections by the end of this year.

Narayanan was also critical of Israel's continued engagement in Gaza, which he said should be called out.

"You cannot accept the pogrom going on in Gaza. India's greatness lies in the fact that we do not want people to be killed. Therefore, no hesitation in saying Israel is committing genocide. Israel's domination cannot be at the cost of human lives," he said. "How India is going to maintain its friendship with Israel on one hand and the West Asian countries on the other, is a question that will torment us for some time."

Narayanan said in the present times, the international order is in great danger.

"The US is no longer a bulwark of democracy. Europe is wallowing in self-pity. Europe is in shambles and cannot protect itself. Europe wants the vestiges of power without the strength," Narayanan said.

Narayanan said the advent of AI had altered the nature of war and the role of the military.

"Into a blind darkness they enter who are devoted to ignorance; but into a greater darkness they enter who engage in knowledge of deity alone," Narayanan signed off quoting from the

33 Naxalites surrender in Chhattisgarh's Bastar region

As many as 33 Naxalites, among them 24 carrying a cumulative bounty of Rs 91 lakh, surrendered before security forces in Chhattisgarh's Bastar region on Friday, police said. The surrender came days

The top court in July, 2023 sought a response from the Centre on the then AAP government's plea challenging the Government of National Capital Territory of Delhi (GNCTD) (Amendment) Act, 2023 which created an authority for transfer and posting of Group-A officers in Delhi. The Act, initially an ordinance, came a week after the Supreme Court handed over the control of services in Delhi excluding police, public order and land to the elected government.

It envisages to set up a National Capital Civil Service Authority for the transfer of and disciplinary proceedings against Group-A officers from the Delhi, Andaman & Nicobar, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Civil) Services (DANICS) cadre. Another such case was against a decision of the Commission (DERC)

NGT, which was stayed in July 2023 by the top court.

Sood orders to implement 'Summer Action Plan' in Delhi Fire Services meet

Delhi Home Minister Ashish Sood chaired a crucial meeting of the Delhi Fire Service at the Delhi Secretariat today. The session was attended by the Principal Secretary of the Home Department, the Director of Delhi Fire Service, and other senior officials. The discussions focused extensively on the department's operations and future development strategies. Sood instructed officials to diligently implement the existing Summer Action Plan.

Following the meeting, the Minister stated that comprehensive discussions were held on the



administrative and financial frameworks of the department, with particular emphasis on the need to expand manpower. He also highlighted ongoing efforts to modernize the force with advanced technology and the procurement of new fire engines that will feature a combination of indigenous and international technolo-

The Director of the Delhi Fire Service briefed the Minister on the department's current infrastructure, noting that Delhi has 65 fire stations, 311 fire units, and a total workforce of 2,420 personnel. He added that steps are being taken to reduce staff working hours to improve overall efficiency and productivity.

Minister Sood also revealed that the meeting addressed the proposed signing of a Memorandum of Understanding (MoU) between the Directorate General of Civil Defence & Fire Services (Ministry of Home Affairs), the National Centre for Good Governance, and the Delhi Fire Service. This agreement aims to upgrade the service through technological integration, amendments to the Fire Services Act, and the adoption of globally recognized facilities.

Recognizing Delhi's growing population, the Minister emphasized the need to incorporate modern firefighting technologies.

He stressed the importance of deploying smaller fire vehicles in densely populated areas and bustling markets to ensure quick access during emergencies. A rapid response mechanism is essential to reduce casualties during fire incidents,

121 Bangladeshi nationals residing illegally in Delhi to be deported

The Delhi Police has detained 121 Bangladeshi nationals for allegedly residing unlawfully in India with their deportation process being initiated through the Foreigners Regional Registration Office (FRRO), an official said on Friday.

The illegal immigrants were rounded up in a week. the official further stated, adding that five Indians were interrogated in the

"A case has also been registered at the Narela Industrial Area police station to probe a suspected syndicate allegedly involved in facili-



tating the illegal entry and stay of foreign nationals in the country," Deputy Commissioner of Police (outer north) Nidhin Valsan said.

Five Indians have been interrogated in connection with the case, one of whom has been served a notice under Section 35(3) of the Bharatiya Nagarik Suraksha Sanhita (BNSS). he added.

A police team carried out an extensive verification drive over the last week, during which documents of 831 suspected Bangladeshi nationals were scrutinised. "As many as 121 individuals were found residing in the country without valid documentation," the DCP said. A case has been registered under relevant sections of the Bharatiya Nyaya Sanhita (BNS), along with Sections 14 (penalty for contravention of provisions of the Act, etc.) and 14C (penalty for abetment) of the Foreigners Act, 1946, to investigate the syndicate responsible for facilitating illegal entry and residence of immigrants, the officer added.

A Special Investigation Team (SIT) is probing the matter.

Four teenage cousins drown in Delhi's Munak canal

Four teenage cousin brothers drowned after being swept away by strong water currents while they were sitting on the side of Munak canal in outer north Delhi, an official said on Friday.

The incident occurred around 12 pm on Thursday in the Munak canal, which carries water from Harvana to Delhi, he said, adding that the bodies of all four teenage boys have been recovered.

The official said that the



boys were aged between 13 and 18 years.

"Today around 12 pm near Munak canal, which flows from Haryana to Delhi, Waqil came to collect fodder

for the gaushala. He was accompanied by six children: his two sons, his brother-inlaw's son, his brother's son and two other children." said Deputy Commissioner

of Police (Outer North) Nidhin Valsan on Thursday. While the police earlier

said that the boys had entered the canal for a swim, they later stated that it was an accident. Four of them, including Waqil's two sons, his brother-in-law's son and his brother's son, were sitting on the side of the canal when one of them got swept away, a police source said. The remaining three jumped in to rescue him, but all four were carried away by the strong currents, he added. Earlier on Thursday, two bodies were recovered while efforts were on to locate the remaining boys.

"Two more bodies were recovered today by the rescue teams, including personnel from the fire brigade, local police and disaster response units. Two bodies had already been recovered on Thursday," the officer said, adding that the bodies have been sent for postmortem examination.

A case under relevant sections has been registered and further inquiries are underway, police said.

Delhi Govt to deploy anti-smog gun trucks across industrial areas

Aiming to improve the city's air quality, the Delhi Government is set to deploy eight GPSenabled hydraulic anti-smog gun vehicles across key industrial areas of the national capital, with the initiative to continue for ten months, excluding the monsoon period, officials said Friday.

The programme will run for 10 months, excluding the monsoon period, with the goal to significantly reduce airborne particulate matter and improve the air quality.

Each CNG-operated truck is equipped with an advanced anti-smog gun capable of spray-



ing a fine mist over a horizontal distance of 30 meters and rotating 330 degrees, allowing comprehensive dust suppression, Delhi Environment Minister Manjinder Singh Sirsa said. He added that the vehicles also feature horizontal sprinklers along their width to spray water directly onto roads, consuming at least 1,500 litres of water per hour.

currently around 19,200 lockers have been installed across these stations, with each location featuring a grid of 83 to 90 lockers managed through a central digital console, said DMRC Principal Executive Director Anuj Dayal. Dayal said the lockers come in three sizes -- small, medium and large -- and can be rented at Rs 20, Rs 30 and Rs 40 per hour respectively. The DMRC has collaborated with AutoPe Payment Solutions for this service.

"Commuters can store anything that fits the locker and clears security, from bags and tiffin boxes to e-commerce parcels and partner courier agencies handle delivery, removing the need for visits to post offices or cou-

via the Momentum 2.0 app, which generates a PIN code for secure drop and pick-up. Lockers can be rented for one to six hours and a penalty is charged for exceeding the booked duration, he added.

Dayal further said "this service is similar to the cloakroom system in the Indian Railways, but driven by a digital platform aimed at enhancing commuter convenience".

The guidelines were issued to ensure public safety and the scientific management of trees, for which online applications and photographic evidence were mandated.

Any individual, government agency, civic body, RWA, or organisation seeking to prune tree branches with a girth of 15.7 cm or more must now apply through the e-Forest portal.

For light pruning, where the branch girth is less than 15.7 cm, no prior permission is required. However, the pruning agency must upload before-and-after photographs on the portal for documentation, the SOP states.

On a weekly basis, the BSE benchmark dropped 609.51 points or 0.74 per cent and the Nifty declined 166.65 points or 0.66 per cent.

India and the United States are poised to sign the first tranche of the muchanticipated Bilateral Trade sues related to goods trade, Agreement (BTA) before with India pushing for con-July, according to sources who spoke to ANI.

Sources revealed that a round of meetings with the United States Trade Representative has already concluded.

Officials from both nations have discussed various iscessions on labour-intensive exports such as leather and textiles. Service sector issues have also featured prominently in the discussions.

"We want to increase our

exports and preserve what we are already exporting," a source familiar with the negotiations told ANI. "The BTA with the US will be a win-win deal for both countries".

The sources indicated that India remains protective of sensitive sectors, particularly agriculture and dairy products. A key Indian demand is a full exemption from the 26 per cent tariff imposed on certain goods.

"Negotiations are proceeding on a very positive note, and we expect to conclude the agreement before the sunset clause set by the US, which expires on July 8," one of the sources added.

The India-US trade deal would mark a significant milestone in economic relations between the world's ing to more than double total largest and fifth-largest economies, potentially opening new avenues for bilateral commerce and investment.

For the fourth consecutive year in 2024-25, the US was India's largest trading partner, with bilateral trade valued at USD 131.84 billion. India had a trade surplus of USD 41.18 billion in goods in 2024-25.

During the recent meeting between President Donald Trump and Prime Minister Narendra Modi in February, the two leaders resolved to expand trade and investment to make their citizens more prosperous, nations stronger, economies more innovative, and supply chains more resilient.

They resolved to deepen the US-India trade relationship to promote growth that ensures fairness, national security and job creation. To this end, the leaders set a bold new goal for bilateral trade - "Mission 500" - aimbilateral trade to USD 500 billion by 2030. Beyond the US talks, sources mentioned that trade negotiations with the European Union are also underway, and they expect an early harvest.

"Reliance has invested around Rs 30,000 crore in the region in the past 40 years. In the next five years, we will more than double our investments, with our target at Rs 75,000 crore," he said.

This will create over 2.5 million direct and indirect employment opportunities as the conglomerate aspires to touch the lives of most of the 45 million population in the North-East.



TRAILBLAZER GEETA SAMOTA: FIRST CISF WOMAN TO CONQUER EVEREST

n a landmark achievement that exemplifies human endurance. indomitable courage, and unwavering determination, Geeta Samota, a woman sub-inspector of the Central Industrial Security Force (CISF), successfully scaled Mount Everest, becoming the first CISF woman officer to reach the world's highest peak at 8,849 meters (29,032 feet). On the morning of May 19, 2025, as she stood atop the "Roof of the World," it was not just a personal triumph but a powerful symbol of CISF's strength and India's boundless spirit.

HUMBLE **BEGINNINGS, BOLD ASPIRATIONS**

Geeta's journey began in Chak village in Rajasthan's Sikar district, where she was born into a modest family with four sisters. Raised in a traditional rural environment, her early years were shaped by the simplicity and hardships of village life. Despite societal limitations, Geeta harbored dreams far beyond what her surroundings allowed. She often wondered why stories of achievement seemed reserved for boys. This thought planted the seeds of ambition that would later bloom into extraordinary success.

From an early age, Geeta showed keen interest in sports and was a promising hockey player during her college years. Unfortunately, a serious injury cut short her budding sports career. What seemed like a setback turned out to be a turning point, redirecting her energies toward a new path — one that would eventually lead her to the highest peak on Earth.

A New Direction: Entering CISF and Mountaineering In 2011, Geeta joined the Central Industrial Security Force (CISF). In her early years of service, she noticed that mountaineering was a largely unexplored domain within the force, which at the time lacked a dedicated mountaineering unit. Rather than seeing this as a limitation, Geeta viewed it as an opportunity.

Her vision took a significant step forward in 2015 when she was selected for a six-week basic mountaineering course at the ITBP Training Institute in Auli, Uttarakhand. Remarkably, she was the only woman in her batch. Her performance during this rigorous training was exemplary and ignited a passion that would define her future. She followed up with advanced mountaineering training in 2017, becoming the first and only CISF officer to complete the course at the time.



SCALING NEW HEIGHTS

Geeta's grit and mountaineering prowess bore fruit in 2019 when she became the first woman from the Central Armed Police Forces (CAPF) to successfully summit Mount Satopanth (7,075 meters) in Uttarakhand and Mount Lobuche (6,119 meters) in Nepal. Her dream of

scaling Everest almost came true in 2021, when she was selected as a core member of the CAPF's Everest expedition. However, the mission was canceled due to technical reasons — a moment that could have discouraged

But for Geeta, this disappointment became motivation. Instead of stepping back, she set her sights on an even bigger goal: the "Seven Summits" challenge, which involves climbing the highest peak on each of the seven continents - one of the most prestigious accomplishments in global mountaineering.

THE SEVEN SUMMITS **JOURNEY**

Despite the global COV-ID-19 pandemic and its accompanying hurdles, Geeta remained steadfast in her commitment. Between 2021 and early 2022, she climbed four of the Seven Summits: Mount Kościuszko (2.228)

- meters), Australia • Mount Elbrus (5,642 me-
- ters). Russia • Mount Kilimanjaro (5,895
- meters), Tanzania Mount Aconcagua (6,961

meters), Argentina She achieved these feats in just six months and 27 days,

becoming the fastest Indian woman to make such progress on the Seven Summits expedition — a remarkable demonstration of her physical and mental resilience, discipline, and determination.

Adding to this incredible record, she completed an extraordinary feat in Ladakh's remote Rupshu region, where she scaled five peaks in just three days three of which were above 6,000 meters and two above 5,000 meters. With this, she became the first and fastest woman mountaineer to achieve such a feat in the region, further solidifying

Geeta's outlook is as powerful as her achievements. She says, "Mountains treat everyone equally — they don't discriminate based on gender. Only those with an 'X-factor' within can reach the top." Her message is clear and bold: dream big, work hard, and never give up. For young girls across the

country, she is more than a mountaineer - she is a beacon of hope, courage, and limitless possibility.

Her Everest success is not just a personal or organizational milestone, but a national inspiration. She has not only shattered altitude records but has also challenged deeply rooted societal norms about gender roles in adventure, defense, and leadership.

INSTITUTIONAL SUPPORT AND THE ROAD AHEAD

The CISF has played a crucial role in enabling Geeta's dreams, providing her opportunities for training at premier institutes like ABVI-MAS in Manali and financial and logistical support for international expeditions. Her success has now inspired the CISF to consider launching a full-fledged Everest expedition in 2026, marking the beginning of a new chapter for the force in high-altitude adventure and endurance

The Director General of CISF, along with all officers and personnel, have extended heartfelt congratulations to Geeta Samota for her historic Everest conquest. Her journey has brought pride not just to CISF but to the entire Central Armed Police Forces (CAPF) community and the nation.

Illegal immigrants are threat to security of country

After the Pahalgam attack, illegal immigrants are once again in the news. Considering them a threat to the internal security of the country, a special campaign is being run against them. Union Home Minister Amit Shah had instructed all state governments to identify foreign nationals and send them back. After this, the work of driving out illegal immigrants was started in all states including Gujarat and Rajasthan. How dangerous these illegal Bangladeshi citizens are for the security of the country can be gauged from the statement of Gujarat's Home Minister Harsh Sanghvi. He said that many of the illegal Bangladeshi citizens were involved in drugs and human trafficking. Two of the four Bangladeshi citizens arrested worked as sleeper cells of Al Qaeda. News of illegal Bangladeshi citizens reaching many cities and towns of Rajasthan has started coming.

The extradition campaign of illegal Bangladeshi citizens is the result of increased security concerns after the Pahalgam terrorist attack. In 2010, a session titled "Illegal Bangladeshis in India: Impact on Internal Security" was organized by Manohar Parrikar Institute for Defence Studies and Analysis under the chairmanship of Ajit Kumar Doval. Illegal migration to India and its impact were discussed in detail. In that session, it was revealed that between one and two crore illegal Bangladeshis are living in India. This is more of a threat to the internal security of the country than a burden on India's resources. In 2004, the then Minister of State for Home Affairs, Shriprakash Jaiswal, had told the Parliament that about one crore twenty lakh illegal Bangladeshis are living in the country, out of which 57 lakh are in West Bengal alone. However, this



figure later became contro-

versial. According to many reports, this number can go up to two crore. Along with illegal Bangladeshi citizens, a large number of Rohingyas are entering India after the internal conflict in Burma and are becoming a challenge for law and order. There are reports of clashes between Rohingyas and local citizens in many parts of the country. Illegal Rohingyas have also become a problem for the local administration. According to some reports, about 75 thousand Rohingyas are living illegally in India. But this number has increased rapidly in the last few years. These people are mainly settled in Delhi, Jammu, Hyderabad, Nuh and other cities. In the last few years, the role of Rohingyas in the law and order situation in Delhi has been suspicious. The previous government of Delhi had a special kind of affection towards the Rohingyas, which many parties including BJP have been criticizing.

Let us take a look at Bhutan, a small and beautiful country located in the northeast of India. It is among those eight countries of the world where it is very difficult to obtain citizenship. Sangh chief Mohan Bhagwat had said in the year 2014 that illegal immigrants are causing population imbalance, which is a threat to national security. Many such parts have emerged in the country which are tacitly called mini Bangladesh. Apart from this, the Sangh has emphasized the need to implement the National Citizen Register across the country so that illegal immigrants can be identified and expelled from the country. The Supreme Court also recently ruled that only Indian citizens have the right to live in India and Rohingya Muslims do not have this right. This has cleared the way for the deportation of the Rohingya community. In the Citizenship Act 1955, the government was asked to create a national register to identify every citizen of the country. The government should ensure the identification of Indian citizens through the National Register of Citizens (NRC). Experts believe that a holistic policy is needed to deal with the problem of illegal migration. This includes strengthening border security, identification and registration of illegal migrants and repatriation agreements with their countries

HOW IRAN-US NUCLEAR NEGOTIATIONS COULD REDEFINE THE FUTURE OF NUCLEAR DIPLOMACY

Iran and the U.S. resumed indirect nuclear negotiations, aiming to limit uranium enrichment and ease sanctions, despite mutual distrust and regional tensions.

s the United States and Iran prepare to resume nuclear negotiations for the fifth time this year, the world watches with bated breath. Set in Rome, the latest round of diplomacy marks a critical juncture—not only in the decades-long animosity between the two nations but also in the evolving architecture of global nuclear governance. With U.S. Special Envoy to the Middle East, Steve Witkoff, and Iran's Foreign Minister Abbas Araghchi leading their respective delegations, the outcome of these talks could redefine the direction of nuclear diplomacy, reshape Middle Eastern security, and challenge the future of the **Nuclear Non-Proliferation** Treaty (NPT) itself.

FROM COOPERATION TO CONFRONTATION

Iran's nuclear story is paradoxical. In 1957, under the U.S.-led "Atoms for Peace" program, Iran signed a nuclear cooperation agreement with Washington. The deal allowed Iran to acquire civilian nuclear technology and laid the groundwork for what was initially a mutually beneficial partnership. This was further formalized when Iran became a signatory to the NPT in 1968 and

ting to using nuclear energy only for peaceful purposes. However, the Islamic Revolution in 1979 dramatically shifted Iran's political landscape. The new regime viewed nuclear capability not just as a technological achievement but as a matter of national sovereignty and security. Iran's cooperation with the International

Atomic Energy Agency

(IAEA) declined sharply,

raising red flags globally. By the early 2000s, the Iranian nuclear program had expanded significantly. Enrichment facilities like the Natanz Enrichment Plant came online, and Iran began to assert its right to develop nuclear technology under the NPT framework. But suspicions arose over Iran's true intentions, with Western nations alleging that Tehran was secretly pursuing nuclear weapons capability—a claim Iran has consistently denied.

SANCTIONS. **ISOLATION, & GLOBAL BACKLASH**

Iran's nuclear advancements triggered a wave of international concern. The IAEA's limited access to Iranian facilities and Tehran's lack of transparency intensified fears that the Islamic Republic was edging closer to weapons-grade enrichment. The response from the international community, particularly the West, was swift and punitive.

The United Nations, European Union, and United States imposed multiple rounds of economic sanctions targeting Iran's energy, banking, and trade sectors. These measures crippled the Iranian economy, leading to inflation, unemployment, and a severe reduction in oil exports. Simultaneously, regional actors, especially Israel, viewed Iran's nuclear program as an existential threat. Tel Aviv warned of preemptive military strikes and actively lobbied against any leniency toward Iran.

JCPOA: A BREAK-THROUGH AGREEMENT

In 2015, diplomacy seemed to triumph over confrontation. After years of negotiation, Iran reached a landmark agreement—the Joint Comprehensive Plan of Action (JCPOA)—with the P5+1 (United States, United King-

Under the JCPOA, Iran agreed to limit uranium enrichment to 3.67%, reduce its stockpile of low-enriched uranium to 300 kilograms, and cap the number of operating centrifuges. Importantly, Iran allowed the IAEA to conduct regular and intrusive inspections, providing unprecedented access to its nuclear sites.

For a time, the JCPOA was hailed as a diplomatic victory, a model for resolving complex nuclear disputes. Iran complied with its obligations, and sanctions relief offered a glimmer of economic hope. However, the breakthrough was short-

Collapse and Escalation In 2018, then-President Donald Trump unilaterally withdrew the United States from the JCPOA, branding it as a "terrible deal." Washington reimposed stringent sanctions under a "maximum pressure" campaign.

the negotiating table under more favorable terms. Iran responded by gradually breaching the deal's limits, accelerating its enrichment program, and reducing cooperation with the IAEA.

By 2021, Iran had enriched uranium to 60% purity just below weapons-grade and expanded its nuclear infrastructure with support from allies like China and Russia. This escalation alarmed the international community and effectively placed the JCPOA on life support. The resulting stalemate persisted through multiple failed diplomatic overtures under President Joe Biden, as Iran continued to insist on full sanctions relief before returning to compli-

NEW TALKS, FAMILIAR STAKES

In a surprising move during his second presidential term, Donald Trump has returned to the table, signaling a willingness to restart negotiations. This time, however, the tone is markedly different. Trump has coupled diplomatic outreach with threats of military action, and Israel is actively involved in strategic consultations.

COLLAPSE OF NON-PROLIFERATION NORMS

The JCPOA was not just about Iran; it was a test case for the global non-proliferation regime. Its failure weakens the credibility of the NPT and the authority of the IAEA. If Iran is seen as able to defy international norms with impunity, other countries might follow suit, undermining decades of non-proliferation efforts.

NEW GLOBAL ALLIANCES

As Iran turns toward China and Russia, a new geopolitical axis may be emerging. This shift could deepen the divide between Western powers and Eastern autocracies, leading to a more fragmented global order. Nuclear diplomacy might increasingly become a tool of great-power competition rather than a collaborative security framework.

RISK OF MILITARY CONFLICT

Military escalation re-

mains a very real threat. Israel has repeatedly stated that it will not allow Iran to acquire nuclear weapons, even if it means acting unilaterally. Any military strike could spiral into a broader regional conflict, drawing in U.S. forces, Hezbollah, and even Gulf states.

Diplomacy or Deterrence? The negotiations in Rome represent far more than just another round of U.S.-Iran diplomacy. They are a test of the international community's ability to resolve one of the most complex and dangerous nuclear dilemmas of our time. The choices made now could set the tone for global nuclear politics for the next decade.

If a new agreement is reached, it could restore trust in multilateralism. revitalize the NPT framework, and ensure greater stability in the Middle East. If talks fail, the world may witness a new era defined not by cooperation and containment, but by proliferation and confrontation. In the end, the question remains: will diplomacy prevail, or will the world edge closer to a nuclear flashpoint?

Brexit reset was always inevitable – The damage demands repair

Prime Minister Keir Starmer's tentative steps toward repairing Britain's relationship with the European Union have sparked fierce criticism from the very architects of Brexit. Simon Jenkins, writing in The Guardian, exposes the political hypocrisy and national cost of a project that, from the beginning, was doomed to economic and diplomatic regression. Now, as the dust settles on years of missteps, the painful process of reconnection begins-not as a political betrayal, but as a necessity born of reality.

HYPOCRISY AND WASTED BILLIONS

Tory outrage over Starmer's Brexit reset is steeped in irony. The same government that pushed a hard Brexit spent £4.7 billion on post-EU border infrastructure, most of which is now obsolete. The Sevington checkpoint in Kent, hailed as a symbol of sovereignty, stands as a testament to bureaucratic excess and futility. Jenkins suggests memorial plaques be placed on these abandoned structures to mark the follyand the former Prime Minister who inspired it.

STARMER'S OWN ROLE

Yet Ienkins is no blind defender of Labour either. He recalls how Starmer, as Jeremy Corbyn's shadow Brexit secretary in 2019, helped scuttle Theresa May's softer Brexit proposal. By siding with ideological purism over



pragmatic compromise, Labour enabled Johnson's ascent and the entrenchment of hard Brexit. This allowed a narrow, extreme vision of departure to define the next decade of British politics.

A MISGUIDED EXIT

Immigration—not economic autonomy—was the driving force behind the Leave vote in 2016. Polls at the time showed that few voters were motivated by opposition to the EU's economic structures. The idea of a hard Brexit was manufactured by Boris Johnson and his allies as a power play, not as a genuine policy proposal. The campaign misled the public, promising benefits that have never materialized.

Today, the economic damage is irrefutable. Official and independent analyses agree that Brexit has cost the UK tens of billions of pounds, slowing growth and weakening public services. Trade deals with farflung nations cannot replace the ease and volume of commerce lost with the EU.

POLITICAL FARCE AND REBUILDING

Reactions to Starmer's recent concessions-on EU food

standards, fishing access, and youth mobility-have been predictably theatrical. Figures like Nigel Farage decry them as surrenders, even as they benefit personally from EU privileges. Farage himself was reportedly spotted using an EU e-gate on his way to a holiday in France—a moment that typifies Brexit as political

theatre rather than serious

governance.

Britain's weakened negotiating position means concessions are inevitable. The EU remains the larger market and a more powerful bloc. Any trade relationship must reflect that imbalance. Jenkins argues this isn't about surrender but about pragmatism.

LEARNING FROM THE

Jenkins admits he once favoured a looser trade relationship over EU membership but now sees that view as shortsighted. The EU brought half a century of stability to Western Europe. Thatcher was right to push for the single market, just as Major and Blair were wise to avoid deeper integration and the euro. Britain has always functioned best with a semi-detached role-not the

complete rupture delivered by Brexit.

CHANGING LANDSCAPE

Two key shifts now define the post-Brexit reality. First, immigration concerns—once central to Leave rhetoric-now require international cooperation, as all of Europe grapples with rising flows. Second, Britain's immigration today is mostly legal, government-approved, and driven by labour shortages—many created by Brexit itself. The idea that Brexit would reduce immigration was always a myth.

Public opinion reflects this disillusionment. A growing majority-55%, according to recent polls—now believe Brexit was a mistake. Only around 30% of people still support it. The consequences are visible: a decline in farming, manufacturing, academia, tourism, and even the arts. British orchestras have cancelled European tours. Small businesses have struggled with customs. Britain has isolated itself more than any other non-EU European nation.

MOVING FORWARD

The path back will be slow. The EU owes Britain no favours after years of antagonism. But with public sentiment shifting and economic pressures mounting, movement is inevitable. Jenkins calls for a return to civil and commercial cooperation with Europe-not necessarily full re-entry into the EU, but a serious restora-

Trump seeks to end longstanding protections for migrant children

is once again attempting to dismantle the Flores Settlement Agreement (FSA)—a pivotal legal safeguard that has protected immigrant children in U.S. federal custody for nearly three decades. This latest move, revealed in court documents filed on Thursday, signals a renewed effort to strip away rules that limit how long and under what conditions migrant children can be detained by federal immigra-

The Flores Settlement Agreement dates back to 1997 and is named after Jenny Flores, a Salvadoran teenager who sued the federal government in the 1980s over the mistreatment of minors in detention. The agreement has since become a cornerstone of immigration policy regarding children, setting minimum standards for their care while in custody and limiting the time they can be detained—typically no more than 72 hours before being transferred to childappropriate facilities operated by the Department of Health and Human Services

WHY IS THE TRUMP **ADMINISTRATION TARGETING THE FSA?**

Government attorneys argue that the Flores Agreement has become an "intrusive regime" that no longer serves the purpose it once did. They claim that it has "ossified" immigration policy, making it difficult for federal agencies to respond effectively to evolving migration trends. In the motion to terminate the agreement, they also contend that the FSA has inadvertently encouraged families to migrate unlawfully, believing that children provide a sort

longed detention.

"The FSA itself has changed the immigration landscape by removing some of the disincentives for families to enter the U.S. unlawfully," the administration wrote in its filing, as reported by the Associated

ADVOCATES PUSH

BACK

Immigration and child welfare advocates have expressed alarm over the attempt to dismantle what they see as a vital human rights protection. Sergio Perez, executive director of the Center for Human **Rights and Constitutional** Law, condemned the move, calling it a "lawless step" that puts vulnerable children at risk.

"Children who seek refuge in our country should be met with open arms — not imprisonment, deprivation, and abuse," Perez said in a statement. "Ending the Flores protections sacrifices accountability and decency for the sake of a political agenda that demonizes migrants.'

WHAT HAPPENS NEXT?

The Trump administration's motion to terminate the FSA will be reviewed by Chief U.S. District Judge Dolly Gee, who has overseen compliance with the agreement for years. A hearing on the matter is expected in mid-July, according to a joint filing by both the government and child advocates.

As the legal battle plays out, the future of how the U.S. treats immigrant children at its borders hangs in the balance. For critics of the move, the attempt to end Flores marks not just a shift in immigration policy—but a fundamental test of America's commitment to human

TEL AVIV: An Israeli military investigation into Hamas' October 7 attack on Kibbutz Kissufim and the nearby Kissufim army base found glaring failures in the Israel Defense Forces' preparedness. The report, released on Thursday, found that soldiers, trained primarily for combat in Gaza's open areas, were ill-prepared for fighting within a civilian setting.

Forty-five people -- mostly soldiers, but several civilians and Thai workers were killed during an assault by about 150 terrorists from two of Hamas's elite Nukhba Force battalions. The report highlighted how the absence of specialized training and clear operational protocols for urban warfare led to serious tactical errors, including "two-sided shooting" incidents, where IDF troops fired on each other and at fellow civilians. In one case, Tom Godo, a 52-yearold civilian, was killed after soldiers heard Arabic nearby and opened fire without confirming the source -- only later realizing it came from a neighboring Israeli home.

Bangladesh's interim government chief Muhammad Yunus is mulling resignation as he is finding it difficult to work in view of political parties failing to reach a common ground to bring a change in the country, according to a media report.

Student-led National Citizen Party chief Nhid Islam was quoted that Yunus is apprehensive over the evolving political situation in the country and whether he will be able to carry on with his work.

"He (Yunus) said he is thinking about it (resignation). He feels that the situation is such that he cannot work," Islam said on Thursday night after he met with the 84-year-old leader.

Islam said he went to meet Chief Adviser Yunus after hearing throughout the day about the speculation of his resigna-

"Sir (Yunus) said, 'If I can't work... I was brought here after a mass uprising to bring change and reform to the country. But in the current situation, with mounting pressure from movements and the way I'm being cornered, this isn't how I can work," Islam told the media.

Another media report referring to unnamed sources close to Yunus said he actually threatened to resign if political parties do not give him their backing and expressed his desire to quit at a cabinet or advisory council meeting earlier on

Islam told the THE MEDIA that he urged Yunus "'to stay strong for the sake of the country's security, and future and to meet the expectations of the mass uprising' (and) I hope everyone will cooperate with

Islam, one of the key coordinators of the Students Against Discrimination (SAD), who previously served as one three representatives of the platform in the interim government's advisory council or cabinet, quit his office to lead the NCP that emerged in February this year visibly with Yunus's blessings.

The SAD led the July uprising last year forcing the ouster of prime minister Sheikh Hasina's Awami League regime on August 5, 2024.

Three days later Yunus, a Nobel Peace Prize winner for experiment of microfinance, flew from Paris to take charge.

US, Iran resume nuclear talks in Rome

U.S. and Iranian negotiators have resumed talks in Rome, aiming to resolve a longstanding dispute over Iran's nuclear program. The discussions, led by Iranian Foreign Minister Abbas Araqchi and U.S. Middle East envoy Steve Witkoff, mark the fifth round of negotiations mediated by Oman.

The primary point of contention is Iran's uranium enrichment activities. The U.S. insists that Iran cease all enrichment to prevent the development of nuclear weapons, while Iran maintains that it has the right to enrich uranium for peaceful purposes. Iran's Supreme Leader Ayatollah Ali Khamenei has dismissed U.S. demands to halt enrichment as "excessive and outrageous," suggesting that such conditions could derail the talks.

Kamal said Pakistan will invite U.S. investment in mining projects—particularly in the resource-rich Balochistan provincethrough joint ventures with local firms. These concessions would include favorable lease agreements.

"There is untapped potential for U.S. companies in Pakistan, from mining machinery to hydrocarbon ventures," Kamal noted.

In parallel, Pakistan also plans to increase imports from the U.S., especially in cotton and edible oils, to help narrow the trade gap. The offer of mining concessions is expected to be tabled during upcoming bilateral talks.



While Kamal didn't provide details on the bidding process or specific projects, the proposed initiabroader ambitions to develop its mining sector. Notably, the Reko Diq copper and gold project in Balochistan is seeking up to \$2 billion in financing, including up to \$1 billion from the U.S. Export-Import Bank. The mine could generate an estimated \$70 billion in free cash flow over its life. President Donald Trump has expressed interest in forging "big deals" with both India and Pakistan. Minister Kamal believes the U.S. is now recognizing Pakistan as a serious trade partner, unlike previous administrations which focused primarily on India. Pakistan also plans to gradually reduce tariffs in its upcoming federal budget to encourage trade and investment.

INDIA CONTINUES TO SUSPEND INDUS WATER TREATY; PAK ARMY SHOWS COLLABORATION WITH THE TERROR NETWORK; INDIA RECEIVES SUPPORT FROM UAE AND JAPAN

This week, India has unequivocally communicated to the global community that "Operation Sindoor" has become its standard approach to combating terrorism, and it will persist in its diplomatic surgical strikes against Pakistan. Following India's suspension of the vital Indus Water Treaty with Pakistan, it has been met with various threats from Pakistani officials. Recently, Lashkar Chief Hafiz Saeed also issued a warning to the Indian government, threatening severe repercussions if the ban on the Treaty, which is essential for Pakistan's survival, is not lifted. The Pakistani government has echoed similar sentiments; however, numerous countries, including the UAE and Japan, have voiced their steadfast support for India in its multidimensional fight against terrorism.

This week, India reaf-

firmed its stance that any engagement between India and Pakistan must be bilateral. During a media briefing, External Affairs Ministry spokesperson Randhir Jaiswal stated that discussions and terrorism cannot coexist. He mentioned that India is willing to talk about the transfer of prominent terrorists whose names were submitted to Pakistan several years ago. He emphasized that any bilateral dialogue regarding Jammu and Kashmir will solely focus on the withdrawal of illegally occupied Indian territory by Pakistan. Concerning the Indus Waters Treaty, it was made clear that it will remain suspended until Pakistan credibly and irrevocably renounces its support for cross-border terrorism. This declaration has indeed caused concern in Pakistan.Shaken Pakistani authorities, along with the terrorists, are cur-

This statement resonates with the words of Hafiz Saeed, the leader of Lashkar-e-Taiba, who stated, "If you stop the water, God willing, we will stop your breath, and then blood shall follow in these rivers." Additionally, a recording of Lieutenant General Ahmed Sharif Chaudhry, captured during an event at a Pakistani university, revealed him asserting, "If you block our water, we will choke you." "Terrorism poses a threat not only to a single nation or region, but it is a global menace," stated Al Nuaimi, who chairs the UAE Federal National Council's Defence, Interior and Foreign Affairs Com-

mittee. "We are already collaborating with India on initiatives to combat terrorism. The safety of Indian nationals is non-negotiable. India is a strategic partner, not only with the government but also with its populace."

This is not solely India's battle. The global community must provide a united, efficient, thorough, and appropriate response to terrorism. Political frameworks, governance, and policies are established to enhance the quality of life for individuals. Setting politics aside, nations need to consider what they stand to gain by supporting terrorism. While Pakistan should reflect on the implications of its decisions for its future, countries such as the US must not forget the events of 9/11 and should fully support India.

One can never forget when Ethan (Tom Cruise) was descending into a vault, and how he avoided touching the floor, which could have resulted in devastating events in the very first edition of Mission: Impossible, which has now hit the 8th Installment with the release of Mission: Impossible

- The Final Reckoning, released last week. a 1943 Make the Red bifranchise, known for rman, Gulfstream V, and substantially improving action sequences with every newer installment, is back with spine-chilling action in its latest edition.

Ethan entertains the audience in this edition deep under the seas and equally high up in the skies with fantastic stunts. Watching him entering into a dormant mode submarine vessel



ful woman is a MOM. She may not make the headlines. She may not be quoted in interviews. But behind every woman who dares to dream and do, there is often a mother quietly powering the story.

The Indian mother is an institution. She's the original multitasker, the unpaid therapist, the relentless cheerleader. Sometimes. she raises her daughter to be everything she couldn't be. Sometimes, she quietly pushes her into spaces that scare her. Sometimes, she just listens—and that alone moves mountains. And for working women especially, the role of a mother doesn't stop with childhood. She becomes the fallback system-stepping in for school pick-ups, sick days, missed meals, or simply as moral ballast. In modern urban India, where nuclear families frayed traditional support systems, the mother remains a constant-emotionally and logistically.

In fact, when women are asked "How do you do it all?", many smile and look towards their moms-not just out of affection, but acknowledgment. Because sometimes "behind every successful woman" isn't a mentor or a manager—but a mother, keeping the wheels turning behind the scenes.

Caffeine and pregnancy: What you should know about safe consumption

Caffeine is a natural stimulant commonly found in coffee, tea, chocolate, enerboost alertness and energy, pregnant women need to be particularly cautious about their intake. This is because caffeine can cross the placenta and potentially impact the developing fetus, whose body is not capable of metabolizing caffeine efficiently. As a result, excess caffeine exposure during pregnancy may pose several risks to fetal development. Understanding the safe consumption limits, potential dangers, and hidden sources of caffeine is essential for expectant mothers who want to ensure a healthy pregnancy for themselves and their babies.

Health authorities around the world, including the World Health Organization and the American College of Obstetricians and Gynecologists, recommend limiting caffeine intake during pregnancy to under 200 mg per day. This is equivalent to roughly one standard 12-ounce cup of brewed coffee, one to two small cups (100-150 ml) of coffee, two cups of black tea, four cups of green tea, or one to two cans of cola. Despite these guidelines, studies show that many pregnant women unintentionally exceed this limit, often due to a lack of awareness about caffeine content in various foods and drinks.

There are several reasons why restricting caffeine is particularly important during pregnancy. First, pregnant women metabolize caffeine more slowly than non-pregnant women,

in their system longer. More importantly, caffeine passes through the placenta, but the fetus lacks the necesnormal fetal development. Caffeine has been shown to influence placental blood flow, potentially altering the delivery of oxygen and nutrients to the fetus. It may also elevate maternal and fetal stress hormone levels. further complicating devel-

Another consideration is the genetic variability in caffeine metabolism among women. The enzyme CY-P1A2 is responsible for breaking down caffeine in the body, and its activity is influenced by both genetic and hormonal factors. Some women have slower-acting versions of this enzyme, making them more sensitive to caffeine's effects. As a result, even moderate caffeine intake might pose risks for certain women due to these genetic differences, underscoring the need for more personalized healthcare approaches

Caffeine is not only found in coffee or tea but also in a range of other products. Dark chocolate contains significantly more caffeine than milk chocolate. Energy drinks are especially concerning, as they often have extremely high levels of caffeine and should be avoided entirely during pregnancy. Additionally, some overthe-counter medications, such as certain pain relievers and cold remedies, contain caffeine. This makes it essential for pregnant women to read product labels carefully and consult with healthcare providers before taking any medication.

Managing caffeine intake during pregnancy can be done with a few simple

duce reliance on caffeine. In the future, advancements in genetic testing and precision medicine may allow for more individualized recommendations based on a woman's unique response to caffeine.

FINAL THOUGHTS

While caffeine isn't entirely off-limits during pregnancy, moderation and awareness are key. Keeping daily intake below 200 mg, being mindful of hidden sources, and understanding one's own sensitivity to caffeine can go a long way in supporting a safe and healthy pregnancy.


of our original nature.





Nadal's absence from the 2025 French Open changes the tournament

As the French Open enters a new, post-Rafa, era this year, there are a couple of prevailing sentiments among tennis

players. One is: It's a shame the world won't get to see the King of Clay, as Rafael Nadal came to be called, ply his unique brand of topspinheavy relentlessness on the crushed red brick of Roland-Garros, where he won a record 14 of his 22 Grand Slam

The other, expressed by men who would love to get a chance at carving their own bit of history at the place, goes like this: Whew, it sure

will be nice not to have that guy looming in the bracket now that the 38-year-old Spaniard is retired.

"Luckily - or unluckily - I never got to play him in Roland-Garros," said American Tommy Paul, a 2023 Australian Open semifinalist currently ranked 12th. "It's nice to not have to wor-

ry about him, I guess," Paul added with a laugh. "That's the main thing that comes to my mind." Players repeatedly used the

word "different" to describe what it'll be like without Nadal around.

"It'll be strange for the fans, above all," said top-10 player Lorenzo Musetti, an Italian



who reached the semifinals at Wimbledon and earned an Olympic bronze medal in 2024. "But the history he made in Paris will never be forgotten."

To be sure, Nadal's dominance in Paris was unprec-

"Impossible," defending champion Carlos Alcaraz said, "to repeat."

Nadal collected more championships than any other player at one major tennis tournament, spanning from his first, which arrived two days after his 19th birthday in his 2005 debut, to his last at age 36 in 2022 on a painful foot that required nervedulling injections. He went 112-4 overall in the event.

One measure of just how good Nadal was there is reflected in his head-to-head records against the other two members of the Big Three of men's tennis, Novak Djokovic and Roger Federer. Nadal went 8-2 against Djokovic in the French Open - accounting for about 15% of all of Djokovic's lifetime Grand Slam losses anywhere — and 6-0 against Federer.

"What a legend. What an ambassador for the sport,"

Nadal. "One of the greatest athletes ever - not just in tennis."He certainly left his indelible mark in Paris. A larger-than-life statue was erected near an entrance to the tournament grounds in 2021, while he was still active; a ceremony honoring him will be held Sunday in the main stadium, Court Philippe-Chatrier, after the first three matches of Day 1. One would imagine that Nadal will be treated to the sort of applause and chants

of "Ra-fa!" he heard often, including when he played for the final time at the site - at the Paris Olympics last

And no one who ever faced him, or watched him, at the French Open will forget his lefty whip of a forehand or the way he stood so far back to return serve or the way he chased every ball. Or the way Nadal would bite his trophies after winning one, something Naomi Osaka emulated after claiming her first clay-court title just last month."As a tennis community, everybody's going to miss Rafa, for sure. If I were

thinking about it selfishly, I would say, 'Of course I want to watch Rafa play. Of course I want him to be here," former No. 1 and two-time Australian Open champion Victoria Azarenka said. "But I see it a little bit differently. I look at it as that was his decision. Same with when Serena (Williams) left. Of course I miss Serena; she was my biggest motivator. But they've moved on in their life to what's best for them. And I just have so much respect for what they've done for the sport. How much they contributed. How much they elevated it. My only thing is to say, 'Thank you,' to players like that."
