## **SC PANEL SAYS 'MISCONDUCT PROVED', PROPOSES REMOVAL**

Report says judge and his family members had 'covert or active control' over the store room

### AGENCIES NEW DELH

'igh court judge Yashwant Varma, and his family members had "covert or active control" over the store room where a huge cache of half-burnt cash was found, proving his misconduct which is serious enough to seek his removal, a report of the inquiry panel probing the incident said.

The three-judge panel headed by Chief Justice Sheel Nagu of the Punjab and Haryana High Court conducted the inquiry for 10 days, examined 55 witnesses and visited the scene of the accidental fire that started at around 11.35 pm on March 14 at the official residence Justice Varma, then a sitting judge of the Delhi High Court and now in the Allahabad High Court.

## Procedure as laid down has to be followed

#### JUSTICE (RED.) SAKHA RAM SINGH

The three-member committee, constituted by the then Chief Justice of India vide order dated 22.03.2025 for conducting enquiry into the allegations against Justice Yashwant Verma, the then sitting Justice of Delhi High Court has submitted its report dated 03.05.2025 to the effect that the alleged miss-conduct against Justice Yashwant Verma found proved 'is serious enough to call for initiation of proceedings for removal of Justice Yashwant Verma'.

The question that arises for consideration is as to whether the report can be made the basis for removal of Justice Yaswant Verma. A judge of a high court is not liable to be removed from office save in accordance with the provisions of Article 217(1)(b) r/w the Article 124(4) of the Constitution of India which provides the procedure for Varma removal of a judge of a high court

Indian Institute of Technology (IIT), Delhi is the bestranked Indian institution in QS World University Rankings for 2026 as it climbed more than 70 places in two years to secure the 123rd spot in the coveted list.

With eight new institutions added to the ranking this year, India now has 54 institutions included, making it the fourth most represented country behind only the US (192 institutions), the UK (90 institutions) and Mainland China

(72 institutions). No other country or territory has seen as many universities added to the ranking this year. Jordan and Azerbaijan are second most improved and have both seen six added in

The polling that commenced at 7 am and concluded at 6 pm was largely peaceful, with the exception of a few isolated incidents. officials said

While the deaths of the incumbent MLAs necessitated the bypolls in one seat each in Gujarat, West Bengal and Punjab, the resignation of two legislators led to the polling in Kerala and another seat in Gujarat. At Kaliganj in West Ben-

gal's Nadia district, a voter turnout of 69.85 per cent was recorded till 5 pm.

"Polling has been peaceful. There was no report of any incident from anywhere in and around the constituency. Till 5 pm, the polling was 69.85 per cent," an election official said.



tiah, it added. In line with his "Make in India, Make for the World" vision, Modi will flag off a state-of-the-art locomotive built at the Marhowra plant for export to the Republic of Guinea. This is the first export locomotive manufactured in this factory. "They are equipped with high-horsepower engines, advanced AC propulsion system, microprocessorbased control systems, ergonomic cab designs and incorporate technologies like regenerative braking," the statement said. In line with the goal of the conservation and rejuvenation of the Ganga river, the prime Bharat Express between minister will inaugurate (STPs) under the Namami Gange project worth more than Rs 1.800 crore.

The statement said he will launch several other projects related to water supply and power infrastructure, and release the first instalment of the Pradhan Mantri Awas Yojana (Urban) to more than 53,600 beneficiaries.

Modi will also hand over keys to a few beneficiaries to mark the "Grih Pravesh" ceremony of more than 6,600 completed houses.

Assembly polls are due in Bihar later in the year, with the ruling BJP-JD(U) alliance looking to hold fort against the opposition IN-DIA bloc led by the Rashtriya Janata Dal (RJD).

In Odisha, Modi will launch multiple development projects worth over Rs18,600 crore. The projects will cover critical sectors, including drinking water, irrigation, agricultural infrastructure, health infrastructure, rural roads and bridges, sections of national highways and a new railway line.



According to Tewari, Iran has built significant influence across the region through its "Shia crescent" stretching from Iran to parts of Africa. He added that this makes the fallout of any direct U.S. military involvement even more

complicated. "If the US gets involved directly, Israel will retaliate. The US has a military presence in Iraq and several other countries with Shia populations. There would be implications which even the United States may not be able to control," he said.

## Maize farmers left in lurch as govt vanishes from mkt

According to ground reports in Punjab, farmers are managing to sell their produce only between Rs1,000 and Rs1,300 per quintal. In many areas, private buyers are offering as low as Rs 1,000, less than half the promised MSP.

"Private traders dictate the rates. There is no government presence in the mandis," said a farmer Jasbir Singh of Patiala.

This crisis comes despite a significant increase in the area under maize cultivation in both the states as in Punjab the area under maize has reached to around 30,000 acres whereas Haryana has over 25,000 acres under maize crop this year.

Mandis are flooded with the maize crop in several

Haryana and the recent rainfall has added to woes of the farmers as they were getting to space to unload their crop to get it dry for procurement.

The situation is no better in Haryana. Farmers in grain markets like Ladwa of Kurukshetra say they are being forced to accept whatever rates private traders offer, with no official support

available "I had to sell my crop at Rs 1,250 per quintal as there was no government buyer," said Jai Bhagwan, a farmer from Yamunanagar district. "We switched to maize hoping for better returns as paddy was blamed for depleting groundwater. But in lack of government support Maize cultivation is not profitable" Government officials,

however, have defended their stand by stating that maize grown as an alternative to wheat is not covered under procurement norms. "Only maize grown in the Kharif season, as an alternative to paddy, is eligible for procurement," said a senior officer from the Haryana Agriculture Department.

Ironically, the Centre has been aggressively promoting its commitment to procure all 24 notified crops under MSP. However, in the case of maize, those claims appear hollow. The lack of procurement infrastructure and no appointed agency to buy maize in most areas has led to a market collapse.

Since the maize was considered as the best alternative to break the wheatpaddy cycle the agricultural economists warn that such failures may discourage farmers from future crop diversification.

Several farmer unions have come out in support of the maize growers, demanding immediate compensation from the state governments of Punjab and Haryana. They argue that farmers who did not receive MSP despite official declarations must be compensated for the shortfall

Meanwhile the farmer leaders have demanded the immediate intervention of the governments to prevent the farmers from losses. The issue has begun to gain traction on social media and is expected to echo in the upcoming state legislative sessions as farmer unrest grows. Opposition parties in both states have also slammed the ruling governments, accusing them of playing with the livelihood of farmers.

Former Chief Minister Bhupinder Singh Hooda has said that once again BIP's claims of giving MSP on 24 crops have been exposed. "Today, in the markets, farmers' maize and sunflower are being sold at rates much lower than MSP and the ruling BJP is sitting with its eyes closed.

The arrival of both the crops is in full swing in the markets of Kurukshetra, Ambala, Karnal, Kaithal and surrounding areas, but instead of Rs 2400 per quintal MSP, farmers are getting only Rs 1,000 to Rs 1,400 for maize. The rate of completely dried crop is also only Rs 1,800 at the most", he added.

As per the data shared by the Election Commission, the Visavadar seat in Junagadh district and Kadi in Mehsana district recorded a voter turnout of 54.61 per cent and 54.49 per cent, respectively, till 5 pm.

As voting began, people queued up at polling booths in the morning, with candidates from the BJP and Congress in Visavadar being among the early voters. Votes were cast through Electronic Voting Machines (EVMs) at 294 polling stations in each constituency.



The counting of votes will take place on June 23.

No untoward incident causing poll disruptions was reported in any of the two seats, as the process went off largely peacefully, the officials said.

The state government had declared a public holiday on Thursday in both the constituencies for voting.

The BJP, Congress and the Aam Aadmi Party (AAP) had fielded their candidates on both these seats. The Visavadar seat was lv-

ing vacant since December 2023, after the then AAP legislator Bhupendra Bhayani resigned and joined the ruling BJP.

While the BJP nominated Kirit Patel for the bypoll in Visavadar, Congress fielded Nitin Ranpariya. AAP's

former Gujarat president Gopal Italia was also in the fray.

Despite its near-total dominance in the state, the BIP has not won the Visavadar seat since 2007. Party leaders said they are hopeful of overcoming the 18-year jinx here.

In the 2022 assembly election, AAP's Bhupendra Bhayani had defeated BJP's Harshad Ribadiya, a Congress turncoat and former MLA, by 7,063 votes.

The Kadi seat in Mehsana district, a constituency reserved for Scheduled Caste (SC) candidates, has been lving vacant since February 4, following the death of BJP MLA Karsan Solanki.

The BJP fielded Rajendra Chavda from the Kadi constituency, while from the Congress' side, former MLA Ramesh Chavda was in the fray. Ramesh Chavda had won the seat in 2012, but lost it to BJP's Karsanbhai Solanki in the 2017 election.

bound Air India Boeing 787-8 Dreamliner crashed into a hostel complex of BJ Medical College in the Meghani Nagar area of Gujarat's Ahmedabad shortly after takeoff from Sardar Vallabhbhai Patel International Airport. The tragedy claimed 241 lives out of 242 onboard, including former Gujarat Chief Minister Vijav Rupani.

After the accident, an inquiry into the accident is underway, with the Directorate General of Civil Aviation ordering enhanced safety checks on Air India's 787-8/9 Dreamliner fleet and the Tata group, the owner of Air India, along with the airline company has announced a total of Rs 1.25 crore compensation to the families of the victims.


Karnataka Cabinet on Thursday approved an increase in the reservation quota for minority communities under various housing schemes from 10 per cent to 15 per cent.



hief Justice of India BR Gavai on Thursday said that the Indian Constitution has given us the vision, tools, and moral guidance and has shown us that law can indeed be a tool for social change, a force for empowerment, and a protector of the vulnerable.

Speaking at the Milan Court of Appeal, Italy, on the topic "Role of Constitution in Delivering Socio-Economic Justice in a Country: Reflections from 75 Years of Indian Constitution," CJI Gavai said that the journey of the Indian Constitution over the past 75 years in delivering socio-economic justice is a story of great ambition and important success.

"Affirmative action policies in education, which sought to correct historical injustices and ensure representation of Scheduled Castes, Scheduled Tribes, and socially and educationally backward



classes, have been a concrete expression of the Constitution's commitment to substantive equality and socio-economic justice," he said.

NATION

CJI said that Constitution is not just a political document for governance, but was a "revolutionary statement", giving a ray of hope to a country coming out of long years of colonial rule, suffering from

poverty, inequality, and social divisions.

He took pride in stating that the framers of the Indian Constitution were deeply conscious of the imperative of socioeconomic justice while

drafting its provisions. "The framing of the Indian Constitution set a profound precedent for democratic governance in the post-colonial world.

India's Constitution became a model for other emerging nations striving to build inclusive and participatory governance structures," said the CJI. In his lecture, CII said that as we look back on these 75 years, there is no doubt that the Indian Constitution has strived for the change in the life of the common people. "To summarise, several

aspects of the Directive Principles were made enforceable by reading or legislating them as a facet of the fundamental rights. While Parliament took a lead by way of legislation and constitutional amendments, the Supreme Court has consistently worked to transform socio-economic rights, ranging from education to livelihood, into enforceable fundamental rights, which were then given effect by the Parliament," he added.

"In other words, the journey of the Indian Constitution over the past 75 years in delivering socioeconomic justice is a story of great ambition and important successes. To take an example, the earliest initiatives undertaken by the Indian Parliament immediately after the adoption of the Constitution included land and agrarian reform laws and affirmative action policies for backward classes. The impact of these initiatives is clearly visible today," CJI further said.

### India's first hydrogen-powered buses to begin plying in Leh

Five hydrogen fuel cell-based buses will soon begin to commercially ply in Leh district of the Union Territory of Ladakh, which has the highest motorable roads in the world.

The buses were formally handed over by National Thermal Power Corporation (NTPC) Limited to the State Industrial Development Corporation in a ceremony held at the green hydrogen mobility station in Palam. Leh. on Thursday.

The initiative marks the first-ever commercial deployment of hydrogen-powered buses in India. The deployment of these buses running on clean energy on the highest motorable roads in the world makes it a globally significant milestone towards green mobility, officials said. Following the formal flag-

off of the hydrogen buses, Transport Department Administrative Secretary Bhupesh Chaudhary conducted a detailed inspection of the NTPC's green hydrogen plant, including its production, storage and dispensing systems.

He appreciated NTPC's efforts in implementing such a technologically advanced project in Ladakh's highaltitude terrain and noted its significance in furthering the administration's vision of a carbon-neutral Ladakh.

Chief Secretary Pawan Kotwal lauded NTPC's pioneering efforts and observed that the successful operationalisation of hydrogen buses in such extreme conditions could usher in a new era of hydrogen fuel cell mobility in India.

## India records highest growth in power generation after US & China in last five years: IEA

## India's robust trade with G7 nations, except Canada, signals strong economic ties: Report

India has experienced a healthy and growing trade relations with G7 nations, outlining deepening economic engagement and cooperation, according to a report by data science company, Rubix.

G7 nations or the Group of Seven (G7) is an intergovernmental political and economic forum consisting of US, UK, Germany, France, Italy, Canada, and Japan.

Over a period, these G7 countries except Canada has emerged as India's top 30 trade destinations, adding to a stable and diversified export-import relationship.

On the exports side, cumulatively India's exports to G7 countries stood at a value of USD 138 billion in FY25, reflecting an increase of 13 per cent countries and this has recorded a 16%



CAGR between FY21 and FY25. While imports were at USD 110 billion for the same time period, which is a rise 12 per cent CAGR between FY21 and FY25. Total trade (exports + imports) with G7 countries cumulatively stood at USD 248 billion in FY25 and has increased at 13% CAGR between FY21 and FY25. "India had a trade surplus (exports

minus imports) of USD 28 billion in FY25 at an aggregate level with G7 CAGR between FY21 and FY25. India enjoys a trade surplus with 4 of the G7 countries namely the US, Italy, France and UK," the report revealed.

Share of goods exports to G7 nations has increased from 29% in FY20 to 31% in FY25, whereas the share of imports from G7 countries have declined from 18% in FY2O to 15% in FY25.

Sector-wise, Telecom transmission equipment, including mobile phones, and pharmaceuticals are among the most frequently exported products from India to G7 countries. They play an important role in India's trade basket, with their shares ranging from 5% - 16% and 7% - 12% respectively.

Additionally, India's pharmaceutical sector is a key supplier to G7 countries, meeting over 50% of global vaccine needs, 40% of generic demand in the US, and 25% of total medicine consumption in the UK.



India's non-bank financial institutions (NBFIs) are growing strongly, with large lenders leading the way, says Fitch Ratings.

These institutions offer a wide range of financial services, and their credit ratings depend on how strong and stable their business models and finances are.

According to Fitch, large NBFIs with a proven track record are earning more trust from investors and lenders. This growing confidence is helping them stay ahead of smaller players in the sector.

By the end of September 2024, 17 major NBFIs tracked by Fitch had increased their share of the total loan market to 38 per cent, up from 30 per cent in March 2022. These leading lenders recorded an annual loan growth rate of 20 per cent during this period, much higher than the 9 per

all NBFI sector.

These big NBFIs have also become financially stronger. Their debt-to-equity ratio -- a measure of how much they borrow compared to their own funds -- dropped from 4.5 times in 2021 to 4.3times by mid-financial year 2025.

This improvement came from raising more capital and keeping profits within the business, especially during the COVID-19 pandemic

Lower debt levels help reduce the risk of financial trouble if loan repayments slow down. Fitch expects this trend to continue, with most NBFIs using their earnings to fund future growth rather than paying out large dividends.

Fitch also highlights that the type of loans an NBFI focuses on plays a big role in its success. Those with deep experience and large operations in specific segments tend to have more stable and sustainable businesses. Many NBFIs lend to nonprime customers -- people who may not get easy loans from banks -- which can help them earn higher margins, unless banks enter the



## **A RETHINK ON INDIA'S STEM REVOLUTION CATALYSTS AND CONTRADICTIONS: AI, EQUITY AND FUTURE OF STEM IN INDIA**

'ndia's developmental ambitions, epitomised by the vision of developed nation, are inextricably linked to the effective integration of Science, Technology, Engineering, and Mathematics (STEM) education with frontier technologies such as Artificial Intelligence (AI). While India boasts one of the world's largest pools of STEM graduates and a demographic dividend skewed towards youth, these advantages risk remaining notional unless underpinned by sustained investments in quality, contextual relevance, and ethical governance of AIdriven pedagogy. The critical issue, therefore, is not simply the adoption of AI in education, but rather how inclusively, equitably, and ethically AI is being embedded within India's heterogeneous educational landscape.

Despite a proliferation of policy pronouncements and pilot initiatives, the mainstreaming of AI in STEM education is beset by persistent disparities. Digital access remains uneven, with infrastructure deficit particularly acute in rural

variations, and diverse pedagogical traditions. As a pedagogical innovation lag technological advancements, raising concerns about the capacity of mentors to meaningfully integrate AI tools into classroom environment. Moreover, curriculum reform has often been incremental and fragmented, failing to keep pace with the rap-

idly evolving demands of the knowledge economy. These structural impediments threaten to reproduce, rather than redress, existing inequities-risking a scenario in which AI-enabled learning becomes prerogative of the privileged. A critical assessment of

India's AI-STEM interface must therefore move beyond celebratory narratives of technological leapfrogging to engage with the deeper structural and normative conditions shaping this transition. Policy frameworks must foreground issues of access, affordability, and cultural relevance, ensuring that AI integration does not exacerbate social and educational divides. Pedagogical interventions should be rooted in evidence-based practices, prioritising critical thinking, creativity, and ethical reasoning over rote automation. Furthermore, infrastructural investments must be accompanied by robust capacity-building for educators and sustained engagement with local con-



#### **AI AND THE TRANSFORMATION OF STEM LEARNING**

The integration of AI into the educational landscape has generated considerable debate regarding its potential to enhance the understanding of STEM subjects. AI's promise lies in its ability to personalise learning, adapt to individual student needs, and provide real-time feedback, thereby potentially transforming the rigid, one-size-fits-all model that has long plagued STEM education. Adaptive learning platforms powered by AI can diagnose students' strengths and weaknesses, offering tailored contents and upscaling that may help bridge learning gaps. Furthermore, AIenabled simulations and virtual laboratories can democratise access to experiential learning, which is often constrained by inadequate infrastructure. These technological interventions could foster deeper conceptual un-

rote memorisation.

The current status of STEM education in India, however, is marked by both progress and persistent challenges. The NEP 2O2O has provided a much-needed impetus to STEM education, emphasising experiential learning and integration of technology from the early years of schooling. India has one of the largest cohorts of STEM graduates but this quantitative expansion need to be translated into quality. Apart from digital divide, gender disparities are also pronounced, with women constituting only a modest proportion of STEM cohort and an even smaller share of the STEM workforce. Moreover, the curriculum often remains disconnected from real-world applications and rapidly evolving industry needs, leading to a mismatch between educational outcomes and workplace requirements.

Collaboration with teachers, researchers, and industry is vital for developing contextsensitive, multilingual AI tools and adaptive curricula. Targeted interventions to promote diversity and inclusion-especially for girls and disadvantage group-will be the key. Only through such comprehensive, equity-driven reforms. AI can become a genuine catalyst for innovation, social mobility, and a future-ready STEM education system in India.

## Pakistan and the farce of Ummah: When betrayal becomes a habit

As the United States and Israel reportedly strategize a potential ground assault on Iran through covert operations and regional partnerships, one name resurfaces - Pakistan. The recent lunch hosted by former U.S. President Donald Trump for Pakistan's Army Chief General Asim Munir has sparked questions across diplomatic and strategic circles. Is Pakistan once again becoming a staging ground for foreign operations in the Muslim world? And more importantly, can

Pakistan ever be trusted even by the so-called Islamic Ummah it pretends to lead? This question acquires urgency in light of Bharat's ongoing Operation Sindoor, a bold and self-defined military-diplomatic offensive reshaping South Asia's strategic posture. As Prime Minister Narendra Modiasserted in his 35-minute call

with Trump, India shall not tolerate terrorism as proxy war anymore — it will treat it as war itself. No space for ambiguity. And no space for so-called third-party mediation — a direct rebuke to any whispers of American "peace initiatives" involving Pakistan.

#### **THE TRUMP-MUNIR** LUNCH: A TELLTALE SIGNAL

In diplomacy, symbolism often speaks louder than statecraft. So when Trump - a former President with

General Asim Munir to a private lunch, it sends a loud signal. Munir, heading a military that has presided over multiple coups, nuclear proliferation, and terrorism sponsorship, was being accorded legitimacy. Was this an informal message that Pakistan could still act as Washington's foot soldier in future Middle Eastern

scenarios? For seasoned observers, the signs are familiar. And the precedent is chilling. If indeed Pakistan becomes a player in a Western-backed offensive against Iran or any part of the Islamic world, it will be far from the first time Islamabad has sacrificed Muslim lives and solidarity at the altar of selfinterest.

#### **PAKISTAN'S PATTERN OF BETRAYAL: HIS-TORIC AND SYSTEMIC** Let us consider the long and bloodied record of Pakistan's betrayal of the Ummah:

#### **Operation Black Septem**ber (Jordan, 1970): Pakistan vs Palestinians

Perhaps the most coldblooded betrayal of the Islamic spirit occurred when Brigadier Zia-ul-

Haq, stationed in Jordan, enduring clout – invites led Jordanian forces against Palestinian fighters (PLO). Thousands of Palestinians were massacred in cold blood. It was not Israel or the U.S. that crushed Palestinian resistance — it was another Muslim army, under a Pakistani commander. This was no tactical necessity — it was a calculated betrayal of a pan-Islamic cause. Pakistan's loyalty lay with monarchy and money, not the Ummah.

#### **Uyghur Muslims: Silence** in the Face of Genocide

In China's Xinjiang province, over one million Uyghur Muslims have been incarcerated in so-called re-education camps. Islamic practices are criminalized; mosques demolished; Arabic-script Qurans seized. Yet Pakistan - the self-

declared leader of Muslim causes — has not only remained mute but has actively endorsed China's actions. Prime Minister Imran Khan called himself "unaware" of the situation, while Pakistan signed joint statements justifying Chinese crackdowns. Because Beijing holds Islamabad's purse strings.

Brotherhood ends where chequebooks begin.

Afghanistan: CIA's **Frontline State, Twice** Over

During the Soviet-Afghan war (1979–1989), Pakistan acted as a staging ground for U.S. arms and jihadist recruitment. While the Mujahideen fought under the illusion of pan-Islamic resistance, Pakistan's ISI profited immensely by siphoning off American money.

Post 9/11, Pakistan again allowed its territory to be used for American drone strikes against fellow Muslims. Entire tribal families in Waziristan, Swat, and FATA perished — but not a word of protest from Rawalpindi. For Islamabad, Ummah has always been a facade to broker Western deals. Bangladesh (1971): Slaughter of Fellow Mus-

Nothing exposes the hollowness of Pakistan's Islamic rhetoric more than its brutal campaign in East Pakistan (now Bangladesh). The Pakistani Army slaughtered over 3 million Bengali Muslims, raped hundreds of thousands of women, and displaced millions. All because East Pakistan demanded dignity, language rights, and autonomy. There was no India-Pakistan war initially — it was a civil war within a Muslim nation, where West Pakistan treated East Pakistan as a colony. The Ummah was shattered by Pakistan's

#### internal imperialism. Yemen: Sitting on the Fence, Trading Loyalty

In 2015, when Saudi Arabia called on Pakistan to join its military coalition against the Iran-backed Houthis in Yemen, Pakistan refused. Despite years of Saudi aid, loans, and oil supplies, Islamabad chose to abstain, fearing Iranian backlash. This wasn't a decision for peace — it was a diplomatic gamble, where Pakistan sought to balance both Riyadh and Tehran for future leverage. Ummah unity was once again sacrificed for realpolitik.

#### **SECTARIAN TERROR: DIVIDE AND RULE** WITHIN ISLAM

Within Pakistan itself, minority Muslim communities - especially Shias, Ahmadis, and Sufis – are routinely targeted by state-backed or state-ignored terror outfits like Lashkar-e-Jhangvi and Sipah-e-Sahaba. Massacres during Muharram, targeted killings of Shia doctors, and routine hate

sermons against Ahmadis are a norm.

Pakistan doesn't just abandon the Ummah externally — it devours it from within.

#### **THE IRAN DILEMMA: PROXY STATE OR ROGUE ALLY?**

Pakistan has long walked a tightrope between Iran and the U.S./Saudi axis. While it shares a border with Iran. its intelligence services have historically allowed anti-Iranian groups to operate from its soil. The recent visit of General Munir to the U.S. hints at yet another betraval brewing.

If Iran is indeed the target of future military action by the U.S. or Israel – as many analysts fear — then Pakistan's role as a logistical or intelligence base would mark a direct attack on Islamic regional solidarity. Again, loyalty auctioned off.

#### **PAKISTAN - NO VAN-GUARD OF ISLAM**, **JUST A PAWN OF** INTEREST

The Islamic concept of Ummah is one of collective dignity, fraternity, and justice. Pakistan has repeatedly desecrated that idea - notby mistake, but by design. It has turned Islam into a diplomatic slogan, used only when convenient, and abandoned when costlier truths emerge.

In contrast, Bharat has acted with consistency and moral clarity. Prime Minister Modi's statement to President Trump - rejecting mediation, upholding sovereignty, and redefining terrorism as war - shows a civilisational confidence that stands in stark opposition to Pakistan's moral collapse.

As Operation Sindoor continues, India must prepare for both diplomatic deception and covert subversion from Pakistan and its Western backers. But more importantly, Bharat must tell the Islamic world: Pakistan does not speak for Islam. It speaks only for its generals, its debts, and its ambitions. There is no Ummah when Pakistan enters the room only duplicity draped in religious theatre.

riya Sahgal is the Editorial Director at NewsX (iTV Network) interviewed George Eli Birnbaum, an American political consultant. He worked on the United States congressional and senatorial races. In 1998, he moved to Israel to work as a consultant to Prime Minister Benjamin Netanyahu, became his chief of staff, and afterwards formed a partnership with political consultant Arthur Finkelstein.

Q. He is, it's good to have you here, George, on the show, and you know, you have really one person who can give us an insight to the man of the moment. You've been an advisor to the Israeli Prime Minister, and first of all I'd like to begin with, you know, what is happening, what is he thinking, what is going on in his mind?

A. So as of today, the Prime Minister is really focused on one thing and one thing only, and that is eliminating an existential threat, not just to the Jewish people and to Israel, but for the world. He's always believed that the Prime Minister of Israel, whoever it is, has a responsibility to ensure that what happened in the late 30s and 1940s to the Jewish people in Nazi Germany never happens again. And I've said recently that had Israel been around in

1936, 1937, it would have taken out Nazi Germany and prevented World War II. I believe firmly that the Prime Minister and his cabinet and most of the Jewish people around the world believe that what Israel is doing now will be looked at as having prevented World War III.

#### ALL ABOUT ISRAEL-IRAN WAR

The Israel-Iran conflict has erupted into open confrontation after years of shadow warfare and proxy battles. What began as cyberattacks and covert operations has evolved into direct military engagement, with Israeli airstrikes hitting Iranian military and nuclear sites, and Iran responding with missile and drone attacks

Tensions have been escalating for years, rooted in Iran's nuclear ambitions and support for groups like Hezbollah, Hamas, and the Houthis. Israel views these as existential threats. Tehran, in turn, sees Israel as a regional aggressor backed by the U.S

A. Well, you know, in order to make a deal, you have to have two parties that operate and negotiate in good faith. And so the fact of the matter is that there was no good faith on one side of the negotiation. You really can't make a deal when there is only one side at the negotiating table that's operating in good faith. It's impossible to make a deal that way. So I think that was clear, and Donald Trump understood that there was no deal to be had

Q. This is also a time, you know, where we've seen some kind of a peace in the region. We've seen the Abraham Accords being signed. We've seen even the U.S. has strategic interests over there also. This confrontation and regime change in the past hasn't also worked very well. You know, whether you take Iraq or you take Africa, how, I mean, the benefits of this is not going to be as smooth as, you know, the democracy may come back, the people of Iran will be better off without the Avatollah. It never works out like that on ground?

A. Listen, the idea that democracy or the idea of American democracy is the absolute solution to the problem is it is a wrong idea to pursue. I've worked in countries around the world where sometimes, you know, you need strong leadership in order to make sure that you have stability. I'm not suggesting that by simply bringing back the Shah or by bringing democracy to Iran that you'll solve all of the Iranian people's problems. What I am suggesting, what I think most people do believe, is that the Iranian people deserve to choose their future and the path that they go on, as opposed to the Ayatollahs and the Islamic fundamentalists. And I think if you were to poll the Iranian people, most of them would not choose the

intelligence that he saw as the opposition leader in his conversation with the prime minister, that the prime minister had no choice but to act in this way. So the voices in Israel are unified, even at the political level and even with some of the prime minister's most




#### **THE HISTORY OF GALTA TIRTHA HAS A RICH HERITAGE**

## **HOW YEARS OF COVERT INTELLIGENCE LED TO ISRAEL'S MASSIVE STRIKE ON IRAN**

Years of covert espionage, a daring nuclear archive heist, and mounting threats culminated in Israel's massive 2025 strike on Iran—triggering a deadly conflict that now risks spiraling into a full-blown regional war.

n June 13, 2025, Israel launched a massive aerial and drone offensive on Iran, describing it as a "necessary preemptive action" against what it claimed was an imminent nuclear threat. Over 100 strikes were carried out, targeting deeply embedded nuclear facilities, Revolutionary Guard (IRGC) bases, missile depots, and secret intelligence posts spread across Iran.

The result was devastating: at least 224 Iranians were reported dead, numerous strategic installations were leveled, and several high-precision drone attacks reached deep into Iranian territory. Israeli defense officials described it as one of the most complex and far-reaching military operations the country had ever undertaken.

But this wasn't a sudden reaction or a routine military strike—it was the culmination of years of secret intelligence work. And at the heart of it all was a daring Mossad operation from 2018, one that uncovered Iran's nuclear ambitions and helped shape Israel's longterm strategic response.

#### **THE 2018 NUCLEAR ARCHIVE HEIST**

The origins of the June 2025airstrikes trace back to one cold January night in 2018. In an operation that Israeli officials would later compare to a Hollywood thriller, a team of Mossad agents infiltrated a seemingly unremarkable warehouse in Shorabad, on the outskirts

Unbeknownst to the world, the building housed a highly classified nuclear archive that Iran had kept hidden even after sign-

ing the 2015 nuclear deal (JCPOA). The operation had been months in the making, with meticulous surveillance allowing the agents a window of just six and a half hours-timed perfectly between security shifts.

Inside, the team found dozens of safes filled with documents, diagrams, and CDs. They used specialized

equipment to cut through the safes and extracted what they deemed most critical files labeled with diagrams of nuclear warheads and advanced bomb-making technologies. In total, Mossad agents walked out with around 500 kilograms of top-secret material.

By the time Iranian security realized the breach the

the archive included detailed blueprints, weapon designs, and internal communications linked to "Project Amad"-a secret Iranian program aimed at developing nuclear warheads and adapting them for delivery via Shahab-3 missiles. Particularly concerning were files detailing warhead miniaturization and the use of uranium deuteride, a rare material used in nuclear initiators.

These revelations were shared not only with the public but also privately with then-U.S. President Donald Trump, who shortly after withdrew the U.S. from the 2015 nuclear deal, citing bad faith on Iran's part.

Independent verification from Western intelligence agencies confirmed that the documents were authentic and troubling. The archive provided hard proof of Iran's dual-track approach: publicly agreeing to international inspections while secretly preserving nuclear knowl-According to Netanyahu, edge for future use.

Iran immediately dismissed the Israeli claims, branding the documents as fabrications. However, the specificity and scale of the information made the denials difficult to sustain. The documents included

site maps, names of scientists, and testing protocols. Some materials even pointed to a hidden chamber at the Parchin military base, believed to have been used for high-explosive testing related to nuclear triggers.

Worse for Iran, the archive revealed that even after the JCPOA was signed, Tehran had quietly moved sensitive materials and safeguarded began.

The most prominent was Mohsen Fakhrizadeh, the

alleged mastermind behind Iran's nuclear program, who was killed in a 2020 ambush involving remotecontrolled gunfire-an operation widely attributed to Mossad. Others, like Masoud Ali Mohammadi, were killed by explosives placed near their homes or vehicles.Though Israel never officially claimed responsibility, its hand was strongly suspected. Iran, in turn, retaliated with cyberattacks targeting Israeli infrastructure and attempted strikes on Israeli diplomats abroad through its proxy networks.

#### **SPARK THAT LIT POWDER KEG**

By mid-2025, tensions were already at a boiling point. Western intelligence began picking up chatter about accelerated Iranian nuclear activity, including the enrichment of uranium beyond the ICPOA thresholds and renewed development of delivery systems. According to Israeli intelligence, Iran was "weeks, not months" away

from having enough fissile material for a nuclear bomb. Israel's response came swiftly and with over-

whelming force on June 13. Precision-guided missiles and drones rained down on nuclear sites, some of them buried deep underground. While Israel did not disclose the full scope of its targets, independent satellite imagery confirmed the destruction of several research and enrichment centers. Military airfields, missile launch sites, and key IRGC command structures were also hit.

Iran retaliated within hours, launching over 100 ballistic missiles and attack drones toward Israeli territory. Despite the effectiveness of Israel's Iron Dome and David's Sling defense systems, several missiles slipped through, striking civilian areas in Tel Aviv, Haifa, and Beersheba. At least 14 Israeli civilians were killed and hundreds more wounded in what was the deadliest attack on Israeli soil in years.

#### **NO END IN SIGHT**

As of June 19, the fighting has entered its seventh day with no clear sign of de-escalation. Israeli jets continue to conduct deep-penetration raids, while Iran has mobilized its proxies in Lebanon, Syria, Iraq, and Yemen to expand the front. Hezbollah has fired rockets into northern Israel, while Houthi drones have targeted Israeli naval assets in the Red Sea. The humanitarian toll is mounting. Thousands have fled border regions in both countries. Electricity and

internet blackouts have been reported in parts of Iran, and Israel has declared a state of emergency in multiple districts.

Global leaders have issued urgent calls for restraint, but so far, diplomatic efforts have failed to produce a ceasefire. The United Nations Security Council has scheduled an emergency session, but consensus remains elusive, with China and Russia backing Iran's right to self-defense and Western nations standing behind Israel's security concerns.

#### WAR YEARS IN THE MAKING

While the war officially began in June 2025, its roots stretch back nearly a decade-to that warehouse raid in Tehran. The stolen archive not only exposed Iran's nuclear deception but also set into motion a series of covert and overt operations that steadily pushed the two adversaries toward direct conflict.

For Israel, the archive provided both intelligence and justification. It shaped national policy, emboldened leaders, and ultimately convinced them that waiting was too dangerous. For Iran, the exposure was a humiliation and a red line. What followed was a tit-for-tat campaign of assassinations, cyber warfare, and proxy battles-all leading to the present moment.

Now, with missiles flying and cities under attack, the world finds itself on edge, hoping the crisis can be contained before it explodes into a broader regional war.

## How Trump and General Munir's lunch could impact India

The recent private luncheon held at the White House between former U.S. President Donald Trump and Pakistan's Army Chief General Asim Munir has triggered significant discussions regarding its potential implications for India, especially in the context of South Asian geopolitics and evolving international alliances. While the meeting was portrayed as an acknowledgment of efforts to ease tensions between India and Pakistan, it has inevitably raised questions in New Delhi about the direction of U.S. foreign policy and India's strategic interests in the region.

During this meeting, Trump praised both General Munir and Indian Prime Minister Narendra Modi for their leadership roles in defusing what was a tense military standoff earlier this year, preventing the escalation of conflict between the two nuclear-armed neighbors. Trump's remarks notably emphasized the bilateral nature of the resolution, without asserting any direct U.S. mediation, thereby highlighting the agency of the Indian and Pakistani leaders themselves. Despite this recognition, the fact that the U.S. administration hosted Pakistan's military chief in a private setting without involving Indian representatives has sparked unease within Indian diplo-

matic circles. India's concerns stem largely from the perception that the United States may be recalibrating its diplomatic focus towards Pakistan, potentially diluting the strategic partnership it

has cultivated with India over recent decades. The absence of any reciprocal engagement or invitation extended to Prime Minister Modi for a similar meeting further feeds this narrative of shifting priorities. For New Delhi, the timing and exclusivity of the luncheon raise the possibility that the U.S. might be seeking to strengthen ties with Pakistan's military leadership, especially given the shared concerns over regional security threats such as Iran's influence and terrorism.

The implications for India-Pakistan relations are complex and multifaceted. While India has traditionally advocated for direct bilateral dialogue with Pakistan to resolve long-standing



## US analyst warns: Pak may get Iran nukes

Former Pentagon official and a senior fellow at the American Enterprise Institute, Michael Rubin, has said that US forces need to enter Iran and eradicate its nuclear program and said that it is a possibility that Pakistan could receive Iran's nuclear supplies after the cessation of hostilities. "Iran targeting civilian centers with ballistic missiles is no surprise for us. They have been openly declaring their desire to destroy the State of Israel for decades now. These aren't just words. Over the past six days, Iran has launched over 450 ballistic missiles and hundreds of UAVs," he said

He further said that these reasons justify why Iran should not be allowed to procure nuclear weapons.

Defrin said that Iran targeted civilians while Israel targeted existential threat. "Iran targets civilians. We target an existential threat that endangers global security. And we will prevail," he said. Israel embassy in India said that Israel will do all that is necessary to protect its people.

he England Men's and India Men's Test teams will honour James Anderson and Sachin Tendulkar with a new trophy dedicated to their remarkable achievements in Test cricket. The next edition of this great rivalry takes place this summer, with the five-match Test series getting underway at Headingley on June 20.

The Anderson-Tendulkar Trophy, a joint initiative between the England and Wales Cricket Board (ECB) and the Board of Control for Cricket in India (BCCI), will now represent all future Test series between England and India. Previously, the series in England was played for the Pataudi Trophy and the series in India for the Anthony De Mello Trophy.

The Pataudi family will continue to be honoured, with a newly commissioned Pataudi Medal to be presented to the winning captain of each England-India Test series

The trophy features imagery of Anderson and Tendulkar in action, along with their engraved signatures-a

## Prioritise national duty, denial will lead to funds recovery: SAI to tennis players

#### AGENCIES NEW DELHI

India's tennis players who receive financial assistance through various support schemes should prioritise national duty and refusal to play for India without "valid justification" will result in recovery of funds from them, according to a new Sports Authority of India (SAI) order. Making players accountable for funds received, the SAI, in its order, has asked the players, selected for support under the Target Asian Games Group (TAGG), to provide a written undertaking where they acknowledge that receiving financial assistance carries the responsibility of contributing to the nation's sports excellence.

The matter came up for discussion when athletes' names were discussed for inclusion in TAGG, according to a source.

In its order, SAI asked players receiving support under TOPS, NSF and TAGG schemes to confirm their availability and willingness to represent India in "esteemed international events such as the Billie Jean King Cup, Davis Cup, Asian Games, Olympics."

"The above tennis competitions hold significant national pride. Therefore, it is important that all players benefiting from the support, provided under these schemes prioritize representing India if selected by the All India Tennis Association (AITA).

"We would also like to inform you that, in the event of selection by the NSF, should you decide not to participate without valid justification,
