Rijiju said, "The central government called an allparty meeting on July 19 regarding the monsoon session of Parliament. The monsoon session of Parliament is starting from July 21 and will run till August 21." The Monsoon Session of Parliament will be held

from July 21 to August 21. There will be no Parliament sittings on August 13 and 14 due to Independence Day celebrations.

Earlier in a post on X, Union Minister Kiren Rijiju wrote, "The Hon'ble President of India has approved the proposal of the Government to convene the Monsoon Session of Parliament from 21st July to 21st August, 2025. In view of the Independence Day celebrations, there will be no sittings on



the 13th and 14th of August."

This comes amid the demand by Opposition leaders to convene a special session of Parliament upon the arrival of all-party delegations to discuss various issues, especially the developments that followed the ghastly Pahalgam terrorist attack.

The upcoming Monsoon session will be the first Parliament session following **Operation Sindoor, which** was launched by India on May 7 in response to a terror attack in Jammu and Kashmir's Pahalgam, which claimed 26 lives.

The Budget session of Parliament began on January 31 this year. The Budget Session saw the passage of significant legislation, including Waqf Amendment Bill. Rijiju held a press conference after the end of the

Budget Session, informing that the first part of the Budget Session yielded a total of 9 sittings of Lok Sabha and Rajya Sabha. In the second part of the Session, there were 17 sittings of both Houses. During the entire Budget Session, in total, there were 26 sittings.

During the second part of the Session, Demands for Grants of individual Ministries of Railways, Jal Shakti and Agriculture & Farmers Welfare were discussed and voted in Lok Sabha.

In the end the Demands for Grants of the remaining Ministries/ Departments were put to the Vote of the House on Friday, the 21st of March, 2025. The related Appropriation Bill was also introduced, considered and passed by Lok Sabha on 21.03.2025 itself.

Caretaker, wife arrested for elderly woman's murder in Guwahati

A woman was found dead under suspicious circumstances inside a locked room in Guwahati's Kharghuli locality on Wednesday morning, triggering concerns of foul play. The elderly lady aged 71 years was survived by a caretaker along with his wife.

According to ADCP (Central) Sambhavi Mitra, the city police received information about the murder around 6 AM.

The elderly woman, who had been living alone since the death of her husband

The political heat for the 2025 Bihar Assembly elections is intensifying. This election is not just a battle for power but also a blend of social equations, promises of development, and alliance strategies. The National Democratic Alliance (NDA) is putting in all its efforts to further strengthen its hold in Bihar this time. The NDA's strategy and the dynamics of its alliance are adding new colors to the state's politics.

The NDA alliance in Bihar is a strong coalition comprising the Bharatiya Janata Party (BJP), Janata Dal (United) [JD(U)], Lok Janshakti Party (Ram Vilas) [LJP(R)], Hindustani Awam Morcha (HAM), and Rash-



triya Lok Morcha (RLM). According to sources, the NDA has almost finalized its seat-sharing formula: JD(U) is likely to get 102–103 seats, BJP 109-112 seats, Chirag Paswan's LJP(R) 18-25 seats, Jitan Ram Manjhi's HAM 6-7 seats, and Upendra Kushwaha's RLM 4-5 seats. Chirag Paswan has a strong hold over the Paswan community, while Nitish Kumar relies on the Kurmi and Koeri votes. However, when it comes to the votes of the Mallah and some Dalit communities, there is tough competition with the INDIA alliance. The NDA's strategy is to keep its vote bank consolidated and bring along the smaller castes too.

Nonetheless, the NDA also faces significant challenges. Questions are being raised about Nitish Kumar's health and age, which the opposition is trying to exploit. Despite this, the NDA alliance hopes to return to power on the strength of its unity and strategy.

Buried homes, broken hope: Pandavsheela cries out in silence amid rain, landslides

The residents of Pandavsheela, a remote village in the Janjehli region of Himachal Pradesh's Mandi district, have been left to fend for themselves after relentless rains triggered landslides and widespread destruction beginning late on June 30.

Three days later, the village remains completely cut off from the rest of the state. Mobile networks are down. roads have collapsed, and

no relief team has reached the area. The village, once known for its peace and natural beauty, now stands as a grim symbol of abandonment.

Locals describe scenes of devastation—six to seven homes have been entirely buried under debris. Several cowsheds have collapsed, resulting in the loss of live-

stock crucial to the villagers' livelihoods. In nearby Rushaad, two individuals remain missing, while the body of one deceased villager has been recovered.

Despite the gravity of the situation, no official from the district administration, local panchayat, or disaster response team has visited the area. Villagers say they have had no access to food, drinking water, or medical assistance since the disaster began.

In an emotional plea to local media, a woman from the village said, "Our village may be small, but we are still alive. We feel completely abandoned. Please, don't wait for more deaths to take us seriously.'

Residents have resorted to clearing debris by hand and rationing what little food remains. With each passing hour, anxiety is mounting. This humanitarian crisis has raised serious concerns about disaster prepared-

ness in remote Himalayan regions, especially as climate change brings more extreme and unpredictable weather events. Local leaders and villagers are calling for immediate action, demanding emergency supply of food and clean drinking water, deployment of search and rescue teams for the missing, compensation for destroyed homes and livestock and restoration of road access and mobile connectivity. Pandavsheela may be a small village, but its cries for help reflect a larger question: Do remote communities matter less when disaster strikes?

As one local put it: "We're not asking for charity. We're asking to be seen. To be helped. To be treated as human."


The silence from the authorities is now deafening. For the people of Pandavsheela, help cannot come soon enough.



Expressing concern over the rising impact of provocative social media content and cybercrime, West Bengal Chief Minister Mamata Banerjee on Thursday wrote to Union Home Minister Amit Shah and stressed the need for stringent legislative and policy interventions.

The man, identified as Mukesh Kumar, worked as a helper at Kuldeep Sewani's garment shop in the Lajpat Nagar market. Kumar would also transport garment.

The accused, a native of Bihar's Hajipur, was nabbed by Uttar Pradesh Railway Police from a train while he was trying to flee, police said. Both were killed with a

Mentors appointed in 56 Delhi govt schools, focus on improving performance

AIADMK National Spokesperson Kovai Sathyan on Thursday demanded a transparent probe into the alleged custodial death of a security guard in Sivaganga district and added that his party will stand with the family of the deceased.

Kovai Sathyan said, "This is the 25th custodial murder since DMK came to power. Andhra Pradesh High Court grants Jacqueline's plea against bail in TTD ghee adulteration case

The Andhra Pradesh High Court on Thursday granted bail to Pomil Jain, Vipin Jain, and Apurva Chavda, accused in the high-profile case concerning the alleged supply of adulterated cow ghee to the Tirumala Tirupati Devast-

hanams (TTD). The accused were represented by Senior Advocate S. Sriram and Advocate Sushil Kumar, the Managing Partner of Kumar Legal Research

LLP, who jointly argued the matter before the High Court. The bench of Justice Srinivas Reddy allowed the bail pleas after finding serious discrepancies in the investigation. The Court granted relief to Pomil Jain and Vipin Jain, Directors of Bhole Baba

Organic Dairymilk Pvt. Ltd., and Apurva Chavda, CEO of Vyshnavi Dairy. The accused had been in judicial custody since February 2025.

Previously, during the proceedings, the defence counsel strongly contested the manner in which the investigation had progressed. They pointed out that the accused had been initially summoned merely as witnesses, yet were later arrested and incarcerated for an extended period without a sufficient legal basis

The case stems from an FIR lodged by the General Manager of TTD, alleging that the suppliers had violated tender conditions and delivered adulterated cow ghee meant for use in the sacred rituals at the Tirumala temple. Investigations revealed the ghee

allegedly originated from Bhole Baba Organic Dairy, passed through Vyshnavi Dairy, and was ultimately supplied by AR Dairy to TTD.

The probe is being led by the Central Bureau of Investigation (CBI) in coordination with a multi-agency Special Investigation Team (SIT).

Arguing for the petition ers, Senior Counsel S. Sriram and Advocate Sushil Kumar highlighted procedural lapses and irregularities in the investigation. They particularly questioned the delay in lodging FIRs relating to alleged witness intimidation asserting that although SIT and CBI raised the claims in March and April, formal FIRs were filed only in June, suggesting an element of afterthought.

"Environmental regulations should be streamlined and enhanced through the adoption of technology. CII recommends implementing a unified compliance framework that consolidates all state and central environmental clearances," said Rajiv Memani, President of CII, during a press confer-

ence in New Delhi. To improve critical minerals data accessibility and transparency, the CII further suggests that a country like India should establish a National Critical Minerals Data Repository.

Acknowledging the sector's long gestation periods and inherent risks, CII em-

phasised the need for government support through Viability Gap Funding (VGF) and dedicated financial provisions to attract private participation.

CII would also be launching a Mission on Energy transition, to encourage industry to shift to low-carbon alternatives," Rajiv Memani further added. However, the CII Presi-

In fact, some of the most conservative companies are already starting to give some guidance on lowering their production levels going forward," Memani said in the press con-

ference. In the same press conference, CII also projected India's economy to grow at a pace of 6.4-6.7 per cent in 2026-27, boosted by strong domestic demand.

RBI rate cuts lead to cooling between India and the UK, in both credit offtake and deposit growth: Report

With a 100 basis point repo rate cut by the Reserve Bank of India (RBI) since February, Credit offtake and deposit growth have cooled, noted a report by CareEdge. However, despite the rate

Stories of persecution of Hindus and Christians in Pakistan are well known. In truth, Pakistan seems divided into three sections. The first is the army and ISI, which have taken control of the country. The second is cowardly, sycophantic politicians. Betrayal is second nature to both these groups. The third is the unfortunate common people, who, even if they try to stop their country from becoming a commodity for sale, are crushed under military boots. Our sympathies are with them but what can be done? This, for now, is Pakistan's fate. May God help them!

Recently, in Sadhguru Jagadish Vasudev and Anr. v. Igor Isakov and Ors. (2025). the Delhi High Court passed an interim order safeguarding the publicity and personality rights of Sadhguru, reigniting the need to understand the interplay between an individual's publicity rights and the evolving digital ecosystem, particularly the use of artificial intelligence (AI) tools. The Court acknowledged the distinct personality traits associated with Sadhguru, for instance, his appearance, argumentation style, voice, etc. Certain AI websites and social media channels were found exploiting his personality traits, without his consent, for commercial gain. The Court observed the scale of violation and long-term repercussions, keeping in mind the virality aspect of social media and digital landscape. Thus, the Court directed the removal of the materials violating Sadhguru's personality rights, mandating further the disclosure of subscriber-related information and asked the DoT and the MeitY to issue blocking directions against the offending accounts and channels.

In UTV Software Communication Ltd. & Ors. v. 1337x. to & Ors. (2019), the Delhi High Court laid down illustrative criteria to determine whether a website qualifies as a rogue website. These include: (a) primary objective of the website is to facilitate copyright infringement; (b) the scale and magnitude of infringement; (c) whether the majority of content is unauthorised; (d) concealment of registrant information; (e) non-compliance with takedown requests; (f) general disregard for copyright norms; and (g) efforts to evade enforcement mechanisms.

IS INDIA READY?

Violations of personality rights attract both civil and criminal remedies under Indian law. Criminal proceedings may be initiated under the Trade Marks Act for infringement of registered trademarks, while actions for passing off can be taken under Law of Torts for unregistered trademarks. The Copyright Act, 1957 (Section 55), provides for remedies in cases where infringeised use of an individual's identity.

However, traditional/static injunctions are often ineffective in the digital age, as infringing content rapidly spreads across platforms and domains. Hence, Indian

courts have been granting "dynamic injunctions", first recognised in UTV Software Communication Ltd. & Ors. v. 1337x.to & Ors. (2019). These injunctions allow courts to extend protions globally tective measures to future infringing content, ensuring adaptive enforcement of personality rights in a constantly evolving digital

environment. Despite judicial innovations, India still lacks statutory codification of personality rights. With increasing online misuse and AI-generated impersonations, the legal framework must evolve accordingly. Drawing inspiration from Article 9 of the French Civil Code, which offers a comprehensive framework for personality rights, covering both online and offline privacy violations, it is imperative for the Indian Parliament to enact robust legislative measures to address these

n the rapidly evolving geopolitical landscape of the Indo-Pacific region, the Quadrilateral Security Dialogue, commonly known as the Quad, has emerged as a pivotal multilateral forum. Comprising four major democracies—the United States, Japan, India, and Australia-the Quad has grown from an informal dialogue into a strategic platform addressing security, economic, technological, and environmental challenges. THE FORMATION

The Quad experienced a significant revival around 2017-2018, driven by the changing strategic calculus in the Indo-Pacific. Several factors contributed to this resurgence: • China's Assertiveness:

China's growing military modernization, aggressive territorial claims in the South China Sea, and construction of artificial islands with military installations alarmed regional actors and outside powers. Its Belt and Road Initiative (BRI), perceived as expanding Chinese influence via infrastructure investment, raised concerns about debt dependency and geopolitical leverage.



THEWA JEWELRY: THE GLORIOUS FUSION OF GOLD AND GLASS IN RAJASTHAN

ajasthan, the land of royal palaces and vibrant culture, holds within its deserts and forts a treasury of age-old crafts that continue to mesmerize the world. Among these hidden gems is Thewa jewelry, a distinctive and intricate art form that marries the shimmer of gold with the sparkle of colored glass. Originating from a small town in Rajasthan, Thewa jewelry is not merely adornment; it is a heritage passed down generations, echoing tales of royal patronage, artistic mastery, and cultural pride.

ORIGINS: A ROYAL INCEPTION

Thewa jewelry finds its roots in Pratapgarh, a quaint town in southern Rajasthan, nestled between the Aravalli ranges. It is believed that the art of Thewa was developed in the 17th century, during the reign of Maharawat Samant Singh. The craft is attributed to a talented artisan named Nathu Lal Sonewala, who is said to have pioneered this elaborate technique combining 23-carat gold with multicolored glass. Impressed by the beauty and novelty of the design, the local royals patronized the craft, helping it gain popularity across princely courts of India.

The term Thewa is derived from the Rajasthani word meaning "setting"-a reference to the process of fusing gold sheets onto glass. Over time, this regional specialty became a prized possession in roval collections and was even exchanged as diplomatic gifts.

THE UNIQUE **CRAFTSMANSHIP**

What makes Thewa jewelry truly unique is its meticulous craftsmanship. The





process begins with a finely beaten sheet of pure gold. The artisan engraves intricate motifs-often inspired by mythology, Mughal miniatures, hunting scenes, or floral designs—using delicate tools like chisels and needles. These motifs are not randomly chosen; they often tell stories of Krishna's leelas, royal processions, or nature's bounty, all etched with poetic finesse.

Thewa is more than just jewelry; it is a symbol of Rajasthani heritage and identity. In an age of mass-produced ornaments, Thewa holds its ground as a handmade treasure, representing a fusion of Rajput valor, Mughal aesthetics, and Hindu mythology.

Traditionally, Thewa jewelry was worn during weddings and festivals, passed down as heirlooms from mother to daughter. Today, while it has gained recognition globally, its emotional and cultural significance remains rooted in local traditions.

The artisans of Pratapgarh—mainly from the

Sonewala communityhave kept this 400-yearold art alive despite facing economic and technological challenges. In recognition of their dedication, the Indian government granted Geographical Indication (GI) tag status to Thewa in 2008, acknowledging it as a unique product of Rajasthan.

THEWA IN MODERN TIMES

While the heart of Thewa remains in Pratapgarh, its appeal has reached fashion runways, museums, and global art forums. Designers are now incorporating Thewa elements in contemporary accessories, such as cufflinks, rings, and neckpieces, catering to a newer, global clientele.

International exhibitions and handicraft fairs have provided a platform for artisans to showcase their work, while NGOs and government schemes have attempted to bring modernization in tools and marketing without diluting the authenticity of the craft. Institutions like the National Institute of Design (NID) and Crafts Council of India have also played a role in research and documentation.

Rajasthan, the land of kings, palaces, and vibrant cultural expressions, is renowned not only for its architectural marvels but also for its rich textile traditions. Among the many exquisite crafts that originated and flourished in this desert state, Zardozi embroidery holds a distinct place. Once the pride of royal attire, this intricate needlework of gold and silver threads continues to dazzle in wedding trousseaus, festive garments, and luxury décor. Rooted in regal patronage and perfected by generations of artisans, Zardozi is not just embroidery-it's a shimmering symbol of Rajasthan's opulent legacy.

HISTORICAL ROOTS: FROM PERSIA TO PRINCELY COURTS

The word Zardozi is derived from Persian, where 'zar' means gold and 'dozi' means embroidery. The art is believed to have originated in ancient Persia and travelled to India through trade and conquests, particularly flourishing under the Mughals during the 16th and 17th centuries. It received exceptional patronage from emperors like Akbar, who encouraged its use in royal garments, ceremonial tents, scabbards, wall hangings, and even the trappings of elephants and horses.

Though it had spread across the subcontinent, it found a particularly vibrant home in Rajasthan, where the royal courts of Jaipur, Udaipur, and Jodh-

hallmark of aristocratic fashion and ceremonial splendor. Skilled artisans-often known as zardoz-were invited to these kingdoms to craft elaborate patterns for royal costumes, religious idols, and furnishings.

THE **CRAFTSMANSHIP: THREADS OF GOLD AND PATIENCE**

Zardozi embroidery is a labor-intensive and time-honored technique that requires immense precision. Traditionally, pure gold and silver wires were used, along with semi-precious stones, pearls, and beads, all handstitched onto fabrics like silk, velvet, and satin. The metallic threads were made by flattening gold or silver into fine wires and then twisting them into spirals known as badla and kasav. These were either sewn directly or couched onto fabric using silk threads.

The motifs in Zardozi are often inspired by naturefloral vines (bel), paisleys (ambi), birds, animals, and geometric patterns. Religious themes and Mughalinfluenced designs also play a significant role. Each piece can take weeks to months to complete, depending on its complexity, size, and richness

In Rajasthan, the use of gota, dabka, naqshi, sequins, and katori further adds to the diversity and regional uniqueness of Zardozi. Jaipur, in particular, became a major hub where Zardozi evolved to incorporate elements of Rajasthani color





aesthetics and folk motifs, making it distinct from its counterparts in Lucknow or Delhi.

ROYAL PATRONAGE AND CULTURAL SIGNIFICANCE

Zardozi's glory in Rajasthan

was closely tied to royal patronage. It was an essential component of court costumes, bridal ensembles, and temple textiles. Kings and queens would don elabrelevance. orately embroidered robes, turbans, and stoles as sym-

REVIVAL AND RECOGNITION

While Zardozi enjoyed immense popularity during the Mughal and princely eras, its fortunes declined during British rule due to reduced patronage and industrialization. Many artisans were forced to abandon their craft in search of alternative livelihoods. However, the post-indeby governments and de-

signers to revive the craft. In recent decades, Zardozi has experienced a resurgence, thanks to its adoption by fashion designers and its inclusion in global runways. From bridal couture to accessories and home furnishings, Zardozi embroidery has regained visibility and value.

The Government of India has recognized Zardozi as a traditional handicraft and awarded it a Geographical Indication (GI) tag, which protects the uniqueness of the craft and supports the artisan community. In Rajasthan, especially in Jaipur and Ajmer, various training centers, NGOs, and cooperative societies are working to ensure skill transmission to younger generations.

MODERN **ADAPTATIONS AND GLOBAL APPEAL**

Modern Zardozi has adapted to changing times by using cheaper materials such as synthetic threads, copper wires with gold polish, and plastic beads in place of expensive gold and silver. This has made Zardozi more affordable and accessible to a larger market.

Fashion designers continue to innovate with Zardozi, combining it with contemporary silhouettes, minimalist designs, and fusion wear to appeal to younger audiences. It is now common to see Zardozi not just on heavy bridal wear but also on clutches, juttis, saree

The craft has also found admirers in the international fashion world, with global celebrities wearing Zardozi-embellished garments designed by Indian couturiers. Its ornamental richness and handmade legacy appeal to collectors and connoisseurs of slow, sustainable fashion.

PRESERVING THE LEGACY

Despite its growing visibility, Zardozi faces challenges. especially related to artisan welfare, fair wages, and training infrastructure. Many artisans still struggle with inconsistent income, lack of recognition, and exploitation by middlemen.

There is a pressing need to strengthen artisan clusters, offer design interventions, and ensure market access through exhibitions, e-commerce platforms, and government schemes. Supporting Zardozi artisans not only sustains livelihoods but also safeguards a centuries-old cultural heritage.

Zardozi is more than a craft—it is a narrative embroidered in gold, reflecting the grandeur of Rajasthan's royal past and the resilience of its artistic soul. Every stitch tells a story of devotion, beauty, and timeless elegance. As the world moves toward handmade luxury and cultural authenticity, the golden threads of Zardozi continue to weave Rajasthan's legacy into the global fabric of art and fashion.

RUSSIA-AZERBAIJAN STRAIN: PLANE CRASH & CUSTODIAL DEATHS

Russian-Azerbaijani tensions surged after two Azerbaijani brothers diedin Russian custody.

ensions between Russia and Azerbaijan have escalated sharply in

recent weeks, sparked by a series of troubling incidents involving the detention and deaths of Azerbaijani nationals in Russia, the arrest of Russian journalists in Azerbaijan, and long-standing grievances exacerbated by an unresolved tragedy involving a civilian airliner. These developments have not only strained bilateral relations but also stirred public outrage and diplomatic fallout on both sides. **Custodial Deaths**

The immediate catalyst for the current crisis was a large-scale law enforcement operation carried out by Russian authorities on June 27 in the city of Yekaterinburg, located in the Ural region of Russia. More than 50 Azerbaijani nationals were detained as part of an

case dating back 24 years. This sweep was presented by Russian officials as a legitimate criminal inquiry, but the aftermath of the detentions unleashed a wave of diplomatic fury.

Tragically, two of the detained Azerbaijani brothers, Ziyaddin Safarov and Gusein Safarov, died while in police custody. Their deaths provoked an immediate and forceful response from Azerbaijan, with its Ministry of Foreign Affairs condemning the incident as a "brutal killing." Azerbaiiani authorities alleged that the brothers, along with several other detainees, were subjected to violence and abuse while in custody. Postmortem examinations conducted in Baku reportedly found evidence of severe beatings, contradicting the official Russian narrative.

Pushback In response to the deaths and allegations of mistreatment, Azerbaijan swiftly moved to express its displeasure through various diplomatic and cultural channels. The Ministry of Culture in Azerbaijan canceled all cultural events associated with Russia, including concerts, exhibitions, and festivals, signal-

ing a symbolic withdrawal of goodwill. On the political front, Azerbaijan's Parliament

The Russian side, howwithdrew from a planned

bilateral meeting in Moscow, a clear sign of cooling relations. Furthermore, an official visit by Russian **Deputy Prime Minister** Alexei Overchuk was called off, underscoring the depth of Azerbaijan's anger and disappointment.

These steps demonstrate how deeply the issue has impacted Azerbaijan's government and public sentiment, signaling a readiness to escalate diplomatic consequences in response to

Kremlin's Reaction

by spokesperson Dmitry Peskov, expressed regret over the rising tensions but firmly supported Russian law enforcement's role in the case. Peskov stated, "We believe that everything happening in Yekaterinburg is related to the work of law enforcement agencies, and this cannot and should not be a reason for such a reaction." This response reflects Moscow's position that the situation is primarily a domestic legal matter and resists framing it as a diplo-

matic dispute. Meanwhile, analysts in Azerbaijan have criticized Russia's stance. Political analyst Emil Mustafayev described the incident as an example of xenophobia and ethnic scapegoating, reflecting broader patterns of discrimination against ethnic minorities within Russia. He said, "The killing of Azeris is part of a pattern of tendentious politics where ethnic minorities are used as scapegoats." This sentiment echoes longstanding

concerns about the treatment of Azeris and other minorities in Russia, fueling mistrust and resentment.

In a tit-for-tat move, Azerbaijan's Ministry of Internal Affairs announced on June 30 that it had arrested seven individuals at the editorial office of Sputnik Azerbaijan Radio, a media outlet linked to Russia. In addition, a journalist from the Russian media agency Ruptly was summoned for questioning, signaling a broader clampdown on Russian media operations in Azerbaijan. The following day, eight more Russians were arrested, allegedly part of an organized crime group suspected of involvement in drug trafficking, particularly importing drugs from Iran and distributing them online. Reports indicate that some of these detainees showed visible

signs of physical abuse. These arrests have compounded the diplomatic strain, with Russia viewing them as politically motivated actions that target its citizens and interests in Azerbaijan. The detentions tensions.

The Plane Crash Incident The current crisis is rooted not only in recent events but also in deeper, unresolved issues between the two countries. Azerbaijan hosts around two million ethnic Azeris in Russia, a substantial diaspora community that has often reported experiences of racial discrimination and xenophobia.

One particularly painful flashpoint was the tragic incident in December of the previous year, when Russian air defenses mistakenly shot down a passenger plane en route from Baku to Grozny. The plane was shot down over Chechnya and crashed in Kazakhstan, killing all 38 people on board. The incident severely impacted public opinion in Azerbaijan and intensified criticism of Russia's handling of the tragedy.

Mirjalil Gasimli, a member of Azerbaijan's Parliament, strongly condemned the ongoing discrimination faced by Azeris in Russia and linked it to the recent custodial deaths. He called the events "blatant examples of chauvinism, discrimination, and national prejudice in Russia." Gasimli also criticized Russia's failure to adequately address the plane crash, describing the lack of accountability as "utterly unacceptable." He urged Russia to take steps consistent with international law to resolve the matter.

Yet, as Larry Elliott argues, this demographic change may not be the disaster many fear; in fact, it could bring some positive outcomes for the UK and its economy.

An Ageing Population The UK's population has

grown steadily over recent decades, rising from under 60 million at the start of the 2000s to around 67.2 million in 2022. Projections suggest it will increase further by about five million by 2032. Despite this growth, the fertility rate – the average number of children born per woman in England and Wales currently sits at 1.44. This figure is well below the replacement rate of 2.1 needed to maintain a stable population over time. If this low birthrate trend continues, and if net migration decreases, the UK's total population could eventually begin to shrink. This has sparked concerns among government ministers and policymakers, including Education Secretary Bridget Phillipson, who recently voiced "worrying repercus-

sions" and called for policies to make it easier for women to have children.

SOCIETAL CHANGES AND ECONOMIC REALI-TIES

Understanding the reasons behind the decline in fertility is key to assessing whether intervention is necessary or even desirable. For one, women today are better educated and more career-focused

than ever before. University attendance among women has soared, opening doors to rewarding jobs and career advancement. This has shifted priorities, with many women choosing to delay childbirth or have fewer children in favor of personal and professional development. handouts.

Since 2000, homeownership among 25- to 34-yearolds in the UK has dropped from 59% to 39%, while rents have risen significantly. These pressures make early family formation less feasible for many

Global Efforts & Their Limitations

Several European countries are grappling with similar demographic challenges and have introduced pronatalist policies aimed at encouraging higher birthrates. Italy offers tax-free "baby bonuses," France has a "demographic rearmament" plan, and Hungary provides interest-free loans to women with three or more children. Yet, despite these generous incentives, fertility rates remain below the replacement threshold in all these countries.

This suggests that financial incentives alone cannot overcome the deeper social and economic factors that influence reproductive decisions. Career aspirations, housing market conditions, and broader lifestyle preferences often outweigh government

FALLING POPULATION AN OPPORTUNITY

While the prospect of a declining population might seem alarming, it could actually have several benefits. Economist David Miles, who contributes to the Office for Budget Responsibility's forecasts, argues that fears about shrinking populations are "largely bunkum." He notes that the global population will continue growing for decades, placing immense pressure on the environment and accelerating climate change. From this perspective, a gently falling and ageing UK population could alleviate some of these pressures domestically. Fewer people would mean less congestion,

Making childcare more affordable and accessible is another important step to support working parents. Additionally, as life expectancy rises, extending working lives through pension reforms could help maintain a sustainable labor force.

THE OUTLOOK

Ultimately, the focus should not be on artificially boosting birthrates but rather on adapting to demographic realities. A falling population is not inherently negative and may even be beneficial in terms of environmental sustainability and quality of life. Policymakers should concentrate on creating conditions that allow individuals to make their own family choices without undue economic or social pressure.

Discipline Leader in DSTG's Information Sciences Division, Amanda Bessell, said that Target Motion Analysis was a collective term for target tracking algorithms, developed to estimate the state of a moving target.

"Target Motion Analysis is the crucial element in

maintaining platform situational awareness, when a passive mode of operation is required," Ms Bessell said as quoted by the Department of Defence.

The research project, therefore, is unique in the way as it utilises a towed array-based signal processing system.

DSTG Senior Researcher, Sanjeev Arulampalam, explained a towed array consisted of a long linear array of hydrophones, towed behind a submarine or surface ship on a flexible cable.

'We need to harness the best minds in innovation, science and technology to build new capabilities, to innovate at greater pace, and to strengthen our strategic partnerships.The hydrophones work together to listen to the undersea environment from various directions," Dr Arulampalam said as cited by the Department of Defence.

"The sound signal is passed through a signal processor, which analyses, filters and detects underwater acoustic signals emitted from maritime targets."

The combination of the **Target Motion Analysis** with the towed array system is intended to manage noise corruption and explore pos-

sible performance improvements.

This joint project between India and Australia would see novel algorithms put to test, using the strengths and shared knowledge of the two countries

"The project arrangement will involve the sharing of ideas, investigation trials, algorithm demonstrations and performance analysis," Dr Arulampalam said.







Sub Junior Women National Championship 2025 kicks off

The 15th Hockey India Sub Junior Women National Championship 2025 began on July 3 at the Marang Gomke Jaipal Singh Astroturf Hockey Stadium in Ranchi, Jharkhand. The tournament will run until July 14 and will follow the newly-introduced divisionbased format--first implemented earlier this year during the Senior Men and Women's National Championships

This year's edition will feature 28 teams divided into three divisions--Division A, Division B, and Division C--introducing an added competitive edge with promotion and relegation at stake, as per a press release from Hockey India.

Division A, comprising the top 12 performing teams in the country, will see intense action as the defending champions Hockey Jharkhand and last year's runner-up Hockey Madhya Pradesh lead the challenge for the national title. Division B and Division C will serve as competitive battlegrounds for emerging teams to climb the ranks. *Division Format and Pool

Composition

-Division A (Top-tier Championship Division): Teams compete for the title, and two will face relegation. Pool A: Hockey Jharkhand, Hockey Haryana, Hockey Andhra Pradesh

Pool B: Hockey Madhya Pradesh, Uttar Pradesh Hockey, Hockey Chandigarh

Pool C: Hockey Associawinner. tion of Odisha, Hockey Maharashtra, Hockey Punjab

Pool D: Hockey Mizoram, promotion to Division A; Delhi Hockey, Hockey Association of Bihar

Each team will play round-robin matches within their pool. The top two teams from each pool will qualify for the Quarterfinals (July 11), followed by the Semifinals (July 12) and the Final & 3rd place playoff (July 14). The bottom two teams in Division A will be relegated to Division B next

Liverpool player Diogo Jota and his brother killed in car accident in Spain

Liverpool player Diogo Jota and his brother were killed in a car accident in Spain when the Lamborghini they were in veered off a road and burst into flames, police said Thursday.

The Spanish Civil Guard confirmed to The Associated Press that the 28-yearold Jota and his 25-year-old brother, André Silva, were found dead near the northwestern city of Zamora.

Iota's death comes weeks after he married Rute Cardoso while on vacation

from a long season where he helped Liverpool win the Premier League title. On getting married, she wrote in a social media post, "Yes to forever." He leaves behind him three children, the youngest

born last year. Police were investigating the causes of the accident that occurred past midnight local time. They said there were no other vehicles involved and that the brothers

were alone in the car. The bodies were undergoing forensic analysis.

It wasn't clear who was driving the car. Police were looking into the hypothesis that the accident happened because of a blown tire while they tried to overtake another vehicle.

The crash occurred while Jota and Silva, who is also a Portuguese soccer player, were traveling eastward along an isolated stretch of highway about an hour west of Zamora.



Police were investigating the causes of the accident that occurred past midnight local time.

Video images of the aftermath published by Spanish media showed braking tire marks veering off the road toward torn-apart guardrails. The burnt-up car was seen several meters ahead. with some of the vegetation around it destroyed by the fire. Jota was taking his summer break from soccer after having helped Portugal win the Nations League. That June 8 final against Spain in Munich was his last match. Liverpool's players are due back to start training for next season on Monday. But Jota's participation in the Nations League could have earned him some extra time off before being called back to Liverpool. Liverpool said the club was "devastated by the tragic passing.'
