hina used the fourday India-Pakistan **∕**conflict in May like a "live lab" to test various weapon systems and was providing all possible support to Islamabad, in line with its ancient military strategy of killing the adversary with a "borrowed knife", Deputy Chief of Army Staff Lt Gen. Rahul R Singh said on Friday.

The senior military officer said while Pakistan was the "front face", with China extending all possible support to its all-weather ally, Turkiye was also playing a major role by supplying

lamabad, adding that India was actually dealing with at least three adversaries during the May 7-10 conflict.

In an address at a seminar on "New Age Military Technologies" organised by industry chamber FICCI,



Lieutenant General Singh suggested that China used its satellites to monitor Indian military deployment as the Pakistani military was getting live inputs on it during the DGMO (Director General of Military military hardware to Is- Operations)-level phone

The Deputy Chief of Army Staff highlighted China's ancient military strategy of "36 stratagems" and killing the adversary with a "borrowed knife" to buttress the point that Beijing extended all possible support to Pakistan to cause pain to India.

Lt Gen. Singh, who looks after the Indian Army's capability development and sustenance vertical, said Beijing's support to Islamabad was not surprising as 81 per cent of the military hardware used by the Pakistani armed forces are from China.

"Pakistan was the front face. We had China providing all possible support. Army deputy chief highlighted China's ancient military strategy of killing the adversary with a "borrowed knife" to buttress the point

that Beijing extended support to Pakistan

This is no surprise because if you look at statistics, in the last five years, 81 per cent of the military hardware that Pakistan is getting is all Chinese," he said.

"He (China) would rather use the neighbour (Pakistan) to cause pain (to India) than getting involved in a mudslinging match on the northern border," Lt Gen. Singh said.

He said Turkiye also played an important role in providing support to Paki-

"We saw numerous drones coming and landing in the face of war, dur-

ing the war, along with the individuals who are there," Lt Gen. Singh said.

The military officer underlined the need for India to learn its lessons from the conflict.

"The next important lesson is the importance of C4ISR (Command, Control, Communications, Computers, Intelligence, Surveillance and Reconnaissance) and civil-military fusion. There is a lot to be done as far as this domain is concerned," he said.

"When the DGMO-level talks were on, Pakistan actually was mentioning that we know that your such and such vector is primed and ready for action, and we would request you to perhaps pull it back. So he was getting live inputs from China. That is one place we really need to move fast and take appropriate action," Lt Gen. Singh said.

DALAI LAMA SUCCESSION PLAN

India on Friday said it does not take any position on matters concerning faith and religion, two days after the Dalai Lama, the Tibetan spiritual leader, unveiled a plan for choosing his successor that has been rejected by China.

Ahead of his 90th birthday on Sunday, the 14th Dalai Lama Tenzin Gyatso had on Wednesday affirmed that the institution of the Dalai Lama will continue and that only the Gaden Phodrang Trust will have the sole authority to recognise his future "reincarnation", declaring no one else can "interfere" in his succession plan. The Gaden Phodrang Trust was founded by the current Dalai Lama in 2015 to oversee matters related to the

600-year-old institution of the Dalai Lama.

External Affairs Ministry spokesperson Randhir Jaiswal said the Indian government has always upheld freedom of religion for all in the country and will continue to do so.

"We have seen reports relating to the statement made by His Holiness the Dalai Lama about the continuation of the Dalai Lama institution," he said.

"For New India, even the sky is not the limit."

Modi attended the event hours after landing in Trinidad and Tobago in the second leg of his five-nation tour. It is the first bilateral visit by an Indian prime minister to this Caribbean island nation since 1999.

A study undertaken by by doctors of five different departments of AIIMS in Delhi has confirmed that the Covid-19 vaccine is safe.

According to AIIMS study, no death has happened due to Covid vaccine. Those who have a history of the disease in their family have died. Among those who died suddenly, it was found that these

people used to smoke and consume alcohol. Smokers were found at number one.

The doctors said people who take the vaccine are safer than those who did not take the vaccine. Dr. Rajiv Narang, Professor of Cardiology Department at AIIMS, Delhi, said that chances of sudden death are less among those who have

taken the vaccine. Dr Narang said the deaths that are happening in the



youth due to sudden cardiac arrest are of two types. One is rhythmic problem and the other is hypertrophy cardio myopathy. Apart from this, classical heart attacks are



Amid tall claims of transparency in organizational appointments, the Haryana Congress is reportedly witnessing a fierce round of internal lobbying and factional pressure as the party prepares to announce new district presidents and a new Haryana Pradesh Congress Committee (HPCC) chief after over a decade.

Despite assurances by senior Congress leader Rahul Gandhi that the appointments would follow due recommendations from the Central Observers, a number of state leaders have been camping in Delhi to lobby for their loyalists. The All India Congress Commitsubmitted panels from each district—each including six names balancing caste, gender, and regional representation—but the final list remains under wraps.

Party sources revealed that some senior Harvana Congress leaders have expressed displeasure over the selection process, alleging that they weren't given a fair hearing during panel deliberations. They are now seeking meetings with central leadership to register their objections, further delaying the much-anticipated announcement.

The urgency to restructure the organization stems from the Congress's disappointing performance in the 2024 Lok Sabha elections, where it secured only 37 seats against the BJP's 48. Party insiders and analysts attributed the loss to deeprooted factionalism, poor tee (AICC) observers had grassroots engagement, contention, with the party and neglect of local leadership—factors now pushing the party high command to overhaul the state unit.

While the panels of six candidates for each district president have reportedly been finalized with due SC, OBC, and women's representation, leaders from marginalized communities are demanding more. Haryana SC Department chief Manoj Bagri, in a media briefing, called for greater inclusion of Scheduled Caste workers in the party structure. Bagri also met National SC Department chief Rajendra Pal Gautam and other senior leaders to press for equitable representation. "Our SC workers must get their due place in the organization," Bagri said. Also lobbying is intensifying over the selection of the next Haryana Pradesh Congress Committee President. Several OBC leaders are in keen on strengthening its base among the politically significant Other Backward

Palwal CMO caught taking bribe; demanded Rs 15 lakh, ACB seizes Rs 4 lakh from home

In a major crackdown on corruption in the health department, the Gurugram unit of the Haryana State Vigilance and Anti-Corruption Bureau (ACB) has arrested Dr Jai Bhagwan, Chief Medical Officer (CMO) of Palwal district, for allegedly demanding a bribe of Rs 15 lakh from the owners of a private hospital.

The arrest was made during a late-night trap on Thursday, after a complaint was filed by one of the partners of Sunrise Trauma Hospital, which has



been operating in Palwal for the last three months. The ACB team caught the CMO red-handed while accepting an installment of Rs 1 lakh at his government residence.

ACB sleuths, accompanied by a duty magistrate and independent witnesses, con-

ducted search operations at the CMO's official residence in Palwal, recovering an additional Rs 3 lakh in cash from a cupboard, suspected to be part of previously paid bribe installments

A case has been registered under Section 7 of the Prevention of Corruption Act and Section 308(2) of the Indian Penal Code, 2023, at the State Vigilance and Anti-Corruption Bureau Police Station in Faridabad.

According to the complaint filed with the ACB Gurugram unit, Dr Jai Bhagwan had allegedly been pressuring the hospital management-comprising partners Manohar, Dheeraj, Subhash, and the complainant-for a Rs 15 lakh bribe, threatening to shut down the trauma centre by repeatedly highlighting "deficiencies" in its operations during inspections.

The complainant further alleged that Rs 7 lakh had already been paid to the CMO, with Rs 8 lakh more demanded in one go citing that a portion of the bribe was meant to be passed on to senior of-

Faridkot DSP held for taking bribe, tries to bribe SP to 'suppress' plaint

A Deputy Superintendent of Police (DSP) posted in Faridkot district has been arrested for corruption after he allegedly took a bribe of Rs 1 lakh from a complainant and later tried to bribe a subordinate of Senior Superintendent of Police to suppress a complaint filed against him.

The officer, identified as Rajan Pal, was serving as DSP (Crime against Women) in Faridkot. He has been

booked under the Prevention of Corruption Act and taken into custody. Officials confirmed that departmental action has also been initi-

According to Senior Superintendent of Police (SSP) Dr Pragya Jain, the case began when a woman named Kiranjit Kaur, a resident of Pakka village, filed a complaint saying the DSP had demanded Rs 1 lakh from her brother Karmtej Singh to take action in a matrimonial dispute case. Despite

paying the bribe, no action was taken by the officer.

"When the family approached me, they said the DSP had taken money but did nothing in the case," said SSP Jain. "On Thursday, the DSP came to my office and tried to bribe my staff member, ASI Jaswinder Singh, with another Rs 1 lakh to get the complaint withdrawn. I was alerted immediately, and we registered an FIR and arrested him around 1 am.

ASI Jaswinder Singh, who

works as the reader in the SSP's office, is now the complainant in the corruption case. The FIR was filed at Faridkot City Police Station under the relevant sections of the Prevention of Corruption Act.

"The Punjab government's message is clear: there will be zero tolerance for corruption," said SSP Jain.

Police said further investigation is underway to determine if more people were involved in the bribery attempt.

Ch'garh FM calls for strict action on GST fraud

A crucial meeting of the Group of Ministers (GoM), constituted to make GST revenue collection more transparent, tech-enabled, and efficient across the country, was held on Friday in New Delhi. Chhattisgarh's Finance Minister O.P. Choudhary participated as a member and shared the state's experience, offering significant suggestions such as strict action against bogus traders, the use of modern technology in the registration process, and the curbing of fake input tax credit

claims. The GoM is headed by Goa Chief Minister Dr. Pramod P. Sawant.

During the meeting, Choudhary shared Chhattisgarh's policy interventions and practical insights. The primary objective of the GoM meeting was to assess the challenges in revenue collection and explore comprehensive solutions

Finance ministers from various states discussed the economic and other factors affecting GST revenues in their respective regions. On this occasion, Choudhary highlighted several initiatives undertaken by Chhattisgarh in the fields of anti-



evasion and tax compliance. He informed the group that Chhattisgarh is extensively using data analytics and AIbased tools to prevent tax evasion and facilitate genuine taxpayers. These efforts have significantly contrib-

uted to the state's revenue growth. The meeting also included presentations on advanced platforms such as BIFA, GST Prime, and the E-Way Bill portal. Choudhary recommended the nationwide implementation of such innovations, stating that it would accelerate the identification and action against bogus businesses

The Finance Minister also emphasized the need for a centralized digital mechanism to ensure transparency in the registration process, curb fake billing, and stop fraudulent input tax credit claims. He noted that such measures would not only enhance revenue but also build trust among taxpayers.

Choudhary further highlighted that under the leadership of Chief Minister Shri Vishnu Deo Sai, Chhattisgarh has been conducting regular reviews at the state level and adopting datadriven decision-making processes, which have yielded promising results. He added that the Chhattisgarh model could serve as a useful framework for other states.





In his remarks, Modi lavished praise on the Indian community in Trinidad and Tobago, and said: "They left their soil, but not their soul."

"They left the Ganga and Yamuna behind but carried the Ramayan in their hearts. They left their soil, but not their soul. They were not just migrants. They were messengers of a timeless civilisation," he said.

"Their contributions have benefitted this country -culturally, economically and spiritually. Just look at the impact that you have all had on this beautiful nation," he added.

PM Modi said he brought a replica of the Ram temple and some water from the river Sarayu in Ayodhya.

"You all know that earlier this year, the world's largest spiritual gathering, the Maha Kumbh, took place. I have the honour to carry water from the Maha Kumbh also with me," he said.

"I request Kamla ji (prime minister) to offer the holy waters of the Sarayu River and Maha Kumbh to the Ganga Dhara here. May these holy waters bless the people of Trinidad and Tobago," he added.

PM Modi said India is actively working on creating a comprehensive database of the Girmitiya community. The community comprised indentured labourers sent from British India to work on plantations in South Africa, Fiji, Mauritius and the Caribbean islands.

In his address, the Prime Minister also highlighted the resilience of the Indian economy and its upward

trajectory. "India is the fastest-growing major economy in the world. Soon, we will be among the top three economies of the world. The fruits of India's growth and progress are reaching the most needy," he said.

The Prime Minister said India has shown that poverty can be defeated by empowering the poor and that crores of people, for the first time, have developed the confidence that the country can be freed from poverty.

He said India's growth is being powered by its "innovative and energetic" youth.

"Today, India is the thirdlargest startup hub in the world. Nearly half of these startups also have women as directors. Nearly 120 startups have got unicorn status," he said.

"National missions for

Quantum computing are becoming the new engines of growth. In a way, innovation is becoming a mass movement," he noted.

Modi also showcased India's Unified Payments Interface (UPI), saying it has revolutionised digital pay-

"Nearly 50 per cent of the world's real-time digital transactions take place in India. I congratulate Trinidad and Tobago for being the first country in the region to adopt UPI."

It also pointed out that based on the documents attached or not attached, with the signed Enumeration Form, "eligibility verification of each name included in the draft rolls will be done continuously after their receipt".

"Verification will start vigorously from August 2, 2025 onwards after publication of Draft Electoral Rolls. On the

basis of the published Draft of Electoral Rolls, Claims and Objections will be received from any political parties or any member of public August 2, 2025 onwards," it said.

It also said that the final electoral rolls will be published on September 30, 2025 and appeals can also be filed thereafter with the DM and the CEO. The poll panel has issued

instructions to carry out a SIR in Bihar to weed out ineligible names and ensure all eligible citizens are included in the electoral roll, allowing them to exercise their franchise in the polls slated later this year.

"All those who follow the Dalai Lama feel that the incarnation is to be decided by the established convention and as per the wish of the Dalai Lama himself. No one else has the right to decide it except him and the conventions in place," he had said.

Reacting to a question on Rijiju's remarks made on Thursday, Chinese Foreign Ministry spokesperson Mao Ning said India should be clear of the anti-China separatist nature of the 14th Dalai Lama and honour its commitments on Xizang (Tibet) related issues. China refers to Tibet as Xizang.

"India should exercise caution in its words and actions, stop interfering in China's internal affairs with Xizang related issues and avoid impact on the improvement and development of the China-India relationship," Mao told a media briefing in Beijing.

Rijiju, a practising Buddhist, and Rajiv Ranjan Singh, a fellow Union minister, are representing the Government of India at the Dalai Lama's 90th birthday celebrations in Dharamshala on July 6.

POLITICIANS HITTING A NEW LOW, SAYS HC AS IT GRANTS RELIEF TO BJP MLC

Issues stern directive to Ravikumar to cooperate with the investigation.

The Karnataka High Court, on Friday granted temporary relief to the Chief Whip and BJP MLC N. Ravikumar in the case related to his alleged derogatory, vulgar, and sexist remarks against Chief Secretary Shalini Rajneesh, but the court expressed concern over the deteriorating standards of language used by politicians.

Hearing a petition challenging the FIR and to quash it, the High Court bench headed by Justice SR Krishna Kumar issued an interim order directing that no coercive action be taken against Ravikumar until July 8.

The court also issued a stern directive to Ravikumar to cooperate with the investigation.

Expressing displeasure, the bench observed that the lan-

guage used by politicians has stooped to a new low. "Politicians are going to a new low," the bench remarked.

Ravikumar's counsel submitted that his client, while protesting in front of Vidhana Soudha, had issued a statement criticizing the insensitivity of the Chief Minister and the state government, which was now being given a political twist.

The bench questioned the prosecution on whether the complaint was based solely on a media clip. Responding to this, Special Public Prosecutor BA Belliappa played the video clip containing Ravikumar's alleged derogatory statement at the court's request and urged the bench not to grant him any relief. He also brought to the court's notice that even IAS officers in the state had strongly protested against the remarks.

The prosecutor further argued that granting bail to Ravikumar could demoralize the police force. He also highlighted Ravikumar's alleged objectionable remarks about Kalaburagi Deputy Commissioner Fouzia Tarannum.

Earlier, reacting to the controversy, N. Ravikumar had clarified that he had not made any derogatory remarks against Chief Secretary Shalini Rajneesh.

In a press statement, Ravikumar said, "I am shocked by the circulation of selective video clips and claims in print and social media alleging that I have spoken in a derogatory manner against the Chief Secretary."

The Karnataka police had filed an FIR against Ravikumar on Thursday for allegedly making derogatory remarks about Chief Secretary Shalini Rajneesh.

The Karnataka IAS Officers' Association has condemned Ravikumar's alleged remarks and demanded an unconditional apology. Ravikumar allegedly made the controversial statement on July 1 in the presence of the Leader of the Opposition in the Legislative Council, Chalavadi Narayanaswamy, and several police officials.

According to the Congress, Ravikumar, while expressing displeasure over the Chief Secretary's absence during the submission of a BJP delegation's memorandum, allegedly mocked her by saying she works for CM Siddaramaiah during the day and works for the government at night.

DKS urges Cong workers to work together amid 'CM row'

Karnataka Deputy Chief Minister D K Shivakumar on Friday called on everyone in the party to work together, abiding by the advice and message given by Congress President Mallikarjun Kharge, as he refused to comment on whether he was still in the race to become the CM of the state.

After offering prayers to Goddess Chamundeshwari at the top of Chamundi Hills here, he said, "Efforts may fail, but not prayers", and that he had made his wish before the Almighty.

There has been speculation within political circles, especially among the ruling Congress, for some time now about a possible change in the chief minister later this year, citing a power-sharing agreement between Siddaramaiah and Shivakumar.

"I don't want any discussions now. I have not come here to speak about politics.



I want good for the state. Mallikarjun Kharge is the Congress President; he has given us a message and advice. Abiding by his words, let's all work together," Shivakumar said, responding to a question on whether he was out of the CM race after Siddaramaiah's statement that he would serve a full five-year term.

Speaking to reporters here, Shivakumar said he, along with his family, had offered prayers to Goddess Chamundeshwari for the welfare of the state, himself, his family, and everyone.

Asked whether the time had come for the Goddess to bless him for his prayers, he said, "Efforts may fail, but not prayers—I believe in this. I have prayed to the Goddess and wished for whatever I want."

However, with Siddaramaiah asserting that he will be the CM for the full fiveyear term, Shivakumar on Wednesday said he had no objection and that he would stand by and support Siddaramaiah.Indicating that he had "no option", Shivakumar, who is also the State Congress President, said he would abide by the directions of the high command.

There was stiff competition between Siddaramaiah and Shivakumar for the CM's post after the Assembly election results in May

'The 2.5-year' formula likely to increase difficulties for Congress in Karnataka

The party has tried to show that everything is fine in Karnataka on the surface, but the matter has not cooled down yet. The 2.5-year formula is likely to increase difficulties for the Congress. Chief Minister Siddaramaiah and his faction have received some immediate relief, but as the 2.5-year time limit approaches, tensions are bound to rise within the Karnataka Congress.

It seems unlikely that State President and Deputy Chief Minister D. Shivakumar and his supporters will settle for anything less than the Chief Minister's post. The 2.5-year deadline will be completed in November. Shivakumar's supporters remain hopeful that the Leader of the Opposition fulfill the promise made to them.

For some time now in Karnataka, both factions have been making public statements about the Chief Minister's post. Not only were supporting leaders involved in this rhetoric, but even Chief Minister Siddaramaiah and party president Mallikarjun Kharge joined the fray. Siddaramaiah claimed he would remain CM for five years, while Kharge said the high command would decide what to do.

The first controversy arose from Kharge's statement about the high command, as many questioned why he referred to it separately—since he himself is the party president and part of the high command. As tensions escalated, state in-charge Randeep Surjewala visited Bengaluru and managed to temporarily defuse the situation. For now, the Siddaramaiah faction has received some

relief. However, the issue is far from resolved. Siddaramaiah wanted to expand and reshuffle his cabinet, but D. Shivakumar is not ready for this. His supporters insist that the cabinet should only be expanded after a decision on the Chief Minister's post is taken in November.

Kharge, despite being from Karnataka himself, does not appear to be in a position to take a decisive call. Ultimately, the matter seems to be landing on Rahul Gandhi's desk. The biggest challenge before Rahul now is deciding which leader to disappoint. Siddaramaiah and D. Shivakumar are both powerful figures, and upsetting either could prove costly for the party.

According to political experts, the situation in Karnataka is concerning. As in Madhya Pradesh, the 2.5-year power-sharing formula could backfire on the Congress in Karnataka as well.

A suspect detained in connection with the alleged rape of a Pune IT professional at her home was her friend and not a stranger who gained entry by posing as a courier delivery agent, police said on Friday, casting doubt on her version of the events.

It was the woman herself who took a selfie with him and typed a threatening message in her phone, police commissioner Amitesh Kumar said.

"They know each other for a couple of years and belong to the same community," he said. The 22-year-old woman had claimed that a man who posed as a courier delivery agent entered her flat in Kondhwa area on Wednesday evening when she was alone, and forced himself on her. She passed out, and when she regained consciousness, he was gone, she said.

Before leaving, the accused clicked a selfie using her phone in which her back and a part of his face are seen, and left a message warning that he had taken her pictures and would release them on social media if she reported the incident, she told police.

But after detaining the suspect, who is a highly qualified professional, the police found that the woman herself had taken the selfie, which originally showed his face clearly, edited it, and also typed the purported threatening message.

No chemical spray had been used to make her unconscious (as suspected earlier), Kumar said.

"We are still ascertaining why the victim made allegations of rape and it is still under investigation as the girl's mental state is not good at present," the commissioner

Manipur groups urge Shah not to renew SoO agreements over repeated violations

Four organisations - Indegenous people forum Manipur, Meitei Alliance, Foothill Naga coordination committee and Thadou Inpi — have submitted a joint memorandum to Union Home Minister Amit Shah, urging the Government of India not to renew the Suspension of Operations (SoO) Agreements with Kuki militant groups, alleging repeated violations and a failure to maintain law and order.

In the memorandum, the groups claimed that the Kuki National Organisation (KNO) and United People's Front (UPF), which are signatories to the SoO agreements, were responsible for inciting violence that began on May 3, 2023, in Churachandpur, including arson in Torbung and Kanvai.

Delhi government has halted initiative citing 'certain issues'

elhi vehicle owners have supported the policy restricting fuel supply to end-oflife vehicles (ELVs), calling it a positive step towards pollution control. The development comes as the Delhi government has written to the Commission for Air Quality Management (CAQM), seeking a hold on the directive banning fuel sale to ELVs in the national capital.

Speaking to reporters, a vehicle owner said, "I bought a Scotty in 2017. The decision (not to give fuel to end-of-life vehicles) was wrong for those who cannot afford to buy a new vehicle. When I see a vehicle emitting pollution, I tell them to get their pollution certificate made, because we have to suffer because of them. So this decision of the government is good."

The Delhi High Court on Friday pulled up the Delhi Jal Board for supplying contaminated water in colonies and asked how the authorities could expect the citizens to "drink sewage mixed water".

A bench of Chief Justice D K Upadhyaya and Justice Anish Dayal was hearing a plea alleging residents of Yojana Vihar, Anand Vihar, Jagriti Enclave and other adjacent areas in east Delhi received "highly contaminated potable water" mixed with sewer/sewage in their household taps.

"Unless someone knows the doors of the court, you yourself can't do this? You are asking citizens of this city to drink sewage mixed water?" the bench asked.

The court, which on July 2 asked the DJB to conduct an inspection of the areas concerned, was informed that the agency found water supply pipelines in Yojana Vihar area to be very old and requiring replacement.

The DJB filed a status report based on its survey and agreed on the presence of old and damaged water supply pipes in several house con-



nections, including the petitioner's house and adjoining

The DJB said a tender for replacing the pipes would be invited by July 7 and the contract would be awarded by July 17.

The project was proposed to be completed in 20 days from the date of the contract.

The bench directed that the work related to replacing old and damaged water supply pipes in and around these houses should be completed in any case by August 2025 and any failure would be viewed seriously by the court. On the point of the sewage treatment plant, the DJB counsel informed the court about the ongoing desilting work, which would be com-

DJB said in its status report that the water distribution

pleted by August.



Assam, Meghalaya to sign MoU to define boundaries between States

INDIAN STOCKS SETTLE IN GREEN ON FRIDAY

eeping the intraday gains intact, Indian stock indices settled in the green on Friday, despite continued foreign portfolio investor (FPI) out-

This marks the first jump in the domestic indices after multiple sessions of losses.

The Sensex closed at 83,432.89 points, up 193.42 points or 0.23 per cent. The Nifty closed at 25,461.00 points, up 55.70 points or 0.22 per cent. Sensex and Nifty on a cumulative basis declined 0.4-0.7 per cent during this week.

Among the sectoral indices, Nifty FMCG, Nifty IT, Nifty media, Nifty pharma, Nifty PSU bank, Nifty realty, Nifty oil and gas were the top movers, while Nifty metal and Nifty auto were the top losers, NSE data showed.

"The Indian market is experiencing a pause as investors adopt a wait-and-watch strategy ahead of the impending US tariff deadline, with mixed global cues. Ongoing FII outflows reflect a



risk-off approach, while DII inflows are offering partial support," said Vinod Nair, Head of Research, Geojit Investments Limited

"Following the recent rally, main indices are hovering near peak valuation levels, limiting further upside, which is highly dependent on Q1 earnings and details of the trade deal. In the mid- and small-cap space, the market has shifted to being more stock-specific following the recent recovery," Nair added.

Barring Friday, India's stock benchmarks remained in the red this week, which analysts attribute to profit booking by investors.

The case stems from media reports in April 2024, which suggested that Jane Street and its related entities may have used unauthorised proprietary trading strategies in the Indian options market.

Sebi noted that the JS Group continued to carry out suspicious trading activities, mainly near market closing on expiry day, by making large and aggressive trades to unfairly influence the index, even after receiving a warning in February and making promises to the NSE to stop such practices.

"Such egregious behaviour, in clear disregard/ defiance of the explicit advisory issued to them by NSE in February 2025, amply demonstrates that unlike the vast majority of Foreign Portfolio Investors and other market participants, JS Group is not a good faith actor that can be, or deserves to be,

Microsoft closes its Pakistan office after 25 years

Tech giant Microsoft has announced to shut down its limited operations in Pakistan as part of its global strategy to reduce workforce, which various stakeholders termed on Friday as a troubling sign for the country's economy.Microsoft, while closing its office in Pakistan on Thursday after 25 years, cited global restructuring and a shift to a cloud-based, partner-led model.

The move came as the tech giant cut roughly 9,100 jobs worldwide (or about 4 per cent of its workforce) in its largest layoff round since 2023

Jawwad Rehman, former founding Country Manager of Microsoft Pakistan, urged the government and IT minister to engage with the tech giants with a bold KPI (Key Performance Indicators) driven plan. He said the exit reflected



the current business climate. Even global giants like Microsoft find it unsustainable to stay,he posted on LinkedIn.

Former Pakistan president Arif Alvi, in a post on X, also expressed concern over Microsoft shutting down operations

He claimed Microsoft once considered Pakistan for expansion, but that instability led the company to choose Vietnam instead by late

The opportunity was lost, he wrote.

Jawwad explained that Microsoft didn't operate a full commercial base in Pakistan, relying instead on liaison offices focused on enterprise, education, and government clients.

Crypto Boom: India needs regulatory protection now internet more accessible,

India is no longer confined only to tech start-ups in Bengaluru or investment firms in Mumbai. From the narrow lanes of Jaipur to the by-lanes of Coimbatore and Dibrugarh, a new wave of financial participation is unfolding, which is driven not by metro professionals but by citizens living in Tier-2 and Tier-3 cities who see digital assets as a ladder to financial stability. Industry statistics indicate that roughly 50 percent of India's crypto trading volume is currently coming from these smaller cities, and that participation is accelerating at over 40 percent annually in several areas

What is more surprising is the level of grassroots energy. Training academies in cities like Nagpur are seeing record enrolment. One trainer alone claims to have taught over 1,500 newcomers since 2023.

What's fueling this boom outside the urban core is not just curiosity or speculation, it is practical economic necessity. In many tier-2 towns, access to traditional banking, capital markets, or even stable incomes is limited. Small business owners, homemakers, and students are using crypto to bypass these structural barriers. The average trade sizes, around Rs 10,000, reflect a cautious but hope-

ful attempt to supplement stagnant wages or expand limited savings.

Seven of the top ten crypto-active cities in India today are not metros, but smaller towns that have never been involved in the fintech conversation in the past. As smartphones become cheaper and the

there has already been a convergence of sorts. During and after the pandemic, a remote-work culture and an internet-first mindset allowed even remote users to explore crypto markets. Many young Indians now turn to crypto not for quick gains, but because it represents a real opportunity to understand and participate in the global financial ecosystem.

What is more surprising is the level of grassroots energy. Training academies in cities like Nagpur are seeing record enrolment. One trainer alone claims to have taught over 1.500 newcomers since 2023. Platforms tailored for Indian users have also played a role in making onboarding easier. Social media, YouTube tutorials in vernacular languages, and peer-to-peer discussions have helped simplify what would otherwise be intimidating tech. This kind of access and aspiration explains why India is now ranked number one globally in grassroots crypto adoption. Women are also not left be-

hind in this movement and are joining in greater numbers too. A recent survey recorded a ten-fold increase in female participation, with states like Uttar Pradesh and Rajasthan contributing significantly. For many of these users, crypto represents financial inclusion, independence, and the ability to explore wealth-building avenues beyond traditional gold or savings accounts.

TIBET - THE COLLECTIVE FAILURE OF THE GLOBAL COMMUNITY

ixty Five years have gone by since His Holiness The Dalai Lama, after having fled Tibet, took residence in the small hill town of Mcleodganj in Dharamshala, Himachal Pradesh. Ten years earlier in 1951, the world had witnessed in silence the Peoples Liberation Army of Mao Zedong's China carry out its naked aggression and annexation of Tibet. A peace loving people, persuing their religious activities and preserving their rich culture were invaded and forced into

subjugation. That silence continues, but for a few resultions and photo ops with the Dalai Lama many a times with US congressional leaders,

parliamentary and Tibet

support groups and organ-

isations espousing the cause

of freedom and democracy. My own memory takes me back to the autumn and winter of 1962. The unfamiliar and inhospitable terrain of the North East Frontier (NEFA and present day Arunachal Pradesh) looms large before my eyes. The Gorkha Battalion in which I'd been commissioned just a few months earlier, had been stationed in Delhi after its tenure in the Naushehra region of J&K. As news of hostilities breaking-out with China started spreading, our unit was put on notice for induction into the war zone. A few days later we were airlifted to the North East Frontier region. At that young age we had certain romantic notions of battles and wars, but soon the ugliness and the terror of war hit us. Our own un-

preparedness, the adven-

turism of Lt. General BM Kaul, the blue-eyed boy and reported relative of Prime Minister Nehru, the miscalculations of Defense Minister VK Krishna Menon and his coterie all led to a most shameful debacle of our army, appropriately termed by Brigadier JP Dalvi as 'the Himalayan Blunder'.

During the war and post

cease-fire, we were to come across countless refugees fleeing Tibet. In the Lohit Frontier Division there were atleast half a dozen such camps and shelters for them. The condition of these Tibetan refugees was pathetic. Men and women old and young, children without food for days, drained of energy and stamina, many of them sick, needing to be piggy-backed by stronger youth, faltering, fear and hopelessness, pain and suffering showing in their eyes, women unable to hold back their tears, brutalities and atrocities of the occupying forces of China, sending shudders down ones spine. And still we remained silent. 1989 brought the Noble Peace Prize for His Holiness The Dalai Lama.

Jubilatiouns and celebrations. The Prophet and Apostle of Peace! Compassion, Tolerence, Forgiveness, Universal Brotherhood and Harmony! The torch bearer of Budha's

teachings. We embraced his philosophy, his message of 'love all, hate none'. Congressional medals followed, honours and accolades, world leaders hailing his wisdom, sympathising with the Tibean cause. But beyond that nothing. The champions of liberty, freedom and justice having lost their capacity to show righeous indignation towards blatant violations of human rights, genocide and tyranny, their apathy and passivity, in full play. The sheer magnitude of the tragedy of Tibet defies descriptions.

In retrospect we realise that the blunders of the then Prime Minister, Pandit Jawaharlal Nehru, the then Defence Minister VK Krishna Menon and ofcourse the architect of our defeat

Lt Gen BM Kaul, whose over ambition to become the next Army Chief led to this humiliation of 1962 against the Chinese onslaught, a black spot that was to haunt us for years and years to come. Nehru, we realise now went overboard in his effort to seal a permanent peace-pact with Mao Zedong and Zhou Enlai's China not heading to the frequent warnings of Sardar Vallabh Bhai Patel, India's Deputy Prime Minister and Home Minister, sacrificing Tibet in

the process. It is a historical fact that Tibet was never a part of China, though at the height of China's golden era, they did claim sovereignty over Tibet. During British rule over India which lasted a good two hundred years or so, in the Great Game of the nineteenth century, between Britain and Russia to gain influence over Central Assia, primarily Afghanistan, Persia and Tibet, the China factor was never of much relevance. It's a recorded fact that in the seventh century Songtsen Gampo established a Tibetan Empire covering a large portion of Western China. China has turned into an international bully. Sooner or later it has to be confronted. Its settlements across Arunachal Pradesh and Bhutan threaten the peace process.

Chinese, as part of their covert operations have breached the Dalai Lama's inner-circle, with the intention of subverting the succession procedure, post the Dalai Lama's passing away. Dharamshala, the abode of the Dalai Lama is under constant surveillence of the Chinese regime and it's alleged that money is flowing freely into the willing hands of Chinese-Tibetans, not immure from temptation and the lure of wealth.

Amidst rising speculation, much rhetoric and unconcealed passion, the debate rages. Are we on the brink of the third World War! Perhaps, Russia and Uzbekistan. Israel and Iran. China and Taiwan. Are Education and Vidya, synonymous? Education or Shiksha, imparted in schools provides certification, but may or may not lead to learning. Vidya refers to knowledge and wisdom. It nurtures the intellect and the soul. Imparting and imbibing Vidya, ensures learning.

Music and dance are ace methods for helping children who are specially-abled, to learn as well as express themselves. One expert, presented brain stimulating exercises titled, 'Flex your Cortex'. child. By age five, the brain is 92% developed. For the brain to develop, the child needs to be exposed to learning experiences with people and things, nature, situations, circumstances, etc.

Traditional Indian wisdom encourages mothers to talk to their unborn foetus. Mothers caress their babies especially on their head, while breastfeeding them. This stimulates the brain. Love and care are the greatest emotions that build the emotional wellbeing of a child. A child who is cared for at home often has better neural connections.

Playgrounds created at home do not serve the purpose that community playgrounds do. It is in a playground that the child learns to interact with children from other communities, ages, gender, colour, strata of society, etc. The interactions with different kinds of children, stimulates the neurons of the brain to think, process and understand. n a powerful story of dreams, determination, and innovation rising from humble beginnings, government school students from across Punjab are set to showcase their entrepreneurial creations at the prestigious Indian Institute of Technology (IIT) Ropar on July 5. This isn't a typical school exhibition. It's a live demonstration of what happens when the right policy meets raw talent and passion.

Nearly 50 teams of government school students many from families of daily wage labourers and marginal backgrounds — will pitch their startups before a gathering of industrialists, potential investors, and mentors. The event is part of the Punjab Government's ambitious 'Business Blaster Young Entrepreneur' programme, which has become a launchpad for young innovators in the state's public education system.

A SEED OF CHANGE

Launched in 2022 as a pilot project, the Business Blaster scheme was introduced to instil entrepreneurial thinking in school students, going beyond textbook education. Initially rolled out in just 32 government senior secondary schools across 9 districts, the programme reached 11,041 students in its first year. Encouraged by the overwhelming response, the Punjab School Education Department expanded the initiative statewide.

In the 2024-25 academic session, the programme has now touched 1,920 government schools and engaged over 1.38 lakh Class 12 students, of whom 52,050 have been shortlisted based on their project ideas, feasibility, and innovation. Each selected student received ₹2,000 as seed funding to EXPLAINER

kick-start their business

A MINISTER'S VISION

"This programme is not just about business – it's about confidence, about a mindset shift," said Punjab Education Minister Harjot Singh Bains, speaking ahead of the IIT Ropar event. "We are seeing children of masons, farm labourers, and migrant workers dreaming of becoming job creators, not job seekers. That is the real revolution."

Bains added that 7,500 teams had been selected through a rigorous evaluation process that involved concept pitches, product demonstrations, and community feedback.

To ensure these student ventures are adequately supported, the Education Department has allocated ₹10.40 crore this year, with ₹9.38 crore already disbursed to 46,910 students. The remaining amount is under process.

But with the seed money and motivation provided by the Business Blaster programme, Arjun and his team transformed a simple cycle into a fully functional e-cycle.

The e-cycle, which features a battery, motor, controller, LED lights, and a range of up to 70 km at a speed of 25 km/hr, is not just a prototype. With a 5-year battery life and a 10year motor guarantee, it is a serious product. Already, the team has received 15

"These students learn real-world lessons — from budgeting, product development, marketing to teamwork and public speaking," said a senior officer involved in programme implementation. "This learning is priceless, especially for children who never imagined they could take such bold steps.' Another key outcome is financial literacy. Students manage their seed money, track profits and losses, and

learn reinvestment principles — often for the first time in their lives. The event at IIT Ropar is expected to bring industry

stakeholders, startup mentors, and angel investors into direct contact with these young innovators. "If even a few products catch the eye of industry leaders, we'll see students being incubated, mentored, and taken forward — and that's exactly what we aim for," Bains added.

The Punjab government is also considering institutionalising the Business Blaster programmeby creating incubation spaces in selected government schools, partnering with higher education institutions, and creating a statebacked fund for student entrepreneurship.

Meanwhile, the excitement among the students is palpable. From designing promotional posters to rehearsing their product pitches, the participants are treating the IIT event as a real business opportunity, not just an academic exer-



India's Data Law: A privacy promise or surveillance tool?

In an era where data is fast becoming the new oil, the underlying tension between state surveillance and individual privacy is getting increasingly complicated. With the introduction of the Digital Personal Data Protection Act, 2023 (DP-DPA), India took a huge leap towards codifying a legal framework to govern data processing and safeguard the digital rights of Indian citizens. Yet, numerous legal experts, privacy rights defenders, and human rights organizations have posed an uncomfortable but necessary question—does this law go far enough in safeguarding citizens from the surveillance powers of the State? THE PROMISE OF THE

DPDPA

The Digital Personal Data Protection Act, 2023 was conceived of as the end of a very long road that started in earnest after the Supreme Court's historic judgment in Justice K.S. Puttaswamy v. Union of India (2017), which recognized privacy as a fundamental right under Article 21 of the Constitution. In that ruling, the Court not only recognized the requirement for data protection law but also emphasized the fact

that any interference with privacy must satisfy the tests of legality, necessity, and proportionality.

The DPDPA brings in key concepts of Data Fiduciaries, Data Principals, Consent Managers, and enacts obligations for legal data processing. It provides certain rights to the individual—such as the right of access to information, correction, and erasure of personal data—and assures penalties for breaches. A Data Protection Board is instituted to ensure compliance and impose

On the face of it, these provisions look progressive and in line with international data protection standards. The actual problem lies in what the law decides to exclude, particularly the surveillance by the government.

GOVERNMENT EX-EMPTIONS: THE EL-EPHANT IN THE ROOM

The most criticised section of the DPDPA is Clause 17(2), which empowers the Central Government to exempt any government agency from the provisions of the Act, such as notice requirements, purposes limitation, and consent mechanisms, in the interest of sovereignty, security of the state, public order, or friendly relations with for-

This exemption provision is written in sweeping and vague terms, basically granting a carte blanche to the executive to override fundamental privacy protections. The law makes no requirement for any judicial or parliamentary





input prior to surveillance or data gathering under such exemptions.

On the other hand, privacy as a right under the Constitution cannot be derogated by mere executive order. The Supreme Court, in the Puttaswamy verdict, established that any invasion must be supported by law, must have a legitimate objective, and must be proportionate in character. The exception clause fulfills none of these requirementsit is not specific, does not give independent consideration, and does not provide any effective remedy to affected

THE SURVEILLANCE **LANDSCAPE IN INDIA:** A LEGAL VACUUM

India lacks a surveillance law that is comprehensive in scope. Government surveillance is instead being done under archaic legislation such as the Indian Telegraph Act, 1885 and Section 69 of the Information Technology

Act, 2000. Both these acts fail to provide prior judicial sanction or procedures for interception and monitoring of communications in a transparent manner. In reality, authorisation of surveillance is carried out internally within the executive, which raises grave concerns regarding absence of accountability and abuse of power.

The scandalous Pegasus spyware revelations in 2021, which implicated the targeting of journalists, powers, showed how surveillance without any checks could be used as a weapon against opposition. Refusal by the government to deny or confirm the use of Pegasus, on grounds of national security, merely provided further fuel to public suspicion.

The lack of reference to surveillance reform under the DPDPA, given the Supreme Court's focus on proportionality, stands as a conspicuous omission which

cannot be overlooked. THE ROLE AND INDE-**PENDENCE OF THE DATA PROTECTION BOARD**

The other important weakness of the Act is the composition and operation of the Data Protection Board of India. While introduced as a regulator, the Board is not autonomous-its members, including the Chairperson, are to be appointed by the Central Government, and it is subject to its administrative control.

This puts major doubts on the impartiality of action of the Board in taking recourse against government departments or public sector undertakings. For example, if a citizen's information is misused or gathered surreptitiously by a State agency in the name of "public interest," there is no defined mechanism of grievance redressal or constitutional remedy available within the scheme of this legislation. **GLOBAL COMPARI-**

Additionally, state surveillance has to be authorized by the judiciary and independent review, and citizens can turn to the European Court of Human Rights for violations.

In the US, even without a national data protection statute, a number of surveillance programs such as those under the Foreign Intelligence Surveillance Act (FISA) are governed by specialized courts and have been publicly debated and

litigated. Even the Protection of Personal Information Act (POPIA) of South Africa imposes more stringent controls on access to data by the government than the Indian model, which appears to completely tip the balance in the direction

of the executive. **DIGITAL GOVERNANCE AND DIGITAL CON-**

TROL India's dreams of turning into a digital economythrough initiatives such as Aadhaar, DigiLocker, ONDC, and National Digital Health Mission—are laudable. But in a democratic country like ours, digital governance cannot turn into digital control. Citizens should not be made to compromise between efficiency and freedom.

The privacy-security debate is not a zero-sum game. It is possible—and

advance national interests without diminishing the protection of individuals from arbitrary intrusion. Without such equilibrium, trust in digital systems breaks down and people become ever more vulnerable to abuse by the State as well as by private entities.

THE WAY FORWARD

For India to actually come in line with constitutional morality and global best practices, the following reforms are immediately necessary: 1. Surveillance Reform Law: An independent, overarching legislation that governs central and state agency surveillance, with inbuilt checks and balances, judicial sanction, and accountability regimes.

2. Independent Data Regulator: The Data Protection Board needs to be established as an autonomous body, with appointments through open selection process, and separate funding and reporting structures.

3. Right to Remedy: The people should be provided with the right to be informed when their data has been accessed by public authorities, with an open avenue for obtaining judicial redress.

Privacy is not merely a technological or legal issue-it is a democratic value. To truly honour the Puttaswamy judgment and the Constitution's promise of liberty and dignity, India must reimagine its data protection law not as a tool of regulation alone, but as a guardian of fundamental rights in the digital age.

EU URGED TO DELAY AI ACT ENFORCEMENT AMID INDUSTRY CONCERNS

The EU weighs current delayof the AI Act, balancing clarity, risks, and international regulatory influence.

ith less than one month to go before the first tranche of obligations under the EU's Artificial Intelligence Act (AI Act) applies to general-purpose AI (GPAI) models-a milestone scheduled for 2 August 2025—the European Commission finds itself at the center of a heated debate, receiving mounting pressure from some of the world's largest technology companies and European industry leaders to pause or delay its phased implementation, a request that now sits in tension with the bloc's broader ambition to assert global leadership in regulating artificial intelligence through robust risk-based

The AI Act, which formally entered into force on 1 August 2024, was deliberately structured to roll out in successive waves over a threeyear period to give companies and member states time to adapt. The earliest provisions-prohibitions on unacceptable AI use-took effect in February 2025, while the next wave of obligations targeting GPAI models, such as foundational models developed by Google, OpenAI, Mistral, and others, is scheduled for 2 August 2025, requiring compliance in critical areas such as transparency, technical documentation, copyright adherence, bias and toxicity testing, robustness evaluations, and energy usage reporting. The subsequent wave, targeting high-risk and systemically impactful models, will arrive in August 2026, followed by further measures in August 2027, thereby establishing a clear but ambitious timeline designed to balance regulatory rigor with pragmatic deployment.

DEMAND FOR

CLOCKSTOP In recent weeks, U.S. technology giants including Alphabet (Google) and Meta Platforms, alongside European incumbents such as Mistral and ASML, and a coalition of 45 Europeanheadquartered firmsamong them Airbus, BNP Paribas, Philips, Carrefour, Lufthansa, and Siemenshave issued an open letter to the European Commission requesting a sweeping two-year "clockstop" on the GPAI obligations scheduled for next month, urging the Commission to use its legislative authority to pause enforcement until the AI Code of Practice, accompanying standards, and compliance frameworks are fully finalized and disseminated. These companies argue that

the convergence of intricate regulatory obligations covering transparency, model evaluations, and risk mitigation—combined with legal uncertainties about training data, copyright, and energy efficiency, threaten to overload internal compliance teams, create uneven enforcement across member states, raise compliance costs, and ultimately erode Europe's competitiveness at a time when the U.S. and China continue to grow and

One of the principal jus-

Originally expected by 2 May 2025, the Code is now projected by the European AI Board to be released only by end2O25, a sixmonth delay that leaves companies without official guidance for how to meet obligations. Similarly, harmonised technical standards being drafted by CEN-CENELEC—intended to serve as a presumption of conformity with regulatory requirements-have slipped past their August 2025 target into 2026, depriving companies of clear benchmarks for documenting compliance.

sion has maintained a firm public stance that "there is no stoptheclock, there is no grace period, there is no pause" (Thomas Regnier), reaffirming that the GPAI obligations will begin on 2 August 2025, followed by high-risk rules in 2026. The Commission argues that bending the schedule risks eroding legal certainty, undermining harmonization, and compromising Europe's reputation as the global standardsetter for trustworthy AI—a role it has assumed alongside GDPR.

Member-State Readiness While the Commission emphasizes regulatory clarity, EU member states face practical readiness issues: half of the 27 nations have yet to designate their national overseers and market surveillance authorities responsible for enforcing the AI Act, as well as identify competent authorities and adopt implementing laws. A May 2025 Euronews review found that countries such as Germany, Italy, Portugal, and Romania are still finalizing their administrative structures. Without these bodies fully constituted, doubts arise over whether meaningful enforcement is practical on deadline day. The EU AI Board, which coordinates across member states, has picked up momentum, but oversight infrastructure remains uneven—further fueling industry concerns that obligations may be enacted in theory but

severe lack of enforcement capacity at the EU AI Office: Reddit users citing internal leaks report that the office employs as few as 30 dedicated staff, with total numbers at approximately 85, significantly outmatched by the UK's AI Safety Institute, which reportedly has twice as many. This constraint may delay enforcement and reduce the quality of oversight, undermining the Act's credibility. A widely cited Reddit summary states:

"The EU is at risk of lagging in enforcing its groundbreaking AI regulations due to insufficient staffing ... compared to the UK's AI Safety Institute"

CALENDAR As of midJune, analysts note that any formal delay of GPAI obligations would require swift adoption through the EU's fast-track legislative process, concatenating agreement from the Commission, Council, and Parliament before the Parliament's final plenary week beginning 7 July 2025, with formal adoption by 10 July prior to summer recess. A delay at that point could then retroactively halt the rollout to allow guidance to catch up. Historically, the EU has enacted such clockstopsfor example, suspending the application of the Deforestation Regulation and elements of the Corporate Sustainability Reporting Directive—suggesting that, in principle, such actions remain viable if ministers choose.

Kyiv suffers devastating drone strike, Poland's embassy section damaged

night, Kyiv endured the largest drone strike in the history of its ongoing conflict with Russia, marking a significant escalation in Moscow's aerial offensive. The attack resulted in widespread damage across the Ukrainian capital, injuring at least 23 people, with 14 requiring hospitalization, and severely impacting infrastructure, residential areas, and diplomatic premises, including Poland's consulate.

THE SCALE OF THE

ATTACK According to Ukraine's Air Force, Russia launched a massive barrage comprising 539 drones and 11 missiles targeting Kyiv and other regions. Ukraine's air defenses demonstrated remarkable resilience by shooting down 478 of these drones before they could reach their targets. Nevertheless, several drones and missiles managed to evade the defenses, striking critical locations in Kyiv and causing destruction across the city.

Videos circulating on social media captured harrowing scenes of residents fleeing to shelters, emergency services fighting fires under dark skies, and buildings bearing the scars of explosions. Windows and facades of apartment blocks were blown out. with structural damage evident in various neighborhoods. The assault struck six of Kyiv's ten districts, leaving approximately 40 apartment buildings damaged, alongside passenger railway infrastructure, five schools and kindergartens,

multiple cafés, and numerous vehicles.

The wide-ranging impact of the attack was visible on both sides of the Dnipro River, the natural artery running through the city, reflecting the breadth and intensity of the strike. In the leafy Holosiivskyi district, falling drone debris ignited a fire in a medical facility, adding to the chaos and strain on emergency responders.

IMPACT ON POLAND'S DIPLO-MATIC MISSION

Among the buildings hit was the consular section of the Polish embassy in central Kviv. Polish officials reported damage to their consulate but confirmed that the staff remained unharmed. The strike on the consulate underscores the increasing risks faced by diplomatic missions in the city amid the intensifying hostilities. Despite the damage, Poland reassured the public that its consular personnel were safe, highlighting the ongoing diplomatic challenges in the warzone.

CIVILIAN DISRUP-TION & INFRA DAM-AGE

The attack caused severe disruption to Kyiv's transportation network. Ukraine's state-owned railway operator, Ukrzaliznytsia, announced via Telegram that the assault forced the diversion of several passenger trains, resulting in delays and logistical complications for commuters and travelers.

Air raid sirens wailed across Kyiv as residents scrambled to safety, seeking refuge in bunkers and underground metro stations. The city's three million inhabitants faced heightened anxiety as the drone swarm darkened the skies, a reminder of the persistent threat hanging over daily life.

The assault came hours after a high-profile phone conversation between U.S. **President Donald Trump** and Russian President Vladimir Putin. Trump later stated he made "no progress" toward securing a ceasefire during the talks, illustrating the continued diplomatic stalemate even as violence escalates on the ground.

INTENSIFYING AT-TACKS ON KYIV

This drone strike is part of a broader pattern of intensified Russian air assaults on Kyiv in recent weeks. The city, home to millions, has endured some of the war's deadliest attacks, with the Kremlin increasingly targeting urban centers to destabilize the Ukrainian government and morale.

The deployment of kamikaze drones—unmanned aerial vehicles designed to crash into targets—has become a hallmark of Russia's aerial strategy. These drones are capable of evading traditional defenses and striking with precision, posing a severe challenge to Kyiv's air defense systems.

Despite the heavy barrage, Ukrainian forces have demonstrated effective defense measures, managing to intercept the vast majority of incoming threats.

The resilience of the city's air defenses has limited the

potential casualties and destruction, though the damage from successful strikes remains significant.

Human Cost and Ongo-

The human toll of the attack is sobering. At least 23 individuals sustained injuries, many requiring hospital treatment. Beyond physical harm, the psychological impact on Kyiv's residents is profound, with constant air raid warnings and uncertainty taking a toll on daily life.

Emergency services continue to work under difficult conditions, battling fires and conducting rescue operations amid ongoing threats. The attack on civilian infrastructure-schools, kindergartens, and hospitals—raises concerns about the war's toll on non-combatants and essential services.

A City Under Siege The largest drone strike Kyiv has faced so far highlights the relentless nature of the conflict and the high stakes involved for both sides. Damage to Poland's consulate amid widespread destruction across the capital symbolizes the war's reach beyond purely military targets, touching diplomatic and civilian spheres alike.

As Kyiv grapples with the aftermath, the resilience of its people and defenders remains on display. However, with no ceasefire in sight and hostilities escalating, the city faces continued threats. The world watches as the Ukrainian capital endures one of its darkest chapters, navigating the brutal realities of

However, there is a growing feeling in diplomatic circles that 'strategic autonomy' may have outlived its utility.

The strategic positioning was such that India could also not clearly support old friend Iran or major military partner Israel when they fought an intense 12-day-long war.

Iran as members. The obvious ambiguity has landed India in a delicate position. A dominant share of India's military equipment is of Russian origin, while New Delhi has pursued close military collaboration with the US.

With Russian President Vladimir Putin and Chinese supremo Xi Jinping not in attendance at BRICS, Modi will meet Russian defence minister Sergei Lavrov, where a contentious point would be India's support in a joint Quad declaration that had slammed North Korea and expressed concern about nations closely associating with Pyongyang, such as Russia, China and Iran.

The July 1 joint declaration had said: "We express deep concern about countries that are deepening military cooperation with non-proliferation regime." On the other hand, US President Donald Trump has been very critical of BRICS, which has de-dollarisation and multi-polarity as its primary planks.

Notably, the 11-member BRICS has been growing in importance since its setting up in 2009. Its nations now account for about 55 per cent of the world's population and 42 per cent of the world's GDP. It is also increasingly being seen as a voice for the Global South, of which India has been a keen votary.

In his longest foreign jaunt in more than a decade, PM Modi has already visited Ghana, Trinidad and Tobago, and Argentina before his Brazil trip. He will end the five-nation tour with an official visit to Namibia.

He was produced before the Colombo Chief Magistrate's Court, which remanded him until July 18.

He has been charged with causing a loss of 25 million Lankan rupees by putting pressure on officials to release maize seeds to farmers as an election inducement in the 2015 presidential election of 2015.

His wife, who was his private secretary, and his younger brother, who was the north central chief min-



ister, were sentenced to 16 vears of rigorous imprisonment in April for misappropriation of state resources.

With the arrest of Chandrasena, the island nation has seen its second arrest of a political family.

In mid-June, former health minister Keheliya Rambukwella, his wife, three daughters and a son-in-law were arrested and granted bail by the court. His only son, a former international cricketer, was remanded and released on bail.

At least 21 people were injured after an explosion at a petrol and LPG station in the Centocelle area of Italy's southeast Rome on Friday, causing significant damage to nearby buildings and vehicles, as reported by Eu-

While five individuals were hospitalised with minor burns and injuries from shattered glass, none of the injuries were considered serious

Africa, Latin America and Caribbean; Indian PM on his longest foreign trip to strengthen India's pursuit of brighter Global South

In the middle of a turbulent global political landscape, this week will be significant for India's commitment to fostering global peace and security. Indian Prime Minister Narendra Modi has embarked on his longest foreign tour, visiting five countries: Ghana, Trinidad and Tobago, Argentina, Brazil, and Namibia. The aim of this journey is to enhance India's bilateral, regional, and multilateral relations with nations and organizations in Latin America, the Caribbean, and Africa. While in Brazil, he will take part in the BRICS annual summit, which is being hosted by Brazil this year. Next vear, India will have the honour of hosting the summit that includes BRICS+ nations. Throughout this visit, the primary objective for the Indian Prime Minister is to create oppor-

tunities for strategic partnerships with these countries, focusing on capacity building, defence collaboration, cultural exchanges, digitalization, bolstering counter-terrorism efforts, and advancing the agenda of the Global South to new heights

The Prime Minister of India commenced his visit in Ghana, where he was warmly welcomed by both the President and the citizens of the nation. While in Accra, the Indian Prime Minister engaged in discussions aimed at enhancing bilateral relations in various sectors including investment, energy, health, security, and capacity building. He also had the privilege of addressing the Parliament of Ghana, which he regarded as an honour for two dynamic democracies. Also, he was awarded the highest civil-

ian honour by Ghana. Given its status as a stable and democratic nation, as well as a key member of the African Union and ECOWAS, the West African economic organisation, Ghana is expected to play a crucial role in boosting both bilateral and regional ties for India in Africa. During this important visit, the Indian Prime Minister declared a comprehensive partnership with Ghana and mentioned how the bilateral trade between the two nations has crossed USD 3 billion.

The second subsequent destination was Trinidad & Tobago, a key Caribbean nation. Reflecting on the profound people-topeople connections, the Indian Prime Minister remarked in his speech upon arriving in Port of Spain that Indians first set foot in Trinidad and Tobago 180 years ago, and this visit seeks to revitalize the unique bonds of heritage and cultural affinity. He also discussed India's developmental trajectory and expressed his view of Trinidad and Tobago as a vital ally in this endeavour. The citizens of Trinidad and Tobago appeared to be deeply moved by his visit, and he was awarded the highest civilian honour from this prominent Caribbean na-

tion as well. It is important

to highlight that Trinidad and Tobago is a prosperous nation with a commendable per capita income. Its primary exports consist of oil and gas, which represent nearly 40% of the GDP and approximately 80% of total exports. Furthermore, given the robust civilizational connections with India, it plays a crucial role in enhancing India's influence in the Caribbean region.

After departing from the Port of Spain, Prime Minister Modi will head to Buenos Aires, marking the first bilateral visit by an Indian Prime Minister to Argentina in nearly sixty years. During his discussions with President Javier Milei, the focus will be on several key areas includ-

ing agriculture, essential minerals, energy, trade, tourism, technology, and investment. It is noteworthy that Argentina is part of the Lithium Triangle in Latin America, which is vital for lithium production. and the country actively supports India's advocacy for reforms in the United Nations. The Prime Minister is set

to attend the BRICS Summit taking place in Rio de Janeiro on Sunday this week. He highlighted India's commitment to the forum by clearly mentioning that as a founding member, India is dedicated to BRICS as an essential platform for collaboration among emerging economies. He also made clear that India is working meticulously to foster more peaceful, equitable, just, democratic, and balanced multipolar world order. In addition to his

participation in the summit, he will hold bilateral talks with various global leaders on the sidelines. After the summit, PM Modi will proceed to Brasilia for a state visit, where he will engage in bilateral discussions with Brazilian President Lula da Silva. During this meeting, India and Brazil will evaluate their trade relations, which currently stand at USD 12.2 billion, with the goal of increasing this figure to USD 20 billion. India and Brazil share similar history of colonial rule and have identical national interests. India and Brazil are also working closely in novice areas of international Solar alliance and biofuel alliance.

The concluding segment of the tour will bring the Indian PM to Namibia. which he referred to as a trusted partner with whom India shares a common history of struggle against colonialism. He is scheduled to meet with President Netumbo Nandi-Ndaitwah to establish a new framework for collaboration and to address the Namibian Parliament.

The Indian PM has conveyed his belief that these visits would reinforce India's bonds of friendship across the Global South, strengthen its partnerships and deepen engagements in multilateral platforms such as the African Union, ECOWAS, CARICOM, and BRICS. Undoubtedly, these visits play a significant role in enhancing bilateral relations by establishing a platform for dialogue, which in turn fosters improved multilateral relations and promotes peace, security, and development.

Story of infidelity, betrayal, disloyalty, fickleness, and lack of trust arising among couples out of a variety of reasons, including monotony, loneliness, unfulfilled dreams, unrealised aspi-

rations, career struggles, or probably just to explore something outside of the conventional relationships, makes a very good subject. But to tell this in a beautiful musical, lyrical, melodious, and poetic expression could only come from Anurag Basu, and his innovative experiments in the world of cinema.

Metro In Dino (literally -Metro, these days) captures intense romantic encounters and relationship issues between four couples in a comical yet powerful, rhythmic, expressive, and

harmonious musical blend by Pritam. It's a film where the real impact of the story and screenplay is created by its musical narrative and not just the dialogue.

Pankaj Tripathi as Monty and Konkona Sen Sharma as his wife Kajol, Anupam Kher as Parimal and Neena Gupta as his ex-flame Shibani, Ali Fazal as Akash and Fatima Sana Shaikh as his wife Shruti, and Aditya Roy Kapur as Parth and Sara Ali Khan as his partner represent four couples from different age groups, lifestyles, social backgrounds but with a commonness of living in Metro,

in contemporary times. Each couple is gripped

with unique issues in their relationship and is trying to battle out their situations, encountering or escaping the third party, and dealing with not just the mistrust of the other one but also a lot of misunderstanding, miscommunication, and misinterpretation as the story unfolds over four parallel

Anupam Kher getting drunk is super realistic, Sara Ali Khan getting drunk is funny and ribtickling, while Konkona Sen Sharma getting drunk is a bit of cacophony, but all of them do it well for their respective roles, adding a touch of seriousness, comedy, and theatrics. Pankaj

Tripathi has delivered a variety of expressions brilliantly in his character, including deep love of a husband, affection of a father, flirtatious behaviours of infidelity, pain and guilt of being disloyal to his partner, and comical misadventures while chasing his love back.

Excellent chemistry between Anupam Kher and Neena Gupta as an old couple, and an outstanding performance by Aditya Roy Kapoor, especially with his long tongue-twister dialogues appearing quite a few times, making you laugh as he charms his way through fellow actors. Sara remains bubbly and vivacious while portraying the character of a confused individual, who knows her path but not the destination.

You are bound to sink into the melodies crafted by lyricists Amitabh Bhattacharya, Qaisar Ul Jafri, Sandeep Shrivastava, Anurag Sharma, Neelesh Misra, and Momin Khan Momin, etc., and the music composed by Pritam Chakraborty. Almost a quarter of the film's run time is full of music, and that drastically elevates the whole story and screenplay, which wouldn't have stood on its own probably.

In a strange narrative, the film probably justifies the infidelity, individual



needs, and self-love coming above everything, almost all through the film. However, in the end, it lands up with a message of falling in love with the same person again and again, in a true Bollywood style.

While it's fun to watch the film, it is the music that will bring you real joy!

TAKEN: HOW MARRIAGE BECOMES A WOMAN'S **SOCIAL SHIELD IN INDIA**

66 Thad to catch a flight once at 6 a.m. ... I came out of the house at 4 a.m. and it was dark. A man started following me; I went back to my house and I missed my flight. The next day I booked the same flight. But I stayed at my male friend's house. and he dropped me off. I need a man"- this wasn't an abla nari speaking but an empowered and financially independent woman... Yes, this is someone with a voice.. We are talking about acclaimed actor Neena Gupta.

This stark anecdote wasn't about romance—it was about basic safety and the instinctive reliance on male presence when public spaces feel unsafe. Neena's

words cut through idealism to highlight a hard truth faced daily by many Indian

In India, safety is often not a right—it's a status symbol. And marriage? That's the ultimate credential.

Whether consciously or not, society treats married women as being in a "safe zone." You're no longer considered available. You're taken. That word does more than define your relationship—it protects your boundaries. Once married, society tends to back off-literally and figuratively. You're "taken," and that label alone becomes your strongest armour.

It's not just about romantic interest or flirtation. It's about how you're treatedeverywhere—by the electrician who visits your home, the grocery store guy who insists on chatting a bit too long, the neighbour who stares too freely, or the uncle ji whose eyes linger a little too much. There's an unspoken line they dare not cross when you're someone's wife.

But step outside that role become widowed, divorced, or simply choose to remain single—and that shield dissolves. Suddenly, you're "available." You may not be



saying anything with your words, but society projects all kinds of stories onto your silences. A single woman must have a need, a desire, a vulnerability that's up for discussion, analysis—or ex-

It's a cruel paradox. The institution that is supposed to offer companionship is also what society uses to determine how much respect, protection, or dignity a woman deserves. You become safebecause you're attached to a man. Lose that man, and your vulnerability becomes public property.

This belief is baked into every interaction. It's why single women still hesitate to rent homes alone. Why do landlords ask, "Aapke husband kya karte hain?" before offering you a flat. Why does the local plumber behave differently once he sees a man at home? Why women who've lost their partners are suddenly treated with either suspicion or

The truth is, safety shouldn't be marital-status dependent. A woman shouldn't need a male buffer to earn respect. But in

unsolicited sympathy.



our society, being someone's wife is still a certificate of legitimacy—and being single is, unfairly, treated as a question mark.

Maybe it's time we flipped that script.

"It's strange," says Anjali Tiwari, a 34-year-old PR executive. "The same men who were overly friendly when I was single became professionally courteous once I got married. Suddenly, there were no latenight 'work calls' or unsolicited compliments. I hadn't changed-but their perception of me had."

According to Dr. Radhika Menon, a Delhi-based sociologist, "In patriarchal societies, a woman is 'protected' not by laws, but by her association with a man. Marriage is seen as a proxy for respectability, which in turn influences how much harassment or intrusion she may face. It's deeply flawed,

And yet, women are quietly subverting this equation. More women are choosing singlehood on their own terms. They're installing cameras, hiring staff, of assertiveness, not invis-

Counterpoint? Some argue that the perception of safety post-marriage is not just about gender—it's also about structure. Because ultimately, security shouldn't be marital. It should be societal.

That's the heart of the issue, isn't it? Neena Gupta's statement—"I need a man"—is not about dependence, it's a survival strategy in a society where women are conditioned to borrow safetyrather than own it.

Changing this requires a multi-pronged, societal shift—not just policy tweaks or moral outrage. We need to normalize women's Independence-Visibly and Loudly. Representation matters. Show more single women, widows, and divorcees thriving without apology in films, media, public life. Create a culture

ibility. Too often, women shrink themselves in public to "avoid trouble." That must flip.

Cities must be planned with women at the center: well-lit streets, gender-neutral public toilets, visible security, reliable last-mile transport. Recalibrate the Legal & Police Machinery. Fast-track harassment and stalking cases, which are currently underreported and under-prosecuted. Train police in gendersensitivity. Most women don't report threats because they don't want "to create a scene" or face dismissiveness. Make residential societies more inclusive of single women. Ban discriminatory rental practices. Establish women-only complaint redressal cells in workplaces, RWAs, and housing societ-

Stop teaching girls to stay safe by shrinking their lives. Instead, teach boys boundaries, consent, and consequences.

When a woman says she needs a man for protection, she's not endorsing patriarchy-she's surviving it. But a truly safe society is one where no woman has to look over her shoulder. Or reach for a male shield.

In conditions like PCOS (Polycystic Ovary Syndrome) and PCOD (Polycystic Ovarian Disease), doshic imbalances—especially of Kapha and Vata-are commonly observed. These disorders manifest as irregular cycles, ovarian cysts, weight

gain, and skin or hair issues, and may also impact fertility. Ayurvedic management focuses on restoring systemic harmony through diet, lifestyle changes, herbal therapies, and internal detoxification.

WHAT IS PANCHA-KARMA?

Panchakarma, meaning "five actions," is a cornerstone of Avurvedic treatment aimed at purifying the body and restoring doshic balance. It consists of five age Pitta-related disorders. Each therapy is selected based on an individual's constitution (Prakriti), current imbalances (Vikriti), and specific health condi-

PANCHAKARMA AND MENSTRUAL HEALTH

For women experiencing menstrual irregularities or hormonal imbalances, Panchakarma acts as a reset mechanism. It clears accumulated toxins (ama) that interfere with hormonal



primary procedures:

Vamana (Therapeutic Emesis): Induced vomiting to eliminate excess Kapha and toxins from the upper gastrointestinal tract. Nasya (Nasal Therapy): Application of medicated oils or powders through the nostrils to clear toxins from the head and neck region and balance Kapha and

Raktamokshana (Bloodletting): A traditional blood purification technique used selectively to man-

pathways, enhances nutrient absorption, and restores optimal functioning of the endocrine and reproductive systems.

Detoxifying treatments like Virechana and Basti are especially beneficial in managing conditions like PCOS/ PCOD, which involve sluggish metabolism and hormonal disruption. Basti, in particular, is known to support the reproductive system and regulate the menstrual cycle by nourishing the deeper tissues (dhatus).

SUPPORTING THE DE-TOX WITH LIFESTYLE AND DIET

Alongside Panchakarma, Ayurvedic guidelines recommend a supportive diet and lifestyle to maintain hormonal balance:

Include high-fibre foods like vegetables, fruits, legumes, and whole grains to aid digestion and hormonal

regulation.

Reduce intake of sugar. dairy, and processed foods, as these can aggravate Kapha and Pitta doshas and contribute to inflammation and insulin resistance.

Incorporate spices like

turmeric, cinnamon, and ginger to improve digestion and support detoxification. Practice stress reduction techniques such as yoga, meditation, and pranayama (breathwork), which help regulate stress hormones and support emotional well-being.

HERBAL SUPPORT IN AYURVEDA

Herbs such as Ashoka, Shatavari, and Ashwagandha are commonly used in Ayurvedic practice to support menstrual and hormonal health. Ashoka is known to ease menstrual cramps and promote cycle regularity. Shatavari nourishes the reproductive system, while Ashwagandha acts as an adaptogen, helping the body cope with stress and balance cortisol

CONCLUSION

About 90 per cent of all traffic accidents result from mistakes made by drivers, according to studies. Common driver errors include distraction (like texting or talking on the phone), driving under the influence of alcohol or drugs, and reckless driving. Drivers make poor decisions or fail to react correctly in countless situations on the road. Different measures and strategies are in place to reduce driver error and prevent road accidents. These include training courses to teach drivers basic safety rules and responsible driving habits. There are also public awareness campaigns to promote safe driving.

But all that is about accidents on the road. What about the 'accidents' in our lives? They damage our relationships, our health, our careers, and much more. These 'accidents' too result from driver error - loss of control over our thoughts, words, and deeds, acting under the influence of a weakness (such as anger, greed, or pride), and distraction caused by desires. The driver here is the soul, the sentient being who thinks, reasons, and acts. The body is the vehicle, the physical medium through which the soul expresses itself. Just as a car cannot move unless it is started by a driver, the body does not function without the soul. The soul lends life to the body, and consciousness resides in the soul. Ideas, memories, and emotions are rooted in the soul, not the brain. The brain is a physical organ that receives inputs from the sense organs - the eyes, ears, nose, tongue, and the skin. These inputs from the senses are unpredictable, and may change every moment. How does the brain respond to them? It is not programmed to react to



the inputs. Had that been the case, the response to one kind of sensory input would always be the same. But that does not happen in real life. When confronted again with a situation

that we had faced years ago, our response is not necessarily the same – it may be informed by our past experience and could be different. The soul is the intelligent entity that makes the

choices which determine how the brain responds to stimuli. Just as a driver decides whether to stop the car or swerve to avoid hitting someone, the soul decides how to respond to different people and circumstanc-

But unlike in the case of road accidents, the accidents in our lives are rarely attributed to the driver - the soul. Instead, we look at other people, situations, or even our vehicle, the body, and hold them responsible for our experiences. This is akin to a driver blaming his or her car for an accident, completely absolving themselves of all responsibility. However, this is not surprising. Most people are unaware of the fact that they are souls. The body can be seen and felt, not the soul. So, they think the body is the totality of their existence. The seemingly rationalistic - but rather simplistic - idea that seeing is believing, leads many to ignore or doubt the existence of anything beyond the physical realm. The metaphysical is at best a mystery to them, and at worst a deception. It takes courage, and honesty, to go beyond the physical dimension and explore the field of higher consciousness. The rewards are immense. Recognising our spiritual identity brings under-

the law of karma. Our actions are seeds that produce the fruit of our experiences. In other words, all that we go through in life - good or bad - is the result of our own karma. This knowledge encourages us to act responsibly, and wisely, fully aware that the consequences of what we do will surely come to us one day. Every action has an equal and opposite reaction, is a guiding principle for building a happy life. If we ensure that our actions are good, beneficial, charitable, then their karmic return will be of the same quality. When I, the soul, live with this awareness, then the journey of my life is free from accidents. India pacer Mohammed Siraj struck twice in as many balls but Jamie Smith swung the momentum back in England's favour with a counter-attacking hundred as the hosts raced to 249 for five at lunch on day three of the second Test here on Friday.Despite the swashbuckling effort from Smith (102 batting off 82 balls), England remain far away from India's 587 all out.

Smith smashed a memorable hundred in less than a session and Harry Brook (91 batting off 127) was on course to reach three figures at the break.

Strikingly, England hammered 172 runs in 27 overs in the first two hours of play. Resuming the day at 77 for three, England lost half their side in the second over of the morning session when Siraj had Joe Root (22) and Ben Stokes (O) caught behind. Root's was a soft dismissal as he got faint tickle down the leg side while Stokes was surprised to get a sharply



rising ball first up.

England were reduced to 84 for five but Smith and Brook continued to attack and put pressure back on the opposition.

Prasidh Krishna was brought in to implement the short ball plan with six fielders on the leg side but that failed as Smith got the better of him in the 12th over of the morning that yielded 23 runs. Four boundaries and a six over deep square leg came in that eventful over.
