SC REFUSES TO STAY BIHAR ELECTORAL ROLL REVISION

he Supreme Court Thursday refused to stay the Election Commission's Special Intensive Revision (SIR) of voter lists in Bihar.

"We cannot stop a constitutional body from doing what it is supposed to do. Simultaneously, we will not let them do what they are not supposed to do," said a bench of Justice Sudhanshu Dhulia and Justice Joymalya Bagchi.

The Supreme Court has scheduled the matter for a detailed hearing on July 28. This comes just days ahead of the August 1 release of the

draft electoral roll in Bihar. The court was hearing several petitions claiming the revision could lead to

valid voters being unfairly removed from the list. This, petitioners argued, may happen just before the Bihar Assembly elections. The bench noted: "There is a democratic process on we cannot stay it."

The bench made it clear that the manner in which the revision is being carried out will be subject to judicial scrutiny.

The bench said it was not doubting the credentials and sincerity of the election commission in doing the exercise which was a constitutional mandate but said the timing of the process were raising doubts.

Dwivedi responded while referring to Article 326 of the Constitution and said everv voter has to be an Indian citizen and "Aadhaar card is not proof of citizenship".

Justice Dhulia said, "If you are to check citizenship under SIR of electoral rolls in Bihar, then you should have acted early; it is a bit late." The bench, in the mean-



Punjab okays Rs 10 lakh health cover scheme

The Punjab cabinet on Thursday approved the Mukh Mantri Sehat Yojna — a first-of-its-kind scheme in the country to provide cashless medical treatment worth Rs 10 lakh to residents of the state. A decision to this effect was taken during a meeting of the Council of Ministers held under the chairmanship of the Chief

Minister at his official residence. A spokesperson from the Chief Minister's Office said the scheme will be rolled out on October 2. Under the Mukh Mantri Sehat Yojna, every family in the state will

now be eligible for cashless treatment of up to 10 lakh. With this, Punjab has become the first state in India where every household is entitled to such a healthcare coverage

The scheme will benefit the entire population of three crore residents and more than 550 private hospitals have been empaneled

Previously, a family could avail of treatment only up to Rs5lakh; this limit has now been enhanced to Rs10 lakh.

Previously, a family could avail of treatment only up to 5 lakh; this limit has now been enhanced to 10 lakh. By launching this initiative, Punjab has set a new benchmark for the rest of the country, becoming the first state to offer free healthcare,

education, electricity, and bus travel to its citizens.

Under this scheme, every citizen of Punjab - including government employees and pensioners - will be entitled to free healthcare, regardless of income level. Previously, only select families qualified for benefits under income-based criteria, but now the scheme covers all residents.

Health cards under the scheme will be issued at Seva Kendras or Common Service Centers (CSCs). Additionally, citizens can register online using their Aadhaar card or Voter ID to obtain a health card. Treatment under the scheme will

mid escalating tensions over wa-Ler sharing with Haryana, the Bhagwant Mann-led Aam Aadmi Party government in Punjab is set to introduce a resolution in the state assembly on Friday, formally opposing the deployment of Central Industrial Security Force (CISF) personnel at the Bhakra-Nangal dams managed by the Bhakra **Beas Management Board** (BBMB).

"We will bring a resolution in the Assembly to overturn the decision made by the Congress government, which had paved the way for CISF deployment at Punjab's dams and compromised the state's rights. If we can guard our borders, we are more than capable of securing our dams ourselves", Punjab chief minister Bhagwant Mann said during an interaction with media persons.

The move marks a significant assertion of state authority as Punjab seeks to reclaim control over the



security of its key water infrastructure. The decision follows the Cabinet's formal withdrawal of consent granted by the previous Congress-led state government in October 2021.

The Mann government has strongly objected to the Centre's recent move to sanction a contingent of 296 armed CISF personnel at the Nangal dam in Punjab. This deployment, according to the Centre, was meant to provide a counter-terrorist security cover amid a growing dispute between Punjab and Haryana over water allocation.

Addressing the media after a Cabinet meeting earlier this week, Finance Minister Harpal Cheema stated. "The previous Charanjit Singh Channi-led Congress



to the CISF deployment in October 2021. We have withdrawn that consent with immediate effect and will bring a special resolution in the Assembly to officially reject any central deployment at the dams."

Chief Minister Bhagwant Mann echoed this stance, claiming that the Punjab Police is "fully capable" of securing critical infrastructure in the state. Mann has been a vocal critic of the Centre's move, having previously raised objections during a NITI Aavog meeting in New Delhi. The Centre's May decision to deploy CISF troops came amid heightened tensions

between Punjab and Haryana over the sharing of river waters, particularly from the Bhakra system. With government had consented both states laying claim to a fair share of water from the Nangal dam and BBMB reservoirs, Punjab sees the central security deployment as an attempt to override the state's autonomy.

The BBMB, set up under the Punjab Reorganisation Act of 1966, manages water and power resources shared among Punjab, Haryana, Rajasthan, and Himachal Pradesh. In recent years, Punjab has accused the Centre of trying to dilute its representation in BBMB by appointing officers from outside the state.

In 2022, the Punjab Assembly had passed another resolution objecting to the central government's decision to appoint non-Punjabi officers to the BBMB board a move that was seen as an erosion of Punjab's stake in the dam management system. The resolution against CISF deployment, while not legally binding on the Centre, could intensify the standoff and bring greater focus to Punjab's ongoing demands for greater autonomy over its water and law enforcement policies.

Cong hails SC suggestions on Bihar voter list revision

The Congress on Thursday said the Supreme Court's suggestion that the Election Commission (EC) should allow Aadhaar cards, voter-ID cards and ration cards in the Special Intensive Revision of the electoral rolls in Bihar has come as

a "relief for democracy". Congress general secretary, organisation, K C Venugopal pointed out that the apex court will hear the case again later this month, while expressing hope that the EC will go with the court's suggestion.

"Basically, it is a relief for democracy. The case is again fixed for the 28th of this month," Venugopal told reporters, when asked about the Supreme Court's suggestion. He said the court asking the EC to allow Aadhaar cards, ra-

'Acting like party cell of BJP': Tejashwi targets ECI over Bihar's roll revision

Don't cry, try wooing voters: BJP to Oppn TDG NETWORK NEW DELHI

The BJP on Thursday said the apex court allowing the Election Commission to continue with the Special Intensive Revision of the electoral rolls in Bihar was a "setback" to the opposition parties protesting the exercise and asked them to work hard to woo their voters, instead of raising hue and cry over it.

BJP MP and the party's national spokesperson Rajiv Pratap Rudy said that the poll panel initiated the special intensive revision in Bihar ahead of the assembly polls in the state to ensure that only eligible voters exercise their franchise.

"It's the Election Commission's constitutional right," the MP from Bihar's Saran Lok Sabha seat said.

"The Opposition parties had approached the Supreme Court on the issue. But, the apex court did not stay the process. It's a major setback to the political parties which started this campaign (against the revision of electoral rolls in Bihar)," Rudy said, when asked for a comment.

These opposition parties must now be scared and have started sensing their defeat in the upcoming Bihar elections, the former Union minister

India-US trade deal: Farmers welcome maize,

In a major crackdown on illegal online betting operations, the Directorate of Enforcement (ED), has uncovered financial fraud amounting to over Rs 419 crore during search operations targeting Probo Media Technologies Pvt. Ltd. - the operator of the popular online gaming platform "Probo."

The raids, conducted on July 8 and 9 at four premises across Gurugram and Jind of Haryana, were part of an investigation under the Prelegitimacy and intent of the capital flow.

During the raids, the ED seized incriminating documents and digital records. Authorities also froze investments worth Rs 284.5 crore. including fixed deposits and equity holdings. In addition, three bank lockers linked to the accused have been sealed pending further investigation. The probe exposed several disturbing practices – the platform had no checks to prevent minors from registering, failed to follow proper Know Your Customer (KYC) procedures, and used misleading advertisements to attract users. The app also promoted betting disguised as opinion trading, even allowing predictions related to sensitive topics like election results, raising ethical and legal red flags.





Siddaramaiah, when pressed further that few

Cong claims 16 bridge-collapse incidents in Gujarat in last 4 years, seeks SIT probe

A day after a bridge collapsed in Gujarat, the Congress on Thursday claimed that 16 such incidents took place in the state in the last four years and demanded an SIT to probe them, threatening to take to the streets if its demand is not met

Seeking the resignation of Chief Minister Bhupendra Patel, the opposition party also slammed the BJP over the bridge collapse in Vadodara district, alleging its leadership and government have crossed all limits of indifference as they remain busy in making speeches and issuing advertisements in the name of governance.

Congress president Mallikarjun Kharge alleged that there was a leadership crisis, corruption all around and incompetence prevailing under the BJP rule, and asserted that the people would give a befitting reply when the time comes.

At least 15 people were killed as several vehicles plunged into the Mahisagar river after a portion of a four-decade-old bridge collapsed in Vadodara district on Wednesday morning.

A slab of the Gambhira-Mujpur bridge, which connects central Gujarat to the Saurashtra region of the state, collapsed at around 7 am on Wednesday. This caused the vehicles passing through the bridge to plunge into the river.

"Accidents have become a common thing in the country. Sometimes a train accident, sometimes a bridge developing cracks soon after inauguration. Flight Lieutenant Rishi Raj Singh, who died in a crash of a Jaguar fighter plane during a routine sortie near Churu in Rajasthan on Wednesday, was fascinated by fighter planes from childhood and dreamt of becoming a fighter pilot, his family member said.

South Delhi colony marks 8 years of zero landfill waste

At a time when Delhi grapples with mountains of garbage and choking pollution, one residential colony in South Delhi has achieved something extraordinary: for the past eight years, not a single bag of waste generated by its 280 households has gone to a landfill.

From plastic wrappers, kitchen scraps, sanitary waste, expired medicines, electronic waste and old furniture to broken toys,



clothes and footwear, eva 'zero waste to landfill' model. Even benches for ervthing in Navjiwan Vihar is either composted, public spaces have been recycled, repurposed or created using almost 900 responsibly disposed of. kg of plastic waste. The residents named it Behind this change

is 52-year-old Dr Ruby Makhija, an eye surgeon who took over as Navjiwan Vihar Resident Welfare Association (RWA) secretary eight years ago and decided to fix one of the most common yet most overlooked urban problems of waste management.

"I was a doctor, and I knew how health is connected to our environment. I had read about the solid waste management rules and realised how badly we needed to implement them," Makhija said.

Describing her journey, "We began small. We studied, experimented, and got support from the MCD. Initially, we used compost pits, but those had issues of space and smell.

Over time, we switched to machines and more effective solutions," Makhija added.

Today, around 125 kg of kitchen waste is composted daily, which nourishes the colony's gardens. Dry waste like paper, metal, plastic and glass is sent to certified recyclers.



Maharashtra Assembly passes Special Public Security Bill

The Maharashtra Assembly passed the Special Public Security Bill on Thursday, aiming to counter radical left ideologies and organisations allegedly promoting unlawful activities across the state.

Chief Minister Devendra Fadnavis tabled the Bill in the Legislative Assembly.

The bill, which was first introduced during the Winter Session in Nagpur in December 2024, returned to the House after a Joint Committee, led by BJP leader Chandrashekhar Bawankule, reviewed over 12,000 suggestions for amendments.

Fadnavis stated that the revised draft was prepared following detailed deliberations and concerns raised by

Police continue action Calcutta HC seeks report on Bengali workers' detention

The Calcutta High Court on Thursday directed the West Bengal Chief Secretary to appoint a nodal officer to get in touch with the authorities in Odisha and take necessary steps to ensure release of Bengali-speaking migrant workers from the State who were detained there. Citing news reports. State senior counsel Kalyan Banerjee said 200 Bengali speakers from West Bengal and some in Assam were arrested solely for their mother tongue.

On Thursday, a Division Bench of Justice Tapabrata Chakraborty and Justice Reetobroto Mitra of the Calcutta High Court also directed the West Bengal Government to act immediately and submit a report to the court in this regard on Monday.

According to reports, Odisha's Jharsuguda district police have detained 444 Bengali-speaking individuals for "verification" under suspicion of being undocumented Bangladeshi and Rohingva nationals. The individuals detained are primarily engaged in construction, mining, and industrial labour, and have been residing in various parts of western Odisha. The crackdown was initiated on the advice received from the Union Ministry of Home Affairs. The Calcutta High Court

Centre grants tax exemption benefits to IREDA bonds

The central government has granted tax-saving status to PSU renewable projects financing company IREDA $Ltd's \, bonds \, under \, Section \, 54 EC \, of \, the$ Income Tax Act.

This will facilitate low-cost fundraising for renewable energy and offer capital gains tax exemption to investors.

The Central Board of Direct Taxes (CBDT) under the Ministry of Finance has notified bonds issued by the Indian Renewable Energy Development Agency Ltd. (IREDA) as 'long-term specified asset' under section 54EC of the Income-tax Act, 1961.

The notification came into effect from July 9, 2025, as per a statement from the Ministry of New and Renewable Energy on Thursday.

As per the notification, bonds redeemable after five years and issued by Long Term Capital Gain (LTCG) up



IREDA on or after the notification date will qualify for tax exemption benefits under section 54EC of the Income Tax Act, 1961, which allows capital gains tax exemption on investments in specified bonds.

"The proceeds from these bonds will be utilised exclusively for renewable energy projects capable of servicing debt through their project revenues, without dependence on State Governments for debt servicing," said the MNRE statement.

Eligible investors can save tax on

to Rs 50 lakhs by investing in these Bonds in a financial year.

IREDA will benefit from lower costs of funds, a significant development for the renewable energy sector, which in turn supports the expeditious development of the renewable energy sector. Welcoming the move, Pradip Kumar Das, Chairman and Managing Director, IREDA, said, "We are deeply grateful to the Ministry of Finance, Ministry of New & Renewable Energy and Central Board of Direct Taxes for this valuable policy initiative."



RECLAIMING GORAKNATH: LALU PRASAD YADAV'S CULTURAL COUNTERSPIN

'hen Lalu Prasad Yadav decided to turn storvteller. it wasn't just nostalgia or literary curiosity that drove him. It was a strategy.

In his latest collaboration with journalist and folklorist Nalin Verma, Lores of Love and Saint Gorakhnath, [Penguin Random House] the former Bihar Chief Minister steps into the terrain of cultural politics – a domain long dominated by his political rival, Uttar Pradesh Chief Minister Yogi Aditya-

nath. But instead of wielding rhetoric or reforms, Yadav chooses lores. And instead of temple takeovers, he chooses storytelling. The target: Gorakhpur's Gorakhnath Mutt, an institution now synonymous with "militant Hindutva". The goal: to return Gorakhnath to the people who once danced to his ballads – Hindus and Muslims alike

At first glance, the book reads like a collection of folklore and romance – tales of Sorthi and Brijbhar, Heer and Ranjha, Saranga and Sadabrij. But its true subtext is much more ambitious. Yadav and Verma are trying to dismantle a stranglehold — Yogi Adityanath's singular grip on the legacy of Saint Gorakhnath. They do this not through polemic, but through poetry; not through manifestos, but through mythology. In the process, they transform the spiritual core

of a region where the personal is always political.

BREAKING THE MAHANT MONOPOLY

and more as a power base — one that has produced not just mahants but MPs, MLAs, and a sitting Chief Minister. The transformation began in the 1930s, when Mahant Digvijaynath aligned the Mutt with the Hindu Mahasabha. Avaidyanath followed suit. Adityanath's tenure as both mahant and Chief Minister underscores this metamorphosis. Once a centre of composite culture – where, for instance, Nawab Asafud-Daulah donated land to a Muslim fakir devoted to Gorakhnath — the temple now stands as a symbol of exclusionary politics.

But in the introduction to Lores of Love, Yadav and Verma chart a different trajectory – one where Gorakhnath emerges not as a sectarian icon, but as a subcontinental mystic. The authors write:



YOGI VS YOGI

Yogi Adityanath may wear saffron and head the Mutt, but the "original" Yogis the Kanphattas, the Rawals, the Darwes, the Gosawis – belonged to weavers, potters, shepherds, and dyers. They were singers, palm readers, and magicians. Some were Hindu. Many were Muslim. And they found common spiritual ground in Gorakhnath.

According to the book, in places like eastern UP

of Hindu and Muslim Yogis once thrived. In Punjab, they were called Rawals. In Bengal, jugis. In Hyderabad, Darwes. And they didn't just meditate — they sang ballads, performed rituals, and shared verses of Kabir, Raidas, Nanak, Dadu, and Meera.

By shining a light on these forgotten followers, Yadav is reclaiming Gorakhnath from the narrow confines of temple politics and restoring him to the pluralistic soil that first gave him life.

FOLKLORE AS RESISTANCE

Why do this through folklore? Because folklore travels. It slips past censors and cvnics, outlives regimes, and lodges itself in memory. Ballads like Sorthi-Brijbhar or Bhartrihari-Pingla carry within them not just the morality of saints, but the defiance of the marginalised. Take the tale of Brijbhar a lower-caste lover who, under the guidance of Gorakhnath, wins back his beloved

from a powerful oppressor. Or Heer-Ranjha, where Gorakhnath's wisdom becomes the bridge between

a society's traditions and a couple's longing. In every a punisher and more a liberator. He stands with the wronged, not the righteous. He blesses love, not just lineage. Amid Israel-Iran tensions, Iran's fast uranium enrichment and the unraveling 2015 nuclear deal raise fears of a nuclear crisis as October 2025 nears, deepening global geopolitical divides.

"Movers and Shakers' across the globe hiccup as the volatile ceasefire between Israel and Iran continues to hold. The world is simmering in the heat of unresolved wars - while two powerful leaders of Iran and USA trade barbs, ultimatum, and fatwas across the internet in the aftermath of the Israel-Iran's 12-day war. However, there's a darker, silent crisis unfolding in the shadows of peace in the light of the uranium enrichment in the Middle East.

October 2025 looms large in the minds of the UN Veto Power Owners and the EU. Though the date was meant to be a countdown to peace, it is now a ticking clock for Iran's nuclear uncertainty. The 2015 JPCOA was once hailed as a diplomatic victory. However, since the US unilaterally walked out of this iconic deal that was brokered by the Obama Administration between the P5+1 and Iran 2018, its sunset clauses now function like a nuclear red line.

Iran is back in the headlines after the intense exchange of hostilities with Israel and USA. However, the fact remains that while the Ayatollah regime swears it has no nuclear power ambitions, it was stockpiling 60% enriched Uranium at a breakneck pace. It seems with China and Russia backing the regime against the USA and its allies - Iran is waiting to postpone talks to force its way into the power circles. While world powers scramble, Tehran calculates. And the stakes? Atomic.



IAEA unable to access Iran's uranium or nuclear sites

since early 2023. Iran's facilities at Fordow, Natanz, Isfahan, and Arak operate under opaque protocols. Thus, shielding the entire nuclear program from international scrutiny. Intelligence analysts believe Tehran has already mastered the enrichment infrastructure. What's missing is time and the political trigger to assemble a device.

This has rattled the P5+1 -China, France, Russia, the UK, and US, plus Germany - into resuscitating the broken corpse of nuclear diplomacy with Iran. Not for trade or profits' sake, but to delay the inevitable - a nuclear-armed Islamic theocracy in the Middle East that funds and arms the terrorists groups.

OCTOBER 2025 TRIGGER: A SANCTIONS EXPIRY **NO ONE CAN AFFORD**

There are two sets of sunset clauses under the 2015 JCPOA. The first set of these clauses expires in October 2025. This particular clause legally allows Iran access to its more modern nuclear enrichment sites. Many believe that Iran was already using these sites clandestinely since 2018 to fulfil over, it shall have some of its its dangerous nuclear arms



"I have taken a step outward only after unlocking all the doors-this, truly, is the beginning of the inward journey."

These resounding words of Jain Muni Kshamasagar Maharaj are not just devotional musings; they summon us to a sacred form of attentiveness. When we stand before a work of art, are we truly beholding it? Or merely gliding across its surface, unaware of the silence that breathes beyond form?

In the Indian tradition of aesthetics, to see is more than to look it is an invocation. Darshan is a sacred gaze, not an act of sight but an act of being seen, a simultaneous revelation. It is the eye of the self, the antardrishti that opens. What appears to be a simple act of looking is, in truth, a lavered meditation, sacred encounters that stretches inward. The space between the seer and the seen is not just physical but profoundly metaphysical, a crossing from surface into essence. The Nyaya philosophical system gives us the idea of anumiti, knowledge that ripens through a blend of perception (pratyaksha), inference (anumana), comparison (upamana), and testimony (shabda). This layered knowing reminds us that true vision does

Importantly, there is no final rule for how to see a painting. Every act of beholding arises from the ripeness of our own inner climate-our memory, intuition, and vulnerability. 

The Trump administration is orchestrating a major overhaul of NASA's workforce, with plans to eliminate at least 2,145 senior-level employees-mostly in GS-13 to GS-15 ranks-through early retirements, buyouts, and deferred resignations. These employees hold key technical and managerial roles, critical to the core missions of space exploration, science, and human spaceflight. According to internal documents obtained by Politico, of the 2,145 positions targeted, 1,818 belong to missioncritical areas such as science, engineering, and crewed mission planning. The remaining 327 are in support functions like IT, finance, and facilities. This shake-up affects all ten NASA regional centers, with the most significant cuts at the Goddard Space Flight Center (607 positions), Johnson Space Center (366), and Kennedy Space Center (311).





As she wept over the bodies of her three grandchildren, others holding the bodies struggled to let go before they were sent to burial.

Palestinians are desperate for an end to the war that has killed tens of thousands, destroyed vast areas and displaced around 90% of the territory's population. Aid groups say Israeli restrictions and the breakdown of law and order have made it extremely difficult to deliver humanitarian assistance, leading to widespread hunger and fears of famine.

In the sprawling coastal Muwasi area, where hundreds of thousands of people live in tents after being displaced from their homes, Abeer al-Najjar said she had struggled during the constant bombardments to

get food and water for her family.

"I pray to God that there would be a pause, and not just a pause where they would lie to us," she said, referring to an earlier ceasefire that Israel ended in March. "We want a full ceasefire."

Her husband, Ali al-Najjar, said life has been especially tough in the summer, with little access to drinking water. "We hope this would be the end of our suffering and we can rebuild our country again," he said, before running through a crowd with two buckets to fill them from a water truck. People chased the vehicle as it drove away to another

location. Amani Abu-Omar said the water truck comes every four days, not enough for her dehydrated children. She said the summer heat and harsh conditions have caused skin rashes.

The Trump administration announced Wednesday that it is issuing sanctions against an independent investigator tasked with probing human rights abuses in the Palestinian territories, the latest effort by the United States to punish critics of Israel's

21-month war in Gaza. The State Department's decision to impose sanctions on Francesca Albanese, the U.N. special rapporteur for the West

Bank and Gaza, follows an unsuccessful U.S. pressure campaign to force the international body to remove her from her post. It also comes as Israeli Prime Minister Benjamin Netanyahu is visiting Washington this week to meet with President Donald Trump and other officials about the war in Gaza and more. It's unclear what the prac-

tical impact the sanctions will have and whether the independent investigator will be able to travel to the U.S. with diplomatic paperwork.

Albanese, an Italian human rights lawyer, has been vocal about what she has described as the "genocide" by Israel against Palestinians in Gaza. Both Israel and the U.S., which provides military support to its close ally, have strongly denied that accusation.

The U.S. had not previously addressed concerns with Albanese head-on because it has not participated in either of the two Human Rights Council sessions this year, including the summer session that ended Tuesday. This is because the Trump administration withdrew the U.S. earlier this year.

In recent weeks, Albanese has issued a series of letters urging other countries to pressure Israel, including through sanctions, to end its deadly bombardment of the Gaza Strip.

She has also been a strong supporter of the International Criminal Court's arrest warrants against Israeli officials, including Netanyahu, for allegations of war crimes. She most recently issued a report naming several large U.S. companies as among those aiding what she described as Israel's occupation and war on Gaza.

Russia blasts Kyiv with another missile, killing at least 2

Russia pounded Ukraine's capital with another major missile and drone attack overnight into Thursday, killing at least two people and causing fires across Kyiv a day after the heaviest drone attack so far in the more than three-year war, Ukrainian officials said.

In another tense and sleepless night for Kyiv residents, with many of them dashing in the dark with children, pets and blankets to the protection of subway stations, at least 22 people were wounded, according to Tymur Tkachenko, head of the Kyiv Regional Administration.

The night was punctuated with the chilling whine of approaching drones that slammed into residential areas,



exploded and sent balls of orange flames into the dark during the 10hour barrage. Russia fired 397 Shahed and decov drones as well as cruise and ballistic missiles at Kyiv and five other regions, authorities said.

"This is a clear escalation of Russian terror: hundreds of Shahed drones every night, constant missile strikes, massive attacks on Ukrainian cities,"

President Trump announces tariffs

President Volodymyr Zelenskyy said in a Telegram post.June brought the highest monthly civilian casualties of the war, with 232 people killed and 1,343 wounded, the U.N. human rights mission in Ukraine said Thursday, as Russia launched 10 times more drones and missiles than the same month last vear.

At least 13,580 civilians, including 716 children, have been killed and more than 34,000 wounded since Russia's full-scale invasion of its neighbor began on Feb. 24, 2022, the U.N. said.

Two rounds of direct peace talks between Russian and Ukrainian delegations have yielded no progress on stopping the fighting. Kremlin spokesperson Dmitry Peskov said Thursday there is no date for a possible third round of negotiations.



US President Donald Trump on Wednesday announced a fresh round of tariffs on imports from seven nations - Sri Lanka, Algeria, Iraq, Libya, the Philippines, Moldova and Brunei. These tariffs will come into effect on August 1. The White House has shared letters sent by Trump to leaders of these seven nations, which mentioned the tariffs they will face while exporting goods to the US.

According to the letters. the US will impose a 30 per cent tariff on goods imported from Sri Lanka, Iraq, Algeria and Libya. In the letters, Trump mentioned that Moldova will face a tariff of 25 per cent when exporting goods to the US. According to the letter, imports from Brunei will face a 25 per cent tariff while the Philippines will be facing 20 per cent.

A special tribunal indicted Bangladesh's ousted Prime Minister Sheikh Hasina on Thursday by accepting charges of crimes against humanity filed against her in connection with a mass uprising in which hundreds of students were killed last year. A three-member panel, headed by Justice Golam Mortuza Mozumder, indicted Hasina, former Home Minister Asaduzzaman Khan and former police chief Chowdhury Abdullah Al-Mamun on five charges. Hasina and Khan are being tried in absentia.

Responding to the panel's decision, Hasina's Awami League party condemned the trial process and said the tribunal was a "kangaroo" court.

The tribunal opened the trial on June 5. Authorities published newspaper advertisements asking Hasina, who has been in exile in India, and Khan to appear before the tribunal. Hasina has been in exile since Aug. 5.

Bangladesh's interim government, headed by Nobel Peace Prize laureate Muhammad Yunus, sent a formal request to India for Hasina's extradition, but India has not responded. Khan is possibly also in India. Al-Mamun, who was arrested and ap-



peared before the panel on Thursday, pleaded guilty and told the tribunal that he would make a statement in favor of the prosecution at a later stage.

Chief Prosecutor Mohammad Tajul Islam later told reporters that Al-Mamun appealed to the judges to be an "approver." It refers to a person who pleads guilty and who, in exchange for potential leniency or a reduced sentence, agrees to testify against their accomplices as a state witness.

"The tribunal accepted his plea to be an approver," Islam said.

The prosecution offered a leaked audio of Hasina and other documents as evidence to the tribunal.

A petition by Amir Hossain, a lawyer ap-

pointed by the state for Hasina and Khan, for their names to be dropped from the case was rejected by the tribunal.

The tribunal fixed Aug. 3 for the opening statement by the prosecution and Aug. 4 for recording witness statements. In a post on X, the Awami League accused the Yunus-led administration of manipulating the judiciary.

"People have lost their faith over the judicial system as Yunus regime has reduced this key state organ into a means to prosecute dissenters," it said. "We condemn in strongest term the indictment against our party president and other leaders as we assert that this step marks another testament to the ongoing witch hunt against our party and weaponization of judiciary by Yunus regime."

Hasina and the Awami League has previously criticized the tribunal and its prosecution team for connections to political parties, especially the Jamaat-e-Islami party.

Filing five charges, the prosecution argued Hasina was directly responsible for ordering all state forces, her Awami League party and its associates to carry out actions leading to mass killings, injuries, targeted violence against women and children, the incineration of bodies and denial of medical treatment to the wounded.

Rubio meets Russian FM Lavrov amid Ukraine tensions

US Secretary of State Marco Rubio met with Russian Foreign Minister Sergey Lavrov on Thursday on the sidelines of the Association of Southeast Asian Nations (ASEAN) summit, CNN reported. The meeting occurred just days after President Donald Trump expressed frustration with Russian President

Vladimir Putin for not engaging in peace talks regard-

ing the Ukraine conflict. Neither Rubio nor Lavrov made any remarks before the meeting, and when asked about his message to his Russian counterpart, Rubio responded with a wink, CNN reported. The meeting comes amid confusion following a Pentagon-directed pause on weapons shipments to



Ukraine, which President Trump publicly criticized. According to CNN, Secre-

tary of Defense Pete Hegseth had not informed the White House prior to approving

the halt, catching Rubio off guard. Following the pause, Trump stated, "Putin is not -- he's not treating human beings right. He's killing too many people," and added, "So we're sending some defensive weapons to Ukraine, and I've approved that." Trump also criticized Putin sharply, saying he has offered a lot of "bullsh*t" which has proved to be "meaningless," CNN reported.

Following these comments, Russia launched its largest drone assault to date on Ukraine, deploying more than 700 drones, according to Ukraine's Air Force, CNN reported. This marked Rubio's second meeting with Lavrov, the first having taken place earlier this year in Saudi Arabia. The two have also spoken multiple times over recent months as the US

pushed unsuccessfully for a ceasefire between Ukraine and Russia. CNN reported. Rubio's visit to Kuala Lumpur also included meetings with ASEAN counterparts, occurring shortly after Trump declared that many ASEAN countries will face US tariffs starting August 1 unless trade agreements are reached. Eight ASEAN nations, along with South Korea and Ja-

pan, will be subject to these tariffs, adding complexity to Rubio's diplomatic efforts, CNN reported. The Trump administration has made clear that trade and economics are a central focus of its foreign policy. Though Rubio is not the lead trade negotiator, he is expected to face questions and frustrations about the tariffs during his meetings, a senior administration official told CNN.





RESEARCH BEGINS WITH CURIOSITY: SARITA JAIN

My aim is always to move beyond surface facts and grasp the culture, context, and atmosphere that bring a narrative to life.







Review of Yellow: Poemlets New & Earlier by Sukrita, published by Sahitya Akademi, 2024

The poems in Yellow are unified by their broad themes that revolve around the topics of death, human condition, state of displaced existence, and sense of self. For instance, a poem titled 'not so randomly' reminds us that 'my poems/ are the/ epitaphs/ of experiences/ that died with me' (26). The poem is a reflection upon the difficulty of giving words to experience, and therefore its fragmented form. Or consider the poem 'dialogues with ganga', where the poet adds with unaffected bluntness -'but death you confirm has no colour/ it is transparent like truth' (30). Similarly, in 'meaning', death again appears as an unfathomable phenomenon, 'my future lies planned in my elegy/ my death will/ expose it' (100). Another reference to the same in the poem titled 'passage' mentions, 'the garden blossomed/ in winter/ because/ I died in spring' (115). The tricky subject of grief which either eludes literary expression or ends up being conveyed in a verbose manner is given the adequate space and attention here. The short poems with their pithy and exact words convey the right balance of saying enough and not much. The repeated invocation of death lend a sense of brooding atmosphere to the entire collection.

Several other poems map the history of the postcolonial state with references to partition, ensuing riots, displacements, babri masjid demolition and other

such momentous events that left an indelible mark on the people of the country. Another poem 'crows are our ancestors' is structured like a parable with a moody and ominous tone. The poem comments on the sly and untrustworthy nature of humans via the crows who make it a pact to 'not be like the human species' because 'tricksters themselves, crows detect/ tricks in others' (57). The poems in the collection touch upon human sensibility through various experiences born

out of loneliness, displacement, violence, loss and survival.

Overall, the poems in the collection demand slow and intentional readers who may imbibe the stillness of emotion and lingering thought via its stylized language. The individual poem titles are stripped of punctuation, capitalization and other rules of grammar to deliver a minimalistic effect. In doing so, language draws attention to itself, displaying its bare character and focusing on the precise bare words.

Resuming at 83/2 after Lunch, Root and Pope navigated a disciplined Indian bowling attack with patience and control. Their fifty-run partnership came off 116 balls, laying the foundation for a solid middle-order resistance.

Former captain Joe Root brought up his half-century off 102 deliveries and remained unbeaten at Tea on 54 from 109 balls, decorated with seven elegant boundaries. Pope, on the other hand. showcased grit and composure to remain not out on 44, which included four boundaries



New Delhi to host international shooting competitions

The International Shooting Sport Federation (ISSF) on Thursday awarded New Delhi two major competitions -- the combined World Cup in 2027 and the Junior World Championship in 2028 -- during its executive committee meeting here.

Announcing the calendar for the crucial 2026-27 season, the ISSF said that New Delhi, which will also organise the Junior World Cup (Rifle/Pistol/Shotgun) in September-October this year, will host the prestigious World Cup leg in all three disciplines next year, the dates for which will be

announced in due course. The 2026 Asian Cup (Rifle/Pistol) is also scheduled to be held in India in February 2026. The Karni Singh Ranges

in New Delhi had also hosted the season-ending elite World Cup Final in October last year. India had hosted the ISSF World Cup in Pistol/Rifle and Shotgun



in 2021 ahead of the Tokyo **Olympics**

The ISSF also confirmed the cities of Daegu and Cairo for hosting the prestigious World Championships in

2027, which will also serve as one of the 2028 Los Angeles Olympics qualification event.

Daegu, in South Korea, will host the World Championship in Rifle and Pistol, nine years after Changwon organised the big event. It will be the third time Korea will host the World Championships, having first welcomed the global shooting fraternity to Seoul in 1978.

The ISSF World Cup Final will also be held in Daegu in 2027.

Cairo will play host to the 2027 World Championship for shotgun. The city had hosted World Cup events from 2022 to 2024 in rifle and pistol.

Amanda reaches her first Grand Slam final at Wimbledon
