Union Parliamentary Affairs Minister Kiren Rijiju on Friday said that there will be a special discussion in the Lok Sabha on the Pahalgam terror attack and Operation Sindoor on July 28, amid continued disruptions by the Opposition during the Monsoon Session of Parliament.

Addressing media persons in the national capital, Rijiju stated that Lok Sabha Speaker Om Birla convened a meeting of the Business Advisory Committee (BAC) earlier in the day, during which it was reiterated that the government is prepared for a full debate on the sensitive issues.

"Today, Lok Sabha Speaker Om Birla called the Business Advisory Committee (BAC), and it was reiterated that we are ready for a discussion on Operation Sindoor. It has been decided today that there will be a special discussion on the Pahalgam terror attack and Operation Sindoor on Monday (28th July)," Rijiju said.

The Union Minister said, "We have told them that Operation Sindoor will be discussed first. We will decide which issues will be discussed after that... Operation Sindoor will be debated for 16 hours in the Lok Sabha on Monday (July 28) and for 16 hours in the

Seven students killed as roof of Rajasthan school collapses

Seven children died and 28 children injured as the roof of the dilapidated building of Peeplodi Government School in Manoharthana block of Jhalawar collapsed on Friday amid continuing rains. The injured children were admitted to the hospital and the condition of nine is said to be critical.

According to the school administration officials, the prayer meeting in the school was postponed due to rain in the morning and 35 children were sitting in a classroom when the roof of the school came down and all the 35 students were buried under the debris.

Local people rushed to the spot on hearing the screams of students and police and district administration officials too reached the spot. Villagers and teachers immediately started rescue operations and pulled out injured children from under the debris and admitted them to Manoharthana and Jhalawar hospitals.

Agitated villagers block road

As the tragedy led to chaos, screams of the children and scene of bodies of children caused anger among villagers. Accusing the education department and the school administration of negligence, the villagers blocked the Manoharthana-Aklera road. The agitating vil-

lagers demanded strict action against the officials and teachers who did not bother to renovate the dilapidated school building before the rains. They also demanded a compensation of Rs 50 lakh each to the family of each deceased child.

The villagers who were protesting by blocking the road alleged that the identified as Payal (14) Priyanka (14) Kartik (18) Harish (8) Meena (8) Sona (5) Mithun (11).

Haribhau Bagde and Chief Minister Bhajan Lal Sharma expressed deep sorrow over the school accident.

Congress leader Rahul Gandhi also expressed condolences to the bereaved families and appealed to Congress workers to assist in relief work.

Meanwhile, the Education Department issued an order and suspended five teachers including the headmistress Meena Garg of Peeplodi Government School. The suspended teachers are Javed Ahmed, Ramvilas, Kanhaiyalal and Badrilal Lodha.

District Collector Ajay Singh Rathore said that the education department was instructed not to run schools in dilapidated buildings. The villagers also alleged that with the intention of erasing the evidence of the accident,

President Draupadi In a significant crackdown Murmu, Prime Minister on objectionable digital Narendra Modi, Governor content, the Ministry of Information and Broadcasting (MIB) has ordered the blocking of 25 over-the-top (OTT) platforms for allegedly publishing obscene, vulgar and, in some cases, pornographic material.

The directive was issued on July 23, 2025, in consultation with multiple government departments and civil society stakeholders, according to sources.

The platforms in question, which include Ullu, ALTT, Big Shots App, NeonX VIP, and Desiflix among others, were found to be disseminating content that violated several provisions of Indian law, including Section 67 and 67A of the **Information Technology** Act, Section 292 of the Indian Penal Code, and Section 4 of the Indecent Representation of Women (Prohibition) Act, 1986.

India on Friday announced a Rs 4,850-crore line of credit for the Maldives and agreed to finalise a free trade deal soon, with Prime Minister Narendra Modi emphasising that New Delhi is proud to be the "most trusted" friend of the Indian Ocean archipelago.

New Delhi also decided to reduce the Maldives' annual debt repayment obligations by 40 per cent (from USD 51 million to 29 million), seen as a significant move to help the country deal with its economic woes.

These measures were announced after PM Modi held extensive talks with Maldivian President Mohamed Muizzu that focused on deepening bilateral cooperation in a range of areas, including trade, defence and maritime security.

The two sides sealed six pacts in the fields of fisheries and aquaculture, meteorology, digital public infrastructure, UPI, Indian pharmacopoeia, and for India's concessional line of credit to the island nation.

Lok Sabha Speaker Om Birla on Friday called for an all-party meeting after the lower house was adjourned amid sloganeering and protests by Opposition members, urging for members to let the house function properly.

During the meeting, there was also a discussion regarding a session on Operation Sindoor. The proposed 16-hour discussion in Parliament is set for July 28.

Earlier today, both the Rajya Sabha and Lok Sabha were adjourned. While the upper house is set to meet now on Monday 11 AM, Lok Sabha is set to convene again at 2 PM.

Lok Sabha Speaker Om Birla has called for the House to function with discussions and dialogues, including the Question Hour, to continue, amid protests by Opposition members demanding a discussion on the ongoing Special Intensive Revision (SIR) in Bihar. Efforts are currently being

made to reach a consensus during the all-party meet-The opposition MPs have been demanding a discussion on several key issues of public importance, includ-

ing the ongoing Special Intensive Revision (SIR) exercise being carried out by the Election Commission (EC) in Bihar ahead of the upcoming assembly elections.

"There's a way to register a protest. If you don't want to run the Parliament...the house is adjourned till 2:00 PM today," Birla said earlier while addressing the lower house, as the Opposition members entered the well of the house, holding placards.

Before adjourning, the Speaker urged the opposition members to allow the lower house to function normally and objected to the banners, saying that the "stalemate" is not good.

Govt inked six trade pacts with other countries to boost trade since 2021

Minister of Commerce and Industry Piyush Goyal said in the Rajya Sabha that since 2021 nearly six trade agreements have been signed to boost trade and commerce with countries like UK, EU, Australia, South Korea, ASEAN nations, UAE,

Mauritius, etc. Since 2021, India has signed and implemented Free Trade Agreements (FTAs) including Mauritius Comprehensive Economic Cooperation and Partnership Agreement (2021), India-UAE Comprehensive Economic Partnership Agreement (2022), India-Australia Economic Cooperation and Trade Agreement (2022), India-European Free Trade Association (EFTA) (2024), and Trade and Economic Partnership Agreement (To be implemented post ratification by EFTA countries.

The Union Minister said this while responding to the starred question of Raiva Sabha MP Kartikeya Sharma today.

India has also signed India-UK Comprehensive Economic and Trade Agreement (CETA) on 24th July, 2025. Further, India-Oman Comprehensive Economic Partnership Agreement (CEPA) negotiations have been concluded. Negotiations are ongoing on the India-European Union Free Trade Agreement, India-Australia Comprehensive Economic Cooperation Agreement, India-Sri Lanka Economic and Technology Cooperation Agreement, India-Peru Free Trade Agreement, India-Chile Comprehensive Economic Partnership

Agreement, India-New Zealand Free Trade Agreement, India-USA Bilateral Trade Agreement. Review of agreements for upgradation are being undertaken for ASEAN India Trade in Goods Agreement (2009) and India-Korea Comprehensive Economic Partnership Agreement (2009), he said.





Fertilizer supply exceeds demand despite output gap: Union Minister Nadda

Union Minister for Chemicals and Fertilizers and Health and Family Welfare, Jagat Prakash Nadda, on Friday assured that there is no shortage of fertilizers in any part of the country, despite a significant gap between domestic production and consump-

Responding to a question related to the reports of the shortage of the fertilizers in the various states asserted that fertilizer availability in the current financial year (2024-25) has consistently exceeded state-wise requirements, thanks to timely imports, strong monitoring systems, and efficient distribution.

According to government data, total fertilizer production stood at 517.85 lakh metric tonnes (LMT), while consumption reached 705.23 LMT, highlighting a continued dependence on imports to meet national de-



During the financial year 2024-25, India produced 306.67 lakh metric tonnes (LMT) of urea, while consumption reached 387.92 LMT. The figures revealed that the diammonium phosphate (DAP), production stood at 37.69 LMT, compared to a much higher consumption of 96.29 LMT, while the production of NPK complex fertilizers was 121.05 LMT, against a consumption of 149.72 LMT.

In the case of single super phosphate (SSP), the production slightly exceeded consumption, with 52.44 LMT produced and 49.28 LMT consumed. However, there was no domestic production of muriate of potash (MOP), and the entire demand of 22.02 LMT had to be met through imports,

99.8% Bihar electors covered so far under SIR exercise: ECI

The Election Commission on Friday said that 99.8 per cent Bihar electors have been covered so far under its exercise of the Special Intensive revisoon of the voter rolls.

The poll panel in a statement announced that 99.8 per cent Bihar electors have been covered so far and forms of 7.23 crore electors have been received and digitised; the names of all these electors will be included in the Draft Electoral

It said that the digitisation of forms, along with BLO reports, of the remaining electors will also be completed by August 1,2025.

The lists of those electors who have not filled the forms or are deceased and those who have per-



manently migrated have already been shared on July 20 with all the 12 political parties in the state so that any errors can be rectified in the Draft Electoral Roll to be published on August 1.

It also pointed out that since June 24, 2025, the local BLOs/BLAs have reported the names of approximately 22 lakh deceased electors, approximately 7 lakh electors registered in more than one location, approximately 35 lakh electors

have either permanently migrated or could not be traced.

It said that enumeration forms of approximately 1.2 lakh electors is yet to be received.

"The credit for the successful completion of the first phase of SIR so far, goes to the CEO of Bihar, 38 DEOs, 243 EROs, 2,976 AEROs, BLOs deployed at 77,895 polling booths, volunteers, all 12 political parties, their 38 District Presidents, and the 1.60 lakh BLAs nominated by them," the EC said.

Notorious murder case convict gives slip from prison, caught hours later

A notorious convict serving a life term in the sensational 2011 Soumya murder case, escaped from the high-security Kannur central jail on Friday morning but was apprehended by police several hours later with active public support.

"Govindachamy alias Govindaswamy (41), who is missing his left hand, was caught from a well near a derelict building in Thalap, within Kannur city limits," said a senior district police officer.

According to visuals on TV channels, the convict was hiding inside the well near the building.

CCTV footage aired on channels showed a man resembling Govindachamy walking on the roadside with a bundle on top of his head.

An ICMR study has found that Covid vaccination did not increase the risk of unexplained sudden deaths among young adults in India, Union Health Minister J P Nadda told Lok Sabha on Friday.

Past Covid hospitalization, family history of sudden death and certain lifestyle behaviours increased the likelihood of unexplained sudden deaths.

Responding to a question, Nadda said the Indian Council of Medical Research (ICMR) has informed that it and the National Centre for Disease Control (NCDC) explored two approaches to investigate the causes of sudden death.

The first approach was a retrospective case-control study to determine the risk factors associated with sudden death and the second approach of the study was to prospectively

investigate sudden deaths in young adults using a virtual autopsy approach. The ICMR-National Institute

of Epidemiology (NIE) conducted a study titled "Factors associated with unexplained sudden deaths among adults aged 18-45 years in India -A multicentric matched casecontrol study" at 47 tertiary care hospitals located across 19 states and Union territories during May-August 2023.

That was my mistake, which I am going to correct," he said, adding that in a way, it's good that it happened, because if I had conducted a caste-based census back then, it wouldn't have been like it is today.

He added that Dalits, backward classes, tribals, and minorities make up 90 per cent of the country's population yet remain excluded from key decisionmaking processes, including the Union Budget. "In the country, the population of Dalits, backward classes, tribals, and minorities together constitutes about 90 percent.

Flood fear persists in Delhi's coaching hub

A year after a tragic basement flooding in Delhi's Old Rajinder Nagar claimed the lives of three young UPSC aspirants, a quiet but persistent fear still lingers among students and residents of the city's coaching hub as monsoon clouds return.

Delhi sees intensified mosquito surveillance Uma Kanjilal appointed first woman VC of IGNOU to combat vector-borne diseases

Delhi has ramped up its mosquito-control efforts in 2025, with over 2.26 crore house inspections carried out between January 1 and July 19, a significant rise from the 1.89 crore inspections during the same period in 2024, officials said on Friday.

Data from the Municipal Corporation of Delhi's (MCD) anti-malaria operations headquarters indicates a substantial increase in house inspections, legal notices issued, and G-8 challans imposed in 2025 compared to the same period last year. This trend



highlights enhanced vector surveillance and enforcement throughout the city.

Between January 1 and July 19, 2025, field workers visited over 2.26 crore houses to check for mosquito breeding. This represents nearly a 37 lakh increase compared to 2024, which saw 1.89 crore house visits. Additionally, the numbers surpass those from 2023 (1.97 crore) and 2022 (1.68

Spraying operations have also picked up pace. So far in 2025, 5.36 lakh houses have been sprayed with insecticides, compared to 2.23 lakh last year and 5.22 lakh in 2023, indicating a 140 per cent increase from 2024 fig-

The number of houses found positive for mosquito larvae has also increased, touching 79,913 this year compared to 49.513 last year. a rise of over 60 per cent, pointing to a possible surge in stagnant water breeding sites, likely aggravated by intermittent monsoon rains.

In terms of legal enforcement, the MCD has issued 64,424 notices to property owners for mosquito-breeding conditions in 2025, up from 44,070 notices in 2024 and 76.131 in 2023.

Additionally, 11,949 prosecutions have been initiated this year, nearly matching the total of 15,607 from 2023. Officials also imposed G-8 challans (spot fines) worth nearly Rs 9.85 lakh this year, compared to around Rs 7.8 lakh collected by this time last year.

Kanjilal has held various leadership roles at the university including Director, Centre for Online Education (2019–2021); Director, Inter-University Consortium for Technology Enabled Flexible Education (2016–2019): Director, Advanced Centre

for Informatics and Innovative Learning (2012–2013); Director, School of Social Sciences (2007-2010); and University Librarian (2004-2006).

Her global contributions include a Fulbright Fellowship at the University of Illinois, Urbana-Champaign (1999-2000), consultancy for the Commonwealth of Learning, and digital education work for UNRWA in Jordan. She has received multiple accolades including the Manthan Award for e-Education, an Australia-India Council Grant, and a DANIDA Fellowship.

Rekha Govt orders audit as 32,000 Co cameras fail; 15,000 uninstalled

The ambitious CCTV project in Delhi, initiated by the previous government, has come under scrutiny following the discovery of significant lapses. Out of the 2.64 lakh CCTV cameras installed across 70 assembly constituencies, over 32,000 have been found non-functional, while more than 15,000 cameras remain uninstalled. In several areas. the number of installed



cameras falls far short of the approved count.

In response, the current government has announced a comprehensive technical audit of the entire project to pinpoint deficiencies and establish accountability. Meanwhile, on March 19, the Delhi government's anti-corruption branch (ACB) registered a case against AAP leader and former

MLA Satyendar Jain, alleging corruption and bribery in connection with the Rs 571 crore CCTV project for the national capital. According to Madhur Verma, Joint Commissioner of Police (CP) and Head of ACB, the liquidated damages worth Rs 16 crore were allegedly arbitrarily waived by receiving a bribe of Rs 7 crore. An FIR was registered against former Public Works Department (PWD) Minister Jain under section 17A of the Prevention of Corruption Act, 1988, after receiving previous approval from the competent authority. ACB said, "Bribery of Rs 7 crore was allegedly arranged to be paid to Satyendra Jain to waive off the Rs 16 crore penalty for delays in CCTV installation." Despite previous delays,

Bharat Electronics Limited (BEL) received additional orders for another 1.4 lakh cameras under the project. The bribe was allegedly paid through contrac-

tors who benefited from

the additional orders. According to officials, the project was allegedly carried out in a "shoddy manner", with many cameras being dysfunctional even at the time of project handover. Moreover, payments

were artificially inflated to accommodate the bribes involving different vendors. ACB has already examined a BEL officer, who confirmed the allegations and provided a detailed account of the complaint.

Govt mandates installation of CCTVs at pharmacies

The Delhi government has mandated the installation of CCTV cameras in the national capital by the end of July. The decision comes after a meeting under the 11th National Narcotics Coordination portal (NCORD), aiming to curb the sale of Schedule H, H1, and X drugs without prescription. It is a significant move to prevent the misuse of dual-use medicines. The decision was taken after authorities had received complaints about these drugs being misused for intoxication, on humans and animals, and even in textiles, chemicals, and food items. This step is expected to enhance surveillance in coordination with the Narcotics Control Bureau and the Delhi government, thereby curbing illegal drug distribution.

Assam CM flags suspected encroachers on govt lands from Bihar, Bengal

Assam Chief Minister Himanta Biswa Sarma said on Friday that people claiming to be from states like Bihar and West Bengal are among encroachers of government, forest and other land in the northeastern state.

He said his government will share details of these people with local authorities from where they claim to have come, so that it can be verified that they are not actually from "across the border".

Talking to reporters after inspecting sites for eviction drives in Urianghat in Golaghat district, Sarma said, "When we went through the list of encroachers, we found that these people are not just from Assam. There are people from districts like Cachar, Sribhumi, Dhubri, Hojai, Nagaon, Morigaon, but there are people even from Bihar and West Bengal."



"They have said that they are from Bihar, but they could be from across the border," he added.

The CM said names, addresses and other details will be taken from them, and shared with the authorities of the place they claim to have come from.

"If they are genuine people from those parts, we have nothing against them. But if they are not permanent residents there, the local authorities can take steps," he

He said encroachers in Uriamghat were in possession of hundreds of bighas of forest land.

"Government cannot be a mute spectator and we have to take necessary action. We seek cooperation from the people," he said. Sarma said locals have told him

that illegal activities like drug use and thefts were rampant in the encroached areas and a "lot of negative things were happening". "Now, all can work together to make it an area with positive vibes.

Local youths can engage in business by utilising the resources after the land is cleared," Sarma said.

He said about 70 per cent of the encroachers have already left the place, and the remaining will also do so before the anti-eviction drive is launched as per law.

8 Bangladeshis, 2 Indian touts held in Assam's south Salmara

Eight Bangladeshi nationals, along with two Indian touts, have been arrested in South Salmara in Assam.

The operation, conducted around 5:30 am in the Fekamari Tinali area, was jointly carried out by the district police and personnel of the 183 Battalion of the BSF under the supervision of the Assistant Superintendent of Police (Headquarters) and the Deputy Superintendent of Police (Border).

According to officials, intelligence reports had suggested that the group of Bangladeshi nationals had already reached Fekamari and were

attempting to cross the international border from the area under Border Outposts (BOPs) Sanjay Sadhu and Deepchar.

The apprehended Bangladeshi nationals have been identified as Tarek Ali (26), MD Rabel (25), MD Riyaj (22), Abdul Hamid (22), MD Nadim Islam (36), Dulal Hoque (30), MD Morsalim (22), and MD Sariful Islam, all residents of Rajshahi district in Bangladesh. Several of them reportedly entered India through different routes, including Sonamasjid in Malda, Komilla in Tripura, and Cooch Behar-Siliguri.

Along with them, two Indian touts - Khairul Islam (25) of Borobila and Nurul Islam (25) of Nandia Pipulbari – were also arrested. A black Mahindra Bolero Neo (registration number AS-01 FU 1779) suspected to have been used for trafficking was seized.

The Bangladeshi nationals are currently lodged at the Sishumara BOP of the BSF, where biometric data collection and interrogation are underway. Authorities have stated that they will be pushed back to Bangladesh following due verification and protocol.

Earlier, two individuals from Assam's Sribhumi (formerly Karimganj) district have been arrested for allegedly trying to obtain an Indian passport for a Bangla-

deshi national using forged documents created in the name of a deceased Indian citizen.

The accused—identified as Burhan Uddin and Faizur Rahman, both residents of Patharkandi-were arrested after police detected discrepancies during a routine verification process linked to a passport application filed a few months ago.

According to officials, the passport application had been submitted in the name of one Farooq Ahmed. However, upon verification, law enforcement found discrepancies in the submitted documents, which included a birth certificate, Aadhaar card, and PAN card.

Office space leasing in Delhi-NCR more than double in Apr-Jun

Office space leasing in Delhi-NCR more than doubled to 2.62 million square feet during April-June on better demand of workspace in Gurugram and Noida from corporates, according to Vestian.

On Friday, US-based real estate consultant Vestian released its report on India's top seven office markets that showed a 10 per cent rise in absorption or leasing of office space to 18.79 million sq ft during the second quarter of this calendar year.

The consultant attributed the rise in demand to increased activities in three southern cities (Bengaluru, Hyderabad and Chennai), whose share rose to 59 per cent from 46 per cent in January-March quarter.

As per the data, Bengaluru retained its dominant position with leasing of 5.62 million sq ft area in the latest June quarter, an increase of 32 per cent from the vear-ago period

In Hyderabad, the demand grew 5 per cent to 3.56 million sq ft, while Chennai saw a 4 per cent increase in leasing activities to 1.82 million sq ft.

In Delhi-NCR, the office space absorption surged 130 per cent to 2.62 million sq ft in the second quarter of 2025 calendar year. The share of the Noida market in the leasing activities was 27 per cent, while Gurugram contributed the rest.

The leasing of office space in Mumbai was 2 per cent higher at 3.45 million sq ft, led by Navi Mumbai with a 52 per cent share. However, Pune witnessed a drop of 52 per cent to 1.37 mil-

Kolkata, a small office market, saw a 52 per cent growth in leasing to 0.35 million sq ft during the April-June period.

On the demand trend. Shrinivas Rao, CEO of Vestian, said, "As more enterprises are transitioning back to in-office operations and several grade-A office projects are planned to be completed in the second half of 2025, the growth momentum is anticipated to continue with an increase in office utilisation ratio."

Online war games akin to PUBG requiring chats with partners anonymous or otherwise have emerged as a key communication channel for terror groups and Pakistan's ISI to convey messages to their recruits in Jammu and Kashmir, officials here said.

As terror groups operating across the border seek to bypass social media and conventional channels of communication and escape scrutiny by security agencies, it is a virtual battleground and in some cases a real one too. Four cases have been been identified, the officials said.

In one case, an underage boy was being radicalised by his gaming partner sitting across the border. The boy was handed over to parents after proper counselling of the entire family.

The gaming chat applications allow players to communicate with each other in real time in the guise of

playing online games, the officials explained without going into details of which game and how.

These applications, which facilitate voice, video, and text-based communication to enhance teamwork, strategy discussions and social interaction among players, are being used for different purposes, they said.

The gaming applications have been increasingly incorporating encryption to protect user communications but the level of security varies widely. So, some games use basic encryption for in-game voice chat and others offer more robust end-to-end encryption for text and voice. There are also applications that allow for self-destructing mes-

Though several of these gaming applications are banned in India, they are downloaded using Virtual Private Network (VPN) illegally. A VPN creates a secure and encrypted connection over the internet by masking Internet Protocol addresses and encrypts online traffic, making it more difficult to track online activity and access data.

Over 2 800 killed in elephant attacks in India from 2019 to 2023: Govt

More than 2,800 people lost their lives in elephant attacks in India from 2019 to 2023, with Odisha. Jharkhand and West Bengal among the worst-affected states, the Rajya Sabha

was informed on Friday. According to data shared by Minister of State for Environment Kirti Vardhan Singh in response to a question by CPI(M) MP John Brittas, between 201920 and 2023-24, a total of 2,869 people were killed in elephant attacks.

Odisha reported the highest deaths in the country at 624, followed by Jharkhand (474), West Bengal (436), Assam (383) and Chhattisgarh (303), according to the data.

The annual toll from elephant attacks has been rising steadily, increasing from 595 in 2019-20 to 629 in 2023-24. Tamil Nadu and Karnataka recorded 256 and 160 human deaths



due to elephant attacks, respectively, over the five

years. In contrast, tiger attacks claimed the lives of 378 people beteen 2020 and 2024. Maharashtra reported the highest number of deaths during this period at 218, followed by Uttar Pradesh (61) and Madhya Pradesh (32).

As many as 110 deaths were reported from tiger attacks in 2022, most of them from Maharashtra (82). The number declined

slightly to 85 in 2023 and 73 in 2024. The minister also said that the environment ministry does not compile data on livestock and crop losses caused by wild animals at the national level.

On the question of declaring animals as vermin under Section 62 of the Wildlife (Protection) Act, 1972, Singh said the environment ministry had declared rhesus macaque monkeys as vermin in Himachal Pradesh for one year through a gazette notification dated April 23, 2020. Asked whether the Centre would consider amending the Act to empower states to declare animals as vermin within their jurisdictions, the minister said, "There is no proposal to amend the Wildlife (Protection) Act, 1972 as on date."

He added that following the 2022 amendment, Section 11 of the Act empowers the State Chief Wildlife Warden to manage humanwildlife conflict situations.

INDIA NEEDS MORE PACTS LIKE UK FTA. SAYS RBI GUV SANJAY MALHOTRA

eserve Bank Governor Sanjay Malhotra on Friday welcomed the signing of the free trade agreement with the UK, saying it will help multiple sectors of the Indian economy

Speaking at the Financial Express Modern BFSI Summit here, Malhotra said multilateralism has "unfortunately" taken a back seat, and the country needs more such pacts (like the UKFTA) with countries and added that negotiations with the US are in advanced stages.

"Hopefully, it (UK FTA) should help us... that is the way going forward now, because unfortunately multilateralism seems to have taken a back seat," Malhotra said in the central bank's first comments on the trade

"It should help various sectors in our manufacturing as well as on the services side," Malhotra added.

Malhotra said that given the current realities, where multilateralism has taken a back seat, it is necessary for India to have more such pacts with other countries.

He also acknowledged that there are many more such pacts in the negotiation stage.

India and the UK signed the FTA during Prime Minister Narendra Modi's twoday visit to the UK. The agreement has been in the making for many years now and will open up markets for both countries across goods and services.

Meanwhile, Malhotra backed his US counterpart Jerome Powell for his work on upholding the Federal Reserve's independence, at

Donald Trump has gone public with his disagreement with its policies.

"... He (Powell) is doing a very good job. Maintaining the independence of the central bank is very important. I think he has done a commendable job," Malhotra said.

MPC is set to hold a meeting on August 4-6, and monetary policy will be announced on August 6,

2025. Addressing the Financial Express BFSI Summit in Mumbai, Governor Sanjay Malhotra said, "Monetary policy being data-driven, more on the outlook will be guided by the revised numbers if any call is taken.

He further added that, "I may mention over here that the stance of neutral allows them to give them the flexibility to move in either direction or even to have a pause, and the MPC will be looking at the data that comes in.

During the event, the governor also commented on the RBI's effort to maintain price stability

Malhotra said, "Price stability continues to be a challenge number one, and I would say banking regulation, because that's our other area we're a full-service central bank, as they say, so apart from monetary policy, we do so many other things, including banking regulation.

Indian stock markets came under pressure on Friday as selling by Foreign Portfolio Investors (FPIs) weighed on investor sentiment.

At the time of reporting, the Nifty 50 stood at 25,010.35, down 51.75 points or 0.21 per cent, while the BSE Sensex was trading at 82,065.76, a decline of 118.41 points or 0.14 per cent.

Ajay Bagga, Banking and Market Expert, told ANI, "Indian markets are pointing to a continued negative outlook as per the traded futures. FPIs remain sellers while DIIs are absorbing the selling. Once more critical support levels are being challenged, so today's price action is important for the health of the Indian markets. Earnings continued to be weak on the whole, and with no US India Trade deal on the horizon before the August 1st deadline, markets are getting into a worry zone on that front."

He further added, "Fasten seat belts, we see key supports holding due to the blessed Indian retail investors who are determinedly buying every dip and keeping their faith in the Indian managements and economy even as FPIs are selling consistently."

Broad market indices on the NSE also reflected the pressure. The Nifty 100 was down by 0.53 per cent, Nifty Midcap 100 slipped by 0.34 per cent, and the Nifty Smallcap 100 lost 0.56 per cent. All other major indices were trading in the red.

FROM ROTE TO ROOTS

HOW NCERT'S NEW TEXTBOOKS ARE TRANSFORMING INDIAN CLASSROOMS AND IGNITING YOUNG MINDS

rates five years of Lthe NEP-2O2O, the sweeping reforms implemented by the NCERT have ignited both optimism and debate. The 2025 rollout of revised school textbooks is perhaps the most visible expression of NEP's vision aiming to shift pedagogy from rote memorization to experiential, inquiry-driven, and values-based learning. This transformation reimagines classrooms as dynamic spaces for critical thinking and textbooks as living documents reflecting India's diverse cultural heritage. While these reforms aspire to cultivate holistic, critical, and culturally grounded learners, they have also sparked debate over historical interpretation, ideological neutrality, and inclusivity in curricular framing. This article explores the transformative promise of the new textbooks and critically engages with the emerging

and pedagogical currents. A NEW PEDAGOGICAL

criticisms, situating them

within broader civilizational

PHILOSOPHY: FROM FACTS TO FRAMEWORKS

The revised textbooks mark a departure from passive learning toward active exploration and deeper conceptual understanding. Rote memorization is being replaced with critical inquirv. interdisciplinary connections, and engagement with ethical and cultural questions. This shift aligns with constructivist learning principles, encouraging students to build knowledge by interacting with diverse

A key feature of this transformation is the integration of Indian knowledge System into the curriculum. Stories and teachings from the Bhagavad Gita, Ramayana, Panchatantra, and local folktales etc. are used not just for cultural familiarity, but to illustrate values, philosophical inquiry, and civic duties. For example, in Class 6 Social Science, students are introduced to the idea of Bhakti from the *Gita*— as an inclusive devotional practice, while Sanskrit texts include verses like "कर्मण्येवाधिकारस्ते मा फलेषु कदाचन" to teach the idea of performing one's duty without attachment to outcomes. In senior secondary Modern History textbooks, topics like the Vaikom Satyagraha are used to explore themes of social justice and equality.

Yet, the challenge lies in how these texts are used. Their true educational val-

ue lies in encouraging students to probe philosophical plurality and regional diversity—thereby fostering critical pluralism rather than ideological rigidity.

Learning by Doing: Experiential and Inquiry-Driven Class-

In line with NEP's emphasis on experiential learning, the textbooks promote student-led exploration from early grades onward. For example, Class 3 EVS encourages children to explore their neighbourhood and talk to community members, while Class 6 History includes projects that document oral histories. In Science, hands-on activities using ropes, springs, and household items replace rote definitions to explore physical laws. Class 11 Biology asks students to investigate realworld questions like 'How urban pollution affects biodiversity'.

This inquiry-based approach promotes lifelong curiosity and deeper learning, encouraging students to connect scientific knowledge with social responsibility.

Inclusion and Representation: Broadening the Historical

A key strength of the revised curriculum is its attention to previously marginalized histories. Tribal revolts like the Santhal and Bhil uprisings, along with regional movements such as the Travancore Temple Entry agitation, now receive detailed treatment. These narratives, once relegated to footnotes, are now integrated into the core of the Political Science and History syllabi.

Students from these communities gain visibility in the national narrative, while others are exposed to India's pluralistic past. This inclusive lens is extended across disciplines—linking stories of reform and resistance to ethical lessons in literature, civic duty in Political Science, and community mapping projects in Social Science. The result is a more holistic and contextualised curriculum.

Fostering Scientific Temperament with Civic and Ecological

The revamped NCERT text-

books mark a clear shift from rote learning to curiositydriven education. Science lessons now begin with real-world questions—such as connecting theory to practice through activities like home energy audits (Class-8 Geography reference book), encouraging critical thinking and practical application. Equally transformative is the emphasis on ethics and sustainability. Students compare traditional farming methods with the UN's SDGs and study indigenous techniques like Zabo and Khadin as innovative, eco-friendly solutions, prompting critical discussions on climate resilience and sustainable living. By integrating scientific inquiry with ethical reasoning and civic awareness, the curriculum redefines science as a tool for problem-solving and social progress.

Emotional Growth and Language Diversity

Emotional and moral education is now woven into learning. Class-4 and 5 English textbooks use Panchatantra stories and regional folklore to spark reflection on empathy, fairness, and kindness. Prompts like "What would you do in this situation?" create a bridge between narrative and self-awareness. Moreover, language learning honours India's multilingualism. Students are asked to translate local proverbs or songs, nurturing linguistic confidence and preserving cultural identity. These practices develop not just communication skills but a deeper appreciation for diversity.

ADDRESSING THE TEXTBOOK **CONTROVERSIES: A CALL FOR OPEN DISCUSSION**

While the new textbooks aim for positive change, they have also sparked significant debate, especially regarding how history is presented. The portrayal of the Mughal period, emphasis on religious violence, a note on "darker periods," and the reduction of Mughal content have become focal points of debate.

The biggest arguments revolve around the historical content, particularly the changes made to the Mughal period and the portrayal of some Islamic rulers. Critics argue that these changes are driven by a specific viewpoint, removing parts of India's diverse history. However, these revisions are actually based on facts and pitch for honesty, arguing that history should show both good and bad actions, and that acknowledging events like the Chittorgarh massacre or Aurangzeb's Jizya tax is simply being truthful, not biased.

ADDRESSING SPECIFIC POINTS OF DISAGREEMENT:

 Portrayal of Mughal and Sultanate Rulers: Critics caution that highlighting violent acts, like Babur's conquests or Aurangzeb's temple demolitions—may create a selective, negative portrayal of certain rulers, ignoring the complexity and multiple interpretations of history. However, these events are grounded in historical records and that acknowledging both the virtues and vices of rulers is essential for balanced storytelling, asserting that confronting uncomfortable truths fosters critical thinking and ethical understanding among students.

- About Religious Intolerance and Violence: Critics worry that highlighting events like temple destructions or religious persecution, without proper context, may reinforce communal biases and foster social division. They stress the risk of such content being misinterpreted by young minds. But these inclusions will help critically examine how religion was politicized in the past. Moreover, such discussions will help students distinguish faith from fanaticism and promote values like pluralism, tolerance, and good
- governance. About the 'Note on Some Darker Periods in History': The introduction of a note in textbooks advising students not to hold present-day communities accountable for past injustices has also drawn mixed reactions. This, in my view, is a thoughtful, empathetic step that promotes unbiased historical understanding, reconciliation, and social harmony.
- About Reducing Mughal History: The reduced focus on the Mughal era has sparked debate. Critics argue that downplaying such a pivotal period weakens the historical narrative's depth and continuity. In fact, the aim of these reduction is to broaden perspectives by including underrep-

ancient dynasties, tribal and regional movements, thereby enriching and diversifying the understanding of India's holistic past, and making the history curriculum more comprehensive.

CIVILIZATIONAL ETHOS AND MORAL EDUCATION IN CURRICULUM REFORM

The debate over NCERT's 2025 textbook revisions often overlooks a deeper educational vision which aims to foster moral and intellectual growth of learners through values-based curriculum grounded in India's civilizational heritage.

Texts such as the Bhagavad Gita, Ramayana, and Mahabharata are not simply literary or religious sources; they offer enduring insights into ethics, duty (dharma), and critical decision-making. These timeless lessons guide human civilization to act with integrity in the face of adversity, to stand for *satya* (truth), and to resist adharma (injustice), even when it is entrenched or dominant. Lord Krishna's exhortation to Arjuna — to perform his righteous duty without fear is framed in the curriculum not as a retreat from historical complexity, but as a timeless moral compass, encouraging learners to approach the world with clarity rather than reactive victimhood.

Similarly, the Sikh tradition contributes powerfully to this ethical discourse. The lives and teachings of the ten Sikh Gurus, especially Guru Gobind Singh Ji, exemplify the *Sant-Sipahi* (saint-soldier) ideal, an ethic that combines spiritual reflection with social courage and action. His stirring hymn, "Deh Shiva Bar Mohe Eh..." embodies values resented histories like of moral courage, service, and justice that education aspires to instil in citizens.

Thus teaching IKS enshrined in scriptures will help younger generations to imbibe values and virtues.

TOWARDS A NEW EDUCATIONAL ERA

The NCERT's revised textbooks are more than curricular updates, they represent a transformative shift in Indian education. By introducing concepts like svadharma, sustainability, and civic responsibility at the school level, these lay a strong ethical and intellectual foundation for life-long holistic learning.

The colleges and universities must sustain this momentum by fostering critical inquiry, broadening ethical discourse, and translating foundational values into research, innovation, and social impact. This is not a project of erasure, but of expansion of embracing India's rich civilizational wisdom while engaging with global challenges. Education must illuminate both history's triumphs and its trials, empowering learners to navigate the future with courage, integrity, and discernment.

The real task ahead is to deepen these reforms with inclusivity, ensuring that Indian education remains rooted in its heritage, responsive to its diversity, and resilient in the face of change. This moment presents an unprecedented opportunity to realign Indian education with its civilizational values and future aspirations. It is now for us to deepen and extend these transformations. creating a knowledge ecosystem that is rooted, resilient, and forward-looking.

Trumpeting Trump: Between American real estate foray in India, trade deals to trade wars

US President Donald John Trump is as much recognized for his uncontrived press conferences, protracting and retracting statements, controversial resolutions to diplomatic issues and undiplomatic gauches as much as he is acknowledged for starting an obtuse trade war which redundantly unsettled the world financial markets, upended decades of negotiated global trade agreements and stoked worries about a new wave of reticent inflation. Despite the personal and political

bonhomie with the Indian Prime Minister Shri Narendra Modi, there is no love lost and Indo-American relations under Trump can be at best described as ambivalent in nature.

But when Trump is not the partisan Trump, he is the entrepreneurial Trump. With his "Trump Towers", a series of Trump-branded real estate projects that are rapidly expanding in a resurgent India driven by e-commerce boom and manufacturing expansion in the industrial and warehousing sectors, Trump signalled the entry of the American real estateship into India along with his son Eric Frederick Trump from the renowned Mar-a-Lago Club in Florida, USA. India has emerged as an influential market for The Trump Organization conglomerate for the increasing demand for luxury homes in the country. The

business model of Trump Towers in India follows a brand licensing strategy. The Trump Organisation does not directly invest in real estate projects in India. Instead, it licenses the "Trump" name to Indian real estate developers who finance, construct and sell luxury properties under the Trump brand. The Trump Organisation earns royalty fees or a percentage of sales in exchange for allowing developers to use its brand name, which adds an internationalized appeal to the properties. To add more fascination to the fascinating intrigue, Trump is expected to earn crores of rupees from these projects without even directly investing any capital. In India, there are currently four "Trump Tower" properties forthcoming in Mumbai, Pune, Gurugram and Kolkata. With more launches expected in the coming months, India will have the highest number of Trump Towers, surpassing the USA.

new Income Tax Bill, 2025 has been ∟introduced in Parliament to replace India's aging Income-tax Act of 1961. This landmark bill promises a cleaner, easier-tounderstand tax law without fundamentally altering how much tax anyone pays. It's a comprehensive rewrite aimed at simplifying language and structure while preserving core tax provisions. In effect, the government is attempting to declutter six decades of amendments and jargon to create a tax code that ordinary citizens can grasp. This explainer breaks down what the new Bill entails, how it compares to the 1961 law, and what it means for different taxpayers - from salaried individuals to businesses and

WHY A NEW INCOME TAX BILL?

non-profits.

The Income-tax Act of 1961 has been the bedrock of India's tax system for over 60 years, but it has accumulated complex. Finance Ministry officials likened updating it to renovating an old house with too many extensions - at some point, you need a fresh blueprint. The Income Tax Bill, 2025, was tabled in the Lok Sabha on February 13, 2025, precisely to create that fresh blueprint. According to the Press Information Bureau, the effort was guided by three core principles:

Simplify text and structure: eliminating archaic, intricate language for clarity. No major policy changes:

EXPLAINER

In short, the government sought to rewrite the rulebook without moving the goalposts. Union Minister of State for Finance Pankaj Chaudhary summed it up by saying the new code should be "not just understood by experts but also accessible to the common citizens". This means an average taxpayer reading the law should have a better chance of understanding it without needing a tax lawyer at every turn.

The initiative for a new Bill was highly consultative. The Finance Ministry received nearly 21,000 suggestions from the public and experts during the drafting process. Best practices from countries like the UK and Australia were studied to learn how they simplified their tax codes. The result is a proposed law that's almost half the length of the old one. The Bill trims the fat: it cuts the word count by over hundreds of amendments 2.5 lakh words and reduces and become notoriously the number of sections from ogy sees improvement - for 819 to 536, consolidating 47 chapters into just 23. In place of dense text, it introduces user-friendly tables and formulas to present information more clearly (57 tables and 46 formulas, up from a handful before). 
Schemes for Efficiency: The new Bill empowers the government to introduce schemes to improve tax administration efficiency, transparency, and accountability. This builds on the existing "faceless" and electronic systems by allowing further innovations. For example, the law explicitly allows the government to roll out new technology-driven processes (with Parliament's oversight) to eliminate in-person interactions and optimise resources. In practice, this could mean more advanced e-filing systems or AI-assisted compliance tools in the future, all under a legal framework.

While mostly a carry-forward, the Bill does introduce a few notable updates to address emerging areas and

 Virtual Digital Assets Acknowledged: The definition of "undisclosed income" in tax raids is expanded to include crypto assets and digital assets. Under the 1961 Act. if tax officials found unaccounted cash, gold, or jewellery in a search, it could be deemed undisclosed income. Now, cryptocurrencies and digital tokens are explicitly on that list. This recognises the reality of modern investments - if you're hiding gains in Bitcoin, the taxman has a legal basis to count it as unaccounted wealth.

Searching the Cloud: To keep up with the digital age, tax authorities will have clearer powers to access data stored in "virtual digital space" during searches and seizures. Earlier, officers could search physical premises or seize computers and drives. The Bill explicitly allows them (with due authorisation) to penetrate online accounts and cloud storage - email accounts, social media, online trading or wallet accounts – by overriding passwords or encryption if needed. In simple terms, your cloud backup or online portfolio is not off-limits in an authorised tax investigation. While this boosts enforcement in an era where transactions are digital, it has also sparked privacy debates about the extent of these powers. Observers note that maintaining proper safeguards and oversight will be crucial as authorities venture into digital realms for evi-

The current Act said in such cases, the government could notify a definition, but if not, it was a grey area. The Bill now provides that if a term is undefined in both the treaty and the Act (and no notification exists), one can use the meaning from any other central law of India. This is an esoteric change, but it closes a loophole by providing an interpretational fallback, potentially reducing disputes in

cross-border tax situations. Crucially, what stays the same are the fundamental features: the five heads of income (Salary, House Property, Business/Profession, Capital Gains, Other Sources) are intact; the residency rules (determining who is taxed as an Indian resident) remain as before; and the methods of computing income under each head carry on with only cosmetic alterations. The Bill also doesn't tinker with existing offences and penalties for tax evasion - those remain as defined under the old law. So, evaders face the same consequences; the difference is that the provisions punishing weaker terms.

TAX SLABS, **EXEMPTIONS AND DEDUCTIONS: STABILITY WITH SIMPLICITY**

The Income Tax Bill, 2025 makes no changes to existing tax rates or slabs—your tax bracket remains the

same unless revised by the annual Budget. Notably, the Union Budget 2025-26 made income up to Rs 12.75 lakh effectively tax-free under the new regime, but this is a Budget measure, not part of the Bill.

ANTI-AVOIDANCE MEASURES AND TRANSPARENCY

The new Bill retains all key anti-evasion tools from the 1961 Act, including **GAAR**, which remains intact to curb tax-avoidance schemes. By rewriting these rules in clearer language, the Bill aims to reduce misuse and ensure taxpayers better understand compliance boundaries.

Transparency is enhanced with a requirement for the **Dispute Resolution Panel** to issue reasoned orders. The ethos of the law supports a non-adversarial tax envi**ronment**, complementing faceless systems and the Taxpayers' Charter.

Emerging income streams from the digital economy like influencer income or small e-commerce-may require clearer treatment. The parliamentary committee has recommended future amendments to address these.

Additionally, the **updated** return filing window has been extended from 2 to 4 years, encouraging voluntary compliance. For charitable trusts, the validity of registrations is proposed to increase from 5 to 10 years, easing administrative burdens for genuine non-profits.

In short: the Bill strengthens enforcement without adding new burdens, combining clarity, fairness, and tech-friendly compliance.

WHAT IT MEANS FOR SALARIED INDIVIDUALS

For salaried taxpayers, the Income Tax Bill, 2025, offers continuity and simplicity. Tax slabs, deductions like 800 and standard deduction remain unchanged-your benefits stay intact. 



On Friday evening, a Thailand military border commander declared martial law in eight districts on the frontier with Cambodia, citing "Cambodia's use of force to enter Thai territory".

"We have tried to compromise as we are neighbours, but we have now instructed the Thai military to act immediately in case of urgency," said Phumtham.

"If the situation escalates, it could develop into war -- though for now, it remains limited to clashes," he told reporters in Bangkok.

US cuts short Gaza ceasefire talks and accuses Hamas of lacking 'good faith'

The United States is cutting short Gaza ceasefire talks and bringing its negotiating team home from Qatar for consultations after the latest response from Hamas "shows a lack of desire to reach a ceasefire in Gaza", President Donald Trump's special envoy Steve Witkoff

said Thursday. "While the mediators have made a great effort, Hamas does not appear to be coordinated or acting in good faith," Witkoff said in a statement. "We will now consider alternative options to bring the hostages home and try to create a more stable environ-

ment for the people of Gaza." It was unclear what "alternative options" the U.S. was considering. The White House had no immediate

At a news briefing Thursday, State Department spokesperson Tommy Pigott did not offer details on what the "alternative options" the U.S. is considering.

When pressed for clarity on whether and how the U.S. would proceed, Pigott did not offer clarity and said, "This is a very dynamic situation."

He said there's never been a question of the U.S. commitment to reaching a ceasefire, but of Hamas' commitment.

A breakthrough in talks on a ceasefire deal between Israel and Hamas has eluded Trump's administration for months as conditions worsen in Gaza. The territory recentlv had its deadliest day yet for aid-seekers in over 21 months of war, with at least 85 Palestinians killed while trying to

Dozens of people in Gaza have starved to death in July as hunger surges

DEIR AL-BALAH, GAZA STRIP

Five starving children at a Gaza City hospital were wasting away, and nothing the doctors tried was working. The basic treatments for malnourishment that could save them had run out under Israel's blockade. The alternatives were ineffective. One after another, the babies and toddlers died over four days.

In greater numbers than ever, children hollowed up by hunger are overwhelming the Patient's Friends Hospital, the main emergency center for malnourished kids in northern Gaza.

The deaths last weekend also marked a change: the first seen by the center in children who had no preexisting conditions. Symptoms are getting worse, with children too weak to cry or move, said Dr. Rana Soboh, a nutritionist. In past months, most improved, despite supply



shortages, but now patients stay longer and don't get better, she said.

"There are no words in the face of the disaster we are in. Kids are dying before the world ... There is no uglier and more horrible phase than this," said Soboh, who works with the U.S.-based aid organization Medglobal, which supports the hospital.

This month, the hunger that has been building among Gaza's more than 2 million Palestinians passed a tipping point into accelerating death, aid workers and health staff say. Not only children usually the most vulnerable — are falling victim under Israel's blockade since March, but also adults.

In the past three weeks, at least 48 people died of causes related to malnutrition, including 28 adults and 20 children, the Gaza Health Ministry said Thursday. That's up from 10 children who died in the five previous months of 2025, according to the ministry.

The U.N reports similar numbers. The World Health Organization said Wednesday it has documented 21 children under 5 who died of causes related to malnutrition in 2025. The U.N. humanitarian office, OCHA, said Thursday at least 13 children's deaths were reported in July, with the number growing daily.

Ishiba Don't quit': unlikely support grows for Japan PM

Japanese Prime Minister Shigeru Ishiba's future is uncertain but an unlikely campaign for him to stay was growing online this week, including from people who are his natural political opponents.

The life raft has emerged since upper house elections on Sunday deprived Ishiba's coalition of an upper house majority, months after it suffered a similar disaster in the lower chamber.

Despite Ishiba, 68, insisting that he has not discussed

his resignation with members of his Liberal Democratic Party (LDP), multiple reports say that it is just a matter of time.

Some conservative members of the LDP are collecting signatures to hold a special meeting to discuss a leadership election to oust Ishiba, Fuji TV reported on

One reported signee is Sanae Takaichi, a hardline nationalist and onetime heavy metal drummer who lost a leadership contest to Ishiba in September.

Takaichi, 64, would likely run again to lead the party -- and become Japan's first woman prime minister if she wins -- if Ishiba does depart.

The prospect of someone as premier with hawkish views on Japanese history and China has fuelled online calls for the moderate Ishiba to remain in power under the hashtag "#Ishiba Don't quit".

NETANYAHU SAYS ISRAEL WEIGHING OPTIONS TO CEASEFIRE TALKS WITH HAMAS

Israeli Prime Minister Benjamin Netanyahu said Friday his government was considering "alternative options" to ceasefire talks with Hamas after Israel and the U.S. recalled their negotiating teams, throwing the future of the negotiations into further uncertainty.

Netanyahu's statement came as a Hamas official said negotiations were expected to resume next week and portrayed the recall of the Israeli and American delegations as a pressure tactic.

The teams left Qatar on Thursday as President Donald Trump's special envoy, Steve Witkoff, said Hamas' latest response to proposals for a deal showed a "lack of desire" to reach a truce. Witkoff said the U.S. will look at "alternative options," with-



out elaborating.

In a statement released by his office, Netanyahu echoed Witkoff, saying, "Hamas is the obstacle to a hostage re-

"Together with our U.S. allies, we are now considering alternative options to bring our hostages home, end Hamas's terror rule, and secure lasting peace for Israel and our region," he said. He did not elaborate. Israel's government didn't immediately respond to whether negotiations would resume next week.

Hiroshima marks 80 years since atomic bombing with message of peace

The year 2025 marks a significant milestone-80 years since the atomic bombings of Hiroshima and Nagasaki.

It is a solemn and memorable year for both cities, especially Hiroshima, which continues to share its message of world peace and the abolition of nuclear weap-

To commemorate this occasion, Hiroshima City and its partners are showcasing powerful evidence of the

devastation caused by the atomic bomb.

Their goal is to spread the "Hiroshima Spirit" -- a global call for everlasting peace and the complete elimination of nuclear arms.

As part of these efforts, the interior of the Atomic Bomb Dome -- a place usually offlimits to the public -- has

been opened to the media. This rare access serves as a powerful symbol, offering the world a first-hand look at the remains of the catastrophe. Inside the dome lie broken bricks, collapsed stones,

and deformed steel frames, all damaged by the blast.

In 1996, the Atomic Bomb Dome was registered as a UNESCO World Heritage site, standing as a reminder of the horrors of nuclear warfare.

Before the bombing, approximately 6,500 people lived in what is now the Hiroshima Peace Memorial Park. Today, their remains lie beneath the ground. Every year, citizens gather to offer prayers, saying: "Please sleep peacefully. We shall not repeat the same mistake."



An estimated 1,40,000 people died as a result of the bombing in 1945. As of now, around 2,50,000 survivors -- known as Hibakusha -are still alive, serving as liv-

ing witnesses to the tragedy. However, as time passes and survivors age, Hiroshima City is taking steps to preserve their testimonies for future generations.

Legacy Successor Training Program, aimed at training younger generations to share the survivors' experiences. Additionally, a groundbreaking AI-based testimony simulation has been developed. It features virtual interviews with six survivors, including 94-year-old Yoshiko Kajimoto. On one side, she appears in a recorded video, while on the other, an interactive AI avatar answers audience questions. The system includes

Explaining her decision to participate, Ms Kajimoto said, "Even after I am gone, the horror of the atomic bombing must not be forgotten. I want future generations to know and remember. I'm happy to support this project.

Hiroshima Mayor Kazumi Matsui emphasized the city's commitment to peace. He said, "To preserve the memory of this tragedy, we are training the next generation to carry on the testimonies.

In a world where conflicts still erupt. Hiroshima sends a message of peace and nonviolence.' He also extended a mes-

sage to India and said, "We received a statue of Mahatma Gandhi, a symbol of nonviolence. I sincerely hope that India will embody this ideal and work toward a peaceful society and the abolition of nuclear weapons."

On August 6, Hiroshima will host a major ceremony to commemorate the anniversary and send a strong message of peace to the world.

FRENCH PRESIDENT MACRON SAYS FRANCE WILL RECOGNIZE PALESTINE AS A STATE

Additionally, UK service sectors, including financial and legal services, will benefit from increased market certainty within India's expanding economy.

In addition to this agreement, the high-level interactions of the Indian PM in the UK were focused on enhancing bilateral cooperation in various areas. He had a productive meeting with His Majesty King Charles III. During this meeting, various facets of India-UK relations were discussed, including the progress made in trade and investment following CETA and Vision 2035. Other topics of conversation encompassed education, health and wellness, with a particular emphasis on Yoga and Ayurveda. Prime Minister Modi mentioned that they

also addressed issues related to environmental protection and sustainability.

In the second leg of his visit, the Indian PM has embarked on a State Visit to the Maldives at the invitation of the President of the Republic of Maldives, Dr. Mohamed Muizzu. This marks the Indian PM's third visit to the Maldives and is the first visit by a Head of State or Government to the Maldives during President Muizzu's term. The Prime Minister will serve as the 'Guest of Honour' at the celebrations commemorating the 60th anniversary of Maldives' Independence on July 26, 2025. Throughout the visit, it is expected that the Indian PM will engage in discussions regarding issues of mutual interest. Additionally, the two leaders will review the progress made in implementing the India-Maldives Joint Vision for a 'Comprehensive Economic and Maritime Security Partnership', which was established during the State Visit of the President of Maldives to India in October 2024. This visit underscores the significance India places on its maritime neighbour, Maldives, which remains a key component of India's 'Neighbourhood First' policy and Vision 'MAHASAGAR', which was announced by Indian PM during his visit to Mauritius. Furthermore, the visit will create an opportunity for both nations to enhance and fortify their close bilateral relationship. Overall, this week deserves recognition for India due to its endeavours in promoting both bilateral and multilateral cooperation and collaboration, continually echoing the philosophy and vision of "Vasudhaiv Kutumbakam"!

that stirs the chords in your hearts, deeply touching your souls. play and the dialogue. Vaani's diary, with its constant presence, plays an important role in the story right from her first ever introduction with Krish and till the climax.



The science behind IVF has never been stronger. From embryo selection aided by artificial intelligence to precision-driven protocols, fertility care is becoming more advanced and datainformed than ever before. Yet for millions, access to that care remains distant. The World Health Organization reports that one in six people globally face infertility, and in India, 10 to 15 percent of couples are affected. But fewer than one percent receive advanced treatment. The problem is not science. It is access. And solving that requires a rethinking of how fertility care is structured, supported, and delivered.

RETHINKING THE COST BARRIER

For many, the biggest hurdle to IVF is financial. A single cycle can cost between Rs 1.2 and Rs 2.5 lakh, and more than 80 percent of patients in India pay entirely out of pocket. This financial burden often leads to delays in starting treatment, which can reduce the overall chances of success.

What is needed now are scalable solutions that ease this pressure. Tier-wise pricing models, transparent package structures, and zero-interest EMI options are gaining traction. Some clinics report that nearly 20 percent of patients now choose EMI plans. But affordability cannot rely on instalments alone. Insurance coverage must evolve to include fertility treatment as part of essential reproductive care. Without that, financial access will remain one of the biggest barriers to timely interven-

TAKING CARE CLOSER TO PEOPLE

Fertility services have traditionally been concentrated in large metro cities, limiting access for much of the population that lives outside them. This urban concentration often results in delayed diagnosis and lower success rates.

To change this, fertility infrastructure must expand into tier-2 and tier-3 cities. Full-service clinics, local diagnostic camps, and awareness initiatives can bring timely care closer to where people live. While some progress is underway, sustained investment will be key to making this reach reliable and equi-

SUPPORTING PA-TIENTS BEYOND THE PROCEDURE

Fertility treatment can be overwhelming. It involves frequent appointments, hormonal medications, and emotional highs and lows that can stretch over months. Many patients drop out not because of medical failure, but because the process becomes

too exhausting to continue. Digital tools can play a critical role in easing this journey. App-based systems that offer automatic reminders, medication trackers, cycle updates, and ovulation monitoring can help patients stay informed plified communication. and continuous engagement help reduce the burden of coordination and keep people from falling through the cracks.

But the real power of these tools lies in how they make patients feel. In a process where stress often affects outcomes, feeling supported at every step can make all the difference. The goal is not just efficiency, but care that is more human, consistent, and reassuring.

Despite all the advancements, awareness is still limited, and stigma, particularly among men, continues to delay care-seeking. These gaps are precisely why business innovation must remain central to the evolution of fertility care. Because innovation is not just about new systems or technologies. It is about rei-

magining care in a way that is more accessible, more compassionate, and more complete.

MOVING FROM PRO-TOCOL TO PERSON-ALISATION

Fertility care is steadily moving beyond one-sizefits-all protocols. Most clinics now begin with comprehensive diagnostic workups that include hormonal profiles and ultrasound assessments. are supported throughout. Medical science is already advanced. To match that progress, the systems around it must now evolve with equal intent. That is how access can shift from an aspiration to a reality.



WHEN DO GOOD INTENTIONS LEAD TO GOOD RESULTS?

'oral teachings tell us that the legiti-Lmacy of any action is decided by the intention behind it. That is why when someone acts with sincere goodwill, but the outcome turns out badly, we tend to forgive or even honour that effort. Many religious traditions emphasise pure intention as essential to the ethical or spiritual legitimacy of an action. Even in law, intent often determines whether an act is criminal.

Actions performed with intentions without underintentions such as promoting well-being, justice, or honesty, are seen as morally right. They are considered superior to kindly acts that are done with other motives. For example, donating to charity out of genuine concern for others is more ethical than doing so for personal gain or to impress

Actually, intentions reflect our state of mind, including our values, beliefs, and attitudes. They indicate whether we have acted out of compassion, duty, self-interest, or any other motive.

However, having good intentions is not enough. We may have noble intentions but never act on them — or act too late. For example, someone might intend to help the poor but never actually do anything concrete.

standing the full context or consequences. For example, giving money to a beggar on the street might feel generous, but if that money is spent on buying and consuming liquor, which harms the beggar's health and leads to criminal behaviour, we contribute to doing more harm than good.

Actions, no matter how well-intentioned, can have unfortunate consequences if they are naive, poorly executed, and are actually unwanted but are still carried out because of overzealous-

The phrase "The road to hell is paved with good intentions" is a warning about how good intentions, without thoughtful action or awareness of the outcome, can lead to damaging results. The effects of our We can also act on good actions and the responsibil-

ity taken for them are sometimes more important than the intention behind them.

This is what the law of karma teaches us. Karma refers to the principle of cause and effect. Most of us know, even if we do not remember it all the time, that every action has an equal and opposite reaction, and that we reap what we sow. Positive actions generate good karma, while negative actions result in bad karma. Even a good deed done with a selfish motive may not generate good karma. Conversely, a lofty motive may end up causing suffering if it is misguided.

Sometimes we assume what is good for others, based on our own perspective. With a sense of superior intelligence or moral righteousness, we set about 'helping' people, believing that we are doing them a world of good, even as the hapless victims of our attentions pray for a quick end to our unwise exertions. Misplaced charity can go a step further, when good intentions are cited to justify actions that end up causing harm. "I was just trying to help" becomes a convenient excuse to avoid accountability.

The law of karma emphasises personal responsibility. Each individual is responsible for their actions and the consequences that arise from them. To be ultimately beneficial, good intentions must be accompanied by wisdom, humility, critical thinking, and a willingness to be accountable. Without all of these, they can cause real damage — even if they were meant to do good.

It will not be able to relate to others and, when it does, there will always be some conflict or dissatisfaction. Also, when a person lacks self-respect and a sense of identity, it attaches itself to others, believing that other people will fulfil them. So the slogan we hear nowadays is, "I want, I want, I want" and "I need, I need, I need." This is the cry of personal emptiness.

with money, but when people become attached to it, making it the goal of their lives, then problems begin. Self-respect and a sense of purpose in life cannot come from anything external; it is only possible with a consciousness based on spiritual values and criteria. Money is misused not only on a personal level, but



countries also use money negatively. When so many billions are used to buy, invent, or use weapons of war, for example, what kind of karma can that create? Most countries produce much more than for mere defensive purposes because, as with individuals, the condition of fear creates great insecurities which people and countries try to solve in various materialistic ways; inevitably, a materialistic solution is short-term and leaves a void.

Time is precious. It is said, never leave for tomorrow what you can do today. People who waste time and put things off do not value the opportunity that time is constantly offering so that improvement and development can be made for the self. The constant use of such words as "tomorrow", "perhaps", "maybe", "in the next life", all indicate the reluctance of a person to face himself and their responsibilities.

One thing that one can never get back is time that has passed. The person who understands the power of the "now" (the present) has the ability to change any negative consequences of the past and, with confidence and faith, sees a good future.

WHAT CREATES GOOD KARMA?

When a person is selfless - free of egocentric desires and ambitions - he is able to create good karma. Selfless action is the basis of personal peace and happiness and good relationships with others.

A person who is spiritually independent - free of materialistic needs and values - is also full of love and respect for the self and others. A soul who is not dependent on the praise or appreciation of what is done, finds his happiness and contentment $come\,from\,the\,simple\,fact\,that\,an$ action is being done in the right way at the right time. A closeness to God, spiritual values and personal experience shows such a soul what "the right" is.

WHERE IS KARMA RECORDED?

Our accounts, our debts, are recorded in the soul. These recordings then determine where and to whom we are born in every life, what talents we are born with, what handicaps we have, either emotional, mental or physical. This process, of balancing our accounts with others, works automatically, with no interference or direction from God.

HOW IS NEGATIVE KARMA REMOVED?

Despite the fall of wickets, England maintained a solid run rate. Stokes' retirement added a twist late in the day, as he appeared to be struggling after a brief flurry of short-ball exchanges.

Meanwhile, England veteran batter Joe Root surpassed former Australian skipper Ricky Ponting to become the second-highest run scorer in Test cricket history, as his partnership with England skipper Ben Stokes helped his side to take a healthy lead over India at the end of sec-

Indian men's hockey team set to tour Australia for four-match series

The Indian men's hockey team is set to tour Australia in August for a four-match series, set to be held at the Perth Hockey Stadium from August 15 to 21. The series promises to be a highly competitive contest, featuring eighth-ranked India taking on sixth-ranked Australia. The matches will be played on August 15, 16, 19, and 21.

The two sides recently faced

each other in the FIH Pro League 2024-25 in Europe, where Australia edged India 3-2 in both legs. However, India had earlier scripted a memorable 3-2 victory over the Kookaburras at the 2024 Paris Olympics -- their first Olympic win over Australia since the 1972 Munich Games. While recent encounters have been closely fought, Australia have historically held the



edge in the rivalry, winning 35 of the 51 matches played between the two teams since 2013. India have won nine times, with seven matches ending in draws.

The series will serve as important preparation for India ahead of the Hero Asia Cup 2025, set to be held in Rajgir, Bihar, from August 29 to September 7. The tournament offers a direct qualification spot for the FIH Hockey Men's World Cup 2026, making the Australia tour a key milestone in India's buildup.

Speaking on the tour, Indian men's hockey team chief coach Craig Fulton said, as quoted from a press release by Hockey India, "This tour comes at a crucial time for us, just ahead of the Hero Asia Cup in Bihar. While these are technically friendly matches,

they form a very important part of our preparation phase. Playing against a team like Australia will test us in all to the game. Always for In-namurthy's last competitive aspects -- both on the ball dia. Always for the team." and off it -- and that is exactly what we need to sharpen up before a major tournament."

Koneru Humpy vs Divya Deshmukh: First all-Indian final at FIDE Women's Chess World Cup

In a first for Indian chess, the FIDE Women's World Cup will have a winner from the country with Koneru Humpy and Divya Deshmukh set to fight it out in what could be anybody's game in the grand finale here on Saturday. It's the first in the event's history that two Indians are facing each other in the final. Both Humpy and Deshmukh have qualified for the Women's candidates' tournament next year after reaching the final here. On pure experience of playing big games, Humpy goes in the final as the favourite against compatriot Deshmukh.

Humpy held her nerves to score a come-from-behind victory in the semifinals over Tingjie Lei of China in the tiebreaker on Thursday, while



Deshmukh defeated former world champion Zhongyi Tan -- also of China -- in the second game of the last-four stage match.

Grandmaster Humpy, 38, was the winner of the world women's rapid tournament and also tied for first at the women's grand prix in recent times and she has proved yet again that age is just a number. Her grit and determina-



tion has not faded one bit in the past many years.

"It's one of the happiest moments for chess fans because now the title will go to India for sure. But of course, as a player, tomorrow will be quite a tough game as well -- Divya has played tremendously well in this whole tournament," Humpy told FIDE website.

At half the age of Humpy, International Master Deshmukh has already stunned as many as three players ranked in top ten in the event. Her first victim was second seed Jiner Zhu of China, before ousting D Harika.

The 19-year-old Nagpurbased Deshmukh then beat former women's world champion Zhongvi Tan of China in the semifinals.

"I just need some sleep and some food, these days have been so anxious for me," Deshmukh said after entering the final.

"I think I could have played much better. I was winning at a certain point and then it got complicated. I think I messed up in the middlegame and that I should have had a much smoother win," she said about her semifinal

"She put up such a great fight at a certain point. I was iust doubting if it was just a draw -- I think I got lucky in the end."

Humpy was stretched to the tiebreaker in the pre quarterfinals by former world champion Alexandra Kosteniuk of Switzerland and she followed it up with a clinical performance against Yuxin Song.

Her best, thus far, was reserved for the semifinals as she outclassed top seed Tingjei Lei of China in the five minutes' games after the players had reached a 3-3 deadlock.

"I played a bit shaky in the rapid, but she also gave a very good fight. It could have gone either way," Humpy said about her semifinal opponent.

"It was a very tough match. Initially, I played quite badly with the Black pieces and she always had the advantage.
