Rebutting the charges, Prime Minister Modi said the Congress is 'importing issues from Pakistan'

rime Minister Narendra Modi on Tuesday launched a blistering counter to Opposition charges in the Lok Sabha, asserting that India's retaliatory military campaign against Pakistan under Operation Sindoor exposed the neighbouring country's vulnerabilities and was executed without succumbing to any international pressure. Modi, in his most detailed remarks yet since the 22 April Pahalgam terror attack, categorically dismissed suggestions by the Congress and its leader Rahul Gandhi that New Delhi's response was limited or externally influenced.

"No global leader told us to stop. Operation Sindoor is still on and will continue as long as necessary, on our timeline and on our terms," PM Modi told Parliament on the day it was announced by Home minister Shah that the security forces had killed all the three Lashkar-E-Taiba terrorists on Monday who had executed the Pahalgam massacre.

PM Modi further disclosed that Pakistan's leadership had "pleaded for a ceasefire" after sustained Indian missile and drone strikes dismantled multiple terror launchpads and military

to their knees. PM Modi also revealed that on the night of 9 May, US Vice President JD Vance had tried repeatedly to speak with him amid fears of Pakistani escalation. "He tried for an hour, but I was in a meeting with our forces," Modi said. "When I called him back, he warned me Pakistan was planning a big attack. I told him clearly: if that is Pakistan's intention, it will pay a heavy price. Goli ka jawab gole se diya jayega (we will reply to a bullet with a cannonball)."

Diplomatically speaking, not taking a call is often interpreted as a signal to the caller that the recipient is unwilling to entertain the terms likely to be proposed at that time.

Emphasising India's resolve, PM Modi said: "On 10 May, we destroyed Pakistan's military strength. Even Pakistan understands now that every reply by India is bigger than the last. It knows India can go to any extent if provoked."

The Prime Minister's remarks came shortly after Leader of Opposition Rahul Gandhi accused the government of lacking political will and "curtailing the armed forces' freedom of manoeuvre" during Operation Sindoor. Gandhi pointed to Defence Minister Rajnath Singh's earlier statement that India's Director Gen-

Three perpetrators of Pahalgam attack eliminated, Shah announces in LS

Three of the terrorists who carried out the Pahalgam massacre have been eliminated by security forces in a joint operation by the Army, CRPF and Jammu and Kashmir Police near Srinagar, Union Home Minister Amit Shah announced in the Lok Sabha on Tuesday.

The terrorists were killed Monday in an operation dubbed Mahadev but officials had held back in identifying them conclusively as the Pahalgam attackers.

Participating in a special discussion on Operation Sindoor, Shah also attacked the opposition party for giving a "clean chit" to Pakistan for the April 22 Pahalgam attack. Had the Congress opposed Partition, the problem of terrorism in Jammu and Kashmir would never have occurred, he said.

Shah was referring to former Home Minister P Chidambaram's recent remarks that those behind the Pahalgam massacre could be

Stealth, shadow, kill: How forces took out the terrorists

Revealing the precision and stealth of Indian forces, the three Pakistani terrorists killed in Kashmir on Monday were caught completely unaware—until it was too late to escape

According to details accessed by The Daily Guardian, the build-up to the operation that led to the

elimination of the terrorists—who carried out the 22 April Pahalgam massacre began when security forces first picked up indications of their presence in the area on 22 May.

However, it was only on 22 July that movement was confirmed, triggering the deployment of operational

units. Following this confirmation, security teams moved swiftly and began closing in on the suspected hideout. A 12-member unit tracked


one of the terrorists, identified as Hamza Afghani alias Afghani Bhai, while maintaining distance to avoid alerting the group. By following him, the team was led to the hideout used by all three terrorists, which was covered with a plastic sheet strung between trees

Haryanvi singer booked for performing banned song at Punjab University

The Chandigarh police have booked Haryanvi singer Masoom Sharma for allegedly performing a banned song during a live concert at Punjab University earlier this year. The event had sparked controversy, coincided with campus violence leading to the murder of a student. The incident took place on March 28 at a student event hosted by the University Institute of Engineering and Technology (UIET) in Sector 25, Chandigarh.

Sharma, who enjoys massive popularity for songs like Bhagatt Aadmi and 2 Numbari, is accused of performing Chambal Ke Daku, a song officially banned by the Chandigarh administration and Haryana government for its alleged glorification of violence. The track had racked up more

YouTube before it was taken down and even helped Sharma to reach among the top 10 singers of YouTube. Despite giving a written assurance that he would avoid any controversial or prohibited content, Sharma allegedly performed the banned song during the university fest. Based on a complaint by ASI Surendra Singh, Police Station Sector 11 registered an FIR under Section 223 of the Bharatiya Nyaya Sanhita (BNS) for defying the Deputy Commissioner's orders.

As per the police complaint the situation was further compounded by a tragic altercation at the same event. A violent clash broke out between two student groups behind the stage during the show, leading to the death of Aditya Thakur, a second-year Computer Science student. Three others were injured in the incident. However, the Chandigarh

police have launched a separate murder investigation but it remains unclear whether the violent lyrics of the song contributed to the unrest. In the aftermath, the case has reached the Punjab and Haryana High Court, where a petition has been filed referencing a 2019 court directive that ordered a ban on songs promoting violence, weapons, and obscenity.

The petition claims Sharma's actions were in clear violation of that order. The court has issued notices to the Chandigarh DGP, Deputy Commissioner, and PU's Dean of Student Welfare, seeking their responses. This isn't the first time Masoom Sharma has drawn criticism for his lyrics. The Haryana government has banned over 30 songs, many of them by Sharma, citing the promotion of gun culture, substance abuse, and anti-social behavior.

Water Resources Minister allocates Rs 276 crore to prevent floods TARUNI GANDHI

Punjab government has completed the cleaning of the state's drainage systems and strengthened embankments to tackle any kind of flood-like situation, stated Punjab Water Resources Minister Barinder Kumar Goyal while addressing media persons here at Punjab Bhawan today.

After reviewing the arrangements made by the Water Resources Department to deal with any potential floods during the high level meeting, Sh. Goyal informed the journalists that the state government has completed 1220 projects worth Rs.276 crore to tackle potential flood situations. These projects include river revetment work, installation of studs, strengthening operations and desilting/ cleaning of drains. He said that additionally, 600 check dams have been constructed



with 1104 and more check dams under construction. Besides this, 3905 soak pits are being created, over 53,400 bamboo saplings have been planted and 226 kilometers of vetiver grass has been cultivated.

The Cabinet Minister informed that out of the 850 drains, 601 drains required cleaning this year, which has been completed. He said that so far, 4766 kilometers of drains have been cleaned. Goyal said that the department has completed drain desilting/cleaning work using departmental machinery, resulting in 65% cost savings compared to con-



"Innocent civilians were killed in front of their families by asking their religion. I condemn this barbaric act. I express my sympathies to the families who lost their loved ones. he added. On Monday, three terror-

ists were killed in Operation Mahadev in an intense firefight with security forces in the Harwan area near Dachigam National Park of Srinagar in Jammu and Kashmir.

During the discussion on Operation Sindoor in Parliament, BJP MP Baijayant Jay Panda told the House that it appears that at least one terrorist involved in the Pahalgam attack has been neutralised in an ongoing antiterror operation, Mahadev, in Jammu and Kashmir.















Should terrorist hideouts sheltered in Pakistan be attacked once again?

He said after the elimination of the three terrorists. he thought this news would spark a wave of joy across treasury and opposition benches. "But opposition faces are gloomy," he said.

Describing Pakistan as the root of all terrorism, he said Pakistan was a mistake committed by the Congress. "Had they rejected Partition, there would have been no Pakistan," he added.

Highlighting indigenous defence capability, PM Modi added, "From drones to missiles, our entire operation was powered by Made-in-India systems. The world is witnessing the strength of a self-reliant India."

Modi also underlined that Operation Sindoor was conceived as a non-escala-Bahawalpur and Muridke enough to neutralise Pakistan's terror infrastructure. "On the night of May 6-7, we conducted an operation the way we wanted, and Pakistan couldn't do anything. In just 22 minutes, we avenged the April 22 attack," he said.

India into halting its operations, Modi said there was "no question" of India relenting under external influence. "We made it clear from day one: India will decide the terms and the timeline. The three terrorists, all highly trained in military warfare, had so far successfully avoided detection, which was a key reason they had managed to evade a robust surveillance and tracking network that Indian agencies had activated following the Pahalgam attack for almost 100 days.

As reported by this newspaper earlier, it was confirmed by Home Minister

Amit Shah in Parliament on Tuesday that all three belonged to Pakistan. Security forces were able to identify them using Pakistani voter numbers found on their person. Chocolates manufactured in Pakistan were also recovered from the site. Officials believe that ad-

ditional material directly linking the terrorists to Pakistani state support may have been recovered but has not yet been made public for strategic reasons.

All three were designated A-category terrorists and members of the Lashkar-e-Taiba. The time taken by the agencies to officially confirm their identities and involvement in the Pahalgam massacre was, according to Shah's statement in Parliament, due to the requirement of multiple levels of forensic verification before

public disclosure. To that end bullet shells massacre site were matched with rounds fired from weapons seized after Monday's encounter. As reported by this newspaper earlier, these included an American M9 pistol and two AK-47 assault rifles which were flown to the Central Forensic Science Laboratory (CFSL) in Chandigarh on a special aircraft late Monday night.

At 4 AM Tuesday, a ballistic report was presented to Home Minister Shah. In a video call attended by six CFSL scientists, it was confirmed that the bullets matched-conclusively linking the recovered weapons to the Pahalgam killings.

The identities of the three terrorists were further corroborated by arrested over ground workers who had provided them shelter and logistical support during the planning and execution of the massacre.

Govt raised Rs 35,104 cr in tax, penalties under Black Money Act

The government has raised a tax demand of almost Rs 35,000 crore under the Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015 from July 1, 2015 to March 31, 2025, but only Rs 338 crore has been recovered till March 31 this year, the Parliament was informed on Tuesday.

The revelations were made after the Ministry of Finance in a written response to the unstarred question raised by Rajya Sabha MP John Brittas regarding black money and the surge of Indianlinked funds in Swiss bank accounts.

In its response, the Ministry cited media reports referencing Swiss National Bank (SNB) statistics that indicate a rise in Indianlinked funds in 2024 compared to the previous year.

However, the Ministry stated that these statistics



include various financial instruments such as customer deposits, deposits in foreign branches of Swiss banks. other liabilities as well as amounts due to banks.

The Swiss authorities have also reportedly stated that the SNB statistics shouldn't be used for analysing deposits held by Indian residents in Switzerland.

The Ministry further informed that tax demands totalling Rs 21,719 crore were raised between July 2015 and March 2025 under the Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015.

Additionally, penalty demands amounting to Rs 13,385 crore were raised during the same period.

Thus the tax demands of Rs 21,719 crore from 2015 to 2025 and additional penalty of Rs 13,385 crore bring the amount to approximately Rs 35,000 crore.

However, no country-wise breakup of these demands is maintained.

Notably, despite the substantial demands raised, only Rs 338 crore has actually been recovered till March 31, 2025, reflecting a significant gap between the claimed liabilities and actual realisation

Union Agriculture Minister Shivraj Singh Chouhan on Tuesday highlighted the government's efforts to boost agricultural productivity and promote diverse farming practices, including fruits, flowers, vegetables, dairy, fish farming,

and animal husbandry. Speaking during the Question Hour in the Lok Sabha, Chouhan said, "We increased production, reduced input costs, ensured better prices, compensated losses, and promoted diverse agriculture. Not just the farming of one crop, but the farming of fruits, flowers, vegetables, dairy, agriculture, fish farming, and animal husbandry. We have tried many different things."

The minister detailed

significant increases in agricultural output over the past decade, citing specific figures for various crops and milk production.

"Over the last ten years, the production of crops has significantly increased. The production of full food grains was 240.42 million tonnes in 2013-14. It has increased to 353.96 million tonnes. The production of dal was 16.38 million tonnes. It has increased to 25.24 million tonnes. The production of tilhan was 27.51 million tonnes. It has increased to 42.61 million tonnes ... The milk production was 137.7 million tonnes. It has increased to 249.30 million tonnes," he stated.

Chouhan also outlined key financial support schemes for farmers, including the PM-KISAN

scheme, increased Kisan Credit Card (KCC) funding, the Pradhan Mantri Fasal Bima Yojana, and enhanced Minimum Support Price (MSP) policies, while emphasising subsidies on urea and DAP to boost farmer incomes. "Under PM-KISAN, 10

crore farmers benefited with Rs 2 lakh crore in subsidies. KCC funding rose from Rs 7 lakh crore under Congress to Rs 25 lakh crore under the BJP. Pradhan Mantri Fasal Bima Yojana paid Rs 1.43 lakh crore claims against Rs 35,000 crore premiums. MSP now includes 50 per cent profit over production costs, which Congress rejected during its rule. Urea and DAP subsidies further boosted farmer incomes," Chouhan added.

BJP slams Cong over 42% quota move in Telangana

The Telangana unit of the Bharatiya Janata Party (BJP) has launched a blistering critique of the ruling Congress party over its push for 42% reservations for Backward Classes (BCs) in local body elections. In a press statement released on Monday, BJP's Chief Spokesperson and Media In-charge for Telangana, Sri N.V. Subhash, accused the Congress of running a "deliberate and deceptive campaign" aimed at covering up its own legislative failures.

Subhash came down heavily on State Minister Ponnam Prabhakar, alleging that the Congress is attempting to blame the Union Government and even drag the President of India into the matter to mask its own inaction. "The Congress is playing politics with the Constitution. If they are truly committed to BC welfare, they can imple-

ment the 42% reservation directly at the gram panchayat level instead of indulging in political theatrics and blaming the Centre," he stated.

Calling the Congress' current campaign a "smokescreen to mislead the people," Subhash reminded the ruling party that the 73rd Constitutional Amendment-which strengthened Panchayati Raj institutions was enacted during the Congress regime itself under Ra-

"Why is the Congress now

shirking from its responsibility to act? Let them convene a special session of the Assembly and amend the laws if they are sincere," he said.

Subhash further stated that the Modiled NDA government has shown genuine commitment to social justice, citing the constitutional amendment that enabled 10% EWS reservations, and the effective implementation of SC/ ST quotas, all within the 50% ceiling mandated by the Supreme Court.

Quoting the apex court's judgment in the Maratha reservation case, Subhash noted that exceeding the 50% reservation cap is permitted only in exceptional circumstances involving a high SC/ ST population—conditions which Telangana does not meet. "The Congress is falsely equating Telangana with tribal-dominated states like Jharkhand or North-Eastern regions to justify its political agenda," he said.

CISF sees 40% drop in suicides since Nov 2024 post mental health initiative

A mental health initiative launched jointly by the Central Industrial Security Force (CISF) and the Aditya Birla Education Trust (ABET) in November 2024 has led to a 40% reduction in suicide incidents among CISF personnel—a development being hailed as a major breakthrough in institutional mental wellness within India's paramilitary forces.

The initiative, titled Project Mann, has extended psychological support to over 75,000 personnel and their families through a wide network of counselling services, clinical interventions, psychometric screenings, peer engagement, and a dedicated 24×7 helpline across CISF units.

On Monday, CISF Director General R.S. Bhatti and ABET Chairperson

Neerja Birla jointly reviewed the project's progress and committed to expanding its reach in the years ahead. The initiative, being run in partnership with Mpower, the mental health arm of ABET, was formalised through a Memorandum of Understanding signed in November 2024.

"Mental health is as mission-critical

as physical fitness for our personnel." DG Bhatti said during the meeting. "This initiative strengthens our internal support systems and ensures that our personnel remain emotionally resilient, focused and operationally ready."

Official sources told the Daily Guardian that Project Mann has enabled 1.726 CISF officers and sub-officers to be trained in identifying and handling low-risk mental health concerns at the grassroots level, escalating more serious cases to clinical professionals. This two-tiered framework has helped embed psychological support mechanisms within everyday CISF operations.

According to officials, high-sensitivity units like IGI Airport, Delhi Metro, and Parliament have seen over 31,000 personnel undergo psychometric evaluation to flag potential risks early.

Assam launches largest-ever eviction drive in Uriamghat, Golaghat

The Golaghat district administration on Monday launched Assam's largestever eviction drive in the Rengma forest area located along the Assam-Nagaland border in Uriamghat.

For the operation, over 2,000 Assam Police personnel and around 500 forest guards have been deployed in the area. More than 100 excavators and Pokland machines have been kept ready for the drive. The move cleared 11,000 bighas (approximately 3,600 acres) of land in the Rengma Reserve forest at Uriamghat, bordering Nagaland. The eviction drive will affect nearly 2,000 families who have allegedly encroached on the forest land and turned it into a betel nut plantation linked with the betel mafia.

According to officials, the administration will demolish a total of 2,648 illegal houses constructed in 12 suspected villages within the Rengma forest area. The eviction drive will cover localities such as Sonaribil Top, 2 No. Pithaghat, 2 No. Dayalpur, 3 No. Dayalpur, Dalanpathar, Kherbari, Vidyapur, Vidyapur Bazaar, 2 No. Madhupur, Anandpur, Rajapukhuri and

As per Assam Police IGP Akhilesh Kumar Singh, «We had already made preparations and the local people have also cooperated as no one wants construction in the forest lands.»

Security convoys have arrived in Sarupathar from various districts, while heavy machinery has been brought in from Golaghat, Merapani, Sivasagar and Tinsukia. Senior officials, including Additional Superintendents of Police, Deputy Superintendents, and Assistant Commissioners from several districts, are monitoring the operation on the ground.

As per the administration's plan, the eviction drive began on Monday morning from the Vidyapur area.

A bench of Justices Surya Kant and Joymalya Bagchi noted that as a constitutional authority, the Commission must adhere strictly to the legal framework and ensure no eligible voter is excluded arbitrarily.

Yesterday, during the hearing, Justice Surya Kant observed that Aadhaar and the Electoral Photo Identity Card (EPIC) must be treated as valid documents for inclusion in the voter list.

The bench emphasised that large-scale exclusions cannot be permitted and that any suspicion of forgery should be addressed on a case-by-case basis.

Senior advocate Sibal and advocate Prashant Bhushan, appearing for the petitioners, once again alleged that people are being left out from the draft list to be published on August 1 by the poll panel and will lose their crucial right to vote.

Bhushan said the EC has issued a statement that 65 lakh persons have not submitted the enumeration forms during the SIR process as they are either dead or have permanently shifted elsewhere. These people will have to apply afresh for inclusion in the list, he submitted.

Justice Kant said, "The **Election Commission of In**dia, being a constitutional authority, is deemed to act in accordance with the law.

PALESTINIAN DEATH TOLL SURPASSES **60,000 IN ISRAEL-HAMAS WAR**

ore than 60,000 Palestinians have been killed during the Israel-Hamas war, Gaza's Health Ministry said Tuesday. Israeli strikes overnight killed more than two dozen people, mostly women and children, according to health officials

The Israeli offensive, launched in response to Hamas' attack on southern Israel on Oct. 7, 2023, has destroyed vast areas of Gaza, displaced around 90% of the population and fueled a catastrophic humanitarian crisis.

Experts warned Tuesday that the territory of about 2 million Palestinians is on the brink of famine after Israeli restrictions and a breakdown of security have made it nearly impossible to safely deliver aid.

The Health Ministry, part of the Hamas-run govern-



ment, said that the death toll has climbed to 60,034, with 145,870 others wounded since the war started. The victims include 18,592 children and 9,782 women. Together, they make up nearly half the dead.

The ministry, which doesn't distinguish between civilians and combatants in its count, is staffed by medical professionals. The United Nations and other independent experts view its figures as the most reliable count of casu-

alties. Israel has disputed its figures, but hasn't provided its own account of casualties.

Airstrikes on tents housing displaced people in the built-up Nuseirat refugee camp late Monday killed 30 people, including 12 children and 14 women, according to Al-Awda Hspital.

There was no immediate comment from the Israeli military.

end announced humanitarian pauses, airdrops and other measures meant to allow more aid to Palestinians in Gaza. But people there say little or nothing has changed on the ground. The U.N. has described it as a one-week scale-up of aid, and Israel has not said how long these latest measures would last.

"This aid, delivered in this way, is an insult to the Palestinian people," said Hasan Al-Zalaan, who was at the site of an airdrop as some fought over the supplies and crushed cans of chickpeas littered the ground. Israel asserts that Hamas is

the reason aid isn't reaching Palestinians in Gaza and accuses its militants of siphoning off aid to support its rule in the territory. The U.N. denies that looting of aid is systematic and that it lessens or ends entirely when enough aid is allowed to enter Gaza.

The World Health Organization said Sunday there have been 63 malnutritionrelated deaths in Gaza this month, including 24 children under the age of 5 — up from 11 deaths total the previous six months of the year.

Thailand-Cambodia border calm as military commanders hold talks

Military commanders from Thailand and Cambodia held talks on Tuesday as calm returned to their disputed border and displaced residents began trickling back, following the Southeast Asian neighbours announcing a truce to end five days of fighting.

Thai and Cambodian leaders met in Malaysia on Monday and agreed to a ceasefire deal to halt their deadliest conflict in more than a decade that has killed at least 40 people, mostly civilians, and displaced over 300,000 in both countries.

Although Thailand's military said that there had been attacks by Cambodian troops



in at least five locations early on Tuesday, violating the ceasefire that had come into effect from midnight, commanders from both sides met and held talks, a Thai army spokesperson said.

Cambodia denied the charge, insisting that its troops have strictly abided by the ceasefire since midnight and continue to uphold it, accord-

ing to a statement by Defence

Minister Tea Seiha. Negotiations so far include those between the general leading Thailand's 2nd region army, which oversees the stretch of the frontier that has seen the heaviest fighting during the conflict, and his Major Gen. Winthai Suvaree told reporters.

The commanders, who met at the border, agreed to maintain the ceasefire, stop any troop movement, and facilitate the return of the wounded and dead bodies, he said.

"Each side will establish a coordinating team of four to resolve any problems," Winthai said.

Both militaries have agreed not to deploy more troops along their disputed border, said Lim Menghour, Director-General of the Commission on Foreign Affairs and International Cooperation of the National Assembly of Cambodia, who also underlined the need for international observers to monitor the ceasefire.

China is dealing with a summer of extreme weather. Record heatwaves hit the country's eastern region earlier this month while floods swept the country's southwest.

Against the backdrop of the massive floods in northern China, President Xi Jinping has called for "all-out" rescue efforts and told authorities to



prepare for "worst-case and extreme scenarios".

"No effort should be spared to search for and rescue those missing or trapped, to transfer and resettle residents in affected areas, and to reduce casualties to the greatest extent possible," the president said on Monday.

Chinese authorities have allocated 200 million yuan (\$28m; £21m) for recovery efforts, including repairing transportation and other infrastructure.

The outskirts of Beijing, including the suburban districts of Miyun and Huairou, were hit hardest by the torrential rain.

The floods have damaged dozens of roads and disrupted power to more than 130 villages. Videos show rescuers wading in chest-deep floodwaters to reach stranded residents, as well as helicopters and drones ferrying food and other aid to the disaster zone. Ms Yang, who works in Hebei province, told BBC Chinese that she was very worried about her family, who live in Miyun district - one of the areas hit hardest by the floods.

Since Sunday she had not been able to contact her parents and grandfather, who all suffer from health problems and have limited mobility. Her family had also been taking care of her pets: eight cats and three dogs.

Their village is small and remote, with just around 10 households, she said, adding that she feared rescuers might miss it altogether. Out of desperation, she took to social media to appeal for rescue, hoping they would be found

Netanyahu, Putin discuss Iran amid rising regional tensions over nuclear talks

Israeli Prime Minister Beniamin Netanyahu and Russian President Vladimir Putin held discussions on Iran, the Prime Minister's Office confirmed on Tuesday.

Taking to X, the official handle of the Prime Minister of Israel posted, "Prime Minister Benjamin Netanyahu spoke with Russian President



Vladimir Putin. The conversation between the two leaders was on the issue of Iran."

According to The Times of Israel, the phone call also covered wider developments in West Asia East, with a focus on Iran's nuclear program and the recent sectarian violence in Syria.

During the call, Putin "emphasized the importance of supporting the unity, sovereignty and territorial

integrity" of Syria, as per a Kremlin statement cited by The Times of Israel. The discussion came after Israeli airstrikes earlier this month targeted Syrian military sites in Sweida and Damascus, following sectarian unrest in the Druze-majority city.

Clashes in Sweida province, which began on July 13 and lasted for a week, initially involved Druze fighters and Sunni Bedouin tribes.

According to witnesses, experts, and the Syrian Observatory for Human Rights, the violence escalated when Syrian government forces intervened on behalf of the Bedouin. The war monitor reported that more than 1,400 people, mostly Druze, were killed, and over 250 Druze civilians were summarily executed by government personnel.

Putin also reiterated that

"political stability in the country must be achieved through respect for all ethnic and religious groups' interests," The Times of Israel noted. Despite its war in Ukraine, Russia maintains military presence in Syria and continues to support Bashar al-Assad's regime, which fell in December, prompting Assad's relocation to Moscow.

According to The Times of

Israel, the Russian President also offered to mediate renewed talks on Iran's nuclear program, which had stalled following Israel's surprise strikes on Iranian military and nuclear facilities last month, triggering a 12-day war. Moscow had previously played a key role in removing enriched uranium from Iran during the 2015 nuclear deal under the Obama adminis-

or nearly ten years, a quiet bungalow in Ghaziabad wore the mask of diplomacy. Flags fluttered outside, luxury cars bore diplomatic plates, and a gold nameplate declared the residence an embassy. Its self-styled "ambassador," Harsh Vardhan Jain, claimed to represent exotic-sounding nations-Westarctica, Seborga, Ladonia-none of which held any legal standing in the real world.

From this rented home, Jain spun an elaborate con. He posed as a high-ranking diplomat, showing doctored photos with Indian leaders and offering dreams of overseas jobs and business deals. People believed him. After all, who questions an ambassador?

That illusion came crashing down in July 2025. The Uttar Pradesh Special Task Force raided the property and exposed the farce. Inside, they found Rs 44.7 lakh in cash, fake passports, forged government seals. phony identity cards, and documents from imaginary states. Jain's financial web stretched across shell companies and bank accounts in India and abroad. Authorities suspect the scam ran deep-potentially Rs 300

crore worth. Charged with forgery, impersonation, and money laundering, Jain's diplomatic masquerade was swiftly dismantled. Even the very micronations he had claimed to serve-Westarctica and Seborga-publicly disowned

The story of Harsh Vardhan Jain didn't just reveal a scam. It exposed the curious loophole where fantasy meets fraud, where the illusion of nationhood can be weaponized-and where an "ambassador" turned out to serve a country that never existed.

CONNECTION TO THE MICRONATION **PHENOMENON**

Jain's scheme shines a spotlight on the weird world of micronations and how their existence can be misused. Micronations are self-proclaimed miniature "countries" that claim sovereignty without any legal basis. In the Ghaziabad case, Jain hitched himself to several such entities (Westarctica, Seborga, Ladonia, etc.) to appear legitimate. These micronations have officialsounding names, titles, and paraphernalia - which gave Jain's con a patina of authenticity to unsuspecting people. For instance, he called himself Consul General

of Westarctica and even carried fancy certificates and **plates** from these groups. To victims unfamiliar with micronations, these trappings might look like genuine diplomatic credentials. This case illustrates how the niche subculture of micronations can be leveraged as a cover for crime: the absence of recognition means no real embassy oversight, yet the concept is just believable enough to fool people. Importantly, the Ghaziabad fraud also underscores

By definition, a micronation mimics a real nation: it may have a flag, a coat of arms, a constitution, officialsounding offices and titles. and sometimes even "passports" or currency. The key difference is that no established country or international body acknowledges the micronation's sovereignty. In other words, it's a make-believe country – a **po**litical experiment, hobby, **or protest** rather than a legal entity.

Micronations are distinct from microstates like Vatican City or Monaco, which are tiny but fully recognized nations. A micronation lacks legal recognition, meaning it cannot enforce laws beyond its own participants, nor enter valid diplomatic relations. Many micronations invoke (half-jokingly) the Montevideo Convention criteria for statehood - a defined territory, permanent population, government, and capacity for foreign relations. While some meet these on paper, what they lack is the **"force majeure" - the actual power and recognition to enforce sovereignty under international law. In practice, micronations exist in a legal limbo: their claims are not backed by any government's consent or international treaties. Thus, they remain symbolic or pretend countries, even if their founders take them

Micronations are often called "sovereign fantasies" because they lack legal standing. According to the Montevideo Convention (1933), a state must have a population, territory, government, and recognition by other states. Micronations may meet the first three but without international recognition, they're not real countries.

Some micronations are whimsical, others political or artistic—but all share bold claims of sovereignty that make headlines. Here are a few of the most color-

• Sealand (UK): Founded in 1967 on a World War II sea fort, Sealand has its own flag, passports, royal family, and even fended off a mercenary "coup" in 1978. Still unrecognised by any country, it remains micronation lore's biggest legend.

• Hutt River (Australia): In 1970, farmer Leonard Casley declared independence over wheat quotas. As "Prince Leonard," he ruled for 50 years, issued stamps, declared war on Australia, and ran a tourist spot—until tax debts ended the dream in 2020.

• Molossia (USA): A backyard micronation in Nevada run by "President" Kevin Baugh, complete with its own currency (backed by cookie dough), uniforms, and even Olympics. It's fun, harmless, and still going strong since 1977.

• Seborga (Italy): A real Italian village with a playful claim of historic sover-

own "Prince," flies its flag, and draws tourists—but warns that its titles (like the one misused by Harsh Jain)

have no legal value. • Ladonia (Sweden): Born from an art protest in 1996, Ladonia is a sculpture-covered strip of land ruled by a queen and backed by thousands of online "citizens." It grants noble titles and uses micronationhood as a form of creative expression.

• Liberland (Balkans): Declared in 2015 on a disputed Danube River patch, Liberland champions libertarian ideals and claims over 200,000 online citizens. Croatia blocks any real settlement, but the project EnenKio as a sovereign persists as a digital nationin-waiting.

• Flandrensis (Antarctica): Founded in 2008 to promote climate awareness, this micronation claims uninhabited Antarctic land and bans human residents. It issues passports and advocates conservation-not sovereignty.

• New Atlantis (1964): Ernest Hemingway's brother Leicester launched this nation on a bamboo raft to support ocean research. It lasted two years before a storm sank it—but it sparked U.S. concerns about seasteading decades ahead of its time.

Together, these micronations range from eccentric stunts to political statements, showing how the idea of "nationhood" can be playfully—and sometimes provocatively—reimagined.

FRAUDULENT MICRONATIONS AND FAKE SOVEREIGNTY SCAMS

Not all micronations are harmless hobbies—some have been used for fraud, deception, and fake diplomacy. Here are some of the most notorious:

• Other cases: A fake "Maltese consulate" in Italy (2018), a bogus "Sovereign State of Šumava" in the Czech Republic (2011), and the invented "United Nations of Africa" in Nigeria (2022) all show how claims of sovereignty are used to sell fake titles, evade taxes, or run shady businesses.

HOW GOVERNMENT SEES IT

In sum, the broader phenomenon of micronations has a decidedly two-faced nature. On one side, there are genuine if peculiar enthusiasts and idealists building their own little countries for fun, protest, or principle largely harmless and sometimes even thought-provoking. On the other side lurk opportunists and fraudsters who see the idea of a sover-

tion on a mystery island. It tricked Newark (USA) into a sister-city deal and nearly pulled off a land deal in Bolivia before 20 arrests in 2025 exposed it as a global con. India still seeks Nithyananda's extradition.


• Fake U.S.embassy in **Ghana:** From the mid-2000s to 2016, scammers ran a fake U.S. embassy in Accra—complete with flag, Obama portrait, and real visas issued via bribery. They sold visas and forged documents for a decade before U.S. and Ghanaian authorities shut it down.

• Moorish sovereign consulates (USA): Sovereign citizen groups in the U.S. have squatted in homes and claimed them as embassies of imaginary Moorish nations. They used fake deeds and diplomatic immunity claims to seize property and evade laws. Courts and law enforcement have uniformly loophole to exploit - a way to dodge laws, swindle the unwary, or claim unearned power. The Ghaziabad fake embassy case sits squarely at the intersection of these: an intriguing micronation story that turned into a criminal enterprise. It highlights the need for awareness that not all that waves a flag is a country, and that terms like "ambassador" or "consul" can be appropriated by con men. Authorities worldwide are increasingly alert to such scams. Meanwhile, the colorful legitimate micronations will no doubt continue declaring independence on a whim - but hopefully with a clear distinction from criminal fakes. As one Indian official quipped after the Ghaziabad bust, "Having a fake country is fine as a fantasy. Swindling others with it is where the line is drawn."

CAN INDIA BALANCE BRICS AND WEST?

by U.S President Donald Trump regarding BRICS reiterated his threat to impose a 10% tariff on imports from member countries of the group. This is an extension of Trump's larger argument that countries aligning with BRICS is an "Anti-American policy". A similar threatening tone was also maintained by NATO Secretary General Mark Rutte calling for punitive measures warning China, Brazil and India with US sanctions. Trump in this context, went a step further threatening secondary tariffs of up to 100% on countries that continue buying Russian exports.

Despite the absence of Chinese President Xi Jinping and Russian President Vladimir Putin, the 11 member BRICS grouping adopted a joint declaration reaffirming their commitment towards multiple fronts from finance and trade to emerging technologies and strategic autonomy. Trump's unease with this grouping, considering its recent attempt to create their own reserve currency raises some pertinent questions. Is BRICS inherently Anti-American?

And a supplementary and perhaps a more pressing question emerges from countries like India i.e How New Delhi can balance between strategic partnerships with the U.S led West and its deepening engagement with

this coalition of emerging economies was mindful of suggesting that the United States is an "indispensable nation". The Chinese foreign ministry had also clarified in 2009, that this cooperation should not "be directed against a third party". However, since Russia's presidency of the group in 2015, BRICS have been appearing to be significantly closer to China, especially in the wake of western sanctions following Russia's annexation of Crimea in 2014. Such actions have led to a persistent narrative in the West that BRICS is anti-American or a Pro-China grouping. However, this characterization is largely misplaced.

A 2023 study of Fletcher School of Diplomacy, counters this claim by suggesting that there are multiple policies where BRICS and the United States shared common positions. On the contrary, attempts of establishing an FTA led by China, never got the support from other member states. Even the highly publicized dedollarization attempts by BRICS, have not been supported by major players like India, who have clearly stated that "de-dollarization is not their policy nor strat-



If one takes the recent joint declaration into account, BRICS seems to unite on major security issues, one of the most important ones being the counter terrorism agenda. This has nothing to do with being closer to China or Russia for that matter, but creating an open and transparent forum towards multipolarity and balanced global order.

CAN INDIA BALANCE THE UNITED STATES **AND BRICS?**

India has consistently demonstrated its strength with respect to strategic balancing on multiple fronts, positioning itself as perhaps the only country capable enough to be a responsible bridge between the U.S led West and BRICS. While deepening its bilateral efforts with the West, in addition to its multilateral commitments as seen in Quad Foreign Ministers' Meeting- India has simultaneously engaged in BRICS viewing it primarily as an economic and developmental platform.

Unlike China and Russia, which have increasingly attempted to weaponize the forum with many failed attempts. India had also been distant with respect to the group's expansion, understanding China's attempt to use BRICS to expand its own geopolitical influence. While the Rio Summit was a missed opportunity, for both China and Russia considering the absence of their leaders in the summit, the joint declaration is clear regarding India's position in utilizing this grouping purely as a forum of cooperation and not as a counterbalancing alternative to its western partners.

India's recent bilateral trade agreement with the United Kingdom further reinforces its image as a major Asian democracy successfully balancing the West and the rest. India is about to host its first Quad Summit this year, which is another opportunity of being a sovereign player- one that does not want to replicate the Cold War era alliance system. This is also the reason that New Delhi has always resisted itself from making QUAD look like a formal military alliance.

Nonetheless, the India-U.S relationship has faced some recent triggers. From Washington's posture during past India-Pakistan hostilities to President Trump's renewed tariff threats, India finds itself in a complex diplomatic fence. The U.S. attempt to conflate trade negotiations with broader security concerns further complicates matters. For India, trade and security exist on distinct but parallel tracks. Trump's increasingly hostile rhetoric toward BRICS places New Delhi in a delicate position as it navigates finalizing a long-pending trade deal with Washington while affirming its independent role in multilateral forums like BRICS.

WAY FORWARD

The way forward requires a fundamental shift in how the United States perceives BRICS. While being a single grouping, BRICS does not represent a unified ideological stance on multiple agendas. The tendency to frame BRICS as a pro China, anti America bloc is highly misplaced and seems like a premature political judgement. As BRICS keeps on expanding, the U.S would be in a better position to view it

as a platform for constructive engagement with the Global South, rather than reinforcing isolationist and punitive measures. Such isolation further creates opportunities for China to keep expanding its diplomatic orbit.

From New Delhi's perspective, India has a unique position as the only country to have a diplomatic capital to shape the bloc's larger trajectory by addressing global challenges like climate security and counter terrorism beyond West Vs the rest thesis. However, it is important to understand that the future of BRICS in this regard is in its ability to balance its own diversity with pragmatic choices and not allow it to be a stage for great power competition.

THE OPPOSITION **ATTACK**

The Opposition has come fully prepared this Monsoon Session of Parliament and seems ready to take on the Government on various issues, from Operation Sindoor to the revision of the Bihar Voter IDs to Trump tariffs. The drama of the Vice President's sudden and mysterious resignation is a bonus. And certainly the Opposition's attack led by Gaurav Gogoi and Deepender Hooda on the first day followed by the Gandhi siblings and SP leader Akhilesh Yaday on the second day is a strong one. However, what has dented it a bit is the absence of two speakers, Shashi Tharoor and Manish Tewari, from the Congress. Manish Tewari on the other hand, wanted to speak but was not fielded by the Congress. This is a pity because Tewari is fast emerging as one of the voices to be counted on matters of geo politics and national security.

Moreover he is the Lok Sabha MP from Chandigarh and being a border state, Punjab did come under the line of Pakistani fire. There is an immense presence of families belonging to armed forces in his constituency and having him speak would have sent a positive message to the state. He did give an interview to NewsX on the weekend before the debate where he argued that while questions needed to be raised about the intelligence and security failure during Pahalgam terror attack it was equally important that the debate in parliament did not sink to he said-she said affair but kept its gravitas and focused on issues of national security. With the changing nature of warfare where conventional rules of engagement need a relook, he felt this debate was an important occasion to engage in a structured dialogue on national security.

That being said, the Opposition was careful not to raise questions about the Operation lest that be misunderstood as a criticism of our armed forces. However the debate focused on two things - the intelligence failure in Pahalgam and also the failure of India's foreign policy that saw no other nation come to India's defence. This was a smart political strategy. The Resistance Front: A sign of evolved menace

In a strategic move in accordance with zero tolerance towards terror organisations the United States of America banned the notorious 'The Resistance Front' (TRF), a proxy of Lashkar-E-Taiba. The organization uses to frequently release statements and videos glorifying its activities and neutralised terrorists by terming hem as martyrs, using sophisticated media strategies to spread its message and recruit new members.

The need of the hour is to understand the fact that proxy fronts like The Resistance Front poses a significant challenge in front of our security apparatus because it was a testimony of the fact that apart from conventional killings, the terror outfits, at the same time are carrying out sophisticated propaganda war against the establishment. The Bhartiya establishment although has understand this fact and it has been preparing for this new age warfare. The hour calls for the implementation of a elastic defence strategy to deal with this emerging threat in a efficient way.

Why did the Government soften its stance in the matter of Asia Cup?

These days, from the streets to Parliament, questions are being raised about the government's stance on India's participation in the Asia Cup. The government is being reminded of its statement at the time of the Pahalgam incident that water and blood cannot flow together. In such a situation, the question is whether blood and cricket can go together?

The second big question is the statement of Lt Gen Anil Chauhan that Operation Sindoor is not over yet... then why cricket with Paki-

There are two big reasons for the government soften-

ing its stance on this matter. The first is that cricket has been included in the 2028 Los Angeles Olympics. Obviously, this game has now become an Olympic sport. Now the BCCI will also have to respect the rules of the International Olympic Committee (IOC). The IOC completely works according to the Olympic Charter, in which it is clearly written that sports should not be disrupted due to religion, politics, apartheid, or any



other reason. Here, the examples of Kuwait and Malaysia are relevant. Kuwait was banned by the IOC for not giving visas to Israeli players in the World Cup

Similarly, Malaysia could not escape this ban for ig-

noring Israel in para sports. Even the IOC had taken a tough step against India for not giving visas to Pakistani players in the World Cup held in Delhi, under which it had instructed all international sports federations not to host any international



Indian Olympic Association (IOA) appealed to the Indian government in this regard and, after consultation with the Ministry of External Affairs and Home Affairs, the Sports Ministry had written to the IOA and assured that

in the future, no player participating in any competition held in India will be denied a visa. It was only after the letter of this effect from the IOA that India was saved from the IOC ban. Now India has staked a claim to host the 2030 Commonwealth Games and the 2036 Olympic Games. If India refuses to play with any country, then it may have to face the consequences.

It is not hidden from anyone that after the Sindoor incident, the rates of Indo-Pak cricket matches have skyrocketed. India is the host of the Asia Cup. India and Pakistan are going to face each other twice in the Asia Cup: once in the league and once in the Super-4. It is also possible that the final match may be played between the two. That means three matches each in the same tournament. If India does not play with Pakistan, then it may have to suffer losses worth billions of rupees.

It is also worth mentioning here that the Sony Network has the rights of the Asian Cricket Council till 2031. Sony has acquired these rights for Rs. 1400 crores. This includes 119 matches including emerging and women's cricket. BCCI is going to get 65 percent of the amount from these media rights and PCB is going to get 25 percent. That means BCCI is going to get Rs. 910 crores and PCB is going to get Rs. 346 crores.

It is obvious why the BCCI would not want to lose such a huge amount of money. It is true that the International

Cricket Council (ICC) and the Asian Cricket Council (ACC) are not under the International Olympic Committee (IOC), but after cricket became an Olympic sport, things have changed a lot. Even the BCCI has come under the National Anti-Doping Agency (NADA) and the ICC has an agreement with the World Anti-Doping Agency (WADA). In the new sports bill, the government will now be directly accountable. BCCI Vice-President Rajeev Shukla has already said that whatever the stand of the government is, will be the stand of the BCCI too. That means everything has changed in the changed environment, and the changed stand of the government can be understood.

High Court dismisses dowry case seven months after divorce

The Punjab-Haryana High Court has dismissed the dowry harassment FIR lodged against a divorcee and his family, calling it an abuse of the process of law. The court said that this FIR lodged seven months after the end of the marriage is malicious and has no justification.

The husband had filed a petition in the High Court in February 2020 seeking quashing of the FIR lodged. The petitioner said that the marriage took place in India on 22 December 2015. Shortly thereafter, in February 2016, a divorce petition was filed in the US, where the spouses and their parents are permanent residents and citizens.

As part of the task, victim Dharmendra initially received a bonus of Rs 800 for liking the photo. After this, a registration fee of Rs 10,999 was taken. On completing the task, he got Rs 16,050 back. This convinced Dharmen-

After this, on Pallavi's request, he completed the task again on July 19 by depositing Rs 14,488. On completion of the task, he got Rs 33,946 back. Dharmendra told that to complete the task as per Pallavi's instructions, he kept depositing money in the account mentioned by her. He got Rs 18.32 lakh deposited in different bank accounts through about 13 bank transactions.

Dharmendra said that he did not get any money back after July 19. The situation is such that in the second survey, larvae have been found in the houses of 200 people, but their challans have

not been issued yet. At the same time, despite the instructions of the DC, even the schedule for spraying the medicine has not been issued. The posts of biologist and insect collector working for dengue are vacant, these are not being

35 dengue tests are being conducted daily in the civil hospital. At the same time, about 100 patients suffering from fever and

low platelet count have increased in a week. Currently, 11 dengue cases have been reported in the district. The fear of last year's dengue is still in people's minds. In view of this fear, people are giving memorandums to the corporation commissioner for spraying of medicine, but the result is the same. On July 15, the DC had a meeting with more than

ten departments includ-

ing the Health Department, Education Department and Municipal Corporation on dengue in the district. After the meeting, it was said that a schedule for fogging would be issued. No work is being done on this at the ground level. Due to lack of spraying of medicine, dengue larvae are being found in Panchkula, Kalka, Pinjore, Barwala and Raipur Rani. Larvae have

been found in 3500 houses during checking within a month. The maximum number of larvae are being found in Kalka and

The Civil Hospital has an OPD of 4500 patients every day. Earlier, 400 patients with fever used to come to the OPD, now around 600 patients are coming. Patients are coming to MD Medicine and Special Fever OPD. The number of patients with low platelets and dengue tests has increased.

In the urban area of Panchkula, the medicine for fogging is purchased by the Municipal Corporation. After this, fogging is done. The Health Department sought information about this, but the **Municipal Corporation** did not provide any information. The schedule for fogging has not been made yet. In Kalka, Pinjore, the Health Department gives the medicine for spraying to the Kalka Municipal Council. Even after purchasing the medicine from the Council, fogging has not been done vet.

Civil Hospital CMO Dr. Mukta Kumar says that 24 liters of medicine has been given to Kalka Municipal Council by the Health Department for the place where larvae are found. The Municipal Corporation also purchases it at its own level for fogging. Despite this, the Municipal Corporation has not issued a schedule for fogging. Due to this, the risk of dengue is high. Municipal Corporation Commissioner RK Singh says that soon a schedule for fogging will be issued. Whatever preventive measures are there in this, they will be taken soon.

It is noteworthy that Northern Railway had is-

sued a tender for this underpass in March 2023. However, due to incomplete land acquisition, the tender had to be cancelled. The project had been pending for the last eight years.

Why students must learn to 'Market' their skills for AI-based recruitment

Artificial Intelligence [AI] has quietly become the first gatekeeper in the hiring process for many companies in India. What began as an experiment to reduce recruiter workload has turned into a standard filter, taking care of tasks such as parsing resumes, ranking candidates, and in some cases, even predicting cultural fit. However, as more organisations rely on AI to identify the "right" people, it is worth asking whether this technology is equipped to recognise the kind of unconventional, emerging tech talent that Indian educational and vocational institutions are producing today.

In many cases, it is not. And that gap between potential and opportunity is something businesses cannot afford to overlook.

THE MACHINE **LEARNS FROM THE**

An AI hiring system does not evaluate candidates in a vacuum. It learns from the data it has been fed, such as old resumes, hiring patterns, job descriptions, and records of how previous employees performed. The trouble is that previous data often reflects outdated ideas about what makes a good hire, and may even be biased.

In India, this histori-

cal data often reflects old hiring biases: a heavy tilt towards elite institutes, a preference for conventional career paths, and an over-reliance on formal degrees. As a result, the algorithm may reject the blockchain developer from Coimbatore who taught herself Solidity on YouTube, or the AI engineer from Guwahati whose only formal credential is an online certificate but whose GitHub profile shows real expertise.

It is following signals shaped by outdated definitions of "potential."

EMERGING TECH DOESN'T FIT OLD **TEMPLATES**

This issue becomes even sharper in emerging fields like AI, blockchain, cybersecurity, and quantum computing. The best talent in these areas often builds skills outside formal classrooms through opensource projects, coding communities, hackathons, and online platforms.

But AI recruitment tools tend to favour neat, predictable profiles. They

look for degrees, keywords, and familiar company names. They are far less effective at recognising skills that do not show

up in standard formats, including project contributions, peer reputation in online developer forums, or complex personal projects. For example, a young

coder contributing to Ethereum India's developer ecosystem, or an AI researcher participating in Kaggle competitions, may never make it past the AI filter if their resume does not check the right boxes.

BIAS GOES BEYOND PAPERWORK

Many Indian firms are also experimenting with AI-driven video inter-The machine is not deviews, speech analysis, First, businesses, espeliberately excluding them. and even emotion-detec-cially in tech, fintech, and tion tools. These systems claim to remove subjectivity. But they often bring in another layer of bias, one that is harder to spot.

> A candidate's accent, speech patterns, or nonverbal cues can unfairly influence outcomes. In a country as linguistically and culturally diverse as India, this creates obvious risks. A technically sound candidate from Bihar or the Northeast may be rejected, not for lack of ability, but because the machine could not process

COMPANIES MAY NOT

EVEN REALISE THE PROBLEM

The bigger concern is that most organisations using these tools have limited visibility into how decisions are being made. AI vendors often sell their products as bias-free, but offer little clarity on how the algorithms work, what data they rely on, or how fairness is measured.

This creates a gap between intention and reality. Companies believe they are casting a wide net by implementing AI, while in truth, they are reinforcing narrow hiring patterns, favouring pedigree over capability, and standardisation over potential.

WHAT NEEDS TO HAPPEN NOW

digital-first sectors, need to demand full transparency from AI recruitment vendors. Any system that decides who gets considered for a role cannot be a black box.

Second, organisations must rethink what they measure. Things like project work, coding competitions, peer recommendations, and the ability to solve real problems should matter just as much as degrees or the names on someone's CV. Some Indian companies are already showing that this approach works. Zoho, for example, has hired people

from small towns and invested in training them, focusing on what they can do rather than where they studied. Freshworks has built strong teams by looking beyond the usual recruitment channels and giving opportunities to people with unconventional backgrounds.

Companies also need to keep an eye on the results. If AI tools keep pushing forward the same kinds of candidates from a few well-known colleges or specific regions, it's a sign that the system has enabled biases and missed a lot of good people along the way. Talent is abundant in India, but if the same narrow profiles keep emerging, the system needs to be fixed.

THE CHOICE IS OURS

Technology can speed up recruitment. But if it ends up filtering out the very people capable of building next-generation solutions, the cost is high for companies and for the country's innovation ambitions.

AI should help spot potential, not police the boundaries of who deserves an opportunity. Getting this right will not happen by default. It requires clear thinking, better-designed tools, and above all, leadership that sees beyond the CV, and beyond the machine. The author is Co-founder, In-

9. DISREGARDING THE TECHNICAL **GUIDELINES AND EXAM FORMAT**

Learn the layout of the questions, the computerbased test guidelines, and the interface of the NEET

PG exam. Minor problems like not understanding the marking system or the navigating process can cause needless anxiety.

10. EXHAUSTION BE-**FORE EXAM DAY**

You should perform at your best on August 3rd, not before. Steer clear of lastminute studying the night before the test. Relax slowly, get enough sleep, and have faith in your planning.

The final portion of NEET PG preparation is a test of mental toughness, dedication, and strategy. Steer clear of these typical errors, polish your editing, and put your health first. Just as important as hard work is smart preparation.






