Modi last visited Russia in 2024, when both leaders lauded the "time-tested" partnership built on trust, mutual understanding, and strategic convergence.

Israel approves Gaza city occupation plan

TDG NETWORK

Israel's security cabinet has approved Prime Minister Benjamin Netanyahu's plan for the military occupation of Gaza City, marking a significant escalation in the ongoing war on the Palestinian territory.

Netanyahu's office announced early on Friday that the Israel Defence Forces will prepare to "take control" of the northern city while providing humanitarian aid to civilians outside combat zones. The plan still requires approval from the full cabinet, which may not meet until Sunday.

The move is expected to force the displacement of tens of thousands of Gaza City residents, many already enduring famine conditions as Israel restricts humanitarian aid. UK Prime Minister Keir Starmer condemned the plan as "wrong", warn-

HAMAS OFFERS 'COMPREHENSIVE DEAL' FOR **ISRAELI CAPTIVE RELEASE**

The Palestinian group said it is ready, via Egyptian and Qatari mediation, to exchange all Israeli prisoners for a ceasefire and full troop withdrawal from Gaza. In a Telegram statement, Hamas warned that occupying Gaza City "will cost [Israel] a heavy price and will not be a picnic", vowing there would be no surrender. "Netanyahu's plans and illusions will fail," it added.

Hamas accused Netanyahu of abandoning negotiations and prioritising personal and ideological goals, while opposition leader Yair Lapid warned the plan would be a "disaster" costing lives, money, and political stability.

The decision comes amid reports that over 61,000 Palestinians have been killed since October 2023. A ground offensive could further impede aid deliveries to the famine-stricken enclave, where nearly 200 people have died from starvation. "There is no Gaza left," resident Maysaa al-Heila said while reacting to news of dia reports cited by Axios central camps by 7 October, the planned takeover.

INDIA bloc unites against 'vote theft', targets EC over Bihar voter roll purge

Amid growing concerns over the unity of opposition parties, the INDIA bloc on Thursday evening showcased its strength as leaders met to discuss the Special Intensive Revision (SIR) of voter rolls in Bihar, alleged vote theft during the 2024 Lok Sabha polls, and the upcoming vice-presidential election in a small group session.

The meeting took place at the new residence of Leader of Opposition in the Lok Sabha, Rahul Gandhi, at 5, Sunehri Bagh, and was attended by at least 50 leaders from 25 parties.

Among those present were Samajwadi Party chief Akhilesh Yadav, accompanied by his wife Dimple Yadav and uncle Ram Gopal Yadav; DMK leaders Kanimozhi and Tiruchi Siva; MNM chief Kamal Haasan: RJD leader Tejashwi Yadav; NCP-SP chief Sharad Pawar along with Supriya Sule; Shiv Sena (UBT) chief

Uddhav Thackeray with his wife Rashmi and son Aaditya Thackeray; and Trinamool Congress leaders Abhishek Banerjee and Derek O'Brien, among others.

According to party leaders, Rahul Gandhi gave a presentation to the Indian National Developmental Inclusive Alliance (INDIA) bloc leaders on the alleged vote theft during the 2024 Lok Sabha elections. Sources said all opposition leaders present took the matter seriously and resolved to raise it both inside and outside Parliament.



EC to Rahul: Put it in writing or retract your claims

The Election Commission on Friday hit back at Leader of Opposition in the Lok Sabha Rahul Gandhi over his allegations of vote theft, asking him to either sign a declaration or apologise to the nation.

The fresh jibe from the poll panel came after Rahul Gandhi continued his attack on the Election Commission, stating that he had taken an



oath inside Parliament on the Constitution, and yet the Commission was asking him to take an oath on the alleged vote theft.

Election Commission sources said it appeared that, as in the past, Rahul Gandhi would submit his response on the Special Intensive Revision only after the Bihar Assembly polls.

Coming down heavily on the Congress leader, a source said, "If Rahul Gandhi believes in his analysis and stands by his allegations against the ECI, he should have no problem in signing the declaration. If he does not sign it, it would mean he does not believe in his own

Tariffs & Nobel: Ex-diplomat links Trump's twin obsessions

After the United States imposed a 50% tariff on Indian goods-citing national security and foreign policy concerns, particularly India's ongoing imports of Russian oil—former Indian diplomat Rakesh Sood said that US President Donald Trump "loves tariffs and the Nobel Peace Prize," hinting that India's lack of recognition on the latter might be a reason for the former.

Speaking to ANI on Friday, Sood said, "There are two things that President Trump loves—one is tariffs,

Trump has publicly expressed his desire for the Nobel Peace Prize, often comparing himself to past winners such as Barack Obama. He has repeatedly claimed credit for brokering peace deals, including the Abraham Accords, which normalised relations between Israel and several

turbulent session in the Lok Sabha on Friday witnessed repeated appeals for order as Opposition members staged a protest in the well of the House, prompting the chair, presided over by Krishna Prasad Tenneti, to adjourn proceedings for the day.

Despite the disruption, the House transacted brief business, with Finance Minister Nirmala Sitharaman formally withdrawing the Income Tax Bill 2025 as reported by the select committee. The withdrawal was cleared through a voice vote amid ongoing commotion.

As the House resumed at 3 p.m. after being adjourned earlier due to an major din by the Opposition, Tenneti made multiple appeals to protesting members to vacate the well, assuring them that their concerns would

His repeated requests went unheeded, forcing him to move to the next item of business.

Parliamentary Affairs Minister Kiren Rijiju expressed dismay over the continued disruptions, remarking, "Opposition members have the opportunity to raise issues of public interest — even during the discussion on private member bills. I am very sad."

His comments reflected growing frustration within the government benches over the impasse.

Several MPs voiced concern that their private member bills were being sidelined due to the repeated stalling of proceedings.

The chair acknowledged these concerns, stating, "We want to raise important legislative proposals, but you do not want to run the House," addressing the Opposition benches di-

With no signs of resolution, Tenneti adjourned the House until Monday, leavpending and underscoring the deepening gridlock in Parliament.

The withdrawal of the Income Tax Bill 2025 marks a notable development in the government's fiscal agenda, while the continued disruption raises questions about the functioning of the House and the space available for individual members to introduce and debate private legislation.

As Parliament reconvenes next week, attention will turn to whether the Opposition and government can find common ground to restore order and resume legislative business.

Rajya Sabha adjourned for the day after Opposition MPs raised slogans in the House and will now reconvene at 11 am on August 11.

TMC says don't want to disrupt Parliament, but demand debate on SIR

TMC national general secretary Abhishek Banerjee on Friday said neither the party nor any INDIA bloc member has any intentions of disrupting parliamentary proceedings, but insisted that a discussion on the Special Intensive Revision (SIR) of electoral rolls must be undertaken immediately.

Speaking to reporters at **NSC Bose International** Airport upon his return from New Delhi, the Diamond Harbour MP expressed support for Congress leader Rahul Gandhi's allegations of voter roll manipulation in a Karnataka Assembly segment.

"His (Gandhi's) claims should be looked into," Banerjee said.

Banerjee, who was recently appointed as the TMC parliamentary party leader in the Lok Sabha,

TMC national general secretary Abhishek

said, "We want the House to function, but not without holding a discussion on SIR. The Supreme Court talks about anomalies in the electoral rolls, then how was the 2024 general elections conducted using the old rolls? Were the Prime Minister, Union Home Minister, and other cabinet ministers elected using a flawed mandate?"

With Bihar elections approaching and West Bengal Assembly polls just months away, Banerjee questioned the feasibility of conducting a comprehensive SIR within a short time frame.

"How can a two-year exercise be completed in two months?" he asked.

Banerjee expressed concern that the SIR process could be manipulated to the BIP's advantage, especially in constituencies where margins were tight in previous elections.

"In past Lok Sabha results, BJP scraped through in places like Balurghat and Bishnupur by very slim margins. A flawed SIR could unfairly tilt results by eliminating genuine poor voters due to their economic vulnerability. We will not allow SIR in Bengal," he said.Continuing his attack, Banerjee also addressed the TMC's ongoing allegation about harassment of Bengali-speaking migrants in BJP-ruled states.

India prioritises energy security amid global tensions: Jaishankar

Cases of attack on Hindus, vandalisation of temples noted in West UK, Canada, US: Govt

Cases of attack on Hindus and vandalisation of temples have been noted in the UK, Canada and the US, the government informed Parliament on Friday.

In a written response to a query in Lok Sabha, Minister of State for External Affairs Kirti Vardhan Singh also said since last year, five cases of vandalisation of Hindu temples in the US and four cases in Canada have taken place.

The Ministry of External Affairs was asked by Shiv Sena (UBT) MP Anil Yeshwant Desai whether the government has taken note their temples, and "discrimination" in some countries.

"Cases of attack on Hindus and vandalisation of Hindu temples have been noted in UK, Canada and USA. How-

ever, no such case has come to notice specifically in Scotland (UK). Since last year, five cases of vandalization of Hindu temples in USA and four cases in Canada, have taken place," Singh said.

The MEA was also asked whether a motion against such "Hindu phobic attempts" is under consideration in Scottish Parliament.

"No motion against Hinduphobia is currently under consideration in Scottish Parliament," Singh said.

DRDO does not undertake any project under 'pilot project' category: LS told TDG NETWORK

NEW DELHI

The Defence Research and Development Organisation (DRDO) "does not undertake" any project under the 'pilot project' category, it undertakes mission-mode projects to deliver state-ofthe-art weapons systems and platform to the Indian armed forces, the government informed Lok Sabha on Friday.

The defence ministry was asked "the number of delayed defence pilot projects" along with the "total cost escalation due to such delays". In a written response, Minister of State for Defence, Sanjay Seth, said, "DRDO does not undertake any project under the category of Pilot Project. DRDO undertakes Mission Mode (MM) projects to deliver state-ofthe-art weapons systems and platform to the Indian Armed Forces."

In a separate query, the ministry was asked the de-



tails of the significant contributions of the DRDO and its associated labs to civilian technological advancements. scientific research and national innovation ecosystem.

"DRDO under the Ministry of Defence through the Technology Development Fund (TDF) scheme provides grants-in-aid to private industries, especially MSMEs and startups for the development of cutting-edge defence technologies/systems/ sub-systems/components up to the prototype level along with strong handholding, mentorship and support of the DRDO for the successful realisation of defence techments of SHQs/DRDO/ DDP," Seth said.

At present, 81 projects worth Rs 343.90 crore have been sanctioned to various industries under the TDF scheme. So far, 30 technologies have been successfully developed, he said.

Also, the DRDO-developed "dual use spin off" technologies are transferred to the industries. Till date, 637 Licensing Agreement for Transfer of Technology (LAToT) have been signed for the dual use (spin off) technologies for the benefit of the society at large, the minister said.

Over 2 lakh Indians renounced Indian citizenship in 2024: Govt

More than two lakh Indians renounced their citizenship in 2024, the government informed the Lok Sabha on Friday.

Minister of State (MoS) for External Affairs Kirti Vardhan Singh said this in a written response to queries on the number of individuals who have renounced their Indian citizenship and taken citizenship of other countries during the last five years.

The minister was replying to queries by Congress MP K C Venugopal.

"As per the information available with the Ministry,



the number of Indians who gave up their Indian citizenship was 85,256 in 2020, 1,63,370 in 2021, 2,25,620 in 2022, 2,16,219 in 2023 and 2,06,378 in 2024, Singh

For reference, such cases were 1,22,819 in 2011, 1,20,923 in 2012, 1,31,405 in 2013 and 1,29,328 in 2014, he added. The reasons for renouncing Indian citizenship or taking foreign citizenship are personal and known only to the individual, the government said.

"The government recognises the potential of the global workplace in an era of the knowledge economy. It has also brought about a transformational change in its engagement with the Indian diaspora," the MoS

A successful, prosperous and influential diaspora is an asset for India, which stands to gain a lot from tapping their networks and productive utilisation of the soft power that comes from having such a flourishing diaspora, he said.

Parliamentary panel raps govt over gaps in OBC representation fee

A parliamentary panel has pulled up the Department of Personnel and Training (DoPT) for failing to act decisively on key recommendations aimed at strengthening OBC representation in recruitment and promotions. easing financial burdens on poorer candidates, and improving transparency in data reporting.

In its ninth report, presented to both Houses of Parliament on Friday, the Committee on Welfare of Other Backward Classes noted that while the government had accepted over half of its earlier suggestions, three crucial

proposals have not been adequately addressed.

These proposals are mandatory inclusion of an OBC member on all selection and promotion boards, complete exemption of application and entrance exam fees for OBC candidates, and public disclosure of representation data.

On the issue of selection panels, the committee expressed dissatisfaction with the DoPT's "lackadaisical and inconclusive" response, saying mandatory OBC representation should apply even when fewer than 10 vacancies are being filled.

The panel criticised the ministry for failing to provide any "convincing measure" or "definite timeline" for imple-

menting this change and said that simply citing recruitment statistics and backlog clearance "does not satisfy the recommendation of the committee".The committee also reiterated its call for a complete waiver of application fees for OBC candidates, arguing that many come from economically weaker backgrounds and face financial stress in seeking education or government jobs.

The DoPT maintained that fees for national-level exams are already nominal, but the panel pointed out the absence of any comment on entrance fees for educational institutions and urged action in consultation with other min-

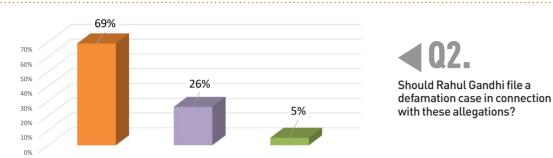

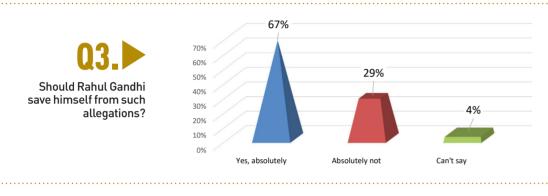

The Select Committee's 4,584-page report, presented in the Lok Sabha on 21 July, proposed tightening definitions, removing ambiguities, and aligning the legislation with existing legal frameworks. The suggested changes include permitting refunds even if tax returns are filed late, harmonising the definition of micro and small enterprises with the MSME Act, and clarifying rules for non-profits on terms such as 'income' versus 'receipts',

anonymous donations, and the deemed application concept.

Other recommendations address advance ruling fees, TDS on provident funds, low-tax certificates, and penalty powers. The panel stressed the need for drafting corrections based on stakeholder input to

ensure clarity and minimise disputes. The new legislation, first tabled by Sitharaman on 13 February, is intended to replace the complex Income-Tax Act of 1961, making the law more concise, reducing litigation, and offering significant relief to taxpayers. On the reaction of the Global South to the US tariffs, he added, "There is no doubt that in facing this kind of new situation, cooperation among some of the major developing countries and emerging economies, like Brazil and India, will be very important."

Earlier on Thursday, Prime Minister Narendra Modi received a call from Brazilian President Luiz Inácio Lula da Silva. The two leaders exchanged views on various regional and global issues of mutual interest.

"We are committed to deepening our strategic partnership, including in trade, energy, tech, defence, health, and more. A strong, people-centric partnership between Global South nations benefits everyone," PM Modi said in a post on X.

The Brazilian President, in his own post on X, shared that India and Brazil had "reaffirmed the importance of defending multilateralism, the need to address the challenges of the current situation, and to explore

possibilities for greater integration between the two countries.

Earlier, China voiced its opposition to the US tariffs on India. Chinese Foreign Ministry spokesperson Guo Jiakun, responding to media queries during a press briefing, called the move an "abuse of tariffs."

On Wednesday, the White House issued an Executive Order imposing an additional 25 percentage points in tariffs on Indian goods, raising the total levy to 50%. The administration cited national security and foreign policy concerns, pointing specifically to India's continued imports of Russian oil. On Thursday (US local time), President Trump said there would be no trade negotiations with India until the tariff dispute was resolved, following his administration's decision to double tariffs on Indian imports.

The US State Department said on Thursday that "India is a strategic partner" and that Washington is engaging with New Delhi in "full and frank dialogue," even as relations remain tense amid the tariff dispute.

When asked whether China and other BRICS nations are seeking to organise a pushback against US trade measures, the State Department said that dialogue with India "will continue."

According to party leaders, Rahul Gandhi will begin the yatra over SIR in Bihar from Sasaram district of the state.

The party leader said that the entire route of the vatra has been planned, which will go on for 15 days and pass from 21 districts.

The leader said that Rahul Gandhi along with the Mahagatbandhan leaders will also address several



public meetings during the yatra, which will be in hybrid mode just like that of the Bharat Jodo Nyay Yatra

Rashtriya Janata Dal (RJD) leader Tejashwi Yaday, VIP's Mukesh Sahni, Left parties leaders will also share the stage with the Congress leader for addressing the public over the issue of the SIR.

He stated that the leaders will highlight that how the poll panel has been removing lakhs of eligible voters mainly from the backward and minority communities ahead of the crucial assembly polls in the state.

The party leader also said that the vatra will start from Sasaram district on August 17 and move towards Aurangabad, and then reach Gaya and Wazirganj.

The vatra will then reach Nawada, Sheikhpura, Lakhisarai, Munger and Bhagalpur

The yatra will also cover the district of Katihar, Purnea. Araria, Madhubani, Darbhanga, Sitamarhi, East Champaran, West Champaran, Gopalganj, Siwan and Saran.

The yatra will then conclude at Ara district of the state.

The Congress leaders said that through this yatra the party wants to highlight the alleged malpractice in the state to remove lakhs of voters. The opposition has alleged the SIR issue as 'votebandi' and daylight dacoity of votes. The assembly polls in Bihar for the 243 seats will take place later this year in the month of October and November.

The Congress, RJD, VIP and Left parties have been targeting the Commission and accusing it of helping the ruling NDA in the state.

Stalin releases State

Tamil Nadu Chief Minister MK Stalin on Friday said that the State Education Policy (SEP) has been curated while keeping in mind the "unique character" of the state and announced that the state will only follow a two-language policy.

"Through this education policy, we don't want students just to mug up, but think and get educated. Physical education will be taught along with studies. Importantly, I want to say firmly that we will follow two two-language policy and it is our firm policy," Stalin said while addressing the gathering at Anna Centenary Library Auditorium.

The Chief Minister informed that smart classes will be introduced under the newly released SEP.

"We are going to make a change in education, our aim is to educate all. Nobody should emphasising the need to teach rational thought in education.

"We will never allow anyone to stop education. We will not allow pirooku (reactionary thinking) in our education. Our state education policy aims to create samathuva kalvi (equality) and will be a pagutharivu kalvi (one with a rational thought). This will serve as a platform to compete with international standards of education," Stalin asserted.

He said that his government aims for a 100 per cent admission of school students in higher education, which now stands at 75 per cent.

"The government, based on the Dravidian model, needs all school students to join higher education. Mother feels happy to see her children study well. 75 per cent of school students joined higher education, and we target 100 per cent to join higher education," the CM

"When you finish school and join college life, it will give a new experience. This will be a way for your career. This year, 901 students joined premier institutions," Stalin added.

This move comes after months of protests by the DMK led government against the National Education Policy (NEP) promoted by the Centre. The DMK-led Tamil Nadu government has consistently opposed the NEP, calling it "against social justice" and an attempt to impose Hindi on the state. Tamil Nadu has refused to implement the NEP.

In May, the state government filed a plea in the Supreme Court over the alleged withholding of about Rs 2,200 crore in central funds, which it linked to its refusal to adopt the NEP. The plea asks the court to declare that the NEP 2020 and the PM SHRI Schools Scheme are not binding on the state unless it formally agrees to them.

Phone-tapping scandal: Bandi Sanjay accuses KCR regime of snooping on 6,500 people

In a sensational revelation, Union Minister and BJP leader Bandi Sanjay Kumar has alleged that the previous BRS government, led by former Chief Minister K. Chandrashekar Rao (KCR), tapped the phones of over 6,500 individuals, including politicians, judges, contractors, bureaucrats, film personalities, and even family members of BRS leaders.

Speaking to the media after appearing before the Special Investigation Team (SIT) probing the phone tapping case, Bandi Sanjay expressed shock over the details shared by police during the inquiry.

"I am shocked to know that the KCR government tapped phones of more than 6,500 people. This includes myself, current CM Revanth Reddv. Harish Rao, ministers. MLAs, and even KCR's own daughter Kavitha," Sanjay

HC extends bail of Asaram Bapu in rape case till August 21 remove Allahabad HC judge

The Gujarat High Court on Thursday extended the bail of self-proclaimed godman Asaram Bapu in a rape case, till August 21, on medical grounds.

Asaram has been in jail since August 2013 for allegedly raping a schoolgirl and was arrested after the 16-year-old, whose parents were both devotees, lodged a complaint with police. Two months later, Asaram and his son Narayan Sai were booked for allegedly raping two sisters at their ashram in Surat, Gujarat.

Earlier in January, the Supreme Court granted interim bail to Asaram on medical grounds till the end of March in the 2013 rape case.

A bench of Justices MM Sundresh and Rajesh Bindal directed that Asaram shall not attempt to tamper with the evidence, and shall not meet his followers after he



is released on interim bail. Three policemen will escort Asaram, and they will not interfere in the treatment, the bench ordered.

The bench noted that Asaram has various age-related health conditions and had two heart attacks."We are inclined to grant bail to the petitioner on medical grounds by the end of March. The petitioner shall not make any attempt to tamper with the evidence, shall not meet his followers," the order stated.

Asaram is serving a life imprisonment sentence at

Jodhpur Central Jail. Approaching the apex court, Asaram has sought

bail citing deteriorating health and the need for advanced medical treatment.

Asaram also sought the suspension of the life imprisonment sentence imposed on him by a trial court in a rape case in Gu-A sessions court in

Gandhinagar, Gujarat in January 2023 convicted Asaram under various provisions of the Indian Penal Code (IPC) in a 2013 rape of a female disciple at a Surat Ashram. In August, while hearing an appeal against the trial court verdict, the Gujarat High Court declined to suspend his life imprisonment sentence.

In its August 4 order, a bench of Justices J.B. Pardiwala and R. Mahadevan had asked the Chief Justice of the Allahabad High Court to remove Justice Prashant Kumar from the criminal roster -- meaning the judge will not be handling criminal matters until his retirement. The top-court had also directed the High Court Chief Justice to change Justice Kumar's roster and bench him along side a senior judge of the High Court.

However, following the

top-court's observation against Justice Kumar, at least thirteen Allahabad High Court judges wrote to the High Court's Chief Justice Arun Bhansali to convene a full-court meeting in defiance of the adverse observations made by the topcourt against Justice Kumar. Subsequently, the Chief Justice of India (CJI) B.R. Gavai wrote to Justice Pardiwala urging the top-court judge to reconsider the said

A viral video showing an injured 48-year-old elephant named Maniki limping along a highway in Assam has triggered widespread condemnation from wildlife lovers and prompted immediate intervention by forest department officials. The elephant was being forced to walk nearly 95 km from Kakopathar in Tinsukia district to Dibrugarh for medical treatment, despite official instructions to transport the animal by truck.

The shocking footage revealed Maniki, suffering from a severely bent left foreleg, struggling to walk with a mahout (elephant handler) riding on her back. The elephant's owner, Ruchi Chetia from Jorhat, had defied forest department guidelines that specifically mandated vehicular transportation for the injured harmony amid rising tension

Delhi to form enforcement team against illegal borewells, says water minister

Water Minister Parvesh Verma on Friday announced that the Delhi Jal Board (DJB) is forming an enforcement team to curb illegal borewells across the city.

The announcement came in response to growing concerns over depleting groundwater levels in the national capital raised by BJP MLA Jitendra Mahajan.

Speaking in the Delhi Assembly, Verma stated that while illegal borewells pose a serious issue, an abrupt shutdown of all borewells would lead to widespread disruption.

"We are trying to provide water to every household. So, borewells should be allowed under regulation. A policy is being formulated to regularise them. Seizing all borewells all of a sudden will cause problems," Verma said.

The new enforcement teams will inspect hotels and commercial establishments that either rely on ground-



water or procure water from tankers without availing DJB water connections, he added.

Hitting out at Leader of Opposition Atishi, the water minister further said, "In unauthorised colonies of Delhi the previous government used to carry out work of water and sewer lines without any planning and vi-

According to Verma, a water pipeline in Sangam Vihar area was laid but could not be commissioned because of

on new line, additional Rs 4 crore were demanded to plug the leakages. Pipelines were laid so that rates were raised but the network was not connected to main supply," Verma added.

According to Verma, the water losses in the last 10 years increased from 30 per cent to 40 per cent.

"Since coming to power we have launched an app, GPS fitted water tankers and several other steps towards better facilities. If we cut the water loss from 40 per cent to 10-15 per cent, supply situation will improve," he said.

Centre fixes subsidised tomato prices Rs 47-60 per kg

The Centre on Friday announced the subsidised retail sale price of tomatoes in the range of Rs 47-60 per kg in the national capital through the National Cooperative Consumers' Federation of India (NCCF), to provide relief to buyers.

The NCCF, which has been procuring tomatoes from Azadpur mandi since August 4, is retailing them with minimal margins, the

"To date, NCCF has sold 27.307 kilograms of tomatoes at retail prices ranging from Rs 47 to Rs 60 per kg, depending on the procurement cost," the ministry stated. Retail sales are being conducted through NCCF's stationary outlets at Nehru Place, Udyog Bhawan, Patel Chowk, and Rajiv Chowk,

as well as through 6-7 mo-

bile vans operating at various locations across the city. A similar initiative was undertaken by NCCF in previous years as well.

The ministry said tomato prices have spiked temporarily in Delhi due to rains, but the all-India average remains stable. The current average retail price of tomatoes in Delhi at Rs 73 per kg is primarily due to heavy rainfall in northern and north-western regions since the last week of July.

CAQM admits no research on pollution from overage vehicles

The Commission for Air Quality Management (CAQM) has admitted that it has not conducted any research or study on pollution caused by diesel vehicles older than 10 years and petrol vehicles older than 15 years — the very category that forms the basis of the overage vehicle ban in Delhi-NCR.

The CAQM revealed this



in a reply to a Right to Information (RTI) application filed by environmentalist Amit Gupta. The commission confirmed that it has not undertaken any pollution research or study regarding the impact of such vehicles. When asked if there was any other research that formed

the basis of the ban, the commission said the restrictions on "end-of-life" (EoL) vehicles stem entirely from the National Green Tribunal's (NGT) order in Vardhman Kaushik vs Union of India & Ors and the Supreme Court's order in M C Mehta vs Union of India & Ors. Last month, the CAQM deferred until October 31 the enforcement of its earlier directive that fuel stations in Delhi should not supply petrol or diesel to overage

Police rejects charges of communal angle in Asif Qureshi murder

The Delhi Police has rejected all the claims of a communal angle in the actor Huma Qureshi's cousin, Asif Qureshi, who was murdered in Delhi following a dispute over parking in the Bhogal area and has noted that the incident was the result of issues between the neighbours.

Deputy Commissioner of Police (DCP) South East, Hemant Tiwari, said to ANI, "Last night at 11:35 pm, we received a PCR call from National Heart Institute East of Kailash. We were told that one Mohd Asif Qureshi, aged 45 years, was brought dead to the hospital after an



IO teams arrived at the hospital, while ACP and ADCP teams proceeded to the incident site. The deceased and the accused are neighbours.'

DCP Tiwari recounted the events of last night and added, "Last night around 10:30 pm, one accused Ujjwal, who had returned from his music class, parked his

house, to which the victim objected, after which they got into an altercation. Ujiwal's brother Gautam also came downstairs, and one of them attacked the victim with a sharp poker. The victim fainted. He was taken to the hospital,l where he was declared dead. The two accused have been arrested, and the murder weapon has been seized... The victim owns a butcher's house in the East district..."

Discarding the claims made by the victim's wife, the SHO said, "There is no communal angle to the incident, it is just an issue between two neighbours which led to the incident..."

Earlier, Shaina, the deceased's wife, alleged that the murder of his husband, Asif Qureshi, was preplanned, highlighting that the whole conflict was religion-based and the accused had a problem with them staying in a Hindu area.

She said, "Asif was a Muslim boy, and all the other residents here are Hindus. They (both the accused) had a problem with how he is so friendly with the Hindus. Why do they speak well of him? This was the whole issue. We do not even talk to them."

She also alleged that the accused's younger sibling had a criminal record and is involved in nefarious activities. She said, "Their younger child is involved in theft and does drugs. He has a criminal record. The elder brother is also like him and supports him."

She further added, "They attacked purposefully. If there is a fight, you can say what you have to. His sister is abusing me and Asif as well. She did not stop her brothers. This was a preplanned murder. The girl kept saying 'maro maro' (beat them).

Bharadwaj slams law and order situation in the city

Aam Aadmi Party (AAP) president Saurabh Bharadwaj on Friday criticised the law and order situation in the national capital, alleging a sharp increase in street crimes and accusing the police of focusing on targeting AAP leaders instead of public safety.

His remarks came after Bollywood actor Huma Qureshi's cousin, Asif Qureshi, was stabbed to death in Jangpura on August 7 following an argument over scooter parking. According to Delhi Police, Asif Qureshi, 42, was killed around 10:30 pm in the Bhogal area of Jangpura after an argument with two local youths.

ECI ASKS TEJASHWI TO SURRENDER 'FAKE' EPIC CARD BY AUGUST 16

The Election Commission on Friday told RJD leader Tejashwi Yadav that it was a crime to forge and use a bogus government document and set a deadline for him to submit his "apparently fake" Electoral Photo Identity Card (EPIC) by August 16.

A fresh letter was issued to the Leader of the Opposition in the Bihar assembly by the Sub-Divisional Magistrate Patna (Sadar) cum Electoral Registration Officer (ERO) for Digha assembly constituency in this regard.

The Official had last week written to the former Deputy CM, urging him to 'hand over for investigation' the voter card which he claimed to possess despite it having been 'not issued officially'.

In the latest letter, the ERO said that a perusal of the voters list for the past several years has led to

the conclusion that the EC had never issued the voter card with the EPIC number quoted by Yadav.

"It appears that the aforementioned EPIC card is fake. Forging and using a bogus government document in the eyes of the law is a crime. You are once again requested to surrender your apparently fake EPIC card by 16/08/2025 till 5 pm," the letter read.

Yadav had in a press conference on August 2 and said that a search conducted with his EPIC number was vielding the result 'no records found' in the draft electoral rolls prepared as part of Special Intensive Revision (SIR).

When the claim was rejected by the District Administration in Patna, Yaday alleged that his EPIC number had been 'changed'. Later, Yadav admitted that he did have the voter ID card with the EPIC number quoted by the officials, but sought to blame them for is-

suance of two EPIC cards in his favour.

Earlier, Janata Dal (United) MP Sanjay Kumar Jha alleged that Opposition leader Tejashwi Yadav holds multiple Election IDs, suggesting a similar practice among his supporters. He further said there is no issue on the ground in Bihar regarding Special Intensive Revision (SIR).

"On the ground, there is no issue in Bihar. When the Opposition leader (Tejashwi

Yadav) kept two Election IDs, then we don't know how many IDs his supporters must be having. This is the reason SIR is being

done," he said. Tejashwi Yadav on Tuesday said that the Election Commission of India (EC) should answer for "several voters who have been left out" in the draft electoral rolls in Bihar.

He also said that he will respond to EC's notice which was sent to him over a voter

ID he showed in a press conference. The EC had said that the voter ID was not officially issued.

"A response will be given. What is the big deal? Election Commission should tell us about several voters who have been left out." Tejashwi Yadav told reporters in Patna.

"Names of 50 people from the same household have been added. There are several such discrepancies by the Election Commission. We will send the same to the Election Commission and present our side before the Court," he said.

Amid the row over SIR, Union Minister and LJP (Ram Vilas) President Chirag Paswan accused Tejashwi Yaday, of involvement in "duplicity of votes".

"... Who is giving rise to this situation of doubt? As an LoP in Bihar, he conducts a press conference and complains that his name is not there in the electoral roll."

Will fight solo in Bihar if NDA ties talks fail: Rajbhar

Suheldev Bharatiya Samaj Party (SBSP) president and Uttar Pradesh Panchayati Raj Minister Om Prakash Rajbhar on Friday reiterated that if his party does not form an alliance with the National Democratic Alliance (NDA) in Bihar, it will contest the elections independently by forming a separate front.

He asserted that such a move would not jeopardise his ministerial position in the BJP-led Uttar Pradesh government and added that he has no greed for holding

Speaking to reporters after a party review meeting in Nawanagar, Rajbhar said that even if the SBSP contests separately in Bihar, his position as a minister in Uttar Pradesh would remain unaffected.

"There is no threat to my ministerial post in Uttar Pradesh. We are not saying that we will definitely not form an alliance in Bihar. Our first preference is to

fight the elections together with the NDA," he said.

When asked whether contesting separately in Bihar would strain relations with the NDA, Rajbhar replied that he was not attached to the perks of ministership.

"If we contest separately in Bihar, it will not affect our alliance in Uttar Pradesh. I am not tempted by the ministerial post — last time, I resigned and walked away, didn't I?" he said.

ECI explains 65 lakh gap in draft voter list in Bihar

The Enumeration Forms for 7.24 crore electors were collected out of about eight crore forms distributed and downloaded during the Enumeration Phase of the Special Intensive Revision (SIR) of the voter list in Bihar, the **Election Commission of India** (ECI) said in a press release on

Giving the reasoning behind the gap between the forms distributed and collected, the ECI stated, "BLO did not find these electors or did not get back their Enumeration Forms beother States/UTs, or were not found in existence, or did not



submit the form till 25 July, or were not willing to register as an elector for some reason or other (Para iv of Enumeration Form at Page 17 of SIR order refers)."

The ECI released the cumulative data for the forms distributed, downloaded, collected, and digitised.

The press release also shared the graphical data for the Enumeration Forms distributed, collected and digitised daily. According to ECI's

graph, the gap of 65 lakh electors is attributed to 22 lakh deceased individuals, 36 lakh who have either permanently shifted from Bihar or were not found, and the remaining 7 lakh who were enrolled in multiple places.

According to the press note, the objective of SIR is to ensure that no eligible elector is left behind and no ineligible elector gets included. Any genuine electors can still be added back in the electoral rolls during the Claims and Objections period from 1st August to 1st September 2025.

Earlier today, ECI reiterated that no claim or objection has been submitted by any political party regarding the draft electoral rolls in Bihar.

BJP leaders in Bihar 'more corrupt than Lalu', alleges Prashant Kishor

Jan Suraaj Party founder Prashant Kishor on Friday flagged "serious irregularities" in the health department of Bihar, a portfolio held by the BJP all through the NDA rule, and alleged that leaders of the saffron party in the state are "more corrupt" than RID president Lalu Prasad. Banke Bihari temple: SC proposes to suspend operation of panel under UP ordinance

The Supreme Court on Friday said it will pass an order to suspend the operation of the Committee under the Uttar Pradesh Shri Bankey Bihari Ji Temple Trust Ordinance, 2025, which has been vested with the management of the Bankey Bihari temple in Vrindavan, Mathura. A bench of Justices Surva Kant and Joymalya Bagchi also said that it will refer the matter to the Allahabad High Court to challenge the constitutional validity of the Ordinance. Till the High Court decides the matter, the Committee will be kept in abevance, it said. It further said that in the



smooth administration of the temple, the apex court will constitute another Committee, which will be headed by a former Judge of the High Court. The Committee will also have certain government officers and the representatives of the Goswamis, who are the traditional caretakers of the temple, said the bench. The bench also orally proposed to recall the directions in the May 15 judgment, which allowed the government to use the temple funds for the corridor.

HC upholds charges against professors in Beas river tragedy that killed 25 students

The Himachal Pradesh High Court on Friday refused to discharge three faculty members of the VNR Vignana Jyothi Institute of Engineering and Technology, Hyderabad, who are facing charges culpable negligence under Sections 336, 304-A read with Section 34 of the IPC, in connection with the 2014 Beas River tragedy that claimed the lives of 25 students and a tour manager near Thalout in Mandi district. Justice Virender Singh, while dismissing the revision plea (Cr. Revision No. 284 of 2024) filed by professors A. Aditya, C. Kiran, and Sumabala, upheld the trial court's February 8, 2024, order, which had denied their discharge un-

der Section 258 of the CrPC. The court noted that the petitioners, who were acting as tour guardians, had stopped the bus during a college trip and allowed students to venture down to the riverbed for photographs, despite being aware of the dangerous nature of mountain rivers and the possibility of sudden water surges from dam releases. "Faculty members were knowing that by not stopping the students from going to the river bed, they were likely to die, which is clear from the fact that while going into the river bed, the faculty member had not taken their own child along," the judgment stated. "This Court finds that the negligence was so gross that it is a criminal negligence punishable under Section

304 IPC," the Judge added, while rejecting the argument that Section 34 IPC (common intention) was not applicable. On June 8, 2014, 48 engineering students and faculty members were travelling from Shimla to Manali when they stopped near the Beas river at Shala-Nala for a photo session. With the river level appearing low, many students moved into the dry riverbed. Suddenly, water was released from the Larji Dam upstream without any prior hooter or warning system in place, sweeping away 25 students and a tour manager. The bodies were recovered over the following weeks from downstream, including Pandoh Dam. The postmortem reports confirmed drowning as the cause of death.

Why only Air India? SC junks PIL seeking audit of airline

Indian Army, IAF seek 200 light helicopters to replace ageing Chetak-Cheetah fleet

The Defence Ministry has issued a Request for Information (RFI) to replace its fleet of Chetak and Cheetah helicopters with about 200 modern light helicopters classified as Reconnaissance and Surveillance Helicopters (RSH). The new helicopters will serve both the Indian Army and the Indian Air Force, with an expected requirement of 120 units for the Army and 80 for the Air Force. The RFI aims to finalise technical requirements, decide the procurement method, and identify potential suppliers, including Indian companies partnering with

original equipment manufacturers (OEMs), who can supply Reconnaissance and Surveillance Helicopters. These helicopters will have multiple roles, operating day and night. Their duties will include reconnaissance and surveillance, carrying small troops or **Quick Reaction Teams for** special missions, supporting ground operations with internal and external loads, scouting alongside attack helicopters, casualty evacuation including search and rescue, and aiding civil authorities when required. In March, the Indian Air Force had already planned to acquire more utility helicopters alongside other defence platforms.

As a result, Russia's share in India's total oil imports surged from just 1.7 per cent in FY2O to 35.1 per cent in FY25, making Russia India's largest oil supplier. In volume terms, India imported 88 million metric tonnes (MMT) of crude from Russia in FY25, out of its total oil imports of 245 MMT.

Sensex dives below 80k on tariff jitters

Equity benchmark index Sensex tumbled nearly 1 per cent to slip below the 80,000 level on Friday as growing concerns over the impact of the additional US tariff and unabated foreign fund outflows unnerved investors.

Deep losses in market heavyweights Reliance Industries, HDFC Bank and Bharti Airtel also added pressure on equities, traders said.

The 30-share BSE Sensex tanked 765.47 points or 0.95 per cent to settle at 79,857.79. During the day, it tumbled 847.42 points or 1.05 per cent to 79,775.84.

As many as 2,507 stocks declined while 1,521 advanced and 145 remained unchanged on the BSE.

The 50-share NSE Nifty dropped 232.85 points or 0.95 per cent to 24,363.30.

Extending losing streak for the sixth consecutive week, the BSE benchmark $\,$ dropped 742.12 points or 0.92 per cent, and the Nifty declined 202.05 points or 0.82 per cent.

"The Indian equity market exhibited downward movement, closing at a threemonth low amid growing concerns over the impact of US tariffs on Indian exports.

"FIIs remained net sellers, intensifying the pressure on domestic indices. The pessimism was broadbased, with realty and metals bearing the biggest brunt," Vinod Nair, Head of Research, Geoiit Investments Limited, said.



If the recently announced US tariffs on Indian goods persist for a longer period, the impact on India's economic growth could be between 0.4 per cent and 0.8 per cent, Morgan Stanley has said in a report.

The US has increased tariffs on Indian goods to 50 per cent. According to the report, if tariffs remain at these high levels for 12 months, India's growth could see downside risks, assuming no mitigating factors.

"To assess the impact of tariffs on India's GDP, we use inferences from the inputoutput table modelled by our global team," the report said.

The report analyzed that assuming all goods exports are subject to a 50 per cent tariff rate, the direct impact on growth is likely to be 60bps (basis points), while the indirect impact could be of a similar magnitude over a 12-month period.

A similar sensitivity analysis for the 67 per cent of nonexempted goods suggests that the direct impact could be 40bps, while the indirect impact could be of the same magnitude, taking the total

Any tariff on pharma will hit India: SBI Research

Imposing tariffs on the pharmaceutical Industry will significantly impact the earnings of Indian pharma companies, as nearly 40 per cent of India's total pharma exports are directed to the US market, according to a report by SBI Research.

The report highlighted that if the US President imposes 50 per cent tariffs on Indian pharma exports as well, the earnings of phar-

SBI stated "a possible tariff of 50 per cent on pharma exports may hit earnings of pharma companies by 5 per cent-10 per cent in FY26, as many big pharma companies' revenues from US stood in the range of 40-50 per cent". In FY25, around 40 per

cent of India's pharmaceutical exports were directed to the United States. India's share in the US's total pharma imports stood at 6 per cent in 2024.

A possible tariff of 50 per cent on pharma exports will also reduce the competitiveness of Indian products in the world's largest pharmaceutical market and create pressure on profit margins as companies may be unable to pass on higher costs to consumers.

The report noted that India has been a cornerstone of the global supply chain for affordable, high-quality medicines, particularly life-saving oncology drugs, antibiotics, and treatments for chronic diseases. In the generic drug market, India supplies nearly 35 per cent of the US's pharmaceutical requirements.

If the US were to shift manufacturing and active pharmaceutical ingredient (API) production to other countries or domestic facilities, the transition would take a minimum of three to five years to achieve meaningful capacity, the report

"The reclassification of these bars under a taxable category ended their long-standing exemption, as Switzerland is a major refining hub and the move has created supply-side uncertainty and revived safe-haven interest in gold amid broader geopolitical tensions," Abans Financial Services' CEO Chintan Mehta said.

US imposes 25% tariff on India: Trade, politics, and the bigger picture

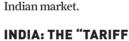
In a significant development that could reshape global trade dynamics, the United States has announced a 25% tariff on selected Indian goods. Alongside this, a new oil-related project and trade deal with Pakistan have emerged, adding layers to an already complex geopolitical and economic scenario.

WHAT IS A TARIFF AND WHY IS IT IMPORTANT?

A tariff is a kind of tax or duty imposed by one country on goods imported from another. For example, if an American car priced at 50 lakhs is imported into India and a 100% tariff is applied, the price effectively becomes 1 crore. The extra money

goes to the Indian government, making imported products more expensive and less competitive compared to local alternatives.

In reverse, if Indian goods go to the US and are hit with a 25% tariff, those products

Interestingly, the US argues that India itself imposes steep tariffs on imported goods, particularly American products. Items like luxury cars, watches, and electronic gadgets often face 30% to 100% tariffs when entering India. This significantly raises the price and makes them less attractive to Indian consumers, who might then choose similar items from other countries.

The US sees its own 25% tariff as a retaliatory or corrective measure. It's also a signal that India must be more flexible if it wants continued trade cooperation with Washington.

STRATEGIC MOTIVES **BEHIND THE MOVE**

While trade balance is one reason, there are deeper strategic motivations. India's growing proximity to Russia, especially its continued oil imports and defense ties despite Western sanctions, has been a sore point for the US. Additionally, India's participation in BRICS and discussions within the group to trade in local currencies rather than US dollars is another concern for Washington.

These developments could weaken the dollar's dominance in global trade, which the US naturally wants to prevent. Hence, the 25% tariff can also be interpreted as part of a broader geopolitical game to nudge India away from Russia and China.

1. Gems and Jewelry-India exports around \$10 billion worth of gems and jewelry to the US annually. With the new tariff, these products will become significantly more expensive in the US market, reducing demand and hurting Indian artisans and exporters.

2. Textiles and Garments-Another vital sector, textiles account for about \$2.5 billion in exports to the US. These products will also become costlier, potentially reducing India's competitiveness compared to countries like Vietnam and Bangladesh.

3. Auto Parts- Indian auto

component manufacturers export parts that are assembled or used for repairs in the US. A tariff will increase prices, affecting demand and eventually production back home.

4. Pharmaceuticals-While not directly targeted (yet), there's concern that Indian pharmaceutical exports, which form a large part of the healthcare ecosystem in the US, could face indirect pressure or future tariff extensions.

The cumulative effect of reduced exports could dent India's GDP, with estimates suggesting a potential impact of 0.2% to 0.5%, depending on how long the tariff remains in place and

WHO PAYS THE PRICE

India, the tariffs will also affect American consumers and companies:

• Apple and Tech Firms-With iPhones now being manufactured in India, the tariff would increase their cost when re-imported into the US. That would raise retail prices for American consumers, causing dissatisfaction and potentially forcing Apple to reevaluate

its supply chain strategies. • Jewelry Retailers- As Indian diamonds and precious stones become pricier, US based jewelers may struggle to maintain margins or pass on the increased cost to consumers, which

could reduce sales. Overall, Americans will end up paying more for several products as a result of these tariffs.

US-PAKISTAN OIL DEAL: ADDING FUEL TO THE FIRE

In a parallel development, the US announced its intention to support Pakistan in a major oil infrastructure project, pledging technical and economic cooperation. Additionally, Pakistan may be granted tariff exemptions

on certain exports to the US. Some experts view this as a geopolitical strategy to strengthen ties with Pakistan and counter Chinese influence in the region, especially via CPEC (China Pakistan Economic Corridor). It's also a message to India highlighting that the US has other partners in South Asia and that India must not take the US rela-

tionship for granted. Cheaper Pakistani exports to the US could compete directly with Indian products, especially in textiles and garments. If Pakistani products become cheaper due to tariff exemptions, Indian products may lose market share, further intensifying the impact of the US tariff.

WHAT LIES AHEAD FOR INDIA?

India now faces a strategic crossroads. It must decide whether to:

1. Negotiate a Bilateral

Deal - The US clearly wants a trade agreement that gives its companies more market access and reduces India's high tariffs on American products. If both sides reach a compromise, some of the current tensions may ease.

2. Explore New Markets - With a possible decline in US-bound exports, India must look for alternative markets. Opportunities exist in Europe, the Middle East, Africa, and Southeast Asia (e.g., Vietnam, Indonesia) where demand for Indian goods is growing.

3. Reform Tariff Policies - India may consider recalibrating its own tariff structure, especially if it wants to be seen as a more open and cooperative trade partner

The 25% tariff imposed by the US on Indian goods is not just about trade it's about leverage, influence, and geopolitics. While it may be seen as a penalty for trade imbalances or India's closeness to Russia, it also reflects America's shifting priorities in the South Asian region.

India must respond with a balanced mix of diplomacy, economic strategy, and policy reform. Whether it chooses negotiation, diversification, or both, the goal must be to protect its economic interests without compromising its geopolitical autonomy.

"I heard a sound like boulders grinding," recalls Sunita Devi of nearby Mukhba village. Within moments, a wall of muddy water and rock was upon Dharali. Witnesses saw the Kheer Ganga stream turn into a monster, a raging torrent tearing through the valley. In a video that later went viral, terrified villagers can be heard screaming "Everything is over!" as the floodwaters swallowed homes and hotels in seconds. What had been a picturesque pilgrim hamlet in Uttarkashi district was suddenly a scene of carnage and despair.

A VILLAGE OBLITERATED

At 1:30 pm on August 5, 2025, the Himalavan village of Dharali in Uttarkashi was all but erased from the map. Without warning, a wall of water, rocks, and sludge roared down from the mountains, engulfing the bustling pilgrim hamlet. Locals had been attendthe deluge struck. "People ran for their lives, but the flood came so fast that there was nothing anyone could do," said Lokendra Bisht, a homestay owner and MLA. Multi-story hotels and

homes were flattened or swept into the Bhagirathi River. Satellite images later revealed a massive sediment deposit nearly 20 hectares wide, burying much of the village under layers of debris. "The whole of Dharali was wiped out," Bisht said. At least five were confirmed dead, and around 100 were feared missing—many of them migrant workers or pilgrims. The floodwaters also struck an Army camp 4 km away in Harsil, where 11 soldiers vanished as bar-

racks were washed away. Dharali, at 2,700 metres, was a key stop for Gangotri pilgrims. Its riverside growth-marked by 20-25 hotels and shops—had made it a tourism hub. But experts warn it sat "on a ticking time bomb," built in an ecologically fragile zone vulnerable to both flash floods and glacial activity.

RESCUE ON WAR FOOTING

Rescue efforts began within hours. Despite heavy rain and unstable terrain, over 800 personnel-including the Army, ITBP, NDRF, SDRF, and local forces launched a high-risk operation. "Rescue teams had been deployed on a war footing," said Chief Minister Pushkar Singh Dhami, who rushed to oversee relief

Reaching Dharali was a battle. With highways buried or broken, rescuers were forced to navigate landslides and waist-deep sludge. "More teams couldn't reach due to continuous landslides," said NDRF DIG Mohsen Shahedi. Yet soldiers pushed through 50foot debris piles, aided by sniffer dogs and drones.

Improvisation saved lives. Army engineers built rope bridges and later a temporary span across the Bhagirathi, enabling access to the isolated side of the village. Airlifting was critical: Chinooks, Mi-17s, and state helicopters ferried food, equipment, and evacuees. Over two days, nearly 355 people were rescued from nearby Harsil, many airlifted on stretchers. By Day 4, 566 people had been evacuing a temple festival when ated—an extraordinary feat in such terrain.

> Communication lines were down, but the Army enabled satellite and radio contact. Families were reunited by short calls from relief camps. "All affected people are being given medical assistance," said Lt. Gen. D.G. Mishra. Still, dozens remained trapped. "The number of missing is unknown," added Colonel Harshvardhan, vowing to $continue\ through\ the\ night.$ CM Dhami camped in Uttarkashi for days, directing efforts to restore roads and power. He pledged a month's salary to the cause. Prime Minister Modi also offered full central assistance. For many soldiers digging through the wreckage, the mission was deeply personal—eleven of their own were among the miss-

TRIGGER As the immediate rescue operation continued, experts and officials began probing what exactly caused such a sudden and devastating flood. Early statements from state authorities blamed a "cloudburst" - a localized extreme downpour - high in the mountains. In fact, the India Meteorological Department reported extremely heavy rain (up to 21 cm in 24 hours) in parts of Uttarakhand around that time. Chief Minister Dhami initially attributed the disaster to a sudden cloudburst and termed the destruction "extremely sad and distressing". Cloudbursts are not uncommon in these mountains: intense downpours over a small area can send deadly flash floods crashing through valleys with little warning. The phenomenon is a notorious monsoon-season threat across Uttarakhand

Himalayan disasters. Yet on closer look, the cloudburst explanation didn't fully add up. Weather stations near Dharali showed very little rainfall on Tuesday - Harsil recorded only 6.5 mm that day, nowhere near cloudburst levels. "The area near Dharali village did not receive heavy rain in the hours preceding the calamity," several scientists pointed out. This raised an ominous alternative theory: the flood might have been triggered by a glacial lake burst or a glacier collapse high above. "It may not have been heavy rain at all," noted Dr. D.D. Chauniyal, a Himalayan geographer. He suspects one of the small glacial ponds upstream of the Kheer Ganga river suddenly breached. By all accounts, climate change is a big part of the story. Uttarakhand's Himalayan glaciers are retreating, and unstable glacial lakes are growing in size and number. "Cloudbursts have increased in recent years partly due to climate change, while damage from storms has increased because of unplanned development," experts say. In 2024, the World Meteorological Organization warned that more intense cloudbursts and flash floods in South Asia are a "distress signal" of the climate crisis. The monsoon rains themselves are becoming more erratic – long dry spells punctuated by bursts of extreme rainfall - which strains the mountains' capacity to absorb water. Whether the trigger was cloudburst or GLOF (or a combination of both), the outcome was magnified by a warming climate that fuels extreme weather. As one Uttarakhand official put it, "the Himalayas are becoming monsoon graveyards" for villages caught in the wrong place at the wrong

MOUNTAIN VULNERABILITIES

AND PAST WARNINGS The Dharali tragedy underscores how fragile the Himalayan terrain is – and how human actions have amplified the risks. "The new settlements, built without planning for natural disasters, were razed. Earlier, this area was agricultural land, then hotels came up, roads were built," he said, lamenting the short-sighted development. In recent decades, tourism and roadbuilding in Uttarakhand have boomed, often with little regard for environmental precautions. Hillsides have been cut for highways, and riversides crowded with guesthouses - many of ing. Such construction can weaken slopes and block natural drainage, making landslides and flash floods more destructive.

Tragically, Uttarakhand has seen this pattern before. Twelve years ago in June 2013, intense cloudbursts and dam breaches around Kedarnath triggered massive floods and landslides that killed over 6,000 people across the state. That disaster wiped out entire villages and 4,500 roads, and was a wake-up call about the dangers of rampant development in a climatestressed region. Two years later in 2015 (and apparently even as far back as 1864), similar cloudburstinduced floods hit the Uttarkashi area, including Dharali, though on a lesser scale. More recently, in February 2021 a chunk

Over 200 workers were killed in that incident, which was later identified as a rare high-altitude rockslide and glacial ice avalanche. Investigations showed how a warming climate contributed to the instability of glaciers, while the presence of infrastructure in hazardous zones led to high casualties.

development has marched on in the name of progress and connectivity. Uttarakhand is building allweather roads to its Char Dham pilgrimage sites, and hydroelectric dams continue to be planned on the Dharali mudslide are forcing a rethink. "The Dharali tragedy has yet again brought to spotlight the perils of unplanned construction in the ecologically sensitive Himalayas," noted one report. Environmentalists have long argued that the region's carrying capacity is limited, and that aggressive construction is a "recipe for disaster" in places like the Bhagirathi valley. Sure enough, in the Uttarakashi floods, concrete buildings and widened roads in vulnerable zones paid the price. Congress MP Ranjeet Ranjan called the calamity "man-made", revealing that she had raised concerns in Parliament about the Char Dham road widening through areas "like Dharali... an ecosensitive region near the Bhagirathi River". Bring-

terrain, she warned, was courting disaster - and her words proved prescient.



As the floodwaters in Uttarakhand recede, the disaster in Dharali has left behind pressing questions for policymakers. How can remote mountain communities be better protected in an age of escalating climate extremes? While the India Meteorological Department had issued general rainfall warnings, they were too broad to help a small village like Dharali. Experts now urge the implementation of hyper-local early warning systems using dense rainwhich lack sturdy engineer- its rivers. But events like gauge networks and satellite surveillance of glacial

lakes.

The calamity has also reignited debates over unchecked construction in fragile zones. Opposition leader Priyanka Gandhi Vadra called for a comprehensive disaster prevention strategy, including tighter enforcement of building codes, no-build zones near rivers, and reforestation to restore natural buffers. The fact that "old" Dharali withstood the flood while newly developed areas were destroyed has prompted calls to prioritise traditional wisdom in reconstruction. Experts warn that rebuilding should not replicate past mistakes-tourist infrastructure must be shifted to safer ground, and climate-resilient systems must be prioritised. Crucially, evacuation pro-

tocols and early alerts must be improved. In Dharali, residents had only minutes before disaster struck. Authorities are now considering upstream sensors that can detect landslides or glacial lake outbursts (GLOFs) and instantly alert downstream communities, potentially saving lives.

The tragedy has amplified calls for serious climate adaptation. Former CM Akhilesh Yadav urged unified action across India's hill states to "Save the Himalayas." The Centre has announced aid, and Prime Minister Modi has stressed better connectivity in border regions-but experts caution that the line between development and


KANHAIYA PAD DANGAL LIVING CULTURAL HERITAGE

Kanhaiya Pad Dangal is such a unique singing and dancing style of Meena tribals of eastern Rajasthan which includes Sawai Madhopur, Dausa, Tonk and Dholpur districts. This folk dance is performed in groups throughout the year, especially on auspicious occasions, except during the rainy season.

CHANGE IN STYLE, INCLUSION OF FOLK

Initially, this tradition was

based on classical music with 16 maatra and three taals. But in the last 120 years, the style has changed and to make the pada gayan more simple and effective, it is especially done with naubat, ghera (big dhap), dholak, harmonium and manjiro. 10 to 100 men participate in a group. If there are more people, two or more groups are formed. In this dance, which is performed entirely by men, the Madia (artist) wears simple attire of dhoti kurta or kurta pyjama and the members of one group give the words to the other group. On one side the nau-



side the Madia beats the gera loudly. The members of the other group speak the words by connecting them to the story. The Madia dances by stamping their feet loudly on the ground and moving around with a towel in their hands.

This folk dance is performed with full enthusiasm and zeal, which creates enthusiasm in the minds of the audience as well. Rajasthan education transforms through reforms, community support

In recent years, Rajasthan has witnessed a significant transformation in its education sector, with improvements not only in the quality of education but also in infrastructure. The implementation of the National Education Policy (NEP) has played a major role in driving innovation and modern learning approaches across the state. Government schools are being upgraded and developed in ways that rival private institutions, offering hi-tech classrooms, digital learning tools, and modern facilities.

The results of the Parakh National Survey 2024, recently released by the Ministry of Education, provide strong evidence of Rajasthan's remarkable progress. The survey assessed the reading, writing, and comprehension abilities of students in Classes 3, 6, and 9 in subjects such as Hindi, English, Mathematics, Sci-

ence, and Social Science. Rajasthan outperformed the national average in several categories. For instance, Class 3 students in the state scored an average of 70% in language knowledge, compared to the national average of 64%. In Mathematics, Rajasthan achieved an average score of 66%, outperforming the national score of 60%. Similar trends were observed in the higher classes as well.

A notable highlight of the survey was that students from rural areas outperformed their urban counterparts, with girls performing better overall—demonstrating growing educational inclusivity and effectiveness in remote regions.

These improvements are not a result of short-term changes but of consistent efforts and innovative strategies by the state government and the education department. Initiatives such as regular teacher training, introduction of smart classrooms, weekly assessments, ICT labs, and community participation have significantly enhanced both the learning environment and student interest in educa-

In many villages, students who had never seen a computer are now learning through ICT labs. Teachers



are using digital tools and videos in smart classrooms to enhance understanding. For younger children, **Activity-Based Learning** (ABL) kits are making learning fun and interactive, encouraging better literacy from an early age.

Another key factor driving educational progress in Rajasthan is the strong partnership between the community and the education system, especially through the contributions of Bhamashahs (philanthropists). These contributors are playing a vital role in building infrastructure and supporting quality education across the state.

One such success story is the Shrimati Geeta Devi Bagdi Government Girls **Higher Secondary School** in Napasar, Bikaner, which has seen its enrollment double in the past six years due to the joint efforts of the CM Mundhra Trust and the education department. Similarly, in Sisoda, Rajsamand, a higher secondary school was recently constructed with the support of local philanthropists at a cost of 15 crore rupees. Another new school building for the Government Girls Higher Secondary School in Deshnok, Bikaner, is being built with Rs 2 crore contributed

These examples are just a glimpse of the broader change taking place. With continued focus on innovation, community participation, and infrastructural development, Rajasthan is paving the way for a brighter and more inclusive educational future. The combined efforts of the government, educators, and citizens are transforming schools into spaces of real learning and empowerment, setting new benchmarks for public education in India.

India has emerged as an economic power, but recent reforms are superficial



Eleven years after the NDA government came to power. economic growth is strong, inflation is low, rupee is stable, external sector is strong, fiscal position is better and bad loan problem has also ended. Though there are many global constraints and uncertainties created by tariff barriers and worsening geopolitical tensions, India has emerged as an economic power, which is important. But we have failed to push forward quality employment, manufacturing and next-generation economic

reforms. The economic growth rate from 2000 to 2014 was driven more by private investment and the economic growth rate from 2014 to the present is driven more by government investment. But the common man did not get much benefit from these reforms. Certainly, GDP is growing, and we have moved ahead. Today we are a four trillion-dollar economy. In 2014, we were ranked 11th. Today we are the fourth largest economy in the world and in 2027 we will be the third largest. But GDP is just a measure. As we know, we are a big economy, we have a population of 1.4 billion.

But the truth is that in terms of per capita income, we are still a poor country, which is a measure of a country's well-being. With a per capita income of about

\$2,800 (US\$2,878), we are 136th (out of 196 countries) in this respect. We are the poorest in the BRICS. We are the poorest in the G-20. And we have more poor people than any other country in the world. It is worth noting that jobs are being created in the economy, but they are low-productivity, part-time jobs in the unorganised sector. There are not enough productive jobs being created in the organised sector, and this is one of the biggest failures of the current government. We should focus on manufacturing to create jobs. There should be more focus on small and medium industries in particular, they are employment intensive sectors. But the situation in the manufacturing sector has not improved much in the last 11 years.

According to the data, the contribution of the manufacturing sector to GDP has remained stagnant. In 2014, the contribution of the manufacturing sector to GDP was 16.7 percent which is currently around 17 percent. Another disappointing thing about the current government regarding next generation economic reforms is that it seems that they have retreated from reforms. Land reform, labor reform, taxation reform. foreign investment reform, governance reform, all these are important. But no one is talking about this now. It is worth mentioning that after coming to power in 2014, the government had taken steps to resolve the issue related to land acquisition but it was put on hold due to protests. The amendment in the agricultural law was also withdrawn due to

protests. In the case of labor

reform, the government has

made a code of conduct, but



it has not been implemented vet. The Reserve Bank of India's latest Economic Review paints a mixed picture. On the surface, India's growth rate appears strong, among the highest globally, inflation is down and the agricultural sector is performing well. But behind this optimism lurks a more fragile reality. Urban demand remains weak, unemployment is rising and credit growth is slowing. The RBI has passed on recent rate cuts to banks to stimulate the economy, but structural issues such as rising inequality, stagnant wages and uneven recovery remain. Global risks, including rising geopolitical tensions and growing financial protectionism, are further clouding the outlook.

Amid this uncertainty, the RBI has moved to weaken priority sector lending, a key pillar of inclusive banking. Small finance banks, which were previously required to direct 75% of their lending to essential sectors such as agriculture, education and small businesses, will now be required to allocate only 60%. This quiet rebalancing dilutes the social mandate of priority sector lending, shifting its purpose from empowerment to efficiency and from equity to profit. What was once a mechanism to enhance financial justice is now being hollowed out, percentage point by percentage.

The RBI's final project finance framework, which will come into effect in October 2025, is worrying. Despite persistent pressure from civil society to integrate climate safeguards, social audits and public consultation into lending rules, the RBI has chosen to ignore these calls. Instead, it has relaxed key provisions, such as reducing the construction-stage provision from 5% to 1%. This has opened the door to high-risk infrastructure lending with little public oversight. In the age of climate crisis, this signals a worrying regulatory drift, enabling opaque, unsustainable mega-projects at the expense of public interest and environmental integrity. Together, these policy decisions reflect a sweeping ideological shift from responsible growth to unregulated financial arrangement.

The airstrike near the Lebanese border crossing of Masnaa on Thursday afternoon killed Mohammed Wishah, a member of the central committee of the Popular Front for the Liberation of Palestine, or PFLP, the group said in a statement. The Israeli army confirmed the airstrike, saying that Wishah was responsible for coordinating with other militant groups in the region and strengthening ties between the PFLP and Iran's so-called axis of resistance. The military said that Wishah was advancing attacks against Israel and took his job as the PFLP's top security official in Syria after his predecessor was killed in an airstrike in Beirut in September.

In a post on social media, senior PFLP official Marwan Abdel-Al mourned the death of Wishah and his bodyguard, Mufid Hussein. "We have lost two of the most loyal comrades who gave their precious souls to freedom, Abdel-Al wrote. Lebanon's state-run National News Agency, or NNA, said that the airstrike on east Lebanon killed six people and wounded 10 others, without identifying the victims.

Heavy rains since Thursday have triggered severe flooding and at least one landslide in mountainous areas near the city of Lanzhou, according to state broadcaster CCTV.

The downpour knocked out power and telecommunications services in the Xinglong Mountain area, stranding more than 4,000 people across four villages.

Three people are still missing after a landslide in the village of Maliantan in Yuzhong County, which happened late on Thursday.

Maximum rainfall in the area had reached 195 millimetres by early Friday, according to Lanzhou local authorities.

In the southern metropolis of Guangzhou, seven people died and seven others were injured after a floodtriggered landslide buried homes in the city's northern Baiyun district on Wednesday.

In Zhengzhou, the capital of the central Henan province, local authorities shut down schools, offices and factories and closed traffic in parts of the city, which saw catastrophic floods that killed at least 292 people in

While in late July, local officials said that 31 people had died at the Taishitun Town Elderly Care Centre in Beijing's Miyun district, which was one of the areas hardest hit areas by storms that dumped nearly a year's worth of rain in the area over a few days.

Officials offered a rare public apology when they announced the deaths.

"For a long time, this senior centre was in the town's centre and was safe, and as such was not included in the preparedness plans. This means that our prepared plans had holes," Mivun Party secretary Yu Weiguo said, calling the incident a "bitter lesson."

Xi and Putin discuss Ukraine war ahead of Russia-US summit

Chinese President Xi Jinping on Friday spoke with his Russian counterpart Vladimir Putin over the phone ahead of the latter's planned summit with Donald Trump to discuss the future course of the Ukraine war.

During the phone call, held at the request of Putin, the Russian leader briefed Moscow's views on the current situation of the Ukrainian crisis and recent contacts and communications between Russia and the US, a statement released by the Foreign Ministry here said.

Putin was under pressure from Trump to end the Ukraine war started by Russia in February 2024 to assert its territorial

According to reports from the US, Trump wants Putin to agree to a ceasefire to be followed by a peace deal.



The summit plan came after Trump's special envoy Steven Witkoff travelled to Moscow, where he held a prolonged meeting with Putin.

Putin and Xi struck a personal friendship since 2013, adding a strategic dimension to Russia-China relations, forging close political and military ties, posing a major challenge to the global dominance of the US and European Union.

They met numerous times and established close trade ties under which China has emerged as the largest buyer of Rus-

China also maintained strategic ambiguity over Russia's invasion of Ukraine and denied allegations that it supplied arms to Moscow.

In his phone call, Putin, who is expected to visit China later this month to take part in the SCO summit in Tianjin, emphasised that the Russia-China comprehensive strategic partnership of coordination will remain unchanged under any circumstances, the statement said.

The Shanghai Cooperation Organisation (SCO) summit is due to be held on Aug 31 and Sept 1.

After the summit, Putin is expected to stay back to witness the massive military parade of the Chinese military to be held in Beijing on Sept 3 to mark the 80th anniversary of the victory in the Chinese People's War of Resistance against Japanese Aggression and the World Anti-Fascist War.

Both continued to accuse



each other of cross-border attacks, even after their leaders agreed to a ceasefire ending five days of fighting that began on July 24 and left 32 dead in Thailand and at least 13 in Cambodia. The two countries had been quarrelling for decades over their 817km (508-mile) undemarcated land border with the recent dispute breaking out after a landmine explosion on the border injured five Thai soldiers last month, with the resulting fighting killing at least 43 people.

It has been reported that more than 17 Nepali citizens have also been affected by the floods. Immediate diplomatic discussions were held through the embassy for their rescue. I pay my respects to all those who lost their lives in the



floods and landslides and wish the bereaved families the strength to bear the loss," Oli wrote on Face-

Amongst those missing 17 are from Jajrkot District and four others from Bardiya district local officials has confirmed. As per the officials whereabouts of them is unknown since Tuesday afternoon after a devastating flood hit the Dharali area of Uttarkashi district in Uttarakhand, India.

"The missing locals have not been contacted since the flood, and their families are deeply worried. We also have requested the Ministry of Foreign Affairs to assist in search and rescue operations," Hari Chandra Basnet, Chairperson at Kushe Rural Municipality in Jajarkot District told ANI over phone.

In addition, the Bardiva District Administration Office has confirmed that four people from Bardiya are also missing due to the same flood. Reports indicate that dozens of Nepali have been injured in the disaster.

Chief District Officer of Jajarkot, Megh Bahadur Mangrati, said the local government is coordinating efforts to identify and locate the missing persons.

South African court backs Zambia in dispute over former President burial

A South African court on Friday ruled in favor of the government of Zambia and ordered that it can repatriate the remains of its former president and bury him in his home country, against his family's wishes.

The Zambian government and the family of the late Edgar Lungu, Zambian president from 2015 to 2021, have been embroiled in legal battle over his remains and burial. Lungu died in June, aged

68, at a South African hospital following an undisclosed illness.

His family wanted him to be buried in South Africa and for the current President Hakainde Hichilema neither to attend his funeral nor be involved in its arrangements.

The family said it was Lungu's final wish that Hichilema should not get anywhere near his burial, but the Zambian government went to court to stop him being buried in South Africa.

The court ruled on Friday that Zambia had the authority to hold a state funeral for its former leader. "The court noted that the

state funeral is a matter of viously emphasized that a public interest and proto-

col for a person of national significance."Such that even if a president has expressed a desire not to be given a state funeral, such a wish must be overridden by public interest," said Judge President Aubrey Ledwaba. Lungu and Hichilema

were sworn political rivals. Their conflict led to Hichilema's imprisonment in 2017, when Lungu was president.

Last year, Lungu accused Hichilema's government of using police to harass him and restrict his movements. His family also said the government had initially prevented him from traveling to South Africa for treatment, a charge the

government denied. Zambia's Attorney General Mulilo Kabesha welcomed the judgment,

telling reporters that he hoped the ruling would bring the matter to a close even though the family still had a right to appeal.

"This is not winning. You don't win over a burial. It's just what makes good sense, that the former president of the Republic of Zambia should be buried in his own country, the country where he was president," said Kabesha.

This unexpected escalation, announced through an executive order, led to a strong backlash from India. The Indian government has labelled the decision as "unfair, unjustified, and unreasonable." with Indian PM promising to safeguard national interests. While Trump cites India's oil purchases from Russia as justification, he may be using these elevated tariffs to negotiate trade concessions, especially in agriculture, dairy, and pharmaceuticals sectors that India has always protected. Though the US and India established a robust strategic partnership during Trump's initial term, which

persisted through Biden's administration. However, that foundation is now under threat. Trump's imposition such a hefty tariff on Indian imports has also reverberated throughout the Indo-Pacific, not only due to its economic ramifications but also because it jeopardizes the integrity of the QUAD, the four-nation alliance comprising the US, India, Japan, and Australia, which was formed to counter China's expanding influence in the region. After Trump's announcement, Indian PM delivered a defiant address at a public conference in New Delhi. The statement was clearly directed at Trump's tariff demands and highlighted the politically sensitive nature of concessions regarding agriculture and dairy in India. PM Modi has unequivocally stated that India will not compromise on

its national interests or the welfare of farmers, fishermen, and the dairy sector. He also expressed his willingness to 'pay a personal price for the same,' possibly alluding to his relationship with Trump and the political challenges he may face domestically

Trump's assertions are inconsistent with his behaviour. He cited India's oil purchases from Russia as the primary justification for imposing these substantial tariffs; however, China, the largest purchaser of Russian oil, has not encountered any new penalties. Additionally, Turkey, another significant importer, has been exempted. Al-

though Trump has mentioned that tariffs might be modified based on the progression of discussions, his declarations are perceived as a coercive tactic aimed at pressuring India to liberalize its markets for US dairy and agricultural products, which India has declined From multilateralism's

point of view, Trump's decision is going to impact US' partnership with India in several groups like QUAD. This announcement has arrived several months prior to India's scheduled hosting of the QUAD Leaders' Summit. However, the future of the summit now appears to be in doubt. In-

dia participation in QUAD was perceived as a flexible arrangement that honored its independent foreign policy as it is not a military alliance. However, the future of QUAD seems to be in shadow as there may be serious repercussions on the group's trade, technology, defence collaboration, and infrastructure coordination. India ranks as the fourth-largest economy and serves as a centre for supply chain strategies linked to the QUAD. Trump's actions could undermine the QUAD's vision of a free, open, and resilient Indo-Pacific.

Trump is perplexed as US companies, including Apple have invested billions in India with the aim of decreasing dependence on China. Previously, Trump had recommended that Apple manufacture its products in the US rather than in India. Also, his threat to impose duties of up to 250% on Indian pharmaceuticals would adversely affect a sector where India leads in global supply chains and significantly contributes to American healthcare. In the meantime, India is working to enhance its relationships with China and Russia, which directly contradicts the strategic goals of the QUAD. Trump may have overlooked India's crucial role in its Indo-Pacific strategy and its status as a key member of the QUAD. He has also undermined India's strong presence in BRICS. Additionally, he seems to have forgotten that India has a long-standing trusted partnership with Russia, which could positively influence India-China relations.Indian PM is set to visit China for the first time since 2018 to attend the SCO meeting. Also, Russian

President Putin is expected to visit India later this year. Additionally, discussions are ongoing to rejuvenate the Russia-India-China trilateral framework. This period presents an opportunity for China to stabilize its relations with India, although it remains a nation that cannot be fully trusted. Russia may also seek to take advantage of the discord by suggesting new collaborative projects across various sectors. Currently, US expenditures account for approximately 2.5% of India's GDP. India will undoubtedly explore alternatives and diversify its trade and trading partners. Furthermore, it has the chance to place greater emphasis on the 'Make in India' initiative and leverage its substantial domestic market.

While India would be looking for the alternatives, the public in the US will have

to bear the consequences of the elevated tariffs that Trump has imposed on India, resulting in increased costs for medicines, medical equipment, gems, jewelry, and numerous other items that India sends to the US. Ultimately, Trump will have to face the repercussions of his choices aimed at maintaining his global authority. I have previously expressed similar sentiments regarding Trudeau, as I observed him leveraging his power for personal gain. Leaders who prioritize their nation's interests are celebrated for their leadership, whereas those who exploit their power to intimidate and protect their own interests are often forgotten or remembered as antagonists. Indian animation film industry seems to have come of age now with the release of the latest offering, as Mahavatar Narsimha proves that animation is not just for children but also for grown-ups alike. While there have been few Indian animation films that have made their

presence in Indian cinema in the past decades, this one is with a difference, making a huge impact, proving that India can produce world-class animation from concept to delivery on the silver screen.

We have all grown up hearing the story of the demon king Hiranya Kashyap, his sister Holika, and son Prahlad, we have celebrated the festival of Holi every year, and all of this has been captured in cinematic stories time and again. However, Mahavatar Narsimha is a case apart where you see this story unfolding in an animated form at its best. The Indian ani-


egos and eccentricities of devil kingdoms, and at the same time the cultural ethos and practices of Indian scriptures, which we treat as history.

in soul awareness, we can see our value and be able to observe what is going on with detachment.


It is when we feel that we

VIRAT GEARS UP FOR AUSTRALIA ODIS?

In what seems to be an exciting development for fans, legendary Indian batter Virat Kohli posted a picture with Naeem Amin, a coach, who is also associated with the Indian Premier League (IPL) franchise Gujarat Titans (GT) as an assistant coach, after what seemed be like a practice session

Virat took to his Instagram to post a picture with Naeem and captioned it, "Thanks for helping out with the hit brother. Always lovely to see you."

This could very well be a sign that Virat, retired from Tests and T2OIs, is gearing up for a season of ODI cricket. From October 19 onwards, India will tour Australia for a three-ODI and five-T20I series. Fans could get to see the 'King' back in action from October 19 onwards at Perth's Optus Stadium, with two more matches scheduled for Adelaide (October 23) and Sydney (October 25).

Back in May, Virat sent a huge wave of shock and grief



among the cricketing fraternity, announcing his retirement from Tests ahead of India's tour of England, which kickstarted the team's ICC World Test Championship (WTC) 2025-27 campaign.

In 123 Tests, Virat scored 9,230 runs at an average of 46.85, with 30 centuries and 31 fifties and a best score of 254*. He ended as India's fourth-highest run-getter in Tests. He also ended his career as India's most successful Test captain, with 40 wins in 68 Tests, including memorable wins in England, Australia and South Africa and a series win in Australia.

Virat's final image in whites was helplessly edging a Scott Boland delivery to the slips in the final fifth Test at Sydney. He ended the horrific Australia tour with just 190 runs in nine innings under his belt, at an average of 23.75, despite

a century at Perth during the first Test. His struggles with deliveries outside the off-stump channel and poor performances against Boland marked his final outing in white clothing. Virat and more than him, his fans would be hoping that he scores in heaps during the ODI tour to Australia. He has an outstanding record in the country in ODIs. having made 1.327 runs in 29

average of 51.03, with five centuries and six fifties. His best score is 133*. Notably, in his previous ODI outing, he won the ICC Champions Trophy for India back in March, scoring 218 runs in five innings at an average of 54.50, with a century and fifty each. In seven ODIs this year, he has been in a solid form, with 275 runs in seven innings at an average of 45.83, a century and

Australia's T20I opening pair locked in: Captain Marsh as T20I WC nears

Australia T20I captain Mitchell Marsh confirmed that they have locked in the opening pair in the lead up to next year's T20I World Cup, set to be held in India and Sri Lanka.

The burly all-rounder orchestrated a Player of the Match performance in the final to steer the Baggy Greens to their first T20 World Cup title.

But now, the 33-year-old



declared that he will retain his spot at the top after opening the five consecutive games against the West Indies last month. Marsh and Head have never opened in the shortest format together.

"It'll be myself and Heady up the top for the foreseeable future. Obviously, we've played a lot together, (we've) got a great relationship, so (we'll) start there," Marsh told reporters in Darwin on Friday as quoted from cricket.com.au.

Including Marsh and Head, Australia have tried and tested five openers in the format since David Warner had his last dance after last year's Caribbean World Cup. Marsh remained tight-lipped about the appearance of the rest of the batting unit but confirmed there were discussions about Tim Davind's place.

Last month, David unleashed havoc with his blistering strokeplay in the third T20I against the Caribbean side.

Asian Games medalist Tanvi Khanna fell short in the final of the women's singles event of the Squash India Tour Jaipur 2025, ending as a runner-up in a well-fought contest at Sawai Mansingh Stadium on Friday.

At Jaipur, she was in the battle with top-seed, Egypt's Nour Khafagy and Tanvi lost 3-1 (11-3, 5-11, 11-5, 12-10) despite a spirited effort, as per Olympics.com.

Tanvi lost the opening game, but was leading in the second, which she ended up winning. She lost the third game as well, with the battle moving to the fourth game. Ultimately, she fell short of world number 94, who held the title.

The 29-year-old started her campaign with a first-round bye and then proceeded to outclass compatriot Rathika Suthanthira Seelan 3-O (11-5, 11-3, 11-1) in a brilliant round of 16 outing.

In the quarterfinals, Tanvi pulled off an upset against the second-seeded Menna Walid of Egypt, pulling a 3-2 (11-8, 8-11, 11-7, 10-12, 11-6) upset win in 54 minutes. This turned out to the longest match of the tournament.

In the semis, Tanvi eliminated the Malaysian challenge, the fourth-seeded Goh Zhi Xuan, 3-O (11-8, 11-8, 11-4) to secure a ticket in the final.

Anahat Singh did not participate in the tournament. The Squash Tour Jaipur, sponsored by HCL, is one of the two Professional Squash Association (PSA) Challenger 9K events that India will host this year, with the second one lined up for Mumbai next month.

The tour has been extended to six Indian cities in total, with all-important PSA ranking points on offer. Apart from Jaipur, Mumbai, Chennai, Bengaluru, Ahmedabad and Delhi are also supposed to host events as a part of the tour.

This tour plays a vital role for India as Squash makes its Olympics debut during the Los Angeles 2028 edition.

BWF World Junior 2025: India to face Hong Kong, China, Nepal, Ghana in Group H

The Badminton World Federation (BWF) on Friday announced the draw for the BWF World Junior Championships 2025 - Suhandinata Cup (Mixed Team Event), to be held at the National Centre of Excellence, Amingaon, Guwahati, from 6 to 11 October 2025, according to a release from BWF.

Second-seeded India will compete in Group H alongside Hong Kong China,

Nepal, and Ghana. This prestigious global junior team event returns to India for the first time since 2008 and will feature 37 teams from across the world. The tournament format will see the winner from each group advance to the quarter-

Top seeds Thailand are drawn in Group A with Denmark, Slovenia, and Cook Islands. Defending champions Indonesia are placed in Group C with Turkiye, Romania, and the



Netherlands, while 14-time champions China will face Japan, Singapore, Brazil, and Bhutan in Group E.

This year, a new relay format will be tested in the competition. In the new format, there will be bestof-three sets, where a team reaching 45 points in a relay format wins a set. A set will have each of men's singles, women's singles, men's doubles, women's doubles and mixed doubles matches, with the first match ending after one team reaching nine

points, and the next match

will start. Earlier, the relay format consisted of a single set with a race to 110 points in 10 matches. For the Indian team, medal winners from the Badminton Asia Junior Championships 2025 will gain direct entry, while the remaining spots will be decided through a selection trial from 9th to 13th August 2025 at the same venue.

Players eligible for the trials include those meeting the BAI ranking cut-offs,

Indian shuttlers ranked in the BWF World Junior Top 20, and juniors ranked in the BWF Senior Top 50 as of 29 July 2025. All players selected in the Indian team for the WONDR Badminton Asia Junior Championships 2025 are also invited for the trials, except the medalists who already have direct entry. Following the Suhandinata Cup, the individual events will also be staged in Guwahati from 13 to 19 October 2025 at the National Centre of Excellence.
