ECI assures SC of safeguards against wrongful deletions

The Election Commission of India (ECI) has filed an additional affidavit about the progress of the Special Intensive Revision (SIR) of electoral rolls in Bihar.

The EC informed the top court that the first stage of the exercise has been completed, with the Draft Electoral Roll published on August 1, 2025.

The Commission assured that safeguards were in place to prevent wrongful deletions from the draft rolls. No voter's name could be removed without prior notice and an opportunity for a hearing.

The affidavit reads: 'As part of the SIR, Booth Level Officers (BLOs) conducted house-to-house visits to collect enumeration forms from electors. Lists of voters who had not submitted forms were shared with recognised political parties, enabling them to assist in filling the gaps.'

The affidavit stated that over 7.24 crore of Bihar's 7.89 crore registered electors have submitted their forms with the help of officials, volunteers, and party

The ECI noted that extensive awareness campaigns along with repeated visits by Booth Level Officers, were carried out to ensure that no eligible voter was left out.

334 unrecognised political parties out of ECI list

NEW DELHI: The Election Commission of India on Saturday said that it has delisted 334 registered unrecognised political parties, which according to it have failed to fulfil the essential condition of contesting even a single election for six years since 2019.

The Commission also said that it was unable to locate its offices of these parties could also not be physically located anywhere.

It said: "The Commission, after considering all the facts and recommendations of the CEOs, has delisted 334 RUPPS."

"Now, out of the total of 2854 RUPPs, 2520 are remaining. This delisting exercise is part of a comprehensive and continuous strategy of the Election Commission to clean up the electoral system," it said.

The poll panel said that guidelines for registration of political parties mention that "if the party does not contest elections continuously for 6 years, the party shall be taken off the list of registered par-



Rahul Gandhi, who has been engaged in a bitter war of words with the poll panelin last few weeks on Sunday took to X and wrote, "Vote Chori is an attack on the foundational idea of 'one man, one vote'."Asserting that 'a clean voter roll is imperative for free and fair elections', he said, "Our demand from the EC is clear - be transparent and release digital voter rolls so that people and parties can audit them."He also released the

his claims. Rahul Gandhi had explained that there were 1,00,250 votes stolen in the Mahadevapura assembly in Karnataka.

He mentioned that there were five types of voter theft, which included 11,965 duplicate voters, 40,009 fake and invalid addresses, 10,452 bulk

concept in India refers to the principle that every eligible citizen has an equal right to cast one vote in an election, and that each vote carries the same weight in determining the outcome. This idea is fundamental to a democratic system and is enshrined in the Indian Constitution.

In India, the concept is rooted in universal adult suffrage, introduced when the Constitution came into effect on January 26, 1950. Article 326 of the Constitution provides that elections to the Lok Sabha and State Legislative Assemblies shall be based on adult suffrage, meaning that every citizen of India who is 18 years or older (the age was reduced from 21 to 18 in 1989) and not otherwise disqualified by law (such as due to mental incapacity, criminal conviction, or corruption) is entitled to vote.

The phrase "one man, one vote" means that no matter the person's gender, caste, religion, wealth, education, or social status, their vote counts equally. This ensures political equality and prevents discrimination in the electoral process. It also implies that constituencies are designed to have roughly equal populations so that each elected representative speaks for a similar number of people. In practice, however, challenges remain. Population disparities between constituencies sometimes lead to malapportionment, where one vote in a smaller constituency effectively has more influence than one in a larger constituency.

'We questioned EC, but BJP gets irritated': Shiv Sena's (UBT) Anand Dubey

Shiv Sena (UBT) leader Anand Dubey on Sunday said NCP-SCP chief Sharad Pawar's remarks about being offered help to secure Assembly seats point to possible irregularities in the Election Commission.

Dubey said that while his party questioned the EC, the BJP became irritated. He stressed that they were questioning the institution that protects democracy, not the BJP, and demanded the resignation of the chief election commissioner.

"...Yes, two people came forward, claiming they could help him secure 160 seats. It means that there are certain irregularities in the Election Commission...



We questioned EC, but the BJP gets irritated by this. We are not questioning the BJP; we are only questioning the institution that upholds democracy... We demand that the chief election commissioner should resign," Dubey told ANI.

'BJD first party to raise electoral discrepancies in Odisha'

TOP COMMANDER AMONG TWO HIZBUL MILITANTS TRAPPED IN JK'S KISHTWAR

An intense gunfight broke out in Jammu and Kashmir's Kishtwar district on Sunday after security forces launched a search operation in the hilly Dool area based on specific intelligence inputs about the presence of terrorists.

Officials said that as the search parties closed in, the hiding militants — believed to be two in number - opened fire, triggering the encounter.

According to sources, the trapped militants are suspected to be Riyaz and Mudasir of the proscribed Hizbul Mujahideen outfit. Both are believed to be holed up inside a cave deep in the forest, which they have been using as a hideout.

The cave is said to be wellstocked and strategically located to avoid aerial detection.

Police have already an-

Noor Mohammad, then a civilian porter from Mohura village near the LoC Uri, was called to assist the 7 Maratha Light Infantry in building Tilpatra Post, close to the LoC. Braving heavy

rain and enemy shelling, he hauled supplies and ammunition to forward troops through treacherous terrain.

One foggy morning, Noor and three other porters went to fetch water and were ambushed by Pakistani infiltrators. Taken blindfolded across the Ceasefire Line to Muzaffarabad, he was accused of being an Indian spy. For months, he endured brutal torture, starvation, and isolation by Pakistani army and ISI. But Noor remained

After over a year in captivity, Noor was released

in October 1966 under a UN brokered prisoner exchange. He returned quietly to his village, uncelebrated but not broken, and continued porter duties for another decade to support his family.

Speaking at the ceremony, a senior officer said, "He endured what soldiers dread. Noor's service was no less than that of any uniformed man."

Today, Tilpatra Post still stands in Uri as a testament to that forgotten chapter. And with this long-overdue recognition, Noor Mohammad's silent heroism finally finds its place in the history books

Madurai district has ranked first in TN for corruption, says former minister

The Deputy Opposition leader and former AIAD-MK Minister R B Udhayakumar hit out at Tamil Nadu Chief Minister MK Stalin, claiming that Madurai has "ranked first in corruption" in the state.

Speaking to the mediapersons, the former AIADMK minister said, "Madurai district has ranked first in Tamil Nadu for corruption. Because of corruption in the municipal corporation, a situation has arisen where zone leaders have to demand the Chief Minister's resignation...In 2026, the DMK will not be able to

The Deputy Opposition leader also criticised the DMK government for "failing" to address water management issues in Madurai district.

"Even though there is adequate water in the Vaigai Dam, water has not been released for the 58th canal project. During the AIAD-

MK regime, water was released into the 58th canal three times, whereas in the DMK regime, it has been released twice," he said.

He further alleged that residents were now compelled to fight for their fundamental right to water under the DMK rule.

"During the AIADMK rule, schemes were introduced to prevent sewage from mixing into the Vaigai River. After the change in government, the DMK administration has scrapped those schemes. Due to the abandonment of the project, sewage is now mixing into the Vaigai River at 425

locations," he added. Meanwhile, the 'Thenkal Kanmoi', a major irrigation tank situated in the Thirupparankundram area of Tamil Nadu's Madurai district, had completely dried up due to extreme heat, raising serious concerns among farmers and local residents who depend on it for irrigation and drinking water.

The drying up of the tank had significantly impacted both farming operations and daily life in the area. With no water available, agricultural activities have come to a halt, and residents are facing severe water shortages.

'80% of Metro project grant is ours, BJP's only 20%': K'taka Dy CM

Karnataka Deputy Chief Minister DK Shivakumar claimed Sunday that the State government contributed 80 per cent and the Union government 20 per cent to the Metro Yellow Line inaugurated by Prime Minister Narendra Modi during his visit to Karnataka on Sunday.

"While the State government has spent 80 per cent on the Metro Yellow Line, the central BJP government has spent only 20 per cent. In some places, it has spent only 11 per cent," said Shivakumar.

Although Bengaluru is the second-highest taxpaying city in the country, the grant received is very little," he said.

"Ahmedabad has been given a 20 per cent tax share. We have been given only 10 per cent. For that, consider us like other big cities in the country. Also, think of Bengaluru as the capital of the

country. We are not doing politics, but are making a request," he said.

The senior Congress leader lashed out at the BJP leaders for neglecting Ben-

"BJP says we did everything ourselves. They have no achievements. Not a single MP has brought even 10 rupees to Bengaluru city or the state. They have not even provided any cooperation. Maha cyber fraud row: CBI busts illegal call centre racket, arrests 5

The Central Bureau of Investigation (CBI) has busted an illegal call centre racket, being run by certain private persons in rented premises, in Igatpuri (Rainforest Resort), Nashik, Maharashtra, an official statement said.

According to the statement, CBI registered this Cyber Fraud Case on 08.08.2025 against 06 accused private persons, all residents of Mumbai, as well as unknown private persons and Bank officials. It was alleged in the FIR that the accused persons entered into criminal conspiracy with each other and other unknown persons, and have committed financial fraud by impersonation and making phishing calls/deceptive calls, from an illegal call centre, posing as Amazon Support Services Call Centre.

The accused persons have

been allegedly cheating citizens of the US, Canada and other countries and fraudulently obtaining proceeds of crime via Gift Cards/cryptocurrency, the statement added.

The call centre is located at Igatpuri, Nashik, Maharashtra.

The accused persons reportedly recruited around 60 operators, comprising dialers, verifiers, and closers, to run the said illegal call centre. Investigation by the CBI has resulted in the recovery of 44 laptops, 71 mobile phones, and other incriminating digital evidence, as well as unaccounted cash of Rs. 1.20 crores, 500 gms of Gold, and

Transactions of approximately 5000 USDT cryptocurrency (Rs. 5 lakhs) and 2000 Canadian dollars worth gift vouchers (Rs. 1.26 lakhs) were also detected.





New investors at NSE rise 15% in June 2025

New investor registrations at the National Stock Exchange (NSE) increased by 15 per cent monthon-month in June 2025, reaching 12.7 lakh compared to 11.0 lakh in May. Despite this growth, the figures were significantly lower than June 2024, when 21.6 lakh new investors had joined the market, according to the latest NSE Market Pulse report for June 2025.

Region-wise, the rise in new registrations was led by West India, which saw a 20.5 per cent month-onmonth jump. South India followed with a 15.2 per cent increase, while North India and East India recorded growths of 13.4 per cent and 10.4 per cent, respectively. State-wise, Uttar Pradesh topped the list in June 2025,



all new registrations with 1.8 lakh additions, marking a 13.1 per cent increase from the previous month.

Govt taking relook at licensing rules for petrol pumps

The Ministry of Petroleum and Natural Gas has formed an expert committee to review the 2019 norms for issuing licenses for petrol pumps, keeping in mind market efficiency and India's push for alternative fuels, decarbonisation, and e-mobility.

Ravi and the Petroleum and Natural Gas Ministry's Director, Marketing, Arun Kumar. The government had liberallow more companies to set up retail fuel outlets.

Firms with a net worth of Rs 250 crore could sell petrol and diesel, provided they agreed to set up infrastructure for at least one alternative fuel such as CNG, LNG, biofuels, or EV charging within three years.

Forex reserves decline to \$689 bn

India's foreign exchange reserves (forex) reported a sharp decline, slipping USD 9.32 billion to USD 688.871 billion in the week ending August 1, official data released by the Reserve Bank of India showed.

At the latest monetary policy meeting, RBI Governor Sanjav Malhotra said the foreign exchange kitty was sufficient to meet 11 months of the country's imports. CII calls for land reforms to boost manufacturing

these emerging opportunities and march towards the goal of Vikit Bharat by 2047, India must adopt a comprehensive and forward-looking competitiveness agenda, including factor market reforms such as land reforms, said CII in its press release. Elaborating on the importance of land reforms, CII said, "India has made remarkable progress in several areas of reform, but land remains a domain where foundational changes are overdue in terms of access, cost, and regulatory ease for

Does GM technology increase the inherent yield potential of the seeds?

GM crops do not enhance the inherent yield potential of the seeds/plants.

GM crops can only indirectly contribute to better yields by reducing crop losses due to pests, diseases or weeds - similar to application of

pesticides and weedicides. It is the traditional breeding includinghybrid technology that increases the inherent yield potential of crops due to "heterosis" (hybrid

vigour).

Traditional breeding techniques continue to be a major growth driver of crop yields and agricultural production.

The claim that GM technology consistently increases the crop yield is not supported by evidence.

The yield of Bt cotton in India peaked in 2016-17 and shows a steady decline since then. The present average yield of Bt cottonin India is 15% less than what it was a

In 2010-11, India ranked 25th globally in cotton yield. Now the rank has slipped to 36th which is far below than countries such as Benin, Bangladesh, Cameroon, Ethiopia, Iran, Pakistan, Sudan, etc.

India has around 40% of cotton global acreage but only around 20% of the global production.

Introduction of Bt cotton has not helped India achieving "fibre security" for our textile mills. India's import dependency has increased in recent years.

Neither the GM lobbyists nor our scientific institutions have explained why the Bt cotton in India has miserably failed.

Indian farmers have paid millions by way of trait fees to US companies for this failed technology. This cannot go unquestioned. There requires to be accountability.

Thankfully, the present government scrapped all the trait fees five years ago. This prevented continuance of a major loot.

Out of 1,600 mn ha of agricultural land under cultivation globally only around 200 mn ha is under GM crops.

Just three countries (USA, Brazil and Argentina) account for about 80% of the global area under GM crops. This means a vast majority of our agriculture production comes from non-GM crops.

China that ranks number one in global agricultural production, has less than 2% of area under GM crop. (Source: Global GM Crop Area Review 2025)

Therefore, it is illusory and illogical to believe that GM technology is essential to drive agricultural production in India.

Battling for God's Kingdom: Cambodian-Thailand questions of border

The international border that runs between the Kingdom of Cambodia and Kingdom of Thailand has traditionally switched back and forth between the ethnic Khmer people speaking the Khmer Austro-Asiatic language in Cambodia and the ethnic & sub-ethnic groups of Siamese, Phuan, Mon and Lao Wiang people speaking the Tai language in Thailand. The same border has historically been the apple of discord between the French, British and Japanese prior to and after the World Wars. Cambodia and Thailand by divine prognostication

have been separated topographically by the Dangrek Mountain Ranges, which forms a natural barrier between both the kingdoms.

Under Jayavarman VII, adherent follower of Mahavana school of Buddhism, Emperor of the Varman Dynasty and the Khmer Empire of Cambodia, the Dangrek mountain ranges became a majestic part of the Khmer Empire. Little did the Hindu and Buddhist Varman dynasty and the preceding Zhenla dynasty of Funan knew retrospectively that the Preah Vihear Temple, nestled in the Poy Tadi cliffs at the Dangrek mountains, dedicated to the Hindu God Shiva in his manifestation as the mountain Gods Sikharesvara and Bhadresvara, would become the source of a sustained and contiguous frontier dispute all through the Victorian Era, Industrial Age to the Modern Era.

The 1950's in Indo-China

consolidation of Chinese, Soviet, American and French interests in the Indo-china geo-political region - with communist, anarchist and fascist socio-political ideologies solidifying the Cold War dynamics and geo-political fluctuations. The 1950's also brought to the fore the Cambodian-Thai border dispute, centred on the ownership and nationalization of the Preah Vihear Temple Complex. The United Nations got involved, and through the International Court of Justice from the Peace Palace, The Hague, Netherlands, decided in favour of Cambodia the ownership of the temple complex in 1962. The ownership issue though stood unresolved and dormant, simmering quietly as Cambodia fell into a protracted Civil War between the Sino-centrist Communist Party of Kampuchea (Khmer Rouge) and the American-centrist Kingdom of Cambodia.

The simmering dispute erupted in nationalist atmosphere again through 2008-2013, when the Cambodian ruling class defined by the Cambodian People's Party (CPP) led by Prime Minister Hun Sen nominated the Preah Vihear Tem-



Heritage Site status. The Thai Defence Ministry protested Cambodia's attempt to register the temple as a UNESCO World Heritage Site without agreement from Thailand. The issue rapidly evoked nationalist sentiments and both countries militarily escalated and deployed troops to the border and frontier areas, leading to several deadly clashes resulting in both civilian and soldier deaths. The Registry of the International Court of Justice (ICJ) again resolved the dispute in a partial manner, clarifying its 1962 ruling in favour of Cambodia in 2013 and instructing Thailand to withdraw its forces from the surrounding areas.

All was good for a decade. Cambodia's political landscape from 2013 to 2024 has been marked by a shift from competitive authoritarianism towards a more closed, one-party system under the Cambodian People's Party (CPP). Campursuing international recognition and a positive reputation, particularly in the areas of post-conflict peacebuilding and economic development in sectors of textiles, construction, garments and tourism. Conversely, Thailand's political landscape from 2013 to 2024 has been marked by instability, coups and shifts in power dynamics. The period saw the ousting of the

Yingluck Shinawatra gov-

ernment through both ju-

Prayut Chan-o-cha led military-backed governance before a contested election in 2023. The 2023 election saw the Move Forward Party win the most seats, but they were blocked from forming a government due to the Senate's opposition, ultimately leading to The Pheu Thai Party, in coalition with several militaryaligned parties forming the government, with Srettha Thavisin as Prime Minister. Srettha Thavisin's premiership was terminated by the Constitutional Court over an ethics violation, as his successor Paetongtarn Shinawatra's premiership was challenged following a leaked audio recording, leading to her suspension. Suriya Juangroongruangkit served as acting Prime Minister until Phumtham Wechayachai was sworn in as the new acting Prime Minister.

Clashes erupted again between Cambodia and Thailand in 2025, masquerading as tactical self-defence by both the neighbours, and it continues amid internationalized appeals to deescalate, bilateral talks and regional mediation. The role of the International Court of Justice (ICJ) is once again in notoriety with Si-

no-Centrists, Ameri-Centrists and Euro-Centrists collectively poised to see the United Nations Security Council (UNSC) getting involved to quell the flare-up and chaos.

The dispute mostly stems

from the Franco-Siamese treaties of 1904 and 1907 and the objective colonialera mis-mapping by the French surveyors mapping the jurisdiction, placing the Preah Vihear Temple Complex under the French protectorate of Cambodia. The redundant flare-up is also the consequence of the diplomatic paralysis and sensitive animosity between former friends turned foes, the political patriarchs Hun Sen and Thaksin Shinawatra. The world-at-large and the United Nations must bear in mind whether the ongoing conflict has its momentum in religious fanaticism and regional politics, or is the result of the inter-personal dealings of two political heavyweights and their inconclusive deal spilling in the realm of ultra-nationalism.

DRUG RESISTANCE IN E. COLI, KLEBSIELLA **DOUBLES: ICMR**

"Who speaks for sepsis deaths?" — a question that humanises AMR and demands urgent action.

ntimicrobial Resistance (AMR) - the "silent pandemic" - is among the world's biggest health threats. It happens when bacteria, viruses, fungi, or parasites evolve to resist the drugs that once killed them, making common infections hard or even impossible to treat.

At a national AMR media workshop in New Delhi this month, experts warned the crisis can't be ignored. Dr. S. S. Lal, Director of ReAct Asia Pacific, opened the event stressing AMR's urgency and the media's role in "breaking the silence" and holding all stakeholders accountable.

The message was clear: AMR is already here, already deadly, and needs action now. On 7 August 2025, at the "AMR: The Silent Pandemic - Let Media Break the Silence" workshop, health experts and journalists discussed the rising danger of drug-resistant infections and the need for urgent, coordinated action across sectors.

GROWING THREAT MEASURED IN LIVES AND DATA

In 2021, 4.71 million deaths worldwide were linked to bacterial AMR, with 1.14 million directly caused by it – already more than HIV/ AIDS or malaria. Forecasts are worse: between 2025 and 2050, drug-resistant infections could kill 39 mil**lion people** – three lives every minute. By 2050, total AMR-related deaths 8.2 million annually - almost one death every few seconds. The economic toll could reach \$3.4 trillion in GDP losses yearly by 2030, pushing 24 million more people into extreme poverty. UK AMR Envoy Dame Sally Davies warned: "The world is facing an an-

tibiotic emergency." India, seen as an AMR hotspot, shows how fast resistance is rising. ICMR data (2017-2022) found carbapenem resistance in E. coli doubled from ~20%

to 40%, and in Klebsiella **pneumoniae** from 40% to 60%. This means far more infections are untreatable with top-tier drugs.

AIIMS Bhopal (2025) found only **39% of E. coli** (a major cause of UTIs) responded to ciprofloxacin - it fails 6 out of 10 cases. Klebsiella showed nearly 48% **resistance** to meropenem, leaving it effective just 52% of the time. These drops warn of a future where routine infections can be deadly.

There is some hope: the Bhopal study found older drugs like **nitrofurantoin** and **fosfomycin** still work direct AMR deaths could well for UTIs, and hospital AMR Survivors. Her meshit **1.9 million a vear**, and use of **amikacin** improved outcomes for Pseudomonas. This shows treatments can be saved if used wisely. Still, the overall trend is grim drug-resistant **superbugs** are evolving faster than we can make new medicines.

Ms. Bhakti Chavan, a 23-year-old biotechnology student, spoke of how a neck swelling turned out to be extensively drug-resistant tuberculosis (XDR-TB) - TB that did not respond even to second-line antibiotics. "The medicines I studied in textbooks failed me," she said. For two years, Bhakti endured toxic, painful treatments, including daily injections, unsure if she would survive. She recovered after 24 months and now works as an AMR advocate with the WHO's Task Force of sage: "If it happened to me.

it can happen to anyone." Ms. Pooja Mishra, an HIV/AIDS advocate, told of her fight with a multi-drugresistant bacterial infection while living with HIV. "Treatment becomes so difficult when drug resistance enters the picture," she said. She went through seven antibiotic combinations before one worked. "The bacteria are evolving faster than the medicines we're making," she warned. Her story shows how AMR hits vulnerable people hardest those with weak immunity,

other illnesses, or poor access to care.

Doctors stress that every AMR case brings ripple effects: longer illness, higher costs, lost income, and the risk of passing the resistant infection to others. **Dr.** Narendra Saini, former Secretary-General of the Indian Medical Association, summed it up: "AMR is a pandemic in waiting."

ONE HEALTH: HUMAN, ANIMAL, AND **ENVIRONMENTAL DIMENSIONS**

The main reason is heavy pressure on microbes from human health, farming, and the environment. Experts now push for a One Health approach, linking the health of people, animals, and na-

At the workshop, the One Health panel stressed these links. **Dr. Chanchal** Bhattacharya, a veterinary specialist, warned about unchecked antibiotic use in livestock and poultry. In India and elsewhere, even antibiotics critical for humans are routinely given to animals—not only to treat sickness but also in low doses for growth or to prevent disease in cramped conditions. "Without proper vet guidance, farmers may overuse or misapply antibiotics, essentially medicating entire herds or flocks," he said. Over 70% of antibiot-

Fighting AMR means phasing out growth-promotion antibiotics, improving farm biosecurity, treating wastewater, and monitoring hotspots like hospital sewage. Doctors, vets, and environmental experts must work together.

India's National Action Plan and the new **National One Health Mission** aim to link human, animal, and environmental labs for faster detection. The G20 leaders' declaration (2023) also pledged to fight AMR with One Health. The challenge now is putting these plans

DRIVERS OF AMR Antimicrobial resistance (AMR) is often called a manmade disaster. While some resistance is natural, today's crisis is largely of our own making. In agriculture, antibiotics are widely used in healthy animals for growth promotion or disease prevention. This fuels resistant strains like E. coli and Salmonella that cause foodborne illness in humans.

Poor water, sanitation, weak. and hygiene (WASH) systems also drive AMR. Contaminated water and inadequate hospital infection control spread disease, increasing antibiotic use and resistance. Hospitalacquired bugs like MRSA and carbapenem-resistant Klebsiella thrive in such settings.

The slow pace of new drug development is another critical factor. "No new antibiotic molecules have been developed in the past two decades. Existing ones are failing," warned Dr. Narinder Saini. With pharmaceutical companies exiting antibiotic R&D, doctors are left with older, more ports such innovations. toxic drugs—or sometimes

no options at all. Other contributors include substandard medicines, limited diagnostic capacity, and poor awareness. Curbing antimicrobial resistance (AMR) needs action from everyone — policymakers, doctors, farmers, and citizens. Experts outline a multi-step plan.

Prudent Antibiotic Use: Misuse in medicine and farming is the biggest driver. Doctors should prescribe antibiotics only when needed, choose the narrowest drug, and ensure full courses are completed. Hospitals must run stewardship programmes. In farming, routine use for growth or mass prevention in healthy animals should be banned. The EU and US already do this; India's 2017 AMR plan calls for the same. As the workshop said: "Antibiotics are lifesaving — but only when used correctly."

Public Awareness: Many think every illness needs antibiotics, but colds, flu, most sore throats, and viral fevers don't. Using them wrongly fuels resistance. Patients should ask, "Is this really necessary? Are there tests to confirm it?" Campaigns ing with leftovers or sharing

Global Cooperation: Bacteria cross borders. Countries must share data, build capacity, and coordinate responses. AMR is now on G2O agendas, with funds like GARIF and the Fleming Fund pooling resources.

Media & Communities: The Delhi workshop stressed media's role in telling patient stories, exposing misuse, and pressuring leaders. The new India chapter of the Global AMR Media Alliance aims to keep coverage alive. As Dr. Gangakhedkar asked, "Who speaks for sepsis deaths?" The answer: all of us.

KEY MESSAGES FOR EVERYONE

Toward the end of the media workshop, experts distilled some key take-home messages for the public and stakeholders. These are worth highlighting here, as

they apply to all of us: Antibiotics are lifesaving — but only when used correctly. Misuse and overuse of antibiotics lead to drug-resistant infections that are harder and costlier to treat. We must treasure these medicines and not take them for granted.

• Not all infections need antibiotics. Colds, flu, and many common fevers are caused by **viruses**, against which antibiotics don't work. Taking antibiotics for a viral illness won't make you better - it will only contribute to resistance and

Always take antibiotics exactly as prescribed. If you are prescribed an antibiotic, use it responsibly:

might cause side effects.

don't skip doses, don't stop the course as soon as you feel better, and never save or reuse antibiotics without medical advice. Stopping early can leave some bacteria alive to develop resistance.

• Get tested when needed. Whenever possible, doctors should base antibiotic choices on diagnostic tests (like cultures) to ensure the right drug is used. If your provider suggests a test or

says an antibiotic isn't necessary immediately, trust their guidance. Proper diagnostics help identify if antibiotics are necessary and which one will be effective. • Good hygiene prevents infections. Simple mea-

sures such as regular handwashing, drinking clean water, using toilets/sanitation, safe food preparation, and keeping vaccinations up to date can drastically reduce infections. Fewer infections mean less need for antibiotics and less chance for resistance to develop. Infection prevention truly is the first line of defense. AMR affects everyone —


not just hospital patients. Drug-resistant bugs can be in the community, in our food, and in the environment. You could pick up a resistant infection from a contaminated river, or through person-to-person spread, even if you've never been in a hospital. So everyone has a stake in this fight, not just doctors or patients.

• You have the right to

- ask questions. In a healthcare setting, patients (or their families) should feel empowered to ask the doctor, "Is this antibiotic really necessary? Are there alternatives?" Good doctors will appreciate these questions because it means you care about proper use. Taking an antibiotic when it's not needed won't help you always understand why a medication is prescribed.
- Antibiotics are a shared resource. Unlike other medicines, the more we use antibiotics, the less effective they become for everyone. Think of the efficacy of antibiotics as a limited common resource - we must all help preserve it. As the experts said, using antibiotics responsibly today ensures they remain effective for future generations. We owe it to our children and grandchildren to hand down a world where a simple cut doesn't lead to an untreatable infection.

These key points serve as a practical guide to action at the individual and community level. If each of us adheres to these principles, the collective impact will be significant in slowing down AMR.

KAJARI TEEJ OF BUNDI: A MONSOON CELEBRATION OF CULTURE & TRADITION

ajasthan, the land of royalty, colors, and Ltraditions, offers much to explore beyond its majestic forts and palaces. The state is a treasure trove of vibrant fairs and festivals that reflect its rich cultural heritage. Among these, the Kajari Teej festival celebrated in Bundi, often called the queen of Hadoti, holds a unique place. Distinct from the other Teej festivals observed across Rajasthan, Kajari Teej transforms Bundi into a week-long celebration of joy, devotion, and artistic splendor.

Teej is celebrated throughout the rainy season across Rajasthan, with each region having its own customs and traditions. The festival is dedicated to the eternal love and union of Lord Shiva and Goddess Parvati. Women wear traditional attire. adorn themselves with new bangles, apply mehendi, and pray for the well-being and longevity of their husbands. With the arrival of the monsoon, swings are hung from trees and decorated with flowers. The air is filled with traditional songs as young girls dress in colorful clothing to mark the season. Teej is essentially a women's festival, celebrating feminine devotion and the advent of

Kajari Teej, however, carries both religious and cultural significance that sets it apart. While most Teej festivals are celebrated in the month of Shravana, Kajli Teej is observed in Bhadrapad, fifteen days later, on the third day of the month. It is one of Bundi's most anticipated events and draws visitors from across the country and abroad, especially foreign tourists curious to witness the charm of local traditions. The celebration begins with

the traditional shobha yatra - a grand procession of Goddess Teej in a beautifully adorned palanquin, which moves through Bundi's main streets and bazaars. This ritual is marked with great enthusiasm, as people from all walks of life join in the festivities. The palanquin is surrounded by a grand display of camels, elephants, horses, folk artists, and musicians. Traditional dancers and performers keep the crowd entertained throughout the journey. A special feature of the Kajari Teej procession is that the idol of Teej Mata is covered with a canopy, unlike the Gangaur idol, which is kept open to the sky.

The celebration continues at the Kumbha Stadium, which becomes a hub of activity with a large fair showcasing Bundi's rural crafts, traditional weapons like kataar, bangles, paintings, and various handicraft items. Artisans and vendors from different parts of Rajasthan gather here, and their stalls draw huge crowds. The fair also offers an array of local delicacies and snacks that further enhance the festive experience.

Cultural events are held every evening as part of the





Kajari Teej celebration. The first two days are dedicated to a folk musical instrument called algoza, with a competition that fills the air with melodious tunes. These festivities continue well beyond Janmashtami (the birthday of Lord Krishna), making Kajari Teej one of the longest and most engaging festivals in the region. Events such as qawwali nights, kavi sammelans, devotional songs, and musical performances by both local and renowned artists are organized by the district administration and municipality.

The grand procession eventually culminates at Azad Park, in the heart of Bundi, after a long, vibrant march across the city. The entire town participates, and the festival is a blend of religious devotion and social celebration.

Bundi's famous miniature paintings also capture the festival in vivid detail, with scenes of women carrying the idol of Teej Mata depicted in rich colors and traditional styles. Poems and songs dedicated to Teej further highlight the emotional and spiritual importance of the event.

Historically, the original Teej idol was made of gold and precious stones and was once in Jaipur. It was seized by Thakur Balwant Singh of Gothra and brought to Bundi by Hada King Rao Raja Ram

Singh, who established the tradition of celebrating Teej in Bhadrapad. Today, a decorated replica of the idol is used in the procession, while




the original is preserved at the Garh Palace in Bundi. Kajari Teej is more than just a festival — it is a celebration of Bundi's spirit, culture, and devotion, making it a mustexperience event for anyone looking to witness Rajasthan's true essence.

Giriraj Ji: The sacred hill of devotions and faith

Giriraj Ji, also known as Govardhan Hill, holds a deeply revered place in Hinduism, especially among the devotees of Lord Krishna. Located in the Braj region of Uttar Pradesh, this sacred hill is a living symbol of divine love, faith, and protection. Its spiritual importance originates from the legendary episode in the Bhagavata Purana, where Lord Krishna lifted the entire hill on his little finger to shield the people of Braj from torrential rains sent by the rain god Indra. This act of divine strength and compassion earned Krishna the title "Giridhari," the lifter of Govardhan, and transformed the hill itself into an object of worship as Giriraj Maharaj.

Devotees regard the stones of Giriraj Ji as sacred, often carrying small pieces home as blessings. One of the most significant devotional practices associated with Giriraj Ji is the Parikrama, a sacred 21-kilometer circumambulation per-




formed barefoot around the hill, passing through holy spots like Radha Kund, Kusum Sarovar, Govind Kund, Mansi Ganga, and Poonchari Ka Lotha. Some devotees perform the Parikrama by lying flat on the ground and measuring the entire path with their bodies, demonstrating complete surrender. The Parikrama is most prominent dur-

ing Govardhan Puja, celebrated a day after Diwali, when lakhs of pilgrims visit to offer food, light lamps, and participate in religious festivities. The celebration marks Krishna's divine intervention and the triumph of faith over pride. The hill has been glorified by saints like Vallabhacharya, Chaitanya Mahaprabhu, and others, who viewed Giri-

raj not as a symbol but as Krishna himself. Though the physical form of the hill has eroded over time, its spiritual power remains undiminished.


The town of Govardhan, surrounding the hill, is vibrant with temples, ashrams, gaushalas, and sadhus, all contributing to a community centered on devotion and service. Daily



life here reflects a deep commitment to Krishna bhakti, with pilgrims feeding cows, helping fellow travelers, and engaging in kirtans and prayers. Artistic and cultural expressions of devotion are also seen in the famous Bundi-style paintings and devotional songs written in praise of Teej Mata and Giriraj Ji. Historical accounts mention that

the original gold and gemstone-studded idol of Teej Mata was once taken from Jaipur and later brought to Bundi by Hada King Rao Raja Ram Singh. Today, a decorated replica is used during Kajli Teej, while the original is preserved in the royal palace.

In the context of Giriraj Ji, this history reinforces the strong cultural and spiritu-



al ties between regions and traditions, centered around shared devotion. For many, walking the path of Giriraj Parikrama is more than a pilgrimage—it is a personal journey of transformation, surrender, and divine connection.

The spiritual atmosphere, the sound of chants, the simplicity of faith, and the stories of Krishna's pastimes infuse the experience with timeless depth. Whether one is a devout follower or a curious traveler, the presence of Giriraj Ji is both humbling and uplifting. It stands not only as a sacred site but as a living embodiment of devotion, reminding all who come in contact with it of the eternal bond between the divine and the devotee.



NETANYAHU DEFENDS PLANNED MILITARY OFFENSIVE ON GAZA

sraeli Prime Minister Benjamin Netanyahu on Sunday sought to defend a new military offensive in one of Gaza 's most populated areas amid growing condemnation at home and abroad, declaring that Israel "has no choice but to finish the job and complete the defeat of Hamas.'

He spoke to foreign media minutes before an emergency meeting of the United Nations Security Council on Gaza. Notably, Netanyahu said he has directed Israel's military in recent days to "bring in more foreign journalists" — which would be a striking development, as they haven't been allowed into Gaza beyond military embeds during 22 months of war.

"Our goal is not to occupy Gaza, our goal is to free Gaza," Netanyahu asserted.



He also pushed back against what he called a "global campaign of lies" - and said Chancellor Friedrich Merz of Germany, one of Israel's strongest backers, had "buckled under" by announcing that Germany won't authorize exports of military equipment to Israel that could be used in Gaza until further notice.

Netanyahu said there is a "fairly short timetable" in mind for next steps in Gaza, but didn't give specifics. The goals there, he said, include

demilitarizing the territory, the Israeli military having "overriding security control" there and a non-Israeli civilian administration in charge.

Netanyahu again blamed many of Gaza's problems on the Hamas militant group, including civilian deaths, destruction and shortages of aid. "Hamas still has thousands of armed terrorists in Gaza," he asserted, adding that Palestinians are "begging" the world to be freed

ISRAELI SAYS TWO PROJECTILES 'LIKELY' LAUNCHED FROM GAZA

Jerusalem: The Israeli military on Sunday said two projectiles were "likely" launched from Gaza and crossed into Israel, as the war between Israel and Hamas in Gaza, approaching its third year, has attracted global condemnation and outrage.

The military said interception attempts were made, but the results of the interception are under review. Sirens were sounded in southern Israel close to the border with Gaza. No injuries or damages were reported.

This came amid mounting domestic and international outrage over Israel's military offensive in Gaza, which has killed more than 60,000 Palestinians, reduced the enclave to rubble and brought millions of people to the brink of starvation. Several people have died of hunger amid Israel's tight blockade of humanitarian aid.

On Saturday night, thousands of protesters took to the streets of Tel Aviv in Israel to oppose Israeli Prime Minister Benjamin Netanyahu's plan to escalate the nearly two-year Gaza war, demanding an immediate end to the campaign and for the release of the hostages. A day earlier, the prime minister's office said the security cabinet, a small group of senior ministers, had decided to seize Gaza City, expanding military operations in the devastated Palestinian territory despite widespread public opposition and warnings from the military the move could endanger the hostages.

"This isn't just a military decision. It could be a death sentence for the people we love most," Lishay Miran

Lavi, the wife of hostage Omri Miran told the rally, pleading to U.S. President Donald Trump to intervene to immediately end the war.

Public opinion polls show an overwhelming majority of Israelis favour an immediate end to the war to secure the release of the remaining 50 hostages held by militants in Gaza.

Israeli officials believe about 20 hostages are still alive. The Israeli government has faced sharp criticism at home and abroad, including from some of its closest European allies, over the announcement that the military would expand the war. The full cabinet is expected to give its approval as soon as Sunday.Most of the hostages who have been freed so far emerged as a result of diplomatic negotiations.

China detains senior diplomat: Report

Liu Jianchao, a senior Chinese diplomat heading the foreign relations department of the ruling Communist Party, has been detained for questioning, the Wall Street Journal reported on Sunday.

The 61-year-old senior diplomat was taken away for questioning in late July after returning to Beijing from an overseas work trip, the paper reported,

quoting people familiar with the matter. There is, however, no official confirmation of his detention yet.

Liu, the Minister of the International Department of the Communist Party of China (CPC), is regarded as the potential future foreign minister and shares close ties with President Xi Jinping.

Liu led a CPC delegation that attended the Liberation Movements Summit in South Africa on July 28, according to the official media here.

The news of Liu's detention, coming



ahead of the upcoming Shanghai Cooperation Organisation (SCO) to be held in China's Tianjin city later this month, sent shock waves across the Chinese official and diplomatic circles.

The summit of the 10-member SCO is scheduled to take place from August 31 to September 1.

As a Minister of the International Department of the CPC, Liu wielded considerable influence over China's foreign policy, though Wang Yi is the Foreign Minister.

Liu was one of the top officials who

External Affairs Minister S Jaishankar met during his visit here on July 14 and discussed the progress of the normalisation of the relations after last year's meeting between Prime Minister Narendra Modi and Chinese President Xi Jinping in Russia ending the over four year's freeze in ties due the military standoff in eastern Ladakh.

The official website of the CPC International Department still has Liu's photos and the statements of his meetings with various international digni-

In 2023, the then-foreign minister Qin Gang was ousted. Qin, too, was regarded as Xi's protégé. The reasons for Qin's removal were not made public.

After Qin's removal, Wang, who is currently a member of the powerful Political Bureau of the CPC and Director of the Office of the Central Commission for Foreign Affairs, was made the Foreign Minister, a post he relinquished to facilitate Qin's elevation.

Iran has said it will block a corridor planned in the Caucasus under a United States-brokered peace accord between Azerbaijan and Armenia, which has been hailed by other countries in the region as beneficial for achieving lasting peace.

Ali Akbar Velayati, a top adviser to Iran's supreme leader, said on Saturday that Tehran would block the initiative "with or without Russia", with which Iran has a strategic alliance alongside Armenia.

US President Donald Trump "thinks the Caucasus is a piece of real estate he can lease for 99 years", Velayati told state-affiliated Tasnim News, referring to the trans-

Yunus calls for 'complete security' during general elections next year

Bangladesh Chief Adviser Muhammad Yunus has called for "complete security" at polling centres for the country's general elections set to take place in February 2026, stressing the need to make the polls "free, fair and peaceful", a media report said on Sun-

The interim government head made the remarks on Saturday at a high-level meeting at the state guest house Jamuna here, reported the state-run Bangladesh Sangbad Sangstha (BSS).

"We must guarantee complete security at all polling centres, no matter the cost. Our goal is to make the February election the most free, fair, and peaceful in the country's history," Yunus was quoted as saying.

The polls next year would be the 13th Parlia-



mentary elections.

At the meeting, Yunus' special assistant on Telecommunications and Information and Communication Technology (ICT) Affairs Faiz Tayeb Ahmed said the process to procure 40,000 body cameras was

in the final stages. The use of bodycams by police will enhance security at voting booths during the upcoming elections, he said.

The Chief of Army Staff (COAS) "is undertaking an

official visit to the United States", the Army said in a statement released in Islamabad.

The Army chief engaged in high-level interactions with senior political and military leadership as well as members of the Pakistani diaspora, according to the statement.

No details were shared about his stay in the U.S., and it was also not clear when he arrived.

In Tampa, Mr. Munir attended the Retirement Ceremony of outgoing U.S. Central Command (CENT-COM) Commander General Michael E. Kurilla and the Change of Command Ceremony, marking the assumption of command by Admiral Brad Cooper.

Field Marshal Munir lauded General Kurilla's exemplary leadership and



his invaluable contributions to strengthening bilateral military cooperation and extended his best wishes to Admiral Cooper, expressing confidence in continued collaboration to address shared security challenges, the statement said.

He also met with Chairman Joint Chiefs of Staff, General Dan Caine, where matters of mutual professional interest were discussed. He extended an invitation to General Caine to visit Pakistan, it added. On the sidelines, Mr. Munir interacted with Chiefs of Defence from friendly nations.

During an interactive session with the Pakistani diaspora, Mr. Munir urged them to remain confident in Pakistan's bright future and to actively contribute to attracting investments. The diaspora reaffirmed its commitment to support in Mr. Trump's announce-Pakistan's progress and development, according to the Army

In June, Mr. Munir travelled to the U.S. on a rare five-day trip during which he attended a private luncheon with President Donald Trump, an unprecedented gesture typically reserved for visiting heads of state or government. That meeting culminated

EUROPEAN LEADERS RALLY BEHIND UKRAINE BEFORE FRIDAY SUMMIT

uropean nations have rallied behind Ukraine, saying peace in the war-torn nation can't be resolved without Kyiv, ahead of a planned meeting between U.S. President Donald Trump and Russia's Vladimir Putin.

Trump had said Friday's meeting in Alaska with his Russian counterpart was to discuss ending the more than three-year war.

Zelenskyy responded by thanking European allies and wrote on X on Sunday: "The end of the war must be fair, and I am grateful to everyone who stands with Ukraine and our people."

Saturday's statement by top European leaders came after the White House confirmed the U.S president was willing to grant Putin the one-onone meeting Russia has long pushed for, and suggestions from Trump that a peace deal could include "some swapping of territories." That raised fears that Kyiv may be

pressured into giving up land or accepting other curbs on its sovereignty.

A White House official, who spoke on condition of anonymity as they aren't allowed to speak publicly, told The Associated Press that Trump remained open to a trilateral summit with both the Russian and Ukrainian leaders, but for now, he will have a bilateral meeting requested by Putin.

Meanwhile, U.S. Vice President JD Vance met Saturday with top European and Ukrainian officials at the British Foreign Secretary's weekend residence to discuss how to end the war.

Trump had earlier said he would meet with Putin even if the Russian leader would not meet with Zelenskyy.

A monthlong U.S.-led push to achieve a truce in Ukraine has so far proved fruitless, with Kviv agreeing in principle while the Kremlin has held out for terms more to its liking.

Trump had also moved up an ultimatum to impose additional sanctions on Russia and introduce secondary tariffs targeting countries that buy Russian oil if the Kremlin did not move toward a settle-

Moscow strikes kill 5; refinery hit in Russia

A new round of Moscow's shelling and drone attacks killed five persons in Ukraine on Sunday (August 10, 2025) authorities said, while Kyiv hit an oil refinery in Russia's Saratov region.

There was no reduction in hostilities on the frontline, even as the United States and Russia agreed to hold a summit in a bid to resolve the conflict, which, so far doesn't include Ukraine.

"Three people killed, one wounded in Zaporizhzhia region as a result of Russian shelling," Ukraine's national police said, adding that two more civilians died in the highly contested Donetsk region in the east Meantime, three beach-

goers were killed in the Black Sea coastal city of Odesa, after they tripped on a mine while swimming in a prohibited area, which was mined to fend off a potential Russian navy at-

The Ukrainian Army claimed its drones had hit a large oil refinery in Russia's western Saratov region, almost 1,000 km away from the front line.

The Saratov Governor, Roman Busargin, only gave a vague comment saying that "one of the industrial enterprises was damaged," adding that one person died as a result of the drone attack.

Another woman died in Russia's region of Belgorod, often under Ukrainian fire due to its proximity to the frontline, the local Governor said.

Kyiv is trying to hamper Moscow's ability to fund the more than three-vear war of attrition by attacking its oil and gas facilities, the key sources fuelling the state budget.

Ukraine's military claimed to have taken back the village of Bezsalivka in the Sumy region from the Russian Army, which has made significant recent gains. The focus of the Russian offensive is on eastern Ukraine, where it has stepped up gains in recent months against its less well-equipped opponents.

Presidents Vladimir Putin and Donald Trump will meet in the U.S. state of Alaska this Friday to try to resolve the grinding conflict, despite warnings from Ukraine and Europe that Kyiv must be part of negotiations.

Trump open to Alaska summit with Putin and Zelenskiy

President Donald Trump is open to holding a trilateral summit in Alaska with Russian President Vladimir Putin and Ukrainian President Volodymyr Zelenskiy, a White House official said on Saturday

However, the White House is currently planning a bilateral meeting with Putin at his request, the official added.

The last time Alaska hosted a high-stakes diplomatic gathering was in March 2021, when senior officials from the administration of Democratic former President Joe Biden met with top Chinese officials



The get-together involving Biden's top diplomat Antony Blinken and his Chinese counterpart Yang Jiechi quickly turned into a stunning public clash in front of the cameras, with both sides levelling sharp rebukes of the others' policies that reflected the high tension in bilateral

Since his return to the White House in January, Trump has moved to mend relations with Russia and sought to end the

In his public comments he has veered between admiration and sharp criticism of Putin. Trump announced on Friday that he would meet with Putin in Alaska to push

for a ceasefire in Ukraine. The White House had initially insisted that Putin meet Zelenskyy before Trump agreed to a summit with the Russian leader, but this was later dropped.

If Zelenskyy does attend, sources say it is unclear whether he and Putin would meet directly.

The renewed diplomatic push follows a visit to Moscow by Trump's special envoy, Steve Witkoff, ahead of a deadline set by Trump for Putin to agree to a ceasefire or face sanctions. Putin did not agree to the terms but proposed an arrangement allowing Russia to retain large areas of occupied Ukrainian

London police arrest 365 people as pro-Palestinian protesters defy new law

British police said they arrested 365 people in central London on Saturday as supporters of a recently banned pro-Palestinian group intentionally flouted the law as part of their effort to force the government to reconsider the ban.

Parliament in early July passed a law banning Palestine Action and making it a crime to publicly support the organization. That came after activists broke into a Royal Air Force base and vandalized two tanker planes to protest against Britain's support for Israel's offensive against

Hamas in the Gaza Strip. Backers of the group, who have held a series of protests around the U.K. over the past month, argue that the law illegally restricts

freedom of expression.

More than 500 protesters filled the square outside the Houses of Parliament on Saturday, many daring police to arrest them by displaying signs reading "I oppose genocide. I support Palestine Action." That was enough for police to step in.

But as the demonstration began to wind down, police and protest organizers sparred over the number of arrests as the organizers sought to show that the law was unworkable.

"The police have only been able to arrest a fraction of those supposedly committing 'terrorism' offenses, and most of those have been given street bail and allowed to go home," Defend Our Juries, which organized the protest, said in a statement.

FDA reinstates ousted top vaccine regulator Vinay Prasad

Vinay Prasad, a top vaccine regulator ousted from the Food and Drug Administration (FDA) late last month, is set to return to his post, according to the Department of Health and Human Services (HHS).

"At the FDA's request, Dr. Vinay Prasad is resuming leadership of the Center for **Biologics Evaluation and** Research," HHS spokesperson Andrew Nixon told The Hill in a statement. "Neither the White House nor HHS will allow the fake news media to distract from the critical work the FDA is carrying out under the Trump administration."

Prasad's July 30 resignation as the FDA's chief science officer followed criticism from right-wing figures — including activist Laura Loomer and former Sen. Rick Santorum (R-Pa.) — that ran parallel to a regulatory showdown with



drug manufacturers over a gene therapy treatment for boys with Duchenne muscular dystrophy.

Loomer, a key ally of President Trump with noticeable influence, lavished attacks on the FDA official in recent weeks — calling him a "saboteur" and "trojan horse" for HHS's "Make America Healthy Again" initiative.

She called his return "another egregious personnel decision" in a Saturday post on social platform X, vowing to "ramp up" her pres-

"In the coming weeks, I will be ramping up my exposes of officials within HHS and FDA so the American people can see more of the pay for play rot themselves and how rabid Trump haters continue to be hired in the Trump administration," she wrote. "There are several Senate Confirmation hearings coming up and I have multiple oppo books ready for distribution! Should be a good time."

Prasad was named head of the FDA's Center for Biologics Evaluation and Research in early May as a replacement for Peter Marks, who resigned from the position in March after clashing with HHS Secretary Robert F. Kennedy Jr.

The doctor, just one of several health officials tapped by Trump who criticized COVID-19 vaccines, had been in the role for less than three months when the FDA announced he would

Great Barrier Reef records largest annual coral loss in 39 years

The Great Barrier Reef has experienced its greatest annual loss of live coral across most of its expanse in four decades of record-keeping, Australian authorities say.

But due to increasing coral cover since 2017, the coral deaths — caused mainly by bleaching last year associated with climate change — have

across the iconic reef system close to its long-term average, the Australian Institute of Marine Science said in its annual survey on Wednesday (August 6, 2025).

The change underscores a new level of volatility on the UNESCO World Heritage Site, the report said.

Mike Emslie, who heads the tropical marine research agency's long-term monitor-

left the area of living coral ing program, said the live coral cover measured in 2024 was the largest recorded in 39 vears of surveys

The losses from such a high base of coral cover had partially cushioned the serious climate impacts on the world's largest reef ecosystem, which covers 344,000 square kilometers (133,000 square miles) off the northeast Australian coast, he said.

"These are substantial im-



pacts and evidence that the bleaching is really starting increasing frequency of coral to have detrimental effects

Emslie said on Thursday. "While there's still a lot of coral cover out there, these are record declines that we have seen in any one year of monitoring," he added.

Mr. Emslie's agency divides the Great Barrier Reef, which extends 1,500 kilometres (900 miles) along the Queensland state coast, into three similarly-sized regions: northern, central and south-

Living coral cover shrunk by almost a third in the south in a year, a quarter in the north and by 14% in the central region, the report said.

Because of record global heat in 2023 and 2024, the world is still going through its biggest — and fourth ever recorded — mass coral bleaching event on record, with heat stress hurting nearly 84% of the world's coral reef area,

including the Great Barrier Reef, according to the U.S. National Oceanic and Atmospheric Administration's coral reef watch. So far at least 83 countries have been impacted. This bleaching event started

in January 2023 and was declared a global crisis in April 2024. It easily eclipsed the previous biggest global coral bleaching event, from 2014 to 2017, when 68.2% had bleaching from heat stress.

The lip filler debate? explains the right and wrong of lip enhancement



Social media influencer and fashion provocateur Urfi Javed has once again made headlines-this time, not for her bold fashion choices, but for her visibly overdone lip fillers. Her exaggerated pout, showcased in recent appearances, sparked both concern and criticism across the internet, with many wondering: what went wrong?

To demystify the situation, we spoke to New Delhi based Aesthetic physician, Cosmetologit and Skin Specialist Dr. Karuna Malhotra from Cosmetic Skin and Homeo Clinic in Rajouri Garden who shares her expert insights on what likely happened, what lip fillers should and shouldn't look like, and how to approach aesthetic treatments safely.

What Are Lip Fillers?

Lip fillers are non-surgical cosmetic injectables, typically made of hyaluronic acid-a substance naturally found in the skin-that adds volume, shape, and hydration to the lips.

"When done right, fillers can give you soft, plump, and natural-looking lips," explains Dr. Karuna Malhotra. "But when overdone, or done by untrained hands,



it can result in duck lips, uneven shape, or even longterm damage.

What possibly went wrong with Urfi Javed's lips?

While we cannot confirm the exact procedure or injector involved in Urfi Javed's case, but it happened because of the allergic reaction when she dissolved her previous done fillers.

According to Dr. Karuna Malhotra, "lip fillers should not look unnatural, and one has to be very clear about the look they need, how much plump or how much pout. So, bascially it could be over filled or under filled according to your liking and most importantly please go to a certified doctor only to get these kind of procedures done otherwise it can cause blunders. It shouldn't lost proportion and harmony with the rest of the face."

She further explains that lip anatomy and facial balance must be assessed before any injection. "One size doesn't fit all. A good aesthetician studies the patient's natural lip shape, skin elasticity, and bone structure before suggesting how much product to use," she adds.



The concept of Global Village and Decadent Human Values are the focal points of the third article. Kundu has dwelt on how, with the advancement of science

Kundu has focused mainly on the horrific aspects of communal violence, migration and feel of rootlessness while stating how the distressing time and situation have been depicted in the contemporary literary works. The another article highlights the contents of S. Barathi's remarkable book A Conversation With Contemporary Indian English Poets. That Barathi's questionnaire brings out the background and revelation of innermost feelings of some ten poets, namely, T. V. Reddy, K. V. Dominic, Manas Bakshi , Molly Joseph, Aloysius Papang, Malsawmi Jacob, Ravi Ranganathan, Hema Ravi, Padmaja Iyengar-Paddy and Pankajam Kottarath, interviewed in her book has been perfectly explicated.

Part 2 of the book begins with a tribute to Dr. Ramesh Chandra Mukhopadhaya whose treatise on Modern Bengali Drama is the subject matter for discussion. Bengali plays, written and staged from time to time, bear the imprint of the then prevail-





No clarity on Rohit, Kohli future post Australia series

It's that time of the year when speculation is rife about the impending ODI future of Virat Kohli and Rohit Sharma, but if one goes by the decision makers in the Indian cricket board. there is no tearing hurry to take an immediate call on the two maestros.

With the Bangladesh series scheduled in August being called off. India's next ODI assignment will be an away series from October 19-25 against Australia. However, whether Rohit and Kohli will be playing ODIs post Australia tour is a thing of conjecture.

Indian cricket runs on narratives and currently it is about whether Kohli and Rohit, with a cumulative 83 ODI hundreds and 25,000-plus



runs, can last till the October 2027 ODI World Cup when they would be 39 and 40-year old respectively. "Obviously, if they (Rohit

and Kohli) have something in mind, they would tell the BCCI brass like they did before the England Test tour. But from an Indian team's perspective, the next big assignment is the T20 World Cup in February and preparations before that. The imme-

diate focus will be on sending the best team for the Asia Cup T20 tournament, hoping all players are fit and available," a BCCI source privy to the developments told PTI on conditions of anonymity.

The BCCI never believes in taking decisions in haste and would always gauge the mood and public perceptions before taking a call, which is sensitive in nature considering the massive fan following of the

two players.

The last tournament that they played was the Champions Trophy in Dubai where Kohli scored a hundred in a successful chase against Pakistan at the group league stage while Rohit starred with a sublime half-century in the chase during the final.

However, both have not played competitive cricket since the conclusion of the Indian Premier League.

Kohli, who is now a resident of London, had recently posted an Instagram story after an indoor nets session. which is an indicator that he has started training.

Rohit, who was also in the UK on a break post IPL, is recently back in Mumbai and would certainly be expected to start training in a few days. While there are some media

reports about BCCI offering the duo a farewell game at Sydney on October 25, the BCCI source in the know of things said that as of now, no such discussions have taken place. As far as playing the Vijay Hazare Trophy is concerned, the source said that the national One-Day Championship starts on December 24, 2025 and even before that, there is another three-match ODI series at home against South Africa starting November 30. "Even if they play Vijay Hazare, before that there would already be six ODIs that will be played. In between the Australia ODIs and the South Africa ODIs, there is an India A series against South Africa A where three List A games (50 overs) will be held at Rajkot on November 13, 16 and 19

The India U20 women's national team secured qualification for the AFC U2O Women's Asian Cup for the first time in 20 years, after defeating hosts Myanmar 1-O in their final Group D encounter at the Thuwunna Stadium in Yangon, on Sunday, according to the AIFF

website. The Young Tigresses finished top of their group with seven points, after winger Pooja's 27th-minute goal secured a victory for them in front of a partisan crowd at the Thuwunna Stadium.

It was a game of two halves, the first dominated by India, while Myanmar controlled the proceedings in the second. Neha and Sibani Devi Nongmeikapam combined as early as the third minute, when the former fizzed in a cross to the latter, who was merely inches away from tapping it in.

While the hosts absorbed all the pressure, they did launch a few counterattacks, and forward Su Su Khin came close in the ninth, after receiving a chest-down from Yin Loon Eain.

The hosts began to ease their way into the game as



the minutes wore on, but Pooja minutes ahead of the India took the lead through

30-minute mark. It was

Pooja herself who had started the attack on the counter before crossing it in from the right. Her ball evaded one and all, but Neha, at the opposite flank, managed to get onto the end of it and sent it looping back in. Pooja, who had made her way to the goalmouth by then, barely had enough time to react, and plonked it over the line with her torso.

That calmed the nerves in the Indian camp, at least till the end of the first half. The Young Tigresses kept the ball and took their slender lead into the break.

The second half was a completely different prospect, however. Buoyed by

the home support, Myanmar came all guns blazing, and India goalkeeper Monalisha Devi had to make a smart 48th-minute save to keep Su Su Khin out.

India had dug their trenches, and they dug deep, as they absorbed wave after wave of Myanmar attacks. Monalisha, who had not conceded a single goal in the previous two matches, was called into action with 10 minutes left on the clock when Myanmar substitute Moe Pwint Phyu struck a headed cross by Ei Thet Phyo into the upright. The ball kept rolling tantalisingly on the line before the India goalkeeper leapt across and swiped it away to safety. Phyu hit the woodwork

once again, this time in the 90th minute, when her shot took a deflection off Shubhangi, only to crash into the upright and bounce out of play. Seconds later, India broke on the counter as Sibani sent a cross to Sulanjana Raul, who also hit the woodwork, her header crashing into the cross-bar. Despite all the pressure from the hosts, India clung on to their lead and secured qualification for the first time in two decades.
