SPICEJET CLEARS DGCA **AUDIT WITH CLEAN SLATE**

Outcome reaffirms our robust safety culture, strict adherence to regulatory requirements, says SpiceJet

niceJet has emerged as one of the few Indian carriers to receive a clean slate in the Directorate General of Civil Aviation's (DGCA) latest annual safety audit, recording zero Level 1 findings—the most serious category of safety

In a press release issued on Tuesday, the airline said the outcome reaffirmed its "robust safety culture, strict adherence to regulatory requirements, and alignment with global best practices." SpiceJet also noted that it had successfully renewed its IATA Operational Safety Audit (IOSA) certification earlier this year, valid through March 2027. The IOSA certification is glob-

ally recognised and reflects with ICAO norms and do a high benchmark for operational safety.

The DGCA's audit covered eight major scheduled carriers over the past year and flagged a total of 263 safety and compliance lapses, including 19 Level 1 violations and 244 Level 2 lapses.

While the aviation regulator clarified that these findings are part of routine annual surveillance aligned not necessarily indicate ongoing risk, the audit has nonetheless drawn atten-

tion to lapses at some of In-

dia's largest airlines. In contrast to SpiceJet's clean record, Air India recorded 51 findings—seven of them Level 1—ranging from inadequate pilot training and use of unapproved simulators to violations of crew duty time regulations.

Vistara, now merged with Air India, accounted for ten Level 1 breaches—the highest among all airlines.

Air India Express was flagged for 25 audit observations, including two critical lapses, while IndiGo, India's largest carrier by market share, had 23 findings, all categorised as Level 2.

Alliance Air, a smaller state-run operator, logged 57 observations but no Level 1 violations.

The release of the audit results comes at a time of heightened sensitivity around aviation safety in India, following the fatal crash of Air India Flight 171 near Ahmedabad on 12 June, which claimed over 260 lives. The incident has prompted deeper scrutiny into operational procedures and regulatory oversight.

Four killed, dozens rescued after cloudburst in Uttarkashi

At least four people were killed and several others feared missing after a devastating cloudburst struck Uttarakhand's Dharali region in Uttarkashi district on Tuesday, triggering flash floods and widespread destruction. The devastating cloudburst caused torrential rains leading the Kheer Ganga river to overflow, sweeping away hotels and residential buildings in the town situated over 8,600 feet above sea level. Rescue operations are being carried out on a war footing by teams of the National Disaster Response Force (NDRF), Indo-Tibetan Border Police (ITBP), State Disaster Response Force (SDRF), and

Amid a ruckus in the Upper House over deployment of CISF personnel in Rajya Sabha, Union Parliamentary Affairs Minister Kiren Rijiju slammed the opposition on Tuesday, saying that they have attempted to lower the decorum of the House and mislead the nation by spreading false information about the deployment of security personnel inside Parliament.

Speaking to reporters outside Parliament, Rijiju mentioned that the ruckus erupted in the House when they raised objections to Rajya Sabha Leader of Opposition (LoP) Mallikarjun Kharge's letter to the Deputy Chairman during discussions.

"The opposition has alleged that the government deployed personnel from the Army, police, and CISF. However, the Chair clarified that no external military or police forces were deployed; only the House marshals were present. As per the rules, only marshals are al-

lowed inside the Parliament. Apart from marshals, only members and staff are permitted entry. The opposition spread falsehoods through the media... They attempted to lower the decorum of the House and mislead the nation," the Union Minister said.

"Today marks the start of the third week of the session. In these days, we haven't been able to pass a single bill. We passed a Shipping Bill in the Rajya Sabha, and in the Lok Sabha, we passed the statutory resolution on President's Rule in Manipur, which we will pass in the Rajya Sabha today," he said.

The Union Minister appealed to the Opposition to allow the smooth functioning of the House.

"We will be bringing more bills forward, but before that, I appeal to the main opposition parties not to obstruct bills and other parliamentary work. The people of the country have sent us to Parliament so we can work for them," Rijiju said. Earlier in the day, Leader of

Rajya Sabha adopts resolution to extend President Rule in Manipur

Rajya Sabha on Tuesday adopted the Statutory Resolution to extend President's Rule in Manipur for six more months

Union Minister of State for Home Affairs Nityanand Rai moved the resolution in the Upper House today amid heavy sloganeering by the opposition.

The house adopted the Statutory resolution "continuance in force of the Proclamation dated the 13th Feb'25 in respect of Manipur, issued under article 356 of the Constitution by the President, for a further period of six months with effect from 13th August,

Earlier on July 30, the Lok



Sabha passed the resolution to extend President's rule in Manipur. The President's rule was imposed in Manipur on February 13, days after N Biren Singh resigned from the Chief Minister's position. Singh resigned amid violence and political instability that had plagued the state for nearly two years. The decision, exercised under Article 356 of

the Constitution, means that the president will now directly control the state's administrative functions through the Governor. The proclamation, pub-

lished in the Gazette of India issued by the Union Home Ministry, states that the powers of the Manipur Legislative Assembly will be transferred to Parliament, effectively suspending the state government's authority. Under this order, the Governor's powers will now be exercised by the President; the state legislature's authority will be assumed by Parliament; and specific articles of the Constitution, including those concerning legislative procedures and governance, have been suspended to ensure smooth central administration.

Kharge slams security deployment in Upper House

Held meetings on B'desh; Foreign Secy Misri addressed all queries: Tharoor

Following the Parliamentary Standing Committee meeting on External Affairs held on August 4, Committee Chairperson and Congress MP Shashi Tharoor stated that multiple meetings were held on Bangladesh, during which Foreign Secretary Vikram Misri addressed all queries raised by the members.

"We have held 3-4 meetings on Bangladesh, and this was the last meeting where the Foreign Secretary has given us a briefing, and in this briefing, all the questions that the Members had to ask were discussed. The Foreign Secretary has answered all of them," Tharoor told the media.

He added that the Committee will now prepare its report, which will be

placed before Parliament. "After this, it is our job to write a report, adopt it and present it to the Parliament. Before doing that, I cannot tell what we will decide, what advice we will give..." he said.

The Parliamentary Standing Committee met on August 4 to review the future of India-Bangladesh relations. The meeting saw officials from the Ministry of External Affairs (MEA) presenting evidence on the future of India-Bangladesh relations. The agenda also included a review of the draft report on action taken by the government on recommendations made in an earlier report concerning the MEA's demands for grants for 2024-25. According to Tharoor, the August 4 meeting marked the final round of deliberations on the issue. He reiterated that

the Foreign Secretary had briefed the panel and addressed all queries raised by the members. The committee will now prepare, adopt, and present a report to Parliament.

The panel had earlier met on June 27, during which it heard the views of experts on the topic 'Future of India-Bangladesh Relationship'. Following the meeting, Tharoor stated that the Committee benefited from the insights of "four first-class experts." He also noted that the number of Bangladeshis entering India had declined in recent times."You will see our report in the next few weeks... "India began importing from Russia because traditional suppliers were diverted to Europe after the outbreak of the conflict," the ministry noted. It also accused Western nations of double standards, highlighting that the EU's trade with Russia far exceeds India's, including a record 16.5 million tonnes of LNG imported by Europe in 2024

The MEA also pointed out ongoing US imports from Russia, such as uranium hexafluoride for nuclear energy and palladium for the EV industry. "Like any major economy, India will take all necessary measures

to safeguard its national in-

terests and economic security," the spokesperson said.

According to reports, the United States and China agreed to a temporary 90day tariff reprieve in May, slashing US tariffs from 145% to 30%, and Chinese duties from 125% to 10%.

India has maintained that its foreign and energy policies are rooted in strategic autonomy. MEA spokesperson Randhir Jaiswal reiterated last week that "our ties with any country stand on their merit and should not be seen from the prism of a third country.'

Meanwhile, Russia also issued a sharp rebuke to Washington's tightening tariff policies. Foreign Ministry Spokeswoman Maria Zakharova described US actions as part of a "neocolonial agenda," accusing the Biden administration of using "politically motivated economic pressure" to punish countries following an

independent foreign policy. "Sanctions and restrictions

have unfortunately become a fitting reply to terrorist a defining feature of the current historical period," Zakharova said, arguing that the US is attempting to impose its will through protectionism, undermin- nuclear threats. ing global trade norms and sovereignty. She emphasised that Russia remains committed to building a multipolar world order alongside partners such as BRICS nations.

The mounting tensions come amid fears that global oil prices could surge to \$200 a barrel if India halts Russian imports, severely impacting consumers and economic stability.

With no clear resolution in sight, the spat underscores growing divisions in global trade alliances and highlights the geopolitical complexities surrounding the Russia-Ukraine conflict, energy security, and multipolar diplomacy.

It emphasizes that Jammu and Kashmir has historically shared a federal relationship with the Union of India, and restoring statehood is essential for preserving its autonomy and enabling its meaningful contribution to national development.

Earlier, Shibu Soren's mortal remains were laid on a flower-decked charpoy at his ancestral home in the village in adherence to full tribal customs, as near and dear ones made a beeline to offer shrouds, chadar, shawls and bouquets.

An emotional wheelchairbound Roopi Soren, Shibu Soren's wife, was unable to control her tears, while his sons Hemant and Basant, and daughter-in-law Kalpana were seen standing silent as grief writ large on their faces.

The house was packed with people paying their last respects, with many breaking down.

Dera Sacha Sauda Chief Mamata slams DVC granted 40-day parole a

Dera Sacha Sauda chief Gurmeet Ram Rahim Singh has been granted a 40-day parole, his counsel, Advocate Jatinder Khurana, con-

firmed on Tuesday. Speaking to ANI, Khurana stated, "Gurmeet Ram Rahim Singh has been given a 40-day parole under the law. Every convict has the right to avail a 70-day parole and a 21-day furlough in a year. During this parole period, he will stay at his ashram in Sirsa.'

Earlier on April 9, Gurmeet Ram Rahim Singh was granted a 21-day furlough, marking the 13th time he has been temporarily released from prison since his conviction.

His lawyer, Jitendra Khurana, confirmed the development, stating that the furlough was approved through proper legal chan-

nels. "There is nothing extraordinary in this. It is the legal right of a prisoner to receive up to 70 days of parole and 21 days of furlough in a year. This is not a favour but part of the due legal process," Khurana said.

The timing of Ram Rahim's releases has often stirred controversy, particularly when they coincide with elections or religious events. However, Khurana dismissed such speculation this time, asserting, "People repeatedly ask why Ram Rahim is given parole during elections, but what will they say now? There is no election, no political movement. Clearly, it has nothing to do with politics.'

Since his incarceration, Ram Rahim has received multiple paroles and furloughs. He was first granted a one-day parole in 2020, followed by a 12-hour parole

DU student, entire class failed in exam; HC seeks response from college

She claimed of "arbitrarily and unjustly" being awarded an "F" grade in the practi-



cal exam of the subject titled "Children with Disability in India" in her sixth semester result for the academic session 2024-2025.

The petitioner claimed of appearing in theory, internal assessment and the external practical examination, which comprises practical file evaluation, viva voce and a written ex-

amination. She further claimed securing good marks in both the theory and internal practical components, but alleged due to the "negligence and mismanagement" on the part of the teacher concerned and the college administration, the marks for the external practical examination were not uploaded on the university portal.

"Consequently, the entire class, including the petitioner, has been unjustly marked as 'fail' in the practical component of the said subject. Despite raising repeated complaints through emails and other modes to the college and university authorities, no corrective action has been taken till date," the plea, filed through advocate Ashu Bidhuri, said. The teacher concerned and the college administration, the plea said, have been involved in mutual blameshifting instead of resolving the error, leaving the petitioner and other similarlyaffected students without

BIHAR CABINET NOD FOR DOMICILE POLICY IN RECRUITMENT OF SCHOOL TEACHERS

he Bihar Cabinet on Tuesday gave its nod for the implementation of domicile policy in the recruitment of teachers, reserving around 85 per cent of posts for "native residents" of the state.

Chief Minister Nitish Kumar had on Monday announced that the policy will be implemented for the recruitment of school teachers.

The decision assumes significance ahead of the assembly polls, due to be held later this year.

"The proposal for giving preference to native residents of the state in teachers' recruitment exams was cleared," Additional Chief Secretary (Cabinet Secretariat) S Siddharth said after the cabinet meeting.

"Already more than 50 per cent of seats are reserved for the state's residents. This is because quotas for SCs, STs, **OBCs and Extremely Back**wards Classes account for nearly 50 per cent, while another 10 per cent is reserved for the economically weaker sections," he said.



Siddharth said another 35 per cent is reserved for women, and the government has already taken a decision that only residents of the state will be accommodated in that quota.

"Of the remaining seats, 40 per cent shall now be reserved for native residents of Bihar, who completed their class 10 and class 12 in the state. So the quota for native residents effectively will be more than 85 per cent," he added.

The state has witnessed massive protests over the issue in the recent past.

Leader of Opposition Tejashwi Yadav promised

"100 per cent domicile" if his RJD comes to power in the state.

Union minister Chirag Paswan also came out in support of the demand for the implementation of the domicile policy.

Animal cruelty penalty as low as Rs 10 for first offence: Govt

NEW DELHI

The penalty for acts of cruelty to animals, including killing or maiming, under the Prevention of Cruelty to Animals Act, 1960 is currently as low as Rs 10-50 for the first offence, Parliament was informed on Tuesday.

Minister of State for Fisheries, Animal Husbandry and Dairying S P Singh Baghel, in his written reply to the Lok Sabha, said as per Section 11(1) of the Prevention of Cruelty to Animals Act, 1960, any person who treats an animal cruelly shall, for the first offence, be punishable with a fine not



less than Rs 10 but which

may extend to Rs 50. For the second or subsequent offence committed within three years of the previous offence, the person is punishable with a fine of not less than Rs 20 but which may extend to Rs 100, or with imprisonment for a term that may extend

to three months, or with both, he said.

The minister said the subject of Prevention of Cruelty to Animals falls under the Concurrent List (List III) of the 7th Schedule of the Constitution of India.

The Bharatiya Nyaya Sanhita 2023, also contains enabling provisions for penalising acts of cruelty to animals, he said.

While enforcement primarily rests with the respective state governments, the Animal Welfare Board of India (AWBI) actively pursues complaints received from across the country by forwarding them to the state governments, district collectors, magistrates, and superintendents of police.

Over the last five years, AWBI has addressed 4,589 complaints, forwarding them to the appropriate authorities for necessary legal action, he added.

Complaints of animal cruelty are primarily dealt with by local authorities, as enforcement of the Prevention of Cruelty to Animals Act, 1960 is under the jurisdiction of state governments and Union Territory Administrations

"AWBI does not maintain any data on penalties imposed or nature of punishments awarded," he said.

Of the 4,589 complaints fisheries in India. forwarded to state governments, action taken reports have been received for 306 cases, he said. The government and AWBI continues to promote animal welfare through education, training, awareness programmes, and financial assistance.

Climate change alters marine fisheries dynamics warn scientists Marine Fisheries Research and recruitment into fisher-TDG NETWORK

Pointing out shifts in species biology, distribution and environmental changes, marine scientists have warned that climate change is significantly transforming marine ecosystems and

The scientists highlighted the need for a proper action plan for climate mitigation and ecosystem restoration at a two-day national seminar on 'Mitigating Climate Change Impact on Marine Ecosystems' jointly organised by ICAR-Central

Institute (CMFRI) and Institute of Social Sciences (ISS) a CMFRI release here said on Tuesday.

"Following fresh tariff threats from President Donald Trump, both the benchmark indices Nifty and Sensex came under intense selling pressure in the first hour of the trade before consolidating in a range for the remaining part of the day," said Sudeep Shah, Head -Technical and Derivatives

and market expert, said, "Trump tantrums are overlaying an otherwise sea of green across global markets. Indian markets bounced back from oversold levels on Monday in line with a global markets recovery from Asia to Europe to USA."

A new social media post by Trump threatening levy of secondary tariffs on India for buying Russian crude oil became a source of worry.

Observing the markets, Ashika Institutional Equities in a note said caution prevailed ahead of monetary policy announcement.

"Ahead of tomorrow's monetary policy announcement, caution prevailed, and banking stocks came under renewed selling pressure during the second half of the session."

Among the Nifty constituents, the top four stocks by weightage namely HDFC Bank, ICICI Bank, Reliance Industries and Infosys witnessed strong selling which weighed on the index. Nifty Oil & Gas and Nifty Pharma emerged as top losers while Nifty Auto & Nifty Metal closed with gains.

Rupee weakens amid high USD demand, US tariff and FII outflows: Experts

The Indian Rupee continued to weaken on Tuesday as it came under pressure due to continuous dollar demand from importers and persistent foreign institutional investor (FII) outflows.

Currency experts highlighted that the situation has been further aggravated by the uncertainty around US tariffs and possible penalties related to India's continued crude oil imports from Rus-

In an exclusive conversation with ANI, experts noted that there is still no clarity on the nature or extent of the penalties that might be imposed by US President Donald Trump. The lack of details has added to the uncertain environment in the currency market.

KN Dey, a currency expert told ANI "The Rupee is still in the middle of a storm, trading now at 87.80/81. Interventions from RBI continue, otherwise the Rupee might have breached the 88 level today,".

He added, "There is continuous demand for dollars from importers as well as due to FII outflows. Inflows have slowed down on anticipation of a weaker Rupee

NEW DELH India is actively involved in the discussions on the India-USA Bilateral Trade Agreement, which aims at expanding trade and investment and deepening the US-India trade relationship to promote growth that ensures fairness, national security and job creation, especially in the labour-intensive sector, including agricultural products. According to Ministry of Agriculture & Farmers Welfare, the Minister of State for Agriculture and Farmers Welfare, Ramnath Thakur in a written reply in Lok Sabha today said that the ongoing discussions are focussed on how to take an integrated approach to strengthen and deepen bilateral trade by mutually increasing market access, reducing tariff and nontariff barriers, and deepening

supply chain integration. Further, the livelihood interests of our farmers and requirements of food security have always been paramount for the Government while negotiating trade agreements with our international partners, including the US.

The Insurance Regulatory and Development Authority of India (IRDAI) has imposed a penalty of Rs 5 crore on Policybazaar Insurance Brokers for multiple violations of the Insurance Act, 1938 and related rules and regulations.

In an official statement, the IRDAI said that the action was taken under Section 102 of the Insurance Act, 1938.

It stated, "IRDAI in exercise of the powers under Section 102 of the Insurance Act, 1938, has imposed a penalty of Rs. Five Crore on M/s Policybazaar Web Aggregator Pvt. Ltd. (Now known as "M/s Policybazaar Insurance Brokers Pvt.

The penalty was imposed after the regulator examined 12 charges related to Policybazaar's operations. One of the key violations pertained to Key Managerial Personnel (KMPs) holding directorships in other companies, which goes against

exclusivity norms.

Policybazaar had argued that disclosure was not required unless the other roles were in the insurance sector. However, IRDAI disagreed, citing potential conflict-ofinterest risks and imposed a penalty of Rs 1 crore for this violation.

Policybazaar was also found to have received hundreds of crores from insurers for outsourced services without maintaining clear agreements that defined service-level details or provided a transparent pricing structure. IRDAI considered this non-transparent and imposed another Rs 1

on the Policybazaar website as "TOP" or "BEST," which is against the guidelines that mandate neutral and unbiased listings.

the use of Policybazaar's own payment gateway and nodal accounts to collect premiums from customers. In several cases, the remittance to insurers was delayed by more than 30 days, breaching the 24-hour rule. This violation also attracted a Rs 1 crore penalty.

Policybazaar was also unable to provide call recordings when requested, citing challenges in retrieval. While no fine was imposed for this, IRDAI directed the company to undergo an external audit by Chartered Accountant.

The regulator also found instances of commission pavouts exceeding the prescribed limits, which it attributed to delays in reconciliation. A formal caution was issued on this matter.

Moreover, several Authorized Verifiers were also found to be acting as insurance agents, a clear compliance failure. IRDAI issued a caution and directed the company to implement stronger verification and compliance measures.

DECARBONISING THE SHIPPING INDUSTRY IN INDIA

s the world grapples with the twin imperatives of economic development and environmental sustainability, the shipping industry finds itself at a critical juncture. Globally, maritime transport accounts for nearly 3% of greenhouse gas (GHG) emissions, according to the Review of Maritime Transport 2023 by UNCTAD. Without significant intervention, these emissions are projected to increase by up to 130% by 2050 compared to 2008 levels, fuelled by rising trade volumes and energy-intensive shipping practices. India, with its 7,517 km-long coastline and

dependence on maritime

trade for nearly 95% of its

trading volume and 70% by value, therefore, must take decisive steps to ensure the sector aligns with its climate commitments and developmental goals.

GLOBAL IMPERATIVES AND INDIA'S STANDPOINT

The International Maritime Organisation (IMO) has undertaken the formidable task of steering the global shipping industry towards decarbonisation. In July 2023, the IMO revised its greenhouse gas strategy, setting a net-zero target for international shipping by or around 2050. One of the most consequential proposals emerging from this effort is a global carbon tax - pro-

posed at \$100 per tonne of CO equivalent, to be levied from 2027. It is expected to generate over \$10–13 billion annually, with the funds earmarked for climate technology transfer and support for developing nations transitioning to green shipping practices.

India's stance within these negotiations has been pragmatic and cautious. At the 80th session of the IMO's Marine Environment Protection Committee (MEPC 80) held in July 2023, the Indian delegation called for more realistic, sciencebased targets that consider the unique challenges of developing countries. India proposed a more measured target of having net-zero carbon fuels constitute 5% of the global marine fuel mix by 2030. Indian representative warned against overly ambitious mandates, suggesting that they could result in "unsustainable investment decisions" and deployment of "immature technologies".

India has also opposed blanket taxation measures that could disproportionately impact developing economies. The Indian delegation to MEPC 81 in March 2024 reiterated the call for a 'Common But Differentiated Responsibility and Respective Capabilities' (CBDR-RC) approach in global shipping taxation. Such a framework, it argued, would ensure fairness while also maintaining the

competitiveness of countries like India in global trade.

DOMESTIC ACTION: GREEN PORTS AND CLEAN SHIPPING

On the domestic front, India has launched a suite of ambitious initiatives aimed at greening its maritime sector. The Sagarmala Programme, launched in 2015, seeks to enhance port infrastructure, improve logistics efficiency, and promote coastal shipping. By increas-

ing reliance on inland and coastal waterways - which are three to four times more fuel-efficient than road transport - the programme aims to reduce logistics costs and carbon emissions.

Complementing this is the Maritime India Vision 2030, which lays out a ten-year blueprint for the holistic development of Indian ports and shipping infrastructure. One of its standout features is the 'Harit Sagar' or Green Port Guidelines, which encourage Indian ports to adopt renewable energy, electrify cargo handling operations, reduce water consumption, and shift to cleaner fuels. According to the Ministry of Ports, Shipping and Waterways, Deendayal (Kandla), Visakhapatnam, New Mangalore, and VOC Port (Tuticorin) have already begun generating renewable energy that exceeds their internal consumption.

Moreover, the Indian government has identified ten highway corridors for exclusive movement of zero-emission trucks, further integrating green mobility with port logistics.

TECHNOLOGY AND FUELS OF THE FUTURE

India is also investing in innovation and clean energy

alternatives. Green hydrogen, ammonia, and electrification of port operations are emerging as viable solutions. Pilot projects are underway to introduce electric catamaran water taxis in cities such as Varanasi and Guwahati. The Inland Waterways Authority of India (IWAI) has also announced plans for hybrid electric Roll-on/Roll-off (Ro-Ro) vessels powered by both liquefied natural gas (LNG) and batteries.

Private sector innovation is also gathering pace. Startups like Blue Energy Motors are producing LNG-powered long-haul trucks that emit 30% less CO₂ compared to diesel counterparts. The company plans to introduce electric trucks and expand its LNG refuelling infrastructure nationwide.

These technologies, while promising, must be scaled efficiently and supported by investment and policy clarity. As highlighted by the UNCTAD Review of Maritime Transport 2023, a global transition to green fuels and infrastructure will require around \$28 billion annually through 2050. In the Indian context, such investments must be prioritised through public-private partnerships, targeted subsidies, and R&D support.

cerns, sustainable shipping is increasingly linked to economic competitiveness. India's early commitment to sustainable practices - such as the green hydrogen mission, shore-power mandates, and electric logistics, positions it as a low-risk, forward-looking partner in global trade networks.

Indeed, as global supply chains begin to impose sustainability-linked performance standards, India's proactive green strategies may offer exporters a critical edge. Carbon border adjustment mechanisms (CBAMs) proposed by the EU and similar trade rules elsewhere make it imperative for India to act now - not just to decarbonise, but also to remain competitive.

CONCLUSION

India's maritime transition will not be easy. But with the right mix of realism and ambition, it can serve as a global model for how developing economies can tackle shipping emissions without compromising on growth. Through targeted investments in green infrastructure, support for clean technologies, and a balanced global negotiating strategy, India is steering its shipping industry towards a greener horizon - one where sustainability and economic progress can sail together. Legal accountability of AI in corporate decision-making: Who bears the risk?

In a rapidly digitising corporate India, the rise of artificial intelligence (AI) is not merely a technological evolution — it is a legal and ethical reckoning. As companies increasingly integrate AI into boardrooms and business processes, a fundamental question arises: Who is accountable when AI fails?

AI JOINS THE BOARDROOM

From drafting contracts and conducting risk assessments to vetting loan applicants and flagging regulatory breaches, AI has assumed an influential role in corporate decision-making. Indian start-ups and conglomerates alike are adopting AI-powered tools to enhance compliance efficiency, reduce costs, and mitigate human error.

However, these intelligent systems are not infallible. They function based on algorithms trained on historical data, which may be biased, outdated, or incomtial minefield of legal and regulatory challenges when decisions made — or heavily influenced — by AI lead to financial loss, reputational damage, or regulatory noncompliance.

THE LEGAL VACUUM

Indian corporate law, particularly the Companies Act, 2013, has not yet evolved to directly address AI's role in governance. The law continues to assign fiduciary duties — such as duties of care, diligence, and good faith — to human directors and officers. These obligations are non-delegable, meaning that a board cannot escape liability by blaming faulty AI tools.

In this context, AI remains a tool — not a legal person, and therefore cannot be held independently accountable under Indian law. This leaves companies and their decision-makers fully exposed when things go wrong.

For instance, if an AI-based financial tool fails to flag a key compliance requirement, leading to SEBI penalties, the directors cannot cite algorithmic oversight as a defence. The Ministry of Corporate Affairs (MCA) and regulators like SEBI have maintained that technological tools must be used prudently, not blindly.

THE BOARD'S

RESPONSIBILITY

This legal position places an enhanced burden on boards and compliance officers. They must now understand not only the business implications of AI tools but also the logic, limits, and biases inherent in such systems.

"Directors are increasingly expected to exercise oversight over the design and deployment of AI systems," says Saurabh Bhatnagar, a Delhi-based corporate lawyer. "They must be able to question the rationale behind AI-generated outputs, particularly when it informs a regulatory or financial ac-

do so lawfully, with consent and accountability.

A breach caused by an autonomous AI-driven system may still attract penalties under the DPDP Act, with corporate entities deemed the "data fiduciaries" — and therefore liable.

As AI becomes more embedded in hiring, procurement, and investment decisions, the risk of algorithmic discrimination is also a legal minefield. Discriminatory outcomes in recruitment or customer profiling, even if unintentional, could invoke regulatory scrutiny and reputational backlash.

UNEARTHING THE TRUTH: INSIDE KARNATAKA'S MASS BURIAL PROBE

Once believed to be a place for truth, Dharmasthala now seems to have buried a hundred lies.

hen a former sanitation worker walked into a Mangaluru police station in early July, holding photos of bones and secrets buried for decades, he cracked open one of Karnataka's most chilling mysteries.

The 48-year-old Dalit man, employed by the Dharmasthala Temple Trust between 1995 and 2014, alleged that over nearly two decades, he was coerced under threats of violence into burying more than a hundred dead bodies across the temple town. Many of the victims, he claimed, were women, minors, or unidentified civilians. The remains, he said, were often disposed of in secret grave sites around the Nethravathi River and adjacent forests.

"They told me if I refused, I would be cut to pieces and buried with them," the man later testified before a magistrate. His statement described scenes of violence, rape, and summary executions, involving everything from beggars to schoolgirls, all allegedly silenced and buried without records.

He recounted one especially haunting instance of being forced to bury a schoolgirl still in uniform, her underwear missing, along with her school bag. In another case. he claimed to have buried a woman who had been thrown into the river with acid burns. Beggars, he said, were suffocated in rooms and their bodies quietly dumped.

Following his formal complaint on July 4, the man was granted police protection. His lawyers claim the threats have continued subtly, even from within the Special Investigation Team site was pinpointed after the (SIT) formed on July 19 to probe his allegations. On recollection, stating that the July 10, the whistleblower burial may have occurred demonstrated his knowl-

edge of burial sites by digging up bone fragments in front of police officers and a magistrate. Preliminary analysis confirmed the bones to be human.

The whistleblower identified 13 burial sites in and around Dharmasthala. On July 28, under tight security, he led SIT officials to riverbanks, forests, and even temple-linked lands. Excavations began soon after. While the first few sites yielded no evidence, signifiThe fragments included a skull and fabric remnants, including a red saree-indicating possible female victims. This recovery has given fresh momentum to the investigation.

Forensic teams are now analysing the remains for DNA, gender, trauma signs, and approximate time of death. Investigators are comparing the data with decades-old missing persons records. But the process is slow. The hot, acidic

cant remains were recovered from two.

At Spot 6, partial skeletal remains believed to be of a male were found on July 31. A skull and rib fragments, along with a torn saree and slippers, were unearthed from Spot 11 on August 4. Both sets of remains were sent to the Forensic Science Laboratory (FSL) for DNA, age, and trauma analysis. Experts say the bones could yield valuable clues despite the time elapsed.

In a recent development, over 100 bone fragments were recovered from a newly identified Spot 14, located about 100 feet above the riverbed, adjacent to the previously dug Spot 11. This whistleblower revised his slightly higher on the slope.

firmed that Unnatural Death Reports (UDRs) and missing persons data between 1995 and 2014 have been collated and secured to avoid tampering. However, human rights advocates note inconsistencies in data and allege many records were either altered or discarded over the years.

A fresh complaint was filed recently by social activist Jayanth T., citing the suspicious death and illegal burial of a 13- to 15-yearold girl more than 15 years ago. This case, previously undocumented, has now been referred by the SIT to the Dharmasthala police for legal follow-up.

Whistleblower advocates have also urged the SIT to employ Ground Penetrating Radar (GPR) technology, arguing that rain, soil erosion, and shifting terrain may have displaced skeletal remains. So far, the SIT has relied solely on manual ex-

Dharmasthala, revered for centuries as a sacred hub of justice and charity, is now grappling with the implications. The temple's hereditary administrator, Rajya Sabha MP Veerendra Heggade, has not commented publicly but a spokesperson stated that the temple welcomes a fair investigation. The temple trust runs free meal programs, arbitration courts, and hospitals-its image is deeply tied to the idea of upholding dharma (jus-

This sanctified aura, some say, has helped shield Dharmasthala from scrutiny. Earlier cases like the 1987 rape-murder of Padmalata and the unsolved 2012 murder of 17-year-old Sowjanya also stirred protests, but no convictions followed. Sowjanya's family has long alleged that powerful people intervened to cover up the

As news of the July 4 FIR broke, reactions varied. Locals whispered of long-suspected secrets. Families of missing girls came forward. Sujatha Bhat, whose daughter vanished in 2003, said, "I believe my Ananya may be one of them. I just want her bones, so I can perform her last rites." A total of 367 women and girls have gone missing in the region over the last two decades. Many of those cases saw no FIRs or were dropped prematurely.

Thile the core concept of the thali remains consistent across the state - a balanced meal featuring various categories of food there are subtle but fascinating regional variations that add to its richness. These differences often stem from the local climate, agricultural produce, and historical influences of the specific princely states.

CORE COMPONENTS OF A RAJASTHANI THALI

Regardless of the region, certain elements are almost always present, making up the soul of a Rajasthani

Breads (Roti/Baati):

Dal Baati Churma: The undisputed king. Baati are hard, unleavened baked or fried wheat or millet balls, often crushed and generously doused in ghee.

Missi Roti: A flavorful flatbread made from a blend of wheat and besan (gram flour), giving it a distinctive nutty taste.

Bajra Roti: A rustic and highly nutritious flatbread made from pearl millet, particularly popular in colder months

Khoba Roti: A thick, dimpled roti cooked over direct heat, often served with more traditional, rustic thalis.

Dals (Lentils):

Panchmel Dal: A staple made from a mix of five different lentils (chana, moong, toor, masoor, urad), offering a rich, wholesome, and protein-packed experience.

Kadi: A tangy, yogurt-based curry, often spicier than its Punjabi counterpart, and sometimes featuring pakoras (fritters).



Israel to partially reopen Gaza private goods trade

Israel will partially reopen private sector trade with Gaza to reduce its reliance on humanitarian aid, the defence ministry civil affairs agency for the Palestinian territories said on Tuesday.

"As part of formulating the mechanism, a limited number of local merchants were approved by the defence establishment, subject to several criteria and strict security screening," COGAT said.

The interim government held discussions with political parties that participated in the movement against Sheikh Hasina before finalising the "July Declaration". India and Philippines stage joint naval drill in disputed South China Sea

India and the Philippines have staged joint naval exercises in the disputed South China Sea for the first time, a high-profile military deployment that antagonized China. Beijing has separate territorial disputes with the two Asian democracies and a long-running regional rivalry with New Delhi.

Armed Forces of the Philippines chief of staff Gen. Romeo Brawner said Monday that the two-day joint naval sail and exercises which began Sunday went successfully, and expressed

hopes that Filipino forces could engage India's military in more joint maneuvers in the future.

Asked if Chinese forces carried out any action in response, Brawner said without elaborating that "we did not experience any untoward incident but we were still shadowed. We expected that already."

Two Chinese navy ships, including a guided-missile destroyer, were spotted about 25 nautical miles (46 kilometers) from one of two Philippine navy frigates that participated in the joint sail on Sunday, the Philippine military said. The Chinese

military's Southern Theater Command said it conducted routine patrols in the South China Sea on Sunday and Monday and added that it remains resolute in defending China's territory and maritime rights and interests.Without mentioning India by name, the Southern Theater Command accused the Philippines of drawing in outside countries to organize joint patrols that it said undermine regional peace and stability. China's Foreign Ministry said territorial disputes should be resolved by those directly involved without any thirdparty intervention.China

The Philippines has staged naval patrols in the disputed waters with its treaty ally, the United States, and other strategic partners including Japan, Australia, New Zealand and France to promote freedom of navigation and overflight and strengthen deterrence against China.

It has allowed journalists to join territorial sea and aerial patrols to witness China's increasingly aggressive actions, provoking angry Chinese reactions.

In response to a question last week about Manila's plans to build up military cooperation, China's Ministry of National Defense called the Philippines a "troublemaker" that has aligned itself with foreign forces to stir up trouble in what China deems its own

Brawner said the Philippines has to boost deterrence to prevent war. "The way to do that is, number one, the Armed Forces of the Philippines has to be strengthened through modernization, and secondly, we need to partner with likeminded nations and that's what we're doing with India," he said last week.Duran Indian navy tanker, the INS Shakti, on Thursday, Brawner said the vessel's port call in Manila was more than ceremonial. SOME FOREIGN VISITORS FACE UP TO \$15,000 BOND TO ENTER US UNDER NEW PROGRAMME

he Trump administration is implementing a pilot programme under which foreign visitors arriving in the US on tourist or business visas could be required to pay a "bond" of up to USD 15,000 to ensure they don't overstay their visas.

The countries that would come under the purview of the programme have not been announced vet.

The US State Department has isasued a 'temporary final rule' under which a 12-month long visa bond pilot programme will be started.

The State Department said that under this pilot programme, foreign individuals applying for the B-1/B-2 visas to come into the US for business or tourism could be required to post a bond of up to USD 15,000.

The Department said that the rule is described as a "key pillar of the Trump administration's foreign policy to protect the United States from the clear national security threat posed by visa overstays and deficient screening and vetting".

"Individuals applying for visas as temporary visitors for business or pleasure (B-1/B-2) and who are nationals of countries identified by the Department as having high visa overstay rates, where screening and vetting



Rwanda to take in 250 U.S. deportees under Trump's third-country plan

KIGALI, RWANDA: Rwanda on Tuesday became the third African nation to agree to accept deportees from the United States under the Trump administration's plans to send migrants to countries they have no ties with to get them off American soil.

Rwandan government spokesperson Yolande Makolo told The Associated Press in a statement that the East African country would accept up to 250 deportees from the U.S., with "the ability to approve each individual proposed for resettlement" under the agreement. Makolo didn't provide a timeline for any deportees to arrive in Rwanda or say if they would arrive at once or in several batches. She said details were still being worked out. The U.S. State Department and the Department of Homeland Security didn't immediately respond to requests for comment on the agreement. The U.S. sent 13 men it described as dangerous criminals who were in the U.S. illegally to South Sudan and Eswatini in Africa last month and has said it is seeking more agreements with African nations. It said those deportees' home countries refused to take them back The U.S. has also deported hundreds of Venezuelans and others to Costa Rica, El Salvador and Panama under President Donald Trump's plans to expel people who he says entered the U.S. illegally and are "the worst of the worst.

ment said in a public notice. It said consular officers may require covered nonimmigrant visa "applicants to post a bond of up to USD 15,000 as a condition of visa issuance, as determined by the consular officers".

The pilot programme, expected to start this month, will be effective till August

The pilot programme appears to be part of the Trump administration's crackdown on illegal immigration, a key agenda of the US president's electoral run and his second term in the White House.

The public notice states that over the years, it has been found that hundreds of thousands of nonimmigrant visitors do not depart the US timely and overstay their visas.

While the public notice does not mention which countries will come under the purview of the programme, it said that the State Department will announce the covered countries within at least 15 days before the pilot programme takes effect and this list will be amended as required.

"In announcing the covered countries, the Department will also provide a brief explanation of the basis for requiring bonds

consistent with this rule," it said.

"The pilot programme is further designed to serve as a diplomatic tool to encourage foreign governments to take all appropriate actions to ensure robust screening and vetting for all citizens in matters of identity verification and public safety... and to encourage specified countries with visa overstays to ensure their nationals timely depart the United States after making temporary visits.'

The public notice said that by its design and intention, the pilot programme is a "tool of diplomacy, intended to encourage foreign governments to take immediate action to reduce the overstay rates of their nationals when travelling to the United States for temporary visits".

The notice also cites estimates by the Department of Homeland Security, which said that in the DHS FY 2023 Overstay Report, data indicated there were over 500,000 "suspected in-country overstays, - individuals who remained in the country past the end of their authorised stay and had yet to depart the country - among nonimmigrants admitted through air or sea ports of entry".

Through the programme, the Department seeks to send a message to all countries to take immediate action to encourage their nationals to comply with US immigration law, it said.

Russia defends India's right to select trade partners

Russia on Tuesday said sovereign countries have the right to select their partners in trade and economic cooperation based on their interests, a day after President Donald Trump threatened to "substantially" raise US tariffs on India for buying Russian oil.

"We believe that sovereign countries must have and do have the right to choose their trade partners, the partners in trade and economic cooperation, on their own and independently determine those modes of trade and economic cooperation that suit the interests of a country in question," Kremlin Spokesman Dmitry Peskov told journalists, commenting on the US' threats regarding

President Trump on Monday said he will "substantially" raise US tariffs on India, accusing it of buying massive amounts of Russian oil and selling it for

big profits.

Hours later, India mounted an unusually sharp counterattack on the US and the European Union for their "unjustified and unreasonable" targeting of New Delhi for its procurement of Russian crude oil.

Firmly rejecting the criticism, India pointed out the double standards in targeting it on the issue and said both the US and the EU are continuing their trade relations with Russia.

"Unlike our case, such trade is not even a vital national compulsion," the Ministry of External Affairs (MEA) said in a state-

The Europe-Russia trade includes not just energy, but also fertilizers, mining products, chemicals, iron and steel, and machinery and transport equipment, the MEA said.

"Where the US is concerned, it continues to import from Russia uranium hexafluoride for its nuclear industry, palladium for its EV industry, fertilizers as well as chemicals," it added.

"In this background, the targeting of India is unjustified and unreasonable. Like any major economy, India will take all necessary measures to safeguard its national interests and economic security," the MEA

Putin doubts potency of Trump's ultimatum to end war in Ukraine

Russian President Vladimir Putin is unlikely to bow to a sanctions ultimatum expiring this Friday from U.S. President Donald Trump. and retains the goal of capturing four regions of Ukraine in their entirety, sources close to the Kremlin told Reuters.

Trump has threatened to hit Russia with new sanctions and impose 100% tariffs on countries that buy its oil - of which the biggest are China and India - unless Putin agrees to a ceasefire in Russia's war in Ukraine.

Putin's determination to keep going is prompted by his belief that Russia is winning and by scepticism that yet more U.S. sanctions will have much of an impact after successive waves of economic penalties during 3-1/2 years of war, according to three sources familiar with discussions in the Kremlin.

Sweden, Norway and Denmark will contribute around \$500 million to a NATO-led initiative to supply Ukraine with U.S. weapons, including Patriot missiles, to ensure it can continue to defend itself against Russia, the three

countries said on Tuesday. U.S. President Donald Trump said last month the United States would supply weapons to Ukraine, paid for by European allies, but did not indicate how this would be done.

"We want to ensure that Ukraine quickly receives the equipment it needs, while strengthening NATO cooperation on Ukraine's defence and securing peace on Ukrainian terms," Norwegian Defence Minister Tore O. Sandvik said in a statement.



Ukraine's President Volodymyr Zelenskiy said the measure created a new foundation for long-term security across Europe.

"This will be felt. And it will serve as a strong example for other NATO countries to strengthen the security ties between America and Europe and to ensure protection from Russian strikes," he wrote on X.

"Russia will never turn Europe into a continent of war, and it is precisely through our joint efforts that we are ensuring peace will prevail," he added.

Danish Defence Minister Troels Lund Poulsen said the money would be available immediately and that Denmark would be willing to consider additional funding later.

Indian-origin taxi driver attacked in Dublin, police probe violent assault

Upon arriving at the destination, the men allegedly opened the vehicle door and struck him twice on the head with a bottle. As the suspects fled, they reportedly shouted: "Go back to your own

"I'm really scared now and I'm off the road at the moment. It will be very hard to go back. My children are really scared," he said.

A Dublin police spokesperson said Singh was taken to the city's Beaumont Hospital with injuries determined as not life-threatening.



'Malegaon Files' is our attempt to bring that reality to the screen," director Rajiv S Ruia, said about the film in the press note.

Ruia told ANI that the film is currently in the preproduction stage and will be

"Our writer team is in talks. It is a very sensitive subject. Every detail behind it needs to be brought out. Research is going on...99 per cent we will shoot on real locations. We will do recce soon." he said.



UNDERVALUED SKILLS: WHY DO WE NEED TO BUILD ROCK-SOLID STEM FOUNDATION?

eepMind CEO and Nobel laureate Demis Hassabis recently emphasized the importance of STEM (Science, Technology, Engineering and Math) skills. He has hit the bulls eye

with his appeal. Building rock-solid STEM foundational skills is crucial in this AI era.

The STEM practice in India has witnessed a peculiar paradox. Disappointing admissions to STEM academics across state-level colleges and universities has raised an uncomfortable question - is a decline a reflection of growing lack of confidence **WE NEED MORE STEM**

On one hand, we witness a

trend of STEM graduates emerging in large numbers; on the other hand, there are concerns around underemployment and misemployment in core engineering and scientific domains. Recent data from the India Skills Report (2024) notes that only about 50% of Indian graduates are considered employable. A report from Aspiring Minds (now SHL) found that 80% of Indian engineering graduates are unemployable in the knowledge economy owing to several challenges - lack of practical exposure, poor communication skills, and outdated curricula.

It is widely believed that automation has made many traditional STEM roles redundant, while others point to tech layoffs even at elite firms. Then, students are greeted with social messages where even engineering toppers are working in unrelated domains. Such visi-

tend to fuel the belief that, probably, STEM no longer guarantees upward mobility. This interpretation may seem emotionally valid, it is still intellectually incomplete. Now is the right time that a developing economy like ours focus and even double-up on STEM skills. **MOVE BEYOND A**

TEMPLATE

The recent experience of an IT company's hiring of 450 jobs for coders is a greater reflection that suggests why we need to focus on core skills. 12,000 candidates applied for 450 jobs. Unfortunately, not a single candidate could be hired because most of them relied on an AI tool for a code rather than to apply their mind to solve a business problem.

Many students are tempted to quick fixes which a solid foundation in STEM can resolve. At its core, STEM is about understanding systems. These could be biological, physical, informational,



ample, an understanding of STEM could empower a student to investigate more about the algorithm that powers ChatGPT than to just rely on it for readymade answers. Naturally, STEM is foundational to real core innovation.

Take a look at Demis Hassabis. He holds a PhD in cognitive neuroscience but it is his scientific understanding that enables him to utilise data into the AlphaFold project. That project solved the complex problem of protein-folding. This was not only a feat for

the AI community but that of the whole interdisciplinary science combining biology, physics, and machine learning.

Even in India, ISRO's Chandrayaan-3 mission was not the product of raw coding talent alone. It required precision engineering, orbital mechanics, materials science, and applied mathematics. These are STEM domains in their classical form.

AI DOESN'T REPLACE **STEM. IT AMPLIFIES**

The real issue with STEM

skills is the teachings can seem siloed - disconnected from application. A good solution would be in reimagining STEM education as systems education. One that focuses on strong industry interface, modern lab access, and inter-disciplinary projects.

A ONE OF ITS KIND **INITIATIVES**

Active Learning Space, at Galgotias helped shift our traditional classrooms into lively hub. The Singapore University has shown benefits from Active Learning, and so does Galgotias University. Such hubs are avenues where not only are ideas exchanged but the silos too can be bridged. Aligned with National Education Policy, the idea of Active Learning cuts across technology, human interaction, and even interdisciplinary approaches to redefine classroom learning.

The rise of AI has stoked fear about large-scale job unemployment and redundancy. While such a fear is not misplaced, it overlooks the full picture. A viable AI model may actually amplify value to those who understand the science and the art behind such systems. For instance, Generative AI could write code, but can we get it to validate complex simulations in aerospace engineering without human supervision? Probably not.

Those are aspects that yet need human involvement. Just like Demis Hassabis, scientists such as Dr. Fei-Fei Li at Stanford or many Indian AI researchers across reputed institutions continue to argue that a STEM education is the basic epistemic framework necessary to question AI outputs and for further improvement.

STEM education is crucial in domains like climate modeling, space research, biomedical sciences, and national security where errors have real-world consequences. AI is a multiplier, not a replacement. The demand will shift away from rote coding and toward algorithm design, mathematical modeling, and systems integration.

BUILDING SCIENTIFIC TEMPER

STEM or education as a matter of fact has been perceived as a job conduit. But a good fundamental base is a country's defence against rising pseudoscience, misinformation, and even ideological extremism.

If properly delivered, STEM can create a culture of inquiry, falsifiability, and evidence. These are nonnegotiables in a society trying to modernize without fracturing itself. In India, initiatives like the Atal Innovation Mission or the National Research Foundation have great propensity to succeed, if the STEM pipeline remains robust. I am confident. That, armed with AI, our next generation will reinvent and even create champions to solve the bigger problems of the world. The author is CEO, Galgotias

Historical evolution of indigenous knowledge systems and practices

Indigenous Knowledge Systems and Practices (IKSP) represent a network of knowledge, beliefs and traditions intended to communicate and contextualise the Indigenous relationships with culture and landscape over time. It is holistic, geographically and culturally context-specific, dynamic, unorganised and adaptive, transmitted through oral traditions and narratives woven

into the ordinary practices of daily existence. From the earliest human

civilisations, communities across continents have developed sophisticated knowledge traditions. Long before the emergence of an organised scientific methodology, Indigenous communities innovated creatively in fields like agriculture, water conservation, medicine, architecture, etc. This came in response to the variety of daily problems they faced. They didn't rely on a one-size-fitsall approach. For Instance, in Africa, communities such as the Maasai and the San people employed rotational grazing, ensuring sustainable use of grasslands. In the Americas, the Maya and Incas engineered complex irrigation and terracing

systems that maintained soil health and supported high productivity. In Asia, communities like Apatani and Mao Naga, practising traditional rice cultivation in India, displayed a nuanced understanding of hydrology, ecological balance and soil fertility.

These practices were not compartmentalised but deeply intertwined with local ecosystems. Unlike modern scientific knowledge, which often emphasises specialised learning, IKSP is rooted in the understanding that human beings are an integral part of nature, not separate from it. This principle of interdependence shapes the foundational philosophy of the Indigenous communities. The animals, plants, rivers and ecosystems are believed



to possess intrinsic value and a right to exist. Humans, while using nature's resources for sustenance, must also take responsibility for their regeneration and balance. Thus, the human-nature interactions are guided by reverence and coexistence, not extraction and control. However, the process of colonisation led to the sys-

tematic marginalisation of these knowledge systems. Indigenous knowledge was labelled as primitive or superstitious and systematically erased from formal ed-

ucation and policy-making. The dominance of Western cultural practices and modern scientific paradigms contributed to the erosion of traditional knowledge transmission. Industrial farming, large-scale dam projects and Western medicinal practices displaced indigenous approaches in agriculture, water management and healing. In India, the post-independence focus on scientific and industrial development side lined community knowledge in textiles, architecture and common property resource management.

For example, focusing on indigenous water management, Anil Aggarwal and Sunita Narain documented in their landmark work, Dying Wisdom: Rise, Fall and Potential of India's Traditional

Water Harvesting Systems, the diversity of water practices across Indian geographies. From Kundis and Johads in Rajasthan to Kuhls in Himachal Pradesh, these systems demonstrated context-specific, ecologically sound and cost-effective community-led water conservation. They succeeded in delivering water even in the scariest rainfall zones, which is a living testament to their relevance and resilience.

Today, in the face of environmental degradation and climate change, there is a renewed recognition of the value of IKSP. The researchers and policymakers acknowledge that Indigenous communities have long practised sustainability, often in ways that modern science is only beginning to understand. These knowledge traditions offer not only practical solutions but also an alternative worldview prioritising sustainability over exploitation and coexistence over dominance. The collaborative efforts that integrate IKSP with modern scientific approaches can open new pathways. While scientific knowledge brings precision and scalability, indigenous wisdom offers long-term, eco-sensitive perspectives. The revitalisation of the IKSP is thus both an ethical obligation and a necessity for building resilient societies.
