PM TO VISIT TO CHINA AMIDST SHIFTING GLOBAL ALIGNMENTS

Prime Minister Narendra Modi will visit China later this month to attend the SCO Summit, marking a key step in thawing India-China ties.

rime Minister Narendra Modi is set to visit China from 31 August to 1 September to attend the Shanghai Cooperation Organisation (SCO) Heads of State Summit in Tianjin. This marks his first visit to China since the 2020 Galwan Valley clashes, which triggered a deep freeze in bilateral ties and accelerated India's strategic alignment with the United States, as New Delhi sought to counterbalance China's aggression.

The visit comes at a time when India-China relations are gradually normalising after more than four years of military and diplomatic

India slams 'unjust' U.S. tariff hike amid ongoing Russian oil row

In a sharp escalation of trade tensions, India on Wednesday condemned the United States' decision to impose an additional 25 per cent tariff on Indian imports, calling the move "unfair, unjustified, and unreasonable". The response came shortly

after U.S. President Donald Trump signed an Executive Order increasing the total tariff burden on Indian goods to 50 per cent, citing India's continued purchase of Russian oil as the primary

reason. The Indian Ministry of External Affairs (MEA) strongly rebutted the decision, stating that India was being selectively targeted, despite other nations such as China and Turkey also continuing large-scale en-

According to data from the Centre for Research on Energy and Clean Air (June 2025), China accounted for 47 per cent of Russia's crude exports, followed by India (38%), the EU (6%), and Turkey (6%). Meanwhile, Turkey emerged as the largest buyer of Russian oil products, purchasing 26 per cent, ahead of China (13%) and Brazil (12%). Despite these figures, neither China nor Turkey is facing similar

'Mockery of justice': SC slams Allahabad **HC ruling**


On August 4, 2025, the Suincluded barring him from preme Court of India delivered a sharp rebuke to **Iustice Prashant Kumar of** the Allahabad High Court for upholding criminal proceedings in what was fundamentally a civil dispute, labelling the decision a "mockery of justice." The case arose from a commercial transaction that had been wrongly prosecuted as a criminal matter. Justice Kumar had justified the approach by arguing that civil remedies would be too time-

consuming and costly. The Supreme Court bench. comprising Justices J.B. Pardiwala and R. Mahadevan, rejected this reasoning as legally flawed, stressing that criminal law cannot be invoked to resolve civil disputes. The court set aside the High Court's order dated May 5, 2025, remanded the case for fresh consider-

ation by another judge, and imposed strict sanctions on Justice Kumar. These handling criminal cases as a single judge, stripping him of all criminal case assignments until his retirement, and directing him to sit only on division benches under the supervision of a senior judge. This ruling sheds light on

a persistent problem within India's judicial system where civil disputes, such as breaches of contract or property disagreements, are frequently mischaracterised as criminal offences like cheating or criminal breach of trust to exert pressure on the opposing party. Such misuse clogs the criminal justice system, delays genuine criminal cases, and undermines public trust.

The Supreme Court's intervention underscores the need for greater judicial clarity in distin-

Trinamool Congress MPs carried out a protest in the Parliament premises on Wednesday over the alleged insult to Bengal. They held placards that read "Stop Insulting Bengal".

They also held portraits of national icons from Bengal, including Rabindranath Tagore and Subhas Chandra Bose

TMC has been conducting protest marches in West Bengal against the alleged targeting of migrants in the BJP-ruled States. The first such marches were conducted across the State on July 27, after CM Mamata Banerjee had called for protests every weekend until the next year's Assembly polls at a Martyrs' Day rally on July 21.

Mamata has alleged that the National Register of Citizens

(NRC) notices are being issued to legitimate Indian citizens simply because they are from her State. "It is deeply unfortunate that a deliberate, systematic attempt is now being made to criminalise our language. Questions are being raised on whether Bengali is even a language," the CM said in a post on X.

"Bengali-speakers are being hounded, hunted, and humiliated in BJP-ruled states. NRC notices are being issued to legitimate Indian citizens simply because they are from Bengal. They seem to have forgotten that without Bengali, there would be no National Anthem or National Song," she said. Earlier, Mamata accused the Delhi Police of describing Bengali as a "Bangladeshi language", calling it scandalous, anti-national and

unconstitutional.


85% believe that glacier melting is the main reason behind the increasing incidents of landslides and floods.

Do you find the administration's response effective after the cloud burst in Uttarkashi?







A key turning point came during the October 2024 BRICS Summit in Kazan, where Modi and Chinese President Xi Jinping agreed to a complete disengagement from all friction points along the Line of Actual Control (LAC). This led to the 21 October agreement restoring pre-2020 patrolling norms in Depsang and Demchok, including resumed grazing rights and

military withdrawal. Since then, both sides have cautiously resumed structured engagement, with significant steps such as the resumption of the Kailash Mansarovar Yatra, visa reinstatement for Chinese nationals, and renewed backchannel dialogue on investment rules and supply chain frameworks.

According to officials familiar with the summit preparations, the visit "may help lay the groundwork

for a mutual economic calibration between India and China," aimed at addressing long-standing concerns over trade imbalance, market access, and investment safeguards. While no immediate announcements are expected at the summit likely to follow in the near

This visit also comes against the backdrop of record-high bilateral trade, which continues despite ongoing geopolitical frictions. In FY2O24-25, India imported \$113.5 billion worth of goods from China while exporting only \$14.3 billion—resulting in a massive \$99.2 billion trade deficit. This imbalance has been driven primarily by a surge in Chinese electronics, solar cells, and battery imports. In March 2025 alone, India's imports from China jumped over 25% year-on-year to \$9.7 billion, while exports to China declined by 14.5%.

The persistent economic asymmetry has intensified calls within India's strategic establishment for a more balanced and regulated trade framework. Suggestions include local production mandates, market share caps in sensitive sectors, and FDI proposals.

Adding to the complexity, the summit takes place even as the United States, under President Donald Trump, adopts an increasingly adversarial stance toward India. Trump recently lumped India together with China and Russia in a social media post while announcing steep tariffs on Indian goods-despite temporarily pausing hikes for certain partners. Indian officials have described this rhetoric as "deeply unhelpful," especially at a time when New Delhi is managing multiple global partnerships. Beijing, meanwhile, is

subtly de-hyphenate its relationship with India from that of Pakistan, reflecting a recalibrated regional approach. This is particularly significant given China's vocal and material support to Pakistan during Operation Sindoor, while Washington maintained a studied distance—something that has not gone unnoticed in Indian strategic circles.

As reported by this newspaper in its March 2025 piece, "Mutual Need Doctrine: Why India Holds the Cards with China and the US," India's status as one of the world's largest consumer markets gives it unprecedented leverage over both Beijing and Washington. With China grappling with slowing growth and industrial overcapacity, and the U.S. tech sector betting heavily on India's digital economy, New Delhi is uniquely positioned to demand new terms of engagement rather than passively

The process of granting the license places have large Muslim will include security as-populations. Sarma had sessment, verification and vetting, compliance with existing laws, nontransferability and periodic review along with monitoring and reporting, according to the post.

The state cabinet on May 28 had decided that arms licences would be given to indigenous people living in "vulnerable and

remote" areas to instil a sense of security in them. Woman ends life after alleged harassment by husband

and emotionally shattered, Shravya consumed sleeping pills, leading to her death.

Before taking the extreme step, she recorded a selfie video where she emotionally explained that she wasn't speaking to anyone and was deeply hurt by the allegations made by her husband. The video has since gone viral, leaving many viewers in tears.

The deeply emotional visuals showed Shravya pleading her innocence and expressing the mental agony she was going through. Upon learning about her death, Dharmatej rushed to Tadikal from Dubai and broke down beside his wife's body.

Huge crackdown on spurious lifesaving drugs racket

Six persons, including a kingpin, indulged in manufacturing, selling and supplying counterfeit lifesaving drugs/medicine have been arrested, police said.

Police said that the racket has a pan-India network at Moradabad, Deoria, Gorakhpur in UP, Panipat and Jind in Haryana, Baddi and Solan in Himachal Pradesh.

Two factories involved in the manufacturing and packaging of these fake medicines were busted at Jind, Haryana and Baddi, HP.

Counterfeit/fake drugs of reputed companies were recovered in huge quantities, police said.

A major fake drug syndicate operating across multiple states has been busted by the Anti-Gang Squad (AGS) of Crime Branch, Delhi Police, with the arrest of six persons involved in the manufacture, supply and distribution of counterfeit life-saving medicines of renowned pharmaceutical



brands. Acting on the initial input,

on 30 July a trap was laid at the HP CNG Petrol Pump, Shyamnath Marg, Civil Lines, Delhi. A car was intercepted. Two occupants, Mohd. Alam and Mohd. Saleem from Moradabad, UP, were found transporting counterfeit medicines. Representatives of a pharmaceutical company confirmed on the spot that the packaging and stamping were not in accordance with company standards. Lab tests further confirmed the drugs to be

counterfeit, police said. Police further said that coordination was established

with legal representatives and technical experts to verify the authenticity of suspected products on the spot. The operation was initiated through systematic surveillance, followed by strategic interception at a fuel station.

This led to the unearthing of the entire counterfeit medicine racket, which expanded through subsequent raids and custodial interrogations across Uttar Pradesh and Haryana.

Mohd. Alam (35), Mohd. Saleem (42), Prem Shankar Prajapati (25), Parmanand (50) and others have been arrested.

SC SEEKS EC RESPONSE ON BIHAR'S **65 LAKH DELETED VOTERS**

The Supreme Court on . Wednesday asked the **Election Commission** to file its response by August 9 on a fresh application of an NGO seeking disclosure of data of 65 lakh voters who were not included in the Bihar draft electoral roll after **Special Intensive Revision**

Advocate Prashant Bhushan, appearing for an NGO, mentioned the matter before the apex court, saying no specific information has been given on who is dead and who has permanently migrated out.

A bench of Justices Surya Kant, Ujial Bhuyan and N Kotiswar Singh asked the counsel for the Election Commission to furnish the details of deleted voters, the data which has been shared with the political parties, and give a copy to the NGO.

The Election Commission said all requisite information had been given to political parties.

However, Bhushan said that some political parties have been given a list of deleted voters, but they have not further clarified whether the voter is dead or has migrated.

"We will see every voter likely to be affected and get the required information. You (ECI) file a reply by Saturday and let Mr Bhushan look at it, and then we can see what is disclosed and what is not disclosed," Justice Kant

Association For Democratic Reforms, the NGO, which has challenged the June 24 order of the poll panel directing the SIR of electoral rolls in Bihar, now sought direction from the ECI to publish the names of around 65 lakh deleted voters with a mention whether they are dead, permanently migrated or not considered for any other reason.

Bhushan claimed that 75 per cent of voters, who have filled the enumeration form, have not furnished any supporting documents mentioned in the list of 11 documents, and their names were included on the recommendation of the Booth Level Officer (BLO) of the Election Commission.

The apex court said it is starting the hearing on a batch of petitions challenging the June 24 order of the poll panel on August 12, and the NGO can make these averments on that day.

"The application seeks direction for the ECI to publish a full and final assembly constituency and part/booth wise list of names and details of approx 65 lakh electors whose Enumeration Forms were not submitted along with reasons for non-submission (death, permanently shifted, duplicate, untraceable etc.)," the application stated.

It further sought direction "to direct the ECI to publish an assembly constituency and part/booth wise list of electors on the Draft Electoral Rolls published on August 1, 2025, whose Enumeration Forms have been marked "not recommended by the BLOs"."

The top court has fixed the hearing on August 12 and 13 of a batch of pleas challenging the Election Commission of India's move to conduct SIR of electoral rolls in pollbound Bihar.

The petitions challenging the ECI decision were filed by RJD MP Manoj Jha, ADR, PUCL, activist Yogendra Yaday, Trinamool MP Mahua Moitra, and former Bihar MLA Mujahid Alam.

Shah to lay foundation for Sitamarhi's Janki Mandir redevelopment in Bihar

11 months.

Of the total sanctioned amount, Rs 137 crore will be used for the development of the old temple and its premises, while Rs 728 crore has been earmarked for tourism-related infrastructure. An additional Rs 16 crore has been allocated for comprehensive maintenance of the temple complex over the next 10 years. A nine-member trust led by the chief secretary has been formed to oversee the construction and redevelopment of the shrine. The project is envisioned as a major pilgrimage initiative, modeled on the comprehensive development of the Shri Ram Janmabhoomi Tirth Kshetra in Ayodhya.

BJP spokesperson Niraj Kumar said that a large number of pilgrims, both domestic and international, already visit Punauradham, which lies about 5 km west of Sitamarhi town. The planned redevelopment is expected to further enhance its religious and cultural appeal. The cabinet has also approved the appointment of Noida-based firm M/s Design Associates Inc. as the design consultant for the project. The firm was also involved in the master planning and architectural design of the Ram Janmabhoomi temple in Ayodhya.

Tejashwi had two voter IDs, how many did his supporters have: JD(U)

Earlier, Tejashwi Yadav alleged that his EPIC (Electors card he mentioned during his Photo Identity Card) number has been "changed."

Yadav had further raised

concerns over his name missing from the electoral roll, questioning how he would contest the upcoming elections. Despite possessing a valid EPIC number, Yadav claimed that his name could not be traced in the voters' list, sparking allegations of irregularities in the electoral process.

Addressing a press conference in Patna, Yadav had alleged, "My name is not there in the electoral roll. How will I contest the elections?"

Following this, the Electoral Registration Officer in Patna on Sunday asked him to provide the details of the EPIC press conference, so that the matter can be thoroughly investigated.

Forms received from New electors on attaining 18 years of age or above are 19,186.

As per the rules, the claims objections are to be disposed of by the concerned Electoral Registra-



tion Officer/ Assistant Electoral Registration Officer (ERO/AERO) after the expiry of 7 days.

As per SIR orders, no name can be deleted from the draft list published on 1st August 2025, without passing a speaking order by the ERO/AERO after conducting an enquiry and after giving a fair and reasonable opportunity.

(SIR) of electoral rolls in Bihar has sparked a political row, with the opposition INDIA bloc alleging that the revision process could lead to the deletion of a large number of voters. They have been protesting in the Parliament, demanding a discussion over the Bihar SIR, since the start of this year's Monsoon Session.

On Friday, ECI released the draft electoral rolls for Bihar, following the completion of the Enumeration Phase under the Special Intensive Revision (SIR) 2025. It said the public has one month to submit claims and objections, assuring that "no name will be removed from the draft voter list without a stated reason".

Sensex and Nifty fell as investors stayed cautious amid Trump tariff surprises

ndian stock benchmarks oscillated in a narrow range on Wednesday, ending the day marginally lower, highlighting widespread profit booking and cautious investor behaviour amid Trump tariffs uncertainty.

Sensex closed the day at 80,543.99 points, down 166.26 points or 0.21 per cent, while Nifty closed at 24,574.20 points, down 75.35 points or 0.31 per cent.

The RBI monetary policy announcements, largely in line with expectations, had hardly any impact on the markets.

Among the index constituents, Asian Paints and HDFC Life emerged as the top gainers, showcasing relative strength amid broader market weakness.

laggards, contributing to the downside.

"Sectorally, the market breadth was largely negative. Except for Nifty PSU Bank, all other sectoral indices ended in the red. Nifty Pharma and Nifty IT were the worst performers, reflecting selling pressure in defensives and technology stocks," Sudeep Shah, Head - Technical and Derivatives Research at SBI Securities.

"This tight range-bound

movement suggests that traders are awaiting a clear directional trigger before committing to fresh positions," Shah added.

One of the key factors contributing to this cautious sentiment is the anticipation surrounding further details of the ongoing trade negotiations between India and the United States.

"The lack of clarity on this front has kept both investors and traders on edge, leading to subdued volatility and limited price action," Shah of SBI Securities asserted.

According to a recent report by Nuvama, India's equity markets are showing signs of fatigue as stretched valuations collide with slowing profit growth, undermining the country's appeal among emerging markets (EMs).

The benchmark indices have been facing substantial selling pressure at higher levels over the past few sessions, with analysts indicating uncertainty on the India-US new interim deal front, given President Donald Trump is vowing for additional tariffs over and above the already announced 25 per cent.

US tariffs to impact \$8.1 bn of Indian exports: PHDCCI

The US reciprocal tariffs will affect approximately USD 8.1 billion worth of India's exports to the US, while the overall impact on India's economy remains manageable, said an analysis by the Industry body PHDCCI.

Analysis indicates that there will be an estimated impact of only 1.87 per cent on India's total global merchandise exports and a negligible 0.19 per cent on India's GDP as a result of the 25 per cent tariff announced by the US on India.

The study added that the engineering goods could potentially be impacted worth USD 1.8 billion, while electronic goods (USD 1.4 billion), pharmaceuticals (USD 986 million), gems and jewelery (USD 932 million) and readymade garments will be impacted worth USD 500 million.

In a latest development, on August 5, US President Donald Trump once again announced that he would increase the tariff charged on imports from India from the current rate of 25 per cent "very substantially" over the next 24 hours due to New Delhi's continued purchases of Russian oil.



Trump's announcement, made on his social media platform Truth Social, came days after be announced a 25 per cent reciprocal tariff on India and an unspecified penalty for importing oil from Russia.

Trump had said on Monday that the United States will "substantially raise" the tariff paid by India for buying "massive amounts of Russian Oil", stating that much of the oil purchased from Moscow is being sold in the open market "for big profits."

Trump's announcement, made on his social media platform Truth Social, came days after he announced a 25 per cent reciprocal tariff on India and an unspecified penalty for importing oil

Goldman Sachs lowers India's growth rate on US tariff concerns

India's economic trajectory is facing fresh turbulence after U.S. President Donald Trump slapped a 25% "reciprocal" tariff on Indian goods.

In its revised outlook, Goldman Sachs lowered India's real GDP growth projection marginally by 0.1 percentage point for calendar year 2025 (CY25) to 6.5 per cent and by 0.2 percentage point for 2026 (CY26) to 6.4 per cent vear-on-vear.

TRAI issues advisory on fraudulent activities misusing its name ments, forged identities, and falsely using its identity,

The Telecom Regulatory Authority of India (TRAI) has issued an advisory cautioning the public about a rise in cyber frauds and financial scams involving misuse of TRAI's name, the Ministry of Communications said in a release on Wednesday.

These include impersonation of TRAI officials through calls, messages, forged documents, and fraudulent letterheads to threaten or mislead individuals and coerce them into sharing personal information or transferring money. The telecom regulator said

that any such outreach allegedly in the name of TRAI is unauthorised and not associated with TRAI. Citing such incidents, the

telecom regulator said that a prominent example is the so-called 'digital arrest' scam, where callers impersonate TRAI or law enforcement officials and falsely accuse individuals of telecom or financial violations or criminal actions.

Victims are manipulated through fake legal docu- zens about various frauds

threats of arrest or account freezing, and are coerced to transfer money under the pretext of bail, fines, or verification.

TRAI reiterated that it does not initiate communication with customers regarding mobile number disconnection through messages or otherwise.

Mahindra CEO backs Govt amid US tariff row

Mahindra Group CEO and **Managing Director Anish** Shah has expressed confidence in the Indian government's handling of trade negotiations with the United States, stating he is optimistic about a strong and positive outcome for the country from the ongoing dialogue. With just a day left be-

fore US President Donald Trump's proposed 25 per cent reciprocal trade tariffs are set to take effect, tensions have escalated. Trump has intensified his accusations against India, claiming the country is indirectly funding Russia's war in Ukraine through continued purchases of Russian oil. He has warned of the possibility of even higher duties if



India does not comply.

"For us, it is not very material." Shah said when asked about the potential impact of US tariffs on the Mahindra Group, in an interview with PTI Videos

Shah, who heads the USD 25 billion SUVs-to-software conglomerate, emphasised that the Indian government has consistently operated in a manner that keeps the broader national interest in mind, and he remains confident that the issue will be resolved with a favourable outcome.

"Based on everything I've seen our government do, they've always kept the overall interest of India in mind and operated in a way where they can get good solutions. So, I have full confidence that this will be resolved and it will settle down to something that will be a very strong, positive outcome," Shah said.

Indian officials are continuing negotiations with the US in pursuit of a bilateral trade agreement expected by October or November. The higher duties are being viewed as a temporary pressure tactic until a formal pact is reached.

DR. MOHAN BHAGWAT'S DIALOGUE WITH ISLAMIC SCHOLARS: A STEP TOWARD INCLUSIVE REFORM AMONG MUSLIMS

n a significant move toward fostering Linterfaith dialogue and communal harmony in India, Rashtriya Swayamsevak Sangh (RSS) chief Dr. Mohan Bhagwat recently met with prominent Muslim clerics and scholars in Delhi on July 24, 2025. The meeting, held at Haryana Bhawan, brought together senior RSS functionaries and influential Muslim leaders. This engagement has sparked widespread discussion about its implications, not only for Hindu-Muslim relations in India but also has the potential scope for Indian Muslim scholars in leading global Islamic reforms. As countries like Saudi Arabia and the UAE push for progressive changes

within Islam, Indian ulemas

are uniquely positioned to project a more inclusive, tolerant, and cooperative vision of the faith as they have a strong cult all over the world Muslims. However, this vision must address contentious issues such as the intolerance in Islamic teachings, the role of madrassas, and the need for mainstream educational integration to combat radicalism and promote

Bhagwat's outreach to Muslim scholars is a continuation of the RSS's efforts to bridge the communal divide in India, a country with a diverse population where Muslims constitute 14.2% (approximately 172.2 million people) of the population, making India home to the third-largest Muslim community globally. The meeting aimed to promote dialogue between Hindus and Muslims, emphasising the need for reconciliation and mutual understanding for India's progress. The Chief Imam of the All-India Imam Organisation, Dr. Umer Ahmad Ilyasi, described the dialogue as positive, noting that it focused on ending hatred and fostering

unity. This initiative follows previous engagements, such as Bhagwat's 2022 meetings with Muslim intellectuals, which received endorsements from key Islamic bodies like Jamiat Ulema-e-Hind and Jamaat-e-Islami Hind.

The importance of this

meeting lies in its potential

to address longstanding ten-

sions between communities in India, particularly in light of recent incidents of communal discord. By engaging directly with Muslim religious leaders, the RSS, a prominent Hindu nationalist organisation, signals a willingness to move beyond historical mistrust and work toward a shared vision of national unity. The dialogue also reflects a broader recognition that India's diverse society requires collaborative efforts to address social, educational, and economic challenges faced by Muslims because of their orthodox culture. As Niaz Ahmed Farooqui of Jamiat Ulema-e-Hind noted, the Muslim community faces significant backwardness in education and employment, which often takes a backseat to communal issues. Bhagwat's initiative could pave the way for addressing these structural challenges while promoting a narrative of coexistence. Institutions such as Darul Uloom Deoband, the Barelvi movement, and the Tablighi Jamaat, hold significant influence not only within India but also globally. Darul Uloom Deoband,

the world's largest Islamic seminaries and the birthplace of the Deobandi movement, which adheres to the Hanafi school of Sunni Islam. The institution has influenced Islamic education and thought throughout by establishing thousands of madrassas worldwide, from South Africa to Malaysia. The Barelvi movement, founded in 1904 by Ahmed Razi Khan, represents a measure portion of India's Sunni population and emphasises traditional Islamic practices rooted in South Asian culture. The Tablighi Jamaat, founded by Muhammad Ilyas al-Kandhlawi in 1926, is a global missionary

movement focused on estab-

lishing radical Islam based

on Quran & Hadish, with a

strong presence in countries

like Pakistan, Bangladesh,

and South Africa. These institutions have historically played a dual role: spreading Islamic teachings while also influencing in social and political spheres. For instance, Jamiat Ulema-e-Hind, closely associated with Deoband, was a key player in the making of Pakistan. These institutions have also faced criticism for certain fatwas and practices perceived as regressive, such as bans on photography or restrictions on women working alongside men. Seeing this, their global reach positions Indian ulemas to lead reforms that could resonate worldwide, particularly in light of progressive changes

in countries like Saudi Arabia

Saudi Arabia and the UAE have undertaken significant steps to modernise Islamic practices, emphasising inclusivity and moderation. Saudi Arabia's Vision 2030 includes initiatives to curb extremist interpretations, promote women's rights, and foster interfaith dialogue. The UAE has also displayed a vision of "tolerant Islam," exemplified by the Abraham Accords and the establishment of interfaith centers like the Abrahamic Family House, construction of a Hindu Mandir in Abu Dhabi etc. These efforts show that reform within Islam is possible to its coexistence with other communities and civilisations with removing those atrocious and radical values of Islam including women's rights which is almost half of the population, focusing on economic progress, gender equality, and coexistence

with other faiths. Indian Muslim scholars can draw inspiration from these models while leveraging their own tradition. Institutions like Darul Uloom Deoband have already shown openness to reform, such as denouncing terrorism in 2008 and issuing fatwas against practices believed un-Islamic but they have contradicted many times. However, to lead global reforms, Indian ulemas must address contentious theological concepts like jihad, kafir (non-believer), and

Darul Islam (land of Islam),

which critics argue fuel intolerance, division & enmity among communities. These terms are always exploited by extremist groups, whereas contradicted by many, this requires nuanced reinterpretation to align with modern values of equality and coex-

The belief that "almost every terrorist is Muslim" stems believed to-be from a complex interplay of geopolitical, social, and economic factors, but the fact of the matter is its solely religious doctrine. While it is not inaccurate to attribute terrorism to Islam's core tenets, certain interpretations of jihad and the binary of Darul Islam versus Darul Harb (land of war) have been co-opted by radical groups to justify violence. Indian scholars, with their deep understanding of Islamic jurisprudence, can help remove these narratives by emphasising Islam's teachings on peace, justice, and respect for all humanity.

Madrassas, particularly those affiliated with the Deobandi movement, have often been criticised for fostering radical ideologies. Reforming madrassa education can only be possible with removal of those atrocious verses of Quran and Hadith. Without doing so, its critical to countering radicalism and integrating Muslim youth into mainstream society. Incorporating subjects like science, mathematics, and vocational training alongside religious studies can

modern economies, reducing their vulnerability to extremist ideologies.

India's madrassa system is vast, with thousands of institutions educating millions of students. However, their isolation from mainstream education often limits opportunities for Muslim youth, perpetuating cycles of poverty and marginalisation. Initiatives to modernise madrassas, such as those in Uttar Pradesh, have introduced secular subjects, but broader implementation is needed. By aligning with national education standards and promoting critical thinking, madrassas can become centers of holistic learning rather than breeding grounds for divisive ideologies leading to terrorism.

Bhagwat's engagement with Muslim scholars aligns with the RSS's broader goal of nation-building through inclusivity. His meetings underscore the importance of dialogue in addressing communal tensions and fostering a shared identity. By engaging with influential Muslim institutions, Bhagwat is encouraging Indian ulemas to take a proactive role in reforming Islam from within, challenging narratives of intolerance, and promoting equality for women and non-Muslims.

For Indian Muslim clerics to lead global reforms, they must focus on several key

Theological Reinterpretation: Scholars should revisit concepts like jihad and kafir, emphasising their contextual meanings and promoting interpretations that align with peace and coexistence & remove verses which are against a civilised society.

Madrassa Modernisation: Integrating mainstream education into madrassa curricula will empower Muslim youth and reduce the appeal of extremist ideologies.

Interfaith Dialogue: Continued collaboration with organisations like the RSS can build trust and dispel stereotypes, fostering a culture of mutual respect.

Women's Empowerment: Addressing gender disparities within Islamic institutions, inspired by reforms in Saudi Arabia, can enhance Islam's image as a progressive faith.

Global Outreach: Indian ulemas can leverage their institutions' international networks to promote a tolerant and inclusive Islam, countering extremist narratives worldwide.

Bhagwat's meeting marks a pivotal moment in India's journey toward communal harmony and positions Indian Muslim institutions as potential leaders in global Islamic reform. As India navigates its diverse social fabric, such initiatives can pave the way for a more united and progressive future both within the country and on the global stage.

In the vast continuum of international economic relations, there are moments that define not merely the trajectory of trade but the temperament of diplomacy. The recent India-UK Free Trade Agreement (FTA) is one such moment-more than a ceremonial accord, it is a substantive leap forward in how sovereign nations craft mutual prosperity in a multipolar world.

This agreement arrives at a pivotal juncture. India, today, stands on the cusp of monumental economic transformation. Under the governance of Prime Minister Narendra Modi, the country has shifted from being a passive recipient of global investment to a proactive architect of global partnerships. The Make in India, Digital India, and Start up India missions have not only reshaped domestic enterprise but have also positioned India as a formidable player in emerging and advanced sectors alike.

Against this backdrop, the India-UK FTA is not a mere act of liberalisation-it is a strategic handshake between two democracies with shared histories and evolving ambitions. For India, it signals enhanced market access, regulatory easing, and the creation of a framework where goods, services, capital, and-most crucially-ideas

can move freely. Nowhere is the emotional

and intellectual significance of this moment more deeply felt than in the corridors where policy was once only aspirational. I speak here not iust as a commentator but as a participant in this journey. In October 2024, I addressed a conference in the House of Commons, UK Parliament, where I had the privilege of speaking about the future of India-UK bilateral relations by 2030 in the presence of Gareth Bacon, Member of Parliament for Orpington, England. It was there that I passionately articulated the urgency and potential of this trade partnership. I submitted a comprehensive memorandum to both British interlocutors and Indian economists, mapping out specific domains of collaboration-from digital trade and education to healthcare and climate technology.

To now witness the materialisation of that vision, through this meticulously crafted FTA, is not only deeply gratifying but, I dare say, a milestone in India's

economic diplomacy. This FTA has a broad scope and high ambitions. It slashes tariffs on key exports like textiles, engineering products, auto parts, and pharmaceuticals allowing Indian companies to compete on a more level playing field in the

British market. In exchange, the UK gets access to the vast and ever-expanding Indian middle-class economy-now an increasingly sophisticated consumer and an increasingly ambitious and inventive producer.

However, this is where the deal is unprecedented when it comes to services and digital trade. India has a natural associate partner in the UK as they complement in information technology, legal and consultancy services, fintech and telemedicine; and the UK has a complementary regulatory and finance ecosystem. Under the agreement, seamless data flow across borders, mutual recognition of professional qualifications and liberalised visa regimes are a few aspects that provide a playing

field to Indian professionals. This is no small victory. This is indicative of a larger reality: India no longer has a comparative advantage in cheap labour; it has comparative advantage in skilled intellect, regulatory maturity, and technological agility.

In my memorandum, I had identified several sectors that required urgent convergence-education and research, healthcare innovation, defence and security cooperation, climate sustainability, and the globalisation of Ayurveda. Each of these has found resonance in the FTA's framework.

Education and research exchanges in particular-the possibility of British universities establishing collaborations or outposts or satellite campuses in India are now very much on the table. Moving beyond scholarships to well-defined, collaborative research -particularly in

quantum computing, AI, and space sciences.

My suggestion of integrating Ayurvedic systems from India into the UK, as part of collaborative care models possibly through the National Health Service (NHS), is being adopted with exceptional support, and in the healthcare field. As holistic health continues to gain acceptance around the globe, Ayurvedic practices may also be used together with Western systems to relieve some of the burden on public health services, providing preventive and integrative approaches to chronic disease.

In the area of climate, both countries have pledged collaboration on renewable energy projects, transfers of technology, and breakthroughs in electric mobility - all essential to a planet whose health cannot be delegated or deferred.

This moment is not accidental. It is the product of vision, persistence, and strategic maturity. I am proud to have played a modest role in nudging this vision into reality from the floor of the House of Commons to the desks of Indian policymakers.

The India-UK trade deal is not simply a document, it is a statement of intent, a blueprint for transformation, and a symbol of two nations choosing convergence over complacency. As we look ahead to 2030, we are no longer writing a memorandum of hope. We are living its first chapters.

the world. Machli's fame wasn't just romanticized—it brought real value. Tourists from around the globe came hoping to spot her, with estimates suggesting she alone contributed nearly \$10 million annually to the local economy. In 2009, she became the first tiger in India to receive a "Lifetime Achievement Award" from a wildlife tourism body. Guides and forest staff, like Phool Chand who tracked her for ten years, spoke of her as if she were a friend.

So profound was her impact that in her final years, when Machli could no longer hunt, officials took the extraordinary step of feeding her-breaking traditional wildlife norms. The debate it sparked reflected





NAME IN THE WILD— CONFLICTS **AND HUMAN CONNECTIONS**

In India, a number of wild animals have become household names over the years, their lives and legacies entwined with our own. From majestic tigresses to gentle temple elephants, these creatures' personal stories have captured public imagination. And through their names, they have bridged the gap between wildlife and people, influencing everything from school lessons and documentaries to court rulings and conservation policies.

how much she meant to the public. Machli was no longer just a tiger; she was Machli—an individual with a story. Her death brought collective grief but also pride in her legacy. Today, her descendants still roam Ranthambore, and her story lives on in photographs, documentaries, and schoolbooks. More than a tourist attraction, Machli became a bridge between humans and wilderness—reminding us that behind every striped coat is a being with will,

WHEN CONFLICT **MAKES A NAME**

Not all iconic animal stories are comforting tales of triumph. Some, like those of Avni and Ustad, are rooted in tragedy and conflict, exposing the uneasy line between conservation and human fear.

Avni, a tigress from Maharashtra's Yavatmal district, was officially known as T1 by forest officials. But conservationists gave her the name Avni—"Earth" in Hindi-hoping it would humanize her as tensions rose. Between 2016 and 2018, thirteen people were found dead in the forests where she lived with her two cubs. Suspected of being a "maneater," she became a figure of fear for local villagers, and a symbol of injustice for wildlife advocates who questioned the evidence. While courts debated and officials

alive, a final decision was made: to shoot.

In November 2018, Avni was killed at night by a hired hunter, allegedly lured with bait. The operation was swift-and deeply controversial. Critics questioned the legality and urgency of the kill, especially given her status as a mother of young cubs. The cubs were later rescued, but the damage was done. Avni's death triggered national outrage and shone a harsh light on India's weak response systems for human-wildlife conflict. Experts pointed out that similar tigers had been rehabilitated peacefully elsewhere. Her name, once a plea for empathy, became a tragic reminder of how policy can fail when fear overrides science.

A few years earlier, another tiger, T-24 of Ranthambore, had already forced the nation to confront a similar dilemma. Better known as Ustad-"Master"-he was a dominant male who ruled a prime territory and was beloved by tourists and wildlife photographers. But after being implicated in four human deaths, including that of a forest guard, Ustad was labeled dangerous. In 2015, he was captured and sent to a zoo enclosure hundreds of kilometers away.

This decision sparked public fury. Supporters argued the attacks happened within his territory, and that no

struggled to capture her clear evidence proved Ustad had "lost fear" of humans. Protests erupted. Legal battles followed. Ustad's fate became a national debate, culminating in court rulings that kept him confined. He died in captivity in 2022 after suffering health complications.

What united these two stories—Avni and Ustad—was not just their controversial ends, but the public's emotional investment in them. Their names transformed them from wildlife data points into beings people could relate to. Their stories raised important questions: How should we treat animals once the public knows their names? Do laws allow for fairness and compassion once an animal becomes more than just a code?

Avni and Ustad, though gone, remain symbols—of policy gaps, of public consciousness, and of the fragile line between coexistence and control.

NAMES, NARRATIVES, **AND THE HUMAN** CONNECTION

Why do some wild animals get names while others remain anonymous, counted only as numbers in census reports or research logs? And when we do name them, what does it really change?

In wildlife conservation, naming an animal isn't just a sentimental act-it's a profound ontological shift.

The moment we call a tiger Machli, a lion Cecil, or an elephant Arikomban, the creature steps out of abstraction and into character. No longer just a data point or a species symbol, they become individuals—with stories, struggles, and sometimes, followers. This transformation matters deeply. It shapes how the public sees them, how policymakers react, and how conservation

itself evolves. Naming has the power to stir empathy. Studies have shown that humans are more likely to support the protection of individual animals when they know their names and backstories. *Machli*, the famed tigress of Ranthambore, became a global icon not only because of her beauty and strength, but because people knew her name, her cubs, her territory, even her old age struggles. Millions followed her updates online, unknowingly learning about tiger biology, habitat threats, and the economic value of ecotourism. Her fame brought in millions of rupees to the local economy, and arguably played a role in influencing Project Tiger's public support.

Similarly, Arikomban, the rice-loving elephant of Kerala, didn't just evoke curiosity; he ignited conversations about humanelephant conflict, forest fragmentation, and the ethics of translocation. His name, meaning "rice tusker," captured the imagination of both villagers and city dwellers. Media frenzy and public sentiment swayed political decisions. People demanded that he be relocated safely rather than killed. That attention. arguably, saved his life.

This phenomenon isn't unique to India. Globally, names have transformed animals into ambassadors. Cecil the lion, studied for years in Zimbabwe, was killed by a trophy hunter in 2015. His death, because he had a name and a backstory, sparked global outrage and led to real policy changes-airlines refusing to transport hunting trophies, governments rethinking wildlife tourism. Sudan, the last male northern white rhino, became the face of extinction when he died in 2018. His name made people care. His story spurred investment in advanced technologies to preserve his species. But naming can be a dou-

ble-edged sword. In Assam, an aggressive wild elephant was dubbed Laden, invoking fear and demonization. Officials later tried to rename him Krishna, hoping to change public perception, but the damage was done. He died in captivity, a victim of both public panic and misplaced symbolism. Names, after all, reflect how we see animals—as friends, foes, or something in between.

too much on named individuals distorts conservation priorities. What about the less charismatic species the frogs, the snakes, the moths—that don't get cute names or headlines? Others warn against anthropomorphism. In Arikomban's case, experts cautioned that emotional responses driven by his name created unscientific pressure on the forest department, forcing action under public glare rather than long-term planning. Wildlife veteran P.S. Easa even suggested that naming conflict elephants might create "unnecessary emotions" that obstruct pragmatic solutions.

Critics argue that focusing

These concerns are valid. Yet, so is the counterpoint: people fight to save what they love, and love often begins with a story. A name anchors that story. It allows children to write essays, artists to draw, activists to protest, and ordinary citizens to care. Machli, Arikomban, Avni, Ustadthey are not just names; they are emotional entry points into larger ecological realities.

In India's long journey of conservation, named animals have often sparked the biggest conversations. The golden jubilee of Project Tiger in 2023 was not just about forests—it was about icons like Machli who turned silent wilder-

nesses into places of pride. The public outrage that followed Avni's killing or Ustad's capture wasn't just for a tiger—it was for that tiger, one with a name, a personal-

ity, and a story. And therein lies the quiet power of a name. It turns "a tiger" into this tiger. It converts anonymity into individuality. In doing so, it demands that we pay attention—not to the species alone, but to life, the narrative, the right to exist.

When we remember Arikomban, Machli, or Cecil, we are not just reminiscing about wild animals—we are honoring a moment when our moral compass stretched to include them. Their names remind us that the fight for conservation is not just statistical; it is personal. And in that personal memory, perhaps, lies our best hope for a more compassionate coexistence.

Naming in Indian Cultural and Religious Context

India's relationship with named animals is rooted in its spiritual traditions. Elephants are sacred in Hinduism-symbolized by Lord Ganesha—and temple elephants like Guruvayur Keshavan are given names, rituals, and reverence. Cows, monkeys, snakes, and peacocks also hold divine associations and are often personified. Even crocodiles like Babiya in Ananthapura are honored protectors. Mythology and oral traditions have long assigned animals names and destinies, blurring the line between story and reality.

Why Named Animals Matter Most in Danger

Names gain power in moments of danger. When animals like Avni or Ustad are labelled threats, the name personalizes the conflict. Conversely, when vulnerable icons like Machli or Arikomban face harm, public empathy surges. A name turns an ecological issue into a narrative—one people remember, debate, and act on.

From the colorful Bandhani of Jodhpur to the intricate Kota Doria of Kota, and the robust woolen weaves of Bikaner, Rajasthan's handloom legacy is a story of tradition, resilience, and timeless beauty.

A HISTORICAL WEAVE: **ROOTS IN TRADITION**

One of the most iconic textile traditions of Rajasthan, Bandhani involves a complex tie-dye technique. The fabric is tied in intricate patterns using threads made up of small dots and circles, often arranged in floral or geometrical motifs.

Popular in cities like Jaipur, Jodhpur, Udaipur, and Sikar, Bandhani is used for turbans, sarees, dupattas, and ghagras. Red, yellow, green, and blue dominate the palette, with each color and pattern often associated with specific occasions such as weddings or festivals. The art is usually a community activity, passed down through generations, especially among women

2. KOTA DORIA: **A DELICATE**

What makes Kota Doria special is the handloom technique employed by the Ansari weaver community, who migrated to Rajasthan centuries ago. Today, efforts by various NGOs and government bodies have helped revive and promote this art, enabling it to compete in global markets.

DOZENS KILLED SEEKING AID IN GAZA AS ISRAEL **CONSIDERS FURTHER MILITARY ACTION**

t least 38 Palestinians were killed overnight and into Wednesday in the Gaza Strip while seeking aid from United Nations convoys and sites run by an Israeli-backed American contractor, according to local health officials. The Israeli military said it had fired warning shots when crowds approached its forces.

The latest deaths came as Prime Minister Benjamin Netanyahu was expected to announced further military action — and possibly plans for Israel to fully reoccupy Gaza. Experts say Israel's ongoing military offensive and blockade are already pushing the territory of some 2 million Palestinians into famine.

Another escalation of the nearly 22-month war could put the lives of countless Palestinians and around 20 living Is-

tion of Gaza, said he wasn't aware of the "suggestion" but that "it's going to be pretty much up to Israel."

Pakistan starts deporting registered Afghan refugees, says UNHCR

Pakistan has started to deport documented Afghan refugees ahead of its deadline for them to leave, according to the United Nations, in a move that could see more than 1 million Afghans expelled from the country.

The United Nations High Commissioner for Refugees said that it had received reports of arrests and expulsions of legally registered Afghans across the country before Pakistan's September 1 deadline for them to leave.

The UNHCR said that sending the Afghans back in this way was a breach of Pakistan's international obligations.

"UNHCR is calling on the government to stop the forcible return and adopt a humane approach to ensure voluntary, gradual, and dignified return of Afghans," it said in a statement.

The voluntary return of the documented refugees shall commence forthwith, said a Pakistan's interior ministry order seen by Re-

"Today, August 5, marks the second anniversary of the incarceration of former prime minister Imran Khan with all basic human rights revoked, no or very limited access to his legal team or family, no access to his political leadership other than

Bukhari, who is the spokesperson of Khan for international relations as well as international media, said the government has imposed a ban on gatherings, blocking main highways, wrecking cars with party flags and raiding the residences of active party leaders and work-

"What makes this event notable is that chikungunya has never been established in mainland China before," Lopez-Camacho said in a statement. "This suggests that most of the population had no preexisting immunity, making it easier for the virus to spread quickly."

Authorities also have threatened to fine people who don't empty water from outdoor receptacles. Residents can be subject to fines of up to 10,000 yuan (\$1,400) and have their electricity cut off.

Because of the virus, the U.S. has issued a travel advisory suggesting that Americans take extra precautions when visiting China's Guangdong province, where Foshan is located, as well as Bolivia and some island nations in the Indian

Since the 2003 SARS outbreak, China has used strict measures to fight the spread of viruses, including hard-line tactics during the COVID-19 pandemic. This time, patients are being forced to stay in hospital in Foshan for at least one week and authorities briefly enforced a two-week home quarantine, which was dropped because the disease cannot be transmitted between people.

Reports also have emerged of attempts to stop the spread of chikungunya with fish that eat mosquito larvae and even larger mosquitoes to eat the insects carrying the virus.

Pakistan will not develop closer ties with US at the cost of China: Experts

Trump has ramped up his country's ties with Pakistan, China's all-weather ally, Chinese strategic experts say Islamabad understands the limits given his strategy to contain Beijing's global influence. Last month, Pakistan's army chief, General Asim Munir, made his first official visit to China since assuming office as field marshal. His visit came shortly after a rare five-day trip to Washington, where he attended a private luncheon with Trump. That meeting culminated in Trump's announcement of enhanced US-Pakistan cooperation in various fields, including an



According to a recent "Economist" article, the outcome of General Munir's US visit marks a shift in American foreign policy, with implications not only for India but also China and the Middle East.

During his time in Beijing, General Munir met with Vice President Han Zheng, Foreign Minister Wang Yi and senior members of the People's Liberation Army (PLA), though not with President Xi Jinping. This contrasts with his predecessor, General Qamar Javed Bajwa, who met Xi during his 2018 trip to China.

While official readouts from Munir's meetings emphasised diplomatic niceties and reiterated strong bilateral ties, Beijing's perception of the Trump-Munir rapport remains unclear -- especially given Trump's overt strategy to curb China's rise as a global power.

Beijing has its concerns considering the decadeslong investment fostering an all-weather relationship with Pakistan.

Two Chinese senior strategic experts PTI spoke to outlined for the first time China's view on the emerging new Washington-Islamabad strategic paradigm in the broader context of Trump's geopolitical strategy.

"Pakistan will not develop its relations with the US at the cost of its relation with China," Hu Shisheng, Director of the Institute for South Asian Studies at the China **Institutes of Contemporary** International Relations. said.

"Pakistan will not be that easily hooked by Trump,"

Hu, regarded as an expert on South Asian politics, said.

Jesse Wang, a research fellow at Huaxia South Asia Economic and Cultural Exchange Centre of China, said "on the surface, Trump's candy to Pakistan looks like a disturbance to China, but actually, cannot affect the structural stability of the Sino-Pak relationship".

"The US intervention has created short-term geopolitical noise but is unlikely to shake the foundation of China-Pakistan dependence," he said.

"For Pakistan, 'make profits both ways' economically is a rational choice, but its security and infrastructure lifelines are tied to China closely, and the strategic balance has not tilted," Wang

Hiroshima marks 80 years since atomic bombing with global call for nuclear disarmament

Thousands gathered in Hiroshima on Wednesday to mark the 80th anniversary of the world's first wartime use of a nuclear bomb, as survivors, officials and representatives from 120 countries and territories renewed calls for global disarmament, Al Jazeera reported.

On August 6, 1945, the United States dropped a uranium bomb, codenamed Little Boy, over

city, killing roughly 78,000 people instantly. Tens of thousands more died by the end of the vear from burns and radiation exposure. Three days later, Nagasaki was hit with a plutonium bomb, leading to Japan's surrender on August 15 and the end of World

the western Japanese

War II. At Hiroshima's Peace Memorial Park, located almost directly beneath the detonation site, delegates from a record number of international

countries and regions attended the annual memorial.

Reporting from the park, Al Jazeera's Fadi Salameh said, "The ceremony procedure is almost the same throughout the years I've been covering it. It starts at eight o'clock with the children and people offering flowers and then water to represent helping the victims who survived the atomic bombing at that time. Then at exactly 8:15... a moment of silence. After that,



the mayor of Hiroshima reads out the declaration of peace in which they call for the abolition of nuclear weapons around

the world.

School children from across Japan read the "Promise of Peace," delivering statements of hope and remembrance. The ceremony also featured a message from the representative of UN Secretary-General Antonio Guterres, urging global peace, Al Jazeera reported. Hiroshima Mayor Ka-

zumi Matsui warned of "the dangers of rising global militarism," criticising leaders who insist nuclear weapons are essential for national security. "Among the world's political leaders, there is a growing belief that possessing nuclear

weapons is unavoidable in order to protect their own countries," he said, adding that the United States and Russia still hold 90 percent of the world's nuclear warheads.

"This situation not only nullifies the lessons the international community has learned from the tragic history of the past, but also seriously undermines the frameworks that have been built for peace-building. To all the leaders around the world: please visit

Hiroshima and witness for yourselves the reality of the atomic bombing." Survivors of the

bombings, known as hibakusha, once faced discrimination due to unfounded fears of disease and genetic effects. Their numbers have now fallen below 100,000 for the first time.

Japan maintains its commitment to nuclear disarmament but remains outside the UN treaty banning nuclear weapons, according to Al Jazeera.

"It's too early, obviously, to talk about it, but certainly he's doing a great job," Trump

"And he would be probably favored at this point."

Trump also floated the idea of Vance teaming up with Sec-



retary of State Marco Rubio to create a formidable Republican ticket.

"I think Marco is also somebody that maybe would get together with JD in some form," Trump said.

Trump has suggested serving another term several times, despite the US Constitution limiting presidents to

Russia has struck a gas pumping station in Ukraine's southern Odesa region used in a scheme to import LNG from the U.S. and Azerbaijan, undermining preparations for winter, Ukrainian officials said on Wednesday.

President Volodymyr Zelenskiy said the gas infrastructure had been attacked in the village of Novosilske on the border with Romania, where the Orlovka interconnector, through which Ukraine receives gas via the Transbalkan route, is lo-

"This was a deliberate blow to our preparations for the heating season, absolutely cynical, like every Russian blow to the energy sector," Zelenskiy said on Telegram.

Reuters could not independently confirm details of the attack.

Russia's TASS news agency quoted the Russian defence ministry as confirming the attack on Ukraine's gas transport system.

Ukraine has faced a serious gas shortage since a series of devastating Russian missile strikes this year, which significantly reduced domestic

production. Ukraine's energy ministry said in a statement that the attacked station was used as part of a route connecting Greek LNG terminals with Ukrainian gas storage facilities via the Transbalkan gas pipeline.

It noted that it had already been used to deliver LNG from the United States and test volumes of Azerbaijani gas. "This is a Russian strike purely against civilian infrastructure, deliberately

The historian and author used his swearing-in speech to parliament to make his position clear: "No to illegal immigration, no to the euro.

Nawrocki's election campaign was marked by a rise in nationalist rhetoric and repeated criticism of Ukrainian refugees living in Poland. His victory has unsettled many at home and abroad.

Russia arrests man accused of passing satellite secrets to US

A man accused of passing Russian satellite secrets to the United States has been arrested for suspected treason and placed in pre-trial detention, a court in the Russian city of Kaliningrad said on Wednesday.

The court, in a statement on Telegram, identified the suspect only as "O" and said action.But cooperation he was a former employee of a company producing electronic engines for space satellites. It said he was suspected of

collecting and storing information about the firm's technology on behalf of U.S. intelligence services between July 2021 and December 2023. The man was placed in detention until September 30, the court said.

'No self-imposed ban on intermediate-range missiles'

Russia has declared that it no longer considers itself bound by a self-imposed moratorium on the deployment of nuclear-capable intermediate range missiles, a warning that potentially sets the stage for a new arms race as tensions between Moscow and Washington rise again over Ukraine.

In a statement Monday, the Russian Foreign Ministry linked the decision to efforts by the U.S. and its allies to develop intermediate



range weapons and preparations for their deployment in Europe and other parts of the world. It specifically cited U.S. plans to deploy Typhoon and Dark Eagle missiles in Germany starting next year.

The ministry noted that such actions by the U.S. and its allies create "destabilizing missile potentials" near Russia, creating a "direct threat to the security of our country" and carry "significant harmful consequences for regional and global stability, including a dangerous escalation of tensions between nuclear powers."

It didn't say what specific moves the Kremlin might take, but President Vladimir Putin has previously announced that Moscow was planning to deploy its new Oreshnik missiles on the territory of its neighbor and

ally Belarus later this year. Asked where and when Russia could potentially deploy intermediate-range weapons, Kremlin spokesman Dmitry Peskov said that it's not something to be announced in advance.

"Russia no longer has any limitations, Russia no longer considers itself to be constrained by anything," Peskov told reporters. "Therefore Russia believes it has the right to take respective steps if necessary."

"Decisions on specific parameters of response measures will be made by the leadership of the Russian Federation based on an interdepartmental analysis of the scale of deployment of American and other Western land-based intermediate-range missiles, as well as the development of the overall situation in the area of international security and strategic stability," the Foreign Ministry said.





No, AWD or 4x4 isn't offered. If you want an all-wheel-drive Tata SUV, then you'll have to go with the electric Harrier QWD. The traditional-fuel Harrier and Safari still continue to be two-wheel-drive vehicles.

What the Adventure variants give you is a lot of features at a starting price of Rs. 18.99 lakh for the Harrier, and Rs. 19.99 lakh for the Safari. All prices mentioned on this page are exshowroom. Please note that although Tata was kind enough to invite me to the launch, I couldn't make it due to prior commitments, (AT), 360° HD Surround so all information in this

story is totally based on Auto Hold, Trail Response my understanding of their superfluous (as is the norm with almost every manufacturer) press release.

WHAT IS THIS ADVEN-**TURE PERSONA?**

From what I could make out, it essentially comprises three variants in total: two for the Harrier and one for the Safari. So, while the Harrier gets Adventure X and Adventure X+ variants (Rs.18.99 lakh and Rs. 19.34 lakh, respectively), the Safari sees an addition of only the Adventure X+ (Rs. 19.99 lakh) variant. India's AI healthcare tools are stuck in pilot mode. What will it take to scale?

DR SABINE KAPASI

India's hospitals are teeming with artificial intelligence demos: slick presentations, promising pilots, and neatly packaged tools. But in practice, most of these innovations remain confined to labs, research papers, or isolated pilot sites. According to the Economic Survey 2024-25, while 34% of healthcare organisations in India were experimenting with AI in 2023, only 16% had successfully operationalised even one tool in routine care.

The World Economic Forum estimates that AI could unlock \$1 trillion in economic value for India by 2035. Yet, that future is slipping out of reach. Without clear pathways from pilot care risks becoming a highpotential idea permanently stuck in the trial phase.

AI WAVE IN INDIA

Across India, a range of AIdriven tools are being tested in clinical settings, often with impressive results in limited deployments. Some notable examples from the past 2-3 years include Qure.ai's chest X-ray algorithm, which already analyses approximately 60,000 scans each month across 25 states, automatically flagging roughly 16,000 suspected tuberculosis cases for review. Rajasthan has

integrated a similar AI model into its Silicosis Portal, enabling district boards to certify miners' lung damage more quickly. These tools reduce diagnosis time to minutes and cost a fraction of the cost of specialist interpretation. Yet, they remain exceptions, not the Cardiology offers a sec-

ond glimpse. Maharashtra's state-run STEMI programme links rural hospitals to cardiologists via Tricog's AI ECG platform. In three years, the network has recorded more than 150,000 ECGs, flagging over 3,500 critical heart attacks within ten minutes, an intervention window that often decides life or death. In oncology, Niramai's Thermalytix breast scan is now to scale, AI in Indian health- available in over 200 hospitals and camps, providing radiation-free early detection at a fraction of the cost of a mammogram. While both pilots have proved their point, neither has a clear nationwide path.

CHALLENGES TO

SCALE Despite high interest and clear potential, systemic hurdles are keeping AI health tools in a state of "pilot purgatory." Several key

challenges have emerged: Firstly, India still has no dedicated rulebook for learning algorithms. ICMR's 2023 ethical guide-



lines are advisory, so hospitals remain unsure how to validate or monitor an evolving model or who is liable if it errs. The result is paralysis: innovators stay in "research" limbo, and purchasers hesitate to sign long-term deals.

Secondly, AI interpretations are exempt from tariffs under Ayushman Bharat or private insurance, leaving hospitals unable to bill for them. A 2023 APAC-Med paper warned that without reimbursement codes, digital health solutions will never reach scale. Maharashtra temporarily buys ECG reads out of its state budget, yet few states can replicate that stop-gap.

Thirdly, many doctors still baulk at "black-box" models trained on data they have never seen. The Economic Survey 2024-25 also flags a shortage of hybrid talent that understands both medicine and machine learning. Fewer than one in four pub-

lic hospitals have fully digi-

tised records, so integrating an AI tool can take longer than writing the algorithm itself.

AN ESCAPE PLAN

Moving from pilot projects to nationwide adoption will require coordinated action on multiple fronts.

Firstly, the Parliament should create a fast-track "software as medical device" pathway with tiered risk classes, annual postmarket audits and explicit liability norms. A national AI sandbox, overseen by CDSCO and NITI Aayog, can let innovators prove safety on live data while regulators watch.

Secondly, Ayushman Bharat can pioneer bundled payments for approved AI screenings that prevent more costly treatment downstream. Once the public paver recognises an AI readout, private insurers will follow, converting pilots into revenue-supported

Thirdly, the Indian Medical Association could accredit AI training modules and establish a public registry of validated models, along with their corresponding accuracy scores. Hospitals should appoint "digital residents", i.e., young doctors trained in data science, to serve as translators between code and clinical teams.

Fourthly, we can pair the

ABDM health-ID rollout with a sovereign, anonymised imaging and ECG cloud that lets approved start-ups train on diverse Indian datasets while preserving privacy. Strong governance, combined with broad access, will make algorithms more effective and cost-efficient.

Lastly, we should invest in designs for the last mile. Co-create voice-based AI apps with ASHA workers, embed usage incentives in their payment schedules, and localise interfaces for dialect and offline use so tools work where physicians are scarce.

India doesn't lack talent or technology; it lacks the connective tissue to scale up good pilots to a national level. The solutions exist, but they require urgency, coordination, and, above all, trust in systems that allow innovation to thrive responsibly. If implemented well. AI can democratise healthcare, empower frontline workers, and close the urban-rural care divide.

As Thomas Edison once said, "The value of an idea lies in the using of it." It's time India stops testing and starts trusting its AI breakthroughs, at scale, for all.

Five years on: Centre for civil society hosts webinar on NEP chapter 8, policy, practice, and School Governance

July 31, 2025, The Centre for Civil Society, a nonprofit think tank that advances social change through public policy, hosted the webinar to unpack India's school governance architecture and how it can be transformed to reflect the National **Edcuation Policy (NEP)** 2020's vision of decentralisation, functional clarity, and institutional autono-

The webinar was moderated by Dr. Amit Chandra, CEO, Centre for Civil Society. The panellists included: Mr. Gurucharan Das. public intellectual and author, Mr. Kapil Khurana, Central Square Foundation, Prof. Geeta Gandhi

lege London, Dr. Leena Chandran Wadia, The University of Trans-Disciplinary Health Sciences and Technology, Prof. Pranati Panda, National Institute of Educational Planning and Administration. Dr. Chandra began the

Kingdon, University Col-

session by anchoring the discusssion in chapter 8 of NEP, underscoring the reforms in both style and functions of educational governance, Mr. Gurucharan Das delivered a philosophically and morally centered keynote address, noting that "governance must serve the child, not the system". He traced the evolution of educational governance in India, emphasizing the moral purpose of schooling, the imperative of autonomy and accountability in governance, and need for reduced state control while ensuring equity. Dr. Leena Wadia focused

on the design of school complexes, bringing attention to how they allow the sharing of resources, especially in rural areas while highlighting the role of school leaders and cluster-level autonomy, and warning against overcentralizing. "Autonomy at the complex level must be protected. These structures are intended to empower, not add another bureaucratic layer." she remarked.

Prof. Geeta Gandhi Kingdon delved into a comparative and evidence-based overview, emphasized on




performance-based accountability rather than compliance. She said, "India needs to move towards a light-but-tight regulatory model, and Chapter 8 explicitly acknowledges this need."

She illuminated the conflict of interest that arises when a single body plays multiple roles - operator, regulator, and assessor and advocated for the separation of powers between policymaking, regulation,



operations, and assessment. She also stressed the need for independent school evaluation boards.

Mr. Kapil Khurana, addressing ground-level implementation, shared insights underlining the urgent need to revise state-level education acts in alignment with NEP, and observed, "Real reform happens in statelevel education rules. NEP gives the vision, but states have to enable it." He also



discussed the problem of overlapping authorities between DIETs, SCERTs, and Directorates, highlighted CSF's partnership with states to pilot school complex models, and called for coordination mechanisms and technical assistance cells to support in NEP implementation.

Prof. Pranati Panda focused on teacher professional development and institutional governance. While emphasizing the



need for a transparent recruitment and career progression system, she called for stronger academic leadership at both the school and cluster levels, and observed, "The NEP rightly shifts the discussion from inputs to outcomes, but outcomes are a function of governance quality."

Before wrapping up the session, Dr. Amit Chandra summarized the key consensus points: The ur-



gency of regulatory reform to enable the NEP vision | The importance of structural clarity and functional autonomy | The role of research, outreach and collaborative implementation.

He concluded with a key remark - "Our job now is to hold the system accountable to NEP 2020's spirit, especially Chapter 8, which rightly places governance at the heart of education reform."

17 Indian athletes to compete in World Games 2025

NEW DELHI

For the World Games 2025, which will be held in Chengdu, People's Republic of China, from August 7-17, India has sent a squad of 17 members, according to Olympics.com.

This is the 12th edition of the World Games, a quadrennial competition for sports not in-

cluded in the Olympics. Running since 1981, the multi-sport event typically takes place a year after the Olympics. The 2025 World Games will feature 253 medal events across 34 sports and 60

disciplines, with powerboating

and cheerleading making their debuts at the quadrennial meet. However, India will be rep-

resented in 23 medal events throughout five sports: billiards, archery, racquetball, roller sports or skating, and wushu.

Many medal winners from the 2023 Asian Games in Hangzhou are among the members of the Indian World Games team that will travel to Chengdu. The list includes archers Abhishek Verma and Parneet Kaur, speedskaters Velkumar Anand Kumar and Aryanpal Singh Ghuman, as well as wushu athlete Naorem Roshibina Devi.

Will Siraj's yorker that dismissed Atkinson get same respect as MS Dhoni's six?

Siraj proves to be even more dangerous without Bumrah, yet his workload rarely gets the attention it deserves. With performances like these, he's no longer just the 'Hyderabad Express', he's truly become Hamara Sirai.

Whenever Indian fast bowling is talked about, it is especially Jasprit Bumrah's workload management that gets attention, but Mohammed Siraj is rarely mentioned in this regard. The truth is, in the last two years, he has bowled the most number of overs (524) in Tests and has taken the most number of wickets after Bumrah. In

the India-England series, he bowled the most overs (185.3) among both teams and took the most wickets (23). According to Cricviz, Siraj bowled 1,118 balls during 47 spells in this series. Not a single ball among these was at a speed less than 131 kmph. The decisive ball with which he got Atkinson out and helped Team India level the series was also at the speed of 143 kmph-that is, his fifth fastest ball of the series.

SIRAJ'S WORKLOAD

The question is whether there is no need to manage his workload today. Siraj has also said that he has

team, Siraj compensates with his striking ability. This is the reason why from Gaba (Brisbane) to Birmingham and then the Oval, he played an important role in winning all these three matches by bowling brilliantly without Bumrah. His role and partner have changed every time. While T Natarajan was his partner in Brisbane, he got good support from Akashdeep's seam bowling. Similarly, in the Oval, he got good support from Prasidh Krishna's seam bowling.

BIG CHANGE IN

The big change in Siraj's bowling is that now he not only focuses on his own bowling but also reads the batsman's mindset very well. While bowling continuously outside to Jacob Bethell, he bowled one ball inside—and that too on a yorker length. Similarly, he bowled Zak Crawley, who was continuously playing behind square leg, on the same yorker length. While bowling continuously outside to Smith, he brought the ball in on a short ball, due to which Smith had to go outside. He also set up Overton and got him out.

MOST WICKETS IN AWAY WINS

Now Siraj knows how

to take wickets not only with the new ball but also with the old ball, which he showed at the Oval. He is the third player after Vinoo Mankad and Kapil Dev to have played three overseas series of five Test matches. He has taken 104 wickets in 27 away matches. Not only this, he also holds the Indian record for taking the most wickets in away

match wins. Siraj played a major role in Team India's historic victories in Melbourne, Brisbane, Lord's, Mirpur, Cape Town, Perth, Birmingham, and the Oval. He took nine wickets at the Oval, eight at Lord's (2021), seven each at Cape Town, Mirpur, and Birmingham, six at Brisbane (Gaba), and five each at Melbourne and Perth. His bowling became a synonym for fear in the Cape Town Test, where South Africa's first innings collapsed for 55 runs with

his six wickets. His late swing and seaming balls became the centre of attraction in this innings. Similarly, he became unplayable after taking three wickets in the second innings of Perth.

A YORKER WORTHY **OF LEGACY?**

Today, Siraj's nip-backer

balls are proving to be the most dangerous. When he brings the ball in with the vowel seam, Harry Brook and Joe Root have no answer to it. He has also troubled Ollie Pope with such balls. Siraj's father was once an auto-rickshaw driver. He has seen struggles closely since childhood. That is why he never hesitates to capitalize on any opportunity given by the country.

Now everyone is calling him 'Hamara Siraj'. 'Hyderabad Express' has become an old metaphor. Cricket legends are counting the series that equalled the historic victory of the Oval Test as one of the most memorable series in Test history.

In such a situation, it is natural to raise the question-will Siraj's yorker that dismissed Atkinson get the same respect as MS Dhoni's six in the 2011 World Cup?
