Across northern India, the Army, BSF and state authorities remain on high alert, battling relentless monsoon fury that has triggered evacuations, rescues and wide-

Gurdaspur and Ajnala, treating more than 900 residents over two days. The highest numbers were reported at Gurdwara Chaharpur in Ajnala (350 people) and Jagdev Khurd (319). Free medicines and health checkups were provided to border villagers left without access to healthcare. Officials said the relief effort, launched under Union Home Ministry directives, will continue

Prime Minister Narendra Modi on Thursday hailed the sweeping Goods and Services Tax reforms as a "double dhamaka" ahead of Diwali and Chhath Puja, calling them a decisive step to strengthen India's economy and ease compliance. The new two-slab structure of 5 and 18 per cent, with a separate 40 per cent rate for luxury and sin goods, will take effect on 22 September, the first day of Navratri.

"The new reforms will bring tremendous benefits to every family in the country. The poor, middle class, women, students, farmers and youth — everyone will gain," Modi said, highlighting the removal of GST on health and life insurance and steep cuts on essentials and medicines. He called GST 2.0 a "double dose of support and growth".

Congress media and publicity department chairman Pawan Khera said a government that won by "vote milawat" is now running the country on "fuel milawat". "After implementing 'vote chori', the biggest fraud on the Indian people, they are now implementing petrol chori. The latest being the E-20 policy to extort mon-

Targeting Union Road Transport and Highways Minister Nitin Gadkari, Khera alleged a conflict of interest, claiming his sons profit from ethanol companies even as he drives the policy. "Cian Agro Industries Infrastructure Ltd, owned

by Nikhil Gadkari, and Manas Agro Industries, linked to Sarang Gadkari, are key players in the ethanol business," he said, pointing out that Cian Agro's revenue surged from Rs 18 crore in June 2024 to Rs 523 crore a year later, with its stock price

jumping over 2,100 per cent. Khera recalled that in 2018 Gadkari promised ethanol production from wood waste and municipal refuse, predicting fuel would drop to Rs 50-55 a litre. "Not a drop has come from those sources and petrol has only become costlier," he said. Petrol prices have risen from Rs 71.41 in 2014 to Rs 94.77 in 2025, while diesel

Terror funding case: SC refuses interim bail to Kashmiri separatist

The Supreme Court on Thursday declined interim bail to Kashmiri Separatist Leader Shabir Ahmed Shah in a terror funding case.

A bench of Justices Vikram Nath and Sandeep Mehta also issued notice to the NIA and sought its response in two

Shah has approached the top court, filing an appeal against the Delhi High Court's June 12 order, which denied him bail in an alleged case of terror funding.

Senior advocate Colin Gonsalves, appearing for Shah, sought interim bail, saying that he was very sick. However, the bench refused to grant him interim bail and posted the matter for hearing after two weeks.

Observing the possibility of Shah carrying out similar unlawful activities and influencing witnesses couldn't be ruled out, the High Court refused to grant him bail in

He further argued that despite approaching the Delhi Police and senior officers with a complaint, no action was taken, leaving the petitioner with no option but to approach the court. The plea, therefore, seeks a direction for registration of an FIR and investigation into the alleged offences.

The complaint also relies on a 1985 Allahabad High Court judgment in Rakesh Singh vs Sonia Gandhi, which had examined the issue of her citizenship in the context of an election petition. While the court had then held that she became an Indian citizen on April 30, 1983, by registration, the present plea argues that any voter enrollment prior to that date was illegal.

The petitioner has urged the court to direct the police to investigate, requisition records, and examine the documents submitted to the Election Commission during that period. The court will take up the matter again on September

SC expresses concern about floods in Himalayan states

The Supreme Court on Thursday expressed serious concern about the floods in Himachal Pradesh, Uttarakhand, Jammu and Kashmir and Punjab and observed that there is illegal felling of trees in the hills.

A bench of Chief Justice of India (CJI) BR Gavai and Justice K Vinod Chandran said it was a serious matter while referring to videos of vast numbers of timber logs washed down the hills by flood waters in Himachal Pradesh.

The bench issued notices to the Centre through **Ministries of Environment** and Jal Shakti, National Disaster Management Authority, NHAI, states of

Punjab, Himachal Pradesh, Uttarakhand and Jammu and Kashmir.

"We have seen unprecedented landslides and floods in Uttarakhad, Himachal Pradesh, and Punjab. From the media reports, it is also noted that during the flood, a huge number of wooden logs were flowing around. Prima facie, it appears that there has been illegal felling of the trees, which has been going on up hills," observed CJI Gavai.

In a significant decision, the Kuki-Zo Council on Thursday decided to open the National Highway-2 for the free movement of commuters and essential goods in Manipur.

The move follows a series of meetings in New Delhi over the past few days between officials of the Ministry of Home Affairs (MHA) and a delegation of the Kuki-Zo Council. The discussions were aimed at addressing the prolonged blockade that had disrupted the movement of goods and vehicles, causing hardships to residents across

the state. "Kuki-Zo Council has given a commitment to cooperate with security forces deployed by the Government of India to maintain peace along NH-

2," MHA said in a statement.

NH-2, a crucial lifeline connecting Manipur with Nagaland and other parts of the Northeast, had been blocked amid the ethnic tensions that erupted in the state in May 2023. The conflict, primarily between the Meitei and Kuki-Zo communities, has led to widespread violence, loss of lives, displacement of thousands, and a deepening humanitarian crisis.

The reopening of the highway is seen as a confidencebuilding measure and a step towards restoring normalcy in the violence-affected state. Officials in both Imphal and New Delhi believe easing access to essential commodities will help reduce the hardships faced by displaced families and civilians living

Side by side, the MHA further said, a tripartite meeting among representatives of MHA, Government of Manipur, and Kuki National Organisation (KNO) and United People's Front (UPF) was also held at New Delhi today.

"The meeting concluded with the signing of a tripartite Suspension of Operations (SoO) Agreement on re-negotiated terms and conditions (ground rules) to be effective from the day of signing of the Agreement for a period of one year," the MHA mentioned.

Among other provisions, the ministry said, the revised ground rules reiterated two key points that included "the territorial integrity of Manipur, and need for a negotiated solution to bring lasting peace and stability to Mani-

It has been disclosed in the Pandora papers that the owners of Radico Khaitan (Lalit Khaitan and Abhishek Khaitan) have their assets in the offshore trusts. One worker lost his life while 17 others were injured after a massive explosion occurred at the Solar Explosives Company near Bazargaon in Maharashtra's Nagpur in the early hours on Thursday, said officials.

All the injured have been rushed to various private hospitals in Nagpur, with four reported to be in criti-

cal condition. The blast took place at the CB-1 plant of the company. Witnesses said that smoke was noticed before the explosion, which alerted senior workers who immediately asked everyone to evacuate. Most workers managed to escape in time, but Mayur Ganvir, who was inside the plant, could not make it out. Moments later, a powerful explosion ripped through the unit.

building were blown several meters away. Flying debris struck several workers, causing multiple injuries. Police, fire brigade teams, and senior district officials rushed to the spot soon after the incident.

critical condition with head injuries. They were taken into the ICU immediately, and they are on a ventilator. The maximum patients were released after primary medical aid. Seven patients are being treated in the hospital as of now."

An injured worker said, "The incident took place around 12-12.30 am. When we saw smoke coming from the reactor, we all came out. After continuous smoke for around 20-25 minutes. there was a blast. Due to the blast, around 40-50 people got injured by stones...'

Since morning, a large crowd of onlookers has gathered outside the factory premises. Workers of the morning shift have not been allowed to enter the company, and security has been tightened at the site.



Finance Minister Nirmala Sitharaman on Wednesday announced a sweeping reduction in GST, aimed at providing relief to households, farmers, businesses and the healthcare sector.

The 56th GST council meeting decided to rationalise GST rates to two slabs of 5 per cent and 18 per cent by merging the 12 per cent and 28 per cent rates.

5% slab consists of essential goods and services, including food and kitchen item like butter, ghee, cheese, dairy spreads, pre-packaged namkeens, bhujia, mixtures,

and utensils; agricultural equipment like drip irrigation systems, sprinklers, biopesticides, micronutrients, soil preparation machines, harvesting tools, tractors, and tractor tires: handicrafts and small industries like sewing machines and their parts and health and wellness like medical equipment and diagnostic kits.

While the 18% slab consists of a standard rate for most goods and services, including automobiles such as small cars and motorcycles (up to 350cc), consumer goods like electronic items, household goods, and some professional services, a uniform 18% rate applies to all auto parts.

Ramesh questions GST Council's role post reforms

Congress on Thursday slammed the government after Union Finance Minister Nirmala Sitharaman on Wednesday announced rate cuts saying even before the GST Council meeting, the Prime Minister had already proclaimed the substance of its decisions in his Independence Day speech of August 15 and asked is the GST Council to be reduced to a formality.

Congress general secretary and communication incharge Jairam Ramesh in a post on X, said, "The Indian National

Congress has for long been advocating for a GST 2.0 that reduces the number of rates, cuts the rates on a large number of items of mass consumption, minimises evasion, mis-classification, and disputes, does away with inverted duty structure (lower tax on output as compared to inputs), eases the compliance burden on MSMEs, and expands GST coverage."

He said, "The Union Finance Minister has made major announcements last evening after the meeting of the stitutional body. However, even before the GST Council meeting, the Prime Minister had already proclaimed the substance of its decisions in his Independence Day speech of August 15th, 2025. Is the GST Council to be reduced to a formality?" Taking a swipe at the gov-

ernment, Ramesh, who is also the Rajya Sabha member said that faced with a lack of buoyancy in private consumption, subdued rates of private investment, and endless classification disputes, the "Union Finance Minister has finally recognised that GST 1.0 had reached a dead end".

"In fact, the very design of GST 1.0 was flawed and this had been pointed out by the INC way back in July 2017 itself, when the PM had made one of his typical U turns and decided to introduce GST.

It was meant to be a Good and Simple Tax. It turned out to be a Growth Supressing Tax," he claimed.

Singapore ready to share decades of semiconductor Lower GST rate to benefit auto sector, knowledge, skills with India: SSIA

Singapore, with nearly six decades of experience in the semiconductor industry, is willing to share its knowledge and know-how with India, where the sector is still at a relatively nascent stage but holds immense potential.

"Singapore, being a mature site (for semiconductor), we have a very diverse experience in this area. We could share experience, could do knowledge transfer and share skills that are needed for the industry," Ang Wee Seng, Executive Director at Singapore Semiconductor Industry Association (SSIA), told ANI here in the national capital on Thursday. He is in India for the Semicon India 2025.

On Day 1 of the three-day semiconductor-focused event (September 2-4), its fourth edition, SSIA had signed an MoU with the National Institute of Electronics and IT (NIELIT) to skill up the talent

He supplemented that cross-pollination of experiences between the industries of the two countries can help create a better network of business-to-business friendships.

Singapore's semiconductor journey began in 1968, when its first company, National Semiconductor, was established. Since then, it has developed a very diverse ecosystem, not just the front-end fabs, OSAT, but also equipment manufacturing. Singapore, a small country in terms of land mass, manufactures and assembles approximately 20% of the global semiconductor equipment, contributing a significant portion to its economy, he noted. "So it's a very significant industry. But, as we all know, the world is now in chaos. But the demand for chips continues to rise. So the only way for us to meet the demand of the world is not just Singapore as a small island, but to build more chips, or Malaysia coming in

Lower GST on automobiles is set to make vehicles more affordable for buyers and create new opportunities for sellers. As per a Crisil Intelligence report, the revised GST slab to 18 per cent from 28 per cent will benefit the auto sector and boost domestic sales.

"The automotive aftermarket segment will also benefit as all components will now be brought under the 18 per cent GST slab, thereby leading to a reduction in prices of components taxed at 28 per cent by about 7.8 per cent," the

GST 2.0 will allow customers to purchase internal combustion engine (ICE) vehicles at lower rates, thereby improving affordability. Sellers are also likely to benefit from increased demand and stronger sales volumes. At the same time, the government has retained the 5 per cent GST rate on electric vehicles (EVs), ensuring that cleaner mobility options remain attractive to buyers and aligned with India's green goals. The report highlighted

that the prices of entry-level hatchbacks, such as Wagon R, premium hatchbacks like Swift, compact sedans including Swift Dzire, and sub-compact SUVs, such as Punch, are expected to fall by nearly 8.5 per cent.

Large sedans like Virtus, compact SUVs such as Brezza, mid-SUVs like Creta, and MPVs such as Ertiga are projected to be cheaper by about 3.5 per cent. Meanwhile, premium SUVs, including the XUV 700 and MPVs with bigger engines like the Innova, may see a decline of about 6.7 per cent.

Two-wheelers are also set to become more affordable. Prices of most ICE twowheelers will drop by nearly 7.8 per cent, though premium bikes with engines above 350 cc could become costlier by 6.9 per cent.

In the farm sector, ICE tractors and fuel cell motor vehicles, including hydrogen-powered models, are likely to see price reductions of about 6.3 per cent. Threewheelers, light commercial vehicles (LCVs), medium and heavy commercial vehicles (MHCVs), and buses will all record a decline of

GST exemption may hurt insurers short term, but aid growth later

Insurance companies are expected to face a setback in the short run following the GST Council's recent exemption on GST, as it could lead to the loss of input tax credit eligibility, said industry experts and executives, adding that the companies, however, will benefit in the long term.

Individual life and health insurance premiums have been exempted from the 18 per cent GST from 22nd September onwards. This includes term insurance, health policies, including family floater and ULIPs.

"For term insurance, GST exemption could result in notable cost reduction, making them more affordable. On the other hand, insurers may lose eligibility for input tax credits. For ULIPs, these products contain a significant investment component; hence, the direct impact of the

exemption may not necessarily bring in a reduction of 18% premiums for such a product," said Vaqarjaved Khan, CFA, Senior Fundamental Analyst, Angel One Ltd. Bankim Mapara, Chief Financial Officer, Universal Sompo General Insurance. said that "the long-term effects will likely be good."

"This move will motivate more families to secure sufficient health protection and reinforce the role of insurance as a financial safety net against increasing medical costs," he

Chinmay Jain, Director -

Insurance & PPI, Jupiter, expressed a similar senti-

ment and said, "While insurers may need to recalibrate their cost structures due to the loss of input tax credits, we view this as an opportunity to innovate and streamline operations."

Observing the impact, Smita Singh, Partner, S&A Law Offices, said, "While this move is expected to encourage wider insurance penetration, its actual impact on premiums will depend on how insurers adjust to the revised tax

'GST rate cuts to boost affordability, spur consumption'

Global investment bank Morgan Stanley notes that the rationalisation of the Goods and Services Tax (GST) structure, approved by the GST Council, is expected to significantly boost consumption in the coming months, coinciding with the onset of the festive season.

In its latest research report, the firm highlighted that the shift from the existing four-tier GST rate system to a simplified two-rate structure of a standard rate of 18 per cent and a merit rate of 5 per cent, will make a range of goods and services more affordable for consumers. A special demerit rate of 40 per cent will continue for a select few items such as tobacco

products and luxury goods. "We expect the improved affordability to give a fillip to consumption, especially as the new GST tax structure is effective from the start of the festive season," the report said, adding

that the indirect tax reduction would help lift demand in a broad-based manner, particularly benefiting low-income households

The new GST rates are set to come into effect from September 22, in line with Prime Minister Narendra Modi's announcement during his Independence Day address about next-generation GST reforms aimed at simplifying the tax regime and benefiting consumers.

According to Morgan Stanley, the government estimates the net fiscal impact of this rationalisation at Rs 48,000 crore, or about 0.13 per cent of GDP, after factoring in revenue foregone of Rs 93,000 crore and gains of Rs 45,000 crore from the new 40 per cent slab.

Japanese firms seen pivotal in India's semiconductor value chain: Deloitte

Japanese companies are set to play a critical role in shaping India's semiconductor mission as the country gears up to become a USD 100 billion semiconductor market by 2030, noted Deloitte India.

In a written reply to ANI questions, P.S. Easwaran, Partner & Supply Chain Leader, Deloitte India, said that the growth of the semiconductor sector in India will be boosted by the USD 10 billion incentive scheme of the government under the Indian Semiconductor Mission

"India's semiconductor market is projected to reach over USD 100 billion by the end of this decade, and nearly 30-35 per cent of this demand will be met through domestic manufacturing," noted Easwaran

However, he emphasised that achieving this aspiration will require strong interna-

ondary sources.

tional partnerships with established semiconductor ecosystems, and Japan plays a very important role in this journey, given its leadership in semiconductor materials and equipment.

"Japan currently accounts for manufacturing of nearly 50 per cent of the world's semiconductor materials including photoresists, specialty chemicals, gases, and wet chemicals, and one-third of equipment, making it a key partner of choice in scaling India's manufacturing base and creation of a robust ecosystem." These strengths make Japan a "partner of choice" for India to scale its semiconductor ecosystem, Easwaran highlighted.

The India-Japan partnership is already taking shape through landmark projects involving technology collaboration and equipment supply by Japanese firms for semiconductor facilities in India. Strategic initiatives such as the India-Japan Semiconductor Supply Chain Partnership of July 2023 and the Digital Partnership 2.0 announced in August 2025 are aimed at strengthening joint research, design innovation, and talent development.

FICCI hails Govt's Rs 1,500 crore scheme for critical mineral recycling

The Federation of Indian Chambers of Commerce and Industry (FICCI) President, Harsha Vardhan Agarwal, lauded the government's decision to approve the Rs 1,500 crore Incentive Scheme to promote Critical Mineral Recycling in the country and termed it a "landmark step."

"It is a landmark step by the government. From the industry perspective, we are very positive and bullish about the step, the government has taken," Agarwal said.

The Union Cabinet, chaired by Prime Minister Narendra Modi, on September 3, approved a Rs 1,500 crore Incentive Scheme to develop recycling capacity in the country for the separation and production of critical minerals from secondary

This scheme is part of the National Critical Mineral Mission (NCMM), which is aimed at building the domestic capacity of and supply chain resilience in critical minerals

The critical mineral value chain, comprising exploration, auction and mine operationalisation, and acquisition of foreign assets, has a gestation period before it can supply critical minerals to the Indian industry.

A prudent way to ensure supply chain sustainability in the near term is through the recycling of

The Scheme will have a tenure of six years from FY 2025-26 to FY 2030-31. Eligible feedstock is e-waste, Lithium Ion Battery (LIB) scrap, and scrap other than ewaste & LIB scrap, e.g. catalytic converters in end-of-life vehicles. Expected beneficiaries will be both large, established recyclers, as well as small, new recyclers (including start-ups), for whom one-third of the scheme outlay has

been earmarked. The Scheme will be applicable to investments in new units as well as expansion of capacity/modernisation, and diversification of existing units.

The Scheme will provide an incentive for the recycling value chain, which is involved in the actual extraction of critical minerals, as opposed to the value chain involved only in black mass production.

The incentives under the Scheme will comprise 20 per cent Capex subsidy on plant & machinery, equipment and associated utilities for starting production within the specified timeframe, beyond which a reduced subsidy will be applicable; and Opex subsidy, which will be an incentive on incremental sales over the base year (FY 2025-26), viz., 40 per cent of eligible Opex subsidy in the 2nd year and balance 60 per cent in the 5th year from FY 2026-27 to FY 2030-31 on achievement of specified threshold incremental sales.

even years, Rs. 117 lakh crore collected and yet citizens still walk on broken roads, breathe toxic air, endure erratic power, and queue for free rations.

So, should I clap or grieve? Perhaps both. Clap, because India has finally moved towards a rational, citizen-friendly GST. Grieve, because the reform came seven years late, after taxpayers had already been overcharged.

The applause will be hollow unless we see a change

not just in the tax code but in the lived experience of citizens. GST 2.0 must not only be about lower rates. It must also be about higher returns—to the taxpayer, to the middle class, to the nation's poor who still stand in

ration lines, and to the very

idea of India's development

Since the introduction of GST in July 2017, taxpayers have contributed an astonishing 117 lakh crore in consumption taxes. A large part of this came from middle-class pockets—the salaried, the shopkeepers, the small entrepreneurs, the families who pay their bills on time and rarely complain.

If the newly announced 5% and 18% slabs had been applied from the start, much of this burden would have been lighter. Back-of-theenvelope estimates suggest that the average middleclass Indian paid thousands

of rupees for hard-earned (income tax paid) money over these years purely due to a faulty slab design and inflated rates. This is money that could have gone to savings, children's education, or healthcare.

The justification was simple: this money would be ploughed back into building a modern India. Better roads, stronger bridges, unclogged drains, reliable electricity, robust healthcare, clean air, and safe water. We paid GST at every shop counter, with quiet hope that it would return as public goods.

IN REALITY...

Step into any Indian city after a bout of rain and reality shatters that hope. Gurgaon, the emblem of a "Millennial City," floods within hours. Traffic police are more visible at collection points than at accidentprone junctions. Bridges across the country are collapsing with alarming frequency—whether in Bihar. Gujarat, or Kerala-exposing weak construction and weaker governance.

Electricity, a basic necessity, remains erratic even in supposedly modern urban clusters. A city that prides

And what of poverty? This is not a symbol of progress; it is a measure of how deeply inequality persists despite trillions in tax revenue.

Meanwhile, law and order is erratic. Street crime is up in many states, cyber scams

flourish, women's safety remains precarious, and communal flashpoints are stoked with political ease. Where exactly has the GST bounty gone if not to ensure a basic sense of security for its citizens?

To be fair, GST has achieved some of its technical goals. It created a unified national market, deepened digital compliance, and expanded the tax base. Businesses no longer navigate the maze of state-level entry taxes. Logistics efficiency has improved.

But the social contract was never just about efficiency. It was about trust—that the rupee collected at checkout would translate into better lives. And here, the gap is glaring. The paradox is striking: India collects more tax than ever, yet citizens still step out daily into broken infrastructure, choking air, erratic electricity, unsafe streets, and unaffordable healthcare.

Now, in September 2025, slabs are being rationalised. Essentials like life-saving drugs drop to 0%, common medicines to 5%, soaps and shampoos to 5%, and small cars to 18%. Sin goods such as cigarettes, pan masala, and luxury yachts move to

It is good economics and much better politics. But it also raises a harder question: why did we wait so long? For seven years, we over-collected from citizens, squeezed disposable income, and only now, on the eve of elections, are we admitting that a simpler structure is sustainable.

This is where the dilemma deepens. Do citizens clap because the government

has finally corrected a distortion? Or do they feel anguish that the correction came seven years late, after they had already overpaid?

The middle class has been the silent workhorse of India's tax system. Unlike the very rich, who can navigate loopholes, or the very poor who are exempted, the salaried and consuming class pays what is levied. With GST, deducted at every point of purchase, escape was impossible. And so they paid-faithfully, quietly, heavily.

The GST rupee collected all along has not been returned as a civic dividend to Indian citizens. If GST 2.0 is to mean anything beyond a rate cut, it must rebuild trust: every rupee collected should show up in roads we can drive on, water we can drink, air we can breathe, and hospitals we can rely on. Without that, the socalled Diwali gift is only a receipt for an unpaid debt.

SC rightly acquits mother-in-law in Section 498A IPC case

ness of things while striking the right chord, the Supreme Court in a most learned, laudable, landmark, logical and latest judgment titled Smt Bhagwati Devi vs State cited in Neutral Citation No.: 2025 INSC 1051 in the exercise of its criminal appellate jurisdiction that was pronounced as recently as on August 29, 2025 while acquitting the mother-in-law of the deceased woman in a case of dowry harassment that had been registered under Section 498-A of the IPC has minced absolutely just no words to hold plainly that the word spreads faster than the wind about a daughterin-law being harassed for dowry by the parents-inlaw. It must be noted that the appeal before the top court was filed by the woman who had been convicted for the offence that is punishable under Section 498-A of IPC. It merits just no reiteration that the Apex Court very rightly acquitted the mother-in-law after taking into consideration among other things the deposition of the neighbour also thus setting aside the judgment of the Uttarakhand High Court. No denying or disputing it in any way!

At the very outset, this brief, brilliant, bold and balanced judgment authored by Hon'ble Mr Justice Aravind Kumar for a Bench of the Apex Court comprising of himself and Hon'ble Mr Justice NV Anjaria sets the ball in motion by first and foremost putting forth in para 1 that, "The Appellant herein who has been convicted for the offence punishable under Section 498-A of IPC is

PW-1 presented a complaint before Bagwshwar (P.S.) on 16.06.2001 alleging that his daughter was found dead inside the matrimonial home and only the accused persons were present in the house. It was also stated in the complaint that the daughter of PW-1 had committed suicide by hanging herself. However, he is said to have seen the wounds on his daughter's body during examination and he along with the Patwari saw blood along with water oozing out from the mouth of his daughter. It was further alleged that she was pregnant at the time of her death and further stated that deceased used to inform that her mother-in-law was commenting on her sarcastically for dowry. Hence, expressing doubt about her death and his daughter having been killed requested suitable action being taken against the culprits. It was also stated by the complainant himself that her husband namely son-in-law was out of city on professional work at Mumbai. The said com-

plaint came to be registered

in Crime Case No.1 of 2001

for the offences punishable

in-law, mother-in-law and brother-in-law of the deceased were arraigned as accused and the trial court framed the charge for the offences under Sections 304-B, 498-A and optional charge under Section 302 read with Section 34 of IPC. On behalf of the pros-

ecution, three (3) witnesses namely Dharmanand Joshi, Shambhu Dutt Joshi and Smt. Heera Devi apart from four (4) other witnesses were examined and on behalf of the accused one Smt. Janki Devi was examined. The learned Sessions Judge after trial held that the charge of Section 302 read with Section 34 of IPC was not proved against all the accused. So also, for the charge of Section 304-B was held to be not proved and accused persons were acquitted for the offences punishable under Section 302 read with Section 34 and Section 304-Bof IPC, However, Accused no.2 - Mother-in-law namely the Appellant herein was convicted for the offence punishable under Section 498-A of IPC on the ground that deceased had informed her mother (PW-3) and brother (PW-2) about the harassment she was facing for dowry to which effect they had accordingly deposed before the trial court. Hence, the learned Trial Judge concluded that deceased had committed suicide due to harassment. However, the offence under Section 498-A of IPC was held to be not proved against Accused no.1 and Accused no.3 and they

As it turned out, the Bench then enunciates in para 3 laying bare mentioning that, "The Accused no.2 being aggrieved by the conviction and sentence of three years rigorous imprisonment with fine of Rs.5,000/- and default sentence of three months imprisonment preferred an appeal before the High Court

came to be acquitted for all

the offences alleged.'

in Criminal Appeal No.174 of 2003. The High Court on reappreciation of the evidence came to the conclusion that evidence of PW3 disclosed that on every visit made by the deceased to the paternal home, she had disclosed the demand of dowry by her mother-in-law as well as other accused persons as an acceptable piece of evidence and as such affirmed the judgment of sessions court. Hence, this Appeal."

Do note, the Bench notes in para 6 that, "Having regard to the submissions made pearing for the parties and on scrutiny of the records of the courts below, it would clearly emerge that though the appellant along with her husband and another son was charged for the offences punishable under Section 304-B and as an alternate under Section 302 read with Section 34 of IPC they have been acquitted by the court below for which there was no appeal. In other words, the order of acquittal for the said two offences had attained finality. While citing the relevant

case law, the Bench opines in para 8 observing that, "A perusal of Section 498-A would clearly indicate that whoever, being the husband or the relative of the husband of a woman, subjects her to cruelty would be liable to be punished with imprisonment for a term which may extend to three years and also liable to fine. Under the caption of explanation "Cruelty" has been defined to mean and include any willful conduct which is of such a nature as is likely to drive the woman to commit suicide or to cause grave injury or danger to life, limb or health whether mental or physical of the said woman or harassment of the woman or where the harassment is with a view to coercing her or any person related to her to meet any unlawful demand for any property or valuable secu-

rity or is on account of failure

to her to meet such demand. Demand for dowry in any form is itself sufficient for Section 498-A of IPC being attracted. Demand made in any form either by the husband or by the relative of the husband would also attract Section 498-A of IPC. Even if the demand exhibits the conduct that would likely to drive the said woman being unable to bear such conduct would attract Explanation (a). Likewise, harassing of a married woman with a view to coercing her or her relative to meet any unlawful demand would also fall within the mischief of the expression 'cruelty'. This court in the case of Manju Ram Kalita vs. State of Assam (2009) 13 SCC 330 has held cruelty for purpose of Section 498-A of IPC is to be established in that context as it may be different from other statutory provisions. In other words, it has been held that it has to be established that the woman had been subjected to cruelty continuously/persistently or at least in close proximity of time of lodging of complaint. It has been further held:-"21. "Cruelty" for the pur-

pose of Section 498-A IPC is to be established in the context of Section 498-A IPC as it may be different from other statutory provisions. It is to be determined/ inferred by considering the conduct of the man, weighing the gravity or seriousness of his acts and to find out as to whether it is likely to drive the woman to commit suicide, etc. It is to be established that the woman has been subjected to cruelty continuously/persistently or at least in close proximity of time of lodging the complaint. Petty quarrels cannot be termed as "cruelty" to attract the provisions of Section 498-A IPC. Causing mental torture to the extent that it becomes unbearable may be termed as cruelty.""

Be it noted, the Bench notes in para 9 that, "Keeping the aforesaid salutary principles

enunciated by this court in mind, while we turn our attention to the facts on hand it would be apt and appropriate to have a look at the complaint lodged by the father of the deceased PW-1 on the very next day of the demise of his daughter. The perusal of the complaint would indicate that the complainant had reached his daughter's matrimonial home on 16.06.2001 at 4 A.M. and he came to know that his daughter had expired in the afternoon on 15.06.2001 and was informed that she had committed suicide by hanging. It is further stated that the deceased used to tell them during her visit to the paternal home that her mother-in-law used to comment on her sarcastically for dowry. There is not even a word with regard to any dowry demand having been raised by the appellant. In this background when the deposition of the complainant PW-1 is perused it would not detain us for long to arrive at a definite conclusion that his deposition does not indicate of any such demand for dowry having been made or the deceased having been inflicted with cruelty so as to drive her to commit suicide. It would be appropriate to note at this juncture itself that the cause of death has been recorded as asphyxia on account of strangulation as evidenced from the postmortem report.'

It is worth noting that the Bench notes in para 10 that, "The trial court has based the conviction on the strength of the evidence of the mother of the deceased PW-3. She has deposed that her inlaws used to state that the dowry given was less and she used to weep. In the cross-examination she admits that her daughter had come with her younger brother-in-law and had not made any complaint about the members of the matrimonial home. She also admits that during Shiv Ratri her daughter had come alongwith son-in-law and she did not make any

to drop her to her matrimonial home she did not make any complaint to her father about any demand for dowry being made. She further admits that the alleged demands made by fatherin-law, mother-in-law and vounger brother-in-law was for the first time disclosed in the court when she tendered her examination-in-chief. She also admits that the married life of her daughter was happy and cordial and at the time of marriage there was no demand for dowry. She infact admits at the time of marriage her son-in-law had told that he has no demand of dowry. A holistic look at the deposition of PW-3 that is the mother of the deceased would not inspire any confidence to any person of common prudence to arrive at a conclusion that on account of either harassment for dowry or on account of demand for dowry made by the appellant she had been perforced to commit suicide. Even the evidence of PW-2 that is the brother of the deceased is in line with the evidence tendered by his mother PW-3. Infact he also admits that there was no demand for dowry made before marriage and the marriage was solemnised happily and properly and only on the basis of doubt he was expressing that his sister might have been murdered. The doctor (PW-4) who conducted the post-mortem and submitted the report (Ex. Ka-2) of the deceased PW-4 has opined the cause of death appears to be asphyxia on account of strangulation. He admits if there is strangulation then possibility of injuries being suffered to other parts of the body is possible and when there is resistance to the strangulation there is likelihood of urination and faecal matter can also be excreted which was not found on the body of the deceased." Most significantly and resultantly, the Bench then

encapsulates in para 11 what

postulating precisely that, "Thus, the cumulative effect of the evidence of these witnesses would drive us to the irresistible conclusion that the deceased had not committed suicide on account of either demand for dowry being made or cruelty being inflicted on her. Our view also gets fortified by the fact that the neighbour of the appellant who was examined as DW-1 has deposed that appellant had never made any demand for dowry. She also deposed that the deceased had informed her of not keeping well. She being neither the relative of the appellant nor belonging to the same community to which the appellant belongs would indicate that there was no interest in her to depose against the factual matrix or in favour of the appellant. Her evidence having been brushed aside by the trial court and also High Court on the premise that she could not have deposed any fact with regard to the demand of dowry as it happens within the four walls is an erroneous finding particularly in such matters the word spreads faster than the wind about a daughterin-law being harassed for the dowry by the parents in law. Such facts being conspicuously absent in the instant case, we have no hesitation in arriving at a conclusion that the conviction of the appellant for the offence punishable under Section 498-A and the sentence imposed on her cannot be sustained." Finally and as a corollary,

the Bench then concludes by directing and holding aptly in para 12 that, "For the reasons afore-stated above, we allow this Appeal, set aside the judgment of the High Court of Uttarakhand at Nainital in Criminal Appeal No.174 of 2003 dated 10.04.2014 and acquit the accused for the offence under Section 498-A of IPC. Her bail bonds stand discharged. No order as to costs."

80th anniversary of Japan's World War II surrender with a massive military parade in central Beijing – a spectacle heavy with symbolism for both domestic audiences and the world. President Xi Jinping stood atop Tiananmen Rostrum in a high-collared Mao-style suit, reviewing ranks of troops, tanks, and missiles amid towering set pieces emblazoned "1945" and "2025". Flanking Xi were two controversial guests: Russia's Vladimir Putin and North Korea's Kim Jong Un, whom Xi pointedly welcomed as "old friends" despite their pariah status in Western capitals. This unprecedented tableau -Xi, Putin, and Kim appearing together publicly for the first time - underscored a dramatic alignment of authoritarian power at a time

of rising East-West tensions.

Officially, the **September 3** parade commemorated China's victory over Japanese aggression and fascism in World War II (a holiday Beijing calls "Victory Day"). display of might in the mantle of historical memory and peace. He hailed the defeat of Japan in 1945 as "China's first complete victory against foreign aggression in modern times," praising the "immense sacrifice" of the Chinese people in WWII. The wartime struggle, Xi noted, "reshaped the national psyche" and paved the way for China's "national rejuvenation", a process he declared "unstoppable". Remembering history, Xi said, is meant "to create a better future and pass the torch of peace from generation to generation" - a line emphasizing China's preferred image as a guardian of peace.

The pageantry was accordingly suffused with peace messaging even as China showed off formidable weaponry. The event opened with an 80-gun salute and a flag-raising, followed by helicopters trailing banners that read "Justice Prevails," "Peace Prevails," and "The People Prevail." Later, as the parade concluded, 80,000 white doves symbolizing peace were released into the sky, accompanied by 80,000 multicolored balloons in a stunning finale. At the same time, columns of troops and cutting-edge armaments rumbled past Tiananmen Square. More than **10,000 soldiers** marched in tight formation and over 100 military aircraft roared overhead. China even unveiled its nuclear triad of land. sea, and air-based strategic missiles for the first time - including new intercontinental ballistic missiles and

hypersonic weapons – as a showcase of its modern military might. Xi underscored that the **People's Liberation** Army (PLA) must become a "world-class force" and "resolutely safeguard national sovereignty, unity and territorial integrity." To China's domestic audience, the message was clear: the country's rejuvenation comes with military strength, but only to ensure peace and prevent the "historical tragedies" of war from

Indeed, this was her international **debut** after only appearing at North Korean military tests and parades until now. Her presence, in a sense, symbolized the dynastic and long-term intentions of North Korea's regime. It also hinted at how tightly North Korea aligns with China: Kim effectively showcased his heir-apparent on Chinese soil, perhaps to confer a degree of legitimacy and Chinese goodwill on his family's future. For Kim, who has never before attended such a large multilateral gathering, the Beijing parade was an opportunity to broaden his diplomatic exposure and gain "implicit support" from powerful friends for his banned nuclear weapons program. Just before heading to China, Kim even visited a missile factory, a not-so-subtle reminder of

lysts note that until a few vears ago, China and Russia had cooperated with the West to sanction North Korea over its nuclear tests - but now all three appear aligned in mutual support. In a startling sign of that shift, **North** Korea has reportedly sent more than 15,000 troops to bolster Russia's war in tralia), and appearing at a **Ukraine**, with hundreds killed in action on the Russian side. (Pyongyang's military aid to Moscow marks a 180-degree turn from its past dependence on Chinese and Soviet aid, and it underscores how shared conflicts with the West are knitting these countries together.) For Beijing's part, inviting Kim and Putin to jointly attend its Victory Day parade - and literally walk shoulder-to-shoulder with Xi – was a powerful statement. "Any new concentration of military power in the East that includes Russia will ring alarm bells for the West," one analyst observed, adding that trilateral military exercises between China, Russia and North Korea now "seem near*ly inevitable.*" The spectacle of unity in Beijing suggests that Xi is willing to flout Western opinion to build an "anti-hegemonic" front, as he urged global leaders just days prior to "take a clear stand against hegemonism and power politics." This phrasing is widely read as a rebuke of U.S. dominance.

INDIA'S DELICATE DISTANCE

Notably absent from Beijing's commemorations was one major Asian leader: India's Prime Minister Narendra Modi. Modi did travel to China earlier in the week for a Shanghai Cooperation Organization (SCO) summit in Tianjin, where, in a somewhat surreal scene, he was photographed smiling and even holding hands with Xi and Putin in a show of diplomatic camaraderie. But when it came to the Victory Day parade in Beijing, India pointedly opted out.

According to Indian officials, New Delhi saw the event as celebrating China's victory **over Japan** and declined to attend "out of consideration for Tokyo". Japan is a close strategic partner for India (both are members of the "Quad" security dialogue alongside the US and Aus-Chinese military parade showcasing triumph over Japan would have been awkward for Modi. The Indian leader, fresh off a warm visit to Japan days earlier, chose to skip Beijing's parade entirely.

Behind this diplomatic snub lies the **simmering** distrust between India and China. Bilateral ties have been strained by a deadly border clash in 2020 and ongoing troop standoffs in the Himalayas. While Chinese state media hinted at improving relations, Modi's no-show underscored the "deep divergence" in how the two Asian giants view history and the future regional order. India also bristled at the anti-West tenor of the SCO gathering. Many leaders at the summit (convened by China and Russia) voiced opposition to U.S. **President Donald Trump's** protectionist policies. Modi's government, facing its own trade frictions with Washington, seemed unwilling to fully align with either side's narrative. In effect, India is walking a tightrope - cooperating with China and Russia in formats like the SCO and BRICS, but keeping enough distance to avoid undermining its partnerships with the U.S., Japan, and other democracies. Skipping China's grand parade was a subtle way for Modi to signal that India isn't signing up for any new Cold War-style bloc, even as Xi, Putin, and Kim

rade was not just about retro WWII memories - it doubled as a platform to deepen their present-day strategic partnership. On the sidelines of the event (and the SCO meetings), a slew of agreements. reinforcing what they famously call their "no limits" friendship. Most headlinegrabbing was a "legally binding" deal to move forward with the **Power of Siberia 2** gas pipeline from Russia to China. This colossal pipeline, which would snake through Mongolia and potentially supply 50 billion cubic meters of gas annually, could re-route a significant chunk of the gas Russia once sold to Europe into China's eager market. Gazprom's chief announced that, in addition to the new pipeline memorandum, Russia will boost gas supplies immediately via the existing Siberia pipeline (up to 44 bcm a year). As one energy analyst put it, these moves are a "huge turning point in the geopolitics of energy" – a clear sign that Beijing no longer pretends to heed Western sanctions or censure of Moscow. Indeed, China's tacit message, in building out energy links and trade with sanctioned Russia, is that it "can resist Western pressure to isolate Moscow". Both Xi and Putin are

visibly positioning their countries for a new era of East-West rivalry. They frequently invoke historical slights – from the "century of humiliation" by colonial powers in China's case to the post-Cold War NATO expansion in Russia's – to justify closer ranks. "The world is entering a new era with the West in decline," is the shared narrative from Beijing and Moscow. In Beijing, Putin hailed the

high" level, emphasizing trust and cooperation in the face of common challenges. The Kremlin noted 22 different **agreements** were signed during Putin's China visit, spanning energy, finance, technology and more, further intertwining the two economies. Such open coziness is a direct rebuke to Western nations that have tried to isolate Putin for his war in Ukraine. Xi's **"old** friend" welcome and the pomp accorded to Putin in Beijing sent a clear signal: China will not distance itself from Moscow, Western opinions be damned. As if to drive that point home, Xi pointedly attended Moscow's own Victory Day parade in May this year – **China and Russia inked** standing with Putin on Red Square – and in turn Putin came to Beijing's parade. The symmetry underscores how the two nuclear powers are bolstering each other's legitimacy on the world stage, forming what they view as a bulwark against U.S. "hegemonism."

Interestingly, this tightening Sino-Russian embrace is playing out against the backdrop of Donald Trump's return to the White House. Trump has often argued that Western policies only pushed Beijing and Moscow closer together, and in some respects he isn't wrong. In fact, Putin remarked during his Beijing visit that he sees a "sincere desire" by Trump's current U.S. administration to help resolve the **Ukraine conflict** – a stark contrast to Putin's hostility toward the previous Biden administration. Speaking to reporters, Putin said he perceives "a certain light at the end of the tunnel" thanks to President Trump's ef**forts** to find a settlement, and that he'd prefer to end the war via talks "if common sense prevails". Nonetheless, Putin warned that if negotiations don't bear fruit, "we will have to resolve all the tasks before us by force of arms." It was an unapologetic ultimatum: peace on Putin's terms, or a continued war. The venue of this statement - **Beijing**, at the tail end of the grand parade events - was symbolic. Standing on friendly soil far from Western

scrutiny, Putin essentially

doubled down on his war

aims while enjoying Chi-

na's implicit backing. Xi, for his part, has balanced on a tightrope regarding Ukraine, calling for peace talks in abstract while never condemning Russia. The Victory Day event reinforced that China's "pro-peace" stance doesn't include pressuring its Russian partner. Instead, Putin and Xi presented a united front. They even indulged in some personal banter that caught observers off guard - and perhaps offered a glimpse into the mindset of two leaders determined to hold power for a long time.

THE IMMORTALITY **CHAT AND OTHER CURIOSITIES**

Amid the highly choreographed pomp, one unscripted moment from the parade garnered nearly as much buzz Xi Jinping and Vladimir Putin walked side by side (with Kim Jong Un trailing just behind) toward the viewing platform, a hot mic picked up snippets of their conversation. Incredibly, the two men were chatting about **organ trans**plants and human longevity. Putin's interpreter was heard enthusing in Chinese about advances in biotechnology: "Human organs can be continuously transplanted... The longer you live, the younger you become, and you can even achieve immortality," the translator relayed. Xi, off-camera, replied matter-of-factly: "Some predict that in this century humans may live to 150 years old." Kim Jong Un, walking alongside them, smiled in apparent fascination - though it's unclear if their remarks were translated for him. The surreal exchange, captured on state TV's livestream before engineers quickly drowned out the audio, went viral. After the parade, Putin confirmed to reporters that he and Xi had indeed discussed "modern means of health improvement" and organ replacements that might extend life "differently than it does today."

The darkly comic "immortality" talk spurred quips that these autocrats plan to rule forever – or at least long enough to see a reshaped world order. It's true that Xi (age 72) and Putin (also 72) have both amended rules to cling to power indefinitely, and neither shows any intention of grooming a successor. Kim, much younger at ~41, has decades ahead of him – and even a successorin-waiting already introduced to the world. The fact that these leaders casually mused about living to 150 while showcasing nuclear missiles is a telling sign of their ambitions. Domestically, they project themselves as fathers of their nations' rejuvenation, indispensably guiding their countries through a perilous era. If science can help them cheat time, all the better. As satirical commentary in one outlet put it, maybe Xi and Putin really are "onto something" with organ transplants for immortality - at least in the metaphorical sense of extending their regimes' longevity.

Another curious subplot

was the shadow of **Donald Trump** looming over the event. Trump has often bragged of his personal rapport with Xi, Putin, and Kim – referring to Xi as a as the weapons on display. As great friend, calling Putin "smart," and famously claiming he and Kim "fell in love" over letters. Now all three of Trump's one-time acquaintances were bonding visibly without him. Some U.S. analysts noted that this Beijing summit of strongmen was a blow to Trump's ego, given that he had touted his unique ability to broker peace with each of them. In a bit of irony, Trump himself had long been enamored with military parades. After watching France's Bastille Day march in 2017, he was so impressed that he pushed for a grand parade down Pennsylvania Avenue, saying "we may have to try that in Washington". Now, as U.S. President again in 2025, Trump finally got his wish - a military extravaganza in D.C. coinciding with July 4 and the U.S. Army's 250th anniversary. Yet even that celebration, replete with tanks on the National Mall, didn't carry the geopolitical heft of Beijing's Victory Day show. One of Trump's own former officials grudgingly remarked that Western missteps had "pushed Moscow and Beijing closer", leading to scenes like Tiananmen Square where America was pointedly not missed. Indeed, Xi's speech at the parade warned that humanity faces a choice of "peace or war, dialogue or confrontation, and win-win outcomes or zero-sum games." To Beijing, Washington's alliances and actions represent the latter - hegemonic, confrontational, zero-sum - whereas

China and its friends claim to

offer a more peaceful, multi-

polar vision.

THE SILENCE OF KEOLADEO'S FOREST LODGE

ajasthan's only forest lodge built in the world famous Keoladeo (Ghana) Bird Sanctuary located in Bharatpur, which is called the Lion Gate of Rajasthan, is now losing its identity due to mismanagement. This sanctuary marked on the world map is home to both native birds and foreign birds. If we leave aside the restrictions of the Corona period, there has been a good influx of domestic and foreign tourists, but the forest lodge built in the middle of this sanctuary 49 years ago for special government guests is no longer the same old thing.

This forest lodge was inaugurated by the then Prime Minister Indira Gandhi on 7 February 1976. The special thing is that at that time the Prime Minister of the country stayed in this lodge for 2 nights with her two sons and daughtersin-law. The witness of this is the visitors' book of the lodge in which signatures and comments of Indira Gandhi as well as Rajiv Gandhi, his wife Sonia Gandhi, Sanjay Gandhi and his wife Maneka Gandhi are still recorded. Perhaps it will be called a misfortune

came the Prime Minister after the death of Indira Gandhi, stayed in this lodge on 7 May 1991, just 15 days before his death in a terrorist incident.

This attractive lodge, which was under the operation of the Indian Tourism **Development Corporation** (Ashoka Group) from 1976 to 2017, has been stayed by not only national but also foreign celebrities. Prince Charles of Britain, who came to India on 28 November 1980, not only stayed overnight in this lodge but also planted a Kadamba tree as a memento, which today is providing shade to tourists and nest to birds in the form of a lush green tree. Former Chief Minister of Rajasthan Haridev Joshi, Shivcharan Mathur and former Governor of the state Omprakash Mehra have also enjoyed the chirping of birds in this bird sanctuary as well as the pleasure of superb hospitality in this lodge.

Along with this, the Prince of Holland and the Prince of Japan have also stayed overnight in this attractive lodge. Although BJP's national leader Lal Krishna Advani also stayed here when he came to visit this sanctuary, but after reading what former Prime Minister Atal Bihari Vajpayee has written in the visitors' book about the efficient management of this lodge, there is nothing left to say about the attraction of the lodge. Vajpayee, who stayed at the lodge on 22 January 1986, wrote- "I suddenly got an opportuni-





ty to come here after almost 8 years. The world of birds is unique. Be it Russia or China, but attracted by the hospitality of India, birds come here regularly. If humans can also roam freely like birds, then the dream of the sages to make the world their nest will come true. I was happy to stay at the Forest Lodge. The management is excellent,

the officers are dutiful, the employees are loyal. Congratulations"- Atal Bihari Vajpayee.

Undoubtedly, neither any tourist nor any domestic or foreign personality had ever raised any question about the management of this lodge which was under the operation of the Indian Tourism Development Corporation from 1976 to 2017,

but ever since the responsibility of operating this lodge came on the shoulders of Rajasthan Tourism Development Corporation, its management started faltering.

In this lodge, 18 air-conditioned rooms with ultramodern facilities have been built for the stay of tourists. The dining hall of this lodge has the capacity to feed 60 people at a time. Vegetarian and non-vegetarian food is available till 9 pm. At present, 6 permanent employees are working in this lodge while 9 employees are employed on contract basis. The walls of this lodge,

same but due to lack of maintenance and regular painting, the lodge looks discolored. The appearance of the curtains hanging at various places in the lodge tells that they are not even washed. The charm that was earlier visible in the rooms built for stay has now almost died. Forget about changing the mattresses of the beds, the sheets laid out are seen crying for washing. It will not be an exaggeration to say that the management which former Prime Minister Atal Bihari Vajpayee had described as excellent in the visitors' book has now become inferior. The interesting thing is that the former Maharaja of Bharatpur and former Tourism Minister of Rajasthan Government Vishvendra Singh did not even show any special interest in the poor condition of this lodge which has made its unique identity on the world map.

Some employees of the sanctuary told me the truth that the Divisional Commissioner and District Collectors residing in Bharatpur did not even deem it fit to know the condition of this lodge which is shedding tears of misery.

Perhaps this is the reason that the condition of this forest lodge which has been attracting domestic and foreign celebrities with its management for the last four and a half decades is now like "the blind grinds and the dog eats".

The power of looking back - Old photos of Rajasthan as heritage

Rajasthan, the land of palaces, forts, deserts, and vibrant cultural traditions, has always been a photographer's dream. But beyond THE VISUAL the aesthetic appeal, photo- LANDSCAPE OF graphs of Rajasthan-especially old and archival ones-hold a deeper significance. They are more than just visuals; they are living documents of the state's heritage, cultural evolution, and socio-political transformation.

From the dusty archives of royal courts to old albums passed down through generations, early photographs of Rajasthan tell stories of a time that feels almost mythical today. These frames capture not only the grandeur of Rajputana architecture but also the subtleties of daily life-the clothes people wore, the unpaved roads they walked on, the rituals they followed, and the expressions they held.

PHOTOGRAPHY AS AN ARCHIVE OF IDENTITY

In the 19th and early 20th centuries, when photography was still a novelty, it found eager patrons in Rajasthan's royal families. Kings and nobles, fascinated by this new form of art and documentation, commissioned photographers to record everything-from majestic palaces and formal portraits to festive processions and everyday life within the walled cities. These photographs were not just vanity projectsthey became a means of preserving cultural memory in a changing world.

Unlike paintings or oral history, photographs gave a sense of realism. They showed dust on the roads, cracks in the forts, shadows cast by ancient pillars, and

the vibrant chaos of street markets. They preserved the texture of life—a reality untouched by imagination

CHANGE

When one compares these early photographs to the present-day visuals of the same locations, the transformation is striking. Narrow lanes that once saw camel carts and barefooted vendors are now crowded with vehicles and wires. Serene courtyards that once echoed with folk music now buzz with tourist chatter and mobile cameras. The majestic facades remain, but the rhythm of life around them has dramatically shifted.

Old images of places like Jaipur's Badi Chaupar or Udaipur's Ghats reveal quieter times—when space was respected, and silence was a presence. The grandeur of palaces wasn't obscured by billboards or traffic. Even modest homes carried ornate doors and hand-carved windows, speaking of a time when craftsmanship and community defined aes-

Today, while much of the architecture still stands, it's often surrounded by layers of commercial clutter. Development has come at a price-the loss of architectural purity, the encroachment on historical sites, and the fading away of oral traditions that once gave depth to these visual records.

REVIVING MEMORY THROUGH THE LENS

Many modern-day photographers and artists are now revisiting these old images—not just for nostalgia, but to understand and interpret heritage in the current context. Some recreate







the same frame from the same angle to show "then vs. now." Others juxtapose traditional elements with modern symbols to comment on cultural continuity or disruption.

These efforts aren't simply artistic—they are part

of a larger movement to document heritage before it disappears. As towns modernize and villages urbanize, traditional crafts, rituals, and ways of life are vanishing quietly. Photography becomes a tool to pause time and pay attention. In some cases, early

black-and-white photographs have even been hand-coloured or digitally enhanced, breathing new life into fading visuals. The process of restoration itself becomes a dialogue between generations—one that encourages viewers to reflect not only on what has changed, but what must be preserved.





PHOTOGRAPHS AS TOOLS OF HERITAGE CONSERVATION

Photographs have also played an instrumental role in heritage conservation efforts across Rajasthan. Old images serve as references for restoring havelis, temples, and public buildings to their original design. The intricate jharokhas, painted ceilings, and mosaic floors of old buildings are often lost or damaged—but photographs help artisans reconstruct them faithfully.

For instance, many palace museums across Rajasthan use early photographs to curate exhibits, restore dress styles, or even revive

lost practices. Photographs of ceremonial processions, religious rituals, or royal attire have helped bring back traditional festivals and community events in their authentic form.

Moreover, educational institutions and cultural organizations increasingly use vintage images to teach history—not through textbooks, but through visual storytelling. When students see images of how their city looked 100 years ago, history becomes more tangible and personal.

UAE WARNS AGAINST ISRAELI ANNEXATION OF WEST BANK

Israeli strikes across the Gaza Strip overnight and into Wednesday killed at least 31 people

he United Arab Emirates on Wednesday warned that any Israeli move to annex the occupied West Bank would be a "red line," without specifying its possible impact on the landmark normalization accord between the two countries.

The warning came as Israel pressed ahead with the initial stages of its latest major offensive, in faminestricken Gaza City. Israeli strikes across the Gaza Strip overnight and into Wednesday killed at least 31 people, according to local hospitals.

Israelis took part in nationwide demonstrations to protest the call-up of 60,000 reserves for the expanded operation, which has sparked global condemnation and left the country increasingly isolated.

The demonstrators accused Prime Minister Benjamin Netanyahu of prolonging the fighting for political purposes instead of reaching

a ceasefire deal with Hamas that would free hostages taken in the Oct. 7, 2023, attack that ignited the war.

The UAE was the driving force behind the 2020 Abraham Accords brokered by U.S. President Donald Trump, in which it and three other Arab countries forged ties with Israel. Trump has said he hopes to expand the accords in his second term, potentially to include regional power Saudi Arabia.

Anwar Gargash, a senior Emirati diplomat, wrote on the social platform X that "annexation is a red line." He linked to a Times of Israel story that quoted another Emirati diplomat, Lana Nusseibeh, as saving annexation would "severely undermine the vision and spirit of (Abraham) Accords, end the pursuit of regional integration and would alter the widely shared consensus on what the trajectory of this conflict should be -- two states living side by side in peace, prosperity and security."

It was unclear what action, if any, the UAE might take, and the Emirati Foreign Ministry did not respond to questions seeking clarifica-

Yemen's Houthi rebels target ship in Red Sea

DUBAI: A suspected attack by Yemen's Houthi rebels targeted a ship in the Red Sea on Thursday, officials said, as the militants increase their missile fire targeting Israel.

The attack off the coast of Hodeida follows an Israeli strike last week that killed the rebels' prime minister along with several officials. The Houthis have been using cluster munitions in the missile attacks on Israel — which open up with smaller explosives that can be harder to intercept, raising the chances of strikes as Israel prepares for a new ground offensive in its war on Hamas that's decimated the Gaza Strip.

The attack Thursday saw an "unknown projectile" land off the side of a vessel as electronic interference was particularly intense, the British military's United Kingdom Maritime Trade Operations center said. It added that the ship and crew were safe after the apparent assault.

The private maritime security firm Ambrey also acknowledged the apparent attack, as did the firm EOS Risk Group, which noted the Houthis have launched multiple missile attacks targeting Israel in recent days as well.

"The current tempo reflects a clear escalation, shifting from sporadic launches to multiple daily attempts," said Martin Kelly of EOS Risk Group.

The Houthis did not immediately claim the apparent attack, though it can take hours or even days for them to acknowledge their assaults.

'If Zelenskyy is ready, he can come to Moscow': Putin

Russian President Vladimir Putin on Wednesday (local time) expressed his openness to meet Ukrainian President Volodymyr Zelenskyy, suggesting that such a meeting could take place in Moscow, provided that the meeting is well-prepared and aimed at producing a constructive outcome.

During a press briefing following his four-day visit to China, Putin emphasised the possibility of dialogue amid the Russia-Ukraine conflict, reiterating that he has "never ruled out" such a meeting, but stressed it must be in line with Ukraine's constitutional framework. "I've already said that I've

never ruled out such a meeting, but whether this can be meaningful in accordance with the Ukrainian constitution... It is possible; I never rule this out. If the meeting is well prepared and if it leads to a positive potential outcome, it is possible. And by the way, Donald (Trump) asked me if it's possible to have such a meeting, and I said that it is. After all, if Zelenskyy is ready, he can come to Moscow. This is quite pos-



sible," he stated.

The Russian president also weighed in on Ukraine's right to sovereignty, including its freedom to choose its own security arrangements.

However, he added a significant caveat, arguing that "no country can ensure its security at the expense of another country, such as

Putin also repeated Moscow's longstanding objection to Ukraine's potential NATO membership, calling it a direct threat to Russian national interests, while showing less resistance to Ukraine's European Union ambitions.

"I concur with those who say that every country has the right to choose how to ensure its security, and it's true for every country, including Ukraine. But it also means that no country can ensure its security at the expense of another country, such as Russia. We always opposed the idea of Ukraine becoming a member of the North Atlantic Alliance, but we never doubted its right to engage in its economic activities in any way it likes, and that includes EU membership," he stated.

Following his remark, the Minister of Foreign Affairs of Ukraine, Andrii Sybiha, slammed the Russian President, accusing him of not accepting proposals given by "at least seven countries" to host the talks, while calling his proposal "knowingly unacceptable".

"Right now, at least seven countries are ready to host a meeting between leaders of Ukraine and Russia to bring an end to the war. Austria, the Holy See, Switzerland, Turkiye, and three Gulf states. These are serious proposals and President Zelenskyy is ready for such a meeting at any point of time. Yet, Putin continues to mess around with everyone by making knowingly unacceptable proposals.

Bangladesh bans war crimes suspects from fighting elections

Bangladesh's interim government on Thursday said it has incorporated a new clause in the International Crimes (Tribunal) Act 1973 to disqualify a candidate from contesting an election if a chargesheet is filed against the person for committing crimes against humanity.

Chief Adviser Muhammad Yunus's press secretary, Shafiqul Alam, said the new clause was included to prevent anyone formally contesting parliamentary elections or remaining in or applying for government jobs."According to the newly added section, if a person is formally charged under Section 9 (1) of the said law, they

will be disqualified from being elected or continuing as a Member of Parliament," Alam said.

He said a new provision, Section 20C, has been added to the International Crimes Tribunal Act. According to the provision, anyone against whom a formal charge sheet is filed under the Act will be disqualified from being elected or remaining a member of parliament.The same restriction applies to holding or contesting positions in local government bodies-including member, commissioner, chairman, mayor, or administrator. Such individuals will also be barred from receiving appointments or employment in the service of the republic or in any other institution.

Sudan's latest tragedy counts a village wiped out by a landslide

A devastating landslide that killed an estimated 1,000 people in Sudan's Darfur region struck as the northeastern African nation reels from a civil war that pushed some of its parts into famine.

The nation of over 50 million people has a long history of conflicts, including the one that created South Sudan in 2011. It's also known for its seasonal flooding that kills hundreds of people every year. Climate change has made the rainfall and flooding more deadly and destruc-

After days of heavy rainfall, a landslide on Sunday wiped out the village of Tarasin in the Marrah Mountains area, more than 900 kilometers (560 miles) west of the capital,

Khartoum.

At least 1,000 people were killed, and only one of the residents survived, according to the Sudan Liberation Movement-Army, a rebel group that controls the area.

The group's spokesman Mohamed Abdel-Rahman al-Nair said search efforts were underway and that about 100 bodies were recovered as of Tuesday evening. The U.N. humanitarian coordinator

in Sudan, Luca Renda, said "between 300-1,000 people may have lost their lives," citing local sources.Marrah Mountains, where the village is located, are hard to reach. The UNESCO World Heritage site is located in a volcanic area with a summit of 3,000 meters (9,840 feet). The landslide happened in the peak of Sudan's flooding season, which runs from July

4.8 magnitude quake strikes Afghanistan again

An earthquake of magnitude 4.8 struck Afghanistan again on Thursday, a statement by the National Center for Seismology (NCS) said.

As per the statement, the earthquake struck at a depth of 135km.

In a post on X, the NCS said, "EQ of M: 4.8, On: 04/09/2025 10:40:56 IST, Lat: 34.38 N, Long: 70.37 E, Depth: 135 Km, Location: Afghanistan." Earlier, an earthquake struck Afghanistan late Wednesday night at a shallow



depth of 10km, making it susceptible to aftershocks. In a post on X, NCS said, "EQ of M: 4.3, On: O3/O9/2O25 23:53:44 IST, Lat: 36.86 N, Long: 71.18 E, Depth: 10 Km, Location:

Shallow earthquakes are generally more dangerous than deep earthquakes. This is because the seismic waves from shallow earthquakes

have a shorter distance to travel to the surface, resulting in stronger ground shaking and potentially more damage to structures and greater casualties. Meanwhile, the World Food Programme (WFP) has sent emergency aid to Afghanistan's quake-stricken Kunar and Nangarhar provinces, where more than 1,400 people have been killed and over 3,000 people injured, Khaama Press reported.

Initial aid shipments include food supplies and high-energy biscuits, with additional flights scheduled to deliver further assistance and personnel.

US approves \$32.5 million to Nigeria to help address hunger

The United States has approved \$32.5 million in assistance to Nigeria to help address hunger, in a rare shift in U.S. foreign policy since President Donald Trump suspended most aid through the U.S. Agency for International Development.

The funding will provide food assistance and nutritional support to internally displaced people in conflict-affected areas, the U.S mission to Nigeria said in a statement Wednesday.

Insecurity and funding cuts have put northern Ni-

precedented hunger crisis" food and force the closure that could leave more than of 150 nutrition clinics in Borno state, Margot van der Velden, the World Food Program's regional director for West Africa, said in July. In July, the WFP suspend-

ed food assistance across crisis-hit West and Central African countries as a result of U.S. and other global aid cuts that are grinding its operations to a halt.

Food stocks were projected to end around September for most of the affected countries, leaving millions of vulnerable people potentially without emergency aid, according to the WFP.



food and nutrition assistance to 764,205 beneficiaries across north-east and northwest of Africa's most populous country.

"This includes complementary nutrition top-ups for 41,569 pregnant and breastfeeding women and girls and 43,235 children through electronic food vouchers," it said.

In recent months, there has been an uptick in attacks on communities in the northwest and north-central regions of Africa's most populous country, where farmers often clash over limited access to land and water.



US REAFFIRMS TROOPS' PRESENCE IN POLAND Trump threatens phase-3 sanctions roll out

US-Poland defense ties spotlighted in Washington.

'S President Donald Trump on Wednesday reaffirmed a robust US military presence in Poland during a meeting with Polish President Karol Nawrocki at the White House, amid rising concerns over the ongoing Russia-Ukraine conflict, Euro News reported.

Trump, who had endorsed Nawrocki during Poland's presidential election earlier this year, said, "We'll be staying in Poland. We're very much aligned with Poland," adding, "We'll put more there if they want.

During the meeting, Nawrocki thanked Trump for his support and highlighted the strong bonds between Poland and the United States. He said, "Those relations for me, for Poland, for Poles, are very important," adding

that these ties are based on shared values of independence and democracy. Euro News reported.

Trump lauded Nawrocki's electoral victory, noting, "It was a pretty tough race, pretty nasty race, and he beat them all. And he beat them all very easily, and now he's become even more popular as they got to know him and know him better.'

The visit comes as Trump continues to express frustration over his inability to bring Russian President Vladimir Putin and Ukrainian President Volodymyr Zelenskyy to the negotiating table to end the war. "Maybe they have to fight a little longer," Trump told

the conservative Daily Caller. "You know, just keep fighting -- stupidly. keep fighting," Euro News reported.

Last month, Trump met with both Putin in Alaska and Zelenskyy alongside several European leaders at the White House. While Putin expressed willingness to meet Zelenskyy in Moscow, Kyiv swiftly rejected the proposal, Euro News added. The White House en-

gagement also included a display of US military strength, with F-16 jets flying in a missing man formation over the South Lawn as a tribute to Polish Air Force pilot Major Maciej "Slab" Krakowian, who died in a crash in Poland on August 28. Nawrocki expressed gratitude for the gesture, saying, "Thank you for this gesture."

Trump previously emphasized closer military ties with Poland, hosting Nawrocki at the White House before the election and promising support to ensure Poland could "fight off enemies that do not share your values," Euro News reported

Currently, approximately 8,200 US troops are stationed in Poland, though Pentagon officials note that troop levels fluctuate. While some advisers favor shifting US forces to the Indo-Pacific, Trump reaffirmed continued commitment to Europe, describing the US-Polish relationship as "better than ever."

Nawrocki, backed by the conservative Law and Justice party, has tense relations with Prime Minister Donald Tusk's government but promises to maintain support for Ukraine. He has criticized Zelenskyy and expressed concerns over Ukrainian refugees taking advantage of Poland's social services, prioritizing Polish citizens for healthcare and schooling.

President Donald Trump on Wednesday warned that the United States has not yet rolled out "Phase-2" and "Phase-3" tariffs against countries continuing trade ties with Russia. He called secondary sanctions on India a direct action against Russia, as "that cost hundreds of billions of dollars to Russia".

He said this when being asked about why he has taken no action against Russia after he assumed the Oval Office in January this year.

He also called India the largest buyer of Russian oil after China, indicating that New Delhi could face further penalties if it continues energy imports from Moscow.

While the US has temporarily suspended additional tariffs on China until November. India has been hit with steep levies. A 25 per cent tariff was imposed ear-

lier this month, and an additional 25 per cent secondary sanction took effect on August 27, bringing the total to 50 per cent on Indian goods.

Trump further mentioned that these steps amounted to direct action against Russia, as they target its oil exports through major buyers.

"Would you say that by putting secondary sanctions on India, the largest purchaser outside China, they are almost equal. Would you say there was no action? That cost hundreds of billions of dollars to Russia, you call that no action? I haven't done Phase-2 yet or Phase-3," Trump told reporters during a joint press conference with the Polish President at the White House.

The US president recalled his earlier warning that India would face "big problems" if it continued Russian oil purchases. "Two weeks ago, I said if India buys, India will have big problems, and that's what will happen," Trump added.

Earlier, in a separate interview, Trump claimed that New Delhi has offered him a "no tariff" deal following Washington's decision to raise duties on Indian goods. Speaking on The Scott Jennings Radio Show, he said, "India was the most highly tariffed nation in the world, and you know what, they've offered me no tariffs in India anymore. If I didn't have tariffs, they would never make that offer."

UC-Berkeley professor flags risks in US-South Korea agreement

Maurice Obstfeld, a renowned economist and professor emeritus at the University of California, Berkeley, has expressed concerns over 'uncertainties surrounding' the South Korea-US trade agreement, announced in July 2025, under which South Korean goods will be subject to a 15 per cent tariff, while US exports will not face duties, as per the Maeil Business Newspaper. While addressing a press conference on Wednesday, during his visit to Korea for the 2025 G20 Global Financial Stability Conference, he said, "What is concerning is that there can be very different interpretations of the agreement between Korea and the United States." "Details such as the structure of profit-sharing and who will be responsible for investment have not been spelled out," he added. Obstfeld, who has held prominent positions

such as chief economist at the International Monetary Fund and a member of the White House Council of Economic Advisers under President Barack Obama, noted that Washington, DC, will likely "make new demands if the trade situation does not improve." Obstfeld also highlighted the difference in negotiation approaches between the past and present US administrations,

Maeil Business Newspaper reported. "During Donald Trump's first term, negotiations were conducted in a reliable way thanks to US Trade Representative Robert Lighthizer," he said. "But this time it was not the case. Washington will likely make new demands if the trade situation does not improve to the level it wants on a monthly or quarterly basis." As for potential new US demands, Obstfeld pointed to exchange rates. "While America's high-tariff policy drives down the value of the Korean won, the US wants the won to appreciate," he said. "However, a Mar-a-Lago-style agreement to forcibly push up the won will not happen."

According to Maeil Business Newspa-Global South. per, Obstfeld emphasises the importance of maintaining healthy trade relations with China, stating, "China is a hugely important trade partner for Korea, and if trade relations with China sour, the Korean economy will pay a high price."

Finnish president warns West: Cooperate or lose

New Delhi is facing global uncertainties due to heightened economic tensions following the US imposition of a 50 per cent tariff on Indian imports, which was supplemented by an additional 25 per cent due to New Delhi's purchase of Russian crude

Russia denies GPS jamming allegations

Russia has strongly rejected claims that it attempted to jam the GPS system of a plane carrying European Commission President Ursula von der Leyen.

At a press briefing on Thursday, Russian Foreign Ministry spokeswoman Maria Zakharova called the allegations "preposterous" and "100% false," RT reported.

Zakharova said Moscow will continue to combat "the West's web of lies" aimed at discrediting Russia on the world stage, suggesting the claims were intended to distract the public from "actual events," including problems in the EU's economy and the recent summit of the Shanghai Cooperation Organization in Tianjin, China, which concluded on Monday.

Zakharova cites Flightradar 24 signal data; Bulgaria declines probe as von der Leyen visits Polish-Belarusian border with Tusk.

ing to RT. Since 2024, Nordic and Baltic countries have accused Russia of disrupting communications on planes and ships as part of "hybrid warfare," allegations Russia has consistently denied.

Amid these claims, von der Leven and Polish Prime Minister Donald Tusk arrived at the Polish-Belarusian border on Sunday, where they discussed defence and security, among other issues, highlighting continued EU focus on regional stability, Euro News reported.

Peru sentences ex-president MK Stalin, UK sign six investment pacts Alejandro Toledo

A Peruvian court has sentenced former President Alejandro Toledo to 13 years and four months in prison for money laundering, his second conviction linked to widespread corruption, Al Jazeera report-

Toledo, who served as president from 2001 to 2006, was found guilty of using bribe money from the Brazilian construction giant Odebrecht, now known as Novonor, to acquire highvalue real estate.

According to prosecutors, Toledo and his wife used \$5.1 million to buy a house and an office in an upscale Lima neighbourhood and to pay off mortgages on two other properties. The funds were funnelled through an offshore company in Costa



Illegal Betting App Case: ED Summons cricketer Shikhar Dhawan

he Enforcement Directorate has summoned former Indian cricketer Shikhar apps, several of which have Dhawan on Thursday for allegedly duped thousands questioning in connection with a money laundering probe linked to the betting app 1xBet.

Dhawan, 39, will appear before investigators as his statement is to be recorded under provisions of the Prevention of Money Laundering Act (PMLA). The federal agency is examining his alleged association with the app, which has been declared "illegal" in India.

According to sources, the left-handed opener came under the agency's scanner after his name surfaced in connection with endorsements tied to the platform. Officials are keen to understand the extent of his links with the betting company and the nature of any financial transactions involved.

WIDER PROBE INTO BETTING APPS

The ED has been pursuing multiple cases related to illegal betting and gaming of users of large sums or evaded substantial taxes. The investigations are spread across states and involve networks suspected of laundering crores of ru-

SC Expresses concern about floods in Himalayan States; Observes there's illegal felling of trees

The Supreme Court on Thursday raised alarm over the scale of destruction caused by recent floods and landslides in the Himalayan states, remarking that illegal felling of trees may have worsened the disaster.

A bench headed by Chief Justice of India B R Gavai, with Justice K Vinod Chandran, referred to disturbing visuals from Himachal Pradesh showing timber logs tumbling down with the floodwaters. "Prima facie, it appears there has been rampant cutting of trees in the hills," the bench said, terming the situation a matter of "grave concern."

COURT PULLS UP AUTHORITIES

The bench issued formal notices to the Union ministries of Environment and Jal Shakti, the National Disaster Management Authority (NDMA), the National Highways Authority of India (NHAI), and the state governments of Punjab, Himachal Pradesh, Uttarakhand, and Jammu and Kashmir. The matter will be heard again in two

CJI Gavai pointed out that villages and farmlands in Punjab had been wiped out in the floods. "Development has to be balanced," he cautioned, stressing the need for sustainable planning in fragile ecological

The court requested Solicitor General Tushar Mehta

to take stock of the situation with the environment ministry and state officials. "It appears a serious issue.

A large number of wooden logs were seen floating around, showing illegal felling of trees," the bench told him.

Mehta acknowledged the concern, remarking, "We have interfered with nature so much that now nature is giving back."

PUBLIC INTEREST



PLEA ON HIMALAYAN ECOLOGY

The remarks came during the hearing of a petition filed by Anamika Rana, who sought stronger safeguards for the Himalayan ecosystem. The plea urged the top court to set up a Special Investigation Team (SIT) or frame guidelines to prevent disasters of this nature in the future.

The petition argued that both the Centre and states have failed to prepare meaningful disaster management plans despite having dedicated authorities in place. It blamed reckless hill road construction, encroachment on water bodies, and neglect of environmental regulations for increasing the frequency of landslides and flash floods.

CALL FOR EXPERT COMMITTEE

The PIL also asked for an independent expert panel of geologists and environmental scientists to examine road and highway projects in landslide-prone areas. It sought an inquiry into environmental laws. breaches in development guidelines, and accountability of officials connected with projects between 2023 & 2025.

According to the petitioner, protecting the fragile Himalayan ecology is essential not only for disaster prevention but also for enforcing citizens' fundamental rights to life and equality under Articles 21 and 14 of the Constitution.

SC QUESTIONS ENFORCEMENT OF PHARMA MARKETING NORMS

The Supreme Court on Thursday expressed concern over the enforcement of rules regulating drug marketing practices, observing that the real challenge lies not in framing norms but in ensuring their proper implementation.

The Uniform Code for Pharmaceutical Marketing Practices (UCPMP) 2024 came into force last year, aimed at regulating how companies promote medicines. SC FLAGS ILLEGAL TREE CUTTING IN FLOOD AREAS; SG SAYS NATURE IS HITTING BACK

The Supreme Court on Thursday issued notices to Punjab, Uttarakhand, Himachal Pradesh, and Jammu and Kashmir over the devastation caused by heavy rains and floods.

A bench led by Chief Justice B.R. Gavai expressed serious concern, noting that 'we have seen unprecedented rains and flooding.' CJI Gavai observed that

prima facie it appears to be a case of large-scale illegal felling of trees in the hilly regions.

Referring to media reports and videos showing huge numbers of timber logs washed down by floodwaters in Himachal Pradesh, the Court said this indicated possible human-made aggravation of the natural disaster.

The bench directed the states to file their responses within 3 weeks.

He submitted that the petitioner was "very sick" and in urgent need of medical attention outside prison.

The court, however, declined to extend interim bail and instead scheduled the

Shabir Shah's plea for bail matter for detailed hearing after two weeks

COURT'S EARLIER DECISION

Shah had earlier approached the Delhi High Court seeking bail in the case but faced rejection on June 12 this year. The high court had observed that releasing him could not be considered safe, as there remained a likelihood of him indulging in unlawful activities and attempting to influence witnesses.

The court underlined the seriousness of the allegations and the possible impact of his release on the ongoing trial, which involves sensitive charges relating to terror financing and conspiracy.

CASE BACKGROUND

The NIA arrested Shabir Shah on June 4, 2019, in connection with its investigation into a wider conspiracy

case. The probe was initiated in 2017, when the agency registered a case against 12 individuals for allegedly raising and collecting funds to foment unrest in Jammu and Kashmir.

The charges include using the funds to instigate stone pelting, damaging public property, and conspiring to wage war against the Government of India. According to the NIA, the accused were part of a larger network that sought to destabilize the region by channeling money into disruptive activities.

Shah, who has been in custody for more than four years, has consistently denied the allegations against him. His legal team maintains that the charges are

politically motivated and that his prolonged incarceration without bail is unjustified, especially given his deteriorating health.



The final ticket prize for an IPL match, which has a base prize of Rs 1,000, will now be upto Rs 1,280-1,400, as per ESPNCricinfo. This raise puts the IPL in India's highest GST bracket, alongside casinos,

The group winners will qualify for the AFC Asian Cup Saudi Arabia 2027.
