A day before PM Modi's flood survey, Punjab rolled out its highest-ever relief package for affected farmers and families.

day before Prime Minister Narendra Modi's scheduled visit to Punjab, Chief Minister Bhagwant Mann on Monday unveiled a landmark relief package for farmers, labourers, and residents severely affected by the recent floods. The measures include Rs 20,000 per acre compensation for crop damage — the highest such assistance announced by any state — and ex-gratia of Rs 4 lakh to families who lost members in the disaster.

Under the newly introduced "Jiska Khet, Uski Ret" scheme, cultivators will also be permitted to commercially utilise and sell the sand deposited in their fields by floodwaters,

turning a liability into an income opportunity. The package further provides financial aid for collapsed or structurally damaged houses, a six-month moratorium on farm loan repayments with full interest waiver, and targeted sup-

port for livestock rearers, including a state-sponsored vaccination drive. Fogging machines will be deployed across 1,700 villages to combat post-flood vectorborne diseases.

SC orders Aadhaar inclusion in voter ID list; Congress slams ECI

The Supreme Court on Monday directed the Election Commission of India (ECI) to include Aadhaar as the 12th acceptable document for establishing identity during the revision of electoral rolls, while clarifying that it cannot be treated as proof of citizenship.

A bench of Justices Surya Kant and Joymalya Bagchi instructed the ECI to issue clear guidelines to officials, stressing that the authenticity of Aadhaar must be verified and forged documents rejected. The court's clarification came after concerns raised by opposition leaders, who argued that the poll panel's earlier stand created

Senior advocates Kapil Sibal and Abhishek Manu Singhvi contended that Aadhaar should be accepted to prevent eligible voters from being excluded, but reiterated that only citizenship confers voting rights. The ECI informed the court that Aadhaar would serve solely as proof of identity, alongside the 11 existing documents such as passport, birth and residence certificates.

Reacting sharply, Congress accused the ECI of 'brazen non-compliance" with the apex court's directions. Party general secretary Jairam Ramesh said the Commission was deliberately creating obstacles in voter registration, citing its refusal to accept Aadhaar earlier and its restrictions on party-appointed boothlevel agents.

"This is a mess of the Election Commission's own making," Ramesh posted on X, adding that the CEC "shall not be forgiven by history" for undermining electoral fairness.

Pakistani intruder caught at Indo-Pak border

In a major security development, the Border Security Force (BSF) on Monday foiled an infiltration attempt along the Indo-Pak international border in the R.S. Pura sector, apprehending a Pakistani national. The incident occurred near the Border Out Post (BOP) Octroi, opposite Pakistan's BOP Inayat, under the jurisdiction of the 165th Battalion BSF.

According to security sources, vigilant BSF personnel spotted a youth moving suspiciously towards the border fence from the Pakistani side. When challenged, the intruder continued advancing, prompting BSF troops to detain him before he could breach the

The individual was taken into custody, and initial interrogation suggested he appeared mentally unstable. However, security agencies are treating the matter with



the utmost seriousness. Sources confirmed that the arrested intruder has been identified as a resident of Sarkoda in Pakistan, a location of strategic importance that was targeted by the Indian Air Force during Operation Sindoor.

This revelation has prompted senior BSF officials and other security agencies to personally question the suspect. Intelligence officials are investigating whether his movement was part of a reconnaissance mission, a test of border alertness, or linked to a larger infiltration plan. Given Sarkoda's strategic

significance and the heavy

damage it sustained during Indian strikes, authorities are keen to determine whether the intruder acted independently or was dispatched on a mission.

"The line of questioning aims to establish whether this infiltration attempt had a deeper operational purpose or was merely a diversionary move," a source familiar with the interroga-

Senior BSF officials emphasised that no infiltration attempt is taken lightly. "The border is under round-theclock surveillance, and any misadventure from across will be dealt with firmly," an officer stated.

The arrest underscores Pakistan's repeated attempts to push individuals across the border, despite heightened security and constant vigilance by Indian forces. The R.S. Pura, Arnia, and Samba sectors remain particularly sensitive, with past instances of infiltration and cross-border activity.

The National Investigation Agency (NIA) has intensified its crackdown on terror funding and conspiracy networks in Jammu and Kashmir, conducting multiple raids across South and North Kashmir.

Early Monday morning, NIA teams, assisted by local police and CRPF personnel, carried out searches in Kulgam and Pulwama districts. In North Kashmir, a major raid was conducted at the residence of Umer Rashid Lone in Zangam village of Pattan town, Baramulla district. These operations are part of an ongoing probe into terror financing and militant networks.

The latest action follows a major operation on June 5, 2025, when the NIA searched 32 locations across

Israel economist calls India-US 50% tariff 'temporary'

Israel's Ministry of Finance Chief Economist Shmuel Abramzon on Monday described the ongoing 50 per cent US tariff on Indian imports as likely "temporary" and expressed confidence that India and the United States would reach an agree-

US President Donald Trump warned that "Phase-2" and "Phase-3" tariffs could still target countries continuing trade with Russia, singling

out India as the world's second-largest buyer of Russian oil after China. He said these measures have cost Russia "hundreds of billions of

dollars."

Trump also noted that India had offered a "no tariff" deal following Washington's initial tariff hike and reiterated that tariffs are crucial to correcting trade imbalances. "China kills us with tariffs, India kills us with tariffs, Brazil kills us with tariffs. I've understood tariffs better than any human beings in the world," he said. The US president de-

scribed the bilateral trade relationship as a "one-sided disaster," claiming India had benefited disproportionately over decades while American firms faced high barriers entering the Indian market.

PM MODI ASKS NDA MPS TO HOLD 'SWADESHI MELA', SAYS SELF-RELIANCE TO POWER INDIA'S RISE

rime Minister Narendra Modi on Monday asked the ruling NDA MPs to organise 'Swadeshi Mela' to promote made-in-India products and hold meetings with traders over the GST rate cuts.

'Swadeshi' was the main theme of his speech to the MPs at the meeting held on the eve of the vice presidential election.

Sources said PM Modi asserted that the GST rate cuts by his government have generated a "lehar" (wave) and asked MPs to build on it by spreading the message to the masses by holding meetings with them.

He stressed the need for promoting made-in-India products by holding special fairs in their constituencies, the sources said.

PM Modi advised MPs to see to it that they vote in a correct manner in the vice presidential polls on Tuesday so that no vote is wasted, the sources said.

The Prime Minister emphasised the theme "Garv se kaho ye swadeshi hai"

and mentioned that the MPs should organise 20 to 30 trader conferences in their respective constituencies so that traders and shopkeepers can be educated and briefed about the GST

During the meeting, PM Modi said that the MPs could organise 'Swadeshi Melas' during Diwali and Navaratri to promote Indian products and encourage people to buy them.

He stated that each MP should organise an exhibition in every sector of their constituency and showcase local artisans, micro and small industries, and indigenous products.

According to Sources, Prime Minister Modi said that the GST reform is revolutionary and its benefits should reach every individual, especially in the trade sector. He asked all MPs to spread awareness about

GST reforms among all sections of society, including women, students, traders, and others. He suggested organizing programs in various places to disseminate this information. Additionally, PM Modi

mentioned that India's concept of Swadeshi (indigenous) has evolved beyond just the traditional spinning wheel. From the charkha to advanced projects like Brah-Mos, India has embarked on a journey of self-reliance (Atmanirbharta). He emphasized the need to take this message to every citizen, highlighting the benefits of this approach. Meanwhile, earlier on Au-

gust 25, Prime Minister Narendra Modi urged citizens to prioritise the purchase of 'Made in India' products during the upcoming festive season, stressing that buying indigenous goods during festivals like Navratri, Vijayadashami, Dhanteras and Diwali would contribute to the country's self-reliance and economic progress.

Addressing a public gathering after inaugurating and laying the foundation stone for multiple development projects in Ahmedabad, the Prime Minister reiterated his call for 'Swadeshi', appealing to both businesses and individuals to opt for locally manufactured items to drive national prosperity.

"This is the season of festivals. Now Navratri, Vijayadashami, Dhanteras, Diwali... all these festivals are coming. These are celebrations of our culture, but they should also be celebrations of self-reliance. Therefore, I want to reiterate my request to you once again that we must adopt a mantra in our lives: whatever we buy will be 'Made in India', it will be indigenous. I appeal to the citizens of our country to prioritise purchasing goods that are 'Made in India'. Whether it's decorative items or gifts, let us choose products manufactured within our own nation," PM Modi said.

He encouraged businesses to refrain from selling imported items, adding, "These small yet impactful steps can play a significant role in driving our nation's progress and prosperity."

In Bihar, the Ganga at Patna, Bhagalpur, Munger, and Saran, the Kosi at Supaul and Khagaria, the Gandak at Vaishali, and the Burhi Gandak at Khagaria are in severe flood situations.

Kulgam encounter: One terrorist killed, ICO injured in ongoing operation

A fierce gunbattle erupted early Monday morning in the Guddar forest area of South Kashmir's Kulgam district, resulting in the killing of one terrorist and injuries to a Junior Commissioned Officer (JCO) of the Indian Army.

The anti-terror operation was launched jointly by the Indian Army, Jammu and Kashmir Police, and the Central Reserve Police Force (CRPF) after receiving specific intelligence inputs regarding the presence of terrorists hiding in the dense

As per officials, security forces advancing into the area came under sudden fire, triggering a retaliatory response. In the exchange, a JCO from the elite 10 PARA unit was injured and later evacuated for medical treatment. His condition is said to be stable

"Based on specific input by JKP, a joint operation was launched by the Army,

Police and CRPF in the Guddar forest of Kulgam. Troops spotted suspicious movement and were fired upon, prolonged anti-terror operaleading to a heavy exchange. One terrorist has been killed, and a JCO has sustained injuries. The operation is still underway." a statement from Chinar Corps said.

The identity of the slain terrorist is yet to be confirmed. The entire area remains under a tight security cordon, with more reinforcements rushed in to plug possible escape routes.

It is worth noting that this

is the second major encounter in the Guddar forest area this year. Earlier, in July, a tion in the same region had lasted nearly 15 days. That operation led to the elimination of multiple foreign terrorists and was marked by difficult terrain, dense forest cover, and unpredictable weather, making it one of the most challenging in recent times.

Security forces remain on high alert as the current operation continues. Further updates are expected.

Two army personnel martyred, operation still underway

Two Indian Army personnel have lost their lives in an ongoing anti-terror operation in the Guddar forest area of South Kashmir's Kulgam district, officials confirmed late Monday

The encounter, which began in the early hours of the day, broke out after a joint team of the Indian Army, Jammu and Kashmir Police, and the CRPF launched a cordon-andsearch operation based on specific intelligence inputs about the presence of terrorists hiding in the forested region.

As the search team closed in on the suspected hideout, they came under heavy fire. A fierce gunbattle ensued in which a Junior Commissioned Officer (JCO) and a soldier from the elite 10 PARA unit sustained critical injuries. Despite being evacuated for

treatment, both succumbed to their wounds later in the

"Two brave soldiers made the supreme sacrifice in the line of duty during an ongoing anti-terror operation in Kulgam.

Their valour and commitment will never be forgotten," an official said.

So far, two terrorists has been neutralized in the operation. Their identity and affiliation are vet to be officially confirmed. The area remains under tight security, with reinforcements deployed to prevent any escape and to continue the search for possible additional terrorists.This is the second significant encounter in the Guddar forest area this year. In July, a prolonged 15-day operation in the same region resulted in the killing of multiple foreign terrorists and highlighted the challenging terrain and intensity of militant activity in the area.

extreme climate events and a discernible slowing down of the SDG Agenda. In the face of these challenges, the multilateral system appears to be failing the world. That so many serious stresses are being left unaddressed is understandably having consequences for the global order itself. It is this cumulative concern that the BRICS is now discussing," he said. The Union Minister said trade patterns and market access are today prominent issues in the global economic discourse.

"The world requires constructive and cooperative approaches to promote trade that is sustainable. Increasing barriers and complicating transactions will not help. Neither would the linking of trade measures to non-trade matters. The BRICS itself can set an example by reviewing trade flows among its member states. Where India is concerned, some of our biggest deficits are with BRICS partners and we have been pressing for expeditious so-

We hope that this realization will be part of the takeaways from today's meeting," he said.

"The international trading system is based on the foundational principles of open, fair, transparent, nondiscriminatory, inclusive, equitable and a rules-based approach with Special and Differential Treatment for developing countries. India strongly believes that this should be protected and nurtured," he added.

Ahead of PM visit, AAP seeks Rs 20,000 cr flood relief for Punjab

As Prime Minister Narendra Modi is scheduled to visit flood-ravaged Punjab on Tuesday, the ruling AAP has demanded that he announces a relief package of Rs 20,000 crore for the border state. Punjab is currently facing one of its worst flood disasters in decades. The death toll due to the devastating floods



PM Modi will visit the stands at 48 while crops on state on September 9 to take 1.76 lakh hectares have been stock of the situation.

Modi was deeply concerned about the flood situation in Punjab and was closely monitoring it, Punjab BJP chief Sunil Jakhar on Sunday said.

On Monday, Punjab Cabinet ministers Aman Arora, Barinder Kumar Goyal and Dr Balbir Singh demanded that the PM should announce a relief package of at least Rs 20,000 crore for the state during his visit.

Jammu and Kashmir AAP chief and MLA Mehrai Malik was on Monday detained under the stringent Public Safety Act (PSA) for allegedly disturbing public order in Doda district, officials said. This is for the first time that a sitting MLA has been taken into custody under the PSA, an administrative law that allows detention without charge or trial for up to two vears in some cases

Earlier during the day, the

37-year-old AAP MLA was detained by police at Dak Bungalow while he was planning to visit flood-hit areas of his constituency, the officials

AAP MLA Mehraj Malik detained under PSA in JK's Doda

He was later shifted to Bhaderwah district jail under the PSA on the orders of the Deputy Commissioner of Doda, Harvinder Singh, after police prepared a dossier against him, they said.

The action against Malik, who has often courted controversies with his statements, comes amid a massive protest by government employees

who came out in support of the deputy commissioner after Malik used a social media platform to launch a disparaging campaign against him.

The protesting employees accused the MLA of "habitually" hurling abuses at senior government officers, including doctors, and provoking youths against the official machinery. In a statement, the protesting employees lauded the deputy commissioner for his "exceptional service, integrity and dedication to public welfare", and said his compassionate approach has

made him a 'beacon of hope' for the residents of Doda in general and the flood-affected population in particular.

They condemned the use of 'abusive language and baseless allegations' against the officer as 'unfortunate, deplorable and unacceptable' and slammed the 'uncivilised and irresponsible behaviour of the legislator. The officials said dozens of cases and complaints are registered against Malik for his 'uncultured' behaviour and fights with government officials in the hill district over the past one year.

Adityanath questions recruitments made during Samajwadi Party regime

Uttar Pradesh Chief Minister Yogi Adityanath on Monday questioned the recruitments made during the previous Samajwadi Party regime, and said that several appointments had to be probed by the CBI."What type of recruitment used to take place? We had to then hand over a number of recruitments which had taken

place to the CBI. Now, you are seeing that one person after getting himself appointed at eight places was drawing salaries. When this matter came to light during the probe," Adityanath said.

Without taking any names, the UP chief minister said, "Who are these people? These people are the ones from a family which used to take money from the people, recruit them, and loot the people of UP... The recruitment was in 2016. We have initiated a probe, the probe is going on and when the probe gets completed in time, a number of relations (mentioned) in the 'Mahabharat' will be compelled to spend the rest of their lives in jail.

"This is because their acts were such that they were continuously pushing UP downwards instead



of allowing it to touch the heights of development," he said.

proof. "On what basis is the State saying there is nothing suspicious? You must satisfy the conscience of this court," Justice Basak remarked, granting the State a week to submit a detailed account.

The court has already directed the State to provide call detail records for 17 individuals, including the IO, the officer-in-charge of Khejuri police station, and the first autopsy doctor. Records of the remaining persons—including members of the cultural programme committee-will also be scrutinised. "The common phone numbers have to be identified and placed before the court. Check all mobile numbers of these three per-

sons," the bench said. The judges also noted the discrepancy between the first and second postmortems, saying the unexplained differences raised broader questions of credibility. "There is a disconnect between the second PM report and the conduct of the investigation until then. This is about instilling public faith in the police," Justice Basak underlined.

The families of the deceased have demanded that the probe be moved out of State control and entrusted to the Central Bureau of Investigation (CBI), arguing that the CID, which took over the investigation last month on court orders, lacks independence in politically sensitive cases.

The next hearing is scheduled for September 15, when the State is expected to file a fuller account of the call records and explain the IO's

Air India Mumbai-Delhi flight performs go-around, lands safely on second attempt

An Air India flight from Mumbai to Delhi on Monday performed a go-around after an initial aborted landing but safely touched down on its second attempt, an official stated.

"Flight AI2910 operating from Mumbai to Delhi on 8 September, discontinued with landing and performed a routine go around at Delhi as per standard protocols. The aircraft landed safely

in its second attempt, and all passengers and crew have disembarked. At Air India, the safety of passengers and crew remains top priority," An Air India Express Spokesperson said in a statement.

Earlier on Friday, Air India Express flight 1028, which was operating from Delhi to Indore, made a priority landing at Indore Airport after the pilot detected a technical snag, an Air India spokesperson confirmed.

On Sunday, Air India CEO Campbell Wilson wrote letters to employees, highlighting the airline's progress in performance, customer experience, and network growth, while reaffirming the company's commitment to transparency and cultural transformation.

"Like all airlines, we faced a variety of operational scenarios--some of which were under our control, and some that were not." the CEO wrote, referring to



the crisis the airline faced following the AI171 plane crash in Ahmedabad earlier this year.

"When the spotlight was on us, it was crucial to offer timely, clear and accurate information and the right context," he wrote in the letters disseminated via email.

He acknowledged that Air India had deliberately been "more transparent than usual in reporting incidents and events, however small."

While this had temporarily increased news coverage, he emphasised that in the context of Air India's scale and size, the incidence rate was "entirely normal."

"This transparency will, over time, help build trust. In the short term, though, it naturally resulted in an uptick of news coverage, and with more than 1,200 departures every single day--nearly one every minute--across the Air India Group, it could seem like a lot.

The danger mark for the Yamuna in the city is 205.33 metres, while the warning level is 204.5 metres. Evacuations are generally initiated when the level reaches 206 metres.

With the level now receding, officials said the situation in the capital is gradually improving, though low-lying areas remain under watch.

The river was flowing above the danger mark last week, following heavy rainfall, leading to inundation in areas such as Monastery Market, Yamuna Bazaar, Vasudev Ghat and nearby residential colonies.

Pumps were deployed to clear floodwater, and residents of low-lying localities were shifted to relief camps near Mayur Vihar Phase-I as a precaution.

On Friday, Delhi Minister Parvesh Verma urged Yamuna River," he said. muna Bridge showed the people not to create unnecessary panic among citizens as he visited the Civil Lines area of Delhi amid the heavy rainfall in the national capital over

Delhi Police on Monday cracked a high-value courier parcel theft case involving 385 mobile phones worth approximately Rs 30 lakh and arrested four accused in connection with the case.

Delhi Police said that the accused in the case are Abhishek Singh (27), Vikas Singh Tomar (22), Kishan Chauhan (20), and Chetan Jha (28).

An E-FIR was registered at PS Karol Bagh on Friday under Section 303(2) BNS, following a complaint by a mobile phone trader from Siwan, Bihar. The complainant stated that he had been operating a mobile shop for the last 8-10 years and had ordered 385 new mobile phones from wholesalers in Karol Bagh, Delhi, on August 31.

The consignment was booked through BHR Courier, Bank Street, Karol The police team scanned hundreds of CCTV footages to trace the accused and the e-rickshaw used in the theft.

Bagh, and handed over to the complainant discovered Abhishek Singh, a courier that the parcels contained driver, for transport in an e-rickshaw to NDLS Railway Station for dispatch via Vaishali Express.

Nitish Katara murder case: SC declines to extend interim bail of Vikas Yadav

INDIA SET TO EMERGE AMONG WORLD'S **TOP THREE ECONOMIES: PIYUSH GOYAL**

Union Minister of Commerce and Industry Piyush Goyal on Monday said that India will become one of the world's top three economies in the coming two to two-and-a-half years, highlighting the country's rapid economic progress in recent years

Speaking at the Platinum Jubilee Celebrations of the **Engineering Exports Pro**motion Council (EEPC) at Vigyan Bhawan, Goyal highlighted India's journey from being one of the weakest economies a decade ago to now standing among the top five. "Under Prime Minister Narendra Modi's guidance, India has come from being one of the world's five weakest economies in 2014 to become one of the top five economies in 2025. In the coming two to two-

and-a-half years, India will become one of the world's top 3 economies," he said.

The event was attended by distinguished heads of mission from various countries and marked by the presence of the President of India, Droupadi Murmu.

The minister spoke about recent economic performance stating that India's GDP grew by 7.8 per cent in the last quarter, which he described as a record. He also projected that by 2047, India will become a 30 trillion-dollar economy. Goyal credited reforms such as the Goods and Services Tax (GST) for creating new opportunities. "The GST reform is very

extensive. With simplification and rate cuts, the country's economy will move forward even more. New job opportunities will increase. People will spend more. We must ensure that the benefits of GST rate cuts reach consumers," he said.

The event was attended by distinguished heads of mission from various countries and marked by the presence of the President of India, Droupadi Murmu.

Speaking about EEPC, the minister pointed to the role of engineering exports in the country's growth story. "In 1970, EEPC exported goods worth 10 million dollars. Today, EEPC has reached 116 billion dollars in exports," Goval said.

He stressed the need for high-quality products to be manufactured and sold within the country, urging people to strengthen their preference for indigenous goods, noting that the world's confidence in India should be met with faith at home, "We must keep the faith that the world shows in India today," Goyal add-

On sustainability, Goyal said India is committed to playing a responsible role in addressing climate change. "In the big challenge of global climate warming, India acts as a responsible global citizen. India has been among the top 3 in global sustainability efforts," he stated.

Goyal said the country has enough strength to face any challenge.

"No matter how big a challenge becomes, the country has enough strength; it neither fears nor bows down before any challenge," he

'India can disrupt Semicon race, lead in post-silicon tech with 2D materials'

India has the potential to disrupt the semiconductor race and emerge as a leader in post-silicon technologies by leveraging two-dimensional (2D) materials, according to a report released by the Indian government think-tank NITI Aayog.

The report highlighted that the convergence of semiconductor policy and 2D materials research presents an opportunity for comprehensive technological advancement. This convergence, it noted, could allow India to position itself at the forefront of the global semiconductor shift.

NITI Aayog stated, "2D materials research presents an opportunity for comprehensive technological advancement that could provide India an opportunity to disrupt the Semicon race."

Explaining the 2D mate-

rials, the report stated that picture smartphones that fold like paper yet remain unbreakably resilient, or displays so thin they disappear into the surface.

Imagine ultra-efficient CPUs and GPUs that run faster and cooler, drastically cutting energy consumption and extending battery life by days. This is the groundbreaking potential of 2D materials.

2D materials are crystalline substances with a thickness of one to a few atomic layers, typically less than 1 nanometer.

Their atomically thin structure, extending in two dimensions with minimal thickness in the third, imparts unique electronic, optical, and mechanical properties compared to traditional 3D materials.

The report highlighted that 2D materials are at the core of next-generation semiconductors, memory, quantum devices, flexible electronics, and energy sys-

Ultra-thin 2D transistors can operate at sub-0.3V threshold voltages, delivering 5-10 times lower power dissipation than current FinFETs.

Additionally, 2D-based synaptic devices in highdensity neuromorphic arrays can shrink chip area by over 40 per cent without compromising performance.

However, it also cautioned that India's efforts in monoto-few-layer 2D materialsbased technology development remain at a very nascent stage.

Per plate food cost in India moderated in August as inflation moderates

Costs of home-cooked vegetarian and non-vegetarian thalis declined 7% and 8% year-on-year in August, respectively, in line with moderate commodity prices, according to Crisil Intelligence's latest Roti Rice Rate (RRR) report.

The decline in the cost of vegetarian thali was led by a sharp drop in the prices of onions, potatoes, and pulses.

Prices of potato and onion, according to the report, declined 31% and 37% yearon-year, respectively, on a high base.

"In the year-ago period, potato production had shrunk 5-7% due to blight infestation and weather changes, pushing up the prices. This year the production is estimated to be 3-5% higher. For onion, an 18-20% rise in annual production has led to a fall in prices this year," it has been

Prices of pulses declined 14% year-onyear, driven by higher production and stock levels compared with the year-ago period. Vegetable oil prices surged 24% year-on-year due to higher demand at the start of the festival season. Additionally, a 6% year-on-year increase in prices of liquefied petroleum gas cylinders limited the decline in the overall cost of thalis,

The decline in the cost of non-vegetarian thali was driven by a 10% year-onyear drop in broiler prices, which make up about 50% of the cost.

"Lower vegetable and pulses prices also supported," it added.

However, on a month-on-month basis, the cost of vegetarian and non-vegetarian thalis both rose, 4% and 2%, respectively, in August.

"The rise in the cost of non-vegetarian thali was capped as oversupply of broilers kept their prices stable on-month despite a rise in demand with the conclusion of the Shravan month," it added.

The overall year-on-year moderation in food costs is in sync with the decline in the headline inflation numbers.

India's retail inflation, as measured by the Consumer Price Index (CPI), eased sharply to 1.55 per cent in July 2025 on a year-on-year basis, marking the lowest level since June 2017.

India's apparel export outlook revised to negative from stable: ICRA

The outlook for the Indian apparel export industry has been revised to Negative from Stable by rating agency ICRA, following the upward revision in tariff rates by the US.

The move is expected to adversely impact India's overall apparel exports, with revenues likely to decline in the coming fiscal.

ICRA in a statement on Monday stated, "Lower exports and pressure on pricing to contract industry operating margins by 200-300 bps in FY2026; impact could be steeper for entities with higher concentration on the US market"

According to ICRA, if the

recently imposed tariffs continue, the revenues of apparel exporters may fall by 6-9 per cent in FY2O26, despite support from the Free Trade Agreement (FTA) with the UK and diversion of supplies to other geographies.

The agency also forecasts a decline in operating profit margins to around 7.5 per cent in FY2O26 from 10 per cent in FY2O25, as weaker operating performance in the second half of the fiscal is expected to reduce operational efficiencies. With lower earnings and

higher working capital dependence, credit metrics are also likely to moderate.

ICRA also added that India currently holds a modest

6 per cent share in the US apparel import market. Exporters are expected to work hard to retain their market position, as losing share could make recovery difficult.

The impact of tariffs will vary depending on product categories. For some specifications, an immediate shift of US orders to lower-tariffed countries may not be feasible due to differences in manufacturing capabilities and the time needed to build capacities.

In constant currency terms, India's apparel exports have been largely flat over the past five years, due to subdued demand in key markets and a shift in sourcing to Bangla

Food-processing sector a major International gold beneficiary of GST cuts

The food-processing sector has been a major beneficiary of the recently announced rationalisation of GST rates, with most products witnessing a decline to a 5 per cent GST slab.

The rationalisation of GST to lower levels provides a variety of stimulants to the sector and encourages a virtuous cycle of economic growth.

On September 22, the first day of Navratri, all changes in GST rates will come into effect.

"The simplified tax structure brings uniformity across food items with reduced number of tax slabs. A stable tax environment will help businesses plan long-term investments, encourage compliance, and drive economic growth," according to a statement from Ministry of Food Processing Industries.

Consumers will witness overall reduced food prices, making staples more afford-

"This in turn stimulates consumer demands, FMCG and packaged food businesses are expected to see an uptick in sales. Additionally, the simplification aids businesses by reducing compliance costs and lowering litigation risk." the ministry added.

The new structure helps correct inverted duty cases -- when inputs were taxed higher than finished prod-

The recent GST reform provides immediate relief for strengthening the value chains in the food sector, improving liquidity especially for MSMEs, reduce working capital blockage and promote domestic value addition.

The new structure eliminates classification disputes arising from varying tax rates for similar products.

For example, packaged versus loose paneer or parathas previously had different rates, but now follow a clearer structure and

greatly reduces classification disputes.

> "GST rate cuts will result in lower retail prices, which in turn will increase demand for manufactured products including processed food products," the ministry further said. "With increased demand, expected rise in investment and formalisation of industry, more employments opportunities are expected to be generated in the sector and economy as whole."

FROM POONA PACT TO **MANDAL PROTESTS: UNRAVELING INDIA'S CASTE QUOTAS AND CENSUS DEBATE**

In 1932, Gandhi's hunger strike forced a deal with Ambedkar: they scrapped separate Dalit electorates in exchange for reserved seats, setting the stage for India's caste-based reservations.

ahatma Gandhi was lying weak in Yerwada Jail, several days into a fast unto death. Outside, frenetic negotiations were underway between Gandhi's emissaries and Dr BR Ambedkar, champion of India's "Depressed Classes" (Dalits). The British government's Communal Award had granted Dalits separate electorates - a move Ambedkar welcomed, but Gandhi vehemently had opposed. Under immense pressure, Ambedkar and Gandhi struck a compromise on September 24, 1932. The resulting Poona Pact averted Gandhi's death and replaced separate electorates with reserved seats for Dalits in joint electorates. It is a seminal moment: an early framework for affirmative action in India, trading independent Dalit political representation for guaranteed representation within the Hindu fold.

Nearly six decades later, Prime Minister V.P. Singh rises in Parliament and announces the implementation of the Mandal Commission recommendations, extending government job quotas to "Other Backward Classes" (OBCs). The news alone would elect their repexplodes like a political bombshell. Protests erupt nationwide; students from upper-caste communities block roads and railways, some resorting to the most extreme form of protest **self-immolation**. The nation is convulsed by debates over merit versus social justice, unity versus caste

identities. Yet, despite the turmoil, the courts uphold the new OBC reservations, solidifying India's most sweeping affirmative action policy since independence.

These two turning points - the Poona Pact of 1932 and the Mandal revolution of 1990 - bookend a complex history of caste-based quotas in India. Together, they set the stage for today's renewed debates over **caste** census and the very counting of caste in policy.

Balancing the legal milestones, political movements, and social implications of India's quota system, while also comparing global approaches to affirmative action tells a story of ideals and compromises: from colonial-era bargains and postcolonial nation-building to the ongoing quest to measure and remedy historic injustices.

THE POONA PACT OF 1932: SETTING THE STAGE FOR **RESERVATIONS**

In September 1932, as Gandhi's life hung in the balance, Dr. Ambedkar faced an agonizing choice. The British Prime Minister Ramsay MacDonald's Communal Award had granted separate electorates to Dalits, meaning Dalit voters resentatives. Ambedkar saw this as essential for empowering a downtrodden com-

ter intense talks (and Gandhi's dramatic insistence that "separate electorates will create division among Hindus so much that it will lead to bloodshed"), a deal was struck.

The Poona Pact, signed on September 24, 1932, discarded separate electorates in favor of joint electorates with reserved seats for Dalits. Instead of the 71 seats that Dalits would have elected on their own under the British plan, the Pact reserved 148 seats for the Depressed Classes in provincial legislatures - 78 more seats than the Award had allotted. These Dalit candidates would be elected by the general Hindu electorate, but Dalit voters would have a primary election to shortlist candidates - a twotiered voting process meant as a workaround to ensure Dalits a voice without separate electorates (though the primary election idea was later dropped). The Pact also pledged to end untouchability and earmarked

within the framework of a united electorate. The Poona Pact was a com-

promise born of high drama and moral duress. Gandhi's approach, rooted in faith that upper-caste "change of heart" would erase caste inequities, clashed with Ambedkar's insistence that political power for Dalits was non-negotiable for true equality. Ambedkar ultimately yielded, fearing that if Dalits were seen as letting Gandhi die, it would provoke backlash against his people. In return, Dalits gained more reserved seats than originally offered, but lost the chance for separate, self-determined leadership. This trade-off had profound consequences. In independent India, the concept of reserved constituencies for Scheduled Castes (and Scheduled Tribes) was enshrined in the Constitution, echoing the Pact's framework. Today, a portion of parliamentary and assembly seats (84 of 543 Lok Sabha seats for SCs, for example) are reserved for Dalit candidates. However, as critics point out, Dalit voters often remain a minority in those same constituencies, meaning Dalit representatives still depend on the goodwill of the majority to win. Ambedkar had warned that joint electorates could leave Dalit politicians beholden to the dominant caste electorate, diluting independent Dalit voices. This critique reverberates even today - a legacy of the fraught pact Ambedkar once likened to being "a settlement reached under the coercion of a fast" (as he later bitterly described it).

Yet, the Poona Pact undeniably paved the way for reservations as a policy tool. By securing formal representation and pledges of fair treatment for Dalits, it introduced the principle The Pact's spirit would live on in the affirmative action clauses of India's post-independence Constitution, even as Ambedkar himself remained ambivalent about the compromise it forced

QUOTAS When India's Constitution took effect in 1950, it incorporated the ethos of affirmative action directly inspired by these earlier struggles. The new republic guaranteed equality but also included provisions empowering the state to make "special provisions" for the advancement of socially and educationally backward classes (Article 15(4)), and to reserve posts in public employment for under-represented groups (Article 16(4)). Using these, the Constitution explicitly reserved seats in legislatures, government jobs, and educational institutions for Scheduled Castes (SCs) and Scheduled Tribes **(STs)**, who together made up roughly 22.5% of the population. These reservations were intended as a temporary measure for 10 years, but seeing their continued necessity, Parliament has renewed them repeatedly – they remain in force to this day.

Crucially, the Constitution also recognized a category of "Other Backward Classes" (OBCs) - a wide spectrum of castes which were socially and educationally disadvantaged but not part of the SC/ST groups. However, identifying who exactly fell into this nebulous category was easier said than done. In 1953, the first **Backward Classes Commission** headed by Kalelkar (popularly known as the Kaka Kalelkar Commission) delivered a voluminous report listing **2,399 communities as** "backward", with recommendations for their uplift. Yet the report's findings were largely shelved; the government felt the criteria were too vague and the political will to act was lacking. Some states, especially in South India, forged ahead with their own backward class quotas – for instance, Tamil Nadu and Karnataka had longstanding reservations for OBCs dating back to pre-independence Justice Party reforms and later state policies. But a coherent nationwide policy for OBCs remained elusive for decades. By the 1970s, socio-political churn brought the

issue of OBC reservations back to the fore. **Rising** movements of intermediate castes and regional parties (often led by leaders from backward communities) began challenging upper-caste dominance in politics. This culminated in 1979 when the Janata Party government of Prime Minister Morarji Desai appointed the Second **Backward Classes Com**mission under chairmanship of B.P. Mandal – the commission that would become synonymous with **Mandal Commission**, as it came to be known, was tasked with defining criteria for backwardness and recommending measures to uplift OBCs in education and employment.

and analysis, the Mandal Commission submitted its report in 1980. Its findings provided a statistical underpinning to what many already observed in society: OBCs formed an enormous section of India's population and lagged behind socially and educationally. Using multiple criteria social stigma, educational attainment, representation in professions, etc. - the Commission identified **3,743 castes** as OBC and 2,108 "depressed backward classes" (the latter a subset needing especially urgent help). Combining survey data, census figures, and existing state lists, Mandal estimated that

After extensive surveys

OBCs constituted about 52% of India's population (including around 8% non-Hindu OBC groups), while "forward" (upper) castes were about 17.5%, and SC/ ST about 22.5%. This 52% figure from Mandal notably echoed the results of the **1931 caste census** – the last British-era census to count caste, which also found OBCs to be roughly half the population. It was an eerie continuity across time, suggesting that despite social changes, the broad pyramid of caste hierarchy – with a large base of "backward" communities - persisted

into independent India. The Mandal Commission's primary recommendation was bold: reserve 27% of seats in central government jobs and educational institutions for OBCs. (Mandal actually contemplated a higher quota proportionate to the 52% population share of OBCs, but was constrained by a crucial legal principle: the Supreme Court had earlier signaled that total reservations should not exceed **50%** in order to preserve OBC reservations. The meritocracy and opportunities for non-reserved categories. With 22.5% already set aside for SC/ST, Mandal's 27% for OBC would exactly hit a 49.5% total, under the cap.) The report also made other suggestions: financial support, educational opportunities, and land reforms to benefit backward classes. But it was the **quotas in jobs** and education that would

become a lightning rod. For nearly a decade, the Mandal report gathered dust as India saw unstable governments and leaders wary of the political risks. That changed in 1990, when V.P. Singh's National Front coalition, sensing a political and social imperative, decided to implement Mandal. On August 7, 1990, V.P. Singh announced in Parliament that 27% of central government jobs would be re**served for OBCs**, fulfilling Mandal's core recommendation. What followed was

nothing short of a political earthquake.



ment Mandal's 27% OBC reservations triggered fierce urban protests, especially among "general" category students. Rallies, bandhs and clashes with police became commonplace; the image of 19-year-old Delhi University student Rajeev Goswami attempting selfimmolation seared itself into public memory. The debate hardened into "merit vs reservation," with critics warning of diluted standards and supporters insisting that merit can't flourish without leveling historic barriers. Politically, Mandal reordered power: sections of upper-caste anger drifted toward the BJP, while OBCled parties and leadersmost visibly Lalu Prasad Yadav and Mulayam Singh Yadav-rode a wave of backward-caste assertion. Analysts often date the fracturing of Congress's dominance to the twin shocks of Mandal (caste) and Mandir (religion). Legally, the Supreme Court's **Indra** Sawhney (1992) judgment upheld the 27% quota, set a **50% ceiling**, created the creamy-layer exclusion, and restricted reservations in promotions. Over time, millions accessed jobs and education, fostering an OBC middle class even as critiques persisted about the poorest being left behind and benefits being cornered by the better-off.

COUNTING CASTES: THE HISTORICAL **ROOTS OF THE CASTE CENSUS DEBATE**

India's expansive reservation regime long ran on thin data: after 1951, the Census stopped counting caste (beyond SC/ST), leaving Mandal to lean on 1931 figures. A caste component gathered in SECC 2011 was never nationally released, compounding the deficit. Proponents of a new caste census argue that accurate, disaggregated data are essential to calibrate quotas, subclassify OBCs, and assess policies (including **EWS**). Opponents fear entrenching identities and zero-sum politics. State surveysmost notably Bihar's 2023 release showing OBC/EBC majorities-have intensified calls for a national exercise. With the Union signaling a caste enumeration in the next census, India appears poised to align its ambitious equity architecture with the evidence needed to steer it.

Scrolling into distraction: The impact of reels on working memory



In recent years, short-form video content commonly known as "reels" on platforms like Instagram, Tik-Tok, and YouTube Shorts has exploded in popularity. Designed to be fast-paced, engaging, and algorithmically addictive, reels offer instant entertainment with minimal cognitive effort. However, this growing trend has raised concerns among psychologists, educators, and neuroscientists about its potential effects on cognitive functions, particularly attention span and working memory. As millions engage with these platforms daily, it is important to examine whether reels are merely harmless fun or if they are subtly reshaping the way our brains function.

THE SCIENCE OF AT-**TENTION SPAN AND WORKING MEMORY**

Attention span refers to the amount of time a person can concentrate on a task without becoming distracted. Working memory, on the other hand, is the brain's ability to temporarily store and manipulate information to complete cognitive tasks like reasoning, learning, and comprehension. Both are essential for effective learning, productivity, and decision-making.

While attention and working memory are not fixed traits—they can be trained or deteriorated over time—they are sensitive to environmental stimuli and usage patterns. With the constant influx of digital content, especially in bitesized formats, our brains are increasingly exposed to rapid shifts in visual and auditory stimuli. This change in consumption habits is believed to influence the brain's attention systems and memory pro-


THE ALLURE OF REELS

Reels are intentionally designed to grab and hold attention in a matter of seconds. Their success lies in the combination of catchy audio, flashy visuals, short duration (typically 15 to 60 seconds), and the reward-based algorithm that tailors content to user preferences. This creates a "dopamine loop," a cycle in which the brain seeks more short bursts of pleasure by consuming more content. Over time, this can lead to compulsive scrolling behaviors akin to behavioral addiction.

The nature of reels also encourages constant novelty-seeking. Unlike traditional videos or articles that require sustained focus, reels condition the mind to expect new, exciting stimuli every few seconds. This may lead to a reduced tolerance for boredom and a lower threshold for cognitive effort, making tasks that require concentration feel tedious or unmanageable.

ATTENTION SPAN: SHRINKING BY THE SCROLL

Several studies suggest that frequent use of short-form video content may be contributing to a decline in attention spans. A 2022 study by the Technical University of Denmark found that the global attention span is narrowing due to the abundance of information and content. The research in-



dicated that as people are exposed to more rapid-fire content, their capacity to maintain focus on a single topic diminishes.

Reels encourage "attentional switching"-rapid shifts of focus from one piece of content to another. This multitasking-like behavior taxes the brain's executive control system, which manages focus, self-regulation, and goal-directed behavior. Over time, this may lead to difficulties in maintaining sustained attention in academic or work settings, reducing overall productivity and task performance.

WORKING MEMORY: A HIDDEN CASUALTY

While attention span is more visibly impacted by reels, working memory also faces subtle but significant consequences. When the brain is constantly bombarded with fragmented, uncontextualized information, it struggles to process and retain meaningful content. Reels often lack narrative depth or continuity, making it harder for the brain to form long-term connections or store information in working memory.

A study published in Nature Communications (2021) revealed that heavy users of

TikTok exhibited reduced brain activity in regions associated with working memory and cognitive control when compared to nonusers. This finding supports the hypothesis that habitual exposure to short-form video content can impair the brain's capacity to engage in deep, reflective thinking—a key component of working

Moreover, the constant consumption of shallow content can displace activities that strengthen working memory, such as reading, problem-solving, or engaging in complex discussions.

memory.

The brain, like a muscle, strengthens with use. When we stop exercising our working memory through mentally demanding tasks, it can weaken over time.

IMPLICATIONS FOR **LEARNING AND MENTAL HEALTH**

The implications of impaired attention and working memory are far-reaching. In educational settings, students who are accustomed to the high-speed nature of reels may find it difficult to concentrate during lectures, read lengthy texts, or engage in critical thinking exercises. This not only affects academic performance but also diminishes their capacity to absorb and retain new

information. In the workplace, reduced attention span can lead to frequent task-switching, increased errors, and decreased efficiency. Furthermore, poor working memory impairs decision-making and problem-solving skills, which are essential in almost all professional fields.

From a mental health perspective, the constant need for stimulation driven by reels may contribute to increased anxiety, restlessness, and even symptoms of ADHD in susceptible individuals. The inability to remain still or focus without external input may lead to frustration, low self-esteem, and a decreased sense of achievement.

CAN THE TREND BE REVERSED?

While the situation may seem dire, cognitive decline is not inevitable. Awareness is the first step toward change. By understanding how reels affect our brain, individuals can take conscious steps to mitigate their impact. This might include: Digital Detoxing: Taking regular breaks from short-

form content to allow the brain to rest and reset. Mindful Consumption: Setting time limits for apps, avoiding aimless scrolling, and choosing content with educational or meaningful

value. Cognitive Training: Engaging in activities that boost attention and memory, such as reading, puzzles, meditation, or learning a

new skill. Parental Guidance: Educating children and adolescents on healthy digital habits to build resilience against cognitive overstimulation.

The rise of reels and short-form video content represents a paradigm shift in how we consume information and entertainment. While these platforms offer accessibility and creativity, they also pose risks to cognitive health, particularly attention span and working memory. As with any powerful tool, the key lies in moderation and mindful use. By striking a balance between digital engagement and cognitive nourishment, we can ensure that our brains remain agile, attentive, and capable in an age

TEL AVIV, ISRAEL

A drone fired by Yemen's Houthi rebels breached Israel's multilayered air defenses on Sunday and slammed into the country's southern airport, the Israeli military said, blowing out glass windows, wounding one person and briefly shutting down commercial airspace.

The damage to Ramon Airport appeared limited and flights resumed within hours. The Houthis claimed responsibility for the strike.

The attack follows Israeli strikes on Yemen's rebelheld capital that killed the Houthi prime minister and other top officials in a major escalation of the nearly 2-year-old conflict between Israel and the Iran-backed militant group in Yemen.

In Gaza City, the Israeli military on Sunday leveled another high-rise tower that housed hundreds of displaced Palestinians and urged people to move south as it intensified its offensive on the city.

Meanwhile, a breakthrough Israeli Supreme Court decision ruled that Israel was not providing Palestinian detainees in its custody with enough food to ensure basic sustenance. It ordered the state to "guarantee basic living conditions in accordance with the law"

for the thousands of Palestinians in its detention facilities.

Sunday's ruling, made in response to a petition by Israeli human rights groups alleging starvation among Palestinians in the country's prisons, marked a rare instance of Israeli legal restraint on its own war policies that have drawn indignation and outrage abroad.

After Israel's killing of Houthi Prime Minister Ahmed al-Rahawi last Thursday, the militants vowed to escalate their attacks targeting Israel and merchant ships navigating the vital Red Sea trade route.

One of several Houthi

drones launched from Yemen on Sunday slipped through Israel's sophisticated defense system and crashed into the passenger terminal at the Ramon International Airport near the resort city of Eilat, the Israeli Airports Authority said, diverting flights over southern Israel and inflicting light shrapnel wounds on a 63-year-old man.

Houthi military spokesperson Brig. Gen. Yahya Saree said the group had fired eight drones at Israel to signal that the rebels operations and not back for Gaza." He warned that Israeli airports "are unsafe

and will be continuously targeted."

The Houthis have stepped up their aerial attacks on Israel in recent months. including by deploying warheads with cluster munitions that scatter smaller bomblets over a large area and can evade Israeli air defenses.

Saying that they were acting in solidarity with the Palestinians, the Houthis began firing missiles and drones into Israel after Hamas' Oct. 7, 2023 attack on Israel ignited the Israeli military's devastating campaign in Gaza. Hamas militants killed 1,200 people, mostly civilians, and abducted over 250 in their assault on southern Israel.

While frequent, the aerial attacks from Yemen have not caused significant damage in Israel.

the city's outskirts, killing five people. Fifteen others were rescued after the boat overturned Saturday, 1ocal officials said. Ghulam Shabir, a 50-year-old construction worker, said that he moved to higher ground near the city after floodwater

entered his village, inundating homes and farmland. He appealed to the government to expedite rescue work as many people were still stranded in flooded villages. The government has deployed hundreds of boats, and thousands of rescuers

and volunteers for evacuations in flood-hit districts.

The Pakistan Markazi Muslim League, a volunteer group known for being among the first responders in natural disasters, is among those involved in the efforts, with members spread across the country. The group's spokesman, Taha Muneeb, said that floodwaters had already submerged all the villages surrounding Jalalpur Pirwala and had begun to seep into the city itself.

"Many residents refuse to leave, saying it is better to remain on their rooftops than to sit helpless on the roadside," he said.

Survivors told reporters that many people remain stranded on rooftops and

China unveils plan to accelerate integration of AI with energy sector

China on Monday unveiled a new plan to accelerate the integration of artificial intelligence with the energy sector to achieve breakthroughs in key technologies such as data, computing power and algorithms.

The plan was announced even as the new data shows the numbers of AI firms in

the country surged to 5000 from 1400 in the past five vears

Xin Guobin, vice minister of industry and information technology, released the new data at the World Smart Industry Expo in Chongqing, state-run Xinhua news agency reported on Monday.

The date reveals the rapid growth of the AI sector in China which also enabled the country to make rapid strides in e-vehicles.

The plan emphasizes breakthroughs in key technologies such as data, computing power and algorithms, outlining measures to optimize data-sharing mechanisms, establish a deeply integrated mechanism for coordinating computing power and

electricity, and drive deeper integration of AI and soft-

ware in the energy sector. The plan, jointly issued by the National Development and Reform Commission and the National Energy Administration, sets targets for 2027 to basically establish an innovation system for AI-energy integration and achieve notable breakthroughs in AI-enabled technologies in the energy

China has set up over 40,000 smart factories, 11 national pilot zones for AI innovation and application, as well as 17 national demonstration zones for intelligent connected vehicle testing, the data reveals.

Also China has launched a 60-billion-yuan national AI industry investment fund to set up rules on AI ethics, China-BRICS centre for AI development and cooperation, and over 240 standards for core AI technologies.

By 2030, China aims for its AI applications in the energy sector to reach a world-leading level overall, with a more advanced mechanism for coordinating computing power and electricity supply, the plan

Ukraine briefs diplomats on Russia's biggest aerial assault

Senior Ukrainian officials led 60 foreign diplomats on a tour of damaged government offices in the heart of Kyiv on Monday, a day after Russia's largest aerial attack on Ukraine since its all-out invasion began more than three years ago.

Russia's assault on Sunday involved more than 800 drones and decoys and occurred as months of U.S.-led peace efforts appear to be getting nowhere. Four people were killed, including a mother and her infant, as drones hit apartment buildings. A plume of smoke rose from the capital's main government building where top officials have their offices.

It's believed to be the first time a Russian attack has struck the 10-story, Sovietstyle building, which was built almost a century ago and has an imposing half-

diplomats, Ukrainian Prime Minister Yuliia Svyrydenko, Foreign Minister Andrii Sybiha and Interior Minister Ihor Klymenko showed them burnt-out offices littered with charred debris.

Another deadline by U.S. President Donald Trump, set in August, for the Kremlin to change course or face severe consequences has passed. Trump has shrunk from imposing more sanctions on Russia despite its onslaught and has blamed both sides in the war for the ongoing fighting, even though Ukraine is defending itself from the full-scale invasion launched by its bigger neighbor on Feb. 24, 2022. Trump said Sunday that he expected to speak with Russian President Vladimir Putin in the next couple of days and acknowledged that the conflict had proved harder to resolve than he anticipated.

Navarro slams India's Russian oil trade, disputes fact-check

US President Donald Trump's senior trade adviser Peter Navarro has once again launched a blistering attack on India's energy trade with Russia, terming its crude imports as "blood money" and accusing India of profiteering from the Ukraine conflict.

On Monday, Navarro, who serves as the White House's Senior Counsellor for Trade and Manufacturing, posted on X that "India didn't buy Russian oil in large quantities before Russia invaded Ukraine. It's blood money and people are dying." He used an expletive to describe the platform itself, calling it "bull****," for being fact checked.

Navarro has been ranting for weeks against India's Russian oil purchases and tariffs. In an earlier post, he claimed: "India highest tariffs costs

U.S. jobs. India buys Russian oil purely to profit/Revenues feed Russia war machine. Ukrainians/Russians die. U.S. taxpayers shell out more. India can't handle truth/spins Leftist American fake news."

When X intervened with community notes, pointing out that India's purchases were legal, aimed at energy

security, and did not violate sanctions, Navarro lashed out at the platform's billionaire owner Elon Musk. He wrote: "Wow. Elon Musk is letting propaganda into people's posts. That crap note below is just that. Crap. India buys Russia oil solely to profiteer. It didn't buy any before Russia invaded Ukraine. Indian govt spin machine moving high tilt. Stop killing Ukrainians. Stop taking American jobs."

The community notes on X repeatedly rebutted Navarro's claims, stressing that India's energy procurement is a sovereign decision and does not breach international law. The notes also underlined what they described as Washington's "double standards," highlighting that the US itself continues to import billions worth of commodities from Russia, including uranium and minerals, even while

Trump plans Putin talks as European leaders visit US

As Russia continues to escalate its strikes on Ukraine, US President Donald Trump on Sunday (local time) said that he has plans to speak with his Russian counterpart Vladimir Putin in the coming days, as several European leaders are expected to visit the United States for what he described as "very interesting discussions" aimed at resolving the ongoing Russia-Ukraine conflict.

"Over the next couple of days, we're going to get it done--the Russia-Ukraine situation," Trump said. "We're going to get it done. Have confidence. We will

get it done."

Speaking to reporters at Joint Base Andrews in Maryland after returning from the US Open finals, Trump expressed deep dissatisfaction with the current state of affairs related to the conflict but reiterated his belief that peace is within reach.

"We'll see. We have very interesting discussions. European leaders are coming over to our country on Monday or Tuesday, individually, and I think we're going to get that settled. I think we're going to get it done. We have to," he added.

Trump, who has long touted his personal rapport with Putin, was asked whether the Russian leader's recent actions, including a major weekend assault on Ukraine, had changed his views. In response, Trump emphasised that while he had been "tougher on Russia than anyone", he was deeply troubled by the

"Nobody was tougher on Russia than I was," Trump said. "But I'm not happy. I'm not happy about the whole situation. It's interesting--it doesn't affect us. It's not our soldiers. It's a horrible waste of humanity."

Prince Harry visits queen's grave, meeting speculation grows

Prince Harry arrived in the U.K. on Monday leading to speculation about whether he will meet with his father, King Charles III, for the first time in 19 months.

Amid signs of a thaw in the frigid relationship between Harry and the rest of the royal family, British media suggest that the prince's trip to London on Monday's third anniversary of the death of Queen Elizabeth II provides an opening for a long-overdue rapprochement between Charles. 76, and his estranged son. Harry visited the monarch's grave in Windsor to offer his respects and lay flowers.

Harry has had little contact with his father and elder brother, Prince William, since he and his wife, the former Meghan Markle, gave up royal duties and moved to California in 2020. The relationship became even frostier after the

couple bared their grievances with Buckingham Palace in a tell-all interview with Oprah Winfrey, a Netflix series and Harry's memoir. "Spare."

The last time Harry and Charles met was in February 2024, when the prince flew to London after receiving news that his father had been diagnosed with cancer. Harry spent about 45 minutes with Charles before the king flew to his Sandringham country estate to recuperate from his treatment. Harry was last in London

in April, when the Court of Appeal rejected his bid to restore a police protection detail that was canceled after he stopped being a working royal. Charles was on a state visit to Italy at the time, so a meeting was impossible.

That case was itself an impediment to improved relations because it involved Harry criticizing the king's government in the courts. But once it was over, change became possible. Immediately after the case ended, Harry said he would "love reconciliation with my fam-

"There's no point in continuing to fight anymore," he told the BBC on the day the court case was resolved. "Life is precious. I don't know how much longer my father has."

Despite that olive branch, Harry struck a combative tone that might torpedo hopes of repairing the family

breach. The prince repeatedly said that the decision to withdraw his security was made at the direction of the royal household in an effort to control him and his wife while putting their safety at

"What I'm struggling to forgive, and what I will probably always struggle to forgive, is the decision that was made in 2020 that affects my every single day and that is knowingly putting me and my family in harm's way," Harry

Indonesian leader fires ministers of finance and security after deadly protests

Indonesia 's president announced a Cabinet reshuffle Monday, replacing key economic and security ministers after deadly protests erupted across the country over lawmakers' perks.

The Cabinet shake-up comes as public dissatisfaction rose with President Prabowo Subianto's admin-

istration and parliament's perceived insensitivity over economic hardships.

Five ministers lost their jobs, including Finance Minister Sri Mulyani Indrawati, a widely respected technocrat who had served as the executive director of the International Monetary Fund and managing director of the World Bank, and Budi Gunawan, the coordi-

nating minister for politics

and security.

Subianto chose economist Purbaya Yudhi Sadewa, chairman of the Deposit Insurance Corporation, to replace Indrawati, 63, one of Indonesia's longest-serving finance ministers.

Violent protests had gripped Southeast Asia's largest economy, home to more than 280 million people, after reports that all 580 members of the

receive a monthly housing allowance of 50 million rupiah (\$3,075), in addition to their salaries. The allowance, which was introduced last year, is nearly 10 times the minimum wage in The National Commission on Human Rights, known as Komnas HAM, an independent institution, reported that 10 people died during the five-day protests, mostly

photo recently showed him playing dominoes with a former illegal logging suspect.

Indonesian stocks tumbled Monday after Subianto removed Indrawati from his Cabinet. The Jakarta Composite Index closed down 1.28% at 7,766.85, shedding 100.5 points, while the rupiah strengthened 0.75% against the U.S. dollar to





Voyages: The Ancient Maritime Silk Route is an art exhibition that takes inspiration from the historic maritime trade and cultural exchanges between the coastal regions of South India and Southeast Asia, spanning from as early as the 3rd century CE until the 15th century CE. For the artists Gunjan Jain and Suresh Muthukulam, and for curator Jaya Mani, the making of this show has itself been a modern-day voyage of discovery. Free from



the limitations of academic scholarship, their creative imaginations were able to travel unhindered, leading



to a body of work infused with wonder, symbolism, and a sense of magic.

The Pallava empire, which

tinent, did not restrict its people from crossing the seas. This openness later expanded under the Chola dynasty, which left a profound imprint on Southeast Asia through maritime trade, religion, and art. Traders, teachers, priests, and adventurers from South India continued to dominate cultural exchanges in the region until around 1500 CE. The ocean became their canvas, mythical sea creatures their motifs. A year later in Odisha, Muthukulam immersed himself in the intricacies of handloom weaving, while weavers engaged with the sensibilities of a mural artist. 

SC turns down Telangana BJP's plea against order quashing defamation case against CM reddy

he Supreme Court on Monday turned down a petition filed by the BJP's Telangana unit challenging the High Court's decision to quash a defamation case against Telangana Chief Minister A Revanth Reddy.

The case stemmed from Reddy's remarks during the 2024 Lok Sabha election campaign.

The bench, led by Chief Justice of India B R Gavai and accompanied by Justices K Vinod Chandran and Atul S Chandurkar, declined to interfere, stressing that courts should not be drawn into political disputes.

"We are time and again saying don't use this court for political battles. Dismissed. If you are a politician, then you should have a thick skin," the court re-

BACKGROUND

The controversy traces back to May 2024, when the BJP's Telangana unit, through its general secretary, lodged a complaint alleging that Reddy's campaign speech defamed the party. The complaint accused him of spreading false narratives, including claims that the BJP planned to abolish reservations if elected. According to the complainant, such

statements misled voters and damaged the party's reputa-

The trial court in Hyderabad, in August 2024, had found that the complaint established a prima facie case for offences of defamation under the IPC and Section 125 of the Representation of the People Act, which pertains to promoting hostility between groups during

The court further pointed out that the state BJP unit was not authorised by the national leadership to file such a complaint. "Even if this court were to accept that the complainant is a part of the national unit of the Bharatiya Janata Party and may be treated as a member of the Bharatiya Janata Party, the complaint is not maintainable for the lack of authorisation," it noted. Accordingly, the high court dismissed the complaint and quashed the trial court's proceedings.

TIMELINE OF ARRESTS & CHARGES

Nitish Katara murder case: SC refuses to extendinterim bail of Vikas Yadav, asks to move HC

The Supreme Court on Monday refused to extend interim bail granted to Vikas Yadav, who is serving a 25-year sentence in the 2002 Nitish Katara murder case.

A bench of Justices M.M. Sundresh and Satish Chandra Sharma directed Yadav's counsel to approach the Delhi High Court for either an extension or fresh interim bail.

COUNSEL'S PLEA REJECTED

During the hearing, Yadav's counsel pressed for the apex court to consider extending the interim bail instead of asking him to move the High Court. However, once the bench indicated it was inclined to dismiss the plea, the counsel agreed to approach the High Court.

Last week, the court had extended Yadav's interim bail by one week after he challenged the Delhi High Court's August 22 order declining to prolong his release.

GROUNDS FOR INTERIM BAIL

Yadav, 54, who has been



behind bars for more than 23 years, had sought interim bail citing two reasons: to look after his ailing mother who had undergone surgery, and to attend his marriage scheduled for September 5.

On April 24, the apex court granted him interim bail to care for his mother, directing that he reside only at his Ghaziabad home.

The court made it clear that he must not contact witnesses in the case, including Neelam Katara, mother of the victim. It also ordered police in Delhi and Uttarakhand to provide security to witnesses and Neelam Katara.

Since then, his interim bail had been extended multiple times until the Delhi High Court rejected further relief.

PENDING ISSUES

Yadav has also filed a plea before the Supreme Court challenging the denial of remission benefits, which remains pending.

AND LEGAL HISTORY

In May 2008, a trial court convicted Yadav for the murder of Nitish Katara, a young business executive, ruling that Katara was killed because of his relationship with Bharti Yadav, Vikas's sister.

On October 3, 2016, the Supreme Court upheld jail terms for Vikas and his cousin Vishal Yadav, imposing 25 years of imprisonment without remission.

The court found that they had kidnapped Katara from a marriage party on the night of February 16-17, 2002, before murdering him.

The Supreme Court on Monday agreed to take up the bail petition of Mahesh Raut, an accused in the Elgar Parishad-Bhima Koregaon case, citing serious medical concerns.

A bench of Justices M.M. Sundresh and Satish Chandra Sharma will hear the matter on September 15, as Raut challenges his continued detention despite being granted bail by the Bombay High Court.

Bail Granted But Stayed

By NIA's Request Earlier, the court allowed Raut's bail petition but stayed the release for a week after the National Investigation Agency intervened. The Supreme Court later extended that stay, keeping him in custody pending further proceedings.

Raut's lawyer informed the court that the activist is

The bench acknowledged the plea but opted for caution, stating that authorities should submit details before deciding. "If the ailment is so serious that it warrants

there is no difficulty. Because all of us know that government doctors play it safe. If serious treatment is required, they will not touch it because if anything happens then they will be responsible. So let's just find out, no problem," the bench remarked.

The court asked the authorities to file an affidavit explaining Raut's health condition and adjourned the matter for further hearing next Tuesday.

DURATION OF CUSTODY ALSO CONSIDERED Raut's counsel pointed out

that the activist has spent nearly 7 years in prison. Justice Sundresh responded affirmatively, "No issue at all, we will consider it. Keep next Tuesday."

CARLOS ALCARAZ BEATS RIVAL JANNIK SINNER AT THE U.S. OPEN

o maybe the first U.S. Open final between young, elite rivals Carlos Alcaraz and Jannik Sinner wasn't as long, riveting and dramatic as their matchup to decide the championship at the French Open. Perhaps it wasn't as seemingly meaningful and plot-driven as their showdown for the Wimbledon trophy.

Still, what the No. 2-seeded Alcaraz's 6-2, 3-6, 6-1, 6-4 victory over No. 1 Sinner on Sunday did do was significant. Alcaraz reasserted his superiority over the defending champion, wrested away the top spot in the ATP rankings and left tennis fans eager for whenever their next clash will come.

They are the first two men in the sport's history to face each other in three consecutive Grand Slam finals within a single season.

"I'm seeing you more than my family," Alcaraz joked during the trophy ceremony, eliciting a grin from Sinner. "It's great to share the

Indian hockey comes back on track only after recovering from setbacks

The last five years have been full of ups and downs for Indian hockey. During this period, India finished on the Olympic podium twice and also won a medal in the Pro Hockey League on one occasion, but after that the hockey team fell flat on its face in the European leg of the Pro Hockey League, where it lost seven matches one after the other and could only manage to fin-

ish eighth out of nine teams. India's world ranking, which had reached third place in the world in these years, has now slipped to seventh place. But now once again the hopes of Indian hockey's graph rising have been raised.

It will be called a good sign that India's performance showed a lot of improvement in the Asia Cup. Although it took some time for India to

find the rhythm, but once it caught the rhythm, India never looked back. Be it Malaysia, China or South Korea, all of them fell flat on their faces in front of India. The result of all this was that India succeeded in qualifying for the World Cup Hockey to be held in Belgium and Netherlands next year. This means that now there will be no pressure on India to enter this prestigious tournament in future competitions and India will be able to prepare for it without any pressure.

It is true that in the Asia Cup, apart from India, no team was in the top 10 rank12th and South Korea was ranked 13th and Japan has also surprised good teams from time to time. It has even proved itself by winning the gold medal in hockey in the 2018 Asian Games. Apart from this, China has raised hopes by reaching the final of the Asian Champions Trophy last year. Then it lost to India by just one goal in the final. This time too, it lost to India by a margin of one goal in the league match. But after the league match against South Korea in Super-4, the Indian team found a great rhythm in the next match against Malaysia and by scoring 15 goals in the last three matches including the final, proved that stopping the current hockey team is not only difficult but impossible for the Asian

teams at this time. India scored a total of 39 goals in the Asia Cup and nine goals were scored against it. Among these, our Sarpanch Sahab i.e. Harmanpreet Singh, Abhishek Nain and Sukhjeet Singh scored six goals each while Dilpreet and Jugraj Singh scored four goals each. Apart from this, Mandeep Singh scored three, Shilanand Lakra and Amit Rohidas scored two

Rai, Vivek Sagar Prasad, Sanjay Rana, Hardik Singh, Manpreet Singh and Rajinder Singh scored one goal each. That means a total of 14 players scored goals in the entire tournament. From this, it can be estimated how many match winners India has. This shows its scoring power. Among these, the number of field goals is the highest. Apart from this, goals were also scored on penalty corners and counter-attacks.

The other good thing about the Indian team is that if the team's plan A does not work, then coach Craig Ful-

goals each and Rajkumar ton quickly brings the team to the second plan. If the Chinese defenders kept the Indian forwards under control to a great extent against China, then Fulton adopted the strategy of Plan B against the same Chinese team in the Super-4 match, under which India showed aerial passes and three-D skills. Also, we were successful in the strategy of tricking the opposition with good stickwork in the opponent's D. When the team got into rhythm, its speed also increased, which most teams could not match.

During practice in Bengaluru, the Indian team practiced on fast turf, which also helped India on the fast turf of most international tournaments, but the turf of Rajgir was slower than this, and it took some time for India to adjust to it.
